Duty on palm oil cut to 12.5 pc



New Delhi: The government Monday cut the basic customs duty on refined palm oil to 12.5 per cent from 17.5 per cent as part of efforts to increase domestic supplies and bring down the retail prices of the cooking oil. The revised Basic Customs Duty (BCD) will be effective till the end of March 2022. The latest move also comes on a day when the government decided to allow traders to import refined palm oil without licence for one more year till December 2022 and markets regulator banned launch of new derivative contracts of crude palm oil and a few other agricultural commodities. All these measures have been put in place at a time when inflation is ruling high.

The findings sug doses are needed to maintain protection in those vaccinated with Covishield or Oxford-Astra Zeneca

London, Dec 21: The protection offered by the Oxford-Astra Zeneca COVID-19 vaccine declines after three months of receiving two doses of the preventive, according to a study published in The Lancet journal.

The findings drawn from datasets in Brazil and Scotland suggest that booster programmes are needed to help maintain protection from severe disease in those vaccinated with AstraZeneca, known as Covishield in India

The researchers analysed data for two million people in Scotland and 42 million people in Brazil who had been vaccinated with the AstraZeneca vaccine. In



Scotland, when compared with two weeks after receiving a second dose, there was approximately a fivefold increase in the chance of being hospitalised or dying from COVID-19 nearly five months after being double vaccinated, the researchers said.

The decline in effectiveness begins to first appear at around three months, when the risk of hospitalisation and death is double that of two weeks after the second dose,

they said. The researchers from Scotland and Brazil found that the risk of hospitalisation and death increases threefold just short of four months after the second vaccine dose. Similar numbers were seen for Brazil, they said.

"Vaccines have been a key tool in fighting the pandemic, but waning in their effectiveness has been a concern for a while," said Professor Aziz Sheikh, from the University of Edinburgh, UK. "By

vaccine, it should be possible for governments to design booster programmes that can ensure maximum protection is maintained,' Sheikh said.

The team was able to compare data between Scotland and Brazil as they had a similar interval between doses -- 12 weeks -- and initial prioritisation of who was vaccinated -- people at highest risk of severe disease and healthcare workers. The dominant variant was different in each country during the study period - Delta in Scotland and Gamma in Brazil.

This means the decline in effectiveness is likely because of vaccine waning and the impact of variants, according to the researchers. The study also estimated vaccine effectiveness at similar fortnightly intervals by comparing outcomes of people who have been jabbed with those who are unvaccinated.

New Delhi, Dec 21: Parliament Tuesday passed a bill to link electoral roll data with the Aadhaar ecosystem with Rajya Sabha passing it by voice vote amid a walkout by the opposition.

The Election Laws (Amendment) Bill, 2021, which was passed in Lok Sabha Monday, seeks to weed out fake voters from electoral rolls. It seeks to allow electoral registration officers to seek Aadhaar number of people who want to register as voters "for the purpose of establishing the identity"

At the same time, the amendment bill makes it clear that "no application for inclusion of name in the electoral roll shall be denied and no entries in the electoral roll shall be deleted for inability of an individual to furnish or intimate

Aadhaar number due to such sufficient cause as may be prescribed". The bill was passed after an hourlong discussion with members of several parties supporting it but had some concerns. They said the bill is part of electoral reforms and will help weed out fake and bogus voters in the electoral rolls. Brushing aside opposition crit-

icism, Law Minister Kiren Rijiju said, "In our democracy, the electoral process should be cleansed and that can happen only if the electoral rolls are clean." "This bill will be opposed only by those who take advantage of fake voting. Otherwise, there is no basis for opposing this bill," he said, adding the new and genuine voters will never forgive them for doing so. He said the country has understood how necessary the electoral reform bill is and termed it as a "revolutionary bill".

CBI books trader over loan fraud

Bhubaneswar: The Central Bureau of Investigation (CBI) Tuesday registered two fresh cases against Cuttack-based businessman for duping a nationalised bank of more than Rs 40 crore. The accused businessman, Pawan Kumar Jajodia, was also allegedly involved in another loan fraud case worth several crores as well. The accused through two of his firms, took loans worth over Rs 40 crores from the bank's branch at KIIT-KIIMS complex in 2015. Later, he defaulted on the payment of installments and the account became a non performing asset. Subsequently, the bank also came to know that the accused availed the loan through various illegal means.

Banker arrested for availing loan illegally

Bhubaneswar: Commissionerate Police Tuesday arrested a woman staff of a nationalised bank for illegally availing loan against the fixed deposit account of a 62-year old retired government servant. The bank authorities recently dismissed the accused, who was holding the post of assistant manager in Andhra Bank (currently Union Bank of India), after her illegal activities came to fore. The accused lady banker was identified as Meena Naik, 40, of Baripada in Mayurbhani district. She is currently staving at Mahalaxmi Vihar under Bharatpur police limits. Police arrested Naik after registering a case (439/21) on the basis of a complaint registered by Hrushikesh Bhujabal of Ghatikia area.

Bhubaneswar, Dec 21: At a time when the state government is pleading before the banks to open more branches in the state, Union Minister of State for Finance Bhagwat Karad Tuesday said all panchayats of Odisha are covered with banking outlets within 5km radius.

Replying to a question of Rajya Sabha MP Prasanna Acharya, Karad said all the GPs (gram panchayats) of Odisha are covered with banking outlets including bank branches, business correspondents and India Post Payments Bank (IPPB) centres within 5km radius.

To ensure availability of banking outlets within 5km of all inhabited villages, the Centre has launched a Geographic Information System (GIS) based mobile app, Jan Dhan Darshak App (JDD App). The banks upload the GIS lo-

cation of their branches, business correspondents (BCs) and automated teller machines (ATMs) on the app.

In terms of the revised guidelines issued by Reserve bank of India (RBI) May 18, 2017, the term 'branch' has been substituted by 'banking outlet (BO)' which includes the brick and mortar branches and business correspondent (BC) outlets to enable banks in expanding their network even in remote areas in a cost-effective manner for hassle-free service to customers,

the Union minister said. However, rolling out of banking outlets in uncovered areas is a continuous process and it is being looked after by the State Level Bankers' Committee (SLBC), in consultation with the concerned state government, member banks and other stake-

holders, he added. The banks are also considering the proposals for opening banking outlets by assessing the commercial viability. The banks carry out surveys to assess the

viability of opening a banking outlet, Karad said. A total of 26,673 banking touch points including 5,822 bank branches

and 20,851 business correspondents are providing banking services in Odisha, he added.

BJD backs electoral reforms Bill in RS

New Delhi: The Biju Janata Dal (BJD) in the Rajya Sabha Tuesday supported the Election Laws (Amendment) Bill, 2021 that seeks to link electoral

bility of abuse of this intent. If the purpose is to ascertain identity of a voter then Aadhaar number is enough but why should we link Aadhaar with voter card,' Kumar said.

The BJD MP raised apprehensions that following this amendment some people may be left out of the voter list. He claimed that use of Aadhaar for PDS and MGN-REGA payments also resulted in exclusion of some beneficiaries.

He also said that this proposed linkage will make the data available to Election Commission of India but there is possibility that the data will be used for targeted political advertisement.

"In the absence of data protection, if the data is available to one political party then it should be made available to every other political party," Kumar said.

Significantly, the Election Laws (Amendment) Bill, 2021 that seeks to link electoral rolls to Aadhaar numbers was passed in the Rajya Sabha Tuesday, amid protests from **Opposition members**

The Bill was passed in the Lok Sabha Monday.

The Bill allows electoral registration officers to ask for Aadhaar numbers of applicants seeking to register themselves as voters. Union Law and Justice Minister Kiren Rijiju, however, clarified that linking of Aadhaar to Electoral Photo Identity Card is voluntary.

The Bill also seeks to allow the officers to ask for the Aadhaar numbers from persons who have already been included in the electoral rolls for the purpose of authentication of entries.

fter Hurricane Katrina in 2005, Ida was the second most damaging And intense hurricane to wreck US State of Louisiana. During landfall, the maximum sustained wind speed was 240kmph. The remnants of the system also caused floods and tornadic destructions across the Northeastern US. Ida, since its inception August 23 in the Caribbean Sea, showed signs of becoming a formidable foe and developed into a tropical depression August 26 and subsequently a tropical storm the same day. The system became a hurricane the next day and moved over Cuba. Owing to rapid intensification over the Gulf of Mexico, Ida turned into a category 4 hurricane and made landfall August 29, also the 16th anniversary of Katrina, devastating the town of Grand Isle. Texas Storm Uri

Winter Storm Uri affected US, Northern Mexico and parts of Canada from February 13 to 17. It started out in the Pacific Northwest, quickly moved into the Southern US and subsequently to the Midwestern and Northeastern US. Uri pushed over 170 million Americans under winter weather alerts and caused blackouts for over 9.9 million people in the US and Mexico, most notably in the 2021 Texas power crisis. It also brought severe weather to Southeastern US, including several tornadoes. By July 14, the death toll had riser to at least 237, including 223 in the US and 14 in Mexico. The system cost over \$196.5billion in damages, including at least \$195billion in the US and over \$1.5billion in Mexico, making it the costliest winter storm on record and the costliest natural disaster in the US.

The year 2021 did nothing positive for the world. It rather rubbed salt into the wounds---- adding cascades of calamities to the pandemic. Earth became a cauldron of chaos, leaving thousands dead and stranded due to successive natural disasters. The very elements of the planet became hostile, raising eyebrows over the evident climatic shift while burning, ravaging and submerging parts of almost every continent. From hurricanes and winter storms in North America to cyclones, volcanoes and typhoons in Asia, nature unleashed its fiercest of forces to torment the already gasping mankind. Orissa POST takes a look back at the endurance of human race in 2021 on the face of a rather nightmarish guise of the world

The Tiburon Peninsula in the Caribbean nation of Haiti was toppled by a devastating magnitude 7.2 earthquake at 8.29 EDT August 14. The 10km deep hypocentre was located 150km west of the capital Port-au-Prince. The quake damaged at least 1,37,500 buildings and left around 6,50,00 people in need of assistance. As of September 1, the death toll was 2,248 and over 12,000 people were injured. The quake remains the deadliest natural disaster of 2021, and the worst disaster to mar Haiti since 2010 earthquake. It has affected more than half a million children, as per UNICEF, and has inflicted an economic loss of over 1.5 billion US dollars which is 10% of the country's economy. The quake claimed the most casualties of any disaster since the 2018 Sulawesi earthquake and subsequent tsunami, which had killed close to 5,000 people.

The Chamoli disaster began February 7 in the environs of the Nanda Devi National Park in the outer Garhwal Himalayas in Uttarakhand. The mayhem was caused by a large rock and ice avalanche estimated at about 27 million cubic meters with 80% rock and 20% glacier ice. and Switzerland. At least 242 people have died in the floods,

including 196 in Germany, 42 in Belgium, 2 in Romania, 1 in Italy

and 1 in Austria. July and August saw many floods occurring at

similar times in Turkey, China, India, Afghanistan, Pakistan, the

US and New Zealand. In addition to the confirmed fatalities, the

flooding led to widespread power outages, forced evacuations

and damage to infrastructure and agriculture in the affected

areas. The damage to infrastructure was especially severe in

Belgium and Germany. The floods are estimated to have cost

up to 3 billion USD in insured losses, with the total damage

costs being much higher, at a minimum of 11.8 billion USD.

La Palma eruptions

The 2021 Cumbre Vieja eruption, the most damaging volcanic eruption on La Palma, began September 19 as a flank eruption at the volcanic ridge comprising the southern half of the Spanish island of La Palma in the Canary Islands. It has caused evacuation of around 7,000 people, and the lava flow has covered over 1,000 hectares. The lava flow is about 3.5km wide in its widest point, about 6.2km long and has reached the sea, destroying over 3,000 buildings, cutting the coastal highway and forming a new peninsula. The town of Todoque, including its easternmost neighbourhood Los Campitos, was completely destroyed by lava, which has also reached La Laguna. The 3-month long eruption has been silent since December 13 and 1 death has been reported.



Wildfires Even at halfway through the calendar year, wildfire seasons were occurring in multiple continents and were larger than in previous history, with increased extreme weather such as droughts and heat waves caused by climate change strengthening the intensity and scale of fires.

Don't Laugh, Nor Cry

No one in North Korea was allowed to buy provisions from grocery shops December 17 to mark the death anniversary of the supreme leader of the country Kim Jong Un's father, Kim Jong II, who had ruled for 17 years until his death in 2011. Ironically, within a week of over 100 countries attending a US-sponsored virtual Summit for Democracy, the world is made to witness the height of dictatorship and trampling of individual freedom in North Korea. A ban has been imposed by the authoritarian regime on exhibiting in public the simplest of human emotions such as laughing and crying for 11 days when the country is in a state of mourning to grieve the death of their past leader who could not even free them from the shackles of hunger during a severe food crisis. What the North Koreans are being made to do is but a continuation of a practice, with even more harshness, being followed for the past decade. Many people who were caught drinking or being intoxicated during the mourning period in the past were arrested and treated as ideological criminals. They were taken away and never seen again.

What is appalling this time is the diktat that even if someone's family member dies during the mourning period, they would not be allowed to cry out loud and the body must be taken out only after the mourning period is over. People would not be allowed to celebrate birthdays either. The state television broadcasts showed people observing several moments of silence and bowing before portraits and statues of the departed leader, while air-raid sirens and car horns could be heard blaring and beeping. Kim Jong Un was shown with hundreds of officials at a ceremony outside the Kumsusan Palace of the Sun in the capital, Pyongyang, where the body of North Korea's founding leader, Kim II Sung, also lies in state under glass. The three generations of the Kim family have ruled the country since 1948.

The question is whether the outpouring of grief is sincere or contrived, a product of brainwashing. Some North Koreans are believed to be sincerely sorrowful. But, analysts explain a minority who have benefited under Kim Jong II's rule, belonged to the category of sincere mourners. Though the state media showcased the wailing students from Pyongyang's premier Secondary School as genuine expression of grief, fact is this school is where the elites, benefiting from the regime, go. But it is surprising that teens of a higher secondary school would actually be bothered to cry or laugh at the death anniversary of any leader who has passed away long back.

To complete the picture of authoritarian rule, state police officers have been deployed to watch for people who fail to look appropriately upset during the mourning period. From the first day of December, they have been tasked to crack down on those who try to destroy the mood of collective mourning in any way. It is a month-long special duty for the police.

To keep up the illusion of humane conduct of the regime, citizen groups and state-owned companies have been ordered to take care of those in poverty during the period of mourning, as the country is in the grip of a food crisis. The message that is being given out is social order and safety must be ensured and companies are being made to collect food to give to residents and employees who cannot come to work due to food shortages. Instructions have also been given to help out the 'kotjebi' (North Korea's street beggars).

Kim Jong II ruled North Korea from 1994 until his death in 2011, and was then succeeded by his third and youngest son, current leader Kim Jong Un. Words trickling down from North Korea give a grim picture of the citizens' suffering during the period of mourning. The common refrain of many people is that the living are being forced to mourn the dead leader to death.

Even the services of old soldiers who had worked during Kim Jong II's tenure are being used to deliver lectures to workers in factories on the supposed dedication of the departed leader "in the cause of the people." The propaganda is so blatant that reports emanating from North Korea suggest the people want food, coal and firewood during the winter and the raging COVID pandemic rather than lectures.

North Korea is facing acute poverty and hardships because of a series of international sanctions over its nuclear weapons and ballistic missile programmes. But, the great dictator ruling the country is least bothered and continues to deny basic human needs to his people. The votaries of democracy need to seriously ponder over how to help the hapless people rather than organising summits to belt out inane lectures on the values of democracy. On the other hand, it is difficult for the international community of nations to act against a country like North Korea, which is highly weaponised and nuclear armed.

he squabbling that has erupted within the US Democratic Party following its loss in the recent Virginia gubernatorial election has convinced many observers that the Republicans will handily retake the House of Representatives next year. In fact, it is the right whose future is most uncertain – a problem for which we are all paying the price.

The right has suffered identity crises before. The rise of mass democracy in the nineteenth century, when industrialisation created huge inequities and immiserated the working classes, could have wiped out traditional center-right parties, such as the British Conservatives. By concentrating tens of thousands of workers in cities and workplaces, new opportunities for solidarity and political organisation opened up. The appearance of new ideas ranging from anarchism and utopian socialism to Marx and Engels's version of communism - reflected mass discontent and provided templates for an alternative organisation of society.

But the center right reinvented itself, perhaps most spectacularly under the leadership of Benjamin Disraeli in Britain. In the 1860s, Disraeli spearheaded reforms to expand the electorate (going even further than his rival, Liberal Prime Minister William Gladstone), because he believed that a conservative nationalist ideology would appeal to many workers. He was right. The Tories soon reemerged as the leading party, often surpassing the Liberals for the rest of the century.

The new right succeeded by fusing several distinct philosophies and instincts. Its first pillar was nationalism, which came in various guises. Its more benign form was expressed in Disraeli's "One Nation" vision: a communitarian identity that would hold all citizens to be part of a single social contract. But Disraeli also channeled more aggressive nationalist sentiments, reflected in his commitment to a iingoistic vision of the British Empire. And in France and Germany, anti-Semitism was often central to the new conservatism.

A second pillar was the impulse to defend traditional institutions and the social order against radical change. These ideas, originating in Edmund Burke's powerful attack on the French Revolution,

were the key to an adaptable conservatism capable of offering meaningful responses when social and political change became inevitable. The darker side of this

the right's electoral success: support for wealthy businesses, which often funded center-right parties. When the interests of big business conflicted with pro-market philosophy (such as opposition to monopoly), the right tended to side with big business.

A combination of economic and social developments has since destroyed this earlier center-right compact. With the rise of more radical right-wing ideas came new challenges and objections to the welfare state and the role of government in the economy. A new antiregulation philosophy, popularised by Milton Friedman and other free-market thinkers, gained traction in the 1980s under British Prime Minister Margaret Thatcher and US President Ronald Reagan. And in the 1990s, it was lent further momentum by the collapse of the Soviet Union, an event that nullified a key social-democratic argument for the welfare state namely, that it was necessary to prevent working-class demands for outright socialism.

Thatcher and Reagan's deregulatory agendas contributed to the rise in inequality over these past four decades of accelerating globalisation and automation, undercutting the feasibility of Burkean traditionalism and communitarian nationalism. At the same time,

the rise of mega-monopolies and multi-billionaires who back rightwing media outlets has made a mockery of the right's commitment to competitive markets.

Once again, the right will need to reinvent itself. Former German Chancellor Angela Merkel's policies, which started resembling core social-democratic measures over the last decade, and British Prime Minister Boris Johnson's desultory efforts to revive Disraeli's one-nation conservatism, are an indication of how center-right parties might proceed. But these attempts appear unlikely to succeed, because they are not commensurate with the severity of the challenges the right – and the world – is facing.

To grapple effectively with the sources of inequality and the challenges posed by globalisation and Big Tech, center-right parties will need to undergo a massive transformation. American conservatives may find this process especially difficult, given their historical loyalties to big business and ultrawealthy individuals. Indeed, they have long since abandoned Burke's ideas in the interest of clinging to power by any means. From Richard Nixon's cynical Southern strategy to Republican voter-suppression laws today, the American right has long relied on the US political system's malapportioned allocation of power to right-leaning rural areas.

This strategy cannot work forever, given demographic shifts toward more urban and educated voters and the mounting discontent with economic stagnation. The American right either will recognise that it must change, or it will become even more aggressive and reliant on a minority of voters – ultimately pitting it against democracy itself.

The Republican Party's worship of former President Donald Trump suggests that it is opting for the second option. That means the US is heading into a period of even deeper polarisation and dysfunctional governance. Meaningful policies to address inequality, climate change, and the stifling dominance of large tech companies are unlikely. Worse, the rise of repressive authoritarianism following a Trumpian restoration in 2024 cannot be ruled out.

Quack

t's an abbreviation of an old Dutch word that in the modern language is spelled kwakzalver. It comes from quack, an early modern Dutch word meaning a person who chatters or prattles (probably connected to the English word for the noise a duck makes), and salf, essentially the same word as our salve. So a quacksalver was somebody who boasted about the virtues of his remedies, so it later became attached to a person who claimed to have miraculous medications. The longer form was common in the sixteenth century, but it was abbreviated later. The similarity of the fulllength word to quicksilver, or mercury, and the once common use of that element in medicine (especially to treat diseases such as syphilis), falsely suggests a link with the name. But there's no connection.

■ Qubit

his is a key concept in the very new field of quantum computing. The aim is to produce a device which is the quantum equivalent of the digital computer. The qubit (pronounced exactly the same was as the Old Testament measurement, the cubit) is a "quantum bit", the analogue at quantum dimensions of the ordinary computer's 1 or 0, on or off, heads or tails binary digit or bit. Unlike such digital representations, a qubit remains in an indeterminate state until it is observed. like a tossed coin that is still spinning. It was shown recently that in theory a quantum computer could solve certain mathematical problems, such as factoring large numbers, much faster than conventional ones, and so could be used, for example, in codebreaking. It might even be possible to employ the "action at a distance" properties of quantum mechanics to transport information instantaneously over great distances without loss. This may all sound like science fiction, but the first two-bit quantum logic gates were actually demonstrated at the end of 1995. If this field takes off, we shall probably see a whole series of new portmanteau words beginning in "qu". Anyone for "quanputer"?

According to a Radio Free Asia (RFA) report, North Korea has periods of mourning every year for the death anniversaries of both national founder Kim II Sung (one week) and his son Kim Jong II (10 days). The mourning period has been extended by one day this year for the 10th anniversary of Kim Jong II's death.

"During the mourning period, we must not drink alcohol, laugh or engage in leisure activities," a resident of the northeastern border city of Sinuiju told RFA's Korean Service.

I'm not sure what happens to people who laugh during a mourning period, but those who've been caught in other non-solemn activities such as drinking alcohol have been treated as "ideological criminals," the Sinuiju resident said. "They were taken away and never seen again."

The message is clear: North

r- Korea doesn't mess around. A mourning period is for mourning, and if you have an urge to laugh, do yourself a favour and cut onions for a while. Just find some way to cry or feel sad. Look at your bank balance if it helps. Ask your mother-in-law to visit. Compare yourself
0 to someone on Facebook.

Whatever you do, don't watch a Vir Das comedy special. Even if you're in the privacy of your own home, you might burst out in laughter. Next thing you know, there'll be a knock on the door.

Police officer: "Was someone laughing? We heard laughter." You: "Oh no, no laughter. It was

crying. I was crying like a baby. I can't believe it has been only 10 years since our great leader left us. It feels like yesterday." Police officer: "We definitely

heard laughter. If you don't tell us who was laughing, we will take the whole family away. Maybe the whole neighborhood."

You: "Sorry, sir, it was this guy on Netflix named Vir Das. That

scoundrel made us laugh. If you are going to arrest anyone, please arrest him!"

Police officer: "Where does he live? We will get him!"

You: "I think he lives in India, but he travels around doing comedy shows. Maybe you can invite him to North Korea and arrest him."

Fortunately (or unfortunately) for people in North Korea, the government controls the media, which means that they can't watch comedians like Vir Das, especially during mourning periods, when the police are on the lookout for people who don't appear to be appropriately bereaved.

"From the first day of December, they will have a special duty to crack down on those who harm the mood of collective mourning," a resident of the southwestern province of South Hwanghae told RFA.

So next time you enjoy a bout of laughter, be grateful you live in a country where laughter is permissible year-round.

Aadhaar-voter ID linking

Sir, The Election Laws (Amendment) Bill, 2021 that seeks to link Aadhaar with the Elector's Photo Identity Card (EPIC), has been passed in Lok Sabha amid Opposition protests. The Opposition demanded the rollback of the Bill. Many social activists and organisations have raised alarm over this move. In fact, the Election Commission had started linking the two in 2015. The process for around 30 crore IDs had been completed when it was stayed by the Supreme Court. Considering that when the EC linked the two about 55 lakh voters were deleted from the voter database of Andhra Pradesh and Telangana, the move to link the two is a matter of concern. Several complicating factors are involved in the linking of the two. Concerns about the proposal include privacy and voter manipulation. A substantial amount of data linked to Aadhaar would be linked to voter database. Exclusion is a stark reality when data is linked to Aadhaar. Deletion of voters is done in an unsystematic way. There is no proper verification of voters whose names are to be deleted. Considering that India does not have a data protection law, the linking of Aadhaar and voter ID may create privacy concerns. To take a particular instance: Aadhaar data of over 7 crore people of Andhra Pradesh and Telangana was leaked in 2019. Initially, Aadhaar was a voluntary facility. Despite the SC order that Aadhaar should not be made mandatory, the government made Aadhaar mandatory for several services. Passage of Aadhaar Act made Aadhaar compulsory for many facilities and services. Despite the 2019 Amendment to the Aadhaar Act, Aadhaar is being used for verification. New Delhi, Dec 21: Asserting that the Omicron variant is at least thrice more transmissible than Delta, the Centre Tuesday asked states and union territories to "activate" war rooms, keep analyzing even small trends and surges and keep taking strict and prompt containment action at district and local levels.

In a letter to the states and union territories, Union Health Secretary Rajesh Bhushan advised implementing strategic interventions for containment like imposition of night curfew, strict regulation of large gatherings, curtailing numbers in marriages and funerals besides increasing testing and surveillance. The letter highlights measures

that need to be taken in view of initial signs of surge in cases of COVID-19 as well as increased detection of the variant of concern Omicron in different parts of the country.

Bill to raise marriage age introduced in LS

New Delhi, Dec 21: A bill that seeks to fix 21 years as the uniform age of marriage for women and men was introduced in Lok Sabha Tuesday with Union Minister Smriti Irani terming it a "decisive step" in the country's history. while some experts stressed that legislative changes alone will not solve the problem of early marriages unless its root causes are addressed.

The introduction of the Prohibition of Child Marriage (Amendment) Bill, 2021 was opposed by some members who contended that it infringed upon several personal laws and was in violation of fundamental rights. The bill was referred to a parliamentary panel for greater scrutiny.

Experts are divided on the issue of raising the age of marriage for women with some saying it will go a long way in empowering women and some others laying emphasis on addressing the root causes behind early marriages such as lack of education

and poverty.

Ch'garh cops mount ponzi raids at Jaleswar

Jaleswar, Dec 21: A team of police officials from Chhattisgarh reached Jaleswar in Balasore district Tuesday to nab some people accused of committing financial fraud through chit fund company Green Ray International

Notably, Green Ray International has allegedly fleeced nearly ₹2,000 crore from thousands of people in the country while the firm is involved in a ₹500-crore fraud in Odisha. Following a directive from the state government, the head office of the ponzi company was sealed in May, 2013. The company had three heads - Sahiuddin, Ayub Saha and Khalik Saha

Sahiuddin had earlier been arrested from Kolkata airport while Ayub Saha was arrested from Chhattisgarh. Managing director

of the company Khalik Saha is still absconding.

Tuesday, four police officials from the neighboring state raided the houses of Khalik Saha, Toimuddin and Ajit Saha in Jaleswar area. However, none of them was traced out.

It may be noted here that a six member team of CBI led by DSP Ashok Kumar had arrested two of the accomplices of the chit fund fraudsters in July, 2020.

After the raids Tuesday, others involved in the financial wrongdoings are panicked.

Two awarded 8-yr imprisonment

BERHAMPUR: A special chit fund court sentenced two persons each to eight years of imprisonment after convicting them of defrauding depositors of their hard earned money by alluring them to deposit their funds in attractive schemes, Tuesday. The convicts were identified as Chandrakant Bhargav Goel managing director of ponzi firm Sriram Electro-Control Ltd and his manager Suresh Kumar Padhi. Judge Debashis Panda of the special chit fund court also slapped a fine of ₹73,000 on each, Bijay Kumar Pradhan, special public prosecutor said. In default, the two would undergo an additional 21 months of imprisonment each, the judge observed

MSME park hits roadblock in Ganjam

Chhatrapur, Dec 21: An ambitious project -- MSME park proposed at Barpalli under Kukudakhandi tehsil in Ganjam district -- has hit a roadblock due to opposition by local people against land acquisition for the park, a report said.

The state government has planned to establish an MSME park at Barpalli by March 2022 in an effort to promote small and medium industries and create scope of jobs for local people.

The park needs vast space to house micro, small and medium industries. But no land has been available in the Berhampur Industrial estate to accommodate these industries.

Meanwhile, the Kukudakhandi tehsildar has handed over 30 acres of land to the state-owned IDCO for the park. However, locals have strongly opposed the park and warned the administration against carrying out its construction work. As a result, the groundwork for



the park has failed to make any headway Local people alleged that the

land identified for the park was a pasture land in past. The tehsil officials converted the land and handed it over to IDCO for the park, they said.

Reports said, the officials of the Kukudakhandi tehsil have identified 30 acres of land at Barpalli and leased it out to IDCO October 24, 2019, to set up the park. As part of groundwork, the stateowned agency had undertaken con-

under its Swadesh Darshan scheme. The state Tourism department submitted a proposal along with a project report to the Union government September 24, 2019. Later, a reminder was sent to the Centre July 17, 2020. However, the Centre is yet to reply in this regard.

The state Tourism department had also submitted a proposal to the Centre, October 24, 2015 for development of a rural tourist circuit and another proposal for a spiritual circuit under the Swadesh Darshan scheme in Odisha, January 1, 2016.

The department has also submitted a list of the tourist sites to the Centre for development under the Sagarmala Highway project, October 22, 2020. However, none of

these projects has been approved so far. The state with a 500-km-long coastline, scenic hills, lakes, natural biodiversity, rivers, wildlife reserves, beaches, temples, monuments, arts and festivals, varied tribal cultures and the delectable cuisines is one of the favoured destinations of tourists.

The state has over 500 small and big tourist sites. The state government is developing sites like Srikhetra Puri, Tara Tarini shrine in Ganjam, Samaleswari temple in Sambalpur, Sun temple at Konark, Lingaraj temple in Bhubaneswar on its own. However, the development of manytourist sites is moving at a snail's pace due to neglect and apathetic attitude of the government officials.

BAN DHAN BIKASH YOJANA SHGs to buy MFPs from tribals

POST NEWS NETWORK

Baripada, Dec 21: Livelihood of scores of traditional forest dwellers and tribals mainly depends on collection and sales of minor for-est produces (MFPs), but most of them allegedly face distress sale of their produce and are deprived of fair price. The distress sale of MFPs is expected to be over as SHGs will buy them from tribals at fair prices. According to reports, Tribal Cooperative Marketing Development Federation of India (TRIFED) has launched Ban Dhan Bikash Yojana in Mayurbhanj district to ensure that tribals get the minimum support prices of their MFPs. Union Minister of Jal Shakti Biswheswar Tudu said that tribals and forest dwellers will immensely benefit from the scheme. Mayurbhanj is the first district in the state where this



scheme has been launched.

Thousands of traditional forest dwellers and tribals in Mayurbhanj eke out their living by selling minor forest produces like mahua flowers, resin, harida, ba-

hada, tamarind and anla in local markets. But the prices they get from sales of the MFPs are too meagre in comparison to their hard labour they invest in collection, and the prices offered by other states

Many a time, the unsold MFPs rot in their houses. Thus, their hard labour goes waste, it is said.

A dozen of 12 self help groups have been involved in the scheme. Four SHGs working under Baripada ITDA, two from Udala and three each from Karanjia and Rairangpur blocks will procure the MFPs from tribals living their respective areas.

Each SHG will be provided with ₹15 lakh loan for the work. The MFPs will be packaged and sold in the market with approval of Food Safety and Standard Authority of India (FSAI). TRIFED will alsoopen a sales outlet named as Tribes India in the district.

Putin blames West for tensions

Moscow: The Russian President Tuesday reiterated his demand for guarantees from the US and its allies that NATO will not expand eastwards, blaming the West for "tensions that are building up in Europe. Russian President Vladimir Putin's speech at a meeting with Russia's top military brass came just days after Moscow submitted draft security documents demanding that NATO deny membership to Ukraine and other former Soviet countries and roll back the alliance's military deployments in Central and Eastern Europe.

Queen cancels Christmas plans

London: Britain's Queen Elizabeth II has been forced to call off traditional Christmas plans at her Sandringham estate in Norfolk, eastern England, and will stay on at Windsor Castle amidst a surge in coronavirus cases being driven by the Omicron variant of Covid-19.

London, Dec 21: Countries across Europe considered new curbs on movement Tuesday as US President Joe Biden called on military medics to support hospitals and fight the Omicron variant that has swept the world days before the second Christmas of the pandemic.

Omicron infections are multiplying across Europe, the United States and Asia, including in Japan, where a single cluster of Covid-19 cases at a military base has grown to at least 180

Biden struck a dire tone about the risks to the one in four American adults who remain unvaccinated. He will lay out new initiatives on testing Tuesday, a senior administration official said. The measures include activating some 1,000 military medical personnel to support hospitals that are already being overwhelmed. Germany, Scotland, Ireland, the



Netherlands and South Korea are among countries to have reimposed partial or full lockdowns or other social distancing measures in recent days. Nicola Sturgeon, first minister of Scotland - part of the United Kingdom but with devolved responsibilities for health - set out plans for further restrictions on big public events, including sports fixtures, for three weeks after Christmas.

"It will also mean unfortunately that large scale Hogmanay celebrations, including that planned here in our capital city (Edinburgh), will not proceed," she said, refering to traditional Scottish New Year parties. New Zealand Covid-19 **Response Minister Chris Hipkins** said his country, which imposed some of the world's toughest Covid-19 measures, was delaying the start of a staggered reopening of its bor-

officials in Brussels to express hope that this will help persuade those hesitant about vaccination to come forward.

The jab uses a traditional technology involving proteins found on coronavirus spike proteins that trigger an immune response.

It is a tried and tested approach, used for decades to vaccinate people against diseases including hepatitis B and whooping cough.

A so-called emergency use listing (EUL) by the WHO paves the way for countries worldwide to quickly approve and import a vaccine for distribution.

It also opens the door for them to enter the Covax global vaccinesharing scheme, set up to provide equitable access to doses doses

Tokyo: Japan hanged three death-row inmates on Tuesday, its first executions in two years, amid growing criticism by human rights groups of the country's use of the death penalty. One of the three, Yasutaka Fujishiro, was convicted of killing seven people and setting fire to their house in 2004, while the other two, Tomoaki Takanezawa and Mitsunori Onogawa, were convicted in the 2003 killings of two pinball parlor employees. Executions are carried out in high secrecy in Japan, where prisoners are not informed of their fate until the morning they are hanged.

Dubai ruler must pay ex-wife \$700M in divorce settlement

London, Dec 21: A British court Tuesday ordered the ruler of Dubai to his ex-wife and their children close to 550 million pounds (\$730 million), in one of the most expensive divorce settlements in British history.

The total amount the children receive could be more or less than 290 million pounds, depending on factors including how long they live and whether they reconcile with their father. The settlement includes 11 million pounds a year to cover security costs for Princess Hava and the children while they are minors. Judge Philip Moor said the family needed "water-tight security," and that "absolutely uniquely," the main threat to them came from Sheikh Mohammed, rather than outside sources

Haya, 47, fled to the UK in 2019 and sought custody of her two children



through the British courts. The princess. who is the daughter of the late King Hussein of Jordan, said she was "terrified" of her husband, who is alleged to have ordered the forced return to the Gulf emirate of two of his daughters.

Sheikh Mohammed, 72, is also the vice president and prime minister of the United Arab Emirates and a major horse breeder. The founder of the successful Godolphin horse-racing stable, he is on friendly terms with Queen Elizabeth II. Haya, a graduate of Oxford University, is also a keen equestrian and competed in show

jumping for Jordan at the 2000 Sydney Olympics. A separate British family court judge ruled in October that Sheikh Mohammed had authorised the hacking of Princess Haya's phone during their legal battle. Judge Andrew McFarlane said the sheikh gave his "express or implied authority" to hack the phones of the princess and her attorneys using Pegasus spyware produced by NSO Group of Israel, the court said. McFarlane earlier ruled that Sheikh Mohammed had conducted a campaign of fear and intimidation against his estranged wife and "ordered and orchestrated" the abduction and forced return to Dubai of two of his adult daughters: Sheikha Shamsa in August 2000 and her sister Sheikha Latifa, in 2002 and again in 2018. The divorce bill eclipses the 450 million pound settlement awarded Tatiana Akhmedova in her 2016 split from Russian billionaire Farkhad Akhmedov, at the time cited as Britain's most expensive divorce.

US population growth at lowest rate in pandemic's first year

Washington: US population growth dipped to its lowest rate since the nation's founding during the first year of the pandemic as the coronavirus curtailed immigration, delayed pregnancies and killed hundreds of thousands of US residents, according to figures released Tuesday. The United States grew by only 0.1 per cent, with an additional 392,665 added to the US population from July 2020 to July 2021, according to population estimates released by the US Census Bureau. The US has been experiencing slow population growth for years but the pandemic exacerbated that trend. This past year was the first time since 1937 that the nation's population grew by less than 1 million people. "I was expecting low growth but nothing this low," said William Frey, a senior fellow at the Brookings Institution's metropolitan policy program, Brookings Metro.

History came full circle in Afghanistan in 2021. The 'forever war' of the US ended as it had begun, with Taliban ruling the land. When the world raced against time to contain a pandemic, Afghans delved into a pandemonium of their own. The age old aphorism 'graveyard of empires' resurfaced on people's minds as the chaotic US skedaddle coincided with a lightning fast offensive of Taliban that took the world aback. World witnessed the unprecedented unfolding of an exceptional humanitarian crisis. A humanitarian catastrophe Taliban rule marked WOMEN UNDER TALIBAN 2.0 - A REVERSAL OF TIME

Taliban's previous regime from 1996 to 2001 brought L havoc in the lives of Afghan girls and women. It was marked by frequent incidents of whipping, lashing, stoning, acid attacks, public executions and sexual violence against Afghan women amid absence of basic rights. Since they took over power, the Taliban have sought to portray themselves as more moderate and tolerant than what their past reign and global reputation suggest. But the world remains sceptic.

In their first press conference held August 17, the Taliban categorically declared, "We will honour women's rights but within the norms of Islamic law.' On September 17, they replaced the Ministry of Women's Affairs with the Ministry for Promotion of Virtue and Prevention of Vice, which was discontinued after 2001. Historically, the ministry is known for its patrol vans that enforced a harsh interpretation of the Sharia law while roaming the streets of Afghanistan. It banned music, carried out public executions, whipped and publicly humiliated women, and insisted upon a strict dress code

The administration also released a set of restrictions on Afghan media, banned television dramas that included female actors and ordered women news presenters to wear Islamic hijab. Many Afghan women and girls now have to be accompanied by a male relative whenever they leave their residence.

Earlier this month, the Taliban issued a decree barring forced marriage in Afghanistan, say ing women should not be considered as "property", but it did not make clear a minimum age for marriage, nor refer to any wider women and girls' rights to education, to work, to freedom of movement, or to

participate in public life.

The militant group told all female government employees to stay at home and banned most girls from attending school after they swept into power. Some 4.2 million young Afghans are already out of school, 60 per cent of them girls. There has also been a decline in girls' secondary school attendance even in provinces where the defacto authorities have permitted them to attend school. This is largely due to the absence of women teachers, since in some locations girls are only allowed to be taught by women.

More than a quarter of all civil servants in Afghanistan were women. The Taliban's move to restrict women from working could immediately cost the Afghan economy up to \$1 billion, or 5%

fame in 1984 as an Afghan refugee girl, after the war photographer Steve McCurry's photograph of her, with piercing green eyes, was published on the cover of National Geographic.

The UN mission in the country, UNAMA, has documented nearly 60 apparently arbitrary detentions, beatings, and threats to activists, journalists, and staff of the Afghanistan Independent Human Rights Commission, attributed to the de facto authorities.

Afghanistan's envoy from the former government accused the Taliban of committing wide range of abuses including targeted killings ind enforced disappearances.

In a report published by International Federation of Journalists, Afghanistan topped the list with nine journalists killed in the country this year.

"With the military takeover of Kabul by the Taliban, not only we see a total reversal of two decades of advances, but the group is also committing a litany of abuses with impunity which in many cases is going unreported and undocumented," Nasir Ahmad Andisha, Kabul's ambassador to the UN in Geneva who is still recognised by the world body, told the forum. "Credible reports have testified accounts of ethnic and tribal purging in several provinces of the country." she added.

CASH WOES & A CRASHED ECONOMY

fghanistan's economy has crashed since the Taliban's takeover, plunging the country into one of the world's worst humanitarian crises. Millions of dollars of aid that once propped up the previous government has vanished, billions in state assets are frozen and economic sanctions have isolated the new government from the global banking system. Now, Afghanistan aces a dire cash shortage that has crippled banks and businesses sent food and fuel prices soaring, and triggered a devastating unger crisis. The country is currently battered by the deepening economic, humanitarian, and security crisis following the keover. Debt and starvation are forcing families to marry off their young daughters in exchange for dowry and in some cases selling off their babies. By the middle of next year, as much as 97 per cent of the Afghan population could sink below the poverty line, as per an analysis by the UNDP.

DESPERATE TO LEAVE, TO LIVE

n one of the defining images of the fall of Kabul, Afghans desperate to escape the Taliban takeover clung to the side of a departing US Air Force jet as it rolled down the tarmac. Scores of people ran alongside the giant plane at the Kabul airport, and some managed to get a foothold before it took off. US authorities said that all told, at least seven people died during the chaotic evacuation at the airport, including several who fell from a military jet. Video showed people watching as one or more objects plummeted to the ground.



n one of the heartbreaking incidents captured on camera, babies were

seen being handed over to soldiers over the barbed wires of the airport wall. The video incited grief and rage on social media. Reports revealed that women were literally throwing their babies over the wall, begging officials to take them away. The desperation and helplessness of the parents made even the soldiers cry, it was reported

Dulitzer Prize-winning Indian photojournalist Danish Siddiqui was killed while covering clashes between Afghan troops and the Taliban in Spin Boldak district of Kandahar city. He was not simply killed in a crossfire in Afghanistan, nor was he simply a collat

eral damage, but was "brutally murdered" by the Taliban after verifying his identity, according to a report published in a US-based magazine. Whole world and the journalist community mourned his demise.

Captive power producers urge govt to normalise coal supplies

New Delhi, Dec 21: A captive power producers' association has urged the government for 100 per cent normalisation of coal supply to captive power producers while blaming independent power generators for the coal crisis and 'complete crash of whole system.'

The Indian Captive Power Producers' Association (ICPPA) alleged that independent power producers did not build up the required inventories which led to the supply crisis.

"Today where we have reached is 35-40 per cent of what we should be getting ... Right from today let there be 100 per cent normalisation of supplies to captive power plants (CPPs)," Rajiv Agarwal, Secretary General, ICPPA said in a press conference

IPPs do not build up the inventories for various reasons, as a result the safety stock and the insurance stock as it is called is depleted and subsequently there is a complete crash of the whole system, he said.

"All the coal rakes made for CPPs have virtually stopped," he said. IPPs, he said, are not building inventories because they know that if there is a crisis the whole government will help them.



"This is the right time the government should start normalising the supplies because we are getting some feeler is that first they want to build up very high some 30 days inventory by March and after that they will start supplying to CPPs and industries....For next year also the CPP would continue to face problem and will be in crisis," he explained. COVID-19 from last year created

havoc for industries, infrastructure and the economy, and in such a situation the current coal crisis has been much more worrying factor for captive power, he said. Out of a total 78,000 mw in-

stalled CPP capacity in the country, around 40,000 MW (i.e. 55 per cent) CPPs are thermal-coal based which require 200 million tonnes (MT) coal per annum.

Significant investments to the tune of 30 billion dollars have been made for setting up these CPPs and associated infrastructure. which have generated 15 lakh direct and in-direct employment.

The CPPs provide grid stability as they operate with minimum T&D losses, reduce demand pressure on the National Grid network and pump excess power into the grid, thereby contributing to the national energy pool.

Axis Bank top bidder for Citi consumer biz

New Delhi, Dec 21: Private sector Axis Bank has emerged as the highest bidder to buy Citi's consumer banking business, according to sources.

American banking major Citibank in April announced its plan to exit from the consumer banking business in India as part of a global strategy.

The business comprises credit cards, retail banking, home loans and wealth management. The bank has 35 branches in the country and employs about 4,000 people in the consumer banking business.

According to the sources, the valuation could be around USD 2 billion (about ₹13,000 crore).

The final valuation will be linked to the number of variables including the quantum of deposits, customers, the quantum of assets and liabilities moving from one franchise to another once all regulatory clearances come through, the sources added. Once approved, the sources added that the balance sheet size of Axis Bank will expand and the retail segment will witness a significant jump. Mails sent to Axis Bank and Citi on the proposed deal remained unanswered. Citi had entered India in 1902 and started the consumer banking business in 1985. Apart from the institutional bank ing business, it will continue to focus on offshoring or global business support rendered from centres in Mumbai, Pune, Bengaluru, Chennai and Gurugram.

Markets stage comeback on bargain-hunting

Mumbai, Dec 21: Market benchmarks clawed back some lost ground Tuesday after two days of heavy declines as investors made a cautious return to energy, IT and finance stocks amid supportive global cues.

A sharp recovery in the rupee further fuelled the rebound. traders said. The 30-share BSE Sensex opened strong and rallied to 56,900, before paring some gains to close at 56,319.01, up 497 points or 0.89 per cent. Similarly, the NSE Nifty advanced 156.65 points or 0.94 per cent to 16,770.85.

HCL Tech was the top performer in the Sensex pack, spurting 3.91 per cent, followed by Wipro, Tata Steel, Tech Mahindra, UltraTech Cement, Titan and Sun Pharma.

On the other hand, PowerGird. Axis Bank, Bajaj Finance, SBI, M&M, Kotak Bank and HDFC closed with losses of up to 1.50 per cent.

The market breadth was in favour of the bulls, with 23 advances compared to seven declines

"Indian market is attempting to recover from yesterday's heavy selloff, domestic indices staged a gap-up opening on bargain hunting supported by positive sentiments across global markets. Although concerns surrounding the impact of Omicron and FII selling still lingers, investors are treading cautiously and are optimistic. Gains in IT commodities and metal stocks lifted the indices higher," said Vinod Nair.

Arijit Malakar, Head Research (Retail), Ashika Stock Broking, said the market is expected to remain weak amid concerns over the new Omicron strain which could derail the global economic recovery and sooner-than-expected interest rate hikes in developed economies.

"The market is now sell on rise market as the sustained foreign fund outflows and renewed concerns around Omicron variant of coronavirus may trigger profit taking at higher levels," he noted.

Canadian fund buys out Odisha toll road

Mumbai, Dec 21: Kolkata-based road developer Bharat Road Network has sold its entire 40 per cent stake in the 67-km-long Shree Jagannath Expressway in Odisha to an arm of the marquee Canadian infrastructure-focused fund Caisse de dépôt et placement du Québec (CDPQ) for ₹2,100 crore, according to two sources.

The Srei Group, which was sent to the NCLT by the Reserve Bank recently, owns 30 per cent in the toll road project through one of its alternate investment funds called Trinity Investment Managers.

The deal is between Bharat Road Network and India Highway Concession Trust, one of the infrastructure investment trusts set up by CDPQ in the country one of the sources told PTI. Both the companies did not re-



spond to calls seeking confirmation of the sale. The 67-km toll road from Bhubaneswar to Chandikhole in Odisha started operations in December 2011 with an initial concession period of 26 years, is given an enterprise value of ₹2.100 crore. the second source added

Those selling shares in the OFS are Starfish I Pte, Wonderful Stars, Sequoia Capital, Kenneth Stuart Glass, Myriad Opportunities Master

Fund, Ontario Teacher's Pension Plan Board, Laurent Amouyal and Milestone Trusteeship Services.

Proceeds from fresh issue would be used towards funding organic growth initiatives, expanding logistics capabilities, and enhancing the company's tech infrastructure. Axis Capital, BofA Securities India, CLSA India and JM Financial are the book running lead managers to the issue. A stellar response to Zomato's

IPO, and a profitable listing in July has prompted a number of internet-led businesses to make a beeline for this route.

Since then a number of internetled businesses, including Nykaa, Paytm and PolicyBazaar got listed on the exchanges too. However, Paytm -- one of the most awaited IPOs -- witnessed lacklustre listing. Snapdeal is an e-commerce company, and focuses exclusively on the value segment, with more than 90 per cent of the products sold on the platform priced below ₹1,000 and more than 80 per cent of its users residing beyond the metro cities.

Once a leading player in the Indian e-commerce space, Snapdeal has seen its fortunes falling amid strong competition from rivals Amazon and Flipkart.

In 2017, Snapdeal walked away from a potential merger deal with

Flipkart and instead pursued what it called the "Snapdeal 2.0" strategy to become "financially selfsustainable".

The company, which is backed by Softbank, BlackRock Inc, Temasek Holdings Pte and eBay Inc, has been investing in video, vernacular and other strategic projects, aimed at growing the online market among new users, especially those coming in from tier II cities and beyond. The company's Power Brands, UniMove logistics platform, multi-lingual user support and its discovery-based shopping approach that replicates the offline journey of buyers are some of the capabilities built by it as part of its Bharat-focused strategy.

As part of its expansion plans, Snapdeal plans to expand intoomni-channel distribution through partner-driven offline stores.









Japan stun India Ashwin walks down memory lane

Heartbreak for title holders in Asian Champions Trophy hockey as they suffer 3-5 loss in the semifinal

Dhaka, Dec 21: Defending champions and Olympic bronze medallist India dished out a below-par performance to suffer a stunning 3-5 defeat against Japan in the second semifinal of the Asian Champions Trophy men's hockey tournament here Tuesday.

India were the overwhelming favourites before the start of the match after having thrashed the same opponents 6-0 in their last round robin match and also on head-to-head record, but the Japanese had other plans.

Japan were a completely different side Tuesday as they toyed with the defence of the Manpreet Singh-led side from the beginning.

The Indians were nowhere near their last match performance against Japan as their defence crumbled under relentless pressure from the lower-ranked opposition from the onset of the match.

It was a complete contrast of the performance India had displayed against Japan in their last outing as the Olympic medallist could never recover from the early goals they conceded.

Japan raced to a 2-0 lead inside the first two minutes and that seemed to have jolted the Indians and they played catch-up hockey thereafter. Japan scored through Shota Yamada

(1st minute, penalty), Raiki Fujishima (2nd minute), Yoshiki Kirishita (29th), Kosei Kawabe (35th) and Ryoma Ooka (41st). India's goals were scored by Hardik Singh (17th, 58th minute) and vice-captain Harmanpreet Singh (43rd).

India and Japan had met 18 times before with the hosts winning 16 games, while Japan emerged victorious on one occasion and one ended in a draw.

Japan will now take on South Korea in the summit clash, while India will be once again up against Pakistan in the bronze medal clash Wednesday. In the other semifinal of the day, South Korea beat Pakistan 6-5 in a thrilling contest.

Japan's dominance can be gauged from the fact that they earned as many as six penalty corners in the first six minutes, two of which resulted in goals. They secured their first penalty corner in the very first minute, which resulted in a penalty stroke and Yamada made

no mistake from the spot. The Asian Games gold medallists continued to put relentless pressure on the Indian defence and secured five more penalty corners in oneand-half minutes, one of which

resulting in another goal through Fujishima. Trailing by two goals, the Indians came out with more purpose in the second quarter and reduced

From a counter attack, Japan earned another penalty stroke for an obstruction by India custodian Krishan Bahadur Pathak and this time Kirishita stepped up and converted the chance to go into the breather with 3-1 lead.

New Delhi, Dec 21: India's premier off-spinner R Ashwin has revealed that he felt like he was being "thrown under the bus" after a remark by former head coach Ravi Shastri left him "crushed" during a torrid phase in his career when he contemplated retirement multiple times.

In an interview with 'ESPNcricinfo', Ashwin was asked how he felt when then coach Shastri anointed Kuldeep Yadav as India's No.1 spinner overseas after he had taken a five-for in the 2019 Sydney Test against Australia.

Ashwin said he was genuinely happy for Kuldeep as he knew how difficult it is to take five wickets as a spinner in Australia but Shastri's remarks left him "absolutely crushed"

"I hold Ravi bhai in high esteem. We all do. And I understand we all can say things and then retract them. In that moment, though, I felt crushed. Absolutely crushed," Ashwin said.

"We all talk about how important it is to enjoy your teammates' success. And I was happy for Kuldeep. I have not been able to get a five-for but he has a five-for in Australia. I know how big it is. Even when I have bowled well (at other times), I haven't ended up with a five-for. So I am genuinely happy for him. And it's an extremely happy occasion, to win in Australia.

"But if I have to come and partake in his happiness, and the success of the team, I must feel like I belong there. If I feel like I am being thrown under the bus, how am I supposed to get up and come for a party to enjoy the team's or team-mate's success?

Ashwin, however, still made it to



the celebration party that was organised following the Indian's team's historic series triumph Down Under.

"I went back to my room and then I spoke to my wife. And my children were there. So we were able to, you know, shrug it off, and I still made it to the party, because, end of the day, we had won a massive series.

The 35-year-old said that recurring injuries meant that he was playing under "excruciating pain" when he took three wickets in each innings to lead India to victory in the first Test.

Shastri's remark was quite too much for Ashwin after he played a role in the team's win in the series opener. "The first Test seemed like a distant memory by then. I had taken three of the first four wickets in the first innings after we were bowled out cheaply, and then

when it got really flat in the final innings, I plugged away for 50-plus overs and took three wickets despite what turned out to be a grade three abdomen tear

"In my mind, I had done something great for the team in excruciating pain, but all I heard was, 'Nathan Lyon took six, Ashwin took three"

In the latest report published by the World Anti-Doping Agency (WADA), 152 (17 per cent of the world total) Anti-doping Rule Violations (ADRVs) were reported in India in 2019, leaving it third in the list with the maximum dope offenders coming from body-

The harder I tried, the farther it felt. Especially with athletic pubalgia and the patellar tendonitis -I used to bowl six balls and then I used to be gasping for breath. And there would be pain all over the place.

"So you needed to make adjustments. When the knee pain got excruciating, the next ball I would probably jump less. When I jumped less. obviously the force needs to be produced through the core and the back and the shoulders, so the pubalgia (a chronic groin lesion) would act up.

"So the third ball I would be extra side-on to try to use the hips. By the time I was done with six balls, I would be like, 'I need a break here'," Ashwin recalled.

Nortje ruled out of **Test series vs India**

Johannesburg, Dec 21: South Africa pacer Anrich Nortje was Tuesday ruled out of the upcoming three Test series against India due to a "persistent" injury.

Cricket South Africa (CSA) did not specify the nature of injury and also did not name a replacement for Nortje who has taken 47 wickets in 12 Tests, including three fivewicket hauls. The first Test is slated to begin in Centurion from December 26.

'Proteas bowler, Anrich Nortje, has been ruled out of the threehas been ruled out or the match, Betway Test series against India, due to a persistent injury," CSA said in a statement.

"He has unfortunately not recovered adequately for the expected Test match bowling loads and is currently consulting with specialists to manage and advise on his recovery. No replacement will be brought in," it added.

Among Olympic sports worldwide, athletics leads the number of dope offenders with 227 (18 per cent), followed by weightlifting with 160. Bodybuilding leads overall with 272.

2 out of 2: Not much is going right for England

Adelaide, Dec 21: After lopsided losses in the first two Ashes Tests. England captain Joe Root savs he's frustrated by three components of his team's performance. Unfortunately for Root, they're the three main ones in the game batting, bowling and fielding.

The Adelaide loss followed a nine-wicket defeat in the opening match in Brisbane. There, England only scored 147 in its first innings and Australia notched 425, leaving the visitors 278 runs in arrears going into their second innings.

The next match begins Sunday, the traditional Boxing Day test at the Melbourne Cricket Ground, followed by matches in Sydney and Hobart in January. With Australia holding the Ashes, the visitors now need to win all three to regain the urn. That won't happen if their fielding doesn't improve.

In the first two Tests, England's total of dropped catches was in double figures and they've taken two



wickets from no-balls. Root said one positive was England's resistance on the final day, led by Jos Buttler, who got through 207 balls before backing into his stumps

PONTING QUESTIONS ROOT'S LEADERSHIP

Adelaide: Former Australia skipper Ricky Ponting has slammed Joe Root for criticising England bowlers after his side's second consecutive defeat in the ongoing Ashes series, saying as the leader it is his responsibility to ensure the strategy is followed. Root didn't hold back after England's 275-run defeat to Australia in the second Test. The 30-year-old blamed his bowlers for not bowling the right lengths, especially in the first innings. "I nearly fell off my seat when I heard that. Whose job is it then to make them change? Why are you captain then?" Ponting was quoted as saying by 'cricket.com.au'. "If you can't influence your bowlers on what length to bowl, what are you doing on the field?" Ponting, who led Australia to two World Cup titles, said the onus is on Root to influence his bowlers. "Joe Root can come back and say whatever he likes but if you're captain, you've got to be able to sense when your bowlers aren't bowling where you want them to. "And if they're not going to listen, you take them off, simple as that. Give someone else a chance that is going to do it for you. Or you have a really strong conversation with them on the field to tell them what you need. That's what captaincy is all about," Ponting said. Root had said England were making the same mistakes they did during their 0-4 series defeat in 2017-18. To which Ponting said as skipper one needs to be firm with the bowlers if they are not executing the captain's plan.

Ollie Pope (5 and 4 in Adelaide) is also under pressure to keep his spot at No.6, potentially creating room for Bairstow to come in.

Haseeb Hameed (6 and 0 in Adelaide) and Rory Burns are under threat at the top of the order,

although Burns fought hard on the fourth night in Adelaide to put up 34 after scoring just 4 in England's first innings. To heat up the bowling, England could bring back rested paceman Mark Wood for Melbourne.
