#### Fake notes in RBI chest, FIR lodged

Lucknow: Fake Indian currency, with a face value of ₹47,710, has been found in the Reserve Bank of India chest during an audit in Lucknow. RBI Assistant Manager Satyavir Singh has lodged a case with Mahanagar police about the recovery of 454 counterfeit currency notes during the checking of notes. "These fake notes comprised a ₹10 rupee note, 18 notes of ₹50, 443 notes of ₹100, one note each of ₹500 and ₹2,000," he stated in the FIR. Singh wrote to the officials to conduct a checking and also take legal action before returning the notes to the RBI. He said circulation/ printing of fake currencies was a serious crime. He added that police may send the fake currencies to the currency printing press or forensic lab during the investigation of the case.



#### **Imran's ex-wife escapes gunshot**

New Delhi: Reham Khan, the ex-wife of Pakistan Prime Minister Imran Khan, narrowly escaped a gun attack in Islamabad late Sunday night, Samaa TV reported. In a tweet, she revealed that on the way back home from her nephew's wedding, her car was shot at and two men on a motorcycle held the vehicle at gunpoint. "I had just changed vehicles. My personal secretary and driver were in the car," the former television presenter said and demanded that the "so-called government should be held accountable for it (the attack)". Reham, in multiple updates on her Twitter handle, complained that she and her staff had to wait for hours to get an FIR registered, the report said.

## Vaccination for 15-18 begins WHO pat on ■ Over 80,000 adolescents

take jabs including 4,107 in the capital city on first day

Bhubaneswar, Jan 3: Amid a rise in Covid-19 cases in the state, 80,129 adolescents in the age group of 15-18 took their first dose of vaccine against Covid-19 on the first day of the drive, Monday.

The teenagers took the jab at 939 dedicated vaccination centres set up across the state. The Bhubaneswar Municipal Corporation (BMC) vaccinated 4,107 adolescents out of a targeted 4,350 on the first day of the vaccination. Over 40 lakh children in the country received their first jab on the first day of vaccination drive. said Union Health Minister Mansukh Mandaviya. The 15-18 age group who have registered themselves on the CoWIN portal since January 1 can get their jab at their vaccination centre. Children who have not registered themselves online on the CoWIN portal for the

vaccination can receive the vaccine by doing on-spot registration at the centres, said health and familv welfare director, Bijay Panigrahi. Only Covaxin is given to the children of 15-18 years. Adequate arrangements have been made to deal with any adverse event following immunization (AEFI), he said.

"As there are possibilities that some children may have fever like minor AEFI, we have decided not

to vaccinate children who have examinations now. They will be vaccinated after completion of the tests," said Panigrahi. The health official further informed that all teachers have been requested to create awareness among students and parents to ensure 100 per cent vaccination of the eligible students in their schools.

#### **GOVT READY TO MEET ALL CHALLENGES: DAS**

Bhubaneswar: State Health Minister Naba Kishore Das Monday said the state government is ready to cope with the rising number of Covid cases and the spread of Omicron in the state. The health department has directed the Odisha State Medical Corporation to arrange the required number of vaccines and necessary medicines and equipment at hospitals with all kinds of auxiliary arrangements, Das said, adding there will be no shortage of oxygen in the state.

tres in many parts of the state including in capital city Bhubaneswar. Director of Capital Hospital Laxmidhar Sahoo said vaccination for 15-18 years age group is essential as they are more susceptible to the infection. A target has been set to complete the process in a month, Sahoo said. A total of 23.65 lakh children in Odisha are eligible for vaccination. Meanwhile, the Centre suspended marking of biometric attendance for all its employees till January 31.

## VIMSAR back

Sambalpur, Jan 3: The World Health Organisation (WHO) has given its approval to a research undertaken by a medical team of the VSS Institute of Medical Sciences and Research (VIMSAR) at Burla over susceptibility of blood groups O+ and B+ to Covid-19 even after two doses of vaccination.

The research report has found a place in WHO's database on Covid-19. The news has brought cheers to the members of the research team and the VIMSAR authorities. Dr Sanjeeb Mishra, principal author of the study, said he is happy about the development. The team also found a big drop in antibody level six months after the jab, thereby increasing the risk of re-infection, and suggested a booster dose.

"This is a moment of pride for us as it will encourage us to undertake further research. The study was jointly conducted by four researchers from the VIMSAR at

Burla and another researcher from the Regional Medical Research Centre at Bhubaneswar.

The five researchers who studied the antibody kinetics of Covishield vaccination six months after the second dose and the factors affecting the kinetics are Dr Sanjeeb Kumar Mishra, Dr Subrat Kumar Pradhan, Dr Rajiv Kumar Nanda and Dr Sumanta Sahu from VIMSAR and Dr Sanghamitra Pati from RMRC, Bhubaneswar.

The team found that the rate of infection is more in O+ and B+ blood groups compared to other groups. Moreover, they found a dip in antibody after the second dose and advised a booster dose. The study covered 122 participants comprising doctors, nurses and other staff. Their blood samples were taken after they were administered the second dose. The blood samples were collected in three rounds - one month after first dose, one month after second dose and six

Lakhimpur Kheri, Jan 3: The Special Investigation Team (SIT) probing the Lakhimpur Kheri violence, which claimed eight lives has filed a chargesheet against 14 accused, including Union minister Aiav Mishra's son Ashish Mishra. The chargesheet was filed in the court of chief judicial magistrate (CJM) Chinta Ram Monday.

In FIR number 219/2021 lodged with Tikunia Police Station, the SIT had identified and arrested 13 accused, including Ashish Mishra 'Monu', Ankit Das, Nandan Singh Bisht, Satyam Tripathi alias Satyam, Latif alias Kale, Shekhar Bharti, Sumit Jaiswal, Ashish Pandey, Lavkush Rana, Shishu Pal. Ullas Kumar alias Mohit Trivedi, Rinku Rana and Dharmendra Banjara.

On Monday, senior prosecution officer (SPO) SP Yadav told reporters that another accused Virendra Shukla's name has been added in the chargesheet under Section 201 (causing disappear-



ance of evidence of offence) of the Indian Penal Code. However, Shukla is yet to be arrested. Yaday said the chargesheet against all 14 accused was filed in the court and the proceedings are on.

Violence had erupted in Lakhimpur Kheri October 3 last year when farmers were protesting the visit of Uttar Pradesh Deputy Chief Minister Keshav Prasad Maurya to Mishra's native place.

Four agitating farmers were run over by a vehicle while four others, including a journalist, two BJP workers were killed in the violence that ensued. Ajay Mishra is currently the MP from Kheri Lok Sabha seat.

#### Junior teachers' pay up by 50pc

Bhubaneswar, Jan 3: The state government Monday enhanced the salary of junior teachers engaged in the primary schools of the state by nearly 50 per cent.

Chief Minister Naveen Patnaik has taken a decision to hike the salary of both 19,714 junior teachers and 13,324 contractual teachers by 50 per cent from January 1, 2022. In total, 33,038 teachers will benefit from this decision

As per the decision, junior teachers receiving a salary of ₹9,200 per month would now be paid ₹13,800 while the contractual teachers receiving salary of ₹7,400 would now get ₹11,000 per month, officials said.

The government would bear an additional ₹168 crore from the state exchequer every year due to the hike in the salary of the iunior teachers.

A day before the New Year day, the government had approved the proposal to provide grant-in-aid to teaching and non-teaching staff of all aided non-government schools, colleges and Madrasas in the state on the basis of the 7th Pay Commission recommendations



#### Forest land in urban areas to go to slum dwellers

Bhubaneswar, Jan 3: Ahead of ernment has decided to divert forest land to create infrastructure for dwellers residing in 253 slums spread across 45 urban local bodies (ULBs) in 22 districts.

This was known from a workshop organised on creation of basic infrastructure for slum habitats in urban forest areas at Lokseva Bhawan Monday. Addressing the workshop, Housing and Urban Development Secretary G Mathivhathanan said the government has launched the special campaign for transforming the urban habitats to Biju Adarsha Colonies.

Around 3,000 slum habitats containing 168,141 households were identified through a special survey named Urban Slum Household Areas (USHA) undertaken with geo-spatial technology in NACs and municipalities, he said. Out of this, 70,000 households were granted in-situ land rights and 1,03,328 households given land entitlement certificates. Meanwhile, 550 slums were upgraded and mainstreamed with urban life, the secretary said.

During the USHA survey, 253 slums spread across 45 ULBs in 22 districts were found to be in urban forest land. Because of the forest area, problems cropped up with regard to settlement of land rights and laying of infrastructure for basic amenities, pointed out Director of Municipal Administration Sangramjeet Navak. To overcome the situation. the forest, environment and climate change and H&UD departments have prepared a standard operating procedure. The SOP would resolve the problems relating to land rights and infrastructure in slum habitats of urban forest areas.

The SOP was successfully piloted in Dhenkanal municipality. The government will implement the SOP in all 253 slums in urban forest areas. The Chief Secretary directed the concerned departments to complete the task in a time-bound manner. Both the administrative departments would nominate seniorofficers as the nodal officers for smooth implementation of the SOP.

## Spider-Man turns third highest grosser

THE TOM HOLLAND-STARRER HAS GRABBED THE NO.3 SPOT AMONG HOLLYWOOD FILMS IN INDIA, AFTER AVENGERS: INFINITY WAR (2018) AND AVENGERS: ENDGAME (2019)

MUMBAI: In just 18 days since its theatrical release, Spider-Man: No Way Home, with Tom Holland and Zendaya playing the lead roles, has become the third highest grosser among Hollywood films in India, after Avengers: Endgame (2019) and

Avengers: Infinity War (2018). Till date, the film, which has globally surpassed the \$1-billionmark, has grossed Rs 259.67 crore in India. That makes it No. 3 among all films released in India in 2021, after Allu Ariun's Pushpa: The Rise and the Akshay Kumar-led Soorvavanshi.

Among Hollywood films in India, Spider-Man is within leaping distance from the pickings of Avengers: Infinity War (Rs 227.43 crore), but is still quite far from Avengers: Endgame (Rs 373.22 crore). Analysts expect the global earn-

ings of Spider-Man to see a sharp spike after its release in China, the world's largest cinema-going The film's unexpected success would have been a cause for cele-

bration, but for the shadow of the Omicron surge, which has made the Delhi government shut down cinema theatres and several state governments reverting to the 50 per cent occupancy rule.

Talking about the success of



Spider-Man, independent film trade analyst Sumit Kadel said: "It was bound to do well because it is a Marvel Studios film. Films coming out of the Marvel universe are hugely popular in India. The coming together of all the actors who had previously essayed the title role, namely, Tobey Maguire and Andrew Garfield, also did the trick,"

Media and internet research analvst Karan Taurani added: "The film offers a large-scale cinema experience. That is why people have gone out to watch the film in large numbers as this experience cannot be replicated on a smart screen or





### State logs 424 fresh nCoV cases

The government has set a target to vaccinate 25.53 lakh beneficiaries by January end

Bhubaneswar, Jan 3: Odisha's Covid-19 tally rose to 10,55,980 Monday as 424 more people, same as Sunday, tested positive for the infection, a Health department bulletin said.

The state's coronavirus death toll remained unchanged at 8,463 as no fresh fatality was registered, it said

Khurda district registered the highest number of 151 new cases, followed by 66 in Cuttack. The administration tested 54,793 samples for Covid-19 Sunday, it said, adding that the daily test positivity rate

(TPR) rose to 0.77 per cent. Fifty-three other patients have died due to comorbidities so far, the bulletin said. More than 2.93 crore people have received the first dose of the Covid-19 vaccine, while 2.1

Subsequently, the accused along with four of his aides including the foreigner reached Bhubaneswar. The accused introduced the foreigner as James Alia Brigton, a native of UK, who owns Trimurti Courier Services in South Delhi.

The person who was in talks with the victim told the latter that Brigton was engaged in construction work in India and that he has four hotel projects in progress in Puri.

## Mix-match of different Covid vax safe, more effective: Study

ix-match of different Covid vaccines is safe and produces higher antibody response, according to a study released by AIG Hospitals in Hyderabad, Monday.

The study, led by AIG Hospitals and researchers from the Asian Healthcare Foundation, sought to determine the safety profile of mixing Covishield and Covaxin, as well as explore the antibody response.

While the study "conclusively showed that mixing of vaccines is absolutely safe", the spike-protein neutralising antibodies in the mixed vaccine groups were found to be significantly higher than the same-vaccine groups

The team included 330 healthy volunteers who were not vaccinated and had no history of Covid

infection. Of these, 44 (approximately 13 per cent) participants were found to be seronegative, that is, they didn't have Covid-related antibodies, while the rest 87 per cent were found to have Covidrelated antibodies.

"One of the incidental findings of the study is the seropositivity among our population. About 87 per cent participants who didn't get vaccinated and never tested positive for Covid had the Covid-related antibodies. This means our population might have developed significant antibodies against the Covid because of the huge Delta wave that we endured," said D Nageshwar Reddy, Chairman, AIG

Hospitals, in a statement. The team divided the 44 participants into four groups: people

The team followed all the participants for 60 days and found none of the participants develop-

ing any adverse effect. The Omicron variant is considered to have more than 30 mutations in the spike protein, which enables it to evade vaccines as well as spread faster.

According to the study, mixing different vaccines can help tackle the new variant much more effectively than two-doses that have shown to be ineffective.

"This is particularly important when considering the third booster

dose. The concept of a booster is to elicit robust antibody response and help in killing the virus. Mixed doses can certainly boost these spike-protein neutralising antibodies and will enhance the vaccines' effectiveness even against the Omicron variant," he said.

The researchers have shared the data from the study with the Indian Council for Medical Research to be considered as a reference study while deciding on the "Prevention" doses starting January 10.

Prime Minister Narendra Modi, last week, had announced that healthcare/frontline workers, as well as elderly population (aged more than 60) with comorbidities, will be prioritised for a precautionary dose from January 10

## Fresh move for seat reservation in ULBs

District magistrates are empowered for delimitation of the wards and reservation of seats for SC, *ST* and women in the municipalities/NACs

Bhubaneswar, Jan 3: Following the amendment of the municipal laws removing reservation for OBC people, the state government has initiated a fresh move for delimitation of wards and reservation of seats in the Urban Local Bodies (ULBs) for the upcoming rural polls.

Director of Municipal Administration (DMA) Sangramjit Nayak has written to all Collectors and Commissioners of Bhubaneswar, Cuttack and Berhampur in this regard.

Nayak said that consequent to the judgement of the Supreme Court regarding reservation of seats for backward class of citizens (BCC). the state government has amended the relevant provisions of the Odisha Municipal Act, 1950 and Odisha Municipal Corporation Act, 2003 by way of ordinances.

The government has decided that the delimitation of wards and reservation of seats for the general election to the 107 municipalities and NACs (except those located in Scheduled Areas) and three corporation towns of the state will be made afresh, he said.

Officials have been asked to conduct the delimitation and reservation of seats as per the 2011 Census report and in accordance with the provisions of the two Acts.

Further, reservation of seats will be made in favour of SC, ST and women as per the provisions under Section 11 of the Odisha Municipality Act, 1950

As per the Act, the district magistrates are empowered for delimitation of the wards and reservation of seats for SC, ST and women in the municipalities/ NACs. The process followed so far related to the municipalities and NACs located in the Scheduled areas will remain valid, pointed out Nayak.



Appeal petitions from the persons aggrieved with the notification of the DMs regarding division of municipal area into wards or assignment of wards will be received in the office of the DM concerned before the stipulated date and time.

Collectors were asked to complete the delimitation process by January 3, while people having any issue with the process can submit his/her plea by January 12. The District Magistrates will publish the list of the reserved seats, January 13.

People who would be aggrieved even after this can submit their grievances to the Housing and Urban Development department between January 13 and 27. Hearing of the grievances will start from January 28, Nayak said in his letter. However, no final date has been set for completion of the entire procedure.

Sambalpur, Jan 3: History is replete with instances of freedoms fighters and their struggles against the Britisher rulers for the Independence of the country.

However, students of Sambalpur Zilla School boycotting classes to join the non-cooperation movement of Gandhiji January 3, 1921 was the first such incident in the history of our freedom movement. The non-cooperation movement by the students of this school completed 100 years, January 3, 2022. A memorial committee was formed to observe the day.

Possibly none of the students of the Zilla School who had participated in the non-cooperation movement are alive today. However, the path shown by them still inspires many to think and do something for the country.


Historian Deepak Panda has mentioned about the students' movement in his book 'Sambalpur Itihas'. Many people of undivided Sambalpur district were drawn towards Gandhiji's call for Independence of the country through non-violence and participated in the non-cooperation movement. The non-cooperation movement

Reports said that the students first assembled under the foothill of Budharaja January 2, 1921 and decided to boycott classes when the school reopened after their vacation, January 3, 1921. As the school reopened, the students staged a demonstration outside the main gate of the school. Over 200 students participated in this demonstration.

Later, the students boycotted their classes and took out a rally which passed through the main thoroughfares of Sambalpur town. Eminent freedom fighters Lakshmi

The non-cooperation movement soon drew widespread support from across the country. The students even opposed the visit of a British Prince to Sambalpur. The locals also observed Sambalpur bandh in support of the students and meetings were organised at various places

Later, a school named National School was opened at Frazer School where the rusticated students were allowed to study. Teachers including Shankar Prasad Padhi, Sayeed Abdula, and Baladev Bahidar taught the students there.

On being apprised about the students' movement, eminent freedom fighter Pandit Nilakantha Das, who was then working as a lecturer in a Kolkata college, resigned from service and returned to Sambalpur to teach the students. Another teacher Bhagirathi Mishra, after completing his studies in Kolkata, also returned to Sambalpur to teach the students. The school was later renamed as Chandra Sekhar Behera Zilla School to honour the great freedom fighter.

### Gujarat to India


hen Prime Minister Narendra Modi was on the ascendant in Gujarat, there was a lot of talk about the so-called 'Gujarat model that could be applied to the entire country. This of course was talking about the economic model. But not all Indians had learned about the full package that Modi had promised the people of Gujarat. Samruddhi, in the sense of economic prosperity, was only one half of the promised story. The other half was salamati, a Hindustani word that has become a part of the Gujarati language and a way of speaking to denote safety and security.

But now, we appear to dislike anything but a Sanskirtised version. So, there are many telling us how saal-mubarak is not Indian and we must instead use nootanvarsh-abhinandan or any other Sanskritised words to wish each other - be it for Diwali or even the turn of the calendar December 31.

After almost seven years of Modi at the national helm of affairs, Bharat has arrived and has taken hold. Every person, or almost every person it may seem, is now consciously religious and the first lesson that has been internalised is that you cannot afford to be tolerant. The call and consensus are to respond violently to any provocation and go to the extent of extinguishing life by taking the law in your hands.

The story of Guru Nanak has receded from folklore and also our collec-

tive memory. He travelled with his disciple and follower Mardaana to Mecca. He retired one summer evening in a sarai, or should it be called a dharmashala in keeping with the version of 'Indianness' that is in vogue. A moulvi saw Guru Nanak stretching his legs towards the Kaaba. He reprimanded the Guru. The Guru requested him to lift his legs and put them in the direction that may be the right one. But whichever direction the feet of the Guru turned, the Kaaba appeared to move in that direction. The priest then sought forgiveness from Guru Nanak, the message being that the house of the Lord is everywhere and in all directions.



Welcome to the Gujarat Model, Part II, as it plays out in the Akhand Bharat of today. Let us not blame Gandhi. He practiced non-violence and sarvadharama samabhava- equal respect for all religions. But we have ingrained violence into the Indian fabric. Further, the version of secularism practiced in the country gave space to intolerance and fanatic elements among certain sections, the disease eventually spreading to most sects and religions. We must come to terms with the picture of a distorted idea of non-violence and secularism that has been promoted and supported for decades.

Against this national background, Gujarat came in handy for the Hindu fundamentalists. One can trace how and why Gujarat became a Hindutva laboratory. After the formation of Gujarat State in May 1960, the Patel community that lived largely in rural areas and was engaged in agriculture benefited from the land reforms, especially in Saurashtra. The Patel community is very industrious. With the ownership of land, they could work hard to reap benefits. They did. Agriculture improved significantly and the Patels prospered. They became educated and also entered the world of business that was hitherto in the hands of Banias and Brahmins. The profits from nonfarm enterprises were invested in agriculture and agriculture surplus was again invested in expanding non-farm businesses. Patels now wanted social and religious recognition, and space in regional politics. This was difficult as Brahmins and Banias had full control.

Patels then turned to the Swaminarayan sect and carved out their socioreligious space. They were yet to get political space. Whatever chance they might have had, the KHAM (Kshatriya, Harijan, Adiyasi, and Muslim) al liance and joint strategy in the early 1980s took away. Congress and secular parties were not open to them either for sharing power. They turned quite easily to the RSS-BJP fold.

The Patels are not meek or mild-mannered. The RSS-BJP combine was looking for precisely this kind of force to kickstart its run. The Patels were offered space. That is how the Hindutva laboratory was set up in Gujarat. Patels and others who were left out in power-sharing arrangements till that time found welcoming space in the BJP. From 1960 to 1990, the Congress ruled Gujarat. Except for Chimanbhai Patel and Babubhai Patel, Patels did not get much space. It was in 1990 when the KHAM strategy threatened to remain strong and upset the entry of the Patels into power structures, Chimanbhai Patel and Keshubhai Patel forged unity and a non-Congress government was formed. Congress returned but only for a brief period, in 1994-95. Since then, the BJP has been ruling Gujarat. With political patronage, RSS and extreme Hindutva forces led by select anti-Gandhi upper caste groups became active and culminated in the Gujarat of 2002.


In 2002, Narendra Modi fought the assembly elections with the promise of providing salamati and samruddhi. In 2014, he fought the national general elections with the promise of samruddhi. It was supposed to be one of a development agenda at work. In the first five years, samruddhi with slogans such as sabka saath, sabka vikaas were made popular. However, the forces that were let loose in the country, especially the cow-belt (now extended to Gujarat, Maharashtra and Karnataka), played out in the open by perpetrating violent suppression of minorities. And the leader maintained his mystical silence.

Come the 2019 general elections, and the theme returned. Akhand Hindurashtra is now the dream and the leader brought in his infamous lieutenant to command the inner policing and law and order of the country and the team became formidable. Gujarat cooled down after 2002 because the followership was out of fear, and people in Gujarat generally don't indulge in violence as they focus more on running businesses. The communal violence that was unleashed under the alleged state support by the Gujarat Hindutva laboratory was bad, but its mutation in other states, especially the cow belt, took on even more virulent forms and continues to play havoc. The Ganga-Jamuni tehazeeb stands severely damaged and the imagined Akhand Bharatvarsh that is supposed to have existed 1,200 years back under the Hindu sanskruti is now blown to smithereens. If the people of Hindustan do not act now. Sardar Patel's Akhand Bharat will move toward Balkanisation. The merchant of dreams cannot continue to call the tunes forever. #### **FOCUS AADHAAR & VOTER ID**

## A PROBLEMATIC LINKING

ndia takes great pride in her Election Commission, an independent authority entrusted with the conduct of free and fair elections for the Parliament and State Assemblies. It has the rep utation of being independent and impartial, and it ensures people vote without fear, and that there is a level playing field among contestants. The EC was born one day before the Republic of India - January 25, 1950. The EC is bound to act within the legal framework enshrined in the Representation of People Act 1951 (RPA). Only Parliament has the power to amend the RPA which has been done from time to time. It has been amended a few times in the past 70 years. One notable amendment was the transfer of election petitions from tribunals to high courts, which was why Prime Minister Indira Gandhi's election petition was heard in the Allahabad High Court where her election in 1975 was declared null and void. But major amendments to RPA have been pending for too long.

There are, for instance, the various recommendations of Law Commissions over many years that have not been implemented. The EC itself has written to the Prime Minister and the government to ensure that some important electoral reform laws are passed by Parliament. But this has fallen on deaf ears. One of the most important suggestions has been to disqualify criminal candidates from standing for election. As of now the disqualification criteria in the RPA is too weak, and has failed to check the rising number of elected lawmakers who face serious criminal charges.

In the absence of any action from Parliament the Supreme Court has often stepped in to remedy certain anomalies. This is how the NOTA (none of the above) button came on the ballot. This is how we have instant unseating of convicted lawmakers, even if the criminal case goes for appeal in a higher court. This is how, thanks to a 2003 iudgement, the voters get to know criminal antecedents of their candidates through self-sworn affidavits. None of these reforms were brought in by Parliament but are

in force thanks to the Supreme Court in response to public interest litigations. The desire of the public to bring political parties under the ambit of Right to Information is still languishing in the courts. This reform is also a reform too far.

When Parliament has chosen to act, it has often done so with dubious intention. One example is that of introducing electoral bonds, to increase the transparency of political funding. That law makes it impossible to know the identity of the donor or the recipient negating transparency completely. The word 'transparency' is used for this legislation almost in an Orwellian sense! One more recent example of Parliamentary action on the RPA is the amendment passed last month. This is the linkage of Aadhaar with the voter identity card issued by the EC. It was passed in the Lok Sabha December 20 without any discussion. It was passed in the Rajya Sabha the next day with a voice vote, even when there was strong demand for recording the vote. The video of the voice vote clearly shows the resounding vocal opposition to the bill, but it was still passed. Be that as it may, the Aadhaar linkage is very problematic, for several reasons.

Firstly, this amendment directly contradicts, at least prima facie, the Supreme Court judgement of 2018 which clearly said that Aadhaar is not mandatory for all citizens. Only for those receiving welfare benefits, and for a limited purpose only, can Aadhaar be made a requirement. That was a landmark judgement delivered in what was the second longest case ever

heard by the Supreme Court. Secondly, Aadhaar is meant to be a proof of identity not of citizenship. It was never meant to be a proof of being a citizen and of the eligibility to vote. In fact, the construction of the voter roll is a critical responsibility of the EC and cannot be outsourced to another agency outside its ambit. The Aadhaar authority is not under the control of the EC. The power to add, delete and modify a voter record is with the electoral registration officer, and is circumscribed by the stringent requirement of physical verification. This can't be outsourced to an authority like the Unique Identity Authority i.e. Aadhaar. When the EC undertook a pilot project, a 'purification' exercise in 2015 to link the Aadhaar to voter id, it was struck down by the Supreme Court. But some damage had been done in that pilot project in Telangana and Andhra Pradesh. With the Electoral Photo Identity Card (EPIC) and Aadhaar linkage exercise undertaken by the EC as part of its 'National Electoral Roll Purification and Authentication Programme', lakhs of voters were affected. Nearly 30 lakh voters in Telangana and 21 lakh voters in AP had been struck off the rolls due to a 'de-duplication' exercise which created a big furore. None of these voters were given a chance for a hearing and neither was the deletion subjected to a rigorous verification exercise, as would have been done under normal EC procedures.

Thirdly, even if the current amendment says linking Aadhaar is voluntary, it is not clear what that means. Will the linking be done at enrolment or at voting time? How is the Aadhaar number going to be verified, if not by the biometric method? But that has been explicitly ruled out. Will the electoral officer just put a tick mark against the voter record or will the Aadhaar number be entered? In which case it would be in the public domain violating a very basic requirement of privacy of the Aadhaar number. The current wording of the legislation says that denial to furnish the Aadhaar number to the electoral officer can only be due to a 'sufficient cause'. This implies that blanket denial is not to be allowed.

The government itself via an affidavit before the Supreme Court has said that the Aadhaar biometric identification fails on average 12 per cent of the time. That is a huge error margin, especially when elections are keenly fought and winning margins can be as thin as single digits. In Jharkhand, it was found that 88 per cent of the ration cards deleted because of Aadhaar verification failure were genuine cases. So Aadhaar failure invariably is a burden that largely falls on the poor, the vulnerable, the indigent who often live in backward areas lacking in the infrastructure of electricity or connectivity.

Finally, the real fear is that Aadhaar linkage can become a powerful tool for voter profiling, wholesale disenfranchisement, gerrymandering and all kinds of electoral mischief, in the hands of those who have the database. The linking of the Aadhaar with the voter identity card is a path best not taken, or one that should be trodden on very, very carefully.

## Corporates can wait; focus on existing set-up

vate bank, RBL Bank. The LCEO has left the bank abruptly and RBI has decided to appoint an additional director on the board. Last month, the RBI superseded the board of Anil Ambanipromoted Reliance Capital Ltd in view of payment defaults and serious governance issues. A similar story played out in March 2020, when the banking regulator placed Yes Bank under moratorium.

Undoubtedly, these concerns would have weighed heavily on the RBI's decision as to not accept the recommendation of its Internal Working Group (IWG) relating to proposed ownership of banks by large corporate or industrial houses. RBI had set up this working group in June 2020 and the IWG submitted its report in November 2020.

While the recommendation relating to ownership is still under consideration, the larger question is whether India is ready to allow corporate houses enter mainstream banking and handle the associated risks. In the last three decades, private banks have grown substantially, and they now occupy nearly 40% of the banking space as against 10% in 1991, at the time of liberalisation. Private banks have made tomation, personalised banking and customised new products but at the same time they have been found wanting when it comes to financial inclusion, infrastructure lending and customer inclusiveness. Take for example the recent report

by credit bureau TransUnion CIBIL Limited which states that of the total loan applications received under the Emergency Credit Line Guarantee Scheme, public sector banks (PSBs) have led from the front. They reached out more to tiny and small borrowers. PSBs with their extensive network operationalised the scheme as soon as it was launched. The story was no different for opening of Jan-Dhan accounts in 2014, demonetisation management in 2016 or offering of essential banking services during the pandemic.

Will corporate houses with focus on profitably show the same tenacity and determination towards furthering such schemes or whether armed with new banking license they will also compete for the housing and car loan segment? If the latter is the case, why should they have access to low cost deposit of individuals and institutions?

The concerns over corporate governance issues are also not un-

private banks have been under the radar for various issues and some bigger ones have shown signs of inherent weakness. Banks basically are intermediaries between depositors and loanees, and there are admittedly two lines of defence-the internal bank board and the regulator. The recent failures of some private banks can be termed as governance failure and attributed to lack of independence of their boards.

The fintech companies have already taken the payment space from the banks. The big technology companies are also trying to enter the financial intermediation space. In this backdrop, it needs to be ascertained what kind of new banks we want in India and are corporate houses the right candidates to be picked up for this new journey.

During the last three years, not withstanding an accommodative monetary policy the credit offtake has not happened on expected lines. This is not on account of absence of corporate/industrial housesowned banks but due to a variety of factors which include skill shortage, absence of a system of incentivisation for performers, the accountability policy, and HR/leadership issues especially

A list not well with another prising significant contribution towards aufounded. In the recent past, many in the PSBs. For now, it will be more prudent to focus on the existing players and bring about the transformation that is required for sound, transparent and robust banking practices. For a nation under transition like ours profit maximisation and social objectives both should always be part of the strategies for all banks. It is a fact that although Indian banking is over 250 years old, things started happening in the banking space in the country post nationalisation and post liberalisation. While PSBs have been associated with nation-building for the last more than five decades the private banks started making their presence felt after 1991. There are issues with regard to asset quality and governance in PSBs. But most of the private banks; both the old ones and the new generation ones too are having the same issues at the moment. It is also a fact that we need strong PSBs and equally strong private banks to embark on a path of inclusive and rapid progress. The RBI will do well if it comes out with more a stringent framework if it considers letting corporates enter the fray.

#### Same old tactics

Sir, China's revelation that it has standardised official names for 15 places in Arunachal Pradesh has worsened the already strained relations between India and China. However, the Indian government rejected the renaming of places and declared that the state has always been and will always be an integral part of India. This move comes along with China's new border law. Eight of the 15 places in 'Zangnan' (Chinese name for Arunachal Pradesh) are for inhabited areas, four are for mountains, two for rivers and one for a mountain pass. New Delhi, Jan 3: The Congress Monday asked Prime Minister Narendra Modi to come clean on Meghalaya Governor Satya Pal Malik's allegation that he was "arrogant" on the farmers' issue and demanded an unconditionally apology if it was true.

Congress general secretary Randeep Surjewala said the Prime Minister should come forward and tell the truth to the nation, and sack the governor, if he is not telling the truth.

The entire nation is shocked with the text of conversation between BJP-appointed Governor Malik and the prime minister on the farmers' agitation. The Congress leader said the "anti-farmer" and "insensitive' face of Prime Minister

Modi, his government and the BJP

stands exposed.

"If Governor Malik is lying, he should be sacked and an FIR should be registered against him. But if he is not lying, Prime Minister Modi and Home Minister Amit Shah must come forward and apologise to India's toiling farmers and farm labourers. Otherwise, they will never pardon them," the Congress chief spokesperson told reporters. "We demand that prime minister and home minister apologise unconditionally to farmers and tell them by when will families of farmers who died (during the farm laws protest) will be compensated," he said. Targeting Modi, he said. "Mr. Prime Minister, is this the language of the person holding the highest public office and elected by farmers." Senior Congress leader

Mallikarjun Kharge asked Modi whether Malik's remarks were true. Kharge also shared a video clip on Twitter of Malik from a function at Haryana's Charkhi Dadri. where he is saying that the prime minister was "arrogant" when he went to meet him on the issue of farmers and had a fight with him within five minutes.

Malik claimed in the video that Modi was not ready to accept that farmers who were protesting against three agriculture laws of the Centre last year died due to him and instead, asked him to meet Shah.

"Meghalaya's Governor Sri. Satya Pal Malik is on record saying PM was 'arrogant' on the issue of farmers and Home Minister Amit Shah called the PM as 'mad'. Constitutional authorities speaking about each other with such contempt!" Kharge tweeted. "Narendra Modiji is this true?" the Leader of Opposition in the Rajya Sabha asked. Malik is also heard saving in the video clip that when he met Shah, the latter told him that "people have clouded his (Modi's) vision" and he should keep meeting the Prime Minister.

The Congress also shared Malik's comments on its Twitter handle and alleged that it was due to Modi's arrogance that so many farmers had died.



### Lawyer pursuing Bofors case claims threat to life

New Delhi, Jan 3: A lawyer who has been pursuing the politically sensitive Rs 64 crore Bofors payoff case has filed a complaint with Delhi Police claiming that he received life threats in an anonymous letter.

Advocate Ajay Agrawal claimed that the letter, received December 31, was sent by an ordinary post and there was no address of the sender on it "The letter said that he (Agrawal) and his family would face serious consequences if he did not withdraw the case he is pursuing in the Supreme Court,' the lawyer said.

Agrawal December 25 had filed an application in the Supreme Court seeking an early hearing on a petition challenging the Delhi High Court's 2005 verdict which quashed all charges, including against the Hinduja brothers, in the case. He said the apex court had November 2, 2018, dismissed

the CBI's plea against the high court verdict and had said the probe agency can raise all grounds in the appeal filed by him against the same judgement.

Agrawal said he had filed the petition in the top court against the high court verdict in 2005 itself and over three decades have gone by since the matter came to light.

The high court in its 2005 judgement had quashed all charges against the three Hinduja brothers - S P Hinduja, G P Hinduja and P P Hinduja -- and the Bofors company. Before the 2005 verdict, the high court had February 4, 2004, exonerated former Prime Minister Rajiv Gandhi in the case and directed the framing of charge of forgery under section 465 of the Indian Penal Code against Bofors company.

The Rs 1,437-crore deal between India and Swedish arms manufacturer AB Bofors for the supply of 400 units of 155 mm Howitzer guns for the Indian Army was entered into March 24, 1986.

## Women MPs seek greater say in Parl panel scrutiny

New Delhi, Jan 3: Women MPs Monday sought greater participation in the scrutiny of a bill that seeks to increase the legal age of marriage for females from 18 to 21 years, expressing dismay over their inadequate representation in the parliamentary panel

examining the proposed law. Trinamool Congress leader Sushmita Dev, a Rajya Sabha member from West Bengal, is the lone woman member in the Parliamentary Standing Committee on Education, Women, Children, Youth and Sports that is scrutinising the Prohibition of Child Marriage (Amendment) Bill

"This is disheartening to note that a bill so pertinent to women and the Indian society will be deliberated upon in a committee where

the representation is highly skewed," Shiv Sena leader Priyanka Chaturvedi, a member of the Upper House of Parliament from Maharashtra, said in a letter to Rajya Sabha Chairman M Venkaiah Naidu. Chaturvedi urged Naidu to ensure more participation of women in the discussion around the Bill.

"Therefore, I request you to ensure that there should be more representation and participation of women in the discussion around the bill that concerns the issues faced by women in India," she said in her letter to Naidu. Dev wrote a letter to Committee chairman Vinav Sahasrabuddhe requesting him to invoke a rule that will allow all the women parliamentarians to testify before the panel

"Under Rules 84(3) and 275 of the Rules of Procedure and Conduct of Business in the Council of States



(Rajya Sabha), I wish to propose that any woman member of both Lok Sabha and Rajya Sabha be empowered to testify either in writing or in person before the Committee on this issue," she said in the letter.

She pointed out that Rajya Sabha

has 29 women members, and the Lok Sabha has 81 women members.

"I am sure all my female colleagues will have much to contribute to the discussion on this issue." "I request you to use the powers of your office to open the

meetings of the Committee on this issue to testimonials from any of the Honourable women members, and request you to allot time accordingly," she said.

DMK leader and Lok Sabha member Kanimozhi also expressed her displeasure over the inadequate representation of

women in the panel. 'There are a total of 110 female MPs but the govt. Chooses to assign a bill that affects every young woman in the country to a panel that has 30 men and only one woman. Men will continue to decide the rights of women. And women will be made mute spectators," she wrote on Twitter. "The muchlauded change in the legal age of marriage for women glides through the rocks of underrepresentation, inadequate stakeholder consultation and ignoring expert opinion,"

Rajya Sabha member from NCP Fauzia Khan said "We can keep making committees to ensure granularity in focus but if the democratic values are compromised, it's never really welfare," Khan said. Chaturvedi said it was of utmost importance that the interests of all stakeholders were taken into account and that the voices of all, especially women, are heard and understood by the committee.

The Bill will apply to all the communities and once enacted, supersede the existing marriage and personal laws. The introduction of the bill in Parliament was opposed by some members, who had contended that the move infringed upon several personal laws in violation of the fundamental rights and demanded that it be referred to a parliamentary panel for greater scrutiny.

Dibrugarh (Assam), Jan 3: The pro-talks faction of ULFA has ex-'sincerity' in taking forward the decade-long peace parleys with it, claiming that no dialogue has been held in the last two years and there was no government interlocutor at present to take the process forward.

The faction alleged that there has been 'not much progress' in the peace talks with it since the Narendra Modi government came to power, though the negotiations had reached the final stages during former Prime Minister Manmohan Singh's tenure

It also maintained that the hardliner ULFA(I) chief Paresh Barua is unlikely to come forward for negotiations until the parleys with the pro-talks faction are completed.

The allegations come at a time when Assam Chief Minister Himanta Biswa Sarma is trying to bring Barua to the negotiating table for a settlement with all factions of the group.

Talking to PTI, former self-styled general secretary of ULFA and pro-talks faction leader Anup Chetia said, "The last round of talks with Discussions were almost over and in the final stages the government was held in

"After that, there has been no contact with us. Still, we are waiting with hope that our issues will be addressed and resolved by the government," he said.

Iron ore dumps new battleground in poll-bound Goa

Panaji, Jan 3: Massive mountains of low grade iron ore, many of them several hundred feet high, have now emerged as the latest flash point between the establishment and activists in Goa.

Referred to colloquially as dumps on account of the fact that the uneconomical, low grade ore is dumped alongside mining leases - the mammoth mountains of what was once rejected iron ore are now in the crosshairs of the BJP-led coalition government, which is under pressure to make efforts to restart the beleaguered mining industry in Goa ahead of the 2022 Assembly polls.

Last Wednesday, Chief Minister Pramod Sawant said that his government had formulated a policy for regularisation of mining dumps on government and private land.

Sawant said that in fiscal 2013-14, the state government had collected nearly Rs 200 crore in fines from mining leaseholders who had dumped reject ore outside the mining lease areas. He added that valid lessees who had paid the fines would be allowed to harvest the ore and export it after taking permission from the Indian Bureau of Mines, on paying royalty Unclaimed ore, the Chief Minister said, would be auctioned by the government, adding that the dump mining policy was in sync with the Supreme Court directives on the subject.

Sawant added that fresh environment clearances were not mandatory for harvesting the dumps, a point which has enraged green activists in the state.

According to Claude Alvares, director of green NGO Goa Foundation, the Chief Minister's claim is an eyewash.

"The policy for dump mining is an eyewash to hoodwink the people of Goa before the elections and will remain a non-starter since no such permits can be issued until the Supreme Court hears the issues related to dump mining pending before it," Alvares said.

"In the absence of an approval from the Supreme Court and in the absence of any valid leaseholders in Goa, such permits to export dump material are illegal unless the dumps themselves are auctioned instead of being handed out in exchange for royalty," he added, calling the state government policy 'completely illegal'.

"The new policy is completely illegal since the issue of the disposition of the dumps is still pending before the Supreme Court. The Advocate General of the state had also advised the Goa government against any removal or working on dumps," he said.

Sawant had said that the harvesting of dumps for iron ore alone would restart mining in the state for five years. "This is why I have been saying there is scope to see the resumption of activity for the next five years. Today we have finalised the ore rates for auction depending

on various grades," Sawant said. Interestingly, while Sawant has claimed that there is around 10 to 20 million metric tonnes of iron ore in Goa's mining dumps, the state government's Goa Mineral Policy 2013, states that according to undertakings submitted to the authorities at the time, the total ore stock in the dumps was in excess

of 700 million tonnes. The Opposition has however raised red flags over Sawant's new initiative, which former Deputy Chief Minister Maharashtrawadi Gomar leader Sudin Dhavalikar has said is more oriented towards elections rather than restarting the mining industry in Goa, where fresh iron ore extraction has been

banned since 2018. "Chief Minister took a cabinet decision to allow extraction of 10 to 20 million tonnes of ore from dumps. I challenge the government that these are not 10 to 20 million tonnes, it is more than 100 million tonnes. These dumps could be a source of a new scam,' Dhavalikar said.



Sela (Arunachal Pradesh), Jan 3: The snow-covered epitaph put up by India's Border Roads Organisation at the top of the 13,700 feet-high Sela Pass reads: "When you come to the end of the road, oh my old friend there is always a hill to be climbed just ahead...

The black granite marker, which must have been hauled from many hundred kilometres away, was put up December 14, 1972, some 10 years after the 1962 war in memory of the men of the 'Fikar (Worry) Not' 14 Border Roads Task Force who died while constructing the road from Sela to Tawang.

The pass was last Friday 'renamed' as Se La (not very different from the Indian map spelling) by the Chinese Ministry of Civil Affairs in accordance with a new law 'on the protection and exploitation of land border areas' which came into effect from January 1, 2022.

The 'renaming exercise' also involved eight villages and towns, four mountains and two rivers in 'Zagnan' or South Tibet, the name Beijing uses for Arunachal Pradesh, as part of a cartological war China has been waging to lay claim on portions of Himalayan India.

'The Chinese name change does not change the fact that these places are part of India. But it does underline their focus on psychological warfare and Sela Pass being of strategic importance as the gateway to the Brahmaputra Valley. In a way, it's like playing a sort of shadow chess, without moving any piece on the board...in the 1962 border war too, they had targeted Sela pass,' Maj Gen (Retd) Biswajit Chakravarty, a military analyst with long experience in the Eastern Command, told PTI.



## **Vaccination for 15 to 18 age group starts**

New Delhi, Jan 3: Over 41 lakh children in the age group of 15 to 18 years received Covid vaccine doses till 8 pm on the first day of the inoculation drive for this group of beneficiaries.

The cumulative Covid vaccine doses administered in the country crossed 146.61 crore with more than 98 lakh shots being administered Monday till 10.15 pm.

According to the Health Ministry, the daily vaccination tally is expected to increase with the compilation of the final reports for the day by late in the night.

'Well done Young India! Over 40 lakh between 15-18 age group received their first dose of Covid-19 vaccine on the first day of vaccination drive for children, till 8 pm. This is another feather in the cap of India's vaccination drive," Union Health Minister Mansukh Mandaviva tweeted.

Over 53 lakh youngsters have registered on the CoWIN portal till 10.15 pm after the process began January 1 for this category.

During the day, Mandaviya visited the Covid vaccination site for children at the Ram Manohar Lohia Hospital and interacted with some of the beneficiaries. "Visited RML Hospital and took stock of the vaccination campaign for children in



Interacted with the children and asked them to motivate their friends

for the vaccine," he said in a tweet. Co-WIN Chief and CEO of National Health Authority Dr R S Sharma said, "We have received a good response. Children are coming forward to get vaccinated and the numbers today itself are very significant."

Sharma said necessary provisions and changes have been made on the digital platform to include the new category of beneficiaries.

The health ministry in a tweet said, "Only Covaxin approved for less than 18 yrs. Eighteen plus (ie born in 2004 or before) are eligible for all vaccines, including Covishield. For 15-17 years (born in 2005, 2006, 2007) eligible only for Covaxin. Validations in place in for children above 12 years with certain conditions on December 24.

The registration for this category of beneficiaries opened Saturday, According to the guidelines, they can self-register online through an existing account on CoWIN or can also register by creating a new account through a unique mobile number as is the case with all other categories of beneficiaries.

#### 84% of Delhi's Covid cases **Omicron variant: Jain**

New Delhi: As many as 84 per cent cases of Covid seen in the last two days of December 2021 are of the Omicron variant, Delhi Health Minister Satyendra Jain said Monday, but stressed that there was no need to panic. Of total genome sequencing reports from Delhi's three labs - ILBS, LNJP and NCDC, 84 per cent have reported the Omicron variant, he said at a press conference. He said that Delhi had reported 3,194 Covid cases Sunday and the Covid positivity rate has gone to 4.59 per cent. "Today, around 4,000 Covid cases are expected by the evening, taking the positivity rate rising to 6.5 per cent," he said, adding that according to the experts, Delhi can see a Covid peak within the week.

The Drugs Controller General of India granted emergency use authorisation to indigenously-deistered onsite. ## Wankhede's tenure with Mumbai NCB ends; sent back to DRI

New Delhi, Jan 3: The tenure of controversial NCB Mumbai zonal director Sameer Wankhede with the federal anti-narcotics agency has ended and his services have been put at the disposal of his parent or ganisation DRI, officials said.

The charge of the NCB Mumbai zonal unit will be handled in an additional capacity by its Indore zonal director Brijendra Chowdhary, a 2009-batch IRS officer of the Customs and Indirect Taxes cadre.

Wankhede, an Indian Revenue Service (IRS) officer of the 2008 batch, was deputed to the Narcotics Control Bureau (NCB) Mumbai zone in August, 2020 "on loan" from the Directorate of Revenue Intelligence (DRI) in the wake of the drugs probe being conducted by the agency linked to the death of 34 year-old actor Sushant Singh Rajput.

The 42-year-old officer served as the head or the zonal director of the NCB Mumbai unit beginning August 31, 2020 with an initial tenure of one year. He was given a four months extension in the post



beyond August, 2021. Wankhede's tenure with the NCB finally ended December 31, 2021 and as there has been no government order for his extension, he has been sent back to his parent organisation DRI, officials said. Officials said the NCB did not seek the officer's extension.

Wankhede has been in the limelight following the high-profile October, 2021 raids by the NCB on a Mumbai cruise after which the agency arrested Aryan Khan, the son of actor Shah Rukh Khan, and around 19 others and claimed to have seized some narcotics too.

Soon after this action, Maharashtra minister and NCP leader Nawab Malik levelled multiple charges of alleged misconduct and corruption against the officer.

### Plea against ILP, top court notice to Centre, Manipur

New Delhi, Jan 3: The Supreme Court Monday sought response from the Centre and the Manipur government on a plea questioning validity of Inner Line Permit (ILP), which restricts entry of nonindigenous people into the state.

The petition, filed by organi-

sation Amra Bangalee, argued that system was draconian, and fundamentally opposes policies of social integration, development, and technological advancement in the area outside the Inner Line. It further argued that ILP hampers tourism within the state, which is a major source of revenue generation for these areas. After hearing the plea, a bench of Justices Abdul Nazeer and Krishna Murari sought a response from the Union and Manipur government. The petition said: "The effect of ILP system in the state of Manipur is that no person who is not a resident of the said state is permitted to enter the state or engage in business there without applying for a special permit



It contended that the system violated fundamental rights of citizens guaranteed under the Constitution, while granting unqualified power to the state government to restrict the entry and exit of non-indigenous persons

The plea contended that permit system was introduced by way of the Adaptation of Laws (Amendment) Order, 2019 (2019 order) which extends 140-year-old 'colonial legislation" Bengal Eastern Frontier Regulations, 1873 (BEFR), which was enacted by the British to create monopoly over the tea plantations in Assam.

New Delhi, Jan 3: The Delhi Police has sought details from the GitHub platform about the developer of the controversial 'Bulli Bai' mobile application and has written to Twitter for information about the account handler who first posted about the app, officials said Monday.

The city police also asked Twitter to block and remove on the microblogging platform any "offensive content" shared from the 'Bulli Bai' app', which had put\_ up pictures of hundreds of Muslim women including prominent personalities for "auction", they said.

After widespread outrage and demands for action against those behind the app. IT minister Ashwini Vaishnaw had said on Sunday that the government is working with police in Delhi and Mumbai, where cases have been reg istered in the matter.

He also said that GitHub has blocked the user who had uploaded the app and that the Computer Emergency Response Team (CERT), the country's nodal agency on cyber security, and police are coordinating further action in the matter.

The National Commission for Women had also written to the Delhi Police to expedite its action in the case related to the app.

Earlier in July, a case was registered by the Cyber Cell of the Delhi Police after it received a similar complaint about an unidentified group uploading photos of Muslim women on 'Sulli Deals' mobile application.

cines are not as effective against Omicron as they were against the original virus, and thus boosters may help enhance immunity, health experts said here. Data from various countries like

South Africa and the UK has shown that it causes only mild illness. But as Omicron can surge infection cases, it can overwhelm an already burdened medical system. 'Vaccines bypass natural im-

munity. The efficacy of existing vaccines is not as effective as it was against the virus that originated from Wuhan," Dr Sanjay Kumar Rai, Professor, Department of Community Medicine, AIIMS, New Delhi, said at a weekly health show by the New-Delhi-based HEAL Foundation on Sunday.

"However, there might not be any severity if an Omicron infection happens," he said.

The Indian Council of Medical

all Covid vaccines do not prevent infection and are primarily disease-modifying. "All Covid vaccines, whether they are from India, Israel, the US, Europe, the UK or China, are primarily disease-modifying. They do not prevent infection. The precautionary dose is primarily to mitigate the severity of infection, hospitalisation and death," said ICMR Director General Dr Balram Bhargava, at a recent press conference. At the same time, natural infection from Covid has can provide "long-term protection against the virus", Rai said. This has been consistent with several studies from across countries which showed that the durability of immunity post the Covid infection persists for about 9 months.

#### OMICRON DRIVING COVID CASES, THIRD WAVE IN INDIA: EXPERTS

New Delhi: The sudden spike in the number of Covid cases in India is driven by an increased spread of Omicron variant in the country, which may have already started the third wave, experts said Monday. Most states and large cities in India have observed a sharp increase in Covid cases, which was not noticed even during festival seasons. On December 31, India recorded 16,764 new Covid cases, up 27 per cent from the previous day. The average number of cases increased in the last week of December after dropping steadily since mid-May. On December 29, 13,187 cases were reported, representing a 76.6 per cent rise over the previous week's infections. "As per the emerging scientific evidence, experts believe that the Omicron variant, first detected in Botswana, is the main reason for the recent rise in infections in India," Dr Dipu T.S., Associate Professor, Division of Infectious Diseases, Amrita Hospital, Kochi, told IANS. "According to statistics from Global Initiative on sharing all Influenza Data (GISAID) - an open-access resource for viral genomic data - Omicron has surpassed all other variants as the most common in India. The Omicron variant was discovered in almost 60 per cent of the samples sequenced in India during the last few days of December," he added.

Security forces responded and rescued the 21 students and are "currently working to rescue the remaining victims and apprehend the perpetrators," Shehu said.

#### 10 terrorists held

Lahore: Ten terrorists belonging to the banned Tehreek-i-Taliban Pakistan (TTP), Al-Qaeda and Islamic State, have been arrested from various parts of Pakistan's Punjab province, police said Monday. In a statement, the Counter Terrorism Department (CTD) said that a huge cache of weapons to be used for terrorism in Puniab has also been recovered from them.

#### Two missing

Louisville: Search teams looked for two missing people in the smoldering debris from a massive Colorado wildfire while people who escaped the flames sorted through the charred remnants of their homes to see what was left. Investigators were still trying to determine what caused flames to tear through at least 9.4 square miles (24 square kilometers), leaving nearly 1,000 houses and other buildings destroyed in suburbs between Denver and Boulder. The inferno broke out Thursday, unusually late in the year following an extremely dry fall and amid a winter nearly devoid of snow.

## Yemen rebels seize UAE ship; hackers hit Israeli newspaper

NO GROUP IMMEDIATELY CLAIMED RESPONSIBILITY FOR THE **HACKING OF THE JERUSALEM POST**

Dubai, Jan 3: Yemen's Houthi rebels seized an Emirati-flagged ship in the Red Sea, officials said Monday, the latest sign of Mideast tensions as hackers targeted a major Israeli newspaper's website to mark America's 2020 killing of a top Iranian general.

The seizure of the Rwabee marks the latest assault in the Red Sea, a crucial route for international trade and energy shipments. The Iranian-backed Houthis acknowledged the incident off the coast of Hodeida, a long-contested prize of the grinding war in Yemen.

No group immediately claimed responsibility for the hacking of the Jerusalem Post. The hackers replaced the Post's homepage with an image depicting a missile coming down from a fist bearing a ring long associated with Qassem Soleimani, the Iranian general killed by a US drone strike in Iraq two years ago

First word of the Rwabee's seizure came from the British military's United Kingdom Maritime Trade Operations, which only said an attack targeted an unnamed vessel around midnight. The coordinates it offered corresponded to the Emirati-flagged landing craft Rwabee, which hadn't given its location via satellite-tracking data for hours, according to the website MarineTraffic.Com.

A statement from the Saudi-led

coalition, carried by state media in the kingdom, acknowledged the attack hours later, saying the Houthis had committed an act of "armed piracy" involving the vessel. The coalition asserted the ship carried medical equipment from a dismantled Saudi field hospital in the distant island of Socotra, without offering evidence.

The Houthi militia must immediately release the ship, otherwise the coalition forces shall take all necessary measures and procedures to deal with this violation. including the use of force," Brig. Gen. Turki al-Malki said in a state-

A Houthi military spokesman, Yahia Sarei, announced that rebel forces had seized what he described as an Emirati "military cargo ship"

carrying equipment into Yemen's territorial waters "without any license" to engage in "hostile acts" against Yemen's stability. He said the rebels would offer more details on the seizure later.

An employee at the vessel's owners, Abu Dhabi-based Liwa Marine Services, told The Associated Press that the Rwabee appeared to have been the target but said they had no other information and declined to comment further. The employee did not give her name and hung up.

A similar incident happened in 2016 involving the Emirati vessel SWIFT-1, which had been sailing back and forth in the Red Sea between an Emirati troop base in Eritrea and Yemen. The vessel came under attack by Houthi

#### **Kenyan conservationist Richard Leakey dies**

Nairobi, Jan 3: Richard Leakey, a Kenyan conservationist and paleoanthropologist who spearheaded campaigns against the ivory trade to save the dwindling African elephant population, has died, the Kenyan presidency said Sunday. He was 77.

For years Leakey served in various roles in the government including as director of the staterun National Museums of Kenya and twice as board chairman at the Kenya Wildlife Service. President Uhuru Kenyatta said Leakey had "served our country with distinction".

"Besides his distinguished career in the public service. Dr. Leakev is celebrated for his prominent role in Kenya's vibrant civil society where he founded and successfully ran a number of institutions."



Leakey was the son of palaeontologists Louis and Mary Leakey, whose work helped demonstrate that human evolution began in Africa. He was celebrated for his work to save wildlife from poachers and for leading campaigns against the ivory trade.

Paula Kahumbu, a wildlife conservationist who heads WildlifeDirect, said she had been mentored by Leakey, as had many other young Kenyans.

### Hong Kong welcomes pro-Beijing lawmakers

Hong Kong, Jan 3: Hong Kong welcomed a new batch of pro-Beijing lawmakers in its Legislative Council Monday who were chosen in an election without opposition candidates, as the editors of one of the city's last remaining pro-democracy news outlets announced its closure.

They are the latest in a series of events in the past year in which the local government has been reshaping Hong Kong, with Beijing's backing, in an effort to stamp out dissent in a city once renowned for its freedoms of expression.

The founders of news outlet Citizen News said Monday that although they have not been contacted by the Hong Kong national security police, the deteriorating media freedoms in the financial hub make it unclear whether their reporting violates the law. They said the news site will stop publishing on Tuesday.

'We all love this place, deeply.

Regrettably, what was ahead of us is not just pouring rains or blowing winds, but hurricanes and tsunamis," Citizen News said in a statement on Sunday, when it originally announced the closure. Citizen News is the third news outlet to close in recent months, following pro-democracy newspaper Apple Daily and online site Stand News.

The outlet was founded in 2017 by a group of veteran journalists. While small, it focused on political news and analysis pieces, as well as investigations.

The space for doing those types of stories has shrunk since China's central legislature imposed a sweeping National Security Law in Hong Kong in 2019 following massive anti-government protests. As authorities stepped up arrests of political activists, civil rights groups and unions disbanded, and some activists fled. Independent media have been

one of the more prominent casualties of the ongoing crackdown.

Seoul, Jan 3: The man who crossed the eastern inter-Korean border into North Korea over the weekend was found to be a North Korean defector, an official at South Korea's Defence Ministry said Monday.

Citing surveillance footage, the official said the man is the 30-something defector who had also used an eastern front-line route to reach the South in November 2020 but stressed no evidence of espionage has been found, reports Yonhap News Agency

The incident on January 1 brought the South Korean Army's 22nd Division in charge of the eastern front-line area under renewed criticism for the latest border breach. "In the footage, the man was recognized to be the same as the defector so we can call him the same person," the official told re-

porters on condition of anonymity. The man crossed the barbed wire fence to enter the Demilitarized Zone separating the two Koreas and then raced across the Military Demarcation Line despite efforts

to stop him. After the defection to the South, the man is known to have worked as a cleaner here, an indication that he might have had economic difficulties here.

Other details about him were not immediately known.

The defector had been out of contact since December 30, while a surveillance camera installed in the Civilian Control Line near the land border captured him hours before his border crossing, the official said.

Sunday, South Korea's military sent a message to the North twice regarding the border crossing through a western cross-border communication line.

### Sudan PM resigns amid political deadlock

Cairo, Jan 3: Sudan's Prime Minister Abdalla Hamdok announced his resignation Sunday amid a political deadlock and widespread pro-democracy protests following a military coup that derailed the country's fragile transition to democratic rule.

Hamdok, a former UN official seen as the civilian face of Sudan's transitional government, had been reinstated as prime minister in November as part of an



agreement with the military following the October coup. In that time he had failed to name a Cabinet and his resignation throws Sudan into political uncertainty amid uphill security and economic challenges.

In a televised national address Sunday, Hamdok called for a dialogue to agree on a "national charter" and to "draw a roadmap" to complete the transition to democracy in accordance with the 2019 constitutional document governing the transitional period.

#### Man held over fire at S Africa Parliament

Cape Town, Jan 3: A man has been arrested after a large fire severely damaged the Houses of Parliament in the South African city of Cape Town.

A police spokesperson said the\_ man was facing charges of arson, housebreaking and theft, and would appear in court on Tuesday, the BBC reported. Firefighters have been working for hours to extinguish the blaze.

President Cyril Ramaphosa called it a "terrible and devastating event", as he vowed parliament's work would continue. Footage from the scene on Sunday showed a plume of black smoke filling the sky, with huge flames coming out from the roof of the building.

Officials said the fire started on the third floor offices and quickly spread to the National Assembly (the parliament's lower house) chamber. The parliament is not currently in session because of the holidays, and no injuries were reported.

Brigadier Nomthandazo Mbambo said the suspect is also expected to be charged under the National Key Points Act, which protects sites of strategic importance. Further details were not immediately available.

In a statement on Sunday, South Africa's parliament confirmed that there had been "significant damage" to the New Assembly Wing of the building.



New Delhi, Jan 3: A new satellite image showing China building a bridge on its side of the Pangong lake in eastern Ladakh emerged Monday amid the prolonged Sino-India military standoff in the border area

People familiar with the development said the satellite imagery is of an area on the Chinese side of the Line of Actual Control (LAC) near the Galwan valley region. The armies of India and China had created a buffer zone in Galwan valley following their deadly clashes on June 15, 2020.

January 1, Indian and Chinese troops exchanged sweets and greetings at 10 border posts along the LAC including in eastern Ladakh to mark the New Year. The sources said the bridge is at a distance of around 40 km from the alignment of the LAC in the region and that India has also been developing infrastructure in the region at a rapid pace.

Geo-intelligence expert Damien Symon posted a satellite image on Twitter suggesting that the new



bridge was being constructed by China to link the North and South banks of Pangong lake. Military experts said the aim of constructing the bridge in the Khurnak area could be to ensure that the Chinese

People's Liberation Army(PLA) is

able to quickly mobilise its troops in the region.

The Indian military sources said India has been developing infrastructure in all key areas along the LAC and that India is aware of Chinese activities in the region.

Last week, Defence Minister Rajnath Singh inaugurated the Chisumle-Demchok road at Umling La Pass at over 19,000 feet in Ladakh that is considered as a key stretch for military purpose.

China has been focusing on strengthening its military infrastructure after Indian troops took control of several strategic peaks on the southern bank of Pangong lake in August 2020 after the Chinese PLA attempted to intimidate them in the area.

The eastern Ladakh border standoff between the armies of India and China erupted on May 5, 2020, following a violent clash in the Pangong lake area. Both sides gradually enhanced their deployment by rushing in tens of thousands of soldiers as well as heavy weaponry.

As a result of a series of military and diplomatic talks, the two sides completed the disengagement process last year in the north and south banks of the Pangong lake and in the Gogra area. Each side currently has around 50,000 to 60,000 troops along the LAC in the sensitive sector.

The 13th round of Corps Commander-level military talks in October ended in a stalemate with the Indian Army saying that the "constructive suggestions" made by it were not agreeable to the Chinese side. The defence ministry last Friday said it held several rounds of military talks with the Chinese side to deescalate the situation in eastern Ladakh without compromising on its stand of "complete disengagement and immediate restoration of status quo ante". India has been insisting onreturning to the status quo that existed before the face-off erupted.

## Exports zoom 37% to \$37.29bln in Dec

New Delhi, Jan 3: The country's exports in December 2021 surged 37 per cent on an annual basis to \$37.29 billion, the highest-ever monthly figure, on the back of healthy performance by sectors like engineering, textiles and chemicals, even as the trade deficit widened to \$21.99 billion.

Imports in December too rose by 38 per cent to \$59.27 billion on account of an increase in oil imports, which soared 65.17 per cent to \$15.9 billion, government data showed Monday. Gold imports expanded by 4.5 per cent to \$4.69 billion.

Exports in December 2020 stood at \$27.22 billion, while imports aggregated to \$42.93 billion. Trade deficit was at \$15.72 billion.

Cumulatively, during April December 2021-22 exports rose by 48.85 per cent to \$299.74 billion.

Imports during the period increased by 69.27 per cent to \$443.71 billion, leaving a trade deficit of

In December 2021, exports of engineering goods grew by 37.27 per cent to \$9.7 billion, followed by petroleum products (140 per cent to \$5.6 billion), gems and jewellery (15.8 per cent to \$2.98 billion), chemicals (26 per cent to \$2.64 billion) and ready-made garments of all textiles (22 per cent to \$1.46 billion).

Addressing a press conference Commerce Minister Pivush Goval said India's merchandise exports will cross \$400 billion this fiscal.

"With \$300 billion in the first nine months of 2021-22 we are on track to achieve our target. This growth is satisfying and we must aspire for more," Goyal said.

#### **Future petitions** Delhi HC to abort **Amazon arbitration**

Mumbai, Jan 3: Future Retail has asked Delhi High Court to declare ongoing arbitration proceedings with Amazon.com illegal, saying the country's antitrust agency had suspended a 2019 deal which Amazon used to assert its rights over Future.

Amazon successfully used the terms of its toehold \$200 million investment in debt-laden Future to block the Indian retailer's attempt to sell retail assets to a rival, alleging breach of certain contracts.

But the Indian antitrust body the Competition Commission of India, in December suspended the 2019 deal saying Amazon suppressed information while seeking ap-

The long-running dispute is being heard by a Singapore arbitration panel, but both sides have been fighting parallel cases in Indian courts to enforce or overrule certain decisions taken by the ar-

In the latest Future Retail filing in New Delhi, the company argues that since the 2019 deal no longer has antitrust approval, it has no legal existence in India and Amazon can no longer assert any of its rights. The continuation of the entire arbitration proceedings is a perpetuation of illegality, Future said in its filing dated December 31. The case will likely be heard by judges this week.

The filing also showed that Future's appeal to the Delhi High Court comes after the Singapore arbitration panel did not agree to its immediate demands to terminate the proceedings, saying arguments would continue this month.

Amazon has long argued that Future violated the terms of its 2019 deal in deciding to sell retail assets to Reliance, and the US company's position has so far been backed by the Singapore arbitrator and Indian courts. Future denies

#### Over 500 employees, ex-staff of OYO buy around 3cr shares

Mumbai, Jan 3: To push digital transactions in rural and semiurban areas, the Reserve Bank of India (RBI) Monday issued a framework allowing offline payments up to Rs 200 per transaction, subject to an overall limit of Rs 2,000. An offline digital payment means

a transaction that does not require internet or telecom connectivity. These transactions will not require an additional factor of au-

thentication (AFA), the Reserve Bank of India said, adding that since the transactions are offline, alerts (by way of SMS andor email) will be received by the customer after a time lag.

"Transactions are subject to a limit of Rs 200 per transaction and an overall limit of Rs 2,000 for all transactions until the balance in the account is replenished. Balance replenishment can only occur in an online mode," said the Framework for Facilitating Small Value Digital Payments in Offline Mode.

"Offline transactions are expected to give a push to digital transactions in areas with poor or weak internet or telecom connectivity, particularly in semi-urban and rural areas. The new framework is applicable with immediate effect," the RBI said.

The offline mode of payment, it said, can be enabled after obtaining the specific consent of the customer.

The customers, it added, will continue to enjoy protection under the provisions of circulars limiting customer liability and will have recourse to the Reserve Bank -

Disappointing run of Pujara, Rahane with bat continues as India manage to post 202 in the first innings of the second Test before South Africa reach 35/1 at stumps on Day 1

Johannesburg, Jan 3: Cheteshwar Pujara and Ajinkya Rahane's saga of failures compounded a shoddy batting performance by India even as stand-in skipper KL Rahul impressed with a defiant show amid the ruins on the opening day of the second Test against South Africa here Monday.


Rahul's patient 50-run knock on a day when India missed Virat Kohli due to back spasms and Ravichandran Ashwin's cavalier 46 at the rear end ensured that India scored 202 in their first innings on a houncy Wanderers track.

At stumps, Mohammed Shami sent back Aiden Markram even as Dean Elgar (11 batting) and Keegan Peterson (14 batting) took South Africa to 35/1. It could have been two down had Rishabh Pant snapped Peterson off Jasprit Bumrah, which seemed a regulation catch.

Worse, Mohammed Siraj hobbled off with what looked like a hamstring strain and if it's bad news, then India would be left with four bowlers.

However, a lot of blame should go to India's batters as some like Pujara didn't show intent to score while others like Rahane seemed completely short of confidence. It prompted the legendary Sunil Gavaskar to say it as it is on air, "I think the next innings will be their last chance.'

Having given up hopes to play for England, Duanne Olivier (3/67), playing his first game for South



Africa in three years, dismissed Pujara (3) and Rahane (0) off successive deliveries to make it difficult for the Indians.

Marco Jansen (4/31), with his giant frame, created awkward lengths for every Indian batter while Kagiso Rabada (3/64), despite not being at his best, got wickets when it mattered.

In his first game as captain, Rahul concentrated hard as he played 133 deliveries. He was peppered with short balls. He would sway to some and duck the others while pulling the ones that he could.

Such is beauty of sport that Rahul, who till five months ago wasn't supposed to start as an opener in England, is now being groomed as an all-format India captain. If the first day composure is any indication, he won't do a bad job.

He had a nice little partnership



of 42 runs with Hanuma Vihari (20) before an inspirational closein catch from Rassie Van der Dussen

at short leg sent the latter back. Pant (17) and an attacking Ashwin added 40 in quick time but what India needed was a partnership of at least 75 if not 100.

### Nehra to be head coach of Ahmedabad IPL team

New Delhi, Jan 3: Former India fast bowler Ashish Nehra will be Ahmedabad IPL franchise's head coach during the 2022 Indian Premier League season while England opener of yesteryears Vikram Solanki is in line to become 'Director of Cricket'.

World Cup-winning former India coach Gary Kirsten will be the 'Mentor' of the franchise which is expecting to get its formal 'Letter of Intent' (LOI) during the month.

"As far as I have heard, they have signed Ashish as their head coach and someone who would be in overall charge of the franchise. Solanki will be the 'Director of Cricket' and also expected to double up as batting coach and Kirsten will be in a mentorship role," a senior IPL source told PTI on conditions of anonymity.

"The Ahmedabad franchise can't announce it formally as it is a BCCI diktat and they can only make a formal announcement after they get the LOI. The head honchos of Ahmedabad franchise has already interviewed the trio and shortlisted them for the season," the

source said. Nehra has earlier been a coach with Royal Challengers Bangalore where Kirsten was also involved for a couple of seasons. Both of them have had a long and fruitful working relationship since the time when Nehra was a player and

Kirsten his national coach. Nehra shares a great rapport even with Solanki, who has worked previously as a coach in IPL. Once it gets the green light from BCCI, the franchise will go ahead and select a few assistant coaches.

Nehra had been away from coaching for two seasons as he had decided that he would be taking up such an assignment only if he has the profile of a head coach where he can make a difference both in terms of team composition and
