Colleges, varsities shut from Jan 10

Several educational institutions in the state have reported detection of large number of Covid-19 cases on their campuses

Bhubaneswar, Jan 7: With the rapid increase in Covid-19 cases in Odisha, the state government has ordered closure of all colleges and universities and their hostels from January 10.

"All colleges, universities, technical educational institutions (other than medical colleges, nursing colleges & institutions under control of Health & Family Welfare department) under the superintendence of Odisha government shall remain closed with effect from January 10, 2022," Special Relief Commissioner (SRC) PK Jena said in an order.

The order will be in effect till February 1, it said. The authorities of colleges, universities and tech-

nical education institutions will have to take all appropriate measures for conducting online classes, it said.

All hostels in such academic institutions will also remain closed and the students will be advised to avoid staying in the hostels in the interest of their personal health, it added. Scholars, researchers and students who desire to stay in hostels for research and project works or other academic activities may be permitted to do so after providing an

undertaking, the order said. However, all ongoing offline examinations will be allowed to continue as per the schedule by complying with Covid-19 guidelines, the order said.

All teaching and non-teaching employees will work as per the prevailing guidelines for government employees and perform duty as assigned to them by the respective authorities, the order said.

Coaching institutions, organisations and individuals offering tuition will also stop taking offline classes, it said. Any person found violating the order will be punished under the provision of the Disaster

Management Act, 2005 and other relevant laws, it said. Several educational institutions in Odisha have reported detection

of large number of Covid-19 cases on their campuses. In the order, Jena informed that the state is passing through a crit-

ical stage of the Covid-19 pandemic due to resurgence of cases in some parts of the state and it is necessary to strictly adhere to Covid-19 safety protocols to check the spread of the infection.

7-day home guarantine must for all int'l arrivals

New Delhi, Jan 7: India Friday made seven-day home quarantine mandatory for all international arrivals and an RT-PCR test on the eighth day, as it issued revised guidelines for international passengers.

The guidelines released Friday come into force from January 11 and will remain effective till further orders. As per existing rules, which have been retained in the revised guidelines, travellers coming from countries specified as 'at risk' have to submit sample for Covid testing post-arrival and they required to wait for the results at the airport before leaving or taking a connecting flight. If tested negative, they need to undergo home quarantine for seven days and then get their RT PCR test done on the eighth.

Travellers from all categories of countries will undergo home quarantine for seven days and undertake an RT-PCR test on the 8th day. officials said, sharing details about revised guidelines said. International travellers arriving through seaports/land ports will also have to undergo the same protocols as above, except that facility for online registration is not available for such passengers currently.

Apex court upholds the validity of 27% OBC and 10% EWS quota, while doctors call it a 'historic day' for the medical fraternity

New Delhi, Jan 7: The Supreme Court Friday, in an interim order, allowed resumption of medical counselling for NEET-PG admissions for the year 2021-22 and upheld the validity of 27 per cent OBC quota.

A bench of Justices DY Chandrachud and AS Bopanna said that detailed reasons for the interim order will follow, and the counselling for the NEET-PG for the academic year 2021-22 will proceed as per the criteria already notified.

Counselling on the basis of NEET-PG 2021 and NEET-UG 2021 shall be conducted by giving effect to the reservation as provided in the notice dated July 29, 2021 including



the 27 per cent reservation for the OBC category and 10 per cent reservation for EWS category in the All

India Quota seats," the bench said. It said the submissions which have been made before this court over a span of two days necessitate a detailed interim order on the applicability of the EWS criteria as notified by Office Memorandum of 2019 for NEET-PG 2021.

"The formulations of the reasons in the interim order on the EWS reservation would take some time. The validity of OBC reservation in the all-India quota seats

Puri, Jan 7: The famed Jagannath temple in Puri will remain closed from January 10 in view of the increasing Covid-19 cases, a senior official said Friday.

The temple will remain closed till January 31, as per the decision taken at the meeting of Chhatisa Nijog -- the apex body of the temple's servitors, he said. The meeting was also attended by staff members of the Shree Jagannath Temple Administration and district officials.

"In view of the health interest of devotees and servitors, it has been decided to close the shrine from January 10 to January 31. The decision was unanimously taken at a meeting of Chhatisa Nijog," Puri's District Collector Samarth Verma told reporters.

The daily rituals at the 12th-century shrine will be carried out as per the tradition by select servitors and priests, he said.

Covid spike in 6 months

Bhubaneswar, Jan 7: Odisha Friday registered its biggest singleday spike in Covid-19 cases in six months as 2,703 more people tested positive for the infection, a health bulletin said. The state had regis-

tered 1,897 cases Thursday. According to the state health department bulletin, 2,703 Covid cases including 409 children in the up to 18 years age-group have been reported. Khurda district, which includes Bhubaneswar, logged the highest 926 cases, followed by Sundargarh (454), Cuttack (191), Sambalpur (179) and Jharsuguda (106). All other districts reported less than 100 cases.

The daily test positivity rate has increased to 3.92 per cent Friday from 2.62 per cent Thursday Odisha now has 8,237 active cases. With the confirmation of another death

Almaty, Jan 7: Kazakhstan's President said Friday he had ordered his forces to shoot to kill to deal with disturbances from those he called bandits and terrorists, a day after Russia sent troops to put down a countrywide uprising.

Security forces appeared to be in control of the streets of the main city Almaty Friday but gunfire could still be heard after days of unrest in which dozens of people have been killed and public buildings ransacked and torched.

'The militants have not laid down their arms, they continue to commit crimes or are preparing for them. The fight against them must be pursued to the end. Whoever does not surrender will be destroyed," President Kassym-Jomart Tokayev said in a televised address. "I have given the order to law en-

forcement agencies and the army to shoot to kill without warning.' Tokavev has blamed foreigntrained terrorists for the worst violence in the Central Asian state's

30 years of independence. Russia's defence ministry, cited by Interfax, said more than 70 planes were flying round the clock to bring Russian troops into Kazakhstan, and they were now helping con-



trol Almaty's main airport, recaptured Thursday from protesters. Demonstrations that began as a response to a fuel price hike have swelled into a broad movement against the government and exleader Nursultan Nazarbayev, 81, the

longest-serving ruler of any former Soviet state. He turned over the presidency to Tokayev three years ago but his family is widely believed to have retained power in Nur-Sultan, the purpose-built capital that bears his name.

TROOPS IN ALMATY

The interior ministry said 26 'armed criminals' had been 'liquidated', while 18 police and national guard service members had been killed since the start of the protests, figures that appeared not to have been updated since Thursday. State television reported more than 3,700 arrests. Widespread unrest has been reported in a number of other cities across the vast country of 19 million people. The internet has been shut off since Wednesday, making it difficult to determine the full extent of the violence.

Psaki said Washington was keeping a close eye on Russian-led deployment. It would be watching for any violations of human rights and 'any actions that may lay the predicate for seizure of Kazakh institutions."

Traffic pollution chokes 2mn kids globally: Lancet

NO2 puts kids at risk of developing asthma and the problem is acute in urban areas, says the study

rom Los Angeles to Mumbai, a traffic-related air pollutant drives nearly 2 million new cases of paediatric asthma every vear, according to a new study. Asthma is a chronic illness that causes inflammation of the lung's airways.

Researchers from George Washington University studied ground concentrations of nitrogen dioxide or NO2, a pollutant that comes from tailpipe vehicle emissions, power plants and industrial sites. They tracked new cases of asthma that developed in children from 2000 until 2019 in more than 13,000 cities.

"Our study found that nitrogen dioxide puts children at risk of developing asthma and the problem is especially acute in urban areas,' said Susan Anenberg, a co-lead author of the article and a professor of Environmental and Occupational Health at the varsity.

"The findings suggest that clean air must be a critical part of strategies aimed at keeping children

healthy," she added. The findings, published in the journal Lancet Planetary Health, showed that out of the estimated 1.85 million new paediatric asthma cases attributed to NO2 globally in 2019, two-thirds occurred in urban areas.

Despite the improvements in air quality in Europe and the US, dirty air, and particularly NO2 pollution, has been rising in South Asia, Sub-Saharan African and the Middle East.

Paediatric asthma cases linked to NO2 pollution represent a large public health burden for South Asia and Sub-Saharan Africa.

In a second study, published in the same journal, researchers from the varsity showed that 1.8 million excess deaths can be linked to urban air pollution in 2019 alone.

The team found that 86 per cent of adults and children living in cities around the world are exposed to a level of fine particulate matter that exceeds the guidelines set by the World Health Organisation.

'Reducing fossil fuel-powered transportation can help children and adults breathe easier and may pay big health dividends, such as fewer cases of paediatric asthma and excess deaths," Anenberg said. "At the same time, it would also reduce greenhouse gas emissions, leading to a healthier climate," she added. IANS

hildren undergoing Covid vaccination must not take paracetamol, a common pain reliever, without first consulting, doctors advised Friday. The advice was issued in re-

sponse to growing concerns that some immunisation centres are advising children to take three paracetamol 500 mg tablets after receiving the Covid vaccine. Taking paracetamol without consulting a doctor can harm children, the health experts warned. "Paracetamol is not recom-

mended as prophylaxis, before and after any Covid vaccination as we don't know how it alters the immune response of the vaccine," said Akshay Budhraja, Senior Consultant, Respiratory and Sleep Medicine, Aakash Healthcare.

"Giving paracetamol to children (15-18 years old) who are receiving Covid vaccines is not recommended. It is because it has the potential to cause hepatotoxicity (liver damage caused by drug exposure) in them," added Vijay Dutta, Senior Consultant - Internal Medicine, Indian Spinal Injuries

A low-grade fever, muscle ache, lethargy, headache, soreness at the injection site is common in the first two days after vaccination, which usually subsides on its own, without any medication.

"However, if the fever persists or the intensity increases then paracetamol or other painkiller is advised after consultation with



a physician. So paracetamol is to be taken only after consultation and not as prophylaxis for fever, which happens because of the immune response of the body to the vaccine components, Budhraja added.





Ropeway for Nilamadhaba shrine in a limbo

Khandapara, Jan 7: Ancient temple shrines are visited by tourists and devotees round the year and are good revenue earners for the state exchequer.

However, the state government has done little for the development of these shrines despite a growing demand among the devotees for the development of these temples.

The famous Nilamadhaba temple at Kantilo in Nayagarh district is a case in this point where installation of a ropeway is stuck in government red-tape despite completion of a survey over last six years.

As a result, elderly and disabled people visiting the temple find it difficult to climb atop the hill for darshan of the deity in the absence of a ropeway.

It has been witnessed that many a times elderly and disabled people return from the foothill without visiting the deity as they find it hard to climb the staircase to reach the hilltop.

Locals have alleged that lack of political will is responsible for the delay in execution of the ropeway



project. The Nilamadhaba temple is a very old temple dedicated to Lord Vishnu of Hindu pantheon and the deity occupies a central position in the Jagannath cult.

The temple is situated atop twin hills of Brahmadri and Padmadri on the banks of the Mahanadi at Kantilo in Nayagarh district. It is visited by hundreds of devotees every day.

The temple is surrounded by four doors namely Lion's Gate

(Singhadwar) on the east, Tiger Gate (Byghradwar) on the west, Elephant Gate (Hatidwar) on the north and Horse Gate (Ghodadwar) on the south. The road to each gate has a flight of 54 steps.

The deity is revered by devotees who throng it round the year to witness the permanent flow of holy water from the feet of Lord Nilamadhaba. Lord Siddheswar present in the shrine is another

Six years ago, a survey was conducted on installation of a ropeway at the famous shrine in Navagarh, but the project has been buried under red-tape. No effort is allegedly made to execute it

highlight of the place.

Keeping the difficulties of devotees in mind, it was decided to construct a ropeway. However, the proposal is buried under red-tape.

Former Khandapara MLA Anubhav Patnaik had stressed construction of a ropeway to the shrine in 2014 during a visit to the shrine with Janakiballav Mohapatra, engineerin-chief of the state water resources department, November 13, 2014.

Later, concerned officials conducted a survey to implement the project in 2016. Since then, six years have passed but the project is yet to be implemented. This has sparked resentment among the visiting tourists and devotees.

Reports said Patnaik realized the difficulty in climbing 54 steps to the temple and stressed installation of a ropeway as has been done in various shrines of Uttar Pradesh and Uttarakhand.

Later, on the advice of the chief engineer, Lingaraj Associate, a private firm, conducted a survey for the project, March 1, 2016. The firm was advised to install a ropeway of 175 mtrs in length from the foothill on the west to the hilltop.

A preliminary estimate pegged the expenditure at ₹3 to ₹4 crore for installation of the ropeway. The survey report was submitted to the District Collector. Later, a detailed project report and a design were submitted to the state government.

However, the ropeway project never became a reality. Locals have demanded that Khandapara MLA Soumya Ranjan Patnaik and the state tourism department should take note of the issue and press for installation of a ropeway to the shrine before the state government.

Change of guard or change of heart?

The secretary-level reshuffle, in which nine Central ministries and departments got new secretaries, is being depicted as an opportunity for upward mobility for 1990-batch IAS officers who were waiting for secretary-level postings at the Centre for a long time. However, people are still trying to wrap their heads around some of these changes. One or two of them had been stowed away in cold storage but, clearly, circumstances have changed at the Centre and in multiple states and, therefore, a change of guard was felt necessary.

Among those who surprised the conventional babu expectations was Vini Mahajan, the former Chief Secretary of Punjab, who has been named as Secretary of the Department of Drinking Water and Sanitation. In 2020, Mahajan was appointed by then Punjab CM Amarinder Singh as the state Chief Secretary but had stepped down from the post in September this year after Amarinder's government was toppled. But since he has joined hands with the BJP, Mahajan has been're-adjusted'. It is likely that her husband Dinkar Gupta, who was removed as Director-General of Police of Punjab by the current state Chief Minister Charanjit Singh Channi, may soon be brought to Delhi in a senior capacity with one of the paramilitary organisations.

Equally of interest is the appointment of Indian Forest Service (IFoS) officer Bharat Lal as the next Secretary of the Lokpal Secretariat. Many expected Lal to become Secretary of the Department of Drinking Water and Sanitation (which has now gone to Mahajan) on the assumption that he had worked as additional secretary in the department and overseen the completion of some prestigious drinking water pipelines projects.

Now bureaucrats are wondering whether this is a change of guard or a change of heart and what the next moves will be.

CALL THE DEMOGRAPHIC TRANSITION



Within the space of just a few generations, humanity has created the material conditions for establishing the kind of society that our ancestors could hardly imagine. But everything now depends on whether we can figure out the politics of wealth distribution

scientists call the demographic transition: a shift from high to low birth and death rates, owing to economic development and technological advances. Malthusian population pressure no longer keeps us poor. Our productivity vastly exceeds that of all previous generations, and it continues to grow. In the next two generations, we will achieve as much proportional growth in our technological powers as our forebears in 1870 had since the great migration out of Africa 50,000 years earlier.

In many parts of the world, there already is enough wealth to ensure that nobody is hungry, unsheltered, or vulnerable to many of the health threats that used to shorten most lives. There is enough information and entertainment that nobody need be bored. There are enough resources to allow everyone to create or pursue whatever his or her calling may be. True, there will never be enough prestige to satisfy everyone; but if we are willing to settle for universal basic dignity, there is no longer any material reason why we should have a society where peo-

ple feel disrespected. Why, then, do things seem to be going badly wrong? First, the world has failed to build governance institutions that can manage global problems like climate change. That challenge could have been han-

dled at very low cost a generation ago. Now, averting a disaster and adapting to the change that is already here will entail much, much larger upfront costs. And to what end? Merely to preserve for a few years longer the wealth of fossilfuel robber barons?

Second, the world's unprecedented wealth is absurdly, appallingly, criminally maldistributed. The bottom billion people may have smartphones and some access to health care, but in many ways, they are not much better off than our pre-industrial Malthusian ancestors. It has been 75 years since US President Harry Truman wisely added global eco nomic development to the Global North's agenda. Though he would be happy to see that the Global South is much, much richer now than it was in 1945, he would be tremendously disappointed to find

that the proportional gap between rich and developing countries is as large as ever.

Even developed countries like the United States are apparently incapable of properly distributing the enormous wealth that has been created by modern post-industrial economies. The past four decades have given the lie to the neoliberal claim that a more unequal society would release immense entrepreneurial energies, lifting all boats. Yet policies to accord well-being, utility, and dignity to all people have consistently been blocked.

One major hurdle is the idea that some of society's non-rich deserve not more but even less. This view has long been applied to Hispanics and African-Americans in the US, Muslims in India, Turks in Britain, and all those who have ever run afoul of blood-and-soil nationalism. Many now seem to believe that the Enlightenment vision of human equality was wrong and should be replaced with the Aristotelian principle that it is unjust to treat non-equals equally.

Another hurdle is economic. It was long assumed that technology, capital, and labor would always ultimately function as complements, because every machine and information-processing task would still need to be supervised by a human. But our informationprocessing technologies have been outpacing our educational system, and the hope for harmonious complementarity has become a pipe dream.

Climate change, nationalism, and the challenges associated with new technologies are just a few of the big problems humanity will be facing in the post-pandemic decades. In his first inaugural address, Franklin D. Roosevelt referenced Proverbs 29:18: "Where there is no vision, the people perthere is no vision, the people pertish..." Unless and until such a vision for our own time emerges, the people will see only gloom ahead.

Cash on the nail

he story says that merchants paid their debts by putting their money on a nail. So pay on the nail or cash on the nail came to mean settling a debt promptly. The nails were erected in Bristol from about 1550 to 1631. They were originally elsewhere but were moved to their present site after the Corn Exchange was built in the 1740s. Although the story seems to have been captured by Bristol, nails have also been recorded in the Stock Exchanges in Liverpool and Limerick. The latter dates from 1685 and was described by the blind Irish playwright John O'Keeffe in his Recollections of 1826: "In the centre of Limerick Exchange is a pillar with a circular plate of copper about three feet in diameter, called The Nail, on which the earnest of all stock-exchange bargains has to be paid." At one time, merchants did transact their business on them as a public way of demonstrating that they were making a deal. The Tome Stone in Barnstaple once served a similar purpose. All this might seem to confirm the truth of the story. However, the popular link of the various nails with the expression seems to have begun only with an entry by Dr E Cobham Brewer in the first edition of his Dictionary of Phrase and Fable, in 1870. The expression on the nail, on the spot, at once, without delay, is first recorded in print in 1596. This predates most of the known nails. This isn't definitive, because they might have replaced others of earlier date. But the reference by John O'Keeffe is the first record of the name, a surprisingly late one if they were known by that name before 1596. The phrase ad ungulum, "on the nail" - to a nicety, to perfection or to the utmost - is in the Satires of the Roman poet Horace 2000 years ago and is based on an even older Greek expression. This may be from the idea of a sculptor having created a carving so perfect that running a fingernail over it couldn't detect any unevenness, or from a joiner testing the accuracy of a joint. This is likely to have been the inspiration for the Anglo-Norman phrase, albeit with a shift in sense from "to the utmost" to "completely; in full".

THE GOVERNMENT MUST CHANGE GEARS IN 2022. IT SHOULD CONSIDER WAYS OF INCREASING DEMAND IN THE ECONOMY

ndia has become the fastest growing economy in the world. Yet domestic demand is weak. The government may consider two policies in order to stimulate domestic consumption. First is a supply side policy; and second, a demand side policy. The government can try to reduce the price of goods in the market to stimulate demand in the supply side policy. Let us say the supply of potatoes in the market declines. Then the consumers will buy more potatoes and less of other vegetables. This will lead to an increase in demand of potatoes. Increased supply will be followed by increased demand. The balance between supply and demand will be reached at a lower price. The government can try to increase the demand for goods in the market and directly stimulate demand in the demand side policy. If the demand for potatoes increases then the price will increase and the farmers will bring in more quantity of potatoes. Increased demand will be followed by increased supply. Again a balance will be reached but, now, at a higher price. Increase in consumption is obtained in both the policies.

The government has adopted the supply side policy. The Reserve Bank of India has made available loan to commercial banks at low rates of interest so that they can lend at low rates of interest. Thinking is that low rates of interest will lead to lower cost of production and increase consumption just as cheap potatoes may stimulate more demand for potatoes. The government has implemented a "Production-Linked Incentive Scheme" (PLIS) wherein industries are provided with financial incentive to increase production. The thinking is that higher production would lead to lower production cost and stimulate demand.

The danger of this policy is that the demand may not actually be created. For example, few years ago farmers of Palanpur in Gujarat had dumped their potatoes on the streets because there were no buyers for potatoes even at ₹3 per kg. The result is that low price of a product does not ensure that it will lead to rise in demand. On the other hand, a demand side approach is more solid. For example, the supply of face masks has

d increased dramatically after the Covid pandemic without low interest rates and PLIS incentives. Producers have found one way or the other to produce the goods since the demand is high. The difference between the "supply side" and "demand side" approaches is that the supply side approach remains uncertain because it may or may not lead to creation of demand, whereas the "demand side" approach is more assured because producers find one way or the other to produce the goods.

The government must change gears in 2022. It should consider ways of increasing demand in the economy. Needless to say, the basic objective of the economy is to increase domestic consumption. The welfare of the people is obtained directly if consumption is increased. It is of no use if the farmers produce more sugarcane, the industries produce more sugar and it is exported for consumption abroad. Two policies may be considered to increase demand. One, the entire government bureaucracy is today acting as middlemen between the government and the recipient. The government should remove these middlemen from the welfare system and provide the money directly to the people just as the government is determined to remove the middlemen from the farmer's mandis. People will be able to purchase the goods from the market with the direct cash transfers and this will stimulate demand in the market. The second policy is to stem the outflow of our own capital. Anecdotal reports indicate that high net worth individuals from India are emigrating in large numbers. Many Indian businessmen are establishing factories in Vietnam or other countries, producing goods there and then importing them into India. In the present times, businessmen are afraid of investing in India. So the government should prepare a study of the reasons for the outflow of Indian capital. My feeling is that the social tension is a major deterrent. The government must make investment attractive within the country.

SCBA writes to CJI, expresses anguish

New Delhi, Dec 7: The Supreme Court Bar Association (SCBA) has written to Chief Justice of India NV Ramana expressing anguish at the non-consideration of names of its members for elevation as judges in various high courts.

SCBA president Vikas Singh in his letter addressed to the chief justice and the four senior-most judges of the apex court on January 6 said that it had constituted a search committee which identified 48 names for consideration for elevation in various high courts (HCs).

The names were handed over to the Chief Justice of India (CJI) several months back. However, none of the names suggested by the committee have been considered by any of the high court collegiums despite having a large number of vacancies in HCs, it said.

"The entire exercise was also to bring more transparency in the exercise of appointment to the higher judiciary which is repeatedly being alleged to be under a cloak of secrecy," it was claimed in the letter.

India hails promise to avoid nuclear weapons

In a rare joint statement, the five key nuclear-armed nations Monday said that a nuclear war cannot be won and must never be fought while vowing to prevent the spread of atomic weapons

New Delhi, Jan 7: India Friday welcomed a joint pledge by the US, the UK, China, Russia and France to prevent the spread of atomic weapons and reaffirmed its nuclear doctrine of maintaining a credible minimum deterrence based on a 'no first use' policy and commitment to universal nuclear disarmament. In a rare joint statement, the

five key nuclear-armed nations Monday said that a nuclear war cannot be won and must never be fought while vowing to prevent the spread of atomic weapons.

Arindam Bagchi, the spokesperson in the Ministry of External Affairs (MEA) said that as a responsible nuclear weapon state, India has a doctrine of maintaining a credible minimum deterrence based on a 'no first use' posture and non-use of nuclear weapons against non-nuclear weapon states.

He said India remains committed to the goal of universal, non-discriminatory and verifiable nuclear disarmament. "We welcome the Joint Statement this week, which reaffirms the importance of addressing nuclear threats, and underscores the desire to work towards creating a security environment more conducive to progress on disarmament with the ultimate goal of a world without nuclear weapons with undiminished security for all." he said.

Bagchi was responding to a media query on the joint statement. In the statement, the five world powers underlined their desire to work with all states to create a security environment conducive to progress on disarmament with the ultimate goal of a world without nuclear weapons with "undiminished" se curity for all. "We intend to continue seeking bilateral and multilateral diplomatic approaches to avoid military confrontations, strengthen stability and predictability, increase mutual understanding and confidence, and prevent an arms race that would benefit none and endanger all," the joint statement had said.

In his comments, Bagchi said India's annual resolution at the UN General Assembly (UNGA) on 'Reducing Nuclear Danger' calls for steps to reduce the risk of unintentional or accidental use of nuclear weapons, including through "dealerting and de-targeting" of nuclear weapons.

"Our annual resolution on a 'Convention on the Prohibition of the use of Nuclear Weapons' seeks the commencement of negotiations in the Conference on Disarmament on an international convention prohibiting the use or threat of use of nuclear weapons under any circumstances," he said. "Both resolutions are adopted

with substantive support at the UNGA. India will continue to contribute further to the global nuclear disarmament and non-proliferation agenda." he added



said.

This is the second consecutive incident wherein a large number of passengers coming from Italy to Amritsar airport have tested positive for coronavirus on arrival.

"This flight came from Rome. It landed at around 12.20 pm today at the airport," he added. The officials said there were total 285 pas sengers on the charter flight that landed on Friday.

District health authority offi cials said all 173 passengers, who were found positive, were being sent for institutional quarantine at their respective home town districts. According to the rules of the Union Health Ministry, passengers coming from "at risk" countries to India have to compulsorily get tested for COVID-19 on arrival at the airport.

Covid mortality 6-7 times higher than official figure: Study

New Delhi, Jan 7: About 3.2 million people could have died from Covid in India by September last vear. six-seven times higher than reported officially, according to a study based on one independent and two government data sources.

The research, published in the journal Science on Thursday, used an independent nationally representative survey of 137,289 adults in all states and union territories interviewed from March 2020 to July 2021

An international team of researchers led by Prabhat Jha, a professor at the University of

Toronto in Canada, found that COVID-19 constituted 29 per cent of deaths from June 2020 to July 2021, corresponding to 3.2 million (32 lakh) deaths, of which 2.7 million (27 lakh) occurred in April-July 2021.

A sub-survey of 57,000 adults showed similar increases in mortality with COVID-19 and non-COVID-19 deaths peaking similarly, they said. Two government data sources found that, when compared to pre-pandemic periods, allcause mortality - or death from any cause -- was 27 per cent higher in 0.2 million health facilities and 26 per cent higher in civil regis-

tration deaths in 10 states, the re-



searchers said. Both increases occurred mostly in 2021, according to the study. "The analyses find that India's cumulative COVID deaths by

September 2021 were 6-7 times higher than reported officially,' the authors of the study said.

The researchers noted that India's reported COVID-19 death

totals are widely believed to be under-reported because of factors like incomplete certification of COVID deaths and misattribution to chronic diseases

The first study is mortality reported in a nationally representative telephone survey conducted by CVoter, an independent, private polling agency.

In addition, the researchers studied the Government of India's administrative data on national facility-based deaths and civil registration system (CRS) deaths in 10 As of January 1, 2022, states. India has reported over 35 million cases of SARS-CoV-2, second only to the US, while its official cumu-

lative Covid death count stands at 0.48 million (4.8 lakh).

"If our findings are confirmed, this may require substantial upward revision of the World Health Organization's estimates of cumulative global COVID mortality, which as of January 1, 2022, stood at 5.4 million," the authors said.

The researchers said modelbased estimates of cumulative COVID deaths through June 2021 in India range from a few hundred thousand to over four million, with most suggesting a substantial official undercount. In order to better estimate India's COVID deaths, alternative approaches to model-based estimates are needed, they said.

Public holiday not fundamental right, it's time to reduce them: Bombay HC

The court made the observation while rejecting a plea seeking directions to declare August 2 a public holiday to celebrate the Liberation Day of the Dadra and Nagar Haveli

Mumbai, Jan 7: The Bombay High Court recently held that there is "no legally enforceable fundamental right to a public holiday and whether or not to declare a particular day as a public holiday or optional holiday is a matter of government policy." It also observed that since there are "too many public holidays in the country, the time has come to reduce and not to increase them.'

The court made these observations while rejecting a plea seeking directions to the Administrator of Dadra and Nagar Haveli to declare August 2 as a public holiday to celebrate the Liberation Day of the Union territory

A division bench of Justice Gautam S Patel and Madhav J Jamdar was Wednesday hearing the plea by Kishnabhai Nathubhai Ghutia who, pending hearing and final disposal of his writ petition. sought an order directing the respondent authorities to issue a notification declaring August 2 as

public holiday from this year. Appearing for the petitioner, advocates Bhavesh Parmar, Devmani Shukla, Rajesh Sahani and Reshma Nair told the court that August 2. 1954 the Union Territories of Dadra and Nagar Haveli gained "Liberation/Independence" from Portuguese rule and became part



of the territory of India.


"From 1954 to 2020, 2nd August was permitted as a public holiday on account of Liberation or Independence. This was discontinued on 29th July, 2021," the petitioner claimed. It was further argued that if August 15 can be declared as a public holiday to mark the nation's Independence Day, there is no reason why August 2 should not be declared a public holiday for Dadra & Nagar Haveli.

The petitioner further referred to an order of another bench of the high court passed April 15, 2019 pertaining to the concerned Union Territory, wherein 'Good Friday' was listed as a restricted (optional) holiday but not a gazetted holiday. As per the said order, the argument was made that taking into

Christians in the area; it was decided not to declare Good Friday as a gazetted holiday. However, observing that Christmas and similar holidays are widely celebrated, the coordinate bench had disposed

of the PIL by directing the administrator to declare Good Friday as a gazetted holiday in the Union territories of Diu, Daman, Dadra and Nagar Haveli. However, the bench led by Justice Patel observed, "That order stands on a different footing from the pres-


THE COURT ASKED NIA HOW THE 83-YEAR-OLD POET-ACTIVIST **CAN BE SENT TO JAIL AMID COVID-19 SURGE**

Mumbai, Jan 7: The Bombay High Court on Friday extended till February 5, the date of surrender for poet Varavara Rao, an accused in the Elgar Parishad-Maoist links case who is currently on medical bail, before Taloja prison authorities in Maharashtra.

A bench of Justices SS Shinde and NR Borkar dismissed the National Investigating Agency's (NIA) request for extending such date of surrender only by a week. The bench said in view of the rising cases of coronavirus across the state it would not be wise to send the 83-year-old poet-activist back to prison. Rao, who was lodged in the Taloja prison in Navi Mumbai as an undertrial, was granted temporary medical bail for six months in February 2021 by another bench of the HC that was led by Justice Shinde. He was admitted to the private Nanavati Hospital in Mumbai at the time for treatment of multiple ailments. His date of surrender was scheduled for September 5, 2021, but Rao filed a new application through advocate R Sathyanarayanan and senior counsel Anand Grover seeking an extension of medical bail.

The date of Rao's surrender has been extended since then by the HC on several accounts, including further time sought by the NIA, which is investigating the case, for filing



replies to the new application and getting the octogenarian medically examined again, among others. The NIA, however, has been opposing extension of Rao's medical bail, saying his treatment at Nanavati Hospital is now complete and as per doctors there, he does not need continued medical care at the private hospital currently.

Friday, NIA counsel Sandesh Patil told the HC that Additional Solicitor General Anil Singh had not been briefed in the matter and sought a week's time to complete the process. He urged the HC to grant the next date of hearing in a week's time. The bench, however, said there was no point posting the matter for hearing next week and extending Rao's date of surrender only till then, considering the coronavirus pandemic.

"Mr Patil, there is no point in keeping (the plea for hearing) next week. Experts say third wave (of coronavirus) may last for 50 to 60 days. This time, the police, health workers are testing positive very rapidly. The situation wasn't as bad the last time. So in such a situation, is it proper to send him (Rao) back to jail?" the judges asked. "Of course, we are aware of the seriousness of allegations (against Rao), and the point of law involved. We will hear you (all parties) on the next date on merits," the bench said. Grover then told the HC that considering Rao's health condition, his old age and chronic ailments, the Telegu poet had also filed a fresh application before the HC seeking "permanent bail on health grounds.'

Mumbai, Jan 7: In a bid to bring its tax structure at par with competing states and secure its revenues, the Maharashtra government is mulling to waive the stamp duty on the import of gold and silver in the state.

While Maharashtra levies a 0.1 per cent stamp duty on gold imported by air, sources said that the import of gold has been shifting to other states, as they don't impose stamp duty. As this arbitrage resulted in decline of gold imports within the state, sources said that

UP CM slashes power tariff for farmers by 50%

the government has been losing hundreds of crores in goods and services tax (GST) on import of gold. They further said that the waiver of stamp duty on gold could increase state revenue.

The India Bullion and Jewellers Association, in its representation to the state government last May, had said that due to levying of stamp duty of gold, the import is getting shifted to the neighbouring state and Maharashtra is losing revenue. India imports nearly 800 tonne of gold, which is equivalent to almost ₹4 lakh crore, every

year by air.

Lucknow, Jan 7: The Yogi Adityanath government in Uttar Pradesh has announced a 50 per cent reduction in power tariff on agricultural use.

The move is apparently aimed at assuaging the feelings of farmers ahead of the state elections.

According to the government spokesman, the decision will directly benefit over 13 lakh users in rural and semi-rural areas.

The order, announced by the Chief Minister's office, divided the targeted consumers into four categories - metered, unmetered, energy efficient pumps and farmers in the urban areas receiving metered power supply.

On metered connections for pumps in rural areas, farmers would be required to pay only Re 1 per unit instead of the existing ₹2 per unit. The fixed charge of ₹70 per horsepower (HP) too has been reduced to ₹35 per HP.



Likewise, in case of unmetered connection, the fixed charge has been reduced from ₹170 per HP to ₹85 per HP.

been slashed from ₹70 per HP to ₹35 per HP. In case of farmers receiving metered power supply in the urban areas, the electricity rate has been reduced from ₹6 per unit to ₹3 per unit. The fixed charge has also been brought down from ₹130 to ₹65 per HP.

The Chief Minister's office said the decision has been taken keeping in view the 'convenience and prosperity' of the farmers. The sop will come into effect immediately, a government spokesperson said.

New Delhi, Jan 7: Underlining the challenge posed by a rising number of COVID-19 cases across the country, with a focus on Omicron, the Centre Friday emphasised that it is the primary responsibility of the states to ensure that all the oxygen equipment at all the health facilities are tested and kept in a functional state to meet any emer-

gency situation. Union Health Secretary Rajesh Bhushan chaired a high-level meeting with representatives from the states and Union territories through a video-conference on Fridav to review the preparedness status of the entire spectrum of oxygen equipment, including ventilators, PSA and oxygen plants, oxygen concentrators and oxygen cylinders, for a timely and effective management of the COVID-19 pandemic, according to a statement issued by the health ministry.

The states were urged to ensure full and optimal utilisation of the ECRP-II funds through daily reviews and to upload the expenditure on the dedicated NHM-PMS portal so that they are eligible to receive further funds to strengthen the healthcare facilities up to the sub-district level

Under ECRP-II, funds are also made available for installing liquid medical oxygen (LMO) tanks and medical gas pipeline systems (MGPS). The states are required to make these facilities operational and secure an approval from the Petroleum and Explosives Safety Organisation (PESO) in respect of the LMO tanks, the statement said.

Bhushan urged the states to commission the PSA plants being set up from the states' funds and CSR funds on a war-footing. The states

3 MILITANTS KILLED IN ENCOUNTER

Srinagar, Jan 7: Three terrorists were killed and one army officer was injured in an encounter with security forces at Zolwa Kralpora Chadoora in central Kashmir's Budgam district, officials said Friday.

The police said that based on specific inputs regarding the presence of terrorists in Zolwa Chadoora village area of Budgam, a joint cordon and search operation was launched on Thursday evening by the police and the army. During the search operation, the terrorists fired indiscriminately upon the joint search party, which was retaliated leading to an encounter. Later on, the CRPF also joined the

operation. "The joint team first evacuated all the civilians trapped around the encounter site to safer places. Besides, to avoid any collateral damage due to darkness, the operation was suspended during night hours and in the wee hours it resumed again, resulting in the elimination of three terrorists linked with proscribed terror outfit Jaishe-Mohammed. During the encounter, one army officer received minor splinter injury," the police said.



Unprecedented rush seen for marriages in Hyderabad

Hyderabad, Jan 7: The Central government's move of raising the legal age of marriage for women from 18 to 21 years has led to an unprecedented rush for marriages in the Muslim community in Hyderabad and other towns of Telangana.

Hundreds of marriages are being solemnised in the state every day due to the panic which has set in ever since the Child Marriage Amendment Bill 2021 was tabled in Parliament last month.

Though the Bill was referred to the Select Committee following objections raised by the opposition parties, the fears of the Bill getting Parliament's approval in the next session of Parliament are driving parents to advance the marriages originally fixed for later this year or next year

Fearing that the legislation will

delay the marriages of their daughters by three years, parents are convincing the parents of bridegrooms to advance the marriages. In many cases, only the legal formalities are being completed with both sides agreeing to have reception, Valima and other rituals as per the original schedule.

Several qazis are performing 10-20 nikah each every day. Nikahs are not just being solemnised in mosques and function halls but also at homes. Qazis, who are appointed by the State Waqf Board, are seen rushing from one place to other to complete the legal for-

malities. Nikahs are usually held in mosques in the evenings but due to the huge demand nikahs are also being performed in the afternoon. On normal days, mosques see one to two nikahs each every day but now this number has gone up to eight-ten.



elements are cashing on the situation by offering anxious parents to help them complete the formalities and documentation.

Appeals by Muslim leaders and organisations to parents not to panic are apparently not having much impact. The parents fear that if the Bill is passed they not only have to wait for a couple of more years but may even lead to cancellation.

The situation has forced Telangana State Waqf Board to step in. Its chairman Mohammed Saleem held a meeting with Qazis and advises them to help allay the apprehensions among parents.

"I have urged Qazis to counsel both sides not to panic as the Bill has not yet passed and the legal age of marriage for women continues to be 18. We are appealing to parents not to take wrong decisions in a hurry." said Saleem.

A leader of Telangana Rashtra Samithi (TRS), Saleem hopes that the Bill will not be passed as several parties were against the move to enhance the legal age of marriage of women. He claimed that 90 per cent of parents in all the communities marry off their daughters at the age of 18-20 and only 10 per cent give them higher education. The Waqf Board chairman said likely to be passed early. He pointed out that the Bill has already been referred to the Select Committee. The panel will have consultation with members of different parties and this process itself will take a few months.

He said TRS and other parties would oppose the Bill in Parliament. Since the Bill has to be passed by both the houses and the President has to give his assent to make it a law, he believes that the entire process may take two years.

United Muslim Forum, an apex body of various Muslim socio-religious organisations, has also appealed to the community not to rush through the marriages as the Bill has still not passed by Parliament. The Bill has already drawn flak from several Muslim groups, who see this as an interference in Muslim Personal Law.-They say Islam permit marriage of a girl once she attains puberty.




Oscar winner and groundbreaking star **Sidney Poitier dies**

Warsaw, Jan 7: Poland's most powerful politician has acknowledged that the country bought advanced spyware from the Israeli surveillance software maker NSO Group, but denied that it was being used to target his political opponents.

Jaroslaw Kaczynski, the leader of Poland's ruling conservative party, Law and Justice, said in an interview that the secret services in many countries are using the Pegasus software to combat crime and corruption

Kaczynski said the use of such spyware arose in response to the growing use of encryption to mask data in transit, which defeated earlier monitoring technologies. By hacking phones, it lets au-

thorities monitor communications, as well as real-time conversations where they are not encrypted.

"It would be bad if the Polish services did not have this type of tool," Kaczynski said in an interview to be published in the Monday

The interview follows exclusive reports by The Associated Press that Citizen Lab, a cyber watchdog group at the University of Toronto, found that three Polish government critics were hacked with NSO's Pegasus.

On Thursday, Amnesty International independently verified Citizen Lab's finding that Sen. Krzysztof Brejza was hacked multiple times in 2019 when he was running the opposition's parliamentary election campaign. Text messages stolen from

Brejza's phone were doctored and aired by state-controlled TV in Poland as part of a smear cam-

The hacking revelations have rocked Poland, drawing comparisons to the 1970s Watergate scandal in the US and eliciting calls for a probe commission in Parliament

paign in the heat of the race, which the populist ruling party went on to narrowly win.

Brejza now maintains that the election was unfair since the ruling party would have had access to his campaign's tactical thinking and plans.

Kaczynski said he saw no reason to set up such a commission, and he denied that the surveillance played any role in the outcome of the 2019 election.

"There is nothing here, no fact, except the hysteria of the opposition. There is no Pegasus case, no surveillance," Kaczynski said in a statement

Colombo, Jan 7: Sri Lanka could face shortage of fuel by the third week of January, Energy Minister Udaya Gammanpila warned Friday, as he urged the Central Bank to step in and pump in foreign currency required for imports.

Gammanpila's grim warning comes close on the heels of the Ceylon Electricity Board issuing a statement, asking citizens to brace for power cuts in the days to come due to its inability to purchase fuel.

The Sri Lankan government Tuesday had announced a \$1.2 billion economic relief package amidst a severe foreign exchange crisis grappling the island nation. At the beginning of December last year, the forex reserves were sufficient for just a month of imports.

However, last week, the Central Bank of Sri Lanka announced that the country's foreign exchange reserves had doubled in the span of just one month, and touched \$ 3.1 billion. According to sources, the forex reserve boost was buoyed by

Troops deployed at UK hosps due to Covid-hit staff shortages

London, Jan 7: The UK's Armed Forces have sent 200 personnel into National Health Service (NHS) hospitals across London as major incidents were declared on Friday due to staff shortages as a result of a continued surge

in Covid-19 cases The UK's Ministry of Defence (MoD) said it will provide 40 defence medics and 160 general duty personnel for the next three weeks to assist with the crisis. These military medics will assist NHS doctors and nurses with patient care, while general duty personnel will help fill gaps caused by other absences as the UK's daily Covid infections maintained a high trend at 179,756,

Armed Forces are once again stepping up to support their dedicated colleagues in the NHS, as they work hand-in-hand to protect the nation from Covid-19," said UK Defence Secretary Ben Wallace.

Across the UK, about 1,800 armed forces personnel are supporting the NHS response to the pandemic. The MoD said that more than 1,000 servicemen and women have also already been made available to support the vaccine booster programme, including 730 in England, 221 in Scotland and 98 in Wales. New Delhi, Jan 7: The Indian economy remains on track to regain its position as the world's fastestgrowing major economy after official estimates Friday put the GDP expansion at a tempered 9.2 per cent this fiscal amid concerns over the impact of a resurgent virus on the fragile recovery.

The growth in the gross domestic product (GDP) of 9.2 per cent in April 2021 to March 2022 fiscal (FY 2021-22) given by the National Statistical Office (NSO) in its first advance estimate compares with 9.5 per cent expansion forecast by the Reserve Bank of India (RBI) last month.

With 9.2 per cent growth in 2021-22 fiscal, the economy will surpass the pre-Covid level in actual terms, mainly on account of improved performance by farm, mining and manufacturing sectors.

"Real GDP or GDP (gross domestic product) at Constant Prices (2011-12) in the year 2021-22 is estimated at ₹147.54 lakh crore. as against the Provisional Estimate of GDP for the year 2020-21 of ₹135.13 lakh crore, released on May

The pandemic hit the country in March 2020, resulting in a nationwide lockdown from March 25. 2020, which severely dented the economic growth in the 2020-21 fiscal.

According to the statement, real GVA (gross value added) at Basic Prices is estimated at ₹135.22 lakh crore in 2021-22, as against ₹124.53 lakh crore in 2020-21, showing a growth of 8.6 per cent.

The NSO estimates significant growth in 'mining and quarrying' (14.3 per cent), and 'trade, hotels transport, communication and services related to broadcasting (11.9 per cent).

Morgan Stanley in a January 4 report had said India's growth trend has faced various exogenous shocks in the last eight years, leading to a weaker than expected growth trend, especially as measured by corporate revenue growth. Over the medium term, India will likely to be one of the few countries to offer high productive growth, it had said

Mumbai, Jan 7: Largest software exporter TCS Friday bagged the second phase of the Passport Seva Programme (PSP), after an over decade-long work in the first phase which has witnessed rapid strides in citizens availing the services.

The second phase of the PSP which is already the largest missioncritical e-governance programme in India, will last nine-and-a-half years and see the company deploy the latest technologies to further ease services. TCS will also introduce the much-awaited e-passport. a senior company official said.

"We will bring in the technology (for e-passport), but you know the sovereign functions like granting or printing of the passport booklet will continue with the government," Tej Bhatla, business unit head for public sector at TCS, told PTI.

He explained that it will not be a completely paper-free document as work like visa stamping will continue, but will definitely reduce the need for paper through automation wherever possible.

The passport jacket will contain an electronic chip which will have important security-related data encoded on it, he said, adding that while some countries do have such passports already and others are working on it, India will be among the leaders in introducing such a system. When asked about the timelines by which the e-passport will be introduced. Bhatla said the

The telecom sector got a shot in the arm with the government last year approving a blockbuster relief package that includes a four-year break for companies from paying statutory dues, permission to share scarce airwaves, change in the definition of revenue on which levies are paid and 100 per cent foreign investment through the automatic

The reforms measures, aimed at providing relief to telecom serv-

ice providers such as Vodafone Idea that have to pay thousands of crores in unprovisioned past statutory dues, also included the scrapping of Spectrum Usage Charge (SUC) for airwaves acquired in future spectrum auctions.

In October 2021, Bharti Airtel said it will opt for a four-year payments moratorium -- on AGR and spectrum dues -- being offered by the government as part of a relief package for the telecom sector.

Bharti Airtel Group's AGR dues is pegged at ₹43,980 crore, and the company has made payment of ₹18,004 crore, so far.

E2W sales iump 132% in 2021

New Delhi: Electric twowheeler (E2W) sales in India increased by 132 per cent in 2021 on a vear-on-vear basis. said the Society of Manufacturers of Electric Vehicles (SMEV). Total sales of E2W, including high-speed and low-speed ones, during the period under review rose to 233.971 E2W as against 100,736 units sold in 2020. The industry body pointed out that customers have now started to shift in large numbers from petrol two-wheelers to electric ones due to attractive prices, lower running costs. and lower maintenance.

Citi to terminate uniabbed staffers

New York: Citigroup Inc Friday told its staff that it would terminate employees who are unvaccinated as of Jan 14, enforcing a policy previously announced last year, according to a source familiar with the matter. Citigroup said in October it would require US employees to be vaccinated against Covid-19 as a condition of their employment.



The Petroleum and Natural Gas Regulatory Board Friday set a deadline of April 6 to submit bids for city gas distribution (CGD) authorisation for areas offered in the states of Bihar, Jharkhand, West Bengal, Uttar Pradesh and Chhattisgarh. The board has so far awarded

CGD licences for some areas of 27 states and union territories covering 70 per cent of India's population, and is in the process of finalising winners for its previous round, in which 26 entities had submitted bids for 61 geographical areas.

After bids in the latest rounds are finalised, about 88 per cent of the country's area will be authorised for the development of the CGD Network, providing access to natural gas to about 98 per cent of India's population, the board said in the statement.

CCI orders probe against Google

New Delhi, Jan 7: India's competition watchdog Friday ordered an investigation into Alphabet Inc's Google following allegations from news publishers, saving its initial view was that the tech giant had broken some antitrust laws

In its order, the Competition Commission of India (CCI) said Google dominates certain online search services in the country and may have imposed unfair conditions on news publishers.

The complainant, Digital News Publishers Association, which comprises the digital arms of some of India's biggest media companies. said Google denied fair advertising revenue to its members. "In a well-functioning democ-

racy, the critical role played by news media cannot be undermined." the CCI order said. "It appears that Google is using its dominant position in the relevant markets to enter/protect its position in the market for news aggregation service.'

News organisations, which have been losing advertising revenue to online aggregators such as Google, have complained for years about tech companies using stories in search results or other features without payment.

The CCI order also mentioned new rules in France and Australia - fuelled by media lobbying and public pressure - that have led to licensing deals around the world collectively worth billions of dollars.

India to become hub for Covid drugs production: Fitch

New Delhi, Jan 7: India will become the largest global hub for Covid-19 antiviral general drug production after the drug controller granted emergency-use authorisation to several pharmaceutical companies in the country to manufacture and market generic versions of molnupiravir, Fitch Solutions said Friday.

Increased access to molnupiravir will keep hospitalisations and deaths in India to a manageable level as Omicron infections

rise, Fitch Solutions said in a report.

Lagevrio (Molnupiravir) was developed by Merck and Ridgeback Biotherapeutics, and it is the first ever oral antiviral drug for the treatment of high-risk adults with mild to moderate Covid-19.

Following the authorisation, Cipla, Sun Pharma, and Dr. Reddy's Laboratories are set to release molnupiravir capsules in the coming weeks, and the rest of the companies will follow.

On January 6, 2022, Covid-19 cases increased to 1,17,100 with 3,007 of these cases confirmed as the Omicron variant, according to the Union Ministry of Health.

Moreover, India continues to lag behind in its Covid-19 vaccine rollout target as 44.5 per cent of the population has been fully vaccinated. Fitch Solutions said quoting "Our World In Data". Therefore, given the slow vaccination and recent sharp rise in Covid-19 cases, generic versions of molnupiravir could significantly reduce risk of hospitalisation admission or deaths.

At stumps, Jack Leach (4 batting) was giving Bairstow company, with England trailing Australia by 158 runs.

Bairstow scored England's first century in their seventh innings this series against Australia. It was the headline performance Friday, when England had slumped to 36/4 by lunch before their middle order counterattacked to get back into the match on another rain-affected day at the Sydney Cricket Ground.

In clear pain after being struck on the thumb by a Pat Cummins delivery and with batting partners running out, Bairstow began attacking at nearly every ball and brought up a deserved century mo ments before stumps by slashing a Cummins delivery for four. His 138-ball hundred contained 12 boundaries and three sixes.

Bairstow celebrated his seventh Test century by running with arms aloft halfway toward the England team's dressing room, where his teammates had gathered to acknowledge a vital innings in the context of the match which had earlier looked to be slipping away.

England has already lost the five-match series with three straight losses, allowing Australia to retain the Ashes, but are determined to get something positive out of the tour.

Déjà vu at SCG

Sydney: England's Jonny Bairstow and Ben Stokes were subjected to abuse while heading into the dressing room during the tea break here with an Australian fan telling him to 'lose some weight'. Both Bairstow and Stokes stopped to confront the spectator as they climbed the steps to the pavilion, with the Yorkshireman firing some words back and describing the sledger as 'weak as p***'. In a video published by the 'Sydney Morning Herald', one spectator can be heard shouting: "Stokes, you're fat." Another then yells: "Take your jumper off, Bairstow. Lose some weight, Bairstow." Stokes didn't react to the abuse aimed at him but stopped at the top of the stairs when Bairstow decided to hit back. "Pal... that's right. Just turn around and walk away. Weak as p***," Bairstow retorted. Other spectators in the vicinity applauded the efforts of the two England batsmen. The police officers reportedly spoke to several men after the incident and they were directed to leave the stadium. It came 12 months after India's Mohammed Siraj was racially abused while fielding at the same stadium. Though Cricket Australia confirmed that Indian players were subjected to racial abuse, six men who were ejected from the stadium following Siraj's complaint were cleared.

Dubai, Jan 7: Slow over-rates in T20Is will invite stricter penalties now with the ICC Friday announcing that teams which fail to keep up with the schedule will end up with one fielder less outside the 30-yard circle for the remainder of the innings, starting this month.

The governing body also introduced an optional drinks interval midway through the innings in bilateral T20 inter-

and Player Support Personnel. The existing sanctions include demerit points and financial penalties on teams and their

captains. "The over rate regulations are captured in clause 13.8 of the playing conditions, which stipulate that a fielding side must be in position to bowl the first ball of the final over of the innings by the scheduled or rescheduled time for the end of the innings," the ICC stated.

"If they are not in such a position, one fewer fielder will be permitted outside of the 30-yard circle for the remaining overs of the innings.

Under normal regulations, five fielders are allowed outside the 30

yard circle after the first six overs. However, in case of the schedule not being kept up by the bowling side, "no more than four fielders shall be permitted outside the fielding restriction area...'

The bowler's end umpire will inform the captain of the fielding side, the batter and the other umpire of the "scheduled cessation time for the innings prior to the start of the innings, and of any rescheduled cessation time following any

subsequent interruption to

The change was recommended by the ICC Cricket Committee, which regularly discusses ways to improve the pace of play in all formats. after considering reports on the effectiveness of a sim-

ilar regulation that was included in the playing conditions for the Hundred com-

petition conducted by the ECB. In another change, an optional drinks break of two minutes and thirty seconds may be taken at the mid-point of each innings subject to agreement between Members at the start of each series.

The first men's match to be played under the new playing conditions will be the one-off tie between the West Indies and Ireland at the Sabina Park in Jamaica January 16.

The first T20I of the three-match series between South Africa and the West Indies in Centurion January 18 will be the first women's match played under the new playing conditions.

Johannesburg, Jan 7: India head coach Rahul Dravid has hinted at having a conversation with wicketkeeper batter Rishabh Pant over the timing of his shots, including the wild slog that led to his dismissal in the second innings of the lost second Test against South Africa here.

Speaking to media after India's seven-wicket defeat Thursday, Dravid said he would always want Pant to play positive cricket but at times, the shot selection can be different.

'We know Rishabh plays positively and he plays in a particular manner and that has got him a little bit of success. But of course there are times when we are going to have to have some sort of level of conversations around that." he said. "It is just little bit or may be selection of the time to play that (shot)," Dravid added at the virtual post-match press conference. Pant tried to smash Kagiso Rabada out of the ground on the third ball of his innings but ended up edging it to the wicketkeeper, drawing sharp criticism from all quarters. "No one is going to ever tell Rishabh (Pant) not to be a positive player or not to be an aggressive player but sometimes it is just the question of picking and choosing the time to do that," Dravid said when specifically asked whether he was upset with Pant's shot.

Djokovic spends religious day in detention

Melbourne, Jan 7: Regardless of who made an error on the visa or the vaccination waiver or whatever, the reality Friday for tennis No.1 Novak Diokovic was spending one of his important religious holidays in an Australian detention hotel working on his challenge against deportation.

Djokovic has been receiving calls from Serbia, including from his parents and the president, hoping to boost his spirits. A priest from the Holy Trinity Serbian Orthodox Church in Melbourne sought permission from immigration authorities to visit the nine-time Australian Open champion to cel-

ebrate the Orthodox Christmas. "Our Christmas is rich in many customs and it is so important that a priest visits him," the church's dean, Milorad Locard, told the Australian Broadcasting Corp. "The whole thing around this event is appalling. That he has to spend Christmas in detention. It is unthinkable.

Djokovic's supporters gathered outside the Park Hotel, used to house refugees and asylum seekers near downtown Melbourne. waving flags and banners.

They mixed with human rights advocates who were there more to highlight the plight of other longerterm people in detention, many who have long complained about their living conditions and exposure to the coronavirus in the pandemic.

A day after both the prime minister and the home affairs minister said it was the responsibility of the individual to have their visa documents in order, it seemed to dawn on people locally that whatever mistakes happened in the process, one of the highest-profile athletes

in the world was in detention. Djokovic flew to Australia confident he had everything he needed

to compete, given he had been approved by Victoria state government for a medical exemption. That same evidence didn't comply with the Australian government's regulations.

So, instead of preparing to defend his Australian Open title, and bid to win a men's-record 21st major title, he's preparing to go to the Federal Circuit Court on Monday to challenge his visa cancellation and deportation.

Attention is moving away from Djokovic's vaccination status — a touchy topic in a city where people spent so long in lockdown and were subject to harsh travel restrictions — and onto questions about how the ninetime Australian Open champion could have wound up in this situation.

Even some who have been critical of Djokovic in the past are now in his corner. "Look, I definitely believe in taking action, I got vaccinated because of others

and for my mums health, but how we are handling Novak's situation is bad, really bad," Nick Kyrgios, an Australian player and outspoken critic of some of Djokovic's opinions on vaccinations, posted on Twitter. "This is one of our great champions but at the end of the day, he is human. Do better.'

Jelena Djokovic posted on social media to thank her husband's supporters. "Thank you dear people, all around the world for using your voice to send love to my husband," she posted on Twitter: "Iam taking a deep breath to calm down and find gratitude (and understanding) in this moment for all that is happening."

Critics of the medical exemptions have said if there were no loopholes, then nobody would be in Djokovic's position right now. And while players have sympathized with Djokovic's situation, some have said getting vaccinated would have prevented the problems.
