New York: The industrial city of Rourkela in India is among the 15 winners, hailing from 13 nations, of a prestigious worldwide innovation competition, which recognised the cities for designing the boldest and most ambitious urban innovations to emerge from the global COVID-19 pandemic. Bloomberg Philanthropies Tuesday announced the 15 winning cities of the 2021-2022 Global Mayors Challenge, the fifth edition of the global innovation competition that supports and spreads cities' most promising ideas. "The yearlong competition launched in 2021 elevates the most promising urban innovations to emerge from the pandemic," said a press release issued by Bloomberg Philanthropies. As many as 631 cities from 99 countries participated in the competition.

Mann is the party's state unit chief. The party had received 21.59 lakh responses under its campaign to elect its CM face for the Assembly polls, party leaders said. Kejriwal said, "Out of 21.59 lakh votes received, many people included my name. I had earlier said that I am not in the race. We declared those votes (naming Kejriwal) as invalid. Out of the remaining, 93.3 per cent people named Sardar Bhagwant Mann's name"

NO STARVATION DEATHS IN ODISHA. STATE TELLS SC

New Delhi: Odisha has informed the Supreme Court that not a single death due to starvation was reported in the state. However, there are 1.429 malnourished children of below five years in all districts of the state. Odisha, in an affidavit following the apex court order of October 2021, submitted that the state has been taking numerous steps to prevent malnutrition. The state also submitted that it has been providing additional nutrients to malnourished children. Significantly, the SC Tuesday asked the Union government to consider framing a model community kitchen scheme to combat hunger.

The state government last year had discontinued the 'Ashirbad' scheme for children who lost their

parents to COVID-19, three and half months after its launch.

The package was meant for orphans and the beneficiaries were divided into three categories children who lost both the parents or one of earning parents or the breadwinner.

'The scheme covers children who lost their parent(s) on or after April 1, 2020. According to the W&CD department, children who lost parents after September 15, 2021 are no longer to be covered under the scheme due to the declining trend of the pandemic.

Giving state-wise details of children who lost their parent/s to Covid, the commission said the maximum number children is from Odisha (24,405) followed by Maharashtra (19,623), Gujarat (14,770), Tamil Nadu (11,014), UP (9,247), Andhra (8,760), MP (7,340).

Mumbai/New Delhi, Jan 18: Three Navy personnel were killed and 11 injured in an explosion onboard the Indian Naval Ship (INS) Ranvir at the Naval dockyard in Mumbai Tuesday, officials said.

The incident took place at 4.30 pm, they added. "In an unfortunate incident today at Naval Dockvard Mumbai, three naval personnel succumbed to injuries caused by an explosion in an in-

ternal compartment on-board INS Ranvir," the statement by the Indian Navy said.

The ship's crew responded immediately and brought the situation under control quickly, it added. "Three sailors have been killed and 11 injured due to the incident. The names (of the victims) will be made public after informing the families about the incident," an official said. As per the Navy's

statement, no major "material damage" was reported.

'INS Ranvir was on cross-coast operational deployment from the Eastern Naval Command since November 2021 and was due to return to the base port shortly," it said. A Board of Inquiry has been ordered to investigate the cause of the

incident, the statement said. Source said several onboard persons were injured in the tragic in-

cident. The fourth of the five Rajputclass destroyers, INS Ranvir was commissioned into the Indian Navy October 28, 1986.

On October 23, 2021, an incident of fire and flooding was reported onboard Indian Navy's destroyer INS Ranvijay. In that incident, four sailors suffered burn injuries and were treated at the naval hospital. INHS Kalvani, the Eastern Naval Command had said.

In 2019, fire onboard INS Sindhukesari, a Kilo-class submarine, destroyed critical components of the vessel. The fire took place in March that year when certain components were being fitted inside the vessel. In August 2013, a massive explosion onboard INS Sindhurakshak sank the vessel and killed 18 sailors. Two officerswere killed in a fire on INS Sindhuratna in 2014.

OUT OF THIS WORLD Rare black diamond 'The Enigma' to be auctioned



Dubai, Jan 18: Auction house Sotheby's Dubai has unveiled a diamond that's literally from out of this world.

Sotheby's calls the 555.55-carat black diamond — believed to have come from outer space — "The Enigma.

The rare gem was shown off Monday to journalists as part of a tour in Dubai and Los Angeles before it is due to be auctioned off in February in London. Sotheby's expects the diamond

to be sold for at least 5 million British pounds (USD 6.8 million). The auction house plans to accept



Sophie Stevens, a jewellery specialist at Sotheby's Dubai, told The Associated Press that the number five bears an important significance to the diamond, which has 55 facets as well.

'The shape of the diamond is based on the Middle-Eastern palm symbol of the Khamsa, which stands for strength and it stands for protection," she said. Khamsa in Arabic means five.

"So there's a nice theme of the number five running throughout the diamond, she added.

Stevens also said the black dia mond is likely from outer space.

With the carbonado diamonds. we believe that they were formed through extraterrestrial origins, with meteorites colliding with the Earth and either forming chemical vapor disposition or indeed coming from the meteorites themselves," she said.

Black diamonds, also known as carbonado, are extremely rare, and are found naturally only in Brazil and Central Africa.

HK to cull 2K hamsters as some test COVID+ve

Hong Kong, Jan 18: Hong Kong authorities said Tuesday that they will cull some 2,000 hamsters after several of the rodents tested positive for the virus at a pet store where an infected employee was working.

Officials said they would also stop the sale and import of the rodents in the city. The move came after the pet shop employee tested positive for the delta variant Monday. Several of the hamsters tested positive for the coronavirus as well.

Even though authorities acknowledged that there is "no evidence" that pets can transmit the coronavirus to humans, as a precautionary measure, customers who had purchased hamsters from the affected store after Jan 7 will be traced and must be subject to mandatory quarantine. They must also hand over their hamsters to authorities to be put down.

Authorities said that all pet stores selling hamsters in Hong Kong must cease operations and that around 2,000 of the small animals will be culled in a humane manner.

Customers who bought hamsters in Hong Kong from Dec 22 will also be subject to mandatory testing and are urged not to go into the community until their tests have returned negative. For now, authorities said they would not rule out transmission between human and animals

Twin tremors claim 26 in western Afghanistan

Kabul, Jan 18: The United Nations Tuesday raised the death toll from twin earthquakes in western Afghanistan the day before to 26, saying three villages of around 800 houses were flattened by the temblors.

TONGA: ALL HOUSES DESTROYED, THREE DEAD

Sydney/Wellington, Jan 18: All the homes on one of Tonga's small outer islands have been destroyed by a massive volcanic eruption and tsunami, with three people so far confirmed dead, the government said Tuesday in its first up date since the disaster struck.

With communications badly hampered by the severing of an undersea cable, information on the scale of the devastation after Saturday's eruption had so far mostly come from reconnaissance aircraft. But the office of Prime Minister Siaosi Sovaleni said in a statement that every home on Mango island, where around 50 people live, had been destroyed, only two houses remained on

Fonoifua, and Namuka island had suffered extensive damage.

Tonga's deputy head of mission in Australia, Curtis Tu'ihalangingie, earlier said pictures taken by the New Zealand Defence Force (NZDF) showed alarming scenes of a village destroyed on Mango and build-

ings missing on Atata island, which is closer to the volcano.

People panic, people run and get injuries. Possibly there will be more deaths and we just pray that is not the case, Tu'ihalangingie told Reuters.

Sovaleni's office said a 65-year-

old woman on Mango Island and a 49-year-old man on Nomuka Island had been killed, in addition to the British national whose body was found Monday. A number of injuries were also reported.

Tsunami waves reaching up to 15 metres hit the Ha'apia island group, where Mango is located, and the west coast of Tonga's main island, Tongatapu, the prime minister's office said. Residents were being moved to evacuation centres as 56 houses were destroyed or seriously damaged on that coast.

Atata and Mango are between about 50 and 70 km from the Hunga Tonga-Hunga Ha'apai volcano, which sent tsunami waves across the Pacific Ocean when it erupted with a blast heard 2,300 km (1,430 miles) away in New Zealand.

Jakarta, Jan 18: Indonesia's parliament has approved a bill to relocate the nation's capital from Jakarta to a jungled area of Kalimantan on Borneo island, the planning minister said Tuesday.

The new state capital law, which provides a legal framework for President Joko Widodo's ambitious \$32 billion mega project, stipulates how development of the capital will be funded and governed. 'The new capital has a central function and is a symbol of the identity of the nation, as well as a

new centre of economic gravity," planning minister, Suharso Monoarfa, told the Parliament after the bill was passed into law Tuesday.

Delhivery to raise **₹7,460cr via IPO**

New Delhi: Supply chain company Delhivery has received capital markets regulator Sebi's approval to raise ₹7,460 crore through an initial public offering (IPO). The IPO comprises fresh issuance of equity shares worth ₹5,000 crore and an offer for sale (OFS) component of ₹2,460 crore by existing shareholders, according to the draft red herring prospectus (DRHP). Under the OFS, investors Carlyle Group and SoftBank as well as Delhivery's cofounders will divest their shareholding in the logistics company. The company, which filed its preliminary IPO papers with Sebi in November, obtained its observations letter January 13, an update with the regulator showed Tuesday. In Sebi parlance, the issuance of an observations letter implies its go-ahead for the IPO.

Prices, however, started to rise fore crucial elections.

There was a 19-day price freeze on petrol and diesel ahead of Karnataka polls in May 2018, despite international fuel prices going up by nearly USD 5 per barrel. However, no sooner were the elections over, oil companies rapidly passed on to customers the desired increase

 over 16-straight days post-May 14, 2018. Petrol price climbed by ₹3.8 per litre and diesel by ₹3.38 per litre after the hike.

Similarly, they had stopped revising fuel prices for almost 14 days ahead of the assembly elections in Gujarat in December 2017.

These companies had also imposed a freeze on petrol and diesel prices between January 16, 2017, and April 1, 2017, when assembly elections in five states — Punjab, Goa. Uttarakhand, Uttar Pradesh and Manipur — were held.

During the 2019 general elections, they moderated the revision by not passing on all of the desired increase in rates to consumers, industry sources said. The rates began to rise a day after the final phase of polling for the Lok Sabha elections ended

The current 74-day hiatus is the second longest since daily fuel price revision was adopted in June 2017. Prior to this, there was a 82day hiatus in rate revision between March 17, 2020 and June 6, 2020.

Reliance Retail's big investment: \$132mn for robot-maker

New Delhi, Jan 18: Mukesh Ambani led Reliance Retail has acquired a 54 per cent stake in domestic robotics company Addverb for USD 132 million (about ₹983 crore), a senior official of the robotic firm said Tuesday.

Addverb Technologies co-founder and CEO Sangeet Kumar told PTI that the company will continue to operate independently and will use the funds received from Reliance to expand business overseas as well as set up one of the biggest robotic manufacturing facilities in Noida.

The company already has a manufacturing plant in Noida where it produces around 10,000 robots per annum. With this investment, Reliance will hold around 54 per cent stake in Addverb. They become the largest shareholder in the company.

Antrix-Devas deal fraud against country, says FM

New Delhi, Jan 18: The government will use the Supreme Court order calling the 2005 deal between ISRO's commercial arm Antrix and privately-owned Devas Multimedia a fraud, to counter seizure of its properties, Finance Minister Nirmala Sitharaman said Tuesday as she launched a blistering attack on the Congress for handing over airwayes used by the defence to the private firm for pittance.

"It is a fraud of Congress, by Congress (and) for Congress," the minister told reporters as she read out paragraphs from the Supreme Court's January 17 decision allowing winding up of Devas Multimedia because of the fraud Antrix — the commercial arm

of the ISRO — entered into an agreement with Devas for providing multimedia services to mobile users, for which it was given Sband satellite spectrum without the knowledge of the Union Cabinet, she said. The Congress took six years to cancel the deal and the then government did not initiate steps to fight the arbitration proceedings the private company brought against the cancellation, she added.

The Congress-led UPA did not cite national security to fight the arbitrations brought by Devas, Sitharaman said and called the party 'master of corruption'.

Devas initiated arbitration against the annulment at the International Chambers of Commerce (ICC). Two separate arbitrations were also initiated under the Bilateral Investment Treaty

(BIT) by Mauritius investors in Devas Multimedia under the India-Mauritius BIT and by Deutsche Telekom — a German company – under the India Germany BIT. India lost all three disputes and has to pay a total of USD 1.2 billion in damages.

Its shareholders are pursuing Indian assets abroad to recover award and have got a French court order for freezing Indian properties in Paris and got partial rights over funds maintained by Air India in Canada.

The Supreme Court has given a comprehensive verdict upholding the liquidation of Devas ordered by the insolvency court, she said, adding this would be cited in the international courts to challenge enforce ment actions of the private firm.

"No country which respects rule of law will ignore these facts," she said, citing the apex court observation that it was a case of fraud of a huge magnitude.

Antrix had approached the National Company Law Tribunal (NCLT) seeking liquidation of Devas. Last year, NCLT ordered liquidation of Devas observing that the firm appeared to have been incorporated with fraudulent intentions. Devas appealed against the order before NCLAT which in September 2021 upheld the liquidation. Devas filed an appeal before the Supreme Court which upheld the liquidation, she said.

The 2005 agreement was "a fraud on people of India, fraud against the country," she said, adding the government is fighting in every court so that Devas does not get away with Antrix deal fraud and taxpayers' money is saved

Cost of debt funds for states surges

Mumbai: States are shelling out more for debt funds, with the weighted average cost for their debt auctions hardening by 9 basis points to touch 7.24 per cent, the highest level so far this fiscal, during the auctions Tuesday. Compared to the previous week, the cost has gone up by 9 basis points (bps). From the first auctions in January, the cut-offs have been trending over 7 per cent. The weighted average cut-off for states' 10-year debt auctions or state development loans as they are known, has hardened by 9 bps to 7.24 per cent at today's auctions as the drawdowns was 6 per cent more than indicated earlier, yet overall down by 12.3 per cent on annualised basis, Icra chief economist Aditi Nayar said in a note. As a result, the spread between the 10-year state debt and the benchmark G-Secs widened to 61 bps today from 58 bps last Tuesday, she said.

New York, Jan 18: Microsoft Corp is buying Call of Duty maker Activision Blizzard for \$68.7 billion in the biggest gaming industry deal in history as global technology giants stake their claims to a virtual future.

The deal announced by Microsoft Tuesday, its biggest-ever and set to be the largest all-cash acquisition on record, will bolster its firepower in the booming videogaming market where it takes on leaders Tencent and Sony.

It also represents the American multinational's bet on the metaverse, virtual online worlds where people can work, play and socialise, as many of its biggest competitors are already doing.

Gaming is the most dynamic



and exciting category in entertainment across all platforms today and will play a key role in the development of metaverse platforms, Microsoft Chief Executive Satya Nadella said.

Microsoft's offer of \$95 per share represents a premium of 45% to Activision's Friday close. Activision's shares were last up 27% at \$83.11, still a steep discount to the offer price, reflecting concerns the deal could get stuck in regulators' crosshairs.

Washington, Jan 18: The airline industry is raising the stakes in a showdown with AT&T and Verizon over plans to launch new 5G wireless service this week, warning that thousands of flights could be grounded or delayed if the rollout takes place near major airports.

CEOs of the nation's largest airlines say that interference from the wireless service on a key instrument on planes is worse than they originally thought.

"To be blunt, the nation's commerce will grind to a halt" unless the service is blocked near major airports, the CEOs said in a letter Monday to federal officials including Transportation Secretary Pete Buttigieg, who has previously taken the airlines' side in the matter. AT&T and Verizon plan to activate their new 5G wire-



less service Wednesday after two previous delays from the original plan for an early December rollout. The new high-speed 5G service uses a segment of the radio spectrum that is close to that used by altimeters, which are devices that measure the height of aircraft above the ground. Two weeks ago. the companies struck a deal with the Federal Aviation Administration to delay the service for two more weeks and reduce the power of 5G

AT&T and Verizon say their equipment will not interfere with aircraft electronics, and that the technology is being safely used in many other countries. Critics of the airline industry say the carriers had several years to upgrade altimeters that might be subject to interference from 5G. The CEOs of 10 passenger and cargo airlines including American, Delta, United and Southwest said 5G will be more disruptive than they originally thought because dozens of large airports that were to have buffer zones to prevent 5G interference with aircraft will still be subject to flight restrictions announced last week by the FAA, and because those restrictions won't be limited to times when visibility is poor.

71% of employees rethinking their careers: Report

Mumbai, Jan 18: As the ongoing pandemic impacted the job market and become a catalyst for employees resetting their priorities, a report has revealed that about 71 per cent of workers surveyed are rethinking their careers and might explore a different career.

While economies across the globe struggled with a new wave of Covid-19, the event had a significant impact on the labour market, the report by global job site Indeed revealed that as many as 71 per cent of employees surveyed said they are rethinking their careers and may even see "if a different career is worth pursuing".

The Indeed India Hiring Tracker HY2 2021, is based on a survey conducted by Valuvox among 1,219

employers and 1,511 employees during October and November 2021. The report further found that 51 per cent pondered if their current job is fulfilling a purpose, while a larger proportion of 67 per cent questioned themselves of being in the right job.

Another 61 per cent of employees also said they are seriously thinking to reprioritise their job in favour of other life priorities, it observed.

The consequences of the re-evaluation have resulted in about three out of 10 employees thinking of quitting their current jobs, said the report.

The report also revealed that this thought has occurred to a greater proportion of male employees (31 per cent) than women employees (19 per cent).



According to the data, Covid-19 has brought a paradigm shift in the priorities of the employees. For 68 per cent of surveyed employees, job satisfaction was solely ranked as 'very' or 'most' important aspect followed by salary and job satisfaction for 62 per cent, the report said.

Work-life balance was a close

third with 61 per cent of employees prioritising for the same, it noted.

Although employees are looking for flexibility, work-life balance, the purpose of work and job satisfaction, the report revealed that it may take some more time to transform this into a reality.

About 77 per cent of employees

said their workplaces do not offer flexibility, while only 7 per cent got the privilege of the flexibility of working fewer hours for reduced pay, it said.

Irrespective of hierarchies and education levels most employees (49 per cent) were found working 5day a week with 51 per cent of them clocking 6-8 hours a day, it said.

Meanwhile, it found that remote work has blurred lines between personal and professional lives, more than half of male employees (57 per cent) worked for 6-8 hours a day during Covid compared pre-Covid where only 15 per cent of male employees worked for the same duration.

While the percentage of women working for 6-8 hours has grown marginally to 43 per cent from 41 per cent pre-Covid, it said.

Surprisingly, 40 per cent of employees said they had no intention of working for fewer hours and at least 35 per cent of employees intend not to work for fewer hours in 2022, it said.

"The tracker sees employers and employees in tandem as employees reprioritise their career. Flexibility at work continues to remain an important conversation and it is important to pay attention to what employees want, to enable them to thrive in a new work environment. Similarly, with more em- ২ ployers hiring in the second half of the year and businesses changing their hiring priorities from sales roles to data analytics roles indicate that businesses are well past the recovery phase and are poised for -(strong growth," Indeed India Head of Sales Sashi Kumar added.

His supporters and Indian cricket in general will be hoping that Kohli has put his differences with the BCCI firmly behind him and come Wednesday, he starts a new innings with his willow doing most of the talking. A highly desired century after two years would be cherry on top

Rahul, who is leading the side in the absence of an injured Rohit Sharma, is expected to turn to Kohli for advice during the series. Not only Kohli has a major role to play as a batter, but as vice-captain Jasprit Bumrah said on the eve of the series, the star "will always be a leader" in the team.

On the previous tour, India hammered the hosts 5-1 in ODIs and they will draw confidence from that. South Africa will be in high spirits after a memorable victory in the five-day format.

But come Wednesday, Dhull would be looking for more support from his openers to ease the pressure on middle and lower-order going into the knock-

The Bayern Munich forward Monday overturned the result last month of the Ballon d'Or prize where he placed second behind Messi, who finally led Argentina to a senior title at the 2021 Copa América. Mohamed Salah of Liverpool placed third.

"I am very honoured to win this trophy," Lewandowski said on a video link from Munich. The trophy was presented by club officials during the online ceremony hosted at FIFA headquarters in Zurich Monday.

Lewandowski was the overwhelming choice of national team captains and coaches plus selected media in more than 200 countries. yet was almost caught by Messi, who got more than double the number of votes from fans worldwide than the Poland captain.

In the women's award, Alexia Putellas added the FIFA trophy to her Ballon d'Or victory. Putellas captained Barcelona to its first Women's Champions League title and teammate Jennifer Hermoso placed third in the FIFA vote. The runner-up was Sam Kerr of beaten finalist Chelsea

Chelsea swept the coaching

awards in a year when its men's and women's teams led by Thomas Tuchel and Emma Hayes reached their Champions League finals. Hayes seemed surprised to win the coaching award for women's soccer ahead of Lluis Cortes.

Cristiano Ronaldo was also the star guest with FIFA in Zurich. The Portugal star appeared in person to close the show and collect a special award for breaking the all-time scoring record in men's national team soccer. The record scorer in women's national teams, Christine Sinclair of Olympic champion Canada, also got a special award from FIFA earlier in the show.

Two awards went to Denmark for the reaction in the stadium to national team star Christian Eriksen collapsing due to cardiac arrest at a European Championship game

in Copenhagen. FIFA's fair play prize went to the Denmark players and medical staff who protected and treated Eriksen. The award for best fans was shared by Denmark and Finland whose supporters chanted Eriksen's name as he was treated on the field before it was clear he

would recover. The Puskas Award for best goal went to Érik Lamela for the rabona flick he scored for Tottenham against Arsenal in the Premier League in March. The best goalkeeper prizes were won by Edouard Mendy of Chelsea and Chile's Christiane Endler, who moved from PSG to Lyon in the offseason.

Defending champion Djokovic was already back in Serbia, two days after losing his legal challenge to stay in Australia despite being unvaccinated against COVID-19, when Medvedev went onto Rod Laver Arena and raced through the first set in 26 minutes.

Nobody has dominated on that court like Djokovic, who was unbeaten in the nine finals he reached at the Australian Open. Medvedev was the most recent recipient of one of those beatings, losing last year's championship match. But he avenged that with his

breakthrough major title at the US Open, where his victory meant Djokovic's bid for a calendar-year Grand Slam finished one win short. Leylah Fernandez, a 19-year-old

Canadian, lost 6-2, 6-4 to 133rdranked wild-card entry Maddison Inglis in her first Grand Slam match since her runner-up finish at the US Open.

Fernandez made 30 unforced errors, dropped her serve three times and hit only eight winners on 1573 Arena against Inglis, who converted her third match point to complete her very first win in the main draw of a major.

She lost in the first round at last year's Australian Open to then defending champion Sofia Kenin.

For Fernandez, the venue and the vibe were a long way from her run to the final at Flushing Meadows, where she lost to Emma Raducanu.

Raducanu was scheduled to play later Tuesday against 2017 US Open champion Sloane Stephens

Make a model scheme to fight hunger: SC

POST NEWS NETWORK

New Delhi, Jan 18: The Supreme Court has told the Centre to give latest data on the number of people who died due to starvation in the country and frame a national model scheme to combat hunger.

During a hearing Tuesday, a bench headed by Chief Justice of India NV Ramana said, "Are you saying there are no starvation deaths in the country except for one? Can we depend on that statement?"

The Centre had relied on a 2015-2016 report on starvation deaths.

'With state governments not reporting any starvation death is it to be understood there is no starvation death in the country? Government of India should give us data on starvation deaths, latest information. Ask your officer to give us information," the court told Attorney General KK Venugopal.

The bench said state governments are announcing welfare schemes ahead of Assembly elections next month in five states, and a policy for community kitchens will make the Centre popular. "It's election time. If you frame the policy and give additional food grains, then states will want to implement the cooked food policy," the Supreme Court said.

When Venugopal told the court

It directed the Centre to formulate a national model scheme for community kitchens, in consultation with states and other stakeholders, which can include extending additional logistics, resources and food grains.

"Our focus is that people should not suffer from hunger, die of hunger. You have to discuss with your officers to come up with a nodal scheme. We have explained the intention of this court and need to explore a solution," the Chief Justice of India told

that there are 134 schemes in place and more funds cannot be diverted Venugopal. "We are not on larger issues of to states as food grains are already being distributed to them, the bench malnutrition ... hunger is to be satiated. Everyone is admitting there's an issue, Have a humanitarian approach. Ask your officers to apply their mind," he added.

The Chief Justice said, "We are not saying that you (Centre) are not doing anything to deal with hunger or starvation... but consider a model scheme nationally. Draft a scheme, finalise it and then leave it to states.

The lawyer said the Centre will consider the court's suggestions. 'We can make a scheme with this... Two per cent additional food grains will be made available to states. Let states file an affidavit and see if this two per cent is acceptable to all the states.

The court adjourned the matter for two weeks and said states can file additional affidavits on malnutrition, hunger and other issues till then.

Meanwhile. Odisha informed the Supreme Court that not a single death due to starvation was reported in the coastal state. However, there are 1,429 malnourished children of below five years in all 30 districts of the state.

Following the apex court's October 2021 order, Odisha, in an affidavit, submitted that it has been taking numerous steps to prevent malnutrition. The state also submitted that it has been providing additional nutrients to the malnourished children

Covid testing centres in capital burdened with seasonal diseases

Bhubaneswar, Jan 18: Covid test ing centres in the state capital are witnessing a sharp rise in tests amidst the outbreak of seasonal flu, common cold and viral fever, whose symptoms are very similar to that of the Omicron variant.

Pointing to the unseasonal rains and drop in temperature, health experts have suggested that outbreak of usual seasonal diseases other than Covid may have triggered panic and confusion among people. This reportedly has increased the burden on all private and government testing centres in the capital.

'Usually we were receiving about 100-120 samples daily for Covid testing a month ago. Now we are receiving around 600 samples a day. Fearing that they have been infected with Omicron, a large number of people have turned up for Covid testing and tested negative. We have made several temporary Covid testing dispensaries to de-

crease the workload and waiting period for RT-PCR sampling," said Laxmidar Sahoo, Director, Capital Hospital here

Similarly, private testing centres that offer more expedite testing and results have also been overburdened with Covid samples. "While we used to deal with around 300 samples a day until December, the number has now increased to 900-1,100 every day. In addition, there is a significant demand in home testing," said Bijay Kant Sahoo, manager at a private testing centre here.

However, despite suffering from symptoms such as running nose, cough and cold, health experts have suggested patients to get Covid testing done. "Usual symptoms such as headache, fatigue, sneezing, sore throat and dry cough are found in patients suffering from Omicron as well as other seasonal disease. Their incubation periods are also similar to that of 2-3 days. However, it's advisable to opt for Covid testing and isolate oneself when one tests positive to Omicron," said Dr. Ashutosh Mohanty, a local physician.

Meanwhile, the Bhubaneswar Municipal Corporation (BMC) has increased Covid testing in the state capital in view of a surge in Covid cases. While only 8,106 tests were conducted until January 7, now the daily tests have in-

creased to 9,010. Moreover, the state capital has also witnessed a 141% jump in Covid cases in last ten days. While only 581 cases were reported until January 8, it shot to 1,402 cases as on January 18.

With the active cooperation of the people, we can deal with the situation without affecting the livelihood activities," he said.

The state has been able to manage the third wave of Covid-19 so far. The number of daily Covid cases has remained almost constant over the past few days. The number of active cases has started declining in major cities of the country. The symptoms are mild and

very few patients need hospitalisation, he said, adding, "Still, we all need to remain alert and fully prepared." He asked the Chief Secretary SC Mahapatra, who was present in the meeting, to advise the people not to panic as a high number of cases were reported.

The Chief Minister advised the officials to further speed up the vaccination programme in the state, especially inoculation of booster dose to the medical staff, police personnel, administrative officials and other eligible persons. As media personnel are treated

as frontline workers, Patnaik advised the officials to give priority to them on vaccination of booster doses. He also emphasised the need for a micro-containment strategy and regular monitoring of health conditions of the Covid patients under home isolation.

There are 11,291 beds for Covid patients in the state of which only 11 per cent are occupied now. The state has adequate medicines, medical oxygen and other essentials.

Giving detals about the vaccination drive, Sharma said that 92.7 per cent of the eligible persons have taken the first dose, while 70.7 per cent are fully vaccinated. He noted that 45.8 per cent of children in the age group of 15 to18 years are vaccinated and 14 per cent have received booster dose.

Man falls to death after Rourkela among 15 winners of worldwide innovation contest stepping into lift shaft

The lift's door lock was malfunctioning for several days

Bhubaneswar, Jan 18: In a tragic incident, an elderly man died after falling into the basement of a residential apartment on the outskirts of Bhubaneswar through the lift passage. Tuesday.

According to reports, the victim lived at Hi-Tech Plaza, a residential complex located near Sundarpada, on the outskirts of the capital city. Like every day, he pressed the button of the lift to go downstairs. After the lift door opened, he stepped inside only to fall to the basement.

Though the door of the lift opened, the lift compartment did not arrive due and the victim fell through the lift passage after stepping in inattentively. He suffered

critical injuries as a result of falling from a height. He was rushed to a nearby hospital where the doctors declared him brought dead.

On being informed, a team from the Airfield Police Station arrived at the spot and launched a probe into the accident.

Sources informed that the lift's door lock was malfunctioning for several days due to which the door opened even though the lift compartment did not arrive on the floor.

Residents of the building have raised concerns over the matter as the irresponsibility of the lift operators and other persons employed for maintenance resulted in the tragedy. The residents said their lives too are at risk unless the lift is not repaired immediately.

BJP doubts SEC impartiality

From this, one can easilv understand the wrongful intention of the state government as well as the SEC," she alleged.

The BJP also demanded the immediate transfer of Vijay Amruta Kulange who has been the district Collector of Chief Minister Naveen Patnaik's home district Ganjam for five years, and D Brundha, district Collector of Kandhamal, district for seven years.

Bhubaneswar, Jan 18: Odisha reported 11,086 new Covid-19 cases Tuesday, 597 more than the previous day, while four more patients succumbed to the highly infectious virus, the Health Department said in a bulletin.

The coastal state's daily test positivity rate (TPR) rose to 15.62 per cent from 14.96 the previous day, as 70,990 samples were tested in the last 24 hours, the bulletin stated.

Khurda district, of which state Capital Bhubaneswar is a part, reported nearly one-third (31 per cent) of the new cases at 3,469, followed by 1,416 cases in Sundargarh and 766 in Cuttack, it said.

As many as 1,061 children were among the new patients. The daily cases jumped by more than 56 per cent from 7,071 a week ago. The state had logged 10,489 cases Monday The active cases surged to 80,914, including 27,010 in Khurda that is in the red zone of districts where current cases are over 2,500. Sundargarh, Sambalpur, Cuttack, Balasore and Mayurbhani are also on the list, Puri and Bolangir are among the nine districts that are in the yellow zone with over 1,000 patients

The toll mounted to 8,488 with one fatality each in Cuttack, Sundargarh, Kendrapara and Koraput districts. Fifty-three other patients have died due to comorbidities so far, according to the bulletin.

CAN A PERSON BE INFECTED WITH OMICRON TWICE?

ALTHOUGH RE-INFECTIONS ARE THERE, "THERE IS NOT YET STRONG EVIDENCE **IN FAVOUR**" **OF OMICRON RECURRING IN** AN INDIVIDUAL

hile Omicron is known to cause Covid re-infection, there is no strong evidence yet in the favour of a person being affected with the vaccine dodging strain again, said Indian health experts here.

However, they also did not rule out such a possibility.

An individual's immunity which has been primed by prior infection or vaccination has the memory of the parent virus.



But because Omicron is a deviant, meaning it has deviated quite a lot from its parent Covid strain it has many dissimilarities. As a result, "our immune system fails to recognise the virus as the original virus and hence the chance of re-infection. Along with the

above the waning immunity of

naturally infected individuals with passage of time will also contribute to the re-infection", Dr Dipu TS, Associate Professor, Division of Infectious Diseases, Amrita Hospital, Kochi, said.

Although re-infections are there, "there is not yet strong evidence in favour" of Omicron recurring in an individual, added Dr Ashok Mahashur, Consultant Chest Physician at PD Hinduja Hospital & MRC, Mahim, Mumbai.

A recent study led by the UK's Imperial College London has showed that the risk of re-infection with the Omicron variant is 5.4 times greater than that of the Delta variant. "This implies that the protection against re-infection by Omicron afforded by past infection may be as low as 19 per cent,' said the researchers.

Dr Rahul Pandit Director, Critical Care, Fortis Hospitals Mumbai, said: "Omicron causes re-infection because it has an 'immune escape phenomenon' - that means that people who had acquired infection before and had antibodies, because of that or who are vaccinated and have antibodies, or have both, which is known as 'hybrid immunity'"

Omicron has more than 30 mutations on its spike proteins, helping it to escape immunity. That is why it is infecting people who were

previously having antibodies as well. "However, there is no understanding if Omicron infection would happen again in these people, or not; that remains to be studied and seen." Pandit, who is also a member of National and Maharashtra's Covid-19 Taskforce, said.

"We should not be speculating if such re-infection would happen or not. I haven't seen any case as such of a patient with Omicron getting re-infected with another Omicron infection, neither has been reported anywhere in the medical journals and medical literature yet," he said. But, some western experts have argued that Omicron can reoccur: "Yes, you can get Omicron twice," Stanley Weiss, Professor at the Rutgers New Jersey Medical School was quoted as saying in a media report.

While, "the data regarding Omicron specifically is just coming out, but there's no reason to think that Omicron in this regard is any different than the previous

variants", added William Schaffner, Professor at the Vanderbilt University School of Medicine, in the report.

However, Kingston Mills, Professor of Experimental Immunology at Trinity College Dublin said it was "too early" for people infected with the virus and then caught again. The picture may be clear in six months' time, Mills was quoted as saying to Financial Times.

Mahashur said that in India, cases of Covid re-infection have been reported and especially among those with low immunity.

'The best way to prevent this is by following a Covid appropriate behaviour because there is no way to know whether the virus is there or not. The virus may be there, but the patient may be asymptomatic, so the best way to prevent it is by taking vaccines, wearing masks, washing hands properly, and avoiding crowded places, Mahashur said. IANS

KOTIA TO VOTE IN RURAL POLLS

Bhubaneswar, Jan 18: A year after voting in Andhra Pradesh rural elections, residents of disputed villages in Kotia gram panchayat (GP) of Koraput will now exercise their franchise in the upcoming panchayat elections in Odisha.

The Andhra Pradesh government had held rural elections in villages in Kotia gram panchayat area, claimed by both the states, in February last year despite the Odisha administration's objection citing a Supreme Court directive to maintain status quo in the disputed area.

"Residents of villages like Madkar, Daliamba, Barnapadu, Patusineri and Konadara under Kotia gram panchayat had voted in Andhra rural polls. Now, they will also vote in the Odisha panchayat elections," an official in Koraput dis-

trict said. State Election Commissioner (SEC) Aditya Prasad Padhi has issued special directions to officials concerned for conducting peaceful polls in Kotia gram panchayat area in Koraput district, and Chitrakonda block of Malkangiri district, official sources said.

in mid-February, they said. Polling could not be held in two zilla parishads, comprising 18 gram panchayats, of Chitrakonda block in the 2017 panchayat elections due to the situation created by ultras.

Despite ban, fishing in Gahirmatha rampant

Mahakalapara, Jan 18: Rampant fishing in the water bodies and seawaters of Kendrapara district and smuggling of marine species have resulted in drastic fall in their count triggering concern among the conservationists, a report said.

Although the Forest department has imposed a ban on catching crabs and trading them in areas under Rainagar forest division. fishermen continue to cast nets in the water bodies near Gahirmatha marine sanctuary. They have been catching fish and crab in huge amounts from Gobari, Ramachandi, and Galia rivers – distributaries of Mahanadi.

Such rampant catching of fish and crab has resulted in a severe food crisis for the giant saltwater crocodiles living in the area. Casting nets in water bodies has become life threatening for the crocodiles.

in national as well as international markets. Foreigners are served with various delicacies prepared with these crabs. A local fish trader said that the demand for these marine fishes and crabs is very high as medicines are also prepared from these marine creatures.

Some fishermen, requesting anonymity, said that despite the ban, they are allowed to fish in the water bodies in lieu monthly bribes to Forest officials. They take action only against fishermen who refuse to pay the bribe.

Fishermen Bikash Mandal. Gurupada Bera, Panchanan Bera, Bimal Bera and Aswini Maiti said they are forced to catch fish and crab from the water bodies and the sea to earn a living as they do not own any farmland.

Environmentalist Samarendra Mahali had earlier said that crabs and fish were found in abundance in the water bodies of this coastal area. However, rampant fishing activities and discharge of industrial effluents into the water bodies have taken a toll on their population.

Moreover, discharge of chemical mixed water from the prawn gheries and use of modern fishing nets has led to a decline in their population. He warned that if proper measures are not taken immediately these marine creatures will vanish from these water bodies soon.

When contacted, Mahakalapara Forest ranger Sahaji Charan Biswal said Forest officials are regularly patrolling in the area and recently caught some fishermen fishing in Kharinasi reserve forest areas

ighty per cent Indians believe they and their families will be eco-→ nomically better off in the next five years. Admittedly this is not a re-✓ sult of any plebiscite held across the country. This fact along with some other data was collected by The Edelman Trust Barometer which has, for two decades, been polling thousands of people in multiple countries on how much they trust their governments, media, business and NGOs. A report published recently by Edelman communications group claimed to have carried out a survey which involved 36,000 respondents in 28 countries during November 1-24 of 2021. This report has come to the conclusion that public trust in governments running the world's democracies has fallen to new lows over the handling of the pandemic and a widespread sense of economic pessimism. The biggest losers of public trust were institutions in Germany followed by Australia, the Netherlands, South Korea and the United States. By contrast, public trust was high in institutions in China followed by the UAE and Thailand which are all non democracies. In Japan only 15% respondents believed they and their families would be better off in five years' time, with most other democracies also clocking very low trust on the same query. This same question to Chinese respondents drew a twothirds optimism about their economic fortunes while 80% Indians quizzed believed they would be better off in five years.

Apart from governance issues, according to this Barometer, business has gained trust globally due to its role in developing vaccines and adapting to new and appropriate workplace and retail practices. On the other side, around two-fifths of the respondents also said that business was not doing enough to address economic inequality, workforce re-skilling and climate change.

People's concern about 'fake news' was at an all time high this time. Three-quarters of respondents globally felt that media was using fake news as a weapon while climate change was the second big issue after loss of employment among societal fears.

This recent survey seems to be an echo of findings of the past few years that demonstrated increasing disillusionment with capitalism, political leadership and the media.

Most important in all of this is the loss of faith in democracy. It can safely be said that this loss is primarily because of the quality of manpower that political parties are attracting. It is mostly individuals like Erdogan, Orban, Duterte, Bolsonaro and others, all of them bearing similar autocratic mindset, that have managed to infiltrate the democratic processes in their respective countries and have come to power through the ballot. The people at large have chosen them. Simultaneously, the people are reposing total faith in the capabilities of this set of leaders to guide them to a better life. This should make the old democratic thought process to stand up and take note. It could be a great harbinger of change. History has shown that the era of the king and the conqueror, landlord, and feudal lord came to an end when autocratic characters usurped the thrones. The dictator was dislodged with pro people movements into which jumped the liberal, thus was born communism on one hand and democracy on the other. Today, maybe, democracy has come full circle. Casting a single vote once only for a fixed number of years does not absolve us, citizens, of our responsibilities. We mostly tend to focus on our rights only. The leader also feels that the certain number of years bestowed on her or his administration implies no accountability. When people forget, there is no accountability. If there is no accountability, there can be no justice in society.

n 2022, the COVID-19 pandemic and the myriad crises it spawned may finally start to recede. But even in that best-case scenario, a tsunami of new challenges-from the failure of climate action to the erosion of social cohesion - is within sight. Addressing them will require leaders to adopt a different gov-

At the heart of our failure to foresee and manage global risks - not only climate change and deepening social divisions but also the reemergence of infectious diseases. debt crises, and inadequate technology regulation - lies an unresolved problem of global governance. Our institutions and their leadership are no longer fit for purpose

We tend to view history as a series of big, earthquake-like events. But the degradation of global governance was mostly a case of gradual erosion.

In the Governance 1.0 period immediately after World War II, both public and corporate governance were marked by the rule of the 'one man': the elected or unelected 'strong leader' and the 'boss.' This type of leadership worked well in a society where the cost of information was high, hierarchical power and management functioned relatively smoothly, and technological and economic advances benefited almost everyone.

The Governance 2.0 model, which emerged at the end of the 1960s, affirmed the primacy of material wealth, and coincided with the rise of the economist Milton Friedman's 'shareholder capitalism' and progressive global financialisation. The new mana-

For now, many leaders remain stuck in the shareholder capitalism mentality of Governance 2.0, while some societies still favour the strongman leadership and structure of Governance 1.0. And as long as COVID-19 remains a threat, the crisis mentality of Governance 3.0 will continue to dominate boardroom and cabinet discussions.

But many leaders are already thinking and acting like pioneers for a new age of governance. They include business executives advocating for environmental. social, and governance (ESG) metrics and political leaders such as French President Emmanuel Macron and Italian Prime Minister Mario Draghi breaking down boundaries. Above all, young people are demanding a better future.

Those still using the governance playbooks of previous eras criticise such leaders for not staying in their lane. But we should welcome leaders who, navigating largely uncharted territory, act outside of their narrow interest as trailblazers and argue for specific action to fight climate change and address social injustice.

The best gauges of responsible and responsive governance today measure the extent to which leaders embrace and consent to stakeholder responsibility over shareholder responsibility. Although the measurement of stakeholder accountability is still in its infancy, the development of consistent metrics will enable us to judge whether leaders are taking a broader view of their role and responsibility.

Riff-raff

o trace this one, we have to start in medieval French. There was then a set expression rifle et rafle. These words are from the verbs rifler, to spoil or strip, and raffler, to carry off. The phrase referred to the plundering of the bodies of the dead on the battlefield and the carrying off of the booty. The French phrase moved into English in the forms rif and raf or riffe and raf, which meant at first every scrap, from which we may guess that medieval plunderers were extremely thorough. It's known by at least 1338 (it appears in Mannyng's Chronicle of English of that date). Later it shifted sense through a series of stages, first referring to one and all, or everybody, and then later taking on the idea of the common people, those of no special social standing. The phrase was abbreviated to riff-raff and can be found in Gregory's Chronicle of London of about 1470. It seems to have taken some decades longer for it to have gone even further downhill and for it to be associated in particular with the dregs of society. It's likely that the negative associations of common soldiers ransacking the bodies of the dead coloured the expression even after it had shifted its meaning. We're familiar with descendants of both of the original old French words in English, by the way. Riffler is the origin of our riffle in the card-shuffling sense, amongst others, and of rifle, for searching hurriedly through possessions for something, or to steal. It also gave rise to the firearms sense, since a rifle takes its name from the spiral grooves cut in the barrel of such a gun to improve its accuracy; this comes from a different sense of the French word, meaning to graze or scratch. And raffler lent its name to a game played with three dice, perhaps because the winner snatched up or carried off the winnings (we're not guite sure of the connection). In English the game was called raffle, and the word was only much later applied to another form of gambling, a lottery. And in the early nineteenth century raffish appeared. This adjective originally referred to somebody who was disreputable or vulgar. Only later did it acquire the undertones it now has of a person who is attractively unconventional. This may have come from the second half of riffraff, or from raff, which had survived by itself in dialect usage in much the same sense of the lowest class of the population.

T drive a Honda that's more than 10 years old. I was quite happy with it, until I happened to rent a new car one day. This new car had all the latest technology installed, including a navigation system that my Honda lacks (I use my phone for directions) and a premium surround sound system. The sound system provides 320 watts of power from eight speakers, which would allow me to blast Abba so loud, my kids would die of embarrassment. For a day or two after returning the rental car. I wondered if it would be worth it to buy a newer car and enjoy some of the amenities that newer cars offer. But then I realised that any additional happiness that I'd get from the newer car would dissipate in a week or two. I'd get used to all the new features and they wouldn't be special to me anymore. I might even grow tired of embarrassing my kids. In the end, what really matters

is whether a car can reliably take me from Point A to Point B. My Honda runs very well—it hasn't broken down on me yet-and I'm not quite ready to get rid of it. Of course, whenever a friend buys a brand new car, I can't help feeling a little envious. But then I imagine all those monthly car payments and the envy disappears.

It's human nature to make comparisons, as David J. Linden, a neuroscientist at the Johns Hopkins University School of Medicine, writes in an article titled "A Neuroscientist Prepares for Death,' which appeared in a recent issue of the US magazine The Atlantic.

Linden, who has terminal cancer, shared a few insights that preparing for death has taught him about the human mind. One of his insights struck me as particularly perceptive. "The deep truth of being human is that there is no objective experience," he writes. "Our brains are not built to measure the absolute value of anything. All that we perceive and feel is colored by expectation, comparison,

and circumstance.'

Even when we can measure something objectively, we do not experience it objectively. This is why, Linden says, 30 minutes fly by when you're chatting with a friend, but the same amount of time can seem like an eternity when you're standing in line at the DMV (Department of Motor Vehicles). In a similar way, 60 minutes seem like such a short time when you're sitting for an important exam, but those same 60 minutes seem neverending when you're sitting in a dentist's chair.

Linden offers another example: "That fat raise you got at work seems nice until you learn that your co-worker got one twice as large as yours." One moment, you're feeling appreciated at work, and the next moment, you're feeling exploited. It's tough not to compare yourself to others. That's how we often measure our accomplishments. If you scored 72 per cent in an exam, you'd probably feel bad about it. But if you find that your score was the highest in your state, you'd feel considerably better about yourself-and considerably worse about your state.

We don't just compare ourselves to others-we also compare our current experiences to previous ones. After you've spent a few years living in Dubai, you'll never complain about the heat in India. You might even wear a sweater all year. But if you just returned from Siberia, you'll feel like you've been thrown into a fire.

For Linden, his cancer diagnosis has made him appreciate every moment of life. His doctor expects him to live just one more year. Linden wishes he had five years left to enjoy life. Five years seems like a lot, but only because he's been given just one year.

"The point is that, in our minds," he writes, "there is no such thing as objective value, even for something as fundamental as five years of life.'

Sir, Accidents on flyovers are on the rise in India. Though flyover accidents and general road accidents have some reasons in common, a few select causes play the first fiddle in flyover mishaps. Roads on overpasses are commonly top class. These are invitations to speed driving. Speed control on overpasses, as compared to that on normal highways, is extremely important. Authorities have to erect familiar signboards on flyovers. No policeman can regulate the drivers on flyovers. So, it becomes important to think of novel ideas to infuse a semblance of discipline among the drivers. The time taken by a vehicle to travel from the entrance of the flyover to the exit can be a handy way of identifying over-speeding drivers. The method, however, needs appropriate technology and exemplary hard work to see the light of day. Many drivers who are unfamiliar with the flyover route will have to be appropriately guided. One may have noticed how good drivers toil to maintain lane discipline on highway roads to compensate for the indiscipline of their erring colleagues. While deviating from the correct lane may prove to be a mistake on highways, on flyovers such blunders could prove fatal. Normally, flyovers are bound by a parapet wall on one side and a median on the other. A vehicle breaching lane discipline can throw another off balance resulting in accidents. Smashing the parapet wall to land on the service road is a very tragic way of putting one's life on the line. On the other side, crushing the median to collide with vehicles coming from the opposite direction is a common cause of flyover accidents in recent times. Architects have to incorporate newer scientific methods, if any, of parapet and median wall construction, laying much emphasis on design that offers convenience and comfort to drivers, keeping in mind safety aspects

FRESH CLINICAL GUIDANCE

NEW DELHI: The Union health ministry has advised Covid patients to go for tests for tuberculosis and other conditions if cough persists for more than two-three weeks. The revised 'Clinical Guidance for Management of Adult Covid-19 Patients' issued by AIIMS, ICMR-Covid-19 National Task Force and Joint Monitoring Group (DGHS) under the health ministry Monday underlined there is no evidence of injectable steroids benefitting Covid patients not requiring oxygen supplementation or in continuation after discharge. Anti-inflammatory or immunomodulatory therapy, such as steroids, can have the risk of secondary infection like invasive mucormycosis, when used too early, at higher dose or for longer than required, they highlighted. If cough persists for more than two-three weeks, one should opt for investigation for tuberculosis and other condi tions, the revised guidelines stated.

Army rescues 30 civilians trapped in avalanches

The top court also sought response from the Central government on the intake of women in Rashtriva Indian Military College (RIMC), Rashtriya Military School (RMS), and Sainik Schools in 2022.

The top court gave three weeks to the Centre to file an affidavit and also asked the parties to file \rightarrow their rejoinder in two weeks. The matter has been posted for further hearing March 6.

In September, last year, the apex court had allowed female candidates to take the entrance examto the NDA scheduled November last year.

Too late for execution, serve life sentence: HC

Mumbai, Jan 18: The Bombay High Court Tuesday commuted to life imprisonment the death sentence awarded to sisters Renuka Shinde and Seema Gavit, who were convicted by a Kolhapur court for kidnapping 14 children and killing five of them between 1990 and 1996

A bench of Justices Nitin Jamdar and SV Kotwal commuted the death sentence awarded to the duo after holding that the Maharashtra gov

ernment and the Centre had caused inordinate delays in executing their death sentence and had breached their fundamental rights.

The bench noted that the government authorities, particularly the state government, had acted casually, delayed protocol despite being aware of the seriousness of the case, and did not execute the death sentence awarded to the women despite their mercy petitions being rejected by the President over seven years ago

The Maharashtra authorities had delayed processing papers related to the mercy petitions filed by the convict women, and a bunch of mercy petitions filed by others on their behalf, it said. The state prison authorities had failed to follow the protocol of informing the convicts about the status of their pleas, the state government officials had delayed sending relevant details to the Union Ministry of Home Affairs, and in seeking a hearing in HC, the bench noted.

'Though the procedure for deciding mercy petitions mandates speed and expediency, the state machinery showed indifference and lax-

Advocate Sandesh Patil, appearing for the Centre, argued that the mercy petition had been sent across to the President as soon as it was received from the state government and that there had been no delay. The President had decided on the application within 10 months, he said.

The bench allowed the women's petition partly by commuting their death sentence to life. It, however, refused to allow them to be released from custody, stating that the two women will have to serve their life sentence till the end of their natural life, considering that the crime committed by them was "heinous". "The argument of the state (Maharashtra government) that they (death sentence) should be executed today overlooks that it is the dereliction of its officers that is the cause for commuting the sentence of death sentence to life imprisonment," it said.

The High Court further said that while the state was supposed to represent the interest of the society in a criminal justice system, in the present case, the state machinery had not only violated the constitutional rights of the two convicts, but it had also "failed the innocent victims of a heinous crime"

Cartoonist Narayan Debnath breathes last at 97

Kolkata. Jan 18: Cartoonist Narayan Debnath, the creator of Bengali comic characters 'Bantul The Great', 'Handa Bhonda' and 'Nonte Phonte', breathed his last in Kolkata Tuesday morning after a prolonged illness, said the hospital where he was undergoing treatment. He was 97 and is survived by two sons, a daughter and a granddaughter.

Debnath, who was handed the Padma Shri award while undergoing treatment, died at 10.15 am, his family said. He was put on ventilator support as his condition deteriorated after being admitted to the hospital December 24.

In his career spanning over six decades, Debnath created comic characters such as 'Bantul The Great', 'Handa Bhonda' and 'Nonte Phonte' -- all of which are household names in Bengal.

The first comic strip of 'Handa Bhonda' was published in 1962 in children's magazine 'Suktara', brought out by Deb Sahitya Kutir. It was followed by 'Bantul The Great' (1965) and 'Nonte Phonte' (1969). Debnath continued working till



the age of 93 when the last comic strip of 'Nonte Phonte' was published in the 2017 Durga Puja issue of Suktara.

Earlier, he created 'Rabi Chobi' -- a comic strip that was published in May 1961 in children's magazine Anandamela to mark the birth centenary of Rabindranath Tagore. Debnath was born in a family

Debnath started freelancing for advertising agencies, creating movie slides and logos, before getting in touch with Deb Sahitya Kutir. "Bantul was not much popular during the initial two-three publications, but became a cult as the average Bengalis identified with his traits and exploits," said Rupa Majumder, the publisher of Deb Sahitya Kutir.

Debnath was conferred with Padma Shri in 2021 but could not visit New Delhi to collect the award. State Home Secretary BP Gopalika and Cooperative Minister Arup Roy handed him the medal and certificate on his hospital bed Thursday.

He was conferred with the Sahitya Akademi award in 2013 and the West Bengal government also honoured him with Banga Bibhushan the same year. The Rabindra Bharati University gave him an honorary DLitt in 2015.

The cartoonist's younger son Tapas Debnath told media that he would urge the government to help preserve his works. "We would like to urge the government to help preserve my father's works, a treasure trove, for the future generations." he said.

Debnath is credited to have first 🛁 introduced the concept of comicstrip in Bengali literature, said actor-MLA Chiranjit Chakraborty, who is the son of noted cartoonist Saila Chakraborty. "Debnath is the inventor of storyboard in truesense in a comic series," he said.

New Delhi, Jan 18: The Indian intelligence agencies have found that Pakistan is purchasing Chinese drones to use them for the purpose of smuggling arms and drugs into the country, sources said.

Sources in the security agencies said that Pakistan's Inter-Services Intelligence (ISI) is purchasing drones from China for terrorist groups Lashkar-e-Taiba (LeT) and Jaish-e-Mohammed (JeM). 'Omicron to peak in India by Feb 15'

New Delhi, Jan 18: Most of India will see a peak in Omicron cases by mid February, health experts said Tuesday

Speaking to IANS, Dr Shashank Joshi, member of Covid-19 Maharashtra State Task Force noted that Omicron has followed the South African pattern in the case of both Mumbai and Delhi.

"It's a very rapidly progressive and explosive wave, which will come very fast and hopefully go very fast. "Mumbai has already passed the peak, Maharashtra will peak by the first week of February.

"Most parts of India might peak between the first and 15th of February. Somewhere in March, Omicron will be much less and hopefully we should have a disruption free India April onwards," said Joshi, who is also an endocrinologist at the Lilavati Hospital, Mumbai. Recent projections by researchers at the Indian Institute of Science and the Indian Statistical Institute (IISc-ISI) claim that the country is likely to witness over 10 lakh Covid cases a day at January-end/beginning of February when the third wave meets its peak.

6 in 10 workers suffering from pandemic-led imposter syndrome

New Delhi, Jan 18: After going through two stressful years of the Covid-19 pandemic, more than 7 in 10 (71 per cent) of professionals questioned their abilities at work more now than before the pandemic while 63 per cent said they suffer from 'imposter syndrome', a new LinkedIn report showed Tuesday. According to the report, the self-doubt seems to be a byproduct of working in isolation for nearly two years as 33 per cent of professionals say the pandemic has negatively impacted their confidence at work.

The findings showed that lack of face-to-face support from supervisors and peers (40 per cent), having to take on new responsibilities (34 per cent), and having to use more technology (31 per cent) are the top three work stressors for professionals in India. Amid the stress, more than 8 in

10 Indian professionals are considering a job change this year and flexible working arrangements are their top-most priority. The report said that the job reshuffle in India



is being led by freshers with up to one year of work experience (94 per cent) and Gen Z professionals (87 per cent), who are more likely

to consider changing jobs in 2022. The professionals are leaving their current jobs due to poor worklife balance (30 per cent), not enough money (28 per cent), or greater ca-

reer ambitions (23 per cent). The report said that professionals in India are confident about their job roles (45 per cent), careers (45 per cent) and overall job availability (38 per cent) getting better in 2022

"In fact, 86 per cent of professionals in India say they are confident about the strength of their professional networks as they enter into the new year looking for new job opportunities," the findings showed.

The top reasons that can convince professionals in India to stay with their current employer in 2022 include better salary (42 per cent), more appreciation (36 per cent), and improved work-life balance (34 per cent).

"The findings also indicate a glaring disparity in the perception of men and women towards how they are being compensated by their current employers today,"the report mentioned.

Working women (37 per cent) are 1.3 times more likely to quit their current job due to poor worklife balance, when compared to working men (28 per cent).

They are also more likely (49 per cent) to say they will remain with their current employer if they get better pay, when compared to working men (39 per cent).
