Analysts are expecting some relief in income tax and corporate taxes as well as reduction of prices of essential commodities like food grains, fuel

New Delhi, Jan 30: Finance Minister Nirmala Sitharaman is Budget (2022-23). Meanwhile sources close to the Finance Ministry said Sunday that the upcoming Budget may increase the standard deduction to ₹1,00,000 from the current ₹50,000.

Budget 2022 might also introduce tax-free work-from-home allowances for salaried employees. Higher deductions for such expenses would increase the takehome salary.

In last fiscal's budget, Sitharaman had introduced a new tax regime. However, this regime offered no major benefits. According to consensus, most taxpayers are continuing with the old regime and were unwilling to move to the new one as they cannot avail of any investment benefits under the new policy. In Budget 2021, the income tax slabs remained untouched. However, it is expected that there may be some relief this time, sources said.

As per a note released by 'William O'Neil India', a company that provides financial services and information, this time there are possibilities the tax-free slab could be increased from the current ₹0-2.5 lakh. If personal income tax is reduced, there would be more disposable income, which in turn would encourage consumption.

With an eye on elections, the rural economy could receive higher allocations. Around 25 per cent of India's rural population is in the five states going to polls in February-March. So, it is expected that the government would maintain elevated rural and agriculture welfare spending. The government could focus on welfare spending such as food subsidies, MGNREGA, PM-Kisan, and fertilizer subsidies, the

note informed. Sources said there could be reductions in prices of food, clothing, medicines, education, housing and health, and above all, in taxes and fuel rates. This is the basic list of just about any family in the country.

Police informed Sunday that Kanchan, wife of Natabar, who is a resident of Sanaraipara village, had delivered January 27 a baby girl at Dharmasala Community Health Centre (CHC). It has been alleged that Natabar allegedly sold the newborn the very next day to 'childless' couple Kailash and Sasmita who are

currently residing at Paradip. However, locals who were aware

of the development brought the incident to the attention of the officials of the Jajpur district administration. The Jajpur district child protection unit was directed to inquire into the matter and submit a detailed report. Based on a written complaint

lodged by the concerned department. Dharmasala police registered a case and initiated probe into the incident. Police had rescued the baby girl Saturday and Sunday arrested all the five involved in the deal. The accused were produced in court Sunday and remanded to police custody, officials said. They informed that the health centre was not aware of the alleged sale.

Meanwhile the father of the newborn stated that poverty had forced him to sell his daughter.

'We already have three children. As I am a daily wager, so it will be very hard to look after a six-member family. So, we decided to give the newborn to the couple. They are relatives and well off. So we thought, they will be able to raise the girl in a proper manner," Natabar said.

author of a book on the merger of princely Tripura with Indian Union said Sunday, "The Maharaja announced April 28, 1947 that Tripura would be a part of Indian Union and on the same day sent a telegram to the secretary of the Constituent Assembly about his decision.'

Roy added, "Unfortunately, the prince died May 17, 1947. After his death, a group of highly placed employees, ministers and the stepbrother of the king in cahoots with the Muslim League hatched a conspiracy for inclusion of the state

with Pakistan., They tried to place a member of the royal family on the throne and sign a fresh agreement transferring the state to Pakistan Luckily, they failed to do so." Roy also said the Muslim League leaders had organised many meetings in Comilla and Noakhali districts currently in Bangladesh, for inclusion of Tripura with East Pakistan (then), and the communal riots sparked off in those areas resulted in large numbers of people fleeing to Tripura as refugees.

The Maharajas of the tribal state not only ruled over the presentday Tripura but also by virtue of having zamindari estates (in British Indian dominion), controlled large chunks of neighbouring districts of Comilla, Noakhali and Sylhet. These areas were awarded by the Radcliffe Commission to Pakistan.

Roy said the then president of Bengal Pradesh Congress Committee, Surendra Mohan Ghosh wrote a letter October 29 to Home $Minister\,Sardar\,Patel\,tipping\,him$ of the conspiracy. This was followed by a letter from Hindu Mahasabha leader Shyama Prasad Mukherji regarding the Tripura sit-

All these warnings led to Patel writing to the Governor of Assam, December 31, 1947 and subsequently the federal government rushing Air Force personnel to Tripura as a contingent measure.

Roy said several ministers were subsequently asked to resign, and one of them was asked by the Maharani to desist from entering the state. Finally, after one more year, the 'Instrument of Merger' for making Tripura a part of the Indian Union was signed October 15, 1949 by Maharani Kanchanprava Devi and the advisor of the Ministry of States, VP Menon.



HE dept brushes off rumours over reopening of colleges



Bhubaneswar, Jan 30: The state Higher Education (HE) Department Sunday issued a clarification regarding a fake letter circulating on social media platforms claiming that the department would reopen educational institutions across the state February 10.

Amid closure of such institutions in Odisha due to the Covid-19 situation, a fake letter was found doing rounds on various social media platforms regarding reopening of colleges and universities in the state from February 10.

"A fake letter is circulating in social media purportedly conveying decision of Higher Education Department to reopen colleges and universities from February 10, 2022. It is hereby clarified that no such decision has been taken by the state government," the department tweeted.

Many students reacted to the clarification by the department. Some students supported the department's decision by acknowledging the prevailing threat of the third wave of Covid-19 in state. They also suggested that the institutions should reopen after February at least, taking into account the situation at that time

On the other hand, some final year students pointed out that delay in reopening of their institution could potentially jeopardize their chances of pursuing their higher



10 officers to monitor BSKY in 37 hosps

Bhubaneswar, Jan 30: In a bid to efficiently implement the state government's Biju Swasthya Kalyan Yojna (BSKY), the Bhubaneswar Municipal Corporation (BMC) will appoint 10 officers across 37 hospitals in the state Capital, who will see to the smooth functioning of the policy.

Modern Health Care Hospital, Vision Care Eye Hospital, ASG Eye Hospital, Maa Shakti Hosptial, Sanjeebani Medicare Hospital, Sri Sri Baroda Hospital, Vikash Hospital, Hi-Tech Medical Hospital, Sunshine Hospital and Sparsh Multi Specialty Hospital.

"At least 10 senior officials have been designated different hospi-

tals. The officers will visit different hospitals under their jurisdictions at least once a month. The officers will submit a detailed report in respect to different aspects such as number of beneficiaries reported for their treatment, those who have availed treatment along with types of treatment availed whether fully or partially cashless by collecting feedbacks from different stake holders such as beneficiaries, medical staff, swasthya mitras and others," a notification in this regard read.

It can be mentioned that as per existing system, no document is required for cashless healthcare service in government facilities. The beneficiaries will have to produce the smart card or food security card at the empanelled private hospitals for availing cashless care up to annual financial limit, which will apply for one-year period from September 1 and after which it will

How did Omicron evolve?

he highly transmissible Omicron variant, which emerged with a host of unusual mutations in late November last vear, has been detected in more than 120 countries. Now, scientists are trying to find out how it evolved.


The spread of the Omicron variant around the world has been the fastest than any previous versions.

While on one hand, there's no transparent path of transmission linking Omicron to its predecessors, on the other, the variant has an unusual array of mutations, which evolved entirely outside the view of researchers, Nature reported.

In fact the variant is so different from earlier strains, such as Alpha and Delta, that evolutionary virologists estimate its closest-known genetic ancestor probably dates back to more than a year ago, sometime after mid-2020.

"It just came out of nowhere," Darren Martin, a computational biologist at the University of Cape Town, South Africa was quoted as

Understanding the origins of Omicron might help scientists to understand the risk of new variants emerging, and suggest steps to minimize it, said Angela



Rasmussen, a virologist at the University of Saskatchewan Vaccine and Infectious Disease

Organization in Saskatoon, Canada. "It's very difficult to try to mitigate a risk that you can't even remotely wrap your head around," she was quoted as saying.

Scientists have explored three theories relating to the origins of Although researchers have se-

quenced millions of SARS-CoV-2 genomes, they might simply have missed a series of mutations that eventually led to Omicron. Alternatively, the variant might have evolved mutations in one person, as part of a long-term infection. Or it could have emerged unseen in other animal hosts, such as mice

or rats, the report said. But as of now, whichever idea a

researcher favours "often comes down to gut feeling rather than any sort of principled argument" Richard Neher, a computational biologist at the University of Basel in Switzerland, was quoted as saying.

Researchers agree that Omicron is a recent arrival. It was first detected in South Africa and Botswana in early November 2021; retrospective testing has since found earlier samples from individuals in England on November 1 and 3, and in South Africa, Nigeria and the United States November 2.

An analysis of the mutation rate in hundreds of sequenced genomes, and of how quickly the virus had spread through populations by December, dates its emergence to not long before that -- around the end of September or early October

A study published in the journal Nature, suggested that the Omicron variant of SARS-CoV-2 diverged from previous SARS-CoV-2 variants as a result of adaptive evolution, in which beneficial mutations are passed onto future generations through natural selection, rather than through recombination between previous variants.

Shallow to moderate fog is very likely to occur at one or two places in coastal Odisha, Dhenkanal, Angul, Kandhamal, Rayagada, Kalahandi, Koraput and Malkangiri during this period.

normal. For coastal stations, it should be 15°C or less, or the departure is at least 4.5 notches from normal.

Bhubaneswar recorded 11.2°C, 4.9 notches below normal, while it was down by 3.6 to settle at 11.6°C in Cuttack, the Met office said.

The weatherman also warned that the cold wave would prevail in Kalahandi, Sundargarh, Jharsuguda, Keonjhar, Bargarh, Nuapada, Bolangir and Subarnapur districts till Monday.

There will be no large change in the minimum temperature in the next 24 hours and it will rise gradually by 3-5°C subsequently, the Met added.

Infant deaths from RSV much higher than thought: Study

RSV IS A COMMON VIRUS THAT PRODUCES COLD-LIKE SYMPTOMS AND IS MERELY A NUISANCE FOR THE VAST MAJORITY OF PEOPLE WHO CONTRACT IT. **BUT FOR BABIES - ESPECIALLY INFANTS IN LOW-AND** MIDDLE-INCOME **COUNTRIES WHO LACK ADEQUATE ACCESS TO MEDICAL CARE - THE VIRUS CAN BE FATAL**

early one in 10 of all deceased infants under six months were infected with Respiratory Syncytial Virus (RSV), according to a study.

RSV is a common virus that produces cold-like symptoms and is merely a nuisance for the vast majority of people who contract it. But for babies - especially infants in low-and middle-income countries who lack adequate access to medical care - the virus can be fatal.

Prior researches have estimated that about 1,20,000 infants die of RSV each year, but this figure is based on modelling conducted in hospital-based settings and does not account for RSV deaths that occur in the community, which are not captured in hospital-based surveillance.

surveillance.
In the new study led by Boston
University School of Public Health
(BUSPH), researchers have found
that the true burden of RSV infant
mortality is substantially higher
than what was previously believed.



The team used systematic surveillance to measure the presence of RSV among infants who died in medical facilities or in the community.

The findings, published in the journal The Lancet Global Health, showed that the virus was present in 7 to 9 per cent of infants under 6 months old and was primarily

concentrated in infants under 3 months old.

Notably, two-thirds of these deaths occurred in the community - that is, among infants who never received medical care in a hospital and were overlooked in previous facility-based surveillance.

old is important for two main reasons," said the study's principal investigator Christopher Gill, associate professor of global health at BUSPH.

"First, it is a reminder that these very young infants with very small airways are at particular risk of RSV infections anatomically. Second, both of the proposed new tools to prevent RSV infections - maternal vaccinations and infant monoclonal antibodies -- will be most effective immediately after birth and could wane after," Gill added.

The researchers enrolled 2,286 deceased infants, representing almost 80 percent of infant deaths in Lusaka from August 2017 to August 2020.

The study showed that RSV directly caused at least 2.8 per cent of all infant deaths, and 4.7 per cent of all infant deaths outside of hospitals. The majority of these were seasonal, occurring in the first half of the year, and were con-

Preventative measure like RSV vaccination of mothers who could pass on antibodies to babies would also be the most effective strategy to reduce infant mortality from the virus, the researchers said. There is no approved vaccine for RSV yet, but trials are underway.

Among the deceased, many died after slip ping down from the trains while some others committed suicide or were mowed down by trains while crossing the railway tracks. As a result, the railway tracks have turned out to be biggest claimants of precious human lives in the past four years. The deaths are mainly caused due to negligence of people.

Reports said Berhampur Railways Station is the largest railway station in south Odisha with over 70 trains plying daily through the station. The Government Railway Police (GRP) and Railways Protection Force (RPF) have been engaged to look after the security of the passengers and other persons visiting the railway station.

GRP has registered 269 cases of unnatural deaths during last four years from 2018 to 2021. Over 73 unnatural death cases were recorded in 2018

The jurisdiction of the GRP spreads up to a distance of 120 km, starting from Chilika in Khurda district, via Ganjam and Gajapati districts to Gunupur in Rayagada district. Many a people have died on the railway tracks passing through the jurisdiction of GRP in

The GRP has registered 269 cases of unnatural deaths between 2018 and 2021. Over 73 unnatural death cases were registered in 2018 out of which 62 persons died either due to slipping down from the train or while crossing the railway tracks.

Over 67 unnatural death cases were registered in 2019 out of which 43 persons died after slipping down from the train or while crossing the railway tracks

Over 57 unnatural death cases were registered in 2020, out of which 24 died either by slipping down from the train or while crossing the railway tracks. As many as 72 cases of unnatural deaths were registered in 2021 in which 41 persons lost their lives on the tracks.

Among them, nine persons have committed suicide on the tracks and 29 persons were moved down by speeding trains while crossing the railway tracks and three persons died after slipping down from train. The railway department is reg-

ularly sensitising the passengers through posters and leaflets urging them to not stand or sit near the doors of train carriages while travelling. However, hardly does anyone pay heed to it. As a result, passengers often slip down from moving trains and die on the tracks. Moreover, railway tracks have become an easy place for people wishing to commit suicide

When contacted, Jyoti Prakash Navak, IIC, GRP station said that the more the people will become aware the accident-related deaths will reduce in the state.

237 booths identified as hyper-sensitive

Keonjhar, Jan 30: While candidates have started door-to-door campaign for the upcoming panchayat polls, the administration has stepped up poll preparedness in Keonihar district. To ensure free and fair, peaceful conduct of elections, police have identified 237 booths as very sensitive in the district. MANY WOMEN LEADERS LOBBYING FOR PARTY TICKET AS MAYOR NOMINEE

Berhampur, Jan 30: The refusal of objections against the decision $\,$ to reserve the mayor post for only women in Berhampur Municipal Corporation (BeMC) in the upcoming urban local body(ULB) polls might spell trouble for the ruling BJD. This has created many rebels in the party. Hopes of those aspiring to contest for the post have vanished into thin air. They had wanted keep the post unre-

served, a report said. The post of mayor has been reserved for only female candidates in Berhampur Municipal Corporation. The state urban development department had issued a draft notification in this regard, January 12.

This time, the mayor will not be picked up by corporators. People will directly elect one. This has recurred after a gap of 30 years.

Some male aspirants of the ruling and other parties had objected to such reservation and challenged the draft notification on the ground



that the post of mayor had been reserved for women in the 2013 elections. However, the urban development department rejected the pleas and upheld its earlier decision in a notification published January 28.

The rejection of pleas has disappointed many male aspirants of various political parties who were expecting to get a ticket for the post to contest in the election. However, this decision has rather left more male aspirants of the ruling BJD fuming.

The fresh notification has angered them so much that they are openly venting out their displeasure before the party MPs, MLAs and district unit president. Observers apprehend that if the party leadleaders in time, then they might play spoilsport for the party nominee in the upcoming elections. Meanwhile, many aspiring

women leaders of the ruling party have started lobbying to get the party ticket as a mayor candidate. Among the prominent faces in the race for party ticket are Sanghamitra Dalai, BJD's district women's wing president, Mamata Bisoi, president of the zone comprising four districts in south Odisha, K Madhavi, former mayor, Jyotshna Nayak, deputy mayor, Sonali Gantayat, BJD's City women's wing president and several other women leaders. All of them are well educated and keep their fingers crossed for ticket.

Earlier, there used to be indirect election for the post of chairperson in this 155-year old civic body. The first direct election for the post of chairperson was held in 1992 when the Janata Dal government headed by Biju Patnaik was in power in the state.

NO MOBILE NETWORK IN RAYAGADA HILLY POCKETS

DIGITAL CAMPAIGN HIT HARD

Rayagada, Jan 30: In the absence of mobile network, digital campaign amid Covid curbs has indeed become arduous for candidates contesting panchayat polls in the remote hilly areas of Rayagada district. A case in point is here: Candidates hitting the electioneering trail are seen climbing atop a hill at Sandubadi bordering Andhra Pradesh to connect digitally with voters in the remote panchayats which receive signal from a mobile tower set up in a village in Andhra Pradesh, a report said.

Accompanied by their limited number of supporters, the candidates are travelling for five to 10 km daily and climbing the hill to access mobile signals received from a mobile tower at Kandukupa village under Gumma-Lakshmipur block in Vizianagaram district of Andhra Pradesh. There, they connect with the voters through social media.

As many as 13 panchayats bordering the neighbouring state are under Rayagada-B zone. People of Sandubadi, Kereda and Jemadeipentha panchayats bordering neighbouring state only get mobile signals from the tower in the Andhra village if they climb the hill.

The rest 10 panchayats --Durgapadu, Mirabali, Pipiliguda, Dangalodi, Karubai, Baisingh, Alubadi, Karli and Bairagi Halua - do not get signals at all.

As a result, the residents as well as the candidates have to suffer a lot due to lack of mobile connectivity. In this situation, many candidates are engaging their supporters to undertake door-to-door campaign at night to avoid getting caught by poll observers.

The candidates are uploading their photos, slogans and poll promises in social media platforms like Facebook, WhatsApp and Instagram, requesting voters to cast their votes in their favour. Many of the candidates are also accompany their kin and supporters in these villages, seeking for votes.

Candidates after getting symbols have launched campaign in their respective areas. They devised various strategies to woo

the candidates as campaign modes like rallies, public meetings and door-to-door visits involving mass gatherings will lead to spread of deadly virus.

As a result, candidates in various parts of the state have taken up digital campaign through social media platforms to connect with the voters. The digital campaign has proved beneficial for them as it saves a lot of time, and money. However, lack of mobile connectivity has proved digital campaign to be an uphill task for the candidates contesting in these remote panchayats

in the district. They have been forced to climb atop a hill at Sandubadi to get mobile signal from a tower in neighbouring Andhra Pradesh and connect with the voters through the

social media platforms. The candidates and the villagers have demanded that the state government to intervene and set up a mobile tower in their area.

Anand Bachel, naib sarpanch of Mirabali panchayat said that in the absence of any alternative they have to depend on Andhra Pradesh's mobile tower to connect with their kin and voters. Lack of mobile network has also proved deterrent in availing healthcare services, online studies for the children and other facilities.

Boris In the Dock

t goes to the credit of the British institution of democracy and the people's awareness of their democratic right to criticise, without fear or favour, the government of the day perceived to be indulging in wrongdoing. This is glaringly visible in the instance that two high level inquiries have begun into alleged breaches of CoVID-19 lockdown rules on gatherings in Downing Street - the Prime Minister's residence-cum-office - for which Prime Minister Boris Johnson is in the dock. By contrast, it also shows Indian democracy in a poor light as its democratic institutions, governments and ruling parties repeatedly flouted and continue to flout CoVID-19 protocols with impunity. The saddest part is that while Britain could put the searchlight on alleged wrongdoing when a miniscule number of people are believed to have gathered violating rules of social distancing at Downing Street during CoVID pandemic, India has witnessed such gatherings by hundreds of thousands in religious melas, elections and other political activities with the stated and unstated approval of the government and independent constitutional bodies. The powers that be did not even deign to take note of public criticism of these actions, let alone order any probe.

On the other hand, the probes instituted by the British Cabinet Office and thereafter the Metropolitan Police Services may decide the future of Johnson's tenure as Prime Minister. The fears that a cover-up operation may be mounted by Johnson and the findings of the probe watered down or doctored are not ruled out. But, the fact that the Prime Minister can be subjected to such public scrutiny under public and Opposition pressure for safeguarding the credibility of democratic institutions in Great Britain speaks volumes. Unfortunately, similar institutions are virtually in shambles in India as recent experiences have shown. The fall of the Election Commission

Metropolitan Police Commissioner Cressida Dick, who had earlier been ambivalent about any probe, finally announced officers were looking into "potential breaches of CoVID-19 regulations" in Downing Street since 2020. In fact, the investigation was launched after an internal inquiry led by civil servant Sue Gray passed information to the force. The PM, who understandably enough, maintained he did not believe he had broken the law, all the same welcomed the police probe which he asserted would clear the air.

But, the police inquiry is being interpreted as both a ploy to delay the publication of the report by Sue Gray and a confirmation of criminality of the parties held by Johnson. For months, the British PM has been facing criticism for reports of staff parties in Downing Street, some attended by him, when lockdown laws preventing the whole nation from holding birthday and other parties and gathering on social occasions were in force. The PM has, however, apologised for attending a "bring your own booze" event 20 May 2020, during the first lockdown, saying he thought it was a "work event." The Police Commissioner is still evasive about the number of parties being investigated by the force. Her statement that while breaches of regulations can result in fixed penalty notices, the police inquiry did not mean they would be issued "in every instance and to every person involved" does arouse suspicion about the real intent of the government. This is nothing but prejudging the case before the investigation is complete. Moving from conclusion to premise is a known tactic of whitewashing government or ministerial guilt. This has prompted Labour deputy leader Angela Rayner to renew calls for Johnson to resign and brand him as a "national distraction." Her argument that the police investigation itself points to "potential criminality" and "a truly damning reflection on our nation's very highest office" is not without substance. For, the terms of reference of the Cabinet Office's inquiry state if during the course of the work any evidence emerges of behaviour that is potentially a criminal offence, the matter will be referred to the police and the Cabinet Office's work may be paused. The moment the police announced its investigation the deputy Labour leader had no hesitation in telling the nation the Prime Minister has no reason

The report of the team led by senior civil servant Sue Gray, was expected to be released last week, but that schedule got derailed when the Metropolitan Police said they had opened an investigation into some of the events to assess whether criminal offences had been committed. Officials are working on ways to publish Gray's report without compromising the criminal investigation. But there are fears that the report may be watered down to save Johnson. The publication of the report may also be delayed which will give Johnson some elbow room to try and save his tenure. The police, however, maintained it had received information it had requested from the Cabinet Office to support its investigation. Assuring that the probe would be prompt enough, the police claimed it had not delayed the Cabinet Office probe report since "the timing of its release is a matter for the Cabinet Office inquiry team." The government's stand is that since it is an independent investigation, the government is not privy to the details of the investigation

It could be a government subterfuge to appear to be innocent about the two probes into what is now known as "partygate" scandal. This may help Johnson claim not to have influenced the probes in any way should be be cleared of the charges or let off with a minor penalty such as fine. But, what stands out as an object lesson to democratically minded people across the world is that Britain has at least the freedom to make anyone, no matter whether he or she holds the highest public office, subject to investigation and face the consequences for alleged wrongdoing. Here in India, it is an oft repeated saying the "The law will take its own course" while, in reality, law on its own can never decide on which path to adopt.

■ Rogue

et's take first the basic meaning of rogue, an unprincipled or dishonest man. This can be traced back to the sixteenth century, to a thieves' cant that invented a series of words for categories of villains. The rogue was said to belong to the Fourth Order of Canters and was a beggar, idle vagrant or vagabond. By Shakespeare's day it had become well established in standard English with a meaning much as today's, and had already developed a playful sense as a term of mild reproach. It's sometimes suggested that it was originally a Celtic word, and the Breton rog, haughty, is put in evidence (though that word is probably not the direct source, just its cousin); the related French word rogue is also suggested as an possible origin. But such theories have been superseded by a better understanding of the roots of cant. It seems it comes from a slang term roger, a beggar who pretended to be a poor university student in order to play on people's feelings. This can be traced to the Latin rogare, to ask (and so was said with a hard g, not like the proper name). Now to the elephants. There is a specific sense of rogue that refers to a solitary elephant that is savage or destructive. This can't be the source of our word, since it's only recorded in the nineteenth century, long after rogue had become part of the language. The Oxford English Dictionary suggests this sense was actually based on the existing meaning of rogue, perhaps influenced by the Sinhalese hora or sora, a thief.

THE COSTS OF CLOSED MINDS

ONE OF THE MAIN REASONS FOR THE UNEVEN RECOVERY HAS MORE TO DO WITH POLITICS **THAN ECONOMICS**

This year began amid widespread despondency about the resurgent COVID-19 pandemic and the struggling global economy, as well as premonitions of heightened political conflict in Eastern Europe, the Middle East, and even the United States. True, there is now some hope that the Omicron variant may be the pandemic's last hurrah. But troubling questions remain about the economic and political legacy of the crisis.

The World Bank's latest biannual Global Economic Prospects report, released last week, points to some possible answers. Produced by a team of talented economists, the report is one of the best summaries of the current outlook for the world economy. And while the report uses the diplomatic language of multilateral organisations, it nonetheless packs a powerful cautionary punch.

For starters, the World Bank forecasts that global economic growth will slow to 4.1% in 2022. from 5.5% last year. With debt burdens rising, supply-chain bottlenecks impeding the flow of goods and services, and inflation picking up, governments are losing the capacity to provide further fiscal support. The report warns that the surge in debt caused by countries trying to soften the "pandemic-induced global recession' means that several economies are now "at high risk of debt distress." Some may need relief.

The report also predicts that energy prices, which surged in the second half of 2021, will increase further – and by more than the World Bank was projecting six months ago.

Finally, the report's tables of summary statistics contain a lot of interesting information – in particular, data on major economies' recent GDP growth and forecasts for the next two years. The fastest-growing economies in 2021 were Argentina, Turkey, and India, which expanded by 10%, 9.5%, and 8.3%, respectively. But growth after a crash

needs to be interpreted carefully. Much of last year's growth merely reflected the depth of the pandemic-induced downturn of 2020, as economies climbed back toward their earlier GDP level. In 2020, Argentina's economy contracted by 9.9% and India's by 7.3% – making them, along with Mexico, the worst-performing major economies that year.

Usually, emerging market and developing economies, helped by their lower base, grow faster than advanced economies. But, according to Global Economic Prospects, the prognosis for EMDEs through the end of 2023 is worse than for advanced economies, because EMDEs have limited policy space to provide additional support and face greater risk of hard landings. Moreover, the pace of recovery is likely to vary significantly between countries. Once the dust settles after the current turmoil, therefore, there will most probably be new winners and los-

One of the main reasons for the uneven recovery has more to do with politics than economics.

From advanced economies such as the United States to EMDEs like Brazil, support for aggressive nationalism has grown sharply in recent years. This is bound to play a major role in determining how these economies perform.

While there are exceptions, hyper-nationalism is usually disastrous for an economy in the long run. This stands to reason, because strident nationalism leads to bloated egos and blurry thinking. Countries in its grip try to become self-sufficient by raising barriers to trade, capital, and ideas from elsewhere.

A striking historical example is Argentina, which was among the world's fastest-growing economies during the early decades of the twentieth century and was widely expected to overtake the US. That changed in 1930, when a military coup resulted in the installation of the hyper-nationalist Lieutenant General José Félix Uriburu as president. Tariffs subsequently rose, together with barriers to immigration. Argentina's open economy, now closed to the world, soon stagnated, and the US surged

The lesson seems even more relevant today. In a globalised world, with new ideas and research emerging everywhere, countries that succumb to nationalist solipsism and pull down their economies' and societies' shutters will be anything but great.

One of the remarkable achieve ments of post-independence India was that its founding fathers and early thinkers, like the first Prime Minister, Jawaharlal Nehru, and the author Rabindranath Tagore, were passionate advocates of openness to the world of ideas. They stood out, not just in India but globally, for their commitment to absorbing the best, from wherever it or they came, and to upholding a common human identity.

I remember a friend of my father's, who visited us regularly and held forth on the need for more strident nationalism. He was critical of Indian thinkers who, while opposing Western colonialism, argued that India must keep its doors open to the best of the West-in science, literature, and philosophy. One day, angry at his failure to persuade us, he thundered. "My motto is: the West does not follow us, so we must not fol-

low the West. I was in elementary school but even then, I could see that his aggressive nationalism had blurred his thinking into adopting a motto that contradicted it self. At a time when policymakers are confronting an ongoing public-health crisis, and in some cases the threat of violent turmoil, countries that succumb to hypernationalism lay the foundations of their own failure.

One, a family of four from Gujarat chasing 'better' jobs freezes to death in the US. ufacturing has suffered. The index for industrial production remains at a low. Educational qualifications have improved causing an aspirational problem. There were 70 million such persons in 2004-05 but increased to 115.6 million by 2017-18. They are growing by about 5 million a year, according to Santosh Mehrotra, Professor of Economics, Centre for Labour. He says what is most worrying is that manufacturing jobs actually fell in absolute terms from 58.9 million in 2011-12 to 48.3 million in 2015-16, a whopping 10.6 million over a mere fouryear period. Indeed, the job strategy has to

change. An interesting aspect is that because of the Modi government's less interference in PSU operations, even in the difficult COVID times 171 PSUs continued to have good profits despite better salary structure. This indicates that proper salaries could be paid even during crisis period and profits could be sustained. It also calls for reviewing the PSU disinvestment policy. The world has seen the failure of the global private sector for unethical practices since 2007-08 Lehman meltdowns.

The Finance Minister may open a new leaf. India has thrived with

abhors. No national economy can thrive without competition within. Monopolised private or public sector would cause inbreeding, leading to poor performance. 

Google, FB may be forced to pay British newspapers

New Delhi, Jan 30: Tech giants such as Google and Facebook will be required to pay newspapers and other media outlets for using their stories, under new laws being drawn up by the UK Government, Daily Mail reported.

Under the plans, which are modelled on a system that has been introduced in Australia, the platforms will be encouraged to negotiate payment deals with news organisations. If the negotiations fail, an independent arbitrator would set a fair price, the report said.

The move, being driven by UK Culture Secretary Nadine Dorries, comes amid growing concerns that the tech companies are dominating online advertising, to the detriment of consumers and businesses.

The new regime will be regulated by the Digital Markets Unit (DMU), the digital watchdog that was set up within the UK Competition and Markets Authority (CMA) to rein in the power of the

tech platforms, the report said. The unit will also investigate

the algorithms used by search engines such as Google, which many news organisations believe are manipulated to disproportionately direct search enquiries towards Leftleaning news organisations, and filter how people read and access news, to the detriment of quality, paid-for journalism, Daily Mail reported.

A source in the UK Department for Digital, Culture, Media and Sport said that the planned regime was 'pro-competition' and 'supports the sustainability of the press'. The source said: 'The new regime will be an important vehicle to tackle the imbalance of power between the largest platforms and publishers.

The measures would give publishers greater transparency over the algorithms that drive traffic and revenue, more control over the presentation and branding of their content, as well as greater access to data on how users interact with their content.

Srinagar, Jan 30: A top commander of the proscribed terror outfit Jaish-e-Mohammed (JeM) and a Pakistani national were among the five terrorists killed in two separate encounters in Kashmir's Budgam and Pulwama districts in a span of 12 hours, officials said Sunday.

Four JeM terrorists were killed in a gunfight with the security forces in Pulwama's Naira area, while one Lashkar-e-Taiba (LeT) terrorist was killed in another encounter in Budgam's Chrar-i-sharief area.

The terrorists killed in the encounter have been identified as --Zahid Wani resident of Karimabad. Waheed Ah Reshi from Khadarmuh, and Inayaitullah Mir from Nvira.

The Pakistani terrorist has been identified as Kafir alias Chotu. He was active in the area since 2020.

Zahid Wani was one of the main commanders of the JeM outfit after Lamboo and Sameer Dar, who were masterminds of the 2019 Pulwama attack, security forces said in a

Oppn to raise farmers' issues, Pegasus matter

New Delhi, Jan 30: The stage is set for a stormy Budget Session of Parliament that begins on Monday with the opposition set to target the Modi government on issues such as the Pegasus snooping row, farm distress and Chinese "incursions in eastern Ladakh.

The session will begin with President Ram Nath Kovind's address to the Lok Sabha and Raiva Sabha assembled together in the Central Hall and chambers of both the Houses in view of the Covid-19 situation. Given the ongoing third wave

of the pandemic, the Lok Sabha and Rajya Sabha will return to have separate sittings in shifts with members seated across both chambers of Parliament to ensure distancing norms.

The Lok Sabha will take up the discussion on the Motion of Thanks on the President's Address from Wednesday and Prime Minister Narendra Modi is expected to reply to the debate on February seven.

Lok Sabha secretariat officials said four days beginning February 2 have been provisionally allotted for the discussion on the Motion of Thanks on the President's Address.

The first part of the Budget Session will be held from January 31 to February 11 after which it will go into recess to examine the budgetary allocations for different departments. The Session would resume March 14 and con-



clude on April 8. The Budget Session is taking place amid a heated election campaign in five states - Uttar Pradesh, Uttarakhand, Punjab, Goa, and Manipur - which go to polls in seven phases from February 10 to March 7.

The main opposition Congress has declared that it will reach out to like-minded parties to raise issues such as farm distress, Chinese "incursions", demand for relief package for Covid-19 victims, sale of Air India and the Pegasus snooping row during the session.

Parliamentary Affairs Minister Pralhad Joshi and Rajya Sabha Chairman M Venkaiah Naidu are set to chair separate meetings with floor leaders of political parties Monday to ensure smooth functioning of the House during the

Minor ends life due to sexual harassment by TDP leader

Vijayawada, Jan 30: Suicide of a minor girl in Vijayawada due to sexual harassment by a leader of opposition Telugu Desam Party (TDP) has sent shock waves in the city while the ruling YSR Congress Party (YSRCP) has demanded harshest punishment to the culprit.

The 14-year-old girl jumped to death from fifth floor of her apartment building in Bhavanipuram area on Saturday. In a suicide note. which police later recovered from her bedroom, the student of class 9 wrote that she was ending her life due to sexual harassment by Vinod Jain, who resides in the same building. Police have arrested the accused, who contested the recent municipal elections as a corporator on TDP ticket.

He has been booked under Protection of Children from Sexual Offences (POCSO) Act.

The girl's grandfather said when he and his daughter were going for an evening walk she came to them and hugged her mother to say 'I love you'.

When the father and daughter duo returned home from walk they were shocked to learn that she ended her life from jumping down. He said the police recovered suicide note from her bed room in which she wrote how Vinod Jain was sexually harassing her.

Meanwhile, Andhra Pradesh State Women's Commission chairperson Vasireddy Padma said that the government has taken the incident seriously and that all efforts will be made to ensure that the culprit gets stringent punishment.

against the deadly virus. Though a number of drugs and other methods have been tried, no definitive treatment has emerged as yet. Since then, India has witnessed three waves of Covid-19, though the line of treatment has

remained the same throughout. Health Minister Mansukh Mandaviya Saturday said irre-

spective of the Covid-19variants, Test-Track-Treat-Vaccinate and Adherence to Covid Appropriate Behaviour' continue to remain the tested strategy for Covid-19 management. Several medical treatments were also tried to tackle Covid-19 but no widely accepted treatment has been seen till now. Recently, at a press briefing,

V K Paul expressed concern over the "overuse and misuse" of drugs. "The use of steroids can increase the chances of Mucormycosis (black fungus).



Lucknow, Jan 30: As election activity begins to peak in Uttar Pradesh, senior Congress leaders are keeping away from the campaign and the party leaders have no explanation for their absence.

Congress general secretary Priyanka Gandhi Vadra remains the only star campaigner for her party and her 'campaigning' so far, has been limited to the virtual world.

Party president Sonia Gandhi and former Prime Minister Dr Manmohan Singh top the list of star campaigners but there is no information of their programme in

"We do not know whether or not they will come for the elections in the state," said a party leader.

Other Congress leaders including Chhattisgarh Chief Minister Bhupesh Baghel, Rajasthan Congress leader Sachin Pilot and former Maharashtra Chief Minister Prithviraj Chavan have campaigned and addressed press conferences for the party but leaders named as star campaigners like Ghulam Nabi Azad, Salman Khurshid, Raj Babbar are conspicuous by their absence. Former Union ministers Jitin Prasada and RPN Singh have left the party alleging lack of direction and leadership'.

The party's "Ladki Hoon, Lad Sakti Hoon" campaign has already taken a severe beating with its poster girl Priyanka Maurya alleging that she was asked to pay bribe for a ticket. She has now joined the BJP.

A number of Congress candidates have either returned their tickets or have resigned in the past few days. The party's door-to-door campaigns at grassroots are yet to pick up momentum apparently due to lack of manpower.

The Congress contested the 2017 assembly elections in alliance with the Samajwadi Party, fielding its candidates on 114 seats for the 403member UP assembly. It won only seven seats, securing 6.25 per cent of the total votes and 22.09 per cent votes on seats contested.

Earlier in 2012, it had won 28 out of the 355 seats contested, securing 11.65 per cent of the

BJP deploys 10L workers with smartphones in UP

Five to six workers with smart phones have been deployed at each polling booth of Uttar Pradesh The saffron party has also formed its IT and social media teams at the block level in the poll-bound state.

A well-placed source in the BJP said that these 10 lakh workers with smartphones will reach out to each and every voter in their respective areas.

"We have formed a 21-member booth committee at each polling station. Among these, a minimum of five members have smartphones which has been made mandatory so that all the information reaches the ground at the booth level," he

Dehradun, Jan 30: Barely six months after becoming Uttarakhand's youngest chief minister in July last year Pushkar Singh Dhami finds himself facing the onerous task of piloting the BJP to a second consecutive victory in the assembly polls against a redoubtable opponent like Harish Rawat who leads the Congress' do or-die comeback battle.

Though Dhami is a fresh face and his six-month tenure gives a good account of him, achieving a huge target of getting more than 60 seats for the saffron party against a seasoned challenger like Rawat is anything but smooth.

Rawat had lost both the seats he had contested in 2017 but he continues to be one of the most popular faces in Uttarakhand politics. He has also emerged as the most

preferred chief ministerial face in several opinion poll projections Rawat is hopeful of reaping a rich harvest due to an anti-in-

cumbency working in favour of the Congress. He raises the issues of BJP giving three chief ministers to the state in five years despite coming to power with a big majority, unemployment and inflation wherever he goes

The trend of power oscillating between the BJP and the Congress every five years in Uttarakhand strengthens Congress's hope.

The BJP is confident of a win because of the big development projects launched for Uttarakhand in different sectors over the past five years. Its leaders at their virtual meetings appeal to people to give another five years to the 'double engine' government so that the projects which have the potential to change the lives of people could be completed.

However, the 46-year-old Dhami's task of recording an even bigger win for the party than in 2017 becomes more complex as he got a short span of just six months to perform and leave his mark

He admits he got little time to perform but has the satisfaction of spending each moment of his short tenure to serve 1.25 crore people of

"In a short span of just six months we took more than 550 decisions and acted on them. The previous Congress government only made announcements. They never saw the light of day while we acted on all the announcements we made." Dhami asserted.

Though his tenure is short, it has been full of challenges as he had quite a few contentious issues to deal with like the anger of the priest community which had been agitating for months demanding dissolution of the Chardham Devasthanam Board, the raging second wave of Covid and the after effects of a shoddily handled Haridwar Kumbh which had earned it the tag of a

Covid superspreader. Dhami also displayed his 'political disaster management' skills soon after coming to power when he constituted a committee headed by Manohar Kant Dhyani to listen to all stakeholders and resolve the contentious Devasthanam Board issue. Showing political acumen, he dissolved the Devasthanam Board and withdrew the related legislation to pacify angry priests who had already started preparations for contesting the polls.

Despite heading a cabinet of seasoned ministers far older than him, he succeeded in taking everyone along and keeping the BJP flock together with the only exception of Harak Singh Rawat who recently defected to Congress after being expelled from the party.

However, apart from propelling his party to a second consecutive victory at the polls, Dhami also has to break the trend of incumbent chief ministers losing the polls in Uttarakhand.

"Incumbent CMs never win in Uttarakhand. Nityanand Swamy lost in 2002, BC Khanduri lost in 2012 and Harish Rawat lost both the seats he contested in 2017," politi-

cal analyst JS Rawat said. ND Tiwari, the only CM of Uttarakhand to complete his full five-year term did not contest in 2007 when he was the sitting chief min-

"As tradition has it, CM candidates in Uttarakhand have to fight not only their opponents on the other side but also rivals within,"

PARTY WINS THE GANGOTRI CONSTITUENCY IN UTTARKASHI FORMS THE GOVERNMENT IN THE HILL STATE PRESS TRUST OF INDIA Dehradun, Jan 30: The Ganga originates in Gangotri, and so does

in Uttarakhand, it seems. According to a widely held notion associated with successive assembly polls, whichever party wins the Gangotri constituency in Uttarkashi forms the government in the hill state.

As Uttarakhand prepares to go

the road to government formation

to the polls February 14, the constituency is once again in focus, but this time it is witnessing a triangular contest with the fledgling AAP is in the fray, which, according to analysts, could put to test Gangotri's status as a bellwether seat.

BJP's Suresh Chauhan is pitted against the Congress' Vijaypal Singh Sajwan in Gangotri and AAP's chief ministerial candidate Col Ajay Kothiyal.

During the counting of votes in

the 2017 assembly polls also, there was immense interest in the result of Gangotri seat and after the victory of BJP candidate Gopal Singh Rawat, the party came to power under the leadership of Trivendra Singh Rawat with a huge mandate of 57 seats out of 70.

Gopal Singh Rawat died after a prolonged illness last year and the seat was vacant since then.

Chauhan exuded confidence that people will once again give their blessings to the BJP not only in Gangotri but throughout the state. Apart from the candidates, their

parties are also campaigning aggressively on the crucial seat. Chief Minister Pushkar Singh Dhami visited Uttarkashi Saturday and sought votes from the people

for the party. Congress nominee Sajwan is also busy in his election campaign and the leaders of his party are leaving no stone unturned to ensure his victory.



"We will win the Gangotri elections and form the Congress government," Sajwan said.

In the first assembly elections of the state held in the year 2002. Saiwan won on a Congress ticket and a Congress government was formed under the leadership of Narayan Dutt Tiwari.

In the year 2007, BJP candidate Gopal Singh Rawat won and his party came to power under the leadership of Major General Bhuvan Chandra Khanduri.

In the year 2012, Sajwan was once again victorious and the Congress came to power under the leadership of Vijay Bahuguna. In the next election in 2017, Gopal Singh Rawat won and Trivendra Singh Rawat's government was formed.

Political observer and professor Harshpati Doval says such 'myths' of bellwethers 'forecasting' the overall election result are common in electoral politics and do catch the imagination of

Like Gangotri, Badrinath seat in Chamoli district and Ramnagar seat in Nainital district have enjoved similar status. In 2002 and 2012, when Congress

Anusuya Prasad Maikhuri and Rajendra Bhandari won respectively, the government was formed by their party, while in 2007 and 2017, the BJP's Kedar Singh Fonia and Mahendra Bhat won and the BJP came to power.

Exactly the same results have come in Ramnagar seat as well. In the 2002 and 2012 assembly elections, Congress' Yogbar Singh Rawat and Amrita Rawat won, while in 2007 and 2017 BJP's Diwan_ Singh Bisht won and his party

Memories of bandits still fresh as Bundelkhand readies for polls

Jhansi, Jan 30: In Uttar Pradesh's Bundelkhand region the role of dacoits, who used to call the shots in the elections in the past 15 years, is nowadays not that significant but the memories are still alive.

Polling in Bundelkhand is scheduled to be held February 20 and 23 and all political parties are making all out efforts to secure a win.

Though Covid-19 has impacted the electioneering and it is dull, at times, parties' flags can be seen waving in the streets and slogans can also be heard. Bundelkhand has 19 Assembly

seats spread over seven districts.

In the 2017 Assembly polls, the BJP

had won all the seats in the region.

The saffron party has the chal-

lenge to retain the seats while the

opposition parties are sweating it out to open their account.

For the past 15 years, political leaders have been taking the help of dacoits to win the elections as the latter used to issue diktats in favour of their preferred candi-

Dacoits such as Dadua, Nirbhay Gujjar, Fakkad, Kusma Nain and Seema Parihar used to work for political leaders from the rugged terrain in the region.

Nirbhay Gujjar used to say openly that he gets messages from veteran leaders of the political parties, and he used to ask the villagers to vote for the party he had struck a deal with.

Nirbhay had even named a political leader after which he was killed in an encounter and his gang was eliminated.



Most of the dacoits, who used to play a key role in deciding who will win the polls, are either languishing in jail or have been shot dead. Therefore, dacoits are not

active this time but the memory

haunts many.


Bundelkhand's social worker Amit said that earlier villagers were forced to follow the diktats of the dacoits and vote as per their direction, but now the situation has

changed. Compared to earlier times, there is not even a one per cent impact.

An elderly resident of Madhogarh area of Jalaun district, said that in all types of polls -- panchayat, Assembly, Lok Sabha, dacoits used to issue diktats telling villagers the party to vote for.

'We used to be scared till the announcement of the poll results for if the poll results went in the opposite direction to the dacoits' wish, it would have invited trouble for us," he said. A resident on condition of anonymity said that when he was held hostage by a dacoit gang, many political leaders came to the outlaws asking for their support in the polls. The police also used to mediate between the dacoits and political leaders in lieu of money, he alleged.

4 killed as car driven by teen hits them

Hyderabad: Three women and a girl died when a car allegedly driven by a 16-year old hit a group of labourers sitting on a pavement in Karimnagar town on Sunday morning, police said. The incident happened at around 6.50 AM when the teenager lost control over the steering while rubbing his eyes due to thick smog in the area and rammed into a divider and hit those sitting on the pavement, they said. A police official said three women (aged between 27 and 32) and a 14year old girl died in the incident (three died on the spot while another died on way to being shifted to a hospital) and two others who were injured were admitted to a hospital.

New Delhi: Northwest India including Punjab, Haryana, Chandigarh, Delhi, and Uttar Pradesh will witness rainfall India Meteorological Department (IMD) said Sunday. "Scattered to fairly widespread light/moderate rainfall is very likely over Punjab, Haryana Chandigarh, Delhi and Uttar Pradesh during February 2 to 4," it said. The IMD also forecast an isolated hailstorm over Punjab, Haryana and northwest Uttar Pradesh February 3.

Man killed over FB post

Ahmedabad: A Muslim cleric was arrested from Delhi by the Gujarat Anti Terrorism Squad in connection with murder of a man in Gujarat's Dhandhuka town recently over an alleged objectionable Facebook post that the accused claimed hurt their religious sentiments, an official said. Kishan Boliya was shot dead by motorcycle-borne men January 25 in retaliation for a Facebook post he had shared January 6, for which some Muslim community members had filed a police complaint claiming it hurt their religious sentiments.

Four killed in fire

Jaipur: Four persons, including three children, were killed Sunday after a fire broke out in a small painting material packaging unit in the Jamwaramgarh area of the district, officials said. "The fire broke out in a hall constructed on a farmland. A man and three children, including his daughter, were burnt alive in the incident," Jamwaramgarh Circle Officer Shiv Kumar said.The deceased were identified as Ramesh (25), his daughter Jaya (3), and two other children -- Garima (3) and Kalu (4).



Fresh plea in SC seeks FIR against PM

New Delhi, Jan 30: A fresh plea has been moved in the Supreme Court seeking that it take cognisance of a news report in international media, in connection with the purchase of Pegasus spyware, and order an FIR against Prime Minister Narendra Modi.

The plea moved by advocate ML Sharma, lead petitioner in the pending Pegasus case, said the New York Times published a detailed report declaring that in July 2017, the Modi government purchased Pegasus from the Israeli firm.

'The report, published Friday, revealed that in 2017, India and Israel



agreed to a \$2 billion sale of a 'package' of weapons and intelligence gear. It further stated that Pegasus and a missile system were the 'centre-pieces' of this deal. In April 2017, it was reported that India had inked a \$2 billion deal with Israel Aerospace Industries for supply of air defence missiles to the Indian Army," said the plea.

The plea seeks registration of FIR "to recover public money paid for the impugned deal and prosecute concerned persons including Narendra D Modi in accordance of law".

"That petitioner has also filed an application to issue a letter rogatory to Israeli Court for securing necessary evidence secured by the

government during its raid upon NSO office and other places. Which

is still pending," the plea added.
On October 27, the top court said it was compelled to take up the cause to determine the truth, as it appointed an independent expert technical committee supervised by a retired top court judge, Justice RV Raveendran, to probe the Pegasus snooping allegations.

It has authorised the technical committee to devise its own procedure to effectively implement and answer the terms of reference. The committee can hold an investigation it deems fit and take statements of any person in connection with the inquiry and call for records of any

Justice Raveendran is oversee ing the functioning of the technical committee and he is assisted by Alok Joshi, former IPS officer, and Dr. Sundeep Oberoi, Chairman, Sub Committee in (International

Organisation Standardisation/International Electro-Technical

Commission/Joint Technical Committee). The three members of the technical committee are Dr. Naveen Kumar Chaudhary, Professor (Cyber Security and Digital Forensics) and Dean. National Forensic Sciences University, Gandhinagar, Gujarat, Dr Prabaharan P., Professor (School of Engineering), Amrita Vishwa Vidyapeetham, Amritapuri, Kerala, and Dr Ashwin Anil Gumaste, Institute Chair Associate Professor (Computer Science and Engineering), Indian Institute of Technology, Bombay, Maharashtra. A batch of petitions including those by advocate Sharma, CPI-M MP John Brittas, journalist N Ram, former IIM professor Jagdeep Chokkar, Narendra Mishra, Paranjoy Guha Thakurta, Rupesh Kumar Singh, SNM Abdi and Editors Guild of India were filed seeking an independent probe into the Pegasus snooping allegations.

No tie-up with NCP-Shiv Sena for Goa polls: PC

New Delhi, Jan 30: Senior Congress leader P Chidambaram Sunday said an alliance could not be forged between his party and the NCP-Shiv Sena for the Goa Assembly polls despite best efforts but asserted that they "will remain friends" and after the elections, the Congress would continue to explore opportunities to "work together" with them.

Chidambaram, who is the Congress' senior election observer for the Goa Assembly polls, also hit out at the TMC for its barbs at the Congress for not forging an alliance with it, saying the party continued to poach Congress leaders, despite making an offer of a tie-up.

The senior Congress leader said he received no instructions from the party leadership to hold talks with the Trinamool Congress (TMC) and added that, "I am sure our leadership had taken into account all the facts and circumstances".

In an interview with PTI Chidambaram said that among all the States and UTs, Goa registered the lowest in real GDP growth in



2019-20, the year for which data has been published by the RBI, and asserted that Goans "deserve better"

He also said that whether the Congress would announce a chief ministerial name before or after the elections would be decided after consulting all the candidates and the party would go by the consensus among them.

He also asserted that the contest in the Goa polls is "between the Congress (plus Goa Forward Party) and the BJP and we will be able to win a simple majority".

Asked why the Congress was not able to tie up with other Opposition parties especially the Nationalist Congress Party (NCP) and the Shiv Sena, Chidambaram said the NCP and Shiv Sena are the Congress' allies in Maharashtra and it would have liked them to be allies in Goa as well.

EC TO REVIEW BAN ON PHYSICAL RALLIES, **ROADSHOWS TODAY**

New Delhi, Jan 30: The Election Commission will meet Monday to assess the Covid-19 situation in the five poll-going states and decide on whether to continue the ban on physical rallies.

The Commission may also decide on whether fresh relaxations can be extended to political parties and candidates in holding physical campaigning events.

Citing the rise in Covid-19 cases, the poll panel had imposed a ban on physical rallies and roadshows when it announced the poll schedule for Uttar Pradesh, Uttarakhand, Goa, Punjab and Manipur January 8.

During its last meeting January 22, it had extended the ban on physical rallies and roadshows till January 31 in the five states but had allowed public meetings with a maximum of 500 people in the constituencies going to polls in the first two phases and relaxed doorto-door campaign rules.

The Commission has been reviewing the situation regularly and has been granting relaxations to ensure that the virus does not spread and parties get an opportunity to hold physical campaign-

HINDU MAHASABHA **PAYS TRIBUTE TO** NATHURAM GODSE

Bhopal/Gwalior, Jan 30: On a day the nation observed Mahatma Gandhi's death anniversary, the Hindu Mahasabha Sunday paid tribute to his assassin Nathuram Godse and a co-accused in the Gandhi murder trial, Narayan Apte, in Madhya Pradesh's Gwalior by observing "Godse-Apte Smriti Diwas".

The right-wing organisation also bestowed "Godse-Apte Bharat Ratna" in Gwalior upon jailed religious leader Kalicharan Maharaj who was arrested last December for allegedly making derogatory remarks against the Mahatma during a Dharma Sansad held in Chhattisgarh capital Raipur, and four leaders of the Mahasabha.

"We performed 'aarti' of Bharat

Mata with a resolve to integrate India with Pakistan to make it 'Akhand Bharat'. We are observing January 30 as the 'Godse Apte Smriti Diwas' day to express our anger over their arrest on January 30, 1948," Hindu Mahasabha's national vice president Jaiveer Bharadwai told PTI over the phone from Gwalior. The country Sunday paid tribute to the Father of the Nation on his 74th death anniversary. Last November, the Hindu Mahasabha had said it will sculpt a statue of Nathuram Godse using the soil brought from Haryana's Ambala Central Jail, where he was hanged to death in 1949. In November 2017, Gwalior district authorities had confiscated Godse's bust foiling the right-wing outfit's attempt to turn its office into a 'temple' of Godse.

Testing times for Adityanath

What was looking like a cakewalk once for the BJP in Uttar Pradesh once, is turning out to be its Waterloo. The BJP tried to ward off anti-incumbency in some of the states by changing Chief Minister prior to the February-March 2022 polls. In Uttarakhand, the BJP even changed three Chief Ministers within a period of one year but Goa and Manipur spared. But the leadership is breaking its head as BJP's social engineering narrative is falling apart. The BJP high command had toyed with the idea of changing the leadership in Uttar Pradesh last year itself. Yogi Adityanath even sounded out about it in the middle of 2021. Sensing trouble, Yogi

rushed to Delhi and made a special presentation before the Prime Minister. It transpires that RSS was averse to change in leadership as Yogi has emerged a Hindu icon. The proposal was dropped. When the BJP swept polls by polling 41% of popular votes and obtaining 325 seats, Narendra Modi was the poll mascot. The BJP had come a long way after the Mandal Commission report was implemented by V P Singh in 1990 and L K Advani took "Kamandal" in his hands to retrieve the political challenge. Narendra Modi had ensured that the Mandal politics took a back seat since 2014 and a different narrative had been creative. But the Mandal is back to haunt the BJP. It is visible in the distribution of tickets too. The BJP leadership is confident of retaining the state saying that Uttar Pradesh is not West Bengal where it fought elections mostly on the strength of leaders and workers imported from other parties. In Uttar Pradesh, the BJP worker is active in every nook and corner.

Omicron heading towards endemic stage

Prof. N K Arora, head of the country's National Covid Task Force and Chairman of the INSACOG, has completely dismissed the reports appearing that Covid will end by February 15. He said the country is in

the midst of the "omicron wave" affecting as many as 92%-95% cases from across the country are detected with the virus. However, Prof Arora, himself avoided giving a date saying he wouldn't be able to give a specific time-frame when this pandemic will end. Other experts also said the same and asserted that the Omicron wave is better than the Delta variant which was dominant during the second Covid wave. However, the genome sequencing data showed that Omicron has spread in India simultaneously and all across the country. Other experts also suggested that Omicron spread so rapidly largely because it leads to asymptomatic infection; thereby many are spreading it without knowing.

Amarinder loses sheen

Former Punjab Chief Minister Captain Amarinder Singh has come in poor light during a series of media interactions in the recent past and showed chinks in his armory. Though he answered all uneasy questions with complete ease and finesse and did not mince words, he was found wanting. While lambasting his successor Charanjit Singh Channi for his alleged involvement in the Sand scam, a reporter asked him why he did not take action against him when he himself was Chief Minister for such a corrupt practice,

Captain admitted his mistake. He took the blame on himself for not acting against Channi then but failed to explain why. Then came the classic case of Channi's alleged "MeToo moment" in which the Captain revealed that a bureaucratic couple came and complained. When he summoned Channi in this regard, he profoundly apologised and he pardoned him rather than lodging a police complaint or holding an inquiry. Here too, the Captain disclosed that he brought the matter to the notice of Sonia Gandhi. This was a serious issue but it did not show Captain as a true leader who hushed up the case then. Then came the Sidhu moment and he disclosed that the recommendation to make him Minister was sent from Pakistan. However, many wonder how Captain took the high moral ground when he himself had been closely associated with a Pakistani journalist. The BJP leaders are not too happy with it either. They feel that the Captain should have focused on national security issues and dangers to Punjab.

BJP no more a **Hindu party in Pb**

The BJP is virtually on the rampage in Punjab as it came out of the shadow of the Akali Dal after 40 years. Secondly, it is not a Hindu Party anymore. It is admitting members of the Sikh Community in large

numbers. If it admitted 75 year old Gen J J Singh into the party the other day, it also welcomed Chief of Damdami Taksal, Harnam Singh, once headed by Jarnail Singh Bhindranwale. His admission raised a lot of eye-brows. But the BJP remains unruffled. The BJP's two major allies, former Chief Minister Capt Amarinder Singh and Sukhdev Singh Dhindsa are also prominent Sikh leaders.

Why are BJP's Brahmin leaders out in the cold

When the list of BJP's star campaigners was released, four names were strikingly missing. The names of two BJP Gandhis' were published. But it did not come to light that even a senior Brahmin leader, former BJP UP Chief and senior Cabinet Minister Mahendra Nath Pandey was dropped too. Varun Gandhi's dropping was understandable. The BJP leaders were shocked but chose to look the other way. The high command thought of sending him a notice. But the idea was dropped until March 10. It was decided that the party will focus on backwards and social engineering formulas in the wake of a series of defections of its leaders to Samajwadi Party. Even Jitin Prasada who was imported from the Congress with big fanfare, was missing from the list.

More than 300 migrants saved

Arguineguin (Spain): Spain's sea rescue service Wednesday picked up more than 300 migrants trying to reach the Canary Islands in rickety boats, with nine of them clinging to a semi-sunken dinghy. The rescue service said it was unaware of any drowning as reported by a rights group. Helena Maleno, founder of the Walking Borders migration monitoring group, said 18 people had died trying to make the perilous crossing to the island of Lanzarote from Africa.

Russia Covid cases hit all-time record

Moscow: Russia's daily count of new coronavirus infections surged to more than 121,000 Sunday, an eightfold increase compared with the beginning of the month as the highly contagious omicron variant spreads through the country. The state coronavirus task force reported 121,288 new infections over the past 24 hours - an alltime high and 8,000 more than a day earlier. The country's infection numbers have rocketed since early January, when only about 15,000 new cases per day were tallied.

Portugal chooses new government

Lisbon: Portuguese voters went to the polls Sunday in an early election that looked set to produce another vulnerable minority government, just as the country is poised to start spending a huge windfall of European Union funds. That outcome would leave Portugal back where it started two months ago, when lawmakers rejected the minority Socialist government's spending bill and the country's president dissolved parliament. The center-left Socialists and their main rivals, the centerright Social Democratic Party. were in a tight race, opinion polls suggested.

Christian priest shot dead in Pak

Peshawar: A Christian priest was shot dead and another wounded by unidentified gunmen who opened fire on them as they were returning home from Sunday mass in Pakistan's northwestern Peshawar city, police said, describing it as a "terrorist act". Bishop William Siraj was shot multiple times and died on the spot.

Seoul, Jan 30: North Korea conducted its largest missile test since 2017 Sunday, sending a suspected intermediate-range ballistic missile soaring into space, seen as taking the nuclear-armed coun-

try a step closer to resuming long-

range testing South Korea's Joint Chiefs of Staff reported that a projectile believed to be a single ballistic missile was launched about 7.52 am (22.52 GMT) from North Korea's Jagang Province toward the ocean

off its east coast.

South Korea's National Security Council (NSC), which convened a rare emergency meeting presided over by President Moon Jae-in, said the test appeared to involve an intermediate-range ballistic missile (IRBM), which North Korea has not tested since 2017.

The launch takes North Korea a step closer to fully scrapping a self-imposed moratorium on testing its longest-range intercontinental ballistic missiles (ICBMs). Moon said.

He noted that this month's flurry of missile tests was reminiscent of the heightened tensions in 2017, when North Korea conducted multiple nuclear tests and launched its largest missiles, including some that flew over Japan.

North Korean leader Kim Jong Un has said he is no longer bound by that moratorium, which included a stop to nuclear weapons tests and was announced in 2018 amid a flurry of diplomacy and summits with then-US President Donald Trump.

North Korea's rulers suggested this month they could restart those testing activities because the United States and its allies had shown no sign of dropping their hostile policies. The United States condemns these actions and calls on (North Korea) to refrain from further destabilising acts, the US mil itary's Indo-Pacific Command said in a statement after Sunday's launch.

A US State Department spokesperson said the launch demonstrates the threat posed by North Korea's unlawful weapons of mass destruction and ballistic missile programmes, and called on Pyongyang to engage in sustained and substantive dialogue.

South Korea's JCS and Japanese Chief Cabinet Secretary Hirokazu Matsuno separately said the missile is estimated to have reached an altitude of 2,000km and flown for 30 minutes to a distance of 800km. IRBMs typically have ranges of 600 to 3,500 miles, while ICBMs have ranges exceeding 3,500 miles.

UK mulls major NATO deployment

London, Jan 30: Britain is considering making a major NATO deployment as part of a plan to strengthen Europe's borders in response to Russia massing troops on the border with Ukraine, the government said Saturday.

Britain has said that any Russian incursion into Ukraine would be met with swift sanctions and would be devastating for both sides.

Prime Minister Boris Johnson is due to visit the region next week, and also will speak to Vladimir Putin by phone.

Johnson is considering the biggest possible offer to members of the NATO defence pact in the Nordics and Baltics, which would double troop numbers and send defensive weapons to Estonia, his office said.

"This package would send a clear message to the Kremlin - we will not tolerate their destabilising activity, and we will always stand with our NATO allies in the face of Russian hostility," Johnson said in a statement.

'NATO wants to drag

Moscow: Russia's foreign minister claims that NATO wants to pull Ukraine into the alliance, amid escalating tensions over NATO expansion and fears that Russia is preparing to invade Ukraine. Truckers throng Ottawa to decry Covid mandates

Ottawa, Jan 30: Hundreds of trucks and thousands of people blocked the streets of central Ottawa Saturday as part of a self-titled Freedom Convoy to protest vaccine mandates required to cross the US border.

Canadian media said the PM and his family had been escorted out of their home and taken to a secret location in the capital, with much of the protesters' wrath directed at Trudeau

Flying the Canadian flag, waving banners demanding Freedom and chanting slogans against Prime Minister Justin Trudeau, the truckers were joined by thousands of other protesters angered not only by Covid-19 restrictions but by broader



discontent with the government.

An enormous clamor rang out as hundreds of big trucks, their engines rumbling, sounded their air horns non-stop.

Closer to Parliament, families calmly marched on a bitterly cold day, while young people chanted and older people in the crowd banged pots and pans in protest under Trudeau's office windows.

The protest originated last week

in western Canada, where dozens of truckers organised a convoy to drive from Vancouver to Ottawa to demonstrate against Covid-related restrictions, particularly a vaccination requirement for truck drivers.

Both Canada and the United States imposed that requirement in mid-January, affecting drivers who cross the 9.000-km border -the world's longest.



Coal import drops 22.5% in November

New Delhi: The country's coal import declined by 22.5 per cent to 15.78 million tonne (MT) in November 2021 compared to 20.35 MT in the same month of last vear. "India's coal and coke imports during November 2021 through the major and non-major ports are estimated to have decreased by 22.5 percent over November 2020," mjunction services said. On a month-onmonth basis, coal imports in November 2021 increased marginally by 0.21 per. During April-November period of the current fiscal, total coal and coke import stood at 138.87 MT, about 1.25 per cent higher than previous year.

Steel output surges 18% to 118 MT in '21

New Delhi: India's crude steel production rose by nearly 18 per cent to 118 million tonne . (MT) in 2021, while world leader China recorded a 3 pei cent decline to 1 032.8 MT, according to worldsteel. India, which is the second largest steel producing nation, had manufactured 100.3 MT steel in 2020 and China had produced 1 064.7 MT of steel in the same year, World Steel Association said in its report. Out of 1,950.5 MT, the top ten steel producing countries jointly produced 1,624.8 MT, the rest came in from other steel producing member nations.

Meanwhile, the Atlanta Federal Reserve's GDPNow forecasting model, released Friday, projected a 0.1 per cent growth in the first quarter, a rapid slowdown from the 6.9 per cent annual rate of growth during the final quarter

For the year as a whole, Bank of America sees a US GDP growth of 3.6 per cent, down from its prior expectation of 4 per cent, citing the Omicron surge, along with the expected path of inventories and the outlook for fiscal spending, which is set to slow sharply.

New Delhi, Jan 30: Investments in Indian capital through participatory notes (P-notes) rose to ₹95,501 crore till Decemberend and experts believe that flow is expected to be "flat to negative" next month.

P-notes are issued by registered foreign portfolio investors (FPIs) to overseas investors who wish to be a part of the Indian stock market without registering themselves directly. They, however, need to go through a due diligence process.

According to Securities and Exchange Board of India data, the value of P-note investments in Indian markets -- equity, debt and hybrid securities -- was at ₹95,501 crore by December-end as compared to ₹94,826 by November-end.

Abhay Agarwal, Founder and Fund Manager, Piper Serica, a Sebi-registered PMS, said P-notes data for December suggest a flattish trend. It suggests equity inflows of about ₹675 crore and debt inflows of about ₹716 crore.

This positive inflow is surprising since FPIs were aggressive sellers in equity and debt segment throughout December with net outflows of ₹19,026 crore and ₹11,799 crore, respectively.

P-notes had invested to the tune of ₹1.06L cr At the same time, it is difficult to extrapolate the numbers for one month into a longer-term trend. The P-note flows are expected to be flat to negative in the month of

New Delhi, Jan 30: Exports of marine products jumped 35 per cent to \$6.1 billion during April-December 2021 as compared with \$4.5 billion in the same period of the previous year, the commerce ministry said Sunday. In December 2021, the exports grew 28 per cent to \$720.51 million.

"Frozen shrimps constitute the major share in India's marine products exports items with 74 per cent share in value terms," it added. Other major items include Frozen Fish (7 per cent) and Frozen Squid (5 per cent).

The Pradhan Mantri Matsya Sampada Yojana (PMMSY), launched in May 2020, has set a target of ₹1 lakh crore fisheries export, additional 70 lakh tonne fish production, and generation of 55 lakh employment in the years to come.

In a separate statement, the ministry said India's export of final consumer food products such as Ready to Eat (RTE), Ready to Cook (RTC) and Ready to Serve (RTS) stood at \$2.14 billion in 2020-21. It

The five-top destinations for exports of marine products include the US, China, Japan, Vietnam and Thailand

stood at \$1 billion in April-October 2021-22, compared with \$823 million in April-October 2020-21.

The products covered under the $\,$ ready to eat (RTE) category include biscuits and confectionery, jaggery, breakfast cereals, wafers, pan masala and betal.

The main markets for these goods include the US, Malaysia, the UAE, Sri Lanka, Australia, Sudan, the UK, Singapore and Nepal.

"Malaysia imported jaggery worth of \$5.09 million and Nepal imported wafers worth of \$3.5 million in 2020-21," the ministry said.

Further, the major exporting destinations for RTC export in 2020-21 are the US (\$18.62 million), Malaysia (\$11.52 million), the UAE (\$8.75 million), Indonesia (\$7.52 million), and the UK (\$7.33 million).

Automakers to suffer from chip, labour crunch

New Delhi, Jan 30: With Covid-19 continuing to impact the global economy in its second year, the automotive semiconductor market will experience uneven shortages and tight supply amid labour shortfall, according to a new IDC report.

The general theme for semiconductors in 2021 was shortages in mature process technology nodes. The IDC expects tight semiconductor supply to continue through the first half of 2022 as the industry builds up inventory to normal levels.



The automotive market continues to be impacted as chips move upstream, limiting automobile manufacturing and driving original equipment manufacturers (OEMs) to utilise their semiconductor supply for higher value vehicles, which raised the average selling price of vehicles for 2021.

Automotive semiconductors will continue to be a limiting constraint on the automotive market through the first half of 2022, but barring any unforeseen shutdowns or semiconductor manufacturing issues, supply should gradually improve

runs in the last 48 balls with seven wickets in hands, but ended up drawing the match with just a wicket left.
