
Actor Bhumi Pednekar says she wants

New Delhi: The National Eligibility-cum-Entrance Test (NEET) for admissions to post graduate medical courses will be held May 21, the National Board of Examination in Medical Sciences (NBEMS) announced Friday, a day after the Union Health Ministry sought postponement of the exam by six to eight weeks. Pursuant to the directions of the Health Ministry vide its letter dated February 3, the conduct of NEET-PG 2022 examination which was earlier notified to be held March 12 stands rescheduled. The NEET-PG 2022 shall now be conducted May 21 from 9 am to 12.30 pm, the notice issued by the NBEMS Friday read. The online application window for submission of applications for NEET-PG 2022 which was earlier notified to be closed February 4 (till 11.55 pm) shall now continue till March 25 (till 11:55 pm), it said. The Union Health Ministry had Thursday asked the National Board of Examination to postpone the NEET PG 2022 by six to eight weeks or suitably since it is clashing with the NEET PG 2021 counselling.



New Delhi, Feb 4: The government is committed to forming a panel on Minimum Support Price (MSP) and the Election Commission has said it can be done after the polls are over, Agriculture Minister Narendra Singh Tomar said in the Rajya Sabha Friday.

While announcing the repeal of three farm laws in November last year, Prime Minister Narendra Modi had promised to set up a committee to discuss the farmers' demand for a legal guarantee on MSP. Replying to a supplementary ques-







in the week commencing February 21. A bench comprising Justice AR Masoodi and Justice NK Jauhri passed the order on the PIL moved by Karni Sena's vice president Sangeeta Singh. The petition sought a ban on the re-

lease of the movie, alleging it was presenting a 'wrong and vulgar' picture of Prithviraj, a Hindu emperor, and hence it hurt sentiments. The petitioner said the preview of the movie itself

shows that it is controversial. Prithviraj is an Akshay Kumar starrer Hindi film.

This is the second time that the Karni Sena is opposing the release of a film.

In 2017, the outfit had mounted a strong protest against *Padmavati*, directed by Sanjay Leela Bhansali and starring Deepika Padukone.

REHAB OF HIRAKUD DAM OUSTEES

NHRC serves notice on Odisha, Ch'garh

Bhubaneswar, Feb 4: The National Human Rights Commission (NHRC) has served notice on the Chief Secretaries of Odisha and Chhattisgarh besides the District Magistrates of Sambalpur, Jharsuguda, Bargarh, Sundargarh and Subaranpur in a case relating to the rehabilitation of people displaced by the Hirakud Dam project one of the oldest unresolved issues of displacement in the country.

While hearing the almost fiveyear-old petition filed by senior lawver Radhakanta Tripathy, the commission expressed displeasure over a report submitted before it by Odisha Chief Secretary recently.

"It is saddened to note that even after 60 years, thousands of displaced families have not been rehabilitated nor granted compensation as promised by the government of Odisha, their lives have become miserable," said the rights body.

The NHRC has questioned the de cision of the Odisha government to dismiss a large number of ap-



want of documentary proof. "It's quite impossible to show the documentary proof after 65 years of displacement. Neither the government has all the records of displacement, nor any survey has been undertaken on the issue," said the commission.

The commission has directed the Odisha Chief Secretary to pay compensation to as many as 13,740 displaced families who are yet to receive compensations and submit the Action-Taken Report (ATR) within eight weeks. The NHRC has also sought reports on a few other issues as well.

This apart, the NHRC has directed the District Magistrates of Sambalpur, Jharsuguda, Bargarh, Sundargarh and Subaranpur to take up the issue 'constructively' and submit compliance reports on directions of the commission regarding rehabilitation and compensation to the displaced families.

On the other hand, the Chief Secretary of Chhattisgarh has been asked to submit a report elaborating measures taken by it to address the grievances, mostly related to amenities, of the residents of all 20 affected villages of both Surguja and Raigad districts within

Notably, Tripathy had moved the NHRC drawing its attention to the incomplete rehabilitation of 26,561 families displaced for construction of the Hirakud Dam project the land for which was acquired

Planetariums to reopen Feb 8

Bhubaneswar, Feb 4: In what would be good news for space lovers and space enthusiasts, the Pathani Planetarium, Bhubaneswar, Dr. APJ Abdul Kalam Planetarium, Burla and Pathani Samanta Museum, Khandapara will be open for public from February 8, 2022 on all days except Mondays in keeping with COVID safety protocols.

Subhendu Pattnaik, Deputy Director of Pathani Samanta Planetarium, Bhubaneswar said planetariums will run with 50% seating capacity in every show at Pathanii Samanta Planetarium, Bhubaneswar, and Dr APJ Abdul Kalam Planetarium, Burla. Wearing masks for the entire period of visit shall be compulsory for the visitors, he added.

Earlier, in accordance with the state government order, the Pathani Samanta Planetarium here, APJ Abdul Kalam Planetarium in Burla and Pathani Samanata Museum in Khandapara were closed for visitors with effect from January 10 until further order

This decision was taken as a precautionary measure against the spread of new Covid variant Omicron which has been a cause of concern for the state, said Laxmidhar Das, director of Pathani Samanta Planetarium.

State power tariff among the highest in India: Citizens' body

Bhubaneswar, Feb 4: The Odisha Janshakti Manch (OJM), a citizens' group, has appealed to the Odisha Electricity Regulatory Commission (OERC) that power consumers in the state are paying more tariff in comparison to their counterparts in other states of the country.

Even though Odisha is a power surplus state, households consume less than 200 units of electricity per month and pay ₹945. However, the consumers in Andhra pay ₹620 while people in Delhi get power free of cost. The households in Chhattisgarh pay ₹861 and people in Punjab pay ₹672 as power bill. The households in Tamil Nadu get 100 units of free electricity bimonthly,

claimed the outfit. The outfit further claimed that the power tariff in Odisha is very high as the rates are determined by the OERC in accordance with the estimation and projection of expenses provided by the distribution and transmission companies. The cost-based tariff concept and the actual cost of the DISCOMs have not been given priority during tariff fixation, it said.

'No audit has been taken up to find out the exact expenses and

losses incurred by the DISCOMs. The rates were drastically reduced in Delhi after an independent audit. Hence, an independent audit must be conducted in Odisha before any rate revision," the outfit added.

While many developed states provide power free of cost for agricultural purposes, while Odisha taxes its farmers heavily. Farmers in Punjab, Karnataka and Maharashtra consume 30 per cent of power for agricultural activities while the figure is 2 per cent in Odisha. Agriculture in Odisha remains backward due to high electricity tariff, it said.

"There is no mention of assets worth ₹20,000 crore created from the public funds through government grants and investments in the audit report submitted in agreement with TATA Power, the new power distribution company,"

Chilika home to many endangered species

Bhubaneswar, Feb 4: Chilika lake, Asia's largest brackish water lagoon, has re-established itself as the one of the hotspots of biodiversity and shelters a number of endangered species listed in the IUCN red list of threatened species. The lake is a unique assemblage

of marine, brackish and freshwater eco-system with estuarine char acters. The lagoon houses about 155-165 dolphins and 10.5 lakhs water birds of 105 species.

"For the first time, near-threatened ferruginous ducks and a group of Eurasian otters were spotted in the lagoon in the 2022 Flora and Fauna Survey in Chilika Lake carried out February 1," an official in the Chilika Development Authority (CDA) said.

This year, 156 dolphins were

sighted with a good number of them in Rambha Bay area along with the outer channel. The range of 155-165 was inferred from yearlong monitoring by CDA, the survey report said.

The report also mentioned that dolphins are now colonising new areas of Chilika lagoon and this gives hope for this endangered mammal. The movement has been facilitated by clearing of gherries (prawn enclosures), it said. Irrawaddy dolphins in India are

protected under Wildlife (Protection) Act 1972, CITES (Appendix-1), and IUCN Red List, the survey report said, adding that the annual survey was conducted by the 'Transact Survey Method' followed worldwide for a population of aquatic

On the water birds, the report said that about a thousand near-threat-



ened Ferruginous Ducks were sighted for the first time in the lagoon during the survey, besides 2,000 greater flamingos at Nalabana. Two uncommon species, the rednecked stint and the Woolly-necked stork were spotted in the marshland of Parikud and Mangalajodi, respectively, it mentioned.

"The findings are favourable since the water bird census conducted by the Chilika Wildlife Division during the first week of January had put the number at

adding that a total of 2,86,929 birds of 75 species were spotted at Nalabana sanctuary alone during the one-day survey.

The most common migratory ducks found in Chilika were northern pintail, gadwall and Eurasian wigeons, each being more than 1.5 lakh. The mudflats of Nalabana and other regions of Chilika are now exposed as a result of the significant drop in water level and is habitat to more than 1.2 lakhs of waders or shorebirds such as the blacktailed godwit, little stint, ruff, curlew sandpiper, and lesser sand plover compared to the January 4 census.

The carnivorous predators were also spotted near the bird's island in the southern sector of Chilika lake. This species has also been camera trapped during fishing cat estimation, it said.

OSPCB Chief Engineer arrested in DA case

Bhubaneswar, Feb 4: The Vigilance sleuths Friday arrested Rabi Narayan Prusty, the Chief Engineer of Odisha State Pollution Control Board (OSPCB) on allegations of amassing assets worth crores disproportionate to his known sources of income. A case (1/22) was registered against Pusty in this regard for failing to produce satisfactory documents to prove the valid sources of his assets worth crores.

The vigilance officials Thursday carried out simultaneous raids at several places related to Prusty in Bhubaneswar, Khurda, Ganjam and Nayagarh.

Vigilance teams comprising eight deputy superintendents of police, four inspectors and five assistant sub-inspectors searched Prusty's residential flat at Kalvik King Palace in Patia area, a flat in Gajapati Palace at Jagmohan Nagar in Jagamara area, a shop at Barabhuja Market Complex in Khandagiri area and a flat at Shreekhestra Bhakta Niwas, all in Bhubaneswar. his parental house at Nuapada under Nuagaon police limits in Ganjam and office chamber in the City. Moreover, the house of one of his relatives at Shreeram Vihar in Nayapalli area here was also raided.

The anti corruption sleuths unearthed huge landed properties owned by Prusty. The accused owned one flat at Patia, in the Grand Awas housing project at Fulnakhara and one shop at the Barabhuja Market Complex in Khandagiri in the capital city.

The market value of the flat at Fulnakhara is more than ₹60 lakhs. This part, three plots registered in Prusty's name are in prime localities of Bhubaneswar and nearby areas. The market value of the above

plots has been valued in crores. The vigilance officials also suspected that the plots

have been undervalued during registration. Similarly, Prusty has a flat worth more than ₹1 crore at Shreekhestra Bhakta Niwas in Puri. The sleuths found deposits worth ₹89.46 lakhs in the accused's bank account, insurance policies and bonds.

The sleuths also found gold and silver ornaments weighing 355 gm and 692 gm respectively during the raids. One four-wheeler and 3 two-wheelers were also owned by the accused. "It is suspected that investments have been made by Sri Prusty outside the state in real estate, including benami properties, which are under verification," revealed Vigilance in a press note.

The chartered accountant and bank consultant attached to the Vigilance directorate have been examining the bank statements collected during search to find out any suspected transactions made for acquisition of benami assets.

The claims commission is appointed by the Supreme Court to look into matters related to compensation to project-affected people of Mahanadi Coalfields Limited (MCL) in Sundargarh district.

A case (423/21) has been registered on the basis of the complaint lodged by retired IAS officer Benudhar Dash, Secretary-cum-Admin and nodal officer at claims commission office. The accused were identified as Trilochan Dandasena, 33, Dusmanta Patel, 43, of Hemagiri in Sundargarh and, Swagat Parkash Barala, 35,

of Mahanga in Cuttack. Dusmanta Patel, technical inspector of MCL, was deputed to claims commission while Barala was a temporary clerk at the claims commission.

Dandasena contacted Mangasira Dharua, whose land was taken over by the MCL, and assured him to provide huge amounts as compensation from the MCL. Dandasena in connivance of Baral and Patel prepared a fake order in connection with the civil case number 306 of 2020 lodged by Dharua.

The accused used fake signature of Dash on the order and prepared a forged compensation rolls. Later, they sent the same order to the ADM of MCL, Basundhara for the sanction of compensation to the tune of ₹1.16 crore in the name of land oustee Dharua.

Dharua later transferred ₹20 lakhs into the account of Dandasena and ₹10 lakhs to the account of Baral. Patel received ₹5 lakhs from Dharua.

Treasure hunt ends in recovery of iron piece at Emar Mutt

Puri, Feb 4: The state government's treasure hunt at the famous Emar Mutt ended Friday with the recovery of a piece of iron buried in the centuries-old religious institution which is located in the southeastern corner of Srimandir here.

The mutt floor was dug up in the presence of the members of its trustee board, government officials, police, the magistrate and media persons anticipating recovery of more hidden treasure, Puri sub-collector Bhabataran Sahu said.

In 2011, a total 522 silver ingots weighing 18 tonne were found from inside the mutt. The ingots were valued at Rs 90 crore and is presently stored at the district armory for security reasons, officials said.



In April 2021, another 45 more silver ingots weighing about 35 kg each were found inside the mutt. This apart a silver tree, silver flowers, 16 antique swords and a bronze cow sculpture were discovered from the premises of the mutt, which was established by Ramanujacharya in 1050 AD when he came to Puri.

Following the discovery, another treasure hunt was carried out in September last year when the metallic detector indicated the presence of some metal at three places in the mutt premises, they said

"But after digging three identified places in the mutt premises, no hidden treasure was detected today. Only one piece of iron was recovered," Sahu said.

Emar Mutt Trust Board president Narayan Ramanuja Das also confirmed that no hidden treasure was found during the day's digging process.

The presence of hidden treasure came to the fore in 2011 when two masons working in the mutt were caught by police while attempting to sell two pieces of silver ingot. Subsequently, the treasure was recovered from a room closed on all the four sides.

BUDGET PEANUTS IRK LOCALS

■ RESIDENTS HAD PINNED HOPES ON RAILWAY MINISTER **ASWINI VAISHNAW, REPRESENTING ODISHA IN THE UNION CABINET, FOR THE COMPLETION OF THE PROJECT**

Gunupur, Feb 4: The fate of Naupada-Gunupur-Therubali rail route has reportedly been pushed into further uncertainty after the Centre sanctioned only ₹10 crore in the Budget for FY 2022-23 placed in the Parliament, Tuesday.

The sanction of a meagre ₹10 crore for the project has sparked sharp resentment in Gunupur and in whole of Rayagada district. The demand for the rail route is not new but for the last 47 years. It found mention in Budget of 2017-18 for the first time after a long standing demand of the residents.

Residents had pinned hopes on Railway Minister Aswini Vaishnaw, representing Odisha in the Union Cabinet, for the completion of the project. However, the amount sanctioned in this year's Budget has shattered the hopes of the people.

Members of a local outfit 'Rail Vikash Manch' also took out a cycle rally and submitted a memorandum to Vaishnaw when he visited Rayagada recently. People also urged him to expedite the GUNUPUR

project work from Gunupur to Therubali.

The Railway Board had sanctioned ₹935.72 crore after 79.15km long Gunupur-Therubali rail route received the approval. Later, the project cost escalated to ₹1,398 crore after preparation of a detailed project report (DPR). The Railways claimed that the rail route would not be financially viable and asked the state government to provide land free of cost and bear 50 per cent of the project cost.

The state government agreed to provide land free of cost but remained tight lipped on bearing 50 per cent of the cost.

A sum of ₹1 crore was sanctioned for the rail route in the first

phase. Later, the plan outlay was hiked to ₹232.37 core after survey was conducted for the project in August 2016.

The plan outlay has increased substantially after the project was shelved for 11 years. It was initially planned to complete the project in six years - by 2023.

Akshaya Das, a social activist of Gunupur, has urged the state government to intervene and take steps for early completion of the project. He has also urged the state government to clarify on bearing 50 per cent of the project cost.

Reader at Nabarangpur Women's College Sanjukta Panda and social activist of Malkangiri Sibaprasad Das opined that the sanctioned fund is much less than what is required to complete the project.

Andhra-Odisha Rail Users' Association convener Satya Prakash Panda of Gunupur said that both the Union and state governments should understand the need for Naupada-Gunupur-Therubali rail project and take steps for expediting it.

MILLERS TO FACE, MUSIC FOR DELAY IN PROCUREMENT

Ex-babus still in play

x-babus do not always go away when their stint in the civil service ends → Often, they find themselves hoisted into government committees and Secretary Gopal Krishna, who heads the Conciliation and Settlement Committee (CSC) set up by the Ministry of Port, Shipping and Waterways, was crucial to settling a decade-old dispute.

The committee includes, besides Krishna, former Special Secretary (Logistics) of Commerce Ministry N Sivasailam, former DoPT secretary Dr C Chandramouli, former special secretary Road Transport and Highways Shambhu Singh, among others.

The mediation by the Krishna-led committee ended a difficult dispute over a contract between the Chennai Port Authority and Chettinad Logistics, remarkably within six months. Sources say though there are more than 100 cases of contractual disputes in major ports, the success of these retired babus sends out a positive signal that disputes can be resolved quickly and also in-

Similarly, it was an alert babu who had first advised the government in 2010 to scrap the controversial Antrix-Devas deal, which is back in the news these days. Former Additional Secretary in the Department of Space Gopalan Balachandran who had been tasked with reviewing the report on the deal had advised the government to scrap the deal and investigate former top officials of the department who had withheld crucial information regarding the deal and led the Cabinet to cancel the agreement.

The good that babus do often remains buried in files and paperwork, but sometimes it does manage to get its rightful time in the sun.

Time to debate cooling-off period for babus

Politically ambitious babus find it hard to resist the call of their parent state, especially when it is headed for elections. In the upcoming Assembly elections in Uttar Pradesh and Punjab, a few "sons of the soil" have heeded this call and

exchanged their civil service career for the rough and tumble of state politics. A few weeks ago, this column (Jan 12) had written about two senior IAS officers in UP, Asim Arun and Rajeshwar Singh, who took VRS and jumped into the poll fray. Close on their heels, DKB has learnt that Additional Chief Secretary of Tamil Nadu, Jagmohan Singh Raju, took voluntary retirement from service, which was promptly accepted. Raju has now been fielded as a BJP candidate in Puniab.

In most cases the babu-turned-netas claim that they felt the compelling need to "do something" for their native state, which they apparently were unable to do while in the service. But the exit of these senior babus once again props up the question of having a mandatory cooling-off period for babus before they can jump ship whether into politics as in this case or other lucrative careers in the private sector.

The Central Vigilance Commission (CVC) has already said so on several occasions, but the government has chosen to ignore the advice. But given the growing number of babus who are quitting the service to join politics, and often the ruling party that they served in their civil service career, the time is ripe to revive this important debate.

Kerala babus told to remove flags on official cars

IAS, IPS and other officers in Kerala often display a blue flag on their official vehicles, which has the same symbol as on the flag of the training academy in Mussoorie. But now that the Kerala Motor Vehicle Department has termed it "illegal" and said there is no order from the state government that allows the flying of flags on the official vehicles of the babus.

Even earlier, babus in the state had got into trouble for not putting registration number plates on official vehicles. Even official vehicles of the state Governor and several ministers were reportedly in violation of the rules. At the time, the then state Transport Commissioner Tomin Thachankary had taken action against this practice and also directed the removal of the flags from the official vehicles. Clearly, the order was not followed through.

Given the reluctance of babus to relinquish the trappings of their official status, this new order in all likelihood will face the same fate, unless there is vigorous follow-through. Do you know of other states that have this rule? Do share if you know.

■ Abecedarian

he strangest aspect of this unusual word is the way it's said, as though the first part is an abbreviation: "ay-bee-see-DAIR-ee-un". That may explain why it has at times been written abcedarian. The source is the post-classical Latin of the fifth century AD. English imported the word from French in the 1500s. An early sense was of a person who taught or learned the alphabet. From the latter sense, it also came to mean more generally a novice or beginner; sometimes this was extended to a person in need of instruction, hence somebody illiterate or ignorant. Paradoxically, it was also attached to a member of a sixteenth-century German sect which opposed all forms of learning, including knowledge of the alphabet. It can be a primer for teaching. reading and spelling and more loosely any listing in alphabetical order. We may also come across it in reference to a poem in which the first letters of each verse or line are in alphabetical order, a special class of acrostic. Some early cases were hymns or psalms: the Hebrew original of Psalm 119 is abecedarian; around 1375 Chaucer translated a French prayer so that verses began with the letters of the alphabet in order (missing J, U and W, not then used). A famous example, often anthologised, is usually attributed to Aleric Watts, although some doubt over authorship remains. It was published in the Literary Gazette of London on 23 December 1820 to illustrate alliteration rather than abecedarianism, though it is abecedaric as well. The abecedarian insult also exists, which requires significant vocabularian talent, especially near the end of the alphabet.


Swerve to avoid a box

A FUTURISTIC BUDGET

EVEN THOUGH BOTH THE PRIVATE SECTOR AND BANK SHEETS HAVE BEEN CLEANED, SOME HESITANCY IS HOLDING THE SPEEDY RUN

he budget proposals for 2022-2023 tabled in Parliament and the preceding speech of the Union Finance Minister are in many ways futuristic and growthoriented. Yet, judicial, administrative and police reforms remain in the shadows. This threatens to wipe out substantial gains of reforms in other areas and in particular in the ease of doing busi-

themes of the budget are becoming manifest:

Futuristic: The budget seeks to address the issues of current sectors of the economy with equal, if not sharper focus on the sunrise sectors like Information Technology, Drones, AI, Blockchain, Digital Currency and even DiFi (Distributed Finance). It also focuses on the green and circular economy with emphasis on clean energy. The proposed investments in e-governance and bridging the digital divide will improve productivity and ease of living. The idea of extending the benefit of technology from communication, manufacturing, trade, distribution and entertainment to defence and agriculture provides a futuristic approach across the spectrum. Harnessing the scope of the International Financial Center for experimentation and a global window including operations of Foreign Universities will function as a sandbox for leapfrogging of the economy. Initiatives have the potential to deliver a future-ready economy.

Holistic: The sharp focus on 'Gati Shakti'will benefit the economy as a whole by enhancing the demand for products and services, reducing supply chain cost and improving inventory management. The facilitation of startups, venture capital and private equity will hopefully lead to a spurt in innovation and co-creation of globally competitive product and services. **Growth:** The proposed increase of 35% in public capital expenditure to ₹7.5 lakh crore further boosted by ₹1 lakh crore of interest-free loans to State governments for CAPEX will help sustain growth impulses and pave the way for crowding in of the private capex.

High GDP growth warrants a high level of investment. Twin-engine firing – private and public sector investment alone can enable sustained investment of over 30% to build a potential GDP growth of 7-8% trajectory. Even though both the private sector and bank sheets have been cleaned, some hesitancy is holding the speedy run. The proposal of enhanced public sector capex will hopefully entice them to join the procession of the medium to long-term CAPEX cycle. **Employment:**The three biggest employment generators of India next to agriculture are construction, infrastructure and manufacturing. The budget proposals deepen the revival of the construction sector by greater allocation to affordable housing and low cost of financing. The 'Gati Shakti' mission alone has the potential to open up a storehouse of employment opportunities. The PLI schemes launched last vear have revived the manufacturing sector, helped boost exports and provided lakhs of jobs. The IT, Telecom and Railway Minister in a TV interview was at pains to emphasise that the electronic manufacturing sector alone in its aspiration to cross \$300 billion of exports in the next three years will create over 10 million jobs.

The direct and indirect tax proposals did not temper with the current rates demonstrating an environment of stability. Infact, the budget seeks to eliminate inconsistencies in capital gains tax and some areas of customs. The critics credit the consistency to tax buoyancy rather than any effort of the government.

Inflation:Both WPI & CPI have emerged as a major risk to GDP growth. Inflation also threatens to snatch away the gains of economic growth from the larger sections of society. Hence, the Finance Minister has reaffirmed the commitment of the government to a fiscal deficit glide path and maintaining prudence by lowering revenue expenditure and enhancing capital expenditure. The budget proposals as also derived numbers reflect a sense of transparency.

The journey of simplifying and creating an environment of trust amongst tax payers has been continued. The proposal to allow to correct the numbers, file revised returns and pay revised tax liabilities within two years is to say, "I trust you". The digital filing, faceless assessment and appeals, digitisation across the economy and integration and aggregation of data and above all the confidence and trust-building have been strong levers of tax buoyancy; complemented of course by GDP growth. The criticism not to dole out

moneys to poorer sections of society even in an environment of revenue gale to spur demand and mitigate their misery is only partly justified. The current global environment is beset with the pandemic and its effects. There is also the revival of nationalism and geopolitical tensions. All part of ne melting pot.

First generation reforms on building efficient allocation of fac-

tors of production - land, labour and capital are done. Whatever is not done is difficult to accomplish in a vibrant democracy like that of India. Marginal tweaking will continue along the road of development. The optimisation of value creation - economists call it Total Factor Productivity (TFP)- is achieved by institutional reforms, which the Economic Survey has described as process reforms.

Implementation of policy decisions for the expected outcomes necessitate authorisations and delegations in an institutional framework. It also opens up avenues for rent seekers who identify kinks in the highway of process management and delay, derail and even frustrate the objective of that policy. Exit policy is one of the signature reforms of the Modi Government and the objectives were sought to be achieved with the vehicle of one of finest legislations, 'IBC'. Unfortunately, it has delivered sub-optimal results, notwithstanding numerous amendments and adequate jurisprudence built up in the last five years.

India ranks 168th amongst 180 plus nations in the matter of enforcement of the contract. It takes on an average over 1200 + days and entails a cost of over 25% of the value of the contract. There are several other areas of concern where delays, cost and deprivation of justice have been voiced. Judicial system, bureaucracy, and the police are overdue for a resurrection. Minor tweaking or even reforms will not work. The edifice of these institutions will have to be rebuilt in consonance with constitutional guarantees. Unless this is done, the ease of doing business and in particular, ease of living will remain distant dreams.

On the whole, the key to delivering in a futuristic budget will be execution in a mission mode. Speed has to be stepped up significantly. The global environment and India's demography offer probably the last opportunity to take the nation on a new trajectory. The focus must therefore shift to execution.

Distress migration amid economic growth

THE STATE'S **ECONOMIC PROGRESS HAS FAILED TO CREATE ADEQUATE NUMBERS OF JOBS AND CONTAIN LABOUR MIGRATION** FROM THE REGION

disha has lately made remarkable progress on the economic front as its growth rate has surpassed the national average in the last couple of decades. It has witnessed gross domestic product (GDP) growth rate of 7.1 per cent against the national average of 6.6 between 2012-13 and 2019-20. While the main driver of the growth remains the service sector in other states, in case of Odisha, the industrial sector has emerged as one of the main drivers. However, when it comes to employment generation, Odisha has failed miserably. Despite its shrinking share (19 per cent) in total output, agriculture and allied activities continue to absorb half of its workforce (48.8 per cent). Theoretically, in a developing economy, shrinking agricultural output with continuing overdependence on it for employment fuels distress migration to the cities. The migrants look for greener pastures leaving behind their abundant mineral resources, mountains, forests and rivers to be encroached upon by the outsiders. The industry is incapable of generating an adequate number of jobs for the local youths.

According to Census-2011, there were 45 crore migrants in India. Of them, 5.4 crore were inter-state mi-

grants. In Odisha, 8.5 lakh people migrated to other states for different reasons, including unemployment. However, the labour migration, called 'dadan' in western Odisha, that occurred in undivided Kalahandi-Bolangir-Koraput (KBK) districts, had gone unreported in the national statistics. In the KBK region, the most underdeveloped districts are known for poverty, agrarian crisis, chit-fund scams and mismanagement of healthcare facilities. This region sends lakhs of distress-driven migrants to different growth poles of urban centres. These segments are primarily unskilled and they belong to the lowest strata of the socio-economic pyramid, especially from Schedule Caste (SC), Schedule Tribes (ST) and Other Backward Classes (OBC). Migrants were forced to work in unhygienic, dangerous and discriminated sites at brick-kilns of Hyderabad and construction sites in Mumbai and Raipur. It has been reported that migrants were treated as 'nowhere citizens' unable to exercise any fundamental rights over their labour. According to a government report,

following the first wave of the COVID-19 pandemic, nearly six lakh migrant workers, most of them being

distressed-driven, have returned to the state. A sizeable number of migrants also reached the state through their own arrangements. Shockingly, 30 stranded labourers from Chennai took the sea route to reach Ganjam coast while thousands came by bicycle from Tamil Nadu, Andhra Pradesh and Karnataka.

During the first and second waves of COVID-19, the government took measures to deal with migrants, including providing cash incentives for voluntary home quarantine, advance rationing for all beneficiaries, and cash transfers to migrants upon completion of the quarantine period, among others. The government has also promised to create jobs through various schemes, particularly the Mahatma Gandhi National Rural Employment Guarantee Act (MGN-REGA). These initiatives have been undertaken perfunctorily to address the grievance of distressdriven migration from the state.

of civil society members and media on some gruesome incidents of brutalisation of migrants didn't awaken the government from its deep slumber. Given the pandemic situation, young people from several parts of the state are ventur-

ing into other states for livelihood. While lakhs of labourers are waiting for their turn to board a train to travel to their workplaces, the Inter-State Migrant Workmen Act (1979) is hardly being implemented on the ground. In sum, the state's economic progress has failed to create adequate numbers of jobs and contain labour migration from the region. Distress-induced migration of unskilled workers bypassing the state's policy is a shameful paradox of the so-called welfare state. The irony is that the state government cannot formulate any particular scheme for the backward region exclusively to stem migration. The 2030 Agenda for Sustainable Development Goals (SDGs) recognises migration as a powerful tool for migrants and their communities to achieve sustainable development. The manner in which migration occurs in the region dehumanises the poor and destitute that have no choice but to become trapped in a "vicious

Oppn slams Cong after Channi's nephew's arrest

"If one relative of Channi accumulated so much ill-gotten wealth in his 111 days of tenure as the chief minister, imagine how much his other relatives would accumulate in five years," Chadha alleged. New Delhi, Feb 4: The Supreme Court Friday said that an order of premature retirement should be passed on the basis of entire service records

The entire service record is to be taken into consideration which would include the ACRs of the period prior to the promotion. The order of premature retirement is required to be passed on the basis of entire service records, though the recent reports would carry their own weight," said a bench comprising Justices Hemant Gupta and V Ramasubramanian.

The bench, while setting aside an order of the Delhi high court, also said that an order of compulsory retirement is in the public interest and is passed on the subjective satisfaction of the Government.

It said the order of compulsory retirement is not liable to be



quashed by the Court merely for the reason that uncommunicated adverse remarks were taken into consideration. The top court was hearing an appeal filed by the Central Industrial Security Force challenging an order of the Delhi high court which set aside an order of premature retirement of a constable.

The apex court referred to its earlier decisions and said the courts should not interfere with the exercise of the power of compulsory retirement if arrived at bonafide and based on material available on record.

"It was held that an order of

compulsory retirement is not an order of punishment. It is a prerogative of the Government but it should be based on material and has to be passed on the subjective satisfaction of the Government and that it is not required to be a speak-

ing order," the bench said. The top court said that the High Court has completely misdirected itself while setting aside the order of premature retirement of the constable. "The writ petitioner has been awarded a number of punishments prior to his promotion including receiving illegal gratification from a transporter while on duty in the year 1993. There are also allegations of absence from duty and overstaying of leave. After promotion, a punishment of four days fine was imposed on the charge of sleeping on duty and two days fine was imposed for overstaying from joining time,'

The accused sent youths to befriend gullible good-looking girls studying in class 10th and PUC (Class 11, 12). Once the girls were befriended they were brought to a penthouse fitted with CCTV cameras by the youth.

The accused would then blackmail them saying that their private videos would be made public and sent to their parents.

According to police, the racket was going on since long but gullible minor girls were targeted on the requests of the clients. Girls with weak financial background were also roped in with promise of monetary help. The nexus came to light. when one of the 17-year-old victims shared her ordeal with her friend.

When the matter reached the Principal, she called the police helpline. Mangaluru Police Commissioner N Shashi Kumar formed a team under the leadership of DCP (Law and Order) Hariram Shankar and conducted raids and arrested the culprits Thursday.

Lucknow, Feb 4: Prime Minister Narendra Modi Friday accused the Samajwadi Party of fielding anti-social elements in the assembly polls and said the "fake Samajwadis" will corner the benefits given by the Centre to the poor if they come to power.

Addressing a virtual rally directed at the western UP constituencies, he urged people to keep "history-sheeters" out, and instead create a "new history". Modi focused on law and order and the government measures to help farmers at the virtual "Jan Chaupal".

The PM asked people to come out in large numbers on polling day, and to "vote before you eat." He said in Hindi, "Pehle matdaan, phir jalpaan," at his second virtual rally for UP in recent days. Polling in the first phase is February 10. The virtual rally targeted voters in Ghaziabad, Meerut, Hapur, Aligarh and Noida.

He said the Yogi Adityanath government in Uttar Pradesh has dealt strongly with criminals and mafias and if a government favourable to them comes to power, they would extract "revenge" from people.

Modi highlighted the "double benefits" of the "double-engine government" over the last five years, referring to the BJP government both in the state and at the Centre during this period.

"Till five years ago, these 'mafiawadis' did not allow the benefits of the Central schemes to reach

Siddaramaiah castigates Sitharaman over river-linking project in Budget '22 Girls denied entry again to college

Bangalore, Feb 4: Senior Congress leader Siddaramaiah Friday ac cused the Central government of unilaterally announcing the riverlinking project in the Union Budget without taking Karnataka into confidence, which, he said, was against the basic structure of the Constitution and federalism.

He said Tamil Nadu is likely to gain benefit from the proposed project. Therefore, the Leader of Opposition in the Karnataka Assembly urged the State government to immediately call for an all-party meet to discuss and send the State's unanimous view to the Centre in this regard.

He expressed Congress's opposition to the project and termed the attitude of the Centre as dictatorial. "The Finance Minister in the Union Budget has announced a proposal for linking southern rivers and this project is probably not viable. Nirmala Sitharaman, the Finance Minister, is from Tamil Nadu and hence I feel she has proposed it in the budget," Siddaramaiah said.

Speaking to reporters here, he said it appears that no discussion on river-linking has been held with Karnataka. "By linking rivers, Tamil Nadu will get more water. How much water will be available from each river and what is the allocation to each state, these have not been discussed with Karnataka. Without discussion, without getting the consent of the state, if gone ahead, it will lead to inter-state water disputes," he said.

Karnataka Chief Minister, reacting to the announcement in the budget, said the state would stick to its stand that peninsular rivers should not be interlinked before the state's share of waters is finalised.

"They (Centre) have said they will go ahead once all states agree with the DPR, which is still under discussion. When the DPR is being prepared, our state's share has to be decided in the right way. This is our stand," the Chief Minister said.

Noting that the project has been discussed at the National Water Development Agency, Siddaramaiah said it has been estimated that 347tmc water would be available by linking rivers, which can be used to provide water to the southern states.

"In Tamil Nadu, Andhra Pradesh, Maharashtra and other states, more than 55 per cent of the lands available for cultivation are irrigated while in Karnataka it is only 30 per cent. After Rajasthan we have more area under the dryland. So, Karnataka should get justice." he said.

Demanding detailed discussions before the commencement of the river-linking project, the Congress Legislature Party leader further said Karnataka is also partner of the project, as Cauvery originates from the state flows here before flowing into neighbouring Tamil Nadu and then to the sea.

'Tamil Nadu will get more than 90 per cent of the benefit from river-linking while the benefit for Karnataka is less." he said. The idea of river-linking is not new and the plan to join rain-dependent Cauvery with Ganga, a perennial river, had started during the Morarji Desai government.

Hitting out at the BJP government in Karnataka and 25 MPs from the ruling party for remaining silent on the river-linking proposal in the Budget, Siddaramaiah urged the state government to immediately call for an all party meeting to explain the advantages and

disadvantages. Alleging that the Centre is biased towards Karnataka, he questioned as to why the Centre was not giving equal importance to give clearance to the Mekedatu project, which is for drinking water purpose.

The girls' parents also protested outside the college gate. When they entered the premises, a few Hindu boy students wearing saffron shawls started roaming around the place as a mark of protest. The boys were soon asked to remove the shawls and attend classes in the college.

In view of the tension, police personnel from Kundapur station present at the gate sent the girls' parents away citing instructions from the government. The girls, however, continued to remain near the gate.

Meanwhile, a group of students of the government girls' PU college at Udupi, where the hijab row first started last month, approached the Additional Deputy Commissioner to resolve the issue at the earliest to



create a suitable environment for ed-

ucation in the college In their appeal, the girls said the final examinations are nearing and the teaching process in the college is disturbed due to the presence of police and the media. The district administration should take immediate action to solve the issue raised only by six students in the college, they said in the appeal.

The incident was followed by another one at the pre-university college in Kundapur in the same district, with the authorities disallowing 28 girl students wearing hijabs from attending classes in the college, citing the government direction. The girls later protested against the order outside the classes as well.

The issue turned worse when around 100 boy students of the college wearing saffron shawls Wednesday protested against allowing girls wearing hijabs inside

Kundapur MLA and college development committee president Halady Srinivas Shetty, who rushed to the college, called a meeting of the girls and their parents to discuss the issue. As the parents did not relent, the meeting failed to reach a consensus.

A bench comprising Justices M R Shah and B V Nagarathna also directed the state governments to give full particulars like name, address and death certificate to the concerned SLSA, as also complete details with respect to orphans, within one week from today (Friday) failing which the matter shall be viewed very seriously.

The top court reiterated that applications seeking compensation should not be rejected on technical grounds and if any technical glitch is found, the states concerned should give them opportunity to cure defects as the ultimate goal of the welfare state is to provide some solace and compensation to victims.

States should make all endeavours to pay the compensation to the victims within a maximum period of 10 days from the receipt of the claim, it said.

recting all the state governments to give full particulars of the deaths due to Covid-19 registered with their portal and the number of persons to whom the ex gratia payment is made, it appears that most of the states have given only statistics and no full particulars are given.

"The object and purpose of our earlier order to give full particulars was to see that at least with respect to those cases which are registered with the state governments if they have not approached the appropriate authorities for compensation," the bench said.

The legal services authority will reach them and see that they make an application and they act as facilitator as a bridge. Similarly the particulars with respect to or-

phans are not given. We direct all the state governments to give full particulars including their name. address, death certificate etc. To the concerned state legal service authority including full particulars with respect to orphans within one week from today failing which the matter shall be viewed very seriously," it said.

The apex court said that the endeavour of legal services authority would be to reach to those sufferers/victims who have yet not approached for whatever reasons.

'We also direct the concerned state governments to appoint a dedicated officer, not below the rank of deputy secretary in Chief Minister Secretariat, who shall be in constant touch with the member secretary of the state legal service authority so that he may coordinate with him and see to it that the applications are received from eligible persons.

"As and when the particulars are given on verification, the member secretary finds that out of the case registered, some of family members are yet not given compensation, the member secretary to reach to them through the secretary DLSA/ secretary Taluka and para legal volunteers. Their function would be to facilitate those who could not approach to make an application for compensation and see that they get compensation. Their role shall be of ombudsman as a bridge between the victims and the government. If there is any difficulty found by the member secretary he may immediately approach the concerned person hereinabove and all are directed to cooperate," the bench said.

The apex court also rapped the Maharashtra government for rejecting applications submitted offline seeking compensation."No application should be rejected for any application which is submitted offline. You are not doing charity. As a welfare state it is their duty. Why are you sending people from pillar to post. Do it from the bottom of the heart," the bench said.

5 workers killed in Pune



Pune, Feb 4: Five labourers were killed and as many injured after the slab of a building under construction collapsed in Pune, police said Friday.

The incident occurred at Shastrinagar in Yerwada area of the city late Thursday night, an official said. Police detained three persons in this connection and also registered a case against a contractor, he said.

"A net of steel bars meant to build a slab at the basement level collapsed late Thursday night. Five labourers working at the time died on the spot and five others were injured," Rohidas Pawar, Deputy Commissioner of Police (Zone V), said. The injured were admitted to a hospital and they are out of danger, he added.

Prime Minister Narendra Modi expressed grief over the loss of lives in the incident. "Pained by the mishap at an under-construction building in Pune. Condolences to the bereaved families. I hope that all those injured in this mishap recover at the earliest," he tweeted.

The incident occurred at Shastrinagar in Yerwada area of the city late Thursday night, an official said

According to the official, fire brigade and police personnel carried out an operation to rescue those trapped under the debris at the site. Pune police commissioner Amitabh Gupta and city civic chief Kunal Kumar visited the site.

"A raft foundation slab collapsed due to the absence of spacing and support. A committee has been formed under the supervision of the district collector to conduct an inquiry into the incident. The College of Engineering, Pune (COEP) has also been roped in to find faults, if any, in the construction. Based on the report, action will be taken," Kumar said. Gupta said, "We have registered a case against a contractor and detained three persons in connection with the incident."

New Delhi, Feb 4: A Parliamentary panel Friday said the use of 'GAY' code for Gaya airport is inappropriate for the holy city and asked the government to make all efforts to change the code.

According to the civil aviation ministry, IATA has expressed its inability to change the code without a "justifiable reason primarily concerning air safety".

The International Air Transport Association (IATA) assigns the code for airports. The committee said the code name appeared inappropriate, unsuitable, offensive and embarrassing considering that Gaya is a holy city.

with 100 percent attendance, Sisodia said. "Schools will reopen for classes 9-12 from February 7 and for nursery to 8 from February 14. The classes will continue to be in a hybrid

mode," Sisodia said. The deputy chief minister, who also holds the education portfolio, said institutions of higher education and coaching institutes will also be permitto open Monday."However, colleges will be discouraged to hold online classes and should start offline teaching," he said.

During the DDMA meeting, chaired by Lt Governor Anil Baijal, it was decided that gyms, spas and swimming pools will be permitted to open, he said, adding that the panel also gave its nod to organising B2B exhibitions.

However, the terms and duration of the loan were being finalised by the authorities from both the countries, it added. Sri Lanka will use the amount for the import of rice and cement from Pakistan.

Turkey 'neutralises' 43 Kurdish ultras

Ankara: Turkish security forces have "neutralized" 43 members of Kurdish People's Protection Units (YPG) in Syria, the Defence Ministry in Ankara said. The move came in retaliation for a bombing in the Syrian town of al-Bab that killed nine people and after the YPG opened fire on Turkish bases in al-Bab. Dadat, Kil Cibrin, and Tall Malid areas, Xinhua news agency quoted the Ministry as saying The killing of a Turkish soldier by a mortar attack on Wednesday at a border post with Iraq in the southeastern city of Sirnak also prompted the retaliation. the Ministry added.

Bali reopens to foreign travelers

Denpasar: Direct international flights to Bali have resumed for the first time in two years as Indonesia opens the resort island to foreign travellers from all countries, but mandatory quarantine remains in place for all visitors. Officials had said in October that Bali would welcome foreign arrivals from 19 countries that meet World Health Organization criteria, such as having their Covid-19 cases under control.



'The Russian side reaffirms its support for the One-China principle, confirms that Taiwan is an inalienable part of China, and opposes any forms of independence of Taiwan," the joint statement said. Some senior ministers believe "it feels like the end" after Thursday's exodus amid mounting fears in Downing Street that more staff and even ministers could resign.

Senior Conservative MPs Friday issued a fresh warning to Johnson that he must "shape up or ship out", the Daily Mail report said.

Number 10 was in meltdown as the Prime Minister ordered a brutal clearout in a desperate attempt to shore up his troubled premiership as Rishi Sunak primed himself for a leadership bid.

Downing Street announced that the Prime Minister's chief of staff Dan Rosenfield and private secretary Martin Reynolds will be leaving.

That announcement came after it emerged the PM's communications chief, Jack Doyle, was also departing. Johnson had already been hit by the shock resignation of one of his closest allies, policy chief Munira

Afghan faces tsunami of hunger: US SIGAR

Kabul, Feb 4: The US government's Special Inspector General for Afghanistan Reconstruction (SIGAR) has said that the war-torn nation is currently facing a "tsunami of hunger" amid the ongoing humanitarian crisis and the collapsed economy.

On Thursday, SIGAR released its 44th quarterly report to the US Congress examining the \$145.87 billion reconstruction effort in Afghanistan, which said that "record drought, rising food prices, internal displacement" as well as economic breakdown and collapse of public services constitute a "humanitarian emergency", reports **TOLO News**

The authority underscored the findings of Integrated Food Security Phase Classification, an organisation active under the UN Office for the Coordination of Humanitarian Affairs (OCHA), saying nearly 19 million Afghans experienced acute food insecurity in "September and October 2021"

WHO and WFP estimate that 3.2 million Afghan children under age five will suffer from acute malnutrition this winter, with one million at risk of dying

Pak disparages Naravane's claim

New Delhi, Feb 4: Major General Babar Iftikhar, the Director General of the Pakistan military's Inter-Services Public Relations (ISPR), has categorically rejected the Indian Army chief's, General MIM Naravane, claim that the ceasefire along the Line of Control (LoC) was holding because they negotiated from a "position of strength", and termed it as

'misleading", Geo News reported. The military spokesperson Friday said it was agreed only due to Pakistan's concerns for the safety of the people of Kashmir living



on both sides of the LoC.

The statement issued from the DG ISPR's official Twitter account came in response to a comment by India's top military commander who claimed the credit for maintaining almost a year-long ceasefire along the LOC, the report said. "Ceasefire with Pakistan continues to hold as we negotiated from a position of strength," Indian Army chief General Manoj Mukund Naravane had said.

However, the Pakistani military spokesperson rejected the claim and said no side should misconstrue it as their strength or other's weakness.

The Director-Generals of military operations of India and Pakistan, after reviewing the situation along the LOC and all other sectors, had agreed to reenforce the ceasefire which went into effect from February 25, 2021.

"I've always thought she should be called Elizabeth the Steadfast. Vickers told The Associated Press. "I think it's a perfect way of de-





Forex reserves down by \$4.531bn

Mumbai: The country's foreign exchange reserves declined by \$4.531 billion to stand at \$629.755 billion in the week ended January 28, RBI data showed Friday. In the previous week ended January 21, the reserves had decreased by \$678 million to \$634,287 billion. It touched a lifetime high of \$642.453 billion in the week ended September 3, 2021. During the reporting week ended January 28, FCAs tumbled by \$3,504 billion to \$566.077 billion, as per RBI data.

BoE hikes rates to curb inflation

London: The Bank of England (BoE) has raised interest rates for the second time in seven weeks to fight a surge in inflation. At its meeting late Wednesdav. the bank's Monetary Policy Committee (MPC) voted to increase the so-called "Bank of England base rate" by 0.25 percentage points to 0.5 per cent, citing 'the current tightness of the labour market and continuing signs of greater persistence in domestic cost and price pressures", reports Xinhua news agency. Thursday's announcement came as the UK's annual consumer price index (CPI) inflation jumped to a 30-year high of 5.4 per cent in December 2021.

CCI penalises seven entities

New Delhi: Competition Commission has slapped penalties on seven entities and their officials for bidrigging activities and cartelisation with respect to supply of signage for branches, offices and ATMs of State Bank of India, Besides imposing fines totalling over ₹1.29 crore on the 7 entities and 9 officials, they have also been directed to cease and desist from indulging in anticompetitive practices.

Hyundai's Jan sales fall 12%

Seoul: Hyundai Motor, South Korea's biggest carmaker, has announced its sales fell 12 per cent last month from a year earlier amid global chip shortages. Hyundai Motor sold 2,82,204 vehicles in January, down from 3,21,068 units a year earlier, the company said. "We will adjust vehicle production schedules to ride out ongoing semiconductor shortages, while focusing on boosting sales of new models and enhancing profitability," the company said in a statement.

Bangalore, Feb 4: Coal India Ltd, the world's largest coal miner, plans to directly export output to neighbouring countries, according to a draft policy sent to the secretary of India's coal ministry and reviewed by Reuters, after decades of exclusively supplying domestic consumers.

The proposal was presented at an internal board meeting on corporate strategy in October 2020 and was confirmed by Coal India's chairman to Reuters this week, although a critical coal shortage in India now means the first such shipments would be unlikely until the end of this year.

We would have ideally wanted to start exporting this financial year (ending March 2022), if not for the energy crisis," Coal India Chairman Pramod Agrawal told Reuters, noting the current priority was to address domestic demand.

Under the proposal "3% of Coal India's annual production will be earmarked separately for exports" with the main focus on encouraging bulk trade for the long-term.

The export push is seen as a longer-term pivot that would help Coal India diversify its revenue streams and boost New Delhi's push to firm up ties with strategi-

However, the proposal has more recently been overshadowed by India's own coal shortage at home, which means the first shipments would be unlikely until the end of 2022, according to Agrawal.

India - which relies on coal for nearly three quarters of its electricity supply - is yet to fully recover from the crunch that forced power cuts, which lasted up to 14 hours a day in some northern states.

Compounding those woes, international coal prices have soared due to a surprise temporary export ban by top exporter Indonesia and large purchases from European buyers concerned that any invasion of Ukraine by Russia could sever gas flows to Europe.

Though domestic coal supplies

half the fully operational utilities in India are under 25% of federally

mandated levels. "I don't expect the energy crisis in India to be fully resolved until at least October," Agrawal said.

India is the second largest producer, consumer and importer of coal. Coal India has previously exported small quantities to neighbouring countries on an ad-hoc basis, but never in commercial bulk.

Last year. Coal India also allowed domestic customers to export coal bought from the miner through e-auctions for the first time.

At Coal India's October 2020 board meeting, it was suggested that the miner should overhaul its marketing department and sell coal at lower-than-current prices to make its output attractive for foreign buyers.

In the draft proposal sent to the coal secretary, Coal India suggested offering coal to its neighbouring countries at prices it offers to non-power sector consumers in India. The policy recommended the miner export 15-20 million tonne by 2024-25.

INDIA TO BOOST OIL, **GAS EXPLORATION**

New Delhi, Feb 4: India will more than double the area that is under exploration and production of oil and gas to 0.5 million square kilometer by 2025 and to 1 million sq km by 2030 with a view to raising domestic output and cut reliance on imported fuel, Petroleum Minister Hardeep Singh Puri said

The world's third-largest energy consumer will continue to rely on hydrocarbons to meet its growing energy needs in the foreseeable future, he said at the World Energy Policy Summit 2022.

"With an objective of increased domestic production of oil and gas, we have declared an ambitious target to increase the area under exploration and production to 0.5 million sq km by 2025 and achieve 1 mn sq km by 2030," he said.

Seven rounds of an auction of acreage under the new Open Acreage Licensing Policy (OALP) in the last five years have doubled the area under exploration for oil and gas to 207,692 (0.2 million) sa km.

Puri said the Indian economy expanding to \$5 trillion by 2025 and to \$10 trillion by 2030 from the current \$3 trillion will lead to burgeoning energy demand.

Referring to India's target to reach net-zero carbon emissions by 2027, he said the government has already taken several measures to overhaul the hydrocarbon policy framework to ensure energy security for the country while pursuing the green path to progress.

"However, we acknowledge that oil and gas will continue to meet the baseload of our energy demand for the foreseeable future," he said.

Over 80 per cent of India's energy needs are met by three fuels -- coal oil and solid biomass. Coal accounts for 44 per cent of all energy consumption while the oil makes up for a quarter. The share of natural gas is 6 per cent.

Govt extends stock limits on edible oils, oilseeds till June 30

New Delhi, Feb 4: In a bid to further cool down edible oil prices and curb hoarding, the Centre Friday extended stock limits on edible oils and oilseeds till June 30.

Besides, the government has specified the stock limits that have to be imposed by states that have not implemented the earlier order on the limits.

In October 2021, the Ministry of Consumer Affairs had imposed stock limits till March 2022 and left the decision to states to decide on the stock limits based on available stock and consumption pattern.

In pursuance with the Centre's October 2021 order, six states --Uttar Pradesh, Karnataka, Himachal Pradesh, Telangana, Rajasthan and Bihar -- had imposed the stock limits in their respective states.

Many states had not imposed the stock limits. The ministry felt that implementation of stock limits across all states was necessary to transfer the full benefit of price control to the end-consumer, an official statement said.

All retro-tax cases to be settled this month

New Delhi, Feb 4: The government will settle almost all the retrospective tax cases this month, closing a chapter that plagued India's reputation as an investment-friendly destination, a top official said Friday

A 2012 amendment that gave taxmen powers to go back 50 years and slap capital gains levies wherever ownership had changed hands overseas but business assets were in India, was used to raise ₹1.1 lakh crore demand against multinationals such as telecom group Vodafone, pharmaceuticals company Sanofi and brewer SABMiller, now owned by AB InBev, and Cairn Energy Plc. Such demands brought uncertainty in the minds of in-

To repair India's damaged reputation as an investment destination, the government in August 2021 enacted a new legislation to drop all such demand and refund about ₹8,100 crore collected on the condition that any pending lawsuit or legal challenge against the government anywhere in the world



would be dropped.

Cairn, from whom ₹7,900 crore was seized to enforce the retrospective tax demand, as well as Vedanta Group, have dropped lawsuits. Cairn is now eligible for the tax refund.

"In the month of August, we abolished the retrospective taxation and we would be settling almost all the cases this month itself. So, we will close that chapter once and for all," Revenue Secretary Tarun Bajaj said.

The move will help restore investor confidence by providing a predictable and stable tax regime.

'So stability, predictability and not giving any surprise is a matter of tax policy which we have implemented," he said at a PHD chamber event here.

Reflecting signs of slow recovery in the pandemic-hit airline industry, IndiGo's revenue from operations jumped to ₹9,294.8 crore in the latest December quarter compared to ₹4.910 crore in the same period a year ago. Total income surged 84.3 per cent on an annual basis to ₹9,480.1 crore in the third quarter of the current fiscal year.

CA approves first tour of Pakistan in 24 years

Karachi, Feb 4: Cricket Australia (CA) Friday approved its first tour of Pakistan in 24 years with a revised itinerary being announced by both the boards amid lingering security concerns. Australia will play three Tests in Rawalpindi, Karachi and Lahore. They will also play three one day internationals and a T20I during the full tour.

The tour will now start and end in Rawalpindi with the opening Test to be played from 4-8 March and the four white-ball matches to be played from 29 March to 5 April.

Pakistan Cricket Board (PCB) chief executive Faisal Hasnain said: "We are pleased that the Cricket Australia Board has formally approved their side's five-week tour itinerary and confirmed that their best available players will visit Pakistan for the first time in 24 years.

Top-flight international cricket



did not take place in Pakistan for nearly a decade since the 2009 terrorist attack on the Sri Lankan team bus in Lahore

The schedule has been revised to ease logistical and operational challenges as well as to avoid Pakistan Day rehearsals, which usually commence in Islamabad in the second week of March.

The two cricket boards have also agreed that the Australia Test side will complete its isolation in Australia, before arriving in Islamabad February 27 on a chartered flight. After a one-day hotel isolation, they will hold training ses-

sions at the Pindi Cricket Stadium. The Tests will be part of the ICC World Test Championship, while the ODIs are linked to the World Cup

Super League.

I want to make it clear, that picture (where Ganguly can be seen sitting with secretary Jay Shah, skipper Virat Kohli and joint secretary Jayesh George) wasn't from a selection committee meeting. Jayesh George isn't a part of selection committee meetings. (I have played) 424 international matches for India. Not

a bad idea at times to remind peo-

ple about it, isn't it? (laughs) ■ How has been your working relationship with Jay Shah in the last 26 months in the

Indian cricket board? • I share a fantastic relationship with Jay. He is a very dear friend and a trusted colleague. Me, Jay, Arun (Dhumal) and Jayesh (George), we have all been working together to get the board going in these difficult times especially with COVID-19 in these two years. To make sure that cricket happens. I would say it has been a fantastic two

years. We have all done it as a team. ■ What kind of a new Test captain are you looking at after Virat Kohli's decision to step down?

 Obviously, there are certain parameters of leadership and whoever fits the bill will be the next Indian Test captain. I believe selectors will have a name in mind and they will discuss it with office-bearers - President and Secretary – and it will be announced in due course of time.

■ You had recently said that Rahane and Pujara will be playing Ranji Trophy. But does that mean they can get dropped for Sri Lanka Tests although that is now pushed to March?

• What I meant was that they will play Ranji Trophy as it starts before the Sri Lanka series. After that, the selectors will take a call. Ranji Trophy Elite group starts in third week of February and Sri Lanka Tests are in March. It will completely be the call of selection com-

mittee and whatever they decide. Let's talk about Ranji Trophy. The BCCI is finally getting it started but even after increasing match fee to up to ₹2.4 lakh per game for a certain bracket, most teams would end up playing only three first-class



games. Isn't it a financial loss and an issue for all stakeholders?

 They have played Vijay Hazare and Syed Mushtaq Ali also where the match money has increased. You have to understand that after we discussed with the medical team, it was decided to keep four teams in a group in a particular city as that was the only way we could probably maintain the sanctity of a biobubble in COVID times. More number of individuals in any particular place would increase the rate of infections. That's why venues are more and teams are less. The timeframe, as we had postponed the mid-January start due to spike in cases, was also a factor.

■ Why isn't BCCI starting the women's IPL straightaway? Why again a T20 Challenge when a state unit like CAB is having a six team 90-player women's

• We are at the level of formulation to have a full-fledged WIPL. It is certainly going to happen. I strongly believe that next year i.e. 2023 will be a very good time to start a full-fledged women's IPL which will be as big and grand a success as men's IPL.

■ Any special celebrations for India's 1000th ODI, which will be against the West Indies Sunday?

 No, nothing as such as everything is being held in the bubble. We have to maintain the COVID-19 protocols so yes elaborate celebrations won't be possible and in any case matches are being held closed doors.

■ The state government has allowed 75 per cent spectators at the Eden Gardens for the three T20Is. But isn't BCCI wary given Motera is having closeddoor ODIs?

• Let me put this on record. We are not allowing spectators at the Eden Gardens for the three T20Is. There will not be any tickets for general public. The only people allowed are CAB officials and representatives of the various units. No tickets for the stands of Life or Associate members will be issued. Obviously, we have the clearance of West Bengal government but BCCI doesn't want to risk the health safety of players.
