Maha woman killed over daughter's post

Palghar: A 48-year-old woman died after the family members of her daughter's friend allegedly beat her up over a petty dispute here in Maharashtra, police said Monday. The woman's 20-year-old daughter had posted a message on her WhatsApp status, which her friend thought was directed towards her and took offence to it, Boisar police station's senior inspector Suresh Kadam said without divulging contents of the post. On February 10, the other girl's mother and siblings went to victim Lilavati Devi Prasad's house in Shivaji Nagar and allegedly thrashed her and other members of her family, he said. Prasad suffered serious injuries and was rushed to a hospital where she died the next day while undergoing treatment, the official said.



Sensex tanks 1,747 pts over Ukraine

Mumbai: The BSE Sensex crashed over 1,747 points while the NSE Nifty ended below the 17,000-level Monday amid escalating Russia-Ukraine tensions. The 30-share Sensex nosedived 1,747.08 points or 3 per cent to settle at 56,405.84 and the broader Nifty plummeted 531.95 points or 3.06 per cent to 16,842.80. On the Sensex chart, barring TCS, all shares closed with steep to moderate losses. Elsewhere in Asia also, bourses closed in deep red after concerns that Russia may soon invade Ukraine, which sent oil prices soaring. Domestic markets opened sharply lower in line with negative Asian MORE P11 bourses as also sharply lower US equities.



From Feb 21, no vax proof needed for temple entry

Bhubaneswar, Feb 14: From February 21 onwards, the double dose vaccination certificate or Covid negative certificate is no longer required to enter Shree Jagannath Temple in Puri.

Keeping in mind the improved Covid-19 situation in the state and a majority of population having taken double doses of the vaccine, the above decision was taken at the Chhatisa Nijog meeting, chief administrator of Shree Jagannath Temple Administration (SJTA) Krishan Kumar said Monday.

However, he advised devotees seeking visits to the temple to be inoculated with two doses of Covid-19 vaccine.

Other Covid-19 restrictions like use of sanitizer and masks, social distance will be mandatory for the devotees. The temple will continue to remain closed Sunday for devotees for sanitization of the premises. he said.

blocked 54 more apps with Chinese links including Tencent Xriver, Nice Video Baidu and Viva Video Editor, over security and privacy concerns.

According to sources, these 54 apps allegedly obtain various critical permissions and collect sensitive user data. The collected realtime data are being misused and transmitted to servers located in a hostile country, they added. The banned apps were allegedly

engaged in activities prejudicial to the sovereignty and integrity of the country, also posing serious threat to security of the state and defence of India, the sources said. IT ministry has issued interim di-



the sources said. The list of banned mobile apps

include Beauty Camera: Sweet Selfie HD, Beauty Camera - Selfie Camera, Rise of Kingdoms: Lost Crusade, Viva Video Editor, Tencent Xriver amongst others. Other apps that have been banned, as per fresh orders, include Garena Free Fire -Illuminate, Astracraft, FancyU pro, MoonChat, Barcode Scanner - QR Code Scan, and Lica Cam.

In June 2020, the government had banned 59 apps with Chinese links, including hugely popular TikTok and UC Browser, saying rections for the blocking of 54 apps, they were prejudicial to sover-

eignty, integrity and security of the country.

The 2020 ban -- that had come in the backdrop of stand-off along the Line of Actual control in Ladakh with Chinese troops -- was also applicable for WeChat and Bigo Live, besides Helo, Likee, CamScanner, Vigo Video, Mi Video Call - Xiaomi, Clash of Kings as well as e-commerce platforms Club Factory and Shein. Thereafter, the government banned 47 more Chinese apps that were clones and variants of the apps blocked earlier. In September the same year, the government blocked 118 more mobile applications.

Bangalore, Feb 14: After a near week-long hijab row forced holiday, high schools in Karnataka reopened Monday, amid prohibitory orders in Udupi, which witnessed violence and tension last week, and sensitive areas of Dakshina Kannada and Bangalore.

Section 144 of the Criminal Procedure Code has been imposed in sensitive areas in the said districts. In Udupi district, all the schools that reopened witnessed normal attendance, education department sources said. Muslim

Bhubaneswar, Feb 14: Campaigning for the first phase of the panchayat election ended Monday evening with polling parties having started departing for their respective booths.

After a marathon campaigning for party candidates, leaders of all three major political parties, BJD, BJP and Congress hoped their candidates would get votes.

In the first phase, 200 Zilla Parishad zones in 71 blocks in all 30 districts will go to vote. Voting will be carried out at 22,379 wards and 1,669 panchayats across the state. As many as 67.51 lakh voters will exercise their franchise in this phase.

Polling officials have been sent to 11 districts Monday while officials will move to other 19 districts Tuesday, said State Election Commission (SEC) secretary RN Sahu.

Meanwhile, the SEC has issued a clarification for the validation of votes polled during the upcoming panchayat elections.

The SEC's clarification comes in the wake of several queries received by the commission regarding the validity of a ballot paper when a voter records his vote for a candidate in the prefold portion and again gives a vote on a symbol not allotted to any contesting candidate, the first vote will not be rejected.

Panchayat Election Rules say a ballot paper is liable for rejection if votes are recorded in favour of more than one candidate in the fray for the election.

"In the instant case, even if the voter has recorded his vote against one contesting candidate and another against a symbol which was not allotted to any candidate, the intention of the voter is clear and it will not be rejected," said Sahu.

The collectors have been asked to implement the above instructions while counting of -(votes during in the panchayat election, 2022.

Man from Kendrapara arrested for having 14 wives

The only intention of Swain, a father of five children, was to mop up money and acquire properties of the women after marrying them

Bhubaneswar, Feb 14: A 54-yearold man in Odisha was arrested Monday for duping several women across the country after marrying them, the police said.

The individual has been identified as Ramesh Chandra Swain a.k.a Bidhu Prakash Swain a.k.a Ramani Ranjan Swain, a resident of Kendrapara district.

Briefing the media persons about the case, Bhubaneswar DCP Umashankar Dash said the man has been arrested from a rented ac-

commodation in Bhubaneswar based on a complaint filed by a woman school teacher of New Delhi at Mahila Thana here in July last year. Swain, posing as a 'deputy director general' rank official in the Union Health Ministry, had married the woman in 2018 in Delhi Arya Samaj. Later, the teacher came to know that the accused had cheated her, and

filed the complaint, Dash said. During investigation, the police found that Swain had married at least 14 women by giving fake identity as a 'deputy director general'. He used to establish contact with the victims through matrimonial websites. Swain used to target middle-aged single women who were looking for companionship, after acquiring their money, used to abandon them. Lawyers, teachers, doctors and highly-educated women, most of



them outside Odisha, are among the victims, the police officer said. "His only intention was to mop up money and acquire properties of the women after marrying them,"

Dash said. Swain is a father of five children. He married first in 1982, and the 'second marriage' took place in 2002.

During the probe, the police also found that Swain had married a woman official of the Central Armed Police Forces (CAPF) in Puniab and collected ₹10 lakh from her He also cheated ₹11 lakh from the Gurdwara where the marriage ceremony with the CAPF official was held by prompting the authority to set up a hospital there, the DCP said.

Earlier, Swain was arrested by Kerala police in 2006 for cheating 13 banks of around ₹1 crore.

He was also arrested by a task force of Hyderabad police after cheating many students by promising them to provide admission in medical colleges. He had collected

about ₹2 crore from the students including an owner of a nursing home in Hyderabad.

The police have already contacted nine out of 14 victims cheated by Swain and suspect that many other women might be his victim, and they may not come out due to fear of hampering their social prestige and status.

A case has been registered against him at the Mahila police station under Sections 498 (A), 419, 468, 471 and 494 of the IPC. The police will also investigate the transaction of the fraud money by bringing him on remand, he added.

During a search operation in Swain's rented house, police have seized 11 ATM cards, 4 Aadhar cards having different identities and a Bihar school certificate of different identity.





State allows paid holiday for employees on poll day

Bhubaneswar, Feb 14: The state government Monday directed the authorities to ensure that paid holiday is granted to employees engaged in various public sector undertakings, corporations, establishments, business, trade and industrial units to exercise their franchise in the upcoming panchayat polls.

The Labour and ESI department has asked the Revenue Divisional Commissioners (RDCs), PSUs, establishments, business, trade and industrial undertakings to ensure enforcement of the order of the State Election Commission (SEC) on panchayat elections, scheduled to be held in five phases-February 16, 18, 20, 22 and 24.

"The SEC has directed that every person employed in any business,

The State Election Commission has directed that every person employed in any business, trade, industrial

undertaking or any other establishment and desiring to vote in the said election shall be granted paid holiday on the date of poll

Any violation of the above instruction will be treated as an offence

The written application by the employees will be sufficient to show their enrolment in a particular gram panchayat

trade, industrial undertaking or any other establishment and desiring to vote in the said election shall be granted paid holiday on the date of poll. gram panchayat," the Labour and ESI department's order said.

Notably, the state government had earlier directed all Principal Secretaries, Heads of Departments, District Collectors, the Panchayati Rai & Drinking Water department to grant special casual leave to employees who desire to vote at places away from their headquarters on the date of the poll.

The special casual leave will be granted for a maximum of three davs-one day preceding the poll, the poll day and one day after the poll. "The leave to be granted may be treated as special casual leave in addition to normal casual leave admissible to them during the calendar year 2022. The written application by the employees will be sufficient to show their enrolment

in a particular gram panchayat,' the state government had said.

Hvderabad. Feb 14: People with epilepsy can lead a normal life, but it is the attitude of the society towards them that impacts the quality of their life, according to doctors.

With recurrent seizures, people with epilepsy are at risk of frequent injuries, burns and even loss of life. They are stigmatised in the society and discriminated against, while also struggling to establish relationships, get educated and being employed.

However, an empathetic approach towards them will help them stay strong and lead a normal life. On the International Epilepsy Day

commemorated February 14, doctors provide answers to certain misnomers.

Healthcare in India has advanced to a great extent and now it is medically possible to evaluate and map the possibility of future seizures and prescribe required solutions. Hence tackling such problems has become easy now.

"Medication is needed to control seizures and treat epilepsy and anti-seizure medications help to control seizures in nearly seven out of every 10 persons with epilepsy. Persons with epilepsy must strictly avoid self-medication and seek right medical advice to ensure that epilepsy is well controlled," said Sita Jayalakshmi, Senior Consultant Neurologist at KIMS Hospitals.

On additional causes that result in epilepsy, Neurology Consultant at Wockhardt Hospital (Nagpur) Amit Bhatti observed that even stress could sometimes cause epilepsy among people with weak nervous systems, and more stress could increase severity of the problem.

"It is important to note that stress affects brain development among children, which could have complications in the latter



stages of life. In fact, the most common causes of onset seizures are the structural changes that occur to the brain.

Abhinay M Huchche, Consultant Neurologist at SLG Hospitals, said, "Epilepsy can be treated and there is surgery route too. While the allpervading myth has been that there is no treatment to epilepsy, historically patients have been put to various rustic, non-medical and unproven methods believed to tame epilepsy. This includes shaking patients and making them hold metal. On the positive side, the fact is that epilepsy has inexpensive yet effective medical solutions and around 70 per cent of those treated lead normal lives.

Commenting on understanding the problem, Neuro Physician at Aware Gleneagles Global Hospitals Suresh Reddy said anyone can develop epilepsy, and it affects both males and females of all races, ethnic backgrounds and ages. "Seizure symptoms can vary widely from some simply turning blank for a few seconds during a seizure, while others repeatedly twitching their arms or legs. Having a single seizure

doesn't mean you have epilepsy. At least two unprovoked seizures without a known trigger that happen at least 24 hours apart are generally required for an epilepsy diagnosis." According to Karthik Y,

Consultant Neuro Surgeon of Century Hospital, one of the major challenges epilepsy patients encounter is low confidence level and uncertain fear of its occurrence.

"The families of epileptic patients, especially the elders and parents who are dealing with seizures in children, need to understand the disease and know more from doctors. Usually it's important to find the underlying cause

of seizures and treat it accordingly. In most of the cases, medical treatment is sufficient. But in few refractory cases, surgical treatment is an emerging victor. Most importantly, it needs to be treated at any cost without ignoring. In fact, epilepsy stands next only to stroke in neuro related deaths," he said.

Besides conventional treatment. epilepsy awareness assumes vital importance as most of the cases become complex only because treatment was never received or began very late in adolescence or adulthood.

The role of doctors cannot be restricted to treatment but transcends to creating awareness and taking message to patients, families and the society in particular.

Many training facilities and physicians need to upgrade themselves with the knowledge and facilities to treat persons with complex epilepsies. Ongoing research and legislations are much needed in guiding the fight against epilepsy.

Doctors say with awareness, most persons with epilepsy who take medical treatment can lead normal lives, remain employed, get married, have children and be productive members of the society. Also, if attention is paid, a lot of epilepsies can be prevented.

Indo-Lankan Tangle

rt is an irony that when Sri Lanka's foreign minister GL Peiris spoke highly of improved Sri Lanka-India relations, Sri Lankan Tamil MP CV Wigneswaran asked India, hours before Peiris' arrival in Delhi last week, to be wary of the understanding between Sri Lanka and China. According to Wigneswaran, Sri Lanka's closeness to China could possibly pose a threat to India. He also charged the Sri Lankan government with trying to drive a wedge between the Tamil population in the north and east of Sri Lanka by settling ethnic Sinhalese group in the Tamil-dominated parts of the country. China is implementing several projects, including electricity generation in three islands just about 50 km away from India. This, the MP said, would harm India's interests. In addition, the lease of 15,000 acres of land in southern Sri Lanka for 99 years given to China should not be music to India's ears, he warned.

True, tensions in the Indo-Sri Lankan relationship have considerably eased and Colombo appears to be ready more than ever before to hail collaborations with India, but it could be the economic crisis the island country is facing that is prompting it to make friendly overtures to India. It is now confronted with dire shortages of essential commodities, fuel and medicines for which it has appealed to several friendly countries, including India, for help. To win India's confidence, it has finally cleared the Trincomalee storage tanks deal shelved for nearly two decades.

Before the Sri Lankan foreign minister's visit to India, another development took place. Tamil legislators of the country had written to Prime Minister Narendra Modi a few weeks back seeking New Delhi's intervention to push the Rajapaksa government to find a lasting solution to the problem of implementing all the provisions laid out in the 13th Amendment, also known as 13A. This is a thorny issue still causing strain in the bilateral ties between India and Sri Lanka. The 13th Amendment became part of Sri Lanka's Constitution as an offshoot of the India-Sri Lanka Peace Accord. The amendment led to the creation of Provincial Councils. Under this, the Sri Lankan government had pledged a power-sharing arrangement to enable all nine provinces in the country, including Sinhala-majority areas, the right to self-govern. However, successive governments in Colombo have not fully implemented the amendment, despite New Delhi's repeated pleadings. This explains why External Affairs Minister S Jaishankar told his Sri Lankan counterpart to ensure "equality, justice, peace, and respect for the Tamil people within a united Sri Lanka' by implementing the long-pending 13th Amendment. He contended this would best serve Sri Lanka's own interests. It is understandable Jaishankar has to be tactful while nudging Colombo to decentralise its powers so that the Sri Lankan Tamils are not marginalised and federal governance is assured. Bilateral ties had hit rough waters last year when the Rajapaksa regime cancelled the \$500-million East Container Terminal project - a tripartite agreement among Sri Lanka, India, and Japan - in February 2021 and instead handed over the West Container Terminal (WCT) development plan to the Adani Group, seeking private investment. However, Sri Lanka's current economic crisis has opened up new opportunities for India to strengthen its relationship with Sri Lanka and check China's overreaching influence on the country. Last week, New Delhi extended a \$500 million line of credit to Sri Lanka to enable it to purchase petroleum products as the country continues to face a severe foreign exchange and energy crisis.

It is only natural that the Sri Lankan Tamils in order to protect their own interests will try to play on India's fears about China's stratagems to keep Sri Lanka within its orbit of influence and encircle India from all sides. But, in a strange way, a friendly neighbourhood in north and east Sri Lanka in the form of Sri Lankan Tamils enjoying the fruits of decentralised power will be to India's advantage as well. What remains a matter of concern, however, is the continued reluctance of President Gotabaya Rajapaksa to engage with the Sri Lankan Tamils. He has not met Tamil parliamentarians even once since he was voted to office in November 2019. On the other hand, the government says a new draft Constitution written by a "committee of experts" could be submitted to Parliament soon. It is this move that has caused anxiety in the Tamil political leadership which fears the government will negate the promise of decentralisation and help a centralised power structure get entrenched.

Against this backdrop, the United Nations Human Rights Council's debate February 28 on alleged human rights abuses by the Sri Lankan Army at the end of the civil war in 2009 offers an opportunity to India to use the occasion to make Sri Lanka address the concerns of its Tamil population. India is in a tricky position. Reports suggest the UNHRC may indict Sri Lanka and if India becomes a party to it, that may affect the ties between the two countries. A middle path could benefit all the stakeholders in which case India may extract concessions from the Sri Lankan government for the Tamils in lieu of India's backing at the session.

ndia's economic performance has been among the worst in the world. According to the IMF in 2020, India's growth was (-) 7.96, placing the country at the 150th rank, nearly at the bottom of the line-up of countries. This position reflects the mismanagement of COVID - India's stimulus package was the weakest among developed and similarly placed countries. Further, even before COVID, the economy was sliding down from around 8.2% growth in 2016-17 to 4% in 2019-20. And even before that in 2016, demonetisation was akin to shooting at the tyres of a speeding car.

The COVID crash was so severe that the recovery in 2020 may appear one of the highest in the world. Data shows that the economy would be barely climbing back to the pre-COVID level of 2019-20. Even this achievement would depend upon the severity of the economic impact of the Omicron wave. Therefore, undoubtedly, the key macro-economic feature is that of stagnation. Of the key variables of aggregate demand exports and domestic investments seem to have climbed back to the 2019-20 level but this does not include private consumption demand. Many who expected the Union Budget would at least try to fill this demand gap have been deeply disappointed.

The budget estimate of overall expenditure is ₹39.45 lakh crore. which is only 4.6% higher than the revised estimate for the previous year. If one were to consider inflation, there would be a real drop in the government expenditure. The economy is expected to grow 8%-8.5% in real terms during 2022-23, which implies that government expenditure-GDP ratio would take a dip during the current year. This is a perverse response to the current economic stagnation and would weaken recovery.

An explanation is that the government has been forced to be prudent because of inflation considerations. This is totally misplaced reasoning as the simple fact is that the present inflation is not because

In 1991, the share of top 1% of the households in the national wealth was 16%. By 2020, it had increased to 42.5%. In sharp contrast, the share of the bottom 50% of the households in the national wealth declined from 8.8% to 2.8% during the same period Similarly, there has been a dramatic widening of inequality in the distribution of national income also. Given the 'K' shaped recovery from the pandemic, inequality has widened to an unbearable level. The recent Oxfam report has sharply highlighted the differential impact of COVID on the rich and poor. The Budget has added to the increasing gap between the rich and poor by ignoring inequality and poverty.

The Budget has been described as a vision for the next 25 years. A cartoon captured the tragic-comic situation: The FM and the PM are holding a picture of sweets and goodies before a poor family sitting down to dine. The PM says "It's all yours...after 25 years."

Salt of the earth

he expression is Biblical and comes from Matthew, 5:13. From the King James Bible of 1611: "Ye are the salt of the earth: but if the salt have lost his sayour, wherewith shall it be salted? it is thenceforth good for nothing. but to be cast out, and to be trodden under foot of men." Salt has always been one of the most prized commodities, essential both for life and for preserving food. Roman soldiers were paid an allowance to buy salt, the origin of our salary. A man worth his salt is efficient or capable. To eat salt with someone was to accept his hospitality and a person who did so was bound to look after his host's interests. The Bible also speaks of a covenant of salt, one of holy and perpetual obligation. Newborn children were anciently rubbed with salt to protect them against evil forces. To Jesus, therefore, salt of the earth was a great compliment. To understand his comment fully, though, you have to know a bit about where Jews of his time got their salt. Some came from saltpans on the margins of the Dead Sea, but much was obtained from Mount Sodom (Jebel Usdum in Arabic), a ridge of limestone and rock salt at the south-west corner of the Dead Sea (a pillar of salt here is said to have given rise to the legend of Lot's wife). This rock salt was the literal salt of the earth. Because the deposit's outer layer was exposed to the elements, it became contaminated and its salt content depleted by weathering, losing its taste and value, so becoming good for nothing. The use of salt to poison the ground is entirely separate.

Today, tens of millions of people who were not even born in 1992 are suffering the worst of the climate crisis. In a world already plagued by economic inequality and social injustice. COVID-19 has exposed and exacerbated the policy failures of the past three decades.

Political leaders have not lived up to their previous commitments. One of Rio's strongest legacies is the creation of the United Nations Framework Convention on Climate Change. The UNFCCC has been the key multilateral body in the international community's effort to strengthen the political consensus on climate action through annual Conference of the Parties (COP) summits.

At COP26 in Glasgow last November, there was some progress toward strengthening the 2015 Paris climate agreement's nationally determined contributions to emis-

to sufficient, given the existential threat posed by rising emissions and temperatures.

That is why 2022 must be the year of accountability, with all major emitters delivering on the promises of the so-called Glasgow Climate Pact. That declaration maintained a lifeline for limiting global warming to 1.5° Celsius, relative to pre-industrial levels, as agreed in the Paris accord. All countries at COP26 promised to step up their ambitions and revisit their emissions-reduction targets as soon as this year. In concrete terms, those who still have not set Paris-aligned 2030 targets should do so by COP27 in Sharm El-Sheikh this November. While all countries must fast-track implementation of their new commitments, it is particularly important that wealthy G20 economies do so, because they are responsible for most global emissions.

Climate finance remains another critical part of the puzzle. It has been over a decade since rich countries pledged, at COP15 in Copenhagen, to provide \$100 billion annually to support developing countries in their mitigation and adaptation efforts. That target has never been met. In the interests of

country, on the shores of the Red Sea. Africa is the continent most vulnerable to climate change, despite African countries' negligible contribution to the problem. In the interest of justice and solidarity, I hope to see Africa speak with one voice to ensure that COP27 advances the region's concerns on adaptation, finance, and loss and damage (L&D) - the acknowledgement that countries are suffering climate effects beyond their ability to adapt.

COP26 left unfinished business on L&D, because the United States, backed by the European Union, postponed the creation of a new financial mechanism to rebuild communities in the aftermath of climate-related disasters. Country representatives nonetheless have committed to holding further discussions on the issue, which means that COP27 represents a major opportunity to achieve a breakthrough.

An effective L&D fund is increasingly important for climate-vulnerable states. At COP26, the Scottish government and the Belgian region of Wallonia took the first step by pledging \$2.7 million and \$1 million, respectively, for L&D (with ment is the deal concluded by South Africa, the EU, the United Kingdom, the US, France, and Germany to support South Africa's 'just transition' away from coal. This now needs to be built upon - and emulated elsewhere.

The spirit of multilateralism that animated the Rio summit and its outcome remains indispensable today, even though the geopolitical climate is fraught with tensions, mutual suspicion, and weak institutions. As my fellow Elder Ban Ki-moon told the 'Generation Green' audience, "We all have a part to play in addressing the climate crisis-especially those with the power needed to bring about change.'

To honour the legacy of the Rio summit, to meet the needs of those already living with the consequences of the climate crisis, and to limit the repercussions for future generations, we all must strive to go further and faster to protect our shared home. And 2022 must be the turning point.

Acid test for BJP

PANCHAYAT ELECTIONS IN ANANDAPUR BJD rebels may play spoilsport

Anandapur; Feb 14: Three zilla parishad (ZP) zones (1, 2 and 3) under Anandapur block in Keonjhar district are likely to see triangular fight in the upcoming panchayat elections, said sources.

Political observers are of the view that all the three zones will see triangular and tough contest among the Biju Janata Dal (BJD), Bharatiya Janata Party (BJP) and Congress candidates.

Candidates of the three parties along with their supporters and front line leaders are conducting door-to-door campaign. ZP zone-1, which comprises of Kodapada, Kolimati, Gayalmunda, Dhakotha, Panasdiha, Budhikuda and Manoharpur panchayats, is reserved for women candidates. The BJD has fielded Tini Rana while BJP has given the ticket to Tapaswini Mohanta and Congress Minarani Behera.

In some panchayats, anti-incumbency factor is expected to come into play as rebels of BJD are actively working in Panasdiha



and Manoharpur panchayats. In Gayalmunda panchayat, some disgruntled BJD leaders allegedly have tacit understanding with opposition candidates.

In 2017 elections, the BJD had grabbed ZP zone-1. Though this zone will see contest mainly between the BJP and BJD, the possibility of the Congress candidate twisting the electoral equation can't be ruled out, given the disenchantment among people, it was said. The young voters leaning towards the saffron is yet another headache for BJD.

ZP zone-2 comprising Kantipal, Kathakata, Tartara, Baunsagada, Mochinda and Shalabani panchayats is unreserved. The seat is expected to witness a tough fight among the three parties. Though the BJD is leading the campaign now, the possibility of some rebels playing spoilsport for the ruling party can't be ruled out.

ZP zone-3 comprising Jalasuan, Panchupalli, Bailo, Belabahali and Haridapal panchayats is also likely to see triangular contest. Interestingly, all the candidates of the BJD, BJP and Congress are residents of Bailo panchayat.

In the 2017 elections, the controversy over Belabahali bridge turned the table on the ruling party. An independent candidate backed by local leader Sanatan Mahakud won the ZP seat.

Currently, Sanatan is backing the BJD candidate Urmila Sahu, But BJP's Asima Mishra is likely to have an edge over her rivals, given some factors, it is said.



Chandigarh, Feb 14: It's the battle among Sikhs to choose the 'Sardar' of Punjab, the state with a debt burden of at least Rs 2.82 lakh crore at the end of the current government's tenure. Based on caste considerations. all four major political parties in the state vying for the February 20 polls for the 117-member Assembly have fielded Sikh gentlemen --- right from the 'maharaja' to the billionaire businessman with interests in hotels, resorts, media, agriculture and to the 'entertainer' to the common man, a former handball player who is commonly seen on cricket pitch and hockey turf during campaigning. Two-time Chief Minister and Captain Amarinder Singh, the scion of erstwhile Patiala, 80, is politically matured among the four chief ministerial faces. He's seen as the nationalist widely respected leader of the BJP-led alliance. His fledgling Punjab Lok Congress (PLC) is contesting the polls in alliance with the BJP, which had earlier played second fiddle to its former ally Shiromani Akali Dal (SAD), and SAD (Sanyukt), an Akali Dal rebel. In the 2019 parliamentary polls, Amarinder Singh steered his former party Congress to a victory in his ruling Punjab in eight out of 13 Lok Sabha seats despite Modi wave across the country. He's contesting from his stronghold Patiala (Urban), the seat that he has won for four consecutive terms since 2002 when he first contested. Among the race for the chief minister is former Deputy Chief Minister

1.25 crore to throng Asia's biggest tribal fair THE FOUR-DAY BIENNIAL EVENT WILL KICK-OFF FEBRUARY 16 AT MEDARAM

Hvderabad. Feb 14: Thousands of devotees have started descending on Medaram in Telangana's Mulugu district for Sammakka Sarakka Jatara, billed as the largest tribal fair in Asia. The stage is set for the four-day

biennial event, which will kick-off February 16 at the village, about 240 km from Hyderabad. Authorities expect 1.25 crore

devotees for the event, often described as Telangana's Kumbh Mela. Tribals and non-tribals from various parts of Telangana, Andhra Pradesh, Maharashtra, Karnataka, Chhattisgarh, Madhya Pradesh, Odisha and other states will converge for the fair, which marks cel-

ebration of tribal traditions. An estimated four lakh devotees have already visited Medaram during the last few days ahead of the Jatara also called as Sammakka-

Saralamma Jatara. Adivasis living in forest fringe habitations in several states along the river Godavari congregate once in two years to celebrate the valour of legendary warriors Sammakka and Sarakka. The tribals treat them as goddesses and hail their bravery in trying to protect them. Belonging to koya tribe, the mother-daughter duo died while fighting against Kakatiya empire about eight centuries ago. The legend is that Sammakka and her daughter Saralamma fought against levy of taxes on tribals during drought conditions by the then Kakatiya rulers in the 12th century.

Tribal king Medaraju was ruling the tribal habitations on the banks



of river Godavari, and was supposed to pay a royalty to the Kakatiya kings. However, due to severe prolonged drought, Medaraju failed to pay a royalty. Treating it as defiance, the Kakatiya Kings invaded the region. Fighting with the Kakatiya army, Medaraju and all kin died. His daughter Sammakka and her daughter Sarakka or Saralamma too died in the fight.

According to local lore. Sammakka, who was fatigued, went above the Chilukalagutta hillocks and disappeared. The Adivasis who reportedly went in search of her only found a casket of vermilion under a bamboo tree.

Once every two years, the tribal priests offer prayers at the bamboo grove and bring a casket of vermilion and bamboo stick wrapped in red cloth symbolising Sammakka, whom they consider their deity. A day before, the priests do similar ritual at Kannepalli village, four kilometers from Medaram and bring the deity Sarakka. Both are installed under the Indian Elm tree at Medaram village and thus begin the Jatara. After three days, they take back the deities and leave them in the forest until the next Jatara.

The poor tribals offer jaggery of their weight considering it to be gold. They also offer red blouse pieces, vermilion, and turmeric to the deities in large quantities. They take a little part of the same as prasadam from the altar back to their homes.

Devotees also take holy dip in Jampanna Vagu, a tributary of Godavari river. Jampanna was the tribal warrior and the son of tribal goddess Sammakka who was killed in a war with Kakatiya Army. The tribals believe that a dip in the stream washes off their sins.

Chief Secretary Somesh Kumar

and Director General of Police Mahender Reddy already visited Medaram to review the arrangements for the fair. Somesh Kumar directed all government departments to work with coordination to ensure smooth conduct of darshan and other rituals.

About 10,000 policemen will be deployed as part of the massive security arrangements for the fair. Police have also set up 382 CCTV cameras and two drone cameras. Senior officers will monitor the massive gathering round the clock on 20 display screens at the command control room in Medaram. Thousands of vehicles carry-

ing devotees have made a beeline to Medaram. The DGP said they were leaving no stone unturned to ensure peaceful and smooth conduct of the Jatara.

Traffic police expect movement of 3.5 lakh private vehicles and 4,000 buses of Telangana Road Transport Corporation (TSRTC). The police chief said this poses a great challenge to the police to regulate vehicular traffic and parking. As many as 33 parking places and 37 vehicle holding points were earmarked to regulate the flow of vehicles. For every four kilometres, one police outpost was set up.

The event is being held with Covid-19 protocol. The police department will also be distributing face masks and sanitiser kits to all policemen on duty. The police have also set up 50 public information centres to guide the devotees. Various departments have undertaken different works to provide all the necessary facilities for the devotees.

As per the Election Commission data, North Goa registered 79.45 per cent while South Goa registered 76.92 per cent. In Uttar Pradesh, where 55 seats across nine districts saw polling, the highest voting was in Saharanpur, at 67.52 per cent, and the lowest in Shahjahanpur at 55.20 per cent.

Veteran scribe commits suicide PRESS TRUST OF INDIA

Chennai, Feb 14: T Kumar, a veteran photojournalist working here for news agency United News of India (UNI), died by suicide and Chief Minister M K Stalin, the principal opposition AIADMK and the journalist fraternity Monday condoled his death.

In a condolence message, Stalin said he was grieved to learn that Kumar had ended his life and added that he has ordered assistance of Rs 3 lakh to his familv from a fund for the welfare of journalists. Stalin's announcement on assistance comes hours after the AIADMK, the Chennai Press Club and the photojournalists' association had requested Stalin to provide financial assistance to Kumar's kin.

Sunday night, a colleague found Kumar hanging from a ceiling hook in the UNI's office here. On information, police personnel arrived and they rushed the photographer to the Kilpauk Government Medical College Hospital where he was declared brought dead.

Following autopsy, the body was handed over to his family Monday Kumar was 56 and he is survived by his wife, son and a daughter. Sources in the UNI here said he was facing financial trouble and 'backlog of salaries.

A photojournalist with over 30 years' experience, Kumar rose through the ranks of the UNI to become its state bureau chief. He had joined the news agency in 1986 and was the first photographer to become the head of the agency in Tamil Nadu.

Kolkata, Feb 14: Nine months after its landslide win in the West Bengal assembly polls, the Trinamool Congress Monday reaffirmed its dominance among urban voters as it made a clean sweep in the elections to four municipal corporations.

The TMC retained control of Bidhannagar, Chandernagore and Asansol municipal corporations and wrested power in Siliguri from the CPI(M)-led Left Front. Both the vote share and the number of seats for the TMC in these civic bodies were much higher than the last election held in 2015.

The CPI(M) lost opposition status to the BJP in Asansol and Siliguri, but retained its distant second position in Bidhannagar and Chandernagore. The re-

sounding victory in the four civic bodies comes when the party is having a hard time amid a growing rift between the old-timers and Gen Next leaders.

While TMC chairperson Mamata Banerjee said it is the victory of the people, the BJP claimed that the ruling party had resorted to "terror tactics" on February 12, the polling day. The Mamata Banerjee-led party retained Bidhannagar by winning 39 out of 41 seats, while the opposition BJP and CPI(M) failed to open their account. The Congress and an Independent candidate bagged one ward each, according to the State Election Commission (SEC) data.

In Bidhannagar, the TMC got 95.5 per cent of the total votes polled, whereas the Congress and the independents secured 2.44 per cent each.



2022'S MAIDEN MISSION

ISRO PUTS 3 SATELLITES INTO ORBIT SUCCESSFULI

Sriharikota, Feb 14: India Monday morning successfully placed into orbit its radar imaging satellite EOS-04 in a text book style.

With this the Indian space agency began its 2022 romance with space missions. At 5.59 a.m. Indian rocket Polar Satellite Launch Vehicle-C52 (PSLV-C52) blasted off from the first launch pad carrying three satellites including the earth observation satellite-04 (EOS-04) ear-

lier named as RISAT-1A. The multiple satellite launch space mission lasted just over 18 minutes. Congratulating Team ISRO for the successful mission, S.Somanath, Chairman, Indian Space Research Organisation (ISRO) said: "The mission was successfully accomplished. The primary

satellite and the co-passenger satel-

lites were put into orbit.'

On his part the Satellite (EOS-04) Director C.V.Sreekantha said the satellite health is good and the solar panels got deployed. In couple of days, the EOS-04 will be ready to send its images,

Sreekantha added. The 44.4 metre tall PSLV-C52 weighing 321 ton slowly rose-up towards the skies with thick orange flame at its tail. The rocket gradually gained

speed as it went up while emitting a rolling thunder sound. Just over 17 minutes into its flight the rocket slung its primary passenger the 1,710 kg EOS-04 into sun synchronous polar orbit of 529 km and soon after INSPIREsat-1 (17.5 kg) and INS-2TD (8.1 kg) were put into orbit. India's radar imaging satellite

EOS-04 is designed to provide high quality images under all weather conditions for applications such



as agriculture, forestry & plantations, soil moisture & hydrology and flood mapping.



How do Russian, Ukrainian militaries stack up?

How big is Russia's military buildup?

ussia is mobilising a massive combat force near its border with Ukraine including tanks, artillery, rockets, and other heavy weaponry. Reports say they are moving naval ships into the region to strengthen their fleet in the Black Sea. Even though the exact number and locations of Russian units are unclear given open source data collection drawbacks, experts opine that these deployments are uncommon and signify a worrying escalation of the nation's continuing conflict with Ukraine.

Russian Forces Deployed Near Ukraine

There are an estimated 59,750 troops near Ukraine. There are possibly additional troops in Belarus. According to data from Rochan Consulting, there are about sixty thousand Russian military personnel positioned in Russia-annexed Crimea, along the border

with Ukraine, and in Belarus, where they ostensibly entered for joint military exercises set for mid-February. However, various Western media sources have said Russia has marshaled between 100,000 and 130,000 forces, likely including additional air, naval, and paratrooper personnel. It is unclear whether and how

many Russian regular forces are in Ukraine's disputed Donbas region



aiding the tens of thousands of separatists. Russia continues to denv any involvement there. How does Russian military com-

pare to Ukraine's? Russian military is far superior. Defense analysts say this gives Russia a range of options if it decides to escalate further, such as bolstering separatists fighting in the Donbas to a full-fledged assault aimed at seizing all of Ukraine. The countries' success or failure

on the battlefield would be influenced by many factors. These include but are not limited to the quality of the militaries' training and leadership, their logistical and technical support, international aid, their morale, the level of civilian resistance, weather, and terrain. Moreover, many of these el-

ements would likely change throughout the conflict. For instance, experts say that Russia's military advantage would diminish if its offensive were to drag on for an extended period and develop into a grinding insurgency with Ukrainian forces.

Russia's Military Advantage

Notes Tanks include only main battle tanks and infantry fighting vehicles. Combat aircraft include only combat-capable fixed-wing aircraft and attack helicopters. Combat vessels include only principal surface combatants and submarines in the Black Sea. Graphic excludes space and cyber forces, as well as most nuclear forces.

Many defense experts note that Russia has undertaken a remark able modernisation effort since its war with Georgia in 2008, one that has transformed its Soviet-era force into an increasingly well-equipped and well-organized military. Additionally, its members have gained considerable combat experience in the conflicts in Syria and Ukraine

How much do Russia and Ukraine spend on their militaries?

Ukraine has increased its military budget significantly since 2014. But even with that boost and the significant financial support of the United States and other allies. Moscow/Kyiv, Feb 14: Ukraine's ambassador to Britain Monday backtracked on remarks suggesting that Kyiv would reconsider its attempt to join NATO as Russia masses a huge force within striking distance of its neighbour, but said other concessions could be on offer.

A day after Washington said Russia could now invade Ukraine at any time on a surprise pretext, the Group of Seven large Western economies (G7) warned Russia of "massive" economic consequences if it did so, and promised Ukraine swift support.

German Chancellor Olaf Scholz flew to Kviv for talks, to be followed Tuesday by a meeting with Putin in Moscow, but a German official said Berlin did not expect concrete results. British Prime Minister Boris Johnson called the situation "very, very dangerous".

A senior Russian military officer was quoted by the news agency Interfax as saying Russia was ready to fire on foreign vessels that entered its waters illegally, though such a decision would have to be approved at the "highest level"

The proposed revision of an election-related law will take effect if it is endorsed by the Cabinet Council and signed by the president - steps widely considered a formality since the governing and opposition parties have already agreed on the measure. Voters diagnosed with highly infectious diseases such as COVID-19 and others placed in guarantine would be allowed to visit polling stations and cast ballots after reg ular voting closes at 6 pm, according to a copy of the legislation on the website of the National Assembly. The special voting time would close at 7.30 pm. Virus patients who have already applied for postal ballots in a nowended registration period can still vote by mail, according to the National Election Commission. On Monday, new virus cases surpassed 50,000 for a fifth consecutive day, taking the country's confirmed total to 1,405,246 with 7,102 deaths.

Police in Windsor cleared the Ambassador Bridge, a vital trade route to Detroit, peacefully two days after the province of Ontario declared a state of emergency and the city got a court injunction to end the protest.

Beijing, Feb 14: Chinese fans of US sitcom 'Friends' have expressed dismay online after noticing censorship in recently released episodes of the beloved show, including of LGBT issues.

Several major Chinese streaming sites, including Tencent, Baidu's IQiyi Inc, Alibaba's Youku, and Bilibili, started showing a version of the first season of the show Friday, its first re-release in China for several years.

But fans soon noticed parts of the long-running show were different to what they had seen before and complained of censorship which included the removal of lesbian, gay, bisexual and trans-related content. as well as mistranslations.



In one example, a conversation where a main character, Ross, explained his wife was a lesbian was deleted

Another scene where another character, Joey, suggested going to a strip joint was translated as 'goes out to play' on the version shown on Tencent Video. Reuters confirmed the Tencent version of the re-released season included those changes.

In recent years, China has shut tens of thousands of websites and social media accounts that contained what it said was illegal content as well as vulgar and pornographic material.

"I resolutely boycott the castrated version of Friends," said one user on China's Twitter-like Weibo.

"This is defiling a classic," said

another. A third user said if you can't show the complete version under the current atmoshphere, then don't import it.

The discussion was a hot search topic on Weibo Sunday.

But in a sign the discussion itself may have caught the attention of censors, searches on Weibo Sunday for several variations on the hashtag or search term #Friendshasbeencensored produced either zero or limited recent results.



In the IPO, the firm will also earmark a certain percentage of shares for policyholders, not exceeding 10% of the offer size, while the portion reserved for employees will not be more than 5% of post-offer equity share capital, according to the filing. LIC employed 114,498 people as of end-March, 2021. In order to encourage policyholders to invest in the IPO, the firm has deployed sales agents to persuade policyholders - many of them first-time investors in equities - to open trading accounts.

RISKS FLAGGED

In the draft prospectus the insurance behemoth has flagged certain risks, such as that it may need additional capital in the future and that it cannot guarantee that it will be able to amass that capital "on acceptable terms or at all".

LIC may also need to pump in additional capital in IDBI Bank, ac-cording to the filing, which could also further strain its balance sheet.

Madrid, Feb 14: One more minute and Espanyol's 13-year winless streak against crosstown rival Barcelona in the Spanish league would finally be over. Sixty more seconds and its 23match winless run against the Spanish powerhouse would finally come to an end.

But Espanyol couldn't stop a goal by Luuk de Jong in the sixth minute of second-half stoppage time, and had to settle for a 2-2 draw Sunday that extended its unsuccessful run in the Catalan derby

The draw came as a relief for Barcelona but halted its good run after consecutive league victories against Alavés and defending champion Atlético Madrid.

The result was enough to move the Catalan club past Atlético and back into fourth place in the final Champions League spot. It is 15 points behind league leader Real Madrid with a game in hand following Madrid's 0-0 draw at Villarreal Saturday.

Espanyol, sitting in 13th place, hasn't beaten Barcelona in the league since February 2009. Its last home victory against its rival was in 2007, though it beat Barcelona in a Copa del Rey match in 2018. Espanyol is winless in its last five league games.

De Jong netted the equaliser with a header from the middle of the area after a long cross by Adama Traoré as the game neared its end Barcelona had taken an early

lead with Pedri scoring from close range after a cross by Jordi Alba two minutes into the match at RCDE Stadium. The hosts equalized in the 40th with a shot from outside the area by Sergi Darder.

Barcelona thought it had gone ahead when Gavi found the net early in the second half, but the goal was disallowed for offside. It was Espanyol that took the lead about 10 minutes later, with Raúl

Real Betis strengthened its hold on third place in the Spanish league with a 4-2 win at last-place Levante, with Nabil Fekir scoring twice and Edgar González and William

Carvalho adding a goal each to secure Manuel Pellegrini's team its seventh win in its last nine matches in all competitions.

The win left Betis seven points behind city rival Sevilla, which defeated Elche 2-0 on Friday, and 11 behind Madrid. Betis has a fourpoint gap to fourth-place Atlético, which beat Getafe 4-3 on Saturday. Atlético has a game in hand.

Betis is one of the hottest teams in Spain under Pellegrini and is still in the Europa League and the Copa del Rey. It won 2-1 at Rayo Vallecano in the first leg of the Copa semifinals on Wednesday.

Daniel Gómez scored both goals for Levante, which had striker Roberto Soldado sent off in the 74th. The club from Valencia has lost six of its last seven league matches, includ ing three in a row.

Valencia's winless streak in the league reached six matches after a 1-2 loss at relegation-threatened Alavés. Joselu's 76th-minute penalty kick gave the hosts their second win in three matches and left the club three points from safety.

Mamadou Loum N'Diaye had opened the scoring for Alavés in the 14th before Gonçalo Guedes equalized in the 62nd. Valencia has lost four of its last six league matches and dropped to 12th in the 20-team standings.

Leao leads AC Milan⁻ to the top of Serie A

Milan, Feb 14: AC Milan surged to the top of Serie A with a 1-0 win over Sampdoria. After beating city rival Inter Milan 2-1 in the previous round, Milan was third in the standings going into its game against Sampdoria and trailed leader Inter — which was held 1-1 at Napoli Saturday — by two points.

That all changed when Milan goalkeeper Mike Maignan set up the winning goal for Rafael Leao in the eighth minute. The France international sent a long kick from outside his penalty area to feed Leao who controlled the ball on the left flank before moving past defender Bartosz Bereszynski to beat Sampdoria goalkeeper Wladimiro Facone

It was the 10th goal of the season for the Portugal forward in his 100th appearance for the Rossoneri. Striker Olivier Giroud, who scored both goals in the game against Inter, had his second-half header from close range fingertipped over by Facone.

Milan tops the table with 55 points, one clear of Inter in second with Napoli another point back. Inter has a game in hand on both teams. Milan's three wins in a week, including a 4-0 rout of Lazio in the Coppa Italia, pleased coach Stefano Pioli.

Danilo scored a stoppage-time equalizer for Juventus to draw 1-1 at Atalanta and retain fourth place. The Brazilian headed in off a corner from Paulo Dybala.

Fifth-place Atalanta was close to bouncing back from a home loss to Cagliari with a victory at the expense of Juventus. Substitute Ruslan Malinovskyi gave the hosts a late lead in Bergamo. Malinovskyi fired a long-distance shot into the top corner in the 76th minute after receiving a backheel pass from a free-kick, giving goalkeeper Wojciech Szczesny no chance to

prevent the goal. In an entertaining game, Juventus' newly signed striker Dusan Vlahovic had several chances saved by goalkeeper Marco Sportiello. Juventus is on 46 points, two more than Atalanta.

Bryan Cristante headed in an injury-time equalizer to salvage a 2-2 draw for Roma at 10-man Sassuolo. Tammy Abraham converted from the penalty spot to put Roma ahead in first-half stoppage time. Sassuolo turned things around after halftime due to an own-goal by Chris Smalling and Hamed Junior Traore

put the hosts ahead in the 73rd. Five minutes later, Sassuolo was reduced to 10 men after Gian Marco Ferrari received his second yellow card. Roma remains seventh, Sassuolo is 12th

Steve Smith is getting medical attention after suffering concussion

Sydney, Feb 14: Senior Australia batter Steve Smith is expected to make a full recovery within a week from his latest concussion episode and be available for the tour of Pakistan next month.

Smith, who has a history of concussions, hit his head hard on the SCG turf in an audacious leaping attempt to stop a six near boundary rope in the second T20I against Sri Lanka which Australia won in Super Over Sunday.

His concussion diagnosis was confirmed late Sunday and Cricket Australia (CA) said the 32-year-old will be subject to "low level protocols" over the coming days before an anticipated recovery within the

week. "(Smith) will be subject to low level protocols for the next few days and full recovery in 6-7 days,' the CA said in a statement.

The star right-handed batter has already been ruled out of the remaining three matches of the ongoing T20I series against Sri Lanka. CA has not named any replacement for Smith in the Australian squad. There is enough time for Smith to recover for the Pakistan tour which begins with a Test March 4.

There was considerable concern when Smith fell near the boundary line after his spectacular but unsuccessful fielding effort as Pat Cummins and Glenn Maxwell urgently gestured for medical attention. Smith was back on his feet not long after and enquired as to whether

"It didn't look great," Smith's team-mate Matthew Wade told 'cricket.com.au'. "I think he hit the ground pretty hard. Whether he went lights out or not, I'm not 100 per cent sure. That's something only he can answer."

Pacer Josh Hazlewood said: "When anyone dives and doesn't get up straight away, there's always a bit of concern. It's good to see him walking around now and make his way off the field.'


