I-T raids former NSE chief's residence

New Delhi/Mumbai: The Income Tax Department raided Thursday the premises of former NSE MD and CEO Chitra Ramkrishna and group operating officer Anand Subramanian in Mumbai and Chennai as part of a tax evasion investigation against them, official sources said in New Delhi. The premises were raided by officials of the Mumbai investigation wing of the department. A premise in Chennai linked to Ramkrishna was also searched. The teams have taken possession of some documents from all the premises searched, they said Ramkrishna hit the headlines after a recent Sebi order said she was steered by a yogi, dwelling in the Himalayan ranges, in the appointment of Subramanian as the exchange's group operating officer and advisor to the managing director (MD). Sebi also alleged that she had shared confidential information with the sage. It levied a fine of ₹3 crore on Ramkrishna and ₹2 crore on Subramanian.

United Nations: The US told Thursday the UN Security Council (UNSC) that its information indicates that over 1,50,000 Russian forces have amassed around Ukraine's borders. They are preparing to launch an attack against Ukraine 'in the coming days". "As we meet today, the most immediate threat to peace and security is Russia's looming aggression against Ukraine," US Secretary of State Antony Blinken told the UNSC. "Russia says it's reducing those forces. We do not see that happening. Our information indicates clearly that these forces including ground troops, aircraft and ships are preparing to launch an attack against Ukraine anytime in the coming days," he added.

Bhubaneswar, Feb 17: The State Election Commission (SEC) has received proposal for re-polling at 25 places in four districts based on reports from the concerned district collectors. A decision on this issue will be taken soon, an official of the SEC said Thursday.

Secretary to State Election Commissioner, Rabindra Sahu said that the recommendation for repolling has been done for 11 booths in Jajpur district, five booths each in Puri and Bhadrak districts and

four in Dhenkanal district. Close to 50 persons were injured in incidents of violence in some of the districts during the first phase of the three-tier panchayat polls Wednesday.

The SEC also said a total of 77.2 per cent of the 67.51 lakh voters exercised their franchise in the first phase. The SEC released the final polling data Thursday. Boudh district recorded the highest voter turnout of 84.7 per cent while Ganjam with 64.96 per cent polling emerged the lowest.

Among other districts Angul registered 82.6 per cent polling while it was 76.58 per cent in Balasore. Bhubaneswar, Feb 17: 'Fake doctor' Ramesh Swain, who was recently arrested for conning and marrying 17 women in different parts of India has actually failed to clear matriculation exams. This information was given by Bhubaneswar DCP Umashankar Dash here Thursday. The police are surprised as to how Swain managed to con his victims who were all educated and successful in

their professional worlds. Dash informed that Capital city police had got in touch with relatives of Swain following his arrest to know his background. They have informed that Swain failed to complete his Class X studies.

"This is being verified," Dash said. However, the misdeeds of Swain have not just been limited to conning women. They informed that the 'fake doctor' has also duped a large number of people on the pretext of providing employment and arranging seats for MBBS courses. Swain had set up two clinics after obtaining franchises of a premier healthcare centre in Cuttack. One clinic was set up in Badamba and the other in Cuttack city, the

Bhubaneswar DCP said. Dash informed that Swain had not paid salaries to 15 women employed at the Badamba clinic. "He had also duped a doctor of some lakhs after engaging him at the clinic in Cuttack city," informed Dash.

More and more women and other victims of Swain are coming forward with complaints. "We have received three more complaints since his arrest. We suspect some more people are involved with Swain and have helped him

to commit the frauds." Dash stated. Police also conducted searches at the rented house of Swain in Patrapada. Several documents have been seized by the sleuths. Notably, Swain had taken the house on rent after identifyinghimself as the Deputy Director of Health Department.

NCW chief for CBI probe into Mamita murder

IRREGULAR by MANJUL **CUTTACK:** National Commission for Women (NCW) chairperson Rekha Sharma has demanded a probe by the CBI into the murder of Kalahandi school teacher Mamita Meher: Her observations came after she met with Odisha DGP Sunil Bansal. "The 'Frontiers Report' identifies and offers solutions to three environmental issues that merit attention and action from

governments and the public at large," UNEP executive director Inger Andersen said in the report.

'Urban noise pollution, wildfires and phenological shifts are issues that highlight the urgent need to address the triple planetary crisis of climate change, pollution and biodiversity loss. These factors can also reduce mortality not only in animals, but also in human and Mismatches: Emerging Issues of Environmental Concern, has been released days before the fifth session of the UN Environment Assembly (UNEA) resumes.

The report says noise pollution in cities is a growing hazard to public health. Unwanted, prolonged and high-level sounds from road traffic. railways, or leisure activities impair human health and well-being. This includes chronic annoyance and sleep disturbance, resulting in severe heart diseases and metabolic disorders such as diabetes, hearing impairment, and poorer mental health. Ultimately it reduces the life span.

Noise pollution already leads to 12,000 premature deaths each year in the EU and affects one in five EU citizens (no information for India available). Acceptable noise levels are surpassed in many cities world-

wide, including Algiers, Bangkok, Damascus, Dhaka, Ho Chi Minh City, Ibadan, Islamabad and New York, the report states.

Particularly affected are the very young, the elderly and marginalised communities near high traffic roads, and industrial areas and far from green spaces.

According to the report, dangerous wildfire weather is projected to get worse. Each year, between 2002 and 2016, an average of about 423 million hectares or 4.23 million sq km of the earth's land surface – an area about the size of the entire European Union – has been burnt. The wildfires are becoming more common in mixed

forest and savannah ecosystems. This in turn is affecting climate making the earth a hotter place to stay in which in turn is also leading to metabolic disorders and diseases in human beings and reducing their life span, the report said.

'Wildfires, noise pollution push human mortality' beings," Andersen said. The latest edition of the 'Frontiers Report', Noise, Blazes





Bhubaneswar, Feb 17: In a bid to reduce human interference and ensure transparency while issuing driving licence, the State Transport Authority (STA) will soon put in place an Automated Driving Test System (ADTS) at the driving test tracks of all Regional Transport Offices (RTOs) in Odisha, an official said Thursday.

Sources said the ADTS, for which the tender has already been floated, will not only check the applicant's driving skills but also ensure transparency while issuing licenses.

In the first phase, ADTS will be set up in driving test tracks of 19 RTOs— Angul, Baripada, Bhadrak, Bolangir, Deoagarh, Dhenkanal, Ganjam, Nayagarh, Phulbani, Rairangpur, Rourkela, Sundargarh, Talcher, Keonjhar, Malkangiri, Nuapada Bhanjanagar, Nabarangpur and Sonepur, it was learnt.

The system will sport a stateof-the-art setup, including video analytics technology and a vast array of cameras and sensors. From the entry of the vehicles to its inspection and driving test, everything will be conducted digitally.

New York, Feb 17: A US woman has reportedly been cured of HIV disease after a stem cell transplant. The woman dubbed as the New York patient is also the third person in the world to be cured of HIV disease, after receiving a stem cell transplant.

She is in remission after receiving a new combination of specialised stem cell transplants for treatment of acute myeloid leukaemia (AML), according to researchers at the University of California, Los Angeles.

Despite the Cessation of Antiretroviral Therapy (ART), she has had no detectable levels of HIV for 14 months, they said.

"This woman has been in remission of AML for four and a half years and has had no HIV rebound in the 14 months since antiretroviral therapy was stopped," said Yvonne Bryson, Professor and specialist in paediatric infectious diseases and HIV pathogenesis at the David Geffen School of Medicine at UCLA.

"If HIV remission continues and she is determined to be cured, she would be only the third person to achieve cure and the first HIV remission to have been success fully engrafted with umbilical cord blood cells with a mutation that is protective against HIV-1 combined with stem cells from an adult, haploidentical (half-matched) re-

lated donor." Bryson said. The two previous patients with HIV cure received adult donor cells - one from bone marrow and one from blood stem cells - that had the protective mutation, but no umbilical cord blood cells.

The woman is of mixed race who was diagnosed with acute HIV in 2013 and high-risk AML in 2017. She achieved leukaemia remission after chemotherapy. Prior to receiving the stem cell transplant, the participant's HIV was well-

HIV remission resulting from a stem cell transplant had been previously observed in two cases. The first, known as the "Berlin patient" (a Caucasian male), experienced HIV remission for 12 years and was deemed cured of HIV; he died of leukaemia in September 2020. The "London patient" (a Latino male) has been in HIV remission for more than 30 months.

Although stem cell transplantation is not a therapy for HIV, its effects in patients living with HIV and undergoing therapy for blood or lymph cancers provide researchers with insights and potential targets in HIV treatment.

"This study provides hope for the use of cord blood cells or a combination of cord blood cells and haploidentical (half-matched) grafts to achieve HIV-1 remission for individuals requiring transplantation for other diseases. It also provides proof that HIV-1 viral 'reservoirs' can be cleared sufficiently to afford remission and possibly cure in the setting of resistant target cells," said Bryson.

After studying measles and polio viruses, Takahashi accepted a research fellowship in 1963 at Baylor College in the United States. It was during this time that his son developed a serious bout of chickenpox, leading him to turn his expertise toward combating the highly

1965 and began culturing live but weakened chickenpox viruses in an-

imal and human tissue. In just five years, the vaccine was ready for clinical trials. In 1974, Takahashi had developed the first vaccine targeting the varicella virus that causes chickenpox.

It was subsequently subjected to rigorous research with immunosuppressed patients and was proven to be extremely effective.

In 1986, the Research Foundation for Microbial Diseases, Osaka University began the rollout in Japan as the only varicella vaccine approved by the WHO.

uch of the democratic world would like the United States to remain the preeminent global power. But with the US apparently committed to strategic overreach, that outcome risks becoming unlikely. The problem with America's global leadership begins at home. Hyper-partisan politics and profound polarisation are eroding American democracy and impeding the pursuit of long-term objectives. In foreign policy, the partisan divide can be seen in perceptions of potential challengers to the US: according to a March 2021 poll, Republicans are most concerned about China, while Democrats worry about Russia above all.

This may explain why US President Joe Biden is treating a 'rogue' Russia as a peer competitor, when he should be focused on the challenge from America's actual peer, China. In comparison to Russia, China's population is about ten times bigger, its economy is almost ten times larger, and its military expenditure is around four times greater. Not only is China more powerful; it genuinely seeks to supplant the US as the preeminent global power. By contrast, with its military buildup on Ukraine's borders, Russia is seeking to mitigate a perceived security threat in its neighbourhood.

Hastening the decline of US global leadership is hardly the preserve of Democrats. A bipartisan parade of US leaders has failed to recognise that

the post-Cold War unipolar world order, characterised by unchallenged US economic and military predominance, is long gone. The US squandered its 'unipolar moment,' especially by waging an expensive and amorphous 'Global War on Terrorism,' including several military interventions, and through its treatment of Russia.

After its Cold War victory, the US essentially took an extended victory lap, pursuing strategic maneuvers that flaunted its dominance. Notably, it sought to expand NATO to Russia's backvard, but made little effort to bring Russia into the Western fold, as it had done with Germany and Japan after World War II. The souring of relations with the Kremlin contributed to Russia's eventual remilitarisation.

So, while the US remains the world's foremost military power, it has been stretched thin by the decisions and commitments it has made, in Europe and elsewhere, since 1991. This goes a long way toward explaining why the US has ruled out deploying its own troops to defend Ukraine today. What the US is offering Ukraine – weapons and ammunition – cannot protect the country from Russia, which has an overwhelming military advantage.

But US leaders made another fatal mistake since the Cold War: by aiding China's rise, they helped to create the greatest rival their country has ever faced. Unfortunately, they have

yet to learn from this. Instead, the US continues to dedicate insufficient attention and resources to an excessively wide array of global issues, from Russian revanchism and Chinese aggression to lesser threats in the Middle East and Africa and on the Korean Peninsula. And it continues inadvertently to bolster China's global influence, not least through its overuse of sanctions.

For example, by barring friends and allies from importing Iranian oil, two successive US administrations enabled China not only to secure oil at a hefty discount, but also to become a top investor in - and security partner of - the Islamic Republic. US sanctions have similarly pushed resource-rich Myanmar into China's arms. As Cambodian Prime Minister Hun Sen, whose country has faced a US arms embargo over its ties to China, asked last year, "If I don't rely on China, who will I rely on?

Russia has been asking itself the same question. Though Russia and China kept each other at arm's length for decades, US-led sanctions introduced after Russia's 2014 annexation of Crimea drove President Vladimir Putin to pursue a closer strategic partnership with China. The bilateral relationship is likely to deepen, regardless of what happens in Ukraine. But the raft of harsh new sanctions the US has promised to implement in the event of a Russian invasion will accelerate this shift significantly, with China as the big winner.

The heavy financial penalties the US has planned – including the 'nuclear option' of disconnecting Russian banks from the international SWIFT payments system – would turn China into Russia's banker, enabling it to reap vast profits and expand the international use of its currency, the renminbi If Biden fulfilled his pledge to block the Nord Stream 2 gas pipeline, which is set to deliver Russian supplies directly to Germany via the Baltic Sea, China would gain greater access to Russian energy.

In fact, by securing a commitment from Putin this month to a nearly tenfold increase in Russian natural gas exports, China is building a safety net that could – in the event of a Chinese invasion of Taiwan – withstand Western energy sanctions and even a blockade. China could also benefit militarily by demanding greater access to Russian military technology in exchange for its support.

For the US, a strengthened Russia-China axis is the worst possible outcome of the Ukraine crisis. The best outcome would be a compromise with Russia to ensure that it does not invade and possibly annex Ukraine. By enabling the US to avoid further entanglement in Europe, this would permit a more realistic balancing of key objectives - especially checking Chinese aggression in the Indo-Pacific – with available resources and capabilities.

The future of the US-led international order will be decided in Asia, and China is currently doing everything in its power to ensure that order's demise. Already, China is powerful enough that it can host the Winter Olympics even as it carries out a genocide against Muslims in the Xinjiang region, with limited pushback. If the Biden administration does not recognise the true scale of the threat China poses, and adopt an appropriately targeted strategy soon, whatever window of opportunity for preserving US preeminence remains may well close.

RAY'S 'PATHER PANCHALI' **MARKS A REMARKABLE** AND CONSCIOUS **DEPARTURE** FROM THE **CONVENTIONS OF INDIAN COMMERCIAL CINEMA**


n a review of Satvaiit Rav's 'Apur Sansar' (The World of Apu), the critic Dwight MacDonald castigated Ray for being "self-conscious. MacDonald, along with many western critics of that time, didn't consider Ray capable of handling the complexities of city life. This was because his movies were seen as being autobiographical and reflective of Ray's own lived experience in India. This attitude stemmed from a stereotypical view of India, the lack of familiarity with its popular culture as well as its city life.

To a contemporary film critic or even someone with a cursory familiarity with Ray, this suggestion is laughable. Not only because his later work, in particular the Calcutta trilogy, dealt explicitly and brilliantly with alienation that came with capitalism but also because his lived experience was as far away from rural life as possible. Born in a family of scholars, Ray grew up in the cosmopolitan city of Calcutta. He was reluctant to study at Shantiniketan due to its "intellectual second rated-ness." He sought to become a filmmaker after watching Vittorio de Sica's Italian neo-realist movie 'The Bicvcle Thieves.' It was the French director Jean Renoir who encouraged him to make 'Pather Panchali.'

In other words, Ray was as cosmopolitan as it gets. It is no wonder that his portraval of city life was accurate. It is, however, worth asking as to why his portrayal of Indian rural life strikes a chord even today.

To answer this, we need to grapple with Ray's critique of commercial Indian cinema. In an interview with Pierre-Andre Boutang, Ray claimed that the Indian audience who are mostly exposed to Hindi commercial cinema were "backward and unsophisticated." At first glance, this might appear a bit snobbish but Ray's essays on filmmaking provide a more nuanced view.

Cinema started out as an international medium. Through the technique of mime, the likes of Charlie Chaplin and Buster Keaton created an art-form that was uni-

versally accessible. With the development of technology and the introduction of talkies, mime no longer retained the centrality that it did in silent films. Dialogue and visual forms became more essential. This led to the development of distinct national styles in different countries. The Americans developed a Jazz-like tempo along with the nostalgia and sentimentality present in the blues. The French were more experimental, with musicians like Darius Milhaud making extensive use of polytonality popularised by Stravinsky in soundtracks and filmmakers like Jean-Luc Godard and Francois Truffaut exploring existentialism and Marxism, often questioning the importance of cinema itself.

Indian cinema, on the other hand, has been devoid of such development as a rule. Indian movies have largely been formulaic. They fail to convey or display the rich heritage of literature, music, culture, painting or even geography that we have. In Ray's words, Indian cinema has "remained as incongruous and clashing elements, refusing to coalesce into the stuff that is cinema."

Ray's 'Pather Panchali' marks a remarkable and conscious departure from the conventions of Indian commercial cinema. While

acutely aware of Western art forms, Ray consciously decided to make movies that were, in his own words, "distinct and indigenous." Ray's realism is derived from the works of Bibhutibhushan Bandyopadhyay. He remains true to the spirit of humanism and lyricism that characterises Bibhutibhushan's novel. Ray even credits Bibhutibhusan for the pictorial aspect which plays an essential role in turning the movie into a truly indigenous one. As Darius Cooper has argued, Ray's narratives strongly reflect the principles of Rasa elaborated by Bharata Muni and Abhinavagupta. A sense of epiphany of wonder and constancy of character is everpresent in The Apu Trilogy. For instance, Apu's character retains constancy though aspects of him change subtly with life's experiences. This constancy is made obvious to the viewer through contrast with his sister Durga in 'Pather Panchali' and his mother in 'Aparajito.'

Ray's quest to develop a form of cinema true to Indian experience can also be seen from his use of music. Though manifest most explicitly in 'The Music Room' (Jalsaghar), glimpses of it are present even in 'Pather Panchali.' Composed by Pandit Ravi Shankar, the soundtrack of the movie al-

most exclusively uses Indian instruments and classical music. However, it was on Ray's request that Chunibala Devi (the 80-yearold playing Indir Thakrun) sang the iconic plaintive traditional song. The song wasn't chosen but was one that Devi had remembered. The song haunts the viewer, especially as it plays in the background when the character of Indir Thakrun dies (made more haunting perhaps with the apt lyrics "Hari, the day is gone and night has fallen. Help me to pass over").

Dissatisfied with the "spasmodic injection of song numbers" that continues to characterise many Bollywood movies, Ray decided to make the musical 'Jalsaghar.' This can be considered at once a critique of the use of music in commercial movies as well as a complete expression of what cinema can achieve. Ray documents the breakdown of the feudal system and the loss of prestige of the hedonistic landlord by making extensive use of Ustad Vilavat Khan's compositions. It was one of the only films of its time which not only used music thematically but also incorporated extensive clas-

sical music. Ray's legacy, apart from his technical achievements and fierce originality, was the fact that he showed Indian filmmakers and artistes what cinema can be. Indian filmmakers weren't suffering from lack of resources, rather from a lack of imagination. Ray's diagnosis was vindicated as it provided directors like Mrinal Sen, Ritwik Ghatak, Tapan Sinha, Adoor Gopal Krishnan and Shyam Benegal an entirely new and unique space to explore. Indian cinema is yet to take a coherent form in the way that French, Japanese and Italian cinema have. However, Ray provided us with a glimpse of the potentialities of Indian cinema and left open possibilities that will no doubt, sooner or later, result in its crystallisation.

✓ promoted to tackle the looming environmental crisis, but the consumer's choice is slowly changing. The demand, be it four or two wheelers, is steadily picking up. From environmental perspective, EVs are the future of the auto industry in India as in many other countries. The thrust has been clearly noted

in the recent Union Budget with the government policy of battery swapping expected to give a boost to the domestic EV industry, especially for public transport, as it will provide an affordable solution to the charging issue. Industry stakeholders said the policy will help develop the infrastructure needed to make EVs improve their use in public transport as also for general users.

In fact, the government's EV policy 'Scheme for Faster Adoption & Manufacturing of Hybrid & Electric Vehicle in India' has seen a big boost from ₹800 crore to ₹2908.28 crore in the budget for 2022-23. E-mobility is all set to get a major impetus with the announcement of a battery swapping policy with the provision of land for establishing charging stations at scale. The target obviously, would be to have more EVs on the road in the coming years.

That India is destined to be a

hicles within the next five years was forecast by Union Road and Transport Minister Nitin Gadkari, stating that several countries no longer want to deal with China following the COVID-19 crisis. Gadkari asked Indian automotive companies to boost their EV technology and also to focus on finding alternatives to lithium-ion battery tech to help make India the next global manufacturing hub for electric vehicles.

So far China has been on top in terms of EV production globally by producing over 80% of all EVs. It has the fourth largest reserves of lithium in the world, hence giving it a monopoly in the lithium-ion cell market. The government had launched the National Electric Mobility Mission Plan 2020 in 2013 to enhance fuel security as also to address vehicular pollution through the promotion of hybrid and EVs. The government launched the Faster Adoption and Manufacturing of Hybrid & Electric Vehicle scheme under NEMMP. 2020 in 2015-16. The scheme was to make hybrid and EVs as the first choice for buyers instead of internal combustion engines and reduce liquid fossil fuel consumption in the country.

Since April, 2019, the outlay of the scheme (FAME-II) has been enhanced to ₹100 billion for a period of

incentive on the purchase of EVs and also to establish the necessary infrastructure for EVs. Though higher EV sales had not picked up initially, from early 2021 the trend is changing as a lot of manufacturers of four wheelers and two wheelers have entered the market.

Recently, the governments of Tamil Nadu, Punjab, Telangana, Maharashtra, and West Bengal invited the auto company Tesla to set up shop in their respective States. This open invitation was a response to company founder Elon Musk's tweet that Tesla was "facing a lot of challenges" launching their EVs in the country. However, the government remains unmoved and maintains the 100 per cent import duty on CBUs manufactured abroad. Instead, it has been pushing for greater localisation of EV manufacturing through multiple policy measures FAME-II.

For EVs production the most important raw materials such as lithium, cobalt and nickel, which are used to make lithium-ion battery cells, are not available in the country. Consequently, Indian manufacturers must rely heavily on imports of battery cells from China, Japan, Korea, and Taiwan and assemble them into battery packs. Though there is optimism and en-

lectric vehicles are causing a manufacturing hub for electric vethree years, mainly to offer upfront couraging response from investors facture ACC batteries domestically, most bidders are expected to start manufacturing only from 2025. It is thus quite natural that India's import-driven strategy, for domestic assembly of critical battery packs, will continue for a few more years.

> Technical experts have suggested that electro-chemical energy in the form of metal air batteries could be the choice of the future, at least for India. Metal air batteries can match the driving range of conventional internal combustion engine vehicles and reload full energy to full energy capacity in less than five minutes. Significantly, much research has taken place on such batteries during the period 2014 to 2020. Unlike conventional batteries, metal air batteries utilise oxygen from the atmosphere at the cathode. These have higher energy density (energy per unit weight) compared with lithium batteries. Aluminum can be used as the anode of metal air batteries as the country has abundant bauxite deposits in the country.

Relocation of cheetahs

Sir, The relocation of cheetahs to India is a much discussed issue because the project has been in the pipeline for quite some time. Asiatic cheetahs vanished from India as far back as 1950; the cheetah was declared extinct from the country in 1952. Worldwide, its population is almost few and far between except for a few regions in Africa. Low genetic variability and prolonged inbreeding were once cited as reasons for the decline of cheetahs though many wildlife experts claimed that the genetic variability was lost ten thousand years ago. The only explanation could be poaching and hunting. Minister of Environment Ashwini Kumar Choubey told the Lok Sabha recently that India's cheetah relocation project was on course. A sum of ₹40 crore has been earmarked, from the Project Tiger to introduce cheetah in the country between 2021-22 and 2025-26. The Kuno Palpur National Park in Madhya Pradesh is all set to receive its special guests. Based on the Wildlife Institute of India (WII) report, and its direct guidance, the reintroduction project is being carried out. As many as 12 to 14 'greyhounds', male and female, are to be inducted in Kuno Palpur. It was after all failed attempts to relocate the greyhounds that Kuno national park, spread over an area of 750 sq km, was identified. Though initially the Supreme Court had stayed the 'cheetah conservation plan' by upholding the plea of conservationists quoting the National Board for Wildlife's policies, it later gave the green signal to the introduction of cheetah to India. Since cheetah is seen as vulnerable by the International Union for Conservation of Nature (IUCN), the reintroduction has to be done with care and caution. Cheetahs of the reproductive age group, that are disease free and genetically diverse, should be relocated in the national park. Ganapathi Bhat, AKOLA



During investigation, the EOW found that the company - Auroxa Deal Multitrade (OPC) Private Limited – was functioning in a rented building in Balasore town of Odisha during the year 2019-



feud that refuses to end, and a turncoat who has entered the fray with another party.

The BJP candidate from Amethi is the erstwhile Raja of Amethi and former MP Sanjaya Sinh. He is returning to state politics after over three decades and his entry has triggered another battle between his two wives.

Garima Singh objected to the omission of her name in Sanjaya Sinh's affidavit, claiming that her 'alleged divorce' had been struck down by court because her signatures were forged. She said that she remained his legal wife. The objection was dismissed.

In 2017, Amethi had witnessed a face-off between the wives --Garima Singh, who was the BJP candidate, and Ameeta Sinh, who contested on a Congress ticket. Garima won the election. Sanjaya Sinh, who has returned to Amethi, ostensibly, to reclaim his legacy but sympathy for Garima, his first wife, still is palpable in Amethi that considers her the 'Rani'.



Sanjaya Sinh claims it was his father Rananjay Singh who offered the Amethi seat to the Gandhis. Rananjay Singh had won the first election after Independence from the Amethi seat as an independent candidate. He later won elections on the Jana Sangh ticket in 1969 and Congress ticket in 1974. Sanjaya Sinh started his political career from Amethi in 1980 and people welcomed him with open arms. In 1985, Sinh won again by getting a record 98 per cent of the votes polled. In 1989, he lost as a

Janata Dal candidate.

Sanjaya Sinh later joined the BJP. In the 1998 Lok Sabha election, he defeated Satish Sharma of the Congress. He lost to Sonia Gandhi in the 1999 general elections. Wife Ameeta, won the Amethi Assembly seat in 2002 on a BJP ticket.

In 2004, the couple returned to the Congress. Ameeta won the 2004 Assembly bypoll and later the 2007 poll from Amethi. In 2012, Ameeta lost to Gayatri Prasad Prajapati of the Samajwadi Party by a close margin

The couple then joined the BJP again. Sanjaya Sinh's main challenger is Maharaji Prajapati, wife of former minister Gayatri Prajapati, who is in jail since 2017 on charges of rape and corruption. Maharaji has been fielded by



MANMOHAN BLASTS MODI

New Delhi, Feb 17: The BJP had been in power for more than seven years and was still blaming first Prime Minister Jawaharlal Nehru for the problems of the people, former Prime Minister and Congress leader Manmohan Singh said Thursday in a scathing attack against the Modi-led government.

Targeting the central government on a host of issues, including the farmers' agitation, foreign policy, price rise and unemployment, Singh said ahead of the Punjab elections February 20 that the BJP's nationalism was "fake" and was based on the British policy of "divide and rule"

The Congress played the message delivered in Punjabi at a press conference here. According to Singh, the government had proved to be a "complete failure" on the issue of foreign policy. The Chinese army, he alleged, was occupying "our pious land for the last one year but efforts are being made to bury this issue". "Our relations



with neighbouring nations are also deteriorating," Singh said. Further targeting the Centre on foreign policy matters, Singh said.

"Old friends are constantly alienating from us, while our relations with neighbouring countries are also deteriorating. "I hope that now the ruling dis-

pensation has come to understand that the relations of the countries do not improve by forcefully embracing the leaders, playing on a swing with them or going for uninvited biryani," he said, in a swipe at Prime Minister Narendra Modi.

With the Congress targeting the Centre saying its governance was visible only in advertisements. Singh said, "The truth somehow always comes to the fore. It is very easy to talk of big things but it is very difficult to put those things into action." He said the government does not have trust in the country's constitution and "institutions are continuously being weakened".

"Today the situation is very worrisome. In the midst of the coronavirus pandemic, the short-sighted

India objects to S'pore PM's remark

New Delhi: India Thursday took exception to the remarks by Singapore Prime Minister Lee Hsien Loong referring to criminal charges on Indian lawmakers, people familiar with the development said. It is learnt that the issue was raised with the Singaporean High Commissioner at the Ministry of External Affairs. "The remarks by the prime minister of Singapore were uncalled for. We are taking up the matter with the Singaporean side," said one of the people cited above. The Singapore PM had invoked Jawaharlal Nehru while highlighting how democracy should work in the city-state during a debate in Parliament. "Many political systems today would be quite unrecognisable to their founding leaders. Ben-Gurion's Israel has morphed into one which can barely form a government, despite four general elections in two years. Meanwhile, a stream of senior politicians and officials in Israel face a litany of criminal charges, some have gone to jail.

policies of the central government, on the one hand, have caused people to suffer from falling economy, rising inflation and unemployment." Hitting out at the central government, Singh, who is a noted economist, said they have no understanding of the economy, which was not in a healthy shape.

Govt removes caps on \prec **India-Ukraine flights**

New Delhi, Feb 17: Amid tense situation in Ukraine, the Ministry of Civil Aviation has removed the curbs on the number of flights that can be operated between India and the Eastern European nation under the bilateral air bubble arrangement to facilitate travel of Indians from that country.

WEDDING CELEBRATION TURNS TRAGIC

13 killed after falling into well

Kushinagar (UP), Feb 17: Loud wails echoed in nondescript Nebua Naurangia village of Kushinagar district Thursday after 13 women and young girls fell into a well during a wedding ritual and died.

The incident, in which at least 10 people were also injured, occurred Wednesday night when an iron grille they were sitting on broke, officials and family members said. Prime Minister Narendra Modi

and Uttar Chief Minister Yogi Adityanath expressed sorrow over the incident. The grief-stricken family

announced that they won't take out the 'baraat' (groom's wedding procession) after the tragedy. Only the groom, Amit Kushwaha, travelled in a car for the wedding. Narrating the incident,

Kushwaha said, "Actually the well is old and it was covered with a slab. During the ritual, girls were standing on the slab when it broke and they all fell inside the well."

On getting information about the tragic incident, Inspector Girjesh Upadhaya reached the spot. Police



Some women and children were sitting on the iron grille and it suddenly broke and they fell into the well

personnel and villagers pulled out all 23 people who had fallen into the well and rushed them to a hospital. Thirteen of them were declared dead by doctors, the officials said.

Senior administrative and police officials also reached the spot. No one from Kushwaha's family died in the incident. His granddaughter Payal fell into the well but was rescued. A posse of police personnel were seen guarding the well where the tragedy stuck. The old well is about 100 metres away from Kushwaha's home

According to the villagers, the well is more than 70 years old and the locals often perform rituals near it, especially during weddings.



Detroit: US auto safety regulators have launched another investigation of Tesla, this time tied to complaints that its cars can stop on roads for no apparent reason. The government says it has 354 complaints from owners during the past nine months about "phantom braking" in Tesla Models 3 and Y. Chad and Burkina Faso have weakened France's alliances in its former colonies, emboldened iihadists who control large swathes of desert and scrubland, and opened the door to greater Russian influence.

Japan eases its border controls

Tokyo: Japan will ease border controls imposed to counter the pandemic, Prime Minister Fumio Kishida said on Thursday, softening measures that have been among the strictest imposed by wealthy nations and have been slammed by business and educators. About 150,000 foreign students have been kept out of Japan, along with workers desperately needed by an ageing nation with a shrinking population, prompting warnings of labour shortages and damage to its international reputation.

Venezuela, Russia hold discussions

Caracas: Venezuelan and Russian officials met for highlevel discussions in the South American country Wednesday, a day after diplomats from the US and several other nations gathered to discuss steps toward a negotiated solution to the country's protracted crisis. The meeting between Russia's Deputy Prime Minister Yuri Borisov and Venezuela's Petroleum Minister Tareck El Aissami was meant to "strengthen strategic cooperation relations", according to a statement from the Venezuelan government.

It's still Bangkok! Thailand quells talk of name change

The Thai name for Bangkok, Krung Thep Maha Nakhon, is actually a short form of the capital's full name, which is also the world's longest place name, according to the Guinness World Records

Bangkok, Feb 17: No, English speakers and others using the Roman alphabet aren't going to have to start calling the Thai capital by its local name, Krung Thep Maha Nakhon, and drop the more familiar "Bangkok."

That's the message from Thailand's Royal Society, which is responsible for academic and linguistic standards, after a seem-

ingly innocuous change in punctuation in official guidance sparked a flurry of speculation that the city's name was being changed.

It started when the Cabinet Tuesday approved a Royal Society proposal changing the way the capital would be referred to internationally from "Krung Thep Maha Nakhon; Bangkok" to "Krung Thep Maha Nakhon (Bangkok).

As people sought to derive the meaning behind changing the semi-



colon to parentheses, many put great weight to the accompanying explanation that it would "revise" the name of the capital city and keep the "former" name in brackets.

The capital is already officially known in the Thai language as Krung Thep Maha Nakhon, which literally means "great city of angels," and most Thais shorten it to just Krung Thep in conversation.

As speculation grew, the Royal Society Wednesday clarified in a Facebook post that their new guidance was simply a stylistic change.

'Writing the capital city's official name with the Roman alphabet can be done both as Krung Thep Maha Nakon and Bangkok," the government agency said, allaying the fears of any non-Thai speakers about adopting the more complicated name. Even if the Royal Society had meant to change the name to the one used by Thais. however, there is another option that would have been an even greater challenge for foreign tongues.

The Thai name for Bangkok, Krung Thep Maha Nakhon, is actually a short form of the capital's full name, which is rooted in Pali and Sanskrit and is more of a phrase to describe the city than a name Krung Thep Mahanakhon Amon Rattanakosin Mahinthara Avuthava Mahadilok Phop Noppharat Ratchathani Burirom Udomratchaniwet Mahasathan Amon Piman Awatan Sathit

'Every indication' Russia mulling an attack: Biden

Moscow/Kyiv, Feb 17: US President Joe Biden said Thursday there was now every indication Russia was planning to invade Ukraine in the next few days and was preparing a pretext to justify it, after Ukrainian forces and pro-Moscow rebels traded fire in eastern Ukraine.

The Kremlin accused Biden of stoking tension and released a strongly worded letter which said Washington was ignoring its security demands and threatened unspecified military-technical measures. Moscow also ejected the number two official from the US embassy.

Early morning exchanges of fire between Ukraine and pro-Russian separatists stoked alarm, with Western officials who have long warned that Moscow could try to create a scenario to justify an invasion saying they believed that was now unfolding. "We have reason to believe they are engaged in a false flag operation to have an excuse to go in. Every indication we have is they're prepared to go into Ukraine and attack Ukraine," Biden told reporters as he departed the White House. "My sense is this will happen in the next several days.'

Biden ordered Secretary of State Antony Blinken to change his travel plans at the last minute to speak at a United Nations Security Council meeting on Ukraine.

Washington says Russia is not withdrawing, but in fact sending more forces. White House spokesperson Karine Jean-Pierre said Thursday Washington had confirmed that Russia had added 7,000 troops to its presence at the Ukrainian border over the past 24 hours, a cause of serious concern.

Kremlin spokesperson Dmitry Peskov said Moscow was seriously concerned about the reports of an escalation. Russia has long accused Kyiv of planning to provoke escalation as an excuse to seize rebel territory by force, which Ukraine denies.

Ukraine's President Volodymyr Zelenskiy said the pro-Russian forces had shelled a kindergarten, in what he called a big provocation.

Ensure multi-lateral funding to tackle future pandemics

New Delhi, Feb 17: India Thursday urged the world's biggest 20 economies (G20) to make joint efforts to ensure increased multilateral funding by global institutions including the International Monetary Fund to prepare for future pandemics.

Low middle-income and middle income countries do not have enough resources and need global support to face these challenges, Indian Finance Minister Nirmala Sitharaman told her G20 counterparts hosted at a virtual meeting by Indonesia.

"It's apparent now for more that has been discussed from the morning and even in this panel that investment should happen now for a safer future is agreed upon," she said while sharing her views on mobilising finance for global public goods.

For example, she said, India alone had allocated \$29 billion for health infrastructure mission in which health insurance was assured for the poor and the low income groups. G20 members should work together to address the gaps in global pandemic preparedness,

She said the World Health Organisation (WHO) needed to augment its capacity and mobilise global resources, and structural bottlenecks would have to be addressed to lessen the impact a pandemic might have.

Earlier Thursday, US Treasury Secretary Janet Yellen urged G20 members to back a proposed fund to invest in pandemic prevention and preparedness, warning that failure to close gaps in global health systems could result in "devastating" costs.

US billionaire announces 3 more SpaceX flights



Washington, Feb 17: US billionaire Jared Isaacman, who chartered the first all-civilian orbital spaceflight, announced Monday three more private missions with SpaceX -- which will include spacewalking and culminate in the first crewed flight of the next-generation Starship rocket.

The first, named Polaris Dawn, will take place no sooner than the fourth quarter of this year, and will be commanded by Isaacman, the founder of payment processing company Shift4.

The program represents a new step for the commercial space sector, as Elon Musk's SpaceX seeks to carry out more ambitious missions that were until now the domain of national space agencies.

In a press call, Isaacman revealed that the Polaris Program, named after the North Star, will be co-funded by himself and SpaceX.



He declined to give further details such as total cost, or the percent-

age each side would contribute. It is however widely expected

of dollars. This program has been purposefully designed to advance long duration spaceflight capabilities... guiding us towards the ultimate goal of facilitating Mars exploration. Isaacman told reporters. For Polaris Dawn, the crew will journey deeper into space than any Dragon has previously flown -- with Isaacman indicating the altitude would be similar to NASA's Proiect Gemini, the agency's second crewed spaceflight program in the 1960s.

Gemini 11 flew around 1,370 kilometers high, which is far deeper into space than more recent missions to the International Space Station, 250 miles high.

But it is still well short of the journey to the Moon during the Apolloera, which is roughly 239,000 miles -- or 30 Earths back-to-back -- away.

The Polaris Dawn crew will also attempt the first commercial spacewalk, which will require new extravehicular space suits that are yet to be developed.

Since Dragon has no airlock, the whole spacecraft will be exposed to the vacuum of space when the hatch is opened.

The crew will make sure that everything is secured very well before we open that hatch, mission specialist and medical officer Anna Menon said.

Launching from the Kennedy Space Center in Florida on a Falcon 9 rocket, the spacecraft will spend up to five days in orbit. The crew's intended altitude

will see them enter the inner Van Allen belt, a region of dangerous radiation that protects the Earth from solar wind.

The last of the three missions will involve a SpaceX Starship rocket, which when complete will be the biggest and most powerful spacecraft ever built.

Musk sees the vessel as key to fulfilling his vision of colonising Mars, while a version has been contracted by NASA as a lunar lander for the Artemis program, which is set to return humans to the Moon around the middle of this decade.


Iraq tightens grip on India oil market

New Delhi, Feb 17: India's imports of oil from Iraq surged in January to a 29-month high of about 1.3 million barrels per day (bpd), making up nearly a third of the supplies to Asia's third largest economy, data from shipping and industry sources show.

Iraq's importance as a key supplier is set to grow this year as at least two Indian refiners have increased their annual oil import deals with the second biggest OPEC producer.

New Delhi, Feb 17: The government Thursday allowed free inter-state wheeling of renewable energy used in the production of green hydrogen and ammonia as it seeks to boost usage of the carbon-free fuel and make India an export hub.

Under the policy, companies will have the liberty to set up the capacity to generate electricity from



the country by themselves or through a developer. They could also buy such power from the exchange. This electricity will be allowed to be wheeled, free of cost through open access of the transmission grid, to the plant where hydrogen is to be produced.

The government will also allow the green hydrogen/ammonia manufacturer to bank unconsumed renewable power, for up to 30 days with the distribution company and take it back when required.

The policy provides for a "w

cluding statutory clearances in a time-bound manner, will be set. Manufacturers of green hydrogen/green ammonia would also be allowed to set up bunkers near ports for storage of green ammonia for export or use by shipping.

The fuels can be a game-changer for the energy security of India, which imports 85 per cent of its oil and 53 per cent of gas requirements. The policy will aid in India's energy transition and achieving the target of becoming carbon neutral by 2070.

Kolkata, Feb 17: Former India midfielder and East Bengal legend Surajit Sengupta, who mesmerised Kolkata Maidan with his dribbling skills in the 1970s, died at a city hospital Thursday following his prolonged battle with

COVID-19. He was 71. After being tested positive for COVID-19, Sengupta was admitted to the hospital January 23 and was put on ventilator since Monday. He breathed his last in the afternoon.

"Lost veteran star footballer Surajit Sengupta today. Heart throb of football fans and an outstanding national sportsman as well as a perfect gentleman, he will ever be in our hearts. Deepest condolences," West Bengal chief minister Mamata Banerjee said in a tweet.

"His condition was stable but since Friday he started develop $ing\, breathing\, complications\, and\, his$ oxygen level started dropping. He was put on life support since Monday," said hospital sources.

Sengupta stole the hearts of football fans at Kolkata Maidan in the 1970s with his magical dribbling skills and was a perfectionist when it came to scoring goals from an acute angle.

The artistic right winger made his International debut July 24, 1974 against Thailand in the Merdeka Cup in Kuala Lumpur and went on to represent India in 14 matches.

He represented India in the Asian Games in 1974 and 1978, the Merdeka Cup in 1974, the President's Cup in 1977 and in international friendlies against UAE and Bahrain (1979). He scored his lone international goal against Kuwait in the 1978 Asian Games
