PUTIN GETS OK TO USE FORCE ABROAD

■ *The move indicates the* imminent breakout of a full scale war with Ukraine

Moscow, Feb 22: Russian lawmakers Tuesday authorised President Vladimir Putin to use military force outside the country a move that could presage a broader attack on Ukraine after the US said an invasion was already underway there.

Several European leaders said Russian troops rolled into rebelheld areas in eastern Ukraine after Putin recognised their independence. But it was unclear how large the deployment was, and Ukraine and its Western allies have long said Russian troops were fighting in the region, allegations that Moscow always denied.

Members of the Federation Council voted unanimously to allow Putin to use military force outside the country—effectively formalising a Russian military deployment to the rebel regions, where an eightvear conflict has killed nearly 14,000 people. Shortly after: Putin laid out three conditions to end the crisis that has threatened to plunge Europe back into war, raising the specter of massive casualties, energy shortages across the continent and economic chaos around the globe.

He called for international recognition of Crimea as part of Russia, an end to Ukraine's NATO membership bid and a halt to weapons







Fake PwD certs cost admission of 28 students

Bhubaneswar, Feb 22: The state Higher Education (HE) department Tuesday directed the Odisha Computer Application Centre (OCAC) to cancel the admission of 28 students on the ground of furnishing fake Persons with Disability (PwD) certificates.

Deputy Director of the HE department Rajesh Kumar Sahoo, in a letter to the General Manager (GM) of OCAC, wrote that 28 students of Bhadrak Autonomous College had taken admission by producing fake PwD certificates for the sessions 2019-20, 2020-21,

He also directed the OCAC GM to update the list of students in the SAMS portal after cancelling the admission of these students.

Earlier, the state government had asked all degree colleges to verify disability certificates of students admitted under the PwD quota in the last three academic sessions. The HE department had taken this step in the wake of fake admissions in the said college. The principals were asked to verify and authenticate the disability certificates of such students.

In order to detect such mal practices elsewhere, the principals of the colleges across the state were directed to verify the disability certificates of the physically handicapped and orthopedically handicapped (PH-OH) students through the Chief District Medical Officers (CDMOs) of the districts concerned.

New Delhi, Feb 22: The Supreme Court (SC) Tuesday adjourned hearing of a batch of petitions filed by Odisha against the order of Vamsadhara Water Dispute Tribunal, which had allowed Andhra Pradesh to construct Neradi barrage over Vamsadhara

A three-judge bench of the SC comprising Justices DY Chandrachud, Surya Kant and Vikram Nath posted the matter for hearing March 9. The bench also asked the apex court registry to list the case on top of board for hearing March 9.

During Tuesday's hearing, Justice DY Chandrachud said the court will take up Vamsadhara water dispute after concluding hearing in another case.

Earlier, the state of Andhra Pradesh had filed an affidavit in response to the Odisha's petition against the order of the tribunal. Andhra Pradesh contended that Odisha's petition is conceived and no case is made out for the interference of the apex court.

The apex court had obs September 24 2021 that such interstate disputes should be disposed of at the earliest and posted the matter for final disposal after Diwali vacations.

Significantly, Odisha had earlier filed two petitions in the Supreme Court challenging the order of the tribunal and also opposed the joint survey of the Neradi barrage as directed by the tribunal.

ECoR breaks own freight loading record of last fiscal

Bhubaneswar, Feb 22: The East Coast Railway (ECoR) surpassed the annual loading of the last fiscal at least 38 days before the end of current financial year, sources said.

The ECoR has surpassed the last financial year's figure within April 1, 2021 and February 21 this year. The ECoR has consistently witnessed incremental loading over the previous year's performance in the field of freight transportation since the inception of

According to sources, the ECoR loaded 205.37MT of freight by February 21 and surpassed the last financial year's annual loading of 204.90MT, registering an incremental growth of 0.23 per cent. It carried 15 per cent more freight than the corresponding period of the last fiscal.

During the period, ECoR carried 116.10MT of coal, 7.29 MT of raw materials for steel plants, 18.87 MT of iron & steel, 27.92 MT of iron ore, 1.17 MT of cement, 2.61 MT of food grains, 5.1 MT of fertilizer, 2.38 MT of POL and 23.94 MT of freight loaded in containers and other cargo. It earned revenue worth Rs 20,368.3 crore, registering an increase of 19.7 per cent than the corresponding period of last financial year.

For this achievement, the ECoR utilised 9,472 wagons per day, which is about 174.6 rakes per day, sources said. This could be possible due to the outstanding performance of all the three divisions of ECoR-Khurda Road, Waltair and Sambalpur.

FAKE DOCTOR, REAL CRIMES, SURREAL FAMILY

More victims show up while cops grill sister

Bhubaneswar, Feb 22: The Commissionerate Police Tuesday claimed to have come across credible evidences suggesting complicity of the notorious conman Ramesh Chandra Swain's family members in his acts of fraud. Swain had reportedly duped around 18 women of cash and ornaments worth over several lakhs after fraudulently marrying them by claiming to be a doctor.

The City police have been interrogating Swain's sister Rashmita Beura who was nabbed in a raid at Iswarpur village in Kendrapara district during the wee hours Tuesday. Meanwhile, the cops also launched a manhunt to arrest Beura's husband Ganesh who managed to give the cops a slip. Police sources claimed that Swain was aided and abetted by his sister. brother-in-law and his second wife in executing the fraudulent marriages. They used to enjoy a handsome share of the valuables and cash collected by Swain.



The City cops hope to extract vital leads from Beura to unravel further details about the modus operandi followed by Swain and family. The cops will conduct raids at other places related to the accused in the state in the coming days.

Similarly, the count of victims, who lost lakhs after falling into Swain's trap, is increasing with the registration of fresh cases every day. Sources claimed that as many as 15 cases of fraud have already been registered at different police stations of the state including the Capital city.

On Tuesday, two persons, including one businessman from

Rajahmundry of neighbouring Andhra Pradesh, lodged separate complaints at the Mahila Police Station and Khandagiri Police Station here. A medical professional who had earlier lodged a case against Swain Tuesday accused the fake doctor of pressurising him to prescribe fake medicines. Swain reportedly owes the Cuttack medico around ₹2 lakh.

Swain allegedly contacted the Andhra businessman G Venkataraman impersonating deputy director of the Union Ministry of Health and Family Welfare. He ordered the victim to supply saplings of worth ₹4 lakh for plantation in Kendrapara district. The cheque of a nationalised bank given to him by Swain was later

found to be fake one. Similarly, Swain duped one Abhay Das of Jagatsinghpur of ₹18 lakh on the pretext of arranging an MBBS seat in Bhuabneswar AIIMS for his son. Das Tuesday lodged a complaint against Swain at Khandagiri police station.

10 deaths, 428 new Cov cases

Bhubaneswar, Feb 22: Odisha's Covid-19 tally rose to 12,83,297 as 428 more people tested positive for the infection Tuesday, while 10 new fatalities pushed the death toll to 9,036, the state Health department said in a bulletin.

The daily test positivity rate (TPR) stood at 0.81 per cent and as many as 136 children were among the newly-infected, it said, adding that 52,672 samples were tested in the last 24 hours.

As per the Health bulletin, six out of the 10 new fatalities were reported from Sundargarh district. Currently, there are 4,955 active Covid-19 cases and 1,095 patients recovered in the past 24 hours, taking the total number of recoveries to 12,69,253, it added.

Of the fresh cases, Sundargarh district registered the highest 96 infections, followed by Khurda (46) and Kendrapara (35). Other districts with new infections are - Angul (15), Balasore (5), Bargarh (5), Balangir (1), Boudh (1), Cuttack (27), Deogarh (16), Dhenkanal (3), Gajapati (28), Ganjam (4), Jagatsinghpur (4), Jajpur (16), Jharsuguda (15), Kalahandi (3), Kandhamal (8), Keonjhar (9), Koraput (19), Malkangiri (3), Mayurbhanj (11), Nabarangpur (4). Booth rigging in Chikiti; locals demand re-polling

SEC TO TAKE A CALL ON RE-ELECTION, SAYS GANJAM COLLECTOR

Chikiti, Feb 22: Hundreds of people from various villages of Pitatali panchayat under Chikiti block in Ganjam district staged protests in front of the block office Tuesday, alleging booth rigging at Chairibada village during the second phase of rural polls.

The agitating villagers blocked the road near the block office and demanded re-polling in booth-13 where election was held February 18.

They alleged that some people had beaten up two voters and driven them out of the booth when polling was underway. The booth was rigged while votes of people who are staying abroad were cast by others.



Some locals including sarpanch candidates like P Danabati, K Narsinghamurty, agent Yudhisthir Sethi and S Rajalaxmi had filed a written complaint with block development officer (BDO) Falguni Majhi February 20 about booth rigging. They had demanded action against the people involved in the incident and warned of agitation over the issue if no step was taken

They had also written to Ganjam Collector, Berhampur sub-collector and the State Election Commission, seeking a re-poll at the booth.

"Since no step was taken over the booth rigging, we had no option than to resort to protests," the local fumed. Over 400 people from Pitatali, Madhabandh, Jagannathpur and Chairibada village took part in the agitation.

The BDO tried to quell the agitators, but the latter refused to relent. Collector Vijay Amruta Kulange visited the spot and said that the decision on re-polling is vested with the SEC. "We have intimated the SEC about the issue. If the SEC orders for re-polling, then their demand will be met," the Collector said.

Clamour for 1,000-yr-old Raibania fort facelift



Balasore. Feb 22: Hundreds of locals have demanded development and beautification of the historic Raibania fort in Balasore district. Despite being a place of much interest for historians, researchers. scholars and tourists as well, the millennium-old fort has not been given due importance, they alleged

"The 1,000-year-old Raibania fort located under Jaleswar tehsil will be renovated soon. Odisha government has sanctioned funds for repair of the South Gate of the ancient structure to give it a new look," state Culture and Tourism Minister Jyoti Prakash Panigrahi had said during his visit to the site in July 2019.

However, little progress has been made in this regard since Panigrahi's visit. A lot more needs to be done to develop the tourist destination, the locals rued.

Raibania fort dates back to King Virat of Matsya Kingdom who reigned during Mahabharat Era.

Raibania fort had played a significant role in thwarting invaders during the reign of Odia kings and helped in establishing their dominance in West Bengal. It has structural remains such as the Jayachandi shrine, Jagannath Temple, observation towers and over 50 ponds.

The fort was providing security from invasion of Mughols, Afghans and Marathas. It was then being regarded as the largest fort of eastern India. The fort had previously three gates – the eastern one was called Singhadwar, the western Hatidwar and the southern Sunamukhidwar. The remains of only two gates can be seen now, the source added. Goddess Kichakeswari was previously worshipped in a temple inside the fort.

As a legend goes, there was a huge meadow spreading from Raibania to Kaptipada in Mayurbhanj district. A ruler of Mayurbhani belonging to Bhanja Dynasty had relocated the deity from here to Khiching in the district and subsequently established the goddess there. Raibania fort is situated about 65 km from Balasore district headquarters and

14 km from Jaleswar tehsil. Notably, Raibania fort was a cen-

Bicycle Kick

t is unfortunate that Prime Minister Narendra Modi equated the Samajwadi Party's poll symbol - the bicycle - with those used to plant bombs by terrorists in Ahmedabad. The reference to Ahmedabad holds special significance at this moment because a trial Court has sentenced as many as 38 Moslems to death for the bomb blasts in that city in 2008. It appears he was enthused by the fact that the judicial verdict may create the impression that his partyruled state can bring to book terrorists with firmness.

This analogy shows the level to which the BJP has stooped during the ongoing crucial election to the UP Assembly. It has lowered the dignity of the chair of the Prime Minister. Earlier, PM Modi had remarked on a poll battle between "shamshan (crematorium) and kabarstan (grave)." It must have been difficult for many to understand the reference to death concerning two religious groups. Apart from morbidity, it could also be said that the Chief Executive of the country has to be very careful about the language he uses in public, which could easily be misconstrued. Although, there is no ambiguity about what the PM wanted to communicate. But, this time, by mocking the poll symbol of Samajwadi Party, the primary opposition to the BJP in UP, and connecting it to a terror attack, thereby insinuating that SP is a party of terrorists, the PM may have crossed the critical line which should have attracted action by the Election Commission.

Addressing a public meeting in Hardoi, where polling is scheduled February 23 in the fourth phase, Modi also targeted the previous SP government for deciding to withdraw cases against some of those accused of terror attacks in the state. Referring to the Ahmedabad blasts, when he was Chief Minister

of Gujarat. Modi said that he had taken a pledge "with that blood soaked soil" that his government would find the terrorists "even in hell and punish them." The objectionable part of his speech was his assertion that the Ahmedabad terrorists had used bicycles to plant bombs before the blast and he was surprised why the SP preferred bicycle as its electoral symbol. It is interesting to observe the Prime Minister raise such a question. On 26 July 2008, Ahmedabad witnessed



22 blasts which killed 56 people and injured 246 more. The blasts were carried out with the help of explosives planted in buses, cars and even bicycles. Drawing such far-fetched connection just to deride a political opponent seems immature. Every Indian is aware that the bicycle is the only and preferred mode of transport for the poor of this country. The bicycle has no gender or religion. Today, the bicycle is globally considered the most non-polluting method of transport that offers the user an additional benefit of exercise for good health. While insinuating that the cycle is connected to terrorism, the PM is not insulting a political party but pointing fingers at the millions of bicycle users who pedal daily to work, school and back home. It is noteworthy that BJP state governments since way back in 2011 have distributed bicycles to students.

SP president Akhilesh Yadav responded in a dignified manner to Modi's remarks and retorted that the BJP did not seem to know that the bicycle is used by the poor, labourers and youth of the country. He said that the people are angry with the BJP and want to "give it a 440-volt shock" which is why the party's top leaders are making "cheap statements." AAP leader and Delhi Chief Minister Arvind Kejriwal also told a Lucknow rally that the PM's remarks were an "attack on the poor who ride bicycles."

The Election Commission was an institution on which Indians prided themselves. It was the symbol of a strong democracy in this country. Other countries took advice from the ECI to conduct elections. This image has been consistently getting tarnished, more so the way the ECI conducted itself during Bihar and West Bengal elections. The last nail on the coffin seemed to be hammered in when all the Election Commissioners dutifully attended a meeting summoned by the Prime Minister's office shortly before the Uttar Pradesh and other state elections were declared. The Prime Minister's speech about the bicycle bombs was a golden opportunity for the EC to redeem itself and act. Had it banned the Prime Minister from campaigning for even a day, it would have proven that institutions are larger than any individual. Unfortunately, India has not been lucky to have people with spine in most positions of power.



he idea here is the paradox of choice. The classic story is the one about the donkey which was placed exactly halfway between two bales of hay. Unable to decide which one of the two bales was the more enticing, the poor animal starved to death. The modern equivalent is supermarket shelves laden with two dozen varieties of tomato sauce or twenty sorts of bread or shops with dozens of styles of trainers or jeans. The burden of having to decide among myriad options has been shown to leave people dissatisfied, stressed and miserable about the choice they finally make perhaps one of the others was better? A satisficer, on the other hand, is content with the idea that good is good enough. If the pair of jeans fits and wears well or the tomato sauce tastes pretty good then that's fine. Another choice might have been better but almost certainly not so much better that the hassle of testing all the possibilities was worth the time and trouble. Though the word is often applied to the consumerist lifestyle in developed countries, the American economist and Nobel laureate Herbert Simon coined it more than half a century ago in more general terms. His original creation was satisfice, a conflation of satisfy and suffice, which appeared first in an article in 1956. He extended his ideas the following year in his books Administrative Behavior and Models of Man. His discussion was directed at all forms of decision making, in which he argued that people showed what he called bounded rationality. Contrary to the conventional view of economists, people don't seek to maximise the benefit they get from some course of action because in most cases they don't have all the facts or too much information would overwhelm them. The best situation may not be, as might be thought, to have no choice at all (which brings problems of its own), but to have a relatively limited range of choices that makes it feasible to select the most appropriate.

FOCUS AMENDMENTS TO BIOLOGICAL DIVERSITY ACT

A BLOW TO BIO-DIVERSITY

WHILE THE INTERNATIONAL **POSTURING OF THE GOVERNMENT HAS BEEN** PRO-CLIMATE, **INDIAN ENVIRONMENTAL GOVERNANCE IS BEING DILUTED** IN THE NAME OF **EASE OF DOING BUSINESS**

hen foreign firms tried to patent the Indian Basmati rice, turmeric, neem or Darjeeling tea and their usage known traditionally for ages, rightly there was widespread resentment, and the government did its best to oppose such patents from being granted. One should be just as agitated if healing traditions indigenous to Odisha are appropriated and commercialised by big AYUSH companies, without any benefit accruing to the region - some of them only Indian by name, if at all. The recently proposed amendments to the Biological Diversity Act, 2002, offer just that and worse.

When passed, the Bio-diversity Act (2002) was viewed with scepticism by various sections of the society, for it provided access to traditional knowledge guarded zealously by local communities. The UN's 1992 Convention for Biological Diversity, which forms the basis for this Act, has three objectives conservation of biodiversity sustainable use of its components, and fair and equitable sharing of benefits arising from the use of genetic resources are complementary and mutually beneficial reinforcing. The second objective of 'use' (access) of these resources by outsiders raised eyebrows because it triggered memories of misappropriation of knowledge by colonial or feudal overlords now well documented. But this was sought to be mitigated by the first and third provisions, i.e., conservation of biodiversity and sharing benefits accrued from such access. There was some hope that the Act would also benefit local communities by improving expenditure in preserving biodiversity and ensuring sustainable development.

The Act also sought to regulate the commercialisation of these traditional resources. It provided for a three-tier set of institutions to perform this crucial gatekeeping function at the national, state and local levels. It also provided a mechanism for disbursement of gains from using these resources to the local community. Thus, by and large, it guarded against the use and patenting of Indian knowledge systems by big pharma companies. Companies with foreign equity were barred from research or commercially utilising tradi-

tional resources without special permission.

The recently proposed changes are unabashed in facilitating 'access' to resources to AYUSH companies by making the aforementioned gatekeeping mechanism inapplicable to them. The Act's preamble invokes the idea of 'benefit sharing' and the development of local communities. Still, it gives broad exemptions to these companies from this mandatory benefit sharing

First, the definition of a 'foreign company' has been changed to only include companies incorporated outside India. Thus, companies with significant foreign investment can avoid the previous regulatory requirement of seeking permission from the National Biodiversity Authority for their research. Notably, 100 per cent Foreign Direct Investment is now permissible in the AYUSH sector – meaning that certain AYUSH companies are 'Indian' in name only.

Secondly, all 'Indians' have been exempted from seeking permission to research 'codified traditional knowledge.' This means that Indian companies can research local resources for monetary gain, even without sharing benefits with local communities. Thus the fundamental basis of the biodiversity convention - of having a mutually reinforcing relationship between the local community and the entity accessing the resources - falls apart.

Third, earlier, only local grow-

ers, cultivators, vaids and hakims who practice the indigenous medicine were exempt from taking permission for commercial utilisation under this Act, as the resources belonged to them collectively. This very clearly excluded AYUSH companies.

In 2020, the Uttarakhand High Court had clarified that Divya Pharmacy-Patanjali Yog Peeth (Baba Ramdev's pharmacy) would also have to seek permission from the State Biodiversity Authority for its research. It must share the profits from commercial utilisation of the research with local communities – echoing that it is not exempt from the Act.

These amendments attempt to clearly and directly circumvent this decision by adding 'AYUSH practitioners' to the set of people who are exempt from the rigours of the Act. Hence any AYUSH firm shall now have free access to research and commercially utilise resources of remote communities, again without any benefit sharing. This is a classic case of facilitating the misappropriation and centralised accumulation of resources, in the hands of the now powerful AYUSH firms, away from communities - tantamounting to biopiracy.

Earlier, the National Biodiversity Authority was supposed to be a semi-independent body of scientists and conservationists who understood the impact of their actions. Even though it was under the direction of the Central government, there was no scope for dayto-day meddling in its affairs. These amendments create a parallel post to the Chairperson, called the 'Member-Secretary' and makes her the convener and coordinator of the NBA. Curiously, this post has almost identical powers and functions to the Chairperson. This raises questions about the intention behind this amendment - particularly the design to end the independence of the NBA.

As per these amendments, the centralisation is also set to happen in the three-tier model. According to the Act, the local body and the locals are key stakeholders in de termining the nature and amount of benefit sharing. However, the recent amendments undermine the importance given to the local body (Biodiversity Management Committee) by providing that it shall be 'represented by the National Biodiversity Board' in these negotiations. The actual holders of the traditional knowledge are no longer a party to the determination of benefits due to them. Thus, it ignores the critical features of environmental legislation - consultation with local communities to assess their impact.

Recent reports suggest that India supports a legally-binding UN treaty to preserve biodiversity in oceans and eliminate single-use plastic. While the international posturing of the government has been pro-climate, Indian environmental governance is being diluted in the name of ease of doing business. From the proposed dilution of the Environmental and Social Impact Assessment policy to everyday executive orders, which hollow out the Forest Rights Act, 2006, the government compromises the environment to secure industry interests. The focus in the budget speech on single-window environmental clearance is a cause for concern when looked at from this perspective. Scholars suggest that environmental regulation should be 'slow' to hear the concerns of affected communities and ecosystems adequately Prioritising speed results in shoddy decisions that threaten communities and the planet.

CONSUMING JUST ONE PLASTIC BAG CAN INCREASE YOUR RISK OF EARLY DEATH TO THE SAME DEGREE **AS BADMOUTHING VLADIMIR PUTIN** ON THE STREETS **OF MOSCOW**

fildlife journalist Ranjeet Jadhav recently shared a video taken near a village inside Sanjay Gandhi National Park in Maharashtra. The video showed a young leopard moving around cautiously with its head stuck inside a large plastic jar.

"Irresponsible behaviour of tourist and people venturing into forest to party is posing a grave threat to the wild animals," Jadhav

The "irresponsible behaviour" was tossing a plastic jar in a place where an animal could easily find it. The jar probably had a little water in it, but it doesn't take much to arouse an animal's curiosity. If you don't believe me, just search online for the video of the two bears that came across some boys playing football in Nabarangpur district, Odisha. The bears started playing with the ball and then ran off with it into the forest, where last I heard, they have formed their own football league.

Trust me, if you conducted a study by leaving large plastic jars in the forest and allowing 10 random animals to come across them, nine out of 10 would get their heads stuck in the jars. And the 10th animal would take a video and share it on Twitter.

The video of the leopard quickly reached forest officials and animal welfare groups, who mounted a search involving about 30 people. Two days later, they tracked down the leopard, tranquilised it and removed the plastic jar. The leopard was dehydrated and needed treatment before being returned to the wild

One reporter did manage to get a short interview with the leopard. Reporter: "What was it like, being trapped in a jar?'

Leopard: "It was very jarring." A growing number of animals, unfortunately, are being affected by plastic waste, not just in India but throughout the world. They're not just getting trapped or entangled in plastic, they're also ingesting plastic—sometimes in great quantities. This is terrible for at least three reasons: (1) plastic tastes awful; (2) plastic has no nutritional value; and (3) consuming just one plastic bag can increase your risk of early death to the same degree as badmouthing Vladimir Putin on the streets of Moscow. As they say in Russia, "No bagging on Putin or Putin bagging in your stomach."

Three years ago, a marine biologist found about 40 kg of plastic, including 16 rice sacks and numerous plastic bags, inside the stomach of a whale that had washed up in the Philippines. Whoever dumped all those rice sacks and plastic bags in the ocean is extremely lucky that whales cannot afford to hire lawyers.

But humans need to be held accountable for all the plastic that's polluting oceans. About 80 per cent of it is being dumped by Asian countries, with India among the top culprits, but the United States and other western countries are more culpable than they appear. The US generates more plastic trash than any other country, but conveniently ships a large quantity of it for "recycling" to Asian coun-

way, via rivers, into the oceans. I'm not sure who is supposed to do the actual "recycling," but the animals in the ocean have not undergone adequate training to do so. This is just an assumption on my part, of course. I have not verified their credentials or observed what they're learning in all those schools of fish.

Dolphins and whales are among the smartest mammals in the ocean, and we might be able to train some of them to recycle, perhaps by putting large recycling containers in the ocean. But there are too many creatures in the ocean and many of them just won't bother to recycle.

Dolphin: "Don't let that plastic bag float around. Bring it to the recycling container. Shark: "Are you talking to me?"

Dolphin: "No, I'm just talking Shark: "You need to see my ther-

apist.' Dolphin: "I can't afford to."

Shark: "Of course you can. He accepts plastic."

Tall task at hand

Sir, This refers to "Time for change: Maha, T'gana CMs", Orissa POST, Feb 21. Telangana CM K Chandrashekhar Rao (KCR) flew down to Mumbai Sunday and held talks with Maharashtra CM Uddhav Thackeray and NCP leader Sharad Pawar to forge an anti-BJP front. KCR has also held telephonic talks with several other prominent regional leaders. The motivation is understandable. With the Congress in doldrums, the national opposition space appears wide open. The regional parties have learnt that the more localised the election becomes, the more vulnerable the national party is to regional vagaries. The BJP's expansion into new frontiers has also alarmed regional leaders that they need to be proactive to protect their turfs. KCR's forays come as the BJP emerges as the principal Opposition party in Telangana - overshadowing the Congress. But the challenges for any such front are formidable. With general elections becoming more presidential, it will be tough for regional parties to do well against the BJP's strategy of making the Lok Sabha polls a referendum on PM Modi, the most popular national leader. No regional formation has gained power in Delhi without the backing of a national party, and voters are becoming adept at making distinct national and state choices. In December 2018, Congress trounced BJP in Assembly elections in Rajasthan, Madhya Pradesh and Chhattisgarh, but the BJP swept in Parliament elections held just a couple of months later. Also, there are perennial problems among regional leaders such as egotism, personality clashes, and contradictory regional priorities, which means that most attempts remain stillborn. Mumbai, Feb 22: The parents of Disha Salian -- who ended her life June 8, 2020 -- made an emotional public plea Tuesday to be "left alone" by the politicians failing which they hinted at taking the extreme step themselves and 'only the political leaders would be responsible' for it.

"Please spare us... We are trying to emerge from the tragedy of our daughter. Don't keep raking it up repeatedly and politicising it... If this doesn't stop, we may be forced to do something drastic. Only the politicians will be responsible for this," Satish Salian and his wife Vasanti said.

Without taking any names, they flayed "certain politicians" (the Opposition Bharatiya Janata Party) attempting to exploit her suicide June 8, 2020, a week before the death of Bollywood actor Sushant Singh Rajput.

Their tearful plea came hours after the BJP State President Chandrakant Patil and MLA Nitesh N. Rane threatened to make a fresh 'mega-expose' claiming it would solve the alleged mystery behind Disha's death.

"The whole matter has been examined by the Mumbai Police, they know everything, we have no problems (with the probe). She had some problems in a business deal and was very disturbed," said her parents. "We are attempting to put it behind and move ahead in life... But the politicians constantly keep raising her death matter... We are tired of this... Please stop all this and leave us alone," they begged.



Salian, 28, allegedly committed suicide by jumping from a high-rise building June 8, 2020, six days before late actor Sushant Rajput, 34, was found hanging at his apartment

They made it clear that Disha was not the manager of the late actor whom she met only once for some costume trials, yet the politicians are trying to "reopen the case".

"She was a sensitive girl and could not handle the setback in her business matters. Yet the media and some politicians have been conveying misleading information which is defaming the Salian family. Let us leave in peace," the aged couple urged. Their strong reactions came when Mumbai Mayor Kishori Pednekar along with a couple of members of the Maharashtra State Commission for Women (MSCW) met them at their home Tuesday.

SRINAGAR ACID ATTACK CASE **POLICE WANT JUVENILE ACCUSED TO**

BE TREATED AS ADULT

Srinagar, Feb 22: Completing its investigation in three weeks, Jammu and Kashmir police Tuesday filed two separate charge sheets against three accused, including a juvenile, in the acid attack on a woman in downtown city, officials said.

Two of the accused, identified as Sajid Altaf Rather and Mohammad Saleem Kumar alias Tota, were produced before Chief Judicial Magistrate here as the police submitted a 1,000-page charge sheet against them. The court committed it to the Principal Sessions Court and the hearing will begin from March 8.

A similar charge sheet was filed against the minor before the Juvenile Justice Board with an additional application that he be treated as an adult under the amended Juvenile Justice (Care and Protection of Children) Act. whereby youngsters in the age group of 16-18 can be tried under Indian Penal Code (IPC) if they are accused of heinous crimes.



The officials said the two accused and the juvenile were charged under sections 120-B (criminal conspiracy) and 326-A (voluntarily causing grievous hurt by use of acid) of the IPC.

"We have filed a water-tight charge sheet and we will make a plea to the court for a daily hearing of this case. If a daily hearing is not possible, we would request the honourable court for a speedy trial," Senior Superintendent of Police (Srinagar) Rakesh Balwal said. He said they have applied to the Juvenile Board to treat the minor as an adult according to Section 15 of the amended Juvenile act.

The charge sheets were filed within three weeks of the incident to ensure swift and exemplary punishment to the accused and to deter those who may be having such "barbaric" tendencies, officials said.

"The maximum punishment under these sections is life and the minimum is 10 years but we will press for maximum so that it acts as a deterrent," Balwal said. He said a dedicated inspector rank officer has been appointed for liasoning with the prosecution team to secure a fast conviction in this case

the case where some Muslim girls are demanding that they be allowed to be wear hijab in classrooms. UP Assembly seat dominated by one family since 1993

THE SEAT IN THE HIGH-PROFILE CONGRESS BASTION WAS LAST OUTSIDE THE FAMILY IN 1991--WHEN THE JANATA DAL AND THE JANATA PARTY WERE TOP CONTENDERS AND INDIA YET TO OPEN EYES TO A MORE LIBERAL ECONOMY

Rae Bareli (UP), Feb 22: Whether it was represented by the Congress, Peace Party, BJP or an Independent, the Rae Bareli Sadar seat has remained within one family for almost three decades now. The segment is part of the parliamentary seat held by Congress president Sonia Gandhi.

It's the family of the five-term MLA, the late Akhilesh Singh, and his daughter Aditi Singh, both of whom have had their trysts with the Congress and the Gandhi family.

The seat in the high-profile Congress bastion was last outside the family in 1991--when the Janata Dal and the Janata Party were top contenders and India yet to open eyes to a more liberal economy.

Last week, just days ahead of the February 23 Assembly polls here, Aditi Singh (34) made an emotional appeal to voters, launching on social media a short documentary of his father. She seeks another term to fulfil his dreams for Rae Bareli. She was elected as a Congress candidate in 2017 but switched over to the BJP in 2021, after a bout of attacks on the

grand old party, which boasted of familial ties with Rae Bareli since the Indira Gandhi days

This time, Aditi Singh's appeal in poll campaigns focused on the "rich legacy" of her father, who passed away in August 2019 due to cancer. The Samajwadi Party, which has fielded RP Yadav, a grassroot-level party worker, dubbed Akhilesh Singh's regime as a "legacy tainted and mired in crime" and claimed it would take the seat out of the family clutches in this election.

The Congress too has launched an all-out campaign against Aditi

Singh, calling her a betrayer. It has fielded Manish Chauhan, an eminent doctor with political lineage in the city. "In 1993, there were discussions about Akhilesh Singh contesting the elections from Rae Bareli (Sadar). No one had any idea that Akhilesh Singh, who was fighting his first poll, would become the cornerstone of Rae Bareli's politics in times to come," says the documentary on Akhilesh Singh.

"His relation with people was such that no equation could cut him off from people. Whichever party had a wave in UP, Rae Bareli would choose Akhilesh Singh only," the documentary added. Considered a strongman, Akhilesh Singh had declared being accused in eight criminal cases including one case each of murder and extortion. while five of intimidation, according to his 2012 election affidavit. His electoral campaign began in 1993, when he contested as the Congress candidate and won. He continued his winning streak in 1996 and 2002 also but after that relations between him and the Congress soured.

Akhilesh Singh was expelled from the Congress but he fought the 2007 election as an independent candidate, winning by 76,603 votes.

Mamata writes to Modi on Ganga erosion

BANERJEE URGED THE PM TO HAVE THE MATTER **LOOKED INTO SERIOUSLY SO THAT FLOOD** MANAGEMENT AND RESTORATION SCHEMES CAN BE CARRIED OUT IN THE RIGHT EARNEST TO SAVE LIVES AND LIVELIHOODS FROM DISASTER

Kolkata, Feb 22: West Bengal Chief Minister Mamata Banerjee has written to Prime Minister Narendra Modi expressing concern over the continuous erosion along the Ganga in Malda, Murshidabad and Nadia districts and urged him to look into the issue so that flood management and restoration schemes can be carried out in earnest to save lives and livelihoods from disaster.

Baneriee also sought reconsideration of the Centre's decision in 2017 to withdraw the extended jurisdiction of Farakka Barrage Project Authority (FBPA) for protection of the river bank from further erosion.

The erosion has caused loss of thousands of square kilometres of land, she said in her letter dated February 21 which was made avail able to the media Tuesday.

The chief minister said that perpetual flood and erosion along trans-boundary rivers like Mahananda, Fulhar, Tangon, Atrayee and Purnabhava are also a major cause for erosion in 21 blocks of Uttar Dinajpur, Dakshin Dinajpur and Malda

She said that erosion along the Ganga for the past two decades after the construction of Farakka barrage has led to loss of public utilities, private properties and agricultural land.

There has been adverse impact on Ganga-Padma erosion in context of the Indo-Bangladesh Ganga Treaty of 1996, both downstream and upstream of Farakka, in the districts of Malda, Murshidabad and Nadia, she wrote.

Almost 2,800 hectares of fertile land have been engulfed by the river and there have been damage to public and private properties to the tune of Rs 1,000 crore during the last 15 years, her letter said.

Banerjee urged the PM to have the matter looked into seriously so that flood management and restoration schemes can be carried out in the right earnest to save lives and livelihood from disaster.

A bilateral treaty was signed between India and Bangladesh in December, 1996, establishing a 30year water-sharing arrangement.

Baneriee said that the erstwhile ministry of water resources had in 2005 extended the jurisdiction

The water resources ministry had in July 2017 unilaterally withdrawn its 2005 decision and restored the original jurisdiction of FBPA from 11.5 km upstream to 5.9 km downstream of Farakka barrage, she said and urged the prime minister to reconsider it so as to fulfil the earlier commitment of the central government and arrange for taking up urgent bank protection schemes in the entire stretch of the extended jurisdiction by FBPA in consultation with the state government.

Stating that her August, 2017 letter to the prime minister seeking restoration of the extended jurisdiction did not elicit any response. Baneriee said that the state

Maintaining that this expenditure will not suffice since as per the latest assessment 37 locations along the river in a stretch of 28.80 km are vulnerable and require immediate attention, she said, "The concomitant expenditure for river bank protection would be to the tune of Rs 571 crore."

Stating that it is becoming increasingly difficult for the state government to arrange for funds required for new bank protection work, the chief minister said that the matter was raised during a visit by Bengal's ministers to the union Jal Shakti minister August 31, 2021, but no response has yet

Tiger population explosion raises serious concern

Serious imbalance in tigers' gender ratio has resulted in the spurt of the big cat population, forcing many of them to either leave the park or die in fighting over territories and females

Jaipur, Feb 22: At a time when the nation discusses the challenge of overpopulation and its ill effects. a new fact has emerged that tigers in the Ranthambore National Park are facing the blues of overpopulation, leading to issues like territorial fights, the big cats leaving the forests, going missing and preying upon the rural folk.

In fact, ever since after the establishment of the Reserve in 1973, the number of tigers is maximum in present times.

The number of tigers and their cubs in the adjoining areas of Ranthambore has gone up from 66 in 2019 to 81 in 2021

Presently, the ratio of male to female tiger is 11.3 which is abnormal, said the Forest Department of Rajasthan in response to a question raised by Amer MLA Satish Poonia on the missing number of tigers.

On Poonia's question whether an inquiry has been conducted into the number of tigers born and missing from areas like the Ranthambore National Park. Sariska Tiger Reserve, Mukundra Hills National Park, among others, from January 2019 to January 2022, the Department said, "At present most of the 32 female tigress are in reproductive age, due to which there has been an increase in the birth of cubs. A total of 44 cubs have been born between the year 2019 to 2021. Due to the high number of tigers in the battered areas of Ranthambore Tiger Reserve, there is a high number of cases of missing tigers, territorial fights and deaths.

The record submitted in the state Assembly on missing tigers revealed that a total of 13 tigers have disappeared from the Ranthambore

National Park between 2019 and 2021. Two male tigers T-20 and T-23 went missing from the park in 2019 and seven big cats - five males named T-47, T-42 T-64, T-95, T-97 and two females T-73 and T-92 disappeared in 2020.

Similarly, two male tigers T-72 and T-62 and two females T-126 and T-100 went missing in 2021. The forest officials said that the

serious imbalance in tigers' gender ratio has resulted in the spurt of the big cat population, forcing many of them to either leave the park or die in fighting over territories and females.

PS Somashekar, a retired forest officer from Rajasthan told IANS, "As the tiger is a carnivore, it needs regular movement from one area to another, however, we have created obstructions in its movement area The government land has been converted into agricultural land, agricultural land into commercial land and so on. Hence, when the animal moves into corridor areas, it gets confused on seeing four-lane highways, dazzling lights and sounds,

leading to conflict.' Another environmentalist Harshwardhan says, "The tiger faces a challenge; its forest territories are shrinking. Almost 10-15 tigers and tigresses are roaming outside almost all the best breeding reserves in India as dominant males do not let newly-born, young and sub-adult males to remain inside the park. Additional population of tigers inside reserves therefore is getting rehabilitated outside the reserves. Further, tiger corridors are missing. The outcome many wild tigers and tigresses are poached by rural folk, or get knocked down

in road accidents and mishaps." May be, it's time to start another Project Tiger.

Administering 'Charak' oath a mistake: Principal

Kolkata, Feb 22: Amid a raging controversy over first-year students of Calcutta Medical College Hospital, Kolkata being administered the new 'Charak' oath, Dr Raghunath Mishra, principal of the prestigious college Tuesday said it was a mistake arising from a misunderstood communication.

The clarification came a day after first-year students of the 187 year-old medical college were asked to take the 'Charak Shapath' (oath named after the author of an ancient Indian medical text), proposed by the National Medical Council, instead of the traditional Hippocratic Oath.

"A few days back, there was a video conference with officials of NMC. During that conference there was a reference to Charak Shapath. Our staff and officials misunderstood it as an official guideline (to be compulsorily followed) and administered it on first-year students," Mishra told PTI.

"It was a mistake on our part ... We misunderstood the reference to be an official guideline," he said.

The NMC, the regulator for medical education that replaced the Medical Council of India two years back, had some weeks ago suggested that medical colleges should replace the traditional Hippocratic Oath by the Charak Oath drawn from an ancient text `Charak Samhita' (Charak's text).

The Principal said interns are normally administered the Hippocratic Oath, a centuries-old code of ethics for medical practitioners worldwide, which asks doctors to pledge beneficial treatment, to refrain from causing harm and to maintain secrecy of a patient's confidences.

"There has never been any instance where we have administered Charak oath. We only follow the centuries-old system of administering Hippocratic Oath," the principal said.






6 killed, 14 injured in firecracker factory blast

Shimla, Feb 22: Six migrant workers were killed and 14 others sustained burn injuries in an explosion at an illegal firecracker factory in Himachal Pradesh's Una district Tuesday, officials said.

The injured included nine women, they said, adding that 11 who were in serious condition were shifted to the Postgraduate Institute of Medical Education and Research (PGIMER), Chandigarh.

Chief Minister Jai Ram Thakur directed the Divisional Commissioner to inquire into the incident and submit a report within a week. The state government announced Rs four lakh assistance to the next of kin of each of the deceased, the officials said. Prime Minister Narendra



Modi condoled the loss of lives and said Rs two lakh each from Prime Minister's National Relief Fund (PMNRF) would be given to the families of those killed in the incident. A sum of Rs. 50,000 would be given to each of the injured.




39 apartments destroyed

United Nations, Feb 22: Voicing "deep concern" over the escalation of tension along the Russia-Ukraine border after Russian President Vladimir Putin ordered his troops into eastern Ukraine, India has told the UN Security Council that the immediate priority is de-escalation of tensions and said it was convinced that this issue can only be resolved through diplomatic dialogue.

President Putin Monday signed decrees to recognise Ukraine's regions of "Donetsk and Luhansk People's Republics" as "independent", escalating the tension in the region and increasing fears of Moscow's invasion of Ukraine. He also ordered Russian troops into eastern Ukraine in what the Kremlin called a "peacekeeping" mission in the Moscow-backed regions.

Addressing an emergency meet-

ing of the UN Security Council on Ukraine Monday night, India's Permanent Representative to the UN Ambassador T S Tirumurti said, "We have been closely following the evolving developments relating to Ukraine, including developments along the eastern border of Ukraine and the related announcement by the

Russian Federation." "The escalation of tension along the border of Ukraine with the Russian Federation is a matter of deep concern. These developments have the potential to undermine peace and security of the region," he said. India called for "restraint on all sides" and stressed that the immediate priority is "de-escalation of tensions" taking into account the legitimate security interests of all countries and aimed towards securing long term peace and stability in the region and beyond.

What will Russian recognition mean

WHAT ARE THE BREAKAWAY REGIONS

Russian-backed separatists in the Donetsk and Luhansk regions - collectively known as the Donbass - broke away from Ukrainian government control in 2014 and proclaimed themselves independent "people's republics", until now unrecognised. Since then, Ukraine says about 15,000 people have been killed in fighting. Russia denies being a party to the conflict but has backed the separatists in numerous ways, including through covert military support, financial aid, supplies of COVID-19 vaccines and the issue of at least 800,000 Russian passports to residents. Moscow has always denied planning to invade Ukraine

WHAT DOES IT MEAN or the first time, Russia is saying it does not regard the Donbass as part of Ukraine. That could pave the way for Moscow to send military forces into the separatist regions openly, using the argument that it is intervening as an ally to protect them against Ukraine. A Russian parliament member Donetsk

cal leader, Alexander Borodai, said last month that the separatists would then look to Russia to help them wrest control of parts of the Donetsk and Luhansk regions still under the control of Ukrainian forces. If that happened, it could lead to open military conflict between Russia and Ukraine.

WHAT ABOUT THE MINSK **PEACE PROCESS**

Russian recognition effectively kills off the 2014-15 Minsk peace agreements that, although still unimplemented, have until now been seen by all sides, including Moscow, as the best chance for a solution. The accords call for a large degree of autonomy for the two regions inside Ukraine.

HOW WILL THE WEST RESPOND Western governments have been lining up for months to warn

Moscow that any movement of military forces across the Ukrainian border would draw a strong response including stringent financial sanctions. U.S. Secretary of State Antony Blinken said last week that recognition "would further dermine Ukraine's

ty, constitute a gross violation of international law, (and) call into further question Russia's stated commitment to continue to engage in diplomacy to achieve a peaceful resolution of this crisis". He said it would necessitate a "swift and firm" response from the United States and its allies.

HAS RUSSIA RECOGNISED BREAKAWAY STATELETS BEFORE?

Ves - it recognised the independence I of Abkhazia and South Ossetia, two Georgian breakaway regions, after fighting a short war with Georgia in 2008. It has provided them with extensive budget support, extended Russian citizenship to their populations and stationed thousands of troops there.

n the Georgia case, Russia used recognition of the breakaway regions to justify an open-ended military presence in a neighbouring former Soviet republic in an attempt to indefinitely thwart Georgia's NATO aspirations by denying it full control of its own territory. The same considerations would apply to Ukraine. On the downside, Moscow faces sanctions and international condemnation for abandoning the Minsk process after long maintaining that it was committed to it. It will also be saddled indefinitely with responsibility for two territories ravaged by eight years of war and in need of massive economic

21 FISHERMEN **RELEASED**

Colombo, Feb 22: The 21 Indian fishermen who were arrested by the Sri Lankan Navy last month for allegedly poaching in the country's territorial waters were released on the instructions from a magistrate court, officials said Tuesday.

The Sri Lankan authorities will hand over the fishermen to the Indian Consulate after which they will be repatriated to India after completing all the necessary COVID-19 protocols.

On January 31, local Sri Lankan fishermen alerted the coastguard after two Indian boats were located off the coast of Point Pedro within the Sri Lankan side of the international waters. The Sri Lankan Navy confiscated their boats and remanded them in custody till February 21

According to the Sri Lankan Navy, these arrests are part of their patrols to cut illegal fishing in the country's waters to minimise the impact from poaching on the local fishermen and sustainability of fishery resources in Sri Lanka.

On Monday, the Point Pedro Magistrate Court ordered the release of the 21 Indian fishermen. 'They were given 3-year jail terms suspended for 10 years while their two boats were ordered to be confiscated," Fisheries official J. Sudakaran said. Last month, a Sri Lankan court ordered the release of 56 Indian fishermen who were detained for allegedly fishing in the island nation's territorial waters.

The MFA too has made vague assurances in the last two years whenever the Indian media here questioned the delay of the return of the students and the plight they suffered at home despite paying hefty fees.

Hong Kong, Feb 22: Hong Kong will test its entire population of 7.5 million people for COVID-19 in March, the city's leader said Tuesday, as it grapples with its worst outbreak driven by the omicron variant.

The population will be tested three times in March, Hong Kong Chief Executive Carrie Lam said. She said testing capacity will be boosted to 1 million a day or more. "Since we have a population of some 7 million people, testing will

Canada lawmakers extend powers

The emergencies act allows authorities to declare certain areas as no-go zones. It also allows police to freeze truckers' personal and corporate bank accounts and compel tow truck companies to haul away vehicles.

The trucker protest grew until it closed a handful of Canada-U.S. Border posts and shut down key parts of the capital for more than three weeks. But all border blockades have now ended and the

Beekeepers turn to anti-theft technology as hive thefts rise

IN THE PAST FEW WEEKS, 1,036 BEEHIVES **WORTH HUNDREDS OF THOUSANDS OF DOLLARS WERE REPORTED STOLEN FROM** ORCHARDS STATEWIDE. AUTHORITIES SAID

Woodland, Feb 21: For a few frenzied weeks, beekeepers from around the United States truck billions of honeybees to California to rent them to almond growers who need the insects to pollinate the state's most valuable crop.

But as almond trees start to bloom, blanketing entire valleys in white and pink flowers, so begin beehive thefts that have become so prevalent that beekeepers are now turning to GPS tracking devices, surveillance cameras and other anti-theft technology to protect their precious colonies.

Hive thefts have been reported elsewhere in the country, most recently three hives containing about 60,000 bees taken from a grocery chain's garden in central Pennsylvania. They happen at a larger scale and uniquely in California this time of year because bees are most in demand during the largest pollination event in the world.

In the past few weeks, 1,036 beehives worth hundreds of thousands of dollars were reported stolen from orchards statewide, authorities said. The largest heist involved 384 beehives that were taken from a field in Mendocino County, prompting the state beekeepers association to offer a \$10,000 reward for information leading to their recovery.

"It's hard to articulate how it feels to care for your hives all year only to have them stolen from you,' Claire Tauzer wrote on Facebook



to spread the word about the reward. A day later, an anonymous tipster led authorities to recover most of the boxes and a forklift stolen from Tauzer's family business some 55 miles (88 kilometers) away, at a rural property in Yolo County. One suspect was arrested.

Investigators also found frames, the kinds used to hold the honeycomb, belonging to Helio Medina, another beekeeper who lost 282 hives a year ago. Medina said the theft devastated his apiary, so this year he placed GPS trackers inside the boxes. He also strapped cable locks around them and installed cameras nearby. As the almond bloom approached and the hives became most valuable, he drove around patrolling the orchards in the dark.

"We have do what we can to protect ourselves. Nobody can help us." Medina said. Thefts usually happen at night, when no one is in the orchard and the bees are back in their hives. The rustler is usually a beekeeper or someone familiar with the transportation of bees.

"More often than not, they steal to make money and leave the bees to die," said Rowdy Jay Freeman, a Butte County sheriff's detective who has been keeping track of hive thefts since 2013.

A tightening supply of bees and soaring pollination fees — jumping from less than \$50 to rent a hive two decades ago to as much as \$230 per hive this year — are likely moti-


vating beekeepers to go rogue. The demand for bees has steadily risen over the last 20 years as popularity of the healthy, crunchy nut turned California into the world's biggest almond producer. Accordingly, the amount of land used to grow almonds has more than doubled to an estimated 1.3 million acres (526,000 hectares).

Beekeepers have been keeping up with that growth by providing an ever-increasing proportion of the nation's available stock of hives. This year, a survey of commercial beekeepers estimated it will take 90% of honeybee colonies in the U.S. To pollinate all the almond orchards.

'What that means is that beekeepers are coming from as far as New York and Florida, and to get them to come all that way, pollinator fees have to rise," said Brittney Goodrich, an agriculture economist at the University of California at Davis.

But bee populations are notoriously unstable due to a host of problems, including disease, loss of habitat and insecticides. The drought that gripped Western states last summer also weakened colonies. The lack of rain ravaged wildflowers that provide the nectar that bees turn into honey. Beekeepers had to artificially supplement their diet with sugar solutions and pollen substitutes—and incur more costs.

Azure refinances solar project



The refinancing has been completed at a rate of interest of 7.2 per cent per annum, which is fixed for 42 months and the lowest rate of interest for any project finance facility in terms of rupee financing for the company's existing portfolio so far.

Oil nears \$100: Fuel price hike coming after polls

New Delhi, Feb 22: International oil prices surged close to USD 100 a barrel Tuesday after Russian President Vladimir Putin sent troops into Ukraine, but petrol and diesel prices in India continue to be on freeze and are expected to rise once assembly elections in states like Uttar Pradesh end.

Amid fears of supplies being disrupted because of Russian aggression, the price of futures contract for Brent crude oil with April delivery on London's ICE rose by 4.18 per cent to USD 99.38 per barrel Tuesday morning, before paring some gains to settle just above USD 98. The last time Brent exceeded USD 99 per barrel was in September 2014. Russia makes up for a third of Europe's natural gas and about 10 per cent of global oil production. About a third of Russian gas supplies to Europe usually travel through pipelines crossing Ukraine.

But for India, Russian supplies account for a very small percentage. While India imported 43,400 barrels per day of oil from Russia in 2021, coal imports from Russia at 1.8 million tonnes in 2021 made up for 1.3 per cent of all coal imports. India buys 2.5 million tonnes of LNG a year from Gazprom of Russia. While supplies at the moment seem to be of little worry for India, it is the

officials said. Petrol costs ₹95.41 a litre in Delhi and diesel is priced at ₹86.67. This price is after accounting for the excise duty cut and a reduction in the VAT rate by the state government.

Prior to these tax reductions, petrol price had touched an all-

time high of ₹110.04 a litre and diesel came for ₹98.42. These rates corresponded to Brent soaring to a peak of USD 86.40 per barrel October 26, 2021. Brent was USD 82.74 November 5, 2021, before it started to fall and touched USD 68.87 a barrel in December.

Prices, however, started to rise thereafter and have risen by 12 per cent in February alone, they said.

Petrol and diesel prices have been in the past frozen before crucial elections. There was a 19-day price freeze on petrol and diesel ahead of Karnataka polls in May 2018, despite international fuel prices going up by nearly USD 5 per barrel. However, no sooner were the elections over, oil companies rapidly passed on to customers the desired increase over 16-straight days post-May 14, 2018. Petrol price climbed by ₹3.8 per litre and diesel by ₹3.38 per litre

Ukraine situation challenge to our financial stability: FM

Mumbai, Feb 22: Finance Minister Nirmala Sitharaman Tuesday said the Russia-Ukraine crisis and the ensuing jump in global crude prices are a challenge to financial stability in India.

The two issues were discussed at the meeting of Financial Stability Development Council (FSDC), which comprises all the financial sector regulators, Sitharaman told reporters here.

"It is difficult to say how it (crude prices) will go. Even today, in the FSDC when we were looking at the challenges which are posed for the financial stability, crude was one of the things. International worrisome situations where we actually voiced that we want a diplomatic solution for the situation that is developing in Ukraine... All these are headwinds," Sitharaman, nancial capital, said.

She said the Brent has touched over USD 96 per barrel Tuesday and added that the country is keeping a watch on the same. The finance minister said the oil marketing companies will take a call on the retail prices.

Trade has not been impacted because of the geopolitical tensions but the government is keeping a close watch on the same, Sitharaman said adding that we are careful that the exporters should not suffer.

Parrying questions on the exact timeline for the LIC IPO, she said there is a buzz and interest in the market after the life insurance behemoth filed its papers with Sebi for the over ₹60,000 crore issue, and the government will be going ahead with it.

She also said that the government is looking into the lapses that happened at the NSE.



Freebies to docs by pharma firms prohibited by law: SC

New Delhi, Feb 22: The Supreme Court Tuesday held that granting freebies to doctors by pharmaceutical companies to boost sales of medicines is 'clearly prohibited by law' and dismissed a plea of a firm seeking deduction under the Income Tax Act on account of giving incentives to medical practitioners.

The top court termed as a "matter of great public importance and concern" the manipulation of doctors' prescriptions in lieu of freebies offered to them by pharmaceutical companies, ranging from gifts such as gold coins, fridges, and LCD TVs to funding international trips for vacations or to attend medical conferences

A bench comprising justices UU Lalit and S Ravindra Bhat dismissed the appeal of M/s Apex Laboratories Pvt. Ltd against the order of the high court and in the verdict, it also dealt with a tricky legal issue where tax deduction on account of granting freebies to doctors was claimed saying though medical practitioners are restrained under the regulations from accepting such gifts, it was not an offence under any law and hence, companies are entitled to the tax benefit.

Analysing the law and regulations concerned, the verdict, penned



by Justice Bhat, said, "pharmaceutical companies' gifting freebies to doctors, etc. Is clearly 'prohibited by law', and not allowed to be claimed as a deduction under Section 37(1). Doing so would wholly undermine public policy. The wellestablished principle of interpretation of taxing statutes - that they need to be interpreted strictly cannot sustain when it results in an absurdity contrary to the intentions of Parliament.

Deprecating the practice of giving freebies, the bench said medical practitioners have a quasi-fiduciary relationship with their patients and their prescriptions are considered the final word on the medication to be availed by the patient, even if the cost of such medication is unaffordable or barely within the economic reach of the patient - such is the level of the trust reposed in doctors.

Shares tumble for 5th straight day on global market rout

Mumbai, Feb 22: Benchmark BSE Sensex plummeted by nearly 383 points in a volatile trade Tuesday due to losses in index heavyweights TCS, Reliance Industries and HDFC Bank amid a massive selloff in global markets triggered by deepening geopolitical tensions.

After sinking about 1,300 points in early deals, the 30-share barometer finally closed lower by 382.91 points or 0.66 per cent at 57,300.68

The broader NSE Nifty too reclaimed part of its early losses before closing 114.45 points or 0.67 per cent lower at 17.092.20. On the Sensex chart, Tata Steel

fell the most by 3.64 per cent, followed by TCS (3.59 per cent), and SBI (2.67 per cent). Dr Reddy's dropped 2 per cent, ITC by 1.44 per cent, Bharti Airtel by 1.39 per cent, and IndusInd Bank

by 1.39 per cent. Reliance Industries, HDFC Bank, Axis Bank, HCL Tech, Wipro, HUL, LT and UltraTech were among the losers.

Of the 30 Sensex constituents, 20 closed in the red

"Escalations in Ukraine tensions with Russia recognising two pro-Russian rebel regions have aggravated the crisis. The economic consequences are already visible



in higher crude and gold prices," VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services, said.

will come in this financial year, Sitharaman said, "DRHP is not issued two years in advance. Is it?" LIC IPO is entirely an Offer for

Sale (OFS) through which the Government of India would dilute 5 per cent of its stake by selling 31.63 crore shares. Employees and policyholders of

the insurance behemoth would get a discount over the floor price.

Mumbai, Feb 22: Forecasting a lower-than-previously projected 10 per cent GDP growth for the fiscal year 2022 due to the third wave_ of the pandemic, foreign brokerage Barclays said the Indian economy is likely to have expanded by 6.6 per cent in the December quarter.

The economy had a relatively stable Q3 with several sectors re turning to pre-pandemic level of activity, with services playing a bigger role in activity, the report said, adding that with the mild Omicron wave in January, there is clear downside risks to the earlier growth forecast of 10 per cent in FY22.

In the July-September quarter, the Indian economy had clocked a growth of 8.4 per cent.

The National Statistical Office (NSO) will declare the GDP estimates for Q3 FY 2021-22 February 28. As high base effects kick in, and activity consolidates, growth rate is likely to slow down from 8.4 per cent in Q2 to 6.6 per cent in Q3, it said, adding there scope for a steady farm sector growth, even though there are clear signs of weakness in rural consumption

Potential investors in LIC's IPO fret over govt control of insurer

HOW EFFECTIVELY LIC AND ITS **INVESTMENT BANKERS ARE ABLE** TO ADDRESS THE **INVESTOR CONCERNS WILL HELP IN DETERMINING THE INSURER'S VALUATION** IN THE FLOAT

Mumbai, Feb 22: Prospective investors in Life Insurance Corp of India's (LIC) \$8 billion IPO are seeking assurances from company management that it will not sacrifice their interests to meet the goals set out by the government, its controlling shareholder, sources said.

In virtual roadshows for India's biggest ever public listing, LIC management and the IPO bankers have been peppered with questions about the insurer's past investments and their quality, four people with knowledge of the matter said.

LIC has in recent years been a kev buyer of shares in state-owned firms sold off by New Delhi, often bailing out less-than-successful public issues of shares. It has also been tapped to rescue struggling financial institutions. Potential conflicts of interest

issues are taking centre-stage in the IPO roadshows that began last week and are expected to go on till the end of the month, the sources said. "The government tends to act as a regulator, manager and shareholder and it tends to get its position confused at different points of time," said Shriram Subramanian, founder of proxy advisory firm InGovern, who has not attended the roadshows.

"The government ministries may tend to think that LIC is 100% under their control and would like to exert that kind of an influence whenever required and that is a concern for investors," Subramanian added. How effectively LIC and its in-

vestment bankers are able to address the investor concerns will help in determining the insurer's valuation in the float, and consequently the state of finances of the Indian government which is banking on proceeds from the IPO

to plug an annual fiscal deficit hole. The Finance Ministry did not respond to emails seeking com-



sources declined to be identified as the discussions are private. In its draft prospectus, the insurer

cited involvement of the government, which owns 100% of LIC now and is expected to own about 95% after the IPO, as a risk factor and said that minority shareholders could be disadvantaged by government action. LIC chairman MR Kumar told a

news conference Monday that potential investors should not worry about government control post the IPO as decisions are taken by its board and not by the government.

PARALLELS TO COAL INDIA?

LIC, which was formed six decades ago when India's insurance sector was nationalised, straddles the business in the country, with more than 280 million policies and over 60% of the insurance segment.

It is also a big investor, owning as of March last year 23.5 trillion rupees (\$315 billion) worth of government securities, higher than even the central bank, out of the total central and state government securities worth 115.2 trillion ru-

pees, according to the prospectus. In 2019, it took over troubled IDBI Bank as the government struggled to find a viable buyer for the lender whose shares had tanked and nearly a third of its book had gone bad. LIC said in its draft papers

that it may have to infuse more capital into IDBI Bank even though it has been pursuing a buyer for its more than 50% stake in the lender.

Some market analysts and fund managers are drawing parallels of LIC with Coal India, which made its market debut in 2010 and, despite being a monopoly, has lost over half its equity value.

In its last earnings call, Coal India chairman and managing director Pramod Agrawal said one of the reasons for its current low market valuation could be because sometimes government takes steps that are not appreciated by shareholders. "If LIC makes decisions that are not beneficial for the shareholders then they will raise concerns," said Ashvin Parekh, an independent financial services consultant.

"We have seen that happen earlier when Children Investment Fund exited from state-owned Coal India after listing as it had concerns over what the majority shareholder was doing and LIC could also face similar pushbacks from its shareholders.

ATLETICO TEST AWAITS RED DEVILS White Ferns thrash

India in rain-hit ODI



Manchester, Feb 22: Manchester United will make the trip to Wanda Metropolitano Wednesday evening looking to claim an advantage in the first leg of their last-16 Champions League clash with Atletico Madrid.

The Red Devils finished top of Group F to advance to the knockout round of the competition, while Atletico claimed second spot in Group B behind Liverpool to ensure that they would be present at this stage.

Atletico will enter Wednesday's

contest off the back of a 3-0 win over Osasuna in La Liga, with Joao Felix, Luis Suarez and Angel Correa on the scoresheet, but there is no getting away from the fact that the Spanish champions have disap-

pointed in the league this term. Indeed, Diego Simeone's side are currently down in fifth spot in the table, 15 points behind leaders Real Madrid, so the Champions League is their only realistic chance of silverware this term, and they might need to win the competition to secure a position in next season's leading European cup competition.

Atletico were far from convincing



in the group stage of the 2021-22 Champions League, winning just two of their six matches against Liverpool, Porto and AC Milan, but a 3-1 victory over Porto on the final matchday moved them onto seven points and allowed them to finish second in the section behind Liverpool.

The Red and Whites have only faced Man United on one previous occasion, tackling them in the second round of the 1991-92 Cup Winners' Cup, with the Spanish outfit winning 4-1 on aggregate, but they twice lost to English opposition -Liverpool-in the group stages of

this season's Champions League. Atletico also lost to Chelsea in last season's round of 16, but they have reached the quarter-finals or better in five of their last eight Champions League campaigns under Simeone, while the capital giants have been victorious in nine of their 12 two-legged knockout contests against English clubs.

Man United, meanwhile, will enter the contest off the back of a 4-2 win over Leeds United on Sunday, with Fred and Anthony Elanga coming off the bench to secure a vital three points for the Red Devils, who sit fourth in the table, four points clear of West Ham United on the same number of matches (26).

The 20-time English champions have picked up big wins over Brighton & Hove Albion and Leeds in their last two but will now switch their attention to the Champions League and will be aware of the importance of picking up a positive first-leg result ahead of the return match at Old Trafford next month.

Man United finished top of Group F to advance to this stage, collecting 11 points from their six matches, with Cristiano Ronaldo coming up with some incredibly important goals to help send his team into the knockout round of the



competition for the first time since the 2018-19 campaign.

The Red Devils, who are twotime winners of the Champions League, beat Paris Saint-Germain at this stage of the 2018-19 competition, but they failed to make it through the group stage last term, ultimately dropping into the Europa League, reaching the final before losing to Villarreal.

The Premier League giants have won seven of their previous 11 round-of-16 ties, while they are in the knockout round for the 19th time - an English record - but the club have not managed to make

the final of the competition since 2011, and it will be fascinating to see what Ralf Rangnick can deliver this season.

Atletico will be without the services of both Yannick Carrasco and Felipe through suspension Wednesday night, while Daniel Wass and Matheus Cunha are both out through knee injuries.

As for Man United, Mason Greenwood is out due to a club suspension, while Edinson Cavani remains a doubt due to a groin problem, but Eric Bailly could recover from an ankle issue to make


Queenstown, Feb 22: The Indian women's cricket team's horror tour of New Zealand continued as the White Ferns demolished the visitors by 63 runs in a rain-curtailed fourth WODI Tuesday to inch towards a clean sweep in the fivematch series here.

The game became a glorified 'T20' due to rain as Amelia Kerr stole the show with a 33-ball-68(11x4, 1x6) which took New Zealand to 191/5. Amelia then mopped up the tail with 3/30 as India managed only 128 before being all-out in 17.5 overs.

Teenager Richa Ghosh's counterattacking half century (52, 29b, 4x4, 4x6) was the only silver lining in an otherwise disastrous performance which has now led to five defeats on this tour including the one-off T20.

The bowling performance of the Indians seemed to have nose-dived with each passing game and it was the worst Tuesday where only Rajeshwari Gavakwad (4-0-26-1) looked the part. Meghna Singh (1/45) and Deepti Sharma (1/49) were two bowlers taken to the cleaners by Amelia.

New Zealand started on a rousing note with a 53-run opening stand between Sophie Devine (32) and Suzie Bates (41, 26b, 7x4). Once the platform was laid, Amelia and Amy Satterthwaite (32, 16b, 3x4, 2x6) literally pummelled the Indian



A chase of 192 was always going to be a tough ask even though the out of form Harmanpreet Kaur was dropped from the playing eleven.

Smriti Mandhana very understandably was out of rhythm after a long and hard quarantine and youngsters Shafali Verma (0) and Yastika Bhatia (0) were out in quick succession. The maych was as good as over by the fifth over when India were reduced to 19/4.

Richa and Mithali Raj (30) added 67 runs but it was in a lost cause as wickets fell at regular interval. Amelia's sister Jess also got two wickets (2/11) upfront while Francis Mackay (2/22) and Heley Jensen (3/32) shared the spoils with two and three wickets respectively.

The only time India had something to cheer about was when Richa clobbered the White Ferns bowlers for four huge sixes and four boundaries while Mithali played the second fiddle. Once Richa was gone, the stomach for fight wasn't evident in others as six wickets fell for 32 runs.

Praggnanandhaa bags two wins in **Airthings Masters**

Chennai, Feb 22: Continuing his good run, India's teen prodigy R against fellow Grandmasters Andrey Esipenko and Alexandra Kosteniuk in rounds 10 and 12 of the Airthings Masters, an online rapid chess tournament.

A day after a stunning victory over World No.1 Magnus Carlsen, the 16-year old scored two wins and drew against Nodirbek Abdusattorov early Tuesday.

He, however, lost to Russian GM Ian Nepomniachtchi in the 11th round. Despite the twin victories and a draw, Praggnanandhaa is in 12th place with 15 points.



He beat the highly rated Russian Esipenko in 42 moves after having started the day with a draw against Abdusattorov. After going down to Nepomniachtchi, he rallied to beat former women's World Champion Kosteniuk in a 63-move encounter.

Praggnanandhaa will be up against Vincent Keymer of Germany, USA's Hans Moke Niemann and Russian Vladislav Artemiev respectively in round 13, 14 and 15 later Tuesday night. Nepomniachtchi, who lost the World Championship match a few months ago to Carlsen, is on top of

the standings with 27 points. Carlsen bounced back from the loss to Praggnanandhaa with wins over Quang Liem Le and Jan Kryzstof Duda but suffered an unexpected reverse against Eric Hansen of Canada in 33 moves. He is in joint. second place with 20 points along with Artemiev and Keymer.

UEFA 'monitoring' situation

NYON: European football's governing body, UEFA, are reportedly "monitoring" the situation with Russia and Ukraine's military crisis, with a possible view to a switch of this year's Champions League final location. The final of Europe's most prestigious club competition is due to be played in Russia's second-largest city - at the Gazprom Arena in St. Petersburg - 28th May. But UEFA has found itself under increasing pressure to move that choice of venue after Russia's president, Vladimir Putin, announced a decision to send troops into Ukraine's eastern Donbas region. UEFA's current position remains that the match will be played in St. Petersburg, but it is understood that the situation is fluid, with officials considering contingency plans.

Nitu, Anamika in quarters

NEW DELHI: Indian women boxers Nitu (48kg) and Anamika (50kg) advanced to the quarterfinals of the 73rd Strandja Memorial Tournament in Sofia, Bulgaria, after clinching impressive opening-round wins. Nitu outpunched Russia's Chumgalakova Iuliia 5-0, while Anamika defeated local hope Chukanova Zlatislava 4-1 to make the last-eight stage Monday. Nitu and Anamika will now take on Italy's Roberta Bonatti and Algeria's Roumaysa Boualem respectively in their next bouts. NEW DELHI: India pacer Deepak Chahar has been ruled out of the upcoming T20 International series against Sri Lanka due to a hamstring injury. The in-form bowler had suffered the injury during the third T20I against West Indies in Kolkata Sunday. "He is ruled out of the series and will complete his rehab at NCA," said a BCCI official. It remains to be seen if Chahar will be fit for the IPL. "The team has sought no replacement as Jasprit Bumrah is already in the side," the official added. The T201 series against Sri Lanka begins in Lucknow Thursday.
