Kolkata: In what may be a first of sorts in legislative history, Governor Jagdeep Dhankhar summoned Thursday West Bengal's legislature for a session past midnight at 2.00am, March 7. Dhankar said he was merely acting on the recommendation of the Mamata Banerjee-led Cabinet which he described as 'unusual'. However, both state government officials and Speaker Biman Banerjee said the request for calling the Assembly session at 2.00am was a case of a simple typographical error where 'PM' became 'AM'. If this really happens, it means that Dhankar would have give his speech at an odd time.

Oil prices at a 7-year high

New Delhi: Oil prices surged past \$100 a barrel Thursday after Russian President Vladimir Putin declared war on Ukraine. The price of Brent crude hit \$105.08 a barrel at one point, the highest level in more than seven years, said a 'BBC' report. Russia is the second biggest exporter of crude oil, and is also the world's largest natural gas exporter, 'BBC' reported. Tina Teng, an analyst at 'CMC Markets' said: "We could see [oil] prices keeping the momentum." Most countries in the world are now apprehending that oil prices will increase further if the war continues.



Modi calls Putin, seeks immediate end to violence

New Delhi, Feb 24: Prime Minister Narendra Modi spoke Thursday with Russian President Vladimir Putin on the Ukraine conflict. He appealed for immediate cessation of violence as well as concerted efforts from all sides to return to the path of diplomatic negotiations.

During their telephonic conversation, Putin briefed Modi about



ing Ukraine, the Prime Minister's Office (PMO) said in a statement. Modi reiterated his long-standing conviction that the differences between Russia and the NATO group can only be resolved through honest and sincere dialogue, the PMO said. It added that concerted efforts are needed from all sides to return to the path of diplomatic negotiations and dialogue.

Modi also sensitised the Putin about India's concerns regarding the safety of the Indian citizens in Ukraine, especially students. He conveyed that India attaches the highest priority to their safe exit

WAR-MONGERING NATION

MOSCOW: From Chechnya to Syria, via Ukraine, the Russia of Vladimir Putin has been involved in a string of wars since the fall of the Soviet Union in 1991.

• 2 WARS IN CHECHNYA

In late 1994, Moscow sent in troops to bring Chechnya to heel. But they meet fierce resistance and were withdrawn in 1996. They were again sent back in October 1999, when Vladimir Putin was PM. In February 2000, the Russian army took the Chechen capital Grozny. The guerrilla movement however, continued. In 2009 the Kremlin brought an end to its operation.

RUSSIA-GEORGIA WAR

In August 2008, Russia and Georgia went to war for five days over South Ossetia, a small separatist Georgian region. In the night of August 7 to 8, the Georgian army took control of South Ossetia, However, Russia immediately responded. It sent troops into Georgian territory and quickly inflicted a resounding defeat on the ex-Soviet republic.



Kyiv, Feb 24: Russian troops launched Thursday a wide-ranging attack on Ukraine, as President Vladimir Putin cast aside international condemnations and sanctions. He warned other countries that any attempt to interfere would lead to 'consequences you have never seen'.

Ukrainian border guards released footage of what they said were Russian military vehicles moving in, and big explosions were heard in the capital Kyiv, Kharkiv in the east and Odessa in the west.

Meanwhile the Ministry of External Affairs said it is looking for alternative routes to evacuate Indian citizens living in Ukraine. More Russian-speaking officials have been sent to India's embassy in Ukraine and are being deployed in countries neighbouring the country, sources in the MEA said.



Bhubaneswar, Feb 24: The Bhubaneswar Municipal Corporation (BMC) released Thursday the final voter list ahead of the urban local body (ULB) elections. The elections are likely to be held after the completion of the panchayat polls in the state.

As per the list, there are a total of 7,25,765 voters in 67 wards who will exercise their franchise at 705 booths in the state capital. Out of the total voters, 3,94,510 are men while 3,30,815 are women. A total of 440 voters belong to 'oth-

have been identified as hyper-sensitive by the ADM and those will have web casting voting facilities. The move is aimed to ensure incident-free polls. It should be stated here that in last urban elections at least 10 hyper sensitive booths were identified. They were booths at Salia Sahi, Bapuji Nagar, Sundarpada, Raghunathpur, Khandagiri, Capital Hospital,

Jayadev Vihar, Sainik School, Niladri Vihar and Patia. The State Election Commission (SEC) has already initiated preparations for the ULB polls by releasing the notification Wednesday. For the first time, the polls in all

107 ULBs (48 municipalities, 59 NACs) and three Corporations will be held simultaneously. The mayor will be directly elected by the voters. Hence, each polling booth will have two EVMs.

Voters will exercise their franchise at a total of 4,584 polling booths in 1,931 wards in the upcoming civic body polls, informed SEC sources.

Bhubaneswar, Feb 24: Amid incident of violences in some places, the last phase of the three-tier panchayat elections was completed in Odisha with a polling percentage of about 74 per cent. State Election Commissioner Aditya Prasad Padhi said approximately 74 per cent out of 41.88 lakh voters exercised their franchise. However, the final figure will only be available Friday. Elections were held for 131 Zilla Parishad (ZP) seats at 13,514 booths in 975 gram panchayats (GPs) of 48 blocks in 25 districts.

In spite of the best efforts of the government, incidents of violence were reported from a number of places. A ballot box was al-



legedly found unsealed while being deposited at AB High School after end of the elections in Basudebvpur of Bhadrak district. Infuriated over the incident, some people attacked the three presiding officers. Six people were arrested in this connection. The injured officers were identified as Malav Ranjan Sahu, Santosh Khillar and

Surendra Sethi. Disturbances were reported from nine booths of Niali block in Cuttack district after ballot boxes were allegedly thrown into a pond. Rigging

allegations also surfaced in some booths of Kalahandi district. In another incident, a BJDbacked sarpanch candidate was attacked by some BJP workers at Padhani panchayat under Dhamnagar block in Bhadrak district. Candidate Sarat Chandra Sahu and some of his supporters had gone to booth No. 2 after getting information rigging was in process.

Talking on the election disturbances, Padhi said action will be taken after getting a detailed report from the concerned district collectors. The Election Commissioner fur-

ther said all arrangements were made for 2.79 crore voters to elect 1,06,353 representatives for Panchayati Raj Institutions (PRIs) at 91,913 booths in this rural poll. He added that 36.523 ward members 126 sarpanchs, 326 panchayat samiti members and one ZP member were elected unopposed. Over 1 lakh polling officials and nearly 40,000 police personnel were deployed for the smooth conduct of the elections.

For the first time, Maoist-hit Malkangiri district recorded over 70 per cent polling in the first four phases. The polls passed off peacefully in the Maoist hot belt,-Swabhiman Anchal in Malkangiri district.







to five years. "The judgment and order passed by the High Court quashing and setting aside the order dated December 12, 2017 blacklisting the contractor is hereby quashed and set aside. However, the period of blacklisting is ordered to be restricted to five years from the date of passing of the order of black-



listing," the bench said

The court ruled that the Orissa High Court has erred by quashing and setting aside the blacklisting order, that too, without adverting to the serious allegations and the act of omission and commission on the part of the contractor which led to a serious incident of collapse of ten meter slab while concrete work of the deck was going on in which one person died and eleven others injured.

'It was specifically found that the safety arrangements were lacking severely in the construction work zone. It was also found that quality assurance was not emphasised as stipulated in the codes and manuals and as per the agreement. Therefore, the High Court ought to have considered the seriousness of the incident," the bench held. The Orissa High Court had in March 2021 set aside the order

Pvt Ltd from participating or bidding for any work to be undertaken by Government of Odisha and transacting any business with Government of Odisha, either directly in the name of propriety bidder or indirectly under any different name or title.

It is to be mentioned here that Panda Infra Projects was awarded a contract for construction of a flyover over the railway level crossing at Bomikhal Junction in Bhubaneswar. In the year 2017, a ten meter slab of the flyover collapsed during concreting of the railway over-bridge at the level crossing, which resulted in loss of life and property. The state government had in December 12, 2017 blacklisted the construction firm with immediate effect, for intentional violation of condition of the contract leading to injuries and loss of life.

Jumbo corridors under red tape even six months after NGT fiat

Bhubaneswar: Feb 24: The National Green Tribunal (NGT) had ordered Odisha government in August, 2021 to issue a notification for the construction of elephant corridors in the state. However, no step seems to have been taken in this regard even after six months.

The NGT also insisted in its order that the government should complete construction work within the next two months

According to sources, the state forest department said in 2010 that Odisha then had as many as 14 elephant corridors. The department had also prepared a draft notification in 2012 to send it for central government's nod, but in vain.

Human-elephant conflicts have been increasing day by day. At least 771 elephants and 881 human beings have died in last ten years due to the conflicts, a government source said. The pachyderms usually cover a distance of around 25 kilometres in

a day in search of food and water. The animals consume about 150 kilograms of leaves and 100 litres of water every day. However, the jumbos use a convenient passage for years together. As per state forest department, four out of 14 elephant corridors are located on inter-state and the rest 10 are on inter-district borders. The four inter-state corridors include Badampahar (Mayurbhanj)-Dhoba Dhobani (Jharkhand), Badampahar (Mayurbhanj)-Karida (Jharkhand), Deuli (West Bengal)-Suliapada (Mayurbhanj) and Karo (Keonjhar) Karampada (Jharkhand). Similarly, the inter-district jumbo corridors are Similipal-Hradagarh-Kuldiha, Telkoi-Pallahara, Jiridamali-Anantpur, Kanheijena-Anantpur, Buguda-Central RF (Nayagarh division), Nuagaon-Baruni, Tala-Kholagarh, Barapahar Tarabha-Kantamal, Kotagarh-Chandrapur and Karlapat-Urladani. The 14 jumbo corridors cover a total area of around 870.61 square kilometres and are 420.8 kilometres in length. Reacting to this, PCCF (Wildlife) Sashi Paul said, "Fourteen elephant corridors have already been identified in Odisha. However. the state government's notification has not been issued yet. A wildlife expert and secretary of an outfit named 'Odisha Vanyaprani Samiti' Biswajit Mohanty said, the NGT has al ready decreed over the elephant corridor issue, but the state government has been delaying to execute the tribunal order and issue a notification.'

Keonjhar, Feb 24: The Odisha Millets Mission (OMM), a flagship initiative of the state government, has supported women self-help groups (WSHGs) to set up 76 'millet tiffin centres' at various community locations in 13 tribal-dominated districts.

The initiative has fortified the strength and conscientiousness of women collectives by setting up primary processing and post-harvesting units for millets in rural areas.

These millet-based enterprises can become a comprehensive solution in addressing malnutrition, unemployment and in motivating farmers to increase their millet

To revive millets as "Nutri-Cereals" in the state, OMM has prioritised creating awareness about production, productivity, consumption and marketing of millet produce and including millets in the state nutrition programme. Awareness-building activities

were organised, such as food festivals, cooking competitions, and celebrating local millet food cultures. Participatory training programmes were also conducted for WSHGs on millet recipes and millet enterprises

Millet Tiffin Centres

The WSHGs entirely manage these centres. They prepare a range of millet-based hot cooked items and ready to cook products. "We prepare pakoda, samosa, jalebi, idli, vada, kheer and kakara from ragi and little millets,

Expansion of OMM

Initially, the OMM was launched in 30 blocks in seven districts and subsequently scaled up to 84 blocks in 15 districts, covering more than

hectares under sustainable agronomic practices. Recently, the state government has allocated Rs 2800 crore to expand the OMM to 142 blocks in 2022.

Considering its visible impact, the OMM model has received numerous recognitions from other state governments and credible institutions. Niti Aayog has pledged to facilitate the inclusion of millets in the Integrated Child Development Services, Mid-day Meal and Public Distribution Services in different states as part of Poshaan Abhiyan as per the learning of OMM.

"Odisha Millet Mission is a replicable initiative," said Abhilaksh Likhi, Additional Secretary, Ministry of Agriculture and Farmers Welfare, Government of India. In order to popularise millets across the state and national level, there is a need to engage with multiple stakeholders, including doctors, chefs and nutritionists. Also, he emphasised that it was essential to strengthen millet farming policies and institutional interventions that are inclusive and market-oriented.

The United Nations General Assembly has declared 2023 as the 'International Year of Millets'. In India, the recent announcement during the 2022-23 Union Budget of supporting post-harvest value addition, enhancing consumption and branding millets further heightens the crucial role OMM could play in reinforcing the supply chain and promoting millets from farm to plate.

Safety of students stuck in Ukraine worries parents

Berhampur, Feb 24: Russia's invasion of Ukraine has unsettled scores of people back in India and particularly in Odisha with many of their kin now stranded in the war-torn country a report said.

The Indian Embassy in Ukraine had directed the Indian citizens to leave for the country from February 15 but many of them including students pursuing higher studies in engineering and medical science are now stuck in Ukraine with Russia launching a full-scale attack on the European country.

As many as 30 students of Silk city studying engineering and medical science are still stranded in Ukrainian capital of Kyiv and Kharkiv city. This was stated here by Asit Mishra, an MBBS student and resident of Berhampur, who returned to the city from Ukraine February 16.

Currently, social media is the only mode of communication with the stranded Indian citizens and students. Lipi Mohapatra, daughter of Umakanta Mohapatra at Vijay Vihar in Berhampur, has taken shelter along with 200 other Indian citizens at the Indian Embassy at Kyiv. Lipi and others were expected to return to India Thursday but left stranded after Kyiv was declared a no flying zone due to the Russian military strike.



Since then, they have been under the cover of Indian Embassy. It is now testing times for the family back in Odisha as the Ukraine airspace has now been closed. Family members of Lipi are

worried about her safety after they heard about the Russian attack on Ukraine. She has been pursuing her medical degree at Kyiv. On the other hand, two other students - D Adarsh Patra and Biswambhar Badatya - have been successful in leaving Kyiv Wednesday, family members said. The two will arrive in India in

a Turkish Airline flight and will reach Bhubaneswar airport by

5pm, Friday. Over 20 students from Rourkela, eight from Jharsuguda and one student each from Soro and Bhadrak have been stranded in Ukraine. Sangita Mohapatra of Karampur (Soro) and Madhumita Nayak of Bhatapada in Bhadrak have been stranded in Ukraine.



Families continue to live with memories that will haunt them for a lifetime, of not being present at the time of death of their loved ones.

to dying in a hospital has been swift and is of fairly recent origin. Even in the 1990s, intensive care was meant for those with a reasonable chance of getting back to a reasonable quality of life. That changed. Healthcare became the healthcare

networks of Kerala support people dying, caring and grieving, and call for conversations on death, dying, and grief. These are difficult conversations. Not all doctors are equipped to help or advise here. Only well-trained palliative care professionals can respond effectively by looking for a balance and guide family members, who themselves would be in a state of confusion and struggling to respond and cope with the situation.

Rather obviously, the value of time increases dramatically when someone suffers from an incurable disease. Compared to a young person with a reasonable chance of living to a life of average expectancy of 70 years, every hour is so much more precious for the person with only days, months or years to live. At this stage, any life-prolonging treatment has to be balanced against the quality of life.

The person has to be treated for pain and any other distressing symptoms and made comfortable with palliative care. Anxiety, depression, anger, guilt or other emotional issues need to be brought out into the open and resolved. The person's time needs to be filled with love, dignity and meaning.

As one of the writers here (Dr MR Rajagopal) who has contributed to the Lancet Commission report writes in that document, death is not always benevolent and beautiful. 'When the physical suffering in peonle with diseases like cancer was extreme, no philosophising, compassion, or companionship helped enough. The suffering was excruciating. People just stood watching helplessly...(yet) the dying person and the family members were never alone in their suffering or grief." Pain relief comes from palliative care, but comfort comes from family care. These are lessons that can hopefully be taken to heart and can spread across India. where the COVID-19 pandemic has highlighted the horrors of separation at the time of death.

In the area of health, the government has implemented a number of structural interventions under the RKSK. These include, for example, the launch of adolescent focused "Ujala" health clinics, the weekly distribution of iron and folic acid supplements, and ensuring the easy availability of free sanitary pads. However, while these structural interventions are very important, their impact can be fully experienced only if they are coupled with well-designed behavioural interventions which specifically focus on the sexual and reproductive health of these young people because often, even when these health services become available, their utilisation is low because of, among other things, social norms. Evidence shows that the knowledge levels of even the older adolescent regarding sexual and reproductive health issues is low and often inaccurate, and that behavioural interventions have

But even before the pandemic, this kind of a death, in a remote location, amid the cold steel of an ICU bed and away from home, has been invading society. It has in fact become so common these days that the Lancet Commission studied it and put out a report with the rather thought-provoking title: The Value

of Death. The report dated January 31, 2022, said: "Death and dying have moved from a family and community setting to primarily the domain of health systems. Futile or potentially inappropriate treatment can continue into the last hours of life. The roles of families and communities have receded as death and dving have become unfamiliar and skills, traditions, and knowledge are lost. Death and dying have become unbalanced in high-income countries, and increasingly in low-

What Lancet is bringing to light is precisely what palliative care teams have been struggling to highlight - that a highly medicalised death, a lingering pushed by modern technology and specialised and skilled doctors mandated to "do everything" often means prolonging the inevitable. This comes at a huge cost not only in terms of medical bills but also in terms of comfort of the patient. It robs the dving and their loved ones of dignity and of opportunities for quiet moments together, reflections, apologies, blessings and the peace of having been close as they part for ever. The critical pre-requisite for all this to happen is the ability to accept death as the inevitable consequence of life.

We had this ability, not too long ago. As recently as two generations

If their concerns are not properly understood and addressed this can lead to inappropriate behaviour, depression, acceptance of sexual abuse, and even attempted suicide.

While there are several venues at which these interventions may be delivered, schools represent a safe, trusted, and effective space within which they can be offered. Before schools can be chosen as an effective location for communicating these messages there are, however, a few barriers that need to be overcome, the most important one being the concerns of teachers, parents, and the community at large at how appropriate this type of education would be for these young minds and what effect it is likely to have. It is well known and reported that programmes like these do not lead to, for example, increased sexual activity but instead, by addressing their natural curiosity in a matter-of-fact way, they take away some of the fascination with these issues that can lead to inappropriate experimentation and behaviours. This evidence needs to be shared with caregivers.

High quality school-based sexual health education programmes are taught by well-trained teachers and school staff, using strategies that are relevant and engaging for all students. They can help connect students to healthcare services, and effectively engage parents and the community. There are examples of successful school-based programmes right here in India. Arpan, a Mumbai-based NGO, for example, working with teachers as educators, offers an effective Personal Safety Education programme in about 250 schools and shelter homes in three districts of Maharashtra. Evaluations have pointed out that the internalisation of these messages by the children receiving them, boosted their self-esteem and feelings of comfort with their own bodies and their personal safety. Dholpur remains a classic study in the same context, achieved with the help of the non-profit, Manjari Foundation

The boys and girls who have participated in this programme have reported a higher sense of comfort with the natural changes occurring in their bodies, reduced feelings of inadequacy and depression, and a stronger sense of empowerment and agency allowing them to express their views more forcefully and with greater conviction. When asked, one of the boys said: "I learnt that my sister cannot live on my leftover vegetables and pickles. The programme widened my perspective.'

That may be a good message to take to all our young boys and girls across India.

THE NDA IS TO BE **FAULTED FOR CONTINUING WITH A LIBERALISATION** THAT REALLY **NEVER WAS EXCEPT FOR UPA'S**

CHOSEN BUSINESS FRIENDS

n economist strangely goes political to criticise a gov-Lernment that follows his Manmohanomics of liberalisaion, globalisation, privatisation with the same devotion that the proponent, Manmohan Singh, former Prime Minister, started. One can understand the pressure on Singh trying to score a political goal. The plunge that he took virtually exposed the kinks in Manmohanomics.

Rising prices were a phenomenon during Singh's UPA regime and continues because the nation never cared to control prices except during a brief period of NDA-I under late PM Atal Behari Vaipavee. As a people's PM having been in touch with the common man, he scripted path-breaking reforms in telecom, road, power, and taxes. Despite sanctions following Pokharan-II in 1998 and the Kargil War in 1999, the government managed to keep economic growth above 6 per cent till 1999-2000. Growth slowed in 2002-03, with drought, but recovered soon.

Vajpayee had left a high GDP for his successor Manmohan Singh. During the UPA years, 2004-2014,

GDP numbers were initially high but slumped drastically towards the end of its tenure. Shockingly, few understand the enigma of electoral rejection of Vajpayee-led BJP in 2004 Lok Sabha elections.

It was nothing hunky-dory in the UPA regime. There started the country's problems. Vajpayee led the biggest ever coalition with élan. The Left differed with him but most leaders in private praised him. The same Left alliance could not continue in the UPA government beyond 2007 as they protested Singh's anti-people decision and poor leadership, though the trigger was the nuclear deal. The check that the Left had on UPA was lost and the government plunged into a series of scams.

Inflation was at a high since 2007 and reached a super high of 11.06 per cent in 2013 giving the BJP the edge to fight against 'inflation dragon'. As per data, Singh's successor, PM Narendra Modi inherited poor GDP numbers after coming to power in 2014. However, the GDP numbers during the NDA started improving initially. In 2014-15, the GDP growth was recorded at 7.2 per cent. This increased to 7.6 per cent in 2015-16.

The NDA government started faltering under the heavy baggage leading to too many corrections. The economic woes it inherited with a fear of 'black money' tormented it. Being under pressure, Modi hurriedly decided in 2016 on a never before demonetisation of 87 per cent of currency notes for cleaning the economy. It theoretically was a good move but practically plunged his government and the people into unseen problems. An economy that just started booming got a shock. It hurt the businesses and the poor. The note-ban slowed growth to 7.1 per cent in 2016-17. Next year, 2018-19, this and GST introduction reduced it to 4.2 per cent and unprecedented 2020 pandemic cut it to minus 7.3 per cent.

The Modi government has got into a vortex for inheriting a poor system as also not trying to move out of the Manmohanomics. The bank NPAs soared during UPA as it opened coffers to incentivise rich companies. Public finances, deposited by the poor, became fodder for the fly-by-night operators. A small number of companies alone heaped over ₹2.24 lakh crore NPA by 2014. This could not be checked and doubled to ₹5.4 lakh

crore in 2021. Decade-long messing up of economy needs heavy correction. It could not happen as the NDA remained under the 'aura' of Singh. It forgot that all the major scams that happened during 1992 to 1998 were under the stewardship of Singh as Finance Minister.

The NDA is to be faulted for continuing with a liberalisation that really never was except for UPA's chosen business friends. Its disinvestments of PSUs never helped the country. Most profitable Navratnas were handed over on a platter to friends and many were deliberately led to losses like MTNL, BSNL and Air India.

The NDA has to go slow also on some such as National Education Policy, bullet and metro-type trains. review extension of roads and too much dependence on infrastructure spending. As also it has to review many administered prices like high tolls, fees, freights and fares that are pushing up inflation. The NDA has opportunities as also prospects to ensure it frees itself from the legacy of Manmohan Singh, his Manmohanomics. and charts out a new people-centric economy.

Welcome amendment

Sir, As many as 11,160 children below the age of fourteen died in road accidents in 2019. Motor vehicle accidents were the top factor for unintentional deaths of children that year. On an average 31 children were killed due to road mishaps in 2020. These numbers point to the vulnerability of children to road accidents. The Centre, by amending Rule 138 of the Central Motor Vehicles Rules, 1989, has taken a right step towards securing the lives of children. By this amendment, the Road Transport and Highway Ministry, has made it mandatory for all children between nine months and four years of age to sport helmets and safety harness on two-wheelers. Violating the rule will attract a fine of ₹1000 and cancellation of driving licence for three months. To be operationalised in one year, this modification has the potential to be a game changer if properly enforced. Children riding pillion with their parents, sandwiched in between, or standing in front of either parent at wheels, is disturbing as well as dangerous. By the new rule, it is possible that there will only be two people on the two-wheelers thereby adding additional safety, and comfort, mechanism. Plus, the amended rule has stipulated 40 km/hour as the maximum speed for two-wheelers. The Ministry should also pay heed to the safety of children travelling in cars and auto-rickshaws. School going children, who commute by autos, are often cramped in a limited space well beyond the permitted capacity leading to dangerous repercussions. There are school vans that ferry children, which do not inspire confidence in terms of speed and seating. It is another matter that pothole filled roads and drunken drivers equally endanger the lives of children. Rash driving near schools is another matter of concern. All such issues affect the safety of children. Ganapathi Bhat, AKOLA

New Delhi: As the situation in Ukraine worsens after the Russian attack, hundreds of stranded Indian students made desperate appeals to the government to ensure their safe return. Several videos emerged on social media in which teary-eyed students urged the Indian authorities to make arrangements for their return. The videos have gone viral on social media, with several prominent personalities sharing them and calling on the government to take action. In one such video, around a dozen visiblydistressed students were seen stranded on a railway station in the capital city of Kyiv. "We are very worried. We are stuck at the railway station from last night. The embassy is not replying. We do not have anywhere to go, no taxi is available. No help from the embassy." one of the students says in the video.

Now our Indians are stranded and are feeling helpless." Describing the situation in Ukraine as "highly uncertain", the India embassy in its advisory Thursday said, "please maintain calm and remain safe wherever you are, be it in your homes, hostels, accommodations or in transit... All those who are travelling to Kyiv, including those travelling from western parts of Kyiv, are advised to return to their respective cities. LeT TERROR BID FOILED IN J&K Weapons dropped by drone recovered

Jammu, Feb 24: Police recovered a huge quantity of weapons dropped by a drone along the International Border in RS Pura sector here, officials said. A search operation was launched

by the special operations group (SOG) of the police following information about a drone activity and dropping of weapons by Pakistan-based terror outfits Lashkar-e-Taiba (LeT) and The Resistance Force (TRF) at the behest of ISI in RS Pura-Arnia area in Jammu district, a senior police officer said. The operation led to the recovery of one pistol with two magazines and 70 rounds, three detonators, three remote-controlled IEDs, three bottles of explosives, one bundle of cortex wire, twotimer IEDs and six grenades at Treva village of Arnia sector, the officials said.

The explosives were dropped by a drone, which is reported to have intruded into the Indian side in Arnia belt of RS Pura from across the border, they said. The dropping of explosives suggests a major terror plan of the LET and the TRF,

which has been foiled, the police officer said.

An FIR under relevant sections law has been registered at police station Arnia and further investigation into the matter case is on, the officials said.

BSF FIRES AT FLYING OBJECT: The Border Security Force (BSF) opened fire at a flying object along the International Border (IB) in RS Pura sector here Thursday, sources said.

The flying object, possibly a drone, was trying to intrude into the Indian territory from across the border but was forced to retreat, they said. A moment of a flying object was detected along the IB in R S Pura-Arnia sector, prompting alert BSF troops to open fire at it, the sources said, adding over 20 rounds were fired. The flying object was forced to return back, they said.



All vacancies across tribunals almost filled, SC told

New Delhi, Feb 24: The Supreme Court on Thursday said the Attorney General (AG) K. K. Venugopal has circulated an email saying that vacancies in all tribunals across the country are almost filled.

Senior advocate Arvind Datar mentioned the tribunal vacancies matter before a bench headed by Chief Justice N.V. Ramana and comprising Justices A.S. Bopanna and Hima Kohli. The Chief Justice told Datar that an email has been circulated by the Attorney General.



"The AG circulated an email saying that all the vacancies are almost filled, except few in the green tribunal and the armed forces tribu-

nal," said the Chief Justice. Citing the email, he added that 'the process to fill up the vacancies in National Company Law Appellate Tribunal (NCLAT) will be finished today (Thursday), but National Company Law Tribunal (NCLT) will take some time'. The Chief Justice said the court has been informed that the remaining vacancies, including the Income Tax Appellate Tribunal will also be filled soon.

On February 16, expressing its discontent with the vacancies in the tribunals, the Supreme Court said some "knee-jerk" appointments were made by the Centre to fill up vacancies across the country, and the bureaucracy has been taking up the issue "lightly,"

A bench headed by Chief Justice N.V. Ramana then observed that after a few appointments made initially, nothing substantial happened. The bench said the court is getting requests for the extension of time for National Company Law Tribunal (NCLT) matters, etc. The bench said: "Some knee-jerk appointments took place and nothing happened after that. We do not know the fate of members and many are retiring". The top court emphasized that the bureaucracy

is taking the issue lightly.

Earlier, the apex court had made some strong observations in connection with vacancies in tribunals across the country. Attorney General K.K. Venugopal contended before the court that he could show the list of vacancies and the steps taken to fill them up. After a brief hearing in the matter, the top court scheduled the matter for further hearing after two weeks.

In August last year, the top court had cited data to show that around 250 posts are lying vacant in various key tribunals and appellate tribunals across the country.

sideration of all petitions related to the hijab row, restrained all the students in the State from wearing saffron shawls, scarves, hijab and any religious flag within the classroom.

The College authorities said they informed the students about the Court order when the educational institution reopened February 16.

However, the deputy director of pre-university education during his visit to the college earlier this week, on finding a group of girls in hijab, informed them about the Court order, asked them to abide by it.

These girls demanded that no girls including the Sikh should be



allowed to wear religious symbols. The college then got in touch and the need to abide by it. According to sources, the girl's family is said to be of the stand that their daughter will not remove the turban and is taking legal opinion, with High Court and government order not mentioning about Sikh turban.

As protests for and against the hijab intensified in different parts of Karnataka and turned violent in some places, the government had declared a holiday for all high schools and colleges in the state from February 9, they were however reopened on February 16, following the High Court order. FRESH LEASE OF LIFE Tamilian heart beats in a Kashmiri woman

Chennai, Feb 24: A heart from an 18-year-old brain dead donor has provided a fresh lease of life to a 33-year old Shahzadi Fathima of Srinagar who was suffering from terminal heart failure. She travelled 3,000 km for her treatment, said MGM Healthcare, a private hospital.

According to the hospital, the harvested heart from a brain dead youth was transported over 350 km for the transplant. Fathima had worsening heart failure symptoms due to restrictive cardiomyopathy (RCM), a condition where the chambers of the heart become stiff over time.

She became terminally ill and her only hope of survival was an early life saving heart transplant. With her condition worsening, on December 31, 2021, she was admitted with sign of severe heart failure.

On January 26, 2022, a suitable brain-dead donor was identified in a private hospital in Trichy The heart was soon rushed here through a green corridor and a high-risk heart transplantation was carried






Tackling marine crimes TN to form elite force

Chennai, Feb 24: The Tamil Nadu government will form two units of the Marine Elite Force to combat marine wildlife crimes, including smuggling, prevention, and poaching of marine animals, especially in the Gulf of Mannar and Palk Bay.

Each unit will have five marine watchers who will be moving around in two deepwater boats. These units will interact with other agencies like Customs, Coast Guards as also with Indian Navy officers for intelligence gathering. Mumbai, Feb 24: A Large Area Soft X-ray Spectrometer (CLASS), a payload on-board Chandrayaan-2 Orbiter, has detected solar proton events which significantly increase the radiation exposure to humans in space, the Indian Space Research Organisation has said.

The instrument January 18 also recorded coronal mass ejections (CMEs), a powerful stream of ionised material and magnetic fields, which reach the Earth a few days later, leading to geomagnetic storms and lighting up the polar sky with auroras. the ISRO said. "Such multi-point observations

The SPE event was seen by NASA's Geostationary Operational Environmental Satellite (GOES) orbiting around the Earth. 🔊 However, the CME event was not detected by GOES. "Chandrayaan-2 Large Area Soft X-ray Spectrometer (CLASS) onboard

Chandrayaan-2 Orbiter detected SPE due to an M5.5 class solar flare that occurred on January 20, 2022," the ISRO said. "The CLASS instrument also detected a CME event as it passed through the moon due to an M1.5 class solar flare that occurred on January 18," it added. The CME travels at a speed of about 1,000 km/s and it takes about two-three days to reach the Earth.

'The signature of this event is missed by the GOES satellite, as the earth's magnetic field provides shielding from such events. However, the event was recorded by Chandrayaan-2," the ISRO said.

"The CLASS payload on Chandrayaan 2 saw both the SPE and CME events pass by from two intense flares on the Sun," it added.

Planned to land on the moon's South Pole, Chandrayaan-2 was launched on July 22, 2019. However, the lander Vikram hard-landed on September 7, 2019, crashing India's dream to become the first nation to successfully land on the lunar surface in its maiden attempt. The ISRO had then said the mission achieved 98 per cent success as theorbiter continues to share data with the ground station.

Justice Mantha said it is expected that no stone will be left unturned in course of such investigation "which shall be carried out in letter and spirit and by the book" and asked the petitioner to cooperate with the TI (identification) parade.



MoD signs ₹1,075cr contract with BEL

New Delhi: The Ministry of Defence Thursday signed a ₹1,075 crore contract with Bharat Electronics Limited (BEL) for retro-modification of commander sight in 957 T-90 battle tanks so that they can detect targets at longer ranges, an official statement said. Commander sight is an optical observation device on a tank. Commander sight of T-90, India's premier battle tank, is presently fitted with image converter (IC) tube-based sight for night viewing, the ministry's statement noted. Based on the requirement projected by the Indian Army, the Defence Research Development Organisation (DRDO) and BEL have jointly designed and developed an advanced mid wave thermal image (MWIR)-based sight as a replacement for the existing IC-based sight, it noted. "The new retro-modified commander sight employs a thermal imager capable of detecting the targets at 8 km during day and night and a laser ranger finder (LRF) to find the ranges accurately up to 5 km, thereby enhancing its capability to engage target at longer ranges," it mentioned.

New Delhi, Feb 24: The Indian government has paid Cairn Energy Plc ₹7.900 crore to refund taxes it had collected to enforce a retrospective tax demand, ending a seven-year-old dispute that had tarred the country's image as an investment destination.

The company, which is now known as Capricorn Energy PLC, in a statement said it has received "net proceeds of \$1.06 billion", of which nearly 70 per cent will be returned to the shareholders.

The tax department had used a 2012 legislation, which gave it powers to go back 50 years and slap



capital gains levies wherever ownership had changed hands overseas but business assets were in India, to seek ₹10,247 crore in taxes from Cairn.

Cairn had in 2006-07 reorganised its India business, which comprised operations of prolific Rajasthan oilfields, prior to its listing on stock exchanges. While the company sold majority holding in the India unit to Vedanta in 2011, it was in 2014 slapped with the tax demand notice over alleged capital gains made on the reorganisation. The British firm contested the demand, saying all taxes due were

duly paid when the reorganisation, which was approved by all statutory authorities, took place. But the tax department in 2014

attached and subsequently sold the residual shares that Cairn held in the Indian unit. It also withheld tax refunds and confiscated dividends due to it to settle part of the tax demand. All this totalled ₹7,900 crore.

Indraprastha Gas Limited, the supplier of Piped Natural Gas (PNG) in the area, however, said its officials inspected the gas pipeline network and there was no leakage in its network.

Panic triggered around 7 PM when locals in sectors 137, 128 and 93 started sharing messages on WhatsApp about the foul smell, even as several called up the officials of the police, the Noida Authority and the district administration to confirm the situation.

Internal messages in some housing societies also cautioned residents against using the cooking gas till normalcy in the PNG pipeline was confirmed, according to locals.

'The alarm towards the smell was raised by the residents of housing societies in Sector 137 and the local police was alerted around 7 PM after which the gas pipeline was stopped as precautionary measure," Additional Deputy Commissioner of Police (Noida) Ranvijay Singh said.

The local police was out on the ground, even as the exact source of the smell was vet to be located, the officer said.

Several people in the meantime took to social media to raise the matter with the IGL, which assured them that their network was working fine.

"Our teams are in the field and have checked the pipeline network in a few sectors of NOIDA where smell has been reported. There is no leakage in PNG net-work of IGL & no disruption in PNG supply," IGL tweeted.

Severe Covid may affect pregnancy outcomes

New Delhi/London, Feb 24: Severe Covid-19 in pregnancy may increase the risk of pre-labour caesarean birth, a very or extreme preterm birth, stillborn birth, and the need for admission to a neonatal unit. finds a new study

The study, published in the journal Acta Obstetricia et Gynecologica Scandinavica, indicated that certain pregnant women with Covid-19 who are hospitalised stand a higher risk of developing serious disease.

"This new analysis shows that certain pregnant women admitted to a hospital with Covid-19 face an elevated risk of severe disease," said senior author Marian Knight, FMedSci, of the University of Oxford



"However, it shows once again the strong protective effect of vaccination against severe disease and adverse outcomes for both mother and baby," Knight added.

For the study, the research team included 4,436 pregnant women hospitalised in the UK with symptomatic Covid-19 from March 1, 2020 to October 31, 2021 (13.9 per cent of whom had severe Covid-19).

In addition to having increased risks of adverse pregnancy-related outcomes, women with severe infection were more likely to be aged around 30 years, being overweight

In the build-up to the attack, Russian state media portrayed Moscow as coming to the rescue of war-torn areas of eastern Ukraine where residents were tormented by Ukraine's aggression. "You paid with your blood for these eight years of torment and anticipation," anchor Olga Skabeyeva said during a popular political talk show Tuesday morning. "Russia will now be defending Donbas." Channel One struck a more festive tone, with its correspondent in Donetsk asserting that local residents "say it is the best news over the past years of war." Vilnius (Lithuania): Viewed from Paris, London and Washington, the events unfolding in Ukraine may seem like a new Cold War taking shape in Europe.

From the Baltic countries, it looks much worse. To Estonians, Latvians and Lithuanians — particularly those old enough to have lived under Soviet control — Russia's belligerence toward Ukraine has some worried that they could be the next target. The tensions have brought back memories of mass deportations and oppression.



Russia's attack on Ukraine sent shockwaves through the Baltic countries Thursday. Lithuania's president declared a state of emergency and Latvia suspended the broadcast licenses of several Russian TV stations accused of spreading disinformation and tries were seized and annexed by Stalin during World War II before gaining independence again with the breakup of the Soviet Union in 1991. They joined NATO in 2004, putting themselves under the military protection of the US and its Western allies. Ukraine is not part of NATO. Along with Poland, also a NATO member; the small Baltic countries have been among the loudest advocates for powerful sanctions against Moscow and NATO reinforcements on the alliance's eastern flank.

Dissatisfied with India's position: Ukrainian envoy



NEW DELHI: Ukraine is "deeply dissatisfied" with India's position on the crisis arising out of Russian military offensive, Ambassador Igor Polikha said Thursday and sought New Delhi's support in defusing the situation.

The Ukrainian ambassador said India has special relationship with Russia and it can play a more proactive role in de-escalation of the situation. He said Prime Minister Narendra Modi is among very few leaders whom President Vladimir Putin listens to and New Delhi can use its proximity with Moscow to control the situation.

The envoy said Ukraine has been following India's position on the crisis and it is "deeply dissatisfied" with it. His comments came a day after Russian Deputy Chief of Mission Roman Babushkin said India has been playing a vital role as a responsible global power and it takes an "independent and balanced" approach to world affairs.

At an emergency meeting of the UN Security Council on Monday night, India had called for "restraint on all sides". It stressed that the immediate priority is "de-escalation of tensions", taking into account the legitimate security interests of all countries and aimed towards securing long term peace and stability in the region and beyond.

'Scared and excited' as Ukrainians watch war arrive

t dawn Thursday, Ukrainians' uneasy efforts at normality were shattered. Smoke rose from cities, even well away from the country's disputed eastern border. A morning commute turned into lines of cars waiting at fuel stations or fleeing from the gray and drizzly capital, Kyiv. People with luggage took shelter in the subway, unsure of where to go. Some panicked immediately.

Others clung to routine, with irritation.

"Tm not afraid. Im going to work. The only unusual thing is that you can't find a taxi in Kyiv," one resident complained, even as air raid sirens wailed.

Many seemed unsure of know how to react. Kyiv's main street, Khreshchatyk, rippled with anxiety as people checked their phones. Some walked their dogs or waved at friends.

"I'm not scared at the moment. Maybe I'll be scared later," resident Maxim Prudskoi said. As the day progressed, alarm across Ukraine rose. People crowded grocery stores and ATMs, seeking supplies and cash. In Kharkiv, worried residents inspected fragments of military equipment strewn

across a children's playground. For weeks, President Volodymyr Zelenskyy had tried to moderate expectations of aggression by Russia, even as warnings by the United States became more urgent. Zelenskyy argued that panic would lead to societal destabilization that could be as much of a tactical advantage for Russia as the estimated 150,000 troops that had massed on Ukraine's borders.

On Thursday, as the president imposed martial law, Ukrainians realised with a jolt that everything might change.

"I feel panic, scared and excited. I don't know who I should ask for help," said Kyiv resident Elizaveta Melnik. "We didn't believe this situation would come."

Chance for India to export more wheat

The Russia-Ukraine crisis might give India an opportunity to export more wheat in the global markets and domestic exporters should tap this opportunity, sources said Thursday. India's central pool stood at 24.2 million tonne, twice more than the buffer and strategic needs, they said. More than a guarter of the world's wheat export comes from Russia and Ukraine, Russia is the world's largest exporter of wheat, accounting for more than 18 per cent of international exports. In 2019, Russia and Ukraine together exported more than a quarter (25.4 per cent) of the world's wheat.

Pharma exporters in wait & watch mode

Amid the military offensive by Russia against Ukraine, Indian pharma exporters are in wait and watch mode on dispatching fresh orders to them and some of the Commonwealth of Independent States (CIS) countries, industry sources said Thursday. India exported over \$181 million worth of pharmaceutical goods to Ukraine in FY 21, nearly 44 per cent growth over the previous year, while Russia contributed nearly \$591 million last fiscal year, with a growth of 6.95 per cent compared to a year before, according to Pharmaceuticals Export Promotion Council of India (Pharmexcil), a body under the Department of Commerce.

barrel Thursday and is expected to mar India's economy with high inflation. At present, India which imports 85 per cent of its crude oil needs, is import-dependent. Any rise in crude oil prices will have a major impact on domestic prices of

petrol and diesel. Besides, the cascading effect of higher fuel cost will trigger a general inflationary trend. Already, India's main inflation gauge --Consumer Price Index (CPI) -which denotes retail inflation, has crossed the target range of the Reserve Bank of India in January. The rise was blamed on high commodities costs.

As per industry calculations, a 10 per cent rise in crude oil prices adds nearly about 10 basis points in CPI inflation. "Crude prices at such higher levels will increase the retail fuel prices by around Rs 8-10 per litre and could create inflationary pressure," said Bhanu Patni, Senior Analyst, India Ratings and Research.

"Although, Oil marketing companies have not increased the retail prices since November 21, the same could be seen post elections," he added.

Besides, crude oil prices surged by 5.50 per cent near \$97.22 per barrel on the NYMEX WTI index. "Crude at over \$100 per bbl would increase the import bill, current account deficit and thereby depreciation of the INR vis-a-vis USD will lead to inflation," said Prashant Vasisht, Vice President and Co-Head, Corporate Ratings, ICRA.

"The Upstream companies would benefit from higher crude oil prices. Besides crude oil, gas prices are also expected to increase as Europe gets a large proportion of gas through pipelines passing through Ukraine," he added. Currently, Russia is one of the world's top producers of crude oil and any western sanctions against Russia will stiffen the global supply.

Mumbai: Tata AIA Life Insurance Co Ltd Thursday said its individual weighted new business premium (IWNBP) jumped about 44 per cent to ₹1.193 crore during the third guarter of fiscal 2021-22. The private life insurer had stood at ₹831 crore in the year-ago period. For the nine-month period ended December 2021, it registered a growth of 32 per cent with an IWNBP income of ₹2,786 crore, compared with ₹2,110 crore for the same period of the previous financial year.

ust what a vulnerable world economy didn't need — a conflict that accelerates inflation, rattles markets and portends trouble for everyone from European consumers to indebted Chinese developers and families in Africa that face soaring food prices.

Russia's attack on Ukraine and retaliatory sanctions from the West may not portend another global recession. The two countries together account for less than 2% of the world's gross domestic product. And many regional economies remain in solid shape, having rebounded swiftly from the pandemic recession.

Yet the conflict threatens to inflict severe economic damage on some countries and industries -

damage that could mean hardships for millions of people. Russia is the world's third-biggest producer of petroleum and is a major exporter of natural gas.

Ukraine's farms feed millions around the world. And financial

markets are in a precarious spot as central banks prepare to reverse years of easy-money policies and raise interest rates to fight a resurgence of inflation. Those higher rates will likely slow spending and raise the risk of another downturn.

"I wouldn't be misled by just calculating GDP ratios...especially at a time when commodity prices are already high, inflation is already high," said Elina Ribakova, deputy chief economist at the Institute of International Finance, a trade group for banks. "It's a tricky moment now, given where the global economy is.

Russia's attack could slow Europe's economic recovery by sending already elevated energy prices ever higher. Europe, an energy importer, receives close to 40% of its natural gas from Russia. A cutoff of that energy source could undercut the continent's economy. High natural gas prices have already led to higher home utility bills for both natural-gas heat and electricity generated from gas, crimping consumer spending.

Costly gas has forced production cutbacks at producers of fertilizer and some other heavy industrial users. Annual inflation hit 5.1% in January in the 19 countries that use the euro, the highest rate since record-keeping began in 1997.

Natural gas prices, which have tended to rise on crisis news, remain about four times what they were at the start of 2021. Russia sold less gas than normal on the short-term spot market, raising concerns that the Kremlin was using gas to press for approval of its Nord Stream 2 pipeline. The pipeline has nowbeen frozen by sanctions imposed by Germany's government.





Dubai, Feb 24: With an aim to conduct an uninterrupted tournament, the ICC Thursday said all matches at the upcoming Women's ODI World Cup in New Zealand could be played with nine players in case of a COVID-19 outbreak.

The nine-player-a-side game is already in place in the ICC guidelines related to playing conditions and has been in effect since the U-19 World Cup in the West Indies, where India won the title for a record fifth time.

ICC's head of events Chris Tetley said that the prevalent playing conditions allow teams to field a truncated side if there is a COVID outbreak in their squad, supplemented by substitute fielders from within the management and coaching staff.

"If it becomes necessary we would allow a team to field nine players as an exception for this envi-

ronment," Tetley was quoted as saying by ESPNcricinfo.

"And if they had female substitutes from within their management team, we would allow two substitutes to play - non-batting, non-bowling-to enable a game to take place.'

Keeping the pandemic scenario in mind, all teams have been allowed to take along three extra players as travelling reserves, who can be brought in the 15-member main squad should there be a COVID casualty.

The ICC official also didn't rule out rescheduling of games if needed. "We'll be asking teams to show maximum flexibility and we'll be as flexible as possible if the need arises to fulfill our objective, which is to get the games on," he said.

The tournament begins March 4 with the opening match between hosts New Zealand and West Indies in Mount Maunganui.

Atlético kept old foe Cristiano Ronaldo in check Wednesday and got a stellar performance from his Portugal teammate Joao Felix, but a defensive lapse near the end meant Diego Simeone's team had to settle for a 1-1 draw in the first leg of the round of 16.

Felix — once touted as the next Ronaldo — was the most dangerous forward and put the hosts ahead with a diving header seven minutes into the match, but substitute Anthony Elanga equalised in the 80th shortly after coming off the bench in one of the few times the Atlético defense broke down.

Atlético was in control during most of the match at the Wanda

Metropolitano and twice hit the crossbar, including with an 86th-minute shot by Antoine Griezmann. The return leg will be March 15 in England. In the other round-of-16 match

Wednesday, Benfica and Ajax drew 2-2 in Portugal.

Ronaldo, who several times ended Atlético's title hopes in the Champions League when he was with crosstown rival Real Madrid, struggled throughout the match and was visibly frustrated. Isolated up front, he was booed by the Atlético fans nearly every time he touched the ball at the Metropolitano.

Félix was much more dangerous for Atlético, constantly threatening with his quick turns and strong runs. The 21-year-old forward opened the scoring with a powerful header off a well-placed cross by Renan Lodi.

The ball came off the post before

going in to make Félix the first Pune.

Portuguese player to score a Champions League goal against United since Ronaldo found the net for Juventus against the English side in November 2018. It was Félix's seventh Champions League goal in 20 appearances in the competition, and first since 2020.

With the 37-year-old Ronaldo well defended and not being able to connect with his teammates, United seemed beaten until Elanga broke free to find the net from inside the area after a nice through ball from playmaker Bruno Fernandes, the competition's assists leader with seven.

Elanga had entered the match five minutes earlier and took advantage of the rare space given up by the Atlético defense, scoring United's 500th goal in the competition previously known as the European Cup.
