### Quake hits Nabarangpur, Kalahandi

Bhubaneswar: An earthquake measuring 3.5 on the Richter scale hit Kalahandi and Nabarangpur districts Thursday. Luckily however, there were no reports of casualties or injuries in either of the two districts. The mild guake struck at a depth of 9km at around 11.30am, informed the Regional Meteorological Centre here. Due to the quake, tremors were felt in several regions of Nabarangpur district including Jharigam and Chandahandi and cracks were found on brick walls of several houses. The shaking lasted for about six to seven seconds, the weather office added. Panicky residents rushed out of their residents when the guake struck.

Mohali: Former Indian captain Virat Kohli is all set to achieve the milestone of playing 100 Tests when he takes the field against Sri Lanka here Friday. Kohli is the 12th Indian to achieve this distinction. Kohli, who made his Test debut against the West Indies in 2011, 'never thought' he would come this far. "I honestly never thought I would play 100 Test matches. It has been a long journey. I am just grateful that I've been able to make it to 100," Kohli said in a video posted by the BCCI. So far he has scored 7,962 runs at an average of 50.39 with 27 centuries.



### SEC panel to look into poll code violations

Bhubaneswar; March 3: The State Election Commission (SEC) formed Thursday a panel led by Chief Secretary SC Mahapatra to examine allegations on violation of the Model Code of Conduct (MCC) for the upcoming urban local body (ULB) polls.

### "The SEC, Odisha has constituted a screening committee headed by the Chief Secretary, Odisha for examining proposals relating to Model Code of Conduct before the same is forwarded to the Commission for clearance with full details and a note of urgency,' read an order issued by the SEC.

Principal Secretary of General Administration and Public Grievances (GA&PG) department has been appointed as a member of the panel while the third member will be the additional chief secretary or secretary of the concerned department to which the proposal is related.

The panel will examine why the proposal/petition can't wait till completion of the elections during the enforcement of MCC for the ensuing general elections to ULBs, 2022. After examining the proposal, the panel will send it to the SEC for necessary action. No proposal shall be forwarded to the Commission directly without prior approval of the screening committee, said the order.

Meanwhile, in another order, the Commission clarified that the MCC will also be applicable to the employees of municipalities, NACs. municipal corporations, development authorities, regional improvement trusts and all such offices located in concerned ULBs till March 26, 2022. Filing of nominations for election of various posts in 109 civic meanwhile continued Thursday also. It will continue till March 7 As per schedule, scrutiny of the papers will be done March 9 and the last date for withdrawal of nominations is March 14 (excluding government holidays). The elections will be held March 24 and the result will be declared March 26. Over 41 lakh voters are eligible to cast their votes in the urban polls. Approximately 27 lakh voters will exercise their franchise in 3,030 booths of 1,731 wards belonging to 106 Municipalities and NACs. In the three corporations, 14.26 lakh people will vote in 168 wards and 1,407 booths. Nomination papers are available for the post of Mayor and Corporators in three Municipal Corporations of Bhubaneswar, Cuttack and Berhampur while the nominations for Chairpersons and Councillors are available at the EO office in 47 municipalities, 59 NACs.

NEW DELHI: The US called India Wednesday to distance itself from Russia, its main arms supplier, after the invasion of Ukraine, which New Delhi has yet to condemn. New US sanctions on Russian banks will make it harder for countries to buy major defence equipment from Moscow, a US diplomat said. He added that no decision had been reached on Washington granting a waiver to New Delhi to take delivery of Russian surface-to-air missiles under an earlier contract. India signed a \$5.5 billion deal with Russia in 2018 to buy five of its \$400 missile systems, initial supplies of which started late last year. The US this week placed more restrictions on Moscow including the bank sanctions after Russia invaded Ukraine last week. "It is going to be very hard for any country to buy major weapon systems from Russia because of the sanctions now placed on Russian banks," Donald Lu, Assistant US Secretary of State for South Asian affairs, told a senate sub-commit-

New Delhi, March 3: There were scenes of joy Thursday at various airports across India including Delhi and Mumbai as stranded Indians in Ukraine, mostly students, reunited with their relatives. However, amid all this feeling of déjà vu. a large number of students were critical of the way the evacuation was planned. They felt it could have been better organised. Above all, most of the Ukraine returnees slammed the way the Indian Embassy at Kyiv, functioned. Divyanshu Singh hailing from Motihari in Bihar had crossed over to Hungary, He arrived at the IGIA here Thursday and strongly criticised the government. He stated gestures like distributing flowers are pointless when timely steps are not taken to rescue citizens from conflict zones. Divvanshu informed that he and other students in Kyiv did not get any help from the Indian Embassy. 'We received help only after we crossed the border into Hungary. Whatever we did, we did on our own. Ten of us formed a group and boarded a train. The train was packed," Divyanshu was quoted as saying by 'NDTV' 'If our government had taken action at the right time, we would not face so many problems," added Divyanshu. The Indian student displayed the rose presented to him by government officials at the airport. "Now that we are here, we are being given this. What is the point?" he asked.

### **Russia facilitates** rescue of Indians

**RUSSIA FACES WAR CRIME INVESTIGATION** 

The Haque: The International Criminal Court (ICC) prosecutor has launched an investigation that could target senior officials believed responsible for war crimes, crimes against humanity or genocide amid a rising civilian death toll and widespread destruction of property during Russia's invasion of Ukraine, ICC prosecutor Karim Khan announced the probe late Wednesday night after dozens of the court's member states asked him to take action. "An investigation by the International Criminal Court into Russia's barbaric acts is urgently needed and it is right that those responsible are held to account." British Foreign Secretary Liz Truss said. "The UK will work closely with allies to ensure justice is done.' Meanwhile Khan said: "Our work in the collection of evidence has now commenced.

Washington/New Delhi, March 3: A majority of Indians completely or mostly agree with the notion that 'a wife must always obey her husband' and support traditional gender roles but at the same time favour women having the same rights as men, according to a recent study by an American think tank.

The report by 'Pew Research Centre' was released Wednesday.

# State can levy duty on human consumption liquor only: SC

A two-judge bench of the apex court refused to interfere with the order passed by the Orissa HC wherein it granted relief to M/s Utkal Distilleries from paying excise duty on weak spirit

New Delhi, March 3: Dismissing petitions filed by the Odisha government challenging the Orissa High Court order of 2008, the Supreme Court Thursday held that the state had power to levy excise duty only on alcoholic liquor meant for human consumption.

A two-judge bench of the apex court, comprising Justices L Nageswara Rao and BR Gavai, refused to interfere with the order passed by the Orissa HC wherein it granted relief to M/s Utkal Distilleries from paying excise duty on weak spirit.

While dismissing the state government's petitions against the

shrine disabled-friendly.

liquor after distillation," the apex court had ruled. Notably, M/s Utkal Distilleries

was granted licence by the Excise Commissioner of Orissa in September, 1990 for manufacturing, bottling, blending and reduction of Indian Made Foreign Liquor (IMFL) from rectified spirit. The license was granted with the condition that the company shall install one rectification column to rectify/purify the rectified spirit to be used in manufacturing of IMFL.

In September 1997, the state government had issued a demand notice to the ¬ company, calling upon it to pay excise duty on the weak spirit, which was more than 2 per cent allowable wastage The company made represen-

tation to the Excise department stating that the wastage generated during rectification was an impure /weak spirit, which was not fit for human consumption. It was, therefore, contended that the state government has no authority to impose excise duty on the weak spirit. However, the state government issued three more demand notices to the company in 1998, 2003 and 2005

The company approached the Orissa HC against the notices issued by the state government. The HC in December 2008 decided the matter in favour of the company. Aggrieved by the HC order, the state government moved the Supreme Court in 2009.

### **Disabled fraudster** held for cheating mobile shop owner

Bhubaneswar, March 3: The commissionerate police Thursday arrested a physically-handicapped fraudster who reportedly duped a person of ₹30,000 by impersonating as a senior officer of Central Bureau of Investigations (CBI). The accused identified as Papuni Swain alias Nikhil, 34, is a resident of Poparada under Madhupatna police limits in Cuttack.

Nikhil has been staying near RD Women University under Saheed Nagar police limits here.

Police claimed the complainant, Tika Prusty, came into contact with the accused who had recently visited his mobile shop to purchase mobile accessories February 12. During an informal conversation, Prusty revealed before Nikhil that his niece has been suffering from a serious disease and her family has to spend big on treatment. Subsequently, Nikhil promised to arrange medicines for his ailing niece at a subsidized rate and took ₹30000 from him. However, Nikhil neither gave medicines not returned the money.

Prusty later lodged a complaint with Tamando police who arrested Nikhil by registering a case (50/22) in this regard. During the course of investigation, the cops found that Nikhil had duped an OLA driver of ₹40,000 on the pretext of releasing his vehicle which was seized by financial institution over nonpayment of EMI. He identified himself as a senior secretary level officer of Odisha government. Nikhil has cheated several others in the past too.

### AGENCIES

Bhubaneswar, March 3: The Commercial Tax and GST enforcement wing Thursday conducted raids on 20 tobacco manufacturers and traders at 30 different locations across the state.

Based on intelligence inputs, data analysis and frequency of interception of vehicles carrying tobacco products illegally, the State CT and GST Enforcement Wing identified 20 manufacturers and traders of pan masala and tobacco products covering 14 districts and conducting simultaneous raids at 30 different places in Bhubaneswar, Cuttack, Puri, Kendrapara, Bhadrak, Keonjhar, Rairangpur, Balasore, Sambalpur, Bargarh, Bolangir, Rourkela, Bhawanipatna, Kesinga and Berhampur.

Bhubaneswar, March 3: Odisha's COVID-19 caseload rose to 12,85,487 Thursday as 138 more people tested positive for the virus, the health department said. The death toll re mained unchanged at 9,085 with no reports of any more fatalities due to coronavirus. The state had registered 143 new COVID-19 cases and six deaths on Wednesday.

Odisha now has 1,923 active cases, while 12,74,426 people have so far recovered from the disease, including 378 in the last 24 hours. The health department said 53 COVID-19 patients have died of comorbidities so far. The daily positivity rate was 0.32 per cent while 33 children were among the newly infected people, the department said in a bulletin. The state has conducted 43,669 sample tests for COVID-19 in the past 24 hours.

Bhubaneswar, March 3: Amblyopia, often called lazy eye, is a serious eye condition that affects about 4 per cent of children globally. Untreated, it can cause permanent vision loss. "This is the first time in the world that this globally endangered species' population is being estimated completely outside the purview of protected areas which required the involvement of local fishermen, local wildlife protection committees as well as student volunteers from national universities," said Jim Sanderson, IUCN (International Union for Conservation of Nature) cat specialist group member. The first

# Loud music may up hearing loss risk in 1bn young adults: WHO

ore than 1 billion people aged 12 to 35 years risk losing their hearing due to prolonged and excessive exposure to loud music and other recreational sounds, the World Health Organisation warned.

"Millions of teenagers and young people are at risk of hearing loss due to the unsafe use of personal audio devices and exposure to damaging sound levels at venues such as nightclubs, bars, concerts and sporting events," said Dr Bente Mikkelsen, WHO Director for the Department for Noncommunicable Diseases, in a statement.

"The risk is intensified as most audio devices, venues and events do not provide safe listening options and contribute to the risk of hearing loss," she added.

The WHO stated that hearing loss due to loud sounds is



permanent but preventable.

Exposure to loud sounds causes temporary hearing loss or tinnitus. But prolonged or repeated exposure can lead to permanent hearing damage, resulting in irreversible hearing loss. Young people can better protect their hearing by keeping the volume down on personal audio devices, using well-fitted,

and if possible, noise-cancelling earphones/headphones, wearing earplugs at noisy venues, and getting regular hearing check-ups.

The WHO has also issued a new international standard for safe listening at venues and events, which includes a maximum average sound level of 100 decibels, live monitoring and recording of sound levels, optimising venue acoustics and sound systems, among others.

"Governments, civil society and private sector entities such as manufacturers of personal audio devices, sound systems, and video gaming equipment as well as owners and managers of entertainment venues and events have an important role to play in advocating for the new global standard," said Dr Ren Minghui, WHO Assistant Director-General, in the statement.

# Truckers to face music for blocking jumbo path

Keonjhar, March 3: Parking of trucks within 100 metres of elephant corridor signage or obstructing the path of pachyderms in this district will invite punishment for the vehicle owners. The Forest department has put up information plaques in this regard to warn the truckers, sources said Thursday

The action follows a recent report published in **Orissa POST** on how the long column of trucks parked illegally on roads was hindering jumbo movement in the district. Sources said the pachyderms need to cross the National Highways-49 and 20 and other roads in the district to travel from

one jungle to another under Keonjhar forest division. However, the animals find it difficult to cross the highways due to heavy traffic on the route and park-



ing of mineral-laden trucks in rows alongside the highways. The blazing lights of the vehicles also dissuade the jumbos from moving ahead.

This has been witnessed near Suakati mines under Bansapal block where hundreds of trucks are lined up to load minerals for hours together.

The animals, after finding it difficult to cross the highways, unleash a reign of terror in the surrounding areas which results in loss of lives and properties. The Forest department has warned that any truck found parked within 100 metres of the signage on elephant corridor or obstructing the path of the animals will be liable to punishment.

The move has been welcomed by the environmentalists as they demanded conduct of patrolling in these areas and ensure safe pas sage for the animals.

# Students recall horror in war-torn Ukraine

Sundargarh, March 3: Two medical students from Sundargarh who managed to escape from Ukraine and reach home safely have shared their nightmarish experience in the war-torn country.

Smiti Kujur, daughter of Kinjirikela health centre officer Franklin Kujur. and Sakit Sohaib Khan from Rourkela were two of the thousands of Indian students stranded in Ukraine.

Their dream to study medicine in Ukraine took an unusual turn after Russia invaded Ukraine. The two medical students recalled the horror they had to go through in Ukraine to reach back home safely.

Speaking about her ordeal, Smiti said, "I had gone to Ukraine Januarv 26 to study medicine. I was a first year medical student at Ukraine's Uzhhorod



National University where at least 600 Indian students were studying.'

"We were just trying to adjust with Ukraine culture and language, when the war broke out. Initially, we thought the war would not have much impact. But, we were wrong. So, amid the ongoing war, we decided to fly back home, but ticket prices skyrocketed

from ₹23,000-30,000 to 1 lakh."

Later, Indian government launched 'Operation Ganga' to airlift Indians stranded in Ukraine. As Ukraine's airspace is closed, flights are being operated from neighbouring Poland, Romania, Hungary and Slovakia.

With the help of our University, at least 240 students arranged five buses and managed to reach Hungary border. "We had to spend 20-30 hours on Hungary border for verification of visa and other documents," she said.

"Later, we were taken to Hungary's Budapest Airport from where we flew to Delhi. I then flew from Delhi to Jharsuguda Veer Surendra Sai Airport from where I was received by my family," she added.

Meanwhile, many students have shared that they had to walk 100-200km in the chilly weather to reach borders of other countries as officials had failed to provide any transportation to shift them to safety.

Many students were not allowed to board trains and Ukrainian guards thrashed them. They were also pushed away from many trains. There are still hundreds of students stuck in Ukraine. On the other hand, two Indian students have lost their lives in the war

# **Imperium of Grievance**

oon after the news of Russia's invasion of Ukraine flashed across my computer screen, I received an email that seemed to mark another milestone in the dismantling of the old global order. Having tickets to attend a Vienna Philharmonic concert at New York's Carnegie Hall, I received a 'Customer Service Announcement' reporting that the Valery Gergiev - described as "a friend and prominent supporter of President Vladimir V. Putin of Russia" - would no longer be conducting the orchestra. Many other orchestras have since cut ties with Gergiev as well.

Until the Russian invasion, it was still possible to believe that a full Western "decoupling" from China and Russia was both unlikely and unwise. Yet Gergiev's removal is a metaphor for how the newly confected Sino-Russian axis is catalysing a rift that will now affect everything from cultural exchanges to trade.

After all, until the invasion, many were skeptical that the European Union (especially Germany) would ever get the Russian natural-gas needle out of its arm - especially with the Nord Stream 2 pipeline offering up a fresh vein. Equally, many have wondered how the US could ever kick its addiction to low-cost Chinese-made merchandise now that so many of its own factories have closed

During the halcyon days of globalisation - when "Davos man" ruled the planet with cheery bromides about win-win-win outcomes - global supply chains seemed to promise boundless benefits for everyone. What was wrong with outsourcing to distant lands if they could make something cheaper and ship it faster? Open markets were touted for their ability to create more open societies. All we had to do was keep trading transnationally, paying no heed to the ideological or political cast of the other country. Thus did the West, and much of the rest of the world, become codependent with Russia (for gas) and China (for rare earths, polysilicon, pharmaceuticals, and old-fashioned consumer goods).

But with Putin invading Ukraine and Chinese President Xi Jinping expressing revanchist attitudes toward Taiwan, we are left to assess not only an upturned world order and a shattered global marketplace, but also the sundering of anodyne cultural exchanges.

What is driving this unexpected and dangerous train wreck? Why would Putin throw Russia's real national interests to the wind by invading a oncefraternal neighbour? What would lead Xi to countenance sacrificing his own people's historic economic miracle for the sake of seizing a flea-shaped island that China hasn't ruled in well over a century? Why have these two latter-day authoritarians indulged such self-destructive urges and alienated so many other important countries, just when

the world was becoming so interdependent? First, it is important to remember that au tocrats are far freer to act in unrestrained ways, because they face few if any political checks and balances. Thus, as "supreme" leaders, they can shape policies according to their own characterological disorder without challenges. While Putin and Xi have very different backgrounds and personalities, they share some key traits. Both are deeply insecure, paranoid men who have been shaped by historical narratives of grievance, especially against the "great powers" of the West.

These narratives center around Leninist themes of foreign exploitation, humiliation, and victimisation. They demonise Western democracies as hypocrites and oppressors (as in Lenin's theory of imperialism). And they impute arrogant and disdainful attitudes to the West.

More than anything else, Putin and Xi want respect. Yet they know that most Western leaders do not, and probably never will, respect their authoritarianism - no matter how successful they are in building high-speed rail lines, constructing modern cities or hosting Olympic Games. It is this respect-deficit syndrome that has created their imperium of resentment and grievance. Putin and Xi recognise that they will never overcome this, regardless of how

# **WHERE INDIA STANDS**

he invasion of Ukraine, a sovereign and independent country, by Russia has shaken the international community. It is unlike the NATO and American forces moving into Iraq, Syria or Afghanistan, where dictators and fundamentalists were torturing their own people. Russia invaded Ukraine on a twisted narrative of Vladimir Putin about the history between the two countries, that Russians and Ukrainians are one people and hence inseparable.

Various reasons and interpretations of the motivations for Russia's outright armed invasion have been put forth by leaders, experts and observers. The front-running perspective of the war is that Ukraine has become a hapless pawn in rivalry between US-led NATO and Russia. The other major interpretation of Russian military action is Putin's reading of history which suggests that Ukrainians and Russians have same ancestry and thus. Ukraine is an inseparable part of Russia. Putin colours this view by seeking to bring order in Ukraine. One could write trees of notes to explain the reasons for Russian invasion. That is not the remit in this article. The war is on causing deaths and destruction in Ukraine. The urgent objective is to end the war, and analyse what other countries in the international community are doing or not doing to contribute to this end.

We are here talking about India's stance on the war between Russia and Ukraine. To put it pithily, New Delhi's position vis-à-vis the Ukrainian crisis has been disappointing so far. It has also diminished India's chance or to be precise, Prime Minister Narendra Modi's ambition of becoming a 'Vishwa Guru'. India's balancing role between two super powers (in the Cold War era), and now between the US-led bloc and the United Front comprising Russia and China has reached a biting

point; New Delhi could neither go forward or backward.

In the current war, India has shown a pro-Russian tilt which is a function of New Delhi's 'time tested' friendship with Moscow as well as of geopolitical necessity. So say the pro-government strategic community and the proponents of the concept of strategic autonomy. The foregoing formulation does not hold water. In fact, it was started by Jawaharlal Nehru who had conceived the policy of non-alignment. It was an impractical idea from the word, go. All countries are interdependent, no country could remain nonaligned or isolated. Nehru could not maintain it. In 1956, he criticised the Anglo-French invasion of Suez Canal, but kept quiet on Soviet Union's attack on Hungary the same year. The explanation for such contrasting positions was that Nehru relied on the Russian Veto on Kashmir. But it was Nehru who took an incredible and inexplicable step in taking the Kashmir dispute to the United Nations.

The current regime which is super-critical of Nehru on his foreign policy is adopting the same stance of neutrality, middle-of-the road, and so-called balancing act. Modi is following the same policy of continuing with non-alignment. He even addressed digitally a non-alignment meeting. Admittedly, there has been some change, but no departure from the past on China and Russia.

What could India do in the case of invasion of Ukraine? Agree that New Delhi could not suddenly oppose Russia. But some of us have been urging New Delhi to choose the corner. either the democratic world or the authoritarian bloc. India has abstained twice (at the time of writing this article) in the United Nations on Russian invasion with small murmurs against the invasion. New Delhi did not want to offend Russia for their long friendship and the arms trade. If India joined a security bloc with tacit assurance of support for her territorial integrity, India's dependence on Russian arms would have been reduced. If New Delhi actively made friends with Japan and South Korea at the behest of the US, it would not have relied on Chinese material for her economy after China has taken away at least 50,000 square kilo-

metres of our land

Secondly, the so-called strate gic autonomy has cost India billions of dollars in arms purchase affecting her growth and development. India, as a poor and developing country, could have followed the policies adopted by Japan and Germany in reducing the defence budget and built her economy.

Anyway, here we are now. India's option to get out of China-Russia axis. like SCO, or BRICS is limited by the mistakes made by the West. American and NATO leadership should not have seduced Ukraine into joining NATO. New Delhi has a great scope in resolving the impasse and stopping the war. New Delhi is correctly focusing its diplomatic resources in evacuating Indians in Ukraine. It should take two more steps. The Indian leadership should convince Putin that annexing Ukraine or proxy ruling the country as a vassal state is not an option. Ukraine could be declared as an internationally acknowledged neutral country like Austria and Switzerland are.

The second step for New Delhi could be, should the first step fail, to differentiate between Putin and Russia. Evidently, many Russians are against the war, and Putin's autocracy has opposition in the country. Putin has violated international laws and the BRICS resolution just six months ago for going the use of force. New Delhi could be seen as guilty of complicity unless it finds a way out for Russia or condemns it.

New Delhi could establish other channels than Putin to help consolidate democracy in Russia. That will help India also in the long run. In any event India's credi bility and capability are challenged at this time of international politics. We wish India succeeds in overcoming those challenges.

# Governing an ocean of plastics



mages of plastic pollution in deplete the ozone layer managed to the ocean and on beaches are now commonplace, and the problem is likely to get worse. Last week. the OECD's first Global Plastics Outlook revealed a dramatic increase in the plastic waste leaked into aquatic environments. That report came only a month after the World Wildlife Fund for Nature released a study that projects a doubling of microplastics in the ocean over the next few decades. While there are promising innovations that extract plastic from the ocean or intercept it in rivers, these projects will barely make a dent in the amount of plastic pollution in the world's waterways. Even under the most optimistic projections, these technologies will affect only 5-10 per cent of all plastic in the ocean. More than 1,000 organisations, including businesses and governments, have signed on to a plan for a new, circular economy for plastics. But this kind of voluntary action also is not enough. The problem requires a new form of global governance to change the entire production and consumption cycle of fossil-based plastics. The fifth meeting of the United Nations Environment Assembly (UNEA-5) offers a unique forum to turn the tide on marine plastics via legally binding mechanisms. The international community has already shown its ability to act on serious environmental challenges. The landmark Montreal Protocol of 1987 on substances that

phase out the use of chlorofluorocarbons in only a few years. An international treaty on plastic pollution will require a similar transformation in societies' priorities, based on ocean literacy and a new vision for the blue economy.

These principles would enable the ocean to be turned from a dumping ground into a source of global prosperity. Meanwhile, the private sector must spearhead the change in unsustainable patterns of plasticwaste production and promote new innovations that can replace plastic or reduce its use. Consumer awareness, based on learning tools such as "reflectories" and curriculum units on marine plastic pollution, will be needed to push these efforts forward. An international treaty on marine plastic pollution based on ocean literacy, industry transformation, and agreed legal principles would recognise the multiple services provided by the ocean. It is a crucially important step toward a blue new deal that emphasises equality, democracy, and justice.

opment, or how much oil and gas they sell to the world. And it does no good to admonish them that gaining respect requires them to behave respectably, rather than jailing opposition candidates and dissidents, persecuting people for their religious beliefs, bullying other countries with punitive trade policies, and launching invasions. Having drunk the Leninist Kool-Aid of victimisation, Putin and Xi simultaneously want to overthrow the Western order and be esteemed by it.

As such, they are animated by a contradiction that no amount of Western handholding can resolve. Not even the tonic effect of "engagement," sustained through nine US presidential administrations, was enough to overcome China's sense of being the target of constant disapprobation and ideological threat from the world's democracies. Putin and Xi take great umbrage at having to live next door to successful democracies, like Ukraine and Taiwan, comprised of peoples with similar histories, cultures, and ethnicities.

The magnetic force of shared grievance has brought these two former rivals so close that they recently declared there were "no limits" to their partnership. Both insist that it should be up to the people of the country "to decide whether their state is a democratic one." And Putin and Xi claim they are leading a new kind of democracy, never mind that Putin fancies himself a czar, and that Xi's version of governance is a "democratic dictatorship of the proletariat.'

The question now is whether Russia and China will be able to maintain their opportunistic pact following Putin's decision to go to war. Just before the invasion, Chinese Foreign Minister Wang Yi told the Munich Security Conference that the "sovereignty" and "territorial integrity" of all countries should be protected, and that "Ukraine is no exception." And Xi subsequently called Putin to explain that, while he understands Russia's security concerns, China still respects the sovereignty of nation-states and intends to uphold the principles of the United Nations Charter. After all, the Communist Party of China does not want foreign powers interfering in its own "internal affairs," never mind invading China.

Which of these imperatives will win out? Most likely, China and Russia's shared aversion to liberal democracy (and to the self-righteousness of democratic leaders) will ultimately trump the quaint nineteenth-century idea that national sovereignty is sacred. The narrative of victimisation that is psychologically fueling both countries' nationalism with reservoirs of resentment is simply too powerful to be nullified by the niceties of international law.

An effective international agreement on ocean plastic pollution should account for all aspects of plastics production - from manufacturing to disposal, and it must involve governments, the private sector, and the public. Specifically, a new treaty should address six issues.

First, plastic use must be reduced at all points along the supply chain. Food packaging, particularly takeout containers, is a major source of ocean pollution. Eliminating it will require policy support and funding for the development of novel biodegradable food containers and stronger efforts to encourage reusable packaging.

Second, a new treaty must encourage the growth of the blue economy. Governments should create programmes to promote sustainable, ocean-friendly tourism, fishing, marine renewable energies, and other businesses. Policymakers also must invest in urban-waste and wastewater-management infrastructure that in-

cludes resource-recovery options. Third, the impact of plastic pollution on the marine environment must be regularly assessed and improved. While research suggests that corals have some resilience

life. Experience with climate-change governance suggests that a more agile structure than the IPCC is needed to improve response strategies. One option is regular ocean assessments that synthesise findings on key topics and engage with relevant parties.

This leads to the fourth issue that a new treaty on marine plastic pollution must address: an agreement on legal principles for sustainable ocean governance. Given that plastic pollution has multiple sources, establishing proper accountability is essential. Packaging producers, food retailers, delivery platforms, shipping companies, tourism firms, and others must be part of the discussion about such principles. Companies already disclose relevant data on emissions, in accordance with environmental, social, and governance reporting standards. Comparable figures on plastic waste could be included in these frameworks.

Fifth, improvements are needed in waste management and circular-economy systems, particularly in key countries like Indonesia and China. Policy options include extended producer responsibility, landfill taxes, deposit-refund, and pay-

# **Several students still** stranded in Kharkiv

**STUDENTS HAVE ALMOST 'RUN OUT' OF FOOD AND ESSENTIALS** 

New Delhi, March 3: A day after the Indian government asked citizens to "immediately" leave the war-hit Ukrainian city of Kharkiv, several students are still stranded there, desperately waiting to get to a safe zone as the Russian onslaught on the eastern Ukrainian city continued.

As fighting intensified in Kharkiv. India had Wednesday asked its nationals to leave the second-largest Ukrainian city urgently to three nearby places "even on foot", while Russia promised to create "humanitarian corridors" for evacuation of Indians from the conflict zones.

"Just because the night passed and we survived does not mean the struggle is over for us. We are far from being in a safe zone. We did start walking but the railway stations were flooded with people and still haven't been able to board a train," said Firdaus Tarannum, an Indian medical student in Kharkiv.

### India 'missing' 25.87mn hectare forests: CSE analysis

Nimli (Rajasthan): India is "missing" 25.87 million hectares (Ha) of forests - combined together, the area would be equivalent to Uttar Pradesh - which is a result of the difference between recorded forest and the forest cover as per official data, Centre for Science & Environment (CSE) analysis showed Thursday. The CSE analysis was based on the India State of Forest Report 2021 (ISFR2021) published a few weeks ago. "The State of the Forest Report does not explain what is the state of this forest land that India is 'missing' - as massive as 25.87 million Ha. This is the difference between what is 'recorded' as forest area and the actual forest cover on that recorded area. The recorded forest area is 77.53 million Ha but the forest cover on these lands is 51.66 million Ha. Which clearly means that as much as 34 per cent of the area classified as forests is missing in the assessment," CSE Director General Sunita Narain said. Nowhere in the whole report is it explained, "where is this difference of 25.87 million Ha?" she said. As, off the record, a very senior forest official told her that 11 million Ha is accounted for, including 3 million Ha is encroached, 1 million Ha is inside villages and 2 million Ha is diverted.

# **HC orders development** of Amaravati as capital

Amaravati, March 3: In a set back to Jagan Mohan Reddy-led government's plans to develop three state capitals, the Andhra Pradesh High Court Thursday directed it to complete implementation of Amaravati capital city master plan in six months.

The court also asked the government to hand over developed plots with all basic amenities to farmers within three months. The government was also asked not to alienate lands in Amaravati for any work other than development of state capital.

It also made it clear that the Assembly has no powers to make laws on state capitals

A bench of three judges headed by Chief Justice Prashant Kumar Mishra pronounced the judgment on 75 petitions filed by Amaravati farmers and others challenging the government's move for trifurcation of state capital.

The court directed the government to keep it informed about the development works taken up as per capital city master plan.

Counsel of one of the petitioners told media persons that the bench directed the government not to shift any office from Amaravati as the earlier interim order in this regard will remain in force. The government was directed to pay Rs 50,000 each to the petitioners towards legal costs.

Andhra Pradesh's main Aopposition Telugu Desam Party (TDP) Thursday hailed the High Court verdict on Amaravati as the state capital. The TDP Politburo meeting, presided over by party President and former Chief

Minister N. Chandrababu Naidu, discussed the High Court's latest verdict and described it as a big blow to the 3 capitals plan of the Jagan Mohan Reddy government. Briefing media about the decisions of the Politburo, former minister Kalva Srinivasulu said by directing the government to implement the CRDA Act, the court has upheld the merit and value of the Act passed by the previous government. It welcomed the court's decision to review the future progress of capital city works.

The Andhra Pradesh government Nov 22, 2021 repealed two laws enacted last year to create three state capitals but announced that it will come out with a new comprehensive legislation.

The Assembly passed Andhra Pradesh Decentralization and Inclusive Development of all Regions Repeal Bill 2021. The Bill repealed the Andhra Pradesh Decentralization and Inclusive Development of all Regions Act 2020 and the Andhra Pradesh Capital Region development Authority Repeal Act 2020 Act. The government, however,

had made it clear that it had not gone back on the decision to have administrative legislative and judicial capitals at Visakhapatnam, Amaravati and Kurnool respectively. The development had come as the

High Court was to resume hearing on a batch of petitions challenging the two legislations made in 2020.

After coming to power in 2019, the YSR Congress Party (YSRCP) had reversed the decision of the previous TDP government to develop Amaravati as the only state capital. This had triggered massive protest from farmers of Amaravati, who had given 33,000 acres of land for the capital and were hoping to reap its economic benefits.

New Delhi, March 3: A study on the adverse impact of air pollution due to thermal power plant at Chandrapur in Maharashtra has estimated that there are several premature deaths happening not just around it but also very far from it.

The residents from Chandrapur and Nagpur are suffering significant health impacts from air pollution caused by the 2,920 MW coal powered Chandrapur Super Thermal Power Station (CSTPS) units in Chandrapur, 150 km from Nagpur.

A comprehensive air pollution health impact modelling conducted by the Centre for Research on Energy and Clean Air (CREA) -- 'Health impacts of Chandrapur coal-based power plant, Maharashtra' -- estimates that the air pollution from the operation of units at Chandrapur Super Thermal Power Station (CSTPS) has resulted in 85 premature deaths in Chandrapur. 62 prema-

This independent assessment by CREA, which comes a little over a month after the National Green Tribunal (NGT) observed clear vi-

tory among other health illnesses which led to 34,000 sick leave days in Chandrapur and 30,000 days of absenteeism in Nagpur in 2020. This shows how the productivity of people from these two cities is being compromised due to the impact of thermal power plant emissions, said Sunil Dahiya, an analyst at CREA and one of the authors of the report.

The operation at CSTPS resulted in the emission of high pollutant load 4,724 tonnes of particulate matter emissions, 1,03,010 tons of sulphur dioxide (SO2), 28,417 tons of nitrogen dioxide (NO2) and 1,322 kgs of mercury in 2020.

The operation of the CSTPS in 2020 alone contributed to more than eight lakh sick leave days, approximately 1,900 asthma emergency room visits, of which over 800 were children, deaths of at least 1,300 people, and 1,800 preterm births across central India at 78 per cent PLF (Plant Load Factor -- the ratio of average power generated by the plant to the maximum power that could have been generated in a given time), according to the study.

New Delhi, March 3: The Supreme Court Thursday directed the Maharashtra government and the State Election Commission (SEC) not to act upon the interim report of Maharashtra State Backward Class Commission to reserve seats for Other Backward Classes (OBC) in the upcoming local bodies election.

A bench, headed by Justice AM Khanwilkar, said the election should be conducted without the OBC reservation. It also pulled up the Commission over its report, and de clined to accept its argument that there is sufficient data to reserve the seats. The bench, also comprising Justice CT Ravikumar, said, "Where is the logic? There is not even a single logic given."

As senior advocate Shekhar Naphade, representing the Maharashtra government, submitted that the Commission may be able to justify the recommendation to reserve the seats. the bench wondered did it rely on the same data, which looked contentious to the court earlier. The top court said it cannot allow the Maharashtra government to move with such an interim report. It declined to accept the Commission's recommendation to restore 27 per cent reservation for Backward 🦛 Other Classes (OBC) in the local body elections, noting that the re-

comply with an earlier Supreme Court direction, under which the Commission was required to conduct research before proposing any suggestions. The bench emphasised that the report filed by the Commission must stand the test of judicial scrutiny, and there should be more authentic data.

It said there is no date on the report and how it could know whether it was prepared with full understanding or not. If this is how a Commission will work, then we doubt the recommendations of the Commission.

Citing that report was not in compliance with its earlier order, the bench said, "We direct all the concerned not to act upon the recommendation." However, it permitted the Commission to continue with its exercise to study the empirical data local-body wise and submit its interim report.

# Protesting for 800 days, Amaravati farmers erupt in joy

Amaravati, March 3: Amaravati erupted in celebrations Thursday after Andhra Pradesh High Court pronounced its judgment on petitions challenging Jagan Mohan Reddy-led government's decision to create three state capitals. Raising slogans of 'Jai

Amaravati, farmers of the region burst crackers and distributed sweets to hail the court order.

Farmers and women, who have been agitating for over 800 days, welcomed the judgment as victory of truth and justice. A group of women bowed down to thank the judiciary



for upholding the justice.

Over 200 people have lost their lives in this protest due to a wrong decision by the government. At least now, the government should shed its arrogance and resume developing Amaravati as the only state capital, one of the women said.

Farmers said the court verdict has come as a big relief for them as they were losing hopes of getting justice. They demanded that the

Jagan Mohan Reddy government respect the court order and implement it without challenging it in the Supreme Court.

Prime Minister Narendra Modi laid foundation stone for Amaravati October 22, 2015. Then Chief Minister Chandrababu Naidu had grand plans to develop the capital.

With nine theme cities, and 27 townships, Amaravati on the banks of Krishna river was planned in an

area of 217 square km as a worldclass city.

After coming to power in 2019, Jagan Mohan Reddy declared that Amaravati, a Rs 2 lakh crore project, was not his priority.

Later, Jagan Mohan Reddy announced that Visakhapatnam will be developed as administrative capital and Kurnool as judicial capital while Amaravati will serve as only legislative capital.

This triggered massive protest from farmers in 29 villages of Amaravati, who had given 33,000 acres of land for the capital and were hoping to reap its economic benefits. The government's decision had shattered dreams of 24,000 farmers who had voluntarily given lands ranging from half-an-acre to 50 acres

For every acre of cultivable land the farmers were promised 1000 square yards of residential plot and 250 square yards of commercial plot with all the infrastructure. Almost all the farmers received the allotment papers but their dreams of owning developed plots remained on paper with the change of guard. They were also promised Rs 50,000 annuity per acre with an annual hike of 10 per cent.

On July 31, 2020, Governor Biswabhusan Harichandan signed the Andhra Pradesh Capital Region Development Authority (APCRDA) Repeal Bill 2020 and Andhra Pradesh Decentralisation and Inclusive Development of All Regions Bill 2020, paving the way for trifurcation of the state capital.

The repeal of the APCRDA, which was created for development of Amaravati as the state capital, had led to formation of the Amaravati Metropolitan Region Development Authority (AMRDA).

Several farmers moved the High Court challenging the two Bills on the ground that they were not passed in accordance ২ with the rules.

Even as more than 75 petitions were being heard by the high court, the government in November last vear repealed the two laws but made it clear that it has not gone -( back on its decision to develop three capitals.

NEW DELHI: Citing the academic journal Science, Congress leader P Chidambaram Thursday said the official number of deaths due to Covid-19 in the country is suspect. The reputed journal estimates that the Covid toll in India between "1-6-2020 and 1-7-2021 was 3,200,000 - eight times the official death toll of 400,000", Chidambaram said on Twitter. ### **'ENSURE NO VIAL OF** to help in evacuation of stranded students AGENCIES

Apex court asks AG

New Delhi, March 3: The Supreme Court Thursday asked Attorney General K K Venugopal to use his "good office" in helping evacuate some Indian medical students stranded in war-ravaged Ukraine near the Romania border

A bench headed by Chief Justice N V Ramana said earlier in the day, when the plea was mentioned for urgent hearing, it sympathised with the stranded students and asked can the court direct the head of the state to stop the war.

"Please tell us what can the court do? Can we direct the President (of Russia) to stop the war," said the bench, also comprising Justices AS Bopanna and Hima Kohli, and asked the counsel for petitioner Fathima Ahana who is stranded in Ukraine to wait inside the courtroom till the time Venugopal appears in court.

The bench took note of the submissions of Ahana's lawyer that several students are stuck near the Romanian border in freezing cold and the government is not running flights from Romania.

There are 1,000 students like this. But some have come here. We cannot say 'no'. Please use your good offices and do something," the bench told Venugopal, who, in turn, apprised that the Prime Minister has sent one minister to Romania. Venugopal said the Prime Minister has also talked to the Presidents of Russia and Ukraine



"Flights are being operated from Poland and Hungary and not from Romania. The students, who also include many girls, are stuck without any facility," the lawyer told the bench. "We have all sympathies with them. But what can the court do," the bench said.

It, however, asked the top law officer to consider extending help to the stranded students. Venugopal asked whether students have crossed the Ukraine border and entered Romania. Senior advocate A M Dar, appearing for the student, said that they are still in Ukraine and have not crossed over to Romania.

In the plea, filed through lawyer Abhay Anand Jena, Ahana has sought a direction to the Ministry of External Affairs to secure permission for her and other stranded students to cross the check point in Moldova from Ukraine enroute to Romania for boarding the Air India evacuation flight.

Lucknow, March 3: The seventh and final phase of Assembly elections in Uttar Pradesh has 28 per cent criminal candidates.

New Delhi, March 3: Under 'Operation Ganga', the Indian Air Force has avoided the Pakistan airspace to bring back stranded Indian nationals from countries bordering Ukraine as the war entered eighth day. The Indian Air Force till Thursday brought 798 citizens from Hungary, Poland and Romania.

The force had sent four C-17 transport aircraft on Wednesday to bring back the Indian nationals who had

crossed the Ukraine border.

All four transport aircraft returned with the 798 citizens to the Hindon airbase in Uttar Pradesh's Ghaziabad bordering Delhi on Thursday early morning.

The force has also sent three more aircraft to bring another lot of stranded citizens. The Air Force was called in to augment the commercial flights.

About avoiding the Pakistan airspace, a military source said that the decision was taken by the gov-



ernment not to take any military favour from Islamabad. What it costs is an additional around 30 minutes of travel.

"To fly military aircraft from any nation's airspace, there is a requirement of various permissions from that country so it was decided to avoid it," source said.

The same aircraft was used to evacuate Indian nationals from Afghanistan after the Taliban took over in August last year. Under Operation Ganga, India has sent 15 aircraft, both commercial and military, till Wednesday. A total 15 more aircraft are also scheduled to land in India on Thursday

### Constable shoots self

Chennai: A 26-year-old Constable with the Central Industrial Security Force (CISF) shot himself dead at the rest room at the Chennai International Airport Thursday. The deceased constable, Yashpal was a native of Rajasthan and police on preliminary inquiry said that it was a case of suicide and that the actual reason for his death was not known. Police said that Yashpal fired from his Self-Loading Rifle (SLR) on his forehead and died on the spot. He was on duty at the departure terminal. He had ioined the CISF service in 2017.

New Delhi/New York, March 3: A whopping 93 per cent of Indians live in areas where air pollution levels exceed WHO standards, according to a global report.

The report revealed that life expectancy in India, as a result, has been shortened by about 1.5 years.

The findings by Health Effects Institute (HEI) in Washington, US, is part of its annual State of Global Air annual analysis for 2020. The study showed that with an

average annual population-weighted PM2.5 of 83 microgram/ cubic metre (mg/cu) in 2019, as many as 9,79,700 deaths in India can be attributed to PM 2.5.

It showed that almost 100 per cent of the world's population lived in areas where the PM2.5 levels

exceeded WHO recommendations - which is average annual PM2.5 exposure levels of 5 mg/cu.

Paniouk left his wife and daughter behind in Ukraine in 1996 when he moved to Buenos Aires. Eight years later, in 2004, his family was able to settle in the South American country with him. There are now some 450,000 Ukrainians living in Argentina.

They, along with others in the Ukrainian diasporas worldwide, have taken to the streets to protest against the war, which marks the most serious confrontation on European soil since World War Two and has roiled global markets and energy prices.

Both said that they felt fear about what was happening to relatives back in Ukraine, with the anxiety keeping them awake some nights glued to news channels to see what is happening. "It's like will I see my mom again? Will I see my brother?" Paniouk said at the couple's home in Buenos Aires.

Paniouk last visited Ukraine five years ago, but plans to travel back in 2020 were scuppered by the COVID-19 pandemic.

HONG KONG: Russia is destroy ing what China is trying to build. Having refused to condemn President Vladimir Putin's invasion of Ukraine and suppressed domestic criticism of Russia, Beijing is alienating many eastern European countries where it is constructing trade, investment and technology relationships under its ambitious Belt and Road Initiative.

Ukraine is strategically positioned across rail, road and energy pipelines linking Russia to the rest of Europe. Since it joined President Xi Jinping's signature infrastructure policy in 2017, Chinese companies have been upgrading the country's ports and subways. And in 2020 Kyiv signed a memorandum of understanding with telecoms giant Huawei Technologies, which the United States has been trying to drive out of worldwide networks. With a population of 44 to Europe in 2021, million, Ukraine provides an atis likely to tractive market for companies such slow. as smartphone maker Xiaomi (1810.HK), and it is an important source of agricultural produce. China bought 30% of its corn imports from Ukraine in 2021.

With Russian army convoys advancing toward Kyiv, Beijing is stuck watching missiles wreck a country once receptive to its overtures. The attacks are galvanizing pan-European sentiment against China, which refuses to call Russia's move an invasion. As the West and Moscow make it harder for private companies to transact, the flow of goods along the "Iron Silk Road," a rail system across which \$75 billion of Chinese products travelled

Another casualty of war might be China's relationship with Poland, which has been trying to strike its own balance between Beijing and Washington.

Poland is a major rail node on the Belt and Road and hosts Huawei's regional headquarters. Having experienced tribulations under Russian dominance, it is now being swamped by Ukrainian refugees who blame China for supporting Putin. Former Soviet satellites are aligning more closely with NATO and the European Union, further undermining Beijing's strategy in the region. China's investment in the EU

was already cooling. Its M&A deals there dipped to 6.5 billion euros in 2020, a 10-year low. Having miscalculated by openly backing Putin, Beijing is now trying to hedge that position. Unless it can orchestrate peace, however, the diplomatic and commercial damage will be hard to repair.

Mohali, March 3: Hailed by many as the 'Last of the Mohicans' in cricket's purest format, Virat Kohli will be focussed on making his 100th appearance memorable while "white-ball legend" Rohit Sharma plots the demolition of an out-ofdepth Sri Lanka as India's 35th Test captain in the series-opener starting here Friday.

If one looks back at Indian team's journey since its inception in international cricket back in 1932, it has been about stars, superstars, and megastars, who become the reason for the footfall at turnstiles of various stadiums across the country.

It was the case when Sunil Gavaskar scored his 10,000th run, Sachin Tendulkar bade the most emotional farewell that cricket has ever seen and now the spotlight will be firmly on Kohli, whose domineering presence has turned an international match into a footnote.

Kohli is one among "them" and in a fast-paced world, perhaps the last cricket star who will enjoy an organic following of manic fans.

India was, is and will remain more of a "cricketer-loving" nation and the social media war-cry that perhaps led to fans being allowed in the stadium from Friday is a testimony to Kohli's immense popularity.

This is his 'Test' and for Kohli, a century to mark a 'century' is something he would be craving, having missed that sense of accomplishment that comes with a three-figure mark for over two years now.

A bowling attack that has the likes of Suranga Lakmal, Lahiru Kumara or Lasith Embuldeniya is perfect for a sumptuous 'five course' Kohli treat with cover drives, on drives, flicks and pulls on the menu. Gavaskar and Tendulkar couldn't, neither could a Virender Sehwag, Rahul Dravid or VVS Laxman but Kohli is a different beast.

The empty amphitheatre was

never meant for him. He feeds off the energy from his fans, and as the undisputed hero of his story, he always finds an antagonist, he is trying to slay.

He is a product of the modern day, who loves the spotlight and the spotlight has always loved him back.

However, every story has its own set of sub texts and this Test match is as much as a Kohli story as it is about Rohit and his remarkable ascendancy making light of set ideas and templates.

They say, 'A good Captain, who is a good captain, is a good captain'. Everyone knows Roht's credentials in white-ball cricket especially IPL, where he has even challenged the hegemony of the peerless MS Dhoni.

There is no reference frame to judge how good he will be in a game that's played over five days for six hours. He is 34 and will surely not be playing white ball cricket for more than three years at a stretch with a demanding calendar.

How he handles a transition phase in Indian cricket, which has started with curtains on careers of Cheteshwar Pujara, Ajinkya Rahane and Ishant Sharma. Will have a huge impact on how he is perceived – just a mere captain or a leader of men.

Does he have it in him to control the ebbs and flows of a Test match where a session changes the complexion or a long partnership can induce frustration? The proof of the pudding as they say lies in eating and one can only wait to see how he responds to the entirely different dynamics of five-day cricket as captain.

The about-face came less than 24 hours after the International Paralympic Committee announced it would allow Russians and Belarusians to compete when the Games open on Friday, but only as neutral athletes with colors, flags and other national symbols removed because of the invasion of Ukraine.

The Paralympics in Beijing, which follow the Winter Olympics, close March 13. "The war has now come to these Games and behind the scenes many governments are having an influence on our cherished event," IPC President Andrew Parsons said Thursday after announcing the ban. "We were trying tinderbox. And it was not only Ukrainians resenting the Russian and Belarusian participation, but across the board. "It was a very, very volatile environment in the (Athletes) Village. We did not think that entire delegations, or even teams within delegations, will withdraw, will boycott, will not participate."

The first instance came when Latvia said its curlers would refuse to play against the Russians in a scheduled group game. Parsons said he expects legal action from the Russian and Belarusian Paralympic committees, which is what he said he feared Wednesday when he ruled their athletes could compete.

Mount Maunganui, March 3: Mithali Raj will be eager to get her hands on a maiden title in what would be her last hurrah for India at the world stage, Heather Knight will hope to defend it while Meg Lanning seems primed to lead Australia to a 'Magnificent Seventh' when the ICC Women's World Cup gets underway here Friday.

The tournament, which was postponed by a year due to the COVID-19 pandemic, will be played across six venues with the ICC deciding that teams will stay in a 'managed environment' instead of stringent bio-bubbles.

The marquee event will be played in the league format, where all eight teams will face each other once with the top four sides qualifying for the semifinals.

India, who were runners-up in the last edition and in 2005, open their campaign against arch-rivals Pakistan, while hosts New



Zealand, who won the title in 2000, will take on West Indies in the tournament opener. Australia, the most successful side with six titles, will meet defending champions England, who have been crowned champions four times.

The month-long event will see young stars and veterans

come together. While the likes of Mithali, Jhulan Goswami, Suzie Bates and Megan Schutt will look to add to their already glittering legacies, teenagers including Shafali Verma, Richa Ghosh, Fran Jones and Darcie Brown will be eager to make one.

### Here's a look at the eight contenders:

**AUSTRALIA:** Hurt by the shock semifinal loss to India in 2017, sixtime champions Australia have left no stone unturned in their quest for an unprecedented seventh title. Such has been Australia's dominance in the past four years in the 50-over format that the Southern stars have lost just one ODI in their last 30 games.

INDIA: Runners up in the last edition, India will be keen to go one step ahead and claim the title that has eluded them, specially skipper Mithali and veteran pacer Jhulan Goswami, who will be playing their last World Cup.

**ENGLAND:** The defending champions and the second most successful team in the history of the tournament, England will be eager to retain their crown. Despite the recent Ashes white-wash, England has been one of the most successful sides in women's ODIs since the end of the last World Cup.

**NEW ZEALAND:** Last time the tournament was held in New Zealand 22 years ago, the White Ferns won their maiden and only title. The hosts will look to repeat the feat and they have had the perfect lead up to the tournament. **SOUTH AFRICA:** Riding high on confidence owing to series victories over West Indies, Pakistan and India, South Africa will aim to ride the momentum in search of their maiden World Cup title. The team have enough depth and talent in

their squad to go all the way. WEST INDIES: West Indies qualified for the tournament owing to their ODI rankings after the Qualifiers was cancelled mid-way last year due to COVID-19. The runnersup finish in 2013 was their best ever performance. They have a blend of youth and experience in their side. PAKISTAN: Pakistan have competed in four World Cups, finishing at the bottom in three of them. Their best result was a fifth place finish in the 2009 edition. Pakistan captain Bismah Maroof, who returns from maternity break, hopes to lead her side to the semifinals. BANGLADESH: Bangladesh will play in the tournament for the first time, having qualified on the basis of their ODI rankings. They will hope to leave an impression in
