Hinjilicut, March 23: Four persons including three siblings and their minor cousin were killed late Tuesday night following a group clash over passing of comments at Pitala Square under this police limits in Ganjam district. The victims were identified as Raja Swain, 28, Shambhu Swain, 25, Pandav Swain, 23, all sons of Mangulu Swain in Narendrapur village and their minor cousin Chandan Swain, 16 of Baulaghai village. Another person, Amiya Swain alias Sadhu suffered grievous injuries and is cur-

Ganjam District Collector Vijaya Amruta Kulange and SP Brijesh Kumar Roy visited the Hinjili police station and took stock of the situation. They also met the bereaved family members of the deceased. Kulange termed the incident 'unfortunate' and assured government assistance to the families of the victims.

Police have detained three persons from the other group involved in the clash. They are being interrogated. Police have also seized the wooden planks and iron bars allegedly used during the fight. Preliminary inquiries indicated that the incident occurred over passing of objectionable comments, the SP said.

Sources said Raja, the eldest among the three siblings and his cousin were running a food stall at Pital Square. Shambhu, a student assisted his brother in running the stall while Pandav was into another business. They were preparing to close shop and leave for home at around 11.30pm when some members of the rival group passed some objectionable comments.

Things then turned ugly and both sides were involved in a free for all using wooden planks and iron rods. Such was the intensity of the fight that all the four deceased and another person from the other group collapsed in a pool of blood after sustaining injuries.

Police reached the spot and rushed all the injured to Hinjilicut Hospital where doctors pronounced the three siblings and their minor cousin dead on arrival.

Petrol in Delhi will now cost ₹97.01 per litre as against ₹96.21 previously while the diesel rate has gone up from ₹87.47 per litre to ₹88.27, according to a price notification of state fuel retailers.

Rates differ from state to state depending on the incidence of local taxes. In the Odisha capital, petrol will now cost ₹103.51 per litre, an increase of 77 paise over the price of ₹102.74 registered Tuesday.

New Delhi, March 23: Even though the probe is on regarding the misfiring of the Brahmos supersonic cruise missile that landed inside Pakistan territory March 9, sources said Wednesday that a Group Captain-rank officer of the Indian Air Force is 'blameworthy' for the incident. As per a report in the *Hindustan Times* website, the probe is being conducted by an Air Vice-Marshal of the IAF.

The report states that the officer was in-charge of the mobile command post of the missile system when the accidental firing happened during a Command Air Staff Inspection (CASI) at its home base. However, all the final details will be available only after the probe is completed in a time-bound manner. The sources said the AVM probing the incident is highly qualified and is in-



charge of operations in the Air Force headquarters.

The incident had sparked of tension between both India and Pakistan with the latter threatening to retort. Pakistan has demanded a joint probe by both the countries into the missile misfire, but it has been turned down by India. Pakistan had also claimed that the missile flew through flight routes and could have caused grave danger to aircraft flying on the same path.

Defence Minister Rajnath Singh had stated March 15 in Parliament that a highlevel probe has been ordered into the incident involving the accidental launch of a missile. India was also very quick to issue an apology to its neighbour regarding the misfiring of the missile.

Norms laid down for care of kids of jailed parents

Bhubaneswar, March 23: The state government Wednesday laid down a set of guidelines for care and protection of children living inside prisons with their parents or those living outside while their parents have been in jails.

The Women and Child Development Department (WCD), in its guidelines, specified that children between the age group of 0-6 years, staying inside the jail with his/her mother, will avail the benefits of Integrated Child Development Scheme (ICDS).

Similarly, children of incarcer ated parents staying outside the jail and declared as Children Need of Care and Protection (CNCP) by the Child Welfare Committee (CWC) will also be eligible for the same.

"The Collectors will identify one nodal Anganwadi Centre (ÅWC) for extension of the ICDS service to a prison. In case of multiple children housed in a single prison, a temporary AWC will be set up as per the jail manual. Such children shall be provided with supplementary nutrition and immunisation facilities under the ICDS, said the guidelines. "Children on attaining the age of 6 may be placed with guardian/remaining parent with the consent of the mother. Otherwise, the child may be produced before the nearest CWC for rehabilitation," it added. Similarly, children residing outside jails will be produced before the nearest/concerned CWC. If they are declared as CNCP. the children will be covered under different institutional and non- institutional care mechanisms available in the state. However, under non-institutional care the child in need shall be linked to different schemes available in the state, including sponsorship, Biju Sishu Surakhya Yojana (BSSY) and foster care or any other scheme in force to continue to live in a family/community based care. Meanwhile the department also instructed the district/circle jail administration to provide quarterly information like number of children, gender, age and others to the authorities concerned to avail benefits under ICDS.

New York, March 23: Evidence is mounting to show that organ donation from dying donors testing positive for SARS-CoV-2 appears to be safe and does not cause Covid-19 in the patient receiving the donated organ, according to a study.

The Covid pandemic exacerbated the shortage of abdominal organs for donation by increasing organ discard rates, due to the unclear risks of using organs from Covid-19 infected donors.

A team from Duke University in the US analysed six abdominal organ transplants performed (2 livers, 2 kidneys/pancreas transplanted together) in four recipients using organs procured from four donors who tested positive for Covid and died.

The donor evaluation protocol included additional review of organ quality, with all four donors undergoing macroscopic and/or mi-



croscopic biopsy review to confirm organ suitability.

Donors were assessed by considering organ type, the duration and severity of Covid-19 illness, whether any signs of hypercoagulable disease were present (meaning potentially increased clotting in the donated organ or vessels) as well as careful overall inspection at the time of organ procurement.

Further, if the organ to be donated was lung or intestine, it would only be considered if the donor last tested positive for Covid more than 20 days ago, a timeline consistent with infection control practices of the US Centers for Disease Control and Prevention (CDC)

And if the virus was found in the base of the lungs, the lungs were deemed unsuitable for transplan-

Donors were assessed by considering organ type, the duration and severity of Covid-19 illness, whether any signs of hypercoagulable disease were present. as well as careful overall inspection at the time of organ procurement

tation, but other organs could still be transplanted safely, provided the donor was not dying from severe hyperinflammatory Covid-19 or showed signs of excessive clotting, the team explained.

Even after passing through all these barriers, doctors must still consider the ultimate cause of death for a donor and weigh up whether that is likely to negatively impact organ quality and/or surgical risk, they said.

Further, to reduce the transplant risk, recipients are now strongly encouraged to be fully Covid-19 vaccinated prior to surgery.

"Being unvaccinated can increase the risk of severe Covid-19 in transplanted patients due to their immunosuppression drugs post-transplant. For that reason, we strongly encourage our patients on the waiting list to get vaccinated. However, being unvaccinated does not take someone off the organ transplant waiting list at our institution at this time," said Dr Emily Eichenberger from the University's School of Medicine.

While a vaccinated donor is also desirable, as it likely reduces the risk of severe organ inflammation, unknown or negative donor vaccine status would not preclude the use of otherwise good quality organs from Covid-19 infected donors.

"While limited, our experience to date supports the use of abdominal organs from Covid-19 positive donors as safe and effective, 🛁 even those actively infected, or with lung disease caused by Covid-19," Eichenberger said.

The research will be presented at this year's European Congress of Clinical Microbiology and Infectious Diseases to be held in Lisbon in April.

Mandi, March 23: Researchers at the Indian Institute of Technology (IIT) Mandi have developed a method that can transform plastic into hydrogen when exposed to light. The generation of hydrogen from plastics is particularly useful because the gas is considered the most practical non-polluting fuel of the future.

Plastics, most of which are derived from petroleum, are not biodegradable, i.e., they cannot be easily broken down into harmless products. It is said most of the 4.9 billion tonnes of plastics ever produced would end up in landfills, threatening human health and the environment.

Fuelled by the need to prevent runaway plastic pollution, IIT-

The findings from this work have been recently published in the Journal of Environmental Chemical Engineering. The research was led by Prem Fexil Siril, Professor, School of Basic Sciences, IIT-Mandi, and Aditi Halder, Associate Professor, School of Basic Sciences, IIT-Mandi, and co-authored by their Ph.D. scholars, Rituporn Gogoi, Astha Singh, Vedasree Moutam, Lalita Sharma and Kajal Sharma.

The researchers have developed a catalyst that can efficiently convert plastics into hydrogen and other useful chemicals when exposed to light.

The IIT-Mandi photocatalyst combines iron oxide in the form of nanoparticles (particles a hundred thousand times smaller than the diameter of a single hair strand), with a conducting polymer -polypyrrole.

The researchers found that combining iron oxide nanoparticles with pyrrole resulted in the formation of a semiconductor-semiconductor heterojunction, which in turn results in strong visible-lightinduced photocatalytic activity.

Elephant found dead in Sonepur

In the last three months, the sanctuary has lost three female elephants. The repeated casualties of the elephants have left the forest department worried.

5-yr jail for raping visually impaired

Kendrapara: A court here Wednesday sentenced a 45year-old man to five years of imprisonment for raping a visually impaired woman on the pretext of a false promise of marriage in Kendrapara district. Additional district and sessions judge Tribikram Keshari Chinhara also imposed a fine of ₹5,000 on the convict. The 23-year-old woman had lodged an FIR at the Nikirai police station June 26, 2015, alleging that the man had a physical relationship with her after promising to marry her. When the woman started pressurising him to tie the knot, the man told her that he was already married and warned her not to reveal anything to her family. After noticing physical changes in the woman, her family members took her to a hospital, where it was confirmed that she was six months pregnant, according to the prosecution. The accused was subsequently arrested and the woman delivered a baby boy in 2016, prosecution counsel Sanjay Jena said.

Bhitarkanika: Green boat to ferry tourists

THE POLLUTION-FREE STATE-OF-THE-ART BOAT **PROCURED AT A COST OF ₹23 LAKH. CAN CARRY EIGHT PEOPLE AT A TIME**

Kendrapara, March 23: A batteryoperated and soundless boat has been thrown open for tourists at the Bhitarkanika National Park in Kendrapara district, a forest official said.

The move was welcomed by an environmentalist, who elucidated that the sound of mechanised boats disturbs the serenity of the place, and distracts the saltwater crocodiles and other wild animals.

Tourists can make use of the paid services of the eco-friendly boat, which will make continuous trips in the water bodies of the country's secondlargest mangrove ecosystem. The pollution-free state-of-the-art boat, was procured at the cost of ₹23 lakh. It can carry eight people, according to the official

"We'll use this boat on an experimental basis for two months, following which more such boats would be purchased," Divisional Forest Officer, JD Pati said

The Forest Department had introduced solar-powered three-wheelers in the park earlier for tourists to move around. Green activist Hemant Rout said it was high time that the authorities motivated private boat operators to use noiseless boats in the water bodies of the sanctuary.

The mechanised boats should be

withdrawn in a phased manner, Rout added. The wildlife sanctuary, which is essentially a network of creeks and canals, is home to the largest congregation of the endangered saltwater crocodiles in the country, according to Odisha Tourism.

The Gahirmatha beach, which forms the boundary of the sanctuary in the east, is the largest colony of the Olive Ridley turtles, according to its website.

It is when the rule-makers disagree that the greatest risks arise. The Ukraine war - the first conflict of the post-Cold War period that pits great powers against each other - is a case in point. On one side, Russia has been carrying out a brutal conventional military assault on Ukraine, in an apparent effort to bring the country - which Russian President Vladimir Putin believes is rightly part of his country - back into the Kremlin fold. On the other side, NATO, led by the United States, has been waging a comprehensive hybrid war against Russia

The West's war has included the supply of huge quantities of weapons to Ukrainian forces: US President Joe Biden alone has authorised the transfer of \$1.35 billion worth of lethal weapons since the war began, with much more to come. The West has also implemented ever-escalating economic and financial sanctions, virtually expelling Russia from the Western-led financial order and sequestering the assets of many wealthy Russians. And it has sought to shape international opinion, with many countries now blocking access to Russian state media.

For all the talk of a rules-based order, the world's rule-makers have reverted unhesitatingly to unilateralism. The risks are legion. The flood of weapons the West is sending to Ukraine - a country with a long history of weak governance and widespread corruption - could eventually flow westward, fueling organised crime, narcotics trafficking, and terrorist violence across Europe. And the Iron Curtain's revival may hasten the emergence of a militarily robust, neo-imperial Russia. Putin, who has called the Soviet Union's collapse a 'tragedy' and the end of 'historical Russia,' has indicated that Kazakhstan, like Ukraine, is not a country.

And it is not just Russia that will become isolated. The Ukraine war could trigger the unraveling of decades of broader

global economic engagement, long viewed as a key deterrent against great-power conflict.

Of course, the notion that countries would rather trade than invade has never been unassailable. Economic interdependence has not stopped China, for example, from engaging in relentless expansionism, from the South and East China Seas to the Himalayas.

Even today, however, economic interdependence has forced rule-makers to exercise some restraint. Despite the raft of financial and economic sanctions it has imposed on Russia, Europe continues to support the Russian economy's mainstay: oil and gas exports. This undermines the West's own mission, especially as the confrontation drives up energy prices. But Europe's longstanding dependence on Russian energy supplies has left it with no good alternatives - at least for now.

Such a tradeoff may not arise in the future. The European Union has already vowed to eliminate its dependence on Russian energy by 2030. At the same time, countries that want to uphold trade ties with Russia are seeking solutions outside Western-controlled channels. For example, India is buying Russian oil with rupees. Similar moves elsewhere - for

example, Saudi Arabia is considering renminbi-based oil sales to China threaten to erode the US dollar's global supremacy.

This is probably the beginning of a broader bifurcation of the global economy. At a time when economic power has shifted eastward but the West still controls the world's financial architecture – including the main inter-

THE SILENT PANDEMIC

ndia ushers in World Tuberculosis Day in 2022 with mixed feelings. As the COVID pandemic (hopefully) wanes, how are we seeing the other major infection that has silently and surely continued to wreak havon on the lives of millions of Indians, year after year? TB is our silent pandemic; away from the headlines, it rages on.

The early months of the pandemic saw much discussion around COVID leading to a drop in identification of new TB infection, and growing malnutrition, both of which are associated with a risk of increasing the burden of TB. It is estimated that this decline in access to services and an increase in malnutrition will lead to almost 0.1 million additional deaths due to TB in the coming years. TB is identified as one of India's major public health problems. Around 1.8 million people developed TB in India, according to the Union Health Ministry's India TB Report 2021. And over 0.4 million died due to TB in India in 2020, according to the World Health Organisation. Globally, India accounted for 26% of the new cases, and over 34% of the deaths due to TB.

For patients suffering from TB in large parts of rural India, the Primary Health Centres are by far the most accessible health facilities. Yet the PHCs take care of only a small proportion of the overall burden of TB. Many are understaffed, and many lack essential diagnostic capabilities. Despite these shortcomings, the PHCs can play a larger role if they are geared to build trust. This requires a greater attention to the patients, thorough examination, respectful behaviour, and kind words. Alongside, strengthening PHCs in general, and equipping them to diagnose and manage patients with $\overline{T}B$ in particular, will go a long way in promoting access and helping patients navigate what today are largely unresponsive health systems. **Enhance diagnostics**

Guidelines from the Indian government call for evaluation of all those with coughs for two weeks or more, for TB. This guidance has emerged from decades of careful attention and its importance cannot be overstated. We have seen many healthy-looking patients diagnosed with TB, only because as per the recommendations, the sputum test was performed. On the ground, we often see patients being denied these tests, for reasons that the

patient "does not look tubercular," or "looks healthy." Many such patients subsequently go back home, to return after a few weeks or months with severe disease.

It is thus essential to adhere to the guidance for testing for TB, however healthy or well the patient may appear. Major constraints in diagnosing TB are the availability of chest radiography, sputum testing and cartridge-based nucleic acid amplification test (CBNAAT), close enough and easily enough. Patients with suspected TB continue to make several trips to different places and spend enormous amounts of money and time to be able to get

themselves tested. In the absence of easy availability, many private practitioners start treatment without the necessary tests, and many public providers delay the management of the disease. The patients suffer, and also transmit the infection to others during this time. There is a need to urgently expand the diagnostic capabilities, specifically x-ray machines, sputum microscopic testing, and CBNAAT machines. We would need to ensure that x-ray machines are available close enough and affordable. For much of rural India, this would mean that we need to have x-ray diagnostic facilities at PHCs.

While the last decade has seen many advances in the tests for TB making it easier to detect TB as well as identify drug resistance, the process for collecting the sputum sample has remained unchanged The onus for sample collection still rests with the patient, who may have to travel a few kms (such as when visiting a PHC), or even

50 kms or more (to the CHC or district hospital, for tests such as the CBNAAT). Sometimes even after making this arduous journev the test is denied as the sample collection for the day may be complete, or the technician is away, or the cartridges are finished, or the machine is out of order. With a lot of resources diverted towards COVID, and the laboratory technicians busy with COVID testing, such denials are now seen even more often. No wonder then that several patients drop out after this contact.

A simple solution to this problem is to transport the sample itself: the patients can deposit their sputum sample at the PHC, from where the PHC staff can transport it to the diagnostic facility. There is strong evidence that such transport of sputum samples helps significantly in improving the detection with much convenience. We need to expand the active transport of sputum urgently.

Improve living conditions of migrants

TB is an infectious as well as a social disease. Its close relationship with determinants including livelihood, nutrition, gender, and culture, influence who will develop the disease as well as the severity thereof. The relationship between TB, informal work and labour-migration is a case in point. South Rajasthan, where we work as physicians, is a rain scarce and food scarce region - malnutrition levels among children and adults are high, and many young men migrate to cities for employment. Poor nutrition levels, exposure to hazardous work, such as stone carving and mining; and living

in overcrowded conditions while in cities, lead to high levels of tuberculosis among the migrant workers. Once infected, the disease also transmits to the family members. The deadly combination affects young men the most leading to reduced work capacity, loss of work, worsening disease, and finally death. Many also contract silicosis.

Treatment and recovery from TB will be incomplete if the determinants are also not addressed. The Poshan scheme of the TB programme provides cash transfers towards nutrition and is a welcome move. However, the amount is inadequate for a nutritious diet and the scheme is also fraught with delays and omissions. Ensuring a nutritious diet will re quire cash transfers, nutritious food through the PDS, and meas ures such as promoting farming and poultry, especially in highmigration areas. Efforts will also be needed to influence deep-rooted practices and customs related to nutrition, such as not consuming eggs and animal products (espe cially among women), and stopping all sour foods and ghee/oil once the treatment has begun. It is imperative to make the workspaces safer, and reduce or ameliorate the risk of lung damage and development of irreversible conditions such as silicosis.

Impacting TB across its lifecycle

These steps have the potential to influence the disease and outcomes at the different steps in the lifecycle of the disease: by increasing linkages with public health systems, higher case de tections, and improving treatment outcomes among those diagnosed with TB.

The last decade has seen several new initiatives introduced in the national programme for TB: an addition of new tests, a cash transfer towards nutrition, and a promise of newer drugs with the potential to reduce the treatment duration significantly. However, unless the foundation of the programme is made strong, the newer measures may offer little advantage and we may end up well short of the desired impact. We must remember that even today, 1200 persons die of TB in India each day

national payments system, the primary currencies for trade and financial flows, and the leading credit-ratings agencies - the establishment of parallel arrangements seems imminent.

China, which dwarfs Russia in terms of both economic power and military spending, will likely lead this process. In fact, China is set to emerge as the real winner of the NATO-Russia conflict. An overstretched America's renewed preoccupation with European security will create strategic space for China to press its strategic objectives - its leaders have been as clear about absorbing Taiwan as Putin was about claiming Ukraine - and bolster its global influence, at the expense of the US.

Chinese global dominance would amount to the final nail in the coffin of the rules-based order. Since its establishment in 1949, the People's Republic has displayed blatant contempt for international law, more than doubling its land mass by annexing Xinjiang and Tibet and currently detaining over a million Muslims. Yet China has paid no tangible price. The Kremlin, for its part, probably did not think twice about rejecting the International Court of Justice order to suspend its military operations in Ukraine.

International law may be powerful against the powerless, but it is pow erless against the powerful. The League of Nations, created after World War I, failed because it could not deter important powers from flouting international law. Its beleaguered successor, the United Nations, may be facing a similar reckoning. How can the UN Security Council fulfill its mandate of upholding international peace and stability if its five veto-wielding permanent members are arrayed into two opposing camps? The world is headed for an era of greater upheaval. However it plays out, the pretense of a shared commitment to international law will be the first casualty.

ne morning I discovered still pending.

In a separate incident, my wife had sent an e-mail to the customer support team of a reputed air-conditioner brand for servicing the AC due to the onset of summer. There was a prompt auto-email response saying that the technician will contact within next 24 hours and attend the call. But 72 hours gone, still waiting for the call.

In both the above cases the wait is much longer than what it should have been. The experience is frustrating, annoying and stressful.

Will the modern-day customer be willing to provide the firms such luxury of time to get their act right for such 'routine requirements'?

Customers are changing and they expect companies to change faster. They want the service providers to recalibrate their responses to up the ante. There is zero patience and zero tolerance to such non-value-added activities.

Even two days wait is unrealistic for today's urban and time-constrained customers. Gen Z & millennials seek insta-action, results and closures or else they will just walk-out without even complaining, never to return. Consumers nowadays demand more than just value or convenience; they expect that there will be no shortfalls either in their expectations and actual experience, especially while fulfilling their transactional demands.

The service or delivery models need to be aligned to cater to such T-20 mindset devoid of the traditional "wait and see" approach. The implications of such changing preferences are profound on the brands. Companies or brands neglecting this aspect of customer service will soon find themselves languishing behind the curve without any early warnings. The shift will be sudden and swift with no time to recover lost ground. There

are brands that have already noticed this and are aggressively working towards zero waiting - be it in deliveries, resolution or repairs. This calls for evolving the entire ecosystem comprising of multiple stakeholders like employees, partners or service agents through training, IT infrastructure, logistics & Artificial Intelligence. The margin of error in meeting such consumer expectations is shrinking towards 'zero'

Fuel shock is back

Sir, This refers to 'Fuel back to singe again,' Orissa POST March 23. It was expected any day, and it has come. Petrol and diesel prices have been increased between 80 paise and Re 1 across the country while LPG cooking gas price has been hiked by about ₹50 a cylinder. The Union government had held the hand of the oil companies to buy goodwill before the Assembly elections in February and March. The polls are now over, and the gloves are off. Also, more hikes are in the pipeline as oil companies scurry to match retail prices with the shooting costs of crude oil. Bulk diesel prices have in fact been raised by as much as ₹25-28 a litre above pump prices. This is likely to fuel inflation as big consumers such as the Railways and factories pass on the hit to small consumers. Meanwhile, oil industry watchers warn that for every \$1 rise in crude prices, petrol and diesel prices are jacked up by 50 paise a litre. This means fuel prices may go up by ₹20 per litre in the coming days to match the crude backlog. These are ominous clouds for the poor man's purse and the government will have to take proactive measures to soften the blows. But, the total incidence of central taxes and local VAT on retail petrol prices is currently around 50 per cent and that on diesel 40 per cent. While the government has little hold over international crude prices, a recalibration of the tax regime on fuel could provide some respite.

Govt starts process to amend IPC, CrPC 11 Bihar workers charred to death

Hyderabad, March 23: Eleven migrant workers from Bihar were charred to death in a huge fire that broke out at a scrap godown in Secunderabad here early Wednesday, police said.

The incident occurred in the godown in IDH Colony of Bhoiguda area in Secunderabad around 4 a.m.

Police said one person managed to jump out of the fire and he was rushed to Gandhi Hospital. Others trapped in the fire due to heavy smoke were burnt alive. All the victims were migrant workers from Chapra district Bihar and were asleep when the fire broke out. Barring one, the rest were between 23 and 35 years of age.

The fire was doused with the help of five fire tenders which rushed to the scene from different areas. Short circuit is suspected to have caused the fire.

Hyderabad Police Commissioner CV Anand said the workers were asleep in rooms on the first while scrap material including plastic, newspapers and other scrap items were stored on the ground floor. Someone alerted the police after a A police officer said the fire broke out around 4 am when around 13 workers were asleep on the upper floor of the warehouse in the densely populated residential colony

gas cylinder exploded due to the fire. The bodies were shifted to Gandhi Hospital. Hospital authorities said bodies of 10 deceased were charred beyond recognition.

Gandhi Hospital superintendent Dr Raja Rao said four teams were constituted for autopsy. "We have to do DNA tests to identify the bodies and after completing the procedure we will hand over the remains to their families," he said.

Police said the negligence by the timber depot owner and violation of safety rules led to the incident. Chief Minister K Chandrasekhar Rao has expressed shock over the fire accident and mourned the death of Bihar workers. He announced an ex-gratia of Rs 5 lakh each for the families of those who died in the fire.

4 kids die after eating poisonous toffees Dhami sworn in

New Delhi, March 23: Covid has significantly reversed the gains made in tuberculosis (TB) control and has led to an increase of about 25-30 per cent patients, particularly young adults, said experts on Wednesday ahead of World Tuberculosis Day.

March 24 is globally observed as World Tuberculosis Day every year to raise awareness about the disease that is curable but affects approximately 4.1 million people across the world, according to the World Health Organisation (WHO). India contributes to 27 per cent

of the global TB burden. It is estimated that over 35-50 crore people in India have TB infection and over 26 lakh people develop TB annually. "The pandemic has reversed years of progress made in tuber-

culosis control not just in India but across the globe. The absolute percentage of those succumbing to the disease has risen to 5-7 per cent now, up from 1-2 per cent during pre-Covid times," Anand K., CEO, SRL

New Delhi, March 23: The National Green Tribunal has directed a joint panel headed by Taj Trapezium Zone Pollution Authority and the Uttar Pradesh Pollution Control Board to prepare a remedial action plan in a plea alleging environmental violations hazard to the Yamuna river and Taj Mahal.

The principal bench of the NGT headed by Justice Adarsh Kumar Goel was hearing a plea against the operation of stone crushers and other such industries in the Agra district in violation of environmental norms.

As per the petitioner, the stone crushers are also using groundwater by deep boring without requisite permission. They are neither maintaining distance nor safe distance from the habitations. The pollution is adversely affecting the public health and the environment apart from being a hazard to the Yamuna river and Taj Mahal, it said.

Acting on the grievance, a joint committee had February 22 reported that some units were found operating while some units were not operating. They were extracting groundwater which stands ex-

The court said such sexual assault by a husband on his wife will have "grave consequences rape against the petitioner who on the mental state of the wife: it has both psychological and physiological impact on her".



Further stating that such acts of husbands scar the soul of the wives, the court observed that it is, therefore, imperative for the lawmakers to now "hear the voices of silence"

The court held that any such exemption for husbands will go against Article 14 which guarantees the right to equality.

"If a man, a husband, a man he is, can be exempted from the allegation of commission of ingredients of Section 375 of the IPC (rape). inequality percolates into such provision of law," the court said.

All human beings under the Constitution are to be treated equally, be it a man, be it a woman and others, it said, adding any thought of inequality, in any provision of law, would fail the test of Article 14 of the Constitution.

New Delhi, March 23: Air pollution is the second biggest factor affecting human health in India and its economic cost is estimated to exceed \$150 billion annually, a latest report said.

The World Air Quality Report 2022, prepared by Swiss organization IQAir and released globally Tuesday, found that India's PM 2.5 level returned to pre-Covid lockdown concentrations measured in 2019.

"Air pollution has a massive impact on human health in India. It is the second biggest risk factor for disease, and the economic cost of air pollution is estimated to exceed \$150 billion dollars an-

nually," it stated.

The major sources of air pollution in India include vehicular emissions, power generation, industrial waste, biomass combustion for cooking, the construction sector, and episodic events like crop burning.

In 2019, the Environment Ministry enacted the National Clean Air Programme (NCAP) which seeks to reduce particulate matter (PM) concentrations by 20 to 30 per cent by 2024 in all identified non-attainment cities, increase air quality monitoring, and implement a city, regional, and statespecific clean air action plan as well as conduct source apportion-

ment studies. The report observed that the

PM-2.5 is the unit to measure the level of pollution. In the category of cities, Ghaziabad is at number two after Bhiwadi, where the pollution level is 102.

Lviv/Mykolaiv/Kharkiv, March 23: US President Joe Biden flies to Europe Wednesday for an emergency NATO summit on Ukraine, where invading Russian troops are stalled, cities are under bombardment and the besieged port of Mariupol is in flames.

Four weeks into a war that has driven a quarter of Ukraine's 44 million people from their homes, Russia has failed to capture a single major Ukrainian city, while Western sanctions have ostracised it from the world economy.

After failing in what Western countries say was an attempt to seize Kyiv swiftly and depose the government, Russian forces have taken heavy losses, are frozen in place for at least a week on most fronts and face supply problems and fierce resistance

Worst hit has been Mariupol, a southern port completely surrounded by Russian forces, where hundreds of thousands of people have been sheltering since the war's early days, under constant bombardment and with food, water and heat supplies cut.

New satellite photographs from commercial firm Maxar released overnight showed massive destruction of what was once a city of 400,000 people, with columns of smoke rising from residential apart



ment buildings in flames.

No journalists have been able to report from inside the Ukrainianheld parts of the city for more than a week, during which time Ukrainian officials say Russia has bombed a theatre and an art school used as bomb shelters, burying hundreds of people alive. Russia denies targeting those buildings.

Biden, due to arrive in Brussels Wednesday evening, will meet NATO and European leaders in an emergency summit at the Western military alliance's headquarters. The leaders are expected to roll out additional sanctions against Russia Thursday, Sources said the US package would include measures targeting Russian mem-

Putin wants rubles for Russian gas from 'unfriendly countries'

Moscow: Russia will now accept pavment for gas exports to "unfriendly countries" in rubles only. President Vladimir Putin said at a meeting with the government Wednesday. The Russian President explained that Russia plans to abandon all "compromised" currencies in payment settlements, RT reported. He added that ille gitimate decisions by a number of Western countries to freeze Russia's assets destroyed all confidence in their currencies. "I have decided to implement in the shortest possible time a set of measures to change the payments for - yes let's start with this for our natural gas supplied to the socalled unfriendly countries in Russian rubles, that is to stop using all compromised currencies for transactions. the Russian President said. Putin gave the Central Bank and the government a week to determine the procedure for operations for buying rubles on the domestic market for importers of Russian gas. The President added that Russia will continue to supply gas in accordance with the volumes and pricing principles of the contracts. Only the currency of payment will change, the report said.

Assange is being held in jail while US authorities seek his extradition to face trial on 18 counts relating to WikiLeaks' release of vast troves of confidential US military records and diplomatic cables more than a decade ago. The 50-year-old Australian, who denies any wrongdoing, has been in Belmarsh prison since 2019 and before that was holed up in the Ecuadorean embassy in London for seven years.

Thailand bans crypto payments

Bangkok: Thailand's securities regulator Wednesday announced it was barring the use of crypto-currencies for payment of goods and services. The ruling effective April 1 does not ban investment in cryptocurrencies, which has become increasingly popular in the past year after being promoted by local exchanges. The Securities and Exchange Commission said it was taking action in order to protect the stability of the country's financial and monetary systems from threats including money laundering and other cyber-crimes. The regulation also specifically bans the promotion of cryptocurrencies for payment along with the distribution of software and devices for that purpose.

Warsaw: Poland is expelling 45 Russian diplomats suspected of working for Russian intelligence, the foreign ministry said Wednesday. Russia said the accusations were baseless. Relations between Russia and Central European countries that once formed part of its sphere of influence have long been fraught but

the invasion of Ukraine has significantly increased fear and suspicion about Moscow's intentions. "In total, 45 people with varying diplomatic status... were ordered to leave the territory of the Republic of Poland within 5 days. Foreign Ministry spokesman Lukasz Jasina told a news conference, "Russia is our neighbour, it will not disappear from the map of Europe, but the aggression towards Ukraine proves that it is an unfriendly state, and even hostile to Poland." The 45 diplomats being expelled represented around half of those currently working at the embassy, he said.

Russia with no intention to return, two sources said on Wednesday, the first senior official to break with the Kremlin since Putin launched his invasion a month ago. The Kremlin confirmed

Chubais was one of the principal architects of Boris Yeltsin's economic reforms of the 1990s and was Putin's boss in the future president's first Kremlin job. He later ran big state businesses under Putin and held political jobs, lately serving as Kremlin special envoy to international organisations.



Lviv: Ukrainian President Volodymyr Zelenskyy said Russian forces not only blocked a humanitarian convoy trying to reach besieged Mariupol with desperately needed supplies Tuesday but took captive some of the rescue workers and bus drivers. He said the Russians had agreed to the route ahead of time. "We are trying to



organize stable humanitarian corridors for Mariupol residents, but almost all of our attempts, unfortunately, are foiled by the Russian occupiers, by shelling, or deliberate terror," Zelenskyy said. Deputy Prime Minister Iryna Vereshchuk said the Russians seized 11 bus drivers and four rescue workers along with their vehicles. More than 7,000 people were evacuated from Mariupol Tuesday, but about 100,000 remain in the city "in inhuman conditions, under a full blockade, without food, without water, without medicine and under constant shelling, under constant bombardment," he said.

Wuzhou, March 23: As recovery teams searched mountainous terrain for victims of Monday's plane crash in southern China, a man surnamed Zhang whose nephew was among the 132 people aboard the Boeing 737-800 said his biggest hope, of finding him alive, was unrealistic.

A retiree in his 60s who asked that his full name not be used, Zhang had driven with his son Tuesday from the southern city of Shenzhen.

"I hope the country can thoroughly investigate this matter and find out whether it is the manufacturer's fault or a maintenance problem," he told Reuters Wednesday. "I came with my son and planned to stay until the matter is sorted out and take his ashes back. But this depends on the work of the government," he said.

Dozens of family members congregated at the heavily-secured checkpoint leading to the site in Teng county in southern China's Guangxi region in pairs or small groups Wednesday. Some arrived in government convoys, accompanied by officials.

"To start with... I just felt shocked about the news," Zhang recalled



during a break in heavy rain that disrupted search efforts, speaking slowly and holding back tears. As he spoke to reporters, Zhang tried to give them lunchboxes provided by officials, saying they looked hungry. "About half an hour later, I found out that someone from my family was on this plane, you can imagine how we feel," he said.

"Such a big disaster, the whole country feels hurt," he said of hearing the news of Monday afternoon's accident, China's first deadly airline crash in over a decade. Another relative at the site, a 57-year-old man surnamed Ding whose brother's sister-in-law had been on the plane, had not given up hope.

"All I want is hope, the hope of survival," he said.

One of two black boxes found

Chinese searchers found Wednesday one of two black boxes from a China Eastern Airlines plane that device was severely damaged, and it was not immediately clear if it was the flight data recorder or the cockpit voice recorder, an official of the Civil Aviation Administration of China (CAAC) told a media briefing. New Delhi, March 23: Many Indians are cutting down on fried food and even vegetables as the Ukraine war inflates the prices of items from edible oils to fuel, threatening a sputtering recovery in the consumption-based economy after two years battling Covid-19.

"God only knows how we will manage this level of price rise," said

Indrani Majumder, the sole earner in a family of four in the eastern city of Kolkata, adding that the past two years of the pandemic had brought a halving in salaries. Mother Dairy and Amul raised milk prices by nearly 5% this month, while FMCG companies such as Hindustan Unilever and Nestle are charging more for items such as in-

stant noodles, tea and coffee. Broiler chicken prices have jumped nearly 45% in six months to a record Rs 145 (\$1.90) a kg this week, as key feed ingredients corn and soymeal have become costlier after supplies from the Black Sea region were affected. Fertiliser prices have shot up

inflation.

But since the invasion late in February, which Russia calls a special operation, Indian firms have raised prices of milk, instant noodles, chicken and other key items by about 5% to 20%.

About 800 million of a population of nearly 1.4 billion received free government supplies of staple foods during the pandemic, and even small price rises now can mean a knock for their budgets.

Families' finances could stay anaemic for the third year in a row, warned Pronab Sen, formerly India's chief statistician.

'The process of rebuilding savings was only beginning post the pandemic." he added. "Because of this latest shock, they will have to cut back on consumption."

Curbs on exports of hydrofluorocarbons

New Delhi: The government Wednesday imposed curbs on exports of hydrofluorocarbons, used in refrigeration and air-conditioning, to boost domestic availability of the chemical. Exporters will now have to seek permission from the government to export hydrofluorocarbons (HFCs). "Export policy of hydrofluorocarbons has been revised from free to restricted category with immediate effect, and export authorisations would be issued on NOC (No Objection Certificate) from MoEF and CC (Ministry of

Environment, Forest and Climate Change)," the Directorate General of Foreign Trade (DGFT) said in a notification. The move assumes significance as the government has extended a Rs 6,238-crore PLI (Production-Linked Incentive) scheme for white goods to boost the manufacturing of components and sub-assemblies of ACs and LED lights. Earlier this month, the government had imposed similar curbs on imports of HFCs.



India freezes plan to allow local firms list overseas

New Delhi, March 23: India has frozen plans to allow local firms to list overseas as it seeks to bolster its own capital markets, government officials and industry sources said, in a blow to foreign funds and stock exchanges seeking to tap into the country's tech

boom. New Delhi's decision marks a sudden reversal in policy after officials said late last year that the new rules for overseas listings would be announced in February.

Three senior government offi-

cials with direct knowledge of the decision told Reuters the plan had been put on hold as India believes there is enough depth in local capital markets for firms to raise funds and get good valuations.

They declined to be named as the move has not been made public.

Indian equity markets have boomed as enthusiastic retail investors and a pandemic-induced flood of easy money pushed prices to record highs, encouraging a slew of Indian tech founders to go local with their initial public offerings (IPOs) More than 60 companies made

their market debut in India in 2021 and raised a total of more than \$13.7 billion, which was more than the previous three years combined. Like other global markets, Indian stocks have been rattled by Russia's invasion of Ukraine, and the volatil-

ity has delayed IPO plans. But the outlook for such listings dimmed after digital payments app Paytm, backed by China's Alibaba and Ant and



Japan's Softbank, plunged on its debut in November, raising questions about valuations. Its shares have slumped 75% from its issue price.

Even before Paytm's rout, US venture capitalists such as Tiger Global and Sequoia Capital had lobbied Prime Minister Narendra Modi to allow Indian firms to list

abroad to achieve better valuations, Reuters has reported.

A second government official said the overseas listing rules were now in "limbo" and both the officials cited the stock market debut of food-delivery giant Zomato, which clocked a high valuation, as contributing to the change of view

When Zomato went public on Mumbai's exchange in July, its

offer was 38 times oversubscribed and its stock jumped 66%. And Indian cosmetics-to-fashion platform Nykaa surged 96% on its debut, achieving a valuation of nearly \$14 billion.

Two industry sources briefed by government officials also said they had been told the plan was on hold, which also marks a setback for exchanges in New York and London, which had been vying for a slice of India's rapidly growing start-up economy.

Global investors have pushed for India to allow overseas listings, saying foreign markets would give Indian companies better access to liquidity and capital. But such a move, which has been under consideration since at least 2020,has deeply divided Indian policy makers

Desai bags gold at Para Athletics GP

Dubai, March 23: Sprinter Pranav Prashant Desai won India's first gold medal at the 2022 World Para Athletics Grand Prix here on Wednesday, claiming the top prize in the men's 200m T64 final

T64 classification is for athletes with a leg amputation, who compete with prosthetics in a standing position. Desai's gold was the only medal for India on the day as throwers faltered at the Dubai Club for People of Determination grounds.

Desai, a former gold medallist at the Fazza Championships, led from start to finish to end the race in 24.42 seconds, ahead of Thailand's Denpoom Kotcharang (25.78 sec) and Kenneth Jenssen Heggdal of Norway (27.08 sec).

"I came here with the gold in my mind and I am happy to lead the race from start to finish. It's nice to be back here. I have been working on my endurance speed for the past few months. Happy to execute my plans here," said Desai.

'My target is to win 100m and 200m gold for India at the Asian Para Games which would pave my way to the Paris 2024 Paralympics, added the 22-year-old, who trains in Sports Authority of India Centre, Gandhinagar. The day also witnessed a world record in men's javelin F40 finals when Iraq's Naas Ahmed hurled the javelin to a distance of 39.08 metres to take the gold.

After two days, Colombia sits on top of the medals table with 13 podiums, including six gold, followed by Thailand (16) and Tunisia (7). India lies in the 15th place with four medals.

Brisbane, March 23: Ash Barty did things on her own terms as she won three Grand Slam singles titles and spent more than two consecutive years at No.1 in the women's tennis rankings.

She retired on her own terms, too. At the age of 25, just two months after winning the Australian Open title. The announcement stunned the tennis world Wednesday.

"I just know at the moment, in my heart, for me as a person, this is right," Barty said, her voice shaky at times, during a six-minute video posted on her Instagram account Wednesday in Australia.

Saying it was time to "chase other dreams," Barty, who announced her engagement to trainee golf professional Garry Kissick in November, said she no longer feels compelled to do what she knows is required to be the best she can be at tennis

"It's the first time I've actually said it out loud and, yeah, it's hard to say," Barty said during an informal interview with her former doubles partner, Casey Dellacqua. "I don't have the physical drive, the emotional want and everything it takes to challenge yourself at the

very top level any more. I am spent." This is not the first time Barty walked away from tennis: She was the Wimbledon junior champion at age 15 in 2011, presaging a promising professional career, but left the tour entirely for nearly two years in 2014 because of burnout, overwhelmed by the pressure and travel required.

She played professional cricket back home in Australia, then eventually picked up a racket once again and returned to her other sport.

Barty went on to win singles major championships on three different surfaces — on clay at the 2019 French Open, on grass at Wimbledon last year and on the hard courts of Melbourne Park in January, becoming the first Australian player in 44 years to triumph at the na-

tion's Grand Slam tournament. But she hasn't played a tournament since being presented with her Australian Open trophy by seventime Grand Slam singles champion Evonne Goolagong Cawley, her mentor and Indigenous and Australian tennis icon, after a straight-sets final victory over Danielle Collins.

"I am so supportive of Ash that she does what makes her happy,' Goolagong Cawley told this agency.

"I can't wait to see what happens in the next chapter of Ash's life, and what helps her achieve her dreams.' Barty won 15 tour-level titles in singles and 12 in doubles since first turning pro in 2010. She spent 121 weeks at No. 1 in the rankings, in-

cluding the last 114 in a row. Her announcement was all the more stunning from an on-court perspective given her recent run of success: Barty had won 25 of her

last 26 matches and three of her past four events Only one other woman has walked away from the sport while atop the WTA rankings: Justine Henin was No.1 when she retired in May 2008. In a statement released by the WTA, CEO Steve Simon called Barty "the

ultimate competitor.' During her 21-month sabbatical from tennis as a teen, Barty played cricket with the Brisbane Heat of the Women's Big Bash League. She returned to tennis in

May 2016, playing a USD 50,000 ITF event in Eastbourne. One year later, she was ranked No. 88; by the end of 2017, Barty was an established member of the top 20. "I know I've done this before." Barty said with a laugh in the re-

tirement video, "but in a very different feeling. I'm so grateful to

It's given me all of my dreams, plus more, but I know that the time is right now for me to step away and chase other dreams and to, yeah, put the rackets down." A semifinal loss to Petra Kvitova

in Doha in February was the last match she played in 2020; Barty stayed home in Australia for the balance of the season when the global pandemic emerged.

After six months on the road in 2021 and after winning five titles, including at Wimbledon, Barty ended her season abruptly after a loss to Shelby Rogers at the U.S. Open.

"Wimbledon last year changed a lot for me as a person and for me as an athlete," Barty said. "When you work so hard your whole life for one goal — to be able to win Wimbledon, which was my dream, the one true dream that I wanted in tennis, that really changed my perspective."

She described what she termed a "gut feeling" after Wimbledon about maybe being ready to move on, but she also described herself then as not "quite fulfilled."

Her victory at the Australian Open satisfied another gap, and Barty said she was completely aware that "my happiness wasn't dependent on the results.

The league phase of the IPL will be held in Mumbai and Pune. Mumbai have been playing their home games at the Wankhede Stadium since the start of the tournament in 2008.

Indian pace spearhead Jasprit Bumrah remained static on fourth in the bowling list. India skipper Rohit, the country's top-ranked batter, fell a spot down to seventh in the latest Test rankings for batters. While former India skipper Virat Kohli and Rishabh Pant remained static on the ninth and 10th place respectively. In the ODI chart, Kohli retained his second spot even as Rohit moved down a rung to be fourth among batters.
