RITU KHANDURI 1ST WOMAN SPEAKER OF U'KHAND

Dehradun: BJP MLA Ritu Khanduri, the daughter of former chief minister BC Khanduri, was elected unopposed as the first woman speaker of the Uttarakhand Assembly Saturday. The announcement about her election was made by pro-tem speaker Banshidhar Bhagat. Her election to the post was a foregone conclusion as the main opposition Congress

chose to stay out of contest. Ritu Khanduri won from Kotdwar by defeating former minister S S Negi by more than 3,000 votes. She had won her maiden assembly election from the Yamkeshwar constituency in 2017. Before taking a plunge into politics, she taught at a private university in Noida for several years. In her address to MLAs, Khanduri exhorted first-time legislators to utilise five years of their tenure in learning about legislative procedures.

New Delhi: The Centre has extended the free foodgrain programme – Pradhan Mantri Garib Kalyan Anna Yojana (PMKAY) – for six months till September this year to provide relief to poor, Union minister Piyush Goyal said Saturday. A decision in this regard was taken in the Cabinet meeting chaired by Prime Minister Narendra Modi.

Food Minister Piyush Goyal tweeted that the government has extended the scheme till September 2022. The extension of the scheme despite the end of the Covid-19 pandemic shows the Modi government's sensitivity towards poor, he tweeted. Under the PMGKAY, which is running for the past two years, the government will distribute 1,003 lakh tonne foodgrain at a cost of ₹3.4 lakh crore to the exchequer.

As per the SEC, the BJD has won chairperson seats in 73 municipalities and NACs and crucial mayor seats of all three municipal corporations— Bhubaneswar, Cuttack and Berhampur.

The BJP is in the second position by winning 16 chairperson seats, Congress in 7 and independent candidates in 9.

BJD candidate Sulochana Das defeated BJP's Suniti Mund with a margin of 61.143 votes and became first woman mayor of the Capital city. However, Congress candidate Madhusmita Acharva was able to get only 11,006 votes and remained in third position in the race.

Similarly, BJD's mayoral candidate for Cuttack Subhash Chandra Singh trounced Congress nominee Giribala Behera with a huge margin of over 45,206 votes. In the Millennium city, BJP can-

didate Sritam Das remained in third position with 49,223 votes.

BJD's mayor nominee for BeMC, Sanghamitra Dalei, too won the election with a margin of 20,286 votes from her BJP rival Sabita Suar. In the Berhampur city. Aam Aadmi Party candidate C Priyanka secured third position with 7,453 votes while Congress nominee Manju Rath remained in fourth position with 6,768 votes.

'Youths should launch startups for economic prosperity'

Education is one of the basic needs of human beings. Good education is the key to development of a country and the society as a whole. In an interview to **Orissa POST**, St. Xavier's Group of Schools director **Prabhu Charan Mohanty** speaks about his journey, future plans and the impact of Covid-19 pandemic on education. Excerpts:



■ How did you begin your career as a husinessman?

■ I had completed my graduation from Ravenshaw College and enrolled myself for post graduation in Political Science in Khallikote College. While doing my post graduation, I developed a desire to become a businessman due to the influence of my maternal uncle Madhusudan Pattanaik, a renowned entrepreneur of Berhampur. But, my father Dambarudhar Mohanty was a government employee. So, it was not



■ What prompted you to become an edupreneur and open schools?

I did well in ceramic tiles and real estate business. Our business was expanded to several places across the state. But, the idea to set up a school struck me only when I met my friend and educationist GS Pattnaik. We planned to open St. Xavier's School in Cuttack and formed a close-knit group with some like-minded people. During those days, a few organisations were controlling the English medium schools in Odisha We decided to open a school with new ideas.

■ Why parents are choosing St. Xavier's Schools for their kids? We have transport facility for our students and we are frequently consulting the parents for the overall

development of their kids. We are organising parent-teacher meetings monthly and implementing their suggestions. Teachers have been asked to give special attention towards weak students. We are also encouraging our students for extracurricular activities like art, music, dance and debate.

> What are the reasons behind opening so many schools one after another? Education for all is

the motto of St. Xavier's Group of Schools. We have been trying hard to provide English medium education to the students of backward regions, including the Left-Wing Extremism affected areas. Our group has altogether 64 schools in Odisha, Chhattisgarh, West Bengal, Jharkhand, Andhra Pradesh, Haryana and Uttar

■ What was the motive behind opening 'Krishnamurty' school?

'Krishnamurty World School' has been set up to preserve our tradition and culture. This school promotes the ideas of service to parents, thriftiness, environment protection and nationalism. We are constantly soliciting the guidance of Jagadguru Shankaracharya and the Gajapati king for this school. We are also following the path shown by Gandhiji.

■ Your future plans?

We have plans to open English medium schools at all prominent places in all 30 districts of Odsiha. Our aim is to inculcate moral values in our students.

■ How did you overcome the challenges posed by Covid-19 pandemic?

We incurred huge financial losses due to the closure of schools for several months during the pandemic. It was not easy to maintain our school buildings, laboratories and equipment during the pandemic. There were also difficulties in paying salaries to our teachers and staff and insurance premiums for our school buses and other vehicles. We were also forced to spend money for arranging facilities and equipment for online classes. My two sons—Samyak and Samarth—played a key role in establishing a lab for online education.

■ Any advice for youngsters?

Youths should launch startups by utilising their talent and pave the way for the socio-economic development of our nation. Our youths should not go abroad for well-paid jobs. They should aspire to become entrepreneurs and create employment opportunities for others.

4kg pangolin scales seized, 1 held

Bhubaneswar, March 26: The Special Task Force (STF) of Odisha Crime Branch Friday seized huge quantities of pangolin scales from a place on the outskirts of the capital city and arrested a wildlife criminal.

The accused has been identified as Biswajit Pattanaik of Ghateswarpur under Delanga police limit in Puri district.

Pattanaik was reportedly waiting for another person at

an isolated place near Dhauli heritage site to sell pangolin scales. On a tip-off, a team of the STF along with Forest department officials rushed to the spot and arrested the accused, sources said.

"Around 4kg pangolin scales and other incriminating materials were recovered from Pattanaik's possession. The accused could not produce any legal documents authorising him to possess pangolin scales. He has been detained and handed over to the Forest de-




tion," informed the STF in a

The STF claimed that it has so far seized as many as 26 leopard skins, 15 elephant tusks, seven deer skins, 11 live pangolins, 23.5kg pangolin scales,

two leopard teeth, 29 leopard claws, 46 live wild parrots under a special drive against the wildlife criminals and poachers. As many as 61 wildlife criminals have been arrested by the STF during the drive.

The pangolin is a protected animal under Schedule I of the Wildlife (Protection) Act, 1972. It is also listed under Appendix I of the International Convention of Trade in Endangered Species (CITES), which prohibits its commercial trade



Oppn slams govt over paddy procurement

Bhubaneswar, March 26: Opposition Congress and BJP Saturday criticised the state government alleging gross irregularities in paddy procurement at mandis across

The BJD government during its 22 years rule had failed to formulate a procurement policy for the state, the Opposition said while participating in a debate on the admissibility of an adjournment motion in the Assembly Saturday on large scale irregularities in paddy procurement.

They alleged that farmers are being exploited due to the system of katni and chatni (Deduction) of paddy during procurement.

Congress Legislature leader Narasingha Mishra said the state government is silent on the recommendations of the Standing Committee on paddy procurement and not spelling out whether it accepted or rejected the recommendations. The distribution of money through the Kalia scheme will not yield any result, unless the real cause of concerns of the farmers is not addressed, he said.

Mishra demanded the government to take steps to stop the exploitation of farmers. protect their interests and ensure how the income of farmers could be increased.

He further alleged that the government was busy in elections and did not prioritise farmers' interests.

Congress MLA Taraprasad Bahinipati alleged that around 10kg of paddy is being deducted per quintal while procuring, and farmers are forced to distress sell their produce as they are not getting the MSP. The Congress leader demanded the government to stop the deduction of paddy and to take action against people involved in this illegal act.

BJP chief whip Mohan Majhi alleged that the entire paddy procurement process is under the control of mill owners. The deduction (katani chhatni) of paddy is being done jointly in a nexus between government officials, mill owners and agents. Majhi also alleged that the state government has failed to provide basic amenities like

drinking water and toilets in

the mandis. In his reply Food Supply and Consumer Welfare Minister Ranendra Pratap Swain refuted the allegations made by the Opposition and said the government has brought transparency and impartially by introducing a token system in paddy procurement. It has prevented the irregularities in paddy procurement at the grass-

roots level, he claimed. The minister also said that the procurement of paddy from small and marginal farmers had increased by 29 per cent during the 2019-20 Kharif season. The Aadhar based biometric authentication has been introduced in 2019-20 to keep ghost farm-

ers away, Swain said. He further said during 2021-22 Kharif, a total of 15.43 lakh farmers have been found eligible to sell their paddy to the government. The number of farmers is 5 per cent more this year in comparison to farmers who registered their names during the Kharif last year to sell their paddy, he added.

State observes **Earth Hour**

Bhubaneswar: Odisha Chief Minister Naveen Patnaik and a host of political leaders joined people of the state in turning off their lights to observe Earth Hour Saturday night. Patnaik turned off all electrical equipment at his home Naveen Nivas in Bhubaneswar at 8.30 pm for one hour. Governor Ganeshi Lal and BJD MP Anubhav Mohanty were among other leaders, who took part in the global movement. Bhubaneswar, March 26: Odisha registered 43 more coronavirus cases Saturday, while there was another fatality, the state Health department said in a bulletin.

Out of the 43 new infections, 13 are in the age group of newborn to 18 years. While 26 cases were reported from quarantine centres, 17 persons contracted the virus locally.

Kendrapara district registered the highest number of new cases at seven, followed by Gajapati with six new infections.

Other districts that reported fresh cases are: Balasore (3), Bolangir (1), Boudh (2), Cuttack (1), Ganjam (2), Jajpur (3), Jharsuguda (2), Kandhamal (1), Khurda (5), Koraput (1), Mayurbhanj (1), Nuapada (1),

The State Pool reported only one new case. The pool logs persons who come from outside Odisha and test positive.

Currently, there are 431 active cases, while 69 Covid-19 patients recuperated in the last 24 hours, according to the Health bulletin. The state had registered 55 cases of coronavirus infections and zero Covid fatality Friday.

The coastal state's daily test positivity rate (TPR) was 0.1 per cent and the infections were detected out of 44,882 sample tests.

The toll rose to 9,118 as a 73-yearold man died in the Ganjam district. In all, the state has logged 12,87,421 cases, out of which 12,77,819 people have recovered so far.

A total of 3,04,51,013 swab samples have been cumulatively tested so far

₹99.75cr for Paradip fishing jetty facelift

Paradip, March 26: The Union government has sanctioned Rs 99.75 crore for the development of the fishing jetty in this port town, a report said.

The amount will be spent on the construction of a second auction hall, a cold storage and mechanisation of the fishing jetty among others, port sources said.

Construction of the riverine port is underway at about two km from the Mahanadi river mouth. The Paradip Fishery Harbour is located on the right

bank of Mahanadi, about 2 km off stream of the river mouth. The fishing harbour spreads over an area of 39 acres, of which the basin area spreads over 21 acres.

Currently, the harbour is being used by more than 740 fishing vessels. The existing facilities are not upto international standards in terms of washing, sorting, packing and loading fish to trucks and maintaining cleanliness at the harbour.

In order to meet the international standards and thereby increase the export volume, the Union government has approved



the upgradation and modernisation of the fishery harbour at Paradip at an estimated cost of Rs 99.75 crore with 100 per cent Central financial assistance under the Central Sector Scheme Component of Pradhan Mantri Matsya Sampada Yojana.

The matter came to fore after Paradip Port Trust Chairman PL Haranadh and Indian Port Rail and Ropeway Corporation Ltd (IPRCL) Managing Director Anil Gupta signed a memorandum of understanding (MoU) in the presence of Sarbananda Sonowal, Union Minister of Ports, Shipping and Waterways, Friday.

Transparency Lacking

The strength of democracies is transparency. When the people know of the difficulty a nation faces, they can combat it together. They become closer, knowing that they face a threat jointly. This spirit, though possible, is not easy to achieve in nations that do not have democracy because authoritarian leadership is secretive.

An example of what is meant is visible today in the war being fought in Europe. Ukraine has come together and the world sees its spirit in the face of adversity. There is of course a dispute over the manner in which Ukraine arrived at its present democracy and that is part of the reason Russia has invaded it. But there is no dispute about how the two nations today differ in terms of transparency. Ukrainians know what they face and have come together to face it. This month Russia blocked access to Facebook for its citizens because Vladimir Putin doesn't want the people to know what is going on. He has also introduced a law that punishes media outlets with 15 years in jail for reporting on the military. This will produce anxiety and alarm in many Russians and will be damaging in the long term for the nation.

in organisations and in government.

March 25, the Foreign Minister of China came to India. The government said it was an "unannounced" visit though media was aware Wang Yi was coming. He met with our Foreign Minister and also met the National Security Advisor so the subject of his visit was not a secret: it is the situation in Ladakh. Wang asked to meet the Prime Minister but this was not allowed, with the excuse that Modi was away in Uttar Pradesh for Adityanath's swearingin. This is the second clue we have and it indicates to us that India is displeased with the situation. What is the situation? This is the problem. Indians have been told by the Prime Minister himself that there is no problem and that nobody is on our territory. The Defence Minister has said that nobody is stopping India's soldiers from patrolling in the spaces that they have been historically patrolling.

If this is the case then what is there to discuss with the Chinese? This the government is not telling us. What is called the 'Godi media' reported that it was the Chinese side that wanted disengagement and this was because "the present situation was not in mutual interest." Disengagement from what? If they are on their side, then there is no real problem. March 11, generals from the Indian Army and Chinese army met for the 15th round of talks since the clash of 2020. What do they talk about if there is no intrusion? Our

The Indian Express reported the following day that "both sides have a platoon-sized strength of soldiers in Hot Springs, but the Chinese troops are on the Indian side of the Line of Actual Control." The government did not deny this report and did not comment on it. Most experts including retired generals, who write, are of the opinion that Indian land has been intruded on and China is refusing to vacate and that is the problem. Some have written that this may escalate and it will be the Chinese who will escalate it. There has also been news of their encroachment into fresh areas in Arunachal Pradesh (which the Chinese claim because the sixth Dalai Lama of Tibet was born in Tawang in 1683)

China is a dictatorship like Russia and doesn't like transparency. India is a democracy but we have chosen to not be transparent on this issue (among others), for whatever reason. I don't want to speculate about why though it is quite clear to me what the reason is.

We should consider that India is not a dictatorship and should be using her natural strength as a democracy. For some reason we are not, and in fact we appear to be misleading ourselves. And we are giving space to China. The foreign policy experts in Beijing will have noticed the confusion that has been produced by the Indian government. It is unlikely that they will not have as sessed how it can be used to their advantage. What is it that China seeks and why has the Ladakh border become and remained hot for two years and what is going on in Arunachal Pradesh? What does this all have to do with the road that China has built in Pakistan Occupied Kashmir, which connects west-

China controls a port in Sri Lanka and Bangladesh newspapers are full of positive reports about joining China's Belt and Road Initiative. Nepal is also a part of this plan. In South Asia, India and Bhutan alone have refused to join. What does this mean for the long term future of India and what are the threats and challenges we may face in the future? Democracies can negotiate their ways through difficult problems because they have transparency and the strength of the entire polity, the people and the Opposition and civil society can come behind the government. For this to happen, however, there must be honesty and transparency. It is clear that here, on this issue with China which continues, unfortunately that has not been the case.

■ Silver bullet

mericans frequently use it to refer to some simple and seemingly Amagical solution to a complicated problem. In that sense, it seems to be a conflation of, or perhaps a confusion between, an older sense of silver bullet and the very similar magic bullet. We have to look into European folklore to find out where silver bullet comes from. There are lots of stories in which they are the only way to kill some supernatural enemy. Werewolves were believed to have been given the power to change form by the Devil in return for acting as his servants. Nothing ordinary could kill one - only a silver bullet would do it. Basically, what a stake through the heart was to a vampire, a silver bullet was to a werewolf. Later, the same idea was applied to other supernatural entities. Some of the legends say that a hare, who was either a witch in disguise or the familiar of a witch, could only be killed in this way. Others refer to any man who had sold himself to the Devil, or sometimes to the Devil himself, who could be scared off by such means. Another legend says that a silver bullet would never miss its target. Obviously, these legends couldn't appear before guns were invented, but the first examples are actually rather late even so. The legends are common to many European countries, but the figurative sense is characteristically American. Magic bullet is rather more recent. It's a direct translation of the German word Zauberkugel, which is said to have been created by the medical scientist Dr Paul Ehrlich in reference to his search, much opposed by the medical establishment of the time, for a cure for syphilis. The term is recorded in English from about 1938 to mean some drug, usually as yet undiscovered, that will be the perfect cure for a specific disease.

WOMEN'S LEADERSHIP IS NEEDED TO RESPOND EFFECTIVELY TO SHARED GLOBAL CHALLENGES

he world is well aware that the climate crisis is one of the main stumbling blocks to sustainable development. And vet, despite the dramatic evidence of the lethal consequences of climate change, and despite possessing the knowledge, technologies, and resources to fix it, we continue on the same highcarbon path that threatens

bilisation depends on a wholeof-society response, and thus on all citizens' equal and fair participation in governance. That has not happened, either: Women have been underrepresented in climate decision-making. And while this trend has slowly been reversed, much more needs to be done to advance a gender-sensitive response to climate change Three imperatives stand out: women's leadership, indigenous rights, and education.

Efforts to improve gender parity in climate governance have been ongoing for nearly a decade. In 2014, delegates to COP20 adopted the Lima Work Programme on Gender to encourage the inclusion of more women in climatechange negotiations. But five years later, at COP25 in Madrid, 60 per cent of government delegates and 73 per cent of heads and deputy heads of delegations were men.

This imbalance led to the adoption of the Enhanced Lima Work Programme and Action Plan on Gender. Under the enhanced plan, the parties to global climate talks pledged to appoint and provide support for national gender and climate-change focal points for climate negotiations, and for project implementation and monitoring. Even so, from 2019 to 2021, women occupied only 33 per cent of all leadership positions in climate-change negotiations and expert mechanisms

But efforts to include women in these discussions continue.



Only a third of leadership positions in climate-change negotiations are held by women, even though women are the most vulnerable to the worst effects of global warming. Absent the active participation of women and girls in local,

national, and global climate strategies, a carbon-neutral future will remain out of reach

The final agreement issued at the close of last November's COP26 in Glasgow included gender equality and women's leadership as central components of climate policy and action strategies. This represents clear recognition that the transition to net zero will be possible only through active citizenship, with women playing a vital role.

Women are disproportionately affected by the climate crisis, but they are also important agents of change. Giving women a seat at the decision-making table and using a gender lens to shape low-carbon development strategies will go a long way toward making progress on efforts to mitigate and adapt to climate change.

The transition to carbon neutrality requires a radical change in production systems and consumption patterns across all sectors. Women must be part of the process to develop effective policies. The task is daunting, but there are examples to follow.

Costa Rica, for one, has set a clear path toward net-zero carbon dioxide emissions. Since 2014, more than 98 per cent of the energy generated in Costa Rica has come from renewable sources. And in 2021, the country was awarded the Earthshot Prize for its conservation model, according to which local citizens are paid to preserve and restore natural ecosystems, including rainforests. Costa Rica's success can be attributed largely to the commitment of its citizens to sustainable development and the involvement of indigenous and rural women in climate adaptation, knowledge production, and

efforts to strengthen resilience. Indigenous and rural women in particular are the most vulnerable to climate change and environmental degradation. The inclusion of these women in creating sustainable practices is thus central to ensuring the effective ness of climate-related decisions Initiatives such as Club de Madrid's Shared Societies approach emphasise that indigenous communities have the right to be involved in these discussions, and acknowledge that local communi ties are more likely to support and implement conservation plans when they are fully invested in their development.

Education is also a crucial component of inclusive climate decision-making. In 2021, UNESCO called for environmental education to be a core curriculum component in all countries by 2025. The Berlin Declaration on Education for Sustainable Development states that environmental education must be available to girls and boys alike from an early age to ensure that future generations have sufficient knowledge to respond to climate change Emphasising gender equality and non-discrimination in access to climate knowledge and skills will boost the ability of young people to effect change.

The recent all-male "CEO lunch" convened at the Munich Security Conference shows that women are still missing from the highest levels of global decision-making. Yet women's leadership is needed to respond effectively to shared global challenges. Without the active and meaningful participation of women and girls in local, national, and global climate strategies, a carbon-neutral future will remain out of reach.

Reinforcing tobacco control regime

THE CONSUMER **PROTECTION ACT 2019 HAS GIVEN A NEW RAY OF HOPE** IN THE FIGHT AGAINST TOBACCO

obacco kills approximately 8 million people annually. Approximately one person dies every six seconds due to tobacco, accounting for one in 10 adult deaths. According to the WHO, more than 80% of such deaths occur in the developing world. India is the second largest country in the world in terms of tobacco consumption and therefore faces a substantial tobacco-related mortality and morbidity encumbrance. Odisha is one of the leading tobacco consuming states, especially smokeless tobacco.

Enacting Cigarettes and Other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Act (COTPA) in 2003 and ratification of the WHO Framework Convention on Tobacco Control (FCTC) in 2004 laid the foundation of legal framework to regulate tobacco consumption in India. The COTPA in last 18 years attempted to defy the tobacco industry's tactics to advertise and promote tobacco. Yet, the industry has been able to target, especially children, through its indirect promotion tactics. Considering these escape routes, the Ministry of Health and Family Welfare has proposed an amendment in COTPA which is awaiting Parliament's approval.

However, Consumer Protection Act (CPA) 2019 has given a new ray of hope in the fight against to-

bacco. India did not have a specific legal regime for fixing product liability prior to 2020. In absence of a specific regime governing product liability, such claims were founded and derived from legislations viz. the Sale of Goods Act. 1930: the Consumer Protection Act, 1986; and the Indian Contract Act, 1872. These claims were also based on case laws, both in the civil and criminal aspects leading to a complex process. Certain sector-specific laws touching upon principles of product liability viz. the Drugs and Cosmetics Act, 1945 and the erstwhile Prevention of Food Adulteration Act, 1954 (replaced by the Food Safety and Standards Act, 2006) were also used in some cases. This has now been addressed to a large extent by CPA 2019. Sections 82 to 87, (Chapter VI of CPA 2019) offer a comprehensive scheme which would apply to every claim for compensation under a product liability action. A product liability action can be filed against a 'product manufacturer' or a 'product service provider' or a 'product seller', as the case may be. Manufacturers, distributor and sellers of any kind of tobacco product owe both a legal and moral duty against their customers to warn clearly and in unequivocal terms about the fatal consequences of tobacco use. The defence of volenti non fit iniuria or contributory negligence does not arise because most of these tobacco

products include toxic chemicals and also as majority of the long term tobacco users start using tobacco when they are minors. Since. the incubation period for tobacco related diseases may vary from 10 to 20 years, the adverse effects are diagnosed and reported when the tobacco user has attained majority. Therefore, the defence of volenti non fit injuria must not apply to those who start using tobacco as minors and grow as addicted adults. The COTPA squarely puts an obligation on every tobacco manufacturer, producer, distributor and seller to prevent minor's access to tobacco products. The CPA 2020 explicitly includes food under the definition of goods as defined in Food Safety and Standard Act 2006 [Section 2(21)]. So, every food vendor, including food delivery platforms also come under its ambit.

The new CPA also ensures liability of endorsers i.e. an endorser of a product/service (for instance a celebrity) is under obligation to not to participate in false/misleading advertisements (Section 21). Section 2(47) while widening the scope of 'unfair trade practices' expounds on such practices and includes, for instance, misleading advertising, refusal to take back defective goods, refusal to refund consideration for such goods within period specified. There are countries where crim-

inal law has been invoked for instance in western Australia by the

Department of Occupational Health. Safety and Welfare under State Legislation following complaints by employees of a gambling casino that they were subjected to passive smoke. The maximum penalty under statute is \$50,000. In the USA the states of Mississippi, Minnesota, Florida and West Virginia are suing the American tobacco companies claiming punitive damages, reimbursement of past healthcare of victims of smoking related disease, compensation for future cost of healthcare for current and future victims and injunctions forbidding the promotion of cigarettes to minors. The aim is to recover the enormous and increasing outlay of individual states on treating tobacco-related disease.

The new CPA is a welcome step but successful enforcement of it to control tobacco industry interference would require active engagement of civil society as an important stakeholder, in particular, to increase people's awareness, solicit their support for law and involve them in monitoring enforcement and reporting violations. Such a mechanism will facilitate regular consultations among major stakeholders and facilitate concerted action by multiple implementing agencies to ensure comprehensive tobacco control in India.

Wang in India

Sir, This refers to 'Peace must for normal ties: India to China', Orissa Post, March 26. All speculation about the Chinese Foreign Minister delivering a special message to the Indian leadership or a breakthrough on the border issue remained just that. In his talks with National Security Adviser Ajit Doval, Wang Yi reiterated the oft-repeated Chinese position that the LAC standoff should be placed in its 'appropriate position' in the broader scheme of bilateral relations. Given that India has never bought into this proposition, it is to the credit of Doval and External Affairs Minister S Jaishankar that they made it clear to Wang that progress in disengagement and de-escalation alone can lead to normal bilateral relations. India and China have had 15 rounds of military talks and eight rounds of diplomatic discussions, and the message sent out from the Indian side to Wang made it clear that the progress made so far in these meetings must be extended to all the friction points in the Ladakh sector before the two sides can move on to other issues. It would appear the Chinese side believed the geopolitical realignments and the turmoil created by the Ukraine war had created an opening for exploratory talks with the Indian side. Wang spoke with Doval about China not pursuing a 'unipolar Asia' and respecting India's traditional role in the region. If that were truly the case, the Chinese foreign minister could have proved his country's intentions by agreeing on some measures to help end the standoff and restore the status quo as it existed on the LAC in April 2020.



New Delhi, March 26: The Congress Saturday announced a three-phased campaign, "Mehngai-mukt Bharat Abhiyaan", against price rise under which it will organise rallies and marches across the country from March 31 to April 7.

Congress general secretary and chief spokesperson Randeep Surjewala told a press conference here that in the first phase of the campaign, Congress workers and common people will protest outside their houses and at public places on March 31.

He said people will garland LPG cylinders, beat drums and ring bells to highlight the issue of inflation and seek to draw the attention of the "deaf BJP government against the insurmountable increase in the prices of cooking gas, petrol and diesel.

"The Congress president, in consultation with the party general secretaries and state in-charges, has decided to champion the people's cause in a three-phased programme --Mehngai-Mukt Bharat Abhiyaan," Suriewala said.

From April 2 to April 4, the Congress,



along with NGOs, religious, social organisations and resident welfare bodies, will organise dharnas and marches at the district level across the country, he added.

April 7, the party will organise "Mehngai-mukt Bharat" dharnas and marches at all state headquarters with the help of social and religious organisations, NGOs and people, Surjewala said."The people of India have been betrayed, duped and deceived by the (Narendra) Modi government. After keeping the prices of petrol, diesel, gas cylinders, piped nat-

ural gas (PNG) and CNG unchanged for 137 days to secure the votes of people, the last one week has been a nightmare for every household," he added.

Exams: After Covid, its hijab Now, AAP eyes hills of Himachal challenge for K'taka edu dept TO MARK ITS PRESENCE, AAP IS LAUNCHING ITS POLL CAMPAIGN APRIL 6 FROM MANDI

Against the backdrop of verdict by the special bench of the Karnataka High Court, the state government has decided not to allow students wearing hijab to take up exams

Bangalore, March 26: Karnataka education department, which successfully conducted board exams during the Covid pandemic in the last two years, is now facing the challenge of hijab issue.

 $Against\,the\,backdrop\,of\,\,verdict$ by the Special bench of the Karnataka High Court, the state government has decided not to allow students wearing hijab to take up exams. To ensure smooth conduct of exams, tight police security will be made near the examination centres.

The state government is conducting crucial SSLC (Class 10) examinations from March 28 and will continue till April 11. As many as 8,73,846 students have enrolled for SSLC exams this academic year.

The exams will be conducted in 3.444 centres across the state. CCTV cameras have been installed in all examination centres and prohibitory orders will be clamped in and around them.

Since the last two years, the teaching fraternity has been under tremendous stress. The teachers pledged their lives and worked during Covid pandemic and conducted board exams. Though, all students were passed, the initiative by the department was appreciated. Separate arrangements were made for Covid affected students to give

The teachers were also used for

Covid-related work and many had lost their lives in the process. Now, its the hijab issue which is equally stressful for them, sources in the education department say.

However, the High Court order on hijab is being challenged in the Supreme Court by petitioner students. Opposition Congress is vehemently demanding ruling BJP to allow students to write exams by wearing hijab.

Opposition leader Siddaramaiah has demanded that the Muslim students with dupatta matching with the uniform be allowed inside the examination halls.

Hindu, Jain women and religious leaders can wear cloth around their faces, why Muslim students can't. The statement stirred a controversy and later. Siddaramaiah clar-

ified that he has great respect for

religious leaders and he didn't

Later, he went on to say that if

mean to insult them. Sources in the police department said that even after govern-

ment order following the court verdict, the students will attempt to write exams wearing hijab and when they will be stopped, there will be chaos near the examination centers. The situation needs to be handled properly to ensure that students attending exams are not disturbed, they say.

BC Nagesh, Minister for Education has clarified that students wearing hijab are not allowed to take exams and there is no second thought about it. We will not allow students with hijab to any exams including board examinations, he said.

Education department is conducting separate exams for all subjects similar to the pre-Covid pattern. The students will have to obtain minimum passing marks this time. The government has clarified that it won't pass the students just like that as it was done in the last two years.

Covid regulations for students have been relaxed and wearing of mask is not mandatory in examination halls. However, the examination halls would be sanitised and social distance will be maintained. Earlier, the Special bench of Karnataka High Court has dismissed the petitions seeking permission to wear hijab in classrooms. It also stated that wearing of hijab is not an essential part of Islam.

Shimla, March 26: After demolishing the citadels of all major political parties in Punjab, the Aam Aadmi Party (AAP) is now preparing to conquer the hills of Himachal Pradesh in the November Assembly polls.

The conditions, on the face of it, are not averse for the party that swept away the traditional political outfits of the Akalis, the BJP and the Congress in Puniab.

A strong anti-incumbency wave against the state ruling BJP -- evident from the loss of three Assembly and one parliamentary seat in the October 2021 bypolls -and the absence of the veteran Chief Minister faces may work for the party that is already ruling in

Both the conventional game changers - Virbhadra Singh of the Congress and Prem Kumar Dhumal of the BJP -- are out of the scene. Singh is dead, while Dhumal is virtually in political exile after his defeat in the previous Assembly

Political observers told IANS the pitch is more or less clear for AAP, which is yet to mark its presence even in state civic body polls, to sweep away the traditional political outfits in the hill state where both the Congress and the BJP ruled the state alternatively from 1985.

Himachal Pradesh was traditionally dominated by the Congress and saw its first non-Congress chief minister. Shanta Kumar, in 1977, when the Janata Party came to the helm.

The state has been seeing a twoparty system. A handful rebels from both the Congress and the BJP have been emerging from time to time, but after failing to mark their presence on the larger political landscape, they either merged with the previous party or joined

ter Suresh Bhardwaj told IANS.

He said AAP is not active for the first time in the state. It had contested the 2014 Lok Sabha elections. After Punjab win, they are hyperactive. But as far as Himachal is concerned, only disgruntled elements will join AAP.

So are a handful of BJP rebels, led by four-time MP Maheshwar Singh, who formed the Himachal Lokhit Party in 2012, and made a serious dent in the saffron party's vote bank. The party then comprised former Assembly Speaker Radha Raman Shastri and two former ministers -- Shvama Sharma

Though the Himachal Lokhit Party won a seat, it proved to be a stumbling block for the BJP to retain the helm. Later, the Himachal Lokhit Party too split and Maheshwar Singh rejoined the BJP.

Ban on Muslim traders in temple fairs spreads to more Karnataka dists

Bangalore, March 26: The move to ban Muslim traders from to more districts of the state and is likely to snowball into a major crisis in the coming days.

The trend which surfaced in coastal districts and capital Bangalore has made its way into Hassan, Tumakuru, Chikkamagalur and Shivamogga districts.

Temple authorities of historical Belur Channakeshava temple, Siddalingeshwara temple in Tumakuru district, Maha Ganapathy temple in Shivamogga have been appealed to allow only Hindu traders to conduct business in fairs which are organised on large scale by these authorities.

The state government's official statement in this regard that they can't help banning of Muslim traders from temple premises and religious fairs has enabled Hindutva organisations to demand a ban on Muslim traders.

Vishwa Hindu Parishad (VHP) has urged the district authorities not allow Muslims to participate in world famous Belur Channakeshava Rathotsava which will be held April Bajrang Dal activists have de-

manded that non-Hindus must not be allowed to carry out business in famous Yediyur Siddalingeshwara fair from April 1.

VHP has also urged not to allow Muslim businessmen in historical Maha Ganapathy fair scheduled to be held April 5.

Hindu activists have erected a banner in Gonibeedu village near Mudigere town in Chikkamagalur district saving they won't allow those to carry out trade who do not respect the judiciary, who cut and eat sacred animal cow and challenge the integrity of the nation at Subramanyeshwara temple fair set to be held March 27.

Recently, Hindu organisations banned Muslim traders in Puttur Marikamba fare, Mangaluru Maarikamba fare, Marigudi temple fare in Udupi. The memorandums have been submitted to ban Muslim traders from participating in Adda Gadde, Kigga fares near Sringeri in Chikkamagalur dis-

Meanwhile, Srirama Sena Founder Pramod Muthalik has earlier stated that the ban on Muslim traders would continue until they do away with the habit of beef consumption. The movement of banning trade with Muslims has gathered steam in Karnataka. The crisis would continue until the change of mindset by Muslims, he stated. Muslim separatist mindset is dangerous to the country, he maintained.

In another important development, the Vishwa Hindu Parishad had asked the Muzrai department not to allow Muslim traders in any of the temples across the state.

Opposition Congress has slammed the ruling BJP government for the development and alleged that it is behind the crisis.

India hosts world's highest Snow Marathon

New Delhi, March 26: India Saturday kicked off its first snow marathon, which will be also the world's highest event in Himachal Pradesh's Lahaul & Spiti district.

India's first-ever Snow Marathon was flagged off from Sissu (near the North Portal of Atal Tunnel). With the average altitude of the marathon track being above 11,000 feet elevation, it will be the highest Snow Marathon to be organised in the world.

Snow Marathon Lahaul has been conceptualised by Gaurav Schimar and organised by Reach India. It will see the participation of around 100 runners with the eldest being a 72 years local Himachali enthusiast and the youngest being around 11 years old. The event, which will see around a dozen women runners, is being supported by Lahaul & Spiti District Administration.

The Marathon Track spread over 42 kilometers will meander across towering snow peaks, overlooking hanging glaciers, passing iced waterfalls, a semi-frozen Chandra River, frozen ice lakes with clear blue skies with ample sunshine; and all at an average elevation of above 11,000 feet.

"We are surely going to ramp up the running quotient in India with the flagging off of Snow Marathon Lahaul. It has been years in the making and while there are few established snow runs on the planet, the time is just right to introduce this format of running to India," said Gaurav Schimar, the

Bogtui turns ghost village as people flee

Bogtui (WB), March 26: An eerie silence encompasses Bogtui, where eight people were burnt alive earlier this week.

The sprawling hamlet near Rampurhat town in West Bengal's Birbhum has become a ghost village as many residents have fled to nearby villages fearing the cycle of violence which started with the killing of local TMC leader Bhadu Sheikh and led to petrol bombs being thrown at a group of houses setting them on fire which killed eight people including women and two children, in an apparent revenge attack which shocked the whole country.

Not only have most residents of Purbapara (East locality), where the killings took place in the early hours of Tuesday, left their houses in a hurry, even those of neighbouring Paschimpara (West locality) and Mayerpara (Mother's locality) in the village have also followed suit. The only staterun school in the area is also nearly empty while the Anganwadi lies vacant with un-

Locked doors welcome the many journalists, officials and policemen, who have invaded the village in the aftermath of the murders on March 21. A peep into the charred houses, through broken window panes reveals the condition in which the escapees fled their dwellings occupied for generations.

Utensils lie hither-thither on the floor. clothing hang on ropes and uncooked vegetables lie scattered in the courtyard of Saddam Sheikh's house. This hastily left behind house is next door to that of Sonu Sheikh whose house was burnt down and from where seven charred hodies were

Neighbouring houses of Rezaul Sheikh, Babar Alam, Pintu Sheikh, Nur Sheikh and Saddam Ali Mollah were found locked despite Chief Minister Mamata Banerjee, who visited the village on March 24, assuring them of full security.

The only woman seen in the vicinity cooking food is the wife of Sahe Alam Sheikh, a maternal uncle of Sonu Sheikh. 'We have no idea where they have fled to. They did not have any other option. Even my sons are not here. They are staying at my relative's place outside the village," Sahe Alam Sheikh said.

An eyewitness to the carnage, Alam, however, remained tight-lipped about the incident."I can only say that it was a revenge killing. We have seen everything from inside our houses. We ran into our dwellings on hearing a mob approaching Sonu's house and hurling bombs. After that, I don't know anything," he said.

His three sons have gone into hiding with their families and are still "unwilling to return home". Alam also welcomed the Calcutta High Court's handing over the probe into the carnage to the Central Bureau of Investigation (CBI).

Student offers namaz in MP college, probe ordered

After the video surfaced on media, members of the Hindu Jagran Manch reached the university campus and staged a protest, raising 'Jai Shree Ram' slogans and reciting Hanuman Chalisa at a temple located on the campus.

They later handed over a memorandum to the university administration demand-

ing action against the girl student. Kapil Swami, a member of Hindu Jagran Manch, claimed that namaz was deliberately offered inside the classroom on Friday."It was a deliberate act carried out on the behest of some faculty members of the university. We have demanded that punitive action be taken against those who helped the girl offer namaz," Swami said.

Neelima Gupta, Vice Chancellor of HGU, has ordered an inquiry into the matter.

"A five-member committee has been constituted to look into the matter. The committee will submit its report within three days, and further action will be taken based on this report. We have asked all the students to follow their religious practices outside the university campus," Gupta said.

Lviv: The mayor of Lviv said another rocket had hit the city in western Ukraine Saturday not long after two rockets struck its outskirts in what appeared to be the first attacks within the city's limits since the start of the war with Russia.



After Grohl, Hawkins was the most recognizable member of the group, appearing alongside the lead singer in interviews and playing prominent roles in the band's memorable videos and their recent horror-comedy film, "Studio 666"

Hawkins was Alanis Morrissette's touring drummer when he joined Foo Fighters in 1997. He played on the band's biggest albums including "One by One" and "On Your Honor", and on hit singles including "My Hero" and "Best of You".

Philippines' volcano spews mile-high plume

Manila: A small but restive volcano south of the Philippine capital spewed a 1.5 km plume Saturday, prompting authorities to raise an alert level and evacuate more than a thousand residents. The alert for the Taal volcano, about 70 km (45 miles) south of central Manila, was increased to level 3 from level 2 on the 5-level scale, which the



seismology and volcanology agency said meant "there is magmatic intrusion at the main crater that may further drive succeeding eruptions". Authorities evacuated more than 1.100 persons living in lakeside communities near the volcano, the disaster agency said. Taal is one of the world's smallest active volcanoes. Despite standing at only 311 metres (1,020 feet), it can be deadly and an eruption in 1911 killed more than 1,300 people. The Philippines lies on the "Ring of Fire", a belt of volcanoes circling the Pacific Ocean that is also prone to earthquakes.

Taliban bar unaccompanied women from flights



Islamabad: Afghanistan's Taliban rulers refused to allow dozens of women to board several flights, including some overseas, because they were travelling without a male guardian, two Afghan airline officials said Saturday. The officials, who spoke on condition of anonymity for fear of repercussions from the Taliban, said dozens of

women who arrived at Kabul's international airport Friday to board domestic and international flights were told they couldn't do so without a male guardian. Some of the women were dual nationals returning to their homes overseas, including some from Canada, according to one of the officials. The order came from the Taliban leadership, he added. This latest assault on women's rights in Taliban-run Afghanistan comes just days after the all-male religiously driven government broke its promise to allow girls to return to school after the sixth grade.

Thinning Antarctic ice shelf finally crumbles

Washington: An East Antarctica ice shelf disintegrated this month following a period of extreme heat in the region, according to scientists. Satellite images show the 1,200 square-kilometre Conger Ice Shelf collapsed completely on or around March 15. "Possible it hit its tipping point following the #Antarctic #AtmosphericRiver and heat wave too?" asked NASA Earth and Planetary Scientist Catherine Colello Walker on Twitter Friday, sharing images of a white expanse crumbling into shards over the dark ocean. The March heat wave, with temperatures reaching 70 degrees Fahrenheit (40 degrees Celsius)

above normal in parts of East Antarctica, was tied to the atmospheric river phenomenon, said Peter Neff, a glaciologist at the University of Minnesota. "The (Antarctic) climate is incredibly variable but this was off-scale," Neff said. "This was at least twice as extreme of a warming event as we would have expected."

New Delhi, March 26: Indian economy can grow consistently at 8 per cent for the next 20 years leading to the generation of up to 1.5 crore new jobs and bringing out 3.5 crore people out of the poverty every year on the basis of the capital investment strategy of the government, Union minister Ashwini Vaishnaw said Saturday.

While addressing the annual general meeting of Assocham, he said that the government has set a target of increasing the capital investment level in the budget from 27 per cent of the GDP to 35 per cent of the GDP over the next few years.

"Many of the European countries followed the prescription of the noble laureates and they are in a very bad situation. We decided to

We follow the strategy of capital investment for 5-6 years more, we can grow at 8 per cent consistently for the next 20 years. 8 per cent growth in the next 20 years means, every year close to 1-1.5 crore new employment, 30-35 million people coming out of poverty. The minister said that the result of Rs 5.5 trillion is now visible and based on the result the government has decided to increase the capital investment to ₹7.5 trillion. "This will add ₹22.5 trillion to the Indian economy," Vaishnaw

He said that the way our economy is structured ₹13 trillion will go to the MSME sector and close to ₹10 trillion will go as wages and salaries which lead to people spending in several sectors.

The minister said that people who are in the brick and mortar industry may have seen that the factory capacity utilisation was around 60-70 per cent a year ago which has now reached about 80-85 (per cent) and in some sectors it has reached 90-95 per cent where people are now planning setting up

SEBI mulls cutting down timelines for open, buyback offers

New Delhi, March 26: To reduce the overall time taken for the completion of open and buyback offers, markets regulator Securities and Exchange Board of India (SEBI) has suggested changes in the timelines for procedural activities, including a lesser time period for tendering shares.

The proposed changes would bring down the overall time taken for completion of open offers to 42 working days from the current 62 working days, while in the case of buyback offers, the time period will reduce to 36 working days from 43 working days at present.

According to the regulator, the changes would be "investor-friendly and make the process more efficient". In this regard, the watchdog has issued a consultation paper, and public comments have been sought on it till April 15.

'Considering the technological advancements in digital and fin-tech and changes made in the manner of tendering and settlement of shares, a need was felt to review the overall timelines for procedural activities, including the duration of the tendering period, involved in the open offers and buy-back



tender offers," it said.

Further, SEBI noted that the changes would also help conclude the offers in a more efficient and time-bound manner and to synchronise the timelines of similar activities across all the tender offers to the extent possible.

Among other changes, the regulator has proposed the period for tendering shares in an open offer to 10 working days from the date of receiving comments from SEBI and would remain open for 5 working days.

"Considering that the same is being proposed in case of open offers, we may implement the same in buyback offers also. Therefore, it is proposed that tendering period may remain open for five working days," as per the consultation paper issued by it.

Toyota to raise prices by up to 4% from April

New Delhi, March 26: Automobile manufacturer Toyota Kirloskar Motor (TKM) Saturday said it will realign the prices of its models, by up to 4 per cent effective from April 1, 2022.

According to the company, this hike has resulted due to the rising input cost, including that of raw materials.

"As a committed and customercentric company. TKM has made all conscious efforts to minimise the impact of rising costs on consumers," said TKM Spokesperson in a statement.

Higher local coal output helps reduce imports

New Delhi, March 26: The government Saturday said that with considerable increase in domestic coal production, India has achieved a significant reduction in the import of coal despite surge in power demand.

Imports of all grades of noncoking coal has come down to 125.611 million tonne (MT) during April-January period of the ongoing from 163.845 MT during the corresponding months of the FY'20, a decline of about 23.33 per cent.

The domestic coal-based power generation up to January 2022 is 815.72 billion units (BU) with an increase of 12.55 per cent over 724.746 BU during the corresponding period of FY'20, the coal ministry said.

Imported coal-based power generation which was 78.07 BU during April to January 2020 has reduced by 55 per cent to 35.13 BU during cor-



responding months of current FY'22.

The import of non-coking coal primarily used in power sector has decreased by 60.87 per cent from 58.09 MT to 22.73 MT up to

January 22 in comparison to the same period of FY'20.

The overall import of coal has also reduced to 173.20 MT during the April-January period of the current fiscal as compared to 207.235 MT during the corresponding period of FY'20, decrease of about 16.42 per cent which has resulted in significant savings of forex reserves this year especially when the coal prices are at a high level in the international market

F1 race on despite attack Swiatek claims top rank among women

Jiddah (Saudi Arabia), March 26: Formula One said its race in Saudi Arabia will go ahead as scheduled Sunday despite attacks on the kingdom by Yemen's Houthi rebels.

The announcement came a day after the rebels attacked an oil depot located about 11 kilome ters (seven miles) from the F1 circuit. The attack happened while the first practice was taking place, and the 20 drivers later met Friday night in talks that stretched well past 2 am. To discuss safety concerns.

In a statement, F1 and governing body FIA confirmed Saturday that "following discussions with all the teams and drivers," the grand prix "will continue as scheduled."

"Following the widely reported incident that took place in Jeddah on Friday, there has been extensive discussion between all stakeholders, the Saudi government authorities and security agencies who have given full and detailed assurances that the event is secure," the statement said.

F1 added that it has been agreed "with all stakeholders to maintain a clear and open dialogue through out the event and for the future."

There was a third and final practice session later Saturday scheduled to start at 5 pm Local time with qualifying set to start under



floodlights at 8 pm.

The top three drivers speak to the media after qualifying and team principals were set for their media duties as scheduled in the early afternoon. The Houthis acknowledged the attacks Friday evening and Saudi Arabia state TV called it a "hostile operation."

The Jiddah oil depot erupted in flames when attacked during Friday's first practice session. It caused a raging fire that rattled the drivers enough to hold extraordinary talks regarding F1's presence in Saudi Arabia.

Many drivers expressed their

concerns about racing in the region and Saudi Arabia's human rights record when F1 ran its inaugural event at the circuit last December. Now back at the track a little over three months later, tensions are heightened amidst the attacks.

Conversations between drivers, team principals and F1 chief executive Stefano Domenicali late into Friday night centered on safety and security conditions.

Friday's second practice was delayed 15 minutes because of an earlier driver meeting that included Mohammed Ben Sulavem, the newly-elected FIA president.

Miami Gardens (US), March 26: Iga Swiatek started her week by deciding that she wanted to set her sights on becoming the No.1 player in the world, without knowing how long that quest would take. A few days and one surprising retirement later, mission accomplished.

Women's tennis has a new name atop its rankings, a 20-year-old who now that Ashleigh Barty has retired and asked to vacate her No. 1 spot on the world list — becomes the first Polish player to hold that distinction.

Swiatek's ascension was clinched Friday night with a 6-2, 6-0 win over Viktorija Golubic of Switzerland in the second round of the Miami Open.

When the tournament ends and the rankings are undated. Barty will be removed and Swiatek officially will move into the top spot no matter what happens the rest of the way in Miami.

Swiatek becomes the 28th different woman to hold the No.1 ranking since the computerized system debuted in November 1975. Her rise has been steady and constant; she ended 2016 ranked No.903, cracked the top 500 for the first time in 2018, ended 2020 ranked No.17, then was No.9 when last year ended.

Barty revealed her retirement de cision Wednesday, and as part of that said she wanted to be removed



from the rankings. She's held the top spot for 113 consecutive weeks. tying Chris Evert for the fourthlongest such streak ever.

And Barty, the two-time defending champion in Miami, would have kept the top spot after this tournament ended even if Swiatek won the title.

But her decision to retire and step out of the rankings opened the door for either Swiatek or Paula Badosa, the No.5 seed in Miami and the only other person who had a mathematical chance of getting

the top spot. Badosa won her second-rounder in Miami Friday, topping Marie Bouzkova 7-5, 7-5 in a match that ended shortly before Swiatek took the court.

Coco Gauff is one of the few exceptions. The 14th-seeded American, whose home is about a 45-minute drive north from where she's playing this event, got past Wang Qiang of China 7-5, 6-4 Friday — avenging a first-round loss to her in the Australian Open earlier this year.

No.16 Jessica Pegula felt right at home too, even though the tournament is held on the grounds where the NFL's Miami Dolphins practice and play — and her parents, Terry and Kim Pegula, just happen to own the Dolphins' AFC East rival Buffalo Bills. Pegula had little trouble beating 2018 Miami

Open winner Sloane Stephens 6-1, 6-4. No.4 Maria Sakkari of Greece, No.10 Jelena Ostapenko of Latvia, No.20 Elise Mertens of Belgium, No.24 Sorana Cirstea of Romania, and No.29 Liudmila Samsonova of Russia all lost second-round

Fan favorite Nick Kyrgios rolled past No.5 Andrey Rublev 6-3, 6-0, and No.9 Jannik Sinner dug way deep to hold off Emil Ruusuvuori 6-4, 3-6, 7-6(10-8)

The event will also see a whopping 138 wheelchair athletes in action. "We are also expecting more than 130 wheelchair athletes in action during the course of the event. Arranging for the travel of close to 130 wheelchair-bound people and ensuring complete accessibility is not easy and I believe we have managed to pull off something wonderful," the first Indian woman to win a Paralympics medal said.

Besides the 138 wheelchair athletes, the 20th National Para-Athletics Championships will also see a total of 758 physically disabled athletes, 153 visually impaired athletes, 44 athletes affected by cerebral palsy, 7 athletes with intellectual disabilities and 20 athletes of short stature.

The National Championships will also witness the presence of 9 National Anti-Doping Agency (NADA) officials, to keep a check on all the top athletes during the course of the four-day event.

Tvesa, Drall make cut at Joburg meet
