#### DA OF CENTRAL EMPLOYEES HIKED BY 3 PER CENT

New Delhi: The Union Cabinet Wednesday hiked Dearness Allowance (DA) and Dearness Relief (DR) by 3 per cent to 34 per cent to compensate for the price rise, benefitting over 1.16 crore central government employees and pensioners. The additional instalment will be effective from January 1, 2022, said an official release after the Cabinet meeting. "The Union Cabinet...Has given its approval to release an additional instalment of DA to central government employees and DR to pensioners

W.E.F. January 1, 2022, representing an increase of 3 per cent over the existing rate of 31 per cent of the Basic Pay/Pension, to compensate for price rise," an official statement said. The increase is in accordance with the accepted formula, which is based on the recommendations of the 7th Central Pay Commission, it added.

Bhubaneswar, March 30: In view of the increase in day temperature across the state, School and Mass **Education Minister Samir** Ranjan Dash Wednesday announced the beginning of morning classes in schools from April 2 for the safety of students.

The new timings for Classes I to VIII will be 6:30 am to 10 am, while for Classes IX and X will be from 7 am to 11 am. This decision was taken after witnessing a steady rise in temperature, the school and mass

education minister said. The regional meteorological centre Wednesday issued a heat wave warning for several districts of Odisha for March 31 and

April 1. It forecasted that the maximum temperature (day temperature) is very likely to rise gradually by 2 to 3°C during the next two days and there will be no large change thereafter. Maximum temperature (day temperature) is very likely to be above normal by 3 to 5°C at many places over the districts of interior Odisha during the next

three to four days. Minister Dash said: Looking at the heat wave situation that is likely to prevail in the state in the coming days, we have decided to change the class timings for school children."

The schools for Classes I to VII opened in the state February 28 after nearly two years with a week-long rapport building exercise.





#### **Penalty for non-linking** of PAN with Aadhaar

New Delhi: Taxpayers not linking PAN with Aadhaar by March 31 would be required to pay a penalty ranging from ₹500 to ₹1,000, the I-T department has said. The last date for linking PAN with Aadhaar is March 31, 2022. Not adhering to the deadline will lead to PAN becoming inactive. In a notification, the Central Board of Direct Taxes said delayed intimation of Aadhaar will attract a late fee of ₹500 in cases where it is linked within the next three months or by June 30, 2022. Thereafter, ₹1,000 would have to be paid by taxpayers as penalty.

### Man burns wife alive over feud

Kuchinda, March 30: In a gruesome crime, a man allegedly burnt his wife alive at Fatatangar village under Mahulapali police limits in Bamra block of Sambalpur district over a domestic dispute, Tuesday night.

The deceased was identified as Lilima Rana (35), wife of Raghu Rana (45). Police registered a case and arrested Raghu under Section 302 of IPC over an FIR lodged by the



woman's brother. The incident was the result of a feud between the couple, sources said.

Police said the couple returned home Tuesday afternoon after collecting 'mahua' flowers from a nearby jungle. The accused consumed liquor after arriving at home and picked up a quarrel with his wife. This resulted in a heated altercation between the two as Raghu started assaulting his wife. Unable to bear the torture, Lilima left home and

went to her parental house. Lilima's father convinced her to return to her husband's house in the village and dropped her back at around 11 pm. However, the issue did not resolve and took an ugly turn when Raghu, under the influence of liquor, dragged his wife to a room and set her ablaze by dousing kerosene on her.

Hearing her screams, neighbours rescued and rushed her in an ambulance to Kuchinda hospital. However, she succumbed to burn injuries during treatment, late Tuesday night. Mahulapali police reached Fatatangar village and launched a probe while arresting the accused. The body was sent for post-mortem and a further investigation was on.

#### LOSS OF FACE FOR 'BHAIJAN'

Laka Bhaijan, a Mumbai court has rejected his interim plea for a 'gag order' in a defamation suit against his NRI neighbour, along with costs.



### Nothing new in Budget, says Oppn

Bhubaneswar, March 30: Soon after Finance Minister Niranjan Pujari presented an interim budget in the Assembly, Opposition BJP and Congress said there is nothing new in the budget statement.

BJP chief whip Mahon Majhi said the state government has failed to bring a full-fledged budget. There is nothing new in the budget. No new scheme or new plan has been announced in the budget. There is no effort to enhance the revenue collection, he added.

The government has not made any provision for the socio-economic development of the poor people, he alleged.

Terming the budget as anti-poor and anti-youth, senior Congress MLA Narasingha Mishra said the state government is taking all credits without doing anything on the ground.

There is inadequate allocation for the education sector and the government doesn't have any inten-





### Sarmistha used Bengal SIM cards to evade arrest: CB

Bhubaneswar, March 30: Sarmistha Rout, the prime accused in sensational murder case of cameraman Manas Swain, had left her mobile phone in her flat and used to communicate with relatives through new Sim cards purchased in West Bengal to mislead the police, Crime Branch Wednesday claimed in a press note.

The Crime Branch in its press note detailed how Sarmistha and her close aide Jhuna Bhoi fled to West Bengal after Bhadrak police intensified probe into the murder of Manas.

Sarmsitha informed the sleuths during interrogation that she along with Jhuna left Bhubaneswar March 7 and went to her in-laws house at Koipasi village under Kaliapani police limits in Jajpur. Sarmistha stayed there for three days lying to her mother-in-law that she had come to do some Puja for reuniting with her husband.

On March 10, the duo along with Sarmsitha's mother-in-law reached Agarapara in Bhadrak, where they purchased a new Sim card. The duo staved at Sarmistha's sisterin-law's house at Purusanda near Agarapara till March 13. The duo later fled to Kolkata by bus from Kupari Bus stand.

Sarmistha along with Jhuna stayed at different places in West Bengal including Kalyani in Nadia district, Mayapuri and Jalpaigudi. They used to stay in the houses of different acquaintances including Asima Das, known to Sarmistha's brother. When the duo ran out of the sav-

ings, they returned to Odisha and were arrested en route Bhubaneswar Monday.

The Crime Branch also confirmed that Manas died due to chest injury inflicted by the accused per-



pact, particularly on the younger generation. Such shows on web channels are also seriously affecting communal harmony as India is a multi-language and multireligious society," he said.

The BJD MP further said that had there been a censorship pro-

vision, this would not have happened. "There is a censor board for films but not for web channels. In the name of creativity and freedom of expression, we cannot encourage debauchery and exploitation of women. We should also careful about the religious sentiment of people," he said.

The senior BJD MP also mentioned about the Delhi High Court's recent strictures against microblogging platform Twitter for allowing objectionable comments against religious communities.

"There should be a law to impose censorship on the web channels who are taking undue advantage of not being censored and spreading hatred among religions and communities," he added.

#### Man gets 20-yr RI for sexually abusing minor

Bhubaneswar, March 30: A Fast-Track Special Court here dealing with POCSO cases Wednesday sentenced a man to 20 years of rigorous imprisonment (RI) after holding him guilty of sexually abusing a 16-year-old girl in Dhauli area of the City in March last year.

The court also slapped a penalty of Rs 30,000 on the convict identified as Ranjit Naik of Naranpur area under Sadar police limits in Dhenkanal and who was residing in Dhauli area.

The court also directed the state government to pay Rs 5 lakh to the victim as compensation under Section 33(8) of the Protection of Children from Sexual Offences (POCSO) Act.

According to the case details, Naik had allegedly abducted the minor from near her residence

After a few days, her family traced the duo and managed to bring back the girl to Bhubaneswar. Upon arrival, the girl revealed before her parents that Nayak had sexually abused her.

On March 13, 2021, the minor's mother lodged a complaint with Dhauli police in this regard. Police registered a case in this regard and arrested the accused March 15 the same month.

The court convicted Nayak after taking into account the statements of 10 witnesses.

Special Public Prosecutor (POCSO) Rajib Sasmal conducted the trial on behalf of the victim.

### 40% bat species in Asia still unidentified, may host new viruses

here are nearly 40 per cent unknown species of horseshoe bats in southeast Asia and China, according to a study. The study, led by researchers at Chinese Academy of Sciences and University of Hong Kong, identified 44 potential cryptic Horseshoe bats (Rhinolophidae) species within 11 species of Rhinolophus sensu lato in Southeast Asia and south

In the paper published in Frontiers in Ecology and Evolution, the team highlighted the need for further work to describe species across the region and better understand their cryptic diversity, and underscoring the unappreciated cryptic diversity in the group.

Horseshoe bats (Rhinolophidae)

are considered the reservoir of many zoonotic viruses - which jump from animals to people - including the close relatives of the viruses that caused severe acute respiratory syndrome and Covid-19.

Identifying bat species correctly might help pinpoint geographical hotspots with a high risk of zoonotic disease, Shi Zhengli, a virologist at the Wuhan Institute of Virology in China, was quoted as saying to Nature.

Better identification of unknown bat species could also support the search for the origins of SARS-CoV-2 by narrowing down where to look for bats that may harbour close relatives of the virus, added study co-author Alice Hughes, a conservation biologist at the



University of Hong Kong. The closest known relatives of SARS-CoV-2 have been found in

Rhinolophus affinis bats in Yunnan province, in southwestern China, and in three species of horseshoe

bats in Laos, the report said. To better understand the di-

versity of bats in southeast Asia and find standardised ways of identifying them, Hughes and her team captured bats in southern China and southeast Asia between 2015 and 2020

They took measurements and photographs of the bats' wings and noseleaf - "the funky set of tissue around their nose", as Hughes describes it - and recorded their echolocation calls. They also collected a tiny bit of tissue from the bats' wings to extract genetic

To map the bats' genetic diversity, the team used mitochondrial DNA sequences from 205 of their captured animals, and another 655

sequences from online databases - representing a total of 11 species of Rhinolophidae.

The researchers found that each of the 11 species were probably actually multiple species, possibly including dozens of hidden species across the whole sample.

Hidden, or "cryptic", species are animals that seem to belong to the same species but are actually genetically distinct. For example, the genetic diversity of Rhinolophus sinicus suggests that the group could be six separate species, the report said.

The findings corroborate other genetic research suggesting that there are many cryptic species in southeast Asia, the report said.

### Andhra-Odisha villages lock horns over forest land



Pottangi, March 30: People of two villages – Sunabeda under Pottangi block of Koraput district in Odisha, and Tekapar in Vishakhapatnam district of neighbouring Andhra Pradesh - have locked horns over a patch of forest land in the fringe area, as per a report.

According to the report, a woodland sprawling around Musapar hill near Sunabeda village belongs

Scores of people of Sunabeda have been cultivating the forest land over generations. However, some people of Tekapar grabbed the land and started farming activities there, triggering protests from the people of Sunabeda. Thereafter, Bhoi Ramchandra and Tamal Potana, residents of Andhra Pradesh, had attacked Bhanja Gemel, a resident of Sunabeda,

Following the incident, people of two other villages like Jamuguda and Nuaguda also opposed the land grab act by Andhra people. The people of the three villages took up the issue with zilla parishad members Laichan Khara and Daudu Dora and Sambhai sarpanch Kishore Chandra Khara before Bhanja filed a complaint at Pottangi police station in this regard.

They also submitted a memorandum to Pottangi BDO Soumvasarthak Mishra.

Notably, the same patch of forest land had triggered controversy in October 2020. The district administration had to intervene in the matter: Then Collector Madhusudan Mishra along with revenue officials of Odisha and Andhra Pradesh had demarcated the land as per the Madras Presidency map. The dispute was settled then.

The incident comes amid non-issuance of job cards to hundreds of workers who are really eligible to work as labourers under the rural

job scheme. However, undue favour is being shown to those who are in government service and being handed over job cards to work as labourers under the poverty alleviation scheme.

According to the complaint, Rabindra Behera, a native of Padmabati village and a fourth grade employee rural water supply office at Bhapur block headquarters, has violated norms and taken a job card in his name despite being a government employee. Moreover, he has also taken a job card even in the name of his wife.

### Blackbuck protection: Ganjam villagers lead by example

Aska, March 30: Population of endangered Indian antelopes (blackbucks) is increasing in Ganjam district, thanks to the tireless efforts the villagers around Aska forest range under Ghumusar forest division.

The villagers here are pulling out all the stops to protect the rare species, which are generally found in Rajasthan, owing to their religious beliefs.

From providing food, growing plants, protecting the herbivores from poachers, to guarding the forest, the villagers are leaving no stones unturned to save this Antelope Cervicapra, also known as Krushnasara' or 'Baliharina' and even 'Kala Barisia' in different pock-

ets of the district. In Ganjam district, this kind of



Indian antelope is found in the areas of Bhetnoi in Aska block and Balipadar of Buguda block. Besides Aska and Buguda, this animal is also found in Polsara, Khallikote

and Jagannathprasad blocks. Blackbucks live on fresh tender leaves, grass, crops, cereals, vegetables and shrubs. They feed for a long time, and select succulent grasses, tender shoots of crops and plants, which help them maintain

water balance in their bodies. They can survive without drinking water for a day to a week.

Locals with the help of the Forest department have constructed more than 10 ponds in order to meet the drinking water need of the blackbucks. Every year, the Forest department cultivates grass on both government and private lands for the

blackbucks to feed on them. The belief that presence of black-

bucks in paddy fields brings prosperity to the villagers has greatly contributed to the conservation of these species. The villagers do not kill the animal even if it strays into the

fields and grazes on their crop. As the story goes, over a century ago, there was a long spell of drought in the area. During this period, a small herd of blackbucks appeared here after which it rained and the drought spell was broken. Since then, people have started protecting these animals religiously as they feel that their fate is linked with

these blackbucks. The Forest department and 70 villagers in the district collectively have formed a committee named as 'Blackbuck Conservation Committee' to protect the endangered species. However, road accidents often turn fatal for the animals.

### **Economic Warfare**

The use of economic weapons during war has a long history. But the rise of globalization and cross-border supply chains has given these nonviolent munitions unprecedented power. While economic and financial sanctions may not strike with the immediacy of an artillery shell, their impact can nonetheless be devastating.

Economic warfare in a globalized world is so novel that we do not yet fully understand it, and few rules regulate it. There is no well-defined list of punitive instruments, much less credible estimates of the direct and collateral damage each is likely to cause. So, when Russian President Vladimir Putin invaded Ukraine, Western policymakers were suddenly confronted with quandaries for which they were not prepared. US President Joe Biden's administration and America's NATO allies rightly decided to contain Putin and prevent the war from escalating into a nuclear conflict, by using sanctions instead of troops

But now Western governments face the enormous task of using all the new data and information available to analyze the efficacy of these tools. And the world needs to introduce some rules to govern economic warfare before the next great-power conflict erupts.

The immediate concern is how to use economic sanctions more effectively to defeat Putin. Cutting off Russia from trade and financial interactions with the United States, Europe, and other advanced economies has

hurt the Russian economy, but not as much as one might have initially thought. For example, the US embargo on Russian oil caused the price of Brent crude to shoot above \$100 per barrel, accompanied by a sharp depreciation of the ruble against the US dollar. But the ruble did not fall as much as many may have expected and has recently recovered somewhat.

It is easy to see why this happened. Consider a market with several buyers and sellers, in which a major buyer, U, says it will no longer purchase oil from a major seller, R. There will be an initial shock as U seeks to buy from other sellers, causing prices to rise. But, over time, this effect will dissipate because R can sell to someone else, say, X, and suppliers that previously sold to X can now divert some of their oil to U.

True, the price of oil will still be higher than it was before the sanctions, because longer supply routes will cause delivery costs to increase. But, as in one of those old Hollywood musical sequences where the dancers switch partners, supply relationships will change, causing much of the initial shock to wear off.

The show must go on. There may be another mitigating factor helping Russia. The oilprice spike triggered by the US embargo

means that, even if Russia's oil exports decline, its overall income may not fall. The ruble's partial recovery signals that this may be happening. To ensure that Russia cannot easily get around the US oil embargo, America needs to use "triadic threats" more effectively – sanctioning not just Russia but also those who buy its oil.

The US is a master when it comes to triadic sanctions and has used them in unethical ways against small countries. In 1973, for example, President Richard Nixon cut off food aid to Bangladesh in the middle of a famine on the grounds that the country was trading with Cuba. While Nixon's move was unethical and had no legal basis that changed with the 1996 Helms-Burton Act, a Machiavellian piece of federal legislation designed to isolate Cuba. In my book Prelude to Political Economy, I discuss how the US used this law to throttle Cuba via triadic sanctions.

Similarly, the US used rigorous strategic analysis to steer the world away from the brink of nuclear war during the 1962 Cuban Missile Crisis. It is important that America deploy similar analytical precision today as NATO confronts a tyrant like Putin at its border. To defeat the threat, the US should communicate more clearly that its sanctions against Russia are meant only for Putin and his cronies, and that America will help to restore the Russian economy fully as soon as the Kremlin's current ruling cabal is gone. This is a message that needs to reach all Russians.

The other long-run matter deserving attention, as Raghuram G Rajan recently emphasized, is the need to set the rules of engagement for economic warfare. In today's globalized world of complex multinational value chains, large and powerful states can use a variety of techniques – including cutting off the supply of some vital input – to flatten another country's economy.

Likewise, a major power in a conflict with a developing country can spark hyperinflation within weeks simply by printing the local currency and showering the notes on cities and towns. Unless such actions are formally prohibited, someone is bound to resort to them. The severe sanctions that the West has imposed on Russia may be justified to defeat Putin, but they have escalated economic warfare to an unprecedented level. Just as we have rules governing conventional warfare, such as a prohibition on targeting civilians, we will need to create rules for what is permitted and what is forbidden in economic conflict.

n March 15, the Karnataka High Court decreed that wearing the hijab is not an essential practice of Islam and upheld the state government order on adhering to uniform in educational institutions. In this invidious process, which has engineered severe backlash, the court has paid no heed to arguments like 'reasonable accommodation', 'test of proportionality' and most importantly thrown to the winds the ideals of a pluralist liberal society like India. The court has observed that allowing women to wear hijabs in the class room will hinder the constitutional spirit of "positive secularism". It also observed that as per Muslim Scriptures wearing of hijab is only recommendatory and not mandatory Further the court has observed that it is impossible to instil scientific temper into the young minds (Article 51A (h) as long as wearing hijab is considered religiously sacrosanct. The school regulation prescribing dresscode as one homogeneous class serves the objective of 'constitutional secularism'. It also dismissed the argument of reasonable accommodation by observing that two category of girl students would bring a sense of social separateness which is not desirable. In the opinion of the court, freedom of conscience and right to religion are mutually exclusive.

The doctrine of essential religion practice was mooted by the Supreme Court in Shiru Mutt case(1954), where the court felt that it should ascertain what constitutes essential part of the religion with reference to the doctrines of that religion itself. In Dr. Faruqui vs Union of India (1994)case, the court observed that 'a mosque is not an essential part of practice of religion for offering Namaz and prayers'. However, the defining case in this regard is COP vs Avadhuta case in 2004 when the Supreme court ruled that the Tandav dance of Anand Margis was not an essential rite of Anand Margi faith as Anand Marg was founded in 1955 while the Tandav dance was introduced in 1966. The

Shyara Bano Vs Union of India case in 2017 brought in a paradigm shift in the approach to the concept of essential religious practice. In a split verdict (3-2), the Supreme Court struck down the practice of the practice of Triple Talaq as unconstitutional. Justice Joseph who gave the majority verdict quoted scriptures to bring out how Triple Talaq is not an essential religious practice and goes against basic tenets of Quran and thus violates the Shariat. A practice that is merely permitted or not prohibited by a religion cannot be considered an essential tenet sanctioned by the particular religion. However, the dissenting judges had observed that "religion is a matter of faith and not of logic. It is not open to a court to assert an egalitarian approach over a practice which is an integral part of religion". Many scholars also find it uncomfortable that the court undertakes a theological study instead of the Imams. They believe that it is not the role of the court to determine true intricacies of faith.

The constitution provides in Article 25(1) that everyone can pursue freedom of conscience and have a right to profess practice and propagate religion. Further, Article 25(2)A mandates that the State can regulate /restrict any economic financial & political activity associated with religious practice. It may be recalled that the right to freedom of speech and expression under Art 19(1) is not absolute but subject to reasonable restriction like public order, decency and morality under Art 19(2). The overwhelming refrain of our Courts is that unless a certain religious activity is disrupting public order, morality and health there should be no restriction of such religious activity. In fact, the Supreme Court went a step further in Bijoe Emmanuel 1986 case where it allowed the Jehova witnesses not to participate in singing of the national anthem. To quote: to compel each pupil to join in singing of the national anthem despite his genuine and conscientious religious objection would contravene the rights guaranteed by Art 19(1) (a) and 25(1) of the constitution. 'The real test of a true democracy is the ability of even an insignificant minority to find its identity under the country's constitution', wrote Justice Reddy.

itution', wrote Justice Reddy. c Sadly, the Karnataka High court V

judgement has not taken any cog nizance of such religious rights of the minority in the landmark Emmanuel Case. By rejecting the doctrine of reasonable accommodation, the court has failed to take note that in a pluralist society, a class room must reflect social diversity without undermining the sense of equality. Further the court has ignored the classic test of proportionality as per which the court determines 'if the restriction imposed by the state has' any reasonable nexus between the objective sought to be achieved and means used'. If the purpose of the uniform is to allow for no difference, every exhibition of faith in the classroom needs to be stamped out, religious marks on the foreheads of Hindus. By targeting the hijabs of Muslim women, the Court has failed to upbraid the state from its blatant act of discrimination on religious grounds (Art 15(1)) of Muslim women. The other important issues are on what ground govt. can restrict persons for exercising their free choice on what to wear. On the face of it the state should not impose any religious authority on our lives. They must be protected from the artifice of coerced sameness. What it means to be an Indian is to feel se cure and comfortable not only in our own home but when we step out, without having educators and judges dictating how we express ourselves. India's civilisational strength is its unique jugalbandi of religious expression and liberalisation. The schools and colleges should foster diversity. Our differences should not lead to so cial, religious separateness. Justice O Chinnapa Ready had presciently observed: "Our traditions teach tolerance, our philosophy teaches tolerance, let's not dilute it". By diluting the spirit of tolerance and upholding uniform as a badge of honour and uniformity, the Karnataka high court has done a disservice to the spirit of impartiality and objectivity which is expected from the guardians of fundamental rights.

### More medical seats, doctors critical

Mansukh Mandaviya recently told Rajya Sabha that the Modi government has taken a number of steps to increase medical seats as well as availability of doctors in the country. However, the question that needs to be addressed is what about the commercialisation of medical education which has accelerated and needs to be checked.

At the same time, while it's encouraging that medical seats have risen, these continue to be meagre compared to the increasing number of students opting for the profession.

The steps taken to increase the number of medical seats, as per the government, include a centrally-sponsored scheme for establishment of new medical colleges by upgrading district/referral hospitals, under which 157 new medical colleges have been approved and 71 are already functional. Additionally, there is a centrally sponsored scheme for strengthening or upgradation of existing State or Central government medical colleges to increase the MBBS and PG seats, and a central sector scheme for upgradation of government medical colleges by construction of super specialty blocks.

A total of 75 projects have been approved and 55 completed. Under the Central sector scheme for setting up new AIIMS, 22 AIIMS have been approved and under-graduate courses have started in 19 of these. Further, for rapid growth in the number of allied medical seats, the National Commission for Allied and Healthcare Professions (NCAHP) Act, 2021 has been enacted and an interim commission has been notified.

Way back in 2018, the Union Cabinet had approved a Rs 10,700 crore plan for 24 new medical colleges with 10,000 under-graduate and over 8,000 post-graduate seats. The Health Ministry had earlier implemented a plan to set up medical colleges attached to 58 district hospitals

hospitals.

Recently, the National Medical Commission (NMC), the apex regulatory body for medical education and ensuring lower the cost of medical education to encourage more students to pursue careers in healthcare, announced that half the seats in private medical colleges will be charged at par with government medical colleges. If implemented, nearly 22,000 seats would become more affordable and if added to over 46,000 government col-

lege seats would take the total number of relatively affordable seats to over 68,000 or about three-fourths of the 90,675 MBBS seats currently available.

However, while the NMC, has also laid down guidelines for fee fixation for remaining 50 percent, the Act does not allow regulation of 100 percent. Even before the NMC's decision, most States already had fee regulatory committees headed by retired high court judges to fix fees for private medical colleges. But this did not cover deemed university medical colleges, which evaded regulation with court orders upholding their position that State committees have no power over them being directly under the UGC.

The NMC proposal may thus motivate private medical colleges to charge whatever they wish for half the seats. Members of the All India Forum Medical Graduates estimated, given the high costs, about 30,000 to 40,000 students enroll annually in under-graduate courses in Russia, Belarus, Ukraine, China and other countries. Private colleges in India charge MBBS students around Rs 10 to Rs 16 lakh fees annually across the five-year course, whereas students pay about Rs 30 lakh for the entire MBBS course in the above countries.

The government's response to this is that while a large number of Indian students go abroad to pursue MBBS and obtain foreign medical qualifications, they still need to clear the Foreign Medical Graduate Examination to be registered as a medical practitioner in the county.

Besides, it has come to light that State regulatory committees are quite ignorant of what fee is actually taken by private medical colleges. The undersigned was informed by a student that the only private medical college in Kolkata refused to accept the test he had taken and sought a total of Rs 80 lakh for getting admission to an MBBS course! A survey by the Health Ministry would do well to get a reality check.

Besides, it's critical that deserving candidates get access to these seats and that private medical colleges are checked from 'selling' seats by ensuring strict regula-

tions and vigil.

While strides have been made in the health sector, the government would do well to fine tune the new system under NMC. It could consider raising further by 10 per cent the medical seats to ensure more qualified post-graduate specialists are available in the country.

On the other hand, the military has had enough of the poor administrative abilities of the government, especially after Khan sought to hold up the appointment of a new Inter-Services Intelligence (ISI) chief last year in an apparent attempt to influence the choice of the next army chief. The Pakistan army, which has never covered itself in glory on its role in politics, appears to be staying neutral. But even the exit of Khan will not mean the end of Pakistan's current woes. The Opposition, if it forms a government, will have its hands full coping with a wide array of challenges.

#### Not making social media users' verification mandatory: Centre

New Delhi, March 30: The government does not intend to make social media users' verification mandatory in view of the privacy issue, Minister of State for Electronic and IT Rajeev Chandrasekhar told Lok Sabha Wednesday.

To ensure that internet is open, safe, trusted and accountable to all users, the government notified the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules in February last year, he said during the Question Hour.

"And we will continue to expand the scope of those kinds of rule to ensure that internet is safe and

He was replying to questions from members of the Congress and DMK. Sharing concerns raised by Congress member Abdul Khaleque, the minister said the internet and technology have empowered people and transformed their lives and governance, being "a platform for good", but user harm, criminality and fake news type of issues are also on the rise.

"I empathise with what you are saying but our approach is not to make it (verification of the users) mandatory," he said.

He asserted that the provisions made in the new IT rules are "effectively" to deal with the issues of safety and trust online, and misuse of social media leading to law and order problems in the country. According to the rules, an intermediary is required to identify the first originator of information for the purposes of investigation, prevention, investigation, prosecution of an offence related to the sovereignty and integrity of India, security of the State, or incitement of an offence, he said. The government has defended the provision in the court "very robustly,"

### LAVROV TO VISIT INDIA TODAY: MEA

It would be the highest-level visit from Russia to India after Moscow launched its military offensive against Ukraine February 24

New Delhi, March 30: Military operations in Ukraine, sale of Russian crude, rupee-ruble denominated payment method, arms deals are a few issues which Russian foreign minister Sergey Lavrov will discuss during the first highlevel visit to India since Russia went to war with Ukraine.

Lavrov is arriving on a two day visit to India March 31. "The Russian Foreign minister Sergey Lavrov will pay an official visit to New Delhi March 31-1 April 2022," the Ministry of External Affairs said. RUPEE-RUBLE PAYMENT **METHOD:** Following the US-led sanctions and a few Russian banks being removed from the SWIFT messaging system, Lavrov will deliberate on the rupee-ruble denominated payment method for crude which Russia has offered to India.

New Delhi is not averse to buying Russian oil at a discounted rate. The government recently informed Parliament that it is examining offers from that country to buy cheap crude and an interministerial committee is working on an alternate payment plan.

It is also stated that Reserve Bank of India senior officers are meeting their Russian counterparts to discuss the rupee-ruble payment. Since the start of the war, India has been facing pressure from the West and its allies to take a stronger stand against Russia. **DEFENCE DEALS:** The war between Russia and Ukraine will cost India's military capabilities dearly with the delivery of many platforms like a nuclear powered submarine, Grigorovich class frigates, fighter jets, Triumf S-400, AK 203 assault rifles and others expected to be delayed. Indian leaders will hold discussions with

Lavrov on the issue. As soon as the war began February 24, both India and Russiamaintained there would be no delays with respect to deliveries of critical platforms but with sanctions imposed and the possibility of the war continuing for long, it would have a major impact. India decided to upgrade its military infrastructure when the country was locked in a major faceoff with China along the Line of Actual Control in July 2020. The threat of a two-front war -- from China and Pakistan -- has made India go for large scale arms deals and Russia is still one of India's largest arms suppliers.

#### SC to resume physical hearing from April 4

New Delhi, March 30: The Supreme Court Wednesday said it will resume full-fledged physical hearing of cases from April 4, after a gap of more than two years, when it switched to virtual hearing due to the Covid-19 pandemic. Chief Justice NV Ramana said

the court will resume physical hearing April 4 onwards. "Monday onwards, we are opening fully, physically," he said.

The Chief Justice added that Monday and Friday, the court will provide links to the advocates for the virtual hearing, if they ask for it.

Supreme Court Bar Association president Vikas Singh appreciated the decision to resume physical hearing. "The Bar expresses its gratitude for the decision," said Singh. Currently, the top court is hearing the matters physically Tuesday, Wednesday, and Thursday, and conducts hearings through video conference Monday and Friday. The apex court began hearing cases through video conferencing March 23, 2020 after the outbreak of the Covid-19 pandemic. On February 7, in the backdrop of declining Covid cases, the Supreme Court had said it will resume limited physical hearing from February 14. A circular issued had said: "In view of significant decline in the number of Covid-19 cases and positivity rate, and in the light of the various instructions issued by the

New Delhi, March 30: In a significant move, the Prime Minister-led Cabinet Committee on Security (CCS) Wednesday approved the procurement of 15 indigenously developed Light Combat Helicopters (LCH) at a cost of ₹3,887 crore.

The defence ministry said 10 helicopters will be for the Indian Air Force and five will be for the Indian Army

"The CCS has approved pro-curement of 15 Light Combat Helicopter (LCH) Limited Series Production at the cost of ₹3,887 crore along with infrastructure sanctions worth ₹377 crore," it said. Light Combat Helicopter Limited Series Production (LSP) is an in-

digenously developed combat helicopter containing around 45 per cent indigenous content by value which will progressively increase to more than 55 per cent.

The state-run Hindustan Aeronautics Ltd (HAL) produces the helicopter.

The decision to procure the helicopters came in the midst of the three services focusing extensively on enhancing their overall combat capabilities in view of India facing myriad security challenges including along the borders with China

The LCH is equipped with requisite agility, manoeuvrability, extended range, high altitude performance and all-weather combat capability to perform a range of roles including combat search and



rescue (CSAR), destruction of enemy air defence (DEAD) and counter-insurgency (CI) operations, according to the ministry.

It said the helicopter can also be deployed in high altitude bunkerbusting operations, counter-insurgency operations in the jungle and urban environments and for supporting ground forces.

The helicopter can also be used against slow-moving aircraft and remotely piloted aircraft (RPAs) of adversaries

The ministry said it would be a potent platform to meet the operational requirements of the Indian Air Force and the Indian Army.

"State of the art technologies and systems compatible with stealth features such as reduced visual. aural, radar and IR signatures and crashworthiness features for better survivability have been integrated into the LCH for deployment in combat roles catering to emerging needs for the next three to four decades," the ministry said in a statement.

"Several key aviation technologies like a glass cockpit and composite airframe structure have been indigenised. The future seriesproduction version will consist of further modern and indigenous systems," it said.

The ministry said India is continuously growing in its capability to indigenously design, develop and manufacture advanced cutting edge technologies and systems in the defence sector under the 'Atmanirbhar Bharat Abhiyaan'.

"The manufacturing of the LCH by the HAL will give a further push to Atmanirbhar Bharat initiative and boost indigenisation of defence production and the defence industry in the country," it said.

"The production of LCH will reduce import dependence for combat helicopters in the country. Light Combat Helicopters are already in the import embargo list. With its versatile features builtin for combat missions, LCH hasthe export capability," the

ministry said.

"The money given for halal products is used for anti-national activities. The money collected here will be used to bring out jailed criminals of terrorist organisations.'

"One of the Popular Front of India (PFI) leaders got Rs 15 crore transferred to his account during the Shaheen bagh protest. Akbar and Aurangzeb (Muslim kings who ruled India) had taxed Hindus, he maintained.

#### Stand after studying objections: Bommai

After calls for ban on halal products in Karnataka grew, Chief Minister Basavaraj Bommai Wednesday said that the state government would spell out its stand after studying the issue. In the latest campaign targeting Muslims, Hindu organisations and BJP leaders in the state have begun raising objections to sale of halal meat to Hindus. The development comes in the wake of the recent ban calls made by the right wing groups on Muslim shops and stalls at Hindu religious fairs and temple premises in the coastal regions of Karnataka. The issue has to be studied in its entirety, Bommai told media persons Wednesday. The Chief Minister said that the state government will examine the serious objections raised in some quarters over the issue. There are no rules as such. It was a practice that was going on. Now, serious objections are raised. We will look into it, he said. Bommai refused to be drawn into the controversial calls for boycott of halal meat, being raised by Hindu right wing groups in the state. Pointing out that similar campaigns have been organised, "We'll respond to those who need a response," he said.

### **EXAM CANCELLED IN 24 UP DISTS**

Lucknow, March 30: The Class 12 English exam of the Uttar Pradesh school board was cancelled in 24 districts Wednesday after the question paper was leaked, prompting CM Yogi Adityanath to order invoking the stringent National Security Act in the case.

The Ballia police have detained 11 people for questioning, a senior official said.

The CM also ordered the Special Task Force (STF) of the Uttar Pradesh Police to probe the case. An official has also been suspended. The English paper cancelled in 24 districts will now be held April 13, an official statement said here.

Additional Director General of Police (Law and Order) Prashant Kumar said the Ballia DM and SP got information Wednesday morning that the second shift paper has been leaked.

The exam was to be held at 2 pm. It appears the English question paper of Class 12 was leaked in Ballia. The matter is being looked into and strict action will be taken against the guilty, UP Secondary

Education Minister Gulab Devi said. Asked why the exam was cancelled in only 24 districts, she said it was done in only those districts where the leaked paper was distributed.

The English paper with series 316 ED and 316 EI was leaked before the exam that was to begin at 2 pm. The incident was treated with seriousness by Chief Minister Yogi Adityanath. DIoS (District Inspector of Schools) of Ballia Brajesh Kumar Mishra has been suspended and the STF has been asked to investigate the matter, the statement said.

The exam in 24 districts will be held on April 13 in the first shift between 8 am and 11.15 am.

#### 7.8 LAKH DROPOUT FROM BOARD EXAMS IN 4 DAYS

LUCKNOW: Nearly 7.8 lakh students have dropped out of the ongoing Class 10 and 12 examinations of the Uttar Pradesh Madhyamik Shiksha Parishad (UPMSP), also known as the UP Board. On Monday, a whopping 2.9 lakh class 10 and 12 students skipped their exams. Class 10 and 12 students had Computer and Geography exams respectively Monday. According to official sources, the 7.8 lakh figure surpasses the total dropouts recorded in 2020 (4.8 lakh) and 2019 (6.5 lakh). There were no exams in 2021 due to Covid-19 pandemic. The UP Board exams began March 24. In fact, the number of students skipping the exam so far is the highest in almost a decade. The UP Board 2022 examinations saw 4.1 lakh students missing the examinations on day one when Hindi exam was slated for both Class 10 and 12. The UPMSP saw over 70,200 students not attending their languages paper which was held March 26. The languages include Urdu, Tamil, Bengali, Assamese, Gujarati, Punjabi, Nepali, etc. The high numbers have now forced officials to probe the reasons for dropouts.

#### 7 suspended for allowing girls in hijab to exams

In his complaint he has warned that if action is not taken, protest will be staged.

### Water wastage now an offence in UP's Pilibhit

Pilibhit, March 30: With the possibility of summer being harsher this year, the Pilibhit district administration in Uttar Pradesh has announced that wastage of water at automobile service stations and public places will now be a state offence.

Pilibhit has become the first district in the state to have announced such a move. The penalty for flouting the rule will be decided soon, said officials.

Chief Development Officer (CDO), Prashant Srivastav, said that the administration will also impose a ban on the plantation of eucalvotus in the district since it absorbs large amounts of groundwater. Uttar Pradesh has ranked first in the entire country in the sphere of water conservation and management and we wish to continue with our efforts, he said

He further said that notices are being issued to automobile service stations in the district, making it mandatory for them to use soak pits for recharging water that they use in large quantities for cleaning cars and bikes every day.



Amitabh Agnihotri, Vice President of NGO Wildlife Biodiversity Conservation Society, said, "A single automobile service station can use up to 10,000-12,000 litres of water in a day. Most of this water is groundwater, which is drinkable. There is a pressing need to keep a check on such wastage.

The setting up of any new service station would also now need prior permission from the minor irrigation department. It would be subject to the compulsory provision of a soak pit, the CDO said.

In public places, the administration plans to keep a check on issues such as broken water pipelines

and overflowing taps. Prohibition on the cultivation of summer paddy would be made more rigorous for the conservation of groundwater, the CDO added.

### Questions leave UP students stumped

Lucknow, March 30: Ever thought of an antonym for 'tree' or the opposite of 60? The students in the state-run schools in Uttar Pradesh are facing weird questions in their ongoing annual examinations.

A Hindi question paper in a Prayagraj school asked the Class 5 students the opposite of 'ped' (tree), while an English question paper in Bhadohi district asked the Class 7 students to write the opposite of 60. Class 5 students in Prayagraj were asked to identify the rectangle among the figures in an English question paper.

While it was bizarre to have a mathematics question in an English paper, the fact that the choices for this question had no figures. The issue has now snowballed into a major controversy and a probe has now been ordered into the matter.

Director General, school education, Anamika Singh said, "Despite Covid and elections, we managed to hold annual examinations after two years. I have directed the UPBEC secretary to examine issues related to ques-



tions and take appropriate action on the same.

The responsibility to prepare question papers for the exams is given to the basic shiksha adhikari (BSA) who rope in teachers at the District Institute of Education and Technology (DIET) for paper setting.

Ideally, the papers should be prepared on the model prepared by the State Council of Educational Research and Training (SCERT).

Over 1.6 crore students, enrolled in 1.3 lakh schools recognised by UPBEC, are appearing in these examinations.

An error-free question paper ঽ can ensure proper evaluation. Even though no student can fail till Class 8, these silly errors point fingers at the standard one is setting before the students and teachers, said a senior education official. He addedthat question papers should be

### **Penalty for non-linking** of PAN with Aadhaar

After March 31, 2023, the PAN of taxpayers who fail to intimate their Aadhaar, as required, shall become inoperative and all the consequences under the Act for not furnishing, intimating or quoting the PAN shall apply to such taxpayers

New Delhi, March 30: The Income Tax Department Wednesday said non-linking of PAN with Aadhaar by March 31 would attract penalty of up to Rs 1,000, but such PAN will remain functional for one more year till March 2023, for filing ITR, claiming refunds and other I-T procedures.

The Central Board of Direct Taxes (CBDT), which is the apex decision making body on direct taxes, has extended the deadline for linking Permanent Account Number (PAN) with Aadhaar many times and the last date now is March 31. 2022. As per a circular issued by CBDT on Wednesday, PAN, not linked to Aadhaar, would become "inoperative" after March 31, 2023. Those taxpayers who link their PAN with biometric Aadhaar by June 30, 2022, would be required to pay late fees of Rs 500. Beyond that, the penalty would rise to Rs 1,000.

In order to mitigate the inconvenience to taxpayers, as per no-



tification dated March 29, 2022, a window of opportunity has been provided to taxpavers up to March 31, 2023 to intimate their Aadhaar to the prescribed authority for Aadhaar-PAN linking without facing repercussions, the CBDT said, adding such intimation would have to be accompanied by late fees.

"However, till 31st March, 2023 the PAN of the assessees who have not intimated their Aadhaar, will continue to be functional for the procedures under the Act, like furnishing of return of income, processing of refunds etc," the CBDT statement said.

As per data available, till January 24, 2022, more than 43.34 crore PANs have been linked with Aadhaar. Over 131 crore Aadhaar cards have been issued so far. PAN-Aadhaar linkage would help in eliminating duplicate PAN and curbing tax evasion. AKM Global, Tax Partner, Amit Maheshwari said "It is ad-

visable for taxpayers to check their income tax portal and ensure that Aadhaar and PAN are linked. NRIs may have some concerns since in some cases they do not have Aadhaar." Nangia Andersen LLP Partner Neeraj Agarwala said, while PAN is used for various transactions like opening a bank account, purchase of immovable property or proof of identity, inactive PAN will trigger domino effect and individual who have not linked their Aadhaar may face multiple challenges. "Once your PAN becomes inactive, the person will be restricted from doing financial transactions (where quoting of PAN is mandatory like mutual funds), subjected to TDS at higher rates and penalty under section 272B," Agarwala said. ### BJP team claims 'mafia rule' in WB

New Delhi/Darjeeling, March 30: A BJP fact-finding team Wednesday submitted its report to party chief J P Nadda on the recent massacre of nine people in West Bengal's Birbhum, claiming "mafia rule" prevailed in the state with the connivance of police and political leadership, provoking sharp reaction from Chief Minister Mamata Baneriee, who said the report will "weaken and interfere" with the CBI probe in the case.

The BJP team, including four former IPS officers, demanded central intervention for restoration of the "collapsed" law and order situation in the state.

The party had constituted a fivemember team in the aftermath of the violence in Bogtui village in Birbhum district, where eight people were burnt alive, while one more succumbed to the injuries a week later, after a mob set some houses ablaze allegedly in retaliation for the killing of a ruling TMC leader Bhadu Sheikh March 21.

The panel comprised Rajya Sabha MP and former Uttar Pradesh police chief Brajlal, Lok Sabha MP and former Mumbai police commissioner Satyapal Singh, Rajya Sabha MP and former IPS officer KC Ramamurthy, a national spokesperson for the party, former West Bengal cadre IPS officer Bharati Ghosh and state BJP chief Sukanta Majumdar.

The law and order machinery has totally collapsed in West Bengal under the TMC rule and there is a rule of the mafia in the state that's run with the connivance of police and the political leadership, the report said.

West Bengal Chief Minister and TMC boss Mamata Banerjee reacted with expected outrage and alleged that the BJP wants to arrest all those who are against it. Lashing out at the saffron party, Banerjee said the report mentions the name of TMC Birbhum district presi-

dent Anubrata Mondal, which "clearly shows the vindictive attitude of the BJP".

#### **Chirag evicted from** bungalow allotted to father Ram Vilas Paswan



New Delhi, March 30: Chirag Paswan, Lok Sabha MP and son of former Union minister Ram Vilas Paswan, is being evicted from the bungalow allotted to his late father. sources said. The government has sent a team to the premises at 12 Janpath Road and Chirag Paswan's belongings are being removed.

The process of moving furniture and household goods from the bungalow in Janpath in Lutyens' Delhi started shortly after a team from the Directorate of Estates, which comes under the Union Housing and Urban Affairs Ministry, reached the property, official sources said.

Two loaded trucks drove out of the 12 Janpath bungalow, which was the official address of the Lok Janshakti Party (LJP), while three more were parked in front.

The bungalow is earmarked for Union ministers and the occupants of the government accommodation have been asked to vacate it, officials said.

The LJP split into two following differences between Chirag Paswan and his uncle Pashupati Kumar Paras after the death of former Union minister Ram Vilas Paswan. Both are locked in a power tussle for the LJP's leadership.

#### **Doctor's suicide** in Raj: Oppn raises questions on system

Jaipur, March 30: The suicide by a gynaecologist Archana Sharma in Rajasthan after being booked under Section 302 (murder) has snowballed into a political controversy with the opposition claiming it to be the death of the system while the government promised to conduct a fair investigation into the matter.

Chief Minister Ashok Gehlot Wednesday expressed grief over the incident. In his tweet, he said, "We treat doctors as God. Every doctor does his best to save the life of the patient. But it is not justified to accuse the doctor as soon as any unfortunate incident happens. If doctors will be intimidated like this, then how will they be able to do their work with confidence. We all should think that in the time of Covid pandemic or in case of suffering from other ailments, the doctors served everyone by risking their lives. How can such treatment be meted out to them.

Gehlot said that the whole matter is being investigated seriously. The guilty will not be spared. Former Chief Minister and BJP leader Vasundhara Raje said that there should be a fair investigation into this incident.

State health minister Parsadi Lal Meena said that the incident is sad. This should not have happened. This is the negligence of the administration.

### Govt: India eyes global satellite launch market

New Delhi, March 30: India is eyeing a share in the global satellite launch market and has secured four dedicated launch service contracts with foreign customers, the government told Lok Sabha Wednesday.

"With the emergence of global  $broadband\ communication\ needs,$ NewSpace India Limited (NSIL) envisages launches of several of these foreign satellites onboard ISRO's SSLV, PSLV and GSLV-MkIII," Minister of State in PMO Jitendra Singh said in a written reply.

Singh said NSIL, a central public sector enterprise under Department of Space, has earned a foreign exchange revenue of 35 million dollars and 10 million euros

during the last three years - 2019-21, through launching satellites of various private and international agencies.

He said NSIL has already launched 45 international customer satellites on-board ISRO's PSLV during the last three years and has secured four dedicated launch service contracts for foreign satel

lite customers. Singh said NSIL, through participation in various international conferences and exhibitions, is ensuring a better footprint of ISRO's expertise in building earth observation and communications satellites, providing launch and mission support services including establishment of ground segments for foreign customers to ensure enhanced foreign exchange rev-

he Small Satellite Launch Vehicle (SSLV) is India's newest launch vehicle to put smaller satellites in low earth orbit. Its first developmental flight is expected in May

### ARE FOREST FIRES IN INDIA INCREASING

MORE THAN 36 PER CENT OF INDIA'S FOREST COVER HAS BEEN ESTIMATED TO BE PRONE TO FREQUENT FIRES. NEARLY FOUR PER CENT OF THE FOREST COVER IS EXTREMELY PRONE TO FIRE WHEREAS SIX PER CENT IS FOUND TO BE VERY HIGHLY FIRE PRONE, THE FSI REPORT SAID

New Delhi, March 30: As the visuals of IAF choppers carrying large buckets of water to douse the forest fire in Sariska Tiger Reserve went viral on social media Tuesday, several people linked it with the prevailing heat wave conditions in northwest India, including large parts of Rajasthan.

Still many others said that the changing climatic conditions are bound to increase such forest fires in India. But is it the case?

Two IAF helicopters flew more than 10 hours Tuesday dispensing more than 33,500 litres of water over the affected area in Sariska, and the operation that continued on Wednesday, following which the Rajasthan government said

Wednesday that as much as 80 per cent of the fire has been controlled. The cause of the fire has not yet been ascertained.

But Sariska is neither the only place nor Rajasthan the only state that saw forest fire. According to the Forest Survey of India (FSI) report, the forest fire season in the country is normally from November to June and with majority fires being caused due to man-made reasons.

During the forest fire season 2019-2020, the number of hotspots detected by two satellite sensors was 22,447 and 1,24,473 while in the fire season 2020-21, the total hotspots were 52,785 and 3,45,989 respectively.

In 2020-21, among the states, the maximum number of fire detections were observed in Odisha

(51,968) followed by Madhya Pradesh (47,795), and Chhattisgarh (38,106);

Rajasthan does not even figure in The FSI issues pre-fire alerts using overlaying factors such as rainfall, rather the deficit of rain. inputs from the Meteorological

Department, satellite data from

NASA and the forest cover layer etc. "Apart from these pre-fire alerts, we also issue a Fire Danger Rating System. After the pilot that started in 2016, we started for all India from 2019-20," said Sunil Chandra

from the FSI Heat wave & Climate Change Since mid-March, large parts of

Rajasthan, including Alwar district - home to Sariska Tiger Reserve - have been witnessing heat wave conditions.

"The forest fires in the Sariska Tiger Reserve look like a case of extreme heat exacerbating the fire. The intensity and increasing frequency of forest fire also points to the dangers this poses for biodiversity and the decades of efforts which have gone into wildlife conservation. These temperatures are much ahead of any predicted seasonal heat waves and speaks to non-linear impacts of climate change in some ways," said Aarti Khosla, Director, Climate Trends, an advocacy non-profit.

This was echoed Ravi Chellam. a member of Biodiversity Collaborative, a network of institutions and individuals promoting biodiversity research and conservation.

"Forest fires are part of the natural ecology of many ecosystems across the world. In fact, there are many habitats and species which are fire dependent. (But) It is the increasing frequency, intensity and scale of these fires which is aided and exacerbated by climate change and that too in the context of accelerating loss, fragmentation and degradation of habitats which is the problem.'

Forest fire is not a new thing either for Sariska or Rajasthan but the extent to which fire spread this time is larger, he said, adding, the bigger animals are hardly affectedbut damages ground nesting and smaller animals.

The Pakistan Army helicopter was deployed on peacekeeping duties with the **United Nations Organisation** Stabilisation Mission in the Democratic Republic of the Congo (MONUSCO) and it crashed during a reconnaissance operation March 29, Foreign Office said.

#### 12-year-old killed by younger sibling

St. Louis: A 10-year-old boy fatally shot his 12-year-old brother as the two played with a gun they found inside a St. Louis home, police said. The shooting happened Tuesday night in a north St. Louis neighbourhood, KMOV-TV reported. Police said the boys were with a parent who was getting a haircut in the home when the older boy was shot in the face. The death follows a spate of shootings in St. Louis involving children handling guns. On Friday, two young cousins who were live streaming from a St. Louis apartment died when one child fatally shot the other before killing herself.

# Russia pounds Ukraine cities

'UKRAINIANS ARE NOT NAÏVE' SAYS ZELENSKYY

Lviv, March 30: Russian forces bombarded a besieged city in northern Ukraine Wednesday, a day after promising to scale down operations there, and Kyiv and its Western allies dismissed a pullback near the capital as a ploy to regroup by invaders taking heavy

Nearly five weeks into an invasion in which it has failed to capture any major cities, Russia said it would curtail operations near Kyiv and the northern city of Chernihiv "to increase mutual trust" for peace talks.

But Chernihiv's Mayor Vladyslav Astroshenko said Russian bombardment had only intensified over the past 24 hours, with more than 100,000 people trapped in the city with just enough food and medical supplies to last about another week. "This is vet another confirmation

that Russia always lies," he told CNN in an interview. "They actually have increased the intensity of strikes," with "a colossal mortar attack in the centre of Chernihiv' Wednesday wounding 25 civilians.

In an overnight address, Ukraine's President Volodymyr Zelenskyy made clear he took noth-

ing Moscow said at face value. 'Ukrainians are not naive people," he said. "Ukrainians have already learned during these 34 days of invasion, and over the past eight years of the war in Donbas, that the only thing they can trust is a con-

Zelenskyy advisor Oleksiy Arestovych said Moscow was shifting some forces from northern Ukraine to the east, where it was trying to encircle the main Ukrainian force there. Some Russians would stay behind near Kyiv to tie Ukrainian forces down, he said.

The past week has seen Ukrainian forces make substantial gains, recapturing towns and villages on the outskirts of Kyiv, breaking the siege of the eastern city of Sumy and pushing back Russian forces in the southwest.

The Pentagon said Russia had started moving very small numbers of troops away from positions around Kyiv, describing the move as more of a repositioning than a withdrawal

#### Poland set to end all **Russian oil imports:** Germany warns on gas

Warsaw: Poland will take steps to end all Russian oil imports by the end of 2022, the Prime Minister said Wednesday, as Germany triggered an early warning level for natural gas supplies and called on consumers to save energy amid Russia's war in Ukraine. Poland has already largely reduced its dependence on Russian oil, Prime Minister Mateusz Morawiecki said. Morawiecki told a news conference that Poland was launching the most radical plan among European nations to wean off Russian energy sources. Poland said Tuesday it was banning imports of Russian coal. Morawiecki said he expects gas imports will be cut in May. In Germany, the government triggered an early warning level for natural gas supplies and called on consumers to save energy amid concerns that Russia could cut off deliveries unless it is paid in rubles. Economy Minister Robert Habeck said the move was a precautionary measure as, so far, Russia is still fulfilling its contracts. But he appealed to companies and households in Germany to start reducing their gas consumption.

### HISTORIC SUMMIT Jordan, Israel leaders meet

The Israeli-Palestinian conflict, including Israel's nearly 55-yearold occupation of the West Bank and East Jerusalem, has long weighed on relations between Israel and Jordan, who have been peace partners since 1994.

# Gas price set to double this week Axis Bank to buy Citi's India biz for \$1.6billion

The government sets the price of gas every six months -- April 1 and October 1 -- each year based on rates prevalent in gas surplus nations such as the US, Canada and Russia in one year with a lag of one quarter

New Delhi, March 30: In a bonanza for gas producers, Reliance Industries is set to get a record price of around \$10 per MMBtu for the KG gas, while state-owned ONGC is likely to fetch more than double the rate for its Mumbai High and other fields, sources said.

The government-dictated price for natural gas produced in the country is to be revised April 1 and factoring in the spike in energy prices witnessed last year, the rate paid for gas produced from fields given to state-owned Oil and Natural Gas Corporation (ONGC) on nomination basis is likely to rise to \$5.93 per million British thermal units from current \$2.9.

Simultaneously, difficult fields like the ones in Reliance and its partner bp plc operated D6 block in KG basin, are likely to get \$9.9-10.1 price compared to the current rate of \$6.13, two sources aware of the matter said. These are the highest rates for administered/regulated fields (like ONGC's Bassein field off the Mumbai coast) and



The sources said the increase in gas price is likely to result in a rise in CNG and piped cooking gas rates in cities, such as Delhi and Mumbai

It will also lead to a rise in the cost of generating electricity but consumers may not feel any major pinch as the share of power produced from gas is very low

Similarly, the cost of producing fertiliser will also go up but as the overnment subsidises the crop nutrient, an increase in rates is unli

free-market areas (such as the KG basin).

Also, this will be the second increase in rates since April 2019 and comes on the back of firming benchmark international prices. So, the price for April 1 to September 30 is based on the average price from January 2021 to December 2021. This is the period when global rates shot through the roofs

The volume-weighted average of the price prevalent in a 12-month period in US-based Henry Hub, Canada-based Alberta gas, UK- based NBP and Russia gas are used to fix price for administered fields of ONGC and Oil India Ltd.

For difficult fields like discoveries in deepwater, ultra-deepwater and high pressure-high temperature areas, a slightly modified formula is used by incorporating the price of LNG, which too had shot through the roof in 2021.

For producers, this will be the first time in six years that they will get a remunerative price.

ONGC had been incurring losses on the 65 million standard cubic me ters per day of gas it produces from domestic fields shortly after the government in November 2014 introduced a new gas pricing formula that had "inherent limitations" as it was based on pricing hubs of gas surplus countries such as the US, Canada, and Russia.

The sources said ONGC had in several communications to the government has stated that the break-even price to produce gas from new discoveries was in the range of \$5-9 per MMBtu and that for old fields such as Mumbai High and Bassein is about \$3.6-3.7.

New Delhi, March 30: Citi Bank Wednesday joined the list of foreign banks that have exited the retail banking business in India as the US-based banking giant announced selling its consumer banking portfolio to Axis Bank for an estimated ₹12,325 crore.

In a mega-deal announcement Wednesday, Axis Bank and Citibank said their boards have approved acquisition of Citibank's consumer businesses in India by Axis Bank.

Under the deal, the US-based Citi will sell consumer banking businesses of Citibank India, which includes credit cards, retail banking, wealth management and consumer loans

Citi's scaling down of operations in India is part of its strategy to exit retail businesses in 13 markets to conserve capital and focus on higher-yielding revenue streams. It had entered India in 1902 and started the consumer banking business in 1985.

Earlier in 2012, British banking major Barclays massively scaled down India operations by closing a third of its branches located in the non-metro areas. Shrinking its operations in India was part of the UK based bank's strategy to move away from retail banking to concentrate more on the corporate banking, investment banking and wealth management verticals.

In 2016, Commonwealth Bank of Australia exited India operations saying the decision was taken after a careful evaluation of its India opGlobal banking majors such as ANZ Grindlays, RBS, Commonwealth **Bank of Australia have** scaled down their operations in India

erations alongside its refocussed strategy.

The same year, Royal Bank of Scotland Plc (RBS) too decided to wind up its corporate, retail, and institutional banking business in the Indian market as it wanted to reduce its global footprint.

Australia and New Zealand Bank had in 2000 wound up domestic operations here after selling its Grindlays Bank unit to Standard Chartered for \$1.34 billion. However, it re-entered the Indian market in 2011 by opening a new branch in Mumbai. ANZ was in India since 1984 through its presence as Grindlays Bank.

In 2011, Deutsche Bank sold its credit card business to IndusInd Bank. In 2013, UBS exited India operations while, Morgan Stanley surrendered banking license while continuing investment banking

Likewise, Merril Lynch,

Barclays and Standard Chartered scaled down their operations in 2015. Among others, HSBC shut down two dozen branches and reduced its presence in 14 cities in\_ 2016 and BNP Paribas shut down its wealth management business in India in 2020

#### Ind-Ra cuts FY23 GDP hope to 7-7.2% India cuts coal supply, halts auctions

New Delhi, March 30: India has cut coal supplies to the non-power sector and put on hold plans for some fuel auctions for utilities without supply deals due to a slump in inventories, even as the country battles a seasonal jump in demand for electricity. The supply cuts come months

after India's most crippling coal shortage in the recent years led to power cuts lasting up to 14 hours in some states and amid worries gruelling summer temperatures will exacerbate shortages.

Coal inventories at state government-owned utilities, which account for a third of all coal-fired plants, have slipped to 22% of mandated quantity, the lowest this year. Inventory levels below 25% are considered "critical" State-run Coal India, which ac-

counts for more than 80% of domestic output, has slashed supplies to the non-power sector which includes aluminium smelter and steel mills - to 275,000 tonne a day, according to an internal company note seen by Reuters, 18.3% lower than February and 29.8% below March 2021.

Coal India told Reuters that its supplies to the non-power sector were in line with its average over the "past few years", without elaborating.

Among other measures to tighten supply, the federal coal ministry has put on hold a plan to conduct three coal auctions for utilities over the next three months and will organise one auction for the quarter instead, saying the methodology to conduct three auctions was "under process"

South Eastern Coalfields, a unit of Coal India, has extended the due date for payment for auctions conducted March 11, thereby delaying supply, and also cancelled another auction scheduled for March 21, according to no-

### CCI raids 3 tyre

New Delhi, March 30: The 'Emergency Credit Line Guarantee Scheme' (ECLGS) has been extended beyond March 2022, till March 2023

Accordingly, the ECLGS extension and enhancement announcement which was made by the Union Finance and Corporate Affairs Minister Nirmala Sitharaman in Union Budget 2022-23 was put into effect by the National Credit Guarantee Trustee Company Wednesday.

Further, the coverage, scope and extent of benefits under ECLGS 3.0 pertaining to hospitality, travel, tourism and civil aviation sectors has been expanded, said the Union Finance Ministry

"New borrowers in the sectors covered under ECLGS 3.0 who have borrowed after March 31, 2021 and

up to January 31, 2022 will also now be eligible to avail of emergency credit facilities under ECLGS 3.0," the ministry said in a statement.

"The extent of emergency credit facilities that may be availed of under ECLGS 3.0 has been increased for eligible borrowers in all sectors covered under ECLGS 3.0. Eligible borrowers in all such sectors (other than the civil aviation sector) are now permitted to avail up to 50 per cent of their highest fund based credit outstanding... This is subject to the existing maximum of ₹200 crore per

borrower. As per the statement, keeping in view the high proportion of non-fund based credit in the overall credit of the civil aviation sector, eligible borrowers in the civil aviation sector are now permitted to avail of nonfund based emergency credit facilities as well under ECLGS 3.0.

### Hackers steal over \$600 million in major crypto heist

San Francisco, March 30: Hackers stole cryptocurrency worth over \$600 million from a digital ledger used by players of the popular online game Axie Infinity, in a major digital cash heist revealed Tuesday.

Interest in cyptocurrency has boomed, along with its values, but the money has also become an attractive target for tech savvy thieves.

Ronin Network said the attack targeting its blockchain netted 173,600 ether and \$25.5 million worth of stablecoin, a digital asset pegged to the US dollar.

The haul was valued at \$545 mil-

lion when it was stolen on March 23, but was worth about \$615 million based on prices Tuesday, making it one of largest thefts ever in the crypto world.

'Most of the hacked funds are still in the hacker's wallet," Ronin

said in a post revealing the theft. The team at Sky Mavis, maker of battle and trading game Axie Infinity, discovered the security breach on Tuesday after a user was unable to withdraw ether, according to the company.

Ronin was still investigating the hack. but said that hackers got hold of private "keys" to withdraw digital funds.



"We know trust needs to be earned and are using every re-

source at our disposal to deploy the most sophisticated security measures and processes to prevent future attacks," Ronin said.

"We are working with law enforcement officials, forensic cryptographers, and our investors to make sure there is no loss of user funds.'

In Axie Infinity, players participate in battles using colorful bloblike Axies, and are mainly rewarded "Smooth Love Potion" (SLPs) that can be exchanged for cryptocurrency or cash - or invested back into the game's virtual world Lunacia.

About 35 percent of Axie Infinity traffic - and the biggest share of its 2.5 million daily active users -comes from the Philippines, where high proficiency in English, strong gaming culture and widespread smartphone usage have fuelled its popularity, according to Sky Mavis. To play the game, players first

have to purchase at least three An Axie is an NFT -- a unique,

non-fungible token, with a particular set of abilities and characteristics. Like NFT pieces of art, they are stored on the blockchain - a digital ledger that cannot be changed.

Axies can be bought, sold or rented to other players. Ownerscan also breed them to create new Axies that provide more value.

#### Rajapaksa seeks Virat tips on fitness issues

**NEW DELHI:** Skills "come first" for Bhanuka Rajapaksa but the Sri Lankan batter has realised that survival in modern-day cricket is not possible without attaining required fitness standards.

Dropped from the national team over fitness issues, Rajapaksa now wants to have a conversation with a supremely-fit Virat Kohli, who he calls the 'Cristiano Ronaldo of cricket'.

The 30-year-old announced his international retirement this January and withdrew it a week later on the insistence of authorities. However, he still missed the plane to India due to the same fitness issues, last month.

"IPL is the best league in the world and with every teammate of yours you get to learn a lot about the game, so I am loving picking the brains of Shikhar Dhawan. I get along very well with Mayank Agarwal as we played U-19 together," Rajapaksa told this agency in an interview.

"Outside of the team Virat Kohli is always someone I could speak to and get some advice on fitness. He's at another different level when it comes to fitness

'To me, he is the Cristiano Ronaldo of cricket for sure. The work he puts in you can obviously see the results. You can compare him to anyone when it comes fitness or even skills wise. He plays so hard and you can learn a lot by talking to him." he said.

On the 'fitness versus skills' debate, Rajapaksa has a clear view. "As a player you need your fitness but it could be different from person to person. For me, of course, skill comes first. And then the fitness, but if you are not fit enough

you definitely can't perform. "I'm actually working hard on my fitness. Whenever I get a free day I hit the gym early in the morning. That there are some fitness requirements to represent the country and with fitness, my international career would be longer.

"I'm hoping to play for the next three to four years at least and do the best for the country because after my resignation I had to withdraw it back because I had a couple of conversations with the technical committee and the Sports Minister as well. They wanted me to reconsider my retirement and I decided to withdraw it," he said

Rajapaksa feels he is now doing "all the right things" as he looks to extend his international career by at least three to four years.

Washington, March 30: Cristiano Ronaldo will get another shot at lifting the World Cup. Portugal beat North Macedonia 2-0 in a European play-off Tuesday, securing a fifth World Cup appearance for the leading men's international scorer. It was one of seven spots in football's pre-

mier tournament decided on the day. Thirty-two teams, including the hosts, will play in Qatar starting November 21. As of Tuesday, 27 teams had qualified with two additional spots to be determined Wednesday. Two intercontinental playoffs will be held in June along with two games to determine the final European berth.

Portugal's win finalized the eight seeds for Friday's draw: Qatar, Argentina, Belgium, Brazil, England, France, Portugal and Spain. Pot two



will include Croatia, Denmark, Germany, Netherlands, Switzerland and Uruguay, and if the teams qualify Wednesday Mexico and the USA.

While the 37-year old is a lock for

his team's roster in Qatar, fellow in-

ternational star Mohamed Salah will

miss out after Egypt fell to Senegal. Senegal advanced on a penalty shootout for one of Africa's five berths after fans shone lasers in

Salah's face while he stepped up to

take Egypt's first penalty kick. He blasted his attempt over the crossbar while he had green-colored lasers pointed at his face and body. Salah's Liverpool teammate Sadio Mané struck the winning penalty after the teams drew 1-1 on aggregate, sending Senegal to its third World Cup.

Ghana qualified after a 1-1 draw with Nigeria to advance on away goals. Algeria won its first leg, vying to qualify after missing out on the 2018 World Cup, but Cameroon came back with a 2-1 victory. Morocco downed the Democratic Republic of the Congo 4-1 to secure its spot 5-2 on aggregate.

Robert Lewandowski converted a penalty in the 50th minute and Poland secured its second straight World Cup berth with a 2-1 victory over Sweden. The Asian region teams that qualified are Iran, South Korea, Japan and Saudi Arabia.
