New Delhi, April 5: The Ministry of Information and Broadcasting (I&B) has directed the blocking of 22 YouTube (YT)-based news channels, of which four are from Pakistan, for allegedly spreading fake news to mislead viewers.

This is the first time that action has been taken against the Indian YouTube-based news publishers

since the notification of the IT Rules, 2021 in February last

year, it said.

In an official statement, the ministry said that it issued an order to block 22 YouTube channels, three Twitter accounts, one Facebook account and one

'Through the recent blocking order, 18 Indian and four 4 Pakistanbased YouTube news channels have been blocked," the ministry said, without naming them.

According to the ministry, multiple YouTube channels were used to post "fake news on various subjects such as the Indian Armed Forces, Jammu and Kashmir, etc. "The content ordered to be blocked also included certain anti-India $content\ posted\ from\ multiple\ social$ media accounts operated in a coordinated manner from Pakistan.

"It was observed that a significant amount of false content was published by the Indian YouTube channels related to the ongoing situation in Ukraine, and aimed at jeopardising India's foreign relations with other countries," it said. The ministry said that the

blocked Indian YouTube channels were using templates and logos of certain TV news channels, including images of their news anchors to mislead the viewers to believe that the news was authentic.

"False thumbnails were used, title and thumbnail of the videos were frequently altered to increase the virality of content on social media. In certain cases, it was also observed that systematic anti-India

fake news was security, sovereignty and integrity originating from Pakistan," it said. "The Government of India re

mains committed towards ensuring an authentic, trustworthy, and safe online news media environment, and thwarting any attempts at undermining India's sovereignty and integrity, national security, foreign relations, and public order,' the ministry said.

Fake doc's 2nd wife held for abetting his fraud

Bhubaneswar, April 5: The second wife of fake doctor Ramesh Chandra Swain has been arrested from Jharkhand on charges of helping him to get married multiple times and duping the other women, police said here Tuesday.

Swain, the 66-year-old man from Kendrapara district, had as many as 18 wives across seven states over 38 years. He allegedly duped the women of lakhs of rupees by posing as a doctor.

Swain's second wife, a medical practitioner, was arrested Monday for allegedly helping him in the

She is being brought to Odisha Tuesday on a transit remand, a police officer said.

The woman was employed at Jamnagar in Gujarat and was absconding since Swain's arrest February 23 this year.

Fake doctor Ramesh Chandra Swain

Earlier, the police had arrested another woman who claimed to be Swain's sister while probing the fraud committed by the 66-year-old. The police came to know about his second wife's involvement during Swain's interrogation, sources said.

A father of five children, Swain had married his first wife in 1982 and second wife in 2002.

Between 2002 and 2020, he befriended other women through matrimonial websites and mar-

A case had been registered against Swain at the Mahila police station here under various sections of the Indian Penal Code

Swain's activities came to fore after a school teacher from Delhi, who was married to him, lodged a complaint at Mahila Police Station here in July 2021 alleging that the accused had married her in New Delhi in 2018 and kept her in Bhubaneswar.

She came to know about his multiple marriages and then sought the help of the law enforcers.

Immediately after the case was registered at the police station, Swain fled from the city and stayed with another wife in Assam.

The fake doctor was nabbed when he returned to his apartment in the city about six

New Delhi, April 5: BJD MP Prasanna Acharya Tuesday urged the Centre to construct a memorial of Veer Surendra Sai at the Asirgarh fort in Madhya Pradesh, where the freedom fighter had spent his last days.

Berhampur/Kendrapara, April 5: More than 10 lakh Olive Ridley turtles have crawled ashore this year to the two major mass nesting sites in state to lay eggs in one of the largest congregations of the vulnerable species, officials said.

The number was much less last year since no mass nesting had taken place at Rushikulva in 2021. Around 7.30 lakh turtles had turned up for mass nesting in both Gahirmatha and Rushikulya in 2020.

The migratory turtles, deriving their name from the olive-green shell, travel from the South Pacific Ocean and turn up in millions every year at the Odisha coast, the largest massnesting site for the species.

This year, incidentally, the congregation at the Rushikulva estuary (river mouth) in Ganjam district was more than Gahirmatha, one of the world's most important nesting beaches for the sea turtle species.

According to a forest official, a record number of 5.5 lakh turtles congregated at the Rushikulya estuary during the eight-day mass nesting that ended Sunday.

"The nesting, which began on the five-km-long island near the Rushikulya river mouth on March 27, broke all the records at the rookery," Berhampur Divisional Forest Officer (DFO) Amlan Nayak said.

The previous highest at Rushikulva was 4.82 lakh in 2018. There was sporadic nesting last year, but no mass nesting, Nayak said.

"We can't say why more turtles preferred the Rushikulya rookery. It's a natural phenomenon," Nayak said.

Around five lakh marine turtles arrived at the Gahirmatha Marine Sanctuary in Kendrapara district this year, for over four days since March 25, Rajnagar Mangrove (Wildlife) Divisional Forest Officer JD Pati said

In Gahirmatha last year, around 3.5 lakh Olive Ridleys, the most abundant and one of the smallest sea tur-



tle species in the world, had turned up en masse from March 9-23.

Meanwhile, at least a dozen female adult turtles, out of around 500 tagged by the Zoological Survey of India in the Rushikulya rookery last year to study their nesting behaviour, have returned to the same beach to lay eggs, scientists said.

The Olive Ridley falls under the vulnerable category of the International Union for Conservation

species. Illegal egg harvesting, turtle poaching and nest destruction by humans are some of the threats they face besides climate change and coastal erosion that is shrinking their breeding zones

According to the World Wide Fund

for Nature, the turtles breed in very few places, and therefore, any disturbance in even one nesting beach could have huge repercussions on their population. During 'arribada' or the arrival,

the female turtles generally reach the beaches in the dead of the night. Usually, each female turtle lays around 120-150 eggs and returns to the sea.

They usually mate between November and January and the breeding period lasts till May.

The hatchlings emerge from these eggs after 45-60 days and grow up without their mothers. Various reports suggest that out of every 1,000 hatchlings which enter the sea, only one manages to reach

its newly demarcated map. The AP government has created 13 new districts by dividing 13 existing districts and expanding its periphery with the inclusion of Kotia into its state. With this, a total of 26 districts were formed in AP. According to reports, 28 border villages in Kotia cluster now come under a new district known as

'Manyam'. Utkal Sammilani, which campaigns for the unification of the state of Odisha, said that the fight with AP over Kotia was underway in the Supreme Court. AP had moved the court against Odisha seeking a stay on conducting Panchayat elections in Kotia, but the apex court re-

jected its petition. "The neighbouring state is targeting to merge Kotia for its rich mineral and mining resources. However. Kotia belongs to Odisha and we will never let the region go to AP. Kotia was in Odisha, is and will remain in the state in future," said Dilip Das Sharma, president of Utkal Sammilani Mancheswar branch.

Utkal Sammilani also criticised Andhra Pradesh Governor and former Odisha minister Biswabhushan Harichandan for allowing this thing to happen. The official announcement comes after the governor's approval. Utkal Sammilani has demanded that the Odisha government submit its data to the court for the protection of Kotia and conduct Chief Secretary level meeting and register its protest.



Runway cleared for Amarda airstrip

Bhubaneswar, April 5: Hurdles have been cleared to operationalise the Amarda Road Airstrip near Rasagobindapur in Mayurbhanj district under the RCS-UDAN scheme.

The Defence Research and Development Organisation (DRDO) has recommended and submitted the proposal to the Ministry of Defence (MoD) to grant 'no objection certificate' to the state government for the use of Amarda airstrip and working permission to develop a civil enclave at the

This was informed by Union Minister of State for Civil Aviation, VK Singh in Raiva Sabha recently.

Singh said the state government had sought permission of MoD to use Amarda airstrip for operations under UDAN. Subsequently, the Ministry of Civil Aviation also requested MoD to consider the request of the state government for granting permission to develop a civil enclave at the airstrip, he said.

The Amarda airstrip belonging to DRDO is included in the UDAN scheme document. Bhubaneswar to Amarda (Rasagobindapur) and vice-versa route was offered as a state sponsored route under bidding

The Airports Authority of India (AAI), the implementing agency, has received one bid on the route. Further, the Amarda Road Airstrip is developed under "Revival of unserved and underserved airports" scheme, he added.

In February, Chief Secretary SC Mahapatra had written a letter to Defence Secretary Ajay Kumar seeking NoC from the DRDO for the commencement of commercial flight operation from the airstrip.

The airstrip, once operationalised, will facilitate tourism connectivity to important places like Similipal National Park, Kuldiha Sanctuary and Chandipur & Talsari Sea beach, boost economic growth through trade, provide jobs, increase revenues from taxes and foster the community relationship with the neighbouring states and

HC notice to 3 civic bodies over untreated effluents



Cuttack, April 5: The Orissa High Court issued notices to three civic bodies Tuesday to inform about the steps taken by them for setting up sewage treatment plants.

The direction came after a report submitted by the State Pollution Control Board (SPCB) stated that rivers flowing through major cities of the state have turned toxic, due to unabated release of untreated sewage and effluents.

The civic bodies of Bhubaneswar, Sambalpur and Rourkela were issued notices by a division bench headed by Chief Justice S

The bench was adjudicating a petition, which had alleged that untreated sewage released into the Kathajodi river in Cuttack polluted the river alarmingly. The Cuttack Municipal

Corporation (CMC) had, however, assured the court that it is taking necessary steps to divert the sewage to a nearby treatment plant. The court expressed displeasure over the civic bodies' practice

of releasing sewage and effluents into the river without bothering to set up sewage treatment plants. It ordered the officials of the

three civic bodies to remain physically present in the court during the next hearing Friday.



Jajpur, April 5: The unholy nexus between some influential mining companies and local leaders have contributed to rampant illegal extraction of valuable minerals in 16 districts of Odisha, a report said. It also said there is a race among several mafia groups as to who can earn more through such illegal activities.

Jajpur, Bolangir, Bhadrak, Bargarh, Boudh, Deogarh, Dhenkanal, Gajapati, Jagatsinghpur, Kendrapara, Keonjhar, Khurda, Koraput, Malkangiri, Nabarangpur and Nuapada are the 16 districts where such illegal mining is rampant with very little action against the miscreants. Sources said most of the mafia groups in these districts have political Penalty to the tune of

around Rs 19,86,50,543 was collected in 14 districts of Odisha from FY 2015-16 to FY 2021-22 as various 'companies' were found indulging in illegal extraction and sale of minor minerals. A total of Rs 6.10.00.562 as penalty was collected in Balasore district alone. It amounts to about 30.70 per cent of the total collection in Odisha. This proves the rampant illegal mining prevalent in the district.

Illegal mining in Dankari hill in Jajpur district is a burning example of indifference of the district administration to curb it. The administration has moved Supreme Court against previous order of National Green Tribunal (NGT) to collect a penalty of Rs 25 crore from lessee.

Going Green

he UN's Intergovernmental Panel on Climate Change (IPCC), in its latest report released April 4, has made one departure from what it has so long been doing for the past few years. Instead of predicting doom for reckless plunder of nature and emission of greenhouse gases by mainly developed countries, the report this time has drawn the world's attention to how governments and people can effectively tackle the issue. Of course, the dire predictions are there. For example, continued heating of the planet, the report says, means that this year will probably be one of this century's coolest. Despite the climate pledges by governments, global heating would be 1.5 degree C above pre-industrial levels, making a mockery of the target promised in the 2015 Paris agreement. Greenhouse gas emissions are rising to the extent that during the past decade, on average, annually they were at their highest levels in human history. The coming decades are going to see temperature rise of more than 3 degree C. This would make large parts of the world too hot to work in. Severe crop failures will become common, while disappearing ice caps would submerge major cities. Governments have hitherto been far too hesitant to confront vested interests and are protecting investments in fossil fuels.

This cannot go on, says António Guterres, the UN Secretary General. He painted a gloomy future remarking the world "is on a fast track to climate disaster." Nations and corporations, he bluntly said, are not just turning a blind eye to a planetary disaster but adding fuel to fire. There is very little time left to implement policies that promote greener lifestyle choices and cheaper renewable solutions that would generate jobs, energy security and price stability, he warned.

However, UN scientists - over 700 spread across the globe working for the IPCC - have unveiled a plan that they believe would help people avoid the worst impacts of rising temperatures. The report virtually calls for a revolution in how we produce energy and power our world. In order to stave off global warming at the most dangerous level, carbon emissions can be allowed to peak within three years from now and then they must fall by 43 per cent by the end of this decade. That is not enough. Technology to pull CO2 from the air will still be needed to keep temperatures down.

The researchers have prescribed several key ideas that must be adhered to for keeping the world safe. The first of these is that the use of fossil fuels will have to stop and alternative, sustainable energy sources such as solar and wind power generation are to be tapped. To achieve 1.5 degree C, the world must reduce annual carbon emissions by about 50 per cent by 2030 and completely stop them by 2050. Methane emissions have to be reduced by a third by 2030 and almost half by 2050. This will need deep cuts in fossil fuel use. Decarbonisation of road transport, industry, mining and manufacturing powered by renewable sources has to be ensured. UN's scientists argue that energy efficiency and conservation are central to achieving a greener and

Much of the carbon dioxide already in the atmosphere was released by rich countries that burned coal, oil and gas to industrialise more than a century ago. The IPCC report says about 40 per cent of emissions since then came from Europe and North America. Only about 12 per cent can be attributed to East Asia, including China. It is in the wealthiest 10 per cent of households, which contribute between a third and 45 per cent of climate-changing fumes, where change will have to be effected fastest. There is an imperative need for better crop management and faster use of solar and wind energy. An interesting finding in this respect is that diets high in plant protein and low in meat and dairy are responsible for lower greenhouse gas emissions. It is heartening, the report says, that such diets are increasingly becoming

The pandemic offered an opportunity to shift from fossil fuels, but it has been missed by most governments. The UN body also welcomed the significant decrease in the cost of renewable energy sources since 2010, by as much as 85 per cent for solar and wind energy, and batteries.

One of the big differences between this report and the previous releases is the emphasis on ideas of reducing people's demand for energy in the areas of shelter, mobility and nutrition. This covers wide areas, including low carbon diets, food waste, how we build our cities, and how people are encouraged to use more carbon friendly transports. Electric cars can make a big difference to emissions from transport but need investment for the technology. The IPCC believes changes in these areas could limit emissions from enduse sectors by 40-70 per cent by 2050, while improving well-being.

That is, indeed, a highly ambitious target, but the report suggests it is doable proper incentives and nudges are given by governments. Answering an often asked question about availability of money for tackling climate change, the IPCC report says there is far too much money still flowing towards fossil fuels and not to clean energy climate solutions. If fossil fuel subsidies from governments were removed, this would reduce emissions by up to 10 per cent by 2030, according to Greenpeace.

These are sensible recommendations. As the IPCC Chair Hoesung Lee has emphasised we are at a crossroads and the decisions we make now can secure a liveable future.

Smithereens

t's an excellent word to describe the action of pummelling something forcibly, with that sm sound at the start that also appears in words such as smack, smite and smash. When an object has become smithereens, it has been thoroughly reduced to little bits. There's nothing half-hearted about the activity, which most often appears in phrases such as blown to smithereens, split in smithereens and your smashed to smithereens. Another: The party is in danger of being blasted to smithereens at next year's General Election (The Sun, 26 Feb. 2015). That huge tribe variously called Smith, Smyth, or Smythe, whose family name has been taken from a worker in iron, need not worry that they are being accused of mayhem by proxy. Though there has been some small doubt about the origin of smithereens, and Ivor Brown speculated in Words in Our Time in 1958 that smithers might be from the detritus of blacksmithing, the experts are now sure that there's no link to blacksmiths. The -een ending at once makes us think of Ireland and of colleen, poteen, shebeen and other words that derive from the Irish diminutive ending -in. (A colleen is a young woman, poteen for illicit alcohol is literally a little pot and a shebeen, in which such liquor was sold, takes its name from the Irish word for a small mugful; but note that tureen, canteen, velveteen, sateen and some other words aren't from Irish, but from French.) Most dictionaries assert that smithereens is indeed Irish, from smidirín, a diminutive of smiodar, a fragment. The Oxford English Dictionary, in an old entry, wondered if smither could have been taken to Ireland by incomers and been extended by the een ending, with the Irish form smidirín coming along later. As smithers was first recorded decades after smithereens, it's just as likely matters are the other way around, with its being an abbreviation of smithereens. Nobody believes either situation now: the two words were probably of independent formation, though they may well have influenced each other.

arch 30. Odisha Finance Minister Niranjan Pujari presented an interim budget for Rs 2 lakh crore and from that outlay, a vote-on-account of Rs 1.06 lakh crore for the first four months (April to July) was presented for seeking approval of the House to defray expenses on payment of salaries, pensions, interests, ongoing schemes and projects. He has said to have focussed on industries as well as MSME sector, social sector, employment generation, and higher investment in infrastructure.

According to Article 114 of the Constitution of India, the government cannot withdraw any amount of money from the Consolidated Fund, prior to it being passed by the Parliament in case of the country and by Assembly in case of any state. Appropriation Bill gives power to the government to withdraw funds from the Consolidated Fund of India for meeting the expenditure during the financial year.

Hence, each year, the incumbent finance minister presents the budget in the month of February which contains a blueprint of the government's revenue and expenditure for the coming fiscal year. The Appropriation Bill is passed before commencement of the new financial year. If for any reason, the government fails to present a full budget, an interim budget or vote-on-account is presented. An interim budget is presented by the government when it does not have time to present a full budget mostly when election is around the corner.

Many people use the term interim budget and vote-on-account interchangeably. However, they have significant differences. A vote-on-account is a grant in advance for the government to function properly. It allows the government to meet its required expenses. An interim budget includes both receipts and expenditures, while the vote-on-account lists only the expenditure and cannot make changes to the tax regime. The vote-on-account is a formality and is passed without any discussion. An interim budget is technically just like the full budget, but only for a temporary period.

Normally, the budgetary outlay is decided in tandem with an expected rise in nominal GSDP

growth. Economic Survey presented before budget mirrors the state of economy. Due to the pandemic-induced recession, in 2020-21, nominal GSDP was forecasted to shrink to a negative 2.24 per cent against the earlier projected rise of 11.7 per cent. However, it has shrunk by 0.64 per cent. The annual average growth of nominal GSDP over the last 10 years stands at 10.90 per cent.

While estimating the total outlay for 2021-22, the finance minister had assumed that nominal GSDP will grow at 10.5 per cent to reach Rs 5.86 lakh crore. According to the Economic Survey-2021-22, nominal GSDP of the state at current prices in 2021-22 (AE) is estimated at Rs 6,38,342 crore with a growth of 17.58 per cent over 2020-

Similarly, the real GSDP was forecasted to shrink to a negative 4.92 per cent against the initial projected rise of 7 per cent. However, it has shrunk to a negative 5.35 per cent, when the national average has shrunk to a negative of 6.6 per cent. The annual average growth of GSDP in real terms over the last ten years stands at 6.48 per cent. The real GSDP or GSDP at constant (2011-12) prices stands at Rs 4,27,592 crore for 2021-22(AE), as per the advance estimates with a growth of 10.11 per cent over 2020-21.

The budget document has

adopted the formula prescribed by the 14th Finance Commission for the estimation of GSDP for the budget year based on the average growth of the three preceding years. As mentioned in budget documents, based on this formula, GSDP for the year 2022-23 works out to Rs 6.26 lakh crore, which is 2 per cent lower than the GSDP for the year 2021-22 (AE). However, the finance department has not accepted this and stated that this abnormality is because of the inclusion of the COVID-hit year of 2020-21 in working out the average growth. Accordingly, the budget assumes

a nominal GSDP growth of 12.7 per cent and real GSDP of 9 per cent 9.5 per cent in 2022-23. Thus, the estimated nominal GSDP of Rs 7.19 lakh crore for 2022-23 is used for working out all monitorable fiscal indicators. This raises questions about the purity of data. How a formula used earlier can be wrong again. If wrong, past estimation might be wrong too. Actually, the nominal GSDP in 2021-22 might be overestimated to show that the target of various deficits and debts as a percentage of GSDP has been The budgetary outlay - which

will be revised in the final budget - for the entire year 2022-23 is estimated to be Rs 2,00,000 crore, which is about 17.6 per cent more than the previous annual budget.

sionary. Budget outlay for 2021-22 which was estimated to be Rs 1.70 lakh crore has shrunk to Rs 1.65 lakh crore in a revised estimate. It may be noted that in addition to Rs 1.70 lakh crore, the finance minister had presented a supplementary budget of Rs 19,380 crore December 1, 2021, which proved redundant.

The state's own tax/GSDP ratio is estimated at 6.40 per cent in 2021-22 and has increased by 6.50 per cent in the revised estimate. However, it is estimated to be 6.39 per cent in 2022-23. Similarly, the non-tax/GSDP ratio which was estimated to be 9.80 per cent in 2021-22 was found to have increased to 13.5 per cent in revised estimate and is estimated at 13.1 per cent in 2022-23. The massive rise was seen as the state's own non-tax revenues have increased from Rs 57500.00 crore in 2020-21 to Rs 86052.01 crore in 2021-22 due to a rise in mining royalties. But this is not sustainable as mineral resources are not unlimited.

Grant-in-aid from the Centre of which the state had expected to get Rs 37963.32 crore in 2021-22, was reduced to Rs 21646.98 crore in the revised estimate and the state is expected to get Rs 32788.64 crore only in 2022-23. The Centre's apathy is crippling state finances too as the former is generating more resources through cesses and surcharges in which states have no share. However, the finance minister underlined that the state's dependence on central transfers has reduced with the state's own revenue contributing about 58 per cent to the total revenue pool.

The revenue receipt for 2022-23 is estimated at Rs 1,63,967 crore and the revenue expenditure is at Rs 1,44,349 crore. The revenue surplus is of the order of Rs 19.618 crore, which would be 2.7 per cent of the GSDP. The estimated fiscal deficit of Rs 21,588 crore amounts to 3 per cent of the GSDP. It is also estimated that the debt-GSDP ratio will be 15.35 per cent in 2022-23 which was 15.64 per cent at the end of 2021-22. Though fiscal rectitude is maintained, doubt on calculation of nominal GSDP creeps in mind.

Picture Arts and Sciences has concluded its formal review of the incident involving actor Will Smith and comedian Chris Rock at the 94thOscars March 24, 2022, and issued the following state-

The Academy would like to apologise once again to the millions of viewers from around the world who were exposed to violence and foul language March 24 without buying a movie ticket. We do not condone violence and foul language in any form that is totally free to con-

When violence and foul language are freely available, they become normalised. We do not want to live in a society where it's considered normal behaviour to slap Chris Rock.

Indeed, slapping any comedian is unacceptable behaviour. Comedians should be free to make jokes of all kinds, even those in poor taste, without the threat of being slapped. If people get slapped whenever they produce something

The Academy of Motion in poor taste, there'd be a lot of red faces at Taco Bell.

> As everyone is aware, the incident at the Oscars occurred while Mr. Rock was presenting the award for best documentary. He made a "G.I. Jane" joke about Will Smith's wife, Jada Pinkett Smith, alluding to her shaved head but unaware that she suffers from alopecia, a disorder that causes hair loss. Mr. Smith walked onto the stage to let Mr. Rock know about his wife's condition by means of a slap. He returned to his seat and issued a verbal warning to Mr. Rock, using language unsuitable for children and offensive to innumerable adults in households around the world.

Mr. Smith's actions were disgraceful and reprehensible This was the first time in the history of award shows that a presenter has been slapped by an award nominee, not counting the annual award show of the World Wrestling Federation.

Mr. Smith's actions were deeply shocking and traumatic, not just for viewers at home but also for thousands of guests in the Dolby Theater who witnessed his actions in-person and have been forever scarred by the image of one celebrity slapping another. Many of them feared for their safety, wondering if Mr. Smith had lost his mind and would go on a slapping spree.

The Academy would like to apologise again to Mr. Rock and commend him for his resilience. While many hosts may have recoiled or retaliated, Mr. Rock kept his composure. Had he chosen to retaliate, we might have witnessed a brawl on stage, resulting in an arrest or two.

No arrest took place, of course. The Los Angeles Police Department was prepared to make an arrest, but Mr. Rock declined to press charges. He made this decision on his own free will—as far as we know—not under threat of another slap.

As everyone is aware, Mr. Smith remained in the theater for the rest of the ceremony. This was a mistake on our part. We asked Mr. Smith to leave and he refused. At this point, we could have summoned security and had Mr. Smith forcibly removed. But after consulting Mr. Rock, we decided not to do so. It is important to note that while we were consulting Mr. Rock, Mr. Smith did not make any slapping gestures in our direction. Mr. Smith also reassured us that there would be no more slapping whatsoever. We asked him to swear to this, but Mr. Rock intervened, saying that Mr. Smith had done enough swearing already.

We realised our mistake when Mr. Smith won the "best actor" award and used his acceptance speech to justify his actions. He received a standing ovation, which sent the wrong message to the audience. Slapping should never be rewarded with clapping.

Mr. Smith has since apologised for his actions and turned in his resignation from the Academy. At the next board meeting April 18, the Academy may take disciplinary action against him. We are waiting to hear from Mr. Rock on how to proceed.

Srinagar, April 5: The Delimitation Commission, which is on a twoday visit to Jammu and Kashmir to meet public and civil society groups for receiving suggestions and objections on its draft proposal, Tuesday held discussions with scores of representatives and individuals here

Scores of individuals and groups including from many political parties, and Panchayati Raj Institutions members, met the commission, which has been tasked to redraw the boundaries of assembly and parliamentary constituencies in Jammu and Kashmir.

On Monday, the commission, headed by Justice (retired) Ranjana Prakash Desai, had meetings with public, civil society groups and po litical parties from all districts of the Jammu region.

The commission met delega tions in two sittings. The first was from 10 am to 12 noon where people from Srinagar, Budgam Anantnag, Kulgam, Pulwama and Shopian met the commission.

The second sitting was from 12 noon to 2 pm during which people from Ganderbal, Bandipora, Kupwara and Baramulla partici pated. The Commission was set up March 6, 2020, with one year term. However, in the wake of the COVID-19 pandemic, its term was extended March 6, 2021, by one year.

A farcical exercise: Awami Itehad Party

Srinagar: Awami Itehad Party Tuesday rejected the draft proposal of the Delimitation Commission for Jammu and Kashmir, terming it "a farcical exercise" to benefit the "B-Teams" of the BJP. MLA rebukes Cong circular to observe upcoming Navami

Bhopal, April 5: Bhopal Central MLA and Congress leader Arif Masood Tuesday said the party was setting a wrong precedent by asking its cadres to celebrate the upcoming 'Ram Navami and Hanuman Jayanti' and recite Sundarkand (a part of Ramayana) and Hanuman Chalisa

Masood wondered why such directives were not issued for Congress workers about celebrating Ramadan and festivals of other faiths. A circular, issued on behalf of MP Congress president Kamal Nath, April 2 directed the party leaders and workers to organise religious programmes April 10 and April 16 to mark Ram Navami and Hanuman Jayanti, respectively, a move which is seen as Congress' outreach to the Hindu community ahead of next year's MP assem-

"I have questioned the circular issued by Congress to its leaders. Being a political party, Congress should not have issued such a circular. We take along all the religions," Masood told reporters.

He said that his colleagues in Congress and other acquaintances celebrate Ram Navami with fervour but there was no need to issue any circular.

"If we issue a circular to celebrate Ram Navami and Hanuman Jayanti then such a letter should also be issued about Ramadan and festivals of other faiths. This is not a good tradition for a political party," he said. When contacted, Madhya Pradesh home minister Narottam Mishra took a dig saying, "Masood's objection is justified. The Congress is only concerned for Muslims by raising a boogie of BJP." Masood is not able to digest that Congress leaders who used to organise 'Iftar' (meal eaten by Muslims after sunset during Ramadan) parties are now visiting temples, Mishra told reporters.

India lost 39 tigers so far this year; MP tops with 14 deaths

Madhya Pradesh, like in the previous years, led the list, followed by Maharashtra with 10, and Karnataka with six tiger deaths

Bhopal, April 5: Tiger state Madhya Pradesh has lost 14 tigers in the last four months in different wildlife habitats of the state, including four between April 1 to 4.

Of the total tigers reported dead, 10 had lost their lives within the earmarked area of tiger reserves. while four were reported dead outside the area

According to the National Tiger Conservation Authority's (NTCA) report, three tigers were reported dead in Pench Tiger Reserve, two each in Bandhavgarh, Sanjay Tiger Reserve, Kanha Tiger Reserve and one in Satpura Tiger Reserve. The remaining four big cats were reported dead outside the wildlife habitat areas.

The NTCA report also suggests that of the 14 big cats lost between January 1 and April 4, six were female and three male, while the identity of five remained unknown.

Of the three tigers who died in the last four days, two were found dead in Satpura Tiger Reserve (STR) in Narmadapuram (Hoshangabad) district and the third in Balaghat. A senior officer in STR said the carcass of a female cub, aged around 5-6 months, was spotted by a forest patrol in Mogra area of Pachmarhi range Saturday. The officer said that there were multiple injuries on her body, suggesting a possible attack by an adult tiger.



Bhopal, April 5: Heatwave continued in Madhya Pradesh Monday as the average temperature in several parts of the state either touched or crossed the 42 degrees Celsiusmark, forcing people to state indoors in the day time.

The maximum temperature Khajuraho, Narmadapuram, Rajgarh, Damoh, Khandwa, Khargone and Nawgaon touched the 43 degrees Celsius-mark Monday, even as the heatwave continued in Chhindwara, Rewa, Sidhi, Guna, Rajgarh, Damoh, Sagar, Satna, Jabalpur, and Gwalior.

According the Met department, the maximum temperature in the four major cities -- Bhopal, Indore, Jabalpur and Gwalior - was recorded at a little over 40 degrees Celsius. Similar conditions are likely to continue over the next four days, said PK Saha, a meteorologist with IMD's Bhopal office. MP students to get GI tag to boost Kashmiri carpet industry digital locker facility A geographical indication Kashmiri Carpets and granted the

Bhopal, April 5: The Madhya Pradesh government is set to introduce a digital locker system in all colleges and universities of the state to provide marksheets, certificates, migration transcripts etc to the students digitally.

The higher education department of the state government has initiated the digital locker system. which will be made available at all the universities of the state.

Every student will have an account on the digital locker system, said an official in the higher education department, adding that the Barkatullah University has been made the nodal varsity for this system. The official informed that in the first phase, marksheets will be made available through the digital locker system, while in the subsequent phases, documents like

degrees, duplicate marksheets, migration transcripts etc. will be made available to the students through the system.

The Barkatullah University in Bhopal, which is the nodal agency for the system, has prepared data for the academic year 2019-20 and 2020-21 to provide the marksheets to the students through the new system which would be made operational soon, the official said.

The official added that the new system will eliminate the problem of missing certificates. The marksheet and degree will be made available to the students on the day of the declaration of result.

It would be possible to provide certificates to the students in a very short time. Also, having digital signatures in the certificates will increase the accountability of the employees to deliver the services in a time-bound manner, the official said.



Srinagar, April 5: Kashmir created history last month when for the first time GI-certified Kashmir silken carpets were exported to Germany, valued at around 40,000 Euros. Last year Srinagar scored a place in the United Nations Educational, Scientific & Cultural Organisation (UNESCO) in Crafts and Folk Arts Category for 2021. Following this development by Lieutenant Governor, Manoj Sinha, launched Geographical Indication (GI) for the famed hand-knotted carpet trade a new lease of life.

Kashmiri hand-knotted carpets, locally known as 'Kalbaffi', date their origin back to the 15th century. Sultan Zain-ul-Abidin brought in carpet weavers from Persia and Central Asia to train the locals. These carpets are weighed in gold owing to the finesse of the weave and quality of wool and silk yarn.

The GI label will assist the tourism industry by projecting a positive image of Kashmir. It's a useful market-access tool as it adds value to the items that are designated this title, allowing them to access larger markets.

The QR-code on all items will reveal information such as the name of the artisan, district of manufacture, knots per square inch, and the raw material used, among others. The GI branding will fetch the carpets their worth and will raise their standards to the Iranian and Turkish knot-



ted carpet varieties

Kashmir has long suffered due to misbranding of products in the international market claiming that they are Kashmir-brand. The cheap quality knock-offs in the international market eroded the trust of buyers. GI-tagging is a one-stop solution to all those problems that have low-balled the price of the original Kashmiri carpets. This initiative


will motivate the younger gener ation to move to carpet weaving and shift their attention from the widespread terrorism in the valley to income generation.

In 2020-21, Germany emerged as the biggest importer of Kashmiri carpets worth Rs 115 crore. The UAE was the second biggest market at Rs 36 crore; and the US at Rs 34 crore. The Netherlands imported artwork worth Rs 22 crore.

The Carpet Export Promotion Council (CEPC), set up by the Ministry of Textile, has proposed the formation of a carpet village in the Sonawari area to regulate this business and secure jobs for the weavers. The village is envisioned to be a one-stop-shop for all carpet and weave needs for outsiders. The designs would be copyrighted for future generations. The tourism sector will highly benefit through this too as people will witness the art first-hand and it will increase their confidence in the product.

GI tag has been embraced by many colonies across the world as a mark of the originality of their produce. Switzerland does it for their watches, Russia for its Bashkir honey, Georgia for Tushuri Guda cheese, and the French for their specialty wine. It will be a guarantee to the buyers that their carpet wasactually woven in Kashmir and by a Kashmiri.

Kolkata: The West Bengal government Tuesday sought a report from the Aliah University over allegations of a now expelled student heckling, threatening and abusing the university Vice Chancellor, Mohammad Ali. The incident is said to have taken place on April 1. A video that went viral next day showed a student -- Giasuddin Mondal, having close links with the ruling Trinamool Congress, heckling, threatening and abusing Ali. On April 3, Mondal was arrested from his rented accommodation in Kolkata's Salt Lake area.

AP CM Jagan to reshuffle Cabinet

New Delhi, April 5: Assets worth ₹4.81 crore of the family and companies "beneficially owned and controlled" by Delhi minister and AAP leader Satyendar Jain have been provisionally attached in connection with a money-laundering probe against him, the Enforcement Directorate said Tuesday.

Jain, 57, is the minister for health, power, home, PWD, industries, urban development, flood, irrigation and water in the Arvind Kejriwalled government. The ED had in 2018 questioned the AAP MLA from Shakur Basti in connection with the case. He had worked in the Central Public Works Department and later quit his job to set up an architectural consultancy firm.

In a statement, the ED said it has issued a provisional order under the Prevention of Money Laundering Act (PMLA) for the attachment of the assets.

The "attached immovable properties worth ₹ 4.81 crore belong to Akinchan Developers Pvt. Ltd., Indo Metal Impex Pvt Ltd, Paryas Infosolutions Pvt. Ltd., Manglayatan Projects Pvt. Ltd., J.J. Ideal Estate Pvt. Ltd., Swati Jain, wife of Vaibhav Jain, Sushila Jain, wife of Ajit Prasad Jain, and Indu Jain, wife of Sunil Jain.'

The probe found that "during the period 2015-16, when Satyendar Kumar Jain was a public servant. the companies beneficially owned and controlled by him received accommodation entries to the tune of ₹ 4.81 crore from shell (paper) companies against cash trans-

ferred to Kolkata-based entry operators through the hawala route.'

'These amounts were utilised for direct purchase of land or for repayment of loan taken for the purchase of agricultural land in and around Delhi," the ED said.

According to the officials, the named persons in the attachment order are associates and family members of Jain. The money laundering case

against the AAP minister stems from an August 2017 FIR filed by the CBI against him and others on charges of alleged possession of disproportionate assets. The CBI has claimed that Jain

purchased 200 bighas of agricultural land in the names of companies controlled by him in Delhi in five years preceding 2018 and "laundered black money" to the tune of several crores of rupees. It had alleged that Jain con-

trolled these companies in the past either in the form of being one of the directors or by holding onethird of shares of these companies in his name or in the names of his family members or others.

The laundered funds were allegedly used to purchase over 200 bighas of land in Auchandi, Bawana, Karala and Mohammed Mazvi villages in Delhi between 2010 and 16, the CBI had said. The Income Tax department too had probed these transactions and issued an order attaching benami assets' allegedly linked to Jain.

ISRO scientists to inspect Bill to unify Delhi MCDs passed objects that fell from sky

New Delhi, April 5: A team of ISRO scientists are visiting Chandrapur district in Maharashtra to inspect some objects, believed to be remnants of a booster rocket, that streaked across the night sky over parts of central India last week.

The space agency decided to depute a team of scientists for "inspection and further scientific inquiry" after the district collector of Chandrapur reached out to ISRO to examine a metal ring and a cylinder-like object that were found in an open field in Pawanpur village.

As requested by the district administration, a team of scientists from ISRO is visiting Pawanpur for inspection and further scientific inquiry," the space agency said in a Facebook post.

On April 2, several social media users posted videos and pictures of unidentified burning objects falling from the sky in north Maharashtra as well as some dis-

New Delhi, April 5: The Centre Tuesday informed Parliament that confirmed death due to oxygen shortage has not been reported by any state or union territory although over 5.21 lakh fatalities due to COVID-19 have been recorded in India.

It told the Rajya Sabha that it had asked states to provide details of people who have died because of shortage of oxygen. "As on April 4, 2022, states/UTs have reported a total of 5,21,358 deaths due to COVID-19 in the country," Minister of State for Health and Family Welfare Bharati Pravin Pawar told the Upper House.

Replying to supplementaries during the Question Hour, she said, "Twenty states/UTs have responded

and none of these have reported confirmed death due to oxygen shortage."She said that some states are even now updating and reporting deaths due to COVID-19 on the ministry's web portal.

To a query by Congress MP Shaktisinh Gohil that the government had promised ₹4 lakh as compensation for Covid deaths and why this money was not being given, Bharati said the government has issued guidelines transparently. She said arrangements had been made to protect and take care of patients through insurance schemes for poor patients.

The minister also said ex gratia payments had been examined at central, state and district levels and it has been determined that the amount to be given is not ₹4 lakh. "An ex gratia of ₹50,000 as per cen-



tral, state and district levels. The NDMA has proposed ₹50,000 compensation and not ₹4 lakh for each victim of COVID-19," she told the House.

Main opposition leader Sajith Premadasa urged the government to pay heed to the protesters whom he said have suffered with hardships experienced recently. Speaker Mahinda Yapa Abeyawardene summoned a meeting of the party lead ers to decide on a two-day debate on the current economic and political crisis which will be held Wednesday and Thursday.

The ruling coalition, which had won 150 seats in the 2020 general elections and went on to increase its numbers through defections from the Opposition, lost the support of at least 41 MPs.

The names of the 41 lawmakers to leave the coalition were announced by party leaders in Parliament.

They have now become independent members, leaving Rajapaksa's government with fewer than the 113 members needed to maintain a majority in the 225member house. The government, however, claimed that it commands simple majority. Sri Lanka is currently experiencing its worst economic crisis in history.

Alleged militia leader on trial at **ICC's 1st Darfur trial**

The Hague, April 5: An alleged leader of a Sudanese militia known as "devils on horseback" took a 'strange glee" in his ruthless reputation during the Darfur conflict, the chief prosecutor of the International Criminal Court said Tuesday as the suspect's trial opened.

The 72-year-old defendant, Ali Muhammad Ali Abd-Al-Rahman, also known as Ali Kushavb, pleaded innocent to all 31 charges of war crimes and crimes against humanity. "I reject all of these charges," he told the court in the first ICC trial to deal with atrocities by Sudanese government backed forces in the Darfur province nearly two decades ago.

Prosecutor Karim Khan called the trial "an important moment in trying to wake peace from its slumber and try to move it, mobilize it, into action.

He noted that Russia voted for a United Nations Security Council mandate in 2005 that sought an ICC investigation in Darfur. Prosecutors say al-Rahman was a senior commander in the janjaweed militias during the Darfur conflict that erupted when rebels from the territory's ethnic central and sub-Saharan African community launched an insurgency in 2003. complaining of oppression by the Arab-dominated government in the capital, Khartoum. Then-President Omar al-Bashir's government responded with a scorched-earth campaign of aerial bombings and raids by the janjaweed, who often at tacked at dawn, sweeping into villages on horseback or camelback.

Pak SC seeks record of NA proceedings on no-trust motion

Islamabad, April 5: Pakistan's Supreme Court Tuesday sought the record of the proceedings of the National Assembly conducted on the no-confidence motion filed against Prime Minister Imran Khan before adjourning the hearing till Wednesday, prolonging the political and constitutional crisis in the country.

National Assembly Deputy Speaker Qasim Khan Suri Sunday ruled that the no-confidence motion was linked with a "foreign conspiracy" to topple the government and hence was not maintainable. Minutes later. President Arif Alvi dissolved the National Assembly on advice of Prime Minister Khan.

The apex court within hours took suo motu notice of it and a fivemember bench started hearing the case Monday. The bench is headed by Chief Justice Umar Ata Bandial and includes Justice Ijazul Ahsan. San Francisco, April 5: Elon Musk, the billionaire Tesla CEO and power Twitter user who is now Twitter's largest shareholder and newly appointed board member, may have thoughts on a long-standing request from users: Should there be an edit button?

On Monday evening, Musk launched a Twitter poll about whether they want an edit button. cheekily misspelling "yes" as "yse' and "no" as "on."

More than 3 million people had voted as of Tuesday morning. The

poll closes Tuesday evening Eastern time. Twitter's CEO, Parag Agrawal, retweeted the poll with a seeming reference to an earlier tweet by Musk. , saying "The consequences of this poll will be important," he wrote. 'Please vote carefully." Musk had used the same language in a March tweet describing another one of his polls that asked whether Twitter adheres to free speech principles.

Twitter spokesperson Catherine Hill declined to comment on whether Agrawal was joking, and did not answer whether Twitter would follow the results of Musk's poll. Musk tweeted Tuesday that he was looking forward to making "significant improvements to Twitter in coming months!" Many Twitter users — among them, Kim Kardashian, Ice T, Katy Perry and McDonald's corporate account have long begged for an edit button. The company itself recently teased users with an April Fool's Day tweet saying "we are working on an edit button.

'Russia regrouping to try to take Donbas'

Brussels, April 5: Russia is likely to launch a new offensive in Ukraine's eastern Donbas region in the next few weeks, NATO Secretary-General Jens Stoltenberg said Tuesday, adding that allies had time to help prepare the Ukrainian military.

Speaking a day before NATO foreign ministers gather in Brussels to discuss more financial, military and humanitarian support for Ukraine, Stoltenberg said Russia was planning a "very concentrated" offensive.

"We now see a significant movement of (Russian) troops away from Kyiv to regroup, re-arm and re-supply and shift their focus to the east," Stoltenberg told a news conference. "In the coming weeks, we expect a further Russian push in



to create a land bridge to occupied Crimea,"he said before Wednesday's meeting of NATO foreign ministers.

Stoltenberg's comments appeared to confirm Moscow's announcement in late March that it was refocusing on "the complete liberation of the Donbas", an industrial region partly under Russian-backed separatist control since 2014.

Stoltenberg said it would be a new, crucial phase of Russia's February 24 invasion, which the Kremlin calls a "special military operation". "Repositioning of the Russian troops will take some time, some weeks," he said. He said that: "In that window, it is extremely important that NATO allies provide support". Foreign ministers Wednesday and Thursday are set to discuss how to send more anti-tank weapons, ammunition and medical supplies to Ukraine, Stoltenberg said, Ukrainian Foreign Minister Dmytro Kuleba is expect to attend part of the two-day meet-

ing in Brussels.

EU targets coal, vodka, vessels in new Russian sanctions sweep

Brussels April 5: The European Commission proposed sweeping new sanctions against Russia Tuesday including banning coal imports and halting trade worth nearly 20 billion euros (\$22 billion) in retaliation over possible war crimes in Ukraine.

Here is a rundown of the measures, which must be approved by all 27 European Union states. They could be adopted this week.

■ IMPORT BAN

The proposals include banning imports of coal, wood, cement, liquors and seafood worth about 9.5 billion euros (\$10.4 billion) a year, according to the European Commission. A source said the restrictions would also hit caviar, vodka, rubber and chemicals.

Coal alone is worth 4 billion euros a year, the Commission said. As a comparison, the EU imported about 100 billion euros of oil and gas from Russia last year. The Commission said it was working on possible sanction on oil, as well. **■ EXPORT BAN**

Brussels is proposing a ban on

exports to Russia worth another 10 billion euros a year, including of advanced semiconductors, quantum computers, and other electrical and transport equipment. The export of technology for liquefied natural gas (LNG) would also be banned, according to a source.

Russian vessels and trucks would be prevented from accessing the EU, further crippling trade. Energy



products, food and medicines would be exempted, meaning for example that LNG cargoes from Russia would

affected. Applying the sanctions may be complicated, officials have repeatedly said because it is not always easy to identify the origin of a cargo ship. The new sanctions would effectively halt transport of goods by road and sea. The EU has already banned air traffic with Russia.

The commission also proposed banning all transactions with VTB (VTBR.MM) and another three Russian banks which have already been excluded from the SWIFT messaging system.


Zelenskyy at the UN accuses Russian military of war crimes

The NRAI represents over 50,000 restaurant operators across the country.

Mumbai, April 5: India's largest private lender HDFC Bank's \$40 billion acquisition of its biggest shareholder could face regulatory hurdles due to the stake it would give the bank in the insurance sector, analysts said.

Sources told Reuters last year that the Reserve Bank of India, which acts as regulator for the financial industry, wants banks to limit ownership stakes in insurance companies.

HDFC Bank's acquisition of HDFC Ltd, announced Monday, will create an entity with a combined balance sheet worth \$237 billion and will include the target's insurance and other financial subsidiaries

HDFC Life and HDFC ERGO are



eral insurance companies in the private sector, and analysts say the RBI is unlikely to be comfortable with the size of the insurance operations the deal will give the bank.

HDFC Bank's management said Monday that they have asked the regulator for clarity on complying with its rules, but analysts believe it may not be easy to come by.

"Considering there are lot of subsidiaries that need to be merged, there could be some regulatory overhang, particularly in the insurance business where the central bank is not very comfortable with banks increasing their stake," said an analyst at a domestic bro-

March auto sales

New Delhi, April 5: Rising vehicle prices, coupled with high fuel costs, subdued India's March automobile retail sales on a year-on-year (YoY) basis, the Federation of Automobile Dealers Associations (FADA) said Tuesday.

FADA data showed a YoY fall of 2.87 per cent in overall automobile retail sales during the month under review. The overall retail sales fell to 16,19,181 units last month from 16,66,996 units sold during the corresponding month

Also, last month's overall retail sales figure, when compared to the March 2020 period, showed a decline of 29.99 per cent. In March 2020, the overall vehicle retail sales stood at 23.12.868 units. On a YoY basis, passenger vehicle (PV) retail sales last month fell by 4.87 per cent to 2,71,358 units last month from 2,85,240 units sold during the corresponding month of last year. Similarly, two-wheeler retail sales YoY declined last month by 4.02 per cent to 11,57,681 units. Besides, tractor retail sales fell by 8.16 per cent to 63,920 units.

However, commercial vehicle (CV) retail sales rose by 14.91 per cent to 77,938 units last month from 67,828 units sold during the

 $corresponding\,month\,of\,\,last\,year.$ In terms of FY22 data, total vehicle retail increased by 7 per cent on YoY basis but fell by 25 per cent when compared to FY20 which was largely a pre-Covid year. Furthermore, except tractors' sales, which fell by 1 per cent, all other categories like '2W, 3W, PV and CV' grew by 4 per cent, 50 per cent, 14 per cent, and 45 per cent on a YoY basis, respectively.

Individual investors can use UPI for up to ₹5L payment in public issues

New Delhi, April 5: Capital markets regulator Sebi Tuesday said individual investors applying in public issues of equity shares and convertibles can use Unified Payment Interface (UPI) for application amount up to ₹5 lakh.

Also, they have been asked to provide their UPI ID in the bidcum-application form submitted with any of these entities -- syndicate member, stock broker, depository participant and registrar to an issue and share transfer agent.

The new guidelines will come into force for public issues opening on or after May 1, 2022, Sebi said in a circular. The decision has been taken after National Payments Corporation of India (NPCI) reviewed the systemic readiness required at various intermediaries to facilitate the processing of applications with increased UPI limit.

As on March 30, 2022, more than 80 per cent of Self Certified Syndicate Banks (SCSBs)/Sponsor Banks/UPI Apps have conducted the system changes and have complied with the NPCI provisions.

In December 2021, NPCI enhanced the per transaction limit in UPI from ₹2 lakh to ₹5 lakh for UPIbased Application Supported by Blocked Amount (ASBA) in Initial Public Offers (IPOs).

Real test awaits Blues

Madrid. April 5: In a repeat of the 2020-21 Champions League semifinals, Chelsea and Real Madrid will lock horns in the last eight of this year's competition, with the first leg taking place at Stamford Bridge Wednesday night.

Thomas Tuchel's side made it past Ligue 1 champions Lille 4-1 on aggregate to book their spot in the quarters, while Carlo Ancelotti's men produced a phenomenal comeback against Paris Saint-Germain.

The continued uncertainty surrounding the Chelsea ownership debacle is doing the Champions League holders no favours, but the Blues' defence of their crown is going swimmingly so far, with a dissatisfactory Lille side no match for their English counterparts in the knockout rounds.

Chelsea already had one foot firmly in the last eight after claiming a 2-0 win versus Les Dogues on home soil before their trip to the Stade Pierre-Mauroy, where Burak Yilmaz's spot kick gave Lille a slight glimmer of hope before Christian Pulisic and Cesar Azpilicueta quickly dashed the Dogues' dreams.

Up until the weekend, Chelsea had done a stellar job of focusing on their on-field endeavours, but Tuchel was at a loss to explain his side's capitulation against Brentford, as the Bees ran out 4-1 winners at Stamford Bridge to leave the home fans shellshocked in their seats.

Seeing their six-game unbeaten run in all competitions come to an end in such bitterly disappointing fashion is not what the doctor ordered before a meeting with Real Madrid, but not since the 2010-11 sea-

son have the Blues been knocked out in the Champions League quarterfinals-going down to Manchester United that year.

The Blues' defence was breached at will by Brentford at the weekend. but Tuchel's side enter the first leg having won each of their last five home games in the Champions League with five clean sheets to

boot, with the first game in that sequence coming against their Spanish capital counterparts. PSG's penchant for seemingly impossible Champions League collapses has defined their European endeavours over the past few seasons, and Real Madrid became the latest side to frustrate Les Parisiens further with a phenomenal come-

back in front of the Santiago

Bernabeu crowd. A side with 13 European crowns to their name dumping out a PSG side still searching for their maiden Champions League honour was an obvious result on paper, but one certainly could not have foreseen the drama that unfolded in the Spanish capital before Real were brought

crashing back down to earth. Being thrashed 0-4 by Barcelona in El Clasico was a sure-fire way to dampen the spirits, and Real were far from their best against Celta Vigo at the weekend, but a pair of Benzema penalties ultimately got them over the line for a sixth win in seven matches.

Victory at Celta also represents a third away win on the bounce for Los Blancos, who went down 0-2 to Chelsea at Stamford Bridge last term following a 1-1 stalemate at the Estadio Alfredo Di Stefano, but the Blues will step out onto more daunting turf for the second leg this year.
