



### Hijab girls turned away from exam centre

Bangalore: Two Muslim students Resham and Alia whose petition challenging the government order banning Hijab was dismissed by the High Court returned home from the exam centre in Udupi after they were denied entry for insisting to write the exam. The authorities cited last month's High Court verdict upholding the government order, which banned any cloth that

could disturb peace, harmony and public order. The second-year pre-university examinations started in Karnataka Friday amid tight security and in the shadow of the hijab row. As there is a ban on hijab or any cloth linked to religious identity, the authorities made arrangements at exam centres for the Muslim girls to remove their head scarves before entering the exam halls. Muslim girls who turned up at the examination centre wearing hijab said they will remove it inside the separate enclosure and will wear it again after the exam is over



Govt may cut LIC IPO size by half New Delhi: New Delhi is halving its fundraising goal for Life Insurance Corporation of India's IPO to 300 billion rupees (\$3.9 billion), having had to cut its valuation estimates after feedback from investors, a government source said. The drastic lowering of ambitions for the IPO - which would still be India's largest to date - is a setback for Prime Minister Narendra Modi's administration which had positioned the sale as the first and

biggest of a wave of privatisations aimed at replenishing state coffers. The state-owned insurance behemoth, also India's largest domestic financial investor, is now valued at around 6 trillion rupees, according to the source, who declined to be identified as the IPO discussions were confidential. Earlier government estimates had called for the insurer to be valued at around 17 trillion rupees.



### 2 killed, 1 critical in clash during fest in Koraput

Jeypore, April 22: In a horrific incident, two youths were beaten to death while another suffered grievous injuries following a clash during 'Chaitra Parba' celebrations at Sindhipar village under Damanjodi police limits in Koraput district early Friday morning.

The deceased were identified as Purna Chandra Nayak and Debendra Kumar Jani and the injured as Somnath Dami, all from Jhadiguda village. According to sources, a few youths from Jhadiguda village had been to Sindhipar to witness a cultural programme organised Thursday night as part of the festival.

For reasons vet to be known vouths of the two villages engaged in an altercation during the programme. Things took an ugly turn when the youths from Sindhipar attacked the other group with sharp-edged weapons.

Bolangir, April 22: In a shocking incident, a first year medical student of the Bhima Bhoi Medical College and Hospital died after falling off the roof of the 5storied hostel here in Bolangir district, Friday.

The student has been identified as Nishant Kumar, 19, from Karnal in Haryana. He was a first year MBBS student. Kumar had taken admission in the medical college and had joined the hostel 10 days back. He was residing alone in Room-312 in the New Boys' Hostel of the institution.

While no exact cause for Kumar's death has been ascertained yet, rumours of him committing suicide by jumping off the building due to ragging has been doing the rounds. However, the police are yet to ascertain whether Kumar fell off the terrace or committed suicide due to ragging. Bolangir police have registered a case and began

a probe. Kumar's parents, who are yet to reach Bolangir, have levelled serious allegations of ragging. As there is a 4-ft high barricade in the terrace, it is not believable that he might have fallen accidentally. According to sources, after hav-

ing his lunch, Kumar had gone to the roof of the hostel. However, it is not clear what happened on the roof and how he fell. He was immediately rescued from a pool of blood and rushed to the Bhima Bhoi Medical College and Hospital, where the doctors declared him dead upon arrival.

On the other hand, Sabita Mohapatra, the Dean of the Medical College, has refuted the allegations of ragging

The man, a resident of Tikhiri village, around 90km northeast of Bhubaneswar, was allegedly made to go through the ordeal by the sarpanch, who had visited his home last Sunday to seek donation for a temple

A complaint was filed by his wife at Marsaghai police station, alleging that the sarpanch abused them when they said that a certain amount had already been donated for the cause.

She claimed that her husband was made to rub his nose in his own spit as locals looked on.

Taking suo motu cognisance of a media report on the incident, the NHRC, in a statement, observed that the issue was of a very "serious nature" as the right to dignity of the victim had been

grossly violated.

A notice has been sent to the Chief Secretary in the wake of the incident recorded in Marsaghai police station area and a report sought within six weeks on the status of investigation into the

case, the commission said. The NHRC also directed that statutory relief be paid to the Dalit man.

PK Kanungo, the Marsaghai police station inspector, said a case had been lodged under various sections of the IPC, and the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act.

An investigation is underway but no arrest had been made yet, the officer added.

Surendranath Satpathy, and Titilagarh IIC Ranjan Bariha reached the spot and launched a probe. The bodies were seized and sent for autopsy. A man from Gulami has been illegally operating the mine and had engaged the workers for the last

three years, family members alleged while lodging a police complaint. Many people have lost their lives while working in the illegal mine yet the administration is not taking any step, locals alleged.

## SC raps Delhi Police over hate speech affidavit

New Delhi, April 22: The Supreme Court Friday expressed its displeasure over a Delhi Police affidavit which said "no hate speech was made" during an event held here by a rightwing outfit, and wondered whether the officer who filed the document had applied his mind or merely reproduced the inquiry report.

Posing searching questions, the court also directed the police to file a 'better affidavit" after which Additional Solicitor General (ASG) KM Nataraj, appearing for the Delhi Police, said they will have a "re-look" of the matter and file a fresh affidavit.

The Delhi Police had told the top court that "no specific words against



any community were uttered" at the event organised by the 'Hindu Yuva Vahini' December 19 last

"The affidavit has been filed by the Deputy Commissioner of Police. We hope he has understood the nuances. Has he merely reproduced the inquiry report or applied his mind? Is it your stand as well or the reproduction of inquiry report of sub-inspector level officer?" a bench of Justices AM Khanwilkar and Abhay S Oka asked.

The bench questioned can such a

stand be taken on an affidavit before the court and wanted to know who verified the affidavit and if Delhi Police was accepting it as a correct finding. "The ASG seeks time to get instructions from authorities to file a better affidavit ... Two weeks time prayed for. List this matter on May 9. Better affidavit be filed on or before May 4," it said.

The top court was hearing a petition filed by journalist Qurban Ali and former Patna High Court judge and senior advocate Anjana Prakash, who has also sought a direction for an 'independent, credible and impartial investigation' by an SIT into incidents of hate speeches against the Muslim community.

As the hearing commenced, senior advocate Kapil Sibal, appearing for the petitioners, drew the attention of the bench towards extracts of the speech and the enquiry report of the Sub Inspector (PS Okhla Industrial Area). "In the speech in question, they say, 'We are ready to kill'! And the Delhi Police says it is to 'save the ethics of the community?' Your Lordships may fix it for hearing and decide what constitutionally the ethics are ... "Sibal said. The court then asked the ASG if any senior officer has verified the affidavit.

"Some superior officer has seen it? Who has verified it? Has there been an application of mind as to if this stand can be taken on affidavit before the court? This affidavit is filed by the deputy commissioner of police? He accepts this position?"







## Longest known Covid infection lasted for 505 days

n immunocompromised UK patient suffered the longest known days, 505, with Covid infections, claim researchers


Previously the longest known PCR confirmed case is thought to be 335 days.

Researchers at the King's College London and Guy's and St Thomas' NHS Foundation Trust studied nine immunocompromised patients, between March 2020 and December 2021, who tested positive for the virus for at least eight weeks.

Infections persisted for 73 days, on average, but two patients had persistent infections for more than a year.

The patients had weakened immune systems due to organ transplantation, HIV, cancer, or medical therapies for other illnesses.

Regular sampling and genetic analysis of the virus showed that five of the nine patients developed at least one mutation seen in variants of concern.



Some individuals developed multiple mutations associated with variants of concern, such as the Alpha, Delta and Omicron variants

The virus from one individual contained 10 mutations that would arise separately in variants of concern, such as the Alpha, Gamma and Omicron variants.

"This provides evidence that mutations found in variants of concern do arise in immunocompromised patients and so supports the idea that new variants of the viruses may develop in immunocompromised individuals, said first author Luke Blagdon Snell, of Guy's and St Thomas NHS Foundation Trust.

Five of the nine patients survived. Two of those five cleared SARS-CoV-2 infection without treatment, two cleared the infection after treatment with antibody therapies and antivirals. and one individual has ongoing infection.

Researchers at the King's College London and Guy's and St Thomas' NHS Foundation Trust studied

nine immunocompromised patients, between March 2020 and December 2021, who tested positive for the virus for at least eight weeks

Infections persisted for 73 days, on average, but two patients had persistent infections for more than a year. The patients had weakened immune systems due to organ transplantation, HIV. cancer, or medical therapies for other illnesses

At their last follow-up in early 2022, the patient with ongoing infection had been infected for more than one year (412 days)

The person has been treated with monoclonal antibodies to try to clear their infection. If this person remains positive at their next follow-up appointment, they will likely pass the previous longest

known infection of 505 days described in this report.

"Immunocompromised patients with persistent infection have poor outcomes, and new treatment strategies are urgently needed to clear their infection. This may also prevent the emergence of variants." said Gaia Nebbia from the Trust.

The researchers also report one of the first cases of an occult Covid-19 infection, who is thought to have cleared the virus, with negative tests, but is later found to have an ongoing infection.

'This has been described with other viruses such as those that cause Ebola or hepatitis B and is different to long Covid where the virus is generally thought to be cleared from the body but symptoms persist," the team explained.

The team will describe the cases at the European Congress of Clinical Microbiology and Infectious Diseases (ECCMID) tobe held in Lisbon, Portugal, from April 23-26.

## MAKE GROUND SURVEY REPORT PUBLIC: HISTORIANS

## Wildfires raging in Chhendipada range

Chhendipada, April 22: Forest fires have been raging at different places under Chhendipada range of Angul district with the Debinagar hill, extending from Patrapada to Similipal, already in flames for the last few days. Though the exact reason of the blaze is not known. it is suspected to be man-made.

In the last few days, tress, bushes valuable plants along with wild creatures living in several hectares of woodland have perished.

It is said that people collecting minor forest produce like mahua flowers and sal leaves often set the forests afire. Subsequently, fires acquire dangerous proportions. Acres of land have been burnt



to ashes in parts of Debinagar hill and at its foothill areas.

Locals say as the fires spread, wild animals stray into villages. They also attributed the cause of wildfires to lack of monitoring and patrolling by Forest department and Vana Surakhya Samitis (VSSes).

Bijay Kumar Pradhan, president of Jay Jagannath VSS, squarely blamed the Forest department's apathy for the raging fires in the forest. "There is no coordination between the VSSes and the Forest department in protecting forests from fires. Situation is going out of con-

trol," Pradhan rued.

Similipal sarpanch Girish Chandra Pradhan said that there is no pond inside the forest to draw water to douse the blaze. Though forest officials have been engaged to extinguish fires, their efforts have failed to yield results, he observed.

Asked about the raging forest fires, Chhendipada ranger Pratap Chandra Roul said. "Forest staffers have been engaged to contain raging inferno. But we are not getting any help from local VSSes.

As the forest is home to some elephants. it is not possible to enter deep into forest and douse fires. Keeping a close watch on elephant movements, forest staffers have been trying to contain fires, he added.

## Korabandi forest denuded of sal trees

Kendrapara, April 22: Accorded the status of a civic body way back in 1869, Kendrapara Municipality, the oldest in the state, is still reeling from scores of basic problems due to the negligent attitude of the officials concerned.

Despite completing 153 years of its formation, the civic body areas are still in the grip of problems like encroachment, traffic snarls, electricity, drinking water supply, healthcare and waste management.

"More than 20 ponds have accumulated silt over the years. With mercury on the rise, unavailability of sufficient drinking water has added to the woes of the citizens. There is no provision for garbage collection and cleaning of the civic area on regular basis," some residents rued.

Drains and ponds filled with garbage are becoming the breeding ground for mosquitoes, thereby spreading vector-borne diseases.

"The Union as well as state government should give special focus on development and beautification of Kendrapara town," irate locals said.

Amarabar Biswal, a local intellectual, said, "Kendrapara district has the second largest waterway of Odisha. Previously, transportation through waterways was going on in nearby areas of the town. However, it is slowly decreasing by the day.

"It is sad that in 21 wards of the civic body only two ponds are in usable condition. A number of water bodies including 20 ancient ponds, canals and Gobari river

have been encroached upon," he added. The ponds and creeks in Kendrapara town can be restored under Jal Shakti Abhiyan, but the civic authorities are in deep slumber, Biswal added.

In a similar vein, a social activist Sheikh Sabbir said, "Smooth management of drainage and garbage is the need of the hour. I along with other residents have drawn the at-

tention of civic authorities in this regard, but to no avail. Ponds at Mahipal. Baniamal and new bus stand need urgent attention.

Main and service roads in the town have become narrow over the years due to encroachments, the activist claimed. Government lands on Gobari river embankment and Gobari canal are now under the ownership of encroachers.

On the other hand, utility poles are not removed during road expansion, thereby affecting vehicular movements. A second bypass road project in Kendrapara town,

which was proposed much earlier, is still on paper, the activist expressed.

Kendrapara and Jajpur Notified Area Councils (NACs) were accorded municipality status at the same time. However, areas under Jajpur municipality have undergone a sea change, activist Sheikh Amzan said.

On being contacted, the newlyelected chairperson of Kendrapara Municipality Sarita Sahu said, "The town has witnessed many developmental works in the last few years. New roads have been laid, parks established and electrifications carried out. Apart from above, local issues in different wards have come to the knowledge of the civic authority. The process to bring Kendrapara town at par with other developed towns of the state will begin very soon.'

## **Face-off on cards**

o address the deficit of SP and DIG-level police officers in Central Armed Police Forces and Central Police Organizations, the Ministry of Home Affairs (MHA) has now proposed that IPS officers who do not come on Central deputation at the SP and DIG-level may be barred from a Central posting for the rest of their career!

Sounds pretty harsh but with more than a reported 50 per cent vacancies at both these levels at the Centre, it seems like a desperate move by the ministry. But coming close on the heels of another proposal to amend the civil service rules that would allow the Centre to summon any IAS, IPS and IFoS officer on Central deputation with or without the state's consent, this move too is unlikely to win the Centre any kudos from the states.

That the move is bound to face stiff resistance from the states is obvious, given that they accuse the Centre of trying to weaken their powers. The MHA babus argue that under existing rules, most IPS officers come on Central deputation only at the IG level, which has led to the current shortage of SP and DIG-level officers at the Centre. But even senior IPS officers feel that the Centre is taking this step as a short-term measure but one that will harm the service in the longer run. There will surely be a fight back from the states on the proposal, but surely the MHA has worked out its plan for that eventuality.

### Kerala babu behind CM-Governor tussle back in old job

Senior Kerala IAS officer KR Jyothilal who was moved out as General Administration Department (GAD) Secretary in February has reportedly been brought back to the same post. The babu had been amid an unprecedented tussle between Chief Minister Pinarayi Vijayan and the state

Governor Arif Mohammed Khan as reported earlier in this column (DKB, Feb 22, 2022). Apparently, a letter written by the

that he refused to sign the Governor's address to the state Assembly. The letter at the heart of the controversy and written by Jyothilal had been sent to the Raj Bhavan with the appointment order of Hari Kartha, a BJP leader, as an additional PA to the Governor. Sources informed DKB that while this letter mentioned that the government had approved the appointment of Kartha as per the Governor's wish, it also conveyed the displeasure of the Chief Minister stating that there was no precedent of appointing political leaders in Raj Bhavan. Khan took umbrage at this. At the time, Vijayan prudently removed Jyothilal from the post and defused a potentially ugly constitutional crisis

But two months later, the babu is quietly back in his old post, his name tucked in between the names of several IAS officers who were recently transferred. Does this mean that the 'truce' between Vijayan and Khan is over? Or will Jyothilal's second coming revive the tensions between the state government and the Governor?

While the Governor's office has not commented on this, future actions of the CM may hold the key to this key relationship, which has seen some rocky moments.

### Post-retirement job bonanza for senior babus

Several retired babus in Haryana have reason to be pleased with the state Chief Minister Manohar Lal Khattar. After all, Khattar has re-employed more than a dozen IAS and IPS officers in important posts after their retirement. Most recently, two former IAS officers Vijai Vardhan and SS Phulia were appointed as Chief Information Commissioner and Information Commissioner respectively of the State Information Commission. Vardhan has retired as chief secretary in November last year. He has replaced former IPS officer Yashpal Singhal, a former DGP in the state. Earlier in January this year, former IAS officer Jyoti Arora who is also the wife of Home Secretary Rajiv Arora, was also made an information commissioner after her retirement.

But the list of such appointments is long, say sources, and goes back several years. Khattar is reportedly unwilling to let senior babus go off into retirement and keeps bringing them back to serve the government. Former chief secretary Keshni Anand Arora was similarly made chairperson of the Haryana Water Resources Authority. And so, it goes. While quite kosher, no doubt, it does seem to suggest that some babus do get a better deal than many of their cohorts!

Russia has brought India into regional grouping with China --BRICS, RIC and SCO. Some observers would argue that Russia did so to counter the Chinese dominance in the region. China has roped in Pakistan to counter India. So, Russia making India sleep with her enemies is no big deal. It is not reducing China's incredible and controversial claims on Indian territory and its questionable actions on the borders.

India perhaps calculates that Russia will be a greater support in its conflicts with China and Pakistan than the United States. And the US will have to ally with India in its hegemonic competition with China in the India-Pacific region. So why alienate Russia!

The point to consider and debate is whether India's dependence on Russia was inevitable and indispensable.

Also, if India's foreign policy, driven by non-alignment and security concerns alone has helped India's growth and development, has it not cost India heavily on defence purchases? Calculate the cost of lack of investment on various sectors of its economy and society. The Soviet Union and Russia have been military powers not economic powers. Look at China, even being an au-

thoritarian communist state, it did brisk business with all the big economies in the West, the US, its allies, the NATO countries, Japan, South Korea, using its strict labour laws and demographic strength. Today, with its huge economy, marginally less than that of the US alone, Beijing can stand up to any big power including the US. New Delhi, tied to its security compulsions, and the unworkable strategy of non-alignment, spent its scarce resources, meagre foreign currency reserves in buying weapons, the biggest bulk of it from one country, Soviet Union/Russia

India thankfully made course correction after 1991 by opening up to the West, causing improvement in her economy, But this happened not because of India's strategic shift, but due to rethinking in the

West in regard to China. As Beijing became ambitious and began to challenge its benefactors, the West turned to India, biggest democracy, huge market and enormous (wo)man-power. As they began to court India, New Delhi in its 'strategic autonomy" and security trap, has not been responding to such overtures, inflicting heavy costs to her economy and even to polity.

Elaborating the costs, India is suffering from its muddled up non-alignment, let us scan three major sectors -- political, economy, and social.

India is known for her democracy, the only Asian country sustaining it despite several challenges. India is also known for its political principles of equality, liberty, harmony, co-existence, non-aggression, a culture of synthesis. Russia has been a communist, one-party, one-leader autocratic country. So, India does not inspire others by standing with such a regime.

In economic growth, the Soviet Union/Russia has drained India by all the defence deals, not helped her economy. Manohar Lal Sondhi, a diplomat and academic, brought it up long back in his book Non-Appeasement: A News Direction in India's Foreign Policy. There are several other studies to show the avoidable drain of India's resources through her defence purchases from the Soviet Union/Russia.

The third sector is social. Indian politics and society tend to relate to the West in terms of rationality, liberalism, progressivism, tolerance and respect for dissent India has hardly anything in common with Russian social and political values which are largely feudal and anti-dissent.

Is it not the time for New Delhi to rethink, reset its foreign policv and redetermine its national interest? Prime Minister Modi was expected to correct the historic fault lines created by Nehru. He and his party rightly point them out. But he is falling into the same trap and not being able to extricate from the Russian bear-hug. Strange indeed for a strongman like him! He may just have to take out his hat of the path-breaker political innovator, like he did in Jammu and Kashmir and Israel-Palestine relations. He does it rather fast

before it gets worse.

### Aerotropolis

When this first appeared, from the mind of Professor John Kasarda of the University of North Carolina in 2000, it looked like one of those words whose life would be short and its death unmourned. But it shows signs of achieving some permanence in the vocabulary of aviation, economics, and urban planning. The idea behind the term is that major air transport hubs are now linked with levels of economic importance that were once the preserve of major seaports. The jobs directly generated by the airport itself are obviously significant; much more financially important, however, are the firms that relocate near the hub to take advantage of the speed with which passengers and high-value cargo can be flown all over the world. In several places, new airports are being created explicitly to exploit this, for example the new Suvarnabhumi International Airport in Thailand and the Dubai World Central airport. The term is a combination of aero-, in its aircraft sense, with metropolis. There's some doubt in writers' minds what the plural should be; both aerotropolises and aerotropoli have appeared; both are ugly, though the latter is to be deprecated because it puts a Latin plural ending on a word of Greek extraction.

orty-six years ago, in the sum-✓ mer of 1976 and the height of Emergency, four judges of the Supreme Court had viewed that a person has no right to appeal against unlawful detention when the state was in emergency due to internal disturbances (Article 352). They were deciding on the appeal of SP Shukla against alleged illegal detention order of ADM Jabalpur on 30th April 1976. As per them, detention under MISA Act is open for challenge by detenues, as Article 359 suspends all fundamental rights, including right to life & liberty (Article 21) when internal emergency is clamped. Justice Beg said 'Liberty is the gift of law & may by law be forfeited or abridged.' The majority judgement in ADM Jabalpur VS SP Shukla case is viewed "as a stain on the legacy of the court for many years'. The dissenting judge was Justice HR Khanna who had observed that 'detention without trial is an anathema to all those to love personal liberty'. In a splendid riposte to the maiority verdict Justice Khanna had said that Article 21 is not the sole

repository of human right to life and liberty. Even in the absence of Article 21, the state cannot deprive a person of life or liberty without the authority of law. This is the basic assumption of rule of law in every civilized society. For Justice Khanna, life and personal liberty are alienable to human existence. Neither life nor liberty are bounties conferred by the state nor did the Constitution created these. The dissenting judgement was given at the height of Emergency when Mrs Indira Gandhi wanted judges and bureaucrats to be committed to the ideology of the ruling party rather than to the rule of law.

When the Emergency was lifted and the Janata Party came to power the government amended Article 352 by replacing internal disturbances with armed rebellion in the 44th Amendment to the Constitution (1978). More importantly it amended Article 359 where it took out Article 20 (protection against violation of law) and Article 21 (right to life and liberty) from the scope of abolition of fundamental rights during imposition of internal and external

emergency under Article 352. Justice Khanna quoted Justice Evan Hughes who wrote "dissent in a court of last resort is an appeal to the brooding spirit of law, to the intelligence of a future date, when a later decision may possibly correct the error into which the dissenting judge believes the court to have been betrayed."

As if to prove his prescience and foresight, the Supreme Court in the famous Putta Swamy case (2017) has formally overruled the majority judgement of ADM Jabalpur Vs SP Sukla. Justice DY Chandrachud, son of Justice YV Chandrachud, who was part of the majority verdict in 1976, has observed "constitutional democracy can survive only when citizens have an undiluted assurance that the rule of law will protect their lives and liberty against any invasion by the state. The view taken by justice Khanna is accepted in reverence for the strength of thoughts and courage of its conviction." It's a rare judgement by a son who has overruled his illustrious father who was CJI of India. We owe it to

HR Khanna to remind us all about the majesty of rule of law, constitutional democracy, independent vigil of institutions created to exercise check and balance and that right to life and liberty is not a gift of the Constitution. It existed before the Constitution of India came into effect.

The Emergency imposed in 1975 and capitulation of judges in ADM Jabalpur case have been the darkest years of Indian democracy and of independent institutions like the judiciary which is to act as an effective check and balance against legislative and executive tyranny. In the Minerva Mills Case (1980) the Supreme Court bounced back to reiterate that Parliament's power to amend the Constitution is limited. And that judicial power to redflag legislative excesses remains robust and inalienable. It requires both courage and supreme intellectual understanding of a judge like Justice Khanna to defend liberty and life from arbitrary emasculation.

### Physicians at greater risk

Sir, It is disturbing to know that doctors with the noble purpose of serving people in rural India are attacked by the local goons. For instance, a doctor couple set up a hospital in a backward region of Rajasthan. Dr Archana Sharma of the hospital was hounded by the locals for the death of a patient. Depressed, she committed suicide. In another case Dr Nilesh Maske, who worked in a rural hospital at Tisgaon village ( Maharashtra), too was brutally thrashed for a patient's death. Such cases always demoralise the doctors to work in rural areas. On the other hand, a World Bank report of 2019 suggests that 66% of our population lives in rural areas and 70% of work force living in rural pockets contribute 40% of the national income. At one level it is encouraging to note how rural India is playing a decisive role in nation building. But the other side reflects that innocence of people living in rural regions has become a thing of the past with a few exceptions. Government wants doctors to serve people in the rural areas. But unless some radical improvement in facilities along with widespread dissemination of information coupled with adequate police infrastructure are established, not many private medicine practitioners will come forward to set up hospitals in K Ravi, BHUBANESWAR rural areas.

### Unforced error

New Delhi, April 22: Within three weeks of lifting its mask mandate, the Delhi government Friday made masks mandatory at public places with immediate effect, and imposed a fine of ₹500 for any violation as coronavirus cases rise in the city again.

However, those travelling together in a private four-wheeler are out of the purview of the new rule, according to an order issued by the city's Health and Family Welfare Department.

The order does not mention if people travelling in hired cabs and taxis will be required to wear masks. The Delhi Disaster Management Authority (DDMA) had in a meeting last Wednesday decided to make masks mandatory at public places with a fine of ₹500 for any violation. The DDMA meeting, attended

by Lt Governor Anil Baijal and Chief Minister Arvind Keiriwal among others, had noted that Covid case positivity rate has been increasing in Delhi over the past fortnight. In its order on Friday, the DDMA said it took the decision on fine after examining all relevant

facts related to the issue of penal provisions for not adhering to the protocol of wearing masks at public places.

"A fine of ₹500 for not wearing of face mask in all public places in Delhi will be imposed from immediate effect till further orders,' the DDMA said. On April 2, the Delhi government had lifted the penalty of ₹500 for not wearing face masks at public places as cases were fairly under control for a few weeks before that.

As far as people travelling in private vehicles are concerned, the Delhi government has modified its rules on at least two occasions this year.

February 4, the DDMA had allowed single person travelling in a private vehicle to remain without masks. From February 26, however, it tweaked the rule to say that no fine for violating the mask norm will be imposed on people travelling together in a private vehicle. Coronavirsu cases and positivity rate have been on the rise for the past few days in the national capital.

Thursday, it logged 965 fresh cases and one death. A day before on Wednesday, the number of fresh cases had crossed 1000 mark



One of the major criticisms by the opposition Congress and BJP is that the Left government is not listening to the concerns of common people and the views of those who oppose it.

Resumption of the survey stone laying work for the project after a gap of almost one month was marred by protests Thursday, with locals and anti-SilverLine activists clashing with the police in the state capital and northern Kannur, prompting authorities to halt the process temporarily.

Alleging police high-handedness against protesters, the opposition Congress came down heavily on the Vijayan government and urged it to stop action against common people and their party activists, who oppose the multi-crore project.

Leader of Opposition in the Assembly, V D Satheesan even drew a parallel between police action against the anti-Silver Line protesters in the state and the demolition drive in New Delhi and asked whether Left leader Brinda Karat was seeing this.



Thiruvananthapuram, April 22: Even though Kerala Health Minister Veena George accused the Centre of propagating false news that the government has stopped updating daily Covid figures, the state Covid dashboard was last updated April 5 leading people to speculate whether there has been a spike in fresh infections.

George had said that they have been e-mailing the daily data on Covid to the Centre. But the practise of regular daily updates given to the media, which was a feature ever since the pandemic began, is not happening.

According to the dashboard April 5, there were 354 confirmed cases and 282 recoveries.

But a mobile laboratory technician in the state capital said on Friday that these days he tests



about 40 people daily, of which 15 to 17 turn positive

Similarly, questions are being raised on party's silence over former Deputy Rajya Sabha Chairman and Congress leader PJ Kurien's slamming of Rahul Gandhi in an interview with a vernacular magazine in state capital

Thiruvananthapuram Sunday. Thomas is 75 years old and has

had a very long innings in electoral politics both at the state and Centre, while 81-year-old Kurien has had an even longer political innings, but it was in Delhi only where he had served six terms in the Lok Sabha from 1980-99 and in the Upper House from 2005 till 2018, when in his last term he was the Deputy Chairman.



Incidentally, both the top Congress leaders have some similarities: former college professors, belong to Christian community and are unhappy especially with the party high command.

While Thomas was not allowed to contest his sitting Lok Sabha constituency in 2019, Kurien wanted another term in the Upper House which was turned down by the Congress, and has led to both of them turning jittery. Another similarity between the two

Congressmen is due to their long innings in Delhi, both of them have very little grassroots support in Kerala and not much tears are being shed on account of their present grouse. But what has come as a shocker is that at the Congress's top committee meeting in Thiruvananthapuram held this week where both Thomas and Kurien need to be present but neither took part.

While Thomas was not invited to the party meet, Kurien expressed

his inability to attend the meeting citing personal reasons.

However, senior Congress leader Ramesh Chennithala intervened and said there is nothing new in what Kurien said and is similar to the statements that the G23 (group of top Congress leaders in

Delhi who first expressed their displeasure against the way Rahul Gandhi is conducting himself) and can be ignored.

Soon, the Kerala Opposition leader VD Satheesan also intervened and voiced the same opinion as Chennithala and said the party committee need not waste its time on the same issue.

A media critic on condition of anonymity said it's strange how the Congress leaders in Kerala behave as the two of the biggest enemies of Kurien -- senior Congress leader Oommen Chandy and Chennithala took a soft political stand.

Kurien has been angry with Chandy and Chennithala as in 2018 when he was expecting a fresh Rajya Sabha term, the latter decided to placate the estranged Kerala Congress (M) leader KM Mani, who had temporarily quit the Congress-UDF alliance, offered the constituency to his son Jose K.-Mani, who had a year left to complete his Lok Sabha term.

## Court can review govt's decision on remission, says SC



PRESS TRUST OF INDIA New Delhi. April 22: Court has the power to review the decision of the government on the acceptance or rejection of remission and is also empowered to direct it to reconsider its decision, the Supreme Court said Friday.

A bench of Justices D Y Chandrachud and Aniruddha Bose said while a discretion vest with the government to suspend or remit the sentence, the executive power cannot be exercised arbitrarily.

It said the prerogative of the executive is subject to the rule of law and fairness in state action embodied in Article 14 of the Constitution."The Court has the power to review the decision of the government regarding the acceptance or rejection of an application for remission under Section 432 of the CrPC to determine whether the decision is arbitrary in nature," the bench said.

The observations of the top court came on a plea filed by a convict Ram Chander who is undergoing a sentence of imprisonment for life upon being convicted for the commission of offences punishable under Section 302 (murder) read with Section 149 (unlawful assembly) of the Indian Penal Code.

The convict sought the issuance of a writ directing the Chhattisgarh government to grant him pre-mature release

The top court said though the court can review the decision of the government to determine whether it was arbitrary, it cannot usurp the power of the government and grant remission itself.

On the issue of the opinion of

the presiding judge of the court for deciding remission, the apex court said that the appropriate government should not mechanically follow the opinion of the presiding judge.

"In the present case, there is nothing to indicate that the presiding judge took into account the factors which have been laid down...."These factors include assessing (i) whether the offence affects the society at large; (ii) the probability of the crime being repeated; (iii) the potential of the convict to commit crimes in the future; (iv) if any fruitful purpose is being served by keeping the convict in prison; and (v) the socio-economic condition of the convict's family," the bench said.

The apex court directed that the petitioner's application for remission should be re-considered."We direct the Special Judge, Durg to provide an opinion on the application afresh accompanied by adequate reasoning," it said. The top court said that in this case the Special Judge, Durg must provide his opinion within a month of the date of the receipt of this order.

New Delhi, April 22: Five states -- Uttar Pradesh, Rajasthan, Bihar, Madhya Pradesh, and Kerala -- account for 49 per cent of the overall extraction of groundwater in the entire country while the rest of the country accounts for 50 per cent, government data between 2004 and 2020 has shown.

"However, it was only in 2009. that Andhra Pradesh replaced Madhya Pradesh," said an official associated with Jal Jeevan Mission (JJM), the flagship programme of the Jal Shakti Ministry.

Groundwater is of vital importance as it sustains ecosystems, maintains the base flow of rivers and prevents land subsidence and seawater intrusion, he said.

"These top five states withdraw about 24.37 billion cubic metres (BCM)," the data from the Ministry of Jal Shakti showed adding, between year 2004 and 2020, groundwater drawl has increased from 18.09 BCM to 27.31 BCM implying an average annual increase of 576 million cubic metres.

However, these are not the highest groundwater withdrawing states in terms of absolute volume. The stage of ground water extraction is very high in Delhi, Haryana, Punjab and Rajasthan, where it is more than 100 per cent, which implies that in these states, the annual ground water consumption is more than annual extractable ground water resources.

In the states of Himachal Pradesh, Tamil Nadu, Uttar Pradesh and UTs of Chandigarh and Puducherry, the stage of ground water Extraction is between 70-100 per cent. In the rest of the states / UTs, the stage of ground water de-

velopment is below 70 per cent.

New Delhi, April 22: The Delhi High Court Friday issued notice to Delhi Police on the bail application of JNU scholar-activist Umar Khalid, who had approached the court following the dismissal of his bail plea from a trial court in the alleged "larger conspiracy" behind the Delhi riots.

While issuing notice in the matter, the division bench of Justices Siddharth Mridul and Rajnish Bhatnagar said the speech delivered by Umar Khalid at Amravati, was "offensive and obnoxious".

Seeking the stand of prosecution and to reply within three days, the bench slated the matter for further hearing on April 27. During the course of the hearing, the court asked Khalid's counsel about the speeches he delivered.

"Did Gandhiji ever employ this language? Did Shaheed Bhagat Singh ever employ such language? We have no qualms about permitting free speech but what are you saying?", the bench asked.

Earlier in the trial court, Khalid's counsel, opposing the charges under the Indian Penal Code and UAPA, had termed the charge sheet a "work of fiction". He argued that the speech given by Khalid was about Gandhi, harmony, and the Constitution, and it was not a crime. After the submissions, the court had reserved the order.

Opposing the bail plea, Special Public Prosecutor (SPP) Amit Prasad had argued on the relevance of the speech given by Umar Khalid in Amravati in February 2020. He said the bail application was rejected on February 11, 2022 pointing out that the announcement of Donald Trump visiting India came on the same day.

Last month, Additional Sessions Judge Amitabh Rawat had denied bail to Khalid, observing that there were reasonable grounds for believing that the accusation against the accused are prima facie true.

New Delhi, April 22: The Supreme Court Friday refused to entertain a plea by Maharashtra Minister and NCP leader Nawab Malik to release him in a case of money laundering.

A bench comprising Justices D.Y. Chandrachud and Surya Kant said: "We will not interfere. It is too nascent a stage to interfere...We can't interfere with the due process at this stage."

The bench asked senior advocate Kapil Sibal, representing Malik, to move the competent court with the bail application. "The special court can consider the bail application," said the bench.

Sibal vehemently argued that there was no prima facie case and there was no predicate offence, no FIR on forgery, and added, 'How does Prevention of Money Laundering Act be applied?"

Sibal said, "How do they arrest me in 2022 for something, which happened in 1993...where I am not in the picture at all?"

Sibal added that the special court is not going to grant his client bail with a 5000-page charge sheet filed in the matter. "The Arnab Goswami judgment is in my favour," Sibal submitted

Refusing to entertain Malik's plea, the bench said: "We are not inclined to exercise jurisdiction under Article 136 when the investigation is at the nascent stage."

The bench clarified that the observation of the high court on merits should not come in the way of parties taking recourse to the rights available under the law.

Malik, moved the top court challenging the Bombay High Court, which declined his interim release in a habeas corpus petition. Malik has claimed that his arrest was completely illegal.

Moscow, April 22: Amid the ongoing Russia-Ukraine war, the Russian Foreign Ministry has issued a list of US figures, including tech honchos, who are now prohibited from entering the county for an indefinite period.

According to TechCrunch, the list includes high-profile US politicians such as Vice President Kamala Harris, tech leaders, including Meta CEO Mark Zuckerberg and LinkedIn chief Ryan Roslansky, as well as journalists and others who it says are promoting a 'Russophobic' agenda

The announcement is also an extension of Russia acting to shut down or restrict access to several Western platforms that are not complying with its regulations on information dissemination, specifically for trying to limit pro-Russian messaging.

These shutdowns have included snapping access to Facebook and Instagram, limiting access to Google News and issuing warnings about YouTube. Meanwhile, Apple, Google, Microsoft and many other tech giants have shut down or paused operations in Russia.

No one immediately claimed responsibility but Afghanistan's Islamic State affiliate Friday claimed a series of bombings that happened a day earlier. the worst of which was an attack on a Shiite mosque in northern Mazar-e-Sharif that killed at least 12 Shiite Muslim worshippers and wounded scores more.

Earlier the Kunduz provincial police spokesman put the death toll at the Malawi Bashir Ahmad Mosque and madrassa compound in Imam Saheb at two dead and six injured. Mujahid later tweeted the higher casualty numbers tweeting "we condemn this crime...And express our deepest condolences to the victims".



Friday's bombing is the latest in a series of deadly attacks across Afghanistan. The United Nations called the attack "horrific". Deputy special representative to Afghanistan Ramiz Alakbarov said in a tweet that "killings must stop now and perpetrators brought to justice".

Since sweeping to power last August, the Taliban have been battling the upstart Islamic State affiliate known as Islamic State in Khorasan Province or IS-K which is proving to be an intractable security challenge for Afghanistan's religiously driven government. Last October the IS-K claimed a

Auxerre, France, April 22: French President Emmanuel Macron and far-right challenger Marine Le Pen made final appeals Friday to undecided voters weighing fears of what a Le Pen presidency could bring against their anger at Macron's record.

According to the latest surveys

for Sunday's run-off, fear may win the day over loathing: Macron the centrist, pro-European incumbent leads his anti-immigration, eurosceptic challenger by between 10-14 points, well outside margins of error.

But the fact that nearly three in 10 voters say they will not vote or have not made up their minds means a surprise Le Pen win sim-



ilar to events such as Brexit and the election of Donald Trump as U.S. president cannot entirely be ruled out. In recent days, Macron has toned down his often abrasive style with acknowledgments that his attempts at economic and social reform had left many French angry and dissatisfied.

"She (Le Pen) has managed to draw on some of what we did not manage to do, on some of the things I did not manage to do to pacify some of the anger," Macron told France Inter radio on Friday, citing the concerns of low- and middle-income voters about law and order or hits to their livelihoods.

Four separate surveys published on Thursday and Friday showed Macron's score nonetheless either stable or slightly rising to reach between 55.5% and 57.5%

But they also put turnout at between 72% and 74%, which would

be the lowest for a presidential run-off since 1969.

In the central city of Auxerre, some voters were rallying, albeit without enthusiasm, to Macron.

That resonates for many on the streets of the former industrial north of France, a region which includes many Le Pen strongholds and where she has chosen to conclude her campaign.

Despite a welfare system more generous than most of the world, massive support for French households during the pandemic and fuel bill caps to offset rising energy prices, the cost of living – emerged as the top campaign issue of the election.





New Delhi, April 22: Equity markets buckled under selling pressure Friday after a two-session rally as selling emerged in IT, bank and energy stocks amid a bearish trend overseas following hawkish comments from the US Federal Reserve.

The BSE benchmark Sensex tanked 714.53 points or 1.23 per cent to end at 57,197.15. The broader NSE Nifty slumped 220.65 points or 1.27 per cent to 17.171.95.

SBI was the biggest laggard in the 30-share Sensex pack, losing 3.08 per cent, followed by HUL, IndusInd Bank, Dr Reddy's, Axis Bank, Bajaj Finserv, Infosys and ICICI Bank.

On the other hand, M&M, Bharti Airtel, Maruti Suzuki, Asian Paints, ITC and HCL Technologies were the gainers, climbing up to 0.98 per cent. On a weekly basis, the Sensex lost

1,141.78 points or 1.95 per cent, while the Nifty shed 303.70 points or 1.73 per cent.

In the broader market, the BSE midcap gauge declined by 0.71 per cent and the smallcap index dipped 0.38 per cent in Friday's session.

A sharp drop in the rupee and unabated foreign fund outflows added to the gloom. analysts said

As many as 1,956 stocks declined, while 1,451 advanced and 124 re mained unchanged.

All BSE sectoral indices settled lower, with bank falling the most by 2.19 per cent, followed by metal (2.17 per cent), finance (1.70 per cent), healthcare (1.57 per cent) and basic materials (1.45 per cent).

World stocks dived after US Federal Reserve Chairman Jerome Powell indicated a 50 bps rate hike in May amid efforts to rein in rocketing inflation.

Meanwhile, international oil benchmark Brent crude declined 1.60 per cent to \$106.6 per barrel. The rupee declined 32 paise to close at 76.49 (provisional) against the US dollar Friday, amid a firm green-

### Govt tweaks coal utilisation norms

New Delhi: The Union power ministry Friday said that it has allowed private power generating stations to secure coal supplies for up to three years instead of current norm of one year, a move that comes against the backdrop of rising demand for electricity. The ministry has tweaked the methodology for the use of coal, allocated to states, by Independent Power Producers (IPPs) wherein the timeline for the bidding process has also been reduced to 37 days from current 67 days.

### **BoB slashes home** loan interest rate

Mumbai: State-owned Bank of Baroda Friday said it has reduced interest rate on home loans to 6.50 per cent per annum from 6.75 per annum for a limited period. The new rates, which are linked to the borrower's credit profile, are applicable till June 30, 2022, the bank said in a release. "We have seen a significant pick-up in home sales over the last many months and we are delighted to extend the good times for home buyers with the introduction of a special, limited period interest rate offer," its GM HT Solanki said.

the resolution while 30.71 per cent voted in favour of it, FRL said in a regulatory filing.

While 85.94 per cent of shareholders have voted in favour of the deal with Reliance, 14.06 per cent of shareholders opposed it.

FLFL's 82.75 per cent secured creditors voted against the deal while 17.25 per cent supported it. Similarly, 81.91 per cent of shareholders supported the deal and 18.09 per cent opposed it.

New Delhi, April 22: Reliance Industries Ltd, operator of the world's biggest oil refining complex, has ordered at least 15 million barrels of Russian oil since Russia invaded Ukraine in February, trade sources said

Before the Ukraine war, Indian refiners, including Reliance, rarely bought Russian oil owing to high freight costs.

But Western sanctions against Russia since its Ukraine invasion, which Moscow calls a "special operation", have prompted many oil importers to shun trade with Moscow, depressing its crude prices to record discount levels.

Indian refiners have snapped up the cheap barrels as India, the world's third-biggest oil importer and consumer, is hit hard by high oil prices. India imports about 85% of its 5 million barrels per day oil needs.

While New Delhi has called for

Reliance is scheduled to received its first parcel of Russia's ESPO oil in early May, the Refinitiv data shows. This grade is mostly supplied to China.

Navi Mumbai, April 22: Former champions Kolkata Knight Riders will be desperate to bring their flagging campaign back on track when they face leaders Gujarat Titans in the IPL here Saturday.

Having suffered three defeats in a row, the Shreyas Iyer-led outfit has slipped to seventh in the table and the task gets tougher against the Titans, who have been a revelation in their maiden season. The Hardik Pandya-led Gujarat Titans

have been firing on all cylinders, with their batting prowess and bowling might.

Pandya pulled out of their last match against Chennai Super Kings owing to a groin injury but it was business as usual for the Titans as stand-in skipper Rashid Khan led the team to a three-wicket win over the four-time champions.

The biggest plus in their win against CSK was Rashid's sensational form with the bat as he smashed a 21-ball 40 to help his team chase down the target with a ball spare.

GT's opening combination may not have given them the desired start and most of the times the middle-order has rescued the Titans. It was David Miller (94 not out from 51 balls) who anchored the show against Chennai after half the side were back in the pavilion with 87 runs inside 13 overs.

According to Rashid, Pandya's injury was "not serious and there's nothing to be worried about". Pandya has been in superlative form with 228 runs from five innings at an average of 76.00.

The onus would be on Kolkata's bowlers



to seize the momentum and stop the Titans' three-match winning run. KKR's pace attack led by Pat Cummins and Umesh Yadav and spinner Varun Chakravarthy were taken to cleaners by the Rajasthan Royals batters in their last match.

It remains to be seen if the team thinktank would bring back Tim Southee in the XI as the key lies in getting early breakthroughs and giving Sunil Narine a perfect stage to restrict the flow of runs.

Narine, a vital cog in KKR's wheel for long, has once again been their go-to man and boasts of the best economy rate of 5.03 after seven matches.

The batters have stopped taking risks against the Trinidadian and he would hope that their pace battery gives some early breakthroughs to make the task easier for the wrist spinner.

The game also throws an interesting



match-up between former KKR batter Shubman Gill and Narine. Gill had a fine start to the tournament but has gone quiet after a couple of splendid knocks.

In such a scenario, the Titans bowling attack in Mohammed Shami, Lockie Ferguson, Rashid Khan and Pandya would look to capitalise.
