#### WC: India archery team bag gold

**Antalya:** Indian men's compound archery team of Abhishek Verma, Rajat Chauhan and Aman Saini downed France by one-point in a thrilling final to win the gold medal at the World Cup Stage 1 here in Turkey Saturday. This was the men's compound team's first World Cup gold medal since Shanghai 2017. India, however, lost out on a second medal after the compound mixed pair of Verma and Muskan Kirar went down 156-157 to Croatia in the bronze medal playoff. # **CBSE drops chapters** on Islamic empires

The Board says the changes are part of rationalisation of syllabus and are in alignment with recommendations by the NCERT

New Delhi, April 23: The CBSE has dropped chapters about the Non-Aligned Movement, the Cold War era, the rise of Islamic empires in Afro-Asian territories, the chronicles of Mughal courts and the industrial revolution from the history and political science syllabi of Class XI and XII.

Similarly, in Class X syllabus, the topic "impact of globalisation on agriculture" from a chapter on 'Food Security' has been dropped. The translated excerpts from two poems in Urdu by Faiz Ahmed Faiz in the 'Religion, Communalism and Politics — Communalism, Secular State' section have also been excluded this year.

The Central Board of Secondary Education (CBSE) has also dropped from the course content chapters on 'democracy and diversity'.

Asked about the rationale behind the choice of topics or chapters being dropped, officials maintained that the changes are part of rationalisation of syllabus and are in alignment with recommendations by the National Council of Educational Research and Training

The dropped chapter 'Central Islamic Lands' in Class XI history syllabus talks about the rise of Islamic empires in the Afro-Asian

territories and its implications for economy and society, according to the description in last year's syllabus. The chapter focused on arenas of Islam in reference to its emergence, the rise of the caliphate and empire building.

Similarly, in the class 12 history syllabus, the dropped chapter titled 'The Mughal Court: Reconstructing Histories through Chronicles' examined the chronicles of Mughal courts to reconstruct the social, religious and cultural history of the Mughals. The syllabus shared with schools for the 2022-23 academic session also hints at the board's decision to revert to a single-board exam in a session from the twoterm examination last year.

While the two-term exam was announced as a one-time special measure taken in view of the Covid pandemic, the board officials had last week said a final call will be taken in due course of time keepState' section have

"CBSE annually provides curriculum for Classes IX to XII containing academic content, syllabus for examinations with learning outcomes, pedagogical practices and assessment guidelines. Considering the feedback of stakeholders and other prevailing conditions, the board is in favour of conducting the annual scheme of assessment at the end of the academic session 2022-23 and the curriculum has been designed accordingly," a senior board official said.

However, this is not the first time the board has dropped from the syllabus certain chapters which have been part of the curriculum for decades. The CBSE in 2020 had announced that chapters on federalism, citizenship, nationalism, and secularism in the class 11 political science textbook will not be considered while assessing students, triggering a major controversy

#### Severe heatwave to singe Odisha

Bhubaneswar, April 23: Severe heatwave conditions continued to prevail in the state as mercury surged to 40 degrees Celsius or above at 22 places including the twin cities of Cuttack and Bhubaneswar, Saturday. The India Meteorological Department (IMD) said that the temperature would rise by 3 to 5 degrees in next three days.

Angul town recorded the maximum temperature of 42.1 degrees Celsius and turned out to be the hottest place of Odisha Saturday followed by Bhubaneswar (41.7 degrees C), according to Bhubaneswar Meteorological Centre.

Similarly, Boudh, Deogarh and Dhenkanal recorded 41.5 degrees each whereas the day temperature was 41 degrees at Cuttack, Barinada. Bolangir and Paralakhemundi

The prevailing heatwave condition will continue to sweep the state for next few days. Due to northwesterly-westerly dry air and high solar insolation, the day temperature is very likely to gradually rise by 3 to 5 degrees at many places over the districts of interior Odisha during next three days.

# Ore smuggling on NH rampant as i3MS fails-

■ Iron ore mafia active on NH-16 and NH-53 manipulate the weight of the loaded vehicles at government weighbridges to plunder the minerals

Chandikhole, April 23: In what appears to be a complete failure of the state government's Integrated Mines and Mineral Management System (i3MS), which aims at tracking the minerals through electronic mode, several tonnes of iron ore are being smuggled by the mafia active on National Highway-16 and 53.

As per reports, iron ore being transported from mineral-rich Keonihar and Sundargarh districts do not reach Paradip Port as the active mafia gangs on National Highway-16 and 53 smuggle it midway. However, records are properly maintained to show that the minerals are delivered at the port.



The i3MS solution was designed to enable the Steel & Mines department officials to regulate the mining activities through electronic mode. However, the GPS trackers which are vital for functioning of the i3MS are missing in most of the vehicles. Moreover, no one is monitoring the duration of halts the vehicles make in between departure and arrival points.

It is also alleged that the truckers are manipulating the weight of the minerals with the help of staffers at government weighbridges in these districts.

A few weeks ago, huge stacks of iron ore were seized from an area near Bandalo Square on NH-16 under Barchana police limits in Jajpur district. Police had also seized the truck. Although the

driver was arrested, police are yet to nab the mastermind of the ille-Similarly, huge amount of iron

ore was seized April 6 by a special squad led by Jajpur SP Rahul PR from Nuasahi locality under Jenapur police limits. A man was arrested and a JCB machine was also seized. Jenapur police had forwarded the mastermind, identified as Sheikh Manan of Dhanmandal area, to court.

It is learnt that a racket is operating from Chandikhole. The racket helps in transportation of iron ore to Paradip Port by preparing fake transit permits.

Barchana inspector in-charge Sushil Kumar Nayak said, "We raid different locations on being tipped off about the illegal trade of iron ore. However, we will henceforth be more vigilant in this re-

#### RIL calls off ₹24,713cr deal with Future Group

New Delhi, April 23: Reliance Industries Saturday said its ₹24,713crore deal with the Future Group cannot go ahead as secured creditors of the latter have voted against it. In a regulatory filing, Reliance

said Future Group companies comprising Future Retail Limited (FRL) and other listed companies involved in the scheme have intimated the results of the voting on the scheme of arrangement by

their shareholders and creditors at their respective meetings.

... The secured creditors of FRL have voted against the scheme. In view thereof, the subject scheme of arrangement cannot be implemented," said RIL, while updating on the scheme of arrangement for the transfer of retail and wholesale business and the logistics and warehousing business of Future Group to its subsidiary Reliance Retail Ventures Ltd (RRVL) and Reliance Retail and Fashion Lifestyle Ltd (RRFLL).

# Avoid scandalous headlines: Centre to TV channels

■ Taking exception to 'hyberbolic' statements by some news anchors, the *I&B Ministry asks the TV* channels not to violate the provisions under Cable Television Networks (Regulation) Act, 1995


New Delhi, April 23: In a strong advisory to private television channels, the Union government Saturday said certain debates on the coverage of the Ukraine-Russia conflict and the Delhi riots had provocative and socially unacceptable language, and it took exception to headlines such as 'Parmanu (nuclear) Putin' and 'Ali, Bali aur Khalbali (unrest)'.

While the government found television news channels making "false

claims" and "frequently misquoting" international agencies while reporting on the Ukraine conflict, it took objection to the reportage on 'incidents' in northwest Delhi, contending that channels had given communal colour to the actions of authority. It also said that certain debates on television channels on the Delhi violence had unparliamentary, provocative and socially unacceptable language.

"Having regard to the above, the government expresses serious concern about the manner in which the television channels have gone about their operations in the matter of transmitting content...," read the advisory issued by the Information and Broadcasting Ministry to self-regulating bodies

of television channels. It also "strongly advised" them to immediately refrain from publishing and transmitting any content which is violative of the aforemen-



tioned provisions of The Cable Television Networks (Regulation) Act, 1995, and the rules thereunder.

The government cited specific instances of 'hyberbolic' statements by news anchors and "scandalous headlines/taglines" while reporting on the Ukraine-Russia conflict and disrupting the investigation process into the incidents in northwest Delhi by airing unverified CCTV footage.

Section 6 of the Programme Code under the Act states that "no programme should be carried in the cable service which - offends against good taste or decency; contains criticism of friendly countries, contains attack on religions or communities or visuals or words contemptuous of religious groups or which promote communal attitudes; contains anything, obscene, defamatory, deliberate, false and suggestive innuendos and half

The advisory said that while reporting on the Russia-Ukraine conflict it has been observed that channels have been making false claims and frequently misquoting international agencies or actors, and using "scandalous headlines or taglines" completely unrelated to

The advisory also cited instances of headlines or taglines such as Parmanu Putin se pareshan Zelenski' (Zelenski worried about nuclear Putin), 'Parmanu action ki chinta se Zelenski ko depression' (Zelenski goes into depression over nuclear action), and making of "unverified claims misquoting" international agencies that the third world war has already started.







# Naveen seeks poll performance reports from dist observers

He is scheduled to meet party observers for the remaining districts in phases. The meetings will continue till Monday. The ruling BJD has 33 organisational districts in state, sources said.

With this exercise, the ruling party has started its preparation for the Lok Sabha and Assembly elections of 2024, said a political observer. According to sources, Patnaik is planning to revamp BJD's organisational structure to further strengthen the party at grassroots level before the 2024 polls. iv. The KML tiles of the area to be diverted and the CA/Addl. CA areas shall be uploaded on the e-Green watch portal with all requisite details before issuing working permission towards linear approval, as the case may be

v. The user agency shall transfer the cost of raising and maintaining the compensatory afforestation at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal. The Scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years. the funds received from the user agency under the

project shall be transferred/deposited in CAMPA account only through e-portal (https://parivesh.nic.in/). Amount deposited through other mode will not be accepted as compliance of the Stage-I

vii. The cost of felling of trees shall be deposited by the user agency with the State Forest Department. The user agency shall explore the possibility of successful transplantation of maximum number of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department.

viii. The compliance report of the Stage-I approval shall be uploaded on e-portal (https://parivesh.nic.in/).

ix. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificates from the concerned District Collector. x. The boundary of the proposed forest land for diversion, shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates

user agency shall provide fuels preferably alternate fuels to the abourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.

xii. No additional or new path will be constructed inside the forest area for any activity related to the project work. xiii. The user agency while executing works, shall not fell any tree or damage forest growth in the surrounding forest area in any manner

xiv. The layout plan of the proposed forest land shall not be changed without the prior approval of Ministry of Environment Forest & Climate Change xv. The forest land shall not be used for any purpose other than that

specified in the proposal. xvi. The forest land proposed to be diverted shall under no

circumstances be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, xvii. No damage to the flora and fauna of the adjoining area shall be

xviii. The concerned Divisional Forest Officer, will monitor and take

necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area. xix. The user agency shall submit annual self-monitoring report or

compliance of stipulated conditions to the Nodal Officer (FCA) of the State and concerned Integrated Regional Office of this Ministry by the end of March every year.

xx. Any other conditions that the Ministry of Environment, Forests & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency

Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in Para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated

4. After receipt of the report on compliance to the conditions stipulated above, from the State Government of Odisha, final/Stage-II approval for diversion of the said forest land under Section 2 of Forest (Conservation) Act, 1980 will be issued by this Ministry Transfer of forest land to user agency should not be effected by the State Government of Odisha till final/Stage-II approval for its diversion is issued by the Ministry of Environment Forest & Climate

Gop, April 23: Tension ran high in Gop area of Puri district after a proprietor of a tent house was beaten to death by a DJ owner and his staff during a wedding procession at Bedapur-Balikandala village Friday night.

The deceased has been identified as Lipun Pradhan, 22, of Erabanga village who was running a tent house business in the area. His death triggered unrest as angry locals and relatives staged a protest and blocked the Gop-Konark road.

According to police, a heated argument erupted between the accused DJ owner and the victim after a vehicle carrying the DJ equipment during the wedding procession tore a

Irked villagers resorted to protest and blocked the road by burning tyres while seeking immediate arrest of all the accused and adequate compensation for

the victim's family. Traffic came to a standstill with hundreds of vehicles stranded on both sides. The locals staged a road blockade seeking immediate arrest of the accused of the road due to the protest. Commuters were stuck for hours and had to go through unwanted problems due to the

road blockade. On being informed, Puri SP Kanwar Vishal Singh and other senior officials reached the spot and convinced the irate villagers to call off the strike. The body was later seized and handed over to family members after autopsy.

The agitation was called off after police assured the victim's family members of compensation and detained one of the accused. A case has been registered in this connection and a manhunt has been

launched to nab the other accused, who absconded soon after the incident.

According to police, a heated argument erupted between the accused DJ owner and the victim after a vehicle carrying the DJ equipment during the wedding procession tore a portion of the tent.

Things took an ugly turn when, in a fit of rage, the DJ owner and his staff mercilessly beat up the victim and also attacked him with sharp-edged weapons. He was rushed to Gop government hospital, where he succumbed to his injuries. "A detailed probe is underway and we will nab the accused soon," SP Singh assured.

# Biju Babu's Dakota aircraft to reach Bhubaneswar soon

THE AIRCRAFT IS NOW LYING IN A STATE OF DISREPAIR AT THE NETAJI SUBHAS CHANDRA BOSE INTERNATIONAL AIRPORT IN KOLKATA

Kolkata, April 23: A Dakota aircraft, presumably the same one flown by Biju Patnaik to Java in Indonesia to rescue the country's then Prime Minister Sutan Sjahrir and Vice President Mohammad Hatta July 21, 1947, is expected to be dismantled and taken to Bhubaneswar by

the end of this year. The aircraft is now lying in a state of disrepair at the Netaji Subhas Chandra Bose International (NSCBI) Airport in

The Odisha government has floated a tender to engage an agency that will dismantle the Dakota and transport it by road to Bhubaneswar where it will be put together and displayed after necessary repairs and a fresh coat of paint at a prominent location.

'The aircraft means a lot to us. Biju Patnaik means a lot to the people of Odisha. The process was delayed due to the Covid-19 pandemic. The tendering process is now on and we expect the aircraft to arrive by the end of this year. We have already received necessary clearances from the Directorate General of Commercial Aviation (DGCA) and Airports Authority of India (AAI). Some

security clearances will be required on the ground for the team that dismantles the aircraft as it is parked close to the taxiways of Kolkata airport," a senior official of the Odisha government said.

"The work will also have to be carried out carefully, so as not to disrupt any services at the busy airport. Space for the aircraft has already been selected in Bhubaneswar. We will create a base for it there. Once the portions arrive, some time will be required to carry out structural repairs before reassembly. The aircraft will then be painted," the official added.

Biju Patnaik, father of Chief Minister Naveen Patnaik, was a towering figure in Indian politics. At 6'2", he was actually an imposing figure. An ace pilot, Biju Patnaik is considered by some as a maverick.

Despite having enrolled with the Royal Indian Air Force, he clandestinely flew Indian freedom fighters from one location to another. He is also said to have dropped leaflets on Indian soldiers of the British Indian Army, asking them to revolt. Later, Biju Patnaik set up Kalinga Airlines with his fleet of Dakotas. This was ultimately

merged with Indian Airlines. "Probably, his greatest moment came in 1947 after the Dutch attempted to recapture Indonesia. Biju Patnaik was

asked by Jawaharlal Nehru to fly to Java and bring out Sjahrir and Hatta so they may inform the world about the situation in their country. Biju Patnaik and his wife Gvan Devi (an accomplished pilot herself) did just that. It is said that the Dutch warned him and said that his aircraft would be shot down. The Dutch had actually shot down a Dakota with a number of Indonesian leaders on board before that. Biju Patnaik is said to have calmly responded that if his aircraft was brought down, no Dutch flights would be able to fly across India safely. The Dutch not only allowed him to land in Java but also leave with Sjahrir and Hatta. Since then, Biju Patnaik became a legend in Indonesia. He was also a personal friend of the country's first president Sukarno," an official in New Delhi said.

# Parents allege murder

POLICE START PROBE, SEIZE DIARY FROM HIS HOSTEL ROOM AT BBMCH

Bolangir, April 23: In a major development in medico Nishant Kumar's death at Bhima Bhoi Medical College and Hospital (BBMCH)in Bolangir, his parents and kin Saturday alleged that he was murdered after days of ragging. Notably, Nishant fell off a five-storied hostel building, Friday. His death is suspected to be a suicide

Meanwhile, police have started an investigation with a scientific team, Saturday. Nishant Kumar's parents and his two uncles Saturday reached Bolangir and alleged that he was tortured physically and mentally by senior students and later murdered.

"My son was a genius and he had cleared NEET in the first attempt without taking any coaching. He had joined college just 10 days back. But, he was subjected to ragging and tortured by the seniors.

Meanwhile, a scientific team Saturday swung into action and began the investigation into the matter. Sadar SDPO Tofan Bag, Sadar IIC Sashikant Sahu and Town IIC Priyanka Routroy examined Nishant's hostel room no-312 and collected some documents, a diary and other articles for verification.

It is pertinent to mention here that Nishant Kumar, 19, a firstyear MBBS student from Karnal in Haryana, had taken admission in BBMCH and just joined the hostel 10 days back. He was residing alone in Room-312 of the New Boys' Hostel.

While police are yet to ascertain the exact reason for Kumar's

# State's 1st jumbo overpass in Kapilash soon

Dhenkanal, April 23: To ensure safe movement of wild elephants across railway tracks and ward off any fatal mishap threatening them, an animal overpass will come up in the Kapilash wildlife sanctuary of Dhenkanal district.

This underpass will be first of its kind in the state. This was informed by a forest official here, Saturday.

"An elephant overpass will come up at Compartment No-1 in Kapilash Wildlife Sanctuary close to railway tracks of Joranda station. Plans are now afoot for an expansion of the existing railway infrastructure. Hence, it has also been decided to construct the animal overpass. The National Board for Wildlife (NBWL) had given its nod to a 100-metre-long animal overpass in December, 2021, Dhenkanal divisional forest officer

(DFO) Prakash Chand Gogineni stated. Structural design of the overpass project and its construction site will be finalised soon by a joint team of officials from the Forest and Railway de-



partments. It was also decided that the construction work will be executed by the Railway department, the DFO informed. "Its design is likely to be finalised within next three to four months and it will take two years for project completion," the DFO added.

The pilot overpass project will cover a large patch of land stretching from Rajathagarh railway station in Cuttack up to the Joranda Road railway station of Gobindapur in Dhenkanal, Gogineni clarified.

According to another official, a sur-

vev work for the country's first ever pilot project to safeguard wildlife has already been done. Another such pilot project is also to come up in a reserve forest of Bihar.

As per expansion plans, the proposed overpass project in the Kapilash sanctuary will be of four lanes with two up and two down tracks.

Reacting to the decision, environmentalist Sishir Satpathy said, "It is certainly a welcome step and the authorities concerned should identify more sensitive elephant corridors in

Dhenkanal and the other districts where overpasses can be constructed to protect the wildlife."

It is pertinent to mention, the sanctuary spreads from Dhenkanal up to Khuntuni under Athagarh forest division of Cuttack. Bhubaneswar-Dhenkanal-Talcher-Angul-Sambalpur railway line passes through the reserve forest. However, herds of the pachyderms entering into the Kapilash sanctuary from Chandaka through Athagarh forest division and the vice versa often face problems leading to their deaths at times.

Jumbo herds have to often cross the railway tracks in the corridor areas of Athagarh forest division, Ranabania and the Kapilash wildlife sanctuary.

Environmentalists opined that the jumbo overpass would play a crucial role in protecting the animals from accidents on the railway tracks.

In order to curb the elephant casualties due to train accidents, the state government has plans to erect iron barriers near railway tracks at sensitive spots for safety of the animals.

# Why Hindu Rashtra?

he Rashtriya Swayamsevak Sangh was founded in 1925 and in three years will be 100. Some have felt, especially after the events since 2019, that 2025 will herald the transition of India to a Hindu Rashtra. I explored what that could possibly mean in a previous book and am taking up some aspects of that here.

A nation can be secular, Hindu Rashtra, Islamic State or any other thing based on the law. It is the laws that define the nature of the State. Today India is governed through a Constitution which was adopted after Independence, and a set of criminal laws codified in the 19th century. These laws, the Indian Penal Code, came in 1860 and have remained more or less intact across South Asia. To understand what changes can come here we must first try to understand what the term Hindu Rashtra means.

To my mind it could mean one of two things. The first is that it is an interpretation of the Hindu texts and the construction of a State and laws based on these texts. The problem here, as Ambedkar has examined in his classic essay 'Annihilation of Caste', is that these texts are not applicable. Enforcing the caste theory in law is not possible in our time, for no reason other than the fact that the majority of Hindus would be disadvantaged by this. It is for this reason that Nepal was an incomplete Hindu Rashtra, which it was till 2008. In the kingdom of Nepal executive authority flowed from a Kshatriya king, as prescribed in the Manu Smriti, and he was advised by a Brahmin, called the Mool Purohit or Bada Gurujyu, in his court. But no other part of the caste framework was applied, because it could not be. So we can rule out a Hindu Rashtra in India where only those born Kshatriya will rule us advised by Brahmins and the rest of us have few or no rights.

The other form Hindu Rashtra could take would be to be exclusionary. This

is the form that many religious States, including Pakistan, have taken. In Pakistan no non-Muslim can become prime minister by law (article 91). This was also the case for the president (article 41), which is important because Pakistan's president had the power to dismiss parliament, which was not something the Indian president had.

So a Hindu Rashtra of this type can mandate by law that no non-Hindu can become prime minister or chief minister, and only Hindus can hold certain offices. We should consider here that though we have no such law, there is no Muslim chief minister in this country, that no Muslim has ever served a full 5 year term as CM in any state besides Kashmir, and of course there has never been a Muslim prime minister in India.

This type of Hindu Rashtra can also adopt some of the other discriminatory aspects against its religious minorities that States like Pakistan have chosen. For instance, non-Muslims vote in separate electorates, and the apostatised community of Ahmadis cannot call themselves Muslims and have no religious freedom. The BJP MP Subramanian Swamy has proposed that Muslims be disenfranchised, meaning lose their right to vote.

Germany in the 1930s adopted a set of laws that prevented inter-marriage between communities. In India, after 2018, seven BJP states have passed laws that also criminalise marriage between Muslims and Hindus. German laws excluded Jews from citizenship, and India has of course adopted the CAA excluding Muslims and the home minister has promised the NRC, which also targets what

he calls 'termites'. Many of the things that India has done especially since 2019, with targeted laws and policy on namaz, hijab, beef, bulldozer, talaq and so on would also be something that we can see in an exclusionary Hindu Rashtra

So the question is, if we have already excluded Muslims from political office by default, and if we are already harassing them daily through laws, like Nazi Germany did and like Pakistan did, then why do we need a Hindu Rashtra or a change from the present set of laws? My book concluded that we did not. That the present Constitution and laws give Hindus enough freedom to apply discrimination against non-Hindus legally, while still pretending to be pluralist, democratic and secular. There appears to be no particular advantage or benefit that we get in officially changing our Constitutional and legal State from secular to Hindu Rashtra.

Of course we can still do it because it can give us pride and we can humiliate Muslims further and tell them they have no stake in India. Some have written that many Muslims might prefer this honesty rather than be marginalised through hypocrisy as they have been done.

Whatever we decide, it will interest the world. The era of religious States is over and no new ones of significance have been founded in the 21st century. Many States founded on religion have reversed their discriminatory laws because birth and faith are too narrow a frame to view individuals through. While for citizens this period may be traumatic, and it is for me the worst period of my life, for writers it is rich with material as a nation once admired around the world is eating itself alive.

Major Walter Wingfield borrowed for the recreation he patented in 1874, in part a conflation of elements borrowed from earlier games: the net from badminton, the ball from fives, and the scoring from racquets. The name was never popular, not least because only those few people well versed in ancient Greek knew how to say it (the Morning Post complained about this in August 1874). Most converted it into a three syllable word that roughly rhymed with "pike". This was soon abbreviated either to sticky or to the mock-French stické: some early writers Frenchified the full name by adding an accent: Sphairistiké. Luckily, Major Wingfield also called his new game lawn tennis, a name chosen to distinguish it from the much older indoor game then called simply tennis. This immediately caught on, though noticed only dismissively by practitioners of more established games, as in this cricket report later in the spring: We also observed a further accessory for the amusement of ladies in the shape of "Lawn Tennis," on the croquet ground at the north side of the carriage drive. -- Daily News, 7 May 1874. A modified version of his game immediately became hugely popular under that name, though it was soon abbreviated just to tennis, so that the aficionados of the older game in snobbish retaliation started to call theirs by the retronym real tennis, a term later mistakenly converted to royal tennis in Britain and some other countries.



# **BUYERS BEWARE!**

f late, China has raised security concerns in the Indian Ocean region with strategic military sales like submarines to Bangladesh and Pakistan. China contends to be a key defence exporter to many Asian and Southeast Asian countries in India's neighbourhood. Many of these countries, who are unable to acquire expensive military technology from other reli able sources, procure seemingly inexpensive weapons and systems from the Chinese market. To this effect, the Bangladesh military imported two Type-035G submarines of 1970s vintage and Type-053H frigates from China, with its import dependence on Chinese hardware touching nearing 85%.

Myanmar, after the military coup in 2021 and sanctions by the West, has turned towards China for procuring majority of its military hardware. Pakistan is shifting its reliance to cheap Chinese hardware with its procurement of Yuan class submarines, J-10/JF-17 fighter's aircraft and Type-054 stealth warships. Sri Lanka has been given warships and military aircraft (Harbins, J-7) in recent times. Nepal is also being aggressively pursued by China in the recent years for procuring Chinese military hardware with NPR 2.5 bil-

lion grant for the Nepalese Army. Chinese development of overseas bases in the region is also bothering Indian military planners. Commissioning of the Djibouti military base in 2017, development of Gwadar port in Pakistan and taking over of Hambantota port in Sri Lanka gives them a credible infrastructure to position military assets in the region. The new entrant in this club is Pekua port in Bangladesh. China plans to develop this port and offer it for berthing and maintenance of submarines given to Bangladesh. However, its real intent might be to establish a transit base for its nuclear submarines, which are likely to increase their forays in the Indian Ocean region in the future. Hence, if we envisage a conflict with China or our neighbouring

countries, we can anticipate that the stance of these countries will be largely driven by Chinese interest in the region.

However, everything is not as rosy for Beijing's customers as it seems. They, at their own peril, do not factor the lifecycle costs and reliability factors of Chinese products. Poor quality and workmanship of Chinese military weapons and systems has turned out to be the bane for its clients. Countries like Pakistan, Bangladesh, Sri Lanka, Thailand and Nepal have found this out the hard way.

Thai PM Prayut Chan-o-cha April 4 threatened to cancel a deal for purchase of Chinese S26T Yuan Class submarines, unless Beijing includes the German-made MTU 396 engine. Beijing has supposedly requested modification in the contract to replace German engines with Chinese MWM 620 engines. Considering the poor reputation related to anything Chinese made, the Thai don't appear willing to go ahead with the deal unless their demands are met.

Earlier in January, Nepal Airlines had grounded six Chinesemade aircraft, saying that it was proving to be unaffordable to fly them. These sub-standard planes delivered extremely poor serviceability rates and required heavy maintenance. The loan from China for these aircraft has, however. continued to haunt the airlines. Dues worth \$35.1 million, at a steep interest rate along with a service charge and management expenses, are still pending. Beijing had gifted two 1970s era Ming class Type-035G submarines to Bangladesh valued at \$100-million each in 2017. These were later re-inducted by the Bangladesh Navy as BNŠ Nobojatra and BNS Jovjatra. However, both the platforms have been lying idle due to technical issues and could not be used as intended. The year 2020, witnessed China gifting Dhaka with two Chinese 053H3 frigates - BNS Umar Faroog and BNS Abu Ubaidah. According to sources, the Type-053H3 frigates gifted to the Bangladesh Navy have defects in fire control system as well as in the helicopter fuelling and defueling system. Defects have also been discovered in the gyro compass.

With regard to naval platforms built by China Shipbuilding and Offshore International Co. Ltd., issues that have surfaced are poor metallurgy, lack of spare part support, machinery failure, defective radars and poor armaments. Defects have also been detected in basic trainer aircraft and K-8 aircraft for the Bangladesh Air Force and short-range air defence system for the Bangladesh Army.

Pakistan, despite being closest to Beijing, has also faced similar issues. Pakistan armed forces, which have been traditionally used to superior quality products made in the West, had to deal with defective military equipment sup plied by China. The Chinese-supplied WL II UCAVs were grounded within days of induction into the PAF due to serious defects. A similar story has emerged with the joint production JF-17 fighters.

As per reports, approximately 40 aircraft are not airworthy due to a shortage of spare parts and the RD-93 engine have reportedly experienced frequent cracks in guide vanes, exhaust nozzles, and flame stabilizers. The Chinese are des perately trying to replace the existing engine with the Chinese made WS 13 engines. However, when these will be made available to Pakistan remains the moot issue. Similar is the case with the SAM system on the Zulfigar class frigate procured through a multi-million-dollar loan from the Chinese EXIM Bank. The system, itself a clone of the French Crotale system, has been plagued with serviceability issues leading to the Pakistan Navy turning to European suppliers for future inductions. Other cases of supply of poor-quality drones, armoured personnel carriers, missiles and even warships across the globe are well documented. In some cases, loss of lives due to malfunctioning equipment has also been reported The lack of quality of military hardware from China is increasingly coming under scanner and has brought to fore the substandard capabilities being sold to economically weaker countries in the garb of supporting them.

The world over, reliability and quality of defence equipment are known as the true mark of a nation's technology, manufacturing ability and maintenance practices. One would have expected Chinese defence manufacturers to have taken this onboard as an inviolable fundamental. If one is to believe opensource narratives, here too China seems to have missed the mark opting for quantity and quick delivery over quality. Buyers beware!

# Applying COVID blueprint to cholera

world two years ago, 'un- outbreaks around the world. precedented' has become something of a buzzword. But while the coronavirus has posed unique challenges at a time of deep global interconnectedness, pandemics are nothing new. COVID is not even the only one we are currently experiencing. In much of the developing world, cholera outbreaks are proliferating. Whereas SARS-CoV-2 virus is 'novel,' cholera – a waterborne diarrheal disease caused by the bacteria Vibrio cholerae – is ancient, as is its history of widespread devastation. The current cholera pandemic is world's seventh

since early nineteenth century. Despite their apparent differences, COVID-19 and cholera have much in common. Both are at least partly controllable by vaccination, and both spread most easily in crowded, unsanitary environments. Ensuring adequate shelter and strengthening water, sanitation, and hygienepractices and infrastructure are therefore vital to limit transmission. These commonalities explain why measures to limit COVID-19, such as decreased travel and increased vigilance regarding personal hygiene, brought about a decline in cholera cases. But as the world's governments roll back nandemic restrictions, cholera is returning with a vengeance. At the end

ince COVID-19 engulfed the of 2021, there were 16 active cholera meaningfully with at-risk commualised populations are addressed.

Yet the response to COVID still holds valuable lessons for bolstering the fight against cholera - beginning with the importance of research to combat disease outbreaks. The emergence of SARS-CoV-2 triggered a massive and largely coordinated global research push, which enabled evidence-based decisionmaking at all levels of prevention and control. Initiatives like WHO's Global Research Roadmap for COVID helped guide this effort, ensuring resources were channeled to areas where knowledge and innovation were most needed.

Research is no less important in the fight against cholera. That is why, last year, the Global Task Force on Cholera Control launched the Cholera Roadmap Research Agenda. Representing the collective vision of 177 global cholera experts and other stakeholders, the agenda identifies the highest-priority research questions. Many of the questions could just as easily be found in a COVID-19 research agenda. For example, what is the fastest, most costeffective way to deliver a limited supply of vaccines? How can we enhance the uptake and sustainability of response measures to prevent the disease from reaching epidemic- or pandemic-level proportions? How do we engage

nities in designing and implementing interventions?

The questions may be the but the effort devoted to answering them has been very different. With COVID, strong political will and massive investment enabled researchers to produce answers quickly. Though cholera has been around much longer, solutions remain elusive. A key reason is that, whereas COVID ravaged developed and developing countries alike, cholera was eradicated from the Global North more than 150 years ago. It is much harder to mobilise resources to tackle a disease affecting the world's poorest and most marginalised people.

With just a fraction of the commitment underpinning the fight against COVID, lifesaving progress could be made in cholera research. Epidemiological surveillance would enable the mapping of transmission patterns. New and innovative diagnostic tests could increase the speed, efficiency, and quality of detecting and confirming cases. And new or improved vaccines would strengthen the connection between emergency response and long-term control and prevention.

Optimising the timing and dosage of vaccines is essential, as is learning how to engage communities to ensure that the needs of margin-

Transforming treatment for vulnerable communities requires studying the impact of antibiotics on cholera transmission, and understanding what enables – and blocks integration of cholera treatment into case management by community health workers. Equipped with this knowledge, countries and health partners would be better positioned to choose the most effective tools and approaches as they pursue their National Cholera Plans.

We have learned so much during the pandemic. We have listened to public-health officials and taken steps to limit spread of the virus. We must leverage this increased awareness and momentum to make further public-health gains, not just in our own communities, but worldwide. That means taking aim at other, much older scourges. We have the tools we need to defeat cholera, but we must still do the research that is required to identify how, when, and where to use them. Only then can we protect the world's most vulnerable populations from this all-too-precedented disease.

#### Indo-UK defence ties

#### 7 killed, 10 hurt

# Kishor flags biggest worry

New Delhi, April 23: In his presentation to the Congress top brass, electoral strategist Prashant Kishor flagged that the biggest worry is that members of decision-making bodies in the party are all nominated, not necessarily connected at the grassroots and barely fight elections.

For the 2024 general elections, Kishor has suggested a "a pan-India avant-garde campaign to reach, connect and mobilise all of India for a mega movement leading to reincarnation of Congress and election of a transformational government".

To win, 45 per cent of votes are required which means a target of 30 crore, Kishor has said. Within the country's digital consciousness, the BJP and its leaders currently score vastly above the Congress, he pointed out

With a theme of "India Deserves Better", Kishor has suggested to the Congress to build a unified platform to provide strategic support and resources to non-political influencers and mount a sustained campaign against the ruling dispensation.

In his presentation, Kishor said his "Reincarnation of Congress" is about "preserving the soul, creating a new body". The inspiration of the campaign is the symbols of Nataraja namely Creation, Protection, Liberation, Destruction, Concealment and Connect.

The resolves include the cre-

ation of a new Congress which will be a political platform of choice for the masses. Destroy a sense of entitlement, lack of accountability and sycophancy, Kishor said in the presentation.

It notes that perhaps for the first time, Congress leadership does not appear fully aligned in terms of goals, strategy, method, approach, tactics and the way forward; leading to a complete lack of cohesion, at times confusion and stalemate.

There is a need for a non-Gandhi Working President/Vice President who can effectively work on the ground as per direction of Congress leadership, it suggests. It advocates a Congress Plus alliance structure with a national character but having 5-6 partners.

The Congress should contest 75-80 per cent of the Lok Sabha seats with a few regional alliances like NCP, DMK, JMM, YSR Congress and TMC. On beefing up the organisational structure, Kishor has called to identify and meaningfully engage 15,000 grassroots leaders and activate 1 crore foot soldiers across India

He questioned the involvement of politicians in the running of the Sri Venkateswara Bhakthi Channel (SVBC) under the TTD. He wondered how movie songs can be played on SVBC as 80 per cent of TTD funds for propagation of Hindu

# **UP seriously considering UCC** implementation: Dy CM Maurya

Lucknow, April 23: The Uttar Pradesh government is thinking seriously in the direction of the implementation of the Uniform Civil Code in the state, Deputy Chief Minister Keshav Prasad Maurya said Saturday

Maurya made the revelation while favouring the expeditious implementation of the UCC both in the country and the state.

Terming the constitutionallyenvisaged measure an 'important step' for the realisation of the governance 'mantra' of 'Sabka Saath, Sabka Vikas' (inclusive growth), he said it should be welcomed by everybody.

"One law for all in one country is the need of the hour. It is required that we should get out of the system of one law for one person and another for others. We are in favour of a common civil code," Maurya said while talking to newspersons here.

"The Uttar Pradesh government is thinking in this direction seriously," the deputy CM said.

Just as the Uttarakhand government has initiated steps, in UP and other states too where there is the BJP government, the "common civil code" should be implemented, he said.


Even in other states where there is no BJP government, its implementation is necessary for inclusive growth, he said, adding the "common civil code is such a thing which should not only be demanded but also welcomed by all."

Soon after the formation of the Uttarakhand government after the recent assembly elections, the first Cabinet meeting presided by Chief Minister Pushkar Singh Dhami there decided to form a committee of experts on the implementation of a Uniform Civil Code in the state.

After his first cabinet meeting, Dhami had said that Uttarakhand will be the first state to implement UCC, however, quickly adding that "perhaps it is already in force in Goa".

"Common civil code is definitely required at this point of time, it is very much required for the country, for Uttar Pradesh and for the people of the country," the deputy CM said.

"But when there are vote bank considerations everywhere, it definitely shows the politics of appeasement. But we are not in favour of this," Maurya said.

### ELHI'S R-VALUE 2.1 THIS WEEK

New Delhi, April 23: Delhi's R value, which indicates the spread of COVID-19, was recorded at 2.1 this week, implying that every infected person is infecting two others in the national capital, according to an analysis by IIT-Madras.

The 'R' or reproductive value indicates the number of people an infected person can spread the disease to, and a pandemic is considered to end if this value goes below one.

The preliminary analysis by computational modelling was done by IIT-Madras' Department of Mathematics and Centre of **Excellence for Computational** Mathematics and Data Science headed by Prof Neelesh S Upadhye and Prof S Sundar.

This was shared with PTI and according to it, Delhi's R-value this week was recorded at 2.1. India's Rvalue, at present, stands at 1.3, the analysis found.

Asked if it can be deduced that this is the beginning of the fourth

wave of COVID-19 in Delhi, Dr Jayant Jha, Assistant Professor, Department of Mathematics IIT-Madras, said it would be too early to declare an onset of another wave.

#### Dump sites in Delhi like time bombs: NGT



New Delhi, April 23: The National Green Tribunal has expressed serious concern over fire incidents at Ghazipur landfill site in the national capital saying dump sites are like "time bombs'

A massive fire erupted at the Ghazipur landfill site Wednesday, the third such incident since March 28, sending a dense plume of smoke into the sky and exacerbating the already polluted air in nearby areas. Last year, the authorities reported four fire incidents at the Ghazipur landfill. In 2017, a large part of it broke away, crashing onto a road and killing two people.

A bench headed by NGT Chairperson Justice A K Goel said the dump sites in Delhi and in other cities are like "time bombs because they constantly generate explosive gases like methane which may escape through vertical and lateral ways posing constant threat of explosion. "It is a matter of concern that such incidents are taking place elsewhere also and there is potential for the same wherever legacy waste remains unremediated. It is for this reason that there is statutory timeline expected to be followed strictly.





The occasion was the 164th death anniversary of Veer Kunwar Singh, the then ruler of Jagdishpur, one of the heroes of the Revolt of 1857 against the British. The event was organised by the Bihar BJP as part of 'Azadi Ka Amrit Mahotsav', the 75th anniversary of India's Independence.

Shah railed against "historians" for their "injustice" to Veer Kunwar Singh and his valiant fight, at a ripe age, against the British imperialists. He also alleged that the Revolt of 1857 had been "belittled as a failure" until RSS ideologue V

D Savarkar penned his seminal work "India's First War of Independence"

Shah was joined by top BJP leaders from Bihar, including Union ministers RK Singh and Nityanand Rai, deputy chief ministers Tarkishor Prasad and Renu Devi. and their predecessor Sushil Kumar Modi in waving the Tricolour for full five minutes, to an instrumental rendition of the national song 'Vande Mataram'.

The attendees were made to wear bands for physical identification and camera trap was installed, with Guinness Book of World Records for supervision. The crowds applauded when the gigantic screen installed at the venue put the head count of flag wavers at 77,700.

The previous world record was of about 56,000 when Pakistani flags were waved at a function in Lahore in 2004.



#### ₹5,050-cr fraud by Yes\_ Bank's Rana Kapoor. **Wadhawans: ED**

Mumbai, April 23: The Enforcement Directorate (ED) has alleged that Yes Bank co-founder Rana Kapoor and Dewan Housing Finance Limited (DHFL) promoters Kapil and Dheeraj Wadhawan siphoned off funds worth ₹5,050 crore through suspicious transactions.

The ED said this in its second supplementary (third overall) charge sheet filed in special court here\_ recently against Rana Kapoor, his family, Wadhawans and others in a money laundering case.

During the probe, it came to light that a big part of the proceeds of crime (POC) generated in this case has been siphoned off overseas by Rana Kapoor and hence they are not available for attachment directly under the provisions of PMLA, it said. "Rana Kapoor, DHFL promoters Kapil Wadhawan, Dheeraj Wadhawan and others were involved in criminal conspiracy with each other in illegal diversion and siphoning off of funds through suspicious transaction of ₹5,050 crore," the central probe agency claimed in its fresh prosecution complaint (charge sheet) filed recently.

The ED said investigation has revealed that Yes Bank had bought debentures worth ₹3,700 crore between April 2018 and June 2018 from DHFL. Therefore, the amount was transferred to DHFL. Subsequently, DHFL gave a loan of ₹600 crore to DOIT Urban Ventures Pvt Ltd (an entity, beneficially owned by Rana Kapoor and his family). The probe also revealed that Yes Bank had used public money for the purchase of the above-said short-term debentures of DHFL, which has not yet been redeemed by DHFL.

Chennai, April 23: The Indian justice delivery system should be Indianised for the benefit of the country's population, said Chief Justice of India N.V.Ramana on

He also said people should relate and understand the practices, procedures of the courts, the development of the case and efforts should be made towards that.

'It should not be like chanting of mantras in a wedding which most of us do not understand." Ramana said. Speaking at the foundation stone laying function at the Madras

High Court here, Ramana stated that Indian people look up to the judiciary in times of distress with a firm belief that their rights will be protected by the courts. Ramana said it is necessary to contemplate on how to improve the functioning of the judiciary and reach out to the people to fulfill their judicial needs. "This is precisely why I have

been a strong proponent of Indianisation of the justice delivery system," he said. According to him, Indianisation of the justice delivery system is a moulding of the judicial system for the benefit of Indian people and is a multi-dimensional concept.



"It calls for inclusivity, providing access to people to participate in the proceedings, removal of language barriers, reforms in practice and procedure, development of infrastructure, filling up of vacancies, augmenting the strength of judiciary and so on," he said.

He said a Judicial Infrastructure Authority both at the national and state level should be set up to implement a National Court Development Project. "I have sent a comprehensive proposal to the Government of India. It is pending with the Government," Ramana said. On the judicial vacancies, he said a proposal has been sent to the central government - to increase the sanctioned strength of judges and fill up the vacancies.

Another issue of Indianisation of the judicial system is the language used in the court. The common citizen cannot relate to the practices, procedures of our courts. Efforts should be to make the general population an active part of the justice delivery process. The people should understand the ongoing process and development of the

"It should not be like chanting of mantras in a wedding which most of us do not understand," Ramana said. On the demand for use of regional language in the High Courts as provided in the Constitution, Ramana said it has been debated several times

"There were certain processes

that prevented local languages from being adopted in the High Court proceedings. I am sure with the innovation in science and technology and the advancement such as artificial intelligence, some of the issues associated with the introduction of languages in the High Court may be solved in near future," he said. "The practice of law before constitutional courts should be based on one's intelligence and understanding of law and not mere proficiency in language. It is time some decisions are taken on these issues after assessment of prosand cons. Inclusivity is one of the dimensions of Indianisation.'

Israel said Palestinian militants fired two rockets late Friday, with one landing in an open area inside Israel and the other falling inside Gaza. Palestinian media reported that two Gaza residents were wounded by the rocket that fell short. There was no immediate comment from health officials.

Another rocket was fired from Gaza early Saturday, but the military did not say where it landed. There were no reports of casualties or damage.

The Israeli military body that coordinates civilian affairs in Gaza said the crossing used by workers would not be re-opened on Sunday, the start of the work week. "The re-opening of the crossing will be decided accordingly with a security assessment," it said in a statement.

#### 'India needs Russia to defend borders'

Mumbai, April 23: India wants to be strong friends with the "liberal world" but it needs Russia's assistance to defend its borders. Finance Minister Nirmala Sitharaman told Bloomberg in an interview in Washington.

India procures most of its military hardware from Russia and in recent weeks has rejected appeals from Western nations to limit bilateral relations with Moscow in response to the Russian invasion of Ūkraine. Prime Minister Narendra Modi's government has faced criticism from Western allies with regard to its refusal to outright condemn Russian President Vladimir Putin over the devastating conflict in Ukraine.

Sitharaman said India, which has long-standing border disputes with neighbouring Pakistan and China and in the past has gone to war with both, was focused on protecting its own regional interests.

Alluding to Pakistan and China.



Sitharaman told Bloomberg: "You have a neighbour who joins hands with another neighbour, both of whom are against me. In the context of the Russia-Ukraine war, God forbid, if there are alliances created, India has to be strong enough to protect itself.'

Sitharaman made the remarks Friday in the United States where she attended the annual spring meetings of the International Monetary Fund and the World

While the United States has traditionally sought to balance relations between arch regional rivals India and Pakistan, in recent years it has also improved strategic ties with New Delhi to counter China.

#### **US** discourages reliance on Russia

Washington: The US discourages India to rely on Russia for its defence needs, the Pentagon has said. "We've been very clear with India as well as other nations that we don't want to see them rely on Russia for defence needs. We've been nothing but honest about that and discouraging that," Pentagon Press Secretary John Kirby said Friday. "At the same time, we also value the defence partnership that we have with India. And as was evidenced a week ago, we're looking at ways to improve that going forward. That's going to continue because it matters and it's important," he said. "India is a provider of security in the region and we value that," Kirby said. US State Department Counsellor Derek Thursday said the Biden administration is very much eager to work with India as it diversifies its defence capabilities and defence suppliers.

# Venice Biennale: Women outnumber male artists for 1st time

Venice, April 23: For the first time in the 127-year history of the Venice Biennale, the world's oldest and most important contemporary art fair features a majority of female and gender non-conforming artists, under the curatorial direction of Cecilia Alemani.

Alemani's main show, titled "The Milk of Dreams," alongside 80 national pavilions opens Saturday after a one-year pandemic delay. The art fair runs through Nov 27. It is only the fourth of the Biennale's 59 editions under female curation.

Women took the top Golden Lion awards announced Saturday for best national pavilion, which went



to the United Kingdom pavilion and artist Sonia Boyce. Best participant in the main exhibition was won by US sculptor Simone Leigh.

The predominance of women among the more than 200 artists that Alemani chose for the main show

"was not a choice, but a process," Alemani, a New York-based Italian curator, said this week.

"I think some of the best artists today are women artists," she told The Associated Press. "But also, let's not forget, that in the long his-



But she also asserted the Biennale's role over the decades as a "sort of seismographer of history ... to absorb and record also the traumas and the crises that go well beyond the contemporary art world." In a potent reminder, the

Russian pavilion remains locked this year, after the artists withdrew following Russia's invasion of Ukraine. Nearby, sandbags have been erected in the center of the Giardini by the curators of the Ukrainian Pavilion, and surrounded by stylized posters of fresh artwork by Ukrainian artistsrepresenting the horrors of the two-month-old war.



#### ICICI Q4 profit surges by 59%

New Delhi: ICICI Bank Saturday reported a 58 per cent jump in its March quarter consolidated net to Rs 7,719 crore, helped by a sharp decrease in the money set aside for bad debts. On a standalone basis, the second largest private sector lender reported a 59 per cent jump to Rs 7,019 crore for the January-March quarter of 2021-22. It ended the fiscal year FY22 with a 44 per cent growth in the bottomline at Rs 23,339 crore. The total income of the bank on a standalone basis rose to Rs 27,412 crore in the January-March period from Rs 23,953 crore in the year-ago quarter, ICICI Bank said in a regulatory filing.

#### **Climate change** ads banned

San Francisco: Twitter Friday banned ads that deny the reality of climate change. Twitter's announcement on Earth Day came as it tries to fend off an unwanted takeover bid by billionaire Elon Musk, who has said he thinks people should be able to say pretty much whatever they want on the platform. "Misleading advertisements on Twitter that contradict the scientific consensus on climate change are prohibited, in line with our inappropriate content policy." Twitter global sustainability manager Casev Junod said in a blog post. "We believe that climate denialism shouldn't be monetized on Twitter, and that misrepresentative ads shouldn't detract from important conversations about the climate crisis.'

New Delhi: HDFC Bank Saturday declared a 1550 per cent or 15.50 per share dividend to its shareholders for the financial year 2021-22. # **EU law targets Big Tech over hate speech & disinformation**

*Up until now, regulators have had no access to the inner workings at Google,* Facebook and other popular services. But under the new law, the companies will have to be more transparent and provide information to regulators and independent researchers on content-moderation efforts

Brussels, April 23: Big tech companies like Google and Facebook parent Meta will have to police their platforms more strictly to better protect European users from hate speech, disinformation and other harmful online content under landmark EU legislation approved early Saturday.

European Union officials clinched the agreement in principle on the Digital Services Act after lengthy final negotiations that began Friday. The law will also force tech companies to make it easier for users to flag problems, ban online ads aimed at kids and empower regulators to punish noncompliance with billions in fines.

#### Govt to sell 3.5% stake in LIC, IPO to fetch Rs 21K cr

New Delhi, April 23: The government is likely to sell a 3.5 per cent stake in Life Insurance Corporation (LIC) through an initial public offering which will hit the markets in the first week of the next month, an official said.

The issue size is expected to be worth Rs 21.000 crore, valuing the country's largest insurer at Rs 6 lakh crore. LIC is likely to file the red herring prospectus with market regulator Sebi by Wednesday.

LIC IPO is likely to come to the market in May first week. 3.5 per cent stake dilution, subject to regulatory approval, an official said

In February, LIC had filed draft papers with Sebi wherein it had said that the government will sell 5 per cent stake or 31.6 crore shares in the state-run insurer.

However, the IPO plans faced headwinds due to the ongoing volatility in stock markets due to Russia-Ukraine war, forcing the government to cut the issue size to 3.5 per cent.

#### **INDONESIA TO BAN PALM OIL EXPORTS**

Jakarta, April 23: Indonesia will ban exports of palm oil starting next week, its president said Friday, as the world's biggest producer faces a shortage of cooking oil made from the product.

The Southeast Asian archipelago has been running low on palmbased cooking oil since November as producers turn to exports to cash in on an increase in prices around the world.

Authorities now fear the scarcity and soaring prices could provoke social tensions and have moved to secure supplies.

"The government will prohibit the export of raw materials for cooking oil and cooking oil itself... until a deadline to be determined later," President Joko Widodo said in a statement.

"I will continue to monitor and evaluate the implementation of this policy so that cooking oil in the country is abundant at affordable prices," he added.

Officials introduced limited curbs on palm oil exports in January, capped prices, and announced cash subsidies for some Indonesians to compensate for rising food prices

But the commodity continued to become harder to find at markets and grocery stores, with long queues appearing at many locations.

This week the Attorney General's Office accused an official in the trade ministry of corruption for is suing export permits to palm oil producers when they had not met domestic market obligations.

The office also arrested several high-ranking officials at three of Indonesia's big palm oil companies, including Wilmar Nabati Indonesia, a subsidiary of Singapore-based giant Wilmar International.

Palm oil is the most widely used vegetable oil in Indonesia whereas crude palm oil is exported worldwide.

New Delhi, April 23: Indian staterun aluminium producer National Aluminium Co Ltd (NALCO) is facing a coal supply shortfall, due to supplies being diverted to priority electricity generation and a shortage of trains to deliver fuel to NALCO's power plants.

Daily supplies to NALCO were falling short of requirement by at least 5,000 tonne due to the train shortage, a senior company official told Reuters.

India has diverted coal supplies from the non-power sector, and put on hold plans for some fuel auctions, in a bid to ensure coal availability for utilities and tackle widespread power outages across the country.

There is also a general shortage of trains to move coal around the country. State-run Indian Railways has fallen short of utilities' requirements by 16% in the first half of April, a government official familiar with the matter said.

NALCO data seen by Reuters show that supplies by state-run Coal India under a long-term supply deal fell short of the contracted quantity by 17% in 2021/22, while shortfalls were more than 75% under another related deal.

A shortage of trains to deliver coal to utilities is exacerbating a coal supply crisis which has lead to power cuts across the country.

Mahanadi Coalfields (MCL), the Coal India unit which supplies NALCO, said it has sufficient coal and has asked NALCO to prioritize moving coal via conveyor belts and trucks instead of using trains.

The NALCO Officers Association, a welfare association for executives of the company, is taking legal action over the coal supply shortfalls, alleging poor planning by the Indian government and the various state bodies involved.

# Important terms to know before buying health insurance policy

lmost everyone has heard the famous adage 'Health is Wealth' and the last couple of years have shown us how much wisdom lies in this age-old saving. Today, having a health insurance policy is a necessity to ensure we are well covered in case of health-related exigency. However, before you buy a health cover, you must understand a few key terms related to health insurance

Free look period

What if after buying your health insurance policy you realise that the terms and conditions of the policy do not meet your requirement or you are not happy with the covers? Don't assume that you are stuck. Fortunately, you have the option to cancel the policy and get a refund of your premium, this is called the free look period. Most of the insurers provide a free look period of 15 or 30 days from date of

receipt of policy document, during which you have the option to cancel or terminate vour new insurance policy and get the due refund. Grace period

In case you missed renewing your policy on time, there is a solution for your worries. Most insurers offer a grace period of 15 days, during which you can renew vour policy even if you have missed the due date. Although you must always renew the policy on time, just in case you missed the renewal you have the grace period to rescue you, considering there has been no claim during the break-in period. Deductible

A deductible is the amount of the claim that you have to bear before your insurer compensates you for the loss. You have to bear the cost till a certain point, and the insurer will pay the claim only after the deductible threshold is crossed.

Suppose the deductible in your policy is 2,000 and your admissible claim amount is 15,000, it means your insurer will pay you 13,000 for the loss, but first you have to bear the initial amount of 2,000. Deductible is inversely proportional to the insurance premium, the higher the deductible, the lower the premium. Although deductible helps bring down the premium, you must understand that this comes at a cost of bearing a portion of a claim during a later stage and you must a cautious about the same. Co-pay Clause

When a policyholder agrees to pay for a certain percentage of the medical expense, it is referred to as copay. If your policy has a co-pay clause it means that you have agreed to bear some part of the expense from your pocket, this is usually mentioned in percentage terms. For example, if your policy has a

co-pay clause of 10 per cent, it implies that you will pay for 10 per cent of the admissible expenses and your insurer will pay the remaining 90 per cent. Like deductible, co-pay too helps bring down premium cost. However, there is a major difference. Once the deductible threshold limit exceeds, the insurer bears entire remaining amount. While co-pay is a set amount that the insured has to be bear for every claim throughout the policy Deductible or Co-pay are popularly known as self-insurance in some countries.

#### ■ Cumulative Bonus in health insurance

A cumulative bonus, also known as CB, is the reward that your insurers give you for a claim-free year. The bonus accumulates for each claim-free year, up to a certain limit. The insurer rewards you with increased cover in the form of

a higher sum insured without charging any additional premium. For example, a sum insured of 20,00,000 will increase to 21,00,000 if the insurer is offering a 5 per cent cumulative bonus for the first claim-free year, to 22,00,000 for the second-claim free year and so on. Similarly, if vou make a claim your bonus will be reduced at the same rate at which it was accu-



Powell joined in the discussion with the umpires too but the officials stood their ground, saying the

# Ravi secures gold, Bajrang bags silver

Ulaanbaatar (Mongolia), April 23: Ravi Dahiya's physical prowess and superior tactical acumen was on show yet again as he became the first Indian wrestler to win three gold medals at the Asian Championship but Bajrang Punia struggled badly on his return to action even as he grabbed a silver, here Saturday.

Tokyo Olympics silver medallist Ravi was his usual dominant self in his three bouts as he outclassed the 57kg field to emerge champion. Ravi had won gold at the 2020 edition in Delhi and in Almaty last year.

Gourav Balian (79kg) was impressive in his silver-winning effort while Naveen (70kg), making his senior debut and the seasoned Satywart Kadiyan (97kg), bagged bronze medals as all five Indians in action earned podium finishes.

The 24-year-old Ravi Dahiya conceded early lead in all his bouts, but as is his wont, he bounced back in tremendous fashion to give India its first gold medal of this edition. He won the final against Kazakhstan's Rakhat Kalzhan by technical superiority.

It was his second final of the season, having won a silver at the Dan Kolov event in February. Ravi, who hails from Nahri village in Sonepat, outsmarted Japan's Rikuto Arai (VSU) and pulled off a comprehensive 12-5 win over Mongolia's Zanabazar Zandanbud en route

In the title clash, Kalzhan moved ahead with a take-down and for considerable time did not let the Indian make any move. However, true to his style, Ravi began to dominate the bout with his unmatched class.

He effected six consecutive twopointers and in-between saved himself from a left-leg attack to finish the bout early in the second period to secure India's first gold medal of the tournament this year.

Before the final, the Japanese was quick with his moves and initially troubled Ravi with his double-leg attacks which even took the Indian off his feet but once the Haryana wrestler got the measure of his rival, he dictated the terms in the bout.

Ravi not only found away to block Arai's attack but also got himself into position to initiate take-down moves from both sides as the Japanese did not have a plan 'B' to counter the in-form Indian. Ravi kept consolidating his lead and eventually won by technical su-

Bajrang, competing in his first tournament since winning a bronze at the Tokyo Games, looked like a pale shadow of himself. Hardly any attacking move was seen from him as he was engaged in standing wrestling, largely defending. It was Bajrang's eighth medal at the Asian Championship.

However, Gourav (79kg) set the mat on fire his gritty performance, including in the final against formidable Ali Bakhtiar Savadkouhi from Iran. He lost the final on criteria after score was tied 9-9 (Iranian had a high-scoring 4-point move) to settle for silver but won hearts with his fearless approach.

India have now won 15 medals, including one gold and four silvermedals, in the continental championship.

Hassane Kamara did get on the scoresheet for the visitors but Roy Hodgson's relegation-threatened side was no match for City, which was relentless and efficient in attack.

# Compound men's team win gold

Antalya, April 23: Indian men's compound archery team of Abhishek Verma, Rajat Chauhan and Aman Saini downed France by one-point in a thrilling final to win the gold medal at the World Cup Stage 1 here Saturday.

This was the men's compound team's first World Cup gold medal since Shanghai 2017. India, however, lost out on a second medal after the compound mixed pair of Verma and Muskan Kirar went down 156-157 to Croatia in the bronze medal playoff.

In the compound men's team final, the Indian trio started off with a one-point deficit, losing the first end 56-57 to their French rivals of Jean Philippe Boulch, Quentin Baraer and Adrien Gontier.

India slowly improved on their first-end score by one-point but the French team had a near perfect set of 59/60 comprising three four 10s, including arrows closer to the centre (X) to extend their lead (113-116).

Trailing by three points, Indians showed amazing resilience to drill in a perfect end of 60/60 with two Xs to win the third set 60-58, and curtail the deficit by one-point (173-174). There was no stopping the Indian trio thereafter as they shot



a 59 in the fourth end, with the under-pressure Frenchmen managing 57 to go down by one-point.

'Mentally we were really strong today, and we've been preparing for this event only and we have the Asian Games coming up this year which is something we also want to do well at," 24-year-old Saini, who bagged his first World Cup gold, said.

"After the gold medal that gives us a great confidence boost especially for the other world cup events, it will hopefully help us.

Sunday, India's recurve mixed team pair of Tarundeep Rai and Ridhi Phor will be vying for a second gold after having defeated Spain in the semifinal 5-3
