Karachi, April 26: A burqa-clad woman suicide bomber struck a van inside the premises of the University of Karachi in Pakistan's financial capital, killing three Chinese nationals and their local driver, in what is believed be the latest targeted attack against Chinese citizens.

The banned Baloch Liberation Army claimed responsibility for the attack that took place near China-built Confucius Institute a non-profit institute teaching Chinese language to local pupilsin the university.

A spokesperson for the university said that three of the victims were Chinese nationals. They were identified as Confucius Institute Director Huang Guiping, Ding Mupeng, Chen Sa and Khalid, the Pakistani driver. The spokesperson added that two others, Wang Yuqing and Hamid, were injured in the incident.

Counter-Terrorism Department official Raja Umar Khattab said that the suicide attack was carried out by a woman, adding that ball bearings were found at the site of the blast, Dawn newspaper reported.

# **PK declines Cong** offer to join party

Kishor had made a detailed presentation before top Congress leaders, which was discussed at length by senior leadership of the party, after which an offer was made to him.

Within a few minutes of the Congress saying that Kishor has declined the offer, he took to Twitter and said the party needs a collective will to fix deep-rooted structural problems through reforms.

"I declined the generous offer of Congress to join the party as



New Delhi, April 26: India's drug regulator has granted restricted emergency use authorisation (EUA) for Bharat Biotech's Covaxin for children in the age group of six to 12 years, Union Health Minister Mansukh Mandaviva said Tuesday. Biological E's Covid-19 vaccine Corbevax also got the regulator's nod for those

aged five to 12 years. The approval by the Drugs Controller General of India (DCGI) for Corbevax and Covaxin for inoculating children below 12 years paves the way for giving protection to a majority of school going children and assumes significance ahead of Prime Minister Narendra Modi's meeting with chief ministers on the emerging Covid-19 situation in the country Wednesday through video conferencing.

The DCGI has also granted emergency use authorisation (EUA) to Cadila for its ZyCoV-D for an additional dose of 3mg with a two-jab inoculation schedule 28 days apart for those aged above 12 years.

### '70 pc of those jabbed with booster didn't get Covid during 3rd wave'

Seventy per cent of the people who received a booster dose of the Covid vaccine did not contract the disease during the third wave, according to a new study that cov ered nearly 6,000 people in India. The study led by Rajeev Jayadevan, co-chairman of the Indian Medical Association's national task force on coronavirus, said that 45 per cent of the people who did not take a precautionary dose reported Covid in the third wave. The survey covered 5,971 vaccinated people; of which 24 per cent were aged below 40 and 50 per cent belonged to the 40-59 age group. Women accounted for 45 pc of the people surveyed.

# Weary of many disasters? UN says worse to come

United Nations, April 26: A disaster-weary globe will be hit harder in the coming years by even more catastrophes colliding in an interconnected world, a United Nations report issued Monday says. If current trends continue the world will go from around 400 disasters per year in 2015 to an onslaught of about 560 catastrophes a year by 2030, the scientific report by the United Nations Office for Disaster Risk Reduction said. By comparison from 1970 to 2000, the world suffered just 90 to 100 medium to large scale disasters a year, the report said.

quake has to turn into a disaster, Mizutori said. A lot of damage is avoided with planning and prevention. In 1990, disasters cost the world about \$70 billion a year. Now

they cost more than \$170 billion a year, and that's after adjusting for inflation, according to report authors. Nor does that include indirect costs we seldom think about that add up, Mizutori said.

For years, disaster deaths were steadily decreasing because of better warnings and prevention, Mizutori said. But in the last five years, disaster deaths are "way more" than the previous five years, said report co-author Roger Pulwarty, a US National Oceanic and Atmospheric Administration climate and social scientist.







# City AIIMS to research on snakebite mitigation

### ON AN AVERAGE, AROUND 800 PEOPLE DIE OF SNAKEBITES IN ODISHA IN A YEAR

Bhubaneswar, April 26: In the wake of an upward trend in snakebite deaths in Odisha, the All India Institute of Medical Sciences (AIIMS), Bhubaneswar, has decided to conduct a research study to reduce such incidents in the state.

Department of Forensic Medicine & Toxicology of AIIMS, Bhubaneswar will undertake this scientific study to tackle human-snake conflict in the current season, sources said.

Initially, the study will be conducted in Bhubaneswar and its peripheral areas. Around 400 families will be included in the research study. It will be conducted under the title of 'A cross sectional study of knowledge, attitude and practice (KAP) on first aid, treatment and prevention of snakebite in the residents of house from where a snake is rescued', said Dr Sudipta Ranjan Singh, MD, Additional Professor in the department of Forensic Medicine & Toxicology at AIIMS, Bhubaneswar.

Singh is also the investigator of the study while Dr Manoj Kumar Mohanty, Professor & HoD of the de-



partment, is the co-investigator.

This is a cross-sectional observational study which will be conducted in collaboration with volunteers of Snake Helpline, an authorised registered organisation engaged in rescue and rehabilitation of snakes in Odisha. The volunteers of Snake Helpline will collect the data through questionnaires from the members of the households from where a call for rescue of the snake was made. The questionnaires will be in Odia and English language. The study will help analyse the level of awareness among respondents about

the appropriate first-aid methods, prevailing taboos, healthcare seeking behavior in cases of snakebite and pre-


For this study, at least 10 volunteers of Snake Helpline were trained by the experts from the Department of Forensic Medicine & Toxicology Monday. The citizens will be asked simple questions on snakes, snakebite, first-aid and prevention methods. After obtaining the data, an awareness leaflet will also be handed over to the respondents to improve their knowledge about snakes and snakebite.

Though the study was approved earlier, it could not be started due to the onset of Covid-19 pandemic. The research team of AIIMS, Bhubaneswar has finalised all the ethical criteria of the study with the help of Snake Helpline volunteers. Snake Helpline general secretary Subhendu Mallik is the research coordinator for the study, sources said.

"The WHO has declared snakebite as a neglected tropical disease. It is a public health issue in Odisha. Deaths due to this mishap are rising day-byday. Though there is availability of definite treatment for snakebite, most people seek help from traditional healers and report late to hospitals. There are many other issues which need redressal. However, valid research data regarding all these issues is lacking. The study is designed to identify these less-talked issues and improve the situation in Odisha," Singh said.

On an average, around 800 people die of snakebites in Odisha in a year. Being an issue of public health, the involvement of common people is important to mitigate and improve the situation, Singh added.

It is worth mentioning here that the AIIMS, Bhubaneswar, in association with the Snake Helpline, has developed a mobile application and website to help people on snakebites.

# Budget collection exceeds target in Odisha region \_

Bhubaneswar, April 26: The budget collection of Odisha region has exceeded the budget target during the last fiscal, said CBDT Chairman JB Mohapatra Tuesday.

The region has collected ₹15,481 crore in the last financial year against a target of ₹14,000 crore, and the collection during FY 2021 22 marked an increase of 52.50 per cent over the Budget collections of previous year. The state has huge potential and is growing at par with national statistics in terms of tax collections, he added.

The net direct tax collections (income tax and corporate tax) reached an all time high of ₹14.09 lakh crore in financial year 2021-22 against ₹9.45 lakh crore collections in FY 2020-21, Mohapatra said.

The net direct tax collection has increased by 49.02 per cent during financial year 2021-22, while it has registered a growth of 34.16 per cent in FY 2021-22 over the collections of 2019-20 when the net collection was ₹10.50.680.56 crore, and



a growth of 23.90 per cent over 2018-19 when the net collection was ₹11,37,718.48 crore, he said.

The gross direct tax collection (before adjusting for refunds) for 2021-22 stands at ₹16.34.454.95 crore compared to ₹12,31,270.52 crore in 2020-21. thereby registering a growth of 32.75 per cent, said Mohapatra.

He also said that the gross collection in 2021-22 has registered a growth of 32.42 per cent over the collections of 2019-20 when the

gross collection was ₹12,34,258.42 crore and a growth of 25.84 per cent over the collections of 2018-19 when the gross collection was ₹12,98,797.32 crore. During the last financial year, 2.43 crore refunds were issued compared to 2.37 crore in 2020-21 amounting to ₹2,24,814 crore. This includes 2.01 crore refunds of AY 2021-22 itself due to faster processing of returns.

More than 7.14 crore Income Tax Returns (ITRs) were filed for

AY 2021-22 as on March 31, 2022 on the new e-filing portal, compared to 6.97 crore ITRs filed for AY 2020-21 till May 31, 2021 (extended last date of the preceding year) representing an increase of 2.4 per cent.

Mohapatra said that the tremendous growth in direct and indirect tax collections in the country indicates the strengthening of the Indian economy. A lot of reforms have been undertaken resulting in all these positive results, he added

# MHA sounds alert on Maoist activities

Kolkata, April 26: Senior officials of the Union Ministry of Home Affairs have told the police of the four eastern Indian states -- Odisha, West Bengal, Bihar and Jharkhand to remain alert during the next 15 days over possible Maoist activities.

The alert was issued by senior officials of the Union ministry of home affairs at a meeting of the Standing Committee of the Eastern Zonal Council that took place at the West Bengal state secretariat of Nabanna here Tuesday. Besides senior officers of the Union Ministry of Home Affairs, the meeting was also attended by the chief secretaries and home secretaries of the four eastern Indian states, among others.

Although, none of the attendees in the meeting was ready to face the media to detail the discussions on the meeting, highly placed sources from the West Bengal government told on the condition of anonymity that as the alerts of MHA officials the next 15 days are extremely crucial for these four states as there are central intelligence inputs of resurgent Maoist activities in the region

during that period.

Although there had been no Maoist activities in West Bengal recently, the West Bengal police is worried about the recovery of Maoist posters in the once Maoist stronghold of Junglemahal area scattered over the three districts of Bankura, Purulia and West Midnapore. Even the state police director general, Manoj Malviya had visited the Junglemahal area and reviewed the security arrangements there.

It is learned that in Tuesday's meeting of the Standing Committee of the Eastern Zonal Council, the

West Bengal government repre sentatives complained about withdrawal of central armed forces from the erstwhile Maoist bastions without prior discussions with the state governments.

The state government also presented the details of the current security arrangements in the Junglemahal area.

In the meeting, the representatives of the West Bengal government also stressed on greater coordination between Border Security Force and local police personnel in the Indo-Bangladesh bordering villages in the state.

# How pandemic contributed to drug overdose risk

he Covid-19 pandemic has disrupted the lives of people who use drugs in ways that hurt their mental health,

and changed drug use behaviour, increasing their risk for overdose, according to a study. Drug overdoses have soared dur-

ing the Covid-19 pandemic, with US overdose deaths topping 1,00,000 during the 12-month period ending in April 2021.

Researchers noted that the pandemic and strategies for preventing the spread of the virus, such as stay-at-home orders, may have contributed to this increase in deaths, from interruptions to harm reduction programs to isolation and worsening mental health.

Further, people who use drugs and live in rural areas may be disproportionately impacted by changes brought on during the pandemic, given that many rural areas have higher rates of opioid and

# **ILLEGAL SAND MINING AND SMUGGLING IN MAYURBHANJ** NGT imposes ₹17-cr fine on lease holders

Baripada, April 26: A bench of the National Green Tribunal (NGT) held Monday a hearing on illegal sand mining and smuggling from two sand quarries in Budhabalanga river under Badasahi block and imposed a fine of over ₹17 crore on the lease holders.

The district administration had earlier been pulled up by the NGT over the illegal sand mining and smuggling from these two particular quarries. The NGT had earlier sought a report from the district administration over illegal sand mining in the Arpata and Dingira sand

quarries. Judicial Member Justice B Amit Sthalekar and expert member Saibal Dasgupta vetted all documents and reports related to mining and pronounced the verdict Monday. The hearing of the case was held on virtual mode in the presence of additional officer of the NGT standing committee Tapas



The NGT has also directed the Collector to file cases against the Badasahi tehsildar and two lease holders for illegal sand mining

Kumar Praharaj, advocates Dipa Ranjan Ghose, Gorachand Raychoudhry, Shivajyoti Chakrabarty, Debashish Ghosh and TS Swarag.

The matter came up before the NGT after Radha Mohan Singh, a

resident of Chhelia village under Badasahi block filed petitions (case no-30/22 and 31/22 EZ) before the green body in this regard. He alleged illegal mining was being carried out at Arpata and Dingira sand quarries.

The NGT also had directed the district administration to form a five-member team and conduct a probe into the charges and file the report within four weeks.

The NGT had heard the matter April 22. The court received a report which said that 2,000 cubic centimetres of sand was supposed to be extracted from Dingira mine. However, 83,000 cubic centimetres of sand has been extracted. The report also stated that sand was mined only 50 to 60 metres from a bridge, posing a threat to it.

The NGT assessed the damage done by excess mining to the environment and biodiversity at ₹12,10,77,404.

Similarly, 2,400 cubic centimetres of sand was supposed to be mined from Arpata quarry, but 25,000 cubic centimetres had been lifted. The damage to environment and biodiversity was pegged at ₹4,92,38,686. The administration has been directed to install demarcation poles around the leased out sand mines areas. The Road and Building department has been told to repair damaged roads due to frequent mineral transportation.

The Mayurbhanj Collector has also been directed to file cases against the tehsildar concerned and the two lease holders under various provisions of the IPC, CrPC and other legal framework.

# Man sets minor niece on fire

Berhampur, April 26: A minor girl was left battling for life after her maternal uncle doused kerosene on her and set her ablaze after she left their home in Bangalore over alleged torture by family members. The incident occurred at Baidya Nagar under Baidyanathpur police limits in Ganjam district, Monday night.

The girl identified as Gayatri Patra sustained critical burn injuries. She was first admitted to MKCG Medical College and Hospital in the city and later shifted to SCB Medical College and Hospital in Cuttack which has a specialised burn unit (SBU). Her condition is stated to be critical.

The accused Sipran Digal, 62 was arrested by Baidyanathpur police after a complaint was lodged

by the victim's mother, Tuesday. He was produced in court from where he was remanded to judicial custody after the court rejected his bail plea. Reports said that the girl's

mother works as a domestic help. She was finding it difficult to meet the expenses of her family and simultaneously provide education to her daughter. So she left Gavatri in the care of the accused, his son and daughter-in-law at Bangalore after he assured to bring her up like his own daughter and provide education. However, the woman learnt that her daughter was being tortured at Bangalore and was being forced to work as a domestic help. She informed 'Childine' and with their help brought back her daughter home. This angered Digal who visited the girl's house and set her on fire to avenge his humiliation.

# Parala Maharaja was Odisha PM for 3 months

STATE REMEMBERS MAN, WHO WAS INSTRUMENTAL IN CREATING ODISHA, ON HIS 131ST BIRTH ANNIVERSARY

Berhampur, April 26: Former royal Parala Maharaja Krushna Chandra Gajapati Narayan Deb as he is popularly known was regarded as one of the architects of an independent united Odisha province formed on the basis of amalgamation of Odia speaking areas in the then Orissa-Bihar-Bengal province, a report said. The state celebrated his birth anniversary. Tuesday,

He became the first Prime Minister of Odisha representing undivided Ganjam district and remained in power for three-and-a-half months. Later, Biswanath Das also from the undivided Ganjam district became the second Prime Minister of an independent Odisha.

Parala Maharaja was born April 26, 1892 and breathed his last May 25, 1974. However, his contribution to the freedom struggle and the rich legacy he left behind makes him a person to be remembered forever.

He was one of the key personalities in the formation of an independent Odisha state on the basis of Odia language. He attended the roundtable conference held in England by the British government and advocated



for the formation of an independent Odisha state. As a result, the England Parliament passed a law to govern India in 1935.

This law helped Odisha to become an independent state on the basis of language. Consequently, an independent state of Odisha was formed April 1, 1936. Soon an intense power struggle started to wrest control over the newly-formed state.

In an independent Odisha, the first elections were held in 1937. This sowed the seeds of factionalism and politics of leg pulling within Congress. The Maharaja, who was very much a man of principle, moved away from **Congress and floated a** separate party to contest in the elections

As per rule framed by the British government it was decided that the Odisha Assembly would have 60 seats. Members for four seats out of the 60 would be nominated by the then Governor while the elections would be held for the rest 56 seats

In an independent Odisha, the first elections were held in 1937. This sowed the seeds of factionalism and politics of leg-pulling within the Congress. The Maharaja, who was very much a man of principle, moved away from

Congress and floated a separate political party to contest in the elections. He named the new party as 'National Party'. His party won 13 seats while Congress won 37 seats. The United Party headed by Kanika royal Rajendra Narayan won six seats.

Pandit Nilakantha Das was then the Pradesh Congress Committee (PCC) President. As per the election results, Congress was expected to form the government as the largest party but it failed to do so due to intense factional war within the party. Later, the Governor invited the Parala Maharaja to form the government as the second largest party.

As a result, Parala Maharaja took oath as the first Prime Minister (now Chief Minister) of Odisha April 1, 1937 with only three persons in his ministrv.

The National Party government lasted for only three months and 18 days and Parala Maharaja lost his power, July 19, 1937.

In the changed political scenario, Das became the second Prime Minister of Odisha. Both the Parala Maharaja and Das made Ganjam district proud by becoming the first and second Prime Ministers of Odisha.

# War & Economy

The April report of the International Monetary Fund (IMF) on the world economic outlook gives a graphic description of the disastrous effects of the sanctions imposed by the US and the European Union on Russia for the latter's invasion of Ukraine. This only reinforces the truth about the strength of the tool of sanctions. The cascading effects are even more devastating as the world has already been ravaged by the COVID-19 pandemic. The war came when some recovery was being made from the economic paralysis due to the pandemic. The first ominous sign that the report mentions is the slashing of its forecast for global economic growth by nearly a full percentage. It has given a grim warning that inflation is now a "clear and present danger" for many countries. The war is expected to further increase inflation, the IMF said, with the cautionary remark that a further tightening of Western sanctions on Russia to target the latter's energy exports would cause another major drop in global output.

The US and its allies were well aware of the economic costs their actions against Russia would cause to the world. The US was being perceived as militarily and economically weak before the Ukraine invasion by Russia took place. The war presented the US with a golden opportunity to make over its sagging global image and, interestingly, China too seems to have been made toothless in this decisive phase of world history. The current layers of sanctions against Russia proved to the whole world that America, especially under the Biden administration, is capable of controlling world affairs even without going to war directly.

There is a marked difference between sanctions against a not so powerful country and a global power-house such as Russia. It could well be that the Western powers knew the shape of things to come, but withheld the knowledge from the world. If Putin's desire for aggrandisement was the cause of the Ukraine crisis, the West was no less culpable for provoking Russia by constantly goading Ukraine to take on the Russian might with the false promise of inducting it into NATO.

Now, the IMF warns rising prices of food, energy and other goods could trigger social unrest, particularly in vulnerable developing countries. Reduced supplies of oil, gas and metals produced by Russia, wheat and corn - produced by both Russia and Ukraine - and fertilisers by Belarus drove up prices sharply in Europe, Asia, the Middle East, North and Sub-Saharan Africa. The effects are most painful in lower-income households around the world

The IMF has downgraded its forecasts for the second time this year and said it now projected global growth of 3.6 per cent in both 2022 and 2023, a drop of 0.8 and 0.2 percentage points, respectively, from its January forecast because of the war's direct effects on Russia and Ukraine and global spillovers. The words of the IMF Managing Director Kristalina Georgieva sound like a pathos-filled cry: "What has Russian invasion of Ukraine cost? A crisis on top of a crisis with devastating human costs and a massive setback for the global economy." According to the IMF's estimate, Ukraine's GDP will collapse by 35 per cent this year, while Russia's output will shrink by 8.5 per cent in 2022. The decline of Russia's GDP would double and go up to 17 per cent by 2023 if tightening of sanctions against it are to include restrictions on energy exports, according to IMF Chief Economist Pierre-Olivier Gourinchas.

Other effects of this war are escalation in energy prices and financial market turmoil that would cut another two percentage points off the global growth forecasts, it is feared. The war exacerbated inflation that had already been rising in many countries because of imbalances in supply and demand linked to the COVID-19 pandemic. The latest lockdowns in China are likely to cause new bottlenecks in global supply chains. The war compounds the problems created by the series of supply shocks that have struck the global economy during the past couple of years. The IMF uses the metaphor of earthquake to describe the impact that the combined effects of the Russia-Ukraine conflict and the pandemic are causing. "Like seismic waves, its effects will propagate far and wide - through commodity markets, trade, and financial linkages," Gourinchas has warned.

On the other hand, central banks face increased pressure to fight inflation with tighter monetary policy. Further tightening of sanctions could only speed up the process that would bring in more difficulties for developing economies. The IMF says inflation is now projected to remain higher for longer, as it is driven by war-induced commodity price increases and broadening price pressures. The situation could get worse if supply-demand imbalances deepened.

The IMF's report gives an important reminder to policymakers that they need to focus much more attention on encouraging innovation, improving productivity and strengthening other drivers of robust, inclusive economic growth. Failure to do so will make the risk of medium-term growth stagnation uncomfortably high The Russia-Ukraine war coupled with the pandemic poses a grave threat to the existing global economic order. The models that are being used are not efficacious enough to tide over the difficulties. In a world that is already plagued by considerable climate, economic, financial, institutional, political and social challenges, the current developments do not augur well.

Telescope (HST), the first of its kind, was sent to space to investigate the cosmic matter by analysing the light coming from it. The Nobel Prize was given to three teams: The Supernova Cosmology Project (Lawrence Berkeley National Laboratory and University of California, Berkeley, CA, USA), The High-z Supernova Search Team (Australian National University, Weston Creek, Australia) and The High-z Supernova Search Team (John Hopkins University and Space Telescope Science Institute, Baltimore, MD, USA) for the discovery of the expanding universe in 2011.

We humans are trichromatic (tri: three, chroma: colour) living beings who can see the sunlight as a seven-colour rainbow in any rainy day. The white sunlight passes through water droplets and undergoes refraction followed by splitting into different spectrums, and we can see only a few colours which were given seven names by Sir Isaac Newton in 1660 -- violet. indigo, blue, green, yellow, orange and red. But basically, there are only three colours -- red, green, and blue -- designated as primary colours. The other colours are derivatives of these three primary colours. But why it is only red, green, and blue, and not any other colour? This is because of three types of receptor genes in our eye expressing at the back surface in the retina. These three receptors are packed in three bags of cells called the cone photoreceptor. These three cone photoreceptor cells are also called the blue cone or short-wave sensitive (SWS) cone, the green cone or medium wave sensitive (MWS) cone and the red cone or long wave sensitive (LWS) cone. The SWS gene is present in autosome (other than the sex

The number of discernible colors in natural scenes" in Journal of Optical Society of America has shown that a normal human can see 2.3 million discernible colours. The photography industry has come up with more shades combination. In the Adobe Photoshop, there are three colour channels that are red, green, and blue and each are having shades ranging from 0-255. The number 0 is black, and number 255 is either blue. green, or red. A normal eye can see (monkey), most of the mammals 16 million hues, according to Adobe Photoshop photography  $(255x255x25\overline{5})$  in a picture. In this way, theoretically in dichromatic and monochromatic animals the colour visualisation luxury decreases to 65025 (255x255) and 255. respectively. But due to the principle of univariance (comparison of colour in brain), the dichromat can see very less colour as compared to theoretical prediction.

Achromatopsia is a disease where people cannot perceive any colour and for them the world is a dull grey colour. Patients with achromatopsia are deficient of three types of colour photore ceptors. This is a hereditary disease with very rare occurrence. A neurologist, Oliver Sacks, has de scribed in his book "The Island of Color Blind" about a tribe in

Pingelap atoll, a Micronesian is land in the South Pacific where everybody is colour blind. But the red-green colour blindness is very common in people which are very similar to dichromatic eyes in mammals. The photosensitive colour receptors originated 550 million years ago in the Cambrian period in the water. Scientists thought that the upgradation of the chromaticity is a gradual evolution for the vision. It is impossible to give a dichromatic eye a trichro matic vision. They argue that the neural wiring is not possible if there is sudden change of dichromatic to trichromatic eve. But this is now possible in a few research studies on mice and owl monkeys (this monkey is nocturnal and does not have red cone). Dr Jeremy Nathans and Dr Jay Neitz in their research papers published in the peer reviewed journal Science and Nature have engineered the trichromatic vision in the dichromatic eye. In this research, they have shown that supplementation of LWS gene to the mice and owl monkey using different delivery techniques causes upgradation of colour vision. Mice and owl monkeys are deficient in LWS gene and hence cannot recognise the red colour. The behavioural test in mice and owl monkey established that they can see the red colour sweet soya flavour or fruit respectively after supplementation of LWS gene. Theoretically, now we can give mice and monkey the colour vision luxury of 10,000 to two million colours. This discovery will pave the way to cure the inherited colour-blindness disease (those who are colour blind from birth).

One of the assumptions is that every upgradation of chromaticity increases the arena of colourful vision to a very vast order. We know now that mantis shrimp has 16 different types of colour cones. I cannot comprehend how they can see the world in colour. But if I could, then this colorful trichromatic vision of ours is just a black and white image to mantis shrimp


### Spissitude

In January 1924 the Atlanta Constitution reported that spissitude had been added to others, such as thermometer and truly rural, as words the New York police used to test the sobriety of midnight revellers. #### Then you open a new bank account and set up online access to your account, a bank employee may say something like this to you: "Do not share your password with anyone!" And you may find yourself think-

ing, "Of course not, Do I look like an idiot? I'm just going to save it on my computer in a file called 'Important passwords.""

Sharing your bank password would be like passing around your ATM card. Before you know it, you'll be writhing on the floor in misery and getting comforted by your pet dog, who knows what it's like to have no money in his name.

Almost every website or app wants you to create an account using a password, and sharing most of these passwords is not advisable. You might find yourself promoting illicit drugs on your social media pages, tweeting anti-vaccine messages, or emailing your friends to let them know that you're raising money to join the armed forces in Ukraine and need them to immediately wire money to a bank account in Nigeria.

Yes, sharing passwords is generally not a good idea, but for many



people, streaming services are an exception. When it comes to passwords for Netflix, Amazon Prime, Disney+ and other streaming services, millions of people have adopted a simple philosophy: "Sharing is caring.

Fo them, a Netflix subscription is like a private swimming pool: it's perfectly fine to allow your friends and family members to enjoy it, as long as they don't all jump in at the same time.

Netflix and other streaming services may frown on password-sharing, but isn't it reasonable to do so, to some extent?

Sharing your password with your spouse or partner is necessary, of course, especially since you share so many other things. Refusing to share your Netflix password would be a relationshipbreaker, no different than refusing to share a drink

password would be a relationshipbreaker, no different than refusing to share a drink But what about your children? If they're still young and live at home, it makes sense to share your password with them, so they can stream their favourite movies and shows to their devices. If they're fully grown-

up and living on their own, sharing your password with them is a good way to reward their independence. It's also a good way to maintain the family connection. No need to buy them a house-warming gift.

Your children, of course, would share the password with their partners, who would share the password with their siblings. And soon. two entire families will be sharing a single Netflix subscription, sending blessings in your direction every time they watch "Bridgerton."

What's the harm in this? Well, for starters, Netflix imposes restrictions on the number of devices that can stream content at any given time, depending on the type

of subscription. The basic subscription limits you to a single device, so if you want to share it with friends or family members, you need to coordinate watching times. You can watch in the evening, while your aunt watches in the morning, your parents watch in the afternoon, and your cousin watches from midnight onwards, which is quite convenient for him, because not only does he live in a different time zone across the world, he is also currently unemployed.

But while this arrangement increases viewership considerably, it doesn't make Netflix happy. In recent months, the company has lost more subscribers than it has gained, and it lays the blame partly on password sharing. More than 100 million households around the world are using a shared password, according to Netflix. The company plans to charge a little more for subscriptions that are being used in multiple households.

In other words, it might be time to send a message to your cousin, your aunt and even your parents: 'Sharing is caring, so would any of you like to share the subscription fee?'

### Malaria no more

Sir, The observance of the First World Malaria Day was held 25 April 2008 and since then every year on the same date the programme has been observed across the world to spread awareness and prevent malarial contagion and deaths. Globally, there were 241 million cases of malaria in 2020 compared to 227 million cases in 2019. There is a sharp rise increase in malaria cases in the world and the malarial deaths too reached at 6,27,000 in 2020 which is about 69,000 more deaths than recorded the previous year. The World Health Organisation (WHO) has set a target of 90 per cent reduction of malarial cases and malarial deaths by the year 2030. # Wake-up call for Europe to look at Asia: Jaishankar

New Delhi, April 26: External Affairs Minister S Jaishankar Tuesday countered criticism of India's position on the Russian aggression against Ukraine, saying the Western powers have been oblivious to the pressing challenges facing Asia including last year's events in Afghanistan and the pressure on the rules-based order in the region.

In responding to a question by Norwegian Foreign Minister Anniken Huitfeldt at the Raisina Dialogue, he said the crisis in Ukraine could be a "wake up call" for Europe to also look at what was happening in Asia and reminded the West about "what happened in Afghanistan less than a year ago where an entire civil society was thrown under the bus by the world".

When the rules-based order was under challenge in Asia, the advice we got from Europe is to do more trade. At least we are not giving you that advice," he said."In terms of Afghanistan, please show me which part of the rules-based order justified what the world did there." he added.

India has not yet publicly condemned the Russian attack on Ukraine and has been calling for the resolution of the conflict through dialogue and diplomacy. "Quite candidly, we have been hearing for the last two months a lot of arguments from Europe saying things are happening in Europe and Asia should worry about it because this could happen in Asia,"



In his question, Bildt asked the external affairs minister what conclusion China could draw from what's happening in Ukraine and whether there was a possibility of Beijing seeing the possibility to do things that otherwise would not be allowed.

The Swedish leader said the conclusion that China could draw from the crisis in Ukraine could have major repercussions perhaps for India's security. In his response, Jaishankar said the questions should have been asked to Chinese Foreign Minister Wang Yi.

"I cannot honestly answer that question. But I do not think international relations necessarily function by precedence. People do not need to see something out there and say aha that's what I am going to do," Jaishankar responded.

New Delhi, April 26: Pakistansponsored terrorism forced 64.827 Kashmiri Pandit families to leave the Kashmir valley in the early 1990s and settle in Jammu, Delhi, and some other parts of the country, government has said.

According to the annual report of the Ministry of Home Affairs (MHA) for 2020-21, as many as 14,091 civilians and 5,356 security force personnel lost their lives to militancy in Jammu and Kashmir between the 1990s, when militancy

first reared its head in the valley, and 2020.

"Militancy in Jammu and

Kashmir is intricately linked with infiltration of terrorists from across the border," the report said. Besides Kashmiri Pandits, militancy forced some Sikh and Muslim families too to migrate from Kashmir Valley to Jammu, Delhi, and other parts of the country, it said.

Nearly 1,054 families from the hilly areas of Jammu migrated to Jammu plains, it said.

As per the records of registration available with the Relief and Migrant Commissioner, J&K, at present 43,618 registered Kashmiri migrant families are settled in Jammu, 19,338 families are settled in Delhi and NCR. and 1,995 families in a few other states and the UTs in the country, the report said.

With a view to resettle Kashmiri migrants in the valley, the MHA has approved 3,000 jobs in the J&K government under Prime Minister's Reconstruction Package - 2008, and an additional 3,000 jobs under the Prime Minister's Development Package - 2015 (PMDP-2015).

To house these 6,000 Kashmiri migrant employees in the valley, construction of 6,000 transit accommodations at an outlay of ₹920 crore has also been approved by the MHA

Lucknow, April 26: Uttar Pradesh Chief Minister Yogi Adityanath Tuesday directed his ministers to declare within three months all property owned by them and their families and asked IAS and IPS officials to put similar details online.



Kolkata, April 26: The first four months of 2022 haven't gone too well for the Indian Leopard, or so it seems. If figures published by the Wildlife Protection Society of India (WPSI) are to be believed, 73 of them have been poached this year. In addition to this, 140 were found dead inside forested areas across the country.

It can't be confirmed whether these 140 animals died due to natural causes, such as old age or fights with other Leopards over mating and territorial rights. Some of them may even have even fallen victim to human-animal conflicts. In 2021, the total number of Leopard deaths in the country was 614. Of these, 182 animals were poached.

# RAJ, MP MOST AFFECTED BY HEAT WAVES MP WHEAT DEMAND SHOOTS UP GLOBALLY

New Delhi, April 26: The early heat waves of 2022, that began March 11, have impacted 15 Indian states and Union Territories, as of Sunday, with Rajasthan and Madhya Pradesh suffering the most with 25 heat waves and severe heat wave days each during this period and also has had an adverse impact on the rabi crop.

According to an analysis of India Meteorological Data (IMD) data by the Centre for Science & Environment (CSE) Down to Earth (DTE) on Monday, after Rajasthan and Madhya Pradesh, the hill state of Himachal Pradesh has been the most affected by heat waves this year with 21 heat wave and severe heat wave days.

Although CSE/DTE counted the heat wave period as single phase from March 11 to April 24, the IMD had held that the first spell was from March 11 to 21 and the second spell started on March 26 and ended between April 20-23 for large parts of India with isolated pockets still witnessing heat wave and severe heat wave conditions.


As per IMD definition, a heat wave is when the temperature of any place crosses 40 degrees Celsius in the plains, 37 degrees in coastal areas, and 30 degrees in the hills. It also declares a heat wave when a place registers maximum temperature that is 4.5 to 6.4 degrees Celsius more than the normal temperature for the area for that day; and it is a severe heat wave if this temperature is over 6.4 degrees.

Another criterion used by the IMD to declare a heat wave is when temperature of a given place touches/crosses the 45 degrees Celsius mark and after 47 degrees Celsius, it is a severe heat wave. "Anti-cyclones over western

Anticyclones cause hot and dry weather by sinking winds around high pressure systems in the atmosphere," said D Sivananda Pai of the Kottayam-based Institute for Climate Change Studies.

Another climate scientist, Raghu Murtugudde from the University

of Maryland, said: "A north-south pressure pattern, associated with the La Nina phenomenon in eastern and central Pacific Ocean that happens during winters in India, has persisted longer than expected and interacted with warm waves coming in from a rapidly warming Arctic region, leading to the heat waves.

The sea surface temperatures over east and central Pacific Ocean become cooler-than-average during La Nina. This affects the trade winds flowing over the ocean surface through changes in wind stress. The trade winds carry this weather disturbance elsewhere and affect large parts of the world.

"In India, the phenomenon is mostly associated with wet and cold winters. Therefore, the current impact of La Nina on the spring and summer season in India is completely unexpected," Murtugudde said, adding: "The heat waves may continue till at least the monsoon season begins in June.

The part I of the IPCC's (Intergovernmental Panel on Climate Change) Sixth Assessment Report in October 2021 had warned that every additional 0.5 degrees Celsius of warming will increase hot weather extremes, along with extreme precipitation and drought. Heat waves in India are likely to "last 25 times longer by 2036-2065" if carbon emissions remain high and push global temperature rise to 4 degrees Celsius by the end of the century.

Heat waves exert enormous impacts on health, agriculture and availability of water - all often related to each other in complex ways, the CSE/DTE analysis pointed out and said: "On the other hand, agricultural yields get impacted as well. For instance, the wheat crop in the current rabi season in Punjab, Haryana and Uttar Pradesh has been impacted by heat waves. Many farmers have reported losses between 20 and 60 per cent in these states.

"This happened because the heat waves were early this year and the temperatures affected the wheat plants during their growth stage, leading to shriveled grains which fetch lower prices in the market, resulting in losses. To reduce agricultural losses due to heat waves, heat-tolerant varieties of wheat need to be developed," it said.

Indore, April 26: The demand for wheat varieties like Sharbati and Kathia grown in Madhya Pradesh has shot up in the international market amid short supply from Russia and Ukraine due to the ongoing war, an official said.

Madhya Pradesh State Agricultural Marketing Board's (MPSAMB) Managing Director Vikas Narwal said that the government procurement of wheat dipped by 30% due to a sharp rise in prices in the open market.

There is a steep rise in wheat export due to Russia-Ukraine crisis and mandis were seeing huge influx of this foodgrain," he said.

Narwal said that 1.76 lakh tonnes of wheat was exported from the state during the last marketing season, whereas about 2.5 lakh tonnes of wheat has been exported in the last one month of this marketing season alone. Two more months are still left for this marketing season to end, he added.

He said that traders were buying Sharbati and Kathia (durum) wheat from farmers and mainly exporting to Bangladesh, Vietnam, the Philippines and the United Arab Emirates (UAE).

"This time around, the importers from Africa are also evincing keen interest in MP's wheat. In the coming days, wheat from

Madhya Pradesh might be exported to Egypt, Zimbabwe, Mozambique and Tanzania also,' he added.

He said that wheat was sown on 95.51 lakh hectares area in the state during 2021-22 Rabi season adding that its production is expected to reach 346.70 lakh tonnes.

# Great Indian Bustard numbers continue to decline

Jaisalmer/New Delhi, April 26: Of the less than 100 remaining Great Indian Bustard, yet another has died. It died of collision with a power line in Jaisalmer in Rajasthan, the home territory of this large, fascinating bird.

Incidentally, the death of this "critically endangered" bird three days ago comes exactly a year after the Supreme Court had, in April 2021, directed the power firms and the government to lay underground wires for all new power projects in Rajasthan and go for diverters for

existing lines. However, both the government and the multiple agencies continued to fight their way out, prompting the apex court to recently give the power companies of Gujarat and Rajasthan a deadline of July 20. Incidentally, the majority of these projects are either solar power plants or wind power plants in these two states

The Great Indian Bustard (GIB) or Ardeotis nigriceps, is listed in Schedule I of the Indian Wildlife (Protection) Act, 1972 and as 'Critically Endangered' on the IUCN Red List and the National Wildlife Action Plan (2002-2016). A large bird of about 1 metre height, the GIB has a wing span of almost 2 metres with the adult weighing between 15-18 kg. In 2018 count, there were only 150 GIBs left in the country, 122 of them in the Jaisalmer area in Rajasthan. The remaining 28 were sighted in Gujarat, Maharashtra, and Karnataka, However, wildlife conservationists have claimed that the number of GIBs is below 100 as of 2022 in the wild.

New Delhi, April 26: The Supreme Court Tuesday directed the Uttarakhand chief secretary to place on record that no untoward statement will be made at the 'Dharam Sansad' scheduled in Roorkee and warned that it will hold top officials responsible in case of any hate speech being made. The event is scheduled for Wednesday. A three-judge bench headed by Justice A M Khanwilkar took note of the assurance given by the Uttarakhand government that authorities are confident that no untoward statement will be made during the event and that all steps

be taken. The bench also told the Uttarakhand government that the chief secretary would be asked to be appear before it if the state failed to take preventive steps.

"We will hold the chief secretary, home secretary, IG concerned responsible if any untoward situation happens despite your assurance! We are putting it on record," the bench said.

The apex court voiced concern that incidents of hate speeches keep occurring in the country despite the apex court guidelines on preventive measures to be taken by government authorities.

"We direct the chief secretary of Uttarakhand to place the above position on record and apprise us about the corrective measures," the bench also comprising Justices Abhay S Oka and C T Ravikumar said.

## 20 to 25 Armymen killed by avalanches every year: Rajnath

New Delhi, April 26: Defence Minister Rajnath Singh Tuesday said that he was saddened to learn that every year 20 to 25 Indian Army personnel lose their lives, not in war or terrorist incident but in avalanches.

Interacting with a team of Tiranga Mountain Rescue (TMR) here, he said: "I am very sad to know that every year, 20 to 25 personnel of our Army lose their lives in such accidents. That is, what can be more sad than this, no war, no terrorist incident, yet so many of our soldiers lose their lives in avalanche."

He commended TMR for saving the lives of the Armed Forces personnel from threats like avalanches, besides raising awareness and imparting training to them.

'Tiranga Mountain Rescue' team is a non-profit organisation affiliated with the Indian Army since 2016 and is instrumental in providing dedicated avalanche rescue and training to Indian Army personnel in mountain craft.

The team provides multiple teams of highly motivated and qualified avalanche rescue professionals who are deployed in snow bound and difficult areas during the winter season.

Rajnath Singh termed 'Tiranga Mountain Rescue' as a source of strength to the soldiers who are deployed in difficult areas and are exposed to various threats such as avalanches.

He appreciated the fact that there has been no Army casualty in the locations where it is deployed.

Stressing that Tiranga Mountain Rescue' has a big responsibility on their shoulders as in the coming times threats such as avalanche may increase due to climate change, he described the work being carried out by it as a shining example of partnership between the government and civil society.

# Mevani sent to 5-day police custody

The Chief Judicial Magistarte's court in Barpeta remanded the Gujarat legislator to police custody after he was re-arrested on Monday, soon after the CJM's court in Kokrajhar district granted him bail, six days after he was arrested by Assam police from his home state in Gujarat in connection with an "objectionable" tweet against Prime Minister Narendra Modi.

Mevani's lawyer Angshuman Bora said that they would decide Wednesday whether the bail petition would be moved to a higher court. The Barpeta police, following a complaint lodged by a woman sub-inspector, levelled several charges against Mevani. These include IPC 294 (obscene acts or words in public), IPC 323 (voluntarily causing hurt), IPC 353 (Assault or criminal force to deter public servant from discharge of his duty) and IPC 354 (Whoever assaults or uses criminal force to any woman, in-

# BSP faced max defections in polls

Lucknow, April 26: The Bahujan Samaj Party (BSP) faced the maximum number of defections by its candidates and MLAs during the recent assembly elections in Uttar Pradesh.

The BSP lost nearly 75 (27 per cent) candidates to other parties during the polls and 12 sitting MLAs crossed over to other parties.

According to a detailed analysis report released by Association for Democratic Reforms (ADR), the number of candidates who left the Congress to join other parties was 37 (13 per cent).

In recent assembly elections, 54 (20 per cent) out of the total of 276 re-contesting candidates switched to the Samajwadi Party followed by 35 (13 per cent) candidates who joined BJP and 31 (11 per cent) candidates who joined BSP.

The highest number of MLAs-27 left BJP to join another party. Eighteen candidates left Rashtriya Lok Dal to join other parties while 22 from SP moved to greener pastures.

# Thieves 'bulldoze' ATM, flee without cash Tejasvi asked to join probe

**Sangli, April 26:** A special squad of the Sangli Police is hot on the trails of a gang of thieves which used a stolen JCB to bulldoze an ATM machine, but suddenly fled without grabbing the Rs 27-lakhs stored in it, an official said here Tuesday.

"We have managed to identify around 3-4 suspects based on the CCTV footage acquired from an



adjoining petrol pump. Our dedicated team is now tracking their whereabouts in the Sangli district or neighbouring districts," Miraj Rural Police Station head Chandrakant Bedre told IANS, around 72 hours after the attempted heist.

The incident happened around midnight on April 23-24 (Saturday-Sunday) in Miraj industrial town bustling with considerable public movements at that time on the main road and market where the Axis Bank ATM is located.

Hoping to make a quick buck, the thieves stole a JCB parked near the petrol pump and bulldozed it into the ATM cabin, uprooting the machine and damaging all its power connections.

"Hearing the commotion, many

locals rushed there and the thieves panicked. They abandoned the JCB there and fled without touching the case stored in the ATM, Bedre informed.

Police have also seized the JCB belonging to a villager living some 4 kms on the outskirts of Miraj and based on a complaint registered by Axis Bank are now trying to zero in on the gang of thieves.

The viral CCTV footage shows a man entering the ATM cabin, leaving suddenly, and moments later a JCB machine shattering the glass doors and then pounding the ATM machine with the giant claws of the bulldozer.

They managed to dig out the steel ATM machine, estimated to be weighing over 700 kgs and flung it at least 5-6 metres away from the cabin, where it landed with a huge sound.

As a crowd rushed there to inquire, the jittery thieves bolted, leaving behind the JCB and the ATM machine with the unstolen booty intact, said Bedre.

by the BJP's Yuva Morcha over Kejriwal's remarks in the Delhi Assembly on "The Kashmir Files" that were deemed as "against the Kashmiri Pandit community" among the saffron clans.

# Four killed in kindergarten shooting in Russia

Moscow. Russia. April 26: An armed man opened fire in a kindergarten Tuesday in Russia's central Ulyanovsk region, leaving at least four people dead, local authorities told AFP.

"According to preliminary information there was a shooting in a kindergarten. As a result, two children, a teacher and the attacker died," the head of the Ulyanovsk region information department, Dmitry Kamal, told AFP. He said investigators were working at the scene to establish further information. The ages of the dead children were not known, but they would be between three and six years old, Kamal said. A source in law enforcement told news agency TASS that the shooting may have been the result of a "domestic conflict". According to Telegram channel Baza -- which is known to have sources in Russian law enforcement -- the man walked into the kindergarten during nap time with an Izh-27 double-barrelled shotgun. There was no guard on duty. Russia in 2021 was rocked by two separate tragic killing sprees -at a school in the city of Kazan and at a university in Perm -- that spurred lawmakers to tighten laws regulating access to guns.

# Lankans intensify anti-govt protests

Earlier, the Colombo magistrate court had refused to issue a police order preventing protests near the Temple Trees. The Rajapaksas are under pressure to resign for their mishandling of the forex crisis which landed the island nation into its worst economic crisis. President Gotabaya Rajapaksa had to drop his older brother Chamal and the eldest nephew Namal from the Cabinet in response to the protests which called for account-

Washington: The global coronavirus caseload has topped 510.1 million, while the deaths have surged to more than 6.22 million and vaccinations to over 11.24 billion, according to the Johns Hopkins University. In its latest update Tuesday morning, the University's Center for Systems Science and Engineering (CSSE) revealed that the current global caseload and the death toll stood at 510,191,435 and 6,220,536, respectively, while the total number of vaccine doses administered increased to 11,246,449,964.

Korean People's Revolutionary Army (KPRA), Kim vowed to boost the country's nuclear capabilities at "the fastest rate", according to Pyongyang's official Korean Central News Agency (KCNA). The KPRA is the anti-Japanese

guerilla force known to have been created by national founder Kim Il-sung in 1932, reports Yonhap News Agency.

The incumbent leader added that the North will make thorough preparations for using nuclear "deterrence" anytime.

He also warned that any forces seeking military confrontation will cease to exist, saying that the North is "thoroughly prepared" to carry out its mission of nuclear deterrence anytime. The parade at the Kim Il Sung



was initially expected to begin earlier in the day, but it did not proceed amid a forecast of rainfall.

An informed source said it fnally kicked off at around 10 p.m.. It marked the North's first military parade to celebrate the KPRA anniversary and 12th major military parade under the leadership of Kim Jong-un, who took power about a decade ago.

The North has typically held such parades on the birth anniversary of national founder Kim Il-sung April 15, the founding anniversary of the ruling Workers' Party October 10 or the nation's foundation September 9.

# Sand is world's 2nd most exploited resource: UN

United Nation/New Delhi, April **26:** Fifty billion tonnes: enough to build a wall 27 metres wide and 27 metres high around planet earth. This is the volume of sand and gravel used each year, making it the second most used resource worldwide after water.

Given by dependency on it, sand must be recognised as a strategic resource and its extraction and use needs to be rethought, a new report by the United Nations Environment Programme (UNEP) said Tuesday

The report, Sand and

Sustainability: 10 strategic recommendations to avert a crisis, released by UNEP's GRID-Geneva team, provides the necessary guidance gathered from world experts to switch to improved practices for the resources' extraction and management.

Extracting sand where it plays an active role, such as rivers, and coastal or marine ecosystems, can lead to erosion, salination of aquifers, loss of protection against storm surges and impacts on biodiversity, which pose a threat to livelihoods through, among other things, water supply, food production, fisheries, or to the tourism in-



dustry. According to the report's authors, sand must be recognised as a strategic resource, not only

They stress that governments, industries and consumers should price sand in a way that recognises its true social and environmental value. For example, keeping sand on coasts may be the most cost-effective strategy for adapting to climate change due to how it protects against storm surges and impacts from sea level rise - such services should be factored into its value.

An international standard on how sand is extracted from the marine environment should also be developed, the report proposes.

This could bring about dramatic improvements as most marine dredging is done through public tenders open to international companies.

Meanwhile, the report recommends that the extraction of sand from beaches be banned due to its importance for coastal resilience, the environment and the economy. Sand is critical to economic development, needed to produce concrete and build vital infrastructure ranging from homes and roads to hospitals.

By providing habitats and breeding grounds for diverse flora and fauna, sand also plays a vital func-cluding marine plants that act as carbon sinks or filter water.

# Peak power supply crosses 201GW mark 'Make in China, sell in India not done'

New Delhi, April 26: The maximum all India power demand met or the highest supply in a day crossed the record level of 201 GW mark showing spurt on Tuesday amid sweltering heat in large parts of the country.

"The maximum All India power demand met is 201.066 GW at 14:51 hours today." a power ministry statement said.

It has surpassed last year's (record of) maximum demand met of 200.539 GW which occurred 7th July 2021, it informed.

The rising power demand reflects the economic growth in the country, the ministry explained. In the month of March this year, the growth in energy demand has been around 8.9 per cent as per the



ministry's statement. Further, it stated that the demand is expected to reach about 215-220 GW in months of May-June.

"If Elon Musk (Tesla CEO) is ready to manufacture in India then there is no problem ... Come to India, start manufacturing, India is a large market they can export from India," he said.



"But if he wants to manufacture in China and sell in India, then it cannot be a good proposition for India. Gadkari said. According to him, India has got all the competence. "The vendors are available. We

have all types of technology, we have all the spare parts," he said. adding that it will be a win-win situation for both India and Tesla. Last year, the heavy industries ministry had also asked Tesla to first start manufacturing its iconic electric vehicles in India before any tax concessions can be considered.

At present, cars imported as completely built units (CBUs) attract customs duty ranging from 60-100 per cent, depending on engine size and cost, insurance and freight (CIF) value less or above \$40,000.

Last year, in a letter to the road ministry the US firm had stated that the effective import tariff of 110 per cent on vehicles with customs value above \$40,000 is "prohibitive" to zero-emission vehicles.

It had urged the centre to standardize the tariff on electric cars to 40% irrespective of the customs value, and withdraw the social welfare surcharge of 10 per cent on electric cars










# PARAG, BOWLERS LIFT RR

Pune, April 26: Riyan Parag smashed a match-defining unbeaten half century (56 n o, 31b, 3x4, 4x6) before the bowling unit lived up to its reputation to hand Rajasthan Royals a 29-run win over Royal Challengers Bangalore in an IPL match here Tuesday

Parag single-handedly took his side to 144/8 with his innings, which is his highest score in IPL. Parag marshalled the RR lowerorder brilliantly and smashed Harshal Patel (1/33) for a boundary and two huge sixes in the final over to take RR to a decent total after being sent in to bat.

But RCB's chase never got going as RR bowlers, led by young Kuldeep Sen (4/20), Ravichandran Ashwin (3/17) and Prasidh Krishna (2/23), bundled out RR for 115 in 19.3 overs. Opening the innings on the back

of two consecutive first-ball ducks, Virat Kohli started on a cagey note but lit up the stadium and raised

hopes of his fans when he struck two back-to-back boundaries of Trent Boult (0/20) to start his innings.

But as it has been happening in the tournament, Kohli flopped once again when a Prasidh Krishna (2/23) bouncer got the better of him in the next over.

RCB's problems compounded in the seventh over when Sen, who replaced Obed McCoy in the playing XI, picked up two big wickets-of captain Faf du Plessis (23) and Glenn Maxwell (0) - with successive balls. But Shahbaz Ahmed somehow kept his wicket intact to deny Sen

young Choudhary came to him after not being satisfied with a couple of academies.



London, April 26: Novak Djokovic will be allowed to defend his title at Wimbledon, despite not being vaccinated against COVID-19, because the shots are not required to enter Britain, All England Club chief executive Sally Bolton said Tuesday.

Djokovic, a 34-year-old Serb who is ranked No.1, missed the Australian Open in January after being deported from that country because he was not vaccinated against the illness caused by the coronavirus that has led to the deaths of millions during the pandemic that began in 2020.

During the annual spring briefing ahead of Wimbledon, which starts on June 27, Bolton said that "whilst, of course, it is encouraged" that all players get vaccinated, "it will not be a condition of entry to compete" at the grass-court Grand Slam tournament this year.

Djokovic, in addition to being unable to defend his championship at Melbourne Park after an 11-day legal saga over whether he could remain in Australia, had to sit out tournaments at Indian Wells and Miami because he couldn't travel to the United States as a foreigner

The US Tennis Association has

said that it will follow whatever governmental rules are in place regarding COVID-19 vaccination status when the U.S. Open is held starting in late August.

Djokovic — who has said he got COVID-19 twice, once each in 2020 and 2021 - owns 20 Grand Slam singles titles, tied with Roger Federer for the second-most for a man. They trail Rafael Nadal, who won his 21st at the Australian Open.

Six of Djokovic's trophies came at Wimbledon, including victories each of the past three times the tournament was held — in 2018, 2019 and 2021. It was not held in 2020 because of the pandemic.

After what happened in Australia, Djokovic said he would be willing to sit out other Grand Slam tournaments if getting vaccinated were a requirement to compete. The next major event is the French Open, which begins on May 22, and tournament director Amelie Mauresmo said last month there was nothing preventing Diokovic from defending his 2021 title in Paris. The Italian Open, a clay-court tune-up for Roland Garros, also has said Djokovic can play there next month.

#### Former eves hockey team captain Britto dead

BANGALORE: Former Indian women's hockey team captain Elvera Britto died here on Tuesday due to old age related problems. She was 81. Elvera, the eldest of the three famous Britto sisters (others are Rita and Mae), ruled the domestic circuit from 1960 to 1967, guiding Karnataka to seven national titles. She represented India against Australia, Sri Lanka and Japan. In 1965, Elvera became only the second women hockey player to be conferred with the Arjuna Award after Anne Lumsden (1961). Elvera was single throughout life like her sisters. "It is saddening to learn about the passing away of Elvera Britto. She was ahead of her times and achieved so much in women's hockey and continued to serve the sport as an administrator with the state," HI president Gyanendro Ningombam said in a statement.
