Rajya Sabha polls to be held June 10

Bhubaneswar: Elections will be held June 10 to fill 57 Rajya Sabha seats from 15 states falling vacant due to the retirement of members on different dates between June and August, the Election Commission of India (ECI) said Thursday. In Odisha polls will take place for three seats as the tenures of MPs Nekkanti Bhaskar Rao, Prasanna Acharya and Sasmit Patra will end July 1. The BJD may field Patra once again, sources said. Among others who are hopeful of getting the BJD nod are Prasanna Patasani, former bureaucrat Asit Tripathy and Pradeep Maihi.



Rajiv Kumar appointed new CEC

New Delhi: Election Commissioner Rajiv Kumar was Thursday appointed as the next chief election commissioner. He will assume charge May 15 after incumbent Sushil Chandra demits office May 14, a notification issued by the Law Ministry said. Kumar, an officer of the 1984 batch of the Indian Administrative Service of the Bihar/Jharkhand cadre, superannuated from the IAS in February 2020. Born in 1960, Kumar will demit office sometime in February 2025. Prior to joining the ECI, September 1, 2020, Kumar had also been the chairman of the Public Enterprises Selection Board (PESB), He joined as the PESB chairman in April 2020.



FIVE KILLED IN SEPARATE ROAD MISHAPS IN STATE

Keonjhar, May 12: Three persons were killed and over 36 injured in separate road accidents that took place in the state, Thursday.

In the first incident, a woman Kendu vendor and a buyer died on the roadside when they were run over by a speeding truck near Nipa village in Kanjipani Ghat of this district.

Four other buyers suffered serious injuries and have been admitted to the hospital. The deceased have been identified as Niali Mantry of Nipa village under Kanjipani police limits and Sudarsan Chhatria of Bargarh district. Sources said condition of two of the four injured is quite critical and they may be shifted to other hospitals.

Niali was selling Kendu fruit when five persons arrived on a tractor to buy those. While they were negotiating the price, an iron ore-laden truck ran over all the six, killing two on the spot.

Police have launched an investigation into the matter and have launched a manhunt for the driver of the truck who managed to escape with his vehicle.

In another incident a mini-truck driver was killed and six people including children sustained serious injuries when their vehicle was hit by a tanker near Humma in Ganjam district on NH-16. Sources said that the mini-truck, carrying household and decor items, was heading towards Chhatrapur when the accident occurred

Two persons, including a minor were killed, and six critically injured when a mini-truck and an auto-rickshaw collided on Chandeneswar Road under Bhograi block of Balasore district. The deceased were identified as Gangamani Bhuyan (23) and her **MORE P5** niece Asmita (3).



Criminal injured in shootout

Two sub-inspectors of police were also hurt during the encounter with the miscreants, but now their condition is stated to be stable

Bhubaneswar, May 12: Dreaded criminal Chakradhar Barik alias Chakara was injured after a shootout with cops at Baramunda under Khandagiri police limits in this city on the intervening night of May 11 and 12. In the firing two police sub-inspectors, Rajiv Kumar Nayak and Debadutta Samantray also suffered injuries. However, sources said that the conditions of all the three are stable Barik is currently undergoing

treatment at the SCB Medical College & Hospital in Cuttack. Once he recovers, he will be arrested, police sources said. They also informed that

Commissionerate Police received a tip-off regarding the gathering of seven to eight notorious antisocials including Barik and his associates at the Melana Padia (a playground) near Baramunda high school here.

"Yesterday (Wednesday night), Khandagiri police received information that seven to eight suspected criminals had gathered at

the Baramunda playground. The cops also learnt that the accused were armed with lethal weapons like pistols and bombs and were planning some criminal acts. Immediately, a team of the Special squad and Khandagiri police rushed to the spot," DCP Prateek Singh

told the media Thursday.

"Upon seeing the police, the antisocials hurled crude bombs at the cops and opened fire as well. In self defence, police fired back and in the exchange Barik was injured. However, his associates managed to give police the slip taking advantage

of darkness." Singh informed. Barik who suffered bullet in-

juries below the knee in his right leg was first admitted to Capital Hospital here before being shifted to Cuttack. Two firearms, seven rounds of

live bullets, unused bombs and a car were seized from the encounter spot. Singh also visited the spot to take stock of the situation. A forensic team also visited the spot to examine the car and other materials left behind by the miscreants.

Police sources claimed that Barik was a close associate of notorious miscreant Rabi Rao who was arrested after an encounter with police at Bharatpur in Khandagiri in August 2019.

Subsequently, Barik created another gang. Members of his group were engaged in various criminal activities like loot, snatching, robbery and illegal drugs trade. The gang frequently used to target jewellery shop owners. A total of 16 cases are pending against Barik at different police stations of the city.

Bhubaneswar, May 12: In an aim to attract more tourists, the Odisha government has decided to develop infrastructure at important tourist destinations like Bhitarkanika, Chandrabhaga, Nrusinghanath and Harishankar. The government will spend ₹132.32 crore for the development work. This decision was taken Thursday during a highlevel meeting held here under the chairmanship of Chief Secretary Suresh Chandra Mahapatra.

During discussions it was decided that for Bhitarkanika, tourism facilities would be developed in four principal zones. They are Dangmal, Gupti, Khola, and Chandbali.

The primary interventions would include setting up of cottages, laying of floating jetties, development of arrival plazas, common facility centres, towers for wildlife sighting, toilets and parking, officials informed after the meeting.

Land for projects would be acquired and developed by IDCO near Gupti, Khola, and Kasturikana. The entire project in Bhitarkanika would be undertaken in three phases. In the first phase,

Bhubaneswar, May 12: Chief Minister Naveen Patnaik accorded in-principle approval Thursday to Mahanadi Coalfields Limited's (MCL) proposal to take over the operations of the medical college in Angul district. The state government will run the medical college and hospital, while MCL will provide the necessary funds for it, officials said.

"The medical college will further strengthen the efforts of the state government to improve the capacity of the medical education institutions in Odisha," the Chief Minister's Office (CMO) said in a statement.



MCL has constructed the infrastructure in Talcher on 20 acres of land provided by the Odisha government at a cost of ₹500 crore, officials said. The medical college will have 100 seats for MBBS students while the hospital will have 500 beds. The MCL tried to operate the

Mahanadi Institute of Medical Sciences and Research (MIMSR) through public-private partnership (PPP) mode initially. However, after communication between the Coal Ministry and the chief minister, a proposal was sent to the

state government for taking over the responsibility of operating it.

The construction was completed in 2018 and the facility was inaugurated by Union Minister Dharmendra Pradhan in 2019. If everything goes according to plan the medical college will be operational in the next couple of years, sources said.

This facility will be a major step towards providing quality healthcare to the people of Angul and adjacent districts. The medical college will further strengthen the efforts of the government to improve the capacity of the medical education institutions in the state, said officials.

Meanwhile, Health department special secretary Dinabandhu Panda in a letter to MCL has asked the PSU to meet the additional capital expenditure required for the college in the next few years and also to bear the entire operational cost of the **MORE P4**

Honey-trapped IAF official held for espionage

New Delhi, May 12: An Indian Air Force (IAF) sergeant at the records office here has been arrested for allegedly leaking classified and sensitive information about defence installations and personnel to a Pakistan-based 'agent', police said Thursday. They informed that the sergeant had been 'honey-trapped'.

The accused has been identified as 32-year-old Devender Narayan Sharma. He was working as an administrative assistant (GD) at the IAF Record Office at Subroto Park here.

During investigation, it was found that Sharma was allegedly 'honey-trapped' by a Pakistanbased woman with whom he shared sensitive documents related to personnel, national security and defence, police informed.

The Delhi Police Crime Branch arrested the sergeant for allegedly leaking the sensitive information through WhatsApp to the 'agent of adversary country' after deceitfully obtaining material and documents from computers and other files, according to police. Police also said Sharma had also received money from the agent for the leaked information.

On the basis of a complaint received by the IAF, a case under the Official Secrets Act was registered and the sergeant was arrested May 6 and dismissed from service, police said.

During investigation incriminating evidence such as electronic gadgets and documents were seized, police informed. They added probe is on in the matter.

Sources said that police have also detected some suspicious transactions in Sharma's wife's bank account. Efforts are on to trace the origin from which money was deposited in the account.

Last year in July, two people, including an Indian Army man, were arrested under the Official Secrets Act for allegedly providing classified documents to Pakistan spy agency Inter-Services Intelligence (ISI).

The development had come after a 34-year-old vegetable supplier at the Pokhran Army base camp was held for allegedly getting sensitive documents from an Army man for money and providing them to the ISI.

Colombo, May 12: Opposition leader Ranil Wickremesinghe was Thursday sworn-in as Sri Lanka's new prime minister. The 73-yearold United National Party (UNP) leader was appointed as the prime minister by President Gotabaya Rajapaksa after they held closeddoor discussions Wednesday.

It was indeed a strange development as the UNP has just one representative in the 225-member strong Sri Lankan Parliament. This is the sixth time Wickremesinghe will be the PM of the island nation.



Prepare roadmap for forest health: CM

Bhubaneswar, May 12: Chief Minister Naveen Patnaik Thursday asked divisional forest officers (DFOs) to prepare a roadmap for improving forest health or the general condition of forests in state.

Inaugurating a two-day conference of divisional forest officers (DFOs) here, Patnaik said the roadmap will suggest ways to reduce man-animal conflict, prevent trafficking, provide livelihood to people living on the fringe of forests, mitigate wildfires and allow forests to grow without destruction, thus improving their health.

He said the forest cover in the state has increased due to the tireless efforts of Van Suraksha

Samiti (VSS) members and for-

est personnel.

Odisha has recorded the highest increase in mangrove forest cover and the third highest in overall forest cover among all the states and Union Territories between 2019 and 2021, as per the India State of Forest Report-2021

Noting that afforestation is a key component in providing employment to people residing in villages on the fringes of the forest, thus improving their living standards, he advised officials concerned to rope in women self-help groups for planting seedlings and taking care of those.

He urged the DFOs to carry out the plantation programmes under the 5T Initiative

This would bring transparency, timeliness and teamwork among all stakeholders, he added.

He said that eco-tourism has brought Rs 10.51 crore business in 2021-22, and local communities have benefited Rs 2.61 crore from it.

"Eco-tourism has provided new opportunities to people of the fringe villages, and we should upscale this to harness the untapped potential of our forests," he said.

He expressed happiness over Odisha extensively using digital technology in forest management.

Speaking on various issues such as human-elephant conflict, wildlife trafficking, and incidents of forest fires, he said that these are key concerns where we need to prepare an integrated plan with a focused approach for significant reduction in such cases.

Half of Covid survivors ailing even 2 years after infection, says study


ore than half of people hospitalised with Covid-19 still have L at least one symptom two years after they were first infected with the SARS-CoV-2 virus, according to the longest follow-up study published in The Lancet Respiratory Medicine journal.

The research followed 1,192 participants in China infected with SARS-CoV-2 during the first phase of the pandemic in 2020. While physical and mental health generally improved over time, the study suggests that Covid-19 patients still tend to have poorer health and quality of life than the general population.

This is especially the case for participants with long Covid, who typically still have at least one symptom including fatigue, shortness of breath and sleep difficulties two years after initially falling ill, the researchers said.

The long-term health impacts of Covid-19 have remained largely unknown, as the longest follow-up studies to date have

spanned around one year, they said. "Our findings indicate that for a certain proportion of hospitalised Covid-19 survivors, while they may have cleared



the initial infection, more than two years is needed to recover fully from Covid-19," said study lead author Professor Bin Cao, of the China-Japan Friendship Hospital, China.

"Ongoing follow-up of Covid-19 survivors, particularly those with symptoms of long Covid, is essential to understand the longer course of the illness, as is further exploration of the benefits of rehabilitation programmes for recovery," Cao said in a statement.

The researchers noted that there is a clear need to provide continued support to a significant proportion of people who have had Covid, and to understand how vaccines, emerging treatments, and variants affect long-term health outcomes. They evaluated the health of 1,192 par-

ticipants with acute Covid-19 treated at Jin Yin-tan Hospital in Wuhan, between January 7 and May 29, 2020, at six months. 12 months, and two years. Assessments involved a six-minute walking test, laboratory tests, and questionnaires on symptoms, mental health, health-related quality of life, if they had returned to work. and health-care use after discharge.

Six months after initially falling ill, 68 per cent of participants reported at least one long Covid symptom, according to the researchers.

By two years after infection, reports of symptoms had fallen to 55 per cent. Fatigue or muscle weakness were the symptoms most often reported and fell from 52 per cent at six months to 30 per cent at two years, the researchers said. Regardless of the severity of their initial illness, 89 per cent of participants had returned to their original work at two years, they said.

They noted that two years after initially falling ill, Covid-19 patients are generally in poorer health than the general population, with 31 per cent reporting fatigue or muscle weakness and 31 per cent reporting sleep difficulties.

Bhubaneswar, May 12: The Enforcement Directorate (ED) has seized cash and fixed deposits worth more than ₹133 crore of former MLA Jitendra Nath Patnaik in a money laundering case linked to alleged illegal mining in the state, the agency said Thursday

The action came after the ED carried out raids at various offices and residential premises of Patnaik and his related entities at Joda in Keonihar district of the state

Patnaik, popularly known as Jitu Patnaik, is a former independent MLA from the Champua Assembly constituency.

The agency alleged that the former MLA derived undue pecuniary advantage by way of illegal mining without necessary statutory approvals. "A seizure of cash amounting to ₹70 lakh and 124 fixed deposits amounting to ₹133.17 crore has been made during the search opera-

he agency alleged that the former MLA derived undue pecuniary advantage by way of illegal mining without necessary statutory approvals

tions along with seizure of various incriminating documents and digital evidences," the ED said in a statement.

The money laundering case stems from the FIR and charge sheet filed by the Odisha Vigilance cell against Patnaik and others.

"As per the charge sheet filed by the state vigilance, the accused indulged in illegal mining for a long period causing huge loss to the government exchequer which amounts to be more than ₹130 crore. The ED has been able to recover almost entire amount of proceeds of crime," it said.

PURI HERITAGE CORRIDOR PROJECT

BJP MLA goes against party line, seeks early completion

Puri, May 12: Going against the party line on the Puri Heritage Corridor Project, BJP MLA of the pilgrim city Jayant Sarangi Thursday said that the work close to the Jagannath temple here should be completed as soon as possible and urged parties not to politicise the issue.

Sarangi's statement came a day after the BJP national spokesperson Sambit Patra demanded that the work in the prohibited zone of the 800-year-old temple be stopped accusing the BJD government of the state of carrying out the proj-

The Archaeological Survey of India (ASI) May 9 informed the Orissa High Court that the ongoing construction work might have caused damage to the 12th-century shrine and the state government project was being carried out without valid permission from the competent authorities

"It is better for the temple as

well as for the local people to complete the work without further delay. I also request parties and people not to politicise the corridor project issue," the Puri MLA told in a press conference.

Sarangi said that the ASI's stand has delayed the project which he has been supporting from the very beginning. "If it is not completed before monsoon, people of the pilgrim town would face a lot of problems in their daily activities due to the deep pits dug around the temple for construction of different facilities," he said.

He appealed to both the state and the Central governments to work in coordination with each other for completing the works before the rainy season.

Claiming that he was the first to raise the heritage corridor issue in the Assembly, the BJP leader said that a House Committee headed by the Speaker has been formed to look into the matter. Besides, the matter is under consideration of the Orissa High Court, he added.

The BJP MLA's statement was in contrast to senior BJP leaders such as Patra and Bhubaneswar MP

Patra, who unsuccessfully contested the Puri Lok Sabha seat in 2019, Wednesday charged the BJD administration with undertaking the heritage corridor project work in an "illegal" manner.

Aparajita Sarangi had also demanded that the work for the project be stopped immediately after the ASI informed the High Court that it had not given any permission to undertake construction work in the restricted zone of the temple.

Asked whether he was supporting the demolition of several mutts near the temple because of the project, the Puri MLA said, "What can I do if Mutt heads and others come forward to donate land for it?"

However, only two days ago, he had said that no one is happy with the heritage corridor project and all have parted their land for it "out of compulsion".

On May 11, Sarangi said that Prime Minister Narendra Modi should intervene in the contro-

Thursday, he demanded the project be completed soon. On his changing stance on the issue, Sarangi said, "I have replied according to

the questions of the media.' Sarangi claimed that several developmental projects have been taken up in Puri after he became the MLA and none of them, except the heritage project, faced op-

position from any quarter. A PIL claiming that construction work for the project has affected the health of the temple was filed in the high court which had ordered a joint inspection of the Jagannath temple by the ASI and the state government.

The state had informed the court that correspondences were exchanged between the Odisha government and the National Monuments Authority, which functions under the Union Ministry of Culture and is responsible for grant of permission for construction-related activity in the "prohibited and regulated" areas.

West Got It Wrong

The West responded to Russia's invasion of Ukraine with sanctions of unprecedented severity and scope. By the standard of proportionality, the reaction of the United States, the European Union, and their allies seems appropriate. Serious international aggression demands a serious response. But by the standards of consistency, efficiency, and fairness, it is far from clear that the West has chosen the correct strategy. Governments may need to rethink the design of the sanctions regime.

So far, Western commentary has focused on the strength of the punitive measures. These have targeted trade, by restricting exports of technology and imports of Russian oil and gas; finance, by preventing transactions by designated Russian banks; official assets, by freezing much of the Russian central bank's foreign-exchange reserves; foreign investment, by forcing Western firms to cease operations in Russia; and personal assets, by expropriating possessions of Russian oligarchs and officials.

Many have argued for even stronger sanctions. The EU, for example, is currently trying to reach consensus on phasing out imports of Russian oil by the end of 2022, on the grounds that payments for these supplies are funding the Kremlin's war machine. As Russia escalates its attacks on Ukraine, the West should probably ratchet up its response as well.

But policymakers must first answer a more fundamental question: Is the current sanctions strategy truly serving the West's interests, or are there better ways to achieve the same goal? In war, ends may overwhelm means. When the survival of the international

order itself is at stake, as it is now, it may seem as if ends are all that matter. But when the fighting in Ukraine eventually stops, the means that the West has employed will have conse-

quences. So, even in extremis, countries that uphold democracy and the rule of law must strive to adhere to certain principles. Forswearing expropriation should be a key

tenet, but the West violated it by effectively seizing Russian official foreign reserves, annulling claims on Western goods and services that Russia had legitimately acquired over time. Such retroactive confiscation is one of the worst kinds of expropriation.

The ramifications of this decision may not be visible today, but the damage will become apparent over time. Other countries might be less willing to hold reserves in US dollars or euros, or deal with US banks. And some large countries, such as China, might one day be tempted to apply the same measure against the US, citing the current expropriation as a precedent. More broadly, freezing Russia's foreign reserves has damaged trust in the very international system that the West aims to preserve.

True, the sanctions on Russian trade and financial activities are not retroactive. But they reflect a misdiagnosis.

The Western sanctions aim to inflict economic pain on Russia by depriving it of basic inputs and consumer goods. Russia is a classic commodity producer, with relatively limited manufacturing capacity. It exports oil and gas, while importing inputs to supply its factories and consumer goods to satisfy its population's needs. The sanctions are intended to curtail those imports, thereby reducing Russia's productive capacity and hence its abil-

But seeking to curb the ways in which Russia can accumulate hard currency is a remarkably indirect way of reducing the country's imports. There is a much more straightforward means of reaching this objective: restricting supplies from the West

Under this strategy, the West would continue to buy oil and gas from Russia, but would not provide any goods in return. Already, the US and the EU have banned exports of high-tech and dual-use products, which could be used by Russia's military. This list should be widened to encompass all exports. And diplomatic efforts should focus on expanding the number of countries participating in the export boycott. To ensure its legality, the World Trade Organisation's national-security exception should be invoked.

Of course, Russia would still accumulate dollars and euros, which it could use to pay for imports from other countries, such as China. But Russia would not find it easy to switch suppliers, because Europe, the US, and their allies currently account for more than 50% of the country's imports. For example, the French automaker Renault appears poised to offload its majority stake in Avtovaz, Russia's largest automobile producer, and to stop supplying it with parts and machinery. Redesigning the Lada manufacturer's cars and assembly lines will take time and resources, and in the meantime, production will grind to a halt.

Russia could of course respond by trying to import Western goods from third-country suppliers. But again, this would not be easy. The US has a system for monitoring such diversions, and has already warned other countries that it will "bring the full force of the law to hold accountable those that knowingly violate the new rules.

Russia might also consider responding by stopping its exports of oil and gas. But in the end, doing so would be far too dangerous to its strategic interest. After all, if it stopped accumulating foreign exchange, it would be unable to import anything at all, from any country.

Aside from efficiency, shifting to a supply-based sanctions strategy would have three other advantages. First, restricting exports to Russia - which account for only a small proportion of European and US exports and a smaller share of production – would reduce the costs of sanctions to the West and be far less disruptive to the global economy than ending energy

Second, an export-oriented approach would allocate the costs of sanctions more fairly. The burden would shift from European energy consumers to the far smaller number of Western firms exporting to Russia, which are much more able to absorb the costs.

Finally, restricting exports to Russia would result in fairer burden-sharing among the countries imposing sanctions. The current approach favours Germany at the expense of the US - but not in the obvious sense that Germany is still able to import gas from Russia. The reason is that German firms can continue to supply the Russian market, whereas the financial sanctions are undermining trust in US financial markets and banks, and in the US government itself.

The US has carried the load for Germany in order to deal with what is primarily a European problem. In effect, Germany has managed to invert former US Treasury Secretary John Connally's famous quip directed at Europe about the dollar being "our currency, but your problem." Dollar-related sanctions have become America's problem and Germany's solution.

Russia's illegal military action can and should be countered by an economic response that is principled, effective, fair, and legal. The West can achieve such a response by replacing its current sanctions with comprehensive and collective restrictions on exports of goods to Russia.



THE PLASTIC PANDEMIC

arge sections of the Indian subcontinent starting from Balochistan and Sindh in Pakistan all the way to Odisha and Bihar in eastern India are experiencing extreme heat. Such heat waves in India are expected to increase in duration and become three to four times more common in the future. This marker of climate catastrophe has not spared the Earth's poles, the Arctic and Antarctic regions are getting more heat than ever before, even though it is the beginning of winter in the south polar region. One of the most visible examples of this climate calamity and the havoc being caused to the planet is identified as plastic pollution, so much so that recently a majority of the world concentrated solely on plastic and adopted a resolution to

curb its spread. Heads of State, environment ministers and other representatives from 175 nations focussed on the threat of plastic and endorsed a historic resolution at the UN Environment Assembly in Nairobi in March this year to end plastic pollution. The resolution, based on three initial draft resolutions from various nations, addressed the full lifecycle of plastic, its production, design and disposal and established an Intergovernmental Negotiating Committee (INC) which will work on a legally binding instrument looking at diverse alternatives to address the problem of plastics. Also looked at will be the design of reusable, recyclable products and materials with international collaboration facilitating access to technology. In conjunction with the first session of the INC by this year end, the UN Environment Programme will convene a forum to share knowledge and best practices in different parts of the world.

Plastics have a strong relationship with climate change. They contribute about 3.8 per cent of global emissions, nearly double that of the aviation sector. In a fairly short period of time from 1907

to the present day, plastic has travelled from a wondrous discovery

to a poisonous reality. From local beaches to the distant Arctic, plastic products are choking the oceans and killing wildlife. The pervasiveness of the pollution caused by plastic, WWF says, is at a point where by 2050 there may be more plastic than fish in the ocean. More recently, there have been images of divers fishing up plastic masks dumped in the ocean, many of them single-use plastics, worn during the COVID pandemic. India has been identified at the helm of the top ten countries polluting the oceans with plastic. A recent study done by the UK-based packaging group RAJA (an amalgam of the founders' names Rachel Marcovici and Janine Rocher) found India to be the worst country for plastic waste in the oceans in 2020, with some 126.5 million kg of plastic per year being dumped. The weight of plastic waste dumped by India is equivalent to the weight of over 250 thousand bottlenose dolphins, one of the most commonly found dolphin species in the ocean. Despite the United States producing double the amount of India's plastic waste annually (42 billion kg), only 2.4 million kg of it ends up in the oceans. But this could be on account the US exporting its plastic waste to African or South East Asian countries.

The Indian government did admit to the country's part in the plastic problem saying India's plastic waste generation has more than doubled in the last five years with an average annual increase of 21.8 per cent. A frightening 79 per cent of the plastic produced the world over enters the environment as waste and a miniscule 9 In an earlier study published

per cent is all that is recycled. in the Science Journal, researchers quantified the amount of plastic entering oceans from the coastlines of 192 countries. Of the 275 million metric tonnes (MT) of plastic waste generated by 192 countries in 2010, nearly 8.8 million MT entered the world's oceans and seas. The study placed India (rank 12) in the list of top 20 disbursers of plastic waste into the high seas from their coastlines. China ranked first, followed by countries in Southeast Asia, South Asia and Africa, Sri Lanka and Bangladesh among them. "The top 20 countries, including India, account for 83 per cent of all the mismanaged waste available to enter the ocean, according to Dr Jenna Jambeck lead author of the study and professor of environmental engineering at the University of Georgia, US.

Though India holds a prominent position among plastic waste generators the country has not taken a strong position in the battle against polluting plastic. Although among the 175 countries that adopted end of plastic pollution resolution, India seemed to hold back stating that countries should be allowed to decide the actions to be taken voluntarily. India also said that amidst this push for reduction of plastic, developing countries should be allowed to set down their own goals in line with their development plans. This stand is in contrast with India's past efforts to bring the problem to the fore, especially in 2019 at the United Nations Environment Assembly.

While it is unclear how effective the move initiated in Nairobi will be, India must take a stronger role in curbing plastic waste especially as it is a frontline producer.

The collective push against plastic comes against a backdrop of conflict and geopolitical turmoil and can be showcased as "multilateral cooperation at its best," as President of the UN Environment Assembly and Norway's Minister for Climate and the Environment, Espen Barth Eide puts it. "Plastic pollution has grown into an epidemic. With today's resolution we are officially on track for a cure," says Eide. He and others from the participating nations classify the path-breaking resolution taken in Nairobi entitled "End Plastic Pollution: Towards an internationally legally binding instrument" as "historic" India must play a more central role in this historic effort.

Ecosystem restoration good for health

multiple, interlinked exis-L tential crises. The catastrophic consequences of climate change, ecological degradation, and biodiversity loss have cascading knock-on effects on human health and well-being. As the COVID-19 pandemic illustrates, ecosystem damage can contribute significantly to a global publichealth emergency. But scientists are also increasingly finding that ecological restoration, by reversing the threats to soil, biodiversity. water, and other ecosystem services, can deliver major health benefits.

There have been many attempts to understand the nexus between ecological degradation and human health. A recent study of over 6,800 ecosystems across six continents provided further evidence that deforestation and extinction of species will make pandemics more likely. Ecosystem damage also leads to water contamination, creating breeding grounds for infectious diseases. Similarly, soil degradation not only reduces agricultural productivity, but also has been linked to disease increased mortality.

The emergence and spread of zoonotic diseases like COVID-19 are closely associated with the health of ecosystems. For example, 75% of emerging infectious diseases are zoonotic, caused by unsustainable use of natural resources, factory farming of animals, and other industrial-scale anthropogenic factors. Ecosystem decline has also con-

tributed in recent decades to reduced immunological resilience on Ecosystem Restoration, run-Alliances and a sense of and an increase in allergic conditions in humans. The effects are not limited to physical health, but also include mental-health problems such as an increase in ecoanxiety, or fear of environmental damage due to ongoing ecosystem degradation. Conversely, restoring natural ecosystems could provide pathways for reversing some of the effects of climate change and ease the global chronic-disease burden, thus improving human health and well-being. One recent study showed that soil restoration and the reintroduction of native plant species led to a reduction in physical and psychological impacts of certain diseases. In another case, ecological restoration of an urban river in northwest England was linked to psychological benefits for surrounding communities.

There is also evidence that ecological restoration can protect people from extreme climate events and related public-health crises Finally, using alternative cooking fuels such as biogas in improved stoves, thereby reducing the need for fuelwood and helping to prevent forest degradation, has been shown to improve respiratory health and household diets.

Some prominent international efforts to reap the benefits of ecological restoration to planetary and human health are already underway. The United Nations Decade sustainability domains. ning from 2021 to 2030, and the land degradation neutrality programme of the UN Convention to Combat Desertification encourage signatory countries to recognise the central importance of ecological restoration. Likewise, the #HealthyRecovery initiative, signed by over 4.500 health professionals from 90 countries, urged G20 leaders to fund projects that enable ecological restoration as part of their pandemic stimulus packages.

In recent decades, researchers have developed various models - including the Mandala of Health, the Wheel of Fundamental Human Needs, and, more recently, the One Health approach - to capture the interconnected relationship between humans and nature. The challenge now is to develop a unifying framework to maximise the synergy of ecological restoration and human health. Policies designed to address one should not exclude the other.

We therefore need to redefine ecological degradation, understand its far-reaching effects on human health, and recognise that these effects cannot be fully addressed without structured, context-specific ecological restoration plans. Achieving this will require institutionalising and mainstreaming inter-sectoral collaboration between scientists and practitioners from the ecological, medical, and

ership among core governance structures of public health and ecosystem restoration will be crucial. In India, for example, a pioneering effort to mainstream crossdisciplinary initiatives is bringing together the government, scientists, and local partners and practitioners with the aim of improving zoonotic-disease control. Ecological restoration is a clear

and identifiable way to tackle the global disease burden and improve public health. As the UN Decade on Ecosystem Restoration commences, policymakers should encourage collective action to spur inclusive, interdisciplinary activities that demonstrate the positive global benefits of restoration for social, physical, and mental health. We owe it to ourselves and to the planet to mitigate at least some of the threats we have created.

Chintan Shivir begins today

In a bid to overcome internal challenges and electoral setbacks, the Congress' three-day conclave will focus on time-bound party restructuring for strengthening the organisation and evolving a strategy for future alliances

Udaipur, May 12: Facing the daunting task of revamping the party after a series of poll reverses, over 400 Congress leaders will go into a huddle at its 'Chintan Shivir' starting here Friday focusing on time-bound party restructuring, finding ways to combat politics of polarisation and getting battle-ready for upcoming electoral challenges.

Congress' chief spokesperson Randeep Surjewala said the 'Nav Sankalp Chintan Shivir' is also aimed at deliberating on challenges facing the country such as "freefall of the economy", increasing inequality of wealth, price rise of essential commodities, "deep-rooted conspiracy" to hand over farming sector to a select group of private corporates, "attack on India's territorial integrity by China, "attack" on rights of Dalits, SCs/STs, minorities and attempts to divide by using Hindu-Muslim rhetoric.

The Congress has chosen six subjects and constituted groups to examine and submit their primary reports on actionables for the same, he said.

These groups are political, social justice and empowerment, economy,



Congress organisation, Kisan and Khet Mazdoor and Youth. These groups will present their first impressions for a conclusive discussion during the 'Chintan Shivir' (brainstorming session).

The roadmap will provide a way forward not only to the Congress to meet up with the current set of "reverses and challenges", but will also pave the way for a resilient, strong and inclusive nation, he said. Sending out a clear message to critics within the organisation, Congress president Sonia Gandhi at a CWC meeting earlier this week cautioned ahead of the session that self-criticism is needed in party forums but it should not be done to erode selfconfidence and morale, as she asserted that it is time "to repay our debt to the party'

The issue of leadership in the Congress is not likely to be discussed at the Udaipur conclave, party sources said, even as several leaders at the shivir are likely to rake up the issue of Rahul Gandhi taking over the party leadership. Top Congress leaders will come out with solutions and clear the party's stance on key issues including polarisation, Centre-state ties, form-

ing of alliances and attempts at bringing in "uniformity", especially in the Northeast, that are confronting the country and the party, Congress sources said.

Unlike in the past, when 'Chintan Shivirs' did not set any set timelines, the Udaipur declaration will state timebound initiation and accomplishment of structural changes in the organisation at all levels - national, state, district and block levels.

The conclave will begin with introductory remarks of Congress chief Sonia Gandhi May 13 and a valedictory address by Rahul Gandhi May 15.

The shivir will begin Friday af ternoon following which over 400delegates will discuss subjectspecific issues across six groups.

These discussions will continue on the first and second day and the conclusions will be recorded in the form of a declaration, a draft of which will be discussed at the CWC meeting to be held there on the last day.

Rahul Gandhi and several other leaders would reach Udaipur by train in an overnight journey, while Sonia Gandhi would reach Udaipur May 13 by air.

Four CBI officers held, dismissed from service for fake C'garh raid

New Delhi, May 12: In the swiftest action against erring personnel, the CBI has dismissed its four officers under a stringent constitutional provision and arrested them after they were allegedly found involved in staging a raid on a company in Chandigarh to extort money, officials said Thursday.

The CBI received a complaint from a Chandigarh-based businessman on May 10 that six people, including four from the CBI, had entered into his office and threatened him of arrest on the charges of supporting and providing money to terrorists. They also claimed to have information regarding it.

"It was further alleged that the accused forcefully took the complainant in a car and demanded Rs 25 lakh from him," CBI Spokesperson R C Joshi said.

As part of its zero-tolerance policy towards corruption, CBI Director Subodh Kumar Jaiswal swung into action, looked into the matter and found prima facie involvement of his men in the embarrassing episode. Under Article 311, presidential pleasure stands withdrawn and a government official is dismissed from service. The accused - Sumit Gupta. Pradeep Rana, Ankur Kumar and Akash Ahlawat (all sub-inspectors at the CBI's Delhi-based units) -were taken into custody by the agency on Wednesday night and Thursday after registering a case against them under various sections of the Indian Penal Code, including 388 (extortion by threat of accusation of an offence), under which the minimum sentence is 10-vear imprisonment and the maximum is life imprisonment.

WHO must be reformed: Modi

India has been pressing for the TRIPS waiver to ensure scaling up of the vaccine production for equitable and global access

New Delhi, May 12: Prime Minister Narendra Modi Thursday called for reforming the World Health Organisation (WHO) and streamlining its approval process for vaccines and therapeutics, and favoured making flexible the WTO's rules relating to trade-related aspects of intellectual property rights (TRIPS).

In his address at the second global

virtual summit on COVID-19 hosted by US President Joe Biden, Modi also said that a coordinated global response is required to combat future health emergencies and called for building a resilient global supply chain for equitable access to vaccines and medicines. Modi said the World Health Organisation must be reformed and strengthened to build a more resilient global health security architecture. The Prime Minister's call for making flexible rules of the WTO, particularly the TRIPS, came over a year-andhalf after India and South Africa placed a proposal at the World Trade Organization (WTO) to temporarily waive intellectual property rights for producing Covid-19 vaccines to effectively deal with the pandemic.

"It is clear that a coordinated global response is required to combat future health emergencies. We must build a resilient global supply chain and enable equitable access to vaccines and medicines,' Modi said. "The WTO rules, particularly TRIPS, need to be more flexible. WHO must be reformed and strengthened to build a more resilient global health security architecture," he said in the opening session of the summit. "We



also call for streamlining WHO's approval process for vaccines and therapeutics to keep supply chains stable and predictable. As a responsible member of the global community, India is ready to play a key role in these efforts," Modi said. In his address, the prime minister also spoke about how India's Genomics Consortium has contributed significantly to the global database on the virus and added that New Delhi will extend this network to countries in its neighbourhood. Referring to India's handling of the pandemic, Modi said the country has fully vaccinated almost 90 per cent of the adult population and more than 50 million children. Modi participated in the first global virtual summit on COVID-19 hosted by Biden on September 22 last year as well.

The second summit intends to galvanize new actions to address the continued challenges of the pandemic and build a stronger global health security architecture.President Biden, Vice President Kamala Harris, Canadian Prime Minister Justin Trudeau and South African President Cyril Ramaphosa were among the key leaders who addressed the summit.

The judge rejected the application for replacing advocate commissioner Ajay Kumar Mishra and also appointed Vishal Singh as special advocate commissioner and Ajay Pratap Singh as assistant advocate commissioner.

Sc refuses to grant interim relief on pleas seeking stay

New Delhi, May 12: The Supreme Court Thursday declined to grant interim relief to petitioners challenging the amendments to LIC Act by Finance Act of 2021, which facilitated the LIC IPO.

A bench headed by Justice DY Chandrachud said: "We are of the view that no case of interim relief has been made out. No interim relief granted." The top court declined to interfere with the LIC IPO process

"In matters of IPO, the court will be reluctant in granting interim relief. It is about investments", said the bench also comprising Justices Surya Kant and P.S. Narasimha. New computer model can help assess Covid impact

New Delhi, May 12: Scientists have developed an ultra-large scale computerised model of 1 million to 100 million individuals, closely representative of the Indian population, that they say can help assess the impact and progression of an infectious disease, including Covid-19, at the most granular level.


The synthetic population model termed BharatSIM has been developed by using data from sources such as the National Sample Survey Office (NSSO) surveys and Census.

Developed by researchers at Ashoka University in Sonipat, Haryana in collaboration with global technology company Thoughtworks, the tool is also being used to make predictions on Covid-19. It also allows adding interventions like lockdowns, levels of vaccine coverage to determine the effects of the disease.

The scientists said the model would be made available with open access, helping governments, NGOs, and researchers to test interventions and outcomes through these simulations, they said.

"BharatSIM allows us to assess the impact of a pandemic of infectious disease at the most granular level, since the basic unit there is the individual person," said Gautam Menon, Professor of Physics and Biology at Ashoka University.

"Imagine a map of India with lots of individuals moving around on it, like a strategy game. These individuals are not all the same; each has been constructed carefully using machine learning techniques



ily, a workplace, and demographic

characteristics," Menon told PTI. These are developed based on a combination of various large-scale surveys such as the Census, India Human Development Survey (IHDS), etc.

Because each individual is modelled while maintaining the statistical properties of the population, this allows for the differential impact of the disease at different ages, the effects of co-morbidities in increasing the risk of an adverse outcome and so on, the researchers said.

Using the model, the researchers can also explore different scenarios, such as the impact of interThe synthetic population model has been termed BharatSIM

ventions, including lockdowns and school closures.

"The model incorporates geographical information as well, therefore we can look at the impact of the disease in different areas, such as wards in a city," added Debayan Gupta, Assistant Professor of Computer Science at Ashoka University.

"The model uses high-performance computing infrastructure to run these large-scale simulations on cities and states with their realsize population. Although, our simulation engine is also efficient enough to simulate mid-range cities easily even on a run-of-the-mill laptop," Gupta told PTI.

The outputs of the system are fed into a "visualisation engine", which helps quickly analyse and gain insight into what would otherwise be a huge quagmire of data. Combined, the researchers hope that it will prove to be a powerful aid to understand various what-if scenarios

with extreme granularity. All prior disease models for Covid-19 in India are based on what are called 'compartmental' descriptions which make specific assumptions about how people interact with each other in spreading the disease.

Taj Mahal in communal cauldron

A LEGAL SUIT IN THE **LUCKNOW BENCH OF** THE ALLAHABAD HC, DEMANDING **OPENING OF THE 20 ODD SEALED CHAMBERS IN THE** TAJ, HAS OPENED A PANDORA'S BOX

Agra, May 12: It is not the first time that the 17th century monument of love, the Taj Mahal has been caught in communal cross fire that shows no signs of early abatement.

The current phase was triggered by the visit, a fortnight ago, by a Hindu seer who was prevented from entering the world heritage monument, ostensibly due to the religious symbols he was carrying. This provoked a backlash from the local Hindutva outfits to raise war cries.

Ever since historian PN Oak in his controversial book 'Taj Mahal, the True Story', essayed to establish that the Taj was indeed a Hindu temple built by Rajput kings, there have been periodic demands to allow research and extensive investigations to explore the truth in various claims. Till about three decades, the Taj Mahal was considered a secular monument, but then some minority groups claimed it was their property. Later, a planned process of communalisation of the monument began, with increasing presence of the

Muslims, a local historian recalled.

After events in 1992 and later, the Hindutva groups retaliated by offering 'pujas' and performing 'aarti' of the imaginary Shiva temple from outside the monument.

Tourism bodies in Agra have been consistently expressing concern over the continuing tug of war between the Hindutva and Muslim groups over conducting 'puja-aarti' and offering 'namaz' inside the Taj Mahal premises. The length of the ceremonial 'chadar' offered during the annual Shah Jahan Urs, has also continued to lengthen each year from a few me-

tres to over a thousand metres. The fear of communal flare up could impact tourism, the industry leaders fear Sometimes, it is 'namaz'. other times it is 'puja' and 'aarti' with sprinkling of Ganga Jal by a variety of outfits from Bajrang Dal to Shiv Sena and so on. Now a legal suit in the Lucknow bench of the high court, demanding opening of the 20 odd sealed chambers, has opened

a Pandora's box The Archaeological Survey of India (ASI) sealed the chambers and blocked the staircases leading to pathways in the basements, more than three decades ago. While officials claim periodic repairs and maintenance work are undertaken in the basement, conservationists fear that the underground chambers may not have been opened for a significantly long time to avoid brewing controversies relating to its original ownership.

Local historians are more concerned with the safety of the monument that attracts millions of tourists round the year. If the sealed chambers are opened for public view, it would be possible to undertake conservational work, if required, as there were unconfirmed reports of minor cracks and termite colonies in some parts of the foundation. "We need to be assured that all is well with the foundation which could be affected by the toxic and polluted water of the river Yamuna,' said a conservationist.

Allahabad HC junks petition

Lucknow: The Allahabad High Court's Lucknow bench Thursday dismissed the petition seeking opening of 22 rooms in the Taj Mahal premises. The two-judge bench ripped into the petitioner who sought opening of the 22 locked rooms, stating that the truth about the iconic monument needs to come out, and that he has filed multiple PILs for the same. "Tomorrow you will ask for permission to see our chambers. Please, don't make mockery of the PIL system," the bench said during the hearing. The writ petition, seeking to "find the truth" behind the 22 locked rooms in the Taj Mahal, was filed last week before the Lucknow bench by Rajneesh Singh, who is the media in-charge of the BJP's Ayodhya unit. The petition cited the claims of some historians and Hindu groups about the mausoleum actually being an old Shiva temple. The petition has sought the Archaeological Survey of India form a special committee to examine the locked rooms and release the report to the public. "What judgment do you want us to pronounce? Who built the Taj Mahal? Don't go into historical facts... Mandamus can only be issued when rights have been infringed. What rights of yours have been infringed?" the bench asked.

Irulas held as bonded labour in TN brick kiln



Chennai, May 12: In Tamil Nadu, the Hosur RDO has commenced an investigation into the complaint received by the Krishnagiri District Collector that 10 Irulas are being held as bonded labour in a brick kiln in the district.

The complaint was made by an Irula person who is working in the kiln for the past year along with his family.

Sakappan (37), an Irula tribal member from Perunkaadu near Marandahalli in Dharmapuri district in his petition to the district collector, said that he and his family along with another family were working as bonded labourers in a brick kiln at Denkanikottai. He said that the families were working for the past one year in the kiln and they were ten people in total.

The Irula tribe member said that they had taken Rs 75,000 for each family from the brick kiln owner and that they are being harassed by

the owner of the brick kiln.

He also said that he, his wife and two children were working in the kiln and there was another family of one Shakthivel. In the petition to the district collector, he said that Sakhivel's two-year-old daughter died after being electrocuted in the kiln.

The office of the Hosur RDO when contacted informed IANS that the investigation is on and that a team of officials will be visiting the brick kiln and taking a statement from the complainant and necessary action if required.

The Krishnagiri District Collector's office also said that there will be stringent action against anyone who is indulging in bonded labour and brick kiln employment without a proper license.

While in some areas of the state the Irula community are trying to wriggle out of years of slavery, in some other areas of the state, the community is living in difficult circumstances including working as bonded labourers.

Higher judiciary should reflect cooperative federalism: Stalin

Chennai, May 12: Tamil Nadu Chief Minister MK Stalin has urged Prime Minister Narendra Modi and Chief Justice of India NV Ramana to ensure that the judiciary also reflect the spirit of Co-operative Federalism enshrined in our Constitution Stalin in a letter to Modi and

Ramana said certain important aspects relating to the higher judiciary - like setting up of regional benches of the apex court, having judicial diversity and proportional representation of the states in judicial bench and the use of Tamil as the official language of the Madras High Court - needs to be addressed early.

Referring to the appointments of judges of High Court and Supreme Court, Stalin said it should reflect the diverse and pluralistic society of India. "For the past few years." we have been witnessing declining representation from all the sections of the society in the higher judiciary, leading to a 'diversity deficit', Stalin said.

A broad based, heterogeneous group of judges representing various sections of the society as a whole alone can reflect the views and values of society as a whole, particularly on issues involving historical, traditional, linguistic and cultural matters, he said.



According to Stalin, all the states must find proportional representation on the Bench of the Supreme Court. The Chief Minister said establishment of Permanent Regional Benches of the Supreme Court is another issue that would reflect the federal character of India

Considering the fact that the Supreme Court is located at New Delhi (which is not equidistant to all parts of the country) and is far away from many states, particularly the Southern, South Western & Eastern States, the citizens in these states are deprived of their fundamental right to approach the Court Stalin said

While there are 25 High Courts across the nation, it is seen from data that the number of appeals being filed in the Supreme Court is more from States around the NCR region than States located further away from Delhi, Stalin added.

He said the Constituent Assembly Debates show that even the framers of the Constitution, as early as 1950, recognised that the Supreme Court would need to have branches in other parts of the country as the nation grows. That is why in Article 130, the Constitution permits the Court to sit in other places in the country

'Therefore, I request you to take appropriate steps to establish Permanent Regional Benches of the Supreme Court in New Delhi Chennai, Kolkata and Mumbai. apart from the Constitution Bench in New Delhi, so that the citizens in other parts of this vast country have equal access to the Supreme Court," Stalin said.

Recalling Ramana's words judicial proceedings cannot be like chanting of mantras in a wedding that nobody understands at a function held here, Stalin said making law and justice comprehensible to the common man in its proceedings is essential in the

justice delivery system. In four High Courts - Rajasthan, Madhva Pradesh, Uttar Pradesh and Bihar. Hindi has been authorised as the official language in addition to English. One therefore wonders what impediment is there to make the official language of other states the official language of the High Court in addition to English, Stalin said.

According to Rosatom, the group company has manufactured four guide vanes for reactor coolant pump set (RCPS) housings for

Unit 5 with a generation capacity

The Russian nuclear power major said RCPS housing is a first safety class item. At a nuclear plant, it ensures coolant circulation in the primary circuit and operates under pressure of 160 atmospheres and temperature of 300 degrees.

The reactor plant equipment of one power unit includes four RCPS. Each guide vanes consists of upper and lower discs, between



which 13 guide blades are welded. The vanes are fixed in the pump

housing and designed to direct coolant flow inside the pump, Rosatom said.

India's atomic power plant operator Nuclear Power Corporation of India Ltd (NPCIL) has two 1,000 MW plants (Units 1 and 2) at Kudankulam, while four more (Units 3, 4, 5 and 6) are under construction.

All the six units are built with Russian technology and equipment supplied by Rosatom.

Low yield will make 'Aam' turn 'Khaas' BJP to get more RS seats from UP

Lucknow, May 12: 'Aam' is going to turn 'khaas' for the second consecutive year since the yield is much lesser than expected.

Mango growers in Malihabad on the outskirts of Lucknow say that the extreme temperatures in April have taken a toll on all varieties of mangoes

More than 20 per cent of the fruit has been lost due to the temperature that started rising in March and continued in April, said Insram Ali, President of All India

Mango Growers Association. Naseem Baig, President of the



Malihabad Phal Mandi Samiti, said. "This was not what we had expected. The flowering known as 'baur' got destroyed due to heat. The high temperature and scorching heat have not only impacted Dussehri but also the late maturing varieties like Chausa, Langda, Safeda and Lakhnauva, all of which

are also high on export demand." Baig added, When the baur itself gets destroyed it does not leave much for the growers for damage

The saving grace, however, is

the quality of the fruit which is expected to be better because the yield is low.

Since less yield means more nutrition for the surviving fruits, Dussehri is expected to be sweeter, juicier and bigger in size and of course, more expensive too, said Salim, another mango grower.

Dussehri is expected to hit the market by the end of May or beginning of June and the price will be decided after the harvest and assessment of quality.

A mango tree yields a good quan-

tity of fruit every alternate year. Going by its cycle, Malihabad mango belt is in its 'off-year' and this has reduced the number of panicles already.

The onslaught of heat rendered

another blow to the mango crop. Mango crops are sensitive to weather changes during the flowering stage. Weather conditions affect the emergence of panicles (baur) which is the very first stage of the crop and usually happens in

This year, even the winters were quite harsh and extended and this made the panicles emerge very late in mid-February.

Uttar Pradesh has at least four lakh hectare under mango cultivation in north and central parts of the state.

It is the second largest mango producing state after Andhra Pradesh.

"Since the past two years, we have suffered huge losses because imports were impacted due to the pandemic and its restrictions. This year we hoped for a bumper crop but the weather has dashed out hopes," said Insram Ali.



However, the official announcement regarding the exact date would be made around May



15 when the IMD issues its second stage South-West Monsoon

"Fairly widespread to widespread light/moderate rainfall is very

likely over Andaman and Nicobar Islands during the next five days. Isolated heavy rainfall is very likely over the region between May 14-16 even as squally weather with wind

The early onset of monsoon could bring cheer as most parts of the country witnessed extremely high temperatures over the past fortnight

Southwest Monsoon - considered the real Finance Minister of India - has a wide ranging impact on India's economy with agriculture, economy, trade, travel, almost everything decided by the rainfall quantum and timing.

T'gana man rapes tribal woman even after her death

Hyderabad, May 12: In a horrific incident, a man raped a tribal woman even after she died while resisting his sexual assault.

A construction worker committed the heinous crime at Choutuppal near Hyderabad Monday night but was arrested by police Wednesday.

According to police, E Harish Goud raped and brutally killed the 28-year-old tribal woman working in a brick kiln warehouse at Choutuppal in Yadadri Bhuvanagiri district, about 40 km from Hyderabad

Finding the victim alone in the warehouse, the accused sought sexual favours. When she refused and threatened to reveal this to her husband, he tried to sexually assault her. As she resisted, he hit her on the face with a log, resulting in bleeding injury. Police investigations revealed that though the victim succumbed to the assault, he still raped her. After committing the act, he robbed the silver articles she was wearing and escaped. The 25-yearold has been booked for rape, robbery and murder. Chouttuppal police registered a case under various sections of the Indian Penal Code (IPC) and the SC/ST (Prevention of Atrocities) Act.

Booster norms relaxed for overseas travellers

New Delhi, May 12: Relaxing norms for Covid vaccine precaution dose, the Centre Thursday allowed citizens travelling overseas to get the shot before the stipulated ninemonth waiting period as required by the guidelines of the destination

The Union Health Ministry's de-

cision to relax the norms about the precaution dose for overseas travellers was based on recommendations by the National Technical Advisory Group on Immunisation (NTAGI). "Indian citizens and students travelling overseas can now take the

precaution dose as required by the guidelines of the destination country. This new facility will be available soon on the CoWIN portal," Union Health Minister Mansukh Mandaviya said in a tweet. The advisory panel last week

had recommended that those who need to travel overseas can take the precaution dose of Covid vaccine as required by the country they are travelling to before the mandatory nine-month gap.

Currently, all those above 18 years who have completed nine months after the second dose are eligible for the precaution jab.

The ministry had received several representations seeking the precaution dose of Covid vaccine for those who have to travel abroad for employment, business commitments, admission to foreign educational institutes, participating in sports events, and bilateral and multilateral meetings as part of India's official delegation

Copenhagen (Denmark): Denmark's top prosecuting authority Thursday said it would seek to have a former defence minister's parliamentary immunity lifted so he could be charged with illegally disclosing "highly classified information". The office of the director of public prosecutions said it would contact Denmark's parliament, the Folketing, regarding the immunity of Claus Hjort Frederiksen. He served as the country's defence minister from November 2016 to June 2019.

Pak PM meets Nawaz in London

Islamabad: Pakistan Prime Minister Shehbaz Sharif has met his elder brother and former premier Nawaz Sharif in London and briefed him on key political, economic and administrative issues facing the cash-strapped country Shehbaz, accompanied by a group of senior leaders of his Pakistan Muslim League-Nawaz (PML-N) party, travelled to London on a private trip Wednesday. The meeting would approve a strategy to steer the country out of economic and constitutional crises.

22 get 5-year jail term each

Lahore: A Pakistani Anti-Terrorism Court (ATC) has sentenced at least 22 accused to five years of imprisonment each for allegedly attacking a Hindu temple in Puniab province in 2021. In July 2021, miscreants allegedly attacked the Ganesh temple at Bhong city of Rahim Yar Khan district in Punjab province with sticks, bamboos and weapons. The angry mob allegedly assaulted the security guard, damaged idols, walls, doors and electric fittings and set part of the temple ablaze. desecrating the holy Hindu temple.

Colombo, May 12: A Sri Lankan court Thursday imposed a ban on overseas travel on former Prime Minister Mahinda Rajapaksa, his son and MP Namal Rajapaksa and 15 others in view of investigations against them for the deadly attack on peaceful anti-government protesters in Colombo this week.

The Fort Magistrate's Court asked them to surrender their passports to the court due to the investigations taking place on the attacks on the GotaGoGama and MynaGoGama peaceful protest sites on Monday. At least nine people were killed and over 300 others injured in the violence.

The magisterial order came as a response to a request by the police's criminal investigation division who are conducting the investigations into the Monday's violence. The court issued the bans on 13 legislators representing the ruling Sri Lanka Podujana Peramuna (SLPP), including Johnston Fernando, Sanath Nishantha, Pavithra Wanniarachchi, C B Ratnayake, and Sanjeewa Edirimanne. Senior Deputy Inspector General (SDIG) of the Western Province Deshabandu Tennakoon is also in the list of people who need to remain in the country for investigations

The group was accused of bru-

tacked the protesters who had been for weeks demanding the resignation of the Rajapaksas, blaming them for the country's worst economic crisis.

A number of government MPs homes and offices were torched by enraged mobs around the country Monday and Tuesday, in a wave of spontaneous violence that was triggered by the attack on antigovernment protestors by supporters of Mahinda Rajapaksa.

Mahinda Rajapaksa resigned a few hours later and a curfew was imposed across the country. Mahinda Rajapaksa, known for his brutal military campaign against the Liberation Tigers of Tamil Eelam (LTTE) during his presidency from 2005 to 2015, saw his private residence set on fire on Monday. He, along with his wife and family, fled his official residence - Temple Trees - and took shelter at the naval base in Trincomalee after a series of deadly attacks on his supporters.

In a late-night televised address to the nation on Wednesday, President Gotabaya Rajapaksa said action would be taken against the instigators of Monday's "incident". Sri Lanka is facing its worst economic crisis since gaining independence from Britain in 1948. The crisis is caused in part by a lack of foreign currency, which has meant that the country cannot afford to pay for imports of staple foods and fuel, leading to acute shortages and very high prices.

Plane catches fire; 40 hurt

Beijing, May 12: Over 40 people were injured when a passenger plane of China's Tibet Airlines with 113 passengers and nine crew onboard veered off the runway and caught fire while taking off in the country's southwest Chongqing city on Thursday, the second major aviation accident in the country in two months.

All the 122 people aboard the Tibet Airlines flight TV9833 from Chongqing to Nyingchi in the Tibet Autonomous Region have been safely evacuated, the Civil Aviation Administration of China (CAAC) said. The Airbus A319-100 had been in service with the airline for nineand-a-half years, according to the Hong Kong-based South China Morning Post.



The plane bursts into flames after skidding off the runway at the Chongqing airport. Over 40 people who suffered bruising and sprains during the evacuation were taken to a nearby hospital. The crew members aborted the take-off after discovering an anomaly in the Airbus A319 aircraft. The plane caught fire on the left side of its nose after veering off the runway.

All people aboard the plane were evacuated and the injured were rushed to the hospital for treatment. Currently, one runway of the Chongqing Jiangbei International Airport has been closed and the other two are operational, staterun Xinhua news agency reported.

N Korea fires missiles amid 1st virus outbreak

Seoul, May 12: North Korea fired three short-range ballistic missiles toward the sea Thursday. South Korea's military said, in the latest of a series of weapons demonstrations this year that came just hours after it confirmed its first case of the coronavirus since the pandemic began.

The launches could underscore North Korea's determination to press ahead with its efforts to expand its arsenal despite the virus outbreak to rally support behind the leader, Kim Jong Un, and keep up pressure on its rivals amid longdormant nuclear diplomacy.

South Korea's Joint Chiefs of Staff said in a statement the three missiles launched from the North's capital region Thursday afternoon flew toward the waters off the country's eastern coast. It said South Korea's military has boosted its readiness and surveillance while maintaining close coordination with the United States.

Japan also detected the North Korean launches. Japanese Prime Minister Fumio Kishida instructed officials to do their utmost to analyze the launch, ensure safety of aircraft and vessels in the area and take precaution and readiness for any possible emergencies, according to his office.

The Japanese coast guard said



that a possible ballistic missile from North Korea was believed to have landed at sea. It urged vessels around the Japanese coasts to watch out for falling objects and report them to the authorities.

Earlier Thursday, North Korean state media confirmed the country's first COVID-19 infections as Kim ordered nationwide lockdowns to slow the spread of the virus. Kim also ordered officials to bolster the country's defense posture to avoid any security vacuum.

In recent months, North Korea has test-launched a spate of missiles in what experts call an attempt to modernize its weapons and pressure the United States and its allies into accepting it as a nuclear state and relax sanctions on the North. Some observers say that despite the elevated anti-virus steps, North Korea would likely continue its weapons tests to try to boost pub lic morale at home and strengthen loyalty toward the Kim leadership.

Thursday's launches were the North's first weapons fired since the inauguration of new conservative South Korean President Yoon Suk Yeol Tuesday. Yoon's office said his national security adviser Kim Sunghan was planning to convene a meeting to discuss the launches.

North Korea has a history of rattling new governments in Seoul and Washington in an apparent bid to boost its bargaining chips in future negotiations.

UK 'partygate' probe: Over 100 fines issued

London, May 12: Scotland Yard Thursday said that it had issued over 100 fixed penalty notice fines for COVID-19 lockdown breaches at UK government offices as part of its ongoing investigation into the so-called partygate scandal.

The Metropolitan Police had previously confirmed 50 fines, including one each issued to Prime Minister Boris Johnson, his wife Carrie Johnson and Chancellor Rishi Sunak for attending a birthday party for the British prime minister at the Cabinet Room in 10 Downing Street in June 2020.

The force's Operation Hillman inquiry into these illegal gatherings has been ongoing, which has now resulted in a further 50 fines."Operation Hillman, the investigation into breaches of COVID-19 regulations in Whitehall and Downing Street, has made more than 100 referrals for fixed penalty notices (FPNs) to the ACRO Criminal Records Office," the Met Police said in a statement.

"These referrals have continued to be made throughout the period since our last update on Tuesday 12 April and the investigation remains live," it said.

First image of giant black hole at heart of Milky Way revealed

Geneva, May 12: Astronomers unveiled the first image of the supermassive black hole lurking at the centre of our own Milky Way galaxy which is four million

times more massive than the Sun, terming it a "gentle giant" while announcing the breakthrough

The finding, published in The Astrophysical Journal Letters, greatly improves our understanding of what happens at the very centre of our galaxy and offers new insights into how these giant black holes interact with their surroundings The image shows a fuzzy glow-

ing ring of red, yellow, and white surrounding a darker center. The picture of the black hole known as Sagittarius A* (Sgr A*) -- only the second one ever to be imaged -was produced by a global research team called the Event Horizon Telescope (EHT) Collaboration, using observations from a worldwide network of radio telescopes.

"It is the first direct image of the gentle giant in the center of our galaxy," said Feryal Ozel, an as-



tronomer at the University of Arizona during a news conference in Washington."This image shows a bright ring surrounding the darkness, the telltale sign of the shadow of the black hole," Ozel said.

Black holes are regions of space where the pull of gravity is so intense that nothing can escape it, including light. The EHT achievement follows the collaboration's 2019 release of the first image of a black hole, called M87*, at the centre of the more distant Messier 87

The two black holes look remarkably similar, even though our galaxy's black hole is more than a

thousand times smaller and less massive than M87*.

'We have two completely different types of galaxies and two very different black hole masses, but close to the edge of these black holes they look amazingly similar," said Sera Markoff, Co-Chair of the EHT Science Council and a professor of theoretical astrophysics at the University of

Amsterdam, the Netherlands. This tells us that General Relativity governs these objects up close, and any differences we see further away must be due to differences in the material that surrounds the black holes," Markoff said. The finding was unveiled during simultaneous press conferences around the world, including at the European Southern Observatory (ESO) headquarters in Germany

The image is a long-anticipated look at the massive object that sits at the very centre of our galaxy. Scientists had previously seen stars orbiting around something invisible, compact, and very massive at the centre of the Milky Way.

This strongly suggested that this object — known as Sagittarius A*(Sgr A*) is a black hole, and the image provides the first direct visual evidence of it. Although we cannot see the black hole itself, because it is completely dark, glowing gas around it reveals a tell-tale signature: a dark central region (called a shadow) surrounded by a bright ring-like structure.



The company had posted a consolidated net loss of ₹7,585.34 crore in the same period last fiscal, Tata Motors said in a regulatory filing. Total consolidated revenue from operations stood at ₹78,439.06 crore in the fourth quarter as against ₹88,627.90 crore in the year-ago period, it added.

PNB shares dip 14% after Q4 earnings

New Delhi: Shares of Puniab National Bank (PNB) Thursday tumbled nearly 14 per cent after the company reported over 60 per cent decline in standalone net profit for the quarter ended March 2022. The stock tanked 13.60 per cent to end at ₹28.60 apiece on the BSE. During the day, it tumbled 13.89 per cent to its 52-week low of ₹28.50. On the NSE, it plummeted 12.53 per cent to settle at ₹28.95 apiece. In volume terms, 171.82 lakh shares were traded on the BSE and over 20.34 crore shares on the NSE during the day.

L&T Q4 consolidated PAT rises 10% YoY

Mumbai: India's largest infrastructure company Larsen & Toubro Limited May 12 reported a 10 percent yearon-year rise in consolidated net profit at ₹3,621 crore, which was below analysts' expectations. The infrastructure giant's consolidated revenue from operations rose 10 percent on-year to ₹52,851 crore for the reported quarter, missing analysts' expectations.



Bitcoin's 2021 gains wiped out in stablecoin rout

The digital currencies continued to bleed Thursday, thanks to multiple factors. The unstable algorithms of stablecoins are hurting the crypto market sentiments, while the US

dollar-pegged tokens are getting depegged and dragging the market lower

Hong Kong, May 12: Cryptocurrencies extended their sell-off Thursday, with Bitcoin falling to its lowest levels in 16 months as a stampede out of socalled stablecoins sent shockwaves around broader markets.

The latest blow to Bitcoin and its smaller rival Ether, which has shed more than half its market value so far this year, came from a meltdown this week in TerraUSD, also one of the world's biggest cryptocurrencies

Bitcoin dropped to a low of \$25,401.05, its lowest level since Dec 28, 2020. In the past eight sessions, it has lost a third of its value, or \$13,000, and is down more than 45% so far this year. From a peak of \$69,000 in November 2021, it has lost nearly two-thirds of its value.

TerraUSD, also known as "UST", slipped below its 1:1 peg to the dollar this week, roiling cryptocurrency markets already under pressure alongside tumbling stock markets.



The Terra incident is causing an industry-based panic, as Terra is the world's third-biggest stable coin. But TerraUSD couldn't hold its promise to maintain a stable value in terms of US dollars

"The collapse of the Peg in TerraUSD has had some nasty and predictable spillovers. We have seen broad liquidation in BTC, ETH and most ALT coins," said Richard Usher, head of OTC trading at BCB Group, adding that the moves are reminiscent of the bank runs during the 2008 financial crisis.

Stablecoins are digital tokens pegged to the value of traditional assets, such as the US dollar. They are popular in times of turmoil in crypto markets and are often used by traders to move funds around and speculate on other cryptocurrencies. Thursday, TerraUSD was quoted

around 50 cents, according to CoinGecko price data.

Unlike most stablecoins which are backed by reserves. TerraUSD is an algorithmic, or "decentral-

ized", stablecoin. It was supposed to maintain its peg via a complex mechanism which involved swapping it with another free-floating token. But even reserve-backed stablecoins, which say they have sufficient assets to maintain their pegs, were showing signs of stress Thursday.

Major stablecoin Tether slipped below its dollar peg, hitting as low as 98 cents Thursday, according to CoinGecko. USD Coin was trading at around \$1.04 while Binance USD was at \$1.07 - a significant breakout of its usual range.

Market players are still assess ing the fallout of the collapse of TerraUSD to identify whether major companies or investors have been badly hurt. That would be a possible clue to wider contagion.

TerraUSD: Plunging value of \$-linked crypto sparks panic

Paris: A cryptocurrency whose value is supposed to be pegged to the dollar has lost half its value this week, sparking panic in the already febrile world of crypto assets. TerraUSD, which is supposed to track at roughly \$1 per coin, at one stage was trading at 30 cents Wednesday before recovering to around 50 cents, according to the CoinGecko website. So-called stablecoins like terra are meant to be less volatile than cryptocurrencies such as bitcoin or ethereum. Their peg to traditional currencies is meant to offer investors more certainty and security. But terra and several other stablecoins are not backed by any revenue streams, instead relying on algorithms to rapidly move funds between cryptocurrencies as they rise and fall in value. The coin's founder Do Kwon said on Twitter Tuesday he was about to present a recovery plan. But terra continued to crash, perhaps caught up in a broader sell-off of cryptocurrencies

TerraUSD investors lose life savings

The dramatic crash of TerraUSD, ranked among the top 10 most valuable cryptocurrencies, has wreaked havoc in the lives of investors who are feared they will become homeless after the crypto mayhem. "I lost all my life savings. Had bought Luna at \$85, not sure what to do," wrote a Terra investor on Reddit community forum. Another investor lost \$15,000 after failing to sell it when it was trading above \$100 last month. "I got greedy hoping to get more money so I can at least afford a down payment for a house for my family. I guess no house and savings then," the user posted. Another user on the Reddit forum posted that, "I lost over \$450,000, I cannot pay the bank", while another said, "I will lose my home soon. I'll become homeless.'

Mumbai, May 12: The Sensex nosedived over 1,150 points while the Nifty crashed below the 16,000level on Thursday, extending their losing streak to the fifth straight session, as world markets were unnerved by elevated US inflation which triggered concerns of accelerated rate hikes.

The forex market too bore the brunt of heightened risk aversion, with the rupee plunging to a fresh lifetime low of 77.63 per US dollar intra-day amid foreign capital outflows. The 30-share BSE Sensex tumbled 1,158.08 points or 2.14 per cent to finish at an over two-month low of 52,930.31. Similarly, the broader NSE Nifty tanked 359.10 points or 2.22 per cent to 15,808. Barring Wipro, all Sensex constituents finished in the red.

IndusInd Bank lost 5.82 per cent, followed by Tata Steel, Bajaj Finance, Bajaj Finserv, Axis Bank, HDFC Bank, HDFC, Titan and L&T. In value terms, HDFC twins and Reliance Industries were the top drags on the benchmark.

RUPEE SLUMPS TO NEW ALL-TIME LOW

The rupee plunged by 25 paise to close at its lifetime low of 77.50 against the US currency Thursday as the dollar touched a fresh two-decade high in global markets on strong risk-averse sentiment and a higher-thanexpected US inflation triggered fears of aggressive rate hikes. The local currency also touched its record intra-day low of 77.63 to a dollar as losses in domestic stocks, concerns over weak growth, and persistent forex outflows negated the impact of a fall in crude oil prices. At the interhank forex market, the rupee opened steeply lower at 77.52 against the greenback and moved in a range of 77.36 to 77.63 in the day trade. The rupee finally ended at 77.50, down by 25 paise over its previous close of 77.25, cutting short its twoday winning run. Previously, the domestic unit had closed at the record low of 77.44 against the greenback May 9.



tion, the RBI in a surprise move raised the repo rate by 40 basis points to 4.40 per cent last week. Inflation has remained above the RBI's comfort zone of 6 per cent for four months in a row mainly due to the Russia-Ukraine war which has impacted the prices of commodities across the globe.

The previous high in the consumer price index (CPI)-based retail inflation was recorded at 8.33 per cent in May 2014. CPI inflation was 6.95 per cent in March this year and 4.23 per cent in April 2021.

Inflation in the food basket rose to 8.38 per cent in April from 7.68 per cent in the preceding month and 1.96 per cent in the year-ago month,



showed the data released by National Statistical Office (NSO) Thursday.

The rate of price rise in 'fuel and light' category in the retail inflation basket quickened to 10.80 per cent

in April from 7.52 per cent in March. In the 'oils and fats' category, inflation remained at an elevated level of 17.28 per cent (18.79 per cent in March 2022) during the month, as Ukraine is one of the major sunflower oil producers in the world and India imports a major

portion of the commodity from the war-ravaged country.

Vegetables witnessed an inflation print of 15.41 per cent during the month as against 11.64 per cent in March, the data showed

Notably, retail inflation has remained above 6 per cent since January 2022. The Reserve Bank of India has been mandated by the government to ensure that inflation remains at 4 per cent with a margin of 2 per cent on either side.

March IIP growth at 1.9%

New Delhi: Industrial production growth remained subdued at 1.9 per cent in March compared to a /ear ago, mainly due to poor performance by the manufacturing sector which showed staggered impact of the third wave of the pandemic. Factory output measured in terms of Index of Industrial Production (IIP) had recorded a growth of 24.2 per cent in March 2021, as per government data released Thursday. As per the data released by the Ministry of Statistics and Programme Implementation, growth in the mining sector was 4 per cent in March 2022 against a growth of 6.1 per cent in the same month last year. The manufacturing sector expanded by meagre 0.9 per cent, compared to a growth of 28.4 per cent in the year-ago period. Power sector showed a growth of 6.1 per cent compared to 22.5 per cent growth a year ago. For the full fiscal 2021-22, IIP grew 11.3 per cent as against an 8.4 per cent contraction in 2020-21.

Washington, May 12: Ford Motor Co said Thursday it had dropped plans to make electric vehicles (EVs) in India for exports, while it explores options for its two factories in the country that stopped production last year.

"After careful review, we have decided to no longer pursue EV manufacturing for exports from any of the Indian plants," a spokesperson for Ford India said in an email

The company did not offer details on its U-turn, while adding that its previously announced business restructuring continues as planned, including exploring alternatives for its manufacturing facilities in India. "We continue to work closely with unions and other stakeholders to deliver an equitable and balanced plan to mitigate the impacts of restructuring,' the spokesperson added.

New Delhi, May 12: Air France-KLM and IndiGo Thursday announced that they have implemented a codeshare agreement allowing each airline to sell seats on other's flights. The agreement between the two was

signed December 23 last year. With the implementation of the codeshare agreement, Air France and KLM will offer their passengers access to 30 new Indian cities, a joint statement of the two carriers said. This means that Air France and KLM will be able to sell seats, on its distribution system, of IndiGo flights on 30 domestic routes.

Similarly, IndiGo will be able to sell seats on the European airline group's flights on more than 300 routes, the joint statement said. IndiGo also has codeshare agreements with Turkish Airlines, Qatar Airways and American Airlines.

IPL gives India more finishing options in DK, TEWATIA



New Delhi, May 12: IPL form can't be the sole criteria for a national call-up but Dinesh Karthik and Rahul Tewatia with their stellar shows as finishers for their respective franchises have certainly made a strong case for themselves in the coming months leading up to the T20 World Cup.

The ICC event in Australia is still more than four months away but the selectors and team management will soon have to decide on their core group of players, starting with the five match home series against South Africa next month.

The finisher's job is only gaining significance in the powerpacked modern game and the Indian team is definitely in need of players who can go ballistic from ball one.

In the absence of Hardik Pandya due to fitness issues, the Indian team management tried out Deepak Hooda and Venkatesh Iyer in the middleorder post World Cup debacle last year but they haven't yet found closure as far as their search is concerned.

Hardik, who has done well in the IPL in what has been his comeback competition, too has thrown himself back into national contention. However, Hooda and Hardik have been batting higher up in the order for their respective IPL teams but

for the national team. Venkatesh has had a tough second year in the IPL and has gone down in the pecking order of finishers.

With Ravindra Jadeja being the only established finisher in the Indian team, IPL performers like Karthik and Tewatia sensed an opportunity and have made full use of it.

Tewatia has built a reputation of winning games from improbable situations while Karthik has shown insatiable hunger to make another come-

Former India chief selector MSK Prasad feels both Karthik and Tewatia must be tried in the series against South Africa beginning June 9 besides calling for Hardik's return.

Mumbai, May 12: Mumbai Indians Thursday snuffed out defending champions Chennai Super Kings' faint hopes of making the Indian Super League playoffs with a five-wicket win in a low-scoring match here.

Opting to bowl, MI shot CSK out for 97 with pacer Daniel Sams (3/16) running though the MS Dhoni-led side's top-order with three quick wickets in a fiery opening spell, and then huffed and puffed to overhaul the small target of 98 with 31 balls to spare.

MI were four wickets down for 33 runs in the fifth over before Tilak Varma (34 n o) and Hrithik Shooken (18) calmed the fraved nerves with a 48-run stand for the fifth wicket. MI reached 103/5 in 14.5 overs. Tim David remained not out on 16 off just seven balls.

With their eighth loss in 12 matches, CSK are out of reckoning for a playoffs berth. They remained at ninth position with eight points.

Already out of reckoning for a play-offs berth long time ago, MI remained rooted at the 10th and bottom place with three wins from 12

Both CSK and MI have two inconsequential matches left to be played. It will be the first time in IPL history that neither MI nor CSK would be part of the playoffs.

Rome, May 12: Inter Milan remained on course for a league and cup double by beating Juventus 4-2 after extra time in the Italian Cup final. Ivan Perisic scored twice in extra time after Hakan Calhanoglu had converted a controversial late penalty Wednesday.

Juventus had turned the match around early in the second half with two goals in as many minutes from Alex Sandro and Dusan Vlahovic after going behind on an early Nicolo Barella strike.
