

State enhances scholarships for SC, ST students

Bhubaneswar, June 6: The Odisha government Monday enhanced the pre-matriculation scholarships for the students belonging to Scheduled Tribe (ST) and Scheduled Caste (SC) communities.

The pre-matriculation scholarship for boy students has been increased to ₹950 from ₹750. Similarly, the girl boarders will now be entitled to get ₹1,000 from ₹800.

An expenditure amounting to ₹490 crore would be incurred annually towards pre-matric scholarships. The monthly scholarships for the SC, ST students was last enhanced in the year 2015.

Provision of pre-matric schol arships to ST&SC boarders of schools under the ST&SC Development department and School & Mass Education department is one of the flagship schemes of the Odisha government.

The scholarship primarily meant for the mess management in the hostels, aims at the educational and holistic development of Scheduled Caste and Scheduled Tribe boarders.

Further, millet (mandia)-based food items would be introduced in the menu of the hostels to address the nutritional security of all the boarders. The scheme once implemented, would benefit more than five lakh ST&SC boarders.

Mamata replaces Governor as Chancellor

Kolkata: West Bengal Chief Minister Mamata Banerjee will replace Governor Jagdeep Dhankhar as Chancellor of all the state-run health, agricultural, and animal & fishery sciences universities. A formal decision was taken Monday by the state Cabinet to replace the Governor with the Chief Minister as the visitor of private universities operating in the state. West Bengal is the second state after Tamil Nadu to implement this rule. "The Monsoon Session of the West Bengal Assembly will start June 13. The amendment bills will be tabled clearance. Once cleared, they will be sent to the Governor for his consent," said a member of the Cabinet.

Aircraft crashes at Birasal; pilot injured

Dhenkanal: A Cessna 152 aircraft belonging to pilot training organisation GATI crashed Monday on the Birasal airstrip at Kamakhyanagar area in this district. The trainee pilot who was flying the aircraft solo suffered injuries, but his condition is stable, sources said. He was initially taken to the Birasal community health centre and then shifted to the Kamakhyanagar hospital. The DGCA informed Monday that a probe has been initiated over the incident. The aircraft, which has registration number VT-EUW nosedived while landing at the Birasal airstrip, officials said. The propeller and the nose wheel of the aircraft were extensively damaged, they added.

New Delhi, June 6: Amid growing criticism by the Islamic countries over controversial remarks made by now-suspended and expelled BJP leaders against Prophet Mohammed, India slammed Monday the comments by Organisation of Islamic Countries (OIC) as 'narrowminded' and 'motivated, misleading and mischievous'.

A day after Kuwait. Qatar and Iran summoned Indian ambassadors, several Islamic countries in-



cluding Saudi Arabia, Jordan, United Arab Emirates (UAE), Indonesia, Bahrain, Maldives and

the duo Sharma and Jindal.

Reacting strongly to remarks by the OIC, External Affairs Ministry spokesperson Arindam Bagchi said India accords 'highest respect' to all religions and that the statement by the 57-member grouping exposed its 'divisive agenda' which is being pursued at the behest of 'vested interests.

The OIC has also urged the UN to take necessary measures to ensure that the rights of Muslims are protected in India.

"We have seen the statement on India from General Secretariat of the OIC. The Indian government categorically rejects the OIC Secretariat's unwarranted and narrow-minded comments. The Indian government accords the highest respect to all religions," Bagchi said.

'The offensive tweets and comments denigrating a religious personality were made by certain individuals. They do not, in any manner, reflect the views of the government of India. We would urge the OIC Secretariat to stop pursuing its communal approach and show due respect to all faiths and religions," Bagchi added.

SC unhappy with mining sans forest clearance

New Delhi, June 6: The Supreme Court Monday took strong note of continuing 'illegal mining' of minerals by some firms in Odisha without obtaining forest clearance (FCs) from authorities under the garb of 'status quo' orders, and asked the state high court to dispose of such matters in six months.

The SC was irked over the fact that the mining companies, which have not been granted FCs by the Centre and other authorities, are continuing with the 'illegal excavation' of minerals on grounds that the high court has passed the status quo orders with regard to the dispute.

"How can the mining be continued without getting forest clearance under the garb of a status quo order from the HC," a vacation



bench of Justices MR Shah and Aniruddha Bose said. The bench, which was hearing the appeal of M/s Balasore Alloys Ltd of Odisha against the HC's refusal to continue with the status quo order favouring the firm, permitted the company to withdraw its plea. It said that it would permit the withdrawal but the company cannot be allowed to mine as it does not have the forest clearance to mine as on today and hence, this is illegal and cannot be done.

'We've heard the …Counsel. It is not in dispute that the petitioner is not having the forest clearance at this stage. Merely because the application for forest clearance is pending cannot be treated as having obtained the forest clearance permitting the petitioner to carry on the mining," it said.

"Before parting with the present order, we request, the (Orissa) high court to decide and dispose of all such pending matters, where the order of status quo is continuing since long and the mining activities have been continued under the order of status quo, within a period of six months from today without fail. With this the present SLP is dismissed as withdrawn," it ordered.

SUNDARGARH HOCKEY PLAYERS' ELECTROCUTION DEATHS NHRC seeks report from Energy secy

Bhubaneswar, June 6: The National Human Rights Commission (NHRC) has sought action-taken reports (ATRs) from the Sundargarh superintendent of police (SP) and the Energy department secretary in connection with the electrocution deaths of two budding hockey players in the tribal-dominated district in May this year, an official said Monday. While hearing a plea filed by

rights activist Radhakanta Tripathy, the NHRC asked the duo official to submit the reports within four weeks. In case of non-submission of

the reports within the stipulated time, the commission shall be forced to invoke coercive process under section 13 of the Protection of Human Rights Act, 1993 calling for a personal appearance of the authority concerned for submission of the report, it said.

In his petition, Tripathy in-

formed the commission that Sujal Ekka, 19, a resident of Pandratoli Kukuda under Alanda panchayat, and Birendra Kujur, 20, of Jhagarpur village, had gone to Gariamal coaching centre in Alanda for practising hockey around 6am.

While returning home around 9am, Sujal and Birendra were electrocuted as they came in contact with a live electric wire. The two were rushed to the community health centre at Rajgangpur where doctors declared them brought

Report sought on journo's torture

BHUBANESWAR: Expressing displeasure over the 'lackadaisical' attitude of the Balasore police in submitting report in connection with the alleged torture meted out to a journalist in the district in April this year, the NHRC Monday once again asked the district's SP to submit an ATR in connection with the incident.

While hearing a plea filed by rights activist Himanshu Sekhar Nayak, the NHRC asked the Balasore SP to submit the report within four weeks.

In case of non receipt of ATR within the stipulated period, the commission would seek personal appearance of the SP, said the NHRC order.

case. Claiming that the incident of chaining Dalei to hospital bed has violated his human rights, Nayak urged the NHRC to direct the state government to pay ₹5 lakh to the victim.

Why not all obese patients develop diabetes

besity, often a result of eating too much fat and sugar in combination with low physical activity, is known as a key factor for developing Type 2 diabetes. However, some obese people do not develop the disease that affect millions globally. Turns out their gut bacteria have a role to play.

Andrey Morgun and Natalia Shulzhenko of Oregon State University and Giorgio Trinchieri of the National Cancer Institute developed a novel analytical technique, multi-organ network analysis, to explore the mechanisms behind early-stage systemic insulin resistance.

The findings, published in the Journal of Experimental Medicine, showed that a particular type of gut microbe leads to white adipose tissue containing macrophage cells, large cells that are part of the immune system, associated with insulin resistance. In the human body, white adipose



tissue is the main type of fat.

"Our experiments and analysis predict that a high-fat/high-sugar diet primarily acts in white adipose tissue by driving microbiotarelated damage to the energy synthesis process, leading to systemic insulin resistance," said Morgun, associate professor of pharmaceutical sciences in the OSU College of Pharmacy.

"Treatments that modify a patient's microbiota in ways that tar-

'The so-called 'western diet', high in saturated fats and refined sugars, is one of the primary factors. But gut bacteria have an important role to play in mediating the

effects of diet," Shulzhenko said. Experiments in mice, looking at the intestine, liver, muscle and

white adipose tissue, the team found "adipose tissue has a predominant role in systemic insulin resistance"

Further they "discovered that the Oscillibacter microbe, enriched by a western diet, causes an increase of the insulin-resistant adipose tissue macrophage".

The researchers add, however, that Oscillibacter is likely not the only microbial regulator for expression of the key gene they identified, Mmp12, and that the Mmp12 pathway, while clearly instrumental, is probably not the only important pathway, depending on which gut microbes are present.

Previously studies have shown that another microbial species "Romboutsia ilealis worsens glucose tolerance by inhibiting insulin levels, which may be relevant to moreadvanced stages of Type 2 diabetes", Shulzhenko said.

Two trampled to death by wild elephants

Dhenkanal/Baripada, June 6: Two persons lost their lives in separate incidents due to elephant attacks in the state.

In the first instance, a tusker trampled a 70-year-old man to death at Bhingiri village under Bampha section of Hindol forest division in Dhenkanal district Monday

The deceased has been identified as Nirupa Samal.

The incident occurred when the elderly man had gone to answer nature's call in the backyard of his house. He came face to face with the tusker that had strayed into the village and was hiding in his backyard.

The tusker lifted him and dashed to the ground before trampling him. Hearing the screams, neighbours rushed to his rescue and chased the pachyderm away.

Samal, who was critically injured in the attack, died on the way to the district headquarters hospital here by his family members.

Forest department officials from Hindol have launched an inquiry into the incident.

In another incident, a youth was trampled to death by one of the 14-member herd of elephants when he was asleep inside a liquor shop at Manchabandha near here in Mayurbhanj district, late Sunday night.

The deceased was identified as Dhiraj Kumar Singh, a native of Aurangabad in Bihar and an employee at a local country liquor shop.

The incident occurred when the herd was on its way to Manchabandha from Mahulia. The herd barged inside the liquor shop after smelling the aroma of 'Mahuli' – a country brew prepared in the locality.

One of the elephants in the herd picked him on its tusk and trampled him under its feet.

Locals rescued him in critical condition and rushed him to PRM Medical College and Hospital at Baripada where doctors pronounced him dead.

Siddhamatha medicinal plant garden on the wane

Keonjhar, June 6: Chorus for revival of a medicinal plant garden on the premises of ancient religious shrine Siddhamatha in this town has gained momentum as several rare and precious medicinal plants are slowly becoming extinct due to lack of proper upkeep, said sources.

The shrine on the foothills of Chulia hill is situated in natural surroundings with various medicinal plants and trees dotting the landscape. However, due to lack of proper upkeep, the shrine and the adjoining medicinal plant garden are slowly on the wane.

Legend has it that the place was once abound with dense forests as saints and monks used to meditate inside it. The shrine has several temples on its premises including that of Lord Jagannath, Siddha Kali, Siddha Hanuman, Siddha Shiva, Shani and of Sai Baba of Shirdi. The temples are managed by the Endowment department while the



plants Forest department looks after the garden. However, due to lack of proper coordination between the two departments the shrine and the me dicinal plant garden are on the verge

off when there will be no trace of the garden of extinction. Moreover, the walls and houses inside the shrine and garden

> have started crumbling. Sanjay Tripathy, a priest of Siddhamatha temple, said that the

place was once full of precious medicinal plants but they are becoming extinct fast due to theft.

The garden is spread over two acre of area and houses several precious medicinal plants like red sandalwood, white sandalwood, Indian rose chestnut (Nageshwar), Champak, Karnikar (muchukunda), Myrobalan (Haridra), Bastard Myrobalan (Bahada), Indian Gooseberry (Amla), Arjun, Neem, Pongame Oiltree (Karanja), Odasmari, Asana and Bhalia.

However, due to lack of proper upkeep and safeguard, many of plants and trees including many sandalwood trees are slowly getting extinct due to theft by timber mafia.

Residents alleged that the Forest department is spending crores of rupees in planting trees and medicinal plants for the protection of environment, but it has overlooked the protection of a large and ancient garden which is full of rare and precious medicinal plants.

The garden has become a safe

haven for criminals and timber smugglers. The plants and trees are slowly vanishing from the garden and the day is not far off when there will be no trace of the garden.

The department instead of renovating this garden seems to be keen on constructing a new medicinal garden which is only wastage of public funds. The tranquil beauty of the place makes it a much soughtafter retreat for nature lovers, physicians and botanists away from the din and bustle of urban life.

When contacted, Keonjhar DFO Dhanraj HD said, "Steps will be taken soon for the revival of medicinal plant garden.

An Ayurvedic physician Kabiraj Harekrushna Mohanta said medicinal plants and herbs are getting extinct now due to loss of forest cover. It is high time that steps were taken for revival of the garden which would go a long way in conservation of the precious herbs and plants. This will also help in protecting the environment, he added.

Chicken-rice, War

hen war combines with a pandemic, it is, indeed, a recipe for disaster. Almost every country is having a taste of it, but Singapore is paying the worst price as its staple diet - chicken-rice - is faced with the threat of disappearing from the menu of 5.5 million citizens of the city-state. Singapore is bracing for a shortage of its defacto national dish as major supplier Malaysia has halted all chicken exports from the beginning of June. There is panic everywhere and a mad rush to stock as many of the birds as possible to stave off the crisis as long as possible. This further complicates the situation as private hoarding leads to chicken going out of the market too fast. Restaurants and street stalls in Singapore are faced with raising prices of the staple food or shutting down altogether as their supplies dwindle. The main cause for the unprecedented crisis is the decision of neighbouring Malaysia to ban export of chicken. This has dealt a great blow to the supply chain as Singapore imports one third of its need which amounts to 3.5 million chickens a month. But, Malaysia is not to blame for the ban since production there has been disrupted by a global feed shortage.

In fact, Malaysia's export ban is the latest case of growing global food shortages as countries, reeling under the effects of Russia's invasion of Ukraine and the COVID-19 pandemic-related supply disruptions, are scrambling to maintain their own domestic supplies and control food inflation. Rising prices for basic food items have already triggered protests in countries such as Argentina, Indonesia, Greece and Iran. India has already banned export of wheat and sugar so that it can meet its domestic demands. It is the second largest sugar exporter in the world. Indonesia also blocked exports of palm oil to rein in domestic cooking oil prices, though it is now trying to relax the export restrictions.

Unfortunately, Singapore is faced with a situation unlike any other country because of its people's food habits and the city-state's geographical position. Malaysia's ban, fear owners of many supply chains in Singapore, will be catastrophic for vendors. The ban would mean they would no longer be able to sell and they compare their plight with the hypothetical situation where McDonald's is unable to sell burgers. Singapore is among the wealthiest countries in Asia, but it has a heavily urbanised land area of just 280 square miles for which it has to depend largely on imported food, energy and other goods. Nearly all of its chicken is imported - 34 per cent from Malaysia, 49 per cent from Brazil and 12 per cent from the United States, according to data from the Singapore Food Agency (SFA).

A plate of chicken and white rice cooked in broth served with a side of greens is a dish the country's population loves most. It is usually widely available for about 4 Singapore dollars (US\$2.92) at eateries known as hawker centres. The dietary habit of the population is such that they take rice with chicken brought live from Malaysia and cooked fresh in Singapore. The only option that the Malaysian ban has forced on Singapore is to switch to using frozen chicken. But, the people detest the choice so much that frozen chicken with rice is a "no-go." Knowing well the alimentary habit of Singaporeans, the SFA has urged the consumers to opt for other protein sources such as fish and make do, at least for the time being, with frozen chicken from Brazil.

Malaysia itself is facing soaring prices as the bloody conflict between Russia and Ukraine has caused a severe dislocation in the supply of feed. Chicken feed typically consists of grain and soybean, which Malaysia imports. But the government is having to consider alternatives amid a global feed shortage due to the war and the pandemic. Lower-quality feed means the birds are not growing as fast as usual, slowing down the entire supply chain.

Prime Minister of Singapore, Lee Hsien Loong, does not find a ray of hope in the prevailing gloomy situation in the world due to the Ukraine war. In a loaded message, he warned his people to be prepared for the worst. "This time it is chicken, next time it may be something else. We have to be prepared for this," he said.

It does not augur well, especially for the poor who are the hardest hit when prices of essential commodities go up or supplies dry up for some reason or the other. The common man in India is currently being made to pay through his nose to buy fuel, a steep rise of which has already got cascad ing effects pushing the prices of common food items sky high. The attention of the big players in the Russia-Ukraine conflict has so long been riveted on the geopolitical impact and effects of sanctions by the US and its allies on Russia. The present situation reconfirms the age old belief that leaders and rulers do not care a bit for the lowest in the economic ladder. Their cries are not heard nor seen by the rich and powerful of any nation.

TWO TALES ON INDIA

ndia's ministry of health and family welfare (MoHFW) as well as the Indian media appear to be pleased that the nation's Accredited Social Health Activists, or ASHAs as they are popularly called, have been chosen for the World Health Organisation (WHO) Director General's Global Health Leaders Award, as announced in Geneva May 22. WHO recognised the ASHAs' "outstanding contribution towards protecting and promoting health," which in other countries would be the job of a public health workforce.

The Prime Minister stated on Twitter: "They are at the forefront of ensuring a healthy India." There is something very celebratory about the work that ASHAs do in the Indian system. Yet, we must also recognise that ASHAs are technically "volunteers" from and for the community. The Union Minister of State, MoHFW, Dr. Bharati Pawar told Parliament last year that ASHAs receive an honorarium of ₹2.000 per month effective 2018-19, with an additional ₹1,000 as maximum incentive (based on visit/services rendered. like preventive antenatal care, immunisations) and ₹1,000 further added for COVID-related work. States add top-up payments that vary. Billings and payments are often not transparent, verifiable or audited easily.

In essence, ASHAs are minimally trained community volunteers that are now being seen as the backbone of India's health delivery. Are we happy that a large part of the onerous burden of health promotion and disease prevention among low-income families, especially in rural areas, rests on these ASHAs? If ASHAs have come in for laudatory mentions from WHO, then India's response to the pandemic has received a different mention from the WHO.

It was only last month that WHO said five million Indians died as result of the pandemic, nearly ten times the official count of 520,000 deaths admitted by India. India stood out as the worst performer of all nations by this count. India was also the only nation to oppose the WHO findings, which were based on independent and robust

models that have been upheld by a range of global experts.

That huge disparity became an unseemly dispute limited to numbers, diverting the discussion from core issues of how numbers are counted or not counted as a reflection of the quality of the government's health management.

Almost 75 years Independence, we do not yet have a system to count deaths as "health events" with a reliable or reasoned out cause of death. We rely on a civil registration system that counts deaths as "demographic events" for estimating, for example, the number of deaths during the pandemic. This reduces death to a deadpan number rather than the insight it can offer to prevent more deaths, if cause of death is understood and spread of disease deduced. It is not that COVID numbers were underreported. We do this with all diseases because the system is geared to undercount. We underreport mortality from all important diseases like pulmonary tuberculosis, extra-pulmonary tuberculosis, malaria, cholera, typhoid fever, leptospirosis, brucellosis, scrub typhus, haemolytic uremic syndrome, viral encephalitis, influenza, acute respiratory distress syndrome, bacillary and amoebic dysenteries, red-tide algal toxicity, and so on. Even death by snakebite is not well reported or appropriately counted.

This is because we just do not have a public health infrastructure to collect reliable numbers

of health events and place facts in the public domain every week, like a "marked to market" value that offers the current and live view of a portfolio. While ASHAs make us proud, the state of the health management system makes us hang our heads in shame. Globally, health management comprises two parts – a) healthcare. which is the response to disease and b) public health, the eyes and ears watching health events, studying microbial spread and building the dashboard that managers must use to mount a meaningful response to diseases. Without the public health dashboard, the health care car will not know where to drive, what speed to go and where it has to reach. In other words, the lack of a watchful eye on diseases renders all response un-objective and less scientific, less timely or less useful than it ought to be. It is only the public health system that demands case-based. real-time, comprehensive disease surveillance under which every registered medical practitioner has a legally binding duty to report to the local public health officer any of the many notified communicable diseases. Once clinically suspected, that fact has to be reported without any delay. India has none

ments. Union and states, and we have a flourishing set of private sector healthcare establishments that the MoHFW qualifies as the "healthcare industry".

The term "public health" originated in a Parliamentary Act in England in 1848, which came about as a result of the advocacy of a lawyer-cum-social reformer, Edwin Chadwick. He had understood that epidemics of communicable diseases had environmental determinants; only the government had the jurisdiction over environment. The Public Health Act mandated the government to bring about comprehensive sanitation and that resulted in a drastic reduction in disease burdens Diagnosing and treating individuals with disease, be it communicable or non-communicable, remained in the realm of the duties of physicians and the medical es tablishment. Thus, a clear distinction was obvious - healthcare was for individual needs whereas public health was for the benefit

of the community as a whole. We have made huge strides in fighting disease. India has had its contribution too. India created two excellent vaccines -- the adjuvanted, inactivated SARS-CoV-2 vaccine (Covaxin) and a live attenuated Rotavirus vaccine (Rotovac) developed from an indigenous virus isolate (by Late Dr Maharaj K Bhan) and extensively researched by US investigators who found it to be suitable for a vaccine. Thereafter Indian scientists developed and evaluated it until approved as a vaccine that is in current use in our national immunisation programme.

Yet, in terms of the simple cause of death, we appear not to understand that numbers are more than mere numbers, because they tell us exactly how we are performing. Awards and recognition should spur us to act and not sit self-contented with a pandemic death toll that is worst anywhere in the world. Dr T Jacob John is retired

his was a small spinning top. Strictly and originally, it wasn't just any spinning top, but one with four sides, each with a letter on it that decided the outcome of a player's turn in a game. The letters were conventionally TADN, the initials of Latin words, one of them being totum, take everything from the pot. This supplied the old name of the device, the initial T, expanded to tee, being added later. The other letters stood for aufer, take one stake from the pot, depone, put one stake into the pot, and nihil, do nothing. The letters were later changed to fit English words, but the old name remained, though it can sometimes mean a four-sided die instead. Despite its form, teetotum has no connection with teetotal. It is an ancient device, once common in adult gambling, but by the nineteenth century was largely restricted to children's games. The device was so familiar that it was commonly used to refer to the act of spinning around, as Mary Kingsley did in her Travels in West Africa: "We spun round and round for a few seconds, like a teetotum. I steering the whole time for all I was worth, and then the current dragged the canoe ignominiously down river, tail foremost". It appears in Lewis Carroll's Through the Looking-Glass: "Are you a child or a teetotum?' the Sheep said, as she took up another pair of needles. 'You'll make me giddy soon, if you go on turning round like that." It isn't surprising that the word should have taken on the broader sense of spinning top, losing the connection with a game of chance. The toy has had many local or dialect names, such as jenny-spinner, whirligig, and scopperil, the last of these once known in the Midlands and North of England; these names often referred to an improvised top, perhaps made from a button with a piece of wood through it, rather than to a method of plaving a game of chance. Jews will know dreidel (from a Yiddish word related to German drehen, to turn), similarly a foursided spinning top that was used especially for a children's game played at Hanukkah. This has the Hebrew letters nun, gimel, he and shin on it. The letters are often said to spell out the initials of the Hebrew phrase "a great miracle happened there" (the miracle being the tiny amount of oil that burned for eight days in the Temple in Jerusalem) but in the game meant "do nothing", "take all", "take half" and "put in".

Extreme temperatures are thus an "all of society" problem. Such conditions not only harm human health; they also have detrimental effects on infrastructure, crop yields, and poultry mortality, threatening livelihoods and undermining food security. The 2021 heat dome

Bathinda (Punjab), June 6: The Punjab Police has arrested one more person from Haryana in connection with the killing of Punjabi singer Sidhu Moosewala, even as sources said eight sharp shooters have also been identified.

Davinder alias Kala was nabbed Sunday evening from Fatehabad, taking the number of people held in the case from Haryana so far to three, police said Monday. Two suspects involved in the killing had allegedly stayed with Davinder, police sources said.

June 3, two other suspects were nabbed by the Punjab Police from Fatehabad and their roles in the Moosewala's murder were being probed. Meanwhile, eight sharp shooters are learnt to have been identified by the police in connection with the case and they hail from different states, including Punjab, Haryana and Maharashtra. the sources said.

Besides, police have also rounded up some people and got several important leads in connection with the murder, they said. As many as 15 teams have been constituted by the police to arrest the culprits involved in the killing. Two days after the killing of

Moosewala in Mansa district, the Punjab Police had on May 31 made the first arrest in this case. Manpreet Singh, who was arrested from Uttarakhand, was accused of providing logistic support to the assailants. Meanwhile, politicians cutting across parties continued to reach Moosewala's native village in Mansa to meet the singer's family to express their condolences

incident a case of an inter-gang rivalry and said the Lawrence Bishnoi gang was behind the killing. Canada-based Goldy Brar, who is a member of the gang, had claimed the responsibility for the murder.

Old-age homes in every district soon

New Delhi, June 6: The govern ment is planning to establish oldage homes in every district of the country and has identified 250 districts where it will be tying up with local NGOs of the area, the Ministry of Social Justice and Empowerment said Monday.

Addressing a press conference, Union Social Justice and Empowerment Minister Virendra Kumar listed out various initiatives taken by his ministry in the last eight years. He said the government is planning to establish an old-age home in every district of the country for the elderly.

He added that the ministry is tving up with local NGOs to set up such old-age homes. A senior ministry official explained that 250 districts have been identified for the purpose and work is going on.

Meanwhile, he said the government has started a major reformulation of the schemes through which scholarships are provided to SC students scholarships owing to complaints.

Also for the first time, the students are getting the money directly to their accounts through the Direct Benefit Transfer (DBT) scheme, the ministry official said, adding 41 lakh students have so far been benefited under it.

Social Justice and Empowerment Minister Kumar said the Senior Able Citizens for Re-Employment in Dignity (SACRED) portal and nine start-ups have been roped in for senior citizen employment seekers. The IT platform brings such employment seekers and providers together.

The senior ministry official said a strong movement is going on across the country under the Nasha Mukt Bharat Abhiyaan. The government is targeting to make 100 districts 'nasha mukt' this year as part of the campaign.

New Delhi, June 6: Stepping up pressure for legal action against Nupur Sharma and Naveen Kumar Jindal, opposition parties Monday demanded that they be arrested for their controversial remarks on Prophet Mohammad and accused the BJP of denting the image of the country

While the ruling party faced more criticism at home, the diplomatic fallout of the row continued as Saudi Arabia, Bahrain, Indonesia. Jordan, UAE and Afghanistan joined several Muslim nations in condemning the controversial remarks. The BJP had Monday suspended

its spokesperson Nupur Sharma and expelled Naveen Kumar Jindal, its Delhi media head, in a fire-fight-

ing exercise, but the opposition parties like the Congress, AAP, BSP, SP and the Left dismissed it as mere "drama" and "sham" and demanded strict legal action against the two. While Sharma is facing cases in various cities over her remarks, the Delhi Police has now registered an FIR on her complaint that she is receiving death threats. The Congress hit out at the BJP,

demanding the immediate arrest of those who have defamed India at the international level instead of enacting a "drama of action"."Divided internally, India becomes weak externally. BJP's shameful bigotry has not only isolated us but also damaged India's standing globally." Rahul Gandhi said on Twitter.

Congress chief spokesperson Randeep Surjewala alleged the BJP leadership is pushing the country into the dark age of communal polarisation to serve its narrow political interests and asked. The AIMIM also demanded the immediate arrest of the BJP functionaries and said the country's image has been dented internationally due to the "wrong policies" of the BJP. The Aam Aadmi Party alleged that Prime Minister Narendra Modi's patronage of "hate politics" has brought disgrace to the country.

Delhi Deputy Chief Minister Manish Sisodia alleged the BJP has led the country to such a situation that even "small countries are now challenging the great nation of India". He claimed that every Indian is pained by it and "the sorrow is endless".

The opposition parties targeted the prime minister after the



Organisation of Islamic Cooperation (OIC) slammed India for comments by the two Bharatiya Janata Party (BJP) functionaries. Countries like Qatar, Iran and Kuwait had summoned Indian ambassadors and handed over protest notes on Sunday.

At least 3 trees felled every hour in Delhi in last 3 yrs: Data

THE ACTUAL NUMBER OF TREES FELLED COULD BE MUCH MORE IF THE NUMBER OF TREES CUT ILLEGALLY IS ALSO CONSIDERED. ENVIRONMENT ACTIVISTS SAID

New Delhi, June 6: The Delhi forest department granted permission to cut or transplant at least 77,000 trees, or three trees every hour, for developmental work in the city in the last three years, according to government data submitted to the high court recently. It also said only one-third of the trees transplanted during the period have survived. Officials allowed agencies to cut or transplant 29.946 trees under section 9 of the Delhi Preservation of Trees Act (DPTA) and 47,474 trees under section 29 of the Act in the last three years.

The actual number of trees felled could be much more if the number of trees cut illegally is also considered, environment activists said. They also feared that the project proponents cut more trees than allowed over the years.

The data has been submitted in response to orders on a contempt plea filed by RTI activist Neeraj Sharma through advocate Aditva N Prasad against the concretisation of trees in east Delhi's Vikas Marg area. Section 9 of the Act says anyone desiring to remove a tree should file an application before the tree officer concerned for permission with ownership documents of the land and the girth measure of trees at a height of 1.85 metres from the

ground level Section 29 empowers the government to exempt "any area or any species of trees" from the Act in public interest through a notification.



According to the data, authorities in the West forest division granted permission to cut 8,953 trees and transplant 13,486 trees, the maximum among all forest divisions

in the capital, in the last three years. The forest department granted permission to cut 2,866 trees and transplant 701 trees in the Central forest division during the

period. Officials allowed agencies to cut 689 trees and transplant 269 trees in the North forest division. They permitted the felling of 982 trees and transplantation of 2,000 trees in the South forest division.

The Delhi government issued 52 notifications under section 29 of the DPTA from 2019 to 2021, allowing the felling of a total 15,426 trees and the transplantation of 32,048 trees in the capital. In a status report dated May 18, the forest department said only one-third (33.33 per cent) of the 16.461 trees transplanted under section 9 of the Act in the last three years have survived.

An affidavit filed by the department on May 31 painted a grim picture of compensatory plantation. It said the user agencies

planted just 1,58,522 saplings as against the mandated 4,09,046 in the last three years in lieu of the trees cut. According to the provisions of the DPTA, the forest department has to ensure that 10 saplings are planted for each tree felled.

The data showed that a large number of offences registered for illegally cutting, damaging, pruning and concretising trees in the last three years are pending and the offenders have not submitted fines in most cases.

Hearing the petition, Justice Najmi Waziri had on May 20 directed that no tree will be felled in Delhi till June 2, saying the capital cannot have the luxury to allow such "large-scale of denudation oftrees" due to the rampant air pollution.

tracked satellite phone calls made to foreign locations from state's coastal and Malnad regions, sources said Monday.

Three calls were detected from the thick forests in these regions between May 23 and 29, according to the sources. Two calls were tracked in places near Mangaluru in Dakshina Kannada district. Chikkamagalur and Uttara Kannada jungles by the Central intelligence agencies.

The sleuths of State Internal Security Division (ISD) visited the spot and have launched a probe. Preliminary findings have suggested that the satellite phone calls were made from four locations in 10 days. The agencies are tracking down the persons who used the banned satellite phones

Sources explained that this is the third time that satellite phones were being used in this year in the coastal and Malnad regions. The Central agencies have been alerting the state police department on these developments.

This time satellite phone signals originated from the forest that falls between Yallapur and Sirsi towns in Uttara Kannada: Natekal, Kulai regions in the outskirts of Mangaluru city; and the jungles between Kadur-Birur towns in Chikkamaglur, the sources said.

Bangalore, June 6: Mandya district in Karnataka may be in the news for all the wrong reasons in connection with the Jamia Masiid row, but a large number of people from the same district are more concerned about the health of the people's doctor, Dr Shankare Gowda

He had suffered a heart attack recently. His ill health made headlines and news of his discharge was flashed by state media and celebrated by the people.

Dr Shankare Gowda, a native of Shivalli and a resident of Bandi Gowda Layout in Mandya, is known as the 'Five Rupees Doctor'

He has been treating people for this meagre amount for four decades. Family members told IANS that he will be operated on again in another 10 to 15 days and he is responding well to the treatment.

If he attends a marriage, funeral, or other programmes, people would queue up wherever he went. People are required to go to him with a blank paper and pen. Gowda treats them irrespective of where he is.

An MBBS from Kasturba Medical College of Manipal, he has also done his Diploma in Venereology and Dermatology (DVD). He started his service at the age of 30 years. He remembers 1,500 medicines and keeps updating. He would choose the cheapest medicine for skin treatment and he won't allow medical rep-

Tagganahalli Venkatesh, a relative and former ZP President, said that Shankare Gowda is the son-in-law of his village. "He could have chosen to make money at any point of time. He chose service. People are really concerned about his health. They believe that God would bless him with good health," he said.

New Delhi, June 6: In a significant move, the defence ministry on Monday approved the procurement of military equipment and platforms worth Rs 76,390 crore from domestic industries.

The procurement proposals were approved by the Defence Acquisition Council (DAC) headed by Defence Minister Rajnath Singh, the ministry said.

For the Indian Navy, the DAC accorded approval for the procurement of next generation corvettes (NGCs) at an estimated cost of around Rs 36,000 crore, it said. These NGCs will be versatile platforms for a variety of roles namely surveillance missions, escort operations, deterrence, Surface Action Group (SAG) operations, search and attack and coastal de-

fence. The NGCs would be constructed based on a new in-house design of the Indian Navy, using latest technology of ship building, the ministry said in a statement.

The DAC also approved a proposal for the manufacture of Dornier aircraft and Su-30 MKI aero-engines by Hindustan Aeronautics Limited (HAL) with a focus on enhancing indigenisation. For the Indian Army, the DAC

Kathmandhu, June 6: Teams led by the Nepal Army have collected over 33 tonne of wastes, including human skeletons, from Mount Everest and three other peaks in a two-month-long cleaning campaign.

The cleaning teams involving a total of 92 individuals started their work April 5 on Everest, Mount Lhotse, Mount Kanchenjunga and Mount Manaslu, which attract

climbers from around the world each year, reports Xinhua news

agency. "Our teams collected 33,877 kg of wastes from the four mountains along with skeletons of two human bodies," Himansu Khadka, a Nepal Army Brigadier General, said at a press conference.

The cleaning teams had sorted out biodegradable and nonbiodegradable wastes, which weighed 7,227 kg and 26,650 kg respectively, and the skeletons re-



covered from the base camp of Kanchenjunga were handed over

to Taplejung district police for identification and cremation.

The Nepal Army has been leading the clean campaign since 2019, and a total of 27.6 tonnes of waste were collected in 2021 and 10 tonnes in 2019.

The campaign was suspended in 2020 due to the Covid-19 pandemic.

"The cleaning is necessary to save the biodiversity of the mountains and lessen the impact of climate change," Prabhu Ram Sharma, Chief of Army Staff, said at the press conference.

sciousness. It also enables us to backup the biosphere, protecting all life as we know it from a calamity on Earth, he tweeted.

Starship and Super Heavy are both designed to be completely and rapidly reusable, and both will be powered by SpaceX's new Raptor engine -- 33 for Super Heavy and six for Starship. Musk earlier said that Mars settlement and deep space exploration will see reduced costs due to its reusability.

NASA also sees considerable

promise in Starship. The US space agency selected the vehicle to be the first crewed lunar lander for its Artemis programme, which aims to put astronauts on the moon in the next few years.

However, the Starship programme has not yet been given a green signal by the US Federal Aviation Administration (FAA).

The FAA, last week, delayed the completion of its environmental review of the Starship by another two weeks to June 13.

While SpaceX has conducted a number of high-altitude test flights of Starship prototypes at Starbase site in South Texas, its plan to launch the system's first-ever orbital test mission needs approval from-(the FAA and a host of other regulatory bodies.

Washington, June 6: Elon Musk may walk away from his \$44 billion deal to acquire Twitter Inc if the social media network fails to provide data on spam and fake accounts, the billionaire warned in a letter to the company Monday.

Twitter was in a "clear material breach" of its obligations and that Musk reserves all rights to terminate the merger agreement, the letter said.

Twitter had previously downplayed Musk's warning that the deal was "on hold", arguing that the data would help him prepare for his ownership of Twitter, not to carry out due diligence and reopen negotiations.

Earlier in March, Musk said he would put the deal "temporarily on hold", while he waits for the social media company to provide data on the proportion of its fake accounts.

"Musk believes Twitter is transparently refusing to comply with its obligations under the merger agreement, which is causing further suspicion that the company is withholding the requested data," according to the letter.

A self proclaimed free-speech absolutist, Musk has questioned the accuracy of Twitter's public filings about spam accounts representing less than 5% of its user base, claiming they must be at least 20%

"Musk is clearly entitled to the requested data to enable him to prepare for transitioning Twitter's business to his ownership and to facilitate his transaction financing," his lawyers said in the letter.

Musk has said that he has lined up financing for the deal, through equity and loans, pulling in top shareholders including Saudi Arabian investor Prince Alwaleed bin Talal and Sequoia Capital.

RBI comes out with provisioning norms for large NBFCs

Mumbai: Reserve Bank of India (RBI) Monday came out with a set of norms for provisioning for standard assets by large Non-**Banking Financial Companies** (NBFCs) in view of the increasing role played by such entities in the financial system. In a circular Monday, the central bank specified rates of provision for outstanding loans extended by 'NBFC-Upper Layer'. In case of individual housing loans and loans to Small and Micro Enterprises (SMEs), the rate of provision has been specified at 0.25 per cent and for housing loans extended at teaser rates, it has been fixed at 2 per cent. The latter will decrease to 0.4 per cent after 1 year from the date on which the rates are raised. For Commercial Real Estate - Residential Housing (CRE - RH) sector, the rate of provision is 0.75 per cent, and for CRE. other than residential housing, it will be 1 per cent.

Canara Bank, Karur Vysya raise rates

New Delhi: Canara Bank and Karur Vysya Bank Monday said they have revised their lending rates leading to an increase in EMIs linked to the respective benchmarks. State-owned Canara Bank has raised the marginal cost of funds based lending rate (MCLR) by 0.05 per cent of 5 basis points to 7.40 per cent for one year tenure. The bank has also raised the MCLR rate for 6 months tenure to 7.35 per cent from 7.30 per cent. The new rates are effective from June 7. Canara Bank said in a regulatory filing.

Cyient to acquire Celfinet for ₹340cr

New Delhi: IT solutions provider Cyient will acquire Portugal-based wireless engineering services firm Celfinet for 41 million euro (about Rs 340 crore) in an allcash deal, the Hyderabadheadquartered company said Monday. Cyient will pay 65 per cent of the deal amount upfront and the remaining 35 per cent as an earnout over two years, subject to business performance.

New Delhi, June 6: India's bilateral trade with all the six countries of the Gulf Cooperation Council (GCC), including the UAE and Saudi Arabia, has risen significantly in 2021-22 on account of increasing economic ties between the two regions

India's exports to the GCC have increased by 58.26 per cent to about \$44 billion in 2021-22 against \$27.8 billion in 2020-21, according to data of the commerce ministry. The share of these six countries in India's total exports has risen to 10.4 per cent in 2021-22 from 9.51 per cent in 2020-21. Similarly, imports rose by 85.8 per

cent to \$110.73 billion compared to \$59.6 billion in 2020-21, the data showed. The share of GCC members in India's total imports rose



to 18 per cent in 2021-22 from 15.5 per cent in 2020-21.

The GCC was established in May 1981. Its members are Saudi Arabia, Bahrain, Kuwait, Oman, Qatar and the UAE.

The top five product categories which were exported from India to GCC countries during 2021-22 in cluded petroleum products; pearls, precious and semi-precious stones; premium metals and articles of imitation jewellery; electrical machinery and equipment; sound recorders and reproducers; television image and sound recorders; iron and steel; and organic chemicals.

The main imported goods included petroleum products, premium metals, imitation jewellery, fertilisers, chemicals and plastics.

India imported 101 tonne of gold in May, compared to 13 tonne a year earlier, the source said Monday on condition of anonymity as he is not authorised to speak to media.

'Retail consumers were wait ing for price correction. As prices corrected during Akshaya Tritiya festival, they rushed to jewellery shops," said Harshad Aimera, the proprietor of JJ Gold House, a wholesaler in the eastern Indian city of Kolkata.

Buying gold is considered auspicious during the annual Hindu and Jain festival, celebrated in the first week of May.

Local gold futures fell to Rs 49,572 per 10 grams in May, the lowest in nearly three months.

Demand for gold was also improved last month because of wedding season as lots of weddings were postponed to 2022 from the last year because of restrictions imposed to curb the spread of Covid-19 infections, said a Mumbai-based dealer with a private bullion importing bank.

Gold is an essential part of the bride's dowry in India and also a popular gift from family and guests at weddings.

India's gold imports in June could fall below 60 tonne as demand has started to falter due to the recent rebound in prices, the dealer said.

deal bodes ill for India's plan to create rupee-rouble trade mechanisms that can bypass dollar and euro payments to avoid US and Western sanctions imposed after Moscow's February 24 invasion of Ukraine.

IPL set up a rupee account with Sberbank's New Delhi branch in early February at the request of Belarusian Potash Company (BPC), as Belarus faced steadily tougher US sanctions since a 2020 election Washington called fraudulent. Minsk disputes this.

IPL made its first payment of Rs 1.77 billion (\$23 million) to the Sberbank branch in India after setting up an account, according to an IPL letter addressed to the chief executive of Sberbank in India Ivan Nosov, and seen by Reuters.

The letter, dated May 23, said only a "negligible" amount of rupees had been converted to roubles to pay BPC and said IPL could not wait indefinitely for the transaction to be processed.

It said that, if the bank confirmed it could not complete the transaction, "we are afraid, we will call back our funds." "But Sberbank has not yet responded," one of the sources, speaking on condition of anonymity, said.

The second source said sanctions imposed on Russia after its invasion of Ukraine had hindered processing of the IPL payment. "That made it difficult to settle payment in roubles as Russian banks were barred from using SWIFT mechanism," the source said.

Since the invasion, India and Russia have discussed setting up a rupee-rouble payment mechanism to smooth trade, including a proposal for Russian banks and companies to open accounts with Indian state banks to settle trade deals.

Three government officials said India would tread cautiously on setting up any rupee-rouble trade payment mechanism as long as fierce fighting in Ukraine was still raging, amid calls from Washington and European capitals to isolate Russia.

Global wheat prices jump after India export ban, Ukraine war

Last month, India announced that it was banning wheat exports in a bid to check high prices amid concerns of wheat output being hit by the scorching heat wave

United Nations, June 6: The price of wheat has jumped in the international markets after India announced a ban on the export of the staple cereal and due to the reduced production prospects in Ukraine following the Russian invasion, the UN food agency has said.

The Food and Agriculture Organisation (FAO) Price Index averaged 157.4 points in May 2022, down 0.6 per cent from April.

The index, which tracks monthly changes in the international prices of a basket of commonly-traded food commodities, however, remained 22.8 per cent higher than

in May 2021. The FAO Cereal Price Index averaged 173.4 points in May, up 3.7 points (2.2 per cent) from April and as much as 39.7 points (29.7

per cent) above its May 2021 value. "International wheat prices rose for a fourth consecutive month,

up 5.6 per cent in May, to average 56.2 per cent above their value last year and only 11 per cent below the record high reached in March 2008," it said Friday.

"The steep increase in wheat prices was in response to an export ban announced by India amidst concerns over crop conditions in



several leading exporting countries, as well as reduced production prospects in Ukraine because of the war," it said.

In contrast, international coarse grain prices declined by 2.1 per cent in May but remained 18.1 per cent above their value a year ago. Slightly improved crop condi-

tions in the United States of America, seasonal supplies in Argentina and the imminent start of Brazil's main maize harvest led maize prices to decline by 3.0 per cent, however, they remained 12.9 per cent above their level of May 2021, it said. International rice prices increased for the fifth successive month in May.

Quotations strengthened in all the major market segments, but monthly increases were least pronounced (2.6 per cent) for the most widely traded Indica varieties, amid ample supplies, especially in India, it said.

The FAO Sugar Price Index declined by 1.1 percent from April, as a bumper crop in India buoyed global availability prospects.

The weakening of the Brazilian real against the US dollar, along with lower ethanol prices resulted in further downward pressure on world sugar prices

"The FAO Sugar Price Index averaged 120.3 points in May, down 1.3 points (1.1 per cent) from April, marking the first decline after sharp increases registered in the previous two months," the agency said.

Geneva. June 6: Cristiano Ronaldo scored his world record-extending 116th and 117th goals for Portugal Erling Haaland got his 17th and 18th at a faster rate for Norway. Gavi opened his Spain account at age 17.

Ronaldo had gone five games and nearly nine months without an international goal until Portugal routed Switzerland 4-0 in the Nations League Sunday

After scoring twice in four firsthalf minutes, Ronaldo missed two more good chances before halftime, had a goal disallowed for a late offside flag and forced Swiss goalkeeper Gregor Kobel into two good saves late in a lopsided League A game between World Cup-bound teams in Lisbon. It's now 117 goals in 188 international games for the 37-year-old Ronaldo heading to his fifth World Cup in November. Portugal is in a group with South Korea, Uruguay and Ghana.

Erling Haaland has 18 goals in 19 games for Norway after scoring twice in a 2-1 win at Sweden in League B to show why the 21-yearold forward might be the biggest talent missing in Qatar

There was a first international goal for teenage Gavi in an eighth international game for Barcelona's latest midfield prospect, and Spain drew 2-2 at the Czech Republic in League A. Gavi's curling left-foot shot between two defenders in first half stoppage time in Prague leveled a fourth-minute opener for the Czech Republic by Jakub Pešek.

ANAND SEALS WIN AGAINST CARLSEN,

At the age of 17 years and 304 days Gavi broke the record set in 2020 by his Barcelona teammate Ansu Fati who found the net for Spain at the age of 17 years and 311 days.

The Czechs led again when Jan Kuchta scored in the 66th with an audacious chip over advancing goalkeeper Unai Simon. Spain drew level, again late, when Inigo Martinez's 90th-minute header was checked to have crossed the goal-line. Portugal now leads top-tier Group

2 with four points after drawing 1-1 at Spain Thursday, Switzerland has now lost three games and drawn one in 2022 and it gets no easier hosting Spain and Portugal in Geneva next week. The Swiss had an apparent goal

THE DRAGONS BREAK UKRAINE HEARTS TO END 64-YEAR WAIT FOR WORLD CUP RETURN Gareth 'Bales' out Wales of curse

Cardiff, June 6: Weeks of back spasms were not going to stop Gareth Bale's mission to lead Wales back to the World Cup. Try stopping the captain taking to the field when there is a 64-year drought to end.

Try stopping a free-kick from a forward who was once the world's costliest footballer. Ukraine winger Andriy Yarmolenko could only divert it into his own net with a header.

The 1-0 win over war-disrupted Ukraine Sunday, secured in the 34th minute in the Cardiff downpour, was enough to send Wales back to the World Cup as the country with the longest gap between qualifications for the FIFA showpiece.

"It's the greatest result in the history of Welsh football," Bale said. "I'm just delighted we are going to a World Cup. It means everything, it's what dreams are made of, I'm speechless, I'm so glad we've done it for these amazing fans."

Bale was one of those spectators for the remaining 10 minutes or so after being substituted when his body could offer no more.

The trip to Qatar gives Bale -British soccer's most decorated a chance to finally play on the sport's biggest stage. But the fivetime Champions League winner is without a club for next season after being released by Madrid. While saying he has "loads" of offers, the 32-year-old free agent had been coy about his playing future.

Now there is a new club to find to stay match fit for the November 21 World Cup opener against the

United States. Then there is Iran and England to play in Group B. The Welsh also played their neighbors at the 2016 European Championship when they lost to England in the group stage.

But Wales did go further than England at Euro 2016 in France, reaching the semifinals where Cristiano Ronaldo led Portugal to victory and then the title. Another soccer great knocked out Wales at the 1958 World Cup, with Pele netting the only goal in eventual champion Brazil's quarterfinal win.

Wales did contest a third tournament last year, returning to the European Championship and los-

ing to Denmark in the round of 16. Now Doha is the destination for Wales, which is more accustomed to featuring at Rugby World Cups, having qualified for all nine editions. Thanks most of all to goalkeeper Wayne Hennessey who thwarted nine shots on target to prevent Ukraine scoring.

This qualification has been achieved with coaching uncertainty. Robert Page stepped up to lead the team on a temporary basis in early 2021 with Ryan Giggs still out of the management job while awaiting trial on charges of domestic violence. Now Page is set to lead the team in Qatar.

MESSI NETS FIVE, OVERTAKES PUSKAS

Pamplona (Spain), June 6: Lionel Messi scored five goals for Argentina for the first time in a 5-0 rout of Estonia in a friendly match in Spain, becoming the fourth-highest scorer for a national team in men's football.

Messi scored twice in the first half, including from a penalty kick, and three times after the interval to reach 86 international goals. He moved past the 84 goals of former Hungary great Ferenc Puskas.

Portugal's Cristiano Ronaldo tops the list with 117 goals — including two Sunday as Portugal routed Switzerland 4-0 in the Nations League — followed by

Messi had never scored five times before for Argentina at senior level. He scored five goals with Barcelona in a 7-1 win over Bayer Leverkusen in the round of 16 of the 2011-12 Champions League.

The 34-year-old Messi had two assists last week when Argentina defeated Italy 3-0 in the first Finalissima meeting of the South American and European champions. He last year helped Argentina win the Copa America for his first major title with the national team.

Argentina is unbeaten in their last 33 matches. The match was played at Osasuna's stadium.

Stavanger (Norway), June 6: Indian ace Viswanathan Anand returned to winning ways, upstaging World No.1 Magnus Carlsen in the fifth round of the Classical section early Monday in the Norway Chess tournament to climb to the top spot.

After defeating the Norwegian superstar in the Blitz event that preceded the Classical section, Anand claimed the victory in a thrilling Armageddon (sudden death game) after the regular match ended in a 40-move draw.

In the Armageddon, the 52-year old Anand recreated magic of old when he stunned Carlsen to post a win in 50 moves. With 10 points in his kitty, the Indian GM leads the field with four more rounds to go in the prestigious tournament which features some of the best players in the sport.

Anand had started the Classical section with three straight wins, beating Maxime Vachier-Lagrave (France), Veselin Topalov (Bulgaria) and Hao Wang (China) before American Wesley So ended his streak in the fourth round.

Carlsen lies in second spot with 9.5 points despite the loss to his long-time rival. So, who won the Blitz section earlier, shares third place with Shakhriyar Mamedyarov (Azerbaijan) on 8.5 points.

New Delhi, June 6: Preparing for the upcoming T20 series against India. South African all-rounder Dwaine Pretorius Monday said he would like to inculcate the legendary MS Dhoni's calmness and self-belief.

The South African made his IPL debut for Chennai Super Kings this year after joining the franchise for a base price of Rs 50 lakh. Pretorius played just six matches, scoring 44 runs and claiming six wickets with best bowling figures of 2/30. The limited opportunities notwithstanding, Pretorius said playing alongside Dhoni has been his biggest gain.

"Playing my first IPL was a great experience. It was one of my bucket list items and that too to get the opportunity to play for CSK, one of the most successful franchises. I enjoyed every moment of it. You get a lot of responsibility as a player.

"I really enjoyed playing under Dhoni as well and batting with him, seeing the brand value he has in India just shows how big he is and what he has done for the sport in this country. It was awesome being a part of that," the 33-yearold said.

"The biggest thing that I have learnt from him is how calm he is at the crease, the way he takes the pressure off himself and tries to put it on to the bowler.

"He made me realise that at the death it's actually the bowlers who are under pressure. It was a fresh mindset and also he doesn't get too excited and is always optimistic. "He believes he can do anything

and I am going to try to bring his calmness and self-belief into my game," Pretorius added.

The five-match T20 series between India and South Africa starts here Thursday, followed by matches in Cuttack (June 12), Visakhapatnam (June 14), Rajkot (June 17) and Bangalore (June 19).

The Indian team's evening session under Rahul Dravid and Paras Mhambrey was as intense as it could get. While Umran, the toast of the nation for his express pace, bowled as quick as he can, Rishabh Pant didn't leave any opportunity to smash him with equal ferocity.

Young Arshdeep first bowled a short spell and then had a session under bowling coach Mhambrey, when he was seen practicing the

blockhole deliveries. Mhambrey kept a baseball mitt (gloves) on the front crease, exactly on middle stump line for the yorker on middle stump and an energy drink bottle around tramline for the wide yorker. Arshdeep was supposed to hit the two 'props'

as part of match simulation.

Dinesh Karthik might not be a certainty going into the first game with Pant being deputy to KL Rahul but his short net session was entertaining.

Bhuvneshwar Kumar, who will lead the pack, bowled for hardly 15 minutes. Similarly, Harshal Patel, who is also a certainty was rested on the day along with two sureshot first XI candidates, Yuzvendra Chahal and Hardik Pandya.

Before the match, the ones who bowl more at the nets are the ones who are likely to be benched.

At 36, Karthik knows what he needs to practice and thus asked the throwdown experts Nuwan, Daya and Raghu to provide him with deliveries that allows him to play lap scoop and reverse lap scoop over short fine and short third man fielder.
