# Pujari presents **₹2L crore Budget**

Bhubaneswar, July 2: Finance Minister Niranian Pujari Saturday presented an annual Budget of ₹2 lakh crore for financial year 2022-23 in the state Assembly. The budget size is ₹30,000 crore more than the annual Budget of the previous fiscal.

"The fiscal space created has been effectively employed for creation of physical, social and human capital. Over the last 22 years, there has been a 17-fold increase in the Budget size and this year, we are touching the landmark figure of ₹2 lakh crore," Pujari said while delivering a budget speech in the House.

Programme expenditure has shown a 28-fold increase and capital spending has increased by about 50 times during the same period, he said.


 $Total\ programme\ expenditure$ outlay for FY 2022-23 is estimated at ₹1 lakh crore, which is half of the entire budgetary allocation. In addition, ₹10,000 crore will be spent through off-budget sources and by Public Sector Undertakings (PSUs), he said. Administrative revenue expenditure is estimated at ₹89,590 crore in 2022-23 while the outlay for disaster risk management fund is ₹3,210 crore and ₹7,200 crore earmarked for transfers from state, said the Finance minister.








#### PROGRESSIVE, PRO-POOR BUDGET: CM

Bhubaneswar, July 2: A Plus III first-year girl student of a Government autonomous college here committed suicide in her hostel room, Saturday.

The deceased was identified as Ruchika Mohanty from Kakhadi area in Cuttack district. Ruchika, a History Honours student, was allegedly under severe mental pressure due to ragging by her

Sources claimed that Ruchika, who was good at studies, was also preparing for UPSC examinations.

'When I was taking a class in my department, the matron of Karubaki Hostel informed me that

a girl was not opening the door of her room (201). I rushed to the hostel after informing the Principal about the incident. I asked other students to call an ambulance and directed the male staffers to break open the door. Meanwhile, police also reached the spot and we found the deceased lying on her bed,' one of the faculties told media.

Later, police recovered the body and sent it to Capital Hospital for post-mortem. Her body was later handed over

to the family members after the autopsy was conducted.





Bhubaneswar, July 2: Odisha Assembly Saturday witnessed several adjournments amid uproar by two opposition parties - the Congress and BJP over Nupur Sharma's controversial statement on Prophet Mohammad and subsequent Supreme Court's admonishment of her.

### Budget Stabilisation Fund of ₹10k cr soon

Bhubaneswar, July 2: With an aim to meet an unexpected revenue shortfall or budget deficit, the state government is going to create a Budget Stabilisation Fund (BSF) of Rs 10,000 crore, state Finance Minister Niranjan Pujari announced while presenting the annual Budget for the year 2022-23.

"Due to our proactive steps in renewal of the mining leases at the appropriate time, we had a substantially higher collection of mining revenue during previous two years, which had been instrumental in meeting the need of a higher public expenditure in revamping health service delivery and creating livelihood opportunities during the pandemic," Pujari said.

However, as the best practice, the state now was able to acknowledge the substantially higher realisation of mining revenue as a positive fiscal shock. It may turn Finance Minister Niranjan Pujari and Speaker Bikram Keshari Arukha with the

negative affecting the state budget and public expenditure, since the international commodity prices are highly volatile, pointed out the Minister.

"As a mitigation measure to neutralise the risk of price shock of metals on the state budget, we are going to set up a Budget Stabilization Fund (BSF), which is the first of its kind initiative in a state in the country," he announced.

Pujari said this fund would help the government to set aside certain surplus revenue for times of unexpected revenue shortfall or budget deficit.

In 2021-22, Odisha's own revenue constituted about 61 per cent of total revenue, resulting in reduced dependence on central transfers. To facilitate higher spending, Finance

#### State's debt burden to reach ₹1.12 lakh crore by FY 23 NHRC moved over Balasore electrocution

Bhubaneswar, July 2: A petition has been filed with the National Human Rights Commission (NHRC) in connection with the electrocution of a devotee during Rath Yatra at Gudikhala Mutt under Basta police limits in Balasore Friday. Petitioner Himanshu Sekhar

Nayak sought financial compensation for the family of deceased Anil Kumar Sahu of Agarpada village. Sahu was electrocuted when the chariot of lord Jagganath accidentally came in contact with a live electric wire during Rath Yatra. As many as 11 persons have sustained injuries in the mishap.

Nayak requested the rights body to direct the Chief Secretary of Odisha to pay a compensation of Rs 30 Lakh to Sahu's family and send the documentary proof of the same

**Petitioner Himanshu** Sekhar Nayak sought financial compensation for the family of deceased Anil Kumar Sahu of Agarpada village

to the commission within three weeks. Nayak also sought Rs 5 Lakh as compensation to the crit-

Bhubaneswar, July 2: The public debt burden of the state will climb up to Rs 1.12 lakh crore by the end of 2022-23 financial year, according to the Status Paper on Public Debt in Odisha released by the government Saturday.

As per the report, the total outstanding public debt of the state as per the revised estimate for the financial vear 2021-22 stood at Rs 1,00,813 crore which is 15.8 per cent of the State's Gross Domestic Product (GSDP).

For the year 2022-23, it is estimated that the total debt burden will be Rs 1,12,401 crore which is 15.6 per cent of GSDP.

The Fifteenth Finance Commission and Odisha FRBM Act, 2005 prescribe for limiting the debt to GSDP ratio within 25 per cent. The current debt level of Odisha is within the stipulated



debt limit, it said.

In the medium term, the total debt to GSDP ratio of the state is projected to reach to a level of 18.1 per cent in the financial year 2025-26, which will be also within the stipulated limit of 25 per cent.

Similarly, the fiscal deficit stands at 0.4 per cent of GSDP and the interest payment to revenue receipts (IPRR) pegged at 4.3 per cent for the financial year 2021-22, which is also within the limit of 15 per cent set by the FRBM Act.

As per the budget estimate for FY 2022-23, fiscal deficit and IPRR are estimated to be 3 per cent and 5.2

The state government, last year, had decided to avail loans from Odisha Mineral Bearing Area Development Corporation fund and compensatory afforestation fund through amendment to the accounting procedures at interest rates 2 to 2.5 pc lower than the open market borrowing. The state government can borrow up to 60 per cent of the surplus fund available in these funds.

The open market borrowing during the last fiscal of 2021-22 is zero because cheaper sources were available to meet the total requirement of borrowing in the previous fi-

nancial year, sources said. Similarly, the total loan guarantees (guarantee to PSUs, urban local bodies, co-operative institutions) as on March 31, 2022 is Rs 6,140.91 crore which is 0.96 per cent

of GSDP. The guarantees do not constitute a part of the state government's loan. But, in case of default hy the state owned entities (PSUs), the state government is liable to repay the loan, sources added.

Additionally, loans and advances, grants for creation of capital assets and other expenditure for capital formation together account for ₹11,933 crore - additional 1.7 per cent of GSDP.

The outlay is proposed to be financed mainly through revenue receipts of ₹1,63,967 crore and borrowing and other receipts of ₹36,033 crore, he pointed out.

A total sum of ₹12,624 crore has been proposed for public health care, which is an increase of about 25 per cent over previous year's provision. Similarly, an allocation of ₹27,324 crore has been made for the education and skill development sector and ₹21.166 crore for agriculture & allied activities.

For conserving and developing the places of religious and cultural importance, the state has allocated ₹1,950 crore under different schemes for FY 2022-23. This includes an outlay of ₹1,325 crore under ABADHA, ₹200 crore each under EKAMRA and SAMALEI, and ₹150 crore under Integrated Development of Heritage, Monuments & Tourists Destinations in the Budget.

Pujari said, "To further improve road infrastructure for the upcoming industrial regions and their connectivity with the mineral hinterlands and ports, it has been proposed to allocate about ₹14,454 crore during the year 2022-23 for construction and improvement of roads in the state.

This apart, around ₹2,970 crore will be utilised for maintenance of the existing roads, he stated.

Similarly, ₹830 crore has been earmarked for tourism sector, ₹911 crore for sports, ₹7,850 crore for rural drinking water supply, ₹7,258 crore for Housing & Urban Development, ₹2,000 crore for Mission Shakti department, ₹2,001 crore under MGNREGA, ₹3,337 crore under social security pension schemes, ₹1,023 crore for ₹1 per kg rice scheme, ₹3,482 crore for power sector, ₹1,269 crore industry & MSME sector, ₹2,217 crore for the forestry sector and ₹3,262 crore for disaster management.

day after the Ministry of Environment, Forest and Climate Change (MoEF&CC) announced its intention to bring about amendments to the Environment, Water and Air Acts for decriminalisation of relatively minor offences; experts have slammed the proposed move terming it as dilution of environmental jurisprudence.

As reported by IANS Friday, the Ministry put out proposed amendments to decriminalise the existing provisions of three important legislations - Environment (Protection) Act, 1986; Water (Prevention and Control of Pollution) Act, 1974; and Air (Prevention and Control of Pollution) Act, 1981

Apart from decriminalisation, the proposed amendments to the three basic building laws also proposes creation of an earmarked fund that can be utilised for paying compensation to the affected parties, for restoration of the environment or for reparation. The three funds are to be named 'Environmental Protection Fund'. 'Water Pollution Remediation Fund' and 'Air Pollution Remediation Fund'.

incentivise compliance and whether the fund creation mechanism can become a distraction from acknowledging the long history of pollution related impacts in many parts of the country.

Leo Saldanha, Coordinator of Bangalore's Environment Support Group (ESG), an advocacy NGO that also files petitions against environmental and forest law violations, drew attention to the exercise of dilution of environmental laws that had started in 2003-04 during NDA-I rule and continued through

till the current dispensation took it to further levels of dilution. Charting out the chronology. Saldahna said that it was in 2004 when then Environment Secretary Pradipto Ghosh had proposed to turn India's environmental jurisprudence based on criminal jurisprudence to civil.

The UPA I and II regimes neither pushed for watering it down nor strengthened it, and also made no attempt to ensure it remained without trampling," Saldahna said.

The TSR Subramanian Report of 2014 was the first major environmental reform brought about by Prime Minister Narendra Modi and this dilution got a boost based on self-regulation by the corporate/industry sector in 'utmost good faith', he said, adding that following the nation-wide outcry and criticism, the then Environment Minister backed out only to bring the Environmental Laws Amendment Bill of 2015, which too was heavily slammed by the civil society.

"Then during the pandemic came the Forest (Conservation) Act, EIA notifications - all pushed back by public pressure. Now, these proposed amendments. The EPA is an umbrella protection law. If you remove this, you are leaving the field open. It will legalise criminality in the garb of decriminalisation and lead to dilution of environmental jurisprudence built over the last four decades," Saldahna warned. IANS

Baripada, July 2: A day after the world famous Rath Yatra at Puri, pulling of chariots of the Holy Trinity was started in Baripada Saturday as per tradition. The Rath Yatra at Baripada, known as the Dwitiya (second) Shrikhetra, is held on the second day of the Puri Rath Yatra.

A woman fainted while trying to catch hold of a rope to pull the chariot of Devi Subbhadra. This allegedly happened as women police officials were not there to control the crowd.

Lakhs of devotees thronged the



Badadanda to witness the Rath Yatra notwithstanding the sultry atmosphere. Many devotees climbed on the chariots to have a close look at the deities. The chariot pulling started at 2.30 pm as per the time schedule set by the endowment department.

The chariot of Lord Balabhadra was first pulled by devotees and it reached the Mausima temple at 4.30pm. Later, the pulling of the Darpadalan chariot of Devi Subhadra started at 5.15 pm and it reached near the Town police station at 6pm. Women from in and

outside the district and from neigh bouring state gathered in large numbers on Badadanda to pull the Darpadalan. It stopped halfway after the sunset.

The pulling of chariots will resume Sunday. The cars of Devi Subhadra and Lord Jagannath will be pulled to Gundicha temple where a set of rituals will be performed.

he jailing of Mohammed Zubair is the latest in a line of miscarriages of justice India's government is inflicting on its citizens. I say India's government because though law and order is a state subject, it is the Union government's agencies under Amit Shah that have been misusing its vast power to destroy the lives of citizens without trial and without conviction.

Zubair, the brilliant fact-checker and founder of AltNews, an alternative news organ that has roiled the pliant media space, is in jail on such a ludicrous charge that it is not worth reproducing. There is no real complainant against Zubair except an anonymous individual who has forwarded a tweet, and the BJP has jailed Zubair and wants to keep him in custody though the tweet he has been jailed for is visible. The government has sent police to his house and 'seized' his property for no reason. Why is it doing all this? Of course the intent is to harass and humiliate and terrorise individuals. Zubair is the person who dug out the BJP spokeswoman's abuse of a religious figure, which led to the government having to eat its words. This current spell of action is retribution and vengeance by our government against a fellow citizen.

The legal scholar Faizan Mustafa has noted that "since the promise of crim-

inal law as an instrument of safety is matched only by its power to destroy, guarantees of due process were accordingly incorporated in the criminal procedure so that every accused person gets a fair trial.

In India the presumption of innocence has been tossed out and replaced with the assumption of guilt. This is why jail is first and everything else later if at all. There was no reason to jail Zubair, just as there was no reason to jail Arvan Khan, on whom no drug or evidence was found. There was no reason to jail Teesta Setalvad, Rhea Chakraborty or Nawab Malik either, other than to make a circus out of the arrests and to punish people using the enormous and disproportionate power that the State holds over individuals.

In the criminal justice system, the State holds all the cards. The prosecution, the police, the courtroom and even the judge come from the State. The accused is alone. This is why justice systems have safeguards in favour of the accused and against the State. That is why we say "innocent until proven guilty" and that is why the burden of proving criminal activity is on the State.

India has reversed that principle on several laws and this is not just under the BJP. The laws of UAPA (on terrorism), NDPS (for narcotics), PMLA (for money laundering) and even on citizenship (the NRC of Assam) push the burden of proof on the individual. Many harsh state laws, such as Gujarat's GUJCOCA (on organised crime) make the condition of getting bail so difficult as to be near impossible. But even without these laws, India is piling the burden onto the individual as we can see in the case of Zubair and the State is enthusiastic about using its destructive power. This is dangerous and the reckless State which the judiciary cannot contain is doing

great damage.

The interest of the State is not in prosecuting, as we can see in the cases of the celebrities who were jailed and denied bail for weeks. Once they secure bail, the government usually loses interest and the case drifts. This is not about the rule of law or the upholding of Constitution. This is about how to harass someone and keep them in jail in the first instance. There are many who are enjoying the fact that activists like Setalvad and journalists like Zubair are in jail without being convicted. These people should realise that there is no benefit to India as a constitutional democracy or modern State from such actions. The world sees this angry state in India wreaking vengeance on individuals with a negative view. Our journey towards becoming a developed and prosperous nation becomes more difficult when the destructive power of the law is misused in the way that it is being done now.

I notice that I have not even once here referred to the positive qualities that Mohammed Zubair and his work have brought to our nation. He is a genuine hero who in another nation would be honoured for having done the sort of work he has done along with his partner Pratik Sinha. It is a sad reflection of our times that such a contribution is not only disregarded by the State and large parts of society but held in contempt and with hatred. This is New India, where our heroes and heroines are vilified and jailed by a State intent on damaging its own people.

#### ■ Tripudiate

f you tripudiate a person, you dance with excitement or figuratively trample on an opponent in triumph. The Oxford English Dictionary marks this as "rare and affected", a reasonable conclusion. It had its time before the public, in the sixteenth and seventeenth centuries, but as writers came to eschew rhetoric and prefer straightforward prose, it gradually fell out of use and had pretty much vanished by the end of the nineteenth century. A typical instance of the type of high-flown language in which it flourished is Thomas Carlyle's History of Friedrich II of Prussia. He recounts the occasion in 1730 when the future king let slip some premature news about the marriage of his sister Wilhelmina to Frederick, the British Prince Of Wales: "Upon which the whole Palace of Charlottenburg now bursts into tripudiation; the very valets cutting capers. making somersets, - and rushing off with the news to Berlin." [Somerset is an old form of somersault, to turn head over heels.] The word is from Latin tripudium, stamping on the ground, which is possibly from words meaning three and foot, indicating a measured dance of some sort, perhaps during a religious ritual. The first sense in English referred to dancing, skipping or leaping for joy or excitement. The sense of trampling on an opponent came into the language only in the nineteenth century. An example is in Love's Meinie by John Ruskin: "And observe also, that of the three types of lout, whose combined chorus and tripudiation leads the present British Constitution its devil's dance, this last and smoothest type is also the dullest.

# **BEYOND ELECTORAL POLITICS**

**AS PARTIES CAN'T ISSUE** WHIPS IN THIS **ELECTION, THE OPPOSITION CAMP IS WORRIED** THAT SOME, **PARTICULARLY TRIBAL MLAS** AND MPs, MAY **VOTE WITH THE RULING CAMP** 

t a time when the country is celebrating its 75 years of Independence, it is really heartening that a tribal and a woman. Droupadi Murmu, is set to get elected as the President of India. Belonging to the Santhal community, she hails from Odisha and is a self-made leader, who was a Minister in Odisha government and later became Governor of Jharkhand Nominated by the BJP-led NDA largest bloc in the electoral college that elects the President, and with BJD and YSR Congress extending support, Murmu's victory is just a matter of time.

Sceptics, however, are refusing to view this beyond symbolism. They argue that the post of President is a ceremonial one and the nomination of a tribal is just an eyewash. True, the post is mostly ceremonial and the power rests with the Prime Minister and his Cabinet, but that doesn't mean the President has no powers. One of the crucial powers vested is that in case of a hung Lok Sabha, it is the President who has the authority to elect the Prime Minister and also dismiss the government if it doesn't have the majority in the Lok Sabha.

The Opposition parties and Leftleaning intellectuals claim the policies of the present dispensation, led by PM Narendra Modi, haven't been fair to the marginalised sections of the country. And opting for a tribal for the top post is just an act of symbolism by the BJP. Their assessment is simply refusing to see the changes happening on the ground.

Over the last years, the BJP has increased its support among the marginalised sections. In the 2019 Lok Sabha elections, 44% of tribals, according to the Lokniti-CSDS post-poll survey, voted for the BJP. In the 2014 Lok Sabha elections, the figure of tribals voting for the saffron party was 38%. Not only tribals, but the BJP has also been able to increase its support among the Dalits. According to CSDS-Lokniti, it got 33% votes of Dalits in 2019 polls, an increase of 9% in com-

parison to 2014.

The Left and the liberals choose not to accept the bitter fact that the BJP is no more a Brahmanical party or a party of the 'uppercastes'. A significant chunk of the backward sections of the society today are its voters. Not only is the BJP ruling at the Centre but in majority of the states because of the tacit support it is getting from these backward sections. So it's quite natural the BJP sees its responsibility to address their issues and aspirations.

At the same time, the Left and the liberals aren't wrong when they say Murmu's nomination has a lot to do with electoral politics. Given the tribal population in many states, of course, this decision is taken by looking at the electoral interests of the party. In a democracy, this isn't wrong either. As Murmu hails from Odisha, it is no secret that the BJP is eveing this eastern state ruled by Naveen Patnaik. Additionally, the calculated move is also taken to ensure electoral benefits in two neighbouring eastern states -- Jharkhand and West Bengal.

In tribal areas of West Bengal, the BJP got electoral benefits in the 2019 polls but failed to keep that momentum in the 2021 Assembly polls. Similarly, the BJP is also focussing on Jharkhand, a state with a significant tribal population, where the party lost in the 2019 Assembly polls due to erosion in tribal support. There are other states such as Madhya Pradesh, Chhattisgarh, Maharashtra and Gujarat with significant tribal populations. The critics are also missing the

point that the nomination of a tribal to the President's post isn't just about electoral politics. The ideological parent of the BJP, the RSS-led Sangh Parivar, has been trying to get a foothold for decades among the backward sections, particularly the Dalits and the Scheduled Tribes. It has been working tirelessly to spread the ideology of Hindutva among these marginalised sections.

By nominating a tribal, the Sangh Parivar wants to clearly convey the message that the Scheduled Tribes have the right to occupy the highest post of the country, which never happened in the past 75 years. Although the BJP and the Sangh Parivar have been able to gain a foothold among these marginalised sections, their target is to consolidate their presence. Also, there are areas where the party and the Sangh still have to grow -- the tribal dominatedareas in the northeast.

In recent times, the BJP has successfully penetrated here, as

Assembly polls. However, BJP's electoral victory has little to do with the party's Hindutva ideology. That's the reason the BJP chose Murmu out of a list of 20 probable candidates this time. Last time, it had nominated Ram Nath Kovind, a Dalit, to enter Rashtrapati

On the other hand, the Opposition has nominated former BJP leader Yashwant Sinha, who was a Union minister in Vajpayee government. He quit the party as he felt ignored by the "New BJP". Sinha's nomination hasn't gone down well within the Opposition too. The supporters of CPM are questioning the party for supporting a former BJP leader and a candidate sponsored by their arch-rival Mamata Banerjee. After quitting BJP last year, Sinha had joined TMC. The tribal party, Jharkhand Mukti Morcha is unlikely to support him as it can't be seen to vote against one of its own. Mayawati's BSP has already announced support for Murmu.

As the parties can't issue whips in this election, the Opposition camp is worried that some, particularly tribal MLAs and MPs, may vote with the ruling NDA camp. The only achievement for the Opposition camp is that this time Telangana CM KCR's Telangana Rashtra Samithi has extended support to Sinha, though last time it had supported NDA's candidate.

That the BJP-led NDA has the upper hand in the presidential polls was known to all. The Opposition could have at least sent a correct political message by nominating a better candidate than Sinha. But it failed to do so, clearly showing its hopelessness and desperation to just fight the BJP without an alternative agenda. On the other hand, supported by its Hindutva agenda, the BJP by choosing Murmu has sent a loud and clear message: it cares about the marginalised sections and is serious about women empowerment. The election of the country's next President is to prove it.

## Don't cancel Russian culture

efore he wrote The Brothers particular, America's efforts to seems to be based on flawed logic. Karamazov or Notes from turn Ukraine into "anti-Russia." Even Russians who do not fully Dostoevsky was sentenced to death by the czarist government for allegedly participating in revolutionary activities, sent to a Siberian prison camp, and forced to perform military service in exile. Nonetheless, it was after returning from Europe, where he spent years living in freedom, that Dostoevsky wrote in A Writer's Diary, that "everyone" has "secretly harbored malice against" Russians, that Russians "were followers and slaves.

With many, if not most, cultural institutions in both Europe and the United States having effectively "canceled" Russian artists and culture, Dostoevsky's words ring truer than ever. As Ian Buruma recently noted. Russians are now increasingly thinking that the Kremlin might have been right all along: Russia really is a "besieged fortress," forever misunderstood and undermined by a hostile West.

Of course, there is something of a chicken-or-egg question at play here. The West's rejection of Russian culture is a response to Russian President Vladimir Putin's launching of a brutal "special military operation" in Ukraine, But that operation, Putin claims, was a response to Western hostility – in

Even Russians who do not fully buy the Kremlin's Ukraine narrative are aghast at the readiness with which the West turned on all things Russian. After World War II. schools continued to teach the German language; orchestras continued to perform Bach and Mozart to full houses; and people continued to read Goethe and Thomas Mann. All of German history and culture was not stained by the crimes of the Nazis

Yet, since Putin launched his war on Ukraine, the Munich Philharmonic orchestra has fired its Russian chief conductor, Valerv Gergiev, and the New York Metropolitan Opera has severed ties with Russia's Bolshoi Theatre. Russian musicians have been excluded from international competitions Some orchestras have even removed Tchaikovsky from their concert programs.

Another great Russian author, Vladimir Nabokov, described the tendency to dismiss a culture as a form of vulgarity. While cutting ties with Russian universities might seem less vulgar than smashing German stores on Nevsky Prospect in St. Petersburg, as Russian nationalists did in the 1910s, the underlying sentiment is the same.

Even in Ukraine's case, the dismissal of Russian art and culture

Of course, if anyone is justified in rejecting Russia, it is Ukraine. But the decision to eliminate Russian literature and language from school curricula is not nearly as straightforward as "throwing out" everything that "somehow connects us with the Russian Empire," as Ukrainian Deputy Minister of Education and Science Andriy Vitrenko put it. The Ukrainian film director

Sergei Loznitsa has urged caution in canceling Russian artists, partly because what makes something "Russian" is not always clear. He was expelled from the Ukrainian Film Academy over his stance, but he makes a good point. In fact, the education ministry's approach to Nikolai Gogol highlights this ambiguity. Though Gogol was born in Ukraine-and his Ukrainian stories will be allowed - he wrote masterpieces like The Overcoat and Dead Souls while living in St. Petersburg and Rome. These works will thus be banned from Ukrainian schools, depriving the country's students of great art by a genius many Ukrainians claim as their own.

In Nikolai Leskov's short story 'The Tale of the Cross-eyed Lefty from Tula and the Steel Flea," Czar Alexander I orders his servant to find a Russian capable of improving upon a small mechanical flea

the czar had brought back from London. Tula's blacksmiths work for days, to no apparent avail. But czar that the Russians had managed to fit the flea with horseshoes, using tiny nails Lefty had forged. It was a masterful achievement, but what was the point?

Invading Ukraine does not serve Russia's national interests. But, like Alexander I in Leskov's story. Putin has a point to make: Russia is a great power, capable of achieving things others cannot. Peter the Great - whom Putin has invoked in his effort to justify the Ukraine  $war\,{-}\,made$  a similar point in the eighteenth century, by reclaiming from Sweden the "Russian lands' on the Baltic coast.

Like so many Russian works, Leskov's story ends in tragedy. After astonishing the czar and the English alike, Lefty engages in a drinking competition with a British sailor in St. Petersburg that ends with him being sent to a hospital for unknown people, owing to his lack of identification. There, Lefty dies, with little to show for the point he so impressively made. Perhaps Putin, too, should be reading Russian literature more closely.

#### Ideological compromise



#### Two arrested for death threats

Durg: Two persons, including a woman, were arrested on Saturday for allegedly giving death threats to a 22-year-old man in Chhattisgarh's Durg district after he shared a social media post in support of former BJP spokesperson Nupur Sharma over her remarks against Prophet Muhammad, an official said. The accused identified as Kunal Sendre alias Kasif (22) and Ritika Bharti (20), both residents of the Gole Bazar area in the state capital Raipur, were arrested from their native places, said Vishwas Chandrakar, City Superintendent of Police (Old Bhilai), Based on the mobile numbers provided by the victim, Raja Jagat, a resident of a town in Durg, the accused were traced and nabbed, he added. Jagat works in a shopping mall located near Gole Bazar area.

#### Cop found dead

New Delhi: A Delhi Police Constable was found dead inside a car here on Saturday, an official said. Deputy Commissioner of Police, Rohini, Pranav Tayal said a passerby informed police about a dead body in a car parked alongside a petrol pump boundary wall at Prashant Vihar around 9 a.m. "On reaching the spot, there was a foul smell from inside a Santro car and the body of a person was found on the driver seat. It was later identified to be of Constable Amandeep Singh posted in Prashant Vihar police station and on casual leave," he said. A crime team of Delhi Police also reached the spot along with forensic experts. "Family members have been informed and the inquest proceedings under section 174 CrPC have been undertaken," DCP Tayal said, adding that no suicide note was recovered from the spot.

#### **Manipur landslide** death toll rises to 29

Imphal, July 2: The toll in the landslide at a railway construction site in Manipur's Noney district climbed to 29 Saturday after eight more bodies were recovered from under the debris, officials said.

Thirty-four people are still missing after a massive landslide hit the Tupul yard railway construction camp on the night of June 29. Inclement weather is affecting the search operations, officials said.

Out of the eight bodies recovered during the day, five are of Territorial Army personnel and one of an employee of a construction company. The two others are yet to be identified. The defence personnel were there to provide security to the construction site. "Eight bodies were found on Thursday and 13 yesterday," an official said.

He said that altogether 34 people, including 14 employees of two construction companies, five villagers and three of the railways, are still missing. Eighteen people were rescued from the site on Thursday.

The search started at 4 am and rescue teams have been advised to proceed with caution

#### **Cops issue lookout** notice against Nupur

Kolkata, July 2: Kolkata police, Saturday, issued lookout notice against suspended BJP leader Nupur Sharma, whose controversial comments about Prophet Muhammad had created nationwide stir and tension last month.

A senior official of the city police informed that they were forced to issue the lookout notice as Sharma did not turn up after she was sent two notices for appearance for interrogation. Kolkata Police is the first to issue a lookout notice against Sharma on this issue.

First, Narkeldanga Police Station, under the eastern suburban division of Kolkata Police, had issued a similar summon to Sharma, asking her to be present for questioning at the said police station on June 20. Then a fresh notice was issued by Amherst Street police station, under Kolkata Police's north and north suburban division, asking Sharma to be present at the police station on June 25.

However, in both the cases, she had sent a last moment email communique to the city police ex-



pressing her inability to appear seeking more time for the same. She also expressed apprehension about security threats if she comes to Kolkata.

The city police official informed that different individuals have filed

# In Chhattisgarh, it is a straight contest between Baghel, BJP

Raipur, July 2: Chhattisgarh is probably the only state in the country where the Congress and especially its Chief Minister have become a big challenge for the BJP. Here the BJP is not competing with the Congress as much as with Chief Minister Bhupesh Baghel. This situation is likely to continue till next year's assembly elections.

There are 90 seats in the state assembly, out of which 71 are occupied by the Congress and only 14 MLAs belong to the BJP. Apart from this, three MLAs are from the Janata Congress Chhattisgarh and two MLAs are from the Bahujan Samaj Party. Overall, the position of the Congress in the Assembly is very strong as it enjoys more than a two-thirds majority in the state. While maintaining this position is a big challenge for the Congress, it is a far cry for the BJP to return

More than the organisation, the pro-activity of Chief Minister Baghel is clearly visible. Here the Congress is Bhupesh Baghel. He had the command of the Congress before 2018 and the party won under his leadership. During the election to strike a chord with the voters, he raised the slogan 'Chhattisgarh ki Char Chinhari Narva, Garwa, Ghurva au Bari, Ella bachana hai Sangwari'. (There are four symbols for the identity of Chhattisgarh, Narva (nala), Garva (cattle), Ghurva (manure of the garbage heap) and Bari (garden), their protection is necessary). After



forming the government, he started

implementing this. Referring to the developing state, Baghel said that important programmes being run in Chhattisgarh using innovation in the public interest are being discussed in other states. "Our main goal is to increase the income of the people. Keeping this in mind, the schemes are being implemented in a better way. Through them, farmers, labourers, youth, women and tribals etc. have started getting ample opportunities to

progress in the state," he stated. Baghel said apart from the four symbols of Chhattisgarh, the Rajiv Gandhi Kisan Nyay Yojana, Godhan Nyay Yojana, Rajiv Gandhi Grameen Bhumiless Krishi Mazdoor Nyay Yojana etc. programmes are bringing change in

the rural economy of Chhattisgarh. On the other hand, BJP MLA Shivratan Sharma says that the Congress government in the state had come with many promises, but not a single public announcement has been implemented. "Every class is upset and annoyed. Due to this, the departure of the Congress government in the assembly elections to be held next year is certain. The BJP will come to power again," he claimed.

The Congress implemented the farmers' loan waiver scheme as soon as it came to power in the state, whereas, through the Godhan Nyay scheme, it made cowsheds and bought cow dung. It also provided employment opportunities to women. Presently, the unemployment rate in the state is the lowest in the country.

# 4 communal incidents in 3 months highlight intel failure in Rajasthan

*In Rajasthan, riots have taken place in Karauli, Jodhpur, Bhilwara and now* the horrific murder in Udaipur, but the intelligence had no clue

Jaipur, July 2: Four incidents of communal violence in three months in Rajasthan have shifted the attention to the intelligence failure in the desert state and now questions are being raised on the governance.

The intelligence failure is being discussed all across the state after the brutal and horrific murder of Kanhaiya Lal, a tailor in Udaipur, the video of which was put on the social media.

In three months, communal riots have been reported in four districts of the state and surprisingly in all these incidents, the intelligence failed to give any input to the district administration.

The riots have taken place in Karauli, Jodhpur, Bhilwara and

now the horrific murder in Udaipur, but the intelligence had no clue.

In Karauli, stone pelting was reported April 2 on the occasion of Ram Navami, but the intelligence had no idea about it. A total of 37 people were arrested while around 140 were booked. Some are still absconding. Several shops were set on fire. The police registered a case against 144 people but till now only 37 could be arrested.

A month later; communal tension erupted at Jalori Gate in Jodhpur triggered by dispute over raising flag of a certain community, near the statue of freedom fighter Bal Mukund Bissa. Internet was suspended for four days. Around 40 people were rounded up, and as usual there was no intelligence about the communal clash.

In Bhilwara, May 5, in the Sanganer area, the fight between the two communities took the form of communal tension. Members of both the communities came on the streets. The police had to shut down Internet for two days. While twenty five people were booked, only a few have been arrested so far. After six days, there was communal tension again in Shastri Nagar area of Bhilwara. The authorities again shut the Internet for a day. Bhilwara police had no intelligence about the communal tension in the area.

Rajasthan Police have formed an SIT to probe if these riots were a part of any conspiracy, a report is yet to be given to the government.

Meanwhile, BJP State President Satish Poonia said that the Udaipur murder has highlighted the complete failure of the law and order as well as of intelligence in the state.

He said, "The Udaipur incident shows how criminals are becoming fearless which highlights the failure of the law and order of the state government. The NIA or central agency comes only when local administration fails. If the police administration and the state government become weak, it is the Home Minister and Chief Minister who have the moral responsibility to maintain law and order. It is regrettable that the CM appealed for peace through Twitter.'

Kochi, July 2: Cochin International Airport Limited (CIAL) Saturday said it has started facilitating technical landing for refueling of flights operating in the nearby international air route

Having established itself as a major airport in the Indian sub-continent and capable of addressing technical requirements for aircraft up to Code E category, the in-built hydrant fuelling system at Cochin Airport meets the quick turnaround requirement of international carriers, it said in a statement here.

The technical landing facility is being done for the first time in the history of Kochi airport.

The last three days saw 9 aircraft flying either in Colombo-Europe or Colombo-Middle East sectors opting for Cochin airport's technical landing capability and uplifted 4,75,000 litres of ATF from Kochi airport, it said.

With the fuel crisis in Sri Lanka looming large, airlines bound to Colombo from the Middle East or flying out from Colombo to the Middle East European destinations started using the route proximity advantage of Cochin airport.

Quick response by CIAL in terms of efficient apron management by making available a fuel hydrant system for such a requirement, more aircraft could effectively be accommodated on the apron without affecting scheduled operations

Since June 29, six flights operated by Sri Lankan Airlines bound to Sharjah, London Heathrow and Frankfurt, two flights operated by Air Arabia to Abu Dhabi and one flight operated by Jazeera Airways bound to Kuwait (all flying out from Colombo) used the technical landing facility of CIAL, the statement said.

CIAL Managing Director S Suhas said the management's prompt response and adaptability to changing situations have helped connect with the foreign carriers and make available its fuel hydrant system to tide over a commercial aviation crisis.

"When we have foreseen the change in fuel distribution dynamics in the region, we upped the ante by recalibrating our apron management systems. Now more airlines have started contacting us and we are sure that this will boost our revenue potentials,' added Suhas.

There are many airports in the world doing more business in technical landing compared to regular operations. The system established at Cochin Airport has the potential to serve more airlines, whether for a planned stopover or for any unplanned technical stopovers, the company said. CIAL said it has started discussions with airlines using this flying route offering to make use of its facility.

### Refuting Cong charge, BJP says Udaipur killer not its party member



New Delhi/Jaipur, July 2: The Congress on Saturday alleged that the main accused in the Kanhaiya Lal murder case in Udaipur was a member of the BJP, which dismissed the claim as "fake news" and an attempt to deflect attention from the "failures of Ashok Gehlot government" in Rajasthan.

At a press conference in the national capital, Congress' media department head Pawan Khera cited Facebook posts showing accused Rivaz Akhtari with local BJP leaders and sought to know whether the Centre had moved quickly to transfer the case to the NIA due to this reason. "Through the posts of BJP leader

Irshad Chainwala on Facebook November 30, 2018, and Mohammad Tahir February 3, 2019, October 27, 2019, August 10, 2021, and November 28, 2019, and other posts, it is clear that the killer of Kanhaiya Lal terrorist Riyaz... Was not only close to BJP leaders, but was also an active member of the BJP," Khera alleged.

He said Rajasthan Chief Minister Ashok Gehlot had welcomed the transfer of this case to the NIA.

However, in light of new facts, the question arises whether the BJPled government at the Centre moved quickly to transfer the case to the NIA due to these reasons, he said and demanded that the BJP come

clean on the issue. Responding to a tweet by a Congress leader, BJP's IT cell chief Amit Malviya said the accused were not BJP members and the opposition party should "stop fooling around" on matters related to national security.

'I am not surprised that you are peddling #FakeNews. The Udaipur murderers WERN'T members of the BJP. Their attempt to infiltrate was like the LTTE assassin's attempt to enter the Congress to kill Rajiv Gandhi," he tweeted.

Congress should stop fooling round with terror and national curity, Malviya said.

Mohammad Sadiq Khan, Rajasthan president of the BJP Minority Morcha, also said the photos cannot be held as proof of Akhtari being a party member.

He alleged that the Congress wanted to shift the blame on the saffron party to divert public attention from the failures of the Ashok Gehlot government which did nothing for minorities in three-and-a-

Anyone can have a photo with any leader. It does not mean that he is a member of the BJP, Khan told

He might have gone to some programme of the party to carry out a recce and got photos clicked with local leaders. Since it is a normal trend to upload photos with leaders or celebrities on Facebook and other social media platforms, he might have also uploaded the photo but it does not mean that he is a BJP member, Sadiq said.

The BJP leader said the murder highlights the state government's failure as it did not provide security to Kanhaiya Lal despite a clear threat.

Khan said Akhtari's vehicle number was 2611, which he obtained by choice in 2013, and this

indicated his radical ideology. BJP leader Kapil Mishra met the family members of Kanhaiya Lal and announced financial help of Rs 1 crore collected through a fundraising initiative.

Kanhaiya Lal, a tailor, was hacked to death Tuesday afternoon by two cleaver-wielding men, who posted online a grisly video of the crime saying they were avenging an insult to Islam. The killing has sparked widespread outrage.

Akhtari and another accused Ghouse Mohammad were arrested hours after the incident while flee-

ing on a motorcycle. Two more people, who were allegedly involved in a recce of Kanhaiya's shop and the conspiracy to kill him, were also arrested later. The four were Saturday remanded in police custody till July 12.

SNAKE-BOATS HAVE SEVEN CENTURIES OF HISTORY, STARTING WITH AN ORDER OF 14TH-CENTURY KING DEVANARAYANAN TO DESIGN WOODEN VESSELS WITH ITS ONE PROW RISING IN THE SHAPE OF A REPTILE'S HOOD

Kochi, July 2: The second edition of the IPL-modelled Champions Boat League (CBL) will be held from September 4 to November 26 across five districts in Kerala, Tourism Minister PA Mohamed Riyas said Saturday.

The inaugural leg of the snakeboat races will be held at Punnamada Lake in Alappuzha alongside the iconic Nehru Trophy Boat Race September 4, the minister announced

at a curtain-raiser event here. Concluding with President's Trophy in Kollam November 26, CBL-2 is being organised by Kerala Tourism as consecutive weekend events - after the inaugural at the sprawling Punnamada Lake, 50km south of Kochi.

CBL-2, like its first edition held in 2019 on the lines of Indian Premier League in cricket, will have half of its legs in Alappuzha district, two each in Kollam and Ernakulam districts and one each

in Thrissur and Kottayam districts. The venues in Alappuzha will be Pulinkunnu, Kainakary, Karuvatta, Pandanadu (Chengannur) and Kayamkulam, besides the district



headquarter city.

Piravom and Marine Drive will be the venues in Ernakulam, while Kollam town and Kallada will be those in Kollam. Thazhathangadi (Kottayam) and Kottapuram (near Kodungallur in Thrissur district) are the other venues.

Besides, there will be an allied round, featuring a competition of small boats, at the Chaliyar river in Kozhikode district, said Riyas, who also unveiled the new jerseys of the nine CBL teams.

The final, which is set to be held at the scenic Ashtamudi Lake, is 60 km north of the state capital of

Thiruvananthapuram. Kerala Tourism Principal Secretary KS Srinivas and Director of Tourism PB Nooh were present at the function.

The debut CBL edition, which was flagged off by Chief Minister Pinarayi Vijayan in the presence of cricket legend Sachin Tendulkar in August 2019, featured nine teams and carried prize money totalling Rs 5.86 crore.

Tropical Titans (traditionally Pallathuruthy Boat Club) turned out to be the winners by scoring 173 points, followed by Raging Rowers (Karichal) and Mighty Oars

(NCDC Devas). Snake-boats have seven centuries of history, starting with an order of Chembakassery principality's 14th-century king Devanarayanan to design wooden vessels with its one prow rising in the shape of a reptile's hood.

The ruler won the battle in the sprawling backwaters, earning more reputation to the 138-footlong boats as multipurpose

The looks of the boat made from wild jackfruit tree remain unchanged in the present times; only that CBL rules permit the number of rowers to be between 80 and

100 (when the capacity can be 150). Kerala has a string of local boat races, but the first among them to gain national prominence was the

Nehru Trophy Boat Race (NTBR). That was in 1952, when the then Prime Minister Jawaharlal Nehru was accorded welcome as the chief guest at the boat-race on the Punnamada Lake in water-logged Kuttanad. So excited was Nehru on seeing the racing boats that he got into one of them and went on to donate a silver trophy before re-

turning to Delhi. If NTBR subsequently earned Kerala international fame, CBL has further strengthened the state's

legacy of snake-boat races. Though conceived as an annual event, the CBL missed its 2020 and-'21 editions owing to the outbreak of Covid-19.

#### SpiceJet flight returns to Delhi

The police had produced Zubair before the court on expiry of his five-day custodial interrogation, and urged it to send him to 14day judicial remand, saying they might need his custodial interrogation later. "Since the matter is at the initial stage of investigation and considering overall facts and circumstances of the case and nature and gravity of the offences alleged against the accused, no ground for grant of bail is made out. Bail application of accused is accordingly dismissed. Accordingly, accused is remanded to judicial custody for 14 days," the judge said in the eight-page order. The judge considered addition of new sections during the course of investigation while rejecting the bail application.

MHA amends FCRA rules PRESS TRUST OF INDIA

New Delhi, July 2: The Union Home Ministry has amended certain rules related to the Foreign Contribution (Regulation) Act (FCRA) allowing Indians to receive up to Rs 10 lakh in a year from relatives staying abroad without informing the authorities.

The earlier limit was Rs 1 lakh. In a notification, the home ministry also said if the amount exceeds, the individuals will now have 90 days to inform the gov-

ernment instead of 30 days earlier. The new rules, Foreign Contribution (Regulation) Amendment Rules, 2022, were notified by the home ministry through a gazette notification Friday night.

"In the Foreign Contribution (Regulation) Rules, 2011, in rule 6, for the words "one lakh rupees", the words "ten lakh rupees" shall be substituted; and for the words "thirty days", the words "three months" shall be substituted," the notification said. Rule 6 deals with intimation of receiving foreign funds from relatives.

It stated earlier that "any person receiving foreign contribution in excess of Rs 1 lakh or equivalent thereto in a financial year from any of his relatives shall inform the central government (details of funds) within 30 days from the receipt of such contribution"

Similarly, making changes in rule 9, which deals with application of obtaining 'registration' or 'prior permission' under the FCRA to receive funds, the amended rules have given individuals and organisations or NGOs 45 days to inform the home ministry about bank account (s) that are to be used for utilisation of such funds.

# Political weather in HP a little too rough for lotus to bloom

Shimla, July 2: The political weather in Himachal Pradesh, it seems, in the assembly election vear is a little rough for the lotus to bloom -- at least for the time

As the silent rebels within the BJP continue to prick, the task also appears to be uphill for the main rival Congress, which is largely banking on a trend to sweep the polls as both the Congress and the BJP ruled the state alternatively from 1985.

Political observers say though the ruling BJP, which believes the forthcoming assembly polls is a

semi-final ahead of the final of the 2024 parliamentary polls, has somehow managed an edge over its seemingly 'faction-ridden' rival by signalling about its chief ministerial candidate well ahead of the yearend assembly polls, the Congress is still a "divided house" in the absence of a mass leader like the late Virbhadra Singh, who had devoted over 50 years to the common man.

Sensing a threat from the Aam Aadmi Party (AAP) after its emphatic win in neighbouring Punjab by crushing the traditional players that ruled the state for over seven decades, Bharatiya Janata Party (BJP) chief J.P. Nadda, who has his roots in Himachal Pradesh, in



April announced that the party will not replace Chief Minister Jai Ram Thakur and the assembly elections will be contested under

his leadership. His assertion came in the wake of a claim by AAP leader Manish Sisodia that Union minister Anurag Thakur will replace Jai Ram Thakur as Chief Minister to counter anti-incumbency. The Congress, under the leadership of state party chief Pratibha Singh, wife of six-time Chief Minister Virbhadra Singh, is struggling to speak unitedly about the key issues to put the government in the dock relating to corruption, deteriorating law and order, rising debt, an education scam for selling more than 45,000 fake degrees and the constable recruitment question paper leak that was sold for Rs 6 lakh to Rs 8 lakh.

A strong anti-incumbency wave against the ruling BJP is evident from the loss of three Assembly and one parliamentary seat in the October 2021 by-polls.

Confident of repeating the government on the basis of performance, senior BJP minister Suresh Bhardwaj said Friday, "Though the BJP is always ready for elections,

but that is not our priority." "Our government works for the people's welfare. In Himachal, our government led by Chief Minister Jai Ram Thakur under the guidance of Prime Minister Narendra Modi has initiated several steps in the public interest. "We have enhanced the ambit of social security pensions, Ayushman scheme by rolling out Himcare, free power within certain limits, low bus fare for the women, reduced fare for others, etc. There are so many other steps taken by our government. The BJP is strong with the people's blessings and ready for the 2022 assembly polls." A confident four-time legislator, Bhardwaj said the party has just organised conventions of booth-level office-bearers in all four Lok Sabha segments. "This (assembly polls) is just like a semifinal, while the final is the 2024 Lok Sabha elections. We will win the semi-final in the state's interest and strengthen Modi ji for the final in the nation's interest.

#### Strong quake kills 5 in Iran

Tehran: Five people were killed and 44 others injured in a magnitude 6.3 earthquake in southern Iran Saturday, state television reported. Rescue teams were deployed near the epicenter. Sayeh Khosh village, which is home to around 300 people in Hormozgan province, some 1.000 kilometers south of the capital, Tehran, the report said.

#### **Gunmen attack** anti-polio team

Peshawar: Gunmen have opened fire at a polio vaccination team in northwest Pakistan bordering Afghanistan, injuring a worker, police officials said Saturday --- the latest attack on vaccination teams in recent years by militants in the restive region. Unidentified assailants attacked a polio vaccination team in Mir Ali tehsil in North Waziristan tribal district Saturday, which left a worker named Sher Ali injured, police said. Ali was immediately admitted to a local hospital, where he is undergoing treatment, they said.

#### **Protesters storm** into Libyan Parl

Benghazi: Demonstrators broke into the building that houses the eastern Libyabased parliament in Tobruk Friday, setting fire to parts of it amid protests over months of failed efforts to set the divided country on a path toward elections. One witness Taher Amaizig, said thousands ioined a march to the parliament building calling for the current political powers to be dissolved and elections to be held. He said that as security guards tried to prevent people from entering a protester was shot in the legs and other demonstrators then forced their way inside.

#### **WWII-era boat** emerges in US

Las Vegas: A sunken boat dating back to World War II is the latest object to emerge from a shrinking reservoir that straddles Nevada and Arizona. The Higgins landing craft that has long been 56 metres below the surface is now nearly halfway out of the water at Lake Mead. The boat lies less than a mile from Lake Mead Marina and Hemingway Harbour. It was used to survey the Colorado River decades ago, sold to the marina and then sunk, according to dive tours company Las Vegas Scuba.

# Monkeypox cases triple in Europe: WHO

London, July 2: The World Health Organization's Europe chief warned Friday that monkeypox cases in the region have tripled in the last two weeks and urged countries to do more to ensure the previously rare disease does not become entrenched on the continent.

And African health authorities said they are treating the expanding monkeypox outbreak as an emergency, calling on rich countries to share limited supplies of vaccines to avoid equity problems seen during the Covid-19 pandemic.

WHO Europe chief Dr Hans

Kluge said in a statement that in creased efforts were needed despite the UN health agency's decision last week that the escalating outbreak did not yet warrant being declared a global health emergency.

"Urgent and coordinated action is imperative if we are to turn a corner in the race to reverse the ongoing spread of this disease," Kluge said.

To date, more than 5,000 monkeypox cases have been reported from 51 countries worldwide that don't normally report the disease. according to the US Centers for Disease Control and Prevention. Kluge said the number of infections in Europe represents about



90% of the global total, with 31 countries in the WHO's European region having identified cases.

Kluge said data reported to the

WHO show that 99% of cases have been in men — the majority in men that have sex with men. But he said there were now "small hold contacts, including children. Most people reported symptoms including a rash, fever, fatigue, muscle pain, vomiting and chills.

Scientists warn anyone who is in close physical contact with someone who has monkeypox or their clothing or bedsheets is at risk of infection. Vulnerable populations like children and pregnant women are thought more likely to suffer severe disease.

About 10% of patients were hospitalised for treatment or to be isolated, and one person was admitted to an intensive care unit. No deaths have been reported.

#### Pak journalist attacked for criticising army

Lahore, July 2: Senior journalist and political analyst Ayaz Amir was assaulted by unidentified men in Lahore Friday night, a day after he termed Pakistan's Army generals property dealers.

Amir (73) was returning home after his TV programme on Dunya News was intercepted by unidentified men. He claimed that he was dragged out of the car and thrashed.

With bruises on his face, Amir alleged that the masked men not only hit him and tore his clothes, they also took away his cell phone and wallet. They left when people started gathering on the busy road.

On Thursday, during a speech at a seminar in Islamabad on the 'Regime Change and its Fallout on Pakistan', Amir targeted the powerful military establishment for its role in Pakistan's politics. The seminar was also attended by former prime minister Imran Khan.

He referred to the Army generals as property dealers and even suggested removing the portraits of Muhammad Ali Jinnah and Allama Iqbal and replacing them with the property dealers.

In an indirect reference to Army chief Gen Qamar Javed Bajwa, Amir said he was into his sixth year of tenure and looking for another extension.Parts of Amir's speech have gone viral on social media. Journalists, lawyer bodies and rights activists condemned

### **Blasts rock Ukrainian city 'TRADE-DISTORTING PRACTICES'** 12 lawmakers urge Biden to hold India as Russia grinds out gains

Washington, July 2: A group of US lawmakers have urged President Joe Biden to file a formal request for consultations with India at the World Trade Organisation (WTO) over its dangerous trade-distorting practices.

The 12 Congressmen, in a letter to Biden, stated that current WTO rules allow governments to subsidise up to 10 per cent of the value of commodity production. However, the Indian government

continues to subsidise more than half of the value of production for several commodities, including rice and wheat, they said.

India's lack of rule-following and the Biden administration's lack of enforcement have reshaped the global agricultural production and trade channels by driving down prices, depressing production of rice and wheat commodities, and putting American producers at a disproportionate disadvantage, the Congressmen alleged in the letter.

India's practices are dangerously trade-distorting on a global scale and impact US farmers and ranchers, the letter read. The lead in the letter was taken by Congressmen Tracey Mann and Rick Crawford.

'We urge the administration to file a formal request for consultations with India at the WTO and to continue monitoring other WTO



members' domestic support programmes that undermine fair trade practices," they said.

The US must not yield for the sake of reaching a consensus. Instead, America must work to promote solutions that will alleviate the global supply chain and food shortages. It must take actions that will address those consumers most impacted by inflation and rising food prices, the lawmakers demanded.

"It is up to the American agriculture to contribute to building resilient conditions for food security for the US and throughout the world," they said.

India has defended its stand at he WTO. Several countries and organisations across the world have applauded India for taking a firm stand in protecting the interests of its farmers

Kyiv/Konstyantynivka, July 2: Blasts shook Ukraine's southern city of Mykolaiv Saturday as Russia's artillery helped grind out gains in the east, after a week when the civilian death toll from Russian missile strikes climbed in urban centres well behind the frontline.

'There are powerful explosions in the city! Stay in shelters!" Oleksandr Senkevych, mayor of the Mykolaiv region which borders the vital Black Sea port of Odessa, wrote on the Telegram messaging app as air raid sirens sounded.

The cause of the blasts was not immediately clear, although Russia later said it had hit army command posts in the area. Reuters could not independently verify the reports.

Kyiv says Moscow has intensified missile attacks on cities far from the main battlefields in the country's east and that it deliberately hit civilian sites. Ukrainian troops on the eastern frontlines meanwhile describe intense artillery barrages that have pummelled residential areas.

Russia says it has targeted military sites and denies aiming at civilians. Kremlin spokesperson Dmitry Peskov said "Russian Armed Forces do not work with civilian targets"

### NY bans guns in many places

New York, July 2: New York state passed a law Friday banning guns from many public places, including Times Square, and requiring gunlicense applicants to prove their shooting proficiency and submit their social media accounts for review by government officials.

The law, passed in an emergency legislative session, was forced by a landmark US Supreme Court ruling last week that struck down New York's restrictive gun-license laws. The court's conservative maiority ruled for the first time that the US constitution grants an individual the right to carry weapons in public for self-defense.

New York's Democratic leaders have decried the ruling and the court, saying there will be more gun violence if there are more people carrying guns.

They conceded they must loosen the state's century-old permit scheme to comply with the ruling, but sought to keep as many restrictions as they could in the name of public safety. Some will likely be targets for further legal challenges.

The court ruled that New York's former license regime, which dates from 1911, gave too much discretion to officials to deny a permit.

The law passed Friday makes it a felony crime to carry a gun into a new list of sensitive places, including government buildings, medical facilities, places of worship, libraries, playgrounds, parks, zoos, schools, colleges, summer camps, addiction-support centers, homeless shelters, nursing homes, public transit including the New York City subway, places where alcohol or marijuana is consumed, museums,

# Google to delete location history when users visit abortion clinics

United States, July 2: Google announced Friday it would delete users' location history when they visit abortion clinics, domestic violence shelters and other places where privacy is sought.

"If our systems identify that someone has visited one of these places, we will delete these entries from Location History soon after they visit," Jen Fitzpatrick, a senior vice president at Google, wrote in a blog post. This change will take effect in the coming weeks.

Other places from which Google will not store location data include fertility centers, addiction treatment facilities, and weight loss

The announcement comes a week after the US Supreme Court made the tectonic decision to strip



American women of constitutional rights to abortion, leading a dozen

states to ban or severely restrict the procedure and prompting mass protests across the country.

Activists and politicians have been calling on Google and other tech giants to limit the amount of information they collect to avoid it being used by law enforcement for abortion investigations and prosecutions. Fitzpatrick also sought to reassure users that the company takes data privacy seriously.

Google has a long track record of pushing back on overly broad demands from law enforcement, including objecting to some demands entirely, she wrote.

We take into account the privacy and security expectations of people using our products, and we notify people when we comply with government demands.

Concerns over smartphone data and reproductive rights arose even before the Supreme Court ruling, when several conservative US states in recent months passed laws that give members of the public the right to sue doctors who perform abortions - or anyone who helps facilitate them.

That led a group of top Democratic lawmakers in May to send a letter to Google chief executive Sundar Pichai, asking him to stop collecting smartphone location data lest it become a tool for far-right extremists looking to crack downon people seeking reproductive health care.

"It has been noticed that taxpayers are facing issues in accessing ITD e-filing portal. As informed by @Infosys, they have observed some irregular traffic on the portal for which proactive measures are being taken," the I-T department tweeted.

The new e-filing portal www.Incometax.Gov.In, launched on June 7, 2021, had a bumpy start with taxpayers and professionals reporting glitches and difficulties in its functioning. Infosys was given the contract in 2019 to develop the portal.



More recently, the portal faced snags on the first anniversary of its launch and many users complained that they were unable to log in into the portal, while some complained malfunctioning of the search functionality. The government has paid ₹164.5 crore to Infosys to build the new income tax e-filing portal.



# INDIA HOLD ALL ACES

#### BUMRAH'S SPLENDID ALL-ROUND SHOW, ALONG WITH JADEJA'S TON, HELPS VISITORS PUSH ENGLAND INTO BACKFOOT

Birmingham, July 2: Skipper Jasprit Bumrah (31 no, 16b, 4x4, 2x6; 3/35) held sway with a mesmerizing all-round performance, which included a world record feat with the bat and an incisive spell with the ball as India seized complete control from England on a rain-hit second day of the rescheduled fifth Test here Saturday.

Such was the power of Bumrah's all-round show in his first appearance as India captain that it easily overshadowed Ravindra Jadeja's superbly constructed third Test hundred (104, 194b, 13x4) that took India to a commanding first innings score of 416.

England were in all sorts of trouble with half of the team back in the pavilion with the scoreboard reading a sorry 84/5 with the hosts 332 runs behind the visitors.

In the first session, Stuart Broad must have had a feeling of 'deja vu' when he was literally butchered by the stand-in Indian captain, who scored 29 runs with the willow and also was gifted six extra runs to make it 35, highest ever in a single over in Test cricket.

Broad can't be faulted if he remembered that September, 2007 night in Durban, when Yuvrai Singh pummelled him for six sixes in an over. He got his 550th Test wicket on the day but by the end of it all, Bumrah had wiped that wry smile off his face.

When England came out to bat, the skipper had nicely warmed up and bowled a menacing first spell and for a change was rewarded for even putting his 'foot wrong' on two occasions that resulted in ad-



ditional deliveries which fetched him a couple of wickets.

After two days of play, India held all the aces and look good to retain the Pataudi Trophy and stay in contention for a place in the World Test Championship final.

Bumrah was good with his bowling changes, field placements and also DRS call of his own bowling. In all, a complete package in place.

At the start of the day, Jadeja reaffirmed his status as India's most valuable player across formats as he scored his best Test hundred. This century, though, was of a far better quality than his earlier two, especially if one factors in the conditions, match situation and qual-

ity of opposition bowling. Having already scored 2500 runs in Test cricket alongside taking 242 wickets, Jadeja can safely be termed as the best all-rounder that the Indian team has had since the great Kapil Dev. A Test batting average of 37 plus is better than many specialists who have played for

The Indian captain, in fact, gave the hosts a dose of 'Bazball' (Brendon McCullum's attacking philosophy), which had become a trending lingo in English cricket during the past few weeks.

While Rishabh Pant's century for the ages and Jadeja's third Test ton set up the platform, one can't discount the 93 runs that India added with contributions from No.9, 10 and 11.

As far as England's bowling is concerned, James Anderson (5/60), who is a month shy of turning 40, is still class personified, as he got his 32nd five-wicket haul in Test matches. But 40 extra runs, including 14 no balls, will certainly haunt England in the long run.

Once he came out to bowl, Bumrah had by then already known left-handed opener Alex Lees' (6) weaknesses. He went round the wicket and got one to nip back slightly with the angle as it breached the opener's defence.

In case of Zak Crawley (9), Bumrah bowled a fuller delivery on the 'fourth off-stump' and Crawley's drive was snapped up by Shubman Gill stationed at third slip. Similarly, after another rain break, he tested Ollie Pope (10) with another fuller delivery that was slightly wider and the expansive drive only ended in Shreyas Iyer's hands in the second slip.

But India saved their best for the last as Mohammed Siraj got one to rear up awkwardly with wobbly seam as England's best batter Joe Root (31) could only get into a tangle and offer a simple catch to Pant behind stumps.
