# Lady cop's MUV kills 3

The driver of the vehicle was allegedly moving on the wrong side of the road before ramming into an auto-rickshaw and two-wheeler

Sonepur, July 12: When protectors of law break it, then danger looms large. Rash driving and brazenly ignoring the law by moving on the wrong side of the road by the driver of a cop's vehicle turned fatal and claimed three lives and injured five others on NH-57 near Badabahali Chhak early Monday morning in Subranapur district. The 'Maruti Ertiga' MUV going at high speed on the wrong side of the road first hit an auto-rickshaw and then a two-wheeler leading to the death of three persons including a woman. Later in the evening, police informed that the driver of the vehicle and Ajit Jethi and inspector Snigdharani Suna, who was present in the vehicle when the accident occured have been arrested from Bolangir: They had both fled the spot after the accident. Police were bringing the arrested duo to Sonepur for questioning. Earlier in the day, Sonepur SP Amaresh Panda blamed the MUV driver for the mishap. He informed that the vehicle bearing registration number OD16J 1355 belonged to Suna. She was returning to Bolangir on completion of her Rath Yatra duty in Puri when the mishap occurred. Sources said that Suna being a

'The woman inspector was travelling in the car. They fled the spot after the mishap. We have already informed her posting authorities-SP Rourkela and DIG Rourkela. We will nab the driver soon," Panda had assured after the mishap

The three deceased have been identified as Guabati Jai (40), Satya Pradhan (45) and Prananath Biswal (45). The injured were rushed to a hospital nearby for treatment. All of them were vegetable vendors going to weekly market nearby.

Chief Minister Naveen Patnaik expressed grief over the death of the three persons and prayed for speedy recovery of the injured ones. He announced ₹2 lakh ex-

gratia to the next of kin of the deceased and free treatment for the injured persons.

The mishap sparked tension with local residents blocking the road demanding compensation and arrest of the woman cop. Panda. who held discussion with the protestors, said, "The district administration will ensure that the families of the deceased get compensation at the earliest and the culprits will be booked."

DCP Prateek Singh said that the cops have till date interrogated 198 students, close relatives, friends, batch mates, seniors and juniors of Ruchika, and college hostel staffers. However, none of them have given any information to support the ragging allegations. The cops have also interrogated all the students in the hostel but they haven't confirmed anything on allegations of ragging. They have also not come out with any statement regarding the victim suffering from mental depression.

Singh informed that the police will continue interrogation of students. A psychiatrist has been roped in to ensure that students do not face any mental agony.

Singh also revealed that a 'confidential' phone number has been given to the students in case they want to provide any vital information. He also claimed that Ruchika's room has also been searched thoroughly by the officials of scientific team.

"We are trying to retrieve data from the mobile phone recovered from Ruchika's room. However, we have not been successful in doing so. Now we are sending the phone to Singapore to retrieve data stored in it. We do not want to lose any crucial information," Singh said.

Sources said later in the day that an official has already left for Singapore via Mumbai with the victim's phone.

Meanwhile the parents of the victim continued Tuesday with their demonstration at PMG Square here seeking justice for the victim.

Ruchika's father informed that some of the students are being pressurised not to say anything. "Some of them have told us that the warden and the superintendent are threatening them not to disclose anything. These officials have to be removed, otherwise a proper probe cannot take place," he said. On the other hand, Ruchika's mother said that she has no faith in police investigation.

# Balasore may get RBI's 5th currency printing press

Balasore, July 12: A three-member team of Reserve Bank of India (RBI) visited Tuesday a couple of places in Balasore district to take stock of availability of suitable land for establishment of a press required for printing currency notes and paper, sources said.

The team members upon their arrival met District Collector Dattatrava Bhausaheb Shinde and held discussions regarding the project. Reports said that over 100 acres of land is required in two places for establishment of the printing press

Later, the RBI team left for

Padabadagaon locality under Remuna block to carry out a land survey for the project Remuna tehsildar Chhabirani Sahu and IDCO officials from here and Bhubaneswar accompanied the team.

The RBI team surveyed the government land at Padabadagaon and examined the communication facilities available in the area. Later, the team visited Baunsamuhan and Naraharipur areas under Remuna block and examined the various government and private lands available in the locality. Sources said that work will start on the project after the team identifies

# 'Menacing' lions spark emblem row

Some Opposition parties took a swipe at Modi stating that the new symbol conveys the true nature of a human

New Delhi, July 12: Opposition members and activists among others accused Tuesday the government of distorting the national emblem by replacing the 'graceful and regally confident' Ashokan lions with those having menacing and aggressive posture and sought immediate change.

'Narendra Modi Ji, please observe the face of the Lion, whether it is representing the statue of Great Sarnath or a distorted version of GIR lion. Please check it and if it needs, mend the same," Adhir Ranjan Chowdhury, Leader of the Congress in the Lok Sabha, said on Twitter.

Prime Minister Narendra Modi had Monday unveiled the cast of

the national emblem atop the new Parliament building. The Opposition had hit out at Modi for flouting constitutional norms and not inviting opposition leaders for the event.

"Insult to our national symbol, the majestic Ashokan Lions. Original is on the left, graceful, regally confident. The one on the right is Modi's version, put above the new Parliament building - snarling, unnecessarily aggressive and disproportionate. Shame! Change it immediately," TMC Raiva Sabha member Jawahar Sircar said on Twitter sharing two different images of the national emblem.

Historian S Irfan Habib also objected to the new lions. "Meddling with our national emblem was totally unnecessary and avoidable. Why should our lions look fero-



cious and full of angst? These are Ashoka's lions adapted by independent India in 1950," Habib said. Senior lawyer and activist Prashant Bhusan also joined in the chorus of protests. "From Gandhi



to Godse; From our national emblem with lions sitting majestically & peacefully; to the new national emblem unveiled for the top of the new Parliament building under construction at Central Vista; Angry

lions with bared fangs. This is Modi's new India," Bhushan said.

Lalu Prasad Yadav's Rashtriya Janata Dal (RJD) tweeted that the lions in the national emblem are known to have a mild expression, but those on the new sculpture appear to have a 'man-eater tendency'. The RJD's official handle tweeted in Hindi, "The original emblem has a mild expression, but those built during 'Amrit Kaal' show a man-eater's tendency to consume everything in the country. Symbols convey the true nature of a human.

The designers of the massive sculpture Sunil Deore and Romiel Moses, however, claimed that there is 'no deviation'. "We've paid attention to detail. The character of lions is same," they said. - P9

# FAKE LOAN APP CASE **Lookout circular against Chinese national**

The EOW has so far received over 100 complaints from Odisha related to Liu Yi's illegal and abusive activities

Bhubaneswar, July 12: The Bureau of Immigration has issued a lookout circular against Chinese national Liu Yi for his alleged involvement in duping people through fake loan applications at the request of the Economic Offences Wing (EOW) of Bhubaneswar, a police official said Tuesday.

Yi is the prime accused in a case lodged in EOW police station here April 21, 2022, under various Sections of the IPC and IT Act.

The EOW has already arrested five accomplices of Yi and is in touch with various state police on his illegal activities. It has conducted raids in Mumbai, Bangalore and Delhi and has frozen more than Rs 6.57 crore

A lookout circular is generally issued to alert immigration check posts at airports and seaports to alert law enforcement agencies if the wanted person tries to leave the country or arrive in it from a foreign place.

According to the EOW, Yi used to run many illegal digital loan apps in India like KOKO Loan, **MODUS OPERANDI**

Day Loan among others. The EOW said that there are more than 1.5 lakh downloads in one of the apps and it is suspected that lakhs of people across the country, particularly those from the lower middle class in need of small loans, especially during difficult times

of Covid, have been cheated or exening calls to the loanees. It said Yi, whose parent company Jianbing Technology was at Hangzhou in China, had started

> his illegal business in India in 2019 from Bangalore. He is the director of Omlette Technology Private Limited and indirectly controls and owns other shell companies.

The release said that there are at least two more Chinese persons who assisted Yi in the scam. They used to make Yi's employees or any vulnerable and needy person directors of the shell companies but actually used to control and operate the companies and bank accounts. They also used many call centres to make abusive and threat-

downloaded in a customer's mobile play store, a small amount ranging from Rs 3,000 to Rs 10,000 was credited to his/her bank account. Within a week the customer or borrower is asked to repay the amount at an excessive rate of interest.

If the person refused to pay the high rate of interest he/she is humiliated and bullied in many ways, the EOW said.

Obscene messages and indecent pictures along with abusive texts in filthy languages are sent to his/her WhatsApp number and as well as to his/her contact list as a coercive measure to recover the loan amount with interest.

"This process of recovery is so overbearing and humiliating that there are some instances of customers committing suicide," the EOW release said.

There have been already more than 1.5 lakh downloads of KOKO and JOJO loan apps and the EOW has received more than 100 complaints from Odisha related to Yi's illegal and abusive activities.

The EOW has issued advisory on the illegal loan apps to contain them and to create awareness among the public about using them. If someone has already downloaded or used the illegal loan apps they should not tolerate any harassing behaviour, but report the matter to the police.

Bhubaneswar, July 12: The state government has withdrawn its order restricting journalists from entering the premises of schools in some areas following a statewide outrage against the move.

The government instruction has been sent to the block education officers withdrawing the July 8 order. The block education officer of

Kankadahad in Dhenkanal district in a fresh notification issued Monday to all headmasters of government schools in the area said ... As per the instruction of the District Magistrate-cum-Collector, Dhenkanal dated 11.07.2022 in the joint public grievance redressal held at Panchayat Samitee Office, Kankadahad regarding unauthorized entry of media persons in the school premises, this office letter No 1066 date 08.07.2022 which was issued earlier is hereby withdrawn," the letter said. In the face of statewide protest against the government's decision to prohibit the entry of journalists in schools, Dhenkanal collector Saroj Kumar Sethi has clarified that scribes had not been completely barred. They were allowed to enter the premises after school hours to collect information.

"Media persons can enter the school premises and discuss matters with the managing committee after the school hours as the visits disturb students when their classes are on. Disturbance during class hours will psychologically impact the minds of the students," he said.

The state's ban on the entry of\_ journalists to schools in some areas came after some TV news channels showed how students were poor in mathematics and triggered a political row.

# Covid virus may survive for 30 days on refrigerated, frozen meat: Study



he SARS-CoV-2 virus, which causes Covid-19, may survive on meat and fish products in the refrigerator or the freezer for up to 30 days, a study suggests.

The research, recently published in the journal Applied and Environmental Microbiology, was conducted using chicken, beef, pork, and salmon, and surrogate viruses with spikes similar to those on SARS-CoV-2.

The researchers stored the meat and fish products at both refrigeration (4 degrees Celsius) and freezer temperatures (minus 20 degrees C).

"Although you might not store meat in the fridge for 30 days, you might store it in the freezer for that long," said

study first author Emily S. Bailey, an assistant professor at Campbell University in the US.

"We even found that the viruses could be cultured after (being frozen for) that length of time," Bailey said in a statement

The researchers undertook the study after learning that Covid-19 outbreaks were occurring in Southeast Asia prior community transmission.

"Reports from those communities suggested that packaged meat products, produced in areas where SARS-CoV-2 was circulating, could have been the source of the virus," said Bailey

"Our goal was to investigate whether or not similar viruses could survive in

this environment," she said.

The research is important because SARS-CoV-2 can replicate within the gut. as well as in the respiratory tract, said Bailey

In the study, the researchers used one RNA virus with a lipid envelop, and two animal coronaviruses, murine hepatitis virus, and transmissible gastroenteritis virus as surrogates.

All three viruses have previously been used as surrogates for SARS-CoV-2, generally with greater reductions in their numbers observed at refrigeration than at freezing temperatures.

The reduction in numbers also varied according to the food item used

"Continued efforts are needed to prevent contamination of foods and food processing surfaces, worker hands, and food processing utensils such as knives," the researchers noted.

"The lack of, or inadequate, disinfection of these foods prior to packaging needs to be addressed," they added.

# **Open drains death trap** for Balimela residents

Malkangiri, July 12: Pedestrians of Balimela in Malkangiri district face a constant threat of falling into open drains, thanks to a number of drains left uncovered in the area. At least 80% of the drains are uncovered in Balimela area alone. thereby putting the lives of many including the elderly, kids and domestic animals in risk.

On many roads, drains as deep as 5 feet remain open as slabs are either absent or damaged. It is alleged that pedestrians and cattle often fall into the drains and get injured, but the civic body does not consider it an issue serious enough to merit its attention. The authorities seem to be waiting for some tragic accident to occur be-

Despite the state government spending crores of rupees for development works, the grim condition of the drains in Balimela is worrisome.

"Recently, a child fell in a drain and got injured. Luckily, a few passers-by saw him and pulled him out immediately. Otherwise, the accident could have been fatal," a local said on condition of anonymity.

"We fear to send our children for tuitions and to school. A little carelessness and they might end up losing their lives," a guardian said.

Furthermore, residents are worried about the stagnant water in the drains spreading vector-borne diseases. Residents have alleged that filth from these drains litter the surrounding areas "Sometimes, the drain water enters into our compounds during heavy rain. The choked drains are also the breeding ground for mosquitoes," another local alleged. When contacted, Balimela executive engineer refused to comment over the issue.



As per the letter, Kahna has been arrested several times in the past for involvement in drug peddling. However, he again engaged in illegal trade after coming out of the jail on interim bail each time. Nath along with his associates has been selling drugs to innocent students and others in various parts of the city. There are six cases pending against Nath at different police stations of the city.

# Centre proposes to decriminalise some sections of Indian Forest Act

New Delhi, July 12: Continuing the spree of public notices for amendments to its various acts at a pre-draft stage, the Ministry of Environment, Forests and Climate Change has now proposed decriminalisation of certain sections of the Indian Forest Act, 1927.

During last 10 days, the Ministry has issued similar notices seeking input/feedback from public and experts for decriminalisation of environment, water, and air acts

It has also brought out notification for changes in Forest (Conservation) Act that has become a bone of contention between the opposition Congress and the government. Now, the Ministry said it is



a tree to decriminalise certain sections of the law, including carrying

The Indian Forest Act. 1927 provides a legal framework for the protection and management of forests, transit of forest produce

and timber and the duty leviable on forest produce and timber.

As per the public notice, a person who kindles, keeps or carries any fire, permits cattle to

pasture or trespass, or causes damage by felling of a tree or dragging timber through the forest was earlier penalised with six months imprisonment or a fine upto Rs 500 or both. Now, the penalty proposed is simply a fine of Rs 500.

Explaining its reasoning, a senior Ministry official said that at times there are difficulties in differentiating between major and minor offenses and because of that punishments are often not distinct and that this abets habitual offenders to commit more crimes as there is the same level of punishment for both first time and repeat offenders.

The notice, issued Saturday, seeks comments, feedback and objections etc from common public and experts by July 31, a mere three weeks.

# **SPECIAL OBSERVATION HOME SHOCKER** 7 months on, 5 juvenile inmates untraceable

#### POST NEW NETWORK

Berhampur. July 12: Although more than seven months have passed since five juvenile inmates escaped from the state government-run Special Observation Home for Boys on Jarada Bungalow Road here, the police are clueless regarding their whereabouts.

A special team led by district child protection officer (DCPO) has submitted a 4-page report to the Collector on the basis of which the latter is expected to take next course of action. Moreover, security aspect of the observation home is being monitored. Over 100 inmates are housed at the special observation home, but only four security guards have been deployed there.

The inmates were suspected to have taken advantage of possible laxity in security arrangements.

Hence, the administration has initiated efforts to tighten the security around the observation home. It may be noted here that on the

night of November 21, 2021, six inmates of a ward reportedly broke open the grille, reached the main gate and escaped.

The matter came to the fore at 2am when the observation home staffers

checked the rooms. Six inmates were found missing. Superintendent of the special observation home P Ramesh Rao had informed the police about the inmates' escape. A special police team was formed to track down the escapees.

It was surprising as to how they managed to flee when buses and trains in the area were not in operation then. It is suspected that the escapees might have walked too far under darkness from the Berhampur city limits.

The inmates were natives of Kalahandi, Rayagada, Nayagarh, Kandhamal and Ganjam districts. They had been sent to the observation home by the Juvenile Justice Board because of their involvement in criminal activities.

In December last year, Gajapati police had rescued one of the six inmates and handed him over to the authorities of the observation home. The authorities of the observation home are in touch with the families of the missing inmates.

# **AIDING FINANCIAL INCLUSION**

round the world, high inflation, slow economic growth, and food shortages are hurting the poor the most. Coming on top of the unequal effects of the COVID-19 pandemic, today's multiple crises have already caused dramatic reversals in development and led to a substantial increase in global poverty.

On the positive side, the COVID 19 crisis spurred unprecedented change, especially in industries with a large digital component. This digital revolution has catalyzed increases in access to and use of financial services in de veloping economies, transforming how people make and receive payments, borrow, and save.

These changes are strikingly evident in the latest edition of the Global Findex database, compiled from a survey of more than 125.000 adults in 123 economies, covering use of financial services through out 2021. The survey found that 71 per cent of adults in developing economies now have a formal financial account – whether with a bank, another regulated institution such as a credit union or microfinance lender, or a mobile money service provider - compared to 42 per cent when the first edition of the database was published a decade ago. In addition, the difference in the share of men and women in developing economies who own an account has fallen for the first time, from nine percentage points to six.

This digital transformation makes it easier, cheaper, and safer for people to receive wages from employers, send remittances to family members, and pay for goods and services. Mobile money accounts can better handle high-volume, small-denomination transactions, which help users to access financial services and save in order to cope better with crises. Individual accounts also give women more privacy, security, and control over their money.

The share of adults in developing economies who make or receive digital payments grew from 35 per cent in 2014 to 57 per cent in 2021. In Sub-Saharan Africa, 39 per cent of mobile money account holders now use their accounts to save. And more than one-third



the cost of digital transactions, and channeling wage payments and social transfers through financial accounts will be vital to mitigating recent economic setbacks in developing countries. Governments and the private sector can help further this transformation in several ways

of people in low- and middle-income countries who paid a utility bill from an account did so for the first time after the start of the COVID-19 pandemic

Importantly, the digital revolution also serves as a powerful anticorruption tool, because it helps to increase transparency as money flows from a government's budget to public agencies to citizens. Government social programmes can now reduce delays and leak age by channeling transfers directly to their beneficiaries' mobile phones. Millions of people in developing countries received payments in this way during the pandemic, helping to cushion the impact of COVID-19 on livelihoods.

Building on these encouraging trends is crucial, especially given the current economic headwinds. Expanding people's access to finance, reducing the cost of digital transactions, and channeling wage payments and social transfers through financial accounts will be vital to mitigating development setbacks resulting from the ongoing turbulence.

Governments and the private sector can help further this transformation in several critical areas. First, they need to create a favourable operating and policy environment. For example, endata for 2021 show that 865 mil lion account owners in developing economies opened their first account at a bank or similar institution in order to receive money from the government. This helped households directly and also helped build the digital financial ecosys tem, because people who received payments into an account were more likely to use their account to make payments and access other services. Digital payments by governments thus serve as a foundation for assembling credible social registers and identifying gaps

As digital payments become more widespread and less costly, many private businesses will be able to pay their workers and suppliers electronically-and should. The digital revolution offers a chance to increase formal-sector employment without making compliance excessively burdensome. At a time of tighter government budget constraints, digital payments can help broaden the revenue base by reducing tax avoid-

Finally, policymakers will need to make additional efforts to include underserved groups. The gender gap in financial access has narrowed, but it still exists. Women along with the poor, are more likely to lack a form of personal identification or a mobile phone, to live far from a bank branch, and to need support to open and use a financial account. Financial-education programmes, especially those that involve peer-to-peer learning (such as through women's self-help groups) are essential as well.

The World Bank is firmly committed to expanding financial inclusion through digitalisation. We will continue to support countries as they enhance mobile-phone networks, rework regulations to foster access to finance, adopt e-government platforms, and modernise social-protection systems. For the many millions of people who still lack an account, we need to redouble our efforts and find creative ways to connect them to the financial system. build economic resilience, and reap the benefits of inclusion.

But many questions remain. Can less financially and technologically well-endowed institutions keep up? How will banks and banking adapt to a future of instantaneous cross-border transfers, all facilitated by trusted code? Will the emergence of open-source financial-market infrastructure be an all-consuming source of disruption and disintermediation, or will these technologies simply level the playing field?

Undoubtedly, crypto and blockchain have a branding problem, not least because they are associated with a highly technical lexicon and inscrutable jargon. But someday soon, the underlying technology will fade to the background, where it will power a system-wide upgrade of the rails that move value around the world. The change will be about payment and banking system optionality, not substitution.

Personal checks did not replace paper money. Rather, they added value by giving people the ability to set an expiry date for payments with greater security than carrying around cash. Perhaps even more importantly, they are also improving interoperability in the financial system through routingand account-number standards.

Likewise, future routing and account numbers will reside on digital wallets with near ubiquitous global access to well-regulated, always-on financial services. Some call this an internet of value; others are referring to it as the third generation of the internet, or Web3. Whatever the moniker, and the ups and downs in the market, the breakthrough innovation is here to stay.

Such innovation should be encouraged, developed, and harnessed, including by the world's traditional financial-services firms and governments, lest they find themselves consigned to history when the Amazons of Web3 emerge.

#### very month or so, my 🚽 teenaged daughter, Divya, ✓ screams for my help while she's in her bedroom or bathroom. "Come quickly!" she yells, and I know exactly what I need to do:

grab a weapon. This weapon is usually a fly swatter, broom or rolled-up magazine – anything to take care of an uninvited guest. It could be a centipede, spider, ant or other insect.

I don't mind being the resident exterminator, but I can't help wondering what my daughter will do when she's all grown up and living by herself. Will she call the emergency number?

That's what a woman in the UK did recently. She called the British emergency number, 999, after encountering a spider in her home.

"Hiya, you're probably gonna go mad at me right but I've literally tried ringing everyone and you're my last hope," the woman said, according to a recording of the call released by the West Yorkshire Police. "I need someone to come and get this spider out of my house. It's absolutely massive and I'm not even joking!'

Unfortunately the call operator told the woman that there are some intruders that the police are not keen on arresting. In fact, the West Yorkshire Police used the woman's call as an example of the frivolous calls that are made to the emergency number, calls that don't qualify as life-or-death emergencies.

But while many people ripped the woman for calling the emergency line, I'm sympathetic with her for two reasons:

(1) Many people suffer from arachnophobia – fear of spiders and other arachnids. I don't like spiders myself. While some people have pet spiders and allow them to crawl on their arms, I make it a point to stay away from such people.

(2) Some spiders are truly dangerous. If you are bitten by a widow spider or recluse spider, for example, you'll want to seek medical attention as soon as you are done screaming.

It all began when she felt a strange burning sensation while using the toilet. She jumped up and looked under the seat, where she spotted a huge spider.

"I screamed instantly at the sight, managed to knock it into the bowl and flushed it straight away," she told the Daily Mail. "It was so huge, it was a real big bugger! It completely freaked me out." When the bite marks started stinging, she decided to call the non-emergency British number, 111.

Bhopal, July 12: At least 47 people in Madhya Pradesh have been killed due to lightning strikes in a span of just a week, while 111 others lost lives in the last one-and-ahalf months, officials said Tuesday.

State capital Bhopal has alone reported around 7,000 lightning strikes, according to scientists at Regional Meteorological Centre, Bhopal. Heavy rainfall since Sunday

has thrown normal life out of gear in several parts of Madhya Pradesh, particularly Bhopal, and Chhindwara district.

Sausar in Chhindwara reported heavy rainfall, causing flash floods in low-lying areas, forcing closure of traffic on the main highway linking the town to Nagpur for around an hour.

Bhopal recorded 92 mm rain since Monday night, which was 133 per cent more than the same period last year. According to data re-

leased by the Met department on Monday, out of 52 districts of Madhya Pradesh, 27, including Bhopal had reported excess rain and seven districts reported normal rainfall. The state Health Department has issued guidelines for preventive measures and emergency services for people hit by lightning, storm and weather related disasters.

Deputy director (disaster management) of the state directorate of health services, Pragya Tiwari, came out with the guidelines for chief medical and health officers and civil surgeons of the all the districts, detailing the steps to be taken to prop up emergency services and the precautionary measures that could be disseminated to the public.

## 9TH INCIDENT IN 24 DAYS SPICEJET FLIGHT'S NOSE WHEEL **MALFUNCTIONS** PRESS TRUST OF INDIA

New Delhi, July 12: SpiceJet's Dubai-Madurai flight was delayed Monday after the Boeing B737 Max aircraft's nose wheel malfunctioned, Directorate General of Civil Aviation officials said.

Monday's incident is at least the ninth incident of technical malfunction in a SpiceJet aircraft in 24 days. On July 6, the DGCA issued a show-cause notice to SpiceJet following eight incidents of technical malfunction in its aircraft since June 19 The aviation regulator said the budget carrier had "failed" to establish safe, efficient and reliable air services.

On Monday, the Boeing B737 Max aircraft with registration number VT-SZK operated the Mangaluru-Dubai flight, DGCA officials noted. After the aircraft landed, an engineer did a walk around inspection and found the nose wheel strut was compressed more than usual, they said. The engineer therefore decided to ground the aircraft, the officials noted.

The airline sent another aircraft from Mumbai to Dubai to operate the return Dubai-Madurai flight, they stated.

Asked about the matter, a SpiceJet spokesperson said, "On July 11, 2022, SpiceJet flight SG23 operating from Dubai to Madurai was delayed due to a last minute technical issue. Alternate aircraft was arranged immediately which brought passengers back to India."

"Flight delays can happen with any airline. There has been no incident or a safety scare on this flight," the spokesperson added.

Gehlot will be assisted by T S Singh Deo, a Minister in Chhattisgarh and Milind Deora former Mumbai chief. Baghel will be helped by former Deputy Chief Minister of Rajasthan Sachin Pilot and Punjab Congress legislative party leader Partap Singh Bajwa. Both the states go to polls this vear.

Milind Deora, who was sidelined since his resignation from the post of Mumbai Congress chief, has made a comeback in the election management of the crucial state of Gujarat where the Congress has been out of power for more than two decades.

Deora, a former Union Minister. was once considered to be very close to Rahul Gandhi, but was out of mainstream Congress in Mumbai and also had been ignored for the Raiva Sabha polls after he lost Lok Sabha elections.

Covid in 'endemic stage': Telangana public health dir

Hvderabad. July 12: Covid-19 has reached an endemic stage though it has not fully come to an end vet and citizens should continue to wear masks for protection against coronavirus and other infectious diseases, a Health official in Telangana said Tuesday

State Director of Public Health G Srinivasa Rao said there was no need to fear coronavirus and added that it could be said it has become like a seasonal disease.

"What we appeal to people through you is that we need not fear about corona in the days to come. Though it has not fully disappeared, it has already reached an endemic stage. It can be said that it has become like a seasonal disease." he added.

Rao, who spoke to reporters here on Covid-19 and seasonal diseases during the ongoing rainy season, said coronavirus cases have been on the rise in Telangana and other states in the country like Maharashtra and Kerala since the last six weeks

The World Health Organisation (WHO) has recently changed some of the guidelines concerning Covid-19, he said

Those having symptoms should be in quarantine for five days and they can carry on with their routine once the symptoms subside, he said. Extensive contact tracing and tracking are not needed now.

Heroin worth ₹376.5cr seized from Mundra port

Ahmedabad, July 12: The Gujarat Anti-Terrorist Squad (ATS) has seized 75.3 kg of heroin estimated to be worth ₹376.5 crore from a container near the Mundra port in Kutch district, an official said Tuesdav.

The contraband, hidden inside fabric rolls to dodge the authorities, was sent from the United Arab Emirates (UAE) and was meant to be transported to Punjab, Gujarat Director General of Police Ashish Bhatia said.

The Punjab police recently gave a tip off to the Gujarat ATS that a shipping container which arrived at Mundra port about two and half months back might be containing drugs and the cargo was meant to be delivered in Punjab, Bhatia told reporters in Gandhinagar.



drugs sent to the Gujarat ports had been seized, thanks to the alertness of the state police and other agencies.

Various state and central agenies, including the ATS and the Directorate of Revenue Intelligence (DRI), have in the recent past seized drugs worth crores of rupees from shipping containers arriving at Gujarat ports from other countries.

The DRI in September last year seized nearly 3,000 kg of heroin, believed to have originated in Afghanistan and worth about ₹21,000 crore in global markets, from two containers at the Mundra port.

In May this year, the DRI seized 56 kg of cocaine, estimated to be worth around ₹500 crore, from a container near the Mundra port. In April, the DRI seized 205.6 kg

# Downpour claims 6 in Gujarat; 27K shifted

Ahmedabad, July 12: Heavy downpour continued in various parts of Gujarat Tuesday and six people died in rain-related incidents in the last 24 hours, raising the toll to 69 since June 1, out of which 33 due to lightning strikes, officials said. A total of 27,896 people were evacated from flood-affected areas and

Narmada, Surat, Dang, Valsad and Tapi districts of south Gujarat, and Panchmahal and Chhota Udepur in central part of the state witnessed heavy rains over the last one day.

The India Meteorological Department has issued a 'red alert' for heavy to very heavy rains in Valsad, Navsari, Surat, Tapi, Dang, Narmada, Chhota Udepur districts as well as Kutch, Rajkot, Jamnagar, Devbhumi Dwarka and Morbi in the Saurashtra region till Wednesday morning. A total of 9,500 people have so far been evacuated from the affected areas in Navsari district, an official said. In Navsari city, fire department personnel rescued around 20 people, including a five days old child, from a residential society affected by flooding, he said. Besides, 21 people stranded on the Karjan river bank near Rajpipla in Narmada district after a sudden water surge were rescued Monday night in a joint operation by the National Disaster Response Force and the State Disaster Response Force. They carried out the rescue operation in the night without waiting for helicopters.

"A cloth was wrapped on long cylindrical pipes made of cardboard. Drug dealers had created a cavity by putting a plastic pipe of a larger diameter on the cardboard pipe. Heroin was filled in the cavity and then sealed tightly using carbon tapes so that it goes undetected in X-ray check," the official said.

"We got suspicious as the containers were filled only one third, which seldom happens. There were 540 textile rolls, out of which 64 carried heroin. To bypass the X-ray machine, plastic rappers were used to conceal the drugs, while cello tapes were used to cover the plastic layer," he added.

# BHIMA KOREGAON CASE Top court extends Varavara Rao's interim protection

New Delhi, July 12: The Supreme Court Tuesday extended the interim protection from surrender to activist P Varavara Rao in the Bhima Koregaon case till July 19.

Solicitor General Tushar Mehta requested an adjournment in the matter before a bench headed by Justice UU Lalit.

Mehta submitted before the bench that the matter should be kept for either Wednesday or Thursday and added that protection may continue till then. Senior advocate Anand Grover, representing Rao, said he would not come in the way of Mehta's request. The bench said it would extend Rao's protection, as it did not want him to be arrested for the reason that the matter was not heard. It passed the order for extension of temporary bail granted by the Bombay High Court.

Rao had moved the top court challenging the Bombay High Court's order of April 13, which declined his request to stay at his home in Telangana. However, the high court extended the period of temporary bail for three months against the backdrop of medical reasons.

# New Parl emblem exact replica of Sarnath: Govt

New Delhi, July 12: The BJP Tuesday asserted that the national emblem unveiled by Prime Minister Narendra Modi on Parliament's new building was an exact replica of the one in Sarnath and accused the Opposition of deliberately trying to create one controversy after another for political reasons.

Opposition members and activists have accused the government of distorting the national emblem by replacing the "graceful and regally confident" Ashoka lions with those having menacing and aggressive posture and sought immediate change.

BJP chief spokesperson and Rajya Sabha member Anil Baluni said the real reason behind the Opposition's allegation is its frustration over India creating its own Parliament building under Prime Minister Narendra Modi-led government, replacing the one created by the British over 150 years back. "The opposition is totally due to

political reasons. Opposition parties want to target Modi for one reason or another. It is just a conspiracy to vitiate the atmosphere by misleading people," he said.

Critics are comparing the national emblem inaugurated on Monday with the one in Sarnath, considered the inspiration behind the national insignia, by producing pictures taken from different angles, Baluni said. This also must be noted that the emblem over the Parliament building is 6.5 metre high, almost three times the one in Sarnath, he said. The state emblem of India is an adaptation from



the Sarnath Lion Capital of Emperor Ashoka which is preserved in the Sarnath Museum. The Lion Capital has four lions mounted back to back on a circular abacus

Prime Minister Narendra Modi had Monday unveiled the cast of the national emblem atop the new Parliament building in the presence of Lok Sabha Speaker Om Birla and Rajya Sabha Deputy Chairman Harivansh.

Over 100 artisans from various parts of the country worked on the design, crafting and casting of the emblem for over six months to bring out the quality that could be seen in the final installation. The installation itself was a challenge as it was 32 meters above the upper ground level.

Once the ballot boxes and ballot papers reach the state capitals, these are stored in previously sanitised and properly sealed strong rooms and the process is videographed

After the poll is over, the polled and sealed ballot boxes and other election material have to be transported back to the office of returning officer -- this time it is the Rajya Sabha secretary general -- by the next available flight.

The boxes and other documents are carried personally in the aircraft cabins -- never out of sight of accompanying officers.

Voting is held in Parliament House and state legislative assemblies and elected MPs and MLAs -- not the nominated -- are entitled to vote. MLCs are not entitled to vote in presidential poll. While speaking to the assistant returning officers, Chief Election Commissioner Rajiv Kumar emphasised that strict adherence to procedures by the EC teams has become its hallmark in delivering error free elections time and again.

He said a set of well-defined instructions and standard operating procedures that are required to be followed thoroughly to complete every electoral process account for EC's robustness for conducting elections.

He asked the officials to be vigilant and ensure strict adherence to protocols and guidelines for transportation and storage of election materials, including ballot boxes and ballot papers, the poll panel said in a statement.

In a two-day exercise, the poll materials will sent to the state Assemblies where polling will be held.

Apart from the state Assemblies, voting will be also held in Parliament House.

# Zubair's interim bail extended by Supreme Court in UP case

### **US kills IS group** leader in Syria

Washington: The Pentagon said Tuesday that it killed a leader of the Islamic State group in Syria in a drone strike US Central Command said in a news release that Maher al-Agal was killed Tuesday and an unidentified senior official in the Islamic State group was seriously injured. The Pentagon said there were no civilian casualties, though it wasn't possible to immediately confirm that information. The US carried out the strike outside Jindaris, a town in northwest Syria close to the Turkish border.

### 11 tourists killed in northwest Pak

Peshawar: At least 11 tourists were killed and two injured after the vehicle they were travelling in skidded off a mountainous road and fell into a ravine in northwest Pakistan Tuesday, authorities here said. The incident took place in the scenic Lalko valley, near Gabin Jabba in the Swat valley of Khyber Pakhtunkhwa province as the vehicle carrying the tourists skidded and fell into a deep ravine, police said. The 11 people who were dead were identified as residents of Matta tehsil of Swat valley, who were on their way back home after an excursion trip, rescue authorities said.

Manila, July 12: US Secretary of State Antony Blinken called on China to comply with a 2016 arbitration ruling that invalidated Beijing's vast territorial claims in the South China Sea and warned that Washington is obligated to defend treaty ally Philippines if its forces, vessels or aircraft come under attack in the disputed waters. Blinken's statement, issued by the U.S. Embassy in Manila Tuesday, was released on the sixth anniversary of the 2016 decision by an arbitration tribunal set up in The Hague under the U.N. Convention on the Law of the Sea after the Philippine government complained in 2013 about China's increasingly aggressive actions in the disputed waters. China did not participate in the arbitration, rejected its ruling as a sham and continues to defy it, bringing it into territorial spats with the Philippines and other Southeast Asian claimant states in recent years.

# Pope reveals retirement plans

Rome, July 12: Pope Francis said he would not live in the Vatican or return to his native Argentina if and when he ever retires, but would instead like to find a church in Rome where he could continue hearing confessions

"I'm the bishop of Rome, in this case the emeritus bishop of Rome,' Francis said in an interview segment with Spanish-language broadcaster TelevisaUnivision that aired Tuesday. Francis, 85, denied he was planning to retire any time soon but repeated that "the door is open" after Pope Benedict XVI in 2013 became the first pope in 600 years to step down.

While having a retired pope on hand has gone well, the Vatican needs to better regulate the figure of an emeritus pope, Francis said in the interview. Some cardinals and canon lawyers have long questioned Benedict's decisions in retirement, including his continuing to wear the white cassock of the papacy and keeping his papal name, Benedict, rather than reverting back to his birth name, Joseph Ratzinger.



They say those choices and Benedict's continued presence in the Vatican created confusion among the faithful and enabled Francis' traditionalist critics to use Benedict as a conservative point of reference, threatening the unity of the Catholic Church.

Greenbelt, Md., July 12: Following a presidential sneak peek of a galaxy-studded image from deep in the cosmos, NASA officials gathered Tuesday to unveil more of their initial showcase from the James Webb Space Telescope, the largest and most powerful orbital observatory ever launched.

The first batch of full-colour, high-resolution pictures, which took weeks to render from raw telescope data, were selected by NASA to provide compelling early im-

ages from Webb's major areas of inquiry and a preview of science missions ahead. The \$9 billion infrared telescope, built for NASA by aerospace giant Northrop Grumman Corp, is expected to revolutionise astronomy by allowing scientists to peer farther than before and with greater clarity into the cosmos, to the dawn of the known universe

list of science projects exploring the evolution of galaxies, the life cycles



of stars, the atmospheres of distant exoplanets and the moons of our outer solar system.

The introductory assortment of pictures had been a closely guarded secret until Friday, when the space agency posted a list of five celestial subjects chosen for its big reveal Tuesday at NASA's Goddard Space Flight Center in Maryland. Whoops and hollers from a spritely James Webb "cheer team" welcomed some 300 scientists, telescope engineers, politicians and senior officials from NASA and its international partners into a packed and lively auditorium ahead of the opening remarks

"I didn't know I was coming to a pep rally today," NASA Administrator James Nelson said from the stage, enthusing that Webb's every image is a discovery.

#### PRESIDENTIAL PEEK

US President Joe Biden got a

jump on the unveiling with his own White House briefing on Monday to release the very first photo - an image of a galaxy cluster dubbed SMACS 0723, revealing the most detailed glimpse of the early universe recorded to date. Among the four other Webb targets getting their close-ups Tuesday are two enormous clouds of gas and dust blasted into space by stellar explosions to form incubators for new stars - the Carina Nebula and the Southern Ring Nebula, each thousands of light years away from Earth. The debut collection includes

another galaxy cluster known as Stephan's Quintet, which was first discovered in 1877 and encompasses several galaxies described by NASA as locked in a cosmic dance of repeated close encounters. NASA will also present Webb's first spectrographic analysis of an exoplanet - one roughly half the mass of Jupiter that lies more than 1,100 light years away - revealing the molecular signatures of filtered light

passing through its atmosphere.

Built to view its subjects chiefly in the infrared spectrum, Webb is about 100 times more sensitive than its 30-year-old predecessor, the Hubble Space Telescope, which operates mainly at optical and ultraviolet wavelengths. The much larger light-collecting surface of Webb's primary mirror - an array of 18 hexagonal segments of gold-coated beryllium metal - enables it to observe objects at greater distances, thus further back in time, than Hubble or any other telescope

All five of Webb's introductory targets were previously known to scientists, but NASA officials promise Webb's imagery captures its subjects in an entirely new light, literally. The SMACS 0723 image Biden released Monday showed a 4.6 billion-year-old galaxy cluster whose combined mass acts as a gravitational lens, distorting space to greatly magnifythe light coming from more distant galaxies behind it.

The RBI has the mandate to ensure that inflation remains at 4 per cent, with a margin of 2 per cent on either side. However, retail inflation is ruling above the RBI's upper tolerance limit of 6 per cent since January 2022.

As per the data, the inflation print in vegetables eased to 17.37 per cent during the month from 18.26 per cent in May, while for 'pulses and products' it slowed to (-) 1.02 per cent against (-)0.42 per cent.

However, the rate of price rise in 'cereals and products' moved up to 5.66 per cent, from 5.33 per cent in the preceding month. Inflation in the 'fuel and light' category rose



to 10.39 per cent as against 9.54 per cent, while that for fruits increased to 3.10 per cent from 2.33 per cent. Last month, the Reserve Bank in

its bi-monthly monetary policy review raised the benchmark reporate - at which it lends short-term money to banks - by a sharp 0.50 per cent to 4.90 per cent to rein in spiralling prices. It followed an off-cycle meeting on May 4, when the central bank hiked the reporate by 0.40 per cent.

Governor Shaktikanta Das had said the global geopolitical situation remains fluid and commodity markets remain on the edge, rendering heightened uncertainty to the domestic inflation outlook.

However, certain positive developments such as expectations of a normal south-west monsoon and kharif agricultural season, recent supply side measures taken by the

government as well as lifting of palm oil export ban by Indonesia may help ease the acute price pressures to some extent, he had said.

The RBI also raised its retail inflation forecast for the current financial year to 6.7 per cent from its previous estimate of 5.7 per cent.

Saturday, the RBI Governor while speaking at the Kautilya Economic Conclave exuded confidence that the price situation will gradually improve in the second half of the current fiscal. He also said the central bank would continue to take monetary measures to anchor inflation with a view to achieving strong and sustainable growth.

The Governor said price stability is key to maintaining macroeconomic and financial stability and the central bank will undertake necessary measures for the same.

# Industrial production grows at a year-high of 19.6 per cent in May

New Delhi, July 12: India's industrial production grew the highest in a year at 19.6 per cent in May 2022, mainly due to strong performance by manufacturing, power and mining sectors, according to the government data released Tuesday.

Factory output, measured in terms of Index of Industrial Production (IIP), had recorded a growth of 27.6 per cent in May 2021 due to low base effect, the data showed. As per the data released by the ministry of statistics and programme implementation, the manufacturing sector expanded by 20.6 per cent compared to a growth of 32.1 per cent recorded in the year-ago period.

Power sector showed a growth of 23.5 per cent as against 7.5 per cent a year ago, while the mining sector witnessed an expansion of 10.9 per cent in May 2022 compared to a growth of 23.6 per cent last year. During April-May this year, IIP grew 12.9 per cent as against 67.3 per cent growth in the same period a vear ago. Capital goods output. which is a barometer of investment, showed a growth of 54 per cent in May 2022 against a jump of 74.9 per cent in the year-ago month. The consumer durables segment grew by 58.5 per cent against a growth of 80.4 per cent a year ago.

The primary goods segment, which accounts for nearly 34 per cent of the index, expanded by 17.7 per cent in May compared to 15.8 per cent growth a year ago.

Consumer non-durable segment grew by 0.9 per cent in May compared to a growth of 0.2 per cent in same month a year ago.

# Govt will tap capital markets to fund road projects, says Gadkari AGENCIES

New Delhi, July 12: Union Transport Minister Nitin Gadkari Tuesday said the government will raise funds from capital markets for road projects

The minister further said despite fears of global recession, there is no problem in funding infrastructure sector projects. "Now I am going to the capital

market. I don't have financial resources problems. But, I don't want to use the finances of rich people. I am going to share market, and there I am going to take investments from small people -- ₹1 lakh, ₹2 lakh, where I am giving them a guaranteed return of 8 per cent," Gadkari said while addressing an event here.

Thus, I will get tremendous money from the market, he added. The minister said the construction equipment industry's size is ₹50,000 crore, but due to the rise in crude oil prices, the sector

is facing a problem. "Because of high diesel prices, we are facing an economic viable problem...As early as, get rid of diesel, it is a hazardous fuel," he urged the construction equipment manufacturers. The minister pointed out that the government's policy is to encourage alternative fuels like methanol, ethanol and green hydrogen. Noting that electric mobility is the future, he said the market share of Indian auto-



mobile companies has increased and the share of foreign automobile companies has decreased because some Indian firms have started making electric vehicles.

Pointing out that despite having sufficient coal reserves, India is importing coal, Gadkari said the government has decided to privatise 60 coal mines to increase productivity.

Asked whether the elevated crude price will be a threat to NHAI's capex funds as it may increase the chances of cess reduction on petrol this fiscal, Gadkari said, "The finance ministry will look into it"

A large chunk of the budget outlay for NHAI is estimated to come from the central road and infrastructure fund (CRIF) into which petrol and diesel cess flows.

Gadkari also said that without economic viability technology is not useful and asked construction equipment manufacturers to concentrate on fuel efficiency.

The minister also emphasised skilled manpower, appropriate training and road safety for longterm planning.

Mumbai, July 12: RBI's move to allow cross border trade transactions in rupee will reduce the demand for foreign currency for settlement of trade and help curb the fall in the domestic currency,

experts say. According to them, it is also a step towards liberalisation of capital account convertibility.

Reserve Bank of India (RBI) Monday asked banks to put in place additional arrangements for invoicing, payment, and settle-

ment of exports/ imports in the domestic currency in order to promote growth of global trade with emphasis on exports from India and to support the increasing interest of the global

trading community in rupee. 'With this, there will be less pressure on rupee as dollar demand for imports will not be there," Bank of Baroda's Chief Economist Madan Sabnavis said.

In a report, Bank of America Merrill Lynch said the measure should arguably take off immediate pressure on the demand for dollars.

Amid ongoing rupee weakness, the steps appear to be aimed at reducing demand for foreign exchange by promoting rupee settlement of trade flows, Barclays MD & Chief India Economist Rahul Bajoria said.

For settlement of trade transactions, the banks concerned will require Special Rupee Vostro Accounts of correspondent bank/s

of the partner trading country, according to RBI.

Indian importers undertaking imports through this mechanism shall make payment in the rupee which shall be credited into the special vostro account of the correspondent bank of the partner country against the invoices for the supply of goods or services from the overseas seller/ supplier, RBI said.

Indian exporters, undertaking exports of goods and services through this mechanism, shall be paid the export proceeds in rupee from the balances in the designated special vostro account of the correspondent bank of the partner country.

CR Forex Advisors Managing Director Amit Pabari said allowing payments for cross-border trade in rupee through the vostro account is a step taken specially to benefit trade with Russia.

"In a bid to ease the pressure on the country's import bill after sharp depreciation in the rupee, RBI is forced to come up with an alternative payment mechanism where the bank seems to be aiming for an explicit rupee-rouble trade arrangement between India and Russia to settle oil dues in rupees instead of dollars," Pabari said.

According to India Ratings and Research's Soumyati Niyogi, RBI announcement is part of the measures towards liberalisation of capital account convertibility.

"If the capital account gets fully convertible and there are no restrictions on bringing money and taking out money from India, then the requirement of the foreign exchange reserves will not be that much for trade transactions," he said.

However, volatility of overseas flows and their impact on the domestic economy will be critical to watch for, given low absorption capacity of the economy and banking system as a whole, Niyogi added.

London, July 12: Jasprit Bumrah produced a devastating display of fast bowling on way to career best six-wicket haul to set up India's 10-wicket hammering of England in the first ODI here Tuesday.

Bumrah ended with envious figures of 6/19 7.2 overs as India skittled out England for 110, their lowest against the visitors, after opting to bowl in overcast conditions.

Skipper Rohit Sharma (76 n o, 58b, 7x4, 5x6) and Shikhar Dhawan (31 n o, 54b, 4x4), who was playing his first competitive game since the IPL, steered India home with an unbeaten 114run partnership off 18.4 overs.

While Dhawan understandably took time get into rhythm, Rohit regaled the crowd with some sublime shots, including the two front foot pulls off Craig Overton that went for a six and four.

Dhawan, who struggled to 2 off 17 balls, got going with back to back boundaries off Reece Topley. India had all the time to breeze to victory, allowing the southpaw to take it easy. Rohit reached the 50-run mark with his third six of the innings, an effortless hook off Brydon Chase over fine leg. He pulled Chase towards the end of the innings for his fifth maximum before Dhawan

hitting the winning boundary.

Earlier, considering the overcast conditions and grass on the pitch, India decided to put the opposition in and the pacers exploited the conditions perfectly. The ball was swinging and seaming around at good pace, making Bumrah and Mohammed Shami (3/31) all the more lethal.

Jason Roy's (0) struggle continued as he played on while attempting an expansive drive from a full and wide ball off Bumrah. Roy had little idea about the booming inswingers Bumrah unleashed before getting his number.

Two balls later, the in-form Joe Root (0) was expecting another fast inswinger but Bumrah got one to rise outside the off-stump that took an edge on way to wicketkeeper Rishabh Pant for a double wicket maiden over. Shami too got into the act from the other end and got rid of Ben Stokes (0). It turned out to be a busy day for the India wicketkeeper who took his second one handed catch to get rid of the dangerous Jonny Bairstow (7), giving Bumrah his third wicket.

Bumrah soon made it 26/5 as Liam Livingstone (0) charged down the track to upset the bowler's rhythm but ended playing around a fast and swinging yorker on the leg stump.

England skipper Jos Buttler (30) showed positive intent to get his team out of the hole but played one too many considering the game situation. Brought back into the attack, Shami went for a short ball and Buttler mistimed the pull to be caught at deep square leg, leaving England tottering at 59/7.

India playing four pacers including Hardik Pandya and Prasidh Krishna also helped the visitors maintain the pressure. A ninth wicket partnership for 35 runs between David Willey (21) and Bryson Carse (15) allowed England get past their lowest total, 86, made against Australia back in 2001.

Bumrah came back into the attack to pick his second five-wicket haul in ODI cricket. It was not surprise that he got to the milestone with a yorker that was too good for Carse.

New Delhi, July 12: Batting great Sunil Gavaskar has questioned the commitment of the senior India players, saying he "doesn't agree" with cricketers skipping international series but playing the IPL without a break.

Gavaskar's remarks came after senior players Virat Kohli, Rohit Sharma, Jasprit Bumrah, Hardik Pandya and Rishabh Pant were rested for the upcoming ODI series against the West Indies.

"See, I do not agree with this concept of players resting. Not at

all. 'You don't take rest during IPL. then why ask for it while playing for India? I don't agree with it. You will have to play for India. Don't talk about rest," Gavaskar said on 'Sports Tak'.

"There are only 20 overs in an innings in T20. That does not take any toll on your body. In Test matches, the mind and the body take a toll, I get that. But I don't think there is much problem in T20 cricket," he added.

The former captain said the BCCI will be better off intervening into this "rest policy". "I honestly feel that the BCCI needs to look into this concept of rest. All the Grade A cricketers have received very good contracts. They receive payment for every match. Tell me

if there is any company whose CEO, or MDs get so much time off? "I feel that if Indian cricket is to become more professional, a line needs to be drawn. If you want to

be rested, you need to reduce your guarantees. Then you take rest, because you don't want to play. But how can anyone say that I don't want to play for the Indian team. Which is why I do not agree to the concept," Gavaskar said.

Changwon, July 12: The mixed team pair of Mehuli Ghosh and Shahu Tushar Mane sealed India's second medal at the ISSF Shooting World Cup, here Tuesday, by setting up the gold medal match against Hungary.

In-form Mehuli and Shahu topped the 10m Air Rifle Mixed Team qualifiers with a score of 634.4 after 60 shots to finish well ahead of the strong Hungarian pair of Istvan Peni and Eszter Meszaros, who finished second

and Rhythm Sangwan in 10m air pistol mixed team and Ariun Babuta and Elavenil Valarivan in the corresponding rifle competition could not make the grade after both the teams scored 570 and 627.8 respectively to finish in the eighth position. Earlier in the day, India missed

out on about five medals as none of the top qualifiers in men's and women's 10m Air Pistol as well as in the men's trap, could make their opportunities count.

In the men's 10m Air Pistol discipline, India had three qualifiers in the top eight ranking round but Naveen finished fourth with an effort of 250.7. Shiva Narwal was fifth with 199.7 and was followed by Sagar Dangi (199.2).

In the women's 10m Air Pistol event, India's lone ranking round qualifier Yuvika Tomar ended seventh with 147.1 points. In the men's trap event, young Viyaan Kapoor shot a brilliant 122 out of 125 to qualify third among eight qualifiers but ended fourth in his match to miss out on the medals.

India has won one gold through Ariun Babuta (10m Air Rifle) so far in the tournament and is currently placed fourth on the medal tally.

London, July 12: Four-time Olympic champion Mo Farah has disclosed he was brought into Britain illegally from Diibouti under the name of another child. "The truth is I'm not who you think I am," the 39-yearold Farah told the BBC in a documentary called "The Real Mo Farah."

Farah, who became the first British track and field athlete to win four Olympic golds, said his children have motivated him to be truthful about his past. "The real story is I was born in Somaliland, north of Somalia, as Hussein Abdi Kahin," he told the BBC

"Despite what I've said in the past, my parents never lived in the UK. When I was four my dad was killed in the civil war, you know as a family we were torn apart. I was separated from my mother, and I was brought into the UK illegally under the name of another child called Mohamed Farah. During the documentary, Farah

said he thought he was going to Europe to live with relatives and recalled going through a British passport check under the guise of Mohamed at the age of nine after traveling with a woman he didn't previously know. "I had all the contact details for my relative and once we got to her house,

the lady took it off me and right in front of me ripped them up and put it in the bin and at that moment I knew I was in trouble," he said.

The athlete travelled back to his childhood home in west London, recalling "not great memories" where he was not treated as part of the family. Farah eventually told teacher Alan Watkinson the truth and moved to live with his friend's  $\rightarrow$ mum who took care of him and he ended up staying for seven years.

It was Watkinson who applied for Farah's British citizenship which he described as a "long process." Farah was recognized as a British citizen in 2000.
