### **Prez election today**

New Delhi: Nearly 4,800 elected MPs and MLAs will vote Monday to elect the 15th President of India, with NDA candidate Droupadi Murmu having a clear edge over Opposition's Yashwant Sinha as over 60 per cent votes are expected to be cast in her favour. The polling will take place in Parliament House and state legislative assemblies between 10 am and 5 pm for which ballot boxes have already reached their destinations. The counting of votes will take place at Parliament House July 21 and the next President will take oath July 25. MORE P9

### Alva Oppn's VP pick

New Delhi: Opposition parties Sunday decided to field former Rajasthan Governor Margaret Alva as their joint candidate for the Vice Presidential election. Alva, 80, would file her nomination papers July 19 which is the last date for filing nominations for the August 6 election. The NDA has fielded West Bengal



candidate for the post of Vice President. The decision to field Alva was taken at a meeting of Opposition leaders of 17 parties at the residence of NCP supremo Sharad Pawar. "We have unanimously decided to field Margaret Alva as our joint candidate for the post of Vice President," Pawar announced after the

New Delhi: Odisha Chief Minister Naveen Patnaik-led BJD has decided to support the NDA's Vice Presidential nominee Jagdeep Dhankhar, a party leader said Sunday. "After Prime Minister Narendra Modi spoke to (Chief Minister) Naveen babu, it has been decided that the party will support Dhankhar," senior BJD leader Pinaki Misra told PTI. The BJD has already announced its support to NDA's Presidential nominee Droupadi Murmu, who hails from Odisha. Last time, too, the Patnaik-led party had supported the NDA's Presidential nominee but in the Vice-Presidential elections, it had extended support to Opposition candidate Gopalkrishna Gandhi.

New Delhi, July 17: Customers will have to pay 5 per cent GST on pre-packed, labelled food items like atta, paneer and curd, besides hospital rooms with rent above ₹5,000 from Monday with the GST Council's decision coming into force

In addition, hotel rooms with tariff of up to ₹1,000/day, maps and charts, including atlases, will attract a 12 per cent Goods and Services Tax (GST), while 18 per cent GST will be levied on tetra packs and fees charged by banks for the issue of cheques (loose or in book form).

Last month, the GST Council, chaired by Union Finance Minister Nirmala Sitharaman and comprising her state counterparts, had pruned the exemption list and imposed tax on a host of goods and services.

The Council, based on an interim report of the Group of Ministers (GoM) on rate rationalisation, had also removed duty inversion for goods where the taxes on inputs were higher than those on the output.

Tax rates on products such as printing, writing or drawing ink; knives with cutting blades, paper knives and pencil sharpeners; LED lamps; drawing and marking out instruments will be hiked to

Bhubaneswar, July 17: With heavy rain continuing to batter several parts of Odisha Sunday, at least two districts are reeling under floods, while a landslide has been reported in another, officials said. The flood situation in Motu area

in Malkangiri district adjoining Andhra Pradesh remained grim as backwaters of Godavari river inundated several villages, affecting many people.

Water levels in Sabari and Sileru rivers have risen, and at least three villages in Motu have remained marooned for the last three days, they said.

Adding to the woes, heavy continued to lash Malkangiri district, though its intensity has reduced Sunday, the officials said.

Road communication with neigh bouring Chhattisgarh, Telangana and Andhra Pradesh has been cutoff as water is flowing at least eight feet above NH 326, as a result of which hundreds of trucks carrying essential items have been stranded, they said. Around six other villages in Motu are also under water and residents have been evacuated to safer places by the administration. Some people have also taken shelter on nearby hills as they could

not reach the flood shelters. "Backwaters of Godavari in neighbouring Andhra Pradesh have inundated villages and farmlands in Motu. At least 743 people have been shifted to flood shelters," Malkangiri Additional District Magistrate Maheswar Navak said.

# Lookout circular against 3 Chinese

Bhubaneswar, July 17: A lookout circular has been issued against three Chinese nationals for their alleged involvement in a mobile loan app scam, the Odisha Police said Sunday.

The action was taken by the Bureau of Immigration on the request of the state police's Economic Offences Wing (EOW).

The three -- Shen Zhenhua, alias Tony of Jiangsu, Quan Hongwei alias Paul of Jiangsu, and Yang Haiying, alias Doris of Sichuan, China, - are the main accused in a case registered against Kredit Gold loan app. This is the second illegal loan app case investigated by EOW.

There are more than one lakh victims of Kredit Gold loan app across the country including many from Odisha, EOW officials said. The officials suspect that the Chinese nationals are also running a similar scam in countries like Indonesia, Sri Lanka, Pakistan, Nepal, and Bangladesh.

"They also have links in the US and Hong Kong. They are in the process of expanding their financial criminal network in African and Middle East countries," an official said.

The mastermind operates in India in connivance with many shell companies and Indians are made directors of these companies.

Bhopal/Sheopur, July 17: A wildlife sanctuary in Madhya Pradesh is getting ready to welcome its new inhabitants, African cheetahs, which are being brought under an intercontinental translocation project and if everything goes as per plan, the majestic beasts will be here as early as next month.

The fastest land animal in the world, declared extinct / Chhattisgarh in undividin the country in 1952, will find a new home in the 1947 and the wild animal Kuno-Palpur National Park (KNP) in Sheopur district probably at a time when India will be celebrating its 75th Independence Day, a senior forest department official said.

'We are working on it. Cheetahs will come to Madhya Pradesh in August," forest department's principal secretary Ashok Barnwal told PTI.

When specifically asked if the big cats, which can sprint at speeds of 80 to 130 km per hour, will arrive

The Wildlife Institute of India (WII) dean and senior professor Yadvendradev Vikramsinh Jhala also did not give any exact date for arrival of the fierce felines at KNP. The Dehradun-based institute is also involved in the translocation project.

When pointed out that India was still to sign an MoU, either with Namibia or South Africa, for the cheetah reintroduction programme, Jhala said a lot of legalities are involved in such projects.

"It depends on the (Indian) government. It (MoU) can be done in two days or it may take two months. There are a lot of legalities involved in it," the WII dean said. Another forest department official said the number of cheetahs to be brought to India will be

decided by the central government, but added preparations are on at KNP to receive and house them.

"Our preparations are going on in full swing to welcome cheetahs back to India but we don't know anything about the actual date of arrival or the number of big cats coming to Madhya Pradesh as it is being finalised at the level of Government of India," principal chief conservator of forest (PCCF-Wildlife) JS Chauhan said.

He said KNP has made preparations for housing 12 to 15 cheetahs, including females, and has earmarked an area of five square kilometre having eight compartments in it for initially keeping  $\rightleftharpoons$ the translocated animals.

Sheopur's divisional forest officer (DFO) Prakash Verma, who underwent training to handle cheetahs along with other officials, said 90 per cent preparations tohouse the animals on Indian soil have been completed.





New Delhi, July 17: The Biju Janata Dal (BJD) Sunday reiterated its demand for passing of the Women's Reservation Bill and establishment of a Legislative Council in Odisha during an all-party meeting ahead of the Monsoon Session of the Parliament, scheduled to commence Monday.

BJD MP Pinaki Misra attended the all-party meeting, convened by the Centre, and pleaded for the introduction of a bill for establishment of a Legislative Council in Odisha during the

During the Budget Session, the Centre informed that it hasn't received any resolution from Odisha Assembly for creation of a Legislative Council in the state.

Replying to a query by BJD MP Prasanna Acharva, whose Raiva Sabha tenure ended recently, the Centre claimed that it has not received any resolution from the state government for the establishment of a Legislative Council in Odisha.

The BJD MPs, however, criticised the Centre for its response and informed the House that a delegation of party MPs had met Union Home Minister Amit Shah with the resolution for establishment of a Legislative Council in the state.

Misra also asked the Centre to pass the Women's Reservation Bill during the Monsoon Session of Parliament. Once passed, the Bill will pave the way for reservation of 33 per cent seats for women in the Lok Sabha and state Assemblies across the country.





Unexpectedly, the odds of long Covid among people who experienced chest congestion were lower. There was also a lack of evidence relating the risk of long Covid to pre-existing health conditions such as diabetes or asthma, or age, gender, race/ethnicity, education or current smoking status.

Chandan Padhi of Bega village in Dhenkanal, Ranjan Kumar Sahoo of Jankia in Khurda and Rajesh Kumar Mohanty of Palasuni area in the Capital city have been arrested on charges of killing Mukesh Chaudhury, a petty thief, near the dump yard in Mancheswar area here March 3, 2022 over distribution of booty, said a police official.

The official said Mukesh and Ranjan, also a history-sheeter, were at loggerheads over sharing of items acquired through petty crimes like snatching and theft. "On the fateful day, the duo quarreled over the issue. Soon, a mountain was made out of a molehill and Ranjan with the help of Chandan and Rajesh stoned Mukesh to death near the dump yard in Mancheswar area," said the official, adding that soon after the crime they fled the spot.

About the crackdown, the official said they got a tipoff about Chandan's whereabouts in Dhenkanal.

'Soon after, we managed to arrest Chandan who was hiding at his sister's house at Nihalaprasad in Dhenkanal. Based on the leads given by Chandan, we arrested Rajesh from Palasuni area and Ranjan from his in-laws' house in the Temple City," said the official, adding that the crime scene

Bhubaneswar, July 17: A oneday workshop on 'Stunting and Gut Dysfunction' was held by the Asian Institute of Public Health (AIPH) University, at the Indian Medical Association (IMA) House in Bhubaneswar, Sunday.

Georgetown University, US, and he Indian Academy of Paediatrics (Odisha chapter) were the collaborating partners of this event, organised to find means to combat stunting through research design and novel strategies.

A panel of eminent national and international scientific and action research experts presented the current status and research findings at the workshop

stunting and malnutrition landscape in India and Odisha, changes in the rates of stunting during the last four decades in India and the world, economic impact of childhood stunting, the first 1,000 golden days of life, pathogenesis of stunting, enteric infections, mal-ed study results and stunting, cryptosporidiosis infection and the Vellore birth cohort, AIPH motherbaby cohort, neonatal infections, intestinal helminths, microbial secretions and dysbiosis, maternal and childhood anemia and metabolic disorders, early bacterial colonization and infections, intestinal tight junctions and impact of dysbiosis, intestinal microbiome and its modulators, etc.



After an average of more than five years of follow-up, 145 people with NAFLD, or 5 per cent, were diagnosed with dementia, compared to 1,291 people without liver disease, or 4.6 per cent.


#### Youth arrested for raping minor

Mahakalapara, July 17: Child marriage or marriage of underage girls has seen a sharp spike in various villages under this block in Kendrapara district. The issue has acquired promi-

nence with the number of child marriages increasing day by day. Observers claimed that on an average, around 100 underage girls are getting married every year in villages under this block.

The marriage of a minor girl held secretly at a temple shrine late Friday night is a case in this point. The priest hurriedly completed the marriage rituals after local youths rushed to the spot and opposed the marriage.

The girls after their marriage are attaining motherhood at an early age. This poses serious threats to their life and to the child in their womb. The law has banned such marriages and termed it as social

There is sufficient provision of punishment for the family members and middlemen facilitating such marriages. However, such marriages take place unabated due to negligence of administrative officials and child rights officials.

As the girls get married at an early age, they fail to reap the benefit of Mamata Yojana, a maternity benefit scheme which has been instituted by the state government to assist pregnant and lactating women of age 19 and above across the state. As a result,



over 200 minor girls under this block married off at an underage have been deprived of the benefits of Mamata Yojana.

Child marriages are taking place in active connivance of the parents, locals, middlemen as well as sue to negligence of administrative officials. The middlemen take hefty sums as commissions and facilitate such marriages.

The parents of the girls and middlemen are tampering or editing the age of the minor girls in their Aadhaar cards and marrying them off to men much older to them in age. In many cases, parents, lured by money marry off their underage daughters to persons much older to them in far-off places like Jhansi, Mathura in Uttar Pradesh, West Bengal and Rajasthan.

The problem is rampant in Batighar, Jambu, Suniti, Kebi Dandua, Baulakani, Petachhela, Ramnagar and Kharinasi panchayats of the block where minor girls are married off soon after attaining puberty.

Malkangiri, July 17: People of three panchayats in Swabhiman Anchal of this district have demanded construction of a bridge at Orapad launch ghat near Andarapalli village.

The issue was taken up at a meeting where over a hundred people from Panasput, Jantri and Andarapalli panchayats had assembled.

They pointed out that the Gurupriya Setu has certainly facilitated communication to Swabiman Anchal, but for people of these three panchayats, taking the route of Gururpriya bridge is a long arduous journey to Malkangiri or some parts of Chitrakonda. "If a bridge is built at Orapad ghat, it will reduce the distance between the three panchayats and Chitrakonda by several kilometres," they observed. They added that the state government should pay attention to the demand in the larger interest of the people of the three remote panchayats.

# Scam alleged in supply of kits to Anganwadis

Derabish, July 17: A plethora of programmes are being executed under integrated child development scheme (ICDS) for all-round development of children through Anganwadi centres (AWCs). However, massive irregularities have allegedly been committed in the purchase and supply of medical kits and toy kits for children in Derabish block of Kendrapara district, a report said.

 $\label{eq:cording} According to the report, there are$ 324 Anganwadi and Mini Anganwadi centres in 26 panchayats under this block. Recently, health kits and toy kits have been provided to these centres. The price of each health kit was shown to be ₹1,500 and that of a toy kit ₹2,500.

Local people and many Anganwadi workers on condition of anonymity said that a scam has been committed in supply of these kits. Anganwadi workers said that vendors have been unofficially engaged in supply of such kits and they forcibly want Anganwadi workers to buy such kits from them.

In some cases, funds have been transferred to bank accounts of some Anganwadi workers. In fact, a health kit would cost around ₹500 to 700 in the market while a toy kit will be available in between ₹800 and ₹1,000, locals said.

When contacted, ICDS officer Snehalata Sahu blamed the Anganwadi workers for this. "Funds have been credited to the bank accounts of Anganwadi workers who are supposed to buy the kits from the markets, but they buying kits from traders. I will visit the AWCs and look into the alleged irregularities," she added.

The ICDS officer, however, dismissed the allegation of unofficially engaging some vendors to supply kits to the AWCs.

Former zilla parishad member Raghunath Satpathy said that such irregularities are only defeating the purpose of the ICDS and the officials are tactically promoting such irregularities through vendors. He demanded an impartial investigation into the alleged irreg-

# Freebies

Bundelkhand, in Jalaun of Uttar Pradesh, a highly impoverished area at the border of UP and Madhya Pradesh, had the privilege of seeing the Prime Minister of India as the inaugurator of the 296 km long Bundelkhand Expressway last week. PM Modi, in his speech at the function, drew attention to the freebies culture being propagated by all non BJP state governments with the sole aim to garner support from voters. He further stated that people offering 'revadi', a popular north Indian sweet, are incapable of thinking big and therefore are unable to create large projects such as expressways, airports or defence corridors. Since they were pre-occupied with distributing government sweets (freebies), it was only Modi and his BJP that were thinking for development of the country. His call was for defeating this kind of low level thinking currently observed in the country's politics. The PM said the youth of India had to especially guard against the growth

Undoubtedly, the offering of freebies by all, yes all, parties before elections is an unhealthy practice in a democracy. Yet, many social welfare projects that have been not only declared but also very successfully implemented by most state governments across the length and breadth of this nation have

definitely helped the poorest of the poor. Such freebies, once a standard operating procedure for all parties in Tamil Nadu, have now spread all over this country. It is not as if the BJP has not offered such pre poll condiments itself even in Uttar Pradesh. India's economy still suffers from the Demonetization of November 2016. That sudden blow on cash was claimed to have been done to kill black (unaccounted) money, stop terror funding and destroy the coun-



terfeit currency business that was being promoted by Pakistan. All these assertions are being proven false over and over again. Only one goal was successfully achieved. The opposition to the BJP in UP lost all its cash at that time and the 2017 elections went in favor of Modi's political outfit. The cost to the nation, for that electoral victory of the BJP, has been stupendous. Similarly, the 2022 UP Assembly elections also saw a slew of promises from the incumbent Yogi Adityanath led BJP government which included bicycles, laptops and uniforms for students to specially and temporarily hiked payment for collection of sugar cane to farmers among various other such freebies. Therefore, it is untrue to claim that the culture of 'revadi' (pre poll sops) is limited to non BJP parties alone.

Come elections and all those big sounding, holier than thou political leaders change to meek little scurrying rats holding out attractive gifts for the bulk of the voters. Sad truth is that none of them has been seen even trying to be different and calling a spade a hammer. On the other hand, many recent developments demonstrate the mindset controlling the Central government decisions. Most airports and ports of India, we are told, now belong to only one single individual. The policies implemented lately have all gone to favor only one huge corporate body which has successfully cornered the airlines market. In other words, the sky above India, too, has been privatized. Railways are under the hammer, only delay is an opportune moment. Life Insurance Corporation (LIC) has been grievously damaged in the market because of the Central government initiatives to do so. Hindustan Aeronautics is down in the dumps because no new project is being given to it but, instead, private players are being encouraged to enter the defense production arena. Government bends to pressure from the automobile industry lobby not to allow entry of a 100% electric vehicle like Tesla, whereas that same lobby accepts a Volvo to enter the market as it is going to introduce a dated IC based engine technology. Banks are being merged and the government is on an overdrive to privatize them, without ever considering how to make the nationalized banks healthy and trustworthy. If the Congress led government had damaged the banks, these long 8 years of the BJP administration should be considered as ample time to turn them around.

All these must not divert our attention from the severe blow given to the poor by the increase of GST from today on essential food items, whether living in Bundelkhand or Bhubaneswar, and the resultant economic damage that will be caused to their finances.

### Umami

t's usually said that the human tongue can detect only four basic tastes: sweet, sour, bitter and salty, and that all tastes are combinations of these. Many specialists now believe that taste is actually more complicated than this, with the taste buds being helped along by sense of smell, by the feel of substances in the mouth and even by the noise that food makes when we chew it. In recent years some workers have added a fifth taste, umami, to the other four, though western food scientists are divided about whether it really exists or not. It has been suggested that the taste is triggered by compounds of some amino acids, such as glutamates or aspartates, especially the flavourenhancing substance monosodium glutamate. Both the word and the concept are Japanese, and in Japan are of some antiquity. Umami is hard to translate, to judge by the number of English words that have been suggested as equivalents, such as savoury, essence, pungent, deliciousness, and meaty. It's sometimes associated with a feeling of perfect quality in a taste, or of some special emotional circumstance in which a taste is experienced. It is also said to involve all the senses, not just that of taste. There's more than a suggestion of a spiritual or mystical quality about the word.

## **■** Umbrage

Umbrage is offence or annoyance. These days we almost always take umbrage, the two words having been conjoined into a fixed phrase. It is less common to hear of people giving umbrage, though someone who takes umbrage presumably has had it inflicted on him by another. Or does this imbalance imply that the perceived offence is almost always in the mind of the receiver? Umbrage derives from Latin umbra, shadow, and that was its first meaning in English. A tree might cast umbrage and in later centuries its foliage came to be its umbrage. Shelley wrote "The tall ash and oak, in mingled umbrage, sighed far above their heads." In the time of Shakespeare, an umbrage was a shadowy outline (Hamlet uses it for the shadow of a man), which led to its suggesting somebody lurking out of plain view. From this grew ideas of being under the shadow of suspicion and being in disfavour and indirectly to our modern senses of annoyance, offence or resentment. Umbrage has almost entirely severed its associations with shadows, but its adjective umbrageous usually refers to shade, most often that cast by trees. We have lost its relative umbratile, which once referred to a reclusive person, one who kept in the shade by staying indoors. However, we retain another relative, umbrella, originally a sunshade, which came into English via Italian.

The science makes clear that to avoid the most catastrophic effects of climate change and to build resilience against the effects that are already inevitable. we must end biodiversity loss be fore 2030. That means establishing lasting conservation for at least 30% of land and sea areas within eight years, and then charting a course toward living in harmony with nature by 2050.

Though the challenge is massive, ignoring it makes no sense from a business perspective. A World Economic Forum white paper estimates that nature-positive policies "could generate an estimated \$10 trillion in new annual business value and create 395 million jobs by 2030." Among other things, such policies would use precision-agriculture technologies to improve crop yields – diversifying diets with more fruit and vegetables in the process - and boost agroforestry and peatland restoration.

A nature-positive approach can also be more cost-effective. For example, the Dasgupta Review (the Final Report of the United Kingdom's Independent Review on the Economics of Biodiversity) finds that green infrastructure like salt marshes and mangroves are 2-5 times cheaper than grey infrastructure such as breakwaters.

Nonetheless, private-sector action is lagging, including in economic sectors where the health of value chains is closely tied to that of nature. That is one key finding from an analysis just released by the UN Climate Change High-Level Champions, Global Canopy,

Rainforest Alliance, and others.

Out of 148 major companies assessed, only nine - or 6% - are making strong progress to end deforestation. Among them are the Brazilian paper and pulp producer Suzano and five of the largest consumer goods companies: Nestlé. PepsiCo, Unilever, Mars, and Colgate-Palmolive.

Unilever, for example, is committed to a deforestation-free supply chain by 2023, and thus is focusing on palm oil, paper and board, tea, soy, and cocoa, as these contribute to more than 65% of its impact on land. Nestlé has now made over 97% of its primary meat, palm oil, pulp and paper, soy, and sugar supply chains deforestation-free. And PepsiCo aims to implement regenerative farming across the equivalent of its agricultural footprint by 2030, and to end deforestation and development on peat.

These are positive steps, but they represent exceptions, rather than any new normal. Moreover, the financial sector has also been slow to turn nature-positive. Since the COP26 climate-change conference in Glasgow last year, only 35 financial firms have committed to tackle agricultural commodity-driven deforestation by 2025. The hope now is that more firms will join the deforestation commitment by COP27 this November. Under the umbrella of the Glasgow Financial Alliance for Net Zero, 500 financial firms (representing \$135 trillion in assets) have committed to halving their portfolios' emissions by 2030 and reaching net zero by 2050. And now, the Alliance has issued new net-zero guidance that includes recommended policies for addressing

deforestation. Nature functions as a kind of global capital, and protecting it should be a no-brainer for businesses, investors, and governments. The World Economic Forum finds that "\$44 trillion of economic value generation – over half the world's total GDP - is moderately or highly dependent on nature and its services." But this profound source of value is increasingly at risk, as demonstrated by the current food crisis, which is driven not just by the war in Ukraine but also by climate-related disasters such as drought and India's extreme heatwave, locust swarms in East Africa, and floods in China.

Businesses increasingly have the tools to start addressing these kinds of problems. Recently, the Science Based Targets initiative released a methodology for targeting

emissions related to food, land and agriculture. Capital for Climate's Nature-Based Solutions Investment platform helps financiers identify opportunities to invest in nature with competitive returns. And the Business for Nature coalition is exploring additional moves the private sector can make.

Governments have also taken steps in the right direction. At COP26, countries accounting for over 90% of the world's forests endorsed a leaders' declaration to halt forest loss and land degradation by 2030. And a dozen countries pledged to provide \$12 billion in public finance for forests by 2025, and to do more to leverage private finance for the same purpose. They can now start meeting those commitments ahead of COP27 in Sharm El-Sheikh, by enacting the necessary policies, establishing the right incentives, and delivering on their financial promises.

Meanwhile, the UN-backed Race to Zero and Race to Resilience campaigns will continue working in parallel, helping businesses, investors, cities, and regions put conservation of nature at the heart of their work to decarbonize and build resilience. The five strong corporate performers on deforestation are in the Race to Zero, and the campaign's recently strengthened criteria will pressure other members to do more to use biodiversity sustainably and align their activities and financing with climate-resilient development.

# The varieties of climate-driven medical risk

people to pack a bag and flee to safety, important California's 2007 wildfire season, it was estimated that "at least one family member per household left prescription medication behind during evacuation." Likewise, when Hurricane Harvey threatened to flood my own mother's Texas home in August 2017, she forgot to grab her medication in her rush to escape the storm's path - even though she was normally meticulous when packing for a trip. With climate change contributing

to the increased severity and frequency of such disasters, preventing interruptions in health care and meeting displaced people's unmet health needs will become an increasingly urgent task. We already know that extreme weather drives migration and statelessness, displacing 21.5 million people per year -41 people per minute. Hurricanes, cyclones, floods, and wildfires regularly disrupt access to preventative services (such as routine cancer screening), mental-health services, and treatments for chronic diseases. Owing both to a severe drought and civil war, many Syrian refugees lost access to health care and were later found to be suffering from chronic diseases such as cancer, hypertension, and diabetes

Climate-driven disasters pose both direct and indirect threats to the continuity of health care.

Then natural disasters force According to a 2019 study in the Journal of General Internal Medicine, the ten-year survival items are often forgotten. Following rate of breast cancer patients whose treatment was directly interrupted by Hurricane Katrina was markedly

worse than that of a control group. Likewise, indirect exposures to chemicals, water- and airborne pathogens, and particulate air pollution from natural disasters are known to increase the risk of cancer. During Hurricane Harvey, for example, chemical plants and oil refineries were flooded, releasing cancer-causing substances into the surrounding environment. And researchers warn that currently inert chemicals like the insecticide lindane may become carcinogenic as the planet warms.

Wildfires pose similar threats, not only by destroying homes and health-care facilities but also by churning out harmful ambient particulate matter that increases the risk of death from lung, breast, and liver cancers. Heart attacks, strokes, and respiratory conditions such as asthma and chronic obstructive pulmonary disease often follow in the wake of the flames. New research, conducted over the course of 20 years, shows that people living within 50 kilometers (31 miles) of wildfires in Canada had a 10% higher risk of incident brain tumors and a 4.9% increased risk of incident lung cancer compared to people living farther away.

While relief efforts necessarily

focus on the immediate aftermath of disasters, these direct and indirect health effects tend to persist. Without greater efforts to a result, the Michigan Medicine maintain continuity of care, the anDepartment of Anesthesiology has nual wildfire season may come to be known as cancer season.

We urgently need more equitable approaches to address the heightened risks of cancer and chronic disease following climate emergencies. Mobile alerts and checklists for chronic-disease care can help save lives during emergencies and evacuations. In addition to ensuring safe shelter, disasterpreparedness protocols should also include measures to provide common prescription medicines, telehealth, virtual mental-health services, virtual crisis training for health-care providers, and resourcestratified treatment guidelines.

Among the many tragedies of the climate crisis is that those who contributed the least to the problem stand to bear the brunt of the costs. To address this inequity, the Union for International Cancer Control (and its partners) has launched the Access to Oncology Medicines Coalition to improve access to cancer medicines in low- and lower-middle-income countries.

A related issue is the health sector's carbon footprint. Here, surgical care is notable for its contributions to greenhouse-gas emissions. Administering the anesthetic sevoflurane for one hour is tantamount to driving an internal combustion vehicle 20 miles, and an hour's worth of desflurane is approximate to driving 400 miles. As introduced a Green Anesthesia Initiative to explore ways to reduce the field's emissions, such as by promoting greater use of sevoflurane instead of desflurane. Recently, health-care leaders have pledged to cut greenhouse-gas emissions.

Finally, though we know that people displaced by climate change are subject to a range of health risks, more research and education is needed to improve our understanding of this broad, complex issue. For example, there is more to learn about how scorching heat waves, water scarcity, food insecurity, comorbidities, and the dehydrating effects of cancer treatment might amplify disparities associated with poor cancer outcomes for people displaced by climate emergencies. Addressing the burgeoning climate-driven health crisis is a moral imperative for the World Health Organization, governments, health-care professionals, and health advocacy groups. Our ability to lead healthy lives depends on having a healthy planet. As the climate changes, so must our health policies and protocols.

**Overworked Indians** 

Sir, It's interesting to note that Indians, who are among the most overworked workers in the world, get the lowest minimum statutory income in the Asia-Pacific region, second only to Bangladesh, according to a recent study by the International Labour Organization (ILO). According to the Global Wage Report, 2020-2021, India is placed fifth globally among countries with long work weeks that routinely surpass 48 hours. The survey also revealed that with the exception of some Sub-Saharan African nations, the minimum statutory salary for an Indian worker is the lowest in the world. The report also said Indians don't spend much time relaxing, which is bad for maintaining a healthy work-life balance. As per the report, Indians spend less than a tenth of their day on leisure activities, with women getting less time than men for leisure. The data in the ILO report is based on 2019 estimates presented by national agencies. According to statistics from the 2018-19 Periodic Labour Force Survey (PLFS), self-employed and salaried males in urban areas of India worked more hours per week than their counterparts in rural areas. Recently, India made a historic decision to replace 29 existing labour laws with four new labour codes that deal with pay, social security, industrial relations, and occupational safety. This historic decision was made with the goal of rationalising, simplifying, and streamlining complicated labour laws. This will result in a significant shift in the nation's work culture. Everything is expected to change if the new laws go into effect, from working hours to the pay received in cash.

New Delhi, July 17: Joint opposition candidate for the August 6 vice presidential election Margaret Alva, a Congress veteran, is not new to comebacks.

Barring a brief lull in 2008 triggered by her standoff with Congress President Sonia Gandhi over the issue of family entitlement in ticket distribution, the suave and softspoken Alva's career has largely been a dream run. Alva, 80, has a political career spanning over four

decades during which she occupied several positions including a five-time Congress MP, a union minister and then governor. Alva had publicly alleged the "sale of Congress tickets in Karnataka" in 2008 when her son Nivedith's ticket claim was shot down by the then party in charge of the state. Alva had then openly questioned the denial of ticket to her son while wards of leaders in some other states had been accommodated.

She was dropped at the time as AICC general secretary and also



from the party's election committee but made a comeback later and retired as governor of Rajasthan

in 2014. While she was always close to Sonia, her son Nikhil Alva also served in Rahul Gandhi's closest team of advisors when the latter was Congress President until his resignation after the party's May 2019 embarrassing loss.

She was elected to the Rajya Sabha for the first time in 1974 at the age of 32 years and remained in the upper house for four terms until 1998. She won her first Lok Sabha election from Karnataka and served as a member of the 13th Lok Sabha. Alva was made

Affairs by then Prime Minister Rajiv Gandhi in 1984 when she was just 42. Through her three decades in Parliament as MP and later minister, Alva piloted major legislative amendments on women's rights, reservation for women in local bodies, equal remuneration, marriage laws and Dowry Prohibition Amendment Act. Her first political setback came in 2004 when she lost the Lok Sabha election and was appointed adviser to the Bureau of Parliamentary Studies and

Training, a body established to improve the levels of the legislative function of Parliament and state legislatures. Alva was also made AICC general secretary in charge of crucial states Maharashtra, Punjab and Haryana. She also went on to become the first woman governor of Uttarakhand besides serving as governor of Goa, Gujarat and Rajasthan. A little-known fact about Alva is that she was encouraged to enter politics by her father-in-law Joachim Alva and mother-in-law Violet Alva.

Citing an office memorandum dated July 16, a senior government official said that the briefing by the finance and external affairs ministries has been scheduled for the evening of July 19, the second day of the monsoon session of Parliament. The briefing will be attended by the floor leaders of various political parties, the official added. The monsoon session will begin July 18 and is scheduled to continue till August 12.

India has assured Sri Lanka that it will continue to support democracy, stability and economic recovery in the country, which is at a crucial juncture, amid the unprecedented political crisis and economic turmoil.



# Old newspaper wrappings are back but traders aren't happy

Kolkata, July 17: The good old newspaper 'thonga' or 'thongey' is back with a bang, thanks to the ban on single use plastic (SUP) but shopowners are complaining, even as 'kabadi walas' reselling old newspapers to packet makers are all smiles. Over the last fortnight, the price of these packets have gone up by over 40 per cent in

Kolkata and the suburbs. "We used to buy newspaper packets for Rs 35 a kilogram till June 30. This has now gone up to Rs 50. It is now turning out to more expensive than the SUP bags we used earlier. The other option is to provide plastic bags that are made of thicker material. These are also expensive. Customers are still not keen to pay Rs 2-3 for such bags and demand them for free," a shop owner in Bhowanipore said.

He maintained that he earns a profit of merely Rs 5-6 by selling a dozen eggs. Of this, 50-60 paise is lost for the newspaper packet. A fur-

ther Rs 2 for a bag would see his profit tumbling to less than Rs 3,

"Like always, it is the small-time trader who is suffering. Large grocery stores make a profit of Rs 100-150 from every customer and happily give away bags worth Rs 5. These

same customers expect the same from us when purchasing items of far lesser value. We are expected to give away a bag worth Rs 3 for a profit of Rs 20. There needs to be a awareness among all sections of society,' said Shyamal Sarkar, a trader in

The 'thonga' makers claim that they were forced to increase prices after the used newspapers they use got more expensive. Earlier, they used to buy newspapers at Rs 10 per kilogram. Now, its Rs 14-15 per kg. Most such packets are made by women in marginalised households. Apart from the labour, there are other expenses involved like gum and hardboard for support. At best, every household can churn out 3-4 kg of packets per day. This means an earning of about Rs 100-120 for their effort.

'We have to purchase the newspaper in bulk. Not all of them are usable. Many have stains, some are torn and soggy. Wastage is nearly 20 per cent. It gets more difficult during the monsoons when the material is damp. It is hard work to make these packets and all we get is about Rs 100 a day. We don't go around distributing the packets to shops. There are people who collect them from us. They make a profit too," Sunita, a homemaker from Baguihati said.

# SC to hear pleas filed by Uddhav, Shinde July 20

Cama, Director of Parzor Foundation, one of the implementing bodies for this scheme, said that it is necessary to encourage people of the Parsi community to marry and have children because the total fertility rate in this community is about 0.8 per couple and an average of 800 people die every year against the birth of 200 to 300 children, which is worse in comparison to the situation of

According to the new National Health and Family Welfare Survey (NHFWS), the total fertility rate is 1.94 in the Hindu community, 2.36 in the Muslim community, 1.88

Hindus, Muslims, Sikhs and

in the Christian community and 1.61 in the Sikh community. According to the 2011 census, the population of the Parsi community in the country was 57,264 as against 1,14,000 in 1941.

The Ministry of Minority Affairs launched the 'Jiyo Parsi' scheme in November 2013 with the intention to balance the population of the Parsi community and increase the total fertility rate, for which a budget of 4 to 5 crore is provided every year. "Since the launch of the scheme (till July 15), 376 babies are born, which is more than the average of 200 babies born in the Parsi community every year." Cama told PTL

He said that the biggest reason for the low birth in the community is unmarried adults. "It has been found in the study that about 30 per cent adults of Parsi community are unmarried even though they are eligible for marriage.

Lucknow, July 17: Uttar Pradesh, until not so long ago, was known for its pot-holed roads that made one break the journey instead of com-

Today, the state has emerged as the expressway capital of the country with 13 expressways -- six expressways having been completed and seven under various stages of construction

Prime Minister Narendra Modi, Sunday, inaugurated the sixth 296km-long Bundelkhand Expressway that directly connects with Delhi.

It will connect the backward districts of the region such as Chitrakoot, Banda, Mahoba, Hamirpur, Jalaun, Aurraiya and

According to a government spokesman, "Realising that infrastructure is the growth engine of the economy and roads are the mirror of progress, the double engine Bhartiya Janata Party-led government has worked extensively for the rejuvenation of roads and improving connectivity.'

The access-controlled road network is being developed by the Uttar Pradesh Expressways Industrial Development Authority (UPEIDA), the agency set up by the state government to steer its expressway expansion programme.

All the four expressways, interlinked, will bring the remotest and backward regions closer to not only state capital Lucknow but also Delhi and beyond, opening up markets and giving a big boost to socio-economic development in

"These corridors will give impetus to rapid, balanced and inclusive growth as well as immense



employment potential. Lands have been marked for this. Airstrips are also being built on the expressways for landing and take-off of Air Force aircraft in case of emergency," said Avanish Awasthi, UP Home Secretary and Chief Executive, UPEIDA.

While the Yamuna expressway, which came up in 2012, and the Agra-Lucknow Expressway that opened to public in 2018 started the trend, it is the four new expressways: the 340-km Purvanchal, 296-km Bundelkhand, 91-km Gorakhpur Link, and the 594-km Ganga expressways that are scripting a silent transformation

Once these are complete, UP would have a network of 1,788 km of expressways in all, the highest in the country.

Currently, the total expressway network in India is around 1,822 kilometres which has earned UP the sobriquet of 'Expressway Pradesh'.

The government spokesman said that from village streets to block headquarters and district head-

hours now via the Yamuna, Agra-Lucknow, Purvanchal and Bundelkhand expressways. Currently, there is no direct road link between Delhi and the Bundelkhand region.

While work is underway on the expressways, UPEIDA is also working on creating industrial hubs around the area. Work is also underway on the defence corridor project, where land is being allotted to defence companies to set up their manufacturing unit.

'Take for instance the famed mangoes from Malihabad. Mangoes are a highly perishable commodity. But the Agra-Lucknow expressway has meant that the mangoes get transported to Delhi and beyond during the season," Sehgal added.

The Purvanchal Expressway will be completed in about 22 months. The Bundelkhand Expressway is expected to open a year ahead of its scheduled

According to Awasthi, one of the main reasons for the change in work culture was because of the push given to infrastructure development by Chief Minister Yogi Adityanath.

"UPEIDA was empowered to make quick decisions, be it land acquisition, getting forest and environment clearance, shifting utilities, etc. We managed to get environment clearance for Purvanchal and Bundelkhand expressways in record time," he said

The fast-track decision-making and availability of land ensured that developers promptly came forward to bid. Another reason that developers were confident to take up projects was because UPEIDA did not keep their dues pending for

Experts' take on Guj civic woes exposed

Gandhinagar, July 17: In three hours Ahmedabad received 125 mm rain July 10, and faced waterlogging, Rajkot received 133 mm in 24 hours, yet the roads were still flooded July 11. The same was the story of Surat, Vadodara and other cities in Guiarat. This is because urban planning for storm water is based on historical data and not on projected data, climate change is not considered while planning, is what the experts say

When one listens to the officers or the elected representatives, they prove the experts right. Take the example of Ahmedabad, the Municipal Corporation Water Committee chairman Jatin Patel said, "The city has 980 kilometres storm water pipeline, its capacity is to carry one inch of rain in an hour, if it rains more water-logging will happen.'

In another major city Vadodara, the municipal corporation website says in 2012 the storm water network was 108 square kms, redesigned and maintained natural drains of 33 kms, for a city spread over 158 square kms with a population of 16 lakh in 2011.

City executive engineer Rajesh Shimpi did not answer queries whether this capacity was expanded or not in the last 10 years.

Again, Saurashtra's financial capital Raikot's present storm water capacity is not enough for its requirements. The city's west zone

deputy engineer KS Gohil said, 'Based on other colleagues' experience, where it rains heavily and where less, a pipeline with 1400 mm to 300 mm diameter is installed. Our aim is to bring down the waterlogging time, there can't be a 100 percent solution. Earlier water used to stagnate for one and a half hours, but that has been reduced to 40 to 45 minutes.

According to Devang Parekh, Dean of Indubhai Parekh School of Architecture, Rajkot, the waterlogging for hours and sometimes for a day or two in the cities can be attributed to two reasons -- firstly, very heavy rain and secondly, poor planning.

For decades climate change has been talked about and even budgets have been allocated, but no one is serious, felt Mahesh Pandya, an environmentalist. Citing a recent example, he said June 7 the Ahmedabad Municipal Corporation held a public consultation event to plan how to use a Rs 3000 crore World Bank loan to create storm water and drainage facilities. But no brainstorming happenned, only the Mayor, Deputy Mayor and Commissioner were felicitated.

Sharma and Parekh are of the view that as population growth is estimated, similarly rainfall should be estimated for the next five to ten years. Based on such estimates the drainage/storm water pipeline size and even cement ducks can be planned and designed that can clear rainfall of 4 or 5 inches in an hour.

# Techie makes smart cradle to make life easier for parents

Ahmedabad, July 17: It's hard for working new parents to stay awake all night to care for their child, even during the day they can't be by the cradle the whole day. It's a real challenge for the new parents to calm the crying child every time the cradle stops swinging. A start up from Ahmedabad has come up with an affordable idea. Rushabh Sheth has created an electronic cradle with some interesting features.

Rushabh shared with IANS, "I had to do a project during my final

semester of mechanical engineering in 2017. I used to see the mothers doing labour work at construction sites. How they had to create some temporary cradle out of bedsheets or sarees. They could not even stay near their children to swing them. Sometimes their children got out of the cradle and started playing in the risky areas as the cradle stopped swinging. I saw a similar situation at my home too. That drew me to build a motorised cradle."

Rishabh shares about the journey of his cradle design, "I made a working model with a normal steel cradle as I did not have much money.



But Gujarat Technological University saw potential in my design. So they promoted it, I also got some media coverage at that time.' Rishabh describes the design,

he says this cradle uses a power adapter like laptops and mobile charger, so it doesn't pass an electric current. It has a timer of 20 minutes and speed variation options mal cradle by the customer themselves, he adds. Rushabh said right now the cradle costs between Rs 2,500 and Rs 5.000, 6,000. I have about 6,000 happy customers. # Scientists grow potato, tomato in one plant

Varanasi, July 17: Potatoes and tomatoes are the almost essential ingredients of Indian cuisine, but did anyone ever believe that the two could be grown in one plant?

The Indian Institute of Vegetable Research (IIVR) in Varanasi has developed a technique through which potato and tomato can be grown on a single plant and the same is named as 'pomato'.

 $Pomato\,was\,developed\,last\,year$ and IIVR scientists have been trying to further improve the quality and quantity of the same.

They have now succeeded in growing brinjal on the pomato plant and this is aptly called 'Brimato'. Chillies are also being grown on the Brimato plant.

Scientist Anant Kumar said that it had taken five years of research to develop the new multiple varieties.




Each plant of pomato can vield up to two kilograms of tomatoes and 600 grams of potatoes. The lower layer of soil is for potatoes and the upper layers for tomatoes. Similarly additional layers are used to grow brinjals and chillies. These plants can be grown in pots and are ideal

for households," he added. He further said that for larger cultivation areas, these plants are grafted into the soil but take longer time to be ready for use.

"The brinjal takes about 25 days <del>(</del> to get ready to be plucked while tomato takes 22 days," he said.



# MURMU VS SINHA Indian carriers face tough time

New Delhi, July 17: Nearly 4.800 elected MPs and MLAs will vote Monday to elect the 15th President of India, with NDA candidate Droupadi Murmu having a clear edge over Opposition's Yashwant Sinha as over 60 per cent votes are expected to be cast in her favour.

With the support of regional parties such as BJD, YSRCP, BSP, AIADMK, TDP, JD(S), Shiromani Akali Dal, Shiv Sena and now JMM, Murmu's vote share is likely to reach nearly two-thirds and she is set to become the first woman from the tribal community to occupy the top constitutional post.

The National Democratic Alliance (NDA) nominee now has over 6.67 lakh votes after the support of various regional parties, out of a total of 10,86,431 votes.

The electoral college which elects the President through the system of proportional representation comprises elected MPs and members of state legislative assemblies. Nominated MPs and MLAs, and members of legislative councils are not entitled to vote in this election.

The system of secret ballot is followed and parties cannot issue whip to their MPs and MLAs with regard to voting. The value of the vote of a member of Parliament has

gone down to 700 from 708 in this presidential poll due to the absence of a legislative assembly in Jammu and Kashmir.

The value of vote of an MLA varies in different states. In Uttar Pradesh, the value of vote of each MLA stands at 208, followed by 176 in Jharkhand and Tamil Nadu. In Maharashtra, it is 175. In Sikkim, the value of vote per MLA is seven, while it is nine in Nagaland and eight in Mizoram

Before naming Sinha, a former Union minister and a BJP leader, the opposition camp had approached Gopalkrishna Gandhi, grandson of Mahatma Gandhi and a former governor of West Bengal, NCP supremo Sharad Pawar and

National Conference leader Farooq Abdullah to contest the poll.

After their refusal to be part of the electoral battle, Sinha, then the Trinamool Congress vice president, was named as the Opposition's candidate. The election of the President is held in accordance with the system of proportional representation by means of single transferable vote.

In accordance with the system of proportional representation by means of single transferable vote, every elector can mark as many preferences, as there are candi dates contesting the election.

These preferences for the candidates are to be marked by the elector, by placing the figures 1, 2,

The polling will take place in Parliament House and state legislative assemblies between 10 am and 5 pm for which ballot boxes have already reached their destinations

The counting of votes will take place at Parliament House July 21 and the next President will take oath July 25

3, 4, 5 and so on, against the names of the candidates, in the order of preference, in the space provided in column 2 of the ballot paper.

This is the reason why electronic voting machines are not used in this as well as vice presidential, Rajya Sabha and legislative council polls. The EVMs are based on a technology where they work as aggregator of votes in direct elections such as the Lok Sabha and state assemblies. According to Election Commission's directions, while MPs will get a green-coloured ballot paper, the MLAs will get a pink ballot paper to cast vote. Separate colours help the returning officer ascertain the value of vote of each MLA and MP. Seeking to maintain secrecy of voting, the EC has issued a specially designed pen with violet ink to enable voters mark their ballot papers in the presidential poll.

New Delhi, July 17: Indian carriers which were looking forward to sunny days with the receding of Covid-19 pandemic have hit serious turbulence, as they are now faced with an issue they left unaddressed in the past two years: employees'

disaffection over low pay. On July 2, around 55 per cent of IndiGo's domestic flights were delayed as a significant number of its cabin crew went on leave, with sources saying they reportedly went for an Air India recruitment drive. On July 13, some SpiceJet pilots circulated a message that the airline's captains and first officers will be going on sick leave Thursday to protest their low salaries. However, on the said day, all pilots reported on duty, according to the airline.

Indian carriers, which saw their revenues sapped dry during the global virus attack, had cut down salaries of their employees during the peak of the pandemic to save cash. Most of them are yet to bring these salaries back to prepandemic levels. A senior executive of a low-cost

carrier said employees are not lost on the fact that while their workload at present is as huge as it was before the pandemic, they are getting lower salaries, even as a rising inflation nibbles away at this circumscribed income. This has created a lot of dis-

content among the employees, especially those who are at the bottom of the hierarchy, like technicians, the executive added.

Two technicians - who took part in this 'sick leave protest' -- said the new joinees in the low-cost carriers are paid anywhere between Rs 8.000-Rs 15,000 per month, which is extremely less.

While it seems that the issues of low pay have cropped up only now.

A significant section of aircraft maintenance technicians of IndiGo and Go First have gone on sick leave in the last one week to protest their low salaries

However, despite the staff crunch, both carriers have managed to keep their flight operations unaffected, barring a few embarrassing incidents

The truancy among the employees of these airlines is also being cited as occasioned by the hiring sprees launched by carriers such as Akasa Air. a revamped Jet Airways, and Tataowned Air India

within the aviation industry.

In September and November last year, there were two instances where SpiceJet employees -- primarily from its security department or aircraft maintenance department -- went on strike in front of the Delhi airport protesting reduced salaries and their irregular disbursement.

In a report issued in December 2020, aviation consultancy firm CAPA had said Human Resources (HR) planning is an afterthought in Indian aviation sector's growth equation, and this has been visible since 2003-04.

## IndiGo flight makes emergency landing

New Delhi/Karachi: IndiGo's Sharjah-Hyderabad flight was diverted to Karachi as a precaution Sunday after pilots observed defect in one of the engines, officials of aviation regulator DGCA said. On July 14, IndiGo's Delhi-Vadodara flight was diverted to Jaipur out of precaution as vibrations were observed in the engines of the aircraft for a second. The Directorate General of Civil Aviation (DGCA) is investigating both the incidents, officials noted.

# India crosses 200cr Covid-19 vax doses mark

New Delhi, July 17: India Sunday reached the historic milestone of 200 crore mark in Covid-19 vaccination. The milestone has been achieved after 18 months when the nation began the mass vaccination January 16, 2021.

According to the Co-Win Portal, with a total 1.91 lakhs of vaccine being administered so far Sunday the number crossed the milestone mark of 200 crore. A total of 199.97 crore Covid vaccine doses were administered across the country until Saturday night, which includes 5.48 crore doses of the precaution dose. On January 16, 2021, two Made-in-India vaccines -- Covaxin and Covishield -- were made available for the Indian citizens. After nine months, India completed the first 100 crore vaccination mark October 21, 2021. The nation has completed 200 crore mark again after nine months July 17, 2022.

It took 277 days to reach the earlier milestone of 100 crore doses. On September 17 last year, the highest 2.5 crore vaccine doses were administered in a single day.

Congratulating the nation on this historic mark, Union Health Minister Mansukh Mandaviya said that India has made a new record. "India has set a new record by completing the target of 200 crore vaccinations in just 18 months. Hearty congratulations to all the countrymen on this achievement" said Mandaviva in a tweet. He said that this day is to be remembered forever. Dr Poonam Khetrapal Singh, Regional Director WHO South-East Asia, also congratulated India on administering 2 billion Covid-19 vaccine doses.

#### 12 killed in Sudan

Cairo: Flashfloods triggered by seasonal torrential rains in Sudan's western Darfur region killed at least 12 people, including children, the UN and an aid group said Sunday. Heavy rains started late on Friday in the Kass locality in South Darfur province, according to the the UN Office for the Coordination of Humanitarian Affairs (OCHA). Citing Sudan's Humanitarian Aid Commission, OCHA said around 540 people were affected by the flooding, which also destroyed or damaged more than 100 houses in an area inhabited by displaced people.

#### Pak PM Shehbaz suffers setback

Lahore: Ousted premier Imran Khan's Pakistan Tehreek-e-Insaf Sunday made a 'clean sweep' in the crucial Punjab assembly bypolls, in a major setback to Prime Minister Shehbaz Sharif whose Chief Minister son Hamza Shehbaz is all set to lose his post. The election for the chief minister will be held on July 22 on the Supreme Court's order and PTI-PMLQ joint candidate Chaudhary Parvez Elahi is likely to the new chief minister of politically crucial province Punjab.

### Six dead in highway pileup

Los Angeles: At least six people died after a dust storm caused a 21-car-pileup on a highway in the US State of Montana. Six people are confirmed dead and eight people were transported to nearby hospitals after the pileup, which is described as one of the most intense multivehicle accidents in Montana on Friday evening, a local television station reported on Saturday morning.

# China renews yellow alert

Beijing: China's national observatory Sunday continued to issue a yellow alert for high temperatures as intense heat waves linger in many regions of the country. # Fires scorch France, Spain

Lisbon, July 17: - Authorities across southern Europe battled Sunday to control huge wildfires in countries including Spain, Greece and France, where thousands of people have been evacuated in soaring temperatures.

In Spain, helicopters dropped water on the flames as searing heat and often mountainous terrain made the job harder for firefighters. National weather agency AEMET issued high temperature warnings for Sunday, with highs of 42 Celsius (108 Fahrenheit) forecast in Aragon, Navarra and La Rioja, in the north. It said the heatwave would end Monday, but warned temperatures would remain "abnormally high."

Spain has been experiencing a nearly week-long heatwave, with highs of 45.7C (114F). In Malaga province, wildfires raged into the night, affecting local residents near Mijas, a town popular with northern European tourists.

British pensioners William and Ellen McCurdy had to make a quick escape from their home on Saturday. They were taken to a local sports centre with other evacuated people. "It was very fast .... I didn't take it too seriously. I thought they had it under control and I was quite surprised when it seemed to be moving in our direction and then we were told to go. So we have left a lot of stuff behind," William, 68, said.

"We just grabbed a few essentials and just ran and by that stage

everybody along the street was on the move," Ellen said. Mari Carmen Molina, a local councillor in Alhaurin, one of the evacuated towns, said she was worried homes could be destroyed. "It's terrible. It's a very difficult situation", she said.

# Hindu temple, homes vandalised in B'desh

Dhaka, July 17: A temple, shops and several houses of the Hindu community have been vandalised in southwestern Bangladesh by some unidentified persons over a Facebook post allegedly belittling Islam, in the latest spate of violence targeting the religious minority in the country, according to media reports Sunday.

Police fired warning shots to disperse a mob that vandalised several homes and torched one of them in Sahapara village in Narail district on Friday evening, bdnews24.Com, an online newspaper quoted Haran Chandra Paul, an inspector at the local police station, as saying. The attackers also threw bricks at a temple in the village during the attack around 7:30pm. he said.

They also broke the furniture inside the temple. Several shops were also vandalised, The Daily Star newspaper reported. Haran said a young man posted something offensive on Facebook, triggering anger among Muslims.

As tension mounted over the post after the Friday prayers, a group of Muslims demonstrated outside their home in the afternoon. They attacked the homes later. No attacker was arrested The situation was normal at night, said the police inspector. Narail Superintendent of Police Prabir Kumar Rov said the law enforcers were working to keep the situation under control.

Police forces were deployed in the area to prevent further violence, The Daily Star newspaper reported.

"After one group looted all our valuables, another group came and found our door open. As there was nothing left to loot, they set our home on fire," the paper quoted Deepali Rani Saha, a resident, as saving. Deepali's house was among homes and dozens of shops that were vandalised or burnt down in Sahapara village.

# 90-yr-old Indian woman visits ancestral home after 75 years

Lahore, July 17: An Indian woman's long-cherished dream of visiting her ancestral home in Rawalpindi materialised when Pakistan granted 90-year-old Reena Chhibber Varma a visa and she arrived here Saturday via the Wagah-Attari border, 75 years after leaving the country at the time of Partition.

Moist-eyed Varma, immediately after her arrival in Pakistan, left for her hometown Rawalpindi, where she will visit her ancestral dwelling Prem Niwas, her school, and childhood friends. In a video she uploaded on social media. Varma. who is from Pune, said her family was living on the Devi College Road in Rawalpindi when the Partition took place.

"I studied at the Modern School. My four siblings had also gone to the same school. My brother and a sister also studied at the Gorden College located near the Modern School," she recalled.

"My elder siblings had Muslim friends who would come to our home as my father was a man of progressive ideas and had no issue in meetings with boys and girls. Before the Partition, there was no such issue of Hindus and Muslims. This happened after the Partition,"

"Although the Partition of India was wrong, now that it has happened, both the countries should work together to ease visa restrictions for all of us," she said.

The Pakistan High Commission in India, in a goodwill gesture, has issued a three-month visa to Varma, who was only 15 years old when her family moved to India during the Partition in 1947.

# Russia preparing for next stage of offensive: Ukraine

Kviv. July 17: Russia is preparing for the next stage of its offensive in Ukraine, a Ukrainian military official said, after Moscow said its forces would step up military operations in "all operational areas".

As Western deliveries of longrange arms begin to help Ukraine on the battlefield, Russian rockets and missiles have pounded cities in strikes that Kviv says have killed dozens in recent days. "It is not only missile strikes from the air and sea," Vadym Skibitskyi, a spokesman for Ukrainian military intelligence, said Saturday. "We can see shelling along the entire line of contact, along the entire front line. There is an active use of tactical aviation and attack helicopters.

"Clearly preparations are now underway for the next stage of the offensive." The Ukrainian military said Russia appeared to be regrouping units for an offensive toward Sloviansk, a symbolically important city held by Ukraine in the eastern region of Donetsk.

The British defence ministry said Sunday that Russia was also reinforcing defences across areas it occupies in southern Ukraine after pressure from Ukrainian forces and pledges from Ukrainian leaders to force Russia out.

8 dead in cargo

Palaiochori (Greece), July 17: Experts investigating the site of a cargo plane crash in northern Greece said Sunday they have found no evidence of dangerous substances but say there is still a lot of widespread ordnance, while Serbia's defence minister confirmed that all eight crew members had died in the crash.

The An-12 cargo plane from Serbia flown by a Ukrainian aviation crew smashed into fields between two Greek villages late Saturday Its fuselage dragged on the ground for 170 metres before it disintegrated. Locals reported seeing a fireball and hearing explosions for two hours after the crash.

Serbian Defence Minister Nebojsa Stefanovic told a news conference on Sunday about the crew deaths

He also said the plane was carrying 11.5 tons of Serbian-made mortar ammunition to Bangladesh, which was the buyer. It had taken off from the Serbian

city of Nis and had been due to make a stopover in Amman, Jordan. "These were illuminating mortar mines and training (mines). ... This flight had all necessary permissions in accordance with international regulations,' Stefanovic said.

### Fuel demand falls

New Delhi: India's demand for petrol and diesel fell in the first half of July over the previous month as the onset of monsoon chipped away consumption in some sectors and restricted mobility, preliminary industry data showed Sunday. Diesel, the most widely used fuel in the country, saw consumption drop 13.7 per cent during July 1-15 to 3.16 million tonne from 3.67 million tonne demand in the same period of the previous month. The arrival and intensity of monsoon weighs heavily on diesel demand in the country and consumption traditionally is lower in July-September than in April-June. Floods restrict mobility and demand from the farm sector, which uses diesel in irrigation pumps and trucking, also drops with the onset of rains. Consumption of diesel was 43.6 per cent higher than the 2.2 million tonnes demand during July 1 to 15 of 2020. It was 13.7 per cent more than pre-Covid July 2019, the data showed.

### **Hindustan Zinc** plans huge plant

New Delhi: Vedanta group firm Hindustan Zinc is looking at expanding its footprint in the production of zinc alloys and has received approval to set up a 30 kilo tonne per annum plant (KTPA), company's CEO Arun Misra has said. The move will make way for the production of value-added zinc alloy products and enable the company to deliver international quality products in the domestic market, "As we surge ahead towards the fulfillment of our ambitions, we are also looking at expanding our footprint in the production of zinc alloys and have obtained the Consent to Establish (CTE) a 30 kt plant for Hindustan Zinc Alloys Pvt Ltd (HZAPL)," Misra said in the company's integrated annual report for 2021-22.

### Amazon sees \$12bn sales on Prime Day

San Francisco: Amazon saw sales worth at least \$12 billion (according to third-party estimates) during its Prime Day event in the US and 15 more countries on July 12-13. It was the first Amazon Prime Day event under the new CEO Andy Jassy who took over from Jeff Bezos last year. According to an analysis by Digital Commerce 360, consumers worldwide spent more than \$12 billion during the e-commerce giant's eighth annual Prime Day. That's up 8.1 per cent (year over year) from last years' Prime Day which ran from June 21-22. In 2021, Prime Day sales reached \$11.19 billion and represented a 7.7 per cent increase over Amazon's 2020 event.

# FPIs take out ₹7,400 crore from equities in July so far

Amid a weakening Rupee and recession fears in the *US there has been an exodus* of foreign funds from the Indian equity market over the last nine months

New Delhi, July 17: Foreign investors continue to be cautious about the Indian equity market and have pulled out over Rs 7,400 crore this month so far amid sustained strengthening of the dollar and increasing concerns over a recession in the US.

"Given the uncertainty in the forex market and the sustained strengthening of the dollar. FPIs are unlikely to turn aggressive buyers in the Indian market and at higher levels they may again turn sellers," said VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services

Going forward, FPI flows will remain volatile in the emerging markets on account of rising geopolitical risks, rising inflation and tightening of monetary policy by central banks, Shrikant Chouhan, Head - Equity Research (Retail), Kotak Securities, said.

According to data with depositories, FPIs pulled out a net amount of Rs 7,432 crore from Indian equities during July 1-15. While there have been sporadic net inflows by FPIs last week, the

New Delhi, July 17: Six of the 10 most valued firms suffered a combined erosion of Rs 1,68,260.37 crore from their market valuation last week, mainly dragged down by IT major TCS amid an overall weak trend in the equity market.

The 30-share BSE benchmark Sensex fell 721.06 points or 1.32 per cent last week.

From the laggards, Tata Consultancy Services (TCS) took the biggest hit as its market valuation tumbled Rs 99,270.07 crore to reach Rs 10,95,355.32 crore. Shares of TCS dropped last week after the company's June quarter earnings failed to meet market expectations.

Another IT behemoth Infosys also suffered an erosion of Rs 35,133.64 crore, taking its valuation to Rs 6,01,900.14 crore. HDFC Bank's market valuation

fell by Rs 18,172.43 crore to Rs 7,57,659.72 crore and that of State Bank of India (SBI) declined by Rs 8,433.76 crore to Rs 4,27,488.90 crore.

The market capitalisation (mcap) of HDFC dipped by Rs 4,091.62 crore to reach Rs 4,02,121.99 crore and that of ICICI Bank went lower by Rs 3,158.85 crore to Rs 5,22,498.11 crore.

In the ranking of top-10 firms, Reliance continued to remain the most valued domestic firm, followed by TCS, HDFC Bank, HUL, Infosys, ICICI Bank, LIC, SBI, HDFC and ITC

In contrast, the valuation of Hindustan Unilever Ltd (HUL) jumped Rs 17.128.52 crore to Rs 6,03,551.26 crore. Reliance Industries added Rs 6,801.72 crore, taking its market valuation to Rs 16,24,681.08 crore.

# Falling rupee darkens fight to tame inflation

New Delhi, July 17: Rupee depreciation has impacted the current account deficit and fuelled inflationary pressures but at the same time it has made Indian exports more competitive, according to experts.

The Indian rupee has been depreciating against the USD dollar and is nearing the psychologically key mark of 80, making imports expensive.

"The depreciation of the rupee has multiple impacts on the economy. Given we have a negative trade balance, though a depreciation of the rupee makes our exports more competitive, our import bills go up significantly. It has an impact on the current account deficit thus further putting pressure on the rupee as well as imports inflation too as the price of imports in rupee terms is higher," said Ranen Banerjee, Leader, Economic Advisory Services, PwC India.

# Sequoia and Tiger Global top startup funding in Q2

New Delhi, July 17: Venture capital firms Sequoia Capital and Tiger Global led funding in Indian startups during April-June, with the fintech sector attracting most of the \$6 billion (about Rs 47,870 crore) investments made during the quarter, industry body Nasscom said in a report.

"Prominent investors Sequoia Capital, Tiger Global, Alpha wave and Accel have done over 6 deals across sectors," it added.

Out of Tiger Global's total investments, 40 per cent were in the



fintech sector and 20 per cent in the enterprise technology domain. For Sequoia, enterprise technology accounted for about 25 per cent of the funding, and financial technology (fintech) 20 per cent.

Around 60 per cent of the investments by Tiger Global and Sequoia were made in the growth stage of the startups.

# Without HI polls, Odisha may lose hockey WC: FIH

Lausanne, July 17: The International Hockey Federation (FIH) will write to the Committee of Administrators (CoA) governing Hockey India (HI), asking it to conduct elections and avoid 'jeopardising' the men's World Cup (WC) to be held in Odisha in January.

'FIH will send an official communication to the CoA of Hockey India with a request to have the elections for India's hockey governing body held as soon as possible, in order not to jeopardise the upcoming FIH Hockey Men's World Cup scheduled in Bhubaneswar and Rourkela in January 2023," the FIH said in a statement.

The world governing body's next meeting of the executive board will be held November 3 ahead of the FIH Congress that will be held virtually November 4-5, 2022. Hockey India's situation is expected to be reviewed again in FIH's next executive board meeting.

# Poor display by Sreeshankar in **Athletics Worlds**

Eugene (USA), July 17: Long jumper Murali Sreeshankar failed to live up to the expectations as he finished seventh in the finals with his best effort of 7.96m on day two of the World Athletics Championships here Sunday. Having become the first Indian male athlete to qualify for the long jump finals in the Athletics Worlds, the Indian had raised hopes of a historic medal in the showpiece. But his performance in the final was way below his season's and personal best of 8.36m.

Sreeshankar had had three legal jumps-the opening jump of 7.96m, fourth round effort of 7.89m and last attempt of 7.83m. The other three tries were fouls. The 23-year-old must be disappointed as he could not cross the 8 metre mark in six attempts. He has been a consistent performer this season having jumped 8.17m, 8.36m, 8.31m and 8.23m since March and going into the World Championships. He had qualified for the finals with a best jump of 8m in the qualification round Saturday, finishing second in Group B and seventh overall.

China's Jianan Wang won the gold with a sensational final round jump of 8.36m while Olympic champion Miltiadis Tentoglou of Greece, won the silver.

# Srikanth replaces Jaffer

Bhubaneswar, July 17: Former India batter Wasim Jaffer who had been appointed as the head coach of the Odisha senior cricket team has stepped down from his position. The Odisha Cricket Association (OCA) has said that Jaffer will be replaced by former state player R Srikanth as the head coach of team for now. Srikanth till now had been functioning as the technical director of the Odisha Cricket Academy.

Jaffer had been appointed on a two-year contract. However, he resigned from his position as he accepted an offer from the Bangladesh Cricket Board to become the chief coach of their under-19 cricket team. After several round of discussions, the OCA finally accepted his resignation, informed secretary Sanjay Behera in a release.

Srikanth at present has been appointed head coach just for the 2022-23 domestic season. He was earlier grooming aspiring Level-1 and Level-2 coaches in the state for the NCA programmes and has a successful coaching background from past 20 years at different levels.

It remains to be seen what Srikanth can do with the senior team keeping in mind their past performances. Last season, Odisha failed to qualify for the knockouts in the Ranji Trophy and did not fare well in other tournaments at well.

However, just a change in the



coaching staff will not help Odisha unless the players deliver. In the last few seasons (no cricket was played during the pandemic), Odisha cricketers have failed to perform on a consistent basis.

In the 2021-22 season only opener Shantanu Mishra was able to score a century while Rajesh Dhupar and Abhishek Raut were the two other batters to register 50-plus knocks. Dhupar did it on three occasions while Abhishek scored a half century once. Among thebowlers, none were exceptional.
