The sleuths during the course of search found Pani and his family possessing seven plots in prime areas of Bhubaneswar worth approx ₹1.87 crore as per Registered Sale Deeds, a three-storeyed residential building including garage and singlestoreyed building worth ₹59 lakh located at Chakeisihani here, three triple-storeyed buildings worth ₹68.46 lakh located at Chorda Chowk at Jajpur Road of Jajpur district, a farm house with outhouse valued at ₹38 lakh at Andharua on the outskirts of City, deposits worth ₹53.68 lakh in various bank accounts and insurance policies, six costly four wheeler vehicles worth ₹60 lakh, gold iewellery weighing 839 grams worth ₹20 lakh and cash, household articles worth ₹12.30 lakh.

The Vigilance team suspected deliberate undervaluation of the\_ seven plots by Pani during registration to conceal the actual value, which may be several times more than shown in the documents.

Besides Shah and Patnaik, Union Education Minister Dharmendra Pradhan attended the 75th anniversary of 'Prajatantra', a leading Odia daily, at JN indoor stadium where an equal number of seats were allocated to supporters

and leaders of the two parties. As the programme was about to begin, slogans like "Amit Shah Zindabad" and "Naveen Patnaik Zindabad" rent the air in the stadium. There was a poster war between the two parties ahead of Shah's arrival in the state.

The supporters of the two parties stopped shouting slogans only after Pradhan made an appeal to the audience to calm down.

### CHSE Plus II Arts results out

Pass percentage dips; no school logs nil result

Bhubaneswar, August 8: The Council of Higher Secondary Education (CHSE) Monday declared the much awaited Plus II Arts stream results. The results were announced at the CHSE office in City.

This year's pass percentage in Plus II Arts stream is 82.10 per cent. Last year the pass percentage was 89.49 per cent.

The boys' pass percentage is 75.08 while girls' pass percentage is 87.45. In total 1,71,288 students passed the exam out of 2,08,631 who appeared, CHSE chairperson Ashwini Mishra said.

A total of 62,734 students have passed the Plus II Arts exam this year in the first division, 41,193 students in the second division, and 67.341 in the third division. 177 students got 90 per cent and above. 177 students cleared the exam with more than 90 per cent marks. Khurda district logged the highest pass percentage with 87.80 while Nabarangpur

recorded the lowest with 64.67 per cent. ► Continued on P4

Bhubaneswar, August 8: Lowlying areas were inundated with rivers flowing in spate as torrential rain pummeled southern Odisha Monday due to a low-pressure area, which is set to concentrate into a depression.

The well-marked weather system lies over the northwest Bay of Bengal off the coasts of Odisha and northern Andhra Pradesh, the Met office said.

#### **DEPRESSION BREWS IN BOB**



It is expected to intensify into a depression during the next 24 hours and move northwestwards across Odisha and Chhattisgarh, the Bhubaneswar Meteorological Centre said.

The districts of Nabarangpur, Koraput, Kalahandi and Malkangiri, Ganjam, Gajapati and Kandhamal bore the brunt of heavy

to very heavy rain under the influence of a low pressure and an active monsoon trough, which is passing over southern Odisha.

Dabugaon in Nabarangpur recorded extremely heavy rain of 225 mm over a 24 hour-period till 8.30am, followed by 194 mm in Kotpad town of Koraput.



The McAfee Cyberbullying Report showed that 42 per cent of Indian children have been the target of racist cyberbullying, strikingly 14 per cent higher than the rest of the world at 28 per cent.

Extreme forms of cyberbullying besides racism include trolling (36 per cent), personal attacks (29 per cent), sexual harassment (30 per cent), threat of personal harm (28 per cent) and doxing (publishing private information without consent 23 per cent); all of these are at almost double the global average.



Young girls in India also saw some of the highest rates of sexual harrasment internationally, with girls 10 to 14 at 32 per cent and girls 15 to 16 at 34 per cent.

personal harm, with girls 10 to 14 at

32 per cent and girls 15 to 16 at 34 per

cent. However, this figure dropped

significantly at ages 17 to 18, down to 21 per cent.

Indian children reported cyberbullying up to 1.5 times more than children in other countries across fourteen surveyed platforms, ranging from Facebook and Instagram to Snapchat and WhatsApp.

India also reported prominent acts of cyberbullying such as spreading false rumours at 39 per cent, being excluded from groups and conversations at 35 per cent and name calling at 34 per cent.

About 45 per cent of Indian children said they hide their cyberbullying experiences from parents, perhaps due to the relative absence of conversation.

"Cyberbullying in India reaches alarming highs as more than one in three kids face cyber racism,

sexual harassment, and threats of physical harm as early as at the age of 10 -- making India the number one nation for reported cyberbullying in the world," said Gagan Singh, Chief Product Officer, McAfee, in a statement.

"Parents are displaying important gaps of knowledge around cyberbullying but even more concerning, children aren't considering behaviours like jokes and name-

calling harmful online," he added. The report is based on a 10-country survey conducted from June 15

to July 5. In total 11,687 parents and their children completed an email-survey from countries including India, the US, UK, France, Germany, Australia, Canada, Japan, Brazil and Mexico.



### KOLKATA POLICE NOTICE TO BHUBANESWAR ED OFFICIAL

Bhubaneswar/Kolkata, August 8: Kolkata Police has sent a notice to the Enforcement Directorate (ED) deputy director Subodh Kumar, currently posted in Bhubaneswar, in connection with the arrest of a Ranchi-based advocate at Kolkata with huge cash last week.

Officials of Detective Department (DD) of Kolkata Police nabbed Ranchi-based advocate Rajiv Kumar with cash worth ₹60 lakh from a shopping mall in central Kolkata August 1. The money seized from him was an advance of an extortion amount from a Kolkata-based businessman, who paid the cash to Kumar for getting his name withdrawn from a PIL filed by the latter at Ranchi High Court.

# CS FOR 300 CHECK DAMS THIS FISCAL

Bhubaneswar, August 8: Chief Secretary Suresh Chandra Mahapatra has directed the Works and Rural Development departments to complete at least 300 bridgecum-check dams during the current financial year.

The state government would spend ₹413.81 crore towards construction of these bridge-cum-check dams, the Chief Secretary said while chairing a high-level meeting here recently.

It is part of the government's plan in May to construct 1,000 such wire structures across the state in three vears amid criticism for allegedly not creating more facilities for water storage in the

According to Mahapatra, the state government has constructed 45 bridge-cumcheck dams in the last two months. Of these, 31 were



completed by Works department and the remaining 14 by Rural Development (RD) department.

While raising surface water level in the riverbeds, bridgecum-check dams will significantly help in groundwater recharge and rejuvenation of ecosystem, he said.

"It's a cost-effective techology having multiple microlevel outcomes. The water conserved through this method could be used for irrigation on both sides of the river. The water could also

### Special drive against helmetless riding

Bhubaneswar, August 8: In a move to promote safety, starting August 16, the State Transport Authority will launch two-week long special drive against helmetless riders on the National Highways (NH) and State Highways (SH) across the state. Helmetless driving is widespread in the state especially on highways despite it being a major cause of injuries and fatalities.

As many as 1308 persons, including 868 riders and 440 pillionriders of motorised two-wheelers, were killed in road accidents in the year 2021. Most of them were not wearing helmets. A total of

1280 persons were grievously in-

jured and 747 had sustained minor injuries in accidents involving two

In a press note, Sanjay Biswal, Joint Commissioner Transport, Road Safety said, "It has been observed that out of the accidents taking place on NH/SH many are

related to two-wheeler riders. Due

to continuous enforcement activities people are using helmets in the urban areas but are unfortunately avoiding wearing helmets on highways where protection is much more needed.

 $He\,further\,added, ``Even\,though$ it is mandatory, helmets are rarely worn by the pillion riders despite similar risk of accidents like the driver. If riders take care of own safety by wearing helmets, they should not risk that of the pillion. Biswal appealed the two-wheeler riders and pillions to follow the traffic rules and wear helmets for their

ment officers had imposed penalties on 10,661 two-wheeler riders and suspended 2505 driving licenses. In a special drive conducted on July 30, 1469 riders were issued challan for helmetless driving and as many as 117 vehicles were seized.

During this special drive, triple riders and juveniles driving twowheelers will also be penalised. The special drive will continue till August 30. According to the Motor Vehicles Amendment Act 2019, riding without helmet attracts a penalty of ₹1,000. If a person riding pillion is not wearing helmet, then the driving licence of the rider will be suspended for three months and a fine of ₹1,000 will be imposed against him or her.

## Illegal Bangla migrants a huge threat to Odisha's security



Kendrapara, August 8: Odisha's Minister of State for Labour and Employees' Insurance, Srikant Sahu recently informed the assembly that only 23 non-Odia labourers are working in Kendrapara district. In reality however, the picture is quite different.

Sources informed that a huge number of labourers, mostly illegal Bangladeshi immigrants, are working in Kendrapara district. Such are their numbers that they wield considerable influence, more than the locals do. It is these Bangladeshi immigrant labourers who are calling the shots in Kendrapara district. They are mostly being employed by 29,249 licensed

labour contractors in the district. This development has taken place due to illegal the infiltration by Bangladeshis into Kendrapara district through both land and sea. It still continues as the district administration has not taken any concrete steps to prevent infiltration. All attempts to check infiltration have fallen flat due to manpower and infrastructure shortage plaguing the three marine police stations, Forest department and coast guards in the district.

Reports said that over 20,000 people from outside have settled down in Kendrapara district. However, local police stations have no clue about them and their whereabouts.

Social activist Sunil Kumar Gantavat of Mahakalapara, Pratap Chandra Padhi and Kalpataru Samantray of Pattamundai, Susant Nayak and Chittaranjan Sahu of Kendrapara said that three marine police stations at Jambu, Talachua and Tantiapal were set up along the 48-km coastline of the district. It was done to prevent infiltration and ensure proper law and order in the areas under their jurisdiction. However, these police stations have failed to achieve the purpose for which they were established.

These police stations have been established in Bengali-speaking areas but the infiltration by Bangladeshis continues unabated  $\boldsymbol{much}$  to the disappointment of the locals. The three police stations are reeling under shortage of manpower and infrastructure and are struggling for survival.

Among them, the Jambu police station is situated approximately five kilometres from the jetty. However, such is the location of the police station that it becomes almost impossible to reach it on a two-wheeler during monsoons. The police station also lacks speed boats and trained staff to patrol the sea.

As per rules, each police station should have staff strength of 81 personnel. However, the total staff strength of the three police stations currently stands at 42.

Sources informed that there is no proper verification of boats arriving and leaving the jetty. Former District Collector Reghu Jee had put in place a verification method, but it is yet to be implemented.

As a result, the porous coastline, with no security system in place makes it very easy for the illegal immigrants to enter Kendrapara district in the darkness of the night. They not only become a serious threat to the security of the district but to Odisha and India also.

Similarly, people peddling various illicit products have made the district their second home by renting places. They along with the illegal immigrants indulge in various acts of crime including human trafficking and selling of drugs.

Sources said that criminal activities in the district have increased manifold in the last decade. The house owners give out their places for rent without verifying the antecedents of the takers. So locals have urged the police to carry out screening to identify the outsiders living in the district.

When contacted, SDPO Rajiv Lochan Panda admitted to shortage of manpower and infrastructure in the marine police stations. He said the number of marine police stations will be increased this year while efforts are being made to fill up the vacant posts and ensure supply of speed boats.

### Sand mining rampant, says NGT report

Baripada, August 8: A National Green Tribunal (NGT) appointed joint committee has recommended for collection of penalty of ₹12.35 crore towards compensation damages to environment while submitting a report on illegal sand mining at Mahupura ghat under Badasahi tehsil of Mayurbhanj district, a report said.

The committee comprising the district collector of Mayurbhanj, members of the State Environment Impact Assessment Committee (SEIAA), district Mines department, State Pollution Control Board (SPCB) and Badasahi tehsildar, conducted a probe into the illegal sand mining activities from the river ghat, May 9, 2022

The committee has exposed large scale irregularities in sand mining

in its report. The report said the river has changed its course due to excessive sand mining. It added that sand has been illegally mined

even beyond the lease area. The NGT had directed for a probe while hearing on a petition filed by Radhamohan Singh and it scheduled the next date of hearing for August 25. According to case diary, Singh in his petition had alleged that sand has been mined from Mahupura river ghat 20 times more than the prescribed limits with the help of heavy earth moving equipment. The Union government had granted March 31, 2021 environmental clearance for mining of 2,400 cubic metre of sand annually from the

The permission was to mine sand manually by engaging labourers. However, heavy machinery were used to lift sands more than the prescribed limits, the petitioner stated in his petition. The NGT admitted the case for hearing and directed to conduct a probe and verify the charges by forming a joint committee.

### Poultry farmers want proper marketing facilities

Baripada, August 8: Poultry farmers in the tribal-dominated Mayurbhanj district are reportedly in distress at present as they are unable to get fair price of their products due to lack of adequate marketing facilities.

The poultry farmers are now producing 1.5 lakh eggs per day. However, the price at which they sell the eggs to local traders has gone down to ₹4.37 per piece. This has pushed the farmers into distress with many of them planning to down the shutters.

Reports said that over 1 lakh eggs are produced from the farms at Jhinkapahadi in Duarsuni, Chhanchabani in Karaniia and at the Nalagaja farm in Rasagobindpur. Similarly, 20,000 eggs are produced from the poultry farms of 18 persons, 1,500 from 619 women farmers amd 2,500 from 1,000 Khadia, Mankidia and other tribal families in the district.

Lack of adequate marketing facilities has taken a heavy toll on the business, poultry farmers Pruthviraj Mohanta of Jashipur, Ghanashyam Hembram of Raruan and Tarilokyanath Giri of Bishoi

Animal Healthcare Day-2022. Recently, the district Collector has sanctioned funds to be disbursed to poultry and other farmers in the district.

The district administration will give away ₹1.8 lakh each to 270 poultry farmers in all 26 blocks whose farms have the capacity for rearing of 500 broiler birds. Similarly, ₹59, 210 will be given to 26 farmers for farming of layer hens while three farmers will be given ₹1.12 lakh each for manufacturing of poultry feeds.

### Wheat & War

he good news for countries facing food shortages and starvation, especially in Africa, Middle East and Asia, is that shipment of wheat from Ukraine has started after UN and Turkey brokered a deal between Russia and Ukraine. The first such ship to sail out of the Ukrainian port of Odessa is carrying over 2600 tonnes of wheat, while more than 20 million tonnes are locked up in the country, the fourth-largest wheat exporter in the world. Fears are still haunting the suppliers as Russian missiles had hit the Odessa port soon after the deal was struck. Though Russia has not violated the terms of the export agreement by striking the port, it seems to have sent the message that it may scupper the deal if it wishes so. If the deal brought calm to the trading markets, the missile strikes by Russia have caused some misgivings and added a new dimension to the efforts to tackle the global food crisis, rising above the thoughtless calculations of war.

Russian President Vladimir Putin probably wants to remind the world that while he is not short on goodwill gestures, he intends to remain in control. He has his own interest too, which is to loosen the Western stranglehold on his own exports. He may also be seeking to impress African and Asian countries that are still shying away from tilting towards the West, that Russia is not the troublemaker in the supply of provision to them. All the same, the UN's immediate condemnation of the Russian missile launches clearly shows Putin will not find it easy to determine the trajectory of food supplies as he pleases without endangering the agreement.

Kyiv and Moscow signed the agreement to allow the reopening of Ukrainian ports to resume wheat exports as the war enters its sixth month. Since the war broke out, Russia began a blockade preventing the shipment of Ukrainian wheat to different countries depending on it for their bread. The land routes Ukraine has been forced to take to export the essential commodity by trucks - through Poland, Lithuania and Romania - are woefully inadequate to mitigate the food crisis. The main objective of the deal is to prevent a grain shortage in the world market that would threaten several developing countries with famine.

The other provisions of the agreement are creation of secure shipping lanes in the Black Sea in order to transport grain stored mainly in Odessa, Chornomorsk and Yuzhne to Africa and Asia. Kyiv wants to protect its merchant ships from Russian attacks, while Moscow wants to ensure that ships entering Ukrainian ports do not carry weapons. The challenge is how to effectively fulfill the two conditions.

Ukraine and Russia together account for a third of world wheat trade. Wheat stocks from the 2021 harvest are estimated at between 6 and 6.5 million tonnes in Ukraine and double that in Russia. Ukrainian President Volodymyr Zelenskyy has said the stocks may rise to 75 million tonnes after this year's harvest, even though, due to the war, about 30 per cent of the 86 million tonnes of grain Ukraine normally produces will not be harvested, according to food security specialists. It normally produces 42 per cent of the world's sunflower oil and 16 per cent of its maize.

It reflects poorly on top leaders of the world that they either kept mum or were not fully aware of the impact the war between Russia and Ukraine would have on people across the continents. The West was smug in its confidence that sanctions against Russia would bring Putin to his knees. Western leaders had probably underestimated the price Putin would make the world pay. The Russian blockade of Ukrainian ports have greatly triggered the prospect of starvation, shortage of fuel and essential items of consumption which, in turn, have created soaring inflation globally. This has helped Putin successfully change the rules of this war game.

#### ■ Wassail

In Saxon times you would have used the original form of this word, was hail, to greet or say goodbye to somebody; it literally meant "be in good health". By the twelfth century, it had become the salutation you offered as a toast, to which the standard reply was drinc hail, "drink good health". Hail is an older form of hale, healthy, which is now mainly confined to the set phrase hale and hearty and is also closely connected with hail meaning "to salute, greet, welcome". The toast seems to have come over with the Danes; by the twelfth century the Norman conquerors of Britain regarded was hail as one of the most characteristic sayings of the country. Later on, the word came to be used also for the drink in which the toast was offered, especially the spiced ale or mulled wine that was drunk on Christmas Eve or Twelfth Night. In the western counties of Britain, the tradition grew up on Twelfth Night of toasting the good health of the apple trees that would bear the crop from which next year's cider would be made. Pieces of bread soaked in cider might be placed in the crooks of trees, guns were fired to ward off evil spirits, and special songs were sung: Let every man take off his hat; And shout out to th'old apple tree; Old apple tree we wassail thee: And hoping thou will bear. Ceremonies like these have almost entirely died out, though one or two are self-consciously kept

#### Watershed

This first turns up in English near the beginning of the nineteenth century. It was then purely a scientific term for an imaginary line that separates two river systems. Think of it as the ridge of a roof: which river system rainwater flows into is determined by the side of the line the rain is deposited on. This is the same idea as the German Wasserscheide from which English borrowed the word (what linguists call a calque or loan translation). In English, the noun shed is the English equivalent of the German scheide, both of which have come down to us from the same Old German root. The English noun derives from the verb to shed. It's an old word for a division, split or separation - a shed could be a hair parting, for example, and could also be used for a ridge of land separating two areas of lower country. a divide. (These days a shed is usually a simple building for shelter or storage; this is an altered form of shade, and so has no link to this other sense of the word.) In North America, the word watershed often means not the dividing line, but the river catchment areas on either side of the ridge, the whole land area that drains into a particular river. How the sense shifted isn't clear. It came into use only around the 1870s, and may have been a misunderstanding. The difference in sense explains why Americans don't use the figurative sense of the word as much as the rest of us do. That refers to an important point of division or transition, as in this sentence from the Daily Telegraph in June 1999: "The Balkans conflict is at a watershed between a diplomatic settlement and the prospect of a ground war." This figurative usage only makes sense if you use watershed in its original meaning of a dividing line.

ndia has been managing the world's largest and longest running free food programme since April 2020. This is called the Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY). It ensures that more than 80 crore Indians get a ration of five kilos of either rice or wheat per person per month, completely free. This is a transformed version of the National Food Security Act (NFSA) passed in 2013, which guaranteed to three fourth of rural India and half of urban India, rice, wheat or coarse cereal at 3, 2 or 1 rupee a kilo respectively. PMGKAY has made the food distribution free of cost to the beneficiaries. It was launched during the pandemic and ensured that the economic and livelihood predicament did not become a food crisis. It has been extended beyond two years. The government also claims. validly, that the in-kind transfer of food has protected households from food inflation.

The critics of the NFSA back then (and there were many) had mainly focused on its huge fiscal burden. But NFSA was passed in Parliament after more than a decade-long movement called the right to food campaign. In the early days of the campaign there was a PIL in the apex court asking for its intervention to reduce hunger and malnutrition. It was especially shocking because hunger coexisted along with mountains of food grain stocks in government granaries. There was no question of not affording a programme to ensure nearly universal ration of subsidised food grain. The other objection to NFSA came from a cabinet minister himself, who famously quipped, that since it cost ₹18 to produce a kilo of rice and only ₹3 to buy it at ration shops, why would any farmer have the incentive to produce rice? It was a clever guip and pointed out the incentive effect of freebies.

But this lack-of-incentive argument fails, since the government has a large procurement programme which provides supply side incentives, and the food subsidy is the difference between cost of procurement and revenue from selling at low prices. The right to food along with the right to em-

ployment (MNREGA) and right to education was a new paradigm of rights-based development that the government initiated in the first decade of this century. This new rights-based approach of course does have a fiscal cost, but that cost is inevitable if we as a society believe that these are basic rights and must be enforced, whatever the cost. During the pandemic not only has PMGKAY proved invaluable, but also MNREGA which acts as a proxy for unemployment insurance. The government in the last decade has extended such rights to affordable housing (Pradhan Mantri Awaas Yojana), to health insurance (Ayushman Bharat), and to toilets (Swachh Bharat). All of these programmes have elements of subsidies, and nobody can accuse these programmes of inducing a freebie culture. Indeed, in developed countries even access to electricity and the internet have been raised to the level of basic rights. In Scandinavia even convicts in prisons have the right to internet access. But here sometimes the debate over subsidies, incentives, much needed support, welfare spending, basic rights and election campaign promises often gets mixed up in the slamming of "freebies.

The SC last week suggested setting up a specialised body to debate the issue of doing away with "irrational freebies" offered to voters during elections. Suggestions by the court follow a PIL that has been supported by the government. The PIL wants political parties to be stopped from offering "irrational freebies" and making populist promises that sways voters from making informed decisions.

It is not the first time that the courts have been approached to do something about the "freebie" culture. In 2006 the Madras High Court admitted a petition against the practice of offering free mixers, grinders and whatnot during election campaigns. The case was eventually resolved by the apex court, asking the Election Commission to include some provision for this in the model code of conduct. Then came the Amma Canteens (almost free, highly subsidised cooked food) of Tamil Nadu. Such subsidised canteens for the working urban poor have been

emulated by other states as well. The most discussed issue has been that of free power to farmers. This is a practice which has spread far beyond Punjab where it originated many years ago. It has led to many ill effects such as reckless proliferation of irrigation pumps, tube wells and an alarming lowering of water table. Not to speak of motors which get burnt often, leading to a thriving business of motor winding repair! Similarly, massive subsidies on urea lead to overuse, and increased salinity of the soil making the land fallow. High chemical fertiliser usage has also been linked to the increased incidence of cancer. But how many of these ill effects can be linked to the so-called freebie culture? And is this connection not for elected politicians to explain to their electorate? If the electorate expects parties to deliver on these promises, how can courts intervene? And why should they?

The case of free electricity is worth examining. Technology like metering and remote measurement makes it possible to assure a limited quantity of free power, beyond which commercial rates can apply or the user faces a termination of the connection. Most poor households will not cross the minimum threshold, since they don't own devices that consume massive amounts of electricity Besides more than half the losses of all electricity distribution companies are on account of unpaid subsidies from state governments. The total cumulative losses of all discoms are only 10% of bad loans written off by public sector banks in the past five years. Surely those losses of banks are an egregious waste of taxpayer and voters money. Hence the fiscal argument against so-called freebies does not stand, since much bigger fiscal giveaways exist as loan write-offs or in non-merit subsidies.

The budget itself discloses revenues foregone in terms of tax exemptions, which used to be bigger than even the biggest item, i.e., the annual interest burden of the government. As India's development path is more along the welfarist model of a mixed economy, the expenditure on various modes of welfare, many of which are simply ensuring basic rights to things like food, school lunches, healthcare, primary education, piped drinking water, is fully justified. It is for lawmakers to find the appropriate source of untapped funds, the right mix of direct and indirect taxes to address the needs of welfare spending and to reduce inequality. Promises of welfare spending should not be equated to a reckless freebie culture or a race to the bottom. This is really an issue between lawmakers, the political executive and the people and not a matter of concern for the judiciary. It must be understood that welfare spending is essential to partly redress the widening inequality in Indian society.

## Human rights without handicaps

was built from the rubble of World War II, it would have been inconceivable for someone like me – a young, Black, gay wheelchair user - to be considered for a top job in the organisation. So, it is a stunning testament to the distance humanity has come since 1945 that I will be among candidates UN will consider to succeed Michelle Bachelet when she leaves her post next month as UN High Commissioner for Human Rights.

If selected, I would be the highest-ranking international civil servant with a disability since the UN was founded. This would be a historic victory for the 1.3 billion disabled people who, according to the UN, comprise the world's largest minority group. The UN Convention on the Rights of Persons with Disabilities, signed in 2007, has helped to advance inclusion across the board. But to see someone in a wheelchair in a position of power is still highly unusual. In many parts of the world today, the face of ostracisation is still that of a brown-skinned disabled kid. I could easily have heen that kid. But you could say my experience as a human-rights advocate began at the age of six,

Then the United Nations when – with tears streaming down boundaries of possibility, not just emerging economic crisis, and a my face - I told my mother, "I want to go to school.

Life for a kid in a wheelchair in Namibia, where I spent the first nine years of my life, is often extremely limited - as it is in much of the developing world. According to the UN, 90-98% of kids with disabilities in the Global South do not have the opportunity to go to school at all. At the time, indeed, I was beating the odds just to be alive. As a two-year-old, I was diagnosed with spinal muscular atrophy, a deadly degenerative disease that attacks the nervous system. Doctors told my mother I would most likely not live to see my fifth birthday. I am now 31.

My mother, who wiped the tears from my eyes, was determined. She found a school willing to take me. On my first day, I was placed at the very back of the classroom. It was clear little was expected of me. I stunned the teacher by writing my own name - something most of the other kids could not do. A smile spread across her face. She saw that I could learn just like, or maybe sometimes faster, than the others.

That experience taught me to reach high, no matter the obstacles in my path. My candidacy to succeed Bachelet seeks to push the for people with disabilities but for anyone who has ever felt devalued. underestimated, and marginalised.

If selected, I would be the youngest leader at the main leadership level. The UN often emphasises the importance of engaging young people, given our stake in the future. And yet we are an unrepresented demographic at the institution. Selecting a young leader for this position would give fresh impetus and authority to the work of the UN High Commissioner.

Attainment of human rights for all very often feels like an impossible pursuit, especially now, when everything feels impossible. But, as Nelson Mandela pointed out, it always seems impossible until it is done.

At a time when the world is increasingly fractured and it feels as though we have simply stopped listening to one another, I think the office of UN High Commissioner for Human Rights is uniquely qualified to address the most pressing challenges of our day. For the first time since 2001, a majority of the world's population lives under non-democratic, rights-violating governments. We face heightened nationalism, an

global pandemic - a health crisis that too many governments have met by claiming emergency powers and adopting restrictions that often violate rights. As UN Secretary-General António Guterres has said, human rights underpin "the entire UN system. [They] are essential to addressing the broad causes and impacts of all complex crises, and to building sustainable, safe, and peaceful societies.'

Should the Secretary-General select me for this role, my job will be to identify and expose rights violations tirelessly, no matter what powerful interests stand in the way, and to engage with civil-society advocates to make the UN's work more participatory and more relevant to driving change. I am, admittedly, an outside-the-box candidate for this post - an impossible choice, some might say. But I believe, in these times especially that fresh thinking, new energy, and an ability to see how to overcome seemingly impossible barriers is exactly what the world needs.

New Delhi, August 8: The Monsoon session of Parliament ended Monday, four days ahead of schedule, after continued disruptions during the last three weeks over issues like price rise, suspension of 27 MPs, the controversial "Rashtrapatni" remark and the Enforcement Directorate's action.

Lok Sabha and Rajya Sabha, which were adjourned sine die this afternoon, saw the passage of seven and five bills, respectively, during the session which was to end on August 12. While Lok Sabha saw a total of 16 sittings that lasted for 44 hours and 29 minutes, the upper house met for 38 hours with as many as 47 hours lost due to disruptions, an issue flagged by outgoing Chairman Venkaiah Naidu who has frequently expressed unhappiness over the stalling of proceedings.

Rajya Sabha also bid farewell to Vice President Naidu, whose tenure ends on August 10. During the next session, Rajya Sabha promembers in the House increased during his tenure. The prime minister said a record 177 bills were passed or discussed during these

In his remarks, Naidu said people expect Parliament "to discuss, debate and not disrupt" and appealed to members to maintain 'decency, dignity and decorum" so that the image and respect of the house are maintained

While adjourning the House also, he lamented that over 47 hours were lost due to disruptions in the upper house that prevented members from raising issues of public importance. Brushing aside speculation, Naidu said, "People now often talk -- either president, otherwise dissident or a resident. I am not going to all these three."

Before adjourning Rajya Sabha, which he presided over for the last time, Naidu said the house had 16 sittings during which it conducted business for more than 38 hours. Five government bills were discussed and passed. "However, more than 47 hours were lost due to interruptions which is a sad reflection of the functioning of the upper house of Parliament," Naidu said.

Menda Hima Vamsi, Koyyana Suhas, Palli Jalajakshi, Penikalapati Ravi Kishore and Polisetty Karthikeya are the top scorers from Andhra Pradesh. #### 3 killed, 4 injured in Rajasthan stampede

Sikar (Rajasthan), August 8: Three women were killed in a stampede outside the district's Khatu Shyamji temple when people waiting in queues tried to rush in as its doors opened in the early hours of Monday.

Four others were injured in the incident on a day when tens of thousands of people from Rajasthan and neighbouring states were headed to the famous temple to mark "Gyaras" or "Ekadashi". Sikar Collector Avichal Chaturvedi said close to one lakh people were outside the main gate, queuing up after the doors closed the previous night.

The stamped took place a little before 4.30 a.M. There was rush to enter and a woman fell, triggering the brief stampede that also killed two others, according to officials."Prima facie, they died of suffocation but the exact cause of death will be clear after postmortem," Chaturvedi told reporters.

'The incident is unfortunate. The women fell due to the pressure of the crowd in their line. The lines for the entry to the temple start at different points and converge at the entry point," he

Superintendent of Police K Rashtradeep said a 63-year-old woman who suffered from a heart ailment collapsed. "Two women behind her too fell due to the rush."

Victim Shanti Devi's brother Mangat Ram was among those in the queue."The stampede took place as soon as the temple opened for prayers. Somehow, we managed to escape. My sister was old, she got stuck and died. Others from my family suffered injuries," he said.


New Delhi, August 8: Rajya Sabha MP and senior advocate Kapil Sibal's "no hope left" from the Supreme Court remark stoked a controversy Monday, with the All India Bar Association terming it "contemptuous" and Law Minister Kiran Rijiju saying it was "very sad for the entire country" that opposition leaders start attacking constitutional bodies after verdicts do not favour them.

Also on Monday, two lawyers filed separate pleas with Attorney General KK Venugopal, seeking his consent to initiate contempt proceedings against Sibal while BJP IT chief Amit Malviva asked the top court if it will invoke contempt against the former Congress leader for questioning the powers of the Chief Justice of India and other decisions of the SC.

"It is a misconception that you get solutions in the Supreme Court," he said and alleged that "sensitive" cases are now invariably assigned to a few select judges in the Supreme Court, and the legal fraternity usually knows what the judgment

## Illegal structures at Tyagi's house razed

### SC notice to Centre on plea for law to control population

New Delhi, August 8: The Supreme Court Monday issued notice to the Centre on a plea seeking a central law to control the "population explosion" in the country.

Seeking the government's response, a bench of Justices S. Abdul Nazeer and J.K. Maheshwari tagged the petition with a similar plea filed by BJP leader and advocate

Ashwini Upadhyay. The Public Interest Litigation (PIL), filed through advocate Ashutosh Dubey, sought direction from the Centre to control the population explosion in order to se-

Chennai, August 8: The Tamil Nadu Police's Idol Wing has traced an idol of Goddess Parvati that was stolen from a temple in the state in 1971 to the Bonhams auction house in New York, officials said Monday.

According to the police, the Parvati idol was part of five idols that were burgled from the Nadanapureshwarar temple at Kumbakonam on May 12, 1971. Police have now commenced the process to retrieve the idol and bring it back to India under the UNESCO's World Heritage Convention 1972.

DGP, CID-Idol Wing Jayanth Murali, said: "We sought the help of an archaeologist who said that the photograph of the idol of Parvati that was kept at the French Institute of Pondicherry and the idol of Parvati on sale at Bonham's auction house is the same. This means that the idol of Parvati at Bonhams belongs to the



Nadanapureshwarar temple at Kumbakonam.

Following the complaint after they were stolen in 1971, temple trustee K. Vasu, in 2019, lodged another complaint and said that he had seen the idols in 1971 when they were in public worship, and after that, he had not seen them. In the complaint, Vasu said that he had seen the locks of the temple broken while reaching there for worship and then two trustees of the temple had complained to the Nachiarkoyil police and the inspector had visited the temple.

Vasu also said that no FIR was lodged then and hence he was filing the complaint. He filed the complaint with the Special Officer, Idol-Wing, S.G. Pon Manickavel, and a case was registered in 2019.

# Leopards a worry as Kuno set to welcome cheetahs

Bhopal, August 8: Spread over 344 sq.km, the Kuno National Park located in Sheopur and Morena districts of Gwalior-Chambal division in Madhya Pradesh, is getting ready to welcome the first batch of cheetahs from two African countries - South Africa and

The Union government signed the MoU with Namibia last month per the plan, four to eight cheetahs are likely to arrive in the first lot before August 15. However, Madhya Pradesh Wildlife was yet to receive a confirmed date from the

These African cheetahs will be brought to India under a translocation project. In India, the project is being managed by the National Tiger Conservation Authority (NTCA) under the Union Environment Ministry.

As per the wildlife officials in Madhya Pradesh, cheetahs from Namibia will be flown to South Africa and then to Delhi. After that they will be flown to Gwalior, subsequently they will be taken to Kuno National Park via road.

The official said that the animal will return to a wild enclosure in India 69 years after the last recorded cheetah was hunted down in what is now Chhattisgarh in

Meanwhile, authorities at Kuno have finalised preparations but the presence of three leopards in the enclosure of cheetahs is creating



ect say some conflict between leopards and cheetahs is inevitable, but the fenced off enclosure will give the cheetahs a level of protection during their most vulnerable time as they come to terms with their

"We were trying to shift the leopards naturally but now our priority is to shift them as soon as possible. The trap has been installed but the leopards are eluding the forest officials. Now, the forest officials will tranquilise the animals to remove them from the enclosure of 500 hectares," said JS Chauhan, principal chief conservator of forests in Madhya Pradesh.

Experts said the African cheetahs would be quarantined for at least two weeks, which is called a 'soft release.' During this period their health and activities will be closely monitored.

#### 250 chital deer herded for cheetahs to prey on

**Bhopal:** The Forest department has herded 250 chital or spotted deer as the prey into the enclosure meant for cheetahs being brought to Kuno-Palpur National Park (KNP) from Africa shortly, a senior official said Monday. "We have put more than 250 chitals (spotted deer or axis deer) in the 'soft release enclosure' meant to acclimatize the cheetahs at the KNP," MP Principal Chief Conservator of Forests (Wildlife) JS Chauhan told PTI. The chital deer have been brought from the Pench Tiger Reserve and the Wildlife Sanctuary of Narsinghgarh in MP, he said. Chauhan said 500 more chital deer will be placed in the enclosure for the cheetah to prey on. Preparations are on to provide a good environment to the cheetahs given the fact that these mammals are coming to India from far off Africa and would be stressed and fatigued after such a long journey.

In one of the videos, Sarwan mentioned the identity marks of his missing nephew, saying he had two thumbs on one hand and a prominent mole on one of his thighs. On the other hand, in the video posted by the Pakistani YouTuber similar things were shared about Mohan, said Parvinder.

Later, the Australia-based man managed to get in touch with both families on either side of

the border. The grandfather identified Mohan with his identity marks, said Parvinder.

Sarwan's family used to live in village Chak 37, now in Pakistan, and 22 members of his extended family were killed in communal violence at the time of Partition.

Sarwan and other family members managed to cross over to India but Mohan Singh, who escaped the violence, was later raised by a Muslim family in Pakistan.

Sarwan, who was living in Canada with his son, has been staving at village Sandhman near Jalandhar at his daughter's home since the COVID-19 pandemic struck.

Parvinder said his mother Rachhpal Kaur is accompanying Sarwan who will meet his nephewat Gurdwara Kartarpur Sahib in Pakistan.

### Maha cabinet expansion today

Mumbai, August 8: Maharashtra Chief Minister Eknath Shinde will expand his 40-day-old ministry August 9, a close aide of the CM said Monday.

Shinde was sworn in as the CM on June 30 along with Devendra Fadnavis, who took oath as Deputy CM. A dozen ministers will take oath at Tuesday's ceremony, scheduled at Raj Bhavan at 12 pm, a close aide of Shinde said. The next round of expansion would take place later, the aide said. "The monsoon session of the state legislature has to be held at the earliest, so we decided to induct 12 legislators in the ministry expansion. Some of those taking the oath on Tuesday would be from the Legislative Council," the aide said.

Shinde, who emerged as a surprise choice for the top post after managing to take most of Shiv Sena MLAs with him, will have a difficult task to accommodate all of them in the ministry, sources said. Shinde has made seven visits to New Delhi in the last one month. and with every visit there was talk that the ministry expansion was round the corner.

## Raut sent to 14-day judicial custody

Mumbai, August 8: A special court here Monday remanded Shiv Sena MP Sanjay Raut to 14-day judicial custody in a money laundering case linked to alleged irregularities in the redevelopment of a Mumbai 'chawl'.

The court allowed Raut's plea for home food and medicines, but refused to pass an order on his prayer for bedding. The judge said as per the prison manual, jail authorities make adequate bed arrangements.

### 73 PEOPLE DIE **DUE TO FLOOD**

Bangalore, August 8: As many as 73 people lost their lives while 7,386 people have taken shelter in 75 reief camps in Karnataka due to floods and rain-related incidents during the ongoing monsoon, state Revenue Minister R Ashoka said Monday.

Jammu/Doda, August 8: The National Investigation Agency (NIA) Monday carried out searches at multiple places in Jammu and Doda districts of Jammu and Kashmir against members of the banned Jamaat-e-Islami (JeI) in a terror-funding case, officials said.

Simultaneous raids were conducted at seven premises of JeI office-bearers and members in different parts of the two districts in the early hours of Monday, they said."NIA conducted searches at premises of six suspects in Doda and one in Jammu in the case pertaining to JeI, which even after its declaration as an unlawful association in 2019, continues to raise funds in various forms purportedly for charitable purposes," an NIA spokesperson said.

The NIA said the searches led to the recovery of incriminating literature, receipts of funds raised by JeI, bank and property-related documents, and electronic devices. Official sources said the raids were carried out at Dhara-Gundana, Munshi Mohalla, Akramband, Nagri Nai Basti, Kharoti Bhagwah, Thalela and Malothi Bhalla in Doda district and Bhatindi in Jammu.

The searches were carried out in a case related to terror funding, they said. The case, registered by NIA suo motu on February 5 last year, pertains to the activities of the Jamaate-Islami members who have been collecting funds domestically and abroad through donations, particularly in the form of 'Zakat, Mowda and Bait-ul-Mal' purportedly to further charity and other welfare activities but are using the money for "violent and secessionist" activities.

## The past has a way of returning to haunt the future

ven as the Supreme Court arbitrates on the constitutional aspects of the political imbroglio caused by the splintering of the Shiv Sena and the fall of the MVA government, the traditional Gujarat-Maharashtra rivalry is set to influence political events for quite some time to come.

The first indication that the surface calm hides inner turmoil emerged with the backlash to Maharashtra Governor Bhagat Singh Koshiyari's statement in Mumbai. He was quoted as saying that if Gujaratis and Rajasthanis are removed from the state, especially Mumbai and Thane, it would be left with no money and would cease to be the financial capital of the country. The reaction was swift with the NCP, Shiv Sena, Congress and even Chief Minister Eknath Shinde criticising it.

walked into a minefield at a time when feelings ran high amongst cadres of the NCP and the Congress and particularly Shiv Sena which rose under the leadership of Bal Thackeray riding astride 'Marathi pride'. The unseating of his son Uddhav from chief ministership has hit where it hurts most. The clarification on Saturday that the Governor had been misquoted and no hurt to Marathi pride was intended failed to assuage sentiments primarily because it has added to the perception that the move has the blessings of Prime Minister Narendra Modi and has been executed by his 'chanakya' Amit Shah. That the two hail from the neighbouring state, may be incidental but has heightened the hurt. For Uddhav Thackeray the feeling of betrayal hits harder be-

cause Bal Thackeray had sup-

The Governor had inadvertently

ported Modi rock-like when he was under a cloud in the aftermath of the 2002 communal riots, even pleading with Prime Minister Atal Bihari Vajpayee against re-



placing him.

Maharashtra and Gujarat came into being in 1960 following the bifurcation of bi-lingual Bombay state after a struggle that saw the Marathi and Gujarati speaking population at loggerheads. The transition was not smooth due to claims and counter-claims on towns and cities though these were ultimately settled but resentment lingered due to Gujarati domination of business in Maharashtra.

According to a published report this rivalry was best exemplified in the close race between the two political parties in the 2017 in the Brihanmumbai municipal corporation results. Not only is there a growing perception that Modi wants Maharashtra in his kitty whatever the cost but also that this was the reason for the earlier attempt at splitting the NCP which was thwarted by veteran Sharad Pawar.

Old political hands also believe that the move to split the Sena is a game plan to decimate it so that BJP remains the sole political heir of Hindutva. Koshiyari's controversial statement is also viewed as a part of this Modi-Shah narrative. The choice of Surat in Gujarat as the regrouping point for the Shinde led splinter group before being flown to Assam further strength-

The flight of the Shiv Sena rebels to Assam draws interesting parallels with a similar rebellion that was crafted in 1995 against the first BJP government in Gujarat headed by Keshubhai Patel. Shankersinh Vaghela, a senior BJP leader was the architect of the rebellion wherein 47 of the total 121 BJP legislators in a House of 182 had flown away to Khajuraho by a chartered flight after withdrawing support. Modi was the organization secretary of the state party and in the truce that was brokered by Atal Bihari Vajpayee, Keshubhai Patel was replaced by Suresh Mehta as Chief Minister and Modi was transferred out of Gujarat. However the truce did not last and Vaghela

came to power as chief minister heading a regional party with the support of the Congress. If Modi's boys refined the Khajuraho experience in Assam, the Thackerays too have taken a page out of Modi's strategy book to turn the tables on him at a time of his choosing.

Modi's entire chief ministerial stint in Gujarat was spent in branding UPA chairman Mrs Sonia Gandhi, the Nehru family and the Manmohan Singh-led Congress government as anti-Gujarat. His entire political plank entailed Centre-bashing and cashed-in on the injured innocence of 'gujarati asmita '(Gujarati pride). It won him good until he left in 2014 to take over as prime minister. Thackeray intends to do a Modi on BJP in Maharashtra. He is holding his fire until the apex court ruling.

#### Fragile Israel, Gaza ceasefire holding

Gaza City: A fragile cease-fire deal to end nearly three days of fighting between Israel and Palestinian militants in Gaza held into Monday morning - a sign the latest round of violence may have abated. The flare-up was the worst fighting between Israel and Gaza militant groups since Israel and Gaza's Hamas rulers fought an 11-day war last year. Over three days of fighting, 44 Palestinians were killed, including 15 children and four women, and 311 were wounded, the Palestinian Health Ministry said.

#### **Over 80K tourists** stranded in China

Beijing: The capital of China's Hainan province has locked down its residents for 13 hours Monday as a Covid-19 outbreak grows on the tropical island during the summer school holidays. Some 80,000 tourists have reportedly been stranded by the lockdown in Sanya Those wanting to depart have to test negative five times over seven days. More than 470 new cases were recorded in the province Sunday, of which 245 did not show symptoms. Overall, China reported more than 760 new daily cases, the National Health Commission said Monday.

#### TTP chief killed in Af bombing

Islamabad: The Tehreek-e-Taliban Pakistan (TTP) Monday confirmed that one of its top commander, who was behind some of deadliest attacks in recent years, was killed in a bombing in Afghanistan. Abdul Wali Mohmand, also known under the alias Omar Khalid Khorasani, was on the US State Department's wanted list and was offering a reward of up to \$3 million for information on his whereabouts, reports dpa news agency. At least two other commanders were also killed in the bombing which came exactly a week after a US drone strike in Kabul had killed Al Oaeda chief Ayman al-Zawahiri.

#### 52% fuel price hike: **Protests in B'desh**

Dhaka: A steep increase in fuel prices in Bangladesh saw protests erupting across the country. The hike, which according to Bangladeshi media is "highest ever", has increased the prices of petrol and diesel by more than 50 per cent. Bangladesh is another of India's neighbour after the island country of Sri Lanka, to have been hit by such demonstrations. Angry demonstrators surrounded fuel stations throughout Bangladesh demanding the unexpected price increase be reversed.

# China extends military drills

US House Speaker Nancy Pelosi's visit to Taiwan last week infuriated China, which regards the self-ruled island as its own and responded with test launches of ballistic missiles over Taipei for the first time, as well as ditching some lines of dialogue with Washington

Taipei, August 8: China's military announced fresh military drills Monday in the seas and airspace around Taiwan - a day after the scheduled end of its largest ever exercises to protest against last week's visit to Taipei by US House Speaker Nancy Pelosi.

China's Eastern Theatre Command said it would conduct joint drills focusing on anti-submarine and sea assault operations confirming the fears of some security analysts and diplomats that Beijing would continue to maintain pressure on Taiwan's defences.

"In the face of military intimidation created by China, Taiwan will not be afraid nor back down. and will more firmly defend its sovereignty, national security, and free and democratic way of life," the ministry said in a statement.

The duration and precise location of the latest drills is not yet known, but Taiwan has already eased flight restrictions near the six earlier Chinese exercise areas surrounding the island.

Beyond the firing of 11 shortrange ballistic missiles during the four earlier days of exercises, Chinese warships, fighter jets and drones manoeuvred extensively around the island.

Washington, August 8: After 18 months of arduous negotiations and a marathon night of debate, the US Senate on Sunday passed Joe Biden's ambitious climate, tax and health care plan - a significant victory for the president ahead of crucial midterm elections.

Voting as a unified bloc and with the tie-breaking vote cast by Vice President Kamala Harris, Democrats approved the \$430 billion spending plan, which will go to the House of Representatives next week, where it is expected to pass before being signed into law by Biden.

The plan, crafted in sensitive talks with members on the right wing of his Democratic Party, would include the biggest US investment ever on climate -- \$370 billion aimed

at effecting a 40 percent drop in greenhouse gas emissions by 2030. Biden hailed the passage of the bill, highlighting the work that went into it -- and acknowledging

that not everyone is happy with

the final result. "It required many compromises. Doing important things almost always does. The House should pass this as soon as possible and I look forward to signing it into law," the

president said in a statement.

The bill would provide ordinary Americans with a tax credit of up to \$7,500 when purchasing an electric car, plus a 30 percent discount when they install solar panels on their roofs

It would also provide millions to help protect and conserve forests - which have been increasingly ravaged in recent years by wildfires during record heat waves that scientists say are linked to global warming.

Billions of dollars in tax credits would also go to some of the country's worst-polluting industries to help their transition to greener methods - a measure bitterly opposed by some liberal Democrats who have, however, accepted this as a least-bad alternative after months of frustration

### INDO-PAK 'BACKCHANNEL' TALKS HIT A DEAD END

Islamabad, August 8: Backchannel talks between Pakistan and India have met a dead end as both sides have struggled to agree on the moves that may pave the way for slow but gradual improvement in the relationship, a media report said citing an informed source.

"Talks have been going on but have reached a point where things aren't moving anywhere," The Express Tribune report quoted the source as saying.

There has been a desire from both sides to break the impasse but the issue is how to move forward from this point onwards, the source explained. What has slowed down the process was the political uncertainty in Pakistan, The Express Tribune reported

There was a glimmer of hope for a possible thaw in the relationship following the change of government in Pakistan in April. What spurred the optimism was

that Indian Prime Minister Narendra Modi was one of the first leaders to congratulate his Pakistani counterpart Shehbaz Sharif when the latter assumed office in April. The source said backchannel contacts that began during the PTI

government's tenure picked up

pace in April after the change of government. But despite "intense" backchannel diplomacy, the two sides were not willing to concede an inch on their respective issues. Pakistan is keen that India must take steps with regards to Kashmir before any process of normalisa-

tion of ties begins. New Delhi, however, is more interested in Islamabad first exploring the option of resuming bilateral trade, The Express Tribune quoted the source as saying further.

The friction in the relationship prevented Pakistani and Indian foreign ministers from interacting with each other at the recent meeting of Shanghai Cooperation Organization in Tashkent.

demilitarised zone. The United Nations chief called for access to the plant as Kyiv and Moscow traded blame for the shelling in a southern region captured by Russian invaders in March and now targeted by Kyiv for a counteroffensive. "Any attack (on) a nuclear plant is a suicidal thing," UN



Secretary General Antonio Guterres

told a news conference Monday. Petro Kotin, head of Ukraine's state nuclear power company Energoatom, called for a team of peacekeepers to be deployed at the Zaporizhzhia site, which is still run by Ukrainian technicians.

'The decision that we demand from the world community and all our partners ... is to withdraw the invaders from the territory of the station and create a demilitarised zone on the territory of the station," Kotin said on television.

Russia's defence ministry said

that Ukrainian shelling had damaged high-voltage power lines servicing the Soviet-era plant and forced it to reduce output by two of its six reactors to "prevent disruption".

The Kremlin Monday accused Ukrainian forces of firing on the Zaporizhzhia atomic power plant, warning against potential "catastrophic consequences" for Europe.

The shelling of the territory of the nuclear plant by the Ukrainian armed forces is a potentially extremely dangerous activity... fraught with catastrophic consequences for a vast area, including the territory of Europe," Kremlin spokesman Dmitry Peskov told reporters.

He called on Ukraine's allies to use their influence to prevent the continuation of such shelling".

Zaporizhzhia – Europe's largest atomic power complex that was occupied by Russia early in its offensive -- has in recent days been the scene of military strikes that have damaged several structures, forcing the shutdown of a reactor.

### **Stop disturbing** exchange with SL, China slams India

Beijing, August 8: Riled by Sri Lanka's request to defer the planned docking of a high-tech Chinese research vessel at the strategic Hambantota Port, China Monday took a dig at India, saving it was "senseless to pressure" Colombo by citing the issue of security concerns.

According to reports from Colombo, Sri Lanka has asked Beijing to defer the arrival of the Chinese space and satellite tracking research vessel 'Yuan Wang 5' which was scheduled to dock at the Hambantota Port from August 11 to 17 due to security concerns expressed by India.

Responding to the reports, Chinese Foreign Ministry spokesman Wang Wenbin told a media briefing here that Beijing has taken note of the reports and asserted that "the cooperation between China and Sri Lanka is independently chosen by the two countries and meets common interests.

It does not target any third party". It is "senseless to pressure Sri Lanka" by citing the issue of security concerns, he said, in reference to the reports that Sri Lanka's move was attributed to concerns expressed by India. "Sri Lanka is a sovereign state. It can develop relations with other countries in the light of its own development interests," he said.

"China urges relevant parties to see scientific explorations in a reasonable way and stop disturbing the normal exchange between China and Sri Lanka," Mr Wang said.

Sri Lanka is a transport hub in the Indian Ocean. Many scientific exploration ships including those from China have stopped at the port of Sri Lanka for resupplies, he said. "China has always exercised the freedom of navigation in the high seas and fully respects the jurisdiction of coastal states for the scientific exploration activities within their waters," he said.

According to reports, India informed Sri Lanka that the docking of the high-tech Chinese research vessel could pose a threat to its national security. Sri Lanka received strong messages of protests from India as the ship was said to have the capability to track satellitesand intercontinental ballistic missiles, the reports said.

New Delhi, August 8: The longawaited high-speed 5G services are expected to be rolled out in about a month, Minister of State for Telecom Devusinh Chauhan said Monday.

Addressing the event of the International Telecommunication Union's Regional Standardisation Forum (RSF) for Asia and Oceania region, Chauhan said India is likely to deploy indigenously developed and manufactured 5G telecom gears by end of this year for 5G services. 'In about a month, 5G mobile

services will roll out in the country, which will have multiplier effects on the development of all sectors. A 6G Technology Innovations Group, has also been set up, which is working towards the development of indigenous 6G stack,' Chauhan said

He said that the government is promoting, the indigenously designed, developed and manufactured advanced telecom technology, and as a result. India today has a strong home-grown 5G mobile communications ecosystem.

Tata Passenger Electric Mobility Ltd (TPEML) will make the necessary investments to reconfigure the plant to adapt to Tata Motors existing and future vehicle platforms, the automaker said.

The agreement with FIPL signed today is beneficial to all stakeholders and reflects Tata Motors' strong aspiration to further strengthen its market position in the passenger vehicles segment and to continue to build on its leadership position in the electric vehicle segment," Tata Motors Passenger Vehicles MD Shailesh Chandra noted.

TPEML, a subsidiary of Tata Motors and Ford India Pvt Ltd (FIPL), have signed a Unit Transfer Agreement (UTA) for the acquisition of the Gujarat-based plant.

The Gujarat government, TPEML and FIPL executed a tripartite MoU May 30, 2022, to support all relevant approvals for the above transaction. ### Govt could scrap import duty to cool domestic wheat prices

Mumbai, August 8: India could scrap a 40% duty on wheat imports

and cap the amount of stocks traders can hold to try to dampen record high domestic prices in the world's second biggest producer, government and trade officials told Reuters Monday

The government barred wheat exports in May after as the crop suffered a heatwave, but domestic prices still rose to a record high. Yet, international prices are still way above the domestic market, making it unviable for traders to buy from abroad.

cally drives domestic prices higher. 'We are exploring all possible options to bring down the prices," said a senior government official

who held discussion with industry officials last week.

New Delhi could scrap the 40% import duty and impose stock limits on wholesalers and traders to signal to the market that the government will do everything in its power to keep prices in check, said the official, who declined to be named due to the sensitivity of the subject.

Domestic wheat prices ended last week at a record ₹24.000 (\$301.57) per tonne, having risen 14% from lows struck after the government surprised markets May 14 by banning exports, ending hopes that India could fill the market gap left by the missing Ukraine grain.

Domestic prices are still nearly a third lower than global prices, said a Mumbai-based trader with a global trading firm, who described Indian wheat as the cheapest in the world. India last imported wheat in the 2017/18 (April-March) financial year. "If global prices fall by another 20% and Indian prices continue their rally, then may be, sometime after few months, imports might become feasible," the trader said.

The government has limited options to intervene in the market this year since its procurement has fallen 57% to 18.8 million tonne, said a New Delhi-based dealer with a global trading firm. "New crop would become available only after 9 months. The government has to use stocksvery carefully until then to avoid any shortage," the dealer said.

Birmingham, August 8: Superstar PV Sindhu and young gun Lakshya Sen lived up to expectations by grabbing gold medals as India swept the singles badminton competition at the Commonwealth Games (CWG) for the first time here, Monday.

India's sporting icon Sindhu added a CWG gold to her already bulging collection with a convincing straight game win over Canada's Michelle Li. The World No.7 Indian outplayed her 13th ranked opponent 21-15, 21-13 in front of a packed crowd at the NEC arena.

Later in the day, 10th-ranked Sen came from behind to end Ng Tze Yong's giant-killing run in the competition. The 20-year-old defeated the world number 42 from Malaysia 19-21, 21-9, 21-16. Sen trailed for majority of the first game but stayed close to the Malaysian who had accounted for world champion Yew Kean Loh and Kidambi Srikanth in his previous two matches.

Sen made it 19-18 from 16-19 before Yong produced back-to-back forehand winners to gain a game point. Sen misjudged a baseline call after a gruelling rally to hand the advantage to Yong.

The second game was one-way traffic after Sen led 11-9 at the in-



terval. The Indian took 12 points in a row post the break to level the final. Yong made a slew of unforced errors and it seemed he wanted to preserve energy for the third game.

Sen was at his attacking best in the decider and led until the end. Yong tried his best to mount a comeback but Sen was unstoppable. He converted his first match point following a long rally, leading to a frenzied celebration that saw him throw his racket into the stands.

Earlier, the 30-year-old Michelle had to produce something special for her first win against Sindhu in eight years but the Indian did not give her a window. Sindhu was clinical in her short game and pounced on the slightest of attacking opportunities.

In the first game, Michelle was trying to get points by playing close to the net while Sindhu has the more attacking one. A smash on Li's



left made it 7-5 before the Canadian came with a drop shot on Sindhu's right to make it 7-6.

Sindhu took three straight points after the interval to stretch her lead to 14-8. Michelle then netted a regulation forehand drop, leaving her smiling in frustration.

The talented 26-year-old went wicketless and only managed two runs with the bat as Australia clinched a thrilling nine-run victory, but conjecture surrounded whether or not she should have been able to take the field at all and the toss was even delayed by more than 10 minutes as the issue was discussed.

Harmanpreet said the Indian team had been informed of McGrath's positive test prior to the toss and had no objections to allowing her to take her place in Australia's side. "They informed us before the toss," Harmanpreet said.

"That was something not in our control because the Commonwealth has to take the decision. We were OK because she (Tahlia McGrath) wasn't very ill, so we just decided to play. We had to show the sportsman's spirit. We're happy that we didn't say no to Tahlia because that (missing the final) would have been very hard-hitting for her," she said.

Isolation rules in the UK are slightly more relaxed than in other parts of the world. It meant McGrath was able to take the field for the gold medal match and Commonwealth Games Australia team released a statement to explain the decision.

McGrath took a catch to dismiss Shafali Verma early in India's run chase, but celebrations were somewhat subdued as she stayed away

While Australia opener Beth Mooney was happy that the decision was made to allow McGrath to play, she queried why the news had to be announced to all participants.

"It's a real shame that in elite sport you get publicly shamed for having Covid when over here probably 90 per cent in this room have it right now," Mooney said. "No one is testing, no one is doing anything. It's a shame she couldn't really celebrate with us.

"At the same time, I think the right decision was made in terms of letting her play given we've spoken about protocols and making sure we were trying to keep everyone safe throughout the game. Hopefully people aren't too upset by it," Mooney added.
