JUSTICE UU LALIT APPOINTED 49TH CJI

New Delhi: Justice Uday Umesh Lalit was Wednesday officially appointed as the 49th Chief Justice of India after President Droupadi Murmu signed his warrant of appointment. He will assume charge August 27 after incumbent NV Ramana demits office the day before. "In exercise of the powers conferred by clause (2) of Article 124 of the Constitution of India, the President is pleased to appoint Shri Justice Uday Umesh Lalit, judge of the Supreme Court, to be the Chief Justice of India with effect from 27 August, 2022," a Law Ministry notification said. Justice Lalit was appointed as judge of the Supreme Court in August 2014 from the Bar.

Adani to invest ₹41K cr in state

■ *Investment proposals* worth ₹74,620 crore cleared by panel headed by CM Naveen Patnaik

Bhubaneswar, August 10: The high-level clearance authority (HLCA) of the Odisha government headed by Chief Minister Naveen Patnaik approved Wednesday investment proposals worth ₹74,620.18 crore. These projects will provide employment opportunities for over 24,000 people in Odisha.

Among the projects approved is one belonging to the Adani Group. Adani Enterprises Limited will set up up a 4.0 MTPA Alumina Refinery and 175 MW CPP Plant in Kashipur of Rayagada district. The company has proposed to invest ₹41,653 crore for this project, which will generate employment opportunities for over 7,750 people.

The committee has approved the proposal of ReNew EFuels Private Limited (REFPL) to set up a green hydrogen and green ammonia plant in Paradip against an investment of ₹2,000 crore which will generate employment opportunities for 2,000 persons.

The establishment of these plants will have a pragmatic environmental impact since they will create ammonia and hydrogen using renewable resources, which will cater to the demand of the steel and fertilizer sector in Odisha, said an official.

The committee has also given approval for setting up of 60,000 MT industrial structure and 6,000 MT steel plant equipment facilities to Tata Steel Limited (growth shop) with an investment of ₹1,000 crore creating employment opportunities for over 2.451 people. ► Continued on P4



New Delhi, August 10: BJP MP Varun Gandhi alleged Wednesday that ration card holders are being forced to buy the national Tricolour in some parts of the country. He said it will be unfortunate if celebrations of the 75th anniversary of Independence become a burden on the poor. The government however, denied any such development.

It is 'shameful' to extract the price of 'Tiranga', which lives in the heart of every Indian, by snatching the poor's morsel of food, Varun said in a tweet in Hindi. The Pilibhit MP posted a video purportedly showing some ration card holders complaining about being forced to pay ₹20 to buy the flag.

"It will be unfortunate if the celebration of the 75th anniversary of Independence becomes a burden on the poor. Ration card holders are being forced to buy Tiranga or denied a share of grains they are entitled to," Varun said.

The central government has urged people to hoist or display the national flag at their homes



during August 13-15 as part of 'Har Ghar Tiranga' programme.

In the video, recorded by a news portal in Haryana's Karnal, people are seen alleging that they were forced to pay ₹20 and buy the national flag when they went to collect ration at a state-run depot.

A man in the video, who appears to be a staff of the depot is heard saying that they had received orders that each person taking ration had to buy the flag for ₹20. "We have been told not to give ration to anyone who refuses to buy the flag. We have to do what we are ordered to," he said.

Students can celebrate I-Day: Govt

Bhubaneswar, August 10: In a complete 'U' turn, the Odisha government said Wednesday that students of schools in the state will be allowed to take part in the Independence Day celebrations. This development is in complete contrast to what School and Mass Education (S&ME) Minister Samir Ranjan Dash had said Tuesday

Dash told mediapersons Wednesday that as per the revised guidelines of the Odisha govern-

ment, students will be allowed to participate in I-Day programmes. Earlier he had said that I-Day in schools will be celebrated without students. However, teachers will have to present in schools on August 15 to observe the day.

It should be stated here that there will be no parade on Independence Day this year in the state due to the prevailing Covid-19 situation. A decision in this regard has been taken by the government at a preparatory meeting for observation of Independence Day, a few days back.

SC transfers all Nupur FIRs to Shah's Delhi cops

New Delhi, August 10: The Supreme Court directed Wednesday the clubbing and transfer of all present and future FIRs lodged across India against suspended BJP spokeswoman Nupur Sharma to Delhi Police in connection with her remarks on Prophet Mohammed during a TV debate show. It should be stated that the police in the national capital, a Union Territory, reports to the Home Ministry headed by Amit Shah

A bench of Justices Surva Kant and JB Pardiwala also extended the interim protection from any coercive action to Sharma till the probe is concluded by the Intelligence Fusion & Strategic Operations (IFSO) of the Delhi Police. The bench said that IFSO shall be at liberty to take assistance from other police forces to take the case to a logical end.

"Since this Court has already taken cognizance of the serious threat to life and security of the petitioner (Sharma), we direct that all FIRs against Nupur Sharma be transferred and clubbed for investigation to the Delhi Police,' the apex court bench said.

"In particular facts and circumstances, we clarify and deem it appropriate that the investigation is carried out by Delhi police. The petitioner shall be at liberty to pursue her rights and remedies by approaching Delhi High Court for quashing the current and future FIRs," the bench added.

It should be stated here that apex court July 19 granted interim protection from arrest till August 10 to Sharma in connection with the FIRs filed against her. The FIRs had been filed in a number of states including UP and West Bengal.

However, the same bench July 1 had severely criticised Sharma for her controversial comments against the Prophet. It said her 'loose tongue' has 'set the entire country on fire' and that she is 'singlehandedly' responsible for what is happening in the country'.

Sharma's comments on the Prophet had also evoked strong international reactions with many countries in the middle east demanding action against her.

7 corrupt officials sacked

Bhubaneswar, August 10: The Odisha government continued its relentless drive against corrupt and inept officials and showed the door to seven of them. Among the seven, five were handed compulsory retirements while two others were sacked over various charges of corruption. The state government also permanently stopped the pensions of two more officials, a release from the Chief Minister's Office (CMO) said, Wednesday.

Action has been taken against a superintending engineer, two executive engineers, two assistant engineers, a retired junior engi

neer, an OAS officer, a retired chief district veterinary officer and a social education organiser.

The worst offender among those disciplined, was superintending engineer of Malkangiri Rural Development department (Division-1) Ashis Kumar Das. He was convicted in a corruption case where he had accepted a bribe of ₹10.23 lakh from contractors. He was caught red-handed by Vigilance sleuths while accepting the bribe.

The others who have suffered the ire of the Odisha government are Bhadrak Rural Development department (Division 1) executive engineer Manas Ranjan Mohanty, Cuttack Gandarpur Drainage

Division executive engineer Manoj Kumar Behera, assistant engineer of Baitarani Irrigation Division in Keonjhar district, Umesh Kumar Shashini, Umerkote R&B Section assistant engineer Bishuddhanand Behera, Paralakhemundi CDVO Jaladhar Mallick, OAS officer Sabita Sahu, Bolangir social education organiser Prabhasini Babu and Ganjam Rural Works Division 2 junior engineer, Trinath Sethi.

It has been alleged that all those who have been sacked had amassed wealth disproportionate to their known sources of income.

The state government has so far taken action against 173 officials over corruption.

Space debris may kill humans soon: Study

Toronto, August 10: Rocket parts left in orbit from space launches have a 20 per cent chance of severely injuring or killing a human being in the near future, according to a study done by researchers from the University of British Columbia (UBC) here.

The study published Wednesday noted that governments need to take collective action and mandate that rocket parts are guided safely back to Earth after their use, which could increase the cost of a launch, but potentially save human lives.

"Is it permissible to regard the

loss of human life as just a cost of doing business, or is it something that we should seek to protect when we can? And that's the crucial point here: we can protect against this risk," said study lead author Michael Byers, a professor at UBC's Department of Political Science.

The researchers noted that when objects such as satellites are launched into space, rockets are used, parts of which are often left in orbit. If these leftover rocket parts have a low enough orbit, they can re-enter the atmosphere in an uncontrolled way. Most of the material will burn up in the atmosphere, but potentially lethal pieces



can still hurtle towards the ground, they said. The study, published in the journal 'Nature Astronomy', analysed over 30 years of data from a public satellite catalogue, and

"He is doing fine now. He is out of danger," Pal said in a video he shared with the media.





₹6,367cr worth plan for state's transport infra

Bhubaneswar, August 10: The Transport department has come up with a five-year (2022-23 to 2026-27) plan for the development of state's road, rail and civil aviation infrastructure with an investment of Rs 6,367.34 crore, an official said Wednesday.

While Rs 1,232 crore will be spent on the development of the road transport sector, Rs 4,205.34 crore will be allocated for the railways sector. The state government has planned to spend Rs 930 crore to develop infrastructure in the aviation sector, the official pointed out.

The Transport department has planned to construct 20 truck terminals with a cost of Rs 100 crore. "While 10 truck terminals will be built during 2022-23, as many terminals will be constructed during 2024-25," said the official.

In a bid to act tough on traffic rule violators as well as to curb road mishaps, the Transport department will use an ultramodern camera surveillance system for which it would spend Rs 50 crore. Similarly, Rs 350 crore will be spent on the development of 4,000 km of National Highways passing through the state which often witness mishaps.

To ensure transparency during driving test, the state government would construct 10 more modern testing tracks with an allocation of Rs 12 crore during 2022-23, added

Two Automated Testing Centres (ATCs) will be built during 2022-23,

while three more ATCs will come up during 2023-24. Another ATC will be built during 2024-25. The state government would spend Rs 5 crore towards construction of each ATC, it was learnt.

The official pointed out that under the new Electric Vehicle (EV) Policy, the state will provide a total subsidy of Rs 200 crore on purchase of EVs during 2022-23, 2023-24, 2024-25 and 2025-26 (Rs 50 crore each year).

The state government has proposed to build block-level bus stands with modern amenities. Out of 314 blocks, construction of 242 block level bus stands would be taken up between 2022-23 and 2026-27 with an expenditure of Rs 824 crore.

In the aviation sector, the Transport department has planned to allocate Rs 232 crore for the development of Jeypore airport in Koraput under UDAN scheme. Similarly, Rs 112 crore will be spent on acquisition of 204 acre of additional private land during 2022-23, it was learnt.

During 2023-24, Rs 120 crore will be spent on further expansion of the runway up to 1800 metres and other developments towards the northern side. Rs 300 crore would be spent towards the construction of a new greenfield airport at Puri, it

In the railways sector, the state has proposed an allocation of Rs 433.20 crore for Barbil-Banspani new rail link, Rs 700 crore for Bargarh-Nuapada railway line, Rs 1,600 crore for Gunupur-Therubali new rail line and Rs 1,472.14 crore for the Paradeep-Dhamara rail link project, the official further said.

The programme will be funded through different schemes of state and central governments. Besides, funds under special assistance to the state for capital investment were sought for the purpose, the sources said.

Unfortunate that only a few are aware of constitutional rights: CJI Ramana

New Delhi, August 10: Chief Justice of India NV Ramana Wednesday said it is unfortunate that even after 75 years of independence only a few are aware of the constitutional provisions and emphasised that the public must know their constitutional rights and duties.

CJI Ramana, who was speaking as the chief guest at an event by Eastern Book Company to celebrate the release of 'Supreme Court Cases (SCC) pre-1969', stated that the ultimate consumer of justice is the public and thus called for "simple" judgement writing by the judges as well as publication of important judgements of the Supreme Court and high courts in regional languages by law journals.

He said even a "small school kid" in the western countries is aware of his constitution and the laws and asserted 'we need that kind of culture"

"The lawyers and the public must know the constitutional provisions and the Constitution. It is unfortunate that we are now celebrating 75 years of independence but still only a few selected people in the urban areas or the legal professional are aware of the constitutional rights and duties and the constitutional principles," CJI Ramana said.

"They (people) must know what the Constitution says and how they are



entitled (under the laws). What are their rights, how to implement their rights, how to know their duties. It is necessary for us, especially (law journals) to try and introduce at least selected judgements of importance -- crux and not the entire judgement -- in regional languages to enable access in a simple language," he added.

Acknowledging that translation of judgements in regional languages in a simple manner would entail a financial burden, CJI Ramana added, "Thope some governments can also give some money because they are now starting several projects for popularising the Constitution and the constitutional schemes. We can think of this issue also.'

He further said being a judge for 22 years, he was aware of the criticism that judgements are at times "like a thesis" and requested all members of his fraternity to be simple.

"I request all the fraternity members as well as lawyers who are contributing by arguing to try to be simple in judgement (and write) concise, precise and short sentences. People must feel like they are reading a story,'

"Ultimately, at the end of the day, the consumers of justice are the litigant, public or whoever it is, they must know the end result. That is more interesting than our own imaginations and philosophies. That way I think we can help the public a lot. The reasoning and the conclusion needs to be clear. I hope and trust this will happen," he said.

New Langya virus in China can impair liver and kidney

hina has detected a new oonotic virus named Langya henipavirus, with potential to cause acute liver and kidney infection. About 35 people have reportedly been affected, according to an article published in the New England Journal of Medicine (NEJM) by scientists from China and Singapore.

The study showed that the new Langya henipavirus (LayV) was identified in a throat swab sample of febrile patients with a recent history of animal exposure in east-

Subsequent investigation identified 35 patients with acute LayV infection in the Shandong and Henan provinces of China, among whom 26 were infected with LayV only (no other pathogens were pres-

These 26 patients presented with fever (100 per cent of the patients), fatigue (54 per cent), cough (50 per cent), anorexia (50 per cent), myalgia (46 per cent), nausea (38 per cent), headache (35 per cent), and vomiting (35 per cent), accompanied by abnormalities of thrombocytopenia (35 per cent), leukopenia (54 per cent), and impaired liver (35 per cent) and kidney (8 per cent) function.

There was also no close contact or common exposure history found among the patients, which suggests that the infection in the human population may be sporadic.

from person to person. "Coronavirus will not be the last infectious disease to cause a pandemic worldwide, as new infectious diseases will have an increasingly greater impact on human daily life, Wang Xinyu, Deputy Chief Physician at the department of Infectious Diseases of Huashan Hospital Affiliated to Fudan University, was quoted as saving.

■ Youth gets 12-year **RI for raping minor**

Berhampur: A Special POCSO court sentenced a man to 12 years of rigorous imprisonment after convicting him of raping a minor, Wednesday, The convict was identified as Shiba Shankar Sabat, 30, alias Mitu. The judge also slapped a penalty of ₹20,000. In default, the convict has to undergo additional six months of imprisonment. The court also directed the district legal services authority (DLSA) to provide ₹6 lakh to the survivor for her rehabilitation. The judged passed the order after examining the statements recorded by 17 witnesses. Special PP Narayan Panda pleaded the matter on behalf of the state government. According to the case diary, the convict Sabat is a married man. The incident occurred April 5, 2017 when he sent his wife back to the village. Later, he took the minor who was living in front of his house on his vehicle to Taptapani ghat in the district. There he stopped at an isolated place and repeatedly raped the girl. 30 Bengal tourists injured as bus overturns in Balasore



Balasore, August 10: At least 30 people were injured, seven of them seriously when a tourist bus from West Bengal on its way to Puri skidded off the road and turned turtle on NH-16 near Talanagar at Soro in Balasore district Wednesday,

The bus had about 60 tourists on board and was on its way to Puri from North 24 Praganas district in West Bengal when the accident occurred in the wee hours, the police said.

This was the second bus mishap involving tourists from Bengal in Odisha in less than three months

The injured were admitted to Soro government hospital and the critically injured among them were shifted to Balasore district headquarters hospital where their condition was stated to be out of danger, the police said. Fire brigade and five ambulances were pressed into service to rescue the injured at the accident site.

This was the second bus mishap involving tourists from Bengal in Odisha in less than three months. In May a bus from Howrah district had overturned at Kalinga Ghat on way to Vizag killing six persons.

Malkangiri, August 10: Amid heavy rains, several parts of Motu Padia and other areas in Malkangiri district are reeling under floods. Communication has been disrupted from Malkangiri to Chhattisgarh and from Motu to Andhra Pradesh for three days. Floodwater as deep as four feet is flowing over Kulaguru bridge leading to scores of vehicles being stranded on both sides of the bridge.

As water level is rising in Godavari, water in Sileru and Sabari rivers fails to drain out. The reverse water from Polavaram project has allegedly created flood situation in certain pocket.





Bridge across Jonk river collapses Nuapada/Balasore: While heavy rain has been lashing most parts of the state for the last five days, triggered by the depression in Bay of Bengal,

a bridge over Jonk river in Nuapada district collapsed. It has disrupted vehicular communication between Odisha and Chhattisgarh. Besides, communication to over 50 villages in the district remained cut off.

Meanwhile, two gates of the Jonk irrigation dam were opened. Rainwater as deep as three feet is flowing over Jonk bridge at Sarabang. After the collapse of the bridge, communication to over 35 villages of Amanara, Kendubahara and Motanuapada panchayats has remained cut off from the rest of the world. Locals alleged that the bridge caved in due to sub-standard construction work.

In yet another case, a portion of a bridge across Coast canal near Kalamatia Pahi under Remuna block in Balasore district caved in owing to the torrential rains. The bridge provides connectivity to Balasore and Mayurbhani districts. Officials have visited the spot. Locals alleged that contractor had botched up its construction. Communication to different areas has been badly affected.

House caves in; one dies

Koraput: Following heavy rains, a house at Phulabeba village under Dasamantapur block in Koraput district caved in killing an elderly person. The deceased was identified as Chandra Muduli (60).

He was asleep when the house collapsed. Later, his body was recovered. Sarpanch Hiramani Gadaba reached the village and demanded compensation for the bereaved family.

Owing to heavy rain, as many as 134 houses were damaged in the district, according to sources in the district emergency department.

Work on crucial outer ring road in Sambalpur to start next year

Sambalpur, August 10: Work on the much-awaited outer ring road, which will help resolve the traffic problem of Sambalpur city, is expected to commence in March next year, an official said.

Heavy vehicles coming from the NH-53, Cuttack-Sambalpur NH-55 and the Biju Expressway will not have to enter Sambalpur city after the outer ring road is constructed. Implementation of the project will also pave way for the expansion of the city.

The National Highways Authority of India (NHAI), which will execute the work, has started the preliminary process for the land acquisition, project director K Nageswara Rao said.

A total of 290 hectares, including 170 hectares of private land, will be required for the implementation of the project, Rao said.

'We have planned a joint survey in September and floating of a tender for the construction in October," he said, adding that the work on the project would start in March and a detailed draft project report had been prepared.

The length of the proposed outer ring road, which will be constructed under the Bharatmala programme of the Union government, is 37.82 km. It will originate from National Highway 53 at Goshala in Dhankauda area and connect the Sambalpur-Rourkela Biju Expressway at Ranikhinda in Sasan on the outskirts of the city.

2 held for torturing inmate at de-addiction centre

New Age Disruptions

The current escalation of multiple, overlapping crises – climate-related disasters, a pandemic, war in Europe, and stagflation – is intensifying anxiety and uncertainty the world over. Conventional solutions are no longer working. Politicians have few persuasive answers. Existing institutions are overwhelmed. Global civilization is in the throes of a great transformation of unprecedented scale.

Each of the five foundational sectors that together define a civilization – energy, transport, food, information, and materials – is undergoing rapid technological disruption. These upheavals signal the twilight of today's dominant extractive industries, which are entering an economic death spiral, auguring higher unemployment, deeper inequality, and civil unrest.

But this "global phase shift" is also laying the foundations for a new civilizational life cycle. The most consequential technological disruptions aimed at mitigating climate change affect three foundational sectors - energy, transport, and food - that together account for 90% of global greenhouse-

Fossil-fuel energy is being disrupted by the "super power" potential of solar, wind, and batteries (SWB). Privately owned vehicles powered by gas-guzzling internal-combustion engines will be overtaken by electric vehicles (EVs) and

eventually by autonomous EVs (A-EVs). Livestock rearing and commercial fishing are being upended by precision fermentation and cellular agriculture, which allow us to brew and programme all kinds of proteins without killing

All disruptive technologies follow the same learning-by-doing feedback loop. As costs decline exponentially, their adoption accelerates until they dominate the market. When these technologies become ten times cheaper than the incumbent technology, they swiftly displace it. The disruption of horses by cars, landlines by smartphones, and photographic film by digital cameras all happened within 10-15 years.

Disruptions are not one-for-one substitutions, but instead lead to completely new systems with distinctive properties. For the first time in our history, emerging technologies show a clear pathway to ending the age of

Oil, gas, and coal are becoming more inefficient and expensive. The value of the energy they produce relative to the energy they use has declined by more than half in the past two decades. But the opposite is true of SWB, for which energy return on investment (EROI) is increasing exponentially.

As I explain in a recent Earth4All paper, the cheapest SWB combination involves supersizing solar and wind generating capacity to 3-5 times the level of existing demand. This "super power" capacity - producing more energy than incumbent fossil-fuel systems at zero marginal cost for most of the year would dramatically reduce overall system costs by removing the need for weeks' worth of seasonal battery storage

Swiss government scientists have shown that building such a system globally could generate up to ten times the amount of energy we use today. That will enable the electrification of a vast array of industries, from wastewater treatment and recycling to mining and manufacturing. And this system won't need constant material inputs like the current fossil-fuel system; once built, it will last 50-80 years.

Similar counterintuitive cascading effects will benefit the transport sector. EV and A-EV cost curves show that ride-hailing via Transport-as-a-Service (TaaS) will become up to ten times cheaper than owning and managing your own car by the 2030s. As a result, only a fraction of the number of vehicles we use now will be in service. And, because SWB and TaaS entail a tiny proportion of the battery storage demand anticipated by most conventional analysts, consumption of critical minerals needed to produce the batteries will be much lower than feared.

These disruptions will also render obsolete the entire infrastructure of incumbent fossil-fuel-based energy, transport, and food systems. That includes oil rigs, gas terminals, pipelines, and coal-fired power plants, as well as global logistics and shipping networks for fossil fuels, livestock, and livestock

Dismantling this infrastructure will create unprecedented scope for metals recycling. Iron, aluminum, steel, copper, nickel, and cobalt are used extensively in the oil industry but will also help drive the energy, transport, and food transformation

Meanwhile, the disruption of dairy industries will free up 2.7 billion hectares of land previously dedicated to animal husbandry for rewilding, regenerative agriculture, and active reforestation. This will permit large-scale natural strategies to withdraw and capture atmospheric carbon.

Over the next two decades, the transformation of the global production system will create unique possibilities – what my RethinkX colleagues James Arbib and Tony Seba call an "Age of Freedom." Moreover, we don't need to wait for exotic and expensive breakthrough technologies to solve our biggest global challenges. We have all the tools we need to usher in a new era of superabundance that provides advanced power, mobility, food, education, and infrastructure to everyone at a tenth of the cost of incumbent systems and without breaching planetary boundaries.

But getting to this "Age of Freedom" will not be easy. Today's disruptions are fast, but not fast enough for the world to escape the climate danger zone. If we delay them by clinging to dying incumbent industries, the social, economic. and geopolitical fallout could stall or even obstruct the transformation.

Because disruptive technologies scale for economic reasons, governments can accelerate this transformation by leveraging markets. That requires ending trillion-dollar subsidies and new investments in conventional energy; creating free and fair electricity markets that uphold individuals' right to own and trade power; and establishing open-source intellectual-property systems for global design and local implementation. In the case of residential heating, governments should provide incentives and subsidies for electri

Most of all, we must shift our mindsets and embrace the necessity of a radical shift from centralised to decentralised provision of energy, transport, and food. That means switching from top-down to bottom-up, and from hierarchies to networks and nodes.

The old system is dying as a new one is being born, putting us in the eye of the storm. But with the right choices, we can rapidly build a more just and advanced civilisation that provides unparalleled levels of universal and sustainable prosperity. There is no time to lose - and everything to gain.



√he government must come out of the perils of cycle of debts to ensure growth amid high multiple taxes and little corporate investment. The large business houses get the sweet pill of ₹19.18 trillion loan write-off bonanza since 2013, even as the nation gets into a borrowing mesh. India's inflation may not be just because of the rising prices. High national debt, loan write-offs and tax burdens may have contributed to it, indicates the second major Reserve Bank of India 0.5 per cent Total borrowings at ₹155 lakh

crore (trillion) is set to add ₹11.5 trillion more in 2022-23. Interestingly, as a percentage of GDP, the Centre's liabilities are set to increase to 60.2 per cent in 2023. An emerging view is that the government cannot be the driver of the economy and continue lubricating it for the benefit of big loan defaulters. The small, medium and tiny sectors are becoming restless. More cash use can reduce poverty and boost small business. This would reduce dependence on shearing bank deposits, high NPAs and resorting to manage finances through large deficits.

Finance Minister Nirmala Sitharaman recently re-emphasised that India's long-term growth prospects are embedded in public capital expenditure at the meet of Finance Ministers and central bank governors in Indonesia. She was hopeful that this would spur private investments. The Bretton

Woods bodies promote this. Now this needs a review, as figures indicate that the Modi government's hopes are ditched by poor large-house investments. The government is being forced into a vortex of borrowings for too many high-funded infra projects, such as roads, high-speed rail ways and power sector. Its borrowings are to rise to ₹11.6 trillion from ₹9.7 trillion in 2022-23.

Interestingly enough, the Manmohan Singh government also did the same post-2008 Lehman Brothers meltdown by incentivising loans, most of which turned into NPAs and were



The high government expenditure has not spurred job creation, domestic consumption and capacity expansion of private sector for a decade. Instead, it has led to severe 7 per cent plus consumer inflation and almost 15.9 per cent wholesale inflation, too much burden on a government that is extending free food to 80 crore poor

Private Equity-Venture Capital (PE-VC) investments, contracting since 2012, declined 25 per cent during April-June 2022, at \$11.3 billion across 315 deals; 2021 had \$15.2 billion invested in 264 deals. The RBI, in May 2019, observed that 2017-18 was the seventh consecutive year of annual contraction in private sector capex. It was ₹1,65,000 crore in 2016-17. The RBI found it declining from ₹94,227 crore in 2020-21 to ₹68,649 crore

The government has taken the load off the private sector for spurring economic revival. The Union Budget 2022-23 has increased the capex target to ₹7.5 lakh crore, a 35.4 per cent jump from the budget estimate of ₹5.5 lakh crore in 2021-22. The revised estimate for capex in 2021-22 came in at ₹6.03 lakh crore. Capex accounts for 19.02 per cent of the government's total expenditure at ₹39.45 lakh crore for 2022-23.

The high government expenditure has not spurred job creation, domestic consumption and capacity expansion of private sector for a decade. Instead, it has led to severe 7 per cent plus consumer inflation and almost 15.9 per cent wholesale inflation, too much burden on a government that is extending free food to 80 crore poor. It has added a mere 7.2 lakh government jobs and the private sector, except IT, none.

The private sector though has large profits, benefitting from ₹10.83 trillion lakh crore loan write-offs till 2018 and ₹8.35 trillion after that, as per a Lok Sabha answer, causes high NPAs. Some individual houses alone have over ₹2 trillion NPAs. This has impacted the rupee slide below ₹80 to a dollar causing severe balance

This calls for looking at small businesses and SMEs for real economic growth. The SMEs need to grow independently and not as lackey of large business. A few years back the country's tiny sec tor was thriving on cash, but now is piqued by many curbs. Let people earn and spend transparently. It would lead to more inflow of money, more investments, spur other sectors and if they want to buy gold let them do it. Let citizens thrive and help the nation grow.

Cash circulation in six years has doubled to ₹32.2 crore. But the small businesses are too much under constraints. Let these be removed, let them deposit in banks any amount they want without a demur. Explanations can be given at their annual return. Remember, cash has been the strength of this society.

Easy rules would revive the trades shut during COVID. This would help the government in many ways. It is not only the working classes who have been dependent on the enormous food dole but small traders as well. The small traders also are feeling the pinch with stringent GST rules and penalties that surpass the actual taxes due. Nobody listens to the reasons why they delayed tax payments. The 28 per cent rise in GST collection to ₹1.49 trillion in July may have many sordid stories. The government has to make the rule humane and reduce taxes on food and essential items. It would stop entrepreneurs' flight to become traders and spur growth. The government may earn a few crore less but would add to the people's happiness. In a year's time, politically crucial for the government, it would bring in a sea change in the economic pattern of overall development, growth and happiness.

A government concerned of rising prices may have many easy solutions if it changes its approach to the commoners in different spheres. Like small touches through a painter's brush, the economy would change

ate: 16 August 2002. An unusually dark night, completely black, and a thick blanket of clouds adding to the

Location: Deep inside the mountainous terrain of Afghanistan. Mission: 22 US Special Forces

troops had captured a dreaded terrorist and were escorting him to a safe place. They were under the threat of enemy attacks.

That night Captain Mike Drowley was providing air cover to the ground troops in his A10 aircraft. He was nicknamed Johnny

Bravo, an attack pilot and another A10 aircraft accompanying him were entrusted to track the troops and give them necessary support in case of any eventuality. They were flying above the clouds and could see the glittering stars. snow-capped mountains and the moon from the cockpit. It was quite peaceful at that altitude.

In these types of military operations, the pilot above wants to see the troops on the ground and similarly the ground forces should have a sight of the aircraft flying above them, for reassurance. But

due to the heavy overcast conditions, 16 August was a different night. Descending below the clouds to establish a line of sight with the troops was highly risky due to the treacherous mountain range and valleys. It literally means one has to drop below 1000 feet. Even the ATC does not instruct to descend to such levels in that type of

Although, Bravo could not see the troops he could sense their anxietv and tension. Instinctively he sprang into action. As he was descending below the clouds, Bravo received a radio message "Troops in Contact" which means enemy firing on them. His gut feeling be-

came true! The call of empathy urged him to go down to extend support to the 22 men below, even if it means breaking the guidelines. When he let down his aircraft, he could see and hear gunshots from either side of the valley. Bullets and rockets were fired on the Special Ops Forces which lit up the entire area. Bravo could relate to what the troops were going through at that point of time.

He flew a few thousand feet

straight, fired at the enemy target and took a sharp turn back to avoid colliding against the mountain walls. Again, repeated the attack and disappeared into the clouds. He went on with this exercise several times. There was quietness everywhere and he felt that he has lost his colleagues at the ground. He was breathing heavily and was praying for their safety till he received a message "Good Hit. Keep it Coming." It was the best radio message he has ever heard. Attacking relentlessly, he had silenced the enemy camp. All 22 of his friends were safe.

Later when Capt. Bravo (now a Colonel and the Commander of the 355th Fighter Wing at Davis Monthan Air Force Base in Arizona) was asked why he undertook such a decision which could have been fatal and also there were no commands to do so, he said, he staying alive but losing his colleagues would have been much worse than death. He adds: "I feel in so many years the greatest skill that I have acquired is empathy. The more I can put myself in their shoes, the better I can understand how I can help them.'

It was his unflinching commitment to his team that guided his decisions and actions. He risked his life so that others might survive.

Although, they never knew each other earlier, they hugged like old friends when he met them, finally. For Johnny Bravo and many like him it is not the recognition that drives them to do such acts of sacrifices but it is the culture that they have ingrained in them. Organisations become great due to the people and the culture - where leaders provide protection from above and the people on the ground are willing to push harder and give their best, because they trust each other.

If one is oblivious to the conditions faced by the team, then he is not a leader. The Capt. Bravo effort is one of the best leadership stories in real life which was immortalised hv Simon Sinek in his book "Leaders Eat Last."

The common thread is empathy - as a leader you feel what others feel and act!



While Supreme Court judges retire on attaining the age of 65 years, judges of the 25 high courts retire at 62. Justice Lalit will be the second CJI who was directly elevated to the apex court bench from the Bar. Justice S M Sikri, who became the 13th CJI in January 1971, was the first lawver to be elevated directly

to the top court bench in March 1964. "In exercise of the powers conferred by clause (2) of Article 124

of the Constitution of India, the President is pleased to appoint Shri Justice Uday Umesh Lalit, judge of the Supreme Court, to be the Chief Justice of India with effect from 27 August, 2022," a law ministry notification said.

Top officials of the department of justice, along with principal secretary to the prime minister P K Mishra met Justice Lalit and handed over the warrant of appointment, sources said.

Justice Lalit has been part of several landmark judgements including the one which held the practice of divorce through instant triple talaq among Muslims illegal and unconstitutional.

A renowned senior advocate, he was appointed a judge of the Supreme Court August 13, 2014. He shifted his practice to Delhi in January 1986, and in April 2004, he was designated as a senior advocate by the apex court.

He was appointed a special public prosecutor for the CBI to conduct trial in the 2G spectrum allocation case. He has since been involved in delivery of several landmark judgements of the apex court.

In the triple talaq verdict, while the then CJI J S Khehar and Justice S Abdul Nazeer were in favour of putting on hold the judgement for six months and asking the government to come out with a law to that effect, justices Kurian Joseph, R F Nariman and Lalit held the practice as violative of the Constitution.

Justices Khehar, Joseph and Nariman have since retired. Justice Lalit, who is also the executive chairperson of the National Legal Services Authority (NALSA), recently said the NALSA is going to establish a "legal aid" system for the poor and the marginalised in all districts on the lines of the office of public prosecutors. He was addressing the first All India District Legal Services Authorities Meet here.

Born November 9, 1957, Justice Lalit enrolled as an advocate in June 1983 and practised in the Bombay High Court till December 1985

CABINET EXPANSION

Maha: Independents, smaller parties fume after being 'ignored'

Mumbai, August 10: Legislators from smaller parties and Independents supporting the new government expressed dismay Wednesday after they were 'dropped' from the mini-cabinet expansion carried out Tuesday by Chief Minister Eknath Shinde, 41 days after he was sworn-in along with Bharatiya Janata Party's Deputy CM Devendra Fadnavis.

At least two -- Bacchu Kadu and Rajendra Patil-Yadravkar -- expressed a grouse against Shinde-Fadnavis for not giving them any representation in the 20-member ministry comprising 10 Shiv Sena rebels and 10 BJP MLAs.

Earlier, the 18 Independents and smaller parties who supported Shinde were assured of adequate representation, and now they have been promised inclusion in the next round of cabinet expansion likely after the Monsoon Session of the Legislature starting on August 17.

Incidentally, both Kadu and Patil-Yadravkar of the Prahar Janshakti Party, were ministers in the Maha Vikas Aghadi government headed by ex-CM Uddhav Thackeray.

'I was promised that I would be joining the ministry. It would be wrong to say that I am not upset. Now, we are informed of another cabinet expansion where we shall be included," said Kadu.

Patil-Yadravkar said he was puzzled why he was overlooked, but he had no complaints or expectations, saying "if it has to happen, it will happen".

The state legislature comprises 288 members of which the sanctioned strength of ministers is 43, meaning that there are still 23 vacancies to be filled, though there has been a huge clamour from the Shinde group and the BJP for ministerial berths.

On Tuesday, Shinde faced severe flak for his 'gents only' cabinet, ignoring several women hopefuls while taking on board at least 3 'tainted' legislators.

A day after the Maharashtra cabinet expansion, the Shiv Sena claimed administering ministerial oath to rebels MLAs, whose disqualification pleas are pending before the Supreme Court. amounted to murder of democracy and the Constitution. By finally taking the minis-

terial oath, the rebels have taken a dip in the Ganga river. But will they be able to "wash the sin of betrayal?" an editorial in the Sena mouthpiece 'Saamana' asked Wednesday. The expression on Maharashtra

Governor Bhagat Singh Koshyari's face while administering the oath to ministers was as if he was doing a "divine work", it quipped.

The Marathi daily also slammed Chief Minister Eknath Shinde for "bowing" before Delhi seven times by going to the national capital before the cabinet expansion.

The CM had made seven visits to New Delhi in the last one month, and with every visit there was talk of the ministry expansion.

SC grants bail to Varavara Rao

New Delhi, August 10: The Supreme Court Wednesday granted bail to 82-year-old poet and activist P Varavara Rao, an accused in the Bhima Koregaon case, on medical

The National Investigation Agency (NIA) vehemently opposed Rao's plea in the apex court claiming that he is involved in "serious anti-national activities

The case relates to alleged inflammatory speeches made at the Elgar Parishad conclave held in Pune December 31, 2017, which the police claimed triggered violence the next day near the Koregaon-Bhima war memorial on the outskirts of the western Maharashtra city.

The Pune Police had also claimed that the conclave was organised by people with alleged Maoist links. The NIA later took over the probe in the matter.

Rao was arrested August 28, 2018, from his Hyderabad residence and is accused in the case for which an FIR was lodged by the Pune Police January 8, 2018, under various sections of the Indian Penal Code and the Unlawful Activities (Prevention) Act. While granting him bail, a bench headed by Justice U U Lalit noted that the medical condition of Rao, who is presently out on interim bail on medical grounds, has not improved to such an extent over a period that the facility of bail granted earlier to him be withdrawn

The bench also observed that Rao is 82-year-old and has spent around two-and-a-half-year in custody.

Additional Solicitor General (ASG) S V Raju, appearing for the NIA, argued before the bench that Rao is not an "ordinary criminal" and in certain cases, age cannot be



a factor if the offences are serious and affect the nation

"The medical condition of the appellant (Rao) has not improved to such an extent over a period of time that the facility of bail which was granted earlier be with drawn," the bench said.

Rao, who is a Telugu poet, had

challenged the Bombay High Court's April 13 this year order rejecting his plea for permanent bail on medical grounds.

While granting bail to Rao, the apex court said he shall not leave the area of Greater Mumbai without express permission from the trial court.

Shahjahanpur (UP), August 10:

A child born out of rape has helped his mother get justice, 28 years after the crime. Police put one of the alleged rapists behind bars last week and the other Wednesday.

Police said a DNA reported nailed the criminals -- two brothers who had fled to Hyderabad once the investigation began. The woman was allegedly raped by them in 1994 when she lived in Shahjahanpur's Sadar Bazar as a 12-year-old, Shahjahanpur Superintendent of Police S Anand told PTI.

The child later gave birth to a boy. Over the years, she married and was abandoned by her hus-

The case was lodged at the Sadar Bazar police station March 4, 2021, after her grown-up son nudged her into filing a complaint.

Police said Naki Hasan and his younger brother Guddu raped the 12-vear-old, then living with her relatives, several times when she was alone at home. The family kept mum about the rape when the girl gave birth, fearing humiliation. The child was separated from her and handed over to a relative in Hardoi. In 2000, the rape victim was married off to a man in Ghazipur. But the marriage broke up when her husband came to know about the rape. The victim, now an adult, was abandoned and staved alone. A few years ago her son contacted her and asked her about his father. When she told him about the incident in her past, he encouraged her to lodge an FIR and seek justice.

He accompanied his mother to Shahjahanpur and the FIR was eventually registered on the orders of the court. Police arrested Guddu when he returned to Shahiahanpur for some work, officials said. Naki Hasan was arrested Wednesday.

Mirzapur carpets, Maha teakwood furniture to welcome MPs

New Delhi, August 10: All-out efforts are being made to finish the remaining work on the new Parliament building so that the Winter Session is held there, officials have said.

Handwoven cushioned carpets of Mirzapur and stones from Madhya Pradesh and Rajasthan are being used in the new building. Teakwood furniture from Maharashtra has arrived while work has begun on the interiors and flooring, they said.

Last week, the government told the Lok Sabha that 70 per cent of the physical progress of the new Parliament building project has been achieved and the targeted

date of completion is November 2022. There is no plan yet to extend the deadline considering the national importance of this project, sources said.

"We are making all-out effort to ensure the Winter Session is held in the new Parliament building," officials privy to the development told PTI.

They indicated that some portions of the new Parliament building may be functional by November 26 -- Constitution Day. However nothing has been finalised yet, official sources said.

The government has maintained that the Winter session of Parliament will be held in the new building being built under the Narendra Modi government's



ambitious Central Vista redevelopment project.

In December 2020, Prime Minister Narendra Modi laid the

foundation stone of the new building. Last month, he unveiled the national emblem cast on the roof of the building.

Publication of J&K electoral rolls by Nov 15

Jammu, August 10: The Election Commission of India has set a new deadline of November 25 for the final date for publication of electoral rolls in Jammu and Kashmir.

It said youngsters attaining the age of 18 years October 1 or earlier will be eligible to become voters in the Union territory.

Earlier, the poll panel had given a timeline of October 31 for the publication of the finalised electoral rolls in J&K, where the special summary revision is bsseing undertaken after a gap of three years and the first such exercise after the boundaries of assembly seats were redrawn in the delimitation exercise.

According to the rescheduled timeline issued by the Election Commission, an integrated draft electoral roll will be published September 15. The period for filing claims and objections has been set between September 15 to October 25 followed by disposal of claims and objections November 10.

Checking of health parameters and obtaining the commission's permission for final publication and updating database and printing of supplements has been fixed for November 19 before the publication of final electoral rolls November 25, an Election Commission's order, reproduced by the Chief Electoral Officer's office here, said.

In May, the central government had issued a notification stating that the orders of the Delimitation

Commission which redrew electoral constituencies and provided six additional assembly seats to Jammu division and one to Kashmir would come into effect from May 20.

According to the orders of the Delimitation Commission, set up under the Jammu and Kashmir Reorganisation Act of 2019, the Union territory will have 90 assembly constituencies -- 43 in Jammu Division and 47 in Kashmir Valley-with nine of them being reserved for the Scheduled Tribes.

Lt Governor Manoj Sinha had assured that the assembly elections will take place in Jammu and Kashmir after the completion of the ongoing revision of electoral rolls.

However, political observers are of the opinion that the muchawaited polls are likely to be deferred to next year after the end of the harsh winter in the Kashmir Valley and the Chenab region.

"Any person who attains the age of 18 years on or before October 1, 2022 and is otherwise qualified to be enrolled as an elector in the Electoral Roll, can apply for his registration during the Revision,' the order said.

It noted that presently, the prerevision activities as well as postdelimitation follow up, work is going on in Jammu and Kashmir wherein the existing electoral rolls are being mapped into newly delimited assembly constituencies per the Delimitation Commission's final order made applicable by the Union Law Ministry





New Delhi, August 10:The government has approved Biological E's Corbevax as a precaution dose for those above 18 years fully vaccinated with either Covishield or Covaxin, official sources said Wednesday

This is for the first time that a booster dose that is different from the one used for primary vaccination against Covid has been allowed in the country. The sources told PTI that the Union Health Ministry's approval is based on the recommendations made recently by the Covid-19 Working Group of the National Technical Advisory Group on Immunisation (NTAGI).

"Corbevax will be considered as a precaution dose after completion of six months or 26 weeks from the date of administration of the second dose of either Covaxin or Covishield vaccines for those aged above 18 years enabling use of Corbevax as a heterologous Covid-19 vaccine for precaution dose administration in this age group," the sources said.

This will be in addition to the existing guidelines for homologous precaution dose administration of Covaxin and Covishield vaccine, the sources added.

All necessary changes in regard to the administration of precaution dose of Corbevax vaccine are being made on the Co-WIN portal. India's first indigenously developed RBD protein subunit vaccine Corbevax is currently being used to inoculate children in the age group of 12 to 14 years under the Covid-19 immunisation programme.

The Covid-19 Working Group (CWG), in its July 20 meeting, reviewed data of the double-blind randomised phase-3 clinical study which evaluated the immuno-

genicity and safety of booster dose of Corbevax vaccine when administered to Covid-19 -negative adult volunteers of age 18-80 years previously vaccinated with two doses of either Covishield or Covaxin.

"Following the examination of the data, the CWG observed that Corbevax vaccine can induce significant increase in antibody titers when given to those who have received either Covaxin or Covishield, which is likely to be protective as per the neutralisation data also," the

sources said. The Drugs Controller General of India (DCGI) June 4 approved Corbevax as a precaution dose for those aged 18 and above. India began administering precaution doses of vaccines to healthcare and frontline workers and those aged 60 and above with comorbidities from January 10.

Nitish takes oath as Bihar CM

Patna, August 10: JD(U) leader Nitish Kumar Wednesday took oath as Bihar Chief Minister for a record eighth time in a no-frills ceremony at Raj Bhavan, a day after snapping ties with the BJPled NDA and joining hands with the RJD to form a 'Mahagathbandhan' government.

Kumar was sworn in besides RJD's Tejashwi Yadav, who is likely to be designated as his deputy. A notification is likely to be issued tonight, naming him as the deputy chief minister.

Other cabinet ministers will be sworn in later once the three main alliance partners -- the JD(U), RJD and Congress -- decide on the number of berths and the legislators who will be made ministers.

Kumar is likely to retain the allimportant Home portfolio, while the RJD may get most of the departments that were previously with the BJP, a highly-placed source said.

He said an in-principle agreement has been reached about the composition of the new cabinet, which is likely to have "35 members or more", drawn from Kumar's JD(U), the RJD and the Congress.

Euphoric scenes were witnessed outside the Raj Bhavan and residences of Kumar and Yadav, as hundreds of supporters of JD(U) and RJD celebrated beating drums, bursting crackers and distributing 'laddus' (sweetmeats).

Talking to reporters shortly after he was administered the oath of office by Governor Phagu Chauhan, Kumar rubbished BJP's claim that the new government will not last its full term, and said his former ally "will be back where they were after the 2015 assembly polls" when the NDA could get less than 50 seats in the 243-strong assembly.

Meanwhile, leaders of the BJP, which is the second largest party in the assembly with 77 MLAs,

"Nitish Kumar has been in a habit of ditching allies. He will not be loyal to the RJD as well, and try to break that party taking advantage of Lalu Prasad's ill-health... We are accused of betraying our allies by the JD(U) which cites the example of Shiv Sena. Shiv Sena came apart. And we were not its allies then," he said.

Back in the reckoning as a potential "secular" alternative to Narendra Modi, which the disjointed opposition could project, Kumar said he had no "daawedari' (claims) when asked about prime ministerial ambitions, but guipped

"they should remember 2014 is past. They need to worry ('chinta karni chahiye') about 2024'

Sushil Modi also claimed that Tejashwi Yadav as the leader of the numerically bigger party "will try to act as the de facto CM". "He will also be under pressure to deliver on the promise of 10 lakh government jobs he had been making to the people of the state. This will unsettle Nitish and the internal contradictions will cause the government to collapse before 2025," the former deputy CM said

Kumar, however, asserted that the new government will run fine and fulfil all the promises made to the people of Bihar. "They (the BJP) are worried that they may be back to the same level they were at in 2015," the Chief Minister said, referring to the assembly polls JD(U), RJD and Congress had fought together in which the BJP-led NDA was trounced.

Later, the Rajya Sabha member also claimed that Kumar wanted to "become the vice president" and he dumped the BJP after the party failed to accommodate his ambitions.

ICAR develops vax for Lumpy Skin Disease in cattle

New Delhi, August 10: In a major breakthrough, two institutes of agri research body ICAR have developed an indigenous vaccine for Lumpy Skin Disease in cattle which has spread across many states in the last few months.

ICAR-National Research Centre on Equines (ICAR-NRCE), Hisar (Harvana), in collaboration with ICAR-Indian Veterinary Research Institute (IVRI), Izatnagar, Uttar Pradesh has developed a homologous live-attenuated LSD vaccine "Lumpi-ProVacInd"

The new technology was released by Union Agriculture Minister Narendra Singh Tomar and Union Fisheries, Animal Husbandry and Dairying Minister Parshottam Rupala at an event held in the national capital. While addressing the event, Tomar said: "It is our big responsibility to save animals."

He stressed expanding the production capacity of this vaccine so that it reaches the ground level at the earliest to vaccinate 30 crore animals.

On the sidelines, Rupala complemented the ICAR scientists for the development of this indigenous vaccine, which he said would help in controlling the LSD. 'Scientists were making efforts

to develop this vaccine since the LSD disease was first reported in Odisha in 2019. Today, the technology has been launched and now we will move forward to ensure how this vaccine reaches farmers who have cattle," he said.

Rupala said it is a very "encouraging" development as the spread of the LSD has become a serious issue. He said there is a protocol for the commercialisation of vaccines and the animal husbandry department will see how

Emerging evidence suggests that the LSD virus can also cause mild illness in buffalo, camels, deer and horses, "Due to its recent spread in unnatural hosts, there are growing concerns about its zoonotic implication, although confirmatory evidence of human infection is lacking,' ICAR said.

Sheepox virus (SPV) and goat pox virus (GPV) -based vaccine (heterologous vaccine) is usually authorized to induce cross-protection against LSD in cattle, where homologous LSD vaccine is not $\stackrel{\sim}{\rightarrow}$ available.

The Centre has also authorised the use of goatpox vaccine to control LSD in cattle. However, heterologous vaccines provide partial protection and are not as efficacious as homologous vaccines, the ICAR said.



'US MAIN INSTIGATOR OF UKRAINE CRISIS'

London: China, which Russia has sought as an ally since being cold-shouldered by the West over its invasion of Ukraine, has called the United States the "main instigator" of the crisis. In an interview with the Russian state news agency TASS published Wednesday, China's ambassador to Moscow, Zhang Hanhui, accused Washington of backing Russia into a corner with repeated expansions of the NATO defence alliance and support for forces seeking to align Ukraine with the European Union rather than Moscow. "As the initiator and main instigator of the Ukrainian crisis, Washington, while imposing unprecedented comprehensive sanctions on Russia, continues to supply arms and military equipment to Ukraine," Zhang was quoted as saying. "Their ultimate goal is to exhaust and crush Russia with a protracted war and the cudgel of sanctions." In the interview, Zhang said Sino-Russian relations had entered "the best period in history, characterised by the highest level of mutual trust, the highest degree of interaction, and the greatest strategic importance".

Ailing beluga whale euthanised after removal from river

Paris, August 10: French authorities say a beluga whale stranded for several days in the Seine River has died after it was successfully removed from the French waterway.

Veterinarian Ollivet Courtois said that during the rescue operation, the dangerously thin white mammal began to have breathing difficulties, and so experts decided to humanely euthanise the creature.

The whale was being prepared for transfer to a saltwater pool in Normandy. It was first spotted in the Seine last week after having accidentally veered off its normal

path to the Arctic. Conservation group Sea Shepherd France said veterinary exams after the beluga's removal from the river showed it had no digestive activity. Veterinarians planned to try to

re-stimulate its system. The group posted from the rescue operation showing the white beluga lying on a big net. Plans had called for 24 people to move the huge marine mammal to a refrigerated truck for a drive to the Normandy coast. The whale was expected to spend several days recuperating in the saltwater pool before being towed out to sea.

The rescue team said ahead of time that the transfer carried a risk of the whale dying because of the stress involved in the process.

However, the move was deemed necessary because the animal would not have been able to survive in much longer in the Seine's fresh water. The dangerously thin Arctic marine mammal was spotted in France last week. The group had said the beluga was a male with no infectious diseases and that veterinarians would try to re-stimulate the marine mammal's digestion.

A veterinary team was planning to transport the 4-metrelong (13-foot-long) whale to a coastal spot in the northeastern French port town of Ouistreham for "a period of care," according to Lamya Essemlali, president of Sea Shepherd France.

Authorities were planning to keep the whale in its temporary saltwater home for two to three days of surveillance and treatment before being towed out to sea.

The lost beluga was first seen in France's river, far from its Arctic habitat, last week. It weighed about 800 kilogrammes (1,764 pounds).

'Russia using power plant as nuclear shield'

Kyiv, August 10: Ukraine Wednesday accused Russia of exploiting its position in a nuclear power plant it had seized to target a nearby town in a rocket attack that killed at least 13 people and left many others seriously wounded.

The town Ukraine says Russia targeted - Marhanets - is one that Russia has alleged Ukrainian forces have used in the past to shell Russian forces who are holed up at the Zaporizhzhia nuclear power plant which they took over in March.

Rafael Grossi, head of the International Atomic Energy Agency (IAEA), has urged both sides to exercise restraint, warning of the "very real risk of a nuclear disaster. And foreign ministers from the

Group of Seven leading industrialised countries Wednesday demanded that Russia immediately hand back control of the plant to Ukraine, something Moscow seems unlikely to do. There was no immediate com-

ment from Russia on the Ukrainian allegations of a rocket attack on Marhanets and Reuters could not independently verify the allegations.

Moscow says it does not deliberately target civilians in what it calls its "special military operation" in Ukraine aimed at preemptively safeguarding its own security against expansion of the NATO military alliance.

Bristol, August 10: The menu at The Canteen in southwest England doesn't just let diners know how much a dish costs. They can also check its carbon footprint.

The carrot and beetroot pakora with yoghurt sauce is responsible for just 16 grams of CO2 emissions. The aubergines with a miso and harissa sauce with tabbouleh and Zaatar toast caused 675 grams of carbon dioxide.

As customers weigh their options, the menu at the vegetarian restaurant in Bristol includes a comparison with a dish that it does not serve: the emissions from a UK-produced hamburger.

The menu notes that a real beef



burger's emissions is "10 times the amount of its vegan alternative". The Canteen became in July the

first restaurant to agree to put its carbon footprint on the menu under a campaign spearheaded by UK

vegan campaigning charity Viva! The average British person has an annual carbon footprint of more than 10 tonne, according to UK government figures.

Britain has set the ambitious goal of reducing harmful emissions by 78 percent by 2035, compared with 1990 figures, in order to meet its international climate change commitments.

'Climate emergency

Switching to a plant-based diet is one of the most effective ways for an individual to reduce their carbon footprint, experts from the UN's Intergovernmental Panel on Climate Change said in April.

The livestock industry replaces CO2-absorbing forests with land for grazing and soy crops for cattle feed. The animals also belch huge amounts of methane, a potent greenhouse gas

"In England if you're a big chain restaurant, it's the law that you have to have calories on (the menu)," restaurant's manager, Liam Stock said. "But a lot of people are saying...

they're more interested in carbon.' Laura Hellwig, campaigns manager at Viva!, said the carbon footprint

Panipat (Haryana), August 10: India will start supplying petrol with 20 per cent ethanol at select petrol pumps from April next year and will ramp up supplies thereafter as it looks to cut oil import dependence and address environmental issues.

Oil Minister Hardeep Puri said a fifth of petrol will be made up of ethanol by 2025. "E20 petrol (petrol blended with 20 per cent ethanol) in some quantity will be available from April 2023 and the rest to be covered by 2025," he said.

India, which achieved the target of supplying petrol mixed with 10 per cent ethanol (10 per cent ethanol, 90 per cent petrol) ahead of schedule in June this year, has advanced



the target of making petrol with 20 per cent ethanol by five years to 2025.

'India could emerge as Asia's strongest economy next yr'

Morgan Stanley expects *India's growth to average* 7% for 2022-2023 and contribute 28% and 22% to Asian and global growth, respectively

Washington, August 10: India could emerge as Asia's strongest economy in 2022-2023 as it is bestpositioned to generate robust domestic demand, helped by economic policy reforms, a young workforce and business investments, Morgan Stanley economists said.

Morgan Stanley's projection comes as Asia's third-largest economy grew 9.2% in the fiscal year 2022, a sharp recovery from a 6.6% contraction in the previous year as Covid-19 lockdowns took a severe toll on its economy. The country now expects GDP growth for 2022-2023 at 8% -8.5%.

"Lower corporate taxes, the production-linked incentive (PLI) scheme and India as a potential beneficiary of supply chain diversification will catalyse and sustain domestic demand, especially



said in a note dated Tuesday.

In 2019, India had cut corporate tax rates to woo manufacturers and revive private investment, and launched the PLI scheme in 2020 to aid domestic manufacturing.

Morgan Stanley's outlook also comes as developed economies paint a glum picture, with business activity in the United States and eurozone contracting in July, as per their PMI data.

"The economy is set for its best run in over a decade as pent-up demand is being unleashed," the brokerage said, adding that "healthy" corporate balance sheets and business confidence bodes well for India's investment outlook.

While India, like other economies, raised interest rates to battle inflation, Morgan said the country's Rs 39.45 trillion budget for the current fiscal year has continued to tilt towards lifting public investment.

New Delhi, August 10: Indian companies are using Asian currencies more often to pay for Russian coal imports, according to customs documents and industry sources, avoiding the US dollar and cutting the risk of breaching Western sanctions against Moscow.

Reuters previously reported on a large Indian coal deal involving the Chinese yuan, but the customs data underline how non-dollar settlements are becoming

commonplace. India has aggressively stepped up purchases of Russian oil and coal since the war in Ukraine began, helping to cushion Moscow from the

effects of sanctions and allowing New Delhi to secure raw materials at discounts compared to supplies from other countries.

Russia became India's thirdlargest coal supplier in July, with imports rising by over a fifth compared with June to a record 2.06 million tonne

In June, Indian buyers paid for at least 742,000 tonne of Russian coal using currencies other than the US dollar, according to a summary of deals compiled by a trade source based in India using customs documents and shared with Reuters, equal to 44% of the 1.7 million of tonne of Russian imports that month.

Reuters was able to corroborate customs documents for four of the 11 vessels in the summary of Russian coal trades in June provided by the trade source, which showed payments made using the yuan, euro and the Emirati dirham, using shiptracking data and by speaking to a private customs agent based in India.

Another three vessels in the 11 deals in the trader's summary were paid for using the Hong Kong dollar and the vuan, two trade sources familiar with the transactions confirmed.

Karachi, August 10: Two Pakistani boxers have gone missing in Birmingham after the conclusion of the Commonwealth Games, the

national federation said Wednesday. Pakistan Boxing Federation (PBF) secretary Nasir Tang confirmed the news that boxers Suleman Baloch and Nazeerullah disappeared a couple of hours before the team's departure for Islamabad.

The Birmingham CWG ended Monday. "The travel documents including their passports are still with federation officials who accompanied the boxing team to the games," Tang said. He said the team management has informed the Pakistan High Commission in the UK and the relevant authorities in London about the disappearance of Suleman and Nazeerullah.

Tang said the documents of the missing boxers have been kept as per the standard operating procedure for all athletes who travel from Pakistan. The Pakistan Olympic Association (POA) has formed a four-member committee to investigate the matter of the missing boxers.

Pakistan failed to win any medal in the boxing competition of the Commonwealth Games where it ended up with eight medals, including two gold, won in weightlifting and javelin throw.

The incident came just two months after a national swimmer, Faizan Akbar also disappeared while competing in the FINA World Championships in Hungary.

Akbar, however, didn't even bother to compete in the championships and went missing with his passport and other documents just hours after reaching Budapest. — He could not be traced since June.

FIFA looks to start WC a day earlier

Geneva, August 10: The World Cup in Qatar could start one day earlier than scheduled with FIFA looking at a plan to let the host nation play Ecuador November 20, a person familiar with the proposal told this agency, Wednesday. The person said a decision could

be made within days by a committee comprised of FIFA president Gianni Infantino and the heads of the six continental soccer The proposal to create a 29-day

tournament instead of the longplanned 28 has been favored by Qatari officials and South American soccer body CONMEBOL, with talks also involving the Qatar and Ecuador soccer federations, the person said.

The World Cup is set to open November 21, a Monday, with the Netherlands facing Senegal at 1 pm local time in Doha. Qatar and Ecuador are also in Group A but that match was scheduled to start six hours later on the same day.

The match schedule — with the official opening ceremony at the third match when Qatar was scheduled to play — was finalised after the draw was made in Doha April

A Sunday start for the World Cup had been ruled out several years ago when a shorter, 28-day schedule requiring four games each day during the group stage was $\,$ agreed to by FIFA after talks with



influential leagues in Europe which will play club games through November 13.

However, a Qatar-Ecuador game involves few players who are with European clubs and would give the host nation an exclusive day to open its tournament. The opening ceremony could

now actually be before the opening game, at Al Bayt Stadium, and open up the early evening slot Monday for the Netherlands and Senegal.

The 2022 World Cup is the first in the tournament's 92-year history to be played outside of the traditional northern hemisphere summer. The previous 21 editions were all played between late-May and the end of July.

FIFA finalized a decision in 2015 to avoid the searing heat in Qatar's summer and move to November

and December, despite opposition from most of European soccer unhappy at shutting down their domestic leagues for several peak weeks.

The Nov 21-Dec 18 tournament schedule was agreed to so that European clubs could play on the Nov 12-13 weekend before releasing their players to the 32 World Cup teams.

The final will be played on a Sunday that is Qatar's National Day, allowing a full week for players to return to clubs before the Premier League plays its traditional Boxing Day games Dec 26.

Qatar bid to host in June-July promising innovative stadium cooling technology to overcome heat expected to reach 45 degrees Celsius (113 degrees Fahrenheit) during the first World Cup held in the Middle East.
