New Delhi, August 11: Union Rural Development and Panchayati Raj Minister Giriraj Singh said Thursday that there have been massive irregularities in the allotment of houses under the Pradhan Mantri Aawas Yojana-Gramin (PMAY-G) scheme in Odisha. Singh made the observation after a meeting with Union Minister Dharmendra Pradhan and Odisha

Panchayati Raj Minister Pradeep Amat here. Singh pointed out that a large number of beneficiaries of the scheme in Odisha have still not got

houses. He also pointed out that many cycloneaffected people were yet to be rehabilitated. It should be stated here

that Chief Minister Naveen Patnaik had earlier written to PM Narendra Modi seeking additional houses for Odisha under PMAY-G. In his letter, Patnaik had drawn the PM's attention to the woes of families of cyclone-affected

areas and tribal-dominated districts.

Singh laid down various conditions for the allotment of an extra eight lakh houses. He said that the houses allotted under PMAY-G shall have the logo of the central scheme only. The Union Minister also said that approval for the pending houses will be given only after CM Patnaik assures of transparency in the allotment of the houses and use of PMAY-G logo.

"I held a discussion with Minister Amat over various issues of PMAY-G. I told him there should be transparency, no corruption and compromise for the genuine beneficiaries to avail PMAY-G. He will inform CM Patnaik and I will take further action after receiving a letter from

the CM," Singh said after the meeting.

Amat said that the Odisha government is taking all possible steps to weed out corruption associated with the scheme. transparency, no For lapses found in implementation of PMAY-G scheme, the government has disengaged 22 officials, suspended 44 others and served show cause notices to 268 officials, he informed.

It should be stated here that Pradhan had requested Singh during a meeting August 5 to allow the Odisha government an opportunity to include the names of left out beneficiaries in the PMAY-G scheme

## **Uri revisited in Rajouri**

JeM Terrorists carry out suicide attack on Army camp killing 4 soldiers before being neutralised in the early morning skirmish

Jammu, August 11: It was Uri once more as two ter rorists carried out a suicide attack on an Army camp in Rajouri district in the early hours of Thursday, killing four soldiers. Later both attackers were gunned down in the four-hour shootout that followed. The development comes amid the Centre's claim that the maiority of the militants has been neutralised in Jammu and Kashmir

"In the early hours Thursday, alert sentries of the Indian Army post at Parghal, in Rajouri district detected suspicious persons approaching their post taking advantage of the inclement weather and dense foliage," PRO (defence) Jammu Lt Col Devender Anand said.

Anand informed that the sentries challenged the two terrorists who lobbed grenades while attempting to gain entry inside the post. However, alert troops cordoned off the area and engaged them in a gunfight and prevented them from entering the camp.

Anand informed that in the ensuing gunfight, the two terrorists were neutralised. Six soldiers of Indian Army were injured in the operation and of them, four bravehearts succumbed to injuries.

rorists attempted to breach the external fence of the camp located at Paragal, 185 kms from here. The gunfight ended four hours later.

The attack, which came four days ahead of Independence Day, marks the return of suicide attackers to Jammu and Kashmir after more than three years. The last such attack took place February 14,

2019 at Lethpora in Pulwama district of south Kashmir, in which 40

CRPF personnel were killed. In Thursday's attack, the two 'fidayeen', believed to be from the banned Jaish-e-Mohammed (JeM), tried to sneak into the camp but were neutralised, DGP Dilbag Singh informed.

JeM terrorists had earlier attempted to carry out a suicide attack April 22 here when Prime Minister Narendra Modi was scheduled to be in town. However, the two terrorists were killed in a chance encounter with the CISF near the Sunjwan Army camp. An officer of the paramilitary forces was also killed

It should also be stated here that Rajouri district has been the target of the terrorists for quite some time now. A number of blasts have been reported from the district in

## Bank official goes missing in Sonepur

Sonepur, August 11: An official of the Punjab National Bank (PNB) has gone missing since Wednesday evening here with the police stating Thursday that they were yet to get information about his whereabouts. The police are continuing the search, but have failed to trace Dibyaranjan Mishra, the agriculture manager of PNB at Barpali branch in Bargarh district.

Sources said that Mishra had gone to Binika locality in Sonepur district for bank-related work Wednesday. They informed that he had talked with his wife over

Mishra's family tried to locate him at Binika, but did not find him anywhere. Later, they got information that one motorcycle has been found near the Anga River bridge at Cherupali on Balangir-Sambalpur NH-26. They rushed to the site with the police and identified the two-wheeler and the helmet as those of Mishra's. They approached the police seeking assistance in search of the missing banker.

Following the complaint, the

Loisingha and Dunguripali police have initiated probe into the case.

Mishra's family has ruled out suicide stating that he was a man\_ who was always in control of his emotions. They have also stated that he did not have personal enmity with anyone. They alleged that some foul play is behind Mishra's mysterious disappearance

"My son had gone to Binika branch on official duty. He left the branch somewhere between 5.30pm and 6.00pm and has since been incommunicado. His mobile phone is switched off. We suspect something wrong may have happened to him," Mishra's father said Thursday.

## 4 dead in UP boat mishap, 17 missing

BANDA (UP): At least four people drowned and several others went missing Thursday when a boat capsized in the Yamuna in this district of Uttar Pradesh, police said. Dhankhar was declared elected Saturday as the Vice-President after he bagged 528votes against his rival candidate

United Nations, August 11: China has blocked a proposal by the US and India at the United Nations to blacklist Abdul Rauf Azhar, the brother of Jaish-e Mohammed (JeM) chief Masood Azhar and the deputy chief of the Pakistan-based terror group, in less than two months.

Beijing put a hold on the latest proposal a day after India's Permanent Representative to the UN Ambassador Ruchira Kamboj told a Security Council (UNSC) meeting chaired by China that the practice of placing holds and blocks on listing requests without giving any iustification must end and asserted that the credibility of the Sanctions regime was at an all-time low.

Abdul Rauf, born in 1974 in Pakistan, was sanctioned by the US in December 2010. He was the mastermind behind hijacking of the Indian Airlines Flight IC-814 in 1999

US and India to designate Abdul Rauf as a global terrorist and subject him to assets freeze, travel ban and arms embargo.

Makki is a US-designated terrorist and brother-in-law of Lashkar-e-Taiba (LeT) head and 26/11 mastermind Hafiz Saeed.

New Delhi and Washington had put a joint proposal to designate Makki as a global terrorist under the 1267 ISIL and Al Qaida Sanctions Committee of the UNSC but Beijing placed a hold on this proposal at the last minute here.

Meanwhile Indian government sources said Thursday in New Delhi that China's blocking of blacklisting of Abdul Rauf 'exposes its double speak and double standards in fighting terrorism'.

The sources said such 'politically motivated' actions by China, in nearly every listing case of a Pakistan-based terrorist, undermine the entire sanctity of the working methods of the UNSC Sanctions Committee.



## CM's 'politically significant' visit to Murmu's home dist

**VISIT RAIRANGPUR SOMETIME AFTER THE MONSOON**

Bhubaneswar, August 11: With the Bharativa Janata Party (BJP) leaving no stone unturned to gain political mileage from election of Droupadi Murmu as India's first tribal woman President, Chief Minister and ruling Biju Janata Dal (BJD) supremo Naveen Patnaik is set to visit Mayurbhanj, from where Murmu hails, Friday.

Patnaik Thursday approved a proposal of Rungta Metals Private Limited for setting up of an integrated steel plant at an investment of Rs 1,400 crore in Rairangpur sub-division of Mayurbhanj district, officials said.

Local people have been demanding a steel plant in Mayurbhani district for a long time.

During the visit, the BJD president is also scheduled to inaugurate two major irrigation projects which will benefit farmers of Mayurbhanj, Keonjhar and Balasore districts. He is likely to launch several other development

Patnaik's visit to Mayurbhanj is considered politically significant as the opposition BJP has already

The saffron party has activated its entire network to propagate that PM Narendra Modi

attempted to gain mileage out of the Presidential elections by putting up has sent a posters, banners tribal woman and hoardings from showing Murmu Mayurbhanj tying Rakhi on district to the hands of Raisina Hills

The BJD has

made 'Daughter of Odisha' Murmu's election as the President a major issue. The saffron party has activated its entire network to propagate that Prime Minister Narendra Modi has sent a tribal woman from Mayurbhanj district to Raisina Hills.

During his recent visit to Odisha, Union Home Minister Amit Shah met some tribal people and presented them with Tricolours and photos featuring Murmu and Modi. He also called upon party workers to ensure that the Tricolours and the photos reach 1 crore households in the state.

Speculations are also rife that Modi may visit Rairangpur sometime after the monsoon.

The BJD also attempted to gain mileage out of the Presidential elections by putting up posters, banners and hoardings showing Murmu tying Rakhi on the hands of the CM. Patnaik also campaigned for her before the election and urged all MLAs to vote for the NDA candidate.

The next Assembly and Lok Sabha elections are due in 2024. Patnaik's visit to Mayurbhanj is also considered part of his party's election strategy. Of the nine Assembly segments in Mayurbhani,

BJP in 2019 won six seats and also

the Mayurbhanj Lok Sabha seat. The BJP has won the Lok Sabha elections in 2019 in Mayurbhanj and Sundargarh. On the other hand, BJD emerged victorious in Keonjhar which is adjacent to Sundargarh. All three districts are

tribal-dominated. Though BJD has regained the ground as it won 56 of the 59 zilla parishad seats in Mayurbhanj district in the panchayat elections held in February this year, party sources said, Murmu's election as the President can tilt the balance again towards BJP.

## State to distribute flags free of cost

Bhubaneswar, August 11: As the country gears up to celebrate the 75th anniversary of its Independence, the state government has decided to distribute Tricolours free of cost among people, official sources said.

The state government, under its Mission Shakti department, has engaged self-help groups (SHGs) to make 30 lakh national flags, which were being distributed among common people, they said

The government had provided financial aid to the members of SHGs for making the flags.

More than 300 SHGs across 22 districts of the state were employed for stitching the flags, an official said, adding that distribution activities will be completed by August 13.

## City airport to become carbon neutral

Bhubaneswar; August 11: In a bid to transform the Biju Patnaik International Airport (BPIA) into a carbon-neutral airport, the authorities have decided to make a 3.8mega watt (MW) solar power plant operational and use only clean energy to run the facility.

As part of its plans to reduce carbon footprints, the City airport will use 2-MW electricity for its entire operation while the remaining 1.8 MW will be sold to

The BPIA will be among the four green airports in the country with Hyderabad, Cochin and Delhi being the others

Sources said though the solar power plant has been installed since 2018, it has not yet been made operational.

"Our motto is of green airport concept and carbon-neutral growth. We are among the best airports in the country including Varanasi, Thiruvananthapuram and Kolkata



airports. We have managed to reduce carbon emission and increase passenger footfall. We hope to make world-class infrastructure and provide best-in-class facilities to the passengers," said a BPIA official.

## HC orders ₹10 lakh aid for Keonjhar schoolgirl's death



Cuttack, August 11: The Orissa High Court Thursday directed the state government to pay Rs 10 lakh as compensation to the father of a 7-year-old girl for her "avoidable" death due to a wall collapse at a school in Keonjhar district nine

A division bench headed by Chief Justice S Muralidhar said the responsibility for the girl's death "definitely rests with the State" as the negligence of authorities by use of defective materials to construct a kitchen on the school premises had already been established during the inquiry.

Raimati Soren was staying in Kolhabeda Ashram School hostel in Ghasipura block, around 100 km from Cuttack. It was October 3, 2013 when a wall of a newly-con-

structed kitchen shed collapsed and the Class I student, who was brushing her teeth, was crushed under the debris.

Subsequent inquiries revealed that the wall was constructed illegally without proper foundation.

Bhubaneswar, August 11: Odisha police has arrested a Nigerian from New Delhi for allegedly cheating a Balasore man of Rs 30 lakh by honeytrapping him, police officials

said Thursday. The accused identified as Samson Emeke Alika has been arrested based on a case registered at cyber and economic offence police station. Balasore. Alika was staying in a rented accommodation in the national capital. A man had lodged a complaint before the cyber police April 13, 2022 regarding honey-

trapping and fraud transactions. According to the complaint, the Nigerian came in contact with the victim through Facebook by introducing himself as a young woman from London. Later, they exchanged texts through WhatsApp, said Meena Bindhani, the inspector-in-charge (IIC) of the police station. Then 'the woman' told the victim that she had sent costly gift items including gold biscuits, a Rolex watch and an iPhone for him, said Meena.

One day, a person who identified himself as a customs officer from New Delhi called the victim and asked him to give him custom charges to receive the gifts, she said.

Accordingly, the victim kept on spending lakhs of rupees to receive the gifts. He has transferred around Rs 30 lakh but did not get the gifts. Later, he realised that he was trapped and cheated by cyber

frauds, said the police inspector. The police said they have seized two mobile phones, one laptop, VISA from the arrested Nigerian man. The VISA of the accused has already expired in — 2018 while it seems that his passport is also not a real one.

## World's largest ice sheet melting faster than previously thought he eastern two thirds of Antarctica is covered by an ice sheet so large that if it

melted the sea would rise by 52 meters. Most scientists had once thought this ice sheet was largely invulnerable to climate change, but not any more

And new research, published in Nature, reveals the dire consequences if we were to awaken Antarctica's sleeping giant.

Almost 70 per cent of the Earth's fresh water is frozen in vast continental ice sheets that cover Greenland and Antarctica. Together, they store the equivalent of around 65 metres of sea level rise. Hence. even relatively small changes in the volume of these remote polar ice sheets will have a global impact.

An estimated one billion people live within 10 metres of sea level, including 230 million within one metre. Scientists measure changes in the volume of these ice sheets by estimating the mass input, mostly via snowfall, and the mass output, mostly melting snow and ice along with icebergs that break off and float away. The difference between input and output is known as the ice sheet's "mass balance" which is highly sensitive to climate change.

The most recent efforts to measure ice sheet mass balance paint a very worrying picture. The Greenland Ice Sheet, which contains around 7.4 metres of sea level rise, lost 3,900 billion tonnes of ice between 1992 and 2018, causing global sea level to increase by 11 mil-

limetres over this period. A similar story emerges from the western part of Antarctica, known as the West Antarctic Ice Sheet. It holds around 5.3 metres of sea level and lost more than 2.000 billion tonnes of ice between 1992 and 2017, adding around 6 mm to the sea level

Perhaps surprisingly, much less work has focused on the East Antarctic Ice Sheet, which is by far the world's largest but was thought to be a lot less vulnerable to global warming.

This is because large parts of the ice sheet have persisted through

"natural" climate changes across millions of years, and because recent measurements indicate that it has been in equilibrium or has maybe even gained mass (a warmer atmosphere can hold more moisture, which means more snow). In There is also evidence that parts of East Antarctica retreated quite dramatically during warm periods in the past, when carbon dioxide concentrations and atmospheric temperatures were only slightly higher than present

fact, the ice sheet may have even slightly reduced sea level rise over the past century. However, over the past two

decades or so, observations suggest that the East Antarctic Ice Sheet may be far more sensitive to

climate warming than previously thought.

Major outlet glaciers like the Totten and Vanderford are thinning and retreating. And there are clear signals of mass loss in Wilkes Land, the ice sheet's "weak underbelly", so-called because it rests on "land" that lies well below sea-level

and so is particularly unstable. There is also evidence that parts of East Antarctica retreated quite dramatically during warm periods in the past, when carbon dioxide concentrations and atmospheric temperatures were only slightly

higher than present. It is likely that East Antarctica contributed several metres to global sea level during the mid-Pliocene warm period, around 3 million years ago, with ice loss concentrated in Wilkes Land. Recent work has also suggested that ice in Wilkes Land retreated 700 km inland from its present position around 400,000 years ago, when global temperatures were only 1 or 2 degrees Celsius higher than present.

A key lesson from the past, there-

fore, is that the East Antarctic Ice Sheet is highly sensitive to relatively modest warming, even if it is currently stable.

So what will actually happen over the next few decades and centuries? Research found the ice sheet will probably remain broadly in balance in the short-term, because any mass loss due to global warming will be offset by increased snowfall.

Although there are large uncertainties, researchers concluded that the ice sheet will only raise the sea level by about 2cm by the year 2100, which is much less than the contribution projected from melting ice in Greenland or West Antarctica.

Over the next few centuries, however, the sea-level contribution from East Antarctica will depend critically on whether we manage to curb our emissions. If warming continues beyond 2100, sustained by high emissions, then East Antarctica could contribute around 1 to 3 metres by 2300 and around 2 to 5 metres by 2500. PTI

## **Curbing Speculation**


rimary commodity prices have been on a roller-coaster ride for the past year, and especially for the past six months. In the futures markets, crude oil prices rose by 39% in the month from February 8 to March 8, 2022, from \$89 per barrel to \$124 per barrel, and then fell by 23% in the following month to \$95 per barrel. The price climbed again, to \$122 per barrel, June 8, but had declined to \$88 per barrel August 4 - below the level of early February

Global prices of wheat futures have exhibited similar volatility. The price of soft red winter wheat soared from \$332 per metric ton in January to \$672 per ton in April, but by June had fallen to \$380 – still about 50% higher than a year ago, but well below this spring's crazy peaks.

These dramatic price movements were not triggered by changes in real output and demand. Blaming big commodity-price spikes on supply shortages caused by Russia's war in Ukraine does not capture the full truth. In particular, the large increases in Big Oil and agribusiness firms' profit margins indicate that they raised prices of energy and food, respectively, well beyond any level that could be justified by their own cost increases. But frantic speculative activity, mainly by financial companies like hedge funds that dominate trading, has made matters much worse, as I have noted elsewhere.

For example, a study by Kabir Agarwal, Thin Lei Win, and Margot Gibbs found that investment funds have been hyperactive in the Paris wheat market. These funds' share of long positions in wheat futures increased from 23% in May 2018 to as much as 72% in April 2022, and remained above 50% in May 2022. Another recent study found that trading volumes at the European Union natural gas market's primary gas-pricing hub, the Title Transfer Facility, increased steadily over the past decade from 14 times actual gas consumption in 2011 to more than 114 times in 2020

The chaos that such speculation can cause was evident in March this year, when a dramatic spike in nickel prices forced the London Metal Exchange to suspend trading and cancel all deals. Over-the-counter (OTC) trades that occur outside the regulated exchange were held partly responsible, and the LME will now require all traders to report their OTC positions on all physically delivered metals each week. But prices in other commodity derivatives markets remain highly volatile, as hedge funds and other financial firms rush out as rapidly as they piled in. This matters hugely because food, fuel, and basic metals are essential for production and for life itself. Commodityprice volatility affects living standards and the ability to produce goods and services, and is contributing to the stagflation and hunger now stalking most low- and middle-income countries. Some stabilisation and regulation of these prices is therefore essential - and

not only to curb inflation. So, why are these swings allowed to occur? Policymakers obviously are aware of the implications of frenetic financial activity in markets for essential commodities. Something similar happened in 2007-09, when oil and food prices first rose sharply and then declined to earlier levels in the space of 18 months, causing economic devastation. After that experience and in the aftermath of the 2008 global financial crisis, both the  $\tilde{\text{U}}$ nited States (through the Dodd-Frank Act) and the EU sought to regulate commodity derivatives

Ideally, the regulations should have prevented speculation by ensuring that all trading occurs on regulated exchanges, not on an OTC basis, and in a transparent manner with full information about the actual players and their bids. Furthermore, exchanges should allow only those with a direct operational interest in commodities to trade them. (For example, an airline company should be permitted to operate in the futures market for aviation fuel. but a hedge fund should not.) And market participants should adhere to limits on the positions that they can hold, depending on their real use, need, or production of that commodity.

The US and EU regulations matter most, because these markets largely determine global commodity prices. But the earlier regulatory changes did not go far enough, and have since been watered down.

Existing EU rules help to prevent market abuse on official exchanges by limiting individual traders' positions, but they still allow OTC commodity trading, enabling excessive speculation to continue. The US prohibits OTC trading in most commodities, but financial agents can still enter the market through proxies. And position limits have been kept so high that they do not prevent large bids from influencing prices.

As a result, financial speculation in essential commodities can still play havoc with people's lives and livelihoods. Fortunately, there are signs that regulators are taking notice. At a recent G20 meeting in Indonesia, Klaas Knot, the chair of the Financial Stability Board (a grouping of central bankers, finance ministers, and regulators from G20 countries) called for close monitoring of speculative activity. "The centrality of key energy, metals, and food commodities to the functioning of the global economy," Knot said, "means that any disruptions to the financing of producers or traders in these markets could have an outsized impact." But mere monitoring will not be enough. The regulatory measures needed to restrict commodity-market speculation are obvious, so the lack of prompt action is striking. It suggests that regulators and policymakers are still putting financial interests above everything else, regardless of the cost

lections in India turn into festivity for citizens across the country, wherever cam-/ paigning by political parties takes place. Indian media characterises activities around elections as the 'dance of democracy'. This is perhaps in order as India is known globally for sustaining her democratic politics despite many challenges in other sectors - social, economic, developmental. Since the Arab Spring protests in December 2010 that heralded a wave of transitions to democracy across the Middle-East, several dictatorial regimes were pulled down. Tunisia has been the epi centre of the Arab Spring, which is also called the Jasmine Revolution.

The origin of the Arab Spring could be traced to an incident in Tunisia when a fruit vendor was harassed by the city government officials. The poor fruit vendor, a 27-year old, had borrowed money to set up his stall and was completely unable to pay the extortion money (bribe) demanded by the officials. In exasperation, he set himself on fire 17 December 2010 in Ben Arous, Tunisia, which became a catalyst for the Tunisian Revolution and the wider Arab Spring against dictatorial regimes across the region.

In Tunisia itself, the protests led to the fall of the 23-year regime of Zine El Abidine Ben Ali. Ben Ali ruling since 1987 had to flee the country in the mass uprising. In fact, Tunisia was the only country that experienced a successful transition from dictatorship to democracy. The protests had spread like forest fire to other Arab countries -Egypt, Libya, Bahrain, Yemen and Syria. The other notable casualty of the revolution was the fall of the 30-year-long dictatorship of Hosni Mubarak in Egypt although the revolution did not sustain long in that country. Two years later, in 2013, the military seized power by toppling the elected government of President Mohammed Morsi, the leader of a party called Muslim

Brotherhood. In other Arab countries that were engulfed by the flames of the Arab Spring, the protest resulted in various unanticipated outcomes. Libya slipped into a civil war, saw the fall of Gaddafi regime, and later chaos and confusion continued to haunt the country. In Bahrain, the protest was crushed by the troops sent by Saudi Arabia in support of the Sunni monarchy that ruled over the Shia majority. In Yemen, following the resignation of the President Ali Abdullah Saleh, the Shia Houthi rebels took over: But the country has been under attack by Saudis. In Syria, protests turned into a proxy civil war with President Bashar al-Assad and his opponents backed by their respective international supporters.

Back to Tunisia, the 2014 constitution, emerging out of political churning, in the wake of Jasmine Revolution, provided for sharing of power between the President and the Prime Minister who is to be backed by the majority in the Parliament. Both the President and Parliament were to be directly elected by the people. However, the election of the Islamist Ennahda Party upset the

progressive and secular forces. The politics remained divided. The country had as many as nine governments between 2011 and 2021. The economy was in a bad shape, made worse by COVID-19 pandemic which caused one of the highest per capita global death rates in Tunisia. In the face of such economic and healthcare crises, people rose in revolt again in July last year.

In order to quell the unrest, President of Tunisia, Kais Saied sacked the PM Hichem Mechich and suspended Parliament, plunging Tunisia into a constitutional crisis. International observers suggest that the unchecked Presidential powers would return Tunisia to an autocratic constitutional order. However, the indications coming from Tunisia point to the President on a slippery slope as he receives scanty support from the public.

The current challenge in Tunisia in consolidating its democratic gains after the revolution, gives the scope for a deeper diplomatic interaction with India which is, internationally, especially in the South of the world, known for its strong democratic credentials. In addition to usual trade and com-

merce, political collaboration in mutual interest among the countries is also in order. The internationally accepted premise is that political developments within a country fall under the concepts of 'national sovereignty' and 'right to self-determination'. A country and its people may need those political inputs and support from another country in order to build and enhance progressive political institutions and practices.

India has maintained cordial and friendly relations with Tunisia since establishment of diplomatic contact in 1958. Tunisian leaders have expressed appreciation for India's democracy and its founders such as Mahatma Gandhi and have acknowledged the experience of India's freedom struggle as an inspiration for their country Several high-level visits have taken place since then. Even in the postrevolution Tunisia, visits at high level from both countries have taken place. Mechanisms for bilateral consultations exist between the two countries. They are mainly Foreign Office Consultations, Joint Commissions and Joint Working Groups. India and Tunisia also have considerable bilateral trade, India accounting for around 50% of Tunisia's global phosphoric acid exports. Quite a few Indian companies are active there. Export potential to Tunisia is growing in sectors like pharmaceuticals, ve hicles, renewable energy, software and services. There is a considerable exchange in the field of culture. Indian artists have performed in Tunisia and artisans from Tunisia have participated in trade fairs in India. International Day of Yoga has been celebrated in Tunis. To conclude, India needs to deepen its political contacts with Tunisia, the only country which has tried to embrace the spirit of Arab Spring and has been building the democratic edifice.

## Ignored and excluded from statistics

entation?" In Brazil, where queer people excluded from official statistics, this question holds special significance for the LGBTQ+ community.

Brazil recently took a small step toward positive change when the country's national statistics agency, IBGE, published its latest National Health Survey, which for the first time included questions about sexual orientation. According to the survey, based on data collected in 2019, around 2.9 million Brazilians identify as homosexual or bisexual.

Despite this encouraging development, the IBGE still refuses to include questions about sexual orientation and gender identity in Brazil's national census. In June, a federal court rejected an effort by the Public Prosecutor's Office to force the agency to incorporate these questions. Many leading economies have already done so. Canada's 2021 census asked respondents what their gender identity is and what sex they were assigned at birth. The UK's latest census included a voluntary question on sexual orientation. Australia's recent census offered the option of identifying as male, female, or nonbinary. And the United States Census Bureau is still researching which questions to ask and how to ask them.

But ignoring or excluding the LGBTQ+ community remains the norm in many developing coun-

That is your sexual oritries. According to Kenyan doctor and human-rights activist Stellah Wairimu Bosire, censuses are an imhave historically been ignored and portant tool in government planning, and excluding the queer community means that policies targeting employment, health, and homelessness do not consider the specific needs of LGBTQ+ people. A 2019 report by the Arcus Foundation on violence against LGBTQ+ people in five African countries found that accurate data can also help LGBTQfocused NGOs better target interventions, evaluate their impact and improve advocacy efforts.

In the absence of official statistics, some civil-society organisations have built their own datasets. Brazil, for example, is the world leader in recorded murders of LGBTQ+ people. We know this because a trans-rights group, ANTRA, documented the numbers, names, and stories of the 140 trans people murdered in the country in 2021. Trans-rights groups in other parts of the world, including Letra Ese in Mexico, Helem in Lebanon, and TGEU in Europe, have been doing similar work.

Almost every day, queer researchers send me requests to complete surveys, take part in interviews, or fill out forms. While this research sheds light on our shared experiences, very little of it reaches national audiences, and almost none comes from governments. The lack of official data renders me and my community invisible. It makes it extremely difficult to promote our interests and protect our rights, thereby denying us the fundamental rights of citizenship.

This is no accident or oversight. of LGBTQ+ activists. his book Queer Data. Kevin Guvan notes that decisions about what to ask in official surveys reflect the surveyors' views. If statisticians and politicians don't see LGBTQ-phobia as a problem, or wish to suppress our community's demands, why would they include relevant questions in the census? And so trans people remain invisible, and homophobic violence, exclusion, and poverty are allowed to persist.

Even when official surveys include questions on gender identity and lived experiences, the numbers are likely underreported, owing largely to a lack of trust. Many members of the LGBTQ+ community do not feel safe sharing details about their life with government agencies After all Brazil's dismal failure to protect trans people's lives speaks for itself, and USbased studies consistently find that sexual and gender minorities experience disproportionately higher levels of violence.

Moreover, such violence is often a handmaiden of fascism. In Nazi Germany, the authorities created "pink lists" of individuals charged with the then-crime of being homosexual. Many were sent to concentration camps. The law banning homosexuality remained on the statute books in West Germany

until 1994 and was used to prosecute some 100,000 people. More recently, Russian troops in Ukraine have reportedly been circulating a list

Regardless of how no spond to questions about sexual orientation and gender identity merely asking them is an affirmation. It makes people feel seen, normalises gender diversity, and brings us closer to full citizenship rights. In Brazil, the IBGE blamed budget cuts for its refusal to include LGBTQ-related questions in the 2022 census, claiming that their inclusion would cause delays. The judiciary has accepted these largely bureaucratic arguments, ignoring the struggles, pains, and experiences of the queer community in the name of pragmatism. Brazil is just one front in a global battle for inclusion. Recently, the World Bank published a cross-national analysis of laws affecting LGBTQ+

Politicians must understand that any national census or survey that does not include the LGBTQ+ community will not accurately represent their citizenry. Another decade without data would mean another decade without adequate policies, perpetuating the historical injustices that have kept our community poor, vulnerable, and forgotten.

## 100% samples found Cov +ve in Mumbai

Mumbai: All 230 swab samples collected from Mumbai in June-July were found to have been infected by Omicron sub-variants of coronavirus, the Brihanmumbai Municipal Corporation (BMC) said Thursday. Of the 230 patients whose samples were tested, 74 persons had not taken even a single dose of vaccines against COVID-19, and 19 of them were admitted to hospitals, the civic body said in a release. Three of these patients ended up in ICU, it said.

## Nitish emerges challenger to Modi-Shah

Patna, August 11: At a time when the duo of Narendra Modi and Amit Shah are dictating terms, Bihar Chief Minister Nitish Kumar not only challenged but also sent a message to the BJP and the RSS about his political daring without caring about the CBI, ED and the Income-Tax department.

Nitish Kumar, a socialist leader of Bihar, was elected as the chief minister for the eighth time. Kumar, a product of the political school of Karpoori Thakur and Jayaprakash Narayan was influenced by the socialist ideology of these two great leaders of Bihar.

Nitish Kumar was elected an MLA from Harnaut assembly constituency in Nalanda district in

In 1989, he contested the Lok Sabha election from Barh constituency in Patna district and won the seat. He was in the VP Singh government and served as union minister of state for agriculture and cooperatives.

VP Singh had implemented the Mandal commission report in the country and the BJP which had 88 MPs had withdrawn its support

to Singh. At that time, the Mandal Vs Kamandal politics was going on and BJP leader LK Advani

Lalu Prasad Yadav had emerged as the social justice leader of Bihar with his strong vote bank of the Yadav and Muslim communities. He gave strength to the backward, extremely backward, marginalised communities of Bihar and became the strongest leader in Bihar. He became chief minister in 1990 for the first time with the Janata Dal.

Nitish Kumar was again elected to the Lok Sabha in 1996 with the Samata Party from Barh and George Fernandes won the seat from Nalanda.

In 2013, when the BJP nominated Narendra Modi as the prime ministerial candidate of the NDA, Nitish Kumar objected to it and came out of the NDA.

During the Modi wave in 2014, the JD-U fared badly in the Lok Sabha elections. Nitish Kumar took the responsibility for it and resigned as chief minister. Jitan Ram Manjhi became the CM.

Nitish Kumar took over as chief minister again from Jitan Ram Manihi in November 2014 and formed an alliance with Lalu Prasad Yadav's RJD. They made the Mahagathbandhan and also included the Congress party. They

won the 2015 assembly election on the formula of 100: 100 seats to the RJD and the JD-U and 43 seats to the Congress.

Lalu Prasad, in 2015 announced that Nitish Kumar will be the chief minister's face of the Mahagathbandhan. When the election results came in, the RJD won 80 seats, the JD-U 73 and the Congress 29. They managed to stop the BJP at 53 seats in Bihar despite a strong Modi wave. The RJD, despite having more seats than the JD-U, made Nitish Kumar the chief minister of Bihar.

Apart from Lalu Prasad, the other RJD leaders thought that the chief minister's post should come to the RJD, and they started targeting Nitish Kumar. A war of words started between the RJD and the JD-U. Nitish Kumar, who has one of the sharpest political brains. started looking for an opportunity and he picked on the corruption charges against Tejashwi Yadav in the IRCTC scam as an ideal excuse for him to come out. from the Mahagathbandhan. Though Lalan Singh, the national president of the JD-U, clarified during a press meet on August 10, 2022 that there were four leaders including Sanjay Jha, Harivansh, RCP Singh and another leader who gave him wrong advice to break the alliance with the RJD and the Congress and ioin the NDA.

Nitish Kumar joined the NDA in 2017 and formed the government with the help of 53 MLAs of the BJP in Bihar. In the 2020 assembly election, Nitish Kumar contested under the umbrella of the NDA and became the chief minister of Bihar for the 7th time. After the result of the election, JD-U leaders accused the BJP of backstabbing their party.

When Nitish Kumar resigned from the post of Chief Mminister August 9, he said: "I was not interested in holding the post of chief minister after the 2020 assembly election. They insisted on me. Today's BJP has a different ideology then the BJP of Atal Ji and Advani Ji.'

"The way BJP was trying to sabotage our party, we have discussed aspects with our MPs. MLAs and MLCs and every one suggested that I come out from the NDA. We have listened to their voices and resigned from the post of Chief Minister," Kumar said.

## 3 girls kidnapped, raped in Delhi

New Delhi, August 11: Three girls were allegedly kidnapped and raped after giving them beverages laced with sedatives in Rohini here, police said Thursday.

Four people, including two women, have been arrested in connection with this case, they said. The Delhi Commission of Women has sought from the police a detailed action taken report in the matter, latest by August 14.

On August 6, a resident of Masjid Moth had approached the Defence Colony police station alleging that his daughter had left for school in Andrews Ganj at around 7.30 am but did not return.

Police also found that she was absent from school. Deputy Commissioner of Police (South) Benita Mary Jaiker said the police found that not only the complainant's daughter but two other girls from the school, too, had gone missing. "During investigation, parents and classmates of all missing girls were questioned. CCTV footage of the area was checked. Meanwhile, information was received about their movement in Karol Bagh area from where they were traced and medically examined. All the prosecutrix gave history of sexual assault," she said.

## Accused can't be convicted based on suspicion, says SC



New Delhi, August 11: An accused cannot be convicted on the ground of suspicion, no matter how strong it is, the Supreme Court said on Thursday, while acquitting a man in a murder case.

A bench of Justices B R Gavai and P S Narasimha said an accused is presumed to be innocent unless proved guilty beyond a reasonable doubt. "It is settled law that the suspicion, however strong it may be, cannot take the place of proof beyond reasonable doubt. An accused cannot be convicted on the ground of suspicion, no matter how strong it is," the bench said. The apex court said in the present case, the prosecution has utterly failed to establish the chain of events which can be said to exclusively lead to the one and only conclusion, i.e., the guilt of the accused. "In that view of the matter, we find that the judgment and order of the learned sessions judge and that of the high court are not sustainable," the bench said.

The top court was hearing an

appeal filed by a man challenging an order passed by the High Court of Punjab & Haryana convicting him for the offences punishable under Section 302 (murder) and Section 201 (causing disappearance of evidence of the Indian Penal Code, 1860, and sentencing him to rigorous imprisonment for life. Advocate Rishi Malhotra, appearing for the man, submitted that from the perusal of the postmortem report, it is clear that it is not proved beyond reasonable doubt that the dead body on which the postmortem was conducted was of deceased

The additional advocate general for the state on the contrary, submitted that the high court and trial court have concurrently found the accused to be guilty of the offences charged with. The top court said there has to be a chain of evidence to complete so as not to leave any reasonable ground for a conclusion consistent with the innocence of the accused and must show that in all human probability the act must have been done by the accused.

## Dhankhar sworn in as India's 14th V-P

New Delhi, August 11: Jagdeep Dhankhar was Thursday sworn in as the 14th Vice President of India. President Droupadi Murmu administered the oath to Dhankhar (71) during a brief ceremony at the Rashtrapati Bhavan.

Dhankhar took the oath in Hindi in the name of god. "Bahut-bahut badhai (many congratulations),' Murmu said after Dhankhar signed the register of oath. Before the swearing-in, the Election Commission's certification of election issued to Dhankhar was read out. Prime Minister Narendra Modi, Dhankhar's predecessor M Venkaiah Naidu, former president Ram Nath Kovind, former vice president M Hamid Ansari, and Union ministers Rajnath Singh, Amit Shah, Nirmala Sitharaman



and Nitin Gadkari were among the dignitaries present on the occasion. In the morning, Dhankhar paid tributes at Raj Ghat, the memorial of Mahatma Gandhi. "Felt blessed, inspired and motivated to be ever in service of Bharat in serene sublimity of Raj Ghat while paying respects to pujya Bapu," he

tweeted then. Once a "reluctant politician", Dhankhar's reemergence in the political scene in 2019 as West Bengal governor surprised many, so has his rise to the office of the Vice President of India. Dhankhar was declared elected

as the Vice President on Saturday after he bagged 528 votes against his

rival candidate Margaret Alva's 182. A man of many interests, his long legal career at the Rajasthan High Court and the Supreme Court and a brief stint as the junior parliamentary affairs minister at the Centre will come in handy as he presides over Rajya Sabha as its chairman. Dhankhar, who had been associated with the Janata Dal and the Congress, joined the BJP only in 2008 after a hiatus of nearly a decade. He has championed issues related to Other Backward Classes. including the grant of OBC status to the Jat community in Rajasthan.

While his surprise appointment as the West Bengal governor in 2019 brought him back to the political limelight, he did not shy away from the hurly-burly of politics and was caught in frequent runins with the state's ruling\_ Trinamool Congress.

## Are kids, pregnant women more at risk?

New Delhi, August 11: Scientific literature is limited to prove high absolute risk of monkeypox in children and pregnant women, experts contended Wednesday.

Amid the scare of global monkeypox outbreak that has so far spread to more than 80 countries and infected nearly 30,000 people. an article published in the esteemed medical journal The Lancet Child & Adolescent Health' claimed that children and pregnant women are more at risk of the infectious disease

"The absolute risk of getting monkeypox in kids or pregnant women may not be higher in comparison to other vulnerable groups," Dipu T.S., Associate Professor, Division of Infectious Diseases, Amrita Hospital, Kochi, told IANS. "Though the literature is limited, there are still case series which have defined foetal loss among the pregnant women, including stillbirth," he said, adding, "In the case of pregnant women, the worrying factor is not just the



severity of the disease, but the ef-

fect on the foetus." The Lancet article written by researchers from universities of Lausanne in Switzerland, California in the US, and the National University Hospital in Singapore, said that compared to healthy adults, complications are more frequent in children, and more severe in pregnant women than in healthy individuals who are not pregnant.

It said previous monkeypox outbreaks had reported increased mortality and hospitalisation rates in children, even in high-income countries such as the US, in which the only two severe presentations during the 2003 outbreak were observed in the paediatric population.

Further, the paper claimed that while information regarding the effects of monkeypox in pregnant



## Staggering surge in Delhi Cov cases, deaths

New Delhi, August 11: More than 19,760 Covid-19 cases have been recorded in Delhi from August 1-10, as per official data shared by the city health department.

Besides, there has been a nearly 50 per cent rise in the number of containment zones in the city during this period

On August 1, the National Capital had logged 822 cases with a positivity rate of 11.41 per cent and two deaths.

The figures increased significantly in the next few days amid a surge in coronavirus cases in the city in the last several weeks.

With Covid cases and the positivity rate rising in Delhi, the district officials have started forming teams to strictly enforce the mask mandate and issue a fine of Rs 500 to violators, officials said. The district magistrates have been instructed to ensure that the laxity that had set in due to reduction in cases is corrected and wearing masks in public places is strictly enforced, a senior Revenue department officer said. The Delhi Disaster Management Authority (DDMA) has noted that the positivity rate of Covid-19 infection has increased in Delhi over the past fortnight, according to an order issued by the South Delhi district. The fine will not be applicable to persons travelling together in private four-wheelers, it said. Earlier this week, Chief Minister Arvind Kejriwal said that the government was keeping a close watch on the situation and would take all the steps needed. He, however, said that despite the rise in Covid cases there was no cause for panic as most new infections were mild in nature.

Delhi Wednesday reported eight fatalities due to coronavirus, the highest in nearly 180 days, and 2,146 new cases with a positivity rate of 17.83 per cent. The active cases stood at 8,205, according to data shared by the health department.

The National Capital had February 13 reported 12 deaths due to the viral disease.

On August 9, Delhi reported 2,495 coronavirus cases with a positivity rate of 15.41 per cent and seven fatalities, while the number of active cases stood at 8,506.

The National Capital saw 1,372 infections and six deaths August 8 with a positivity rate of 17.85 per cent, the highest since January 21, as per the data. On January 21, the positivity rate had stood at 18.04 per cent.

The number of active cases Monday stood at 7,484 while the count was 4, 274 August 1.

The total number of cases recorded during the August 1-10 period stands at 19,769.

Delhi has recorded 40 deaths due to Covid-19 in this 10-day period, nearly thrice the cumulative figures registered in the last 10 days of July when 14 people had succumbed to the viral disease, according to official data.

In Delhi, nearly all metrics such as home isolation cases, containment zones, positivity rate and active cases, used in the monitoring of the spread of coronavirus have shown a rising trend in the first 10 days of August. The number of containment zones August 1 had stood at 173, which gradually increased to 259 August 10.

As many as 5,549 patients are in home isolation as August 10. The corresponding figure August 1 was 3,161.

Delhi's tally of Covid-19 cases Wednesday had increased to 19,75,540, while the death toll rose to 26,351, as per the health bulletin issued August 10.

The number of daily Covid-19 cases in the city had touched the record high of 28,867 January 13 this year during the third wave of the pandemic.

It had recorded a positivity rate of 30.6 per cent January 14, the highest during the third wave of the pandemic.

## Skeletons peep out of Shinde's mini-Cabinet

75% ministers face criminal cases

Mumbai, August 11: The 18-member 'mini-cabinet' expansion of Chief Minister Eknath Shinde and Bharatiya Janata Party's Deputy CM Devendra Fadnavis have thrown up many facts, including 75 per cent of the total 20 'crorepati' ministers have criminal cases lodged against them.

According to a study conducted by the Association for Democratic Reforms (ADR), a total of 15 ministers have declared criminal cases, including seven from the Shinde Group Shiv Sena and eight from the BJP, in the 'gents only Cabinet'.

Of these, 65 per cent - or 13 ministers - including seven from Shinde Group and six from the BJP have serious criminal cases filed against them.

Of the 20 crorepatis, BJP's Mangal Prabhat Lodha, a reputed builder, is the richest among the ministers with assets worth Rs 441.65 crore and liabilities of Rs 283.36 crore.

Though a 'crorepati', the poorest in the lot is also BJP's Sandipanrao A Bhumre with as-

sets of Rs 2.92 crore in his name.
The average assets of the ministers' whose poll affidavits were analysed by ADR comes to Rs 47 crore - comprising the BJP's Rs 58 crore and Shinde Group's Rs 36

On the academic front, two ministers (or 10 per cent) have declared their educational track record as SSC pass, six (30 per cent) as HSC pass, 11 ministers (55 per cent) are higher qualified with degrees, and only one Dr Suresh Khade of the BJP holds a doctorate from a university in Sri Lanka.

As far as the age group is concerned, 16 ministers (80 per cent) fall in the upper echelons aged between 51-70, and four (20 per cent) are between 41-50, said the ADR's Maharashtra Election Watch, coordinated by Ajit Ranade, Sharad Kumar and Satish Khot.

CM Shinde carried out his muchawaited Cabinet expansion Tuesday, inducting 18 ministers, including three allegedly 'tainted'. No women MLA could find a place in the cabinet and so could not the Independents and smaller parties.

## No takers for Mumbai's Jinnah House

Mumbai, August 11: Mumbai's famed landmark - the Jinnah House Malabar Hill - which was once the hub of brainstorming sessions over the contentious Partition of India remains a charming orphan since the past 75 years.

Top leaders of the All India Muslim League (AIML) used to converge here frequently to strategise and push forth the much abhorred 'two-nation theory', first propounded by Choudhry Rehmat Ali in 1933, when he was studying law at the University of Cambridge.

After returning from Great Britain to take over the reins of AIML, Jinnah built his beloved European-style house in south Mumbai in 1936, at a staggering cost of Rs 200,000.

Though he owned another bungalow in Delhi, it was the Bombay home where he spent over 10 years be-



fore leaving India to take charge of the new nation named Pakistan in 1947. Before Jinnah left for the new

Before Jinnah left for the new country where he was subsequently revered as 'Founder of Pakistan, Quaid-E-Azam or Father of the Nation', he had expressed his desire to come and live at Jinnah House sometime.

But it was never to happen as he passed away in September 1948 – barely eight months after India's Father of the Nation Mahatma Gandhi was assassinated in January 1948. Sprawled over 2.5 acres of a seafacing green oasis, the Jinnah House was designed by Claude Batley, using Italian marble, walnut woodwork by foreign artisans. Jinnah had supervised its construction 'brick-by-brick' as it bloomed into an awesome mansion with pointed arches, impressive columns, sleek flooring and a luscious garden outside.

Extremely fond of his beautiful abode, Jinnah after Partition even requested Prime Minister Nehru to take care of his home, allot it to any foreign consulate, or to a European family or some refined Indian royalty for a monthly rental of Rs 3,000.

Honouring his wish, Nehru agreed to the proposal but Jinnah died before any rental deal could be finalised. As a special gesture, the house was not declared or seized as 'Enemy Property' like many others at that time.

India at one point of time even wanted to hand it over to the Pakistani Consulate in Bombay before it was rented out as the residencecum-office of the British Deputy High Commissioner from 1955-1983.

For the next 20 years, the house was abandoned and in 2003, a part of it was handed to the Indian Council for Cultural Relations (ICCR) for its activities, though Pakistan kept demanding it for its Consulate, or even as the headquarters of Pakistan International Airlines, while activists wanted it for a Pakistan-India friendship centre.

In 2021, the BJP's Mumbai unit urged the Centre to convert Jinnah House into 'South Asia Centre for Arts & Culture (SACAC)', but there has been no decision yet.

Till the Centre decides on its fate, the enchanting Jinnah House remains a bewitching orphan of history, blatantly ignored while basking in the limelight.

## A quarter in Mumbai, 6% in Delhi originate in their landfills: Study

New Delhi, August 11: More than a quarter of methane emission in Mumbai and six per cent of the planet-warming gas in Delhi originates from landfills, according to a study that used satellite data from four major cities worldwide.

The research, published in the journal Science Advances Wednesday, used satellite data from Delhi and Mumbai in India, Lahore in Pakistan and Buenos Aires in Argentina.

The researchers from the Netherlands Institute for Space Research, Leiden, found that emissions from landfills in 2018 and 2019 were 1.4 to 2.6 times higher than earlier estimates.

"In Buenos Aires and Mumbai, the individual landfills account for more than a quarter of total urban emissions," the authors of the study said.

For Delhi and Lahore, the figure was 6 per cent and 13 per cent re-

spectively, they noted.

The finding may help officials to carry out targeted efforts to limit global warming by pinpointing

hot spots of major concern.

The researchers noted that emis-

sions from the oil and gas sector have received considerable attention, but there are also major opportunities for emission mitigation in the waste sector, which accounts for roughly 18 per cent of global human-caused emissions.

Solid waste emissions are caused by the decay of organic material in landfills, they said.

The researchers leveraged the synergy between satellite instruments with different spatiotemporal coverage and resolution to detect and quantify emissions from individual landfills.

They used the global surveying Tropospheric Monitoring Instrument (TROPOMI) to identify large emission hot spots and then zoom in with high-resolution target-mode observations from the GHGSat instrument suite to identify the responsible facilities and characterise their emissions.

"Using TROPOMI data... We find that city-level emissions are 1.4 to 2.6 times larger than reported in commonly used emission inventories and that the landfills contribute 6 to 50 per cent of those emissions," the authors of the

study said.
"Our work demonstrates how complementary satellites enable global detection, identification, and monitoring of methane superemitters at the facility level," they said.

## DU plans courses on art of being happy, emotional intelligence this academic yr

New Delhi, August 11: The Delhi University will start value-addition courses on topics like emotional intelligence, the art of being happy and Indian fiction from the 2022-23 academic year as part of the Undergraduate Curriculum

Framework-2022 (UGCF).
A resolution to introduce 24 similar courses aimed at developing critical thinking has been approved in a recently held DU academic council meeting. Now the matter will be presented to the highest decision-making body of the university, its executive council.

Students can take one or more such value-addition courses per semester.

Some of these courses are Emotional Intelligence, Art of Being Happy, Financial Literary and Ethics, Vedic Mathematics and Value of Indian Tradition System. These courses have been prepared by the value addition course committee headed by

Professor Niranjan Kumar.
The value addition courses have been designed keeping in mind the National Education Policy 2022.
They have various components like critical thinking, compassion, teamwork, scientific temperament, Indian knowledge systems, ethi-

cal, cultural and constitutional values, and creative writing, Kumar told PTI.

This is the first time a prestigious university like the DU has introduced such courses. They will act as a game-changer in terms of social-building, he added.

Credits gained through these courses will be added to the student's Academic Bank of Credits.

Academic Bank of Credits.

Among the courses are those inspired by prominent campaigns initiated by Prime Minister

Narendra Modi such as Fit India and Swacch Bharat.

Under the Art of Being Happy, students will be taught ways to cope with stress, the physiological and hormonal basis of happiness, factors of happiness and interpersonal relationship towards self-actualisation. It will be a two-prodit gourse.

credit course.

In the Emotional Intelligence course, students will gain insights into establishing positive relationships and discover personal competence and technique for building emotional intelligence, self-awareness, self-management, social awareness and relationship management.

The university will also introduce a course to acquaint students with Indian fiction in English and

analyse novels critically and in the context of their own lived situations.

Through this course, students will learn about the understanding of Indian ethos and values through Indian fiction, develop creative thinking through the reading of fiction and realise the potential of fiction in bringing out social and cultural change.

However, several teachers at the university are of the view that value-addition courses under the Undergraduate Curriculum Framework (UGCF) will discourage critical thinking. Seven academic council members issued a dissent note during the August 3

meeting.

According to the dissenting members, these courses pay a lip service to the question of intellectual attitudes that need to be fostered in students, and also undermine the idea of India as a cosmopolitan site of cultural and philosophical interaction between people, languages and traditions.

The myopic conception of VAC rubric is evidently an outcome of a centralised initiative that has excluded participation of teachers from all subjects. Hence, many disciplines have not found any representation, the teachers said in a statement.



## SC: Freebies, welfare schemes different



he Centre asked the Supreme Court to lay down guidelines to regulate the freebies announced by political parties to induce voters, till the legislature devises a mechanism

New Delhi, August 11: Observing that freebies and social welfare schemes are two different things, the Supreme Court Thursday said a balance has to be struck between the economy losing money and welfare measures.

It also ruled out the possibility of considering a plea for de-recognising parties for making promises to give freebies.

Asking stakeholders to give suggestions on this aspect before August 17, a bench comprising Chief Justice N V Ramana and Justice Krishna Murari said the idea to de-recognise political parties for making promises to give irrational freebies during the polls was "undemocratic"

"I do not want to enter the area of de-registering a political party etc. As it is an undemocratic idea. We are a democracy after all," the CJI, speaking for the bench, said. The CJI said the issue of promise to grant irrational freebies during the poll process is a

"serious issue" but he will not encroach into the legislative domain even if there was a statutory vacuum on the issue.

"You can call me reluctant or nservative but I do not want to encroach upon the legislative domain. I am a strict orthodox. I do not want to encroach on the areas meant for the legislature. This is a serious issue. It is not an easy thing. Let us hear others also," the bench said.

The CJI, who is demitting office August 26, said some suggestions have been made by senior lawyers and asked the remaining parties to do the needful before his retirement and fixed the case for further hearing August 17.

"Freebies and the social welfare scheme are different. Economy losing the money and the welfare of people, both have to be balanced and that is why, this debate. There must be someone who can put their vision and thoughts. Please submit something before my retirement," the

The top court was hearing a PIL filed by lawyer Ashwini Upadhyay, which opposes the practice of political parties promising freebies during elections and seeks the Election Commission to invoke its powers to freeze their election symbols and cancel their registration.

Taking note of the submissions of senior advocate Vikas Singh, appearing for Upadhyay, the bench said it is a "serious issue and those who are getting (the freebies), they want it. Ours is a welfare state. Some may say that they are paying taxes and it has to be used for developmental processes...So both sides have to be heard by committee.'

Solicitor General Tushar Mehta, appearing for the Centre. said, "Distribution of freebies has been elevated to the level of an art by some parties recently. Elections are fought only on this plank. It is unfortunate that in the country's election spectrum some parties understand that distribution of free things is the only way of 'welfare measures' for the society. This understanding is completely unscientific and will

lead to an economic disaster." The top law officer gave the example of the "stressed' electricity sector and said many power generating and distribution companies are PSUs and are under severe financial stress.

Till the time, either the legislature or the poll panel steps in, the top court must lay down "dos and don'ts" for political parties in "larger national interest.

On August 3, the top court, while asking stakeholders like the Centre, Niti Aayog, Finance Commission to brainsform on the issue of freebies, had hinted that it may order setting up a mechanism for suggesting measures to the government to deal with the issue.

Bangalore, August 11: The Karnataka High Court has held that married daughters are entitled for compensation by insurance companies on the loss of their parents in accidents.

The HC said the Supreme Court has held that married sons are also entitled for compensation in such cases. "This Court also cannot make any discrimination whether they are married sons or married daughters and hence, the very contention that married daughters of deceased are not entitled for compensation cannot be accepted," it said.

The HC single judge bench of Justice H P Sandesh heard an appeal filed by an insurance company challenging the award of compensation to married daughters of one Renuka (aged 57) who was killed in an accident April 12, 2012 near Yamanur, Hubballi, in north Karnataka

Renuka's husband, three daughters and a son had sought compensation. The Motor Accident Claims Tribunal had awarded a compensation of ₹5.91.600 with six per cent annual interest to the fam-

The insurance company had

tending that married daughters could not claim compensation, and also that they were not dependents. Therefore, awarding compensation under the head 'loss of dependency' was wrong. It was claimed by the insurer that compensation was to be awarded only under 'loss of estate.'

The HC, however, said that dependency does not only mean financial dependency. Even if the dependency is a relevant criterion to claim compensation for loss dependency, "it does not mean financial dependency is the 'ark of the covenant'.

Dependency includes gratuitous service dependency, physical dependency, emotional dependency, and psychological dependency, which can never be equated in terms of the money, it said.

Other contentions of the insurance company including doubts about the age of the deceased, and her income were also rejected by the court. A warranty card for a sewing machine purchased by the deceased came in handy for the Tribunal to calculate her income at ₹4,500 per month.

The HC rejected the contention of the insurer that exorbitant compensation had been awarded by the Tribunal, and dismissed

## LG ORDERS FIR AGAINST NINE RETD, 2 SERVING DDA OFFICIALS

New Delhi, August 11: Delhi Lieutenant Governor Vinai Kumar Saxena has ordered an FIR against nine retired and two serving Delhi Development Authority (DDA) officials in a nine-year-old case of financial misappropriation, officials said Thursday. The LG, who is the DDA chairman, has also ordered permanent withdrawal of the nine retired officials' pension, they said.

"Lt Governor VK Saxena, in his capacity as DDA chairman, has ordered that an FIR be registered against the then member (finance) and then member (engineering) of DDA, apart from nine other officials in a 2013 case of blatant financial misappropriation and violation of codal formalities, Central Public Works Department Works Manual," officials said. The nine retired officials include a chief en-



gineer, a superintendent engineer and an executive engineer while the others were employed in the finance and accounts departments.

On "permanent withdrawal of full pension benefits", officials said the LG took the stern measure considering the "grave misconduct and loss to the exchequer" even as the DDA recommended deducting

only 25 per cent of the amount. The officials facing action include then Member (Engineering) Abhay Kumar Sinha, the then Member (Finance) Venkatesh Mohan, Chief Engineer (Retd) Om Prakash, Superintending Engineer

Sharma, Dy CAO (Retd) PK Chawla, AAO (Retd) Jasvir Singh, AAD (Retd) SC Mongia, AE (Retd) SC Mittal, AE (Retd) RC Jain, and AE (Retd) Dilbagh Singh Bains.

According to officials, the case relates to the work for up-gradation and beautification of Coronation Park at Kingsway Camp that was awarded in 2013. The tender cost of the work was ₹14.24 crore but additional works amounting to ₹114.83 crore was carried out at Narela and Dhirpur, without any sanctions, they said. The original project cost of ₹14.24 crore was escalated to ₹28.36 crore and the same was further deviated with additional work at a different location altogether. This resulted in overall payment of ₹142.08 crore to the agency This gross irregularity was pointed out by the CAG in its report in 2016, officials said



### ■ Toll rises to 48

Gaza City (Palestine): The Palestinian death toll from last weekend's fighting between Israel and Gaza militants rose to 48 on Thursday after an 11year-old girl and a man died from wounds they sustained during the worst cross-border violence in over a year. Meanwhile, two wounded Gaza children, ages 8 and 14, were fighting for their lives in a Jerusalem hospital. In all, more than 300 Palestinians were wounded over the weekend when Israel struck Islamic Jihad targets across Gaza and the militant group fired hundreds of rockets at Israel.

## Dozens missing

Athens: Greek authorities say a search and rescue operation is ongoing for a second day for dozens of migrants missing after the boat they were on sank in rough seas off a southeastern Greek island. A Greek navy vessel and three nearby merchant ships were still searching on Thursday for between around 25 to 45 people believed missing after the boat that had been carrying them from the Turkish coast of Antalya to Italy capsized in the early hours of Wednesday. Greece's coast guard said it had not located any further survivors since 29 men from Afghanistan, Iran and Iraq were rescued shortly after the boat sank about 33 nautical miles (38 miles, 61 kilometers) southeast of the island of Karpathos and about 38 nautical miles (44 miles, 70 kilometres) south of Rhodes.

## China to provide \$118 mn to Nepal

Beijing/Kathmandu: Facing headwinds over its South Asia push after Sri Lanka's worst economic crisis. China has warmed up to Nepal by pledging USD 118 million in aid and announcing a slew of trade concessions while vowing to speed up work on the stalled BRI projects. Chinese Foreign Minister Wang Yi announced the concessions for Nepal in his meeting with his Nepalese counterpart Narayan Khadka in the eastern Chinese city of Oingdao on Wednesday.

### ■ Taliban cleric killed in blast

Kabul/Peshawar: A prominent Taliban cleric, Sheikh Rahimullah Haqqani, was killed in an attack in a seminary in Kabul when the attacker detonated explosives hidden in a plastic artificial leg Thursday, according to officials and Taliban sources. "Very sadly informed that respected cleric (Sheikh Rahimullah Haqqani) was martyred in a cowardly attack by enemies," said Bilal Karimi. a spokesperson for the Taliban administration.

## Images show Crimea Access to drinking water must be as asy as possible for Il people in termany Images show Crimea airbase badly damaged

Kyiv, August 11: Satellite pictures released on Thursday showed devastation at a Russian air base in Crimea, hit in an attack that suggested Kyiv may have obtained new long-range strike capability with potential to change the course of the war.

Pictures released by independent satellite firm Planet Labs showed three near-identical craters where buildings at Russia's Saki air base had been struck with apparent precision. The base, on the southwest coast of Crimea, had suffered extensive fire damage with the burnt-out husks of at least eight destroyed warplanes clearly visible.

Russia has denied aircraft were damaged and said explosions seen at the base Tuesday were accidental. Ukraine has not publicly claimed responsibility for the attack or said exactly how it was carried out. "Officially, we are not confirming or denying anything; there are numerous scenarios for what might have happened... bearing in mind that there were several epicentres of explosions at exactly the same time," Ukrainian presidential adviser Mykhailo Podolyak said in a message.

Western military experts said the scale of the damage and the apparent precision of the strike suggested a powerful new capability with potentially important implications. Russia, which seized and annexed Crimea in 2014, uses the peninsula as the base for its Black Sea fleet and as the main supply

Aine Davis, who denies being part of the terror group, was remanded in police custody to appear at Westminster Magistrates' Court in London Thursday.

He was arrested at Luton Airport in Bedfordshire after being deported to England from Turkey on Wednesday.

Davis is charged with possession of a firearm for a purpose connected with terrorism.

He was charged with offences contrary to sections 15, 17 and 57 of the Terrorism Act of 2000, following an investigation by the Metropolitan Police's Counter Terrorism Command.

'The CPS [Crown Prosecution Servicel authorised the Metropolitan Police to charge Aine Leslie Junior Davis for terrorism offences in 2014, and after being deported to England by Turkish authorities, he has been arrested at Luton airport following his return to the UK," said a spokesperson for the CPS Special Crime and Counter Terrorism Division.

"Davis, 38, has been charged with terrorism offences and possession of a firearm for a purpose connected with terrorism. The Crown Prosecution Service reminds all concerned that criminal proceedings against Mr Davis are active and that he has the right to a fair trial," the spokesperson said.

## China renews Taiwan threats

Beijing, August 11: China Thursday renewed its threat to attack Taiwan following almost a week of war games near the island. Taiwan has called Beijing's claims to the self-governing democracy "wishful thinking" and launched its own military exercises.

Taiwan's "collusion with external forces to seek independence and provocation will only accelerate their own demise and push Taiwan into the abyss of disaster," Chinese Foreign Ministry spokesperson Wang Wenbin said at a daily briefing.

'Their pursuit of Taiwan independence will never succeed, and any attempt to sell the national interest will be met with a complete failure," Wang told reporters. China's attempt to intimidate the Taiwanese public and advertise its strategy for blockading and potentially invading the island was nominally prompted by a visit to Taipei last week by US House Speaker Nancy Pelosi.

The US, Japan and allies have denounced the exercises, with the Group of Seven industrialised nations issuing a statement at a recent meeting expressing its concern. On Wednesday, Britain's government summoned Chinese Ambassador Zheng Zeguang to the Foreign Office to demand an explanation of "Beijing's aggressive and wide-ranging escalation against

### Pelosi: US can't allow China's 'new normal' over Taiwan

Washington: House Speaker Nancy Pelosi has said the US just cannot allow China to establish a "new normal" to put pressure on Taiwan through the kind of military drills and warplane incursions that Beijing launched after she visited the selfgoverning island. China Wednesday announced that it has "successfully completed" its week-long and unprecedented military drills that have essentially encircled Taiwan. Initially, the People's Liberation Army announced the war games in the busy Taiwan Strait from August 4 to 7, the day after Pelosi, who is the highest-ranking US leader to have visited Taiwan in 25 years, left Taipei after highlevel meetings. It later kept extending them, keeping the breakaway island on tenterhooks.

the island into the Pacific Ocean. China also sent planes and ships across the midline in the strait that has long been a buffer between the sides, which separated amid civil war in 1949.

In a lengthy policy statement on Taiwan issued Wednesday, China distorted the historical record, including the United Nations' 1972 resolution that transferred the China seat on the Security Council from Beijing to Taipei. Taiwan's Cabinetlevel Mainland Affairs Council said. The Chinese statement also discarded a pledge not to send troops or government officials to Taiwan that was contained in previous statements

The UN resolution makes no mention of Taiwan's status, although China regards it as a foundational document proclaiming the Communist Party's right to control over the island. The Taiwanese council's statement said China was orchestrating its moves against Taiwan ahead of the ruling Communist Party's 20th National Congress to be held later this year.

## NK declares victory over Covid, reveals Kim had it

Seoul, August 11: North Korean leader Kim Jong Un has declared victory over Covid-19 and his sister indicated that he too caught the virus, while vowing "deadly retaliation" against South Korea, which the North blames for causing the outbreak.

Kim ordered the lifting of maximum anti-epidemic measures imposed in May though adding that North Korea must maintain a "steel-

strong anti-epidemic barrier and intensifying the anti-epidemic work until the end of the global health crisis", North Korea's KCNA news agency reported Thursday.

North Korea has never confirmed how many people caught Covid, apparently because it lacks the means to conduct widespread testing.

Instead, it has reported daily numbers of patients with fever, a tally that rose to some 4.77 million. But it has registered no new such



cases since July 29. Kim made his declaration in a speech on

Wednesday at a meeting on Covid policy with thousands of unmasked officials sitting indoors, according to footage from state broadcasters.

Kim's sister, Kim Yo Jong, also addressed the gathering and said the young leader himself had suffered from fever symptoms, according to KCNA, indicating for the first time that he was likely infected with the virus.

"Even though he was seriously ill with a high fever, he could not lie down for a moment thinking about the people he had to take care of until the end in the face of the anti-epidemic war," she said in remarks broadcast on North Korean state television.

Some of the officials at the meeting were shown wiping away tears as she spoke about her brother's illness.

She did not elaborate on Kim's health but blamed propaganda leaflets from South Korea found near the border for causing the coronavirus outbreak.

## Firefighters combat major wildfire in southwestern France

Paris, August 11: More than 1,000 firefighters were struggling Thursday to contain a major wildfire which has burned a large area of pine forest in southwestern France, in a region that was already ravaged by flames last month.

Local authorities said more than 68 square km (26 square miles) have burned since Tuesday in the Gironde region and neighbouring Landes as France, like other European countries, swelters through a hot and dry summer.

Temperatures were expected to reach 40 C (104 F) on Thursday in the region.

The blaze forced the evacuation of about 10,000 people and destroyed at least 16 houses. Spanish state television showed dozens of trucks having to turn around and stay in Spain because of a border closure because of the fire raging in France. TVE reported that truckers, many carrying perishable goods, were looking for ways to cross the border because the parking areas in and around the Irun crossing are full.

A major highway near the



French city of Bordeaux was also closed. Photos released by firefighters showed flames raging through pine forests overnight, sending clouds of smoke in the air and illuminating the sky with intense orange light.

Prime Minister Elisabeth Borne and Interior Minister Gerald Darmanin were due to visit the evacuated small town of Hostens Thursday to meet with firefighters, rescuers, local officials and volunteers. Darmanin said that nine aircraft and two helicopters have been mobilised to fight the blaze.

The Gironde region was hit last month by major wildfires that forced the evacuation of more than 39,000 people, including residents and tourists. France is this week in the midst of its fourth heat wave of the year as the country faces what the government  $\rightarrow$ warned is its worst drought on record. French President Emmanuel

Macron tweeted that several European countries have offered their help to combat French wildfires, listing Germany, Greece, Poland, Romania and Austria.

In the June quarter, Bank of Maharashtra (BoM) and State Bank of India (SBI) were in the lowest quartile as far as Gross Non Performing Assets (NPAs) and net NPAs were concerned, according to an analysis of the quarterly financial numbers published by the public sector lenders.

Cumulatively, all the 12 public sector banks reported a profit of about ₹15,306 crore in the three months ended June, registering an annual growth of 9.2 per cent. However, leading public sector lenders -- SBI and PNB -- posted lower profits in the June quarter.

During the April-June period of the previous fiscal, state-owned banks recorded a total profit of ₹14,013 crore.

As per the analysis, the gross NPAs reported by BoM and SBI were 3.74 per cent and 3.91 per cent of their total advances, respectively, in the first quarter of the current fiscal. The net NPAs for these banks

## I-T payers can't join APY from Oct

New Delhi, August 11: Income tax payers will not be allowed to enroll in the government's social security scheme Atal Pension Yojana (APY) from October 1, according to a notification. The government introduced APY

June 1, 2015, to provide social security to workers mainly in the unorganised sector. Subscribers of the scheme get a minimum guaranteed pension of ₹1,000 to ₹5,000 per month after attaining 60 years of age depending on their contributions. "From 1st October, 2022, any cit-

izen who is or has been an income tax payer, shall not be eligible to join APY," the finance ministry said in the notification. The new noti-



fication, issued Wednesday, will not apply to subscribers who have joined or joins the scheme before October 1, 2022

In case a subscriber, who joined on or after October 1, 2022, is subsequently found to have been an income tax payer on or before the date of application, the APY account shall be closed and the accumulated pension wealth till date would be given to the subscriber.

Currently, all Indian citizens be $tween\,the\,age\,group\,of\,\,18\text{-}40\,years$ can join APY through bank or post office branches where one has the savings bank account.

The government had co-contributed 50 per cent of the total contribution or ₹1,000 per annum, whichever is lower, to each eligible subscriber, who joined the scheme during the period from June 2015 to March 2016. It was also subject to the condition that the subscriber was not a beneficiary of any social security scheme and also not an income tax payer.

New Delhi, August 11: Google has grave reservations about developing a self-regulatory body for the social media sector in India to hear user complaints, though the proposal has support from Facebook and Twitter, sources with knowledge of the discussions told Reuters.

The lack of consensus among the tech giants, however, increases the likelihood of a government panel being formed - a prospect that Meta Platforms Inc's Facebook and Twitter are keen to avoid as they fear government and regulatory overreach in India, the sources said.

At a closed-door meeting this week, an executive from Alphabet Inc's Google told other attendees that the company was unconvinced about the merits of a self-regulatory body. ## Los Blancos beat Eintracht Frankfurt 2-0 to claim UEFA Super Cup title

Helsinki, August 11: This time, there were only two goals. David Alaba and Karim Benzema scored in each half for Real Madrid to win the UEFA Super Cup with a 2-0 victory over Eintracht Frankfurt Wednesday.

Alaba prodded the opener home from close range in the 37th minute when Casemiro cushioned Benzema's header back after a corner. The French star then sealed Madrid's record-equaling fifth Super Cup title in the 65th thanks to an assist from the lively Vinicius

It was Benzema's 324th goal for Madrid, overtaking club legend

Raúl. Only Cristiano Ronaldo has more after scoring 450 goals for the club between 2009 and 2018.

Benzema, who also joined Madrid in 2009, lifted the trophy for Madrid, his first as captain after taking over from Marcelo. Barcelona and AC Milan are only other clubs to have won the Super Cup five times.

But the game between the Champions League winners, Madrid, and Europa League champions, Frankfurt, failed to match the spectacle of their previous

Their only other competitive game was the 1960 European Cup final, when Alfredo Di Stefano scored three goals and Ferenc Puskas chipped in with four to give Madrid a 7-3 win and fifth consecutive European crown.

Frankfurt goal-scorer Erwin Stein and teammate Dieter Stinka were in Helsinki for the rematch 62 years later, but it was the 93year-old Jose Santamaria — the only remaining Madrid player from that final in Glasgow — who celebrated another win. The three veterans embraced warmly when they met before kickoff.

Madrid coach Carlo Ancelotti started with his established players, forcing new signings Antonio Rudiger and Aurelien Tchouameni to watch from the bench.

Frankfurt was keen to make amends for a 6-1 rout at home to Bayern Munich in the Bundesliga

opening game last Friday.

Frankfurt's Jesper Lindstrom drew a save from Thibault Courtois early on, though the flag went up for offside, giving the Danish midfielder the distinction of being the first in a European club competition to force UEFA's new semi-automated offside technology into action.

Lindstrom then set up Daichi Kamada, who was onside before Courtois blocked his effort. They were to be Frankfurt's only real chances. Vinicius had Madrid's first big opportunity, but Brazilian compatriot Tuta slid in to deny

Frankfurt keeper Kevin Trapp produced a fine save to stop the next Vinicius effort in the 37th,

but Madrid scored from the resultant corner when Benzema and Casemiro combined to give Alaba an easy finish

Benzema went close shortly afterward as Madrid ended the first half in the ascendancy, and Vinicius tested Trapp again early in the second. The Brazilian cut inside to set up Benzema's goal, when the French forward let fly with a direct shot past Trapp.

Comforted by the two-goal cushion, the Spanish champions began turning on the style with intricate passing combinations — albeit vithout adding to their tally. "We didn't play a spectacular game, but we were really solid. Our usual,' Ancelotti said

## SC voices displeasure over Patel interference

New Delhi, August 11: The Supreme Court Thursday warned the state football associations of 'exercising its authority" if ousted AIFF chief and NCP leader Praful Patel attends their meetings and interferes with the administration of

The top court said it will intervene if any attempt is made to sabotage the hosting of the 2022 FIFA-U-17 Women's World Cup in India.

A bench of Justices DY Chandrachud, Surya Kant and AS Bopanna refused to hear the modification applications filed by the Centre and State Football Associations, and the contempt petition of the Committee of Administrators (COA) against Patel for allegedly "interfering with the proceedings" of the top court after it was informed that a meeting is scheduled for Thursday evening with FIFA authorities.

The All India Football Federation (AIFF) has been at the centre of a controversy after it failed to hold timely elections due to a delay in finalising its constitution, a key requirement for the prestigious tournament to be held in the country.

As the delay persisted, the apex court appointed a three-member Committee of Administrators (CoA) comprising former chief election commissioner SY Quraishi, ex-Supreme Court judge Anil Dave and former India football captain Bhaskar Ganguly to run the dayto-day affairs of the AIFF.

Patel, despite being ousted by the SC, allegedly held a meeting with 35 Intervening Member Associations August 6, amid the continued threat of a ban on AIFF by the world football body AIFA and the Asian Football Confederation on account of nonholding of the election. Patel is an executive council member of the AIFA and vice president of AFC.

CWG silver winner Sreeshankar disappoints

Monaco. August 11: Commonwealth Games silver medallist long jumper Murali Sreeshankar finished sixth in his debut Diamond League meeting here with a below-par 7.94m effort.

Six days after winning a historic silver at the Birmingham CWG, Sreeshankar competed in his much-anticipated maiden Diamond League but was far from his best in a strong field under conditions not very ideal for jumping Wednesday night.

Most of the 10 jumpers faced headwind of above 1m/s in the first round but it got better as the competition progressed.

Sreeshankar had won silver in the CWG six days ago with a best jump of 8.08m. He has a season's and personal best of 8.36m. He had finished seventh in the World Championships in Eugene, USA, last month with a best jump of 7.96m.

The 23-year-old opened with a 7.61m under a 1.5m/s headwind. He bettered it to 7.84m and then followed it by 7.83m. From sixth in the first round, he slipped to eight after the third and just about squeezed into the top eight to save himself from elimination. Sreeshankar had 7.69m in his fourth attempt and 7.94m in his fifth to leave him at the sixth spot.

Under the revised 'Final Three' rule of the Diamond League, only



the top three get the sixth and last attempt. Tokyo Olympics bronze medallist Maykel Masso of Cuba won the event with a best effort of

World Championships silver medallist and reigning Olympic champion Miltiadis Tentoglou of Greece (8.31m) finished second ahead of Marquis Dendy (8.31m) of

USA though both had identical best jumps

Sreeshankar's next event could be in Lausanne, Switzerland as he has said he has entered his name for World Athletics Tour silver label event there August 30.

He collected three Diamond League points to be at 10th in the qualification ranking for the final in Zurich on September 7-8. He will not make the season-ending finale as only the top six qualify for it and there is no men's long jump event in the remaining two legs in Lausanne (August 26) and Brussels (September 2). Tentoglou is at the top of the Diamond League rankings with 31 points, followed by Masso (20) and Montler (16).

## Last bout's loss not in Vijender's mind

New Delhi, August 11: Star Indian boxer Vijender Singh does not want to carry the baggage of last year's  $\,$ maiden defeat on the professional circuit as he returns to the ring Wednesday, saying "I always fight like it's my first.'

Since turning pro in 2015, Vijender was unbeaten till last March with an enviable 12-0 record, including eight knockouts. But that changed in March last year, when his winning run was brought to an unceremonious end by Russia's Artysh Lopsan via a technical knockout in Goa.

"Record toh bante hi tutne ke liye hain. (Records are meant to be broken) It is all part of the game," an upbeat Vijender told this agency.

As he gears up for his next fight against the reigning national West

Vijender's mantra is simple: remove all thoughts of the previous bouts. "I always fight like it's my first fight.

When I start training I'm just like a

blank slate, I learn everything again.

I listen to what my coaches tell me and start over," the 2008 Beijing

Olympics bronze medallist said. Frustrated by the lack of competition and COVID-19 restrictions, Vijender had arranged the bout with Lopsan. Fighting for the first

time in 16 months, he had to do without his team which included trainer Lee Beard.

The British boxing trainer, who has trained professional stars like Ricky Hatton, has been guiding Vijender since the start of his professional career. However, Lee could not travel to India because of the COVID-19 restrictions.

"I learnt an important lesson from that bout. In future, if somebody asks me for advice, I'll will tell them 'pro boxing is a serious business, don't ever go (to a fight) without your team. If you are absolutely sure then only go, otherwise don't take the risk.

However, Vijender seems poised to get his 13th win. "Yes, pressure is there (to not slip to another loss) but I'm confident because I have my team around me.

a potential boycott by the Argentinians, according to Brazilian confederation president

Ednaldo Rodrigues. Brazilian media has reported the Selecao would rather play two friendlies in Europe. "We will reach out to FIFA so

this match is not played. I will make every effort to answer to the request of our coaching staff," Rodrigues said in a statement.
