

NEW YORK: In a possible hate crime, unidentified persons have destroyed a handcrafted statue of Mahatma Gandhi with a sledgehammer at a Hindu temple here after vandalising it earlier this month, media reports said Friday Surveillance video shows a person thrashing a statue of Gandhi with a sledgehammer Tuesday, before smashing the head off and toppling it over, according to cbsnews.Com. Minutes later, a group of six stomp on it and take turns hammering the statue before taking off, the report said. "To see them coming after us like this is very painful," Lakhram Maharaj, the founder of Shri Tulsi Mandir. situated in South Richmond Hill was quoted as saying in the report. Maharaj discovered the Gandhi statue was reduced to rubble Wednesday morning. The word "dog" was spray painted both in front of the temple and down the block, it said.

Bengal intensified into a deep depression bringing rainfall to north Odisha districts, the India Meteorological Department (IMD) said Friday.

However, it has ruled out possibility of a cyclone. Social media was flooded with posts on the possibility of a cyclone following the US Joint Typhoon Warning Centre's (JTWC) warning Thursday that the system has the potential to intensify into a cyclone.

"There is no possibility of a cyclone this time. We have never said that the system will take the shape of a cyclone," IMD Director General Mrutyunjay Mohapatra said. The system will move along the coast as a deep depression at a wind speed of 60 to 65 kmph and it is unlikely to intensify further, he said.

According to the Met office, continuing to move west-northwestwards, the deep depression crossed West Bengal and adjoining North Odisha coasts between Balasore and Sagar Islands, close to Digha between 7pm and 8 pm, Friday. The system would continue to

move west-north westwards across West Bengal, north Odisha and Jharkhand towards north Chhattisgarh during next 24 hours and weaken gradually.

Under its influence, squally surface wind reaching up to 55-65 kmph is expected in coastal areas and 30-40 kmph in interior districts of the state, it said.

"North Odisha will receive the maximum rainfall Friday while rain intensity will increase in western districts tomorrow (Saturday)," Mohapatra said. The IMD has issued a red warning for heavy to very heavy rainfall, with isolated extremely heavy falls, for Keonjhar, Bhadrak, Balasore and Mayurbhanj districts till 8:30am August 20. It has also forecast heavy to very

heavy rainfall at a few places in dis-

Chief Minister Naveen Patnaik made a special appeal to the residents of four districts. "As per IMD forecast, heavy to very heavy rainfall is likely in Keonjhar Mayurbhanj, Balasore and Bhadrak tonight. I appeal to people not to panic rather follow the instructions of the administration," he said. Stating that "every life is precious" for the Odisha government, he said everybody should stay safe and ensure safety of family members as well.

Mumbai, August 19: RBI Governor Shaktikanta Das said the retail inflation is "unacceptably and uncomfortably" high and proposed the 50 basis points hike in repo rate at the recent monetary policy review meeting.

MGNREGS FUND BUNGLING Lokayukta orders recovery of fund

Dharmashala, August 19: After Lokavukta detected embezzlement of fund sanctioned for a road project under Mahatma Gandhi National Rural **Employment Guarantee Scheme** (MGNREGS) in Gangadharpur panchayat under Dhamashala block of Jajpur, three engineers, one GRS and a former sarpanch were served notices for recovery of the fund.

Reports said ₹5 lakh was sanctioned for a road project at Imamnagar under this block in FY 2020-22. The work order was issued in the name of the then panchayat executive officer (PEO).

As per official estimate, a 320metre stretch cement concrete (CC) road was to be laid in the village. However, work for only 90metre stretch was done while wages of 31 job card holders - nearly ₹2.94 lakh – was misappropriated by some dishonest officials.

Learning about the irregularities, RTI activist Sarbeswar Beura sought information from the block administration about the details of fund utilisation in the road project. He had also drawn at- ২ tention of the Lokayukta towards the irregularities.

The Lokayukta registered a case April 13, 2022 and sought detailed report about the project from the BDO. However, the BDOin his report rubbished the allegations. Continued on P4

Women have more sex partners than men in 11 states

New Delhi, August 19: Women on average have more sex partners than men in 11 states and Union Territories (UTs) but the percentage of men who had sexual intercourse with someone who was neither their spouse or lived with stood at 4 per cent, much higher than that of women at 0.5 per cent, according to the National Family Health Survey (NFHS) data.

The NFHS which was conducted among 1.1 lakh women and 1 lakh

- The NFHS which was conducted among 1.1 lakh women and 1 lakh men showed that the number of sex partners on average for women was higher than men in many states and Union Territories
- But the percentage of men who had sexual intercourse with someone who was neither their spouse nor live-in partner, in the 12 months preceding the survey, stood at 4%

These states and UTs are: Rajasthan, Haryana, Chandigarh, Jammu and Kashmir, Ladakh, Madhya Pradesh, Assam, Kerala Lakshadweep, Puducherry and Tamil Nadu. Rajasthan had the highest number of women who had on an average 3.1 sex partners as against 1.8 for men. But the percentage of men who had sexual intercourse with someone who was neither their spouse nor live-in partner, in the 12 months preceding the survey, stood at 4 per cent. For women, the number stood at 0.5 per cent.

The National Family Health Survey-5 conducted during 2019-21 surveyed 707 districts of the country from 28 states and eight UTs.

The national report also provides data by socio-economic and other background characteristics, useful for policy formulation and effective programme implementation.





No letup in Sundarpada flood situation

Bhubaneswar, August 19: Many buildings on one side of Jatni-Sundarpada Road, on the outskirts of Bhubaneswar, appeared to be on an island as one drove along it.

A closer look revealed that scores of residential apartments were marooned amid inundated fields as the Daya river, a branch of the Kuakhai distributary of the Mahanadi, was in spate following heavy rain due to low pressure and subsequent depression.

Many areas of Sundarpada were flooded since Wednesday and people have been without electricity since then after the power supply was cut off due to the risks of short circuits.

"People are staying on the top floors, while others have left for safer places," Jyotiranjan, who lives near the Hi-Tech Plaza, said as he waded along a flooded road with a stick in hand to check any potential pits.

He said the water has receded a bit, but danger lies due to the possibility of heavy rain after the formation of a deep depression over the Bay of Bengal

Over the past two days, personnel of the Odisha Disaster Rapid Action Force rescued those who were in danger as they were living on the ground floor.

Pravesh Agarwal, a resident of Kalyani Plaza area, said his family shifted to the second floor of their double-storey building after floodwater gushed into the garage

The bulletin said that 53 other Covid-19 patients have died due to comorbidities so far.

Can't entertain PIL in disputes relating to service matters: HC

Cuttack, August 19: The Orissa High Court (HC) has held that Public Interest Litigation (PIL) cannot be entertained in disputes relating to service matters, an of ficial said Friday.

While adjudicating a matter relating to alleged irregularities in the appointment of primary school teachers in Jagatsinghpur, a division bench of Chief Justice S Muralidhar and Justice RK Pattanaik dismissed the PIL that sought the court's intervention into such 'illegal' appointment.

According to the case details, four residents of Jagatsinghpur had approached the HC alleging a large number of irregularities in the appointment of teachers for primary schools of the district in accordance with a resolution of the School and Mass Education (S&ME) department of March 12, 1996.

In the PIL, they alleged that the merit list of those eligible for appointment as primary teachers in Jagatsinghpur included less meritorious candidates, bypassing those who had secured more marks in the selection process. The S&ME department, however, realised its mistake and came out with a revised selection list in 2006, the petitioners said, pointing out that the fresh list too featured many candidates who secured less marks than those overlooked and some of them had even produced fake certificates.

The S&ME department, meanwhile, allowed such persons to avail the benefit of the Revised



Assured Career Progression (RACP) Scheme through order July 13, 2015, the petitioners said.

The petitioners urged the HC for a directive to the state for immediate removal of such teachers and a CBI probe into the issue. While hearing the petition for the

first time April 18, 2017, the HC observed that the writ petition in the nature of a PIL would not be maintainable as the matter relates to service of teachers.

Petitioners' counsel Ramakanta Sarangi argued that even though the general rule says PIL will not be entertained in service matters, the exception is where a writ of quo warranto is sought to quash illegal appointments. Sarangi cited the decision of the Supreme Court in Central Electricity Supply Utility of Odisha v. Dhobei Sahoo (2013). On the other hand, S&ME de-

partment's counsel BA Prusty, while citing the decision in Girjesh Shrivastava v. State of Madhva Pradesh (2010), argued that PIL cannot be entertained in service related disputes.

Smoking, alcohol leading causes of cancer deaths: Study

moking, alcohol use, high body mass index (BMI), and other known risk factors were responsible for nearly 4.45 million global cancer deaths in 2019, according to study published in The Lancet journal Friday.

The findings can help policy makers and researchers identify key risk factors that could be targeted in efforts to reduce deaths and ill health from cancer regionally,

nationally, and globally. "This study illustrates that the burden of cancer remains an important public health challenge that is growing in magnitude around the world," said Christopher Murray Director of the Institute for Health Metrics and Evaluation (IHME) at the University of

Washington, US "Smoking continues to be the leading risk factor for cancer globally with other substantial contributors to cancer burden varying," said Murray, a co-senior author of the study.

Using results from the Global Burden of Diseases, Injuries, and Risk Factors (GBD) 2019 study, the researchers investigated how 34 behavioural, metabolic, and envi-

ronmental and occupational risk factors contributed to deaths and ill health due to 23 cancer types in 2019.

Changes in cancer burden between 2010 and 2019 due to risk factors were also assessed. Estimates of cancer burden

were based on mortality and disability-adjusted life-years (DALYs), a measure of years of life lost to death and years lived with disability.

In addition to 4.45 million cancer deaths which made up 44.4 per cent of all cancer deaths in 2019, risk factors included in the analysis accounted for 105 million cancer DALYs globally for both sexes in 2019 -- 42.0 per cent of all DALYs in that year. the researchers said.

Behavioural risk factors such as tobacco use, alcohol use, unsafe sex, and dietary risks were responsible for the vast majority of cancer burden globally, accounting for 3.7 million deaths and 87.8 mil-

lion DALYs in 2019, they said. The study shows that almost 2.88 million deaths in men (50.6 per cent of all male cancer deaths) could be attributed to the risk factors studied, compared to 1.58 million deaths in women (36.3 per

tributable cancer death for both men and women globally was tracheal, bronchus, and lung cancer, which accounted for 36.9 per cent of all cancer deaths attributable to risk factors, they said.

This was followed by colon and

rectum cancer (13.3 per cent), oesophageal cancer (9.7 per cent), and stomach cancer (6.6 per cent) in men, and cervical cancer (17.9 per cent), colon and rectum cancer (15.8per cent), and breast cancer (11 per cent) in women.

Ill health attributed to environmental and occupational, behavioural, and metabolic risk factors increased with age, peaking in the 70s depending on countries' socio-demographic Index (SDI), with countries on the higher end of the spectrum tending to peak at later ages. The five regions with the greatest cancer death rates due to risk factors were central Europe (82 deaths per 100,000 population), East Asia (69.8 per 100,000), highincome North America (66.0 per 100,000), Southern Latin America (64.2 per 100,000), and Western Europe (63.8 per 100,000).

Patterns of cancer deaths and ill health due to environmental and occupational, behavioural. and metabolic risks differed around the world, with unsafe sex a leading risk factor for ill health in locations at the lower end of the SDI spectrum.

Between 2010 and 2019, cancer deaths due to risk factors rose by

20.4 per cent globally, increasing from 3.7 million to 4.45 million, according to the researchers.

Ill health due to cancer increased by 16.8 per cent over the same period, rising from 89.9 million to 105 million DALYs, they said.

Metabolic risks accounted for the greatest percentage increase in cancer deaths and ill health, with deaths increasing by 34.7 per cent and DALYs by 33.3 per cent.

Professor Diana Sarfati and Jason Gurney of the University of Otago, New Zealand, noted that the primary prevention of cancer through eradication or mitigation of modifiable risk factors is our best hope of reducing the future burden of cancer. "Reducing this burden will improve health and wellbeing, and alleviate the compounding effects on humans and the fiscal resourcing pressure within cancer services and the wider health sector," the researchers, who were not involved in the study, said.

On links between cancer risk and poverty, they said, "it is no accident that behaviours associated with higher risk of cancer are patterned according to poverty, particularly within countries". PTI

Bhubaneswar, August 19: Paradip Port has been at the forefront in suc cessfully completing several public-private partnerships (PPP) projects worth over ₹3,000 crore recently, said Shantanu Thakur, MoS for Ports, Shipping and Waterways.

These PPP projects have led to capacity addition of 55 MTPA at the port, said Thakur while virtually addressing the Maritime Public-Private-Partnership Conclave 2022 organised by Paradip Port Authority here, Thursday.

He hoped that as a part of Vision India 2047, Paradip Port will evolve as a world-class mega port with over 750 MTPA capacity by 2047.

New Delhi, August 19: Though the solar and wind energy potential in India are likely to witness a negative trend in the future due to climate change, a new study by Pune-based Indian Institute of Tropical Meteorology says the southern coast of Odisha shows promising potential for wind energy.

The researchers used state-ofthe-art climate models devised by the Intergovernmental Panel on Climate Change (IPCC) to analyse the wind and solar projections for the renewable energy sector over the Indian subcontinent.

The seasonal and annual wind speed is likely to decrease over North India and increase along South India. The southern coast of Odisha and the southern Indian states of Andhra Pradesh and Tamil Nadu show promising potential for wind energy in the climate change scenario, said the study titled 'Analysis of future wind and solar potential over India using climate models'.

The study was published in the peer-reviewed journal Current Science recently.

Regional analysis of wind potential indicates that the frequency of high energy producing wind speeds will decrease, whereas low energy producing wind speeds are likely to increase in the future.

"Solar projections for the future indicate that solar radiation will decrease during all seasons over

The forecasts are important since India has updated its Determined Nationally Contributions (NDCs) to fight climate change, incorporating two of the promises made by Prime Minister Narendra Modi at the Glasgow conference -- reducing emissions intensity of GDP by 45 per cent by 2030, from 2005 level, and achieving about 50 per cent cumulative electric power installed capacity from non-fossil fuel-based energy resources by 2030.

JEYPORE CUSTODIAL DEATH

CB starts probe 8 months after case registration

Koraput, August 19: Nearly eight months after the state Crime Branch (CB) registered a case against four police officers for their alleged involvement in the custodial death of a person in Jeypore town of this district in 2017, the agency started a probe into the case

A three-member CB team met the victim's family, visited the crime spot, talked to doctors at the hospital where the victim was admitted and gathered circumstantial evidence during a visit to Jeypore, an official said.

"Detailed inquiry into the case was made. If required, the CB team may come again in future. said a CB team member.

The CB registered a case into the matter in December last year.

January 30, 2017, Akash Mahuria (28), a resident of Jeypore who was wanted for his alleged involvement in a few offences, was allegedly tortured and beaten to death inside the Jeypore town police station.

While the police claimed that Rakesh, who had a number of criminal cases against his name, died due to an accidental fall while being chased for arrest, the familv members of the youth attributed custodial torture as the reason behind his death

Later, the family of the deceased knocked the doors of the Odisha



Cashew farming under MGNREGS flops

BOTCHED UP POST-PLANTATION CARE, NON-RELEASE OF MAINTENANCE FUNDS HAVE SCUTTLED THE SCHEME PUTTING THE BENEFICIARY FARMERS IN A FIX

Keonjhar, August 19: Cashew farming is being promoted through Mahatma Gandhi National Rural **Employment Guarantee Scheme** (MGNREGS) to create scope of earning for people and enhance the income of interested farmers, but the initiative has allegedly been mired in irregularities in Keonjhar. The scheme has failed to achieve its objectives for the

beneficiaries. As per guidelines, cashew saplings are planted on the land of the beneficiaries under MGNREGS. The saplings are taken care of and maintained for two years before the plantations are handed over to beneficiaries.

Here is a case in point: In 2021-22 fiscal, the horticulture department planted cashew saplings on 8 hectares of land belonging to 12 beneficiaries at Sendakap vil-



lage under Sadar block. Around ₹19 lakh was spent for the project. Scores of job card holders were engaged in raising the plants and fencing.

However, it was alleged that postplantation care was not taken up properly. Pesticides and fertilizers were not used to nurture the saplings. And as a result, saplings died off. Some saplings that had survived were eaten up by goats and

cattle in absence of fences.

With no sapling surviving, the plantation area now resembles a pasture land. Beneficiaries who had nurtured hope of earning from cashew farming were a distressed lot. Locals said that they used to raise crops from their farmlands earlier, but after the cashew plantation, the farmlands are unfit for farming. They blamed some officials of the horticulture depart-

It was built by the National Thermal Power Corporation (NTPC) under its CSR. Later in September 2021, MP Jual Oram had urged Union Health Minister Mansukh Mandaviva for the establishment of the premiere institute in his constituency. In a letter, he cited that the NTPC has completed the construction of the 100-bed medical college and 500-bed hospital in Sundargarh. But even after the lapse of over seven years after signing the MoU, not much has been done in this regard, Oram added.

MURDER NEAR BBMCH

Cousin among 4 🔰 arrested; killer hired for ₹1 lakh

Bolangir, August 19: Police Friday cracked the mystery surrounding the murder of a youth that had taken place in front of his mother on the premises of Bhima Bhoi Medical College and Hospital (BBMCH) in Bolangir district August 16. The deceased had been identified as Aju Dora (25) of Sudapada.

Police have arrested four persons including Aju's cousin who had given blood money of ₹1 lakh to a supari killer to eliminate Aju. Among the accused were mastermind of the crime and Aju's cousin Muna Dora (27) of Sudapada, Rahul Panigrahi (27) of Lalit Nagar, Some Punji (24) of Nuapada and Chandra Pradhan (27) of Brahmanipada in Bolangir.

SP Nitin Kusalkar said that Aju had arguments with his cousin about running a fruit shop on roadside two months ago. Muna had then hatched a conspiracy to kill Aju and had paid ₹1 lakh supari to Rahul Panigrahi. Rahul had involved his friend Chandra Pradhan and Some Punji in the plan, he added.

Aju and his mother were going to an eatery near the diarrhoea ward of BBMCH August 16. All of sudden, Punji attacked Aju with a sword killing him on the spot. Aju's mothers also sustained grievous injuries. Police have seized a sword, knife, ₹9,500 cash, five cell phones and a motorcycle from the accused.

Nine years on, Sona bridge nowhere near completion

Nilagiri, August 19: Nine years have passed since work on a bridge project was started at Ajodhva panchayat, a fringe area under Nilagiri block of Balasore, but it is nowhere near completion.

Locals alleged that despite allocation of funds, the construction work is moving at a snail's pace nearly a decade due to lethargy of the contractor and officials of the rural development department. Thousands of people in the region have been suffering on the communication front owing to noncompletion of the bridge.

Reports said, people of Baliapal, Narsinghpur and Tinidesh under Nilagiri block and several bordering villages in Mayurbhanj district have to negotiate through water in order to cross the Sona river on a daily basis.

The locals had long been demanding for a bridge across the river. Taking the demand into account, the state government sanctioned ₹9 crore for a bridge

in 2014 with an agreement with the contractor to finish it within three years Nine years have passed after that, but the bridge is yet to be completed, lamented locals, adding that the contractor had been delaying the

work citing various reasons, even though the rural development department has sent several reminders to the former to complete the work.

We always face a lot of difficulties in commuting through the river to reach our farmlands across the river. Sometimes, to bypass the



project under Biju Setu Yojana in river, we take a detour of 15 kilo-2013. Its construction was started metre to reach our farmlands,' they pointed out.

The bridge can directly provide a communication link to some pockets of Mayurbhanj district. In the monsoon, the riparian villages fail to venture out as the river remains in spate throughout the season.

dditional Chief Secretary (Information) of Uttar Pradesh Navneet Sehgal has recently written to district/block/tehsil information officers to monitor the news that is published at the micro level. It says that the local news is damaging the Yogi government's image.

Suddenly, a kind of babu at the district level, who was otherwise largely irrelevant to the decision-making at the Centre or the state capital, is now brought into focus. Previously confined to merely distributing releases and trying to be a point of contact for district and sub-district level media, now his task seems to be more empowering.

But what's behind this sudden urge of the Yogi sarkar to scrutinise news emerging from the grassroots? Clearly, while the government seems to be confident in managing its image in most national and regional media, it is unable to extend its reach further into the heartland, where most unflattering coverage seems to emerge from. It now expects skilled 'crisis' manager Sehgal and the army of babus at the tehsil level to plug the gaps.

Interestingly, Sehgal played a similar role when the UP government faced fire over the Hathras rape case. He also played a similar role under two previous state governments.

Ji, Mantriji

Senior Union Minister Nitin Gadkari, besides his considerable administrative prowess, is noted for being a 'task master'. He seems to take his reputation seriously. Recently, the man in charge of transforming the road transportation sector, said that babus should only say "yes, sir" to whatever the mantris say since the government runs on the diktat of the minister. Perhaps he was emboldened by the result of a recent "Mood of the Nation" survey

which named him as among the best performing ministers in the Modi sarkar. But clearly, even the most innovative and dedicated mantris can

late, there has been a spate of reports showing that the pace of new highway construction has faltered while several newly built highways have developed potholes or craters that belie Gadkari's claims. Some months ago, Gadkari had similarly publicly chastised his babus for the delays in executing road projects. Clearly, that rebuke did not have the desired effect.

A peeved mantri pulling up the errant babus is understandable, but how far can it be pushed? While the babus are maintaining a prudent silence, Gadkari's remarks will not go unnoticed. Babus have honed their skills of dealing with mantris of all ilk and saying 'Yes, Minister' requires the least effort on their part!

IPS officers shy off from Central deputation

Only three senior IPS officers have sought a posting on Central deputation, underlining the continuing shortage of All India Services officers in the Union government. This is despite 263 vacancies for IPS officers in at least 17 central organisations including CBI, IB and the central armed police forces. Most of these vacancies are of DIG and SP rank, besides openings in various Union ministries.

Sources have informed DKB that even the three officers who have shown interest are in the rank of superintendent of police. There is no offer from inspector general and above ranks of the IPS.

Perhaps the reluctance of senior IPS officers can be traced to the amended IPS tenure policy announced by the Home Ministry earlier in February, in which it did away with the mandatory requirement of empanelment of IPS officers at the DIG level. That several states are unwilling or slow to sponsor adequate numbers of officers for Central deputation is another aspect of the problem. And this one problem cannot be solved quickly, which means that the situation is unlikely to change in the near future.

hen Taliban leaders visited an elementary school in Kabul in October 2021, two months after retaking control of Afghanistan, several seven- or eight-year-old girls bravely stood up, one by one, to declare: "Our classes have resumed, but not for our older sisters. We have been promised that our older sisters will return to class, but this has not happened yet!"

ANYONE WHO CARES FOR THE COUNTRY'S FUTURE MUST STAND UP FOR ADOLESCENT GIRLS' RIGHT TO EDUCATION -AND WOMEN'S RIGHT TO WORK will return to class, but this has not happened yet!" Now, on the first anniversary of the Taliban's return to power, most of Afghanistan's 1,880 girls' secondary schools remain closed. And when women and girls demonstrated in Kabul this past weekend, calling for their educational opportunities to be restored, Taliban forces fired shots over the protesters' heads.

Islam's holy book, the Koran, encourages both women and men to read, contemplate, and pursue education. The Prophet Muhammad advocated education as a religious duty for males and females: "Seek education from the cradle to the grave," the Prophet instructed. But the Taliban's ban on schools for girls above sixth grade has made Afghanistan the only Muslim country to prohibit girls' secondary education.

In August 2021, the Taliban promised Afghans and the rest of the world that they would reopen all primary, secondary, and tertiary schools for both boys and girls. Girls' secondary schools were expected to reopen March 23 to coincide with the Persian New Year. But when the girls arrived at the school gates, armed Taliban guards refused them entry.

A few days later, dozens of female students protested near the Ministry of Education in Kabul. "Open the schools! Justice! Justice!" they chanted, holding banners declaring that "Education is our fundamental right, not a political plan." The Taliban, however, re-

main unconvinced. As a result, Afghanistan's girls, nearly one million of whom have no access to secondary education, are the world's most forgotten children and adolescents.

No one should remain silent in the face of this discrimination. Islam has 1.8 billion adherents, making it the world's secondlargest religious group, comprising 24% of the global population. In Indonesia, the largest Muslim-majority country, women's university enrollment has increased from 2% in 1970 to nearly 33% today. In Saudi Arabia, half of university-age women attend university, a higher rate than in Mexico, China, Brazil, and India.

According to a World Economic Forum report, 30% of the 450 million women in Muslim-majority economies are in paid work. Although women's labour-force participation rates vary widely – 74% in Kazakhstan, 53% in Indonesia and Malaysia, 42% in the United Arab Emirates, 33% in Turkey, 26% in Pakistan, and 21% in Saudi Arabia – they are increasing faster than for men in nearly all these economies. Muslim women's combined income of just under \$1 trillion would make them

the world's 16th most prosperous country.

After four decades of armed conflict and climate-induced natural disasters, Afghanistan is one of the world's poorest and least-developed countries. But the Taliban are denying the female half of the workforce the chance to help rebuild it. Afghanistan cannot afford to regress a quarter-century to the start of the Taliban's first stint in power in 1996, when the group prohibited women and girls from working outside the home, attending school and university, or leaving their homes unless accompanied by a mahram (husband, father, brother, or son). Back then, the Taliban's religious police meted out severe punishment, including stoning, for any infraction of their moral code.

Prior to the Taliban's 1996 takeover, 60% of Kabul University teachers (and nearly half the students) were women. In addition, women constituted 70% of schoolteachers, 50% of civilian government workers (and 70% of the 130,000 civil servants in Kabul), and 40% of doctors.

Today, with Afghanistan facing economic collapse, soaring poverty, and increasing risks of starvation, and unable to survive without humanitarian assistance, the Taliban are arguing that girls' current school uniforms are not Islamic. But most Afghans do not think long black tunics and pants and a white head scarf (hijab) designed in accordance with Hanafi jurisprudence will solve the country's many deep-rooted problems.

Nonetheless, the Taliban are threatening to close down those girls' secondary schools that have remained open in major provinces, such as Balkh in the north, unless they change their dress codes.

Meanwhile, some Taliban members who can afford to are sending their daughters abroad to study. Others are trying to convince the organisation's religious leadership in Kandahar to rethink the ban and let girls return to secondary school.

In March, the foreign ministers of the G7 countries and Norway, together with the European Union's High Representative for Foreign Affairs and Security Policy, issued a joint statement condemning the Taliban's refusal to reopen girls' secondary schools. "We call on the Taliban urgently to reverse this decision, which will have consequences far beyond its harm to Afghan girls," they said.

But more must be done. The international community, specifically countries in the region, and especially members of the Organisation of Islamic Cooperation, should make Afghan women's and girls' rights central to their diplomatic and economic negotiations with the Taliban. Afghanistan and its people have suffered enough. Anyone who cares for the country's future must stand up for adolescent girls' right to an education – and women's right to work.


Backronym

Abackronym (sometimes bacronym) is a reverse acronym. To create one, Ayou take a word that isn't an acronym and create a fictitious expansion for it. Some backronyms are designed as mnemonics. A classic example is the Apgar score to test the health of newborns. It was named after the American physician Virginia Apgar but to help student doctors and nurses remember the system, it has been changed to the acronym "Appearance, Pulse, Grimace, Activity, and Respiration". Similarly, the US Amber Alert programme is said to mean "America's Missing: Broadcast Emergency Response", though it was actually named after a missing child, Amber Hagerman. Backronyms are frequently humorous - Microsoft's Bing, some quip, is actually an acronym for "Because It's Not Google"; world-weary sailors say navy really means "Never Again Volunteer Yourself", some car owners hold that Ford stands for "Fix Or Repair Daily". Many of this type are actually reinterpreted acronyms, included by courtesy in the backronym collection because nobody has yet come up with a different -nym for them. For example, the name of the one-time Belgian national airline Sabena (which derives from "Société Anonyme Belge d'Exploitation de la Navigation Aérienne", bless the guy who shortened it) was said to be an acronym for "Such A Bad Experience, Never Again." Others are folk etymology: posh doesn't stand for "Port Out, Starboard Home". Wiki, the Hawaiian word that turns up in such sites as Wikipedia, doesn't mean "What I Know Is". Golf wasn't created from "Gentlemen Only, Ladies Forbidden". SOS doesn't mean "Save Our Souls" or "Save Our Ship", or indeed anything at all, since it was chosen as a particularly memorable and easily recognised Morse code sequence. Meredith Williams, in an entry to a competition in The Washington Post 8 November 1983, seems to have coined bacronym, as a portmanteau of back and acronym. Previously, lexicographer Ben Zimmer tells me, the form was called, somewhat cumbersomely, a prefabricated acronym as well as a reverse acronym. The word was popularised in July 1994 by another contest, in New Scientist, though it was then said to be a reinterpreted acronym, neither the original nor the current principal sense.

The term was coined by scifi novelist Neal Stephenson in his 1992 book Snow Crash, which depicts a hyper-capitalist dystopia in which humanity has collectively opted into life in virtual environments. So far, the experience has been no less dystopian here in the real world. Most experiments with immersive digital environments have been marred immediately by bullying, harassment, digital sexual assault. and all the other abuses that we have come to associate with platforms that "move fast and break things.

None of this should come as a surprise. The ethics of new technologies have always lagged behind the innovations themselves. That is why independent parties should provide governance models sooner rather than later – before selfinterested corporations do it with their own profit margins in mind. The evolution of ethics in arti-

published (and republished) research into the dangers of training AIs on biased data sets. A new language was developed to incorporate into the design of new AI applications the values that we want to uphold.

Owing to this work, we now know that AI is effectively "automating inequality," as Virginia Eubanks of the University of Albany, SUNY, puts it, as well as perpetuating racial biases in law enforcement. To call attention to this problem, computer scientist Joy Buolamwini of the MIT Media Lab launched the Algorithmic Justice League in 2016.

This first-wave response aimed a public spotlight at the ethical issues associated with AI. But it was soon eclipsed by a renewed push within the industry for self-regulation. AI developers introduced technical toolkits for conducting internal and third-party evaluations, hoping that this would alleviate public fears. It didn't, because most firms pursuing AI development have business models that are in open conflict with the ethical standards that the public wants them to uphold.

More recently, corporate consultants and various programmes have professionalised AI ethics to address the reputational and practical risks of ethical failures. Those working on AI within Big Tech companies would be pressed to consider questions such as whether a function should default to opt-in or opt-out: whether it is appropriate to delegate a task to AI or not; and whether the data being used to train AI applications can be trusted. To that end, many tech corporations established supposedly independent ethics boards. However, the reliability of this form of governance has since been called into question following high-profile ousters of internal researchers who raised concerns about the ethical and social implications of certain AI models

Establishing a sound ethical foundation for the metaverse requires that we get ahead of industry self-regulation before it becomes the norm. We also must

of behavioural risks that most people will not have considered.

It would be better to overestimate the risks than to repeat the mistakes of the past 15 years. A wholly digital environment creates the potential for even more exhaustive data collection, including of personal biometric data. And since no one really knows exactly how people will respond to these environments, there is a strong case for using regulatory sandboxes before allowing a wider rollout.

Anticipating the metaverse's ethical challenges is still possible; but the clock is ticking. Without effective independent oversight, this new digital domain will almost certainly go rogue, recreating all the abuses and injustices of both AI and social media – and adding more that we have not even foreseen. A Metaverse Justice League may be our best hope.

The decision to abolish it and the expulsion of OPS and his supporters from the AIADMK at the July general council meet indicate that EPS is aiming for complete control of the party. However, his leadership skills will be severely tested as the dissident factions besides OPS, there is Sasikalaa and TTV Dinakaran waiting to take over the party are likely to push back.

New Delhi, August 19: Amid the buzz that Bihar Chief Minister Nitish Kumar may emerge as the opposition's prime ministerial candidate, his party Janata Dal (United) said Friday that this is an option if other parties want.

JD(U) president Lalan Singh said Kumar's main focus is on uniting opposition parties to take on the BJP in the 2024 Lok Sabha polls and he will visit the national capital to meet leaders from various parties after the vote of confidence in the Bihar assembly next week.

Kumar, Bihar's longest serving chief minister and the main face of the JD(U), is not a contender for the opposition's prime ministerial candidate, his close aide Singh said. Asked for the party's view in case of other opposition parties backing him to take on the mantle, he said, "If other parties decide and want so, then it's an option."

The JD(U) president and Lok Sabha MP noted that many opposition leaders, including Sharad Pawar and Arvind Kejriwal, called up Kumar to congratulate him after he snapped ties with the BJP and allied with its rivals to form a new government in Bihar. Singh asserted that Kumar has all the required attributes to be a prime minister while stressing that he

is not a contender for the job. He said all opposition parties should sit together to decide on the leadership to take on the Prime Minister Narendra Modi-led BJP in the next Lok Sabha polls. "Or, all parties should fight unitedly to defeat the BJP and decide later who will be their leader. Both options are there. Nitish Kumar will work on bringing all other parties fighting the BJP on one platform to pose a united challenge to its rule," he said.

Kumar's decision to break ties with the BJP, his ally since 1996 except for the period between 2013 and 17, has fuelled speculation about his prime ministerial bid. BJP leaders have claimed that it was this ambition which was behind his decision to join hands with the RJD-Congress-Left alliance.

Kumar has rejected such claims. There is a view that his image untainted by allegations of corruption and nepotism -- twin planks of the BJP to target most opposition parties including the Congress - makes him a strong choice for the leadership role of the joint opposition.

Coming from Kurmi caste, which falls in Other Backward Classes (OBC) category, Kumar also ticks right boxes in terms of his social profile, his supporters say.

Lalan Singh also made light of the BJP's target of winning at least 35 of the 40 Lok Sabha seats in Bihar, and claimed the party will lose 40 seats from its 2019 tally in Bihar, West Bengal and Jharkhand alone.

Losing 40 seats will reduce the BJP's tally to below the majority mark, he noted, saying the ruling party should worry about its fate across the country in such a scenario.

Serve notice to accused before IAF contingent lands in Aus enhancing sentence: SC to HCs

New Delhi, August 19: The Supreme Court has said that high courts are required to give notice to the accused before enhancing sentences so that they get an opportunity to defend their case. A bench of Justices B R Gavai

and P S Narasimha set aside an order of the Rajasthan High Court which had awarded life term for the rest of their life to accused in a murder case. The top court noted that it was the appellants who had challenged their conviction by way of an appeal before the high court.

It also took into account that the State had not appealed against the order of the Sessions Judge not awarding death penalty to the appellants. "No doubt that the high court could have itself exercised suo moto powers and enhanced the sentence. However, prior to doing so, the high court was required to

give a notice to the appellants. Admittedly, the same has not been done. "As a result of the judgement and order of the high court, the sentence awarded to the appellants has been enhanced without the appellants having an opportunity to defend their case as to why the enhanced sentence should not be granted," the bench said.

The apex court was hearing a plea filed by two accused challenging an order of the Rajasthan High Court which observed that the case against the present appellant fell within the category of 'rarest of the rare cases'.

It was further held that the trial court has failed in not considering the present case to be falling in the category of 'rarest of the rare cases' for the purpose of awarding death sentence. The high court had directed that the appellants shall undergo imprisonment for the rest of their life for the offence punishable under Section 302 of the IPC

Demolition teams race against time to rig Noida Twin Towers **THE ENGINEER SAID EXPERTS HAVE CHOSEN PLASTIC EXPLOSIVES OF A VARIETY USED IN THE CIVILIAN SECTOR FOR HEAVY-DUTY BLASTING, AND NOT MILITARY-**

Noida, August 19: Teams of experts are racing against time to install four tonnes of explosives into the stripped down skeleton of Noidas Twin Towers marked for demolition on August 28 in the most daring such exercise in Indias history. Engineers from South Africa

and Mumbai are working non-stop for the precision demolition of Apex and Cayenne towers, comprising 915 flats, which took three years to build but were deemed illegal by the Supreme Court, signalling zero tolerance for dodgy builders.

The illegal towers rising up to 103



metres nestle between upmarket societies called ATS Village and Emerald Court in Sector-93A, but they are only nine metres from the latter's Aster-2 apartment block. Edifice Engineering, the Mumbai-based demolition agency tasked with the job, said work is going on at full speed to pack some 7,000 drilled holes with explosives.

"The charging (with explosives) of Cayenne is complete and so far we have rigged up to the 10th floor of Apex," Project Director Mayur

Mehta said. The engineer said experts have chosen plastic explosives of a variety used in the civilian sector for heavy-duty blasting, and not military-grade products. But anxiety was visible among

Emerald Court residents, who must vacate their flats at 7 am for the better part of August 28 as a precaution against the inevitable cloud of dust and shooting stones.

Some residents joined a 'Kirtan' on Friday to seek divine aid for unflawed demolition, the second big one since 2020 when Edifice flattened four blocks comprising 350 flats in Kerala which were half the height of the Noida towers.

"Some 40,000 tonnes of debris will come down in a matter of sec-

onds, so the question on the mind of many of us is in which direction the towers will fall," said Aster-2 resident Pratap Chakravarty.

Edifice has assured that the falling debris will be directed towards a service road and in the worst scenario, chunks of concrete may flatten a tiny section of a compound wall of ATS.

'We can only pray because this is the largest demolition in India and there are also nagging doubts over the integrity of our foundation pillars," Ajay Mehra, another Aster-2 resident, said.

Guwahati, August 19: The anti-CAA (Citizenship Amendment Act) agitations returned to the northeastern region after two years with the influential North East Students' Organisations (NESO) staging protests across the capitals

of northeastern states Wednesday in support of various demands including scrapping of the contentious law.

In Assam, a protest meeting was held by the All Assam Students Union (AASU) against the CAA. The AASU is one of the constituents of the NESO, an apex

students' body of eight organisations in the northeastern region. NESO Advisor and AASU leader Samujjal Bhattacharya said that NESO staged peaceful protests at

all the state capitals. The protest is also pertaining to issues related to floods, influx of migrants, complete scrapping of

the Armed Forces Special Powers Act, providing constitutional safeguards to the indigenous communities, the imposition of Inner Line Permit (ILP) to protect the indigenous people in all northeastern states and implementation of the Clause 6 of the Assam Accord,

The anti CAA protests had first started in Assam, parts of West Bengal and other northeastern states in 2019 and continued for some time till 2020 before the outbreak of Covid-19 pandemic.

At least five persons were killed in the protests against the CAA in Assam, which also witnessed largescale violence and imposition of curfew for several days.

Besides the NESO, AASU, var ious tribal organisations, political parties including Congress and Left parties have strongly opposed the CAA.

The CAA seeks to grant Indian citizenship to non-Muslims minorities - Hindus, Sikhs, Buddhists, Jains, Parsis and Christians, who have migrated from Bangladesh, Pakistan and Afghanistan till December 31, 2014, after facing faith-based persecution.

Thiruvananthapuram, August 19: Kerala's ruling CPI(M) Friday described as 'unconstitutional' Governor Arif Mohammad Khan's decision to stay the controversial appointment of a Malavalam Associate Professor in Kannur University and rejected his "favouritism and nepotism" charge over her nomination to the var-

sity. The ruling party claimed nothing 'illegal' was committed by the university authorities in connection with the appointment of a CPI (M) leader's wife as the associate professor.

Rejecting charges of the Governor that the varsity's move appears to be a case of 'favouritism and nepotism', CPI(M) State Secretariat member AK Balan hit back at Khan, saying his appointment to the constitutional post was also a politically motivated decision.

"The stand taken by the Governor is unconstitutional, violation of the Kannur University Act and also against natural justice,' Balan, who is also a former law minister, said in response to Khan's allegations.



Talking to reporters in New Delhi late Thursday, the Governor had also alleged that Kannur University's move to appoint Chief Minister's secretary's wife Priya Varghese as an associate professor in its Malayalam Department was 'political'.

"The process of the appointment...It appears to be a case of favouritism and nepotism. A person who is not qualified to be appointed as an assistant professor prima facie is being appointed because she is the spouse of the secretary to the chief minister. This is political. There is absolutely no

doubt," Khan had said.

Varghese had been proposed to be appointed as an associate professor in the Malayalam Department by Kannur University, which triggered a huge political row as she had the lowest research score but the highest in the interview round and was declared first

in the selection process. Backing the Governor, Congress leader and Leader of Opposition in the state Assembly, VD Satheesan, has said Khan had actually used his power to prevent Kannur University's attempt to make an illegal appointment.



K9 dog squad tracking down poachers in Assam

Guwahati, August 19: A trained dog squad in Assam, billed as the first of its kind in the country, is helping to track poachers in the national parks and wildlife sanctuaries of the state and assist forest security personnel in their conservation efforts

The nation's first dog squad for wildlife crimes was set up in Assam under the initiative of biodiversity organisation 'Aaranyak' in 2011 with one male Belgian Malinois named Zorba

The dog squad known as the 'K9 unit' has over the years evolved into a "very efficient and well trained one" in tracking down wildlife crimes, said Bibhab Talukdar, the secretary general of the body which has undertaken the effort.

The squad, set up in 2011 by Aranyak with just one Belgian Malinois, now has seven dogs with more than one handler for each of them. Two other dogs are undergoing training here, Talukdar told PTI.

Zorba, the first canine of the squad, is credited with helping to nab 60 poachers, 50 of them in Kaziranga National Park, which is known globally for its one-horned rhinos. The dog had served mostly in KNP from 2012 till his retirement from service in 2019. On Independence Day that year he was honoured with a traditional 'gamosa' and a citation.

He was also deployed on various occasions in other national parks. One incident of his expertise in tracking poachers stands out in Orang National Park in the state.

He had then given vital clues from the scene of crime leading to the identification of the suspect's house outside the Park. Later the accused was arrested by forest and police officers, Talukdar said.

Principal chief conservator of forest and head of forest force MK Yadava said that he was very fortunate to have worked with Zorba at Kaziranga.



"Those were difficult days as poaching was at its height and the K9 team made so much difference in dealing with wildlife crimes," he said.

Zorba's lone handler Anil Das said that he is enjoying a retired life at the K9 camp here with no duty in harsh field conditions and better health care.

It is now the turn of his suc-

cessors - Leon, Jubi and Emy to keep guard in the different ranges of Kaziranga. Then there is Misky in Pobitora wildlife sanctuary, Sheela in Raimona and Veera in **Orang National Park**

Hawala operator for LeT, Al-Badr arrested

New Delhi, August 19: In a joint operation, Delhi Police and Jammu and Kashmir police in assistance with central agencies arrested a Hawala operator for funding terror outfits LeT (Lashkar-e-Taiba) and Al-Badr. The accused was identified as

Mohammed Yaseen. "Inspectors Sunil Kumar Rajain and Ravinder Joshi under ACPs Lalit Mohan Negi and Hridaya Bhushan were working on an information. They held Yaseen, a resident of Turkman Gate in Delhi. He was working as an agent in Hawala transactions related to funding of terror outfits LeT and Al-Badr. August 17, Yasin gave around

Rs 10 lakh to a terror operative Abdul Hamid Mir of J&K for further use in terrorist activities in J&K. In this regard, J&K Police registered a case and had arrested Abdul Hamid Mir from Jammu Bus Stand along with the terror funding amount of Rs 10 lakh,' said HGS Dhaliwal, the DCP of Special Cell.

The official said that on August 18, information was received from central agencies and J&K police regarding a person engaged in funding of terrorist activities and operating from Meena Bazar, Delhi itself.

After receiving the information, a raiding team was constituted and deployed in and around area of Meena Bazar. Yaseen was finally held. The police said that they have recovered cash Rs 7 lakh and a cell phone from him.

"Yaseen is a garment trader by profession and was operating from Meena Bazar. He worked as a conduit of Hawala money, collected



funds received from sources based abroad and further delivering to terror operatives in J&K," the official said. During interrogation, Yaseen disclosed the police that the Hawala money was being sent to Surat and Mumbai through South Africa.

Yaseen was the Delhi link in this Hawala chain and from Delhi this amount was further transferred to J&K through different couriers. This amount is further given to operatives of banned terror outfit LeTs and Al-Badr in J&K.

transporting funds from different parts of India to J&K. Recently, he received Rs 24 lakh sent via Hawala from South Africa. out of which he transferred Rs 17 lakh through two different couriers to terror operatives in J&K. was again present at a meeting of the pollution control board, seated next to his brother-in-law minister. The course of events drew strong condemnation from the BJP, which has lost power following the volte-face by the chief minister last week

"Tej Pratap Yadav remains in



Now, as a minister he seems to have outsourced his duties to his brother-in-law," said Sushil Kumar Modi, a senior BJP leader who had served as the state's deputy CM for over a decade.

"Lalu ji's son-in-law was not just present at the meetings. The meetings, where he had no business to be present, were in fact being conducted (sanchaalit) by him," alleged Modi in a statement. It is for the chief minister to answer the people of Bihar on this, he said.

"His new government has a large number of ministers with criminal records which confirms fears of the return of jungle raj in the state. The incident involving Lalu ji's son-in-law is a clear sign that the RJD supremo will try to interfere in the workings of the new government," Modi, now a Rajya Sabha MP, added.

RJD leaders were, predictably, tight-lipped over the embarrassing episode while those in the chief minister's JD(U) said they could comment only after it became clear why Shailesh Kumar was present at the two meetings.



Speed-boat 'scare': ATS files FIR

Mumbai, August 19: After probing the drifted 'speed-boat scare' on Raigad shores, the Maharashtra Anti Terrorism Squad (ATS) has filed a complaint against unknown persons, officials said here on Friday

ATS chief Vineet Agarwal, who rushed to Raigad along with his team, and the Raigad Police have investigated the matter, and a possible terror angle has been discounted for the present. On Thursday, the state security apparatus went into a tizzy after the severely damaged yacht washed up on Harihareshwar beach, around 200 km south of Mumbai, as the fisherfolk alerted the local authorities. The UK-flagged 53-feet-long yacht 'MY Lady Han', owned by an Australian couple, was found with some documents, three AK-47 rifles and boxes containing live ammunition, sparking a major security scare in the state. The Navi Mumbai ATS Unit is handing the probe and has filed a first information report invoking various sections of the Arms Act against unknown persons. Later, a Dubai-based Neptune P2P Group announced that it had provided security to the yacht in June 2022. The Maharashtra government informed the legislature that the speedboat suffered an engine failure in the high seas on June 26 and the crew on board were rescued

MONKEYPOX: SERO-SURVEY PLAN ON CARDS

According to WHO, monkeypox is a viral zoonosis -- a virus transmitted to humans from animals -- with symptoms similar to smallpox although clinically less severe

New Delhi, August 19: The Indian Council of Medical Research may conduct a sero-survey among contacts of monkeypox patients to check for the presence of antibodies and find out how many of them were asymptomatic, official sources said Friday.

As of now, it is not known what is the proportion of people who stay asymptomatic of the viral infection, they said. India so far has reported ten cases of monkeypox. "We are thinking of conducting a sero-survey among close contacts of monkeypox-affected people in India to check for the presence of antibodies in them. "The idea is to find out how many of them contracted the disease due to exposure to the infected and did not show symptoms. The discussions

It can also be transmitted through direct contact with body fluids or lesions, and indirect contact with lesion material such as through contaminated clothing or linen of an infected person. Animal-to-human transmission may occur by bite or scratch of infected animals or through bushmeat preparation.

Wind drives major wildfire in Spain

Madrid: A wildfire burning out of control in the eastern province of Valencia has become one of the biggest this year in Spain, having already scorched more than 19,000 hectares (47,000 acres) along a 120-kilometre (75mile) perimeter, authorities said Friday. Some 35 aircraft have been deployed as the blaze entered its fifth day. 
Moscow, August 19: Russian President Vladimir Putin warned his French counterpart Emmanuel Macron that shelling of the Russian-controlled Zaporizhzhia nuclear power plant in southern Ukraine, which he blamed on Kyiv, could result in a large-scale disaster.

Moscow and Kyiv have accused each other of shelling Europe's largest nuclear power plant, which was captured by Russia in March but is still run by Ukrainian technicians. Only two of the facility's six reactors are working.

"Vladimir Putin, in particular, stressed that the systematic shelling of the territory of the Zaporizhzhia nuclear power plant by the Ukrainian military created the danger of a large-scale catastrophe that could lead to radiation contamination of vast territories." the Kremlin said in a readout of the call, which it said had been initiated by Macron.

WHO recommends use of two antibody drugs against Ebola

Geneva, August 19: The World Health Organisation said Friday that two existing treatments dramatically reduced deaths from Ebola and should be given to people of all ages suffering from the often-fatal haemorrhagic disease.

Publishing its first-ever guidelines on which therapeutics to use against Ebola, the UN health agency strongly recommended using two monoclonal antibodies, mAb114, also known as Ansuvimab or Ebanga, and REGN-EB3, or Inmazeb. Studies had showed that the two treatments significantly "reduced mortality," Janet Diaz, lead of the clinical management unit in the WHO's Health Emergencies programme, told reporters in Geneva. Depending on the standard of care, she said they could save between 230 and 400 lives for every 1,000 people infected.



Pilots fall asleep at 37,000 feet, miss landing

Addis Ababa, August 19 :Two pilots are believed to have fallen asleep and missed their landing during a flight from Sudan to Ethiopia, media reports said.

The incident took place onboard an Ethiopian Airlines Boeing 737-800 enroute from Khartoum to Addis Ababa, according to a report by commercial aviation news site Aviation Herald, CNN reported.

Data obtained by the website indicates that the aircraft was cruising at 37,000 feet on autopilot when it failed to descend at Addis Ababa Bole International Airport, its scheduled destination, August 15. Air traffic control were apparently unable to reach the crew despite making several attempts at contact. However, an alarm was triggered when the plane overshot

mulative, has become Southwest Airlines' number-one safety threat," the Southwest Airlines Pilots Association, or SWAPA, told airline executives in a letter back in April, CNN reported.



Mumbai, August 19: The country's foreign exchange reserves fell \$2.238 billion to \$570.74 billion in the week ended August 12, according to the Reserve Bank of India (RBI) data.

In the previous week ended August 5, the foreign exchange reserves declined \$897 million to \$572.978 billion.

The fall in the reserves in the reporting week ended August 12 was on account a decline in the Foreign Currency Assets (FCA), a major component of the overall reserves, according to the Weekly Statistical Supplement released by RBI Friday.

FCA declined \$2.652 billion to \$506.994 billion, the data showed. Expressed in dollar terms, FCA



includes the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.

Gold reserves surged \$305 million to \$40.618 billion. The Special Drawing Rights (SDRs) increased \$102 million to \$18.133 billion.

The country's reserve position with IMF also rose by \$7 million to \$4.994 billion in the reporting week, as per the data.

Ghosh noted that the word 'free-

bies' indicates the class position of those who use it. Observing that if the political

process makes political parties respond to such needs, these should not be seen as freebies, Ghosh said, in fact, the poor in India pay a larger share of their income in taxes than the rich because of the dominance of indirect taxes in tax collection.

Miami. August 19: Indian prodigy R Praggnanandhaa handed World No.6 Levon Aronian a 3-1 thrashing in the fourth round to notch up his fourth consecutive win in the FTX Crypto Cup, the American finale of Champions Chess Tour, Friday.

The 17-year old Indian is in joint lead with 12 match points along with World No.1 Magnus Carlsen, who defeated Quang Liem Le of China 3-1.

Praggnanandhaa won the third game with white pieces after the first two in the four-game match ended in a stalemate. First, he won with white pieces to take a 2-1 lead after game three and stormed to victory in 44 moves in the fourth to seal an emphatic win over the acclaimed American star.

Having started his campaign with victory over Alireza Firouzja, the Indian GM has subsequently beaten Anish Giri and Hans Nieman. Carlsen, meanwhile, secured a similar result, winning games three and four after the first two were drawn.

Praggnanandhaa and Carslen have a four-point lead over Alireza Firouzja, the World No.4 and the topranked junior.

Firouzja edged out Poland's Jan-Krzystof Duda 2.5-1.5 in another fourth-round clash while Dutchman Anish Giri scored his first win in the tournament, beating Hans Nieman by a similar margin.

Three more rounds remain to be played in the eight-player tournament. The eight-player all-play-all tournament is the American finale of Champions Chess Tour. There is USD 7,500 at stake for each match win at the event. Each match will be played over four rapid games, with blitz tie-breaks in case of a 2-2 draw
