3 held in fake certificate case

Berhampur, August 21: Police Sunday arrested three persons, two on charge of producing fake resident certificate in Army recruitment rally last year near Berhampur University, while another for making the forged documents for them in Ganjam district.

B Lokesh (20) and B Umapatti Reddy (20) of Suvani village under Golanthara police station had allegedly produced fake resident certificates to get job in the Indian Army, while Banamali Behera (24), owner of a common service centre (CSC) of the same village allegedly made the forged documents for them, said police.

Police seized two fake resident certificates and two original certificates of other candidates and a computer in the case.

During the Army recruitment rally held from March 25 to April 6, last year, Lokesh and Reddy had allegedly produced the fake resident certificates, after they were selected in the physical tests.

The recruitment officers, however, were suspicious about their documents and lodged complaints with the police for verification.

During the inquiry, the tehsil office at Chikiti replied that these documents were fake, said Additional SP (Berhampur) Ramesh Chandra Sethi.

The duo revealed that they had produced the fake resident certificates in the CSC of Behera, he

Car swept away, 2 bodies fished out

Sambalpur: Two persons were killed after the car they were driving was swept away in floodwaters here Saturday night. The mishap occurred when the duo -- Tapas Nayak and Pratap Patel - was crossing the Naktipali nullah under Kuchinda police limits. They were natives of Gunduruchuan. After several hours of search, the car and the bodies were retrieved by rescue personnel Sunday morning. Police have registered a case and sent the bodies for autopsy. The two, who were brothers-in-law, had gone to distribute cards for the post death rituals of their uncle who had passed away a few days ago.

"Involve functionaries of the Panchayati Raj System, women self-help groups and others concerned in evacuating people," Jena

said in a message to the District Collectors of Balasore and Mayurbhanj. All the rivers flowing through north Odisha are in spate

deep depression over the Bay of Bengal, and subsequent floodwater release from Jharkhand, According to Jena, nearly 6 lakh cusecs of water were discharged by Jharkhand from Galudih barrage on the Subarnarekha river system, following a heavy downpour.

Most rivers flowing through the northern region of Odisha into the Bay of Bengal originate in neighbouring Jharkhand. Four blocks in coastal Balasore district – Baliapal, Bhograi, Basta and Jaleswar - were identified as most

vulnerable to the latest flooding. Sunday, Chief Minister Naveen Patnaik delegated powers of a Special Relief Commissioner to the Collector of Balasore district so that the local administration could be more effective. A helicopter was also placed at his disposal to deal with any emergency.

Odisha is already reeling under the impact of moderate floods in the Mahanadi river system following incessant rainfall, which has affected above 7 lakh people. Nearly 5 lakh are still marooned in 763 villages, according to government estimates.

New Delhi, August 21: Universities and higher education institutions across the country will now be allowed to create up to 25 per cent supernumerary seats for foreign students in their undergraduate (UG) and postgraduate (PG) programmes, UGC chairman Jagadesh Kumar has told PTI.

There will be no entrance tests for these admissions, Kumar said, adding that the decision was taken at a meeting of the UGC held last week to discuss "internationalisation of UG and PG programmes in India."

The supernumerary seats will be created over and above the total sanctioned strength and the decision regarding these seats will be taken by concerned higher educational institutions (HEIs) according to specific guidelines and regulations issued by the regulatory bodies considering the infrastructure, faculty and other requirements.

"Indian HEIs may admit international students based on the equivalence of entry qualifica-

tion held by them. The equivalence is to be determined by UGC or any other body recognised by UGC for such purpose or the concerned regulatory bodies of the country, HEIs may adopt a transparent admission process for admitting the international students," Kumar told PTI.

"HEIs may create up to $25~\mathrm{per}$ cent supernumerary seats for international students, over and above of their total sanctioned enrolment for undergraduate and postgraduate programmes. The decision regarding 25 per cent supernumerary seats has to be carried out by the concerned higher educational institutions as per specific guidelines/regulations issued by the regulatory bodies considering the infrastructure, faculty and other requirements," he added.

The supernumerary seats for international students will not include the international students under exchange programmes and through Memorandum of Understanding (MoU) between institutions or between Indian government and other countries.

CBI should probe ₹10,000cr liquor scam in Guj: Sisodia

New Delhi, August 21: Delhi Deputy Chief Minister Manish Sisodia Sunday said he was not afraid of a CBI probe but the agency should also investigate the alleged Rs 10,000-crore illicit liquor scam in Gujarat and the Bundelkhand Expressway construction scam as the road developed cracks just five days after the Prime Minister inaugurated it.

In an interview with PTI, Sisodia, who is among 15 people and entities named in an FIR registered by the CBI in connection with alleged irregularities in the implementation of the excise policy, said his party was not scared of any investigation and asserted that the scams being alleged by BJP leaders were nothing but "shagufe (lies).

'The CBI should investigate the scam of Rs 10,000 crore happening every year in Gujarat, where prohibition is in place but still people are dying by con-



suming illicit liquor. The Bundelkhand Expressway caved in five days after being inaugurated by Prime Minister Modi. It has brought disgrace to the nation. There was corruption involved. You should investigate us and everyone else also. We are not against investigation or probe," the deputy chief minister said.

Mobile internet shut to prevent exam malpractices

OVER 14.30 LAKH CANDIDATES ARE ASPIRING FOR NEARLY 30,000 GRADE III AND IV POSTS IN ASSAM



Guwahati/Silchar, August 21: Mobile internet services across 25 districts of Assam were suspended for four hours Sunday to prevent possible malpractices as the state government conducted written examinations for Grade IV posts in its various departments.

Besides, prohibitory orders under Section 144 CrPC were promulgated in the districts where the examinations were on, a top government official said.

The principal of Cachar College in Silchar was detained by the police for alleged gross negligence of duty in conducting the examination.

Police said the deputy commissioner of Cachar district had filed an FIR at the Silchar Police Station this morning against the princi-

pal, Siddhartha Sankar Nath, after visiting the institution. The DC claimed that the principal had failed to conduct the examination as per the guidelines issued for the purpose.

Nath was detained on basis of the complaint, police said. More than 14.30 lakh candidates are expected to appear for nearly 30,000 Grade III and IV posts, with the examinations scheduled for

August 21 and 28, and September 11. While the Grade IV examinations took place Sunday in two shifts, tests for Grade III posts will be held on the other two dates. All examinations are being conducted by the Board of Secondary Education, Assam (SEBA).





Kerala HC Registrar General seeks action against Berhampur jail supdt

Bhubaneswar, August 21: The Registrar General of Kerala High Court has asked the Director General of Police (DGP) of Odisha to take action against the superintendent of Berhampur Circle Jail for dereliction of duty, an official said Sunday.

According to sources, Thufan Malik, a resident of Jahada village under Gangapur police limits in Ganjam, was working as a daily wager at Mathilakam in Kerala.

In 2019, Malik and three others had a scuffle with a 24-year-old man over a trivial issue and in a fit of rage they killed the man.

The Mathilakam police registered a case (583/19) under Sections 323,324,326,302, 201 and 34 of the IPC and arrested the accused including Malik.

Malik walked out of jail on bail March 18, 2021. While granting bail, the court had asked Malik not to leave Kerala and to appear before it on regular basis. Malik, however, fled to Odisha, flouting the court's directions.



Bhubaneswar, August 21: With less than five months left for the FIH Men's Hockey World Cup 2023 to commence, hockey lovers across the world are excitedly looking towards Odisha, which will host the mega sporting event.

As Odisha is not only the hosting state, but also sponsoring the national men's and women's hockey teams, it is leaving no stone unturned to make the event more memorable than the previous World Cup, which was also hosted here.

The Hockey World Cup will be held in Rourkela and Bhubaneswar from January 13 to 29, 2023. Several players, coaches and FIH officials have lauded the marvellous hockey stadium inside the iconic Kalinga Sports Complex in Bhubaneswar, where the last edition of the World Cup was organised.

Apart from the Kalinga Stadium. the 2023 World Cup matches will also be played at the Birsa Munda International Hockey Stadium in Rourkela of Sundargarh district.


Sundargarh district is said to be the heart of hockey in India as the region has produced several international hockey players such as former captains Dilip Tirkey, Ignace Tirkey and Prabodh Tirkey in the men's team and Subhadra Pradhan and Jyoti Sunita Kulu in the women's team.

It has also produced more than 60 international hockey players, including Olympians Lazarus Barla, William Xalco, Birendra Lakra and Sunita Lakra. Three players from Sundargarh -- Deep Grace Ekka (women's team), Amit Rohidas and Birendra Lakra - made it to the 2020 Tokyo Olympic Games.

Recognising the talents of the soil, Naveen Patnaik took the decision to build the country's largest hockey stadium soon after Odisha was selected by the International Hockey Federation (FIH) to host its flagship event for the second time in a row.

Besides the main stadium, which will have a 20,000 seating capacity, a practice pitch is also being developed nearby.

On the other hand, Kalinga Stadium is also being upgraded. Recently, a brand new turf has been laid for the upcoming World Cup. Apart from the stadiums, the

Bhubaneswar, August 21: The state's COVID-19 tally rose to 13,25,061 Sunday as 287 more people, including 62 children, tested positive for the virus, a health department bulletin said.

The death toll mounted to 9,163, with one more patient succumbing to the infection, it said.

The state had logged 320 fresh infections and one fatality Saturday. Odisha now has 2,485 active cases, while 13,13,360 patients have recovered from the dis-



Unlike adults, cognitive deficit in children had a finite risk horizon (75 days) and a finite time to equal incidence (491 days).

"Children have a more benign overall profile of psychiatric risk than do adults and older adults, but their sustained higher risk of some diagnoses is of concern,' said the study.

A sizeable proportion of older adults who received a neurological or psychiatric diagnosis, in either cohort, subsequently died, especially those diagnosed with dementia or epilepsy or seizures.



Just after the emergence of the delta variant, increased risks of ischaemic stroke, epilepsy or

seizures, cognitive deficit, insomnia, and anxiety disorders were observed, compounded by an increased death rate.

"With Omicron, there was a lower death rate than just before emergence of the variant, but the risks of neurological and psychiatric outcomes remained similar," revealed the study, led by researchers at the University of Oxford in the UK.

The observational study extracted data from the 'TriNetX' electronic health records network, an international network of deidentified data from health care records of approximately 89 million patients collected from hospital, primary care, and specialist providers (mostly from the US, but also from Australia, the UK, Spain, Bulgaria, India, Malaysia,

and Taiwan). "This analysis of 2-year ret-

rospective cohort studies of individuals diagnosed with Covid-19 showed that the increased incidence of mood and anxiety disorders was transient, with no overall excess of these diagnoses compared with other respiratory infections," the researchers noted

In contrast, the increased risk of psychotic disorder; cognitive deficit, dementia, and epilepsy or seizures persisted throughout.

"The fact that neurological ২ and psychiatric outcomes were similar during the Delta and Omicron waves, indicate that the burden on the health-care system might continue even with variants that are less severe in other respects," the researchers warned.

nomic and health needs of the elderly and to create a social milieu which is conducive and sensitive to their emotional needs.



Preserving ancient memories through digitisation

he elders of the Wancho community in a remote district of Arunachal Pradesh have taken up the task of recording their age-old folktales in digitised form with the help of a UK-based researcher.

The researcher, Tara Douglas, who spent over three years even during the COVID-19 pandemic with the community elders and workers in Longding district to document the folktales, is helping them to digitally archive the folklores.

The Wanchos have a rich tradition of oral stories, memories, and songs and Douglas was invited to assist them to make the recordings. "The knowledge of the ancestors that has accumulated over generations is a record of life as it has been lived for centuries in this little-known area of the Patkai hills.

known area of the Patkai hills.
"It is the history of the cultural practices and rituals, the precise knowledge of livelihood practices, of plants, animals, the climate and geography. It is the collective memories

of the community," Douglas said. The researcher was introduced to the community when she first visited Kamhua Noknu in 2019 and has since been working with local project partners to record, translate and catalogue the material.

The venture that began in 2019 has led to further visits to some of the villages of the Pongchau and Wakka circles of the district to record local stories.

The Wancho tribe, with a population of nearly 57,000 members, inhabits mostly the Longding district that borders Myanmar.

"The pattern of life is changing rapidly as the district becomes more integrated and accessible to the outside world. Younger people are acquiring new priorities for education and employment, and they have much less time than before to listen to the memories of their parents and grandparents," Douglas told PTI.

Before the demise of the tradition bearers of the village and the disappearance of the knowledge that they hold, the elders are recording their memories, she said.

Literary Mission, have been the interlocutors for Douglas, facilitating introductions to the storytellers and sitting patiently hour after hour with her to translate the recordings into English so that the videos can be subtitled.

The storytellers whose memories have been archived include, Late Ngamchai Wangsa and Nyemnoi Wangsa, Tangkaam Pheam, Wanjay Losu, Phawang Wangham, Gamlong Gampa, Wanghom Losu and

Wanchan Losu from Kamhua

Noknu; Chaidang Dangam from Nyinu and Ngompha Wangsa from Longkai village.

"The archive will be expanded to include more stories from Kamhua Noknu and the neighbouring villages," Douglas, the secretary of Adivasi Arts Trust, a UK-based charity said.

Arunachal Pradesh with recorded 26 major tribes, 110 subtribes, and many unrecorded subtribes is a research hub for anthropologists.

With the recommendation of Stephen Morey, a linguist who specialised in the study and documentation of various languages of the region, Douglas also stored the Wancho folk tales in the Pacific and Regional Archive for Digital Sources in Endangered Cultures (PARADISEC), a digital record of some of the small cultures and languages of the world.

PARADISEC is a consortium of three universities - the University of Sydney, the University of Melbourne, and the Australian National University.

Some of the folktales of the com-

munity archived include Folktale of the Story of the Gourd, Cultural memory of death and the soul, Folktale of Tiger Man Cicada, Folktale of the Story of the Gourd, second version; Folktale of the story of the Stone and Memories of traditional rituals.

Little is known about the rich oral traditions of the indigenous, tribal and Adivasi communities of India, the researcher said. These traditions, increasingly overwhelmed by modern life, may even be forgotten entirely by the younger people, Douglas said.

"I work relentlessly to record the stories from the elders of the village communities and then to translate these narratives into English. I also encourage local artists and I work with them to introduce digital tools to retell their stories in interesting contemporary formats," Douglas said.

This work is extremely difficult to secure support for in India and abroad, as indigenous art and culture, and also work by independent practitioners is increasingly difficult to sustain, she added.

He, however, said he has no knowledge about the notice issued to his wife. Locals demanded a probe into the irregularity and for tracing of persons in top government posts holding ration cards.

CONTRACTORS, NOT SHGs IN MUKTA YOJANA

Ganjam Collector told to keep tab

Chhatrapur, August 21: Contractors have been engaged for projects under Mukhyamantri Karma Tatpara Abhiyan Yojana (MUKTA Yojana) allegedly in urban areas of Ganjam district. As per guidelines, women Self Help Groups (SHGs) were mandated to work under it.

After such blatant violation of guidelines, the Housing and Urban Development department has taken the issue seriously and directed the Collector to keep a close watch on it.

Besides, officials were warned of action if they are caught helping the contractors in the project works.

It was alleged that contractors are working in the name of SHGs while BeMC Commissioner, executive officers of municipalities and NACs, engineers and accountants are helping them.

Complaints in this regard were received by the department. Commissioner cum Additional Chief Secretary of the Housing

and Urban Development department G Mathi Vathanan said this at a review meeting here.

He has directed the Collector to monitor the MUKTA projects in urban areas.

"If officials are found to have helped the contractors, they will be either removed from jobs or sacked." he added.

It was said that SHGS are paid their remunerations in every two months. At the review meeting it was stated that contractors are doing all works while Mission Shakti was issued work orders, but muster rolls are not available.

Bhadrak/Balasore, August 21: Amid torrential rains induced by low pressure, over 200 villages in six blocks of Bhadrak district were marooned while river Baitarani was swelling due to heavy rains in the upstream areas.

People in Palasahi panchayat were panicked after two cracks appeared on Baitarani river embankment. As water level is increasing, there is every possibility of the embankment giving in to force of floodwater.

Some roads in Bankasahi panchayat were inundated.

Junior engineer Kishore Chandra Nayak of the water resources department said that the department had made arrangements of sand packets at the cracks.

In another development, a 200feet stretch of Genguti embankment in Dhamnagar area has caved in making it vulnerable for total collapse in case of more rain. As many

Taliban Year

fghanistan no longer hogs the limelight the way it did for months after the Taliban took over the country August 15 last year. This could probably be due to the instability that has gripped the world in the wake of the Russian invasion of Ukraine. But, heart-rending scenes are being witnessed on the streets of Kabul where women and children are begging for a single loaf of bread in front of bakeries. The rest of the country is facing a similar plight as famine stares in the face. This is the only country in the world where 14 million women have been thrown out of schools, colleges and working places and virtually locked up in their homes. Only a handful of women are being allowed to work so that health care, police and aviation security systems do not flounder. The situation demands that humanitarian aid be stepped up to prevent the country from falling into the abyss of poverty, complete lack of education for women and rule by gun-toting bigots known for

When the Taliban returned to power last year after a gap of 20 years, none believed that they had really changed, though there was a faint glimmer of hope that they must have learnt a lesson from the brutality and mediaeval outlook for which they earned notoriety during their previous rule. The facade they maintained that they would not be as oppressive and bigoted as they had been was only because of the refusal of the international community to accord recognition to their government and the regime's keenness to get billions of dollars frozen in banks abroad, especially in the USA.

But, barely a year later, the Taliban have proved the sceptics right. All forms of freedom of expression - a free Press and judiciary - have been muzzled. Women are banned from education and allowed to be out on the streets only when it is absolutely necessary with the condition that they can only travel with a male family escort, veiled from head to toe. For any violation of the fiat the male members of the 'offending' woman's family would have to pay a heavy price. Many former employees of the overthrown regime are harassed, forced into hiding or exile.

What has shocked and shaken the international community is the treatment the Taliban regime is meting out to the womenfolk. As the UN Under-Secretary-General and Women Executive Director Sima Bahous said, it is a reflection of the character of the regime that there are "no women in the Taliban's cabinet and no Ministry of Women's Affairs." This shows how women's right to political participation has been curbed. This is having disastrous effects on the aspirations of Afghan women who have, since the fall of the first Taliban regime in 2001, become accustomed to receiving education and shaping their own destiny.

No one is in doubt that the empty promises of the new masters of Kabul were intended only to extract international recognition of their government and ensure flow of billions of dollars of the previous government's reserves that were frozen abroad and foreign aid for building infrastructure. No country in the world, not even Pakistan, Saudi Arabia and the United Arab Emirates, has, so far, obliged them.

The only good news from Afghanistan is, as its former President Hamid Karzai said, that the Taliban have brought an end to widespread fighting and conflict. The warlords in different regions, who during the previous regime behaved as if they were law unto themselves, are now tamed. Otherwise, for most Afghans, the first year under the Taliban's rule has been marked by increased levels of poverty and unemployment with over one million people losing their jobs. The United Nations Development Programme (UNDP) has warned that 97 per cent of the Afghan population could sink into poverty before the end of 2022. Incomes have dropped so much that the World Bank in April said about 37 per cent of Afghan households did not have enough money to buy food, while 33 per cent could afford food but nothing more. The global supply chain disruption and runaway food prices due to the war in Ukraine make famine in the country look like almost inevitable.

Afghanistan is fast turning out to be a failed state. This may encourage the ISIS to begin its nefarious designs there. The international community can ill afford the prospect of such an outfit taking over Afghanistan.

Balderdash

'he standard dictionary definition — senseless talk or writing; nonsense may seem anodyne, lacking the fire and passion that so often comes attached to the word. It's often reserved for circumstances in which common-or-garden invective would be thought inadequate. This has been so for two centuries. Here is the grandly-named Victorian historian Thomas Babington Macaulay, writing in a footnote in his History of England from James II: "I am almost ashamed to quote such nauseous balderdash". One of the great wielders of balderdash - it seems somehow to be akin to a bludgeon — was the American journalist HL Mencken; he was in fine form castigating "the general run of business and professional men" in his book In Defense of Women: "Their very capacity to master and retain such balderdash as constitutes their stock in trade is proof of their inferior mentality". It's a pity that such a fine word should come of unknown stock, but we really don't have a clear idea where it comes from. Some argue its origin lies in the Welsh baldorddus, idle noisy talk or chatter (though that is pronounced very differently), while others point to related words in Dutch, Icelandic and Norwegian, such as the Dutch balderen, to roar or thunder. It appears around the time of Shakespeare with the meaning of froth or frothy liquid, or a jumbled mixture of liquids. such as milk and beer, or beer and wine. Only in the latter part of the seventeenth century did it move towards its modern meaning, through the idea of speech or writing that is a senseless jumble, hence nonsense or trash. It has also been used as a verb, meaning to make a jumbled mixture of ingredients or, in plain English, to adulterate. Tobias Smollett used it in his Travels through France and Italy in 1766 to refer to French wine: "That which is made by the peasants, both red and white, is generally genuine: but the wine-merchants of Nice brew and balderdash, and even mix it with pigeons' dung and quick-lime".

Independent reports suggest severe weakness in seven private banks. From 1969 onwards, a 2018 report says, 36 private banks, including 10 during last 20 years, have been put under moratorium, due to mismanagement. The RBI report is almost an echo of the views expressed by the late Pranab Mukherjee as then Finance Minister in 2008 after the collapse of Lehman Brothers. He triumphantly said the country was able to weather the global financial crisis on the back of its strong banks. History proved that later the same government encouraged undue incentivisations of the corporate post 2009. It led to an avoidable critical non-performing assets (NPA) situation. The RBI is right that the banks are not at fault but extra-banking decisions have led to many crisis-like situations and unwanted write offs.

The national psyche has yet to accept the move to privatise banks. The bank employees went on strike a number of times during the past one year. The recent dilution of Life Insurance Corporation (LIC) equities has only resulted in its share prices losing shine. The RBI paper is almost a counter to the policy paper of National Council of Applied Economic Research (NCAER) Director General Poonam Gupta and former NITI Aayog Vice-Chairman Arvind Panagariya which recommended privatisation of all banks except the State Bank of India.

Schemes of the Narendra Modi government such as MUDRA, Skill India, Jan Dhan Yojana, transferring of PM Kisan and other direct benefits were deftly handled because the banks are in social control. Demonetisation would not have been possible had not the public sector banks efficiently managed it.

The Indian financial sector un-

derwent a tectonic shift, when the Indira Gandhi government nationalised the 14 biggest commercial lenders July 19, 1969. The common man, the poorest, the students and the needy entrepreneurs got access to finance, which the private house controlled banks had denied. It paid Congress political dividend in 1971 elections. People in general welcomed it but gradually aberrations set in as politicians could control the banking decisions. The second volume of the official history of the RBI describes bank nationalisation as the single-most important economic policy decision taken by any government after 1947. Central bank historians say that in terms of the impact, even the economic reforms of 1991 pale in comparison.

The RBI bulletin critically observes that PSBs have given yeoman service to the stabilisation and growth of different sectors. They have higher degree of market confidence, better financial inclusion objectives, labour cost efficiency and handled COVID-19 shock well.

The first major loan-waiver by the Janata Party government led by the then Prime Minister VP Singh cost the exchequer ₹10,000 crore yielding to the demands of agitating farmers in 1990. The second one of ₹60,000 crore was by the UPA government in 2008. Thirteen states followed it in the subsequent years to give relief to farmers. This was criticised but there was wide support too as the writeoff of big loans of the industry too became the norm for decades. During 2004 to 2014, the UPA government wrote off loans worth ₹2.20 lakh crore. In subsequent years another ₹19.2 lakh crore of large loans were written off. Banks say these are totally unrecoverable and excluded from balance

Yes, these have been problems. The PSBs suffered a grievous injury when they ended up with a huge amount of gross NPAs or bad loans, which peaked at ₹8.96 trillion in March 2018, 14.6 per cent of total loans. This situation led a section in the government to mull over privatising the banks, starting with four major banks -- Central Bank of India, Bank of India, Bank of Maharashtra and Indian Overseas Bank -- despite the latest recapitalisation of ₹15,000 crore.

The premise that private sector banks are doing better is being

disputed by the RBI paper. It high lights that the private banks have failed to cater to the customers of the rural and semi-urban areas to date and customers from such locations are relying heavily on PSBs for banking. It turns out that even after bank nationalisation and with more stringent regulation of the banking system by the RBI. private banks continue to fail.

Some of the major reasons, as identified by the RBI paper, why PSBs can serve the country better than private banks are -- these have better financial inclusion, superior credit system, and better efficiency. The paper hints at a possible convolution of financial engagement if the entire sector is privatised, as the NITI Aayog suggests. It says that private banks are oriented to profits while the public banks work on thin spread and serve a larger section of the society. This implies that if the sector is privatised many government programmes as well as social welfare targets might get hit resulting in social imbalance. The RBI paper notes that despite weak balance sheet, resource utilisation of the PSBs had been more efficient and that gave them the edge in weathering the COVID-19 pandemic shock remarkably well.

Once privatised, the large social wealth would be beyond the reach of the people and the government. This was the problem that the government faced most during the 1960s. If these banks are sold out again to similar people, many of whom are large defaulters, the countercyclical role of the banks would suffer the most. This apart, it might cause severe fluctuations in lending rates affecting most government programmes. It may not be good for the PSBs themselves as abstract factors can affect their share prices, market sentiments, valuation and may have three risks - interest rate, regulatory, price-to-earnings ratio and price-to-book value. For better social returns the public sector is the ideal and privatisation is not the panacea

pacity last year, is the clearest sign yet that the energy transition is gathering pace. But recent events have shown that unplugging the current energy system before we have built a sufficiently robust alternative puts both economic and climate progress at risk – and calls into question whether we can ensure a just transition that is equitable to all.

A successful energy transition must be built on progress for the economy and the climate together. It must be based on scientific, economic, and engineering facts, appreciate the multiple dilemmas and challenging trade-offs, and accelerate the deployment of practical solutions. And for that, we need an inclusive approach that leverages the experience of all sectors of society and, critically, does not exclude the energy sector.

The world was already facing a profound energy-supply crunch as economies began to bounce back from the COVID-19 pandemic. The Russia-Ukraine conflict then made a tight market even tighter and forced countries to reassess their urgent near-term strategic energy needs. So the message for governments should be clear: Policies aimed at divesting from hydro-

ecord growth in renewables, carbons too soon, without adequate Obviously, no single country, invested in renewable projects in ergy security, erode economic stability, and leave less income available

to invest in the energy transition.

What's needed is a realistic new strategy that is practical, progrowth, and pro-climate. The strategy needs to appreciate the complexity of energy and industrial systems, and that the scale of the transition required is colossal, requiring greater alignment and collaboration on everything from capital allocation to product design, public policy, and behavioural change. This means examining the demand side of the energy system first. Wind and solar power are making great advances, but most energy is used in heavy industry, manufacturing, construction, transportation, and agriculture. These harder-to-abate sectors have the biggest effect on climate and thus require more investment, starting now.

While renewable-energy investment globally exceeded \$365billion last year, combined investment in energy storage, carbon capture, and the hydrogen value chain was only \$12 billion. That is not nearly enough. The energy transition is estimated to need more than \$250 trillion of investment over the next 30 years.

foot this bill.

But financing isn't the only issue. Energy transitions take time. While wind and solar accounted for the vast majority of all new power-generating capacity in 2021, they still comprise only 4% of today's energy mix. As the world's energy needs grow ever larger, maintaining global energy security will require oil and gas to remain a significant part of the mix for decades to come.

That is why we must do more now to reduce the impact of oil and gas on the climate. Producers. governments, and the private sector must work together to make sure that each new unit of output is less carbon-intensive than the last. That will require supportive fiscal policies through tax incentives, operational efficiency via technology, greater commitments to reduce methane and flaring, and significantly greater investment in carbon-capture technologies.

These realities are guiding the United Arab Emirates' approach to the energy transition, which involves continuing to meet global needs today while investing in the new energy systems of tomorrow. The UAE has three of the world's largest single-site solar plants, has

representing over 80% of all viable alternatives, are self-de-much less a single company, can over 40 developed and developing its renewables portfolio to 100 gigawatts by 2030. We have also invested in nuclear power and are laying the foundations of the hydrogen value chain, which is key to achieving net-zero emissions.

While the UAE remains a reliable supplier of some of the world's least carbon-intensive oil and gas, we will reduce its intensity by a further 25% before the end of this decade. And, as the first country in the Middle East and North Africa to announce a 2050 netzero strategic initiative, we are decarbonising our economy sector by sector. We have established the region's first industrial-scale carbon-capture programme, and all the electricity consumed by our national oil company now comes from zero-carbon nuclear and solar power.

If we are going to make good on the pledges of the Paris agreement. we need to deliver results now for the climate and the economy. Our ultimate goal should be to hold back emissions, not progress.

Sir, The management of e-waste is becoming a major issue for the nation. In order to control the e-waste, a few regulations were made. Recent regulations from the Central Pollution Control Board and the Indian government drafted that electronics manufacturing businesses have to register on their websites and specify their yearly goals for e-waste generation and collection. By 2023, these businesses must ensure that at least 60 per cent of their ewaste is collected and recycled, with the goal of increasing that number to 70 per cent and 80 per cent, respectively, by 2024 and 2025. But companies that don't meet annual targets outlined in regulations don't appear to face harsh penalties. Companies that violate these rules ought to be subject to sanctions stringently. Therefore, a steering committee led by the CPCB chairperson is needed to monitor and control the overall execution of these regulations.

New Delhi, August 21: India is in an "advanced stage" of negotiations with the US to procure 30 MQ-9B Predator armed drones for over USD 3 billion to crank up its surveillance apparatus along the frontier with China as well as in the Indian Ocean region, people familiar with the developments said

The MQ-9B drone is a variant of the MQ-9 "Reaper" which was used to launch a modified version of the Hellfire missile that eliminated al-Qaeda leader Ayman al-Zawahiri in the heart of Kabul last month.

Authoritative sources in the defence establishment said talks between New Delhi and Washington are underway for the governmentto-government procurement of the General Atomics-built drones, and rejected reports that the deal is off

Dr Vivek Lall, the Chief Executive for the General Atomics Global Corporation, said that the acquisition programme is at an advanced stage of discussions between the two governments."We understand that the MQ-9B acquisition programme is at an advanced stage of discussion between the US and Indian governments," he said.

"Any questions on those discussions should be addressed specifically to the respective governments. From a company perspective, General Atomics is ready to support India and values our longtime relationship," Lall added.

fare and over-the-horizon targeting. The high-altitude long-endurance (HALE) drones are capable of remaining airborne for over 35 hours and can carry four Hellfire missiles and around 450 kgs of bombs.



Lumpy skin disease kills over 7,300 cattle

New Delhi, August 21: Over 7,300 cattle have died so far due to 'lumpy skin disease' in eight states including one union territory and vaccination drive has been stepped up to contain the infection, a senior government official said.

Lumpy skin disease (LSD) is a contagious viral disease that affects cattle. It is transmitted by blood-feeding insects, such as certain species of flies and mosquitoes, or ticks. It causes fever, nodules on the skin and can also lead to death. LSD has recently spread in Asia following outbreaks in the Middle East and Europe. The disease emerged in Bangladesh in

According to the official, India too saw the first case of LSD in the same year, 2019, in eastern states especially West Bengal and Odisha. But this year, the disease has been reported in western and northern states as well as in Andaman Nicobar.

"First. LSD was reported in Gujarat and it has spread to eight states/union territories now. Over 1.85 cattle have been affected so far and more than 7,300 cattle have died since the outbreak of the disease in July," the official said.

About 74,325 cattle have been affected in Punjab so far, while 58,546 in Gujarat, 43,962 in Rajasthan, 6,385 in Jammu and Kashmir, 1,300 in Uttarakhand, 532 in Himachal Pradesh, 260 in Andaman & Nicobar. he said and added the data from Madhya Pradesh is awaited.

According to the ministry's data, 7,300 cattle have died so far, out of which 3,359 animals died in Punjab, 2,111 in Rajasthan, 1,679 in Gujarat, 62 in Jammu and Kashmir, 38 Himachal Pradesh, 36 in Uttarakhand and 29 in Andaman Nicobar.

Shinde, BJP attempt to undercut Sena by luring 'Govinda' troupes

Mumbai, August 21: Maharashtra Chief Minister Eknath Shinde's announcement that Dahi Handi will be recognised as an adventure sport has drawn criticism, but it is also being seen as an attempt to cut into the base of the Uddhav Thackeray-led Shiv Sena ahead of Mumbai civic polls.

Shinde, who started his political career as an ordinary Shiv Sena worker in neighbouring Thane and rose through the ranks, rebelled against Thackeray in June this year and brought down the Thackeray-led Sena-NCP-Congress government in Maharashtra.

Shinde then became Chief Minister with the support of rebel Sena MLAs and the BJP. The coming elections to the Brihanmumbai Municipal Corporation, the country's richest civic body, will be a do-or-die affair for the Uddhavled faction. The Sena has been in power in the BMC for several years.

Dahi Handi, during which teams of participants form human pyramids and break earthen pots containing curd or buttermilk hung high above the ground, is an important part of the Krishna Janmashtami festival in Maharashtra. But in big cities, especially in Mumbai and Thane, Dahi Handi events have also attracted politicians as a way of distributing patronage at the local level.

"Govindas are an asset for a political party to establish its influence in a locality. Economically it is not very expensive for any politician or party to fund them. They came in handy at the time of election. For a long time, the Shiv Sena has retained their loyalty and thus maintained its dominance in street politics," said a political analyst. In rural Maharashtra, politicians try to control the

Sena leader Sunil Prabhu, who belongs to the Thackeray faction, praised Shinde's decision in the Assembly but also said that it was "our demand for a long time that Govinda troupes be given medical protection and Dahi Handi be recognised as a sports activity." A former spokesperson of the Maharashtra unit of the BJP said the saffron party always had a strong base in the middle and upper middle classes. but not in the lower middle class.

This will definitely help improve their quality of life, an official from the zilla parishad said lauding the initiative taken by the 'Swadhar' care home, located in Alni village.

Currently, the care centre has 110 girls and women, majority of whom were brought in an ailing state and most of them were bedridden, the care home's head Shahaji Chavan told PTI. "They are orphans brought here from big cities like Pune and Mumbai. They are autistic and mentally challenged. They can't express their condition and 30 of them cannot even assess their urge to go to toilet," he said. But with time, they have started studying and 60 of them are now literate, he said. "While trying to find out their area of interest and talent, we decided to engage them in different activities. We found 12 of them were good at moulding clay



ing the idols of Lord Ganesh,' Chavan said. Working with mud, making body parts of an idol and attaching them properly are not easy tasks. But, these inmates are learning and they have now also started painting the idols on their own, he said. Two persons from the care centre work with the inmates and make them learn the art of making idols, he said.

"We try to make around 400 idols every year, but only half of them reach the market," Chavan said. Bharat Kamble, who heads differently-abled wing of the Osmanabad zilla parishad's social justice department, said the care home inmates have no relatives. "Their idols are as beautiful as made by professional artists," he said. The care home is not only making these inmates learn art, but also helping them with different therapies to make them stand on their feet, he said.

20 die as flood hits Afghan's province

Islamabad: At least 20 people died after a devastating flash flood hit Khoshi district in Afghanistan's Logar province, officials said Sunday. According to initial reports, half of the deceased were children, the provincial police said in a statement. Another 30 people were wounded and at least four were missing. As a result, more than 3,000 residential houses have been partially or completely damaged, dpa news agency reported quoting officials. Social media footage showed bodies of children as well as villages inundated by the flooding. "The situation is very worrying. People urgently need basic aid," police spokesman Ahmadullah Anas told dpa.

FIR against **Imran Khan** Islamabad: Former Pakistan

Prime Minister and Pakistan Tehreek-e-Insaf (PTI) chairman Imran Khan has been booked for openly hurling threats to senior most police officials, a female judge, the state institutions and bureaucracy during his public speech in Islamabad's F-9 park. Imran Khan has been booked under the Anti-Terrorism Act (ATA) for challenging judicial and law enforcement authorities under offence, which falls under Sector 7 of the terrorism act.

SL reports nearly **50K dengue cases**

Colombo: Sri Lanka reported nearly 50,000 cases of dengue in the first eight months of 2022, local media reported. According to the National Dengue Control Unit (NDCU), 49,941 people have been admitted to hospitals for dengue treatment in the past eight months. Half the cases were reported from the Western province, comprising Colombo, Gampaha and Kalutara districts, Xinhua news agency reported quoting NDCU.

Turkey: 35 killed in separate crashes

Istanbul: Turkish authorities Sunday investigated a pair of secondary crashes at emergency sites that killed at least 35 people the previous day. In both cases, first responders tending to earlier collisions were among the dead. Saturday's tragedies happened just 250 kilometers (155 miles) apart in southern Turkey. The first happened on the highway between Gaziantep and Nizip when a passenger bus collided with emergency teams that had responded to a crash in Mardin Province, west of Derik. Three firefighters, two paramedics and two journalists were among the 15 people killed, according to Interior Minister Suleyman Soylu, Eight of the victims were from the bus, he said.

Daughter of 'Putin's brain' killed in car explosion

Moscow August 21: The daughter of an ultra-nationalist Russian ideologue who advocates Russia absorbing Ukraine was killed in a suspected car bomb attack outside Moscow, Russian state investigators said Sunday.

Russia's TASS state news agency quoted Andrei Krasnov, someone who knew Dugina, as saying the vehicle belonged to her father and that he was probably the intended target.

Father and daughter had been attending a festival outside Moscow and Dugin had decided to switch cars at the last minute, Russian government newspaper Rossiiskaya *Gazeta* reported.

TV footage accompanying a statement by Moscow region investigators showed officers collecting debris and fragments from the spot where the explosion happened.

The statement, which described Darya Dugina as a journalist and political expert, said investigators had opened a murder case and would be carrying out forensic examinations.

Investigators were considering "all versions" when it came to working out who was responsible, it said.

Singapore will decriminalise sex between men: PM

Singapore, August 21: Singapore will decriminalise sex between men but has no plans to change the legal definition of marriage as being between a man and a woman, Prime Minister Lee Hsien Loong said Sunday.

LGBTQ groups welcomed Lee's decision to repeal Section 377A of the penal code, a colonial-era law that criminalises sex between men, but also expressed concern that ruling out same-sex marriage would help to perpetuate discrimination. In his annual national day rally speech, Lee said Singaporean society, especially young people in the citystate, were becoming more accepting of gay people. Singapore becomes the latest Asian country to move toward ending discrimination against members of the LGBTQ community. In 2018, India's highest court scrapped a colonial-era ban on gay sex, while Thailand has recently edged closer to legalising same-sex unions.

China-backed hackers spying on govts

Beijing/New Delhi, August 21: A hacking group allegedly backed by the Chinese government has been attacking governments, NGOs, news publications and think tanks globally -- including India's National Informatics Centre (NIC) - sending them emails which, once opened, were used to steal their login credentials.

The group known as 'RedAlpha' has consistently spoofed login pages for NIC, which manages wider IT infrastructure and services for the Indian government. The hacking group weaponised some least 350 domains last vear alone.

The China-sponsored hacking group spoofed organisations such as the International Federation for Human Rights (FIDH), Amnesty

International, the Mercator Institute for China Studies (MER-ICS), Radio Free Asia (RFA), the American Institute in Taiwan (AIT), and other global government, think tank, and humanitarian organisations that "fall within the strategic interests of the Chinese government". According to a report by

cybersecurity firm Recorded Future, the group has also engaged in direct targeting of ethnic and religious minorities, including individuals and organisations within Tibetan and Uyghur communities.

"In recent years RedAlpha has also displayed a particular interest in spoofing political, government, and think tank organisations in Taiwan, likely in an effort to gather political intelligence," said the report. divid als via emails containing abasic PDF files with links to the phishing sites, typically stating that a user needs to click the link to preview or download files.

Over the past three years, RedAlpha continued to conduct credential-phishing activity using large clusters of operational infrastructure to support campaigns.

"In late 2019 and early 2020, the group likely shifted away from older infrastructure TTPs exhibited in public reporting, such as the registration of domains through GoDaddy and hosting on Choopa (Vultr) and Forewin Telecom in-

frastructure," the report revealed. The researchers observed RedAlpha consistently register

panded over the past several years to include credential-phishing campaigns spoofing ministries of foreign affairs in multiple countries.

A Chinese government spokesperson told the MIT Technology Review that the country opposes all cyberattacks and would "never encourage, support, or connive" to carry out such activity.

Despite the risk of beatings and detention by Taliban members patrolling the streets in the weeks after the Western-backed government was toppled, she took part in several protests that broke out, determined to protect her hard-fought rights. Those demonstrations have died down - the last one Mubarez took part in was on May 10. But she and others meet in homes in private acts of defiance, discussing women's rights and

While rules on women's behaviour in public are not always clear cut, in relatively liberal urban centres like Kabul they often travel without a male chaperone. That is less common in more conservative regions, largely in the south and east. All women are required to have a male chaperone when they travel more than 78 km (48 miles).

LIC Covid death claims drop 20%

This statement allays fear emanating from the RBI's discussion paper on charges in the payment system suggesting that UPI payments might be subject to a tiered charge based on various amount brackets. Currently, there are no charges levied on transactions done through UPI. The government has mandated a zero-charge framework for UPI transactions with effect from January 1, 2020.

No plans to import wheat: Govt in three weeks of August

New Delhi, August 21: The government has no plans to import wheat as it has sufficient stocks to meet the country's requirements, official sources said.

The Food Corporation of India (FCI) has enough stock for public distribution, they added.

"There is no such plan to import wheat into India. Country has sufficient stocks to meet our domestic requirements and @FCI_India has enough stock for public distribution," the Department of Food and Public Distribution said in a tweet.

The comments come against the backdrop of some reports which said India may import the foodgrain.

India's wheat production is proiected to have declined nearly 3 per cent to 106.84 million tonne (MT) while the overall foodgrain production is estimated to have touched record 315.72 million tonne in the 2021-22 crop year.

Wheat production is estimated to have declined due to a heatwave that resulted in shrivelled grains in the northern states of Punjab and Harvana.

New Delhi, August 21: Freebies are never 'free' and when political parties offer such schemes, they must be required to make the financing and trade-offs clear to voters, RBI Monetary Policy Committee (MPC) Member Ashima Goyal said Sunday, adding this would reduce the temptation towards "competitive populism".

Goval further said a cost is imposed somewhere when governments provide freebies, but this is worth incurring for public goods and services that build capacity.

"Freebies are never free... Specially harmful are subsidies that distort prices," she told PTI. Noting that this hurts production

For years, lawmakers, economists and civil rights organizations have called on the IMF, which has for decades loaned billions to low-income countries, to end its surcharge policy, With an ever-worsening risk of a global debt crisis and rising interest rates, the issue has become more pressing for countries looking to reduce their deficits

Washington, August 21: The International Monetary Fund is facing pressure to reevaluate how it imposes fees on loans it disperses to needy countries like war-torn Ukraine — which is one of the fund's biggest borrowers.

The move comes as more countries will need to turn to the IMF, as food prices and inflation internationally continues to rise. Surcharges are added fees on loans imposed on countries that are heavily indebted to the IMF.

Treasury Deputy Secretary Wally Adeyemo said in Aspen last month that finance ministers of several countries realize they have to pay a price for Russia's war in Ukraine, especially with food prices going up.

"They're going to have to go to the IMF, they're going to need to find assistance," Adeyemo said.

However, the IMF fee system could change through US legislation. An amendment to the National Defense Authorization Act, otherwise known as the defense spending bill, would suspend IMF surcharges while their effectiveness and burden on indebted countries is studied.

As the largest IMF shareholder and member of the Fund's executive board, the US can push for policy decisions and unilaterally veto some board decisions.



Tokyo, August 21: With the injured PV Sindhu missing out for the first time in a decade, the onus will be on young Lakshya Sen and HS Prannoy to spearhead India's challenge in the BWF World Championships, starting here from Monday.

Sindhu's ankle injury has left the task of continuing India's impressive run in the tournament on the young shoulders of Lakshya, and the experienced duo of Prannoy and Kidambi Srikanth. The country has not returned empty-handed from the Worlds since the 2011 edition.

It was Srikanth and Lakshya, who had ensured India's presence at the podium in 2021 when they finished with a silver and a bronze, respectively, but the field this time will be much stronger than last year. It was a depleted field in 2021

with Japan's Kento Momota, and

the Indonesian duo of Jonatan Christie and Anthony Ginting missing out. But there has been no such withdrawal this time

At the same time, the expectations from the Indian male shuttlers will also be high, given their exploits in recent months.

Brimming with confidence following his CWG gold on debut,

Lakshya has been on a sensational run this season, and will go into the top event as one of the favourites. The 20-year-old, who was left

been rising ever since he returned from Huelva in December as he won a maiden Super 500 title at India Open, finished with a silver at All England Championships, before joining hands with Srikanth and Prannoy to earn India its

maiden Thomas Cup win in May. However, the trio will turn foe this week after being clubbed in the same quarter.

Prannoy has been one of the most consistent players in the circuit, with a run of quarterfinals, three semifinals and a runner-up finish this season, and he would be itching to continue his im-

pressive run. The 30-year-old Indian is known for his giant-killing exploits and comes into the event after twin wins over world No 4 Chou Tien Chen recently, and will fancy his chances against Momota, who hasn't looked the same player since his car accident two years ago.

Srikanth, 12th seed, was simply sensational in Bangkok and it was his unbeaten run which played a huge role in India's Thomas Cup win, but the former world No 1's confidence took a beating after he lost twice to upcoming Malaysian Ng Tze Yong at the Birmingham CWG. If Srikanth clears the initial hurdles, world number 5 Malaysian Lee Zii Jia will stand in his way to the quarters.

B Sai Praneeth, a 2019 World Championships bronze medallist, too, is in the fray and will open against Taiwanese Chou Tien Chen. The former Singapore Open champion will look to exorcise his ghosts in Tokyo, where he battled without a proper coach or physio, suffering a series of defeats to bow out early from the Olympics last year.

All eyes will also be on Chirag Shetty and Satwiksairaj Rankireddy, who claimed India's first gold medal in men's doubles at the CWG earlier this month.

Away from all the limelight will be a certain Saina Nehwal, who was once the cynosure of all eyes. The decorated shuttler has a silver and bronze from the Worlds but, of late, has looked a pale shadow of herself, following a series of belowpar performances due to both injuries and lack of form.
