Russia detains IS fidayeen eyeing to kill Indian leader

Moscow, August 22: Russia's top intelligence agency said Monday that it has detained an Islamic State terrorist from a Central Asian country who underwent special training to carry out a suicide attack against a member of India's leadership elite for the offensive comments on the Prophet.

According to Russia's Federal Security Service (FSB), the foreign national was recruited by one of the Islamic State's ringleaders as a suicide bomber sometime between April and June 2022, while in Turkey, state-owned TASS news agency reported.

"The Federal Security Service has identified and apprehended in Russia a member of the outlawed (by the Russian Federation) Islamic State international terrorist organisation. The detainee is a native of a Central Asian country, who planned to commit a terrorist attack against a member of India's ruling circles by blowing himself up," the FSB said.

The terrorist's "ideological in-

doctrination was conducted remotely via Telegram messenger accounts and during personal meetings in Istanbul with an IS representative," the Russian Federal Security Service's Center for Public Relations (CPR) said.

The FSB noted that the wouldbe suicide bomber swore allegiance to the IS Emir (chief), after which he was instructed to leave for Russia, draw up the necessary documents and fly to India to commit this act of terrorism, the report said.

The terrorist, who was not identified by the Russian intelligence agency, confessed that he was preparing an act of terrorism against a member of India's ruling circles for insulting the Prophet Muhammad, the report added.

In a video of his interrogation released by the CPR Monday, the would-be suicide bomber said he swore allegiance to the IS Emir in April 2022 and underwent special training, after which he flew to Russia, from where he was to travel to India. "I was supposed to be given things there to commit a terrorist attack at the behest of the IS for insulting the Prophet Muhammad," he said.

BJP spokesperson Nupur Sharma was suspended and the party's Delhi media head Naveen Kumar Jindal was expelled by the party after their controversial remarks against the Prophet which sparked protests in the Muslim world early this year.



500 Red backers surrender in Malkangiri

BHUBANESWAR: More than 500 Maoist supporters surrendered before the Odisha Police in Swabhiman Anchal of Malkangiri district Monday, DGP SK Bansal said. They were motivated by developmental works of the Odisha government," the DGP tweeted. They also expressed their opposition towards the Maoist ideology by burning their dress and gave the slogan 'Maobadi (Maoist) Murdabad', he said.

Five wagons of goods train derail in City

BHUBANESWAR: At least five wagons of a goods train derailed near Bhubaneswar railway station at about 2035 hours affecting train service for some time Monday evening, official sources said. However, there was no report of any injury or death in the incident. While Hirakhand Express remains stranded at home signal, the Rajdhani Express has been halted at Mancheswar. Similarly, the JanShatabdi Express is stranded en-route before Bhubaneswar and Junagarh Road Express yet to get a place at station. Puri-Durg, Tapaswini, Puri-Gandhidham, Puri-Howrah trains are also halted.

Ahmedabad/New Delhi, August 22: Delhi Deputy Chief Minister Manish Sisodia Monday claimed that he was offered the CM's post by the BJP and closure of all cases if he quit AAP and joined the saffron party, which hit back, accusing him of trying to deflect attention from the corruption charges.

The startling claims of Sisodia



came days after his house was raided by the CBI over allegations of corruption in the implementation of the Delhi excise policy, even as Northeast Delhi BJP MP Manoj Tiwari asked the AAP leader to name the person who made these offers from the party.

Sisodia, who along with Chief Minister Arvind Kejriwal is on a two-day visit to Gujarat to reach out to voters ahead of the assembly polls scheduled for later this year, also played the caste card.

"I have received a message from the BJP - Leave AAP and join BJP. We will ensure that all cases by CBI and ED against you are shut,' he said. "My reply to BJP - I am a descendant of Maharana Pratap and a Rajput. I am ready to get beheaded but can never bow down before conspirators and corrupt people. All the cases against me are false. Do whatever you want to do," he said in a tweet in Hindi.

Bhubaneswar, August 22: Chief Minister Naveen Patnaik Monday urged Prime Minister Narendra Modi for addition of a default provision in NREGASoft to avoid delays in Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) wage payments to workers.

The default provision will enable drawal, utilization and recoupment of budgetary allocation towards State's Revolving Fund to prevent delay in payment of wages under the scheme

Writing a letter to the Prime Minister, Naveen said the state government has taken a slew of proactive measures to ensure proper implementation of MGNREGS and has ensured that the benefits of the scheme reach the intended ben-

The state has done well in ensuring almost 100 per cent timely payment of wages, which is a testimony of the tremendous emphasis it has attached to the mandates of the Act, he pointed out.

Similarly, the Centre has also taken significant steps in raising its budgetary allocation towards MGNREGS during the outbreak of Covid-19 pandemic which has enabled the state government to provide succour to the vulnerable rural households especially the migrant families, said the CM.

Boyfriend abetted suicide: Sweta's kin

Bhubaneswar, August 22: The family members of a 24-year-old software engineer, who recently committed suicide by hanging herself in an apartment here, have lodged a complaint with Chandrasekharpur police accusing her boyfriend of abetting the suicide.

Based on the complaint, the police registered a case under Section 306 of the IPC and started an investigation into the matter.

The deceased identified as Sweta Utkal Kumari was a resident of Bhadrak district. She had been working at a reputed IT firm in Infocity area since 2018.

It was alleged in the complaint that Soumvaiit Mahapatra, the male colleague of Sweta, fell in an unrequited love with the deceased.

Sweta had initially rejected his proposal, but she started reciprocating later. Soon, she got into a livein relationship with Soumvaiit.

Meanwhile, Soumyajit allegedly managed to capture some obscene pictures and intimate videos. He later left the job and took admission

in management institution to pursue MBA. As per the complaint, Soumyajit used to take money from

Sweta after he left his job. When Sweta's family members came to know about their relationship, they talked to the family of Soumyajit about the couple's

marriage. Sweta's father accused Soumyajit's family of demanding ₹30 lakh as dowry.

Soumyajit allegedly blackmailed Sweta threatening to make viral her intimate photos and videos on social media, alleged her father. Soumyajit was allegedly torturing Sweta through various means since 2020. When the torture became unbearable, Sweta ended her life in her rental accommodation at Green Apartment in Sailashree Vihar area late Friday night, her family members said.

Meanwhile, an audio recording purportedly the last conversation between Sweta and Soumyajit, has gone viral. Sweta was reportedly heard pleading with the accused not to snap the relationship. She also allegedly threatened Soumyajit to

BMC tax collector, aide held for receiving bribe

Bhubaneswar, August 22: Vigilance sleuths Monday arrested tax collector-cum-ward officer of Bhubaneswar Municipal Corporation (BMC) and his assistant for receiving bribe of ₹15,000 from a person to reduce the holding tax on the latter's house.

The accused were identified as Hemanta Kumar Sahoo, the tax collector and Jogendra Pradhan, retired tax collector and assistant of the former. Sahoo works at ward office-23, Khandagiri Bari Community Centre. Pradhan also used to visit the office after retirement. Vigilance sources claimed that when the complainant, Sanjay Kumar Sahoo of Ghatikia area, contacted the accused persons to slash his holding tax, they demanded ₹15,000 bribe for the purpose. An aggrieved Sanjay later lodged

a complaint with the Vigilance in this regard. Based on the complaint, Vigilance officials Saturday registered a case (26/22) and laid a trap to arrest the duo.

Bhubaneswar, August 22: In a move to enhance livelihood activities through forestry, the state government Monday approved annual plans of operation (APO) of ₹132.01 crore for the financial year 2022-

The High Power Committee of Odisha Forestry Sector Development Society (OFSDS) led by Chief Secretary Suresh Chandra Mahapatra has approved the annual plan.

The committee has approved the APO of ₹132.01 crore for OFSDP Phase-II, and ₹58.24 crore for Ama Jangal Yojana (AJY). Besides, ₹43.43 crore financial outlay was made from OMBADC for livelihood activities, officials said

Mahapatra directed the officials to intensify livelihood activities for making those sustainable even after end of the project period.

The Chief Secretary directed different departments to prop up convergence of resources with OFSDS proactively for boosting sustainable livelihood programs in forest fringe villages. "People living in these villages are

mostly poor, and they need to be assisted through income generation activities (IGA). Such activities also add to conservation and growth of forest," he said. Mahapatra also directed to ensure

survival of the seedlings with close supervision, and replace deceased plants after resolving the cause of casualty. It was decided to implement local specific IGAs through VSS



and women self-help groups (SHGs). The main activities under OFSDP included entry point activities, sustainable forest management, biodiversity management, livelihood promotion, capacity building of VSS and SHGs, support activities,

assisted natural plant regeneration and block plantation, construction of soil moisture conservation measures, forest protection, fire guarding, construction of IGA Centre, community mobilisation, product mapping of different VSSs, formulation of VSS-wise livelihood plan and skill training.

Project director Meeta Biswal appraised that OFSDP is being implemented in 12 forest divisions and two wildlife divisions across 10 districts. A total number of 1,211 VSSs are actively involved in conservation, growth and promotional activities. Perspective 10-year micro plans for all VSSs were also prepared by them.

Around 56,031 hectares of forest land were developed through them. Soil moisture conservation measures over 2.250 hectares, fire lines across 1,710 km and forest boundaries across 1,900 km were constructed, and being maintained through respective VSSs.

seedlings were also established and being run through them.

A total of 4,118 hectares were covered under farm forestry with 29 lakh seedlings for providing remunerative income to members of 777 VSSs. The balance VSSs would be covered in phases.

Sal leaf clusters in three project divisions namely, Karanjia, Baripada and Rairangpur were made operational, sources said. Under AJY, altogether 4,601 VSSs and 14,263 women SHGs across 22 territorial divisions were involved in forest conservation and associated livelihood activities with an investment of around ₹545.65 crore by end of July 2022.

art and said that it will provide a big opportunity to tribal artists to interact with artists and art lovers



analysis of nearly 43 million peo-

ple, aged 13 and older, has revealed. Several previous studies and reports from public health agencies, including the US Centers for Disease Control and Prevention (CDC), have highlighted a possible connection and potentially increased risk of myocarditis after receiving an mRNA Covid-19 vaccine, generating considerable scientific,

policy and public interest. "We found that the entire Covid-19-vaccinated population of England during an important 12-month period of the pandemic when the vaccines first became available, the risk of myocarditis following vaccination was quite small as compared to the risk of myocarditis after infection," said Martina Patone, a statistician at the



University of Oxford.

"This analysis provides important information that may help guide public health vaccine campaigns, particularly since Covid-19 vaccination has expanded in many parts of the world to include children as young as 6 months old," Patone said in the study published in the American Heart Association's peer-reviewed journal Circulation.

In this study, Patone and colleagues evaluated database of Covid-19 vaccinations for all people aged 13 or older who had received at

least one dose of the University of Oxford-AstraZeneca vaccine, the Pfizer-BioNTech or the Moderna vaccine between December 1, 2020 and December 15, 2021.

This dataset totaled nearly 43 million people, which included more than 21 million who had received a booster dose of any of the Covid-19 vaccines.

Nearly 6 million people tested positive for Covid-19 infection either before or after Covid-19 vaccination during the study period.

The analysis found that less than 3,000 people were hospitalised or died with myocarditis during the

one-year study period. People who were infected with Covid-19 before receiving any doses of the vaccines were 11 times more at risk for developing myocarditis during days 1-28 after a Covid-19 positive test, the findings showed.

'It is important for the public to understand that myocarditis is rare, and the risk of developing myocarditis after a Covid-19 vaccine is also rare. This risk should be balanced against the benefits of the vaccines in preventing severe infection," said Professor Nicholas Mills, the Butler British Heart Foundation Chair of Cardiology at the University of Edinburgh and a co-author of the

It is also crucial to understand who is at a higher risk for myocarditis and which vaccine type is associated with increased myocarditis risk, Mills added.

The SARS-CoV-2 virus continues to shift, and more contagious variants arise.

"Our hope is that this data may enable a more well-informed discussion on the risk of vaccine-associated myocarditis when considered in contrast to the netbenefits of vaccination," said coauthor Julia Hippisley-Cox. IANS



1 gets life term for killing wife

Bhubaneswar, August 22: The court of Additional Sessions Judge, Khurda here Monday sentenced a man to life imprisonment after finding him guilty of killing his wife at his Damduma Housing Board Colony residence in Khandagiri area in 2016. The court also slapped a fine of Rs 50,000 on him and six month additional jail term in case of defaulting on payment.

The convict identified as Rajendra Singh alias Babu, 55, had married the victim, Sasmita Singh, around 19 years ago. He would often beat his wife on different pretexts.

On December 31, 2016, Rajendra engaged in a heated argument with his wife over some money related issues. Soon, the argument turned violent and Rajendra hit Sasmita on his head and strangled her. The convict also made telephonic call to the complainant, cousin brother of the victim, and told him to have murdered his sister. Later, the complainant, along with the family members of Sasmita, reached the house of Rajendra. Meanwhile, police also rushed to the spot, recovered the body and arrested Rajendra.

"After completion of trial, the judgment was pronounced in the open court and the accused was found guilty u/s 302 IPC. Turning data into sound could help astronomy

e often think of astronomy as a visual science with beautiful images of the universe. However, astronomers use a wide range of analysis tools beyond images to understand nature at a deeper level.

Data sonification is the process of converting data into sound. It has powerful applications in research, education and outreach, and also enables blind and visually impaired communities to understand plots, images and other data.

Its use as a tool in science is still in its early stages – but astronomy groups are leading the way.

In a paper published in Nature Astronomy, scientists discuss the current state of data sonification in astronomy and other fields, provide an overview of 100 soundbased projects and explore its future directions.

Imagine this scene: you're at a crowded party that's quite noisy. You don't know anyone and they're all speaking a language you can't understand-not good. Then you hear bits of a conversation in a far corner in your language. You focus



on it and head over to introduce

While you may have never experienced such a party, the thought of hearing a recognisable voice or language in a noisy room is familiar. The ability of the human ear and brain to filter out undesired sounds and retrieve desired sounds is called the "cocktail party effect".

Similarly, science is always pushing the boundaries of what can be detected, which often requires extracting very faint signals from noisy data. In astronomy we often push to find the faintest, farthest or most fleeting of signals. Data sonification helps us to push these boundaries further.

Fast radio bursts are millisecond

bursts of radio emission that can be detected halfway across the universe. We don't vet know what causes them. Detecting them in other wavelengths is the key to un-

derstanding their nature. When we explore the universe with telescopes, we find it's full of cataclysmic explosions including the supernova deaths of stars. mergers of black holes and neutron stars that create gravitational

waves, and fast radio bursts. These events allow us to understand extreme physics at the highestknown energies and densities. They help us to measure the expansion rate of the universe and how much matter it contains, and to determine where and how the elements were creData sonification is the process of converting data into sound, has powerful applications in research education and outreach, and also enables blind and visually impaired communities to understand plots,

ated, among other things. However, the majority of these puters are only so good at finding them. A computer can pick out a faint burst if it's given a template of the "desired" signal. But if signals depart from this expected behaviour, they become lost.

And it's often these very events that are the most interesting and vield the biggest insight into the nature of the universe. Using data sonification to verify these signals and identify outliers can be powerful.

Data sonification is useful for interpreting science because humans interpret audio information faster than visual information. Also, the ear can discern more pitch levels than the eye can discern levels of colour (and over a wider range). Plotting data in ten or more dimensions simultaneously is too complex, and interpreting it is too confusing. However, the same data can be comprehended much more easily through sonification.

As it turns out, the human ear can tell the difference between the sound of a trumpet and flute immediately, even if they play the same note (frequency) at the same loudness and duration

Why? Because each sound includes higher-order harmonics that help determine the sound quality, or timbre. The different strengths of the higher-order harmonics enable the listener to quickly identify the instrument.

Now imagine placing information – different properties of data as different strengths of higherorder harmonics. Each object studied would have a unique tone, or belong to a class of tones, depending on its overall properties, PTI

In order to ensure timely payment of wages, whenever there is a delay in receipt of funds from the Government of India towards the payment of wage liabilities the state government has created the Revolving Fund for payment of wages to the job card holders within the stipulated time as a contingent measure.

For this, the state government has also made a budgetary allocation of Rs 1,000 crore for the financial year 2022-23. The Revolving Fund is to be recouped after receipt of the fund in this regard from the Centre. However, there is no provision for the recoupment of the fund in the NREGASoft, the software of the scheme.

The Ministry of Rural Development has been requested earlier for addition of a default provision in NREGASoft for drawal, utilisation & recoupment of budgetary allocation towards state's Revolving Fund to prevent delay in payment of wages. However, the ministry is yet to take any action on the aforesaid proposals of the state, he added.

Surgeons remove steel glass from man's rectum

Berhampur, August 22: Doctors of a government-run hospital in Ganiam district have successfully removed a steel glass from the rectum of a man through surgery. The glass, around eight centimetres in diameter and 15cm long, was allegedly inserted in the anus of Krushna Chandra Rout around 10 days ago by inebriated friends at a booze party in Surat, Gujarat, where liquor is prohibited.

Rout experienced acute stomach pain, but he did not reveal it to anyone due to the rule in Guiarat. Instead of undergoing treatment in Surat, where he was working at a textile mill, he preferred to return to Balipadar his native place in Buguda block. The 45-year old's stomach started swelling and he could not defecate since the incident. Worried about his condition, Rout's family members rushed him to



MKCG Medical College and Hospital in Berhampur city last Friday.

During consultation, Rout did not say that the glass was inside his rectum (sigmoid colon) until an X-ray revealed so, surgery department assistant professor Sanjit Nayak said. "We formed a team of doctors to retrieve the glass by conducting a surgery on the same day as his condition was serious," said Dr Charan Panda, a professor in the

surgery department. Initially, the surgeons tried to remove the glass through the anus.

Later, they decided to conduct a 'laparotomy', an abdominal incision, because of chances of infection due to a possible rapture in the anus, Dr Panda informed.

"It took around 2.5 hours to remove the glass. The condition of the patient is good and he will remain for another four-five davs under observation," Dr Panda said.

A colostomy-sheet has been attached to Rout and it will remain for a few days for defecation. He, however, is not facing any problems while urinating, sources said.

Mushroom farming turns profitable for women of Kujang

Paradip, August 22: With the Odisha government taking up a host of measures under 'Mission Shakti' programme to push women empowerment, a total of 362 women of three SHGs in Kujang block of Jagatsinghpur district have made themselves self-sufficient through mushroom and vegetable farming.

Mushroom and seasonal vegetable farming have opened up new avenues of livelihood for them. These women have now become economically independent through this project.

In fact, 30 women of three SHGs, who have formed the 'Dayanidhi Mushroom Producers Group', have turned into small entrepreneurs. By managing the finances of their respective families, they have become a role model for others.

Apart from household chores, they utilise two hours for mushroom and vegetable

Traders from Paradip and Kujang buy the produce from their doorsteps. They earn ₹12,000 to ₹15,000 each on a monthly basis, said Swarnalata Swain, the president of Dayanidhi Mushroom Producers Group.

They started mushroom farming in 2019. Master trainer of mushroom farming, Mounabati Swain said that PPL extended financial support for this initiative , apart from providing training and tools. They have now adopted organic ways of cultivating bitter gourd, cucumber, ridge gourd, okra, brinjal, snake gourd and pumpkins on a patch of land. Mushroom cultivation involves fabrication of sheds with very little

SHG members have laid over 100 beds. The process of mushroom farming involves compost preparation, spawn-run, casing and harvesting. The mushroom sheds of several layers are made up of wood. Compost is used as a substrate for growing white button mushrooms, while straw is used as a base material for mushroom farming.

"Around 500gm to 1 kg of mushroom is collected from each bed every day. We spend ₹70 for one bed of mushroom. We sell a kilogram of mushroom for ₹130," they said.

Some of these women have now been chosen as master trainers to guide the SHGs on mushroom farming. This has been done so that utility of mushroom farming can be spread to other areas also.

End of Justice?

The release of 11 convicts serving life imprisonment in the Bilkis Bano gangrape and murder case from the 2002 Gujarat riots is a sad combackwards to please the ruling dispensation. The way the convicts were set free by the BJP government in Gujarat, given sweets and hero's welcome, prompted the victim of the unspeakable barbarity to lament: "Is this how justice ends?" The National Human Rights Commission is likely to take up the issue for discussion, according to a report. But that hardly inspires confidence that justice will be done or seen to be done. The 11 men had been convicted of raping Bilkis, murdering her three-year-old child and participating in the killing of 13 others of the family. Their release is not only a miscarriage of justice, but government endorsement of heinous crimes seemingly taking advantage of technical niceties. This is a new ominous trend of the country's system of justice.

The Bilkis Bano case is an illustration of the abysmal depths to which criminality and communal frenzy in the country have fallen and one which the Establishment gleefully endorses. Even after knowing the victim was pregnant, the criminals raped her, smashed her child to death and massacred the whole family. It speaks volumes for the courage of Bilkis that she did not succumb to threats, fear of social stigma and persecution and left no stone unturned to get justice. The NHRC, under former Chief Justice of India JS Verma, had met her when he visited a relief camp in Godhra in March 2002 and appointed senior advocate and former Solicitor General Harish Salve to represent her before the Supreme Court. The apex court ordered a fresh probe by the Central Bureau of Investigation and subsequently the trial was transferred from Gujarat to Bombay. Bano's case was the only Gujarat riots-related case that was investigated afresh by the CBI. On January 21, 2008, CBI special court judge UD Salvi convicted 13 accused, sentencing 11 to life imprisonment on the charge of gangrape and murder. In May 2017, the conviction was upheld by the Bombay High Court. In 2019, the Supreme Court had awarded compensation of ₹50 lakh to Bano — the first such order in a case related to the 2002 riots. While awarding the compensation, the Bench of the then Chief Justice of India Ranjan Gogoi and Justices Deepak Gupta and Sanjiv Khanna observed, "What should not have happened has happened and the state has

What is of grave concern is the way the Guiarat government handled the case while granting remission to the convicts. This is not just any sexual offence case. The criminality has so many layers including communal strife and politics. Bilkis Bano has vented her frustration and fear after the release of the convicts and said she has trusted the highest courts in land and the system. But, she regrets she is slowly learning to live with her trauma as the release of the convicts has snatched peace from her and shaken her faith

That her fears are not baseless is clear from the fact that for the past few years several prosecution witnesses had, time and again, complained to the state administration and senior police officers that some of the convicts had obtained parole several times on flimsy grounds, including house warming parties, only to live in comfort outside the jail and continue to threaten them with dire consequences if they did not withdraw their statements in

■ Banausic

t's not a word that you're likely to overhear in your local pub or read in your daily newspaper. The source is classical Greek banausikos, relating to artisans (from baunos, a forge), though in English its meaning has been influenced by classical Greek attitudes as much as its etymology. Something banausic is mundane or functional. It might seem to be a relative of banal, but that's from an Old French word of Germanic origin relating to compulsory feudal service. Greeks of the ancient world lived in a stratified society, with a relatively small population of male citizens being supported by the labour of women, slaves and foreigners. For citizens, intellectual pursuits - including logic, rhetoric and philosophy — were key to an active part in public life as well as being satisfying in their own right. Activities that involved physical labour, such as making things to earn a living, were looked on as degrading banausic necessities. Even learning to play a musical instrument was thought by Aristotle to be a banausic occupation. The English word was coined by George Smythe in an article about the second Earl Grey, who had just died: After 1812, and when the worse portion of the Tories got enthroned in the supremacy, when the Banausic principle (we must coin a word from the most expressive of languages to express all its intense vulgarity) began to obtain (Oxford and Cambridge Review, Aug. 1845). Mr Smythe's snobbish comment on the banausic principle (basically non-intellectual pursuits such as manufacturing and earning money) would have delighted the citizenry of ancient Greece. His view was shared by others: in 1901, John Churton Collins described teaching as a banausic occupation, "the one instinct in [teachers] which is not quite banausic being the conscientious thoroughness with which they impart what they have been taught." It has never quite lost its snobbish undertones, but it has shifted sense slightly to refer to the utilitarian or materialistic aspects of everyday life. Aristocratic disdain for "trade" is a commonplace of literature, the latter regarded as tainted by the low and banausic nature of what it involves (Ideas That Matter, by A C Grayling, 2009).

■ Bankrupt

here's little difficulty in defining this common word — a person declared in law to be unable to pay his or her debts. What's odd about it is its etymology. You might connect the first part with a financial institution, and the second part with rupture. So could it refer to a person forcibly torn from the embrace of his bank? It has a weird kind of sense about it, and actually it's not so far from the truth. The word actually comes from Italian banca rotta, a broken bench (not a rotten one, as the false friend of Italian rotta might suggest - it's from Latin rumpere, to break). The bench was a literal one, however: it was the usual Italian word for a money dealer's table (and indeed is the origin of our bank for a financial institution and also for the sense of break in phrases like "He's gone broke"). In his dictionary, the great Dr Johnson retold the legend that when an Italian money trader became insolvent, his table was broken. But the Italian word was being used figuratively — it could also mean "shipwrecked" or "defeated", for example. Bankrupt arrived in English around the middle of the sixteenth century via the equivalent French form of banqueroute. It was changed into our modern form because people linked the second half with medieval Latin ruptus, broken, from the verb rumpere. That root also turns up in abrupt, corrupt, interrupt ... and rupture.

WHEAT IMPORT IMPERATIVE

¶here was an extraordinary heatwave in March in northern India which caused wheat yields to go down. The heatwave in northern Europe was much worse, and has also affected wheat output As a result of the heatwave, and collapse of exports from Ukraine, the world may be short by around 14 million tonnes. This has caused wheat prices to spiral. There are frantic efforts by major importers, both diplomatic and commercial, to ensure adequate supplies, including those from last year's crop stored in silos. India's Prime Minister had made an assurance that the country could "feed the world" since we had a bumper crop. But a reassessment after the March heatwave led to a hastily imposed export ban on wheat, something that dismayed the farmers eyeing windfall gains due to high international prices.

But by now the situation may be grimmer. This year's output could be 10% lower than last year. Thanks to lower procurement combined with higher allocation both to the public distribution system (PDS) and to the Pradhan Mantri Gareeb Kalyan Anna Yojana (PMGKAY) the current stocks are less than adequate. Between PDS and PMGKAY (free food grain scheme) the total annual requirement is around 32 million tonnes. Add to it a minimum buffer stock of 8 MT that must be maintained for contingencies, emergencies and price stabilisation.

Unfortunately, the current stock which includes carry over stock from last year, and a fresh procurement of 20 MT falls short. This possible shortfall has been denied by the Department of Food and Public Distribution. However, the best indicator of any impending shortage is conveyed by prices. Wheat inflation is running at 12%. Traders anticipate an annual production of only 95 MT sharply down from 111 MT last year. Even an independent assessment by the United States agriculture department pegs India's production this year at 98 MT. The PMGKAY commitment was recently extended for a sixth time, to the end of

September 2022. The in-kind transfer of free food grain has not only ensured some amount of food security but also protected the recipients from food inflation. That's because the benefit was given in kind rather than in cash. The total incremental outlay for the sixth phase is around ₹80,000 crore. The government can consider tapering down the benefits of PMGKAY which had begun during first wave of COVID. But the termination of PMGKAY should not be abrupt.

In this context it is worth emphasising that the import of wheat is not a national embarrassment nor should it be politicised. India has been proudly self-sufficient in food grains for several decades, after the initial success of the green revolution, and of policies of public procurement which gives production incentives to farmers. But over the years many distinct changes in consumption patterns of Indians are discernible. Firstly, there is the transition from coarse cereals like jowar and bajra to fine cereals like wheat and rice. Secondly, the increase in consumption of meat, dairy and poultry. These require higher production of food grains including corn and soya, as animal feed. In fact, the demand for animal feed has gone up sharply and so has the cost, causing high inflation in milk. The third trend in changing consumption patterns is more food being served as readymade food in restaurants and community kitchens. That too is likely on a net basis to lead to increase in the demand for food

Thus, if we extrapolate the demand for food grains, taking into account changing consumption patterns, and rising incomes and prosperity, it is clear that domestic availability will not be enough at the current rate of growth of productivity and yields and acreage. Hence sooner or later India has to plan for food security which has a significant linkage with imports, or encouraging Indian companies to own food production in other land abundant countries like Australia or Ethiopia.

Even as India has to plan for food imports due to looming domestic inadequacy (due to changing consumption patterns), the current situation of food insecurity is grim. The recently published State of Food Security and Nutrition in the World report states that 40.6% of India's population suffered from moderate or severe food insecurity during 2019-21. The proportion of those who are severely food insecure has risen from 20.3% in 2018-20 to 22.3%. The world average is much lower at 10.7%. Thus

more than one third of the world's hungry and undernourished people are in India, which is alarming and embarrassing, if not shameful. India's rank in the global hunger index (GHI) also has dropped to 101 out of 116 countries. The GHI score has been improving in the last few years but the latest score of 27.5 is still considered serious. Even sub-component scores for stunting, wasting and child malnutrition are worrisome. The GHI is computed using three dimensions of child mortality, children malnutrition and food supply adequacy.

In another aspect of its food economy, India has very high dependency on imported edible oils. Even in pulses, a crucial source of proteins, the production has not kept pace and imports of pulses make up 10 to 15% of total consumption. That could go up in the future. Milk production is the highest in the world but per capita consumption needs to go up substantially to come up to the world average. For that to happen, milk production requires much higher production of animal feedstock like corn. This too implies pressure on increasing agricultural production at a faster pace. It is thus clear that in the near future India's dependence on food imports will rise. This by itself is neither a matter of national prestige nor embarrassment. We are after all big importers of energy, which we hope to reduce with greater use of renewable energy. In a similar way we have to approach the challenge of meeting food security needs, by increasing imports in the coming years, and combining it with strategic planning and coordination. Technology will also play a role in increasing productivity and ensuring crop diversification.

But till we meet the challenge of food security needs: till we have higher technology to increase yields and diversify crops; till we combine strategic planning and coordination in imports, the large scale import of wheat will be necessary to ensure food security and domestic price stability in India.

Can gender equality be saved?

try's revolution after standing atop a car, dressed in white, and singing to her fellow demonstrators. Ugandan climate-justice activist Vanessa Nakate went from protesting alone at the gates of her country's parliament to demanding action from world leaders at the United Nations. Senegalese activist Oumou has harnessed digital tools to start taboo-breaking conversations about intimate health, sexuality, contraception, and period poverty.

These young women are fighting for better lives for themselves, their communities, and the world - and they are not alone. Thousands of girls and young women in Africa and around the world are fighting to change the power dynamics that perpetuate inequality and prevent marginalised groups from exercising their fundamental rights. They are making speeches, creating nonprofits and community programmes, and participating in marches to catalyse transformative change. This is good news for everyone: countless studies have shown that when girls and women are empowered, entire communities benefit.

But hard-won gains on gender equality are now in jeopardy. The

Studies show that amid economic hardship, families are more likely to marry off their young daughters, thereby denying girls the right to choose whom they spend their lives with and when and how many children they have. UNICEF estimates that ten million girls worldwide are at risk of child marriage over the next decade because of COVID-19. Moreover, girls and women are more likely to face sexual and genderbased violence during times of crisis - a trend that has been borne

out during the pandemic. Making matters worse, as UN Special Rapporteur on the Right to Health Tlaleng Mofokeng has pointed out, lockdowns, movement restrictions, and the diversion of funds to pandemic-related programmes jeopardised access to sexual- and reproductive-health services, from information about menstruation and fertility to contraception. Specialised services for victims of gender-based violence also became inaccessible to many.

All of this has contributed to a sharp rise in unwanted and early pregnancies, and drastically reopened. According to UNICEF, more than 11 million girls may never return to school after COVID-19.

Simply put, the pandemic has wiped out decades of progress toward gender equality, with the most vulnerable groups - such as displaced women and girls - being hit the hardest. To be sure, even in the face of such massive setbacks, young women and girls are not giving up. But they cannot overcome the powerful forces working against them alone. Meaningful engagement from men is crucial here. Initiatives like the clubs des pères (father's clubs) or the écoles de maris (husband schools) in Senegal can make a significant difference. The goal is to foster positive (rather than toxic) masculinity encourage men to share more of the burden of unpaid care work, and bring about improve-

ments in child and maternal health. Engagement with community and religious leaders, as well as with health-care workers and women's rights organisations, also

Likewise, amplifying the voices of young leaders can inspire and invigorate their peers. Ubah Ali, a Somaliland activist, was persuaded that she too could lead, that she

other girls in positions of leadership. Today, she is working to eradicate all forms of female genital mutilation across Somaliland, and to support survivors of the practice. But perhaps nothing will do

more to ensure that young women and girls can fulfill their potential as forces of change than protecting and respecting their rights, including their sexual and reproductive rights. This is a job for governments, first and foremost, though everyone has a role to play.

The pandemic is just the beginning. With climate change and rising food insecurity also set to hurt women and girls disproportionately the barriers to progress on gender equality are as high as the stakes. The first step toward overcoming them is to acknowledge the challenges girls and women face, and to amplify the difficult and important work they are doing.

A world where all girls and young women hold equal power would be better for everyone. That is why it is in everyone's interest to help them achieve it.

Facing an aggressive China

Sir, This refers to "US drones to help India fortify China border," Orissa POST, August 22. It is a timely act by the Centre to procure 30 MQ-9B Predator armed drones from the US in the wake of growing security threat from China in Ladakh region and in the Indian Ocean as well. The Yuan Wang 5, unlike other Chinese warships that have docked at Colombo port, berthed at Hambantota, which has been under Chinese control for almost five years, and this could be a precursor to a more established presence for the Chinese navy in regional waters. The regular presence of vessels in the waters off Sri Lanka that can track satellites and other aerial assets and scoop up technical intelligence does not bode well for India's coastal defences or naval operations in a swathe of the southern part of the country. It is no secret that China plans to establish a larger naval presence in the Indian Ocean, alongside plans to have a fleet of more than 400 vessels by 2025, as it ramps up the construction of infrastructure along the Line of Actual Control. These moves are part of efforts to encircle India, which must move swiftly to catch up. In the initial stages, India should consider greater naval operations along with partners such as Australia, Japan, and the United States while it focuses on the task of expanding its naval fleet. In this alarming situation, India needs to step up the efforts to acquire advanced surveillance equipment and weaponry to counter an aggressive China.



During the daylong "mahapanchayat" organised by the Samyukta Kisan Morcha (Non-Political) at Jantar Mantar, the farmers carrying the flags of their unions raised slogans against the BJP-led Centre for "not fulfilling" its promises. They also demanded the arrest of Union minister Ajay Mishra, who they said was responsible for the "massacre of farmers" in Lakhimpur Kheri district of Uttar Pradesh.

China to resume student visas for Indians PRESS TRUST OF INDIA

New Delhi/Beijing, August 22: China Monday announced plans to issue visas to hundreds of Indian students stranded at home for over two years due to Beijing's strict COVID restrictions, besides various categories of travel permits for Indians including business visas.

"Warmest congrats to #Indian #students! Your patience proves worthwhile. I can really share your excitement & happiness. Welcome back to #China!" Ji Rong, Counsellor, Department of Asian Affairs, Ministry of Foreign Affairs, China tweeted.

Her tweet cited a detailed announcement by the Chinese Embassy in New Delhi announcing the opening of visas for students, businessmen and families of those working in China.

As per the announcement, X1-Visa, will be issued to students who intend to go to China to pursue long-term study for higher academic education, including newlyenrolled students and students who return to China to resume their studies

Over 23,000 Indian students, mostly studying medicine, are reportedly stuck back home due to COVID visa restrictions. India had submitted a list of several hundred students after China sought the names of those wanting to return immediately to pursue their studies.

Some students from Sri Lanka, Pakistan, Russia and several other countries have already arrived on chartered flights in recent weeks.

SC agrees to list plea to review PMLA verdict

New Delhi, August 22: The Supreme Court Monday agreed to list a plea seeking review of its judgement upholding the Enforcement Directorate's powers in connection with attachment of property involved in money laundering, arrest, search and seizure under the Prevention of Money Laundering Act.

As counsel mentioned the matter before a bench headed by Chief Justice N.V. Ramana, the bench said: "Okay, we will list it." Only 27, the top court affirmed the stringent provisions of Prevention of Money Laundering Act (PMLA) in connection with definition of proceeds of crime, power of arrest, search & seizure, attachment of properties and also the twin bail condi-

A bench headed by Justice A.M. Khanwilkar (now retired) and comprising Justices Dinesh Maheshwari and C.T. Ravikumar said: "The international bodies have been discussing the menace of money laundering on regular basis for quite some time; and strongly recommended enactment of stringent legislation for prevention of money laundering and combating with the menace thereof including to prosecute the offenders and for attachment and confiscation of the proceeds of crime having direct impact on the financial systems and sovereignty and integrity of the countries.

It added that money laundering is one of the heinous crimes, which not only affects the social



and economic fabric of the nation, but also tends to promote other heinous offences, such as terrorism, offences related to NDPS

The top court affirmed the validity of Sections 5 (attachment of property), 8(4) (taking possession of attached property),3 (definition of money laundering), 17 (search and seizure), 18 (search of persons), 19 (powers of arrest), 24 (reverse burden of proof), 45 (offences being cognisable and non-bailable and twin conditions for grant of bail by court), 50 (statements made to ED officials), and 44 (offences triable by special

However, the top court left the question whether some of the amendments to the PMLA, 2002 could not have been enacted by the Parliament by way of a Finance Act, to be considered by a larger bench.

Universities to recruit experts as 10% faculty

New Delhi, August 22: Universities and higher education institutions will soon be able to hire distinguished experts as faculty members under a new category for which formal academic qualification and publication requirements will not be mandatory.

The decision was taken by the University Grants Commission (UGC) in its 560th meeting last week and the scheme - "Professors of Practice" -- is likely to be notified next month. According to the approved draft guidelines of Professors of Practice, experts from fields such as engineering, science, media, literature, entrepreneurship, social sciences, fine arts, civil services, and armed forces among others will be eligible to be hired.

"Those who have proven expertise in their specific profession or role with at least 15 years of service or experience, preferably at a senior level, will be eligible for Professors of Practice. A formal academic qualification is not considered essential for this position if they have exemplary professional practice in lieu," read the guidelines, which are likely to come into effect from the upcoming academic session.

"These experts will also be exempted from the requirement of publications and other eligibility criteria stipulated for the recruit-

According to the approved draft guidelines of Professors of Practice, experts from fields such as engineering, science, media, literature, social sciences, fine arts, civil services, and armed forces among others will

be eligible to be hired ment of faculty members at the Professor level."However, they should possess the skills to carry out the duties and responsibili-

ties," according to the guidelines. The commission has decided that the number of Professors of Practice in a higher education institution (HEI), at any point in time, should not exceed 10 per cent of the sanctioned posts. The faculty members under the scheme will be engaged in three categories --Professors of Practice funded by industries, Professors of Practice engaged by HEIs from their own resources and Professors of Practice on honorary basis. "The engagement of Professors of Practice will be for a fixed term. Their hiring will be exclusive of the sanctioned posts of a university or college. It will not affect the number of sanctioned posts and the recruitment of reg-

ular faculty members, "it said.

U'khand to have India's first observatory to monitor space activity

New Delhi, August 22: India's first commercial space situational awareness observatory, to track objects as small as 10 cm in size orbiting the earth, will be set up in the Garhwal region of Uttarakhand by Digantara, a space sector start-up.

The space situational awareness (SSA) observatory will help India track any activity in space including that of space debris and military satellites hovering over the region. Currently, the United States is a dominant player in monitoring space debris with observatories in multiple locations and commercial companies providing additional inputs from across the world.

'The observatory Uttarakhand will fill the crucial gap in SSA observations in the re-

gion as there is a lack of such facilities between Australia and southern Africa," Anirudh Sharma, Chief Executive Officer (CEO) of Digantara said.

The high-quality observations, along with those of its partner ground-based sensor network, would help improve its ability to monitor events occurring in deep space, especially in the geostationary, medium-Earth, and high-Earth orbits. "With this data, it would be able to reduce the potential for collisions between satellites and other spacecraft by making more accurate predictions of their location, speed, and trajectory," Sharma said.

'Will resist voting rights to non-locals in J&K'

Srinagar, August 22: Any decision to include "non-locals" in electoral rolls in Jammu and Kashmir is unacceptable and will be contested by all means including in court, National Conference president Farooq Abdullah said Monday after a meeting of nine parties here over

Abdullah said they were united against the move to extend the voting right to "outsiders" as it would rob Jammu and Kashmir of its

"The state's identity is about to end. The Dogra, Kashmiri, Pahari or Gujjar or Sikh, who reside here, will lose their identity. The assembly will be in the hands of the outsiders... We all oppose it and are not ready to accept it," he told reporters.

The meeting, called by Abdullah, was attended by leaders of the Congress, PDP, Awami National Conference (ANC), Shiv Sena, CPI, CPI(M), JDU and the Akali Dal Mann. However, Sajjad Lone-led People's Conference and Altaf Bukhar's Apni Party staved away.

The BJP, meanwhile, accused the NC, PDP and other parties of spreading "misleading propaganda" to poison the minds of the people over the issue of "inclusion of non-local voters" in the revised electoral rolls in the Union

Kerala govt to table new Bill clipping Guv's powers

Thiruvananthapuram, August 22: Chief Minister Pinarayi Vijayan will Wednesday table a new Bill in the Kerala Assembly aimed at curtailing the powers of Kerala Governor Arif Mohammed Khan as Chancellor of universities.

The 10-day special session of the Assembly that got underway here Monday morning, has been specifically called to float 12 Bills, after 11 Ordinances lapsed following Khan's refusal to re-promulgate them earlier this month.

Consequent to Khan refusing to ink the re-promulgation, the CPI-M and Khan have been having a free-for-all. Slamming the Kannur University Vice-Chancellor Gopinath Ravindran, the Governor had called him a "criminal" act ing as a CPI-M cadre.

Khan has been up in arms against the Kannur University Vice Chancellor, after he cleared the appointment of the private secretary of Vijayan, KK Ragesh's wife Priya Varghese to the post of Associate Professor in Malayalam. Last week, the appointment was stayed after allegations of large-scale nepotism surfaced.

He also announced to constitute a special commission to probe all the appointments made in the various universities in the past few years in the wake of allegations that a good number of kith and kin of the CPI-M led Left have secured back door appointments.

Against the backdrop of all the developments, Vijayan Monday decided to come out with a new Bill which will cull the powers of the Governor, as he is also the Chancellor of all Universities in

Thiruvananthapuram, August 22: The Central intelligence agencies have commenced a probe after an article in the IS mouthpiece Voice of Koharasan' mentioned that the first Indian suicide bomber for them was a Keralite who had converted from Christianity to Islam.

In the latest issue of the magazine, the article about the suicide bomber is in the chapter 'Memories of Shuhada', a portion dedicated to the memories of those who died fighting for IS.

The article did not, however, mention the exact identity of the youth. It dwells that he was an engineering graduate from Kerala who had worked in Bangalore as an engineer and later migrated to Dubai.

The article further states that the youth had assumed the name,



'Aboobacker Al-Hindi' and that he got attracted to Islam while in UAE. He later did more research on the religion through available online portals and later converted to Islam.

After conversion, he, according to the magazine, got attracted to the ideology of Jihad and contacted the IS sleeper cells in Dubai. He was planning to go to Yemen for further training, but was not able to and hence returned to his home state, Kerala. After spending some time in Kerala, he got a message from his IS contacts that there was an opportunity in Libya and accordingly he reached there under the guise of searching for a new job. According to the article, he fought against the Libyan Army at Sirsit,

the IS the stronghold, and later became a suicide bomber and blasted himself to death.

had earlier itself got some wind of such a person and had commenced a probe into the same.

Sources in the agency told IANS that he would have committed the act in 2015-16 and that there was some information about him with the Central agencies

Sources in the agencies also told that they have details of 100 youths from Kerala who had left the shores of the state to reach IS and officials said that there could be more people who have joined the IS in

Svria and Yemen. It is to be noted that 'Aboobacker

Al-Hindi' is the third person from Kerala, who had died for the cause propagated by the organisation, according to its mouthpiece, 'Voice of Khorasan'.

The first one who, according to IS, had become a suicide bomber was identified as Mohsin from Trikkaripur in Kasargod district. He was the suicide bomber who attacked the Sikh Gurudwara in Kabul and blasted himself March 25 2020 He was named in an earlier edition of 'Voice of Khoarasan' as 'Abukhalid Al-Hindi'. In the suicide bombing, he had accompanied two others and caused the death of 25 people.

The second person mentioned in the IS magazine is Dr Ejas, who had ioined the IS from Kasargod district of Kerala. His full name was Ejas Kallukettupurayil and he was a doctor. The IS publication division eulogises him for the 'brave act' of killing 39 people by attacking a jail in Kabul.

The National Investigation Agency had in its report said that Dr Eias had left India in 2016 along with his pregnant wife Refala.

The central agencies are probing the latest revelations in the IS publication and are trying to ascertain whether anyone else had left to join the IS along with 'Aboobacker Al-Hindi'

Jammu, August 22: A special court here Monday offered legal aid to JKLF chief Yasin Malik, but he turned it down and again insisted on his physical appearance in the hearing on the killing of four Indian Air Force (IAF) personnel in 1990.

Malik appeared in the hearing via video conference from Delhi's Tihar Jail where he is currently lodged, standing counsel for the CBI Monika Kohli said. Malik, 56, is serving a life sentence in a terror-funding case.

After the Jammu and Kashmir Liberation Front (JKLF) chief declined the offer of legal aid, the court asked him to submit his stand in writing on the next date of hearing in the third week of September, Kohli said

Turning down his plea for physical appearance, the court said there were clear directions from the high court for producing the accused in all cases through video conferencing. However, the court offered him legal aid but he declined, the CBI counsel said.

Malik observed a 10-day hunger



strike from July 22 after the Centre did not respond to his plea for allowing him to physically appear in a Jammu court hearing the Rubaiya Sayeed abduction case in which he is an accused.

Kohli is the chief prosecutor in the two key cases against Malik - the 1989 abduction of Rubaiya Sayeed, the daughter of then Union home minister Mufti Mohammad Sayeed, and the killing of four IAF personnel -- which had taken place when militancy broke out in Kashmir Valley.

She has been representing the Central Bureau of Investigation (CBI) as a retainer counsel in the Jammu and Kashmir High Court since 2015.

In the case of killing of the IAF personnel, charges were framed against Malik, Ali Mohammed Mir, Manzoor Ahmed Sofi alias Mustafa, Javed Ahmed Mir alias 'Nalka', Showkat Ahmed Bakshi, Javed Ahmed Zargar and Nanaji in March

They all have been chargesheeted for murder, attempt to murder and under sections of the from now-defunct Terrorist and Disruptive Activities (Prevention) Act.

The framing of charges was in connection with the case related to the killing of Indian Air Force of ficers January 25, 1990 on the outskirts of Srinagar city. The chargesheet was filed by the CBI the

same year in August. According to the CBI, the IAF personnel were fired upon by terrorists in which 40 of them, including a woman, received serious injuries and four IAF personnel were killed on the spot.

Recently, the Central Bureau of Investigation (CBI) got summons issued to prime witness Rubaiya Sayeed, who had been kidnapped in December 1989, for recording her statement. This was for the first time in 33 years that she was appearing before the court.

During the trial, Rubaiya Sayeed identified Malik as one of the kidnappers. Malik had recently demanded that he be allowed to appear physically before the Jammu court for cross-questioning the prosecution witnesses in the case.

While four of them died on the spot, two others succumbed to injuries in a hospital, Superintendent of Police (rural) Suraj Rai said. The accident took place late Sunday night.

SC Constitution bench to hear Centre-Delhi govt row

New Delhi, August 22: Chief Justice N V Ramana Monday said he has set up a five-judge Constitution bench to hear the legal issue concerning the scope of legislative and executive powers of the Centre and National Capital Territory government over control of services in Delhi.

The CJI said a bench headed by Justice DY Chandrachud will hear the dispute between the Centre and the Delhi government. The matter was mentioned by an advocate before the bench also comprising Justices Hima Kohli and C T Ravikumar

May 6, the top court had referred to a five-judge Constitution bench the issue of control of services in Delhi. The apex court had said the limited issue of control over services was not dealt with by the Constitution bench which elaborately dealt with all legal questions.

"The limited issue that has been referred to this Bench relates to the scope of legislative and executive powers of the Centre and NCT Delhi with respect to the term services'. The Constitution bench of this court, while interpreting Article 239AA(3)(a) of the Constitution, did not find any occasion to specifically interpret the impact of the wordings of the same with respect



to Entry 41 in the State List."We, therefore, deem it appropriate to refer to the above-limited question, for an authoritative pronouncement by a Constitution Bench..., it had said. Sub Article 3 (a) of 239AA (which deals with the status and power of Delhi in the Constitution. deals with the law-making power of the Delhi Legislative Assembly on the matters enumerated in the State List or the Concurrent List.

The central government had also sought a joint hearing of two separate petitions of the Delhi government on control over services and challenging the constitutional validity of the amended GNCTD Act, 2021 and the Transaction of Business Rules, which allegedly give more powers to the Lieutenant Governor respectively, saying they are prima facie correlated.

M ay 6, the top court had referred to a five-judge Constitution bench the issue of control of services in Delhi

February 14, 2019, in which, a two judge-bench of Justices AK Sikri and Bhushan, both retired since had recommended to the Chief Justice of India that a three-judge bench be set up to finally decide the issue of control of services in the national capital in view of its split verdict.

Justice Bhushan had ruled the Delhi government had no power at all over administrative services. Justice Sikri, however, made a distinction. He said the transfer or posting of officers in top echelons of the bureaucracy (joint director and above) can only be done by the Central government and the view of the lieutenant governor would prevail in case of a difference of opinion on matters relating to other bureaucrats.

In the 2018 judgement, a fivejudge Constitution bench had unanimously held that the Lieutenant Governor of Delhi is bound by the aid and advice of the elected government, and both needed to work harmoniously with each other.



Perked up after its Punjab accomplishments, AAP's heart was set on Himachal Pradesh with an organizational building presence



marked out for Gujarat. However the raid and arrest of health minister Satyendar Jain and the 'attack' on Kejriwal's residence by activists of the Bharatiya Janata Yuva Morcha (BJYM) led to a change in AAP strategy. Jain was heading the AAP election offensive in Himachal and his arrest was timed to throw a spanner in its works.

AAP now realises that it can no longer avoid a straight fight with the BJP. Prime Minister Modi's 'revadi' remarks provided just the opening Keiriwal needed to take the battle to the highest level in the BJP. "Those who were terming his welfare schemes as freebies, were traitors to the country", the Delhi Chief Minister was quoted as saying on August 8, adding that an atmosphere is being created in the country against provisions of free education at government schools and free treatment at government hospitals

Kejriwal was well aware that Modi after a frontal attack leaves it to his sub-ordinates to deal with the contradictions that follow. True to form, it was Finance minister Nirmala Sitharaman who reacted terming it a" perverse twist" to the debate on freebies with the


Delhi Chief Minister attempting to create fear in the minds of the poor. But Kejriwal had secured a tactical advantage. He had escalated the fight to the highest level and turned the action-reaction narrative on its head where he sets the agenda, answers it himself and leaves the opponent to react to it, in true Modi style.

The AAP strategy is now to go all out in Gujarat, taking the poll fight to the Modi-Shah citadel with Kejriwal leading the charge. The Modi government may have staved off an immediate BJP-AAP electoral confrontation this May through the move to unify the three municipal corporations in Delhi, but there are no such compulsions for AAP in Gujarat.

Kejriwal seems to have lifted a page straight out of Modi's stylebook but presents it in a very contrasting style. Similarity is that he sets the narrative, forcing his opponent to react. In essence, Keiriwal is doing to the BJP in Guiarat exactly what Modi as Chief Minister was doing to the Congress-

ruled Centre during UPA rule. In 2014, Kejriwal's decision to take on Modi in Varanasi and his defeat may have seemed an ill-advised move then but is beginning to make sense as he matches paces with him in his home state with an eye on 2024. His strategy is already beginning to yield results.

Indiana governor in Taiwan

Taipei: Indiana's Republican governor met with Taiwanese President Tsai Ing-wen on Monday, following two recent high-profile visits by US politicians that drew Beijing's ire and Chinese military drills that included firing missiles over the island. Fauci to step down as chief medical adviser

Washington: Dr Anthony Fauci, the US epidemiologist who emerged as the face of reason amidst the tide of bigotry that swent through the world in response to Covid, is leaving government service. Fauci said he will leave by the end of the year to "pursue the next chapter of my career". Fauci had been America's top epidemiologist for decades, leading the fight against HIV/AIDS and Ebola.

Sri Lanka hikes kerosene prices

Colombo: Amid the continuing economic crisis, Sri Lanka's state-owned fuel distributor Ceylon Petroleum Corporation (CPC) has hiked the price of kerosene to cut losses. The hike took effect Sunday midnight, reports Xinhua news agency Issuing a statement, the CPC said the price of a liter of kerosene increased by 253 LKR (\$0.7) to 340 LKR.

25 deer die of rabies

Colombo: Around 25 deer that live in Homagama, a suburb of Sri Lanka's capital of Colombo, have died of rabies, the wildlife department announced. The department asked residents of the area not to hand feed deer as rabies can spread from saliva. reports said. The department said local residents have found dead deer in recent weeks.

Imran moves court

Islamabad: Former Pakistan Prime Minister Imran Khan Monday moved the Islamabad High Court (IHC) and sought a pre-arrest bail in a terror case filed against him. The plea was filed through Khan's counsels, Faisal Chaudhry and Babar Awan, in the capital's top court after a late-night drama at Bani Gala, his private residence where police and PTI workers almost came face-to-face following reports that arrest warrants have been issued for the PTI chairman, The News reported.



Area near Ukraine N-plant hit again

Nikopol, August 22: Russian shelling across the river from Ukraine's main atomic plant wounded four people Monday, an official said, only hours after the latest international pleas to spare

the area from attacks to prevent a nuclear disaster.

While Washington and Seoul describe their exercises as defensive, North Korea portrays them as invasion rehearsals that justify its nuclear weapons and missiles development. Cho Joong-hoon, a

Unification Ministry, which handles inter-Korean affairs, said the South hasn't immediately detected any unusual activities or signs from the North.

The United States and South Korea had cancelled some of their regular drills and reduced others to computer simulations in recent years to create space for diplomacy with North Korea and because of Covid-19 concerns.

Ulchi Freedom Shield, which started along with a four-day South Korean civil defense training program led by government employees, will reportedly include simulated joint attacks, front-line reinforcements of arms and fuel, and removals of weapons of mass destruction. port access to the vessel from August 16 to 22 on condition that it will keep the Automatic Identification System (AIS) switched on within the Exclusive Economic Zone (EEZ) of Sri Lanka and no scientific research to be conducted in Sri Lankan waters.

Sri Lanka has said that the security clearance was granted from the Ministry of Defence for the

All states and territories repealed gay sex bans between 1975 and 1997, while Parliament legalised same-sex marriage throughout the country in 2017. The age of consent became equal for all sexual acts as of 2016.

People convicted for consensual sexual acts that are no longer illegal can have their criminal records cleared.

CHINA

Homosexuality is not criminalised by law, but same-sex marriage remains unlikely to be legalised in the near future. While the largest cities have vibrant LGBTQ scenes, the stigma remains strong in Chinese society. **INDIA**

The Supreme Court in 2018 struck down the section of the law that punished sexual intercourse by members of the same sex by up to 10 years in prison. Despite the landmark ruling, same-sex mar-



riage remains illegal and multiple petitions seeking legal recognition have been met with resist ance by the government. **INDONESIA**

Sex between consenting adults of the same sex is not illegal in the world's most populous Muslim nation, except in conservative Aceh province. However, only marriages between a man and a woman are legal. The LGBTQ community in the country of 250 million people complains of regular harassment and persecution.

Support for sexual diversity has grown slowly, but legal protections are lacking for LGBTQ people, who often face discrimination at school,

work and at home, causing many to hide their sexual identities.

A number of same-sex couples have filed lawsuits demanding a right to legally marry, but court rulings have been divided.

MALAYSIA

Malaysia has strict laws against same-sex intercourse that can result in up to 20 years' imprisonment. A former deputy premier was jailed twice for sodomy. He was sentenced in 2000 and again in 2014, in cases that critics say were politically motivated.

Malaysia has even tried to censor or ban movies which it deems to promote what it calls the LGBTQ lifestyle, including Disney's recent animated film "Lightyear."

NEW ZEALAND

New Zealand decriminalised gay sex in 1986. Sex between men was first made illegal in 1961, while sex between women was never specifically made illegal although was stigmatised.

In 2005, New Zealand began recognising civil unions between same-sex couples, which conferred many legal rights to gay couples - but didn't, for instance, allow them to jointly adopt children. In 2013, New Zealand became the first nation in the Asia-Pacific region to legalize same-sex marriage.

Taiwan legalised gay marriage in 2019, but LGBTQ activists want the law to be made more inclusive. It currently says both partners must be from a place where such marriages are already legal. So couples cannot register their marriage in Taiwan if one partner is from a place like Japan or another place where their marriage would



Beijing: China's central bank has cut its mortgage rate as officials work to support the crisis-hit property market. The People's Bank of China (PBOC) lowered the five-year loan prime rate (LPR) by 1.5 percentage points, which matches its biggest cut on record, the BBC reported. The world's second largest economy faces a property crisis that has seen some building projects grind to a halt. PANDEMIC UK economy dip 11% in '20, worst since 1709

London, August 22: Britain recorded its biggest fall in output in more than 300 years in 2020 when it faced the brunt of the Covid-19 pandemic, as well as a larger decline than any other major economy, updated official figures showed Monday.

Gross domestic product fell by



11.0% in 2020, the Office for National Statistics said. British statisticians regularly update GDP estimates as more data becomes available.

The ONS's initial estimates had already suggested that in 2020 Britain suffered its biggest fall in output since the "Great Frost" of 1709. But

more recently the ONS had revised down the scale of the fall to 9.3%, the largest since just after World War One.

Even before the latest revisions Britain's economic slump was the largest in the Group of Seven, and the latest downward revision makes it greater than Spain's, which recorded a 10.8% fall in output.

However the ONS cautioned against direct comparisons with other countries as most - with the ex

ception of the United States - had not yet undertaken the same type of indepth revisions as Britain had.

The downward revision in GDP reflected lower contributions from healthcare and retailers than previously thought.

Britain's economy bounced back sharply last year and recovered its pre-pandemic size in November 2021. But fast-rising inflation means the Bank of England expects the economy will slip back into reces-

sion later this year.

LONDON: British consumer price inflation is set to peak at 18% - nine times the Bank of England's target - in early 2023, an economist at US bank Citi said Monday, raising his forecast once again in the light of the latest jump in energy prices. "The question now is what policy may do to offset the impact on both inflation and the real economy," Benjamin Nabarro said in a note to clients. Consumer price inflation was last above 18% in 1976. With inflation now set to peak substantially higher than the Bank of England's 13% forecast in August, its Monetary Policy Committee was likely to conclude that the risks of more persistent inflation have intensified, the note said

New Delhi, August 22: Indian banks have increased their fundraising activity through the issuance of certificates of deposits, as funding in the banking system continues to contract, analysts said. "Banks are not raising deposit

rates, as they are able to get funds easily from money market by issuing CDs, and that too cheaply, and they may continue to opt for this route of fundraising for next few weeks," said Raju Sharma, head of fixed income at IDBI Mutual Fund.

Indian private and state-run banks have raised around Rs 300 billion (\$3.76 billion) through twomonth to one-year CDs in the two weeks to August 19, sharply higher than the roughly Rs 50 billion in the previous two weeks, data compiled by Reuters showed.

Larger lenders, such as Punjab National Bank and Bank of Baroda, have also jumped the bandwagon and are actively borrowing funds through three-month and one-year notes. These lenders are paying around 6.60%-6.74% for one-year



funds, and keen to tie up funds for a year in anticipation of policy tightening in the near future The Reserve Bank of India's

Toyota doubles down on its hybrid bet in India

Toyota's Indian strategy is at odds with global rivals Volkswagen, General Motors and India's Tata Motors, which are rushing to roll out pure electric vehicles (EVs), and comes in the face of criticism from investors for sticking with fossil-fuel hybrids

Bidadi, August 22: Toyota is rebooting its strategy for India, doubling down on a bet that emerging markets will learn to love its hybrids, as long as the price is right.

Renowned for its pioneering Prius, the Japanese carmaker has struggled to sell large numbers of its hybrid Camry sedan since its Indian debut in 2013, partly due to a sticker price of more than eight times the annual income of a middle-class family.

This time, Toyota is determined to do it differently with lowercost hybrids, said four company and industry executives and sup-

pliers who provided previously unreported details about the carmaker's sourcing, production and pricing strategy.

Central to the strategy is a drive to cut the cost of full hybrid powertrains by making them in India, where the automaker's factories are running well below capacity, and to source key materials within the country.

Toyota Motor is also leveraging its cooperation with partner Suzuki Motor, majority owner of India's biggest carmaker Maruti, to benefit from its low-cost engineering knowhow and mild hybrid technology. The hybrid bet is a turning

Raza's gutsy ton goes in vain as India ride on Gill's maiden ton to beat Zimbabwe by 13 runs in the third and final ODI

Harare, August 22: Sikandar Raza's lion-hearted effort (115, 95b, 9x4, 3x6) took Zimbabwe on the cusp of a famous victory before India held their nerves to pull off a 13-run win in the third ODI and

The final game of the series too was heading India's way until Raza brought Zimbabwe back into the contest with the support of Brad Evans (28). The duo shared a 104run stand off 77 balls for the eighth wicket to raise hopes of a memorable result. However, Raza fell to a brilliant catch by Shubman Gill in the penultimate over, as India scraped through.

It was Gill (130, 97b, 15x4, 1x6) who had set up the game for India as he smashed his maiden international hundred to take the visitors to 289/8. Zimbabwe's innings ended at 276 in 49.3 overs.

Gill, who reached a major career milestone more than three years after making his India debut, shared a 140-run stand with Ishan Kishan (50, 61b, 6x4) after the visitors decided to bat for the first time in the series.

Sean Williams (45, 46b, 7x4) and Raza played some bold strokes early in the Zimbabwe chase. Deepak Chahar (2/75) once again impressed with the new ball while left-arm spinner Axar Patel (2/30) got welcome wickets in the middle overs.

Chahar got his first wicket with a booming inswinger as Innocent Kaia (6) was trapped while charging down the wicket. His opening partner Takudzwanashe Kaitano (13), who walked back to the dressing room with leg pain, returned to the middle but not for long. India spinner Kuldeep Yadav (2/38) drew him



forward with a wrong un that had the Zimbabwean stumped. Though Zimbabwe kept losing wickets regularly, the seasoned Raza stood strong before completing his third hundred in the last six innings.

Opting to bat for the first time in the series. India did not have the most fluent of starts as they struggled to 63/1 in 15 overs. Both the seasoned openers – skipper KL Rahul (30) and Shikhar Dhawan (40) would be disappointed at not being able to convert their starts.

Coming back from a long injury break, Rahul had an ideal oppor-

tunity to get back into groove ahead of the Asia Cup T20. He played on to a length ball off medium pacer Brad Evans who ended up taking five wickets for the first time.

Barring the stand between Gill and Kishan, not much stood out from the Indian innings. Gill, who made his ODI comeback with the series against the West Indies, was a treat to the eye during his innings. The 22-year-old played shots all around, with his straight drives and cover drives standing out.

Gill had a few nervous moments in the 90s before he reached the mile-

stone. Evans appealed for a close leg before call but the DRS was turned down after UltraEdge showed that the ball touched Gill's bat before thudding into the pads. On the same ball however, Kishan was run out at the other end after he left his crease for a quick single, but Gill was pre-

occupied with the appeal.

The bench said bearing in mind the importance of the U-17 Women's World Cup 2022 tournament being held in India, it is passing the directions on the application - the election programme, which was fixed in pursuance of the order dated August 3, 2022, is permitted to be modified by extending the date of election by one week.

It said the returning officers -Umesh Sinha and Tapas Bhattacharya-shall be deemed to be the returning officers appointed by this Court to conduct the elections as there has been no objection to their continuance by any of the contesting parties before this Court, including the member associations representing the States/Union Territories.

Praggnanandhaa beats Carlsen, finishes second

Miami, August 22: Young Indian Grandmaster R Praggnanandhaa produced a superb performance, winning three straight games including two in the blitz tie-breaks to outwit World No.1 Magnus Carlsen 4-2 in the final round of the FTX Crypto Cup here Monday.

However, despite the win over Carlsen, the 17-year old could only take second place in the final standings. The Norwegian won the top prize on the basis of a higher score. He finished with 16 match points to the Indian prodigy's tally of 15.

"I've been playing badly all day, but now I'm getting the results I deserve. It's never good to lose, but this is as good a time as any!' Carlsen said after the match.

Alireza Firouzja, another highlyrated teen and a prodigy, also finished on 15 points but had to settle for third place as he had lost the clash against Praggnanandhaa

The first two games of the Carlsen-Praggnanandhaa match were drawn before the World No.1 went ahead by clinching the third. In a surprise turn of events, the Indian won the fourth game to push the match into the tie-breaks. He shocked the Norwegian by



winning both the games in the tie-break.

Praggnanandhaa has been in splendid form this year and had previously beaten the world champion twice in online events. He also played a crucial role in the India 'B' team claiming a bronze medal in the 44th chess Olympiad in Chennai recently.

'I think it could have done better the last few days but I think overall 2nd is good,' Praggnanandhaa said after the game against Carlsen.

Praggnanandhaa started his campaign with victory over World No.4 Firouzja and also scored wins over World No.9 Anish Giri and World No.6 Levon Aronian.

New Delhi, August 22: Former electoral officer in the Bihar government, Ajay Nayak has been appointed as the returning officer for the Hockey India elections, to be conducted by October 9.

The appointment was made during a meeting held between the International Hockey Federation_ (FIH) and the Committee of Administrators (CoA) running the sport in the country currently.

The meeting was attended by FIH acting president Seif Ahmed, CEO Thierry Weil and members of the CoA, Justice Anil R Dave, SY Quraishi and Zafar Iqbal. AK Majumdar has been appointed as the assistant returning officer: "They will be assuming their positions with immediate effect," the national federation said in a statement.

The two-member FIH delegation was in the national capital to discuss the way forward and avert a possible suspension of Hockey India, currently placed under the CoA on the directive of the Delhi High Court. The FIH categorically stated that it "does not consider the court as third party", ruling out the possibility of a ban with only months left for the men's World Cup, to be held in Bhubaneswar and Rourkela from January 13 to 29.

Protesting workers detained in Qatar

Dubai, August 22: Qatar recently arrested at least 60 foreign workers who protested going months without pay and deported some of them, an advocacy group said, just three months before Doha hosts the FIFA World Cup. The move comes as Qatar faces

intense international scrutiny over its labour practices ahead of the tournament. Like other Gulf Arab nations, Qatar heavily relies on foreign labour. The workers' protest a week ago — and Qatar's reaction to it — could further fuel the concern. The head of a labour consul-

tancy investigating the incident said the detentions cast new doubt on Qatar's pledges to improve the treatment of workers. "Is this really the reality coming out?" asked Mustafa Qadri, executive director of the group, Equidem Research.

In a statement to this agency, Qatar's government acknowledged that "a number of protesters were detained for breaching public safety laws." It declined to offer any information about the arrests or any deportations.
