## **FOURTH JUMBO ELECTROCUTED**

Dhenkanal, August 28: There is no let up in elephant deaths due to electrocution in the state as pregnant female elephant died after coming in contact with live wires laid by poachers in a jungle near Asanbahali in Ghagramunda panchayat under Mahabirod forest range in this district, Sunday.

On being informed, Forest officials rushed to the spot and started an investigation. The carcass was buried after conducting post-mortem.

When contacted, divisional forest officer (DFO) Prakash Chand Gogineni confirmed the development stating that pregnant pachyderm aged less than 25 years died after coming in contact with live wires laid by poachers for killing wild boars. He said that a probe is underway. Forest officials have arrested one of the two poachers responsible for the death and seized the live wires

Notably, this is the fourth elephant casualty due to electrocution in the last four days. A tusker died due to electrocution in Angul district Saturday barely two days after a pair of female elephants met the same fate in Keonjhar district, August 25.

# ₹1,100cr spent on relief per annum

Bhubaneswar, August 28: On an average, the Odisha government has distributed nearly ₹1.100 crore each year as relief to the people affected by various natural calamities including cyclones and floods, during

According to data from the state revenue and disaster management department, the Odisha government has released funds to the tune of ₹5,479.02 crore to various districts for distribution of relief to the affected people in between 2017-18 and 2021-22

The funds were released out of the State Disaster Response Fund (SDRF) and the National Disaster Response Fund (NDRF).

While ₹848.68 crore were released in the financial year 2017-18, this was increased to ₹1,227.92 crore in 2018-19 and ₹2,340.29 crore in 2019-20.

The relief expenditure remained a little low during 2020-21 and 2021-22 at ₹423.10 crore and ₹639.03 crore, respectively.

and drought almost each year. During the above-mentioned five years, the eastern state has faced several such calamities including cyclonic storms Titli in 2018, Fani in 2019, Amphan in 2020, and Yaas, Gulab and Jawad in 2021. Besides heavy rainfall, floods and drought also hit some districts of the state during the five years. This year too, many districts of the state are still reeling under floods.

Among all the natural disasters that affected Odisha during these five years, cyclone Fani had caused severe losses hitting many districts including Puri, Khurda, Navagarh and Cuttack

During the five years, the state government has released the highest amount of ₹1439.47 crore to Puri district, which was severely hit by cyclone Fani. Ganjam, another coastal district of Odisha which was affected by cyclone Titli, has received ₹808.69 crore for relief measures. **Contd...4** 

## Speeding truck rams auto; 5 killed All the deceased are from Bangura village including

Kamakhyanagar, August 28: At least five persons including a minor were killed after a coal laden truck rammed an auto-rickshaw on the front at Patharkhamba Square on National Highway-53 under Kamakhyanagar police limits in Dhenkanal, Sunday morning, police said.

The deceased were identified as Adikanda Samal, 52, his younger brother Akrura Samal, 40, alias Dhelu, Akrura's son Dibyaranjan,



auto-rickshaw driver Anant Samal, 24, alias Bunty. All the deceased were from Bangura village including a man, his son and his elder brother from the same family.

All of them died on the spot, the officer said. The driver and helper of the truck are absconding, and efforts are underway to track them, he said. A pall of gloom and mourning

descended in the whole village after report of the deaths spread. Wailing of the bereaved family members rocked the whole village. Chief Minister Naveen Patnaik, Union Minister Dharmendra Pradhan and state Mines Minister Prafulla Kumar Mallick expressed their deepest condolence over the deaths.

The state government has an-

nounced immediate financial assistance of ₹1 lakh each for the next of kin of the deceased from the Chief Minister's relief fund and ₹25,000 each for the bereaved family as ex-gratia from the District Red-Cross fund, Dhenkanal Collector Saroj Kumar Sethi said.

According to eye-witnesses, the occupants of the auto-rickshaw were on their way to crush Mahua seeds at an oil producing unit at\_ Muktapasi in Parjang block when a Cuttack bound speeding coal laden truck coming from Talcher hit them on front.

The impact was so intense that the auto-rickshaw was hurled almost 30 metre away to the roadside. All of them died on the spot while the driver and helper of the truck fled the scene leaving behind the vehicle.

## Lightning strikes claim 5 lives

Baripada/Jharsuguda, August 28: Five persons were killed and two were injured in separate incidents of lightning strike in Mayurbhanj

and Jharsuguda districts, Sunday. The deceased were identified as Rani Munda, 25, wife of Gopi Munda, her niece Pana Munda of Bagdega Nimdihi village under Bahalda police limits and Shyam Charan Purty, 26, of Barudihi village under Tiring police limits in Mayurbhanj district. The other two deceased are Kasturi Rohidas, 50, and her son Dolamani Rohidas, 27, of Darlipali village in Jharsuguda district.

The first incident occurred when Rani, accompanied by her daughter and niece of Bagdega Nimdihi village under Bahalda police limits in Mayurbhanj had gone outside to attend nature's call. They took shelter under a tree due to heavy rain while they were returning home. However, lightning struck

them killing Rani and her niece at the spot and leaving her daughter injured. A farmer Shyam Charan was killed in lightning when he was ploughing his farmland at Barudihi village under Tiring police limits in Mayurbhanj.

Lightning struck Kasturi and Dolamani when the mother-son duo was in Basupali to attend the 13th day ritual of a deceased relative. Another person, identified as Mahendra Rohidas, sustained grievous injuries in the incident.

When India chased, former skip per Virat Kohli scored 35 off 34 balls. Naseem Shah was Pakistan's


best bowler with figures of 2/27. Earlier, Bhuvneshwar Kumar

## State's new record in crimes against women

Bhubaneswar, August 28: Odisha has set an unwanted record in crimes against women

As per National Crime Records Bureau (NCRB) 2021 figures, Odisha Police registered 31,352 cases of crimes against women in 2021 against 25,489 in 2020 and 23,183 such cases in 2019.

At 137.8 crimes per one lakh pop ulation, the crime rate against women comes second only to Assam at national level where the figure stood at 168.3

Odisha has also topped the states in cases of 'assault or use of criminal force on women with intent to outrage their modesty', as per the recently released NCRB report.

The report further states, altogether 14,853 cases of 'assault or use of criminal force on women with intent to outrage their modesty were recorded in the state last year. At 65.3 crime rate, Odisha has earned the infamy of having wit nessed the most number of such cases. Assam came second with 26.1 crime rate in 2021.

states registering most cybercrime and IT-related cases where women were the victims. The state police registered as many as 565 cybercrime cases in which women were the victims. The cases include publishing sexually explicit material, creating fake profiles with morphed images and blackmailing of women in 2021.

In order to conceal its alleged failure in maintaining the law and order situation, the Odisha Police often claims that women victims approaching the police show their growing confidence on the policing. However, with the latest NCRB data, the claims fall flat.

The state police have closed 3,263 out of the 6,248 cases wherein police submitted final reports accepting that the incidents were true but it could not gather enough evidence or trace the accused.

Similarly, the conviction rate in women related cases also slipped further to 8.3 per cent against 9.2 in 2020. Out of the 2,313 cases in which trials were completed, only 193 ended in conviction, while in 2,120 cases, the accused were acquitted due to poor probe.

## **'Ahimsa Raths' reach** Subarnapur, Bargarh

Bhubaneswar, August 28: The 'Ahimsa Raths', which were flagged off by Chief Minister Naveen Patnaik on the Independence Day to spread the message of non-violence, reached Subarnapur and Bargarh Sunday.

The chariots were welcomed by the district administrations. In Subarnapur, the chariots toured places like Dunguripali, Ulunda and Sindurpur where school students welcomed them.

he volume of ransomware threats detected spiked to more than 1.2 million per month between the January-June period, a report has revealed. In the past 12 months, cyber-se-

curity researchers at Barracuda Networks identified and analysed 106 highly publicised ransomware

They found the dominant targets are still five key industries: education, municipalities, healthcare, infrastructure and finance

Researchers also saw a spike in the number of service providers that have been hit with a ransomware attack

"Ransomware attackers remain defiant and continue to operate their business with extended extortion attempts. As ransomware and other cyberthreats continue to evolve, the need for adequate security solutions has never been greater," said Parag Khurana, Country Manager, Barracuda

Bhubaneswar, August 28: The state's Covid-19 tally rose to 13,26,929 Sunday as 257 more people, including 43 children, tested positive for the virus, a health department bulletin said.

The death toll, too, mounted to 9,172 after a 65-year-old woman succumbed to coronavirus in Sundargarh district it said

The state had recorded 289 new infections and one fatality Saturday. Odisha now has 1,980 active cases, while 13,15,724 patients have

recovered from the disease so far. The daily positivity rate stood at 1.79 per cent, with 14,389 samples being tested since Saturday, the bulletin added.

With 9,436 new Covid-19 cases being reported in a day, India's tally of infections rose to 4,44,08,132, while the count of active cases has declined to 86,591, according to Union Health Ministry data updated Sunday.

The death toll due to the disease has climbed to 5,27,754 with 30 new fatalities being recorded. In addition, 27 deaths have been reconciled by Kerala and 100 deaths by Goa, the data updated at 8 am showed. The count of active cases now comprises 0.19 per cent of the total infections, while the national Covid-19 recovery rate was recorded at 98.62 per cent, the min-

A decline of 720 cases has been recorded in the active Covid-19 caseload in a span of 24 hours, the data showed

The daily positivity rate was recorded at 2.93 per cent and the weekly positivity rate at 2.70 per cent, according to the ministry.

The number of people who have recuperated from the disease has surged to 4,37,93,787, while the case fatality rate stood at 1.19 per cent, as per the data.

According to the ministry, 211.66 crore doses of Covid vaccines have been administered in the country so far under the nationwide vaccination drive.

India's Covid-19 infection tally had crossed the 20-lakh mark August 7, 2020, 30 lakh August 23, 40 lakh September 5, 50 lakh September 16, 60 lakh September 28, 70 lakh October 11, 80 lakh October 29, 90 lakh November 20 and the one-crore mark December 19, 2020.

The country crossed the grim milestones of two crore cases May 4, 2021, three crore June 23, 2021 and four crore January 25 this year.

Thirty fresh fatalities due to the disease were reported in the country - six from Maharashtra, five from Delhi, four from Chhattisgarh, three from West Bengal, two each from Gujarat, Himachal Pradesh and Karnataka, and one each from Goa, Kerala, Odisha, Punjab, Rajasthan

After thorough field verification, the relief or livelihood assistance is being provided to the beneficiaries through DBT, the official said. If the total loss of public and private property is estimated, the total loss to the state will be much more than the amount spent towards relief measures, he asserted. With the aim to face the natural calamities, the state government has initiated steps to build disaster resilient infrastructure in the vulnerable areas. Chief Minister Naveen Patnaik has also been demanding special category status for Odisha for a long time. During the last Governing Council meeting of Niti Aayog held earlier this month, Patnaik had said that Odisha is impacted almost every year by natural disasters. ## Heatwave linked to declining wheat production in India

ndia's wheat production is projected to have declined nearly three per cent to 106.84 million tonnes in the 2021-22 crop year. The decline is likely to have been caused by a heatwave that resulted in shrivelled grains in the northern states of Punjab and Haryana.

There were reports that India was planning to import wheat in view of the shortage but the government denied it.

This year, India recorded its warmest March in 122 years with a severe heatwave scorching large swathes of the country in the month. The average temperatures observed pan-India in April was 35.05 degrees Celsius, which was the fourth-highest for the month

Agriculture experts, however, underscored the need to raise the issue of climate change impacting India's food security at the COP27 which is scheduled for November: They noted that COP27 can be a critical turning point to connect food security and nutrition with climate change

Shweta Saini, a senior consultant at the Indian Council for Research on International Economic Relations (ICRIER), said food security and green energies have to be balanced at these international negotiations

"For countries like India where the malnutrition rate is very high and it is an agriculture-centric country, we feel the commitment for food security and green energies has to be balanced. So, while India is talking about biofuel, the question we should be looking at is whether food can be used for fuel," she said.

The National Policy on Biofuels. 2018 allows production of ethanol from damaged food grains like wheat and broken rice.

Devinder Sharma, a food policy and agricultural trade expert, said at COP27, countries like India need to stop their "obsession" with

"Till the economy is not structured in a way to radically challenge the climate crisis, nothing will change, and that is something that



overall goal of the UNFCCC.

Agriculture experts have flagged the recent rise in mysterious diseases causing dwarfing of crops, saying this too may be the result of climate change

"There is dwarfing (of crops) happening in Punjab and Haryana, and that is mysterious because no one knows why it is happening. We have to see how closely it is

connected to climate change," Saini said.

Sharma added that climate change might be behind the mysterious disease causing dwarfing.

Saini and Sharma also pointed out that there were other Rabi crops which were affected by climate change.

"The heatwave that we were expecting five-six years down the line has already happened. It affected the wheat crop and we also know it led to loss of other crops and most Rabi crops that were harvested then such as barley. Vegetables were affected too and even paddy was affected because

of monsoon," Sharma said. Saini said heat doesn't always impact the crops, but because of the heat, there are pest attacks at times, and that is another symptom of climate change.

"We still have to figure out if climate change has a role in it," she added. Sharma said not just India but every country must focus on food self-reliance.

"There is no escape if we don't have adequate stocks. We will be standing with a begging bowl and it will lead to food riots. Climate change has become a major factor in the geopolitical situation of our country, and we need to acknowl-

edge that," he added. The first impact of climate change via heatwaves was felt on food security and that needs to be dealt with, Saini said.

Betanoti/Patana, August 28: To ensure safety of elephants in Similipal forest under Betanoti forest range of Mayurbhani district. scores of 'Gaja Sathis' will keep track of the animals. Such a step is significant as every year a large number of pachyderms die due to electrocution and poaching. Also a large number of people die in elephant attacks every year in the state.

Sources said that at present there are nine elephants wandering in Durgapur forest under this range while two are roaming around about in KCPur and Badam forest

Meanwhile, reports from Patana of Keonjhar district said elephants are on a damaging spree in Partana range during the last few weeks.

A herd of elephants also strayed from Karanjia range of Mayurbhanj district and entered Saharapada range Saturday night. The animals damaged four houses at Chatarpana, Baikala and Khuntapada villages. They also consumed large quantities of rice

which had been stored and damaged paddy on acres of land. The herd was split into two

groups and they strayed into the Jagannathpur and Gojitangiri forests, said ranger Ghasinath Patra. People in the area have been spending sleepless nights due to elehant menace, he added

For the last few days, the animals have been unleashing a reign of terror in several other villages such as Jamunalia, Talasarua, Haladibata, Nuagan and Dubeipentha.

They damaged crops and houses in Patana a few days ago as Forest department personnel failed to contain the marauding elephants, locals alleged

## School sans building running on temple premises for 7 years

Salipur, August 28: The Odisha government is spending lakhs of rupees to improve infrastructure of schools and has taken a host of measures to ensure quality education. However, the condition of the Dasasahi Project Primary School under Salipur education circle in Cuttack stands in contrast with the government's efforts. The school is being run on the premises of Murkundi Baneswar Shiv temple for the last seven years. Local people, guardians and even teachers have expressed their unhappiness over the state of affairs.

Sources said that over 40 students are studying in the school from Classes I to X. They pointed out that since the school does not have land of its own a building has not been constructed. So students attend classes inside the temple. Many in the district are wondering as to how a school is allowed to function without physical in-



frastructure for so many years.

The part of the temple where students attend classes has no doors and windows. They are crammed into a small space and feel suffocated, sources pointed out. "Most of the time monkeys, dogs and cattle have free access to the temple premises. Only two teachers have been appointed to conduct classes. On days of festivals and rituals, classes remain suspended. The mid-day meal for the students is also prepared inside the temple premises, they added.

Though people of nearby villages have taken up the issue of a

proper building with officials of the School and Mass Education department, so far no steps have been initiated for allotment of government land.

Headmaster Nrushingha Charan Das said the school has no land of its own. "We do not have the physical infrastructure to run a school. The district administration and the district Education department have been intimated about the need for a building, but no concrete steps have been taken," he lamented.

When contacted, Block Education Officer Jagabandhu Satpathy also confirmed that the school has no land of its own. After land provision, steps will be taken to construct a building.

While Esmeralda, a Mexican American, is herself an immigrant, her abuse towards Indians also indicates an isolation of the Indian origin people which may not be limited to North America alone. Reporting of the incident in the Indian media has been skewed and those few reports saw the light of day primarily, maybe, because the involved person herself was an immigrant. The real reasons behind the dislike towards Indians are not to be found in any report. The easy way out has been to blame local politics and changing voter demographics in the US. However, envy for a financially successful and educated group of people with one ethnic root has been touted to be the major reason for the attack. On the other hand, delving into not so old history of the Indian community not only limited to the US but also in other English speaking countries such as the UK, Australia and South Africa as well as in nations such as Thailand and Singapore clearly indicates distrust and dislike for the community, resulting in violence. The beating up and murder of Indian students in Australia, the attacks on Indian shopkeepers in many areas in the UK, the emergence of gangs such as Dot Busters in Canada and the US with a prime objective of assaulting Indians and attacks on them in Thailand are examples of hatred for Indians. Further down memory lane, one may recollect the bitter mass deportation of mostly Gujarati Indians from Idi Amin's Uganda as also the chasing out of Indians from South Africa after the end of apartheid in that country. Everyone is aware that Indians were chased out of South Africa primarily because they had, as a community, supported the White rulers against the Black freedom fighters. In Uganda

and former Rhodesia, the rich Indian community had meticulously kept itself away from the local populace, thereby becoming friendless and isolated. In current times, a similar scenario may well be playing out in many countries. Unless properly researched, it may be difficult to make sweeping statements. But some indications could possibly be taken from recent events. For instance, many Indian Hindoos believe that the Indian



Moslem rejoices and distributes sweets when the Pakistan cricket team scores a victory. It could very well be possible that when Indians living in the US and other English speaking countries celebrate festivals like Deepavali or Independence Day by marching en masse on Main Street with the Indian flag flying, then their very core allegiance to the land that has offered them immense prosperity and success comes under a question mark. Recorded American history tells us that the very old Japanese community in the US was incarcerated immediately after the Pearl Harbour attack. Consequently, many young Japanese Americans had to volunteer and join the US forces in the war in the Pacific to prove their loyalties. It is a known fact that Indians living in many different countries have mostly been disdainful towards the locals. For instance, most Indians in the US and Canada are mortally scared of the African American. This fear keeps them from socializing with the Blacks or the Hispanics. On the other hand, the Caucasian American does not socialize much with the Indians. Whatever interactions exist are limited to professional sphere. It is to be noted that the Indians in the US are in direct competition for medium and high paying white collar jobs that the Whites desire unlike the employment opportunities in the menial jobs sphere that the Hispanics and Blacks normally take up. Another reason for isolation of Indians could be their recent upsurge in political activism connected with their motherland. Politics separates people like nothing else and when politics is added with religion then the divide is even sharper. The recent political activism of people of Indian origin in the US trying to prove their Hindoo background could certainly be a trigger for many more unpleasant

Lest it be forgotten, the Indians living abroad who are forced to bear the brunt of attacks and abuses are those who benefitted the most from the Indian taxpayer. Studying in an IIT, medical college or other such institute of higher learning in India that had been painstakingly built since Independence with the poor taxpayers' money, these fellows thought fit to desert their motherland when it needed them the most. They ran away for personal aggrandizement and thought would never have to look back. Even the second and third and later generations of Indian origin offspring turned to their religious 'roots' when isolation struck them hard. The emergence of a political party with religious overtones could have emboldened the Indian living overseas. This could have resulted in hardening of their attitudes towards religious beliefs of the locals. Instead of melting and mixing, the Indian seems to have become a sore thumb in the eyes of people like Esmeralda. The community has to do some very hard thinking about its future.

To bedizen is to dress up in a gaudy way: But every time one of the trapezoidal doors on Douglas Stein's set blows open, it is to let in a bewigged and bedizened buffoon very nearly her match (New York Times, 4 Jun. 2010). Despite this example, if we were true to the history of European culture, we might argue that it is only women who can be bedizened. It would be fruitless to do so, of course, because its users apply the word as often to men as to women, as well as to houses, cars. Christmas trees, theatrical sets and anything else that can be accused of being decked out with finery to vulgar excess. The female connections exist because the word is linked to distaff, which people now use most often for matters relating to females. That's because spinning thread with the yard-long wooden rod called a distaff was traditionally women's work. The staff part of the word presents no difficulties, but few of us now know that the dis beginning derives from an ancient Low German source that meant a bunch of flax. (The implication that the distaff was first used for spinning linen thread, not wool, is confirmed by the archaeological evidence.) Nearly 500 years ago, the verb dizen appeared, presumably from the same source as dis (though nobody knows how), which meant to dress a distaff for spinning. A century or so later it started to refer to decking a person or a thing with finery. Within decades, be- had been added to it to make the verb stronger. Ever since, bedizened has implied that the bedecking has gone to excess.

he high inflationary trend that has gripped India is stated to be a global phenomenon of corporate adventure to maximise profits through controlling the political system even in times of economic distress. The Western inflation trends have severely impacted the Indian economy, forcing the government to squeeze expenditure, the Reserve Bank of India increasing interest rates, plummeting rupee and the society compromising on lifestyle.

Indian inflation has risen to 6.82% in July from 6.43% in June and 3.92% a year back. As per the wholesale index, it is at 13.93%. Primary articles cost 15.04% more, food 9.41%, manufactured products 8.16% and fuel and power 43.75%. International Monetary Fund puts India's growth at 7.4%, faster than the rest of the world, though some others show lower figures.

In the US, inflation remains at 8.7%, a bit lower than the highest reached in 40 years at 9.1%. Inflation in Britain is at the highest level since 1982. At the August weekend, the UK hiked electricity and gas bills by 80%, in a dramatic worsening of the cost of living crisis. Overall consumer inflation is at 10.1%. The economy may head for a negative growth next year, the Citibank predicts, and prices are likely to rise by 18%.

In contrast, RBI Governor

Shaktikanta Das says that the central bank is moving towards the 4% inflation target in a steady manner, without much growth sacrifice. After hitting its peak in April 2022, Das expects retail inflation to ease to 4% by 2023-24. Assuming crude oil prices at \$105 per barrel, the RBI Governor stated that the current account deficit (CAD) will be manageable and its financing to be done in a reasonably comfortable manner in 2022-23. Real GDP growth projection as per the August MPC is fixed at 5.4% though overall growth rate forecast remains unchanged at 7.2%. It looks

brighter but the way companies are raising prices and maintaining a profit trend it may hurt the people world over and the Indian government in particular which is rushing through many infrastructure projects.

In 2021, US companies logged their most profitable year since the 1950s, as many took advantage of economies of scale and other more efficient production processes. Yet, firms increasingly held on to the savings they gained from these reduced costs, rather than passing them on to customers in the form of lower prices, according to Alexander J Mackay. He says that between 2006 and 2019 the difference between prices charged and the marginal cost incurred by a company climbed about 25 per cent. The new US commerce department data show corporate earnings jumped 35% in 2021, while workers got an 11% bump.

In 2017, Senator Sheldon Whitehouse noted that America faces a crisis of corporate capture of democratic government, where the economic power of corporations has been translated into political power with disastrous effects on people's lives. He warned

that "corporations of vast wealth and remorseless staying power have moved into our politics to seize for themselves advantages that can be seized only by control over government" through what he calls, the "immense pressure deployed by the corporate sector on our government." Corporate interests can vastly outspend labour or public interest groups on the US elections, Whitehouse said.

In 2014, business interests spent \$1.1 billion on state candidates and committees compared to the \$215 million that labour groups spent. That same year, business political action committees (PACs). spent nearly \$380 million in federal elections, while labour union PACs gave close to \$60 million. In 2016, it is estimated that \$1 out of every \$8 went to super PACs. They, from corporate sources, raised \$1.8 billion for the 2016 elections. Whitehouse found that \$800 million of political spending were from obscure donors.

Mackay apprehends that large political contributions will prevent Congress from tackling the important issues facing Americans today, like the economic crisis, rising energy costs, reforming

health care, and global warming. In UK corporate lobbying is part of politics and this helps change decisions in their favour. The corporate power has turned Britain into a less honest state, a Guardian

A World Bank publication "Seize the State, Seize the Day": State Capture, Corruption, and Influence in Transition, says some firms in transition economies have been able to shape the rules of the game to their own advantage at considerable social cost, creating what it calls a "capture economy" where public officials and politicians privately sell "a range of rent generating advantages a la carte to individual firms." "The State capture, influence and administrative corruption are all shown to have distinct causes and consequences," the study says.

A 1981 report in Economic and Political Weekly says that dependence of the private economy in India has come to mean its dependence on the political parties. For the last over two decades, corporations are supposed to have played roles in decision making. The top 20 companies continue to have 70 per cent profits, as per Marcellus Investment Managers, and higher product prices in a supposedly subdued market.

India has brought transparency into donations through electoral bonds in 2016, late Union minister Arun Jaitley mentioned in his 2017 Budget speech. Election Commission told the Supreme Court in March 2019 in an affidavit that the electoral bonds wreck transparency in political funding and with removal of cap on foreign funding, they invite corporate powers to impact Indian politics.

Corporates are becoming cleverer and know their ways. To counter big money, rebalancing of democracy and empowering people to engage politically as a countervailing force across the globe are necessary. It sounds good, but not easy, so prices and profits may not be put in check for the consumers.

In recent years, and especially during the COVID-19 pandemic, attacks on science and scientists have been escalating to an alarming degree. Health officials and the broader scientific community have pleaded with policymakers and the public to "follow the science." Yet such slogans fall flat with those who have little regard for scientific authority, not least because science proponents have been using the same blanket term as those who attack it.

as those who attack it.

When we encapsulate all of science within a single word, we implicitly equate it with truth. In fact, many fields of science are still undergoing constant revision. The importance of this distinction became all too clear during the early stages of the pandemic, when health authorities were charged with providing guidance to the public before all the details about the virus were known.

Science has always come under attack. From Galileo's demonstration that the Earth is not at the center of the universe to Darwin's argument that human beings descended from earlier apes, scientists were long seen as a threat to religious authority and its own claims of true knowledge. One might have thought that modernity would have finally given science a decisive advantage, leading inexorably to more general acceptance of its findings. But a constantly evolving process is not a sure-footed competitor to those

trafficking in timeless absolutes. And though it may feel counterintuitive, scientists themselves should resist the popular characterisation of science as a body of knowledge.

In his 2019 book, The Crisis of

Expertise, sociologist Gil Eyal argues that the appeal to "science" and the moral panic about the "assault on science" are beside the point, because not all of "science" is in fact under assault. No one, for example, "disputes quantum mechanics, nor, for that matter, is any solid-state physics discipline under assault." Indeed, most of science is widely seen as "settled," whether formally in terms of fundamental theories and understandings, or informally in the sense that most people assume that planes can fly, gravity is real, and hydrogen peroxide can bleach your hair. And yet, while most people trust medical professionals with everything from their annual checkups to their cancer therapies, they also subscribe to a wide range of idiosyncratic notions about health, pharmaceuticals, and medical procedures. What the science journalist Michael Specter calls "denialism" is reflected in a broad array of biomedical issues, from fear of vaccines to belief in the effectiveness of nutritional supplements and, sometimes, miracle cures.

Eyal points out that most debates around science concern "what is called 'regulatory science' and 'policy science,' a collection of sub-disciplines, research programmes, and techniques that have in common the need to arrive at a policy recommendation." These debates tend to reach a fever pitch when there are contentious public-policy issues that are inextricably bound up with ongoing science – as in the case of vaccine mandates, masks, drug approvals, and decarbonisation (which entails massive allocations – or reallocations – of resources).

In all these cases, the peril arises after the experts have made their views known. When the process moves into realms beyond the purely scientific – legal disputes, public policy, even electoral politics – trouble frequently ensues. If expertise is seen to be associated with one side in legal proceedings, political debates, and cultural questions (such as diet and lifestyle), that perception tends to undermine rather than buttress the authority of science and scientists more generally.

The dilemma is that the scientific fields most relevant to policy debates are in a constant state of testing, revision, and debate by scientists themselves. But that is exactly how it should be. As the philosopher John Dewey argued in the early twentieth century, science proceeds not as a single truth or set of truths, but as a method; it is not a body of knowledge, but a process for developing more reliable knowledge. This focus on method is meant to ensure that scientific research and discovery proceeds in a rigorous and

transparent fashion. The distilled version of the scientific method taught in grade school hardly captures the wide range of ways that scientists practice their disciplines and test their hypotheses. As important as it is to ensure that science advances methodically, we must also not lose sight of the possibilities opened up by thinking outside the box. Historically, we owe some of the most important scientific discoveries to the imaginative brilliance of visionaries such as Galileo, Darwin, Albert Einstein, James Watson and Francis Crick, and Jennifer Doudna.

Just as good science requires a balance between creativity and method, so, too, building trust in science requires scientists and their public advocates to communicate their findings and processes more effectively. That includes being open about the uncertainties - and serendipities -that are inherent to scientific discovery and drawing clear distinctions between what is and is not considered settled science. We must accept, and impress upon the public, that science owes its greatest achievements not only to its perpetual expansion into new frontiers, but also to its abiding humility. Otherwise, the public will continue to be disappointed - and disillusioned - by many types of scientific claims.

He further said that as far as giving a choice of power supply to the consumer is concerned, this is a complete hoax. In fact, this bill will give a choice not to consumers but to the private electricity supplying companies. If this bill is passed then it will open the flood gates of privatisation.

who take on the role of motherhood in ways that may not find a place in the popular imagination," said Justice Chandrachud who penned down the verdict on behalf of the bench.

The bench said that unless a purposive interpretation were to be adopted in the present case, the object and intent of the grant of maternity leave would simply be defeated. "The grant of maternity leave under Rules of 1972 is intended to facilitate the continuance of women in the workplace. It is a harsh reality that for such provisions, many women would be compelled by social circumstances to give up work on the birth of a child, if they are not granted leave and other facilitative measures" it said.

She felt uneasy on Monday night and the next morning, she was taken to the St. Anthony hospital in Anjuna where she was declared brought dead. Police are further investigating the case.

## Doctors warn against several health hazards

Massive dust pollution can lead to itching in the eyes, nose and skin; coughing, sneezing, breathing difficulty, lung infection, nasal congestion, asthmatic attacks and aggravate heart problems, doctors say

New Delhi, August 28: As the nearly 100-metre-tall Supertech twin towers were razed to the ground on Sunday, doctors said people living nearby, especially those suffering from respiratory diseases, should take extra care and avoid the area for a few days if possible.

The demolition of the structures generated an estimated 80,000 tonnes of debris and sent huge clouds of dust billowing in the air. The doctors said most dust particles have a diameter of 5 microns or less and can remain suspended in the air for a few days in the absence of favourable meteorological conditions like strong winds and rain.

Massive dust pollution can lead to itching in the eyes, nose and skin; coughing, sneezing, breathing difficulty, lung infection, nasal congestion, asthmatic attacks and aggravate heart problems, they said.

Dr Jugal Kishore, head of Community Medicine Department at Safdarjung Hospital, said, "The dust particles will remain suspended in the air for quite some time in case of low wind speed. People suffering from respiratory problems -- chronic obstructive pulmonary disease, asthma and bronchitis -should avoid the area, if possible."

"They should limit exposure to the affected area for at least 48 hours. Others living in and around the area should avoid exercise for a few days," he said. Dr Kishore said people having respiratory diseases should keep taking medicine

regularly and consult doctors if their problems aggravate.

Dr Yudhyavir Singh, assistant professor, Critical Care, AIIMS, said, "Particulate matter of size smaller than 2.5 microns will be a problem. This is likely to increase episodes of coughing, sneezing, asthmatic attacks, lung infection, nasal congestion and breathing difficulty.

"Viruses may also piggyback on the fine particles and increase infection rate as it's the flu season. "People should take precautions and keep a buffer stock of medicines. Use N-95 masks and eyeglasses till pollutants dissipate. Wear full-sleeved clothes and avoid morning walks for a few days. Consult doctors if problems worsen," he said. Dr Dipankar Saha, former chief of the Central Pollution Control Board's air lab, said Noida authorities should keep an eye on the air pollution level till the debris is cleared with the help of low-cost sensors.

"Modelling should be done to ascertain the zone of influence. The people living in and around the area should monitor air quality and step out only in unavoidable circumstances. Avoid exposure for a few days. Water sprinkling on regular intervals will help immensely," he said. The air pollution problem will persist till the debris is cleared and it is certainly going to affect the health of people. A study may be done to ascertain the health impact of this demolition, Dr Saha said.

### The downhill road for Babus

The Centre has promoted 31 officers to the ranks of additional and joint secretary. Of these 31, only 12 are IAS officers, while the remaining 19 are non-IAS officers. It reflected the Modi government's attempt to break "babu dominance" and address the crunch of IAS officers available for deputation. In the past seven years, the IAS cadre at the level of joint and additional secretaries has systematically shrunk. A civil list prepared by the DoPT stated that the number of IAS officers posted as joint secretaries at the Centre was around 77. In 2015, this number stood at 249 IAS officers (from a total of 391 joint

secretaries), according to a 7th Central Pay Commission report published in November that year. The number of IAS officers posted as additional secretaries also fell to 76 this year from 98 in 2015. The Centre has 108 posts for additional secretaries, as stated in the Central Pay Commission report. The positions for additional secretaries has gone down to around 34, while the rest are in-situ upgradation. Of the total 84 secretaries in the central government, 57 are IAS officers now. According to the August 13 appointment order for joint secretaries, only two of 15 officers - promoted as joint secretaries are from the IAS cadre, while the rest are non-IAS officers from the Central Civil Services (Group A). Another order dated August 8 for the appointment of 16 additional secretaries has ten IAS officers and the rest are from other central services. The IAS, the IPS and the IFoS are the only three All India Services. The Central Civil Services officers of which the government is bringing to the fore - comprise services such as the Indian Revenue Service (IRS), the Indian Postal Service (IPoS), Indian Audit and Accounts Service, Indian Defence Accounts Service, Indian

Railway Service, Indian Railway Traffic Service (IRTS), etc.

### **Is Pawan Bansal** dark horse

t is now clear that no member of the Gandhi family will hold any party post after the elections are held. There is speculation that Congress leader Ambika Soni may be chosen to lead the party. Incidentally Soni unfurled the national flag at the AICC headquarters August 15 in place of party president Sonia Gandhi. This was seen as a clear signal that Soni's position in the party's pecking order has improved. She had earlier lost out to Ahmed Patel, Sonia Gandhi's all-powerful late political secretary but has bounced back after Patel's death. ## **Lack of quality textbooks** to hit 'MBBS in Hindi' move

Bhopal, August 28: Though the Madhya Pradesh government has taken a path-breaking decision to start MBBS course in Hindi from the 2022-2023 academic session, experts in the medical field have expressed reservations over the move because of unavailability of quality books in the language on the sub-

Chief Minister Shivraj Singh Chouhan recently announced that from the new academic session, the Bachelor of Medicine and Bachelor of Surgery (MBBS) course will be taught in Hindi at the Bhopalbased Gandhi Medical College (GMC) to first year students. Currently, medical education is imparted only in English.

Besides, Chouhan also announced that BTech degree and polytechnic diploma courses, in six colleges each, will be taught in the Hindi language as part of the National Education Policy (NEP) from July 2022.

State medical education minister Vishvas Sarang, the driving force behind the move, said Madhya Pradesh is the first state in the country to come out with the initiative to teach MBBS in Hindi.

'We are starting MBBS course in Hindi for the first time in the country. No other state is offering medical education in the mothertongue...Madhya Pradesh is the first to do so," he told PTI.

Sarang said textbooks, especially in physiology, anatomy and biochemistry, are being prepared in Hindi for students and they will be

made available soon. However, experts in the medical

fraternity remain sceptical about the "MBBS in Hindi" move. Former vice-chancellor of Indore-based Devi Ahilyabai Vishwa Vidvalava (DAVV) and a senior paediatrician, Dr Bharat Chhaperwal, said, "I am not against imparting medical education in Hindi, but are quality textbooks with updated advancements in the field available

Research articles published in quality medical journals like 'Lancet', 'British Medical Journal' and 'New England Medical Journal. among others, take three to four years at least to find a place in textbooks, he said.

Chhaperwal said he is not against Hindi, but as a medical professional he feels not enough prepanouncing the decision.

"Governments should leave this issue to professionals instead of deciding in which language medicine and surgery should be taught,"

A senior Bhopal-based doctor, Pushpendra Sharma, who has done his MBBS and a course equivalent to MS Surgery from the Odessa State Medical University in Ukraine, said a lot of efforts will be required to make the move successful.

"It is not such a simple task to start teaching MBBS in Hindi. The move requires a lot of preparations as medical terminologies need to be translated in Hindi first. It is a tough call," he remarked.

Asked how some other countries are managing to impart med ical education in their native language, Sharma said they had been doing so for ages and therefore have developed a rich course content for students.

Guwahati, August 28: Political patronage of forces that fuel casteism. and growing intolerance and hatred towards other castes and religions are barriers to effectively form an egalitarian society, according to social observers of Assam.

Education in the real sense of the term and not degrees, and steadfast efforts to eliminate socio-cultural inequalities are required to create an environment of support and positive societal narrative, they

Instances of families being pushed to the periphery of the society over caste issues abound in different parts of Assam, though it took the incident of a person being deprived of proper last rites due to his inter-caste marriage to bring the matter up for discussion among people.

Earlier this month, the buried body of a 65-year-old villager was exhumed and cremated as per Hindu rituals by the Darrang district authorities days after his death, as locals refused to help his family with cremation due to social ostracisation owing to his intercaste marriage 27 years ago.

The body of Umesh Sarma had to be buried initially as it was only his brother who came forward to help the widow with the last rites. The deceased had married a woman belonging to a 'lower caste'.

Sarma's wife, Pranita Devi, claimed that the family has been ostracised ever since her marriage and though they were 'allowed' to mingle with their neighbours on normal days, they are treated as 'near untouchables' at social func-

Dr Pallavi Deka, who teaches Political Science at Handique Girls' College, Guwahati, asserted that the Darrang incident is not an isolated one. "The worry is that we often boast of not being so casteist here in this part of India. But that is a farce," she said.

Casteism is as real in the state as religious fanaticism is in the country, with both phenomena growing and intolerance being heightened. Deka claimed.

She sounded sceptical about any early solution as "intolerance and hatred have become political propaganda"

Sushanta Talukdar, the editor of online magazine nezine.Com, also said, "Prevalence of an egalitarian society in Assam is a myth."

He, however, hastened to add that examples of inter-caste and inter-religious marriage being accepted in many households are also there.

While time heals the scars in most of these cases, a coordinated attempt to keep people divided along caste lines has also been at work, Talukdar claimed.

He said, "Political patronage to such regressive forces has exposed the fault lines, which, if not checked, will bring the efforts by progressive people to build an inclusive society that will also be egalitarian to a complete halt."

According to Jayanta Kumar Sarma, professor and director of Bhupen Hazarika School of Mass Communication, KK Handiqui State Open University, casteism is akin to class struggle.

"Casteism and class struggle are real. But painting all members of a community with the same brush will be wrong," he

Dr Pronami Bhattacharyya, an assistant professor at Royal Global University here, pointed out that caste issues cannot be perceived on a daily basis but come to the fore in the Assamese society during

marriages.

"However, unlike other regions of the country, marriages in Assam do see a combination of rigidity and flexibility. Families initially object to an inter-caste marriage but many of them later accept it," she

The marriage of Hemen Sarma is a case in point. Hemen Sarma, who tied the knot with a woman of a 'lower caste' about eight years ago, said, "We were not ostracised but my family initially barred us from visiting them. It is only about a year ago that we have been allowed to stay with my family."

"My family is based in Guwahati city. We had been raised in a secular atmosphere, but when it came to accepting my wife, things got changed. I couldn't understand what went wrong," Hemen said.

His in-laws had welcomed the couple at their home since their wedding, just as deceased Umesh Sarma's in-laws had continued to maintain relations with their daughter and her new family.

"The so-called lower caste families accept inter-caste marriage as they see it as social upliftment,

While the Grade IV tests were held August 21 in two shifts, the Grade-III examinations are being held Sunday. The tests for more posts under Grade-III are scheduled for September 11.

All examinations are being con-



ducted by the Board of Secondary Education, Assam (SEBA).

dangerous ritual. It forms a part of a tradition that goes back to at least five centuries. On the occasion, the district administration declares public holiday and even liquor shops remain shut. Surprisingly, the stone-pelting is held in the presence of heavy police personnel who simply watch as they are not supposed to interfere in the so-called ritual.

According to reports, since 1955, over a dozen people have succumbed to injuries from stone pelting. While at least 100 people were reportedly injured in 2020, the count was 250 in the following year. Officials recall that in 1978 and 1987, the local police had to resort to firing after mobs from both sides attacked each other as well as the police personnel.

District officials said several attempts over the years to dissuade the villages to give up the dangerous ritual have failed. Even during the two Covid years, some residents managed to keep up the tradition despite all preventive

Every year, the local administration deploys teams of doctors and paramedics at the fair venue for timely treatment of those in-

As a part of the annual fair, the two sides stock up rocks and pelt each other with them, injuring dozens. ## African cheetahs offer hope to blackbuck-troubled farmers

With grasslands being their most favoured habitat, blackbucks permanently reside in farmlands and often damage crops in the initial phases of cultivation

Bhopal, August 28: Madhya Pradesh Forest Minister Kunwar Vijay Shah is on a study tour of South Africa along with some senior forest officials. Sources said that the minister's visit is connected to the much talked about translocation of cheetahs from South Africa to Kuno Palpur Sanctuary located in Madhya Pradesh's Shivpuri district.

Earlier, wildlife officials in Madhya Pradesh had assumed that the first batch of cheetahs will reach Bhopal by August 15. However, it could not happen

It is not just the wildlife lovers, but also farmers in the Gwalior-Chambal division who are eagerly awaiting the arrival of the cheetahs from Africa. The world's first intercontinental translocation of the

fastest moving animal -- from Namibia and South Africa to Madhya Pradesh's Kuno National Park -- whose final dates are far from being decided, will not only give a fillip to wildlife tourism, but also promises to bring smiles to the faces of farmers in three dis-

Farmers in the three districts of Gwalior-Chambal region, including Shivpuri, Ashok Nagar and Guna, may find in the cheetahs the solution to their long standing problem of the Indian antelope 'blackbuck' damaging their crops every season. As part of the efforts to build a wide and suitable prey base for the cheetahs before they arrive in the Kuno National Park, the state forest department is working on a project of translocating blackbucks from Shivpuri, Ashok Nagar and Guna districts to



the new home of the cheetahs.

'The rains have temporarily hit the progress of the blackbuck translocation project, but it will gain momentum once the monsoon eases. We hope to go ahead with the exercise on the ground by October, which will see the blackbucks being translocated through the Boma technique from Shivpuri, Ashok Nagar and Guna districts to Kuno National Park and other ideal jungles having suitable habitat for the Indian antelope," said CS Ninama, Chief Conservator of Forests in Madhay National Park.

Ninama said that the team of the Kuno National Park is already working on developing a prey base for the cheetahs, but with blackbucks considered the most ideal prey for the cheetahs, approval has been given to the project to translocate the blackbucks from

the three districts of Gwalior-Chambal region, where they are a

major problem for the farmers. With the grasslands being their most favoured habitat, the blackbucks permanently reside in the agricultural fields of farmers and often damage the crops in the initial phases of cultivation by crushing the nascent crop. The farmers of the three districts, despite the blackbucks being a major problem for their early crops, haven't harmed them, but have been rais-

ing the issue with the authorities Cheetahs became extinct in India in the 1950s. The plan for their reintroduction has been in the pipeline since decades. The central government had initially approached Iran, where the Asiatic cheetah, the same sub-species that went extinct in India, exists, and was even keen on cloning the species. But, on Iran's refusal to help India, owing to the low number of the species there, the central government turned to the African sub-

## JAPANESE ENCEPHALITIS **CLAIMS 85 LIVES IN ASSAM**



Guwahati, August 28: At least 85 people have died of Japanese Encephalitis (JE) in Assam in the last two months, a bulletin by the health department said.

Ten deaths were reported over the last nine days, including one Saturday. Since July this year, as many as 390 cases of the infection have been detected, the bulletin said.

JE is a viral brain infection that spreads through mosquito bites. The virus, found in pigs and birds, is passed to mosquitoes when they bite infected animals. Given the surge in JE cases over the past few months, a District Rapid Response Team was formed in July to deal with the situation. All Standard Operating Procedures and guidelines communicated by National Health Mission, Assam, are being followed in the districts for case detection, management and referral, official sources said.

Nine medical colleges and 10 district hospitals in the state, equipped with requisite facilities, have been designated as JE treatment centres, they added.

# US warships transit Taiwan Lee Jae-myung to lead SK Oppn Strait, first since Pelosi visit ASSOCIATED PRESS Seoul, August 28: Firebrand law-maker Lee Jae-myung was elected to lead South Korea's main oppo-

Washington, August 28: Two US Navy warships sailed through international waters in the Taiwan Strait Sunday, the first such operation since a visit to Taiwan by US House Speaker Nancy Pelosi enraged China which regards the island as its territory.

The US Navy, confirming a report, said cruisers Chancellorsville and Antietam were carrying out the ongoing operation. Such operations usually take eight to 12 hours to complete and are closely monitored by China's military.

In recent years US warships, and on occasion those from allied nations such as Britain and Canada, have routinely sailed through the strait, drawing the ire of China which claims Taiwan against the objections of its democratically elected government.

Pelosi's Taiwan trip in early August infuriated China which saw it as a US attempt to interfere in its internal affairs. China subsequently launched military drills near the island which have since continued

"These (US) ships transited through a corridor in the strait that is beyond the territorial sea of any coastal state," the US Navy said.

The operation demonstrates the United States' commitment to a free and open Indo-Pacific, and the US military flies, sails and operates anywhere international law allows, the navy said.

The Chinese military's Eastern Theater Command said it was following the ships and warning them.

Troops in the theater remain on high alert and are ready to thwart any provocation at any time," it added in a statement.

The administration of US President Joe Biden has sought to keep tension between Washington and Beijing from boiling over into conflict, reiterating that congressional trips are routine.

The United States has no formal diplomatic relations with Taiwan but is bound by law to provide the island with the means to defend itself.

China has never ruled out using force to bring Taiwan under its

Taiwan says the People's Republic of China has never ruled the island and so has no claim to it, and that only Taiwan's 23 million people can decide their future.

He stressed that his key mission is to bring the Democrats back to power. Yoon edged Lee by a historically narrow margin of 0.7 percentage points in the March election. Yoon's spokesperson, Kim Fun-hve, issued a statement Sunday congratulating Lee on his win at the convention and calling for bipartisan cooperation to address the country's problems.



## Cities near Ukrainian nuclear plant shelled

Kyiv, August 28: Russian artillery fired at Ukrainian towns across the river from the Zaporizhzhia nuclear power plant overnight, local officals said Sunday, adding to residents' anguish as reports of shelling around the plant fuelled fears of a radiation disaster.

Russia's defence ministry said there was more Ukrainian shelling of the plant over the past 24 hours, just a day after Moscow and Kyiv traded accusations of targeting Europe's biggest nuclear plant, which has prompted grave international concern.

Ukrainian nuclear company Energoatom said it had no new information about attacks on the plant. Captured by Russian troops in March, but still run by Ukrainian staff, the complex on the southern front line of the war has been one of the major hotspots in the sixmonth-old conflict.

Regional governor Oleksandr Starukh said on Telegram Sunday that Russian forces struck residential buildings in the region's main city of Zaporizhzhia, about a two-hour drive from the plant, and the town of Orikhiv further east.

On Saturday, Starukh told Ukrainian television residents were being taught how to use iodine in case of a radiation leak.

## Tripoli calm, Libya riven after worst fighting in years

Tripoli, August 28: Charred cars and buildings pockmarked by bullets scarred Libya's capital Sunday, the day after intense fighting killed 32 people yet appeared to leave the Tripoli government more firmly entrenched.

Battles raged across the city throughout Saturday as forces aligned with the parliament-backed administration of Fathi Bashagha failed to take control of the capital and oust the Tripoli-based government of Abdulhamid al-Dbeibah.

On a tour of the city on Sunday, Reuters saw workers clearing glass and debris from streets littered with spent ammunition casings. as fighters aligned with Dbeibah stood in front of bases seized from

forces affiliated with Bashagha. Traffic had returned to many roads as residents inspected damage to their property.

The clashes erupted and ended suddenly. But the brief nature of the flare up has not quashed fears of a wider conflict resuming between rivals after months of stalemate in a nation that has endured more than a decade of chaos and vio-

Libya has had little peace since the 2011 NATO-backed uprising that ousted longtime autocrat Muammar Gaddafi, splitting the nation in 2014 between rival eastern and western factions and dragging in regional powers. Libyan oil output, a prize for the warring groups, has repeatedly been shut off.



xtreme weather events from scorching heatwaves to unusually heavy downpours - have caused widespread upheaval across the globe this year, with thousands of people killed and millions more displaced. In the last three months, monsoon rains unleashed disastrous flooding in India, Bangladesh, Pakistan, China and brutal heatwaves seared parts of South Asia and Europe. Meanwhile, prolonged drought has left millions on the brink of famine in East Africa.

Much of this, scientists say, it is what's expected from climate change. However, cyclones are now more common in the central Pacific and North Atlantic, and less so in the Bay of Bengal, western North Pacific and southern Indian Ocean, according to a study.



The climate crisis has intensified risk conditions for extreme weather events across the world. Erratic seasonal swings have caused floods, wildfires, heatwaves and droughts on an unprecedented scale

Pakistan: The death toll from the devastating floods in Pakistan has crossed the 1,000-mark after another 119 people died due to deluge-related incidents across the country in the last 24 hours, according to the official data. Floods triggered by the torrential rain since June 14 have wreaked havoc, inundating a vast swathe of flat land in the south and southwest of the country. "So far, 1,033 people have died and 1,527 persons injured across Pakistan," the NDMA, the main body tasked to deal with calamities, said.

Afghanistan: In the past one month, at least 178 people have lost their lives as a result of devastating flash floods in Afghanistan, an official said. Another 250 were wounded in the heavy rain falls and flash floods that severely affected 13 of the country's 34 provinces, a spokesman of the Taliban's National Disaster Authority (NDMA), Nasim Haqqani, told dpa news agency.

China: The death toll after a flash flood in China's Qinghai province has increased to 17, with another 17 people still missing, local authorities have confirmed. Twenty people who were previously reported as missing have been rescued and some 4,500 firefighters, policemen, servicemen, emergency response personnel and local residents were carrying out search and rescue operations, Xinhua news agency quoted a top provincial official as saying.

Indonesia: Heavy rainfall has taken its toll in western and eastern parts of Indonesia. At least 3 people have died in floods and landslides in West Papua Province on New Guinea Island, while flooding in provinces of Sumatra Island has affected over 35,000 people. Heavy rainfall affected Sumatra Island, Indonesia, from 17 August 2022 causing floods and landslides.

Kentucky, USA: Heavy rain has pummeled mountain communities in the US state of Kentucky. Water rushed down hillsides, swallowing towns, washing away homes and trapping hundreds of people. At least 30 people have been killed.

**Sydney:** The start of July brought the fourth set of floods in 18 months to the Australian state of New South Wales. The Greater Sydney area was especially affected, with eight months worth of rain falling in just four days. Roads were turned into rivers and tens of thousands of people evacuated from their

Northeastern Brazil: Landslides and flooding following torrential rains wiped away housing in Brazil's northeastern Pernambuco state in May, killing at least 100 people.

South Africa: In April, intense rains hit the eastern coast of South Africa, causing floods and landslides that claimed more than 400 lives, destroyed over 12,000 houses and forced an estimated 40,000 people from their









### Windfall profit tax hits fuel export

New Delhi: India's diesel exports fell by 11 per cent in petrol dropped by 4.5 per cent after the government slapped a windfall profit tax on such sales, official data showed. Diesel exports dropped to 2.18 million tonne in July from 2.45 million tonne a month back, data from the Oil Ministry's Petroleum Planning and Analysis Cell showed. Similarly, petrol exports fell to 1.1 million tonne from 1.16 million tonne in June. In July, India exported 4.68 million tonne of petroleum products, 82 per cent of which was petrol, diesel and ATF.

### Disney bags ICC events' rights

New Delhi: Disney Star will broadcast International Cricket Council (ICC) events in India after bagging the digital rights to both men's and women's global competitions through to the end of 2027, the sport's governing body announced. The ICC said that Disney Star won the rights following a single round, sealed-bid process. In June, Disney-owned Star India retained the broadcast rights to the Indian Premier League for Rs 235.75 billion (\$3 billion).

### **Akasa Air suffers** data breach

New Delhi: Akasa Air, which started operations less than a month ago, has suffered data breach resulting in certain customer information being accessed by unauthorised individuals. The airline Sunday apologised for the data breach and said the incident has been "self-reported" to the nodal agency, the Indian Computer Emergency Response Team. In a communication, the airline said a temporary technical configuration error related to its login and sign-up service was reported August 25.

### **Reliance Capital** bid deadline ends

New Delhi: The deadline for submission of bids for debtridden Reliance Capital Ltd ends Monday amid concerns of investors over the company's most-valuable arm Reliance General Insurance Company **IDBI Trusteeship Services** Limited acting in its capacity as a debenture trustee on behalf of Credit Suisse, had invoked the pledge of Reliance Capital's 100 per cent shareholding in Reliance General in November 2019 and transferred the shares to its account.

## Suzuki drives deeper into India with global **R&D** company

Gandhinagar, August 28: Suzuki Motor Corp will set up a global research and development (R&D) company in India, its president said Sunday, pushing deeper into a market that is set to become an electric vehicle (EV) hub for the Japanese

The new company, a wholly owned unit of Suzuki Japan, will strengthen the carmaker's R&D competitiveness and capabilities in India and other global markets, Toshihiro Suzuki told an event in Gandhinagar, the capital of western Gujarat state.

"India has become one of the most important countries for Suzuki Group," he said, adding that Suzuki would keep investing heavily in the

Suzuki, which already builds combustion engine cars in India for its local unit Maruti Suzuki and for export, will in 2025 start producing EVs at its factory in Gujarat. It is also setting up a separate plant in the state to build batteries for EVs starting 2026.

The Japanese carmaker has said it will spend more than Rs 104 billion (\$1.3 billion) on its electrification plans in India, making it one of Suzuki's biggest battery and EV investments globally. It has already invested Rs 650 billion in the country. "India plays a significant role as

a global automobile production hub in Suzuki Group," Suzuki said. Suzuki also has a joint venture

with Japan's Denso Corp and Toshiba Corp to build lithium-ion batteries for hybrid cars for local use and exports. Suzuki is the majority-owner of

Maruti, which dominates India's car market with its small, low-cost vehicles. But the company faces growing competition as buyers shift to bigger cars such as sports-utility vehicles (SUVs) and regulators demand safer and greener cars, increasing costs.

India is also pushing carmakers to build more electric cars by offering companies billions of dollars in incentives.

Indian Prime Minister Narendra Modi said EVs are starting "a silent revolution in the country" and that his government was acting to boost demand and supply of these clean\_ vehicles.

"This silent revolution is set to bring major changes," he told Sunday's event, which marked 40 years of Suzuki's partnership with Maruti.

## Centre takes steps to boost domestic defence industry

India, facing tough challenges from neighbours on its northern and western frontiers, is one of the largest importers of arms globally

New Delhi, August 28: Defence Minister Rajnath Singh has approved a fresh list of 780 components and subsystems which will only be procured from domestic industry after a ban on their import kicks in under a staggered time-line of around six years.

It is the third such "positive indigenisation" list comprising line replacement units, sub-systems and components used for various military platforms, equipment and weapons, and the aim is to minimise imports by the defence public sector undertakings (DPSUs).

The defence ministry has set specific timelines for import ban of the items, spanning a period from December 2023 to December 2028.

"Singh has approved the third positive indigenisation list of 780 strategically important Line Replacement (LRUs)/Sub-

systems/Components with a timeline beyond which they will only be procured from the domestic in-

dustry," it said in a statement Sunday This list is in continuation to the two similar positive lists that

were brought out in December 2021 and March 2022. 'Indigenisation of these items will be taken up through different routes under 'Make' category."

## BITCOIN DIPS BELOW \$20K, MAY REACH \$10K LEVEL

Bitcoin represents 40 per cent of the \$1 trillion global cryptocurrency market

New Delhi, August 28: After showing some stabilisation in the last few weeks, world's largest cryptocurrency Bitcoin has plunged once again below \$20,000 after Federal Reserve Chair Jerome Powell's keynote address

Bitcoin initially showed little reaction to Powell's remarks, but then nosedived sharply and Sunday it was hovering around \$19,975 per digital coin which is more that 60 per cent drop in its value since last year when it reached a record-high of \$68,000 in November.

Bitcoin prices had stabilised around the \$23,000 to \$24,000 level



after plunging below \$20,000 in June. The prices of ethereum and other leading digital currencies have also rallied in the past two months, leading to hopes that this nascent market may have reached its bottom.

But the optimism could be premature, and fleeting. Companies with direct ties to the crypto landscape continue to struggle, according to media reports.

Bitcoin, despite the hype about it being digital gold, has turned out not to be an asset that performs well when inflation pressures are mounting and interest rates are spiking.

Reports last month suggested that Bitcoin may tumble to \$10,000 this year. A latest Bloomberg 'MLIV Pulse survey' revealed that the Bitcoin price is heading back to \$10,000.

Shark Tank's Kevin O'Leary has also stated that Bitcoin price has not hit bottom yet According to experts, the Bitcoin price will hit \$10,000 before recovering to the \$30,000 level.

Bitcoin has seen its worst-ever days in recent months amid the economic meltdown, leaving several crypto exchanges and trading platforms winding up operations, laying

## Russia blasts West's criticism of India over oil import

New York, August 28: Serena Williams rose from her sideline seat after a break during a training session inside Arthur Ashe Stadium, here Saturday and as she walked to the baseline at the end of the court covered by shade, a few voices from the stands called out in unison. "Serena. we love vou!"

About to hit some serves in preparation for the first round of the US Open which starts Monday - and what could wind up being the last singles match of her career the 23-time Grand Slam champion did not break stride, although she did turn her head in the fans' direction, acknowledging the sentiment with a smile.

"It's the end of a great career. And hopefully she can finish it off feeling good about herself and enjoying the moment and enjoying the crowd and listening to the people, to everyone, saying how much they love her," said Rennae Stubbs, who won four Slam titles in women's doubles and has been working with



Serena, alongside coach Eric Hechtman, since last week. "She responds to that in a positive way and not in a negative manner. She embraces it. My goal is to have her hopefully enjoy this moment,"

With the temperature in the 80s(Fahrenheit) and not a trace of a breeze, Serena was out there a little less than an hour, pausing at one point to eat some fruit. This followed an earlier hitting session

While every match - in singles and doubles - and each practice session involving Serena, who turns 41 next month, is sure to draw plenty of eyeballs, yes the pressure will be on the legend.

Serena's career will come full circle as her final match will be at the site of the first of her 23 Grand Slam singles wins, the 1999 US Open. Then just a teenager, Serena burst onto the scene to stun World No. 1 Martina Hingis in the final and lay the first stepping stone on her path to two decades of dominance.

"If I could just pick one thing that she possesses incredibly strongly compared to other players and champions, it's a strong determination to go through difficult stages and to win no matter what, vear after year." Marin Cilic, the 2014 US Open men's champion was quoted as saying by 'CNN'.

Serena's greatness is not only limited to court. She has won every doubles Grand Slam title at least twice to go with two mixed doubles crowns. Few tennis players have transcended the sport like Serena and her presence will undoubtedly be missed on the Tour.

But then as Serena herself said a few weeks back, she 'will have to evolve away from tennis' as she hates the word 'retirement'.
