# Floods damage 14K houses, crops on 1.26L ha of land

Bhubaneswar, Sept 7: The heavy rainfall and subsequent floods during the second and third week of August caused damage to 14,235 houses and cultivation of over 1.26 lakh hectare of agricultural land in 24 of the 30 districts of Odisha, government officials informed here Wednesday.

The rain and floods impacted lives of people in the districts of Angul, Bargarh, Boudh, Nayagarh, Sambalpur, Subarnapur, Cuttack, Jagatsinghpur, Kendrapara, Khurda, Puri, Bhadrak, Balasore, Bhadrak, Jajpur, Keonjhar, Mayurbhanj Bolangir, Jharsuguda, Kalahandi, Kandhamal, Koraput, Nabarangpur, Nuapada and Sundargarh, the government said in a release. However, there is no mention of the financial losses suffered by the families in the affected villages

As per the damage assessment report submitted by different district collectors, of the 1.26,235 hectare of agricultural land sustaining crop loss of 33 per cent or above, a total of 5,036 hectare have reported sand coating problem.

Meanwhile, the Odisha government has sanctioned ₹128.58 crore for repair of houses and fishing boats, agricultural input and other activities as per the provision of the state disaster response funds (SDRF).

The state has already sanctioned ₹99.92 crore to the districts for relief work. Departments like Water Resources, Works, Rural Development, Housing and Urban development and Energy have also been sanctioned ₹87.15 crore from

# **RUPPs under I-T glare**

Raids carried out in offices of registered unrecognised political parties in over 110 locations

New Delhi, Sept 7: The Income Tax department conducted raids Wednesday in multiple states as part of a pan-India tax evasion probe against certain registered unrecognised political parties (RUPPs) and their alleged dubious financial transactions, official

Over 110 locations in Gujarat, Delhi, Uttar Pradesh, Maharashtra, Madhya Pradesh, Chhattisgarh, Haryana and West Bengal were raided. The tax teams are being assisted by the local police.

Raids are also underway at Delhibased independent think-tank, 'Centre for Policy Research' (CPR) and international NGO 'Oxfam'



Once headed by academician Pratap Bhanu Mehta, a prominent critic of the BJP government, the CPR governing board is at present chaired by Meenakshi Gopinath.

Meanwhile sources said a coordinated action has been launched by the department against certain RUPPs, their promoters and linked entities to probe the source of their income and expenditure. Some

other instances of political funding through alleged illegal means are also being investigated as part of the action, they said.

The surprise action is understood to have been taken by the department on a recent recommendation of the Election Commission (EC) which recently struck off at least 198 entities from its list of RUPP after they were found non-existent during physical verification.

The poll panel had earlier announced that it was taking action against more than 2,100 entities, categorised as RUPP by it, for flouting rules and election laws, including those related to filing of monetary contributions, failing to update their address and names of office-bearers.

# Role reversal: Man bites snake to death in Balasore

A similar sort of incident had occurred in August last year with a poisonous reptile being on the receiving end of a person's wrath

Balasore, Sept 7: In what can be termed very unnatural, a man bit a venomous cobra to death in a fit of rage at Darada village under Basta police limits in Balasore district Tuesday.

It was a typical case of reverse revenge. The man identified as Salim Nayak was bitten by the snake when he was working on his farmland. Instead of fleeing

snake and bit it to death. The entire incident created curiosity in the minds of other residents in the village and Salim since then has become the cynosure of all eyes.

However, the matter did not end there. Salim then cycled around the village with the dead reptile around his neck, showcasing his feat.

However, this is not the only instance of a man biting a snake to death in Odisha. Last year in



Gambharipatia village under Salijanga panchayat in Jajpur district had also carried out a similar act. He was first bit by the snake while he was returning home on his cycle at night. Badra got down from his cycle, managed to catch the poisonous snake, which was a 'krait' and bit it to death.

Meanwhile Salim's act shocked the locals who had never seen such an incident.





Bhubaneswar, Sept 7: On the occasion of International Day of Clean Air for Blue Skies, Chief Secretary Suresh Chandra Mahapatra Wednesday urged upon all concerned for strict enforcement of rules to control air pollution.

Inaugurating an awareness programme and a daylong conference here, Mahapatra said the green coverage and forest density in Odisha are constantly increasing over the last 20 years The state and district pollution action plan has also been prepared, he added.

"Now, we have to take a three pronged approach viz. concrete action at ground level (both at individual and organisational level). intensified awareness among people and strict enforcement of the

Bhubaneswar, Sept 7: The state Housing & Urban Development department (H&UD) Wednesday launched House Allotment System (HAS) under its 'Housing for All Policy' which, the officials said, would help the people belonging to economically weaker section (EWS) in urban areas of the state.

Under this initiative, the Odisha Urban Housing Mission (OUHM) has developed a 'transparent and professionally managed' web-based software solution as well as an android-based mobile application namely 'House Allotment System' which was launched by the Bhubaneswar Development Authority (BDA) with the support

The app was launched by Housing and Urban Development Minister Usha Devi. "I hope this system will be a step towards achieving the vision and goal of our Chief Minister in providing a roof to all the persons belonging to the economic weaker sections of the society," Devi said.

The key objectives of this system are to generate predictability, transparency and ensure social auditing. The system will work on the principle of a continuous process of registration of all those families, who want to avail dwelling units under the 'Housing for All' policy. The app will also help address the challenges of housing in the state by assessing

HAS programme, Mishra said, 'The policy adopts seven models of intervention for creation of affordable housing stock and slum redevelopment.

He pointed out that one of the main conditions of HAS is that any project developer, be it government or private, must keep at least 10 per cent of the total builtup area of a residential project for construction of houses for people belonging to the EWS.

Mishra added that the system developed by the H&UD department will enable allotment of houses to the beneficiaries, through a fair and transparent mechanism right from 'registration to handing over of houses'. The aim of this new application is to see that people get housing at affordable rates, he added.

BDA vice-chairman Sanjay Kumar Singh said that the application will be very useful to the beneficiaries as each, and every service related to house allotment will be available at their fingertips.

# 200-bed cancer hosp at NISER on cards

Bhubaneswar. Sept 7: The state government Wednesday inked a pact with the Tata Memorial Centre. Mumbai for establishment of a state-of-the-art Cancer Hospital at the NISER campus at Jatni, on the outskirts of the City here.

Health and Family Welfare (H&FW) department signed the MoU in the presence of Chief Minister Naveen Patnaik Director of Tata Memorial Centre, Mumbai Rajendra Badwi and Special Secretary to Public signed the pact.

"The state government will provide a cyclotron machine to meet the requirements for radio isotopes for treatment as suggested by Director of Tata Memorial Centre, Mumbai," Patnaik said.

As per the provision of the pact, the Mumbai-based Tata Memorial Centre (TMC) under the Department of Atomic Energy will establish a 200-bed hospital and run it with a proposed cost of Rs

SC Constitution bench to go

green on Centre-Delhi row

New Delhi, Sept 7: Hearing a dispute between the Union and the Delhi government over control of the services in Delhi, a Constitution bench of the Supreme Court (SC) Wednesday decided to go green by shunning use of papers. The bench will be a "complete green bench" averting the use of physical documents.

The top court said the fivejudge constitution bench will September 27 fix the timeline for hearing and told the senior lawyers representing the parties that no bulky case files will be allowed in the courtroom

Justice Chandrachud also said that the court officials are willing to train advocates, who have difficulty in using

technology, Saturdays. "We will keep this a complete green bench, so there will be no papers in this matter. The secretary-general and million papers (Approx) are being used in apex court and 831 million papers (approx) are used in High Courts. The figures are much high in district courts where 11 billion (approx) papers are being used, he said. "To cater the said demand

decided to accept petitions and affidavits only in A4 size paper sheets printed on both sides from April 2020. Then Chief Justice of India SA Bobde had also directed the Supreme Court registry to use A4 size sheets printed on both sides for internal communications at all levels. # Dara Singh denied bail in Arul Doss murder case

Cuttack, Sept 7: The High Court Wednesday refused to grant bail to Dara Singh alias Rahindra Kumar Pal, who was convicted along with three others and sentenced to undergo rigorous imprisonment for life in the Father Arul

Doss murder case of 1999 in Mayurbhanj. Sustaining the conviction and affirming the sentences of all the four, a Division Bench headed by Chief Justice S Muralidhar cancelled the bail bonds of the other three convicts and also asked them to surrender by September 23, failing which the police were directed to take them into custody.

According to the prosecution, a group of persons had gathered around a Church located under the Mahuldiha police station of Mayurbhani district on the intervening night of September

1 and 2, 1999, when a group of Christians were dancing and singing in front of the church.

"All the four convicts, including Dara Singh, entered into the church with other group members and killed Father Arul Doss, who had sustained multiple injuries with arrows," the prosecution said, adding that on subsequent police investigation, 21 persons were arrested in this connection.

The accused, Bapuram Beshra, was arrested and remanded to judicial custody. After completion of investigation, the chargesheet was also filed against

the accused, the SP's report said. Observing that the SP's report is silent about the compensation to the victim, the commission May 9, 2022 asked the SP to come up with the present status of the case and the DM on the compensation to the victim within four weeks.

This time, the SP did revert with the status report, but the DM did not, it was learnt.

A livid commission September 6 directed the DM to turn up with status report of the compensa-tion to the next of the kin of the victim within October 14 this year. In case of failure, the commission would invoke coercive steps under Section 13 of the PHR Act, 1993, it said.

About the incident, the rights activist cited the police complaint to say that Sarita's father Jagannath was told by the school authorities to take his daughter back from school hostel as she was unwell. October 1, Jagannath took his daughter back home. At home, Sarita's health deteriorated following which she was admitted to the district headquarters hospital, where she died during treatment November 4.

Jagannath alleged that as the school authorities did not provide her healthcare during her stay at the hostel, her health deteriorated and subsequently the schoolgirl died, Nayak said citing Jagannath's

The report has been prepared by the International Forum for Environment, Sustainability & Technology (iForest) with the support of the World Bank Group.

It highlights the need of a national-level programme to develop the capacity of all stakeholders cities, state and central government agencies, private sector, NGOs and media - to effectively tackle the problem of air pollution.

"Our report shows that we need to train at least 1 million (10 lakh) people over the next five years for air quality management. This will also create tens of thousands of new jobs in the public and private sector to plan, monitor, mitigate, and control air pollutants," said Chandra Bhushan, the CEO of iFOREST and the lead author of the report.

He said the report is the first attempt of its kind to map the environmental sector in the country. The agencies, organisations and industries working in the air quality management sector include ministries and departments of the government, state pollution control boards, urban local bodies, air polluting industries, and air pollution control industries. The report said there are at least 2.8 lakh organisations and industries across the country which requires personnel for air quality management.

It has identified 42 specific job roles that is required to control air pollution in the country -- from

Khallikote, Sept 7: The district administration has initiated steps to sort out the alleged ostracisation of 85 families of Dharama Vishwakarma Samaj at Fasula village under this civic body limits in Ganjam district. They have been living a life of deprivation and obscurity for over 70 years after being boycotted by their own community members several years back.

Acting on the direction of the district Collector, a meeting was held at the Khallikote block office. It was attended by the block development officer. tehsildar, additional tehsildar and inspector in-charge of Khallikote police station. In the meeting, discussions were made to lift the ostracisation tag from these families of Fasula village. As per reports, no girl of the community in the village can marry a boy of the same community residing in another village after being boycotted by their own community members.

Moreover, girls of the community in other villages are banned from entering into marriage with boys of the community in Fasula village. Anyone violating the order is liable to pay heavy penalty.

The members of Vishwakarma community in Fasula village had filed a written complaint with the district Collector.

Khallikote tehsildar Rajkishore Patnaik said that the administration has given 15 days time to sort out the long pending issue. The Maharana Samaj will discuss the issue with the talukas of South Odisha and find a way to resolve the issue.

According to sources, the group of families of Fasula was asked to pay ₹400 as penalty to get rid of the tag of 'ostracisation' in 1950. As they failed to pay the amount which was too hefty at that time, they were banished from the society till an indefi-

District Collector Ananya Das presided over the meeting and sought assistance of officials in realising the goals. Senior officials and officials of various other departments were present in the meeting.

According to reports, the istrict administration has planned for cultivation of chillies on more land than in previous years. As part of this initiative, it has conducted meetings among the

# **NAC TAG TO BETANOTI**

# 2-decade-old demand still remains unfulfilled

Betanoti, Sept 7: For the last 20 years, people of Betanoti, a developing town in tribal-dominated Mayurbhani district, have been demanding the status of Notified Area Council (NAC) for the town, but their dream has remained unfulfilled due to administrative apathy. This has caused deep resentment among the denizens here.

Reports said, the government has accorded NAC status to Rairangpur, Karanjia and Udala towns in the district. Locals argued that Betanoti fulfils all the eligibility criteria and has necessary infrastructure to get NAC tag, but the government has allegedly dillydallied its initiative.

People have been demanding the NAC status at different fora in the past, but all in vain. Though the local leaders assure the people of taking up their demand with the government before elections, they forget about it after the polls. This is happening every time before polls, locals lamented.

There was a proposal to declare Betanoti as an NAC by including nine villages -Betanoti, Bhogabati, Tulasi Chaura, Pandu Gadia, SS Mahulia, Sagadabhanga, Bahanada, Sathilo and Renugaon - having a population of over 16,000 as per 2011 Census. The proposal was sent by the district administration citing all other requisites to the Housing and Urban Development department in October 2012. But the department reverted the proposal asking the administration to submit a report on other possible sources of revenue apart from the existing ones. "The NAC status would pave the way for development which has been stalled for more than three decades.We have here all prerequisites to fulfill the requirements of the NAC. We demand the NACstatus," said local leaders.

# **Childish Morality?**

onsider the following statements describing our moral judgments: If a child is hungry, or hurt, the child's parents or friends have a greater obligation to help than a stranger does.

If we have to choose between saving the life of a human or that of

a dog - or even many dogs - we ought to save the human.

Almost everyone agrees with these moral judgements, right? Wrong. A sizable group of people disagree. In the past two years, separate studies have compared adults' views on these two issues with those of children between the ages of five and ten years, and found that their responses differed significantly. Both studies seek to shed light on the formation of our moral judge-

ments, and so to help us to answer one of the Big Questions about morality: is it rooted primarily in our culture, or is it innate?

When anthropologists spread across the globe in the nineteenth and early twentieth centuries, their reports emphasised the variation in moral beliefs between societies. As a result, the view that morality is a cultural phenom-

In the 1970s, however, evolutionary theorists like EO Wilson and Richard Dawkins began to push back against cultural explanations of morality. A great deal of human behaviour, they argued, could be explained by genetic selection, not necessarily aimed at the preser-

vation of each individual organism, but rather at the preservation of genes that are likely be shared, not only with offspring, but also with other kin. Thus, moral rules imposing stronger obligations to assist kin rather than strangers would have evolved, along with other rules encouraging reciprocal, mutually beneficial relationships

The evolutionary view of the origins of morality has a lot going for it, including the discovery of precursors of human morality in other social mammals, some of whom, as Frans de Waal showed, clearly have a sense of fairness. And this sense can be more developed than just, "you scratch (= pick the lice from) my back and I'll scratch yours." It can mean demanding something rather like equal pay for equal work: "I'm not accepting a food pellet for doing the same task that you gave that other monkey a grape for doing!

Evolutionary theory does, however, have great difficulty in explaining the idea that we have obligations to come to the aid of strangers. In my book The Expanding Circle, I accepted the evolutionary explanation of the basis of morality, but supplemented it by arguing that our capacity to reason does more than enable us to survive and reproduce: it also enables us to take a universal perspective from which we see that strangers are like us, and disre-

Children certainly seem to think so. One of the two studies, led by Julia Marshall, a postdoctoral fellow at Boston College, shows that children between five and ten years of age say that if a child is hungry or hurt, a stranger has an obligation to help them. Older children and adults, by contrast, are more likely to differentiate between strangers, who don't have to help, and parents or friends, who do

The study was carried out in Germany, India, Japan, Uganda, and the United States, and in all these countries, younger children thought that strangers ought to help. The main cultural difference found is that in India, Japan. and Uganda, participants gave less weight to the differences between parents. friends, and strangers than they did in Germany and the United States. In Uganda, in fact, older children were even more inclined than younger children to regard friends and strangers as being obliged to help.

The study of priorities regarding saving a human or animals, led by Matti Wilks, a lecturer at the University of Edinburgh, also showed that children aged 5-9 take a broader view than adults. But in this case, it was a broader view of the value of life. Whereas almost all adults chose to save one human rather than as many as a hundred dogs or pigs, many children gave as much weight to saving a dog as they did to saving a human, and although the chil dren valued dogs more than pigs, the majority still chose to save ten pigs rather than one human.

This may shed some light on why some children raised to eat meat refuse to eat it after they discover that meat is the flesh of an animal who has been killed. Both studies suggest that young children have broad moral sensitivities, both in terms of who should help someone in need, and in terms of the range of beings for whom they are concerned. The studies also indicate that in most cultures, these sensitivities are narrowed during the child's development. Does this narrowing result from the children's upbringing and cultural immersion, or could it be that the children revise their judgements in the light of greater knowledge of the world? We don't yet have the answer.

The studies have something else in common: the co-authorship of Paul Bloom, a professor of psychology at the University of Toronto. Bloom has acknowledged that the findings of both studies challenge claims he made in his book Just Babies. That is of course laudable. It is only by remaining open to the evidence that we may eventually untangle the roles culture, biology, and our capacity to reason play in the formation of our moral judgements.

black swan event is related to the butterfly effect. The latter was coined Aby the American mathematician and meteorologist Edward Lorenz in 1973 as a way to illustrate the chaotic nature of weather and the huge difficulties of modelling it on computers. A tiny change in the initial conditions can often lead to dramatically different outcomes. His example was of a butterfly that fluttered its wings in Brazil, setting off a tornado in Texas. The phrase black swan gained some popularity in 2008 because of the book The Black Swan: The Impact of the Highly Improbable by Nassim Nicholas Taleb, a former market trader. The phrase was not new: Taleb had introduced it in his work of 2001, Fooled by Randomness: The Hidden Role of Chance in the Markets and in Life and a few appearances are known before 2008, such as in Maggie Mahar's book of 2003, Bull!: A History of the Boom, 1982-1999. Taleb argued that the stock market is as unpredictable as any chaotic system and that people who thought they could forecast it on the basis of past trends were fooling themselves. This was considered a contrarian view in 2007, but recent events have convinced many doubters of its truth. For Taleb, a black swan is an unpredicted and unpredictable event that resembles the finding of black swans in Australia by the seventeenthcentury Dutch explorer Willem de Vlamingh.

people around the world phones, but the information they consume has changed dramatically - and not for the better. On dominant social-media platforms like Facebook, researchers have documented that falsehoods spread faster and more widely than similar content that includes accurate information. Though users are not demanding misinformation, the algorithms that determine what people see tend to favoUr sensational, inaccurate, and misleading content, because that is what generates "engagement" and thus advertising revenue.

As the internet activist Eli Pariser noted in 2011, Facebook also creates filter bubbles, whereby individuals are more likely to be presented with content that reinforces their own ideological leanings and confirms their own biases. And more recent research has demonstrated that this process has a major influence on the type of information users see.

Even leaving aside Facebook's algorithmic choices, the broader social-media ecosystem allows people to find subcommunities that align with their interests. This is not necessarily a bad thing. If you are the only person in your community with an interest in ornithology, you no longer have to be alone, because you can now connect with ornithology enthusiasts from around the world. But, of course, the same applies to the lone extremist who can now use the same platforms to access or propagate hate speech and conspiracy theories.

No one disputes that socialmedia platforms have been a major conduit for hate speech, disinformation, and propaganda. Reddit and YouTube are breeding grounds for Right-wing extremism. The Oath Keepers used Facebook, especially, to organise their role in the January 6, 2021, attack on the United States Capitol. Former US President Donald Trump's anti-Muslim tweets were found to have fuelled violence against minorities in the US. True, some find such observations alarmist, noting that large players like Facebook and YouTube (which is owned by

Google/Alphabet) do much more to police hate speech and misinformation than their smaller rivals do, especially now that better moderation practices have been developed. Moreover, other researchers have challenged the finding that falsehoods spread faster on Facebook and Twitter, at least when compared to other media.

Still others argue that even if the current social-media environment is treacherous, the problem is transitory. After all, novel communication tools have always been misused. Martin Luther used the printing press to promote not just Protestantism but also virulent anti-Semitism. Radio proved to be a powerful tool in the hands of demagogues like Father Charles Coughlin in the US and the Nazis in Germany. Both print and broadcast outlets remain full of misinformation to this day, but society has adjusted to these media and managed to contain their negative effects.

This argument implies that a combination of stronger regula tion and other new technologies can overcome the challenges posed by social media. For example, platforms could provide better information about the provenance of articles; or the same platforms could be discouraged from algorithmically boosting items that might be incendiary or contain

But such measures fail to address the depth of the problem. Social media is not only creating echo chambers, propagating falsehoods, and facilitating the circulation of extremist ideas. It also may be shaking the very foundations of human communication and social cohesion, by substituting artificial social networks for real ones.

We are distinguished from other animals mostly by our advanced ability to learn from our community, and to accumulate expertise by observing others. Our most profound ideas and cherished notions come not in isolation or from reading books, but by being embedded in a social milieu and interacting through argumentation, education, performance, and so forth. Trusted sources play an indispensable role in this process, which is why leaders and those with bully pulpits can have such outsize effects. Earlier media innovations capitalised on this, yet none of them modified the very nature of human networks the way that social media have.

What happens when platforms such as Facebook, Twitter, or Reddit start manipulating what we perceive as our social network? The worrying truth is that nobody knows. And though we could eventually adapt to this change and find ways to neutralise its most pernicious effects, that isn't an outcome that we should count on, given the direction the industry has been heading.

Social media's most corrosive effects are starting to look exactly like what the cultural critic Neil Postman anticipated almost four decades ago in his landmark book Amusing Ourselves to Death. "Americans no longer talk to each other, they entertain each other," he observed. "They do not exchange ideas, they exchange images. They do not argue with propositions; they argue with good looks, celebrities, and commercials,

Comparing George Orwell's "1984" to Aldous Huxley's "Brave New World," Postman then added that, "What Orwell feared were those who would ban books. What Huxley feared was that there would be no reason to ban a book, for there would be no one who wanted to read one. Orwell feared those who would deprive us of information. Huxley feared those who would give us so much that we would be reduced to passivity and egoism. Orwell feared that the truth would be concealed from us. Huxley feared that the truth would be drowned in a sea of irrelevance.'

Whereas Postman was worried more about a Huxleyan future than an Orwellian one, social media have been ushering in both at the same time. While governments acquire the means both to manipulate our perceptions of reality and to reduce us to passivity and egoism, our virtual "friends' are increasingly policing our thoughts. One now must continuously signal one's virtue and call out people who deviate from prevailing orthodoxy. But "virtue" is whatever one's artificial online social circle says it is; and in many cases, it is based entirely on lies.

Hannah Arendt, another prescient twentieth-century thinker, warned about where this can lead "If everybody always lies to you, the consequence is not that you believe the lies, but rather that nobody believes anything any longer.' At that point, social and political life become impossible.

carried away by the reports that Indian economy has overtaken that of the UK to become the fifth largest in the world. First thing is that it is not the first time that India has overtaken the UK. According to IMF, in 2019, India became the fifthlargest economy with a nominal GDP of \$2.94 trillion overtaking France (\$2.71 trillion) and the UK (\$2.83 trillion). But the joy was shortlived as India's \$2.94 trillion for 2019 was revised down to \$2.83 trillion, while France's and the UK's were revised upward to \$2.73 trillion and \$2.88 trillion, respectively.

During the UPA regime, there was a projection that India would overtake the UK in terms of GDP by 2020, because of India's faster growth of population and per capita income. But this was delayed due to a slowdown triggered by the draconian demonetization, flawed GST implementation and the pandemicinduced supply disruption and demand compression.

The GDP measured in national currency or in dollar term is not comparable with other countries because if one's currency appreciates in terms of dollar. GDP in the dollar will automatically be higher and vice versa. Purchasing power

The country should not get parity (PPP) is better way to meast the UK, in terms of GDP, India to touch the global average of 55% ure than the exchange rate expressed in relation to the dollar for comparing GDP. PPP is used to compare the economies and incomes of people by adjusting for differences in prices in different countries.

According to a World Bank report released in April 2014, India emerged as the world's third-largest economy in 2011 from being the tenth largest in 2005, moving ahead of Japan, while the US remained the largest economy closely followed by China. But, over the last eight years, no further improvement in ranking of India was seen while China has overtaken the US.

Countries like the US, the UK, Germany and Japan have exhausted the scope of growth after becoming developed nations. While developing countries like India have to accelerate their growth rate to become developed countries. The growth rate of developing countries should be much higher than developed countries and there should be no comparison between the UK and India. Household consumption contributes 60.8% of India's GDP. The population of India is 140 crore while that of the UK is 6.72 crore. When 140 crore Indians consume as against 6.72 crore of should be much ahead of the UK. While economy of India is the

third-largest by PPP, the economy of the UK is eighth-largest by PPP. But when India's nominal per capita GDP is \$2,543 and per capita GDP (PPP) is \$8.358, the UK's nominal per capita GDP is \$49,761 and per capita GDP (PPP) is \$55,301. Since 2008, India continues to be a lowermiddle-income country while the UK is a high-income country.

India is no way nearer to the UK in terms of per capita income. According to IMF, on a per capita income basis, India ranked 142nd by GDP (nominal) and 128th by GDP (PPP), while the UK ranks 24th by GDP (nominal) and 28th by GDP (PPP). In Human Development Index, the UK is placed at 13th while India is placed at 131st position.

The currency of the UK is the pound sterling where 1 pound is equal to 1.36 US dollars now. But 1 dollar is equal to 79.82 rupees. We need to pay ₹91.82 for one pound.

The unemployment rate in the UK is 3.7%, while in India it is ranging from 8 to 9%. In 2017-18 India's unemployment rate had touched a 45year high of 6.18%. While the employment rate in the UK is 75.6%. in case of India it is only 40%. Even

India needs to give employment to 19 crore people.

Comparison should be made among the comparable. India should be compared with China which also has a huge population. In 1987, the size of India's economy was the same as China's. But now China's economy (with a GDP of nearly \$18 dollars) is 5.43 times that of India's. In 1990, the per capita income of India was \$367, and China's was \$317. That was the last time we were ahead of them. But now China with a per capita income of \$12,556 is much ahead of India.

GDP is only a symbol of economic activities, not the well-being of people. When GDP grows, the rich garner major benefits while the poor suffer. There is no meaning of GDP growth if it does not reduce poverty, hunger, unemployment, and inequality as seen in our country. Even if the government levies more indirect taxes and reduces subsidies, the GDP will increase. This is happening in our country which is regressive.

No age or sex is exempt from selfie and Instagram fixation that has earned India a dubious distinction of topping the number of selfie related deaths in the world. The sad part of these deaths: all were preventable. Due to the preoccupation to be "liked", young minds are losing the ability to think right. No corner of the country is safe for selfie and Instagram maniacs - sea sides, highways, mountain cliffs, high buildings, railway tracks, waterfalls. Interestingly, both overconfidence and low self-esteem contribute to these deaths. Fixation with selfie leads to escalated affinity to a person's mirror image than their usual self. A selfie can be nothing but mere "face"; there is no room for "feelings". The madrassa which was demolished had around 20 students. They were studying theology by staying in the compound which also houses a mosque. The mosque, however, was not dismantled.

The veteran school teacher, who has been serving the institution since 1987, said that he disapproves of the parents' decision to discontinue school education of the kids for religious studies.

Uzir Jamal, a 62-year-old resident of the village, said poor infrastructure of government-run schools is also forcing parents to take their children to madrassas.

Assam DGP Bhaskar Jyoti Mahanta had last week said that there are about 3,000 registered and unregistered madrassas across Assam that are run by four main Muslim organisations.

# Abandoned newborn partially eaten by stray dogs on hosp premises

Mandya, Sept 7: A chilling incident of stray dogs feeding on an abandoned newborn girl child at the Mandya Institute of Medical Sciences (MIMS) in Karnataka's Mandya district has surfaced and police are probing the matter.

Police sources said Wednesday that they suspect the baby was abandoned by her parents due to



the social stigma surrounding the girl child. They are analysing CCTV footage to gather evidence.

According to the police, the doctors have stated that the child was born a day before and looked handicapped, which could also be the reason for her parents abandoning her. People informed the authorities after seeing a pack of dogs eating the baby near Ward No 7 of MIMS Tuesday. As the baby was moving, people could see that she was alive, and were outraged to see the baby's wounds and bite marks from dogs at the time of rescue. The MIMS staff rushed to the spot and rescued the newborn baby. However, the baby succumbed to iniuries, police said

A complaint in this regard was lodged with West police station in Mandya city. Police suspect that the newborn baby was dragged into the premises by dogs.

MIMS Director Dr Mahesh Kumar also visited the spot.

Authorities later checked whether the abandoned baby was born at the MIMS and confirmed that it was not born there. Between September 1 and 5, four babies three male and one female - died at the MIMS. The parents of the female baby confirmed that they have conducted final rites for their baby,

# Cabinet approves ₹27,360-cr scheme for setting up 14K PM-SHRI schools

New Delhi, Sept 7: The Union Cabinet Wednesday approved a ₹27,360-crore scheme for the development of over 14,000 schools across the country as PM Schools for Rising India (PM-SHRI), which is expected to benefit 18.7 lakh

Under the scheme, over 14,000 schools, including Kendriya Vidvalavas and Navodava Vidyalayas as well as schools run by state governments and local bodies, will be strengthened to emerge as PM-SHRI Schools, Union ministers Dharmendra Pradhan and Anurag Thakur told reporters after the Cabinet meeting.

Prime Minister Narendra Modi announced the scheme September 5 on Teachers Day to upgrade and modernise existing schools from amongst those managed by the central and state governments, as well as local bodies.

The total project cost would be ₹27,360 crore for five years, of which the central share would be ₹18,128



crore. The government expects this scheme to benefit 18.7 lakh students and these schools will be monitored vigorously to assess progress and understand the challenges faced in the implementation of the new National Education Policy (NEP), 2020.

"PM SHRI will provide highquality education in an equitable, inclusive and joyful school environment that takes care of the diverse background, multilingual needs, and different academic abilities of children and makes them active participants in their own learning process as per the vision of NEP 2020," said Pradhan, who

# 'Over 47% unapproved antibiotic formulations used in 2019'

New Delhi, Sept 7: More than 47 per cent of antibiotic formulations used in India's private sector in 2019 were not approved by the central drug regulator, according to a study published in The Lancet Regional Health-Southeast Asia.

The research also found that azithromycin 500mg tablet was the most consumed antibiotic formulation (7.6 per cent) in India, followed by cefixime 200 mg tablet (6.5 per cent) during the year.

The researchers at Boston University, US and Public Health Foundation of India, New Delhi, examined the private sector antibiotic use, which contributes to 85-90 per cent of the total consumption

The data were gathered from a panel of 9.000 stockists who store products from approximately 5,000 pharmaceutical companies.

However, these data did not include the drugs dispensed through public facilities, though this is less than 15-20 per cent of all drug sales in the country as per studies and national health accounts estimates

The researchers found a lower consumption rate of antibiotics compared to previous estimates but very high relative consumption of broad-spectrum antibiotics, which act against a wide range of disease-causing bacteria.

The total defined daily dose (DDD) - the assumed average maintenance dose per day for a drug in adults -- consumed in 2019 was 5,071 million (10.4 DDD/1,000/day),

The study shows that formulations listed in the national list of essential medicines (NLEM) contributed 49 per cent while fixed-dose combinations (FDC) contributed 34 per cent, and unapproved formulations were 47.1 per cent.

Antibiotics

FDCs are the combinations of two or more active drugs in a single dosage form. "Centrally unapproved formulations accounted for 47.1 per cent (2,408 million) of total DDDs." the authors of the study noted. "Cephalosporins, macrolides, and penicillins were the top three antibiotic classes among unapproved formulations," they said.

Inappropriate use of antibiotics is a significant driver of antibiotic resistance in India, the authors of the study noted in the journal.

"Largely unrestricted over-thecounter sales of most antibiotics, manufacturing and marketing of many FDC and overlap in regulatory powers between national and state-level agencies complicate antibiotics availability, sales, and con-

sumption in the country," they said. The authors acknowledge some limitations to their study, including the fact that the dataset covers only the private sector sales of antibiotics and will not reflect the antibiotics dispensed through the public system. Also, the data do not differentiate between community and hospitaluse as the data are collected at the stockist level, they said.

# 250 terrorists wait K'taka: 3-day state mourning as Katti laid to rest across LoC, army readies to counter

Keran Sector (LoC), Sept 7: With intelligence reports suggesting presence of around 250 terrorists across launch pads in PoK, the army along the Line of Control (LoC) has upped its ante to counter any nefarious design from across the border

Maintaining a high vigil at the forward post in Keran sector, the northern most part of Kashmir along the LoC, troops are maintaining a birds-eye vigil despite ceasefire between the two countries since February last year.

For the soldiers at this frontier, it's a battle that has to be fought on two fronts -- hostile neighbour and harsh winter, which is approaching

Though the claims of the army that infiltration has reduced in the past few years, officials, who spoke to a group of visiting journalists, said there were intelligence inputs about the presence of about 250 terrorists at various launch pads waiting across the LoC to sneak in. So, we cannot let our guard down, one of the army officials said.

Besides infiltration of terrorists, the army is also worried about the flow of drugs from across the border. Recently, Director General of Jammu and Kashmir Police Dilbag Singh had said smuggling of drugs from across the border is on the rise and Pakistan is using it to fund terrorism in Kashmir.

The army officer said, "We are keeping a close eye on the smuggling of narcotics as well apart from in filtration of terrorists and arms and ammunition. The enemy has its ways, but we are firm and ever ready to defend our motherland. And with the winter not far away the battle is about to get tougher. It is a tough fight. Life in these

terrains is very difficult, a soldier guarding one of the posts here, in Keran Sector in Kupwara district of Jammu and Kashmir told PTI.

These Army posts - some at the highest altitude of about 12,000 feet - are the first line of defence against the intruders in these infamous, traditional routes of infiltration. These infiltration routes converge at the mighty Shamsabari range.

The range with its mighty peaks, rugged mountains, thick forests with dense vegetation, and several streams, poses a difficult challenge, to the forces, of both the kind - the nature as well as of the man.

Apart from the topography, the weather here is very harsh, it is extreme. We have too much cold here when it snows. The snow can accumulate up to 20 feet and remain there for about three-four months, an army officer said.


The soldiers and officers as well as the posts cannot be identified for strategic reasons

For the months of the winter, the forces at such posts or their base camps have to stock up the essentials as the road gets cut-off due to heavy snow. For those months, helicopters choppers are the only mode of transportation.

The road, many bunkers and other infrastructure is not even visible when the snow accumulates. There are high-poles which act as markers for us in such situations when we have to move, the

Notwithstanding the nature, the officer said, the duty to protect the motherland is the priority and has to be performed in any case.

The duty at the forward post can sometimes stretch several hours especially if there is an input (terrorists' movement), he said

While elected representatives of he ruling BJP faced tough questions over tackling the deluge, Chief Minister Basavaraj Bommai Wednesday said he would bat for special grants from Centre to handle the situation arising out of the damage caused by the downpour to civic infrastructure

Parts of Bangalore that were battered by torrential rains for the last couple of days appeared to be slowly returning to normalcy with flood waters receding in some areas.

According to official sources, waterlogging has been cleared in most roads, while work is on for draining water in other affected areas. Traffic is almost returning to near-usual levels and complete normalcy is hoped soon

For people, whose routine life was thrown out of gear due to the showers, the respite is that the rains have stopped.

However, many residents could not forget the travails they endured, like those who live in 'Epsilon', a posh gated community in North Bangalore. Almost all in Epsilon were top business executives and in this neighbourhood, high-end cars were submerged, household belongings were washed away and they used tractors and boats to reach places of safety.

Bengaluru South Lok Sabha member Tejasvi Surya was trolled and criticised by a section of social media users, who accused him of relishing dosa and promoting an eatery in his constituency, when many parts of the city reeled under torrential rains and floods. The Congress party targeted him for eating dosa and 'mocking people' when the city drowned

In the social media, some people questioned the other two Bengaluru BJP MPs Sadananda Gowda (North) and PC Mohan (Central), on their contribution in handling the situation arising out of rains and the deluge. There were also several tweets blaming the city's MLAs and political

Bommai Wednesday said his government will seek special grants from the Union government as compensation for the damage caused in rain-battered Bangalore. He held a meeting with the Inter-Ministerial Central Team (IMCT) headed by Home Ministry's joint secretary Ashish Kumar, which is visiting Karnataka to take stock of the flood situation in the State.

"We have shared details on damages caused during three stages of rainfall - July August and the first week of September," Bommai said. # Killers developed hatred towards Hindus following unrest in K'taka, says NIA

Shivamogga (K'taka), Sept 7: The National Investigation Agency (NIA) probing the murder of the 27vear-old Bairang Dal activist Harsha in Shivamogga district of Karnataka has mentioned in its charge sheet that the killers of Harsha developed deep hatred towards the Hindu community following the situation of unrest in the state, sources said Wednesday.

The NIA has submitted the charge sheet in connection with the sensational murder recently to a special court. The charge sheet also mentions that killers raised slogans at the scene of the crime after executing the murder. The developments surrounding the Citizenship (Amendment) Act, 2019 (CAA) and the National Register of Citizens (NRC), the hijab crisis and the aggressive campaign by Bajrang Dal activists on gohatya (cow slaughter) made the accused develop deep hatred towards the Hindu community.

The NIA probe has also shown that the accused were planning to foment hatred and violence between Hindus and Muslims. The accused closely monitored processions, programmes and festivals of the Hindu community.

They had zeroed on Bajrang Dal activist Harsha who was very active on the ground and on social media as well. Harsha led the protests against the illegal transportation of cows. He made several comments supporting the hijab ban and slammed religious fundamentalism, Sources explain that all these matters have been mentioned in the

# Human greed eats up Kashmir's countryside

Srinagar, Sept 7: Kashmir's fast shrinking countryside is witness to human greed and short-sightedness of planners. Just two decades back, one would

get a divine feeling of entering the lap of nature as Srinagar city was surrounded by vast, lush green paddy fields and crystal clear water Bathers would drink handfuls of

clean water in the Dal Lake which is situated in the heart of Srinagar city. Within less than three decades. this lake has lost its grandeur and purity despite the huge effort put in by the governments to restore this water body to its old glory. Bathers are reported to develop

skin allergies and drinking the water of the Dal Lake is now considered a gastroenterologist's goldmine. Fast growing cities and towns have eaten up the rural greenery in all the 10 districts of

the Valley, Srinagar being the worst affected of all. Monoliths of concrete have come up around and inside Srinagar city and the newfound greed to construct shopping malls and multi-storeyed business complexes in the suburbs has deprived posterity from witnessing the city's glory except in the photoalbums of their grandparents.

The ecological disaster of Srinagar city is in fact much older than just the last three decades.

In the 1960s, a mindless administrative decision was taken to fill up the 'Nallah Mar' that went round the old Srinagar city.

Srinagar till then was called the 'Venice of Asia' because of this serpentine canal that formed a fabulous waterway on the banks of which most of the city's commercial activities took place.

It was a magical waterway in which boats carrying goods would move as buyers would line up at different shopping points.

A macadamised road has replaced the canal on which the security forces and the miscreants kept battling with stones and tear smoke shells during the peak years of violence.

Incidentally, the first burst of the separatist automatic gunfire was also heard on this road in 1989. Till a few months back, the conversion of agricultural land for any other purpose, including house construction and commercial activity, was banned under the law.

This ban order was recently relaxed permitting the conversion of agricultural land for other use after paying a fixed amount of revenue to the government.

The protection of the shrinking agricultural land in the Valley had already given the authorities sleepless nights as encroachers and greedy land brokers kept on selling these protected pieces of land on the sly.

Now that the same can be legally converted for other purposes, how fast Valley's agricultural fields

would last is anybody's guess. Does Kashmir have so much potential for commercial activities that crores of rupees are being spent each day for construction

of shopping malls and complexes. Interestingly, the experts believe that these real estate ownerships have become a convenient method of parking your money.

"Say for example, you construct a shopping complex that might not fetch you the investments in the first few years. Given the normal escalation and appreciation, you would earn 100 times more on such investments over the years than any bank can pay you on that amount,' said a financial expert.

Thanks to the efficient public distribution system, rice, the staple food of the local people, is available at comparatively lower price through the government run ration depots. Rice grown locally costs much more than the same quantity available at the government run ration depot. Farmers have started a novel practice in Kashmir. They sell their own produce of rice and buy their annual requirement on a monthly basis from the government ration depots. Only the richer sections of the local society are now seen eating the locally grown grain.

While everybody is driven by greed to earn more by parking money in real estate and lands are sold and purchased at exorbitant rates, nobody seems to give a damn to the green countryside of Kashmir nor its glistening streams and springs.

# Sufi saint's Urs restarts after 33 years in J&K's Ganderbal



### **ED** summons **Bengal minister**

New Delhi, Sept 7: The Supreme Court, hearing a clutch of petitions against Karnataka High Court judgment nixing wearing on hijab in educational institutions, Wednesday observed that the issue is one particular community insists on a head scarf while others follow a dress code, and also the petitioners' counsel argument on right to dress cannot be taken to "an illogical level".

Senior advocate Devadatt Kamat. representing a Muslim student. submitted that right to dress is recognised as a fundamental right under Article 19(1)(a) and saying if one goes to school wearing a hijab and that person would not be allowed, then the state violates Article 19.

Kamat submitted before a bench comprising Justices Hemant Gupta and Sudhanshu Dhulia that Karnataka government's GO is compelling the students to choose between their identity and dignity and right to education. At this, Justice Gupta orally remarked: "You cannot take it to an illogical end... right to dress is a funda-



mental right then right to undress also becomes a fundamental right?..." As Kamat replied: "I am not here to make cliche arguments... No one is undressing in school...' Justice Gupta said that no one is denying the right to dress. Kamat then said whether could wearing of this additional dress (hijab) be restricted on the basis of Article 19? Justice Gupta noted that the problem here is one particular community is insisting on a head

scarf while other communities are following the dress code. He added that students of other communities are not saying that they want to wear this and that.


Questioning the Karnataka government's GO, Kamat said there has to be reasonable accommodation for the students trying to exercise her fundamental rights under Article 19, 21, and 25 of the Constitution, and hijab does not cresaid if a girl chooses to wear a hijab, can the state prohibit this? The bench replied: "No one is prohibiting her to wear the hijab... but only in school." When Kamat cited foreign judgments from the US and South Africa, Justice Gupta said "come to India", adding that no other country has diversity like India.

During the hearing, it was argued that the South African court had held that asking the girl to remove nose ring even for a short period would send out the message that she and her religion were not welcome. Justice Gupta said that the nose pin is not a religious symbol and women wear earrings all over the world, but it is no religious practice.

The bench said South Africa does not have a diverse population like India and scheduled the matter for further hearing Thursday.

The top court was hearing a clutch of petitions against the Karnataka High Court judgment, which upheld the right of educational institutions to ban wearing of hijab in pre-university colleges in the state.



# Racket running in country on pretext of bonded labour: SC

New Delhi, Sept 7: The Supreme Court Wednesday said there are no bonded labourers in the country and that a racket is running on the "pretext" of bonded labour.

A bench of Justices Hemant Gupta and Sudhanshu Dhulia made the observation while hearing a plea by late social activist Swami Agnivesh on behalf of a woman

worker who was allegedly subjected to repeated rape by an associate of brick kiln contractor in

RS Pura sub-division of Jammu. "Do you know who are bonded labourers? They are not bonded. They take the money and come there and are engaged by brick kilns. They come from backward areas. They take the money and eat the money and then resign. This is a racket in the country.

These labourers only take advantage of this bonded labourer thing, the bench observed. The lawyer appearing for Jammu and Kashmir told the bench that an FIR was registered in the case and investigation was initiated. However, the victim went untraceable leading to closure of the case in 2018. According to the petition filed in 2012, after the woman and her husband expressed their wish to return to their native state

in June, the contractor refused to relieve them unless they paid him Rs 3 lakh. Though the husband managed to escape from the camp, his wife and child were kept under illegal confinement. During the illegal confinement, she was repeatedly raped by the contractor and others, it was alleged. The victim and her son had subsequently shifted to a rehabilitation home at the intervention of an NGO and police, it was claimed.

# Cracker ban not enough, action needed: Environmentalists

New Delhi, Sept 7: Episodic events such as firecracker bursting make the air worse for breathing, but there are other more significant sources for the deteriorating air quality all around the year, environmentalists said after the Delhi government announced a ban on the production, sale and use of all types of firecrackers in the city till January 1.

Greenpeace India's Avinash Chanchal said stricter regulatory action is required, along with better designed and implemented awareness campaigns, to enforce the existing plans and strengthen those. "There is no doubt that bursting of firecrackers makes

the air worse for breathing and needs strict and urgent actions to reduce the prevailing air pollution levels. But there are other more significant sources such as pollution from transport, industries, construction and thermal power plants that are responsible for collectively deteriorating the air quality all around the year," Chanchal told PTI.

According to data from the Central Pollution Control Board (CPCB). Delhi recorded its poorest post-Diwali air quality in five years in November 2021, with a deadly cocktail of noxious fumes from firecrackers and stubble burning pushing the 24-hour average Air Quality Index (AQI) to the "severe" category (462).



Residents had flouted the ban on firecrackers to celebrate Diwali and emissions from farm fires in the region had peaked

at 36 per cent. Environmentalist Bhavreen Kandhari said the ban on the production, sale and use of firecrackers should be in force throughout the year.



All embassy staff, including diplomatic and security personnel, were ordered to leave Albania within 24 hours. On July 15. a cyberattack temporarily shut down numerous Albanian government digital services and websites.

# China quake toll reaches 74

Beijing: The total number of people killed after a 6.8magnitude earthquake jolted Luding county in China's Sichuan province has increased to 74, while 26 remain unaccounted for, local authorities said Wednesday. The rescue headquarters of the Ganzi Tibetan Autonomous Prefecture, the worst-hit area, said 40 were killed, 14 were missing and 170 were injured, reports Xinhua news agency. In the city of Ya'an, 34 were dead, 12 remained missing and 89 were injured as of late Tuesday, said the city's emergency management bureau. The earthquake struck Monday.

### 23 killed, 11 hurt in bar fire

Hanoi: The death count from a fire that tore through a karaoke bar in southern Vietnam has risen to 23, an official said Wednesday. The blaze engulfed the second floor of the building Tuesday night, trapping customers and staff as dense smoke filled the staircase and blocked the emergency exit, reports said.

# 'Russia gaining from Ukraine war'

Vladivostok, Sept 7: President Vladimir Putin said Wednesday that Russia had gained, not lost, from the conflict in Ukraine because it was embarking on a new sovereign path that would restore its global clout.

Putin increasingly casts the conflict in Ukraine, which he calls a "special military operation", as a turning point in history when Russia finally threw off the humiliations which accompanied the 1991 fall of the Soviet Union.

In an attempt to underscore Russia's tilt towards Asia, Putin, speaking to the Eastern Economic Forum in the Russian Pacific city of Vladivostok, said that the West was failing while Asia was the future.

In his main speech, Putin hardly mentioned Ukraine beyond a reference to grain exports. But when asked by a moderator if anything had been lost from the conflict, Putin said Russia had gained and would emerge renewed.

'We have not lost anything and will not lose anything," said Putin. Russia's paramount leader since 1999. "Everything that is unnecessary, harmful and everything that prevents us from moving forward will be rejected."

'In terms of what we have gained, I can say that the main gain has been the strengthening of our sovereignty, and this is the inevitable result of what is happening now," Putin said. "This will ultimately strengthen our coun-

try from within." He did, though, acknowledge

that the conflict had unleashed "a certain polarisation" in both the world and in Russia.

Russia sent tens of thousands of troops into Ukraine February 24 in what it called a special operation to degrade its southern neighbour's military capabilities and root out people it called dangerous nationalists.

Putin's assessment of Russian gains did not take account of NATO's huge build-up of forces in

eastern Europe and its planned admission of Sweden and Finland as members. Preventing NATO expansion was one of his stated objectives for intervening in Ukraine.

He also brushed aside the impact of sanctions that have starved Russian industry of key components like microchips, cut Russians off from international payment systems and led to the departure of thousands of Western companies.

The economy would contract by "around 2% or a little more" this year and the budget would be in surplus, he said.

Putin, who turns 70 in October, told the West in July he was just getting started in Ukraine and dared the United States - which enjoys economic and conventional military superiority over Russia - to try to defeat Moscow. It would, he said, fail. WESTERN 'FEVER'

Putin, though, said that the West was failing because a futile and aggressive attempt to isolate Russia with sanctions was destroying the global economy just as Asia was rising to claim the future.

Putin said that China would pay Gazprom for its gas in national currencies, based on a 50-50 split between the Russian rouble and Chinese yuan. The United States and its allies imposed the most severe sanctions in modern history on Russia for its actions in Ukraine.

# Liz appoints Britain's most diverse Cabinet

London, Sept 7: Prime Minister Liz Truss held her first Cabinet meeting at 10 Downing Street Wednesday after unveiling one of the UK's most diverse Cabinets at a "vital time" for the country, with key frontline posts going to ethnic minority MPs, including Indianorigin Suella Braverman as the Home Secretary.

Truss' complete shake-up of the old guard under predecessor Boris Johnson saw her flanked by several new faces and ethnic minority members of Parliament on the Conservative government front bench in Parliament, including Braverman, Ghanaian-origin Kwasi Kwarteng as the UK's first black Chancellor and mixed Sierra Leone and white heritage James Cleverly as the Foreign Secretary.

After what has been dubbed a purge of her leadership campaign critics and rival Rishi Sunak supporters, only a few incumbent ministers hold on to their portfolios – including Agra-born Alok Sharma, who retains his climate action job as COP26 President, and Ben Wallace who remains Defence Secretary.

London-born junior minister Ranil Javawardena, of mixed Sri Lankan and Indian heritage, has been promoted as Secretary of State for Environment, Food and

Many senior Tories who had backed Truss' rival, British Indian former finance minister Sunak, find themselves without a job including former justice secretary Dominic Raab, transport secretary Grant Shapps and health secretary Steve Barclay. The wife of armed forces veterans affairs minister, Johnny Mercer, took to Twitter in anger after her husband was unceremoniously sacked.

Instead, Truss has packed the top tier of her Cabinet with close allies, such as Therese Coffey as Deputy Prime Minister and Secretary of State for Health and Social Care and Wendy Morton as the Parliamentary Secretary to the Treasury and the first Tory female Chief Whip in charge of party discipline.

Former Tory leadership contender, Kemi Badenoch, is the new International Trade Secretary, with incumbent Anne-Marie Trevelyan shifted as Transport Secretary.

# reaffirm response to N Korea threat

Tokyo, Sept 7: Diplomats from the United States, Japan and South Korea reaffirmed their commitment Wednesday to working together in response to any threat from North Korea, including a possible new nuclear test.

The three senior diplomats in charge of North Korean affairs also underscored their efforts to strengthen their security partnership. Japan and South Korea acknowledge their need to improve bilateral and trilateral cooperation. Relations between Japan and South Korea have been badly damaged by historical disputes over Japan's colonization of the Korean Peninsula.

Takehiro Funakoshi, directorgeneral of the Asian and Oceanian Affairs Bureau of Japan's Foreign Ministry, said the focus of the trilateral cooperation is North Korea and its accelerating nuclear and missile development.

Funakoshi said he and his US and South Korean counterparts, Sung Kim and Kim Gunn, were to discuss their countries' responses to North Korea as they work together to enhance regional deterrence amid "a looming possibility of further provocations including another nuclear test.

North Korea last conducted a nuclear test, its sixth, in 2017, and experts have noted signs of preparations for another test

# Brazil fines Apple \$2.4 million for selling iPhones sans charger

Apple has been under investigation in Brazil since December for "the sale of an incomplete product."

Brasilia, Sept 7: Apple has been barred from selling iPhones without a charger in Brazil and fined more than \$2 million over the issue, the government said Tuesday, after accusing the US tech giant of "discriminatory practices."

In an official notice, Brazilian authorities ordered "the immediate suspension of the distribution of iPhone brand smartphones, regardless of model or generation. that are not accompanied by a bat-



The Ministry of Justice and Public Security ordered the California-based company to pay a fine of 12.28 million reais (nearly \$2.4 million). The measure from

the Department of Consumer Protection and Defense effectively prohibits the sale of all iPhone 12 and 13 models.

The company has faced fines from Brazilian state agencies before, but "did not take any measures to minimize the harm and until now continued to sell the cellular devices without chargers," according to an official statement.

According to Brazilian authorities, Apple alleges that the decision to exclude chargers from iPhone sales comes from an "environmental commitment.

But the ministry determined "there is no effective demonstration of environmental protection on Brazilian soil as a consequence" of Apple's policy, and accused the company of "deliberate discriminatory

practices against consumers.' "There is no justification for an operation which, in aiming to reduce carbon emissions, leads to the introduction into the consumer market of a product whose use depends on the acquisition of another (product) which is also marketed by the company," the official notice added

# Gulf Arab nations ask Netflix to remove 'offensive' videos

**Dubai, Sept 7:** Gulf Arab countries

Tuesday asked Netflix to remove "offensive content" on the streaming service, apparently targeting programmes that show people who are gay and lesbian.

A joint statement issued on behalf of a committee of the Gulf Cooperation Council made the request, saying the unspecified programmes "contradict Islamic and societal values and principles."

Saudi Arabia and the United Arab Emirates each published the statement via their respective governments as well. They, along with Bahrain, Kuwait, Oman and Qatar, make up the six-nation council.

While the statement didn't elaborate. Saudi state television also aired video of an interview it conducted with a woman identified



as a "behavioural consultant" who described Netflix as being an "of-

ficial sponsor of homosexuality.' It aired footage at the same time of a cartoon, "Jurassic World: Camp Cretaceous," in which two women kissed, though the footage was blurred out.

Saudi state television also aired a segment suggesting Netflix could be banned in the kingdom over that programming reaching children.

The move comes after countries in the Muslim world in June banned the public showing of Disney's latest animated film "Lightyear" over a brief moment showing two lesbian characters kissing.

After that, the company's Disney+ streaming service said its "content available should align with local regulatory requirements'

in Gulf Arab countries. Many Muslims consider gays and lesbians to be sinful. In some parts of the Arab world, members of the LGBTQ community have been arrested and sentenced to prison. Some countries even main-

tain the death penalty.

The move also comes as regional streaming services try to eat into Netflix's revenue, including the Shahid service operated by the Saudi-owned MBC Group.

The Saudi government is believed to hold a controlling stake in MBC Group after a series of arrests in 2017 ordered by Crown Prince Mohammed bin Salman over corruption allegations that saw him centralise power in the kingdom.

Netflix has limited content previously in Saudi Arabia.

In 2019, activists blasted the streaming service for pulling an episode of comedian Hasan Minhaj's "Patriot Act" that criticised Prince Mohammed over the killing and dismemberment of Washington Post journalist Jamal Khashoggi, as well as thekingdom's involvement in the war in Yemen.



### Oil plummets to 7-month low

Singapore: Oil prices fell more than \$1 Wednesday to their lowest since before Russia invaded Ukraine as Covid-19 curbs in top crude importer China and expectations of more interest rate hikes spurred worries of a global economic recession and lower fuel demand. Brent crude futures fell \$1.35, or 1.5%, to \$91.48 a barrel by 0420 GMT after slipping 3% in the previous session. The contract hit a session low of \$91.35, the lowest since February 18. US West Texas Intermediate crude futures shed \$1.55, or 1.8%, to \$85.33. The benchmark fell to a session low of \$85.17, the lowest since January 26.

### Adani to build 3 giga factories

New Delhi: Asia's richest man Gautam Adani Wednesday said his ports-to-power conglomerate will build three giga factories for manufacturing solar modules, wind turbines, and hydrogen electrolyzers as part of a \$70 billion investment in clean energy by 2030. Adani group is stepping up investments across the green energy value chain as it aims to become the world's top renewable energy producer by 2030. "The Adani Group has already committed \$70 hillion. This will see us building three giga factories in India leading to one of the world's most integrated green energy value chains," he said after receiving the USIBC Global Leadership Award here.

# US' \$50bn chip plan to counter China

Washington: The Biden administration has announced it will invest \$50 billion in building up the domestic semiconductor industry to counter dependency on China, as the US produces zero and consumes 25 per cent of the world's leading-edge chips vital for its national security. President Joe Biden last month signed a \$280 billion CHIPS bill to boost domestic high-tech manufacturing, part of his administration's push to boost US competitiveness over China.

### China's export sinks, imports fall in Aug

Beijing: China's export growth weakened in August and imports shrank as high energy prices, inflation and anti-virus restrictions weighed on global and Chinese consumer demand. Exports rose 7% over a year ago to \$314.9 billion, barely one-third of July's 18% expansion, customs data showed Wednesday. Imports contracted by 0.2% to \$235.5 billion, compared with the previous month's already weak 2.3% growth.

# **Govt okays long-term** leasing of railway land

The new policy will help in attracting more cargo to railways, increase railways' modal share in freight transportation thereby reducing cost of logistics of the industry and thus generate more revenue, the railways said

New Delhi, Sept 7: The Union Cabinet Wednesday approved a policy for long-term leasing of railway land for the PM Gati Shakti programme, which the government said will help set up 300 cargo terminals and generate 1.25 lakh jobs.

The new policy will help provide land lease for a longer period of up to 35 years as against five years at present, Union Minister Anurag Thakur told the media after the cabinet meeting.

With an employment generation potential of about 1.25 lakh jobs, the policy will also bring more revenue to the Railways; 300 cargo terminals will be developed in five

The new policy will enable the integrated development of infrastructure and more cargo terminals. It has also cut down land lease fee from 6 percent to 1.5 percent, the railways said in a statement.

The proposed changes will pave way for privatisation of the Container Corporation of India (Concor) because it will help strategic buyers pay much less amounts as land rentals to railways for a longer period, officials explained. This was one of the key suggestions put forward by the investment advisors of Concor.

The development is believed to be in line with NITI Aayog's recommendation to keep railway land leasing fee for containers below 3 per cent.

Concor, under the aegis of the railway ministry, is engaged in transportation and handling of con-

Additionally, the policy will also enable use of railway land at nominal cost for setting up of solar plants on railway land.

The policy also encourages development of social infrastructure (such as hospitals through PPP and schools through Kendriya Vidyalaya Sangthan) on railway land at a nominal annual fee of Re 1 per sq m per annum. The statement added.

# **RBI** puts out 'Alert List' of illegal forex trading entities

Mumbai, Sept 7: The Reserve Bank Wednesday came out with an 'Alert List' containing the names of 34 entities, including OctaFX, Alpari, HotForex, and Olymp Trade, that are not authorised to deal in forex and operate electronic trading platforms in the country.

In a statement, the Reserve Bank of India (RBI) said that resident persons can undertake forex transactions only with authorised persons and for permitted purposes, in terms of the FEMA.

Resident persons undertaking forex transactions for purposes other than those permitted under the FEMA or on electronic trading platforms (ETPs) not authorised by the RBI shall render themselves liable for legal action under the

The central bank said it has been receiving references seeking clarification on the authorisation status of some ETPs.

"It has, therefore, been decided to place on the RBI website an 'Alert List' of entities which are neither authorised to deal in forex under the Foreign Exchange Management Act, 1999 (FEMA) nor authorised to operate electronic trading platforms for forex transactions," it said.

The Alert List contains names of entities which are neither authorised to deal in forex nor authorised to ETP for forex transactions under the Electronic Trading Platforms (Reserve Bank) Directions, 2018.

Some of the other names in the Alert List include Forex4money, eToro, FXCM, NTS Forex Trading, Urban Forex, and XM.

The RBI further said the list is not exhaustive and is based on what was known to it at the time of publication.

"An entity not appearing in the list should not be assumed to be authorised by the RBI," the central

"If the current account deficit indeed rises to \$140 billion, the overall BOP (balance of payment) deficit could be as large as \$80 billion for FY23, as we are forecasting a capital account surplus of about \$60

billion," said Kaushik Das, chief economist, India and South Asia, Deutsche Bank.

Accounting for a decline in reserves due to changes in valuation, the deficit in the current fiscal could be as large \$100 billion-\$105 billion. Das said.

India's spot forex reserves fell to \$561 billion by end-August from \$607 in end-March, while net forwards outstanding likely declined to \$17 billion from \$66 billion, implying a drawdown of \$49 billion, Das estimated.

The overall forex reserves, including spot rupee and forwards, stood at of \$578 billion at the end of August and is likely to fall to below \$550 by the end of this fiscal vear. Das said.

He highlighted a speech by Reserve Bank of India Governor Shaktikanta Das earlier this week that said the central bank would aim to anchor expectations around the depreciating rupee and intervene to prevent an overshoot.

We have shown that in the past couple of months that we were able to bring it to a manageable level," she said at the event.

According to official data, retail inflation softened to 6.71 per cent in July due to moderation in food prices but remained above the Reserve Bank's comfort level of 6 per cent for the seventh consecutive month. The Consumer Price Index-based retail inflation was at 7.01 per cent in June.

She exuded confidence that the Reserve Bank would manage the volatility emerging from the aggressive rate hike stance by the US Fed and the European Central Bank.

Referring to the global energy crisis triggered by the ongoing Russia-Ukraine war, she said, uncertainty over the availability of crude, and natural gas continues.

"The Department of Consumer Affairs is coming out with guidelines on social media influencers. It is creating dos and don'ts for them," an official source said.

Sources said social media influencers, who have large followers on social media platforms like Instagram, are endorsing products after taking payments from the brands.

As per the proposed guidelines. if social media influencers endorse any brand after taking money, they will have to declare their association

with that brand, sources said. Social media influencers will need to put disclaimers in such endorsement posts, they added.

Paris, Sept 7: Kylian Mbappe and Erling Haaland took their high-flying scoring acts into Europe as the Champions League returned, while last season's standout star Karim Benzema limped off with an injury after less than 30 minutes. Mbappe and Haaland

both netted two goals as their respective clubs PSG and Manchester City began their European campaigns with victories, underlining just why those two teams are again among the favorites for

Real Madrid's chances of defending its crown probably depend largely on having a fully fit Benzema, but the France forward had to come off with an apparent knee injury in the 30th minute against Celtic. Second-half goals from Vinicius Junior, Luka Modric and Eden Hazard still secured a 3-0 win for the Spanish giant in Glasgow.

> Benzema was in a league of his own in the competition last season, netting 15 goals in 12 games to lead Madrid to the title. But Mbappe and Haaland look ready to challenge the Frenchman for the status of Europe's top striker as they

sive first Champions League title. The 23-year-old Mbappe, who has seven goals in five league games so far, scored his double in the first

22 minutes of a 2-1 home win over Juventus to become the youngest player to reach 35 goals in the competition — beating the mark held by teammate Lionel Messi. The 22-year-old Haaland has 25 goals in 20 Champions League

games — also a record — after scoring once in each half of Man City's 4-0 win at Sevilla. The Norway striker, who has 10 goals in six Premier League games this season, has now netted on his Champions League debut for three clubs — Salzburg, Borussia Dortmund and City.

Also, Dinamo Zagreb upset Chelsea 1-0 at home while Serie A champion AC Milan was held to a 1-1 draw at Salzburg.

Mbappe's opening goal for PSG came after just five minutes following some audacious link-up play from Neymar. The second came after he exchanged passes with Achraf Hakimi and beat Perin with another first-time finish. United States midfielder Weston McKennie pulled one back for Juventus in the 53rd, creating a tense finale in Paris.

Haaland could well be the piece that Man City has been missing as it repeatedly came up short in Europe under Pep Guardiola.
