12 killed, 29 injured in J&K bus accident




JAMMU: Twelve people, including four women, died and 29 more were injured when an overcrowded minibus plunged into a deep gorge in Jammu and Kashmir's Poonch district Wednesday, officials said here. The bus was on its way to Poonch from Gali Maidan when it met with the accident around 8.30am. The officials said a joint rescue operation by the Army, police and local villagers were immediately launched. The condition of six among the 29 injured was stated to be critical. J&K LG Manoj Sinha announced ₹5 lakh exgratia for the kin of the deceased while PM Narendra Modi announced financial aid of ₹2 lakh for the families of the deceased. P7

### **Cabinet nod to revise** ST list of 3 states



**NEW DELHI:** The Union Cabinet, chaired by Prime Minister Narendra Modi, approved Wednesday a Constitution Amendment Bill which seeks to grant tribal status to the Hatti community living in the Trans-Giri region of Himachal Pradesh's Sirmaur district. Addressing the media, Union Tribal Affairs Minister Arjun Munda said the Cabinet has also approved proposals to grant Scheduled Tribes (ST) status to the Binjhia community in Chhattisgarh and the Narikoravan and Kurivikkaran communities in Tamil Nadu. After this amendment, approximately 1.6 lakh members of the Hatti community will be able to derive benefits meant for STs under the existing government schemes. **P7** 



little for critical patients requiring the facility," said a hospital offi-

cial requesting anonymity. According to Odisha government records, the healthcare facility has doctors and other staff needed for the 200 beds. However, the large number of patients poses a serious problem for the existing infrastructure, including beds and doctors. They find it very difficult

to cater to the needs of the patients. Sishu Bhawan superintendent Gyanendra Nath Behera said, "Apart from the 200 beds approved by the state government, we have been offering patient care at 216 functional beds as allowed by the Directorate of Medical Education

and Training (DMET)."

On the ICU beds, Behera said they have decided to use the additional 14 ICU beds, which were reserved for Covid-19 patients, for all. It will definitely help reduce the burden on the existing ICU beds. The superintendent further said that the new building, which is yet to be handed over to them, will go a long way to address the bed crunch.

Sources said that apart from Odisha, patients from Bihar, Jharkhand and Chhattisgarh also visit Sishu Bhawan on a regular basis. Considering the inflow, the Odisha government had initiated the construction of a multi-utility hospital complex on 23,912 square metres of land at an expenditure of ₹117 crore in 2019.

The construction began the same vear and the constructing company had agreed to hand the building over to the Health department by February 2021. However, till now the building is yet to start functioning leading to problems for many patients who visit Sishu Bhawan. Sources said the building will be ready by October.

### 8 Congress MLAs join BJP in Goa PRESS TRUST OF INDIA

Panaji, Sept 14: Eight Congress MLAs in Goa, including former Chief Minister Digambar Kamat, joined Wednesday the ruling BJP. It was a body blow to the opposition party which now is left with just three MLAs in the 40-member Goa Assembly.

In a similar move in July 2019, 10 Congress MLAs had switched over to the BJP. The BJP retained power in the coastal state after the Assembly elections in March. The eight Congress MLAs who defected to the BJP are Kamat, Michael Lobo, Delilah Lobo, Rajesh Phaldesai, Kedar Naik, Sankalp Amonkar, Aleixo Sequeira and Rudolf Fernandes. With the new joinings, the BJP's strength in the Goa Assembly has gone up to 28. The three other MLAs who did not defect are Yuri Alemao, Altone D'Costa and Carlos Alvares Ferreira.

Goa CM Pramod Sawant told reporters that no decision has been taken yet on a Cabinet reshuffle. "The 'Congress Chhodo Yatra' (leave Congress movement) has begun from Goa, as seen from the influx of that party's legislators into the BJP," Sawant told reporters. "With today's development, the BJP now enjoys the support of 33 MLAs in the


### POLICE BUST INTER-STATE SIM CARD RACKET; 6 HELD

London, Sept 14: He had not been as much in the limelight as he is now after the demise of Queen Elizabeth II. Everything about King Charles III is now under media glare and more and more quirky facts about him are emerging, facts that are really hilarious.

Since he ascended the throne, people want to know everything about Charles from what he eats and does in his free time to what music he likes. The New York Post quoting Royal staff has revealed some of King Charles III's quirky habits including 'carrying his own toilet seat and Kleenex Velvet toilet paper wherever he goes'

Paul Burrell, who served as a butler to Charles' late wife Princess Diana and also the Queen, has been quoted as saying in the report that Charles has given precise instructions to iron his shoelaces.

He'd have homemade bread, a bowl of fresh fruit, fresh fruit juices. He will strictly avoid all oily stuff," Newbould said.

He has six different types of honey, some special mueslis, his dried fruit, and anything that's a bit special that he is a bit fussy about. One person is given charge of the box and the responsibility of replenishing the items that are used," Newbould added.







# OHRC asks Malkangiri DM to pay ₹5 lakh aid

Bhubaneswar, Sept 14: The Odisha Human Rights Commission (OHRC) has directed the Malkangiri Collector and District Magistrate (DM) to pay ₹5 lakh as compensation within two months to the next of kin of Soma Kabasi, who died in police custody in 2017, an official said Wednesday.

The commission gave the direction after hearing separate pleas filed by rights activists Biswapriya Kanungo, Akhand and Bijay Panda. They informed the OHRC that Mathili police in Malkangiri had arrested Kabasi, a resident of Jandraguda village, and a few others for their alleged involvement in Maoist activities in the locality. They were kept at Malkangiri police barrack.

### **CUSTODIAL DEATH**

Quoting the police version, the activists said that Kabasi was about to be taken to the court when he sought the cops permission to attend nature's call at the washroom on the police barrack premises December 27, 2017.

"As he did not return for a long, the cops broke open the door to find a lifeless Kabasi hanging from the washroom grille with a towel," the petitioners said, adding that he was rushed to a nearby state-run healthcare facility, where the doctors declared him 'dead on arrival'.

The activists said that it is the duty of the State to ensure safety of the accused in custody. However, it failed to ensure it. ture which prompted Kabasi to end his life," the petitioners claimed, demanding stringent action against those responsible for the incident

Taking cognisance of the complaints, the OHRC sought details of the incident from Malkangiri SP and South-Western Range DIG.

Quoting the magistrate's enquiry report, the SP had informed the OHRC that it was a clear case of suicide.

The DIG also claimed that it was a case of suicide, but raised questions on the construction, including the height of the grille, of the washroom.

The OHRC observed that whatever may be the reasonsecurity lapse or faulty design of the washroom - it is a fact that Kabasi died in custody.

### TEACHER CRUNCH HITS 40 KEONJHAR SCHOOLS

POST NEWS NETWORK

Keonjhar, Sept 14: More than 5.000 students studying in 40 fully-aided schools in this district are facing a bleak future due to lack of adequate number of teachers, sources said. Most of these schools have

two to three teachers while the required number is much more. Many teachers have retired, but no fresh appointment has been made in their places

Studies in most of these schools have come to a halt due to lack of teachers in subjects like Science, Hindi and Physical Education. Students who can afford private tuitions are opting for it, but those from poor financial backgrounds

stare at an uncertain future. The government-aided SMR High School under Sadar block is a case in point. Over 150 students study in this school which is managed by only two teachers. Many posts are lying va-



pointments being made. The school has seven sanctioned teacher posts and five office staff including a clerk, peon and a watchman. However, only two teachers are working in the educational institution. School managing committee president Akshaya Kumar Moharana recently wrote to the district education officer (DEO) asking for the appointment of an IT teacher.

Similarly, there are only four teachers in Lakshmipata High School at Teronti, three teachers each in Khetramohan Vidyapitha at Salapada, GPM High School at Daradaipala, Palashpala High School in Revana and Brahmeswar High School at Khuntapada re-

spectively. Classroom teaching has gone for a toss due to paucity of teachers.

Parents alleged that while the state government is spending a lot in making classroom teaching attractive and upgrading the schools for betterment of students, fullyaided educational institutions are being overlooked and being given a short shrift.

Retired headmaster Ramesh Chandra Hota blamed the lack of fresh appointments for such a precarious situation in 40 such schools.

When contacted, district education officer (DEO) Purnachandra Sethi said that the government has no provisions to fill the teachers' posts in fully-aided schools. New appointments will be made only if the government makes the requisite rule. Sethi added that the government is being apprised of the vacancies in these schools and their problems regularly.

Odisha has more than 68,000 schools and about 82,000 children with special needs are enrolled in these schools but they need special trained teachers to teach them which is in dire

shortage today. Special teachers in general schools. The Supreme Court (SC) of India, in a judgment passed October 28, 2021, ordered the appointment of at least one special teacher in each general school in every state and union territory of India. In this order, it was mentioned that each state will sub-

SC within six month. Again, dated 21/07/2022, the SC has accepted separate norms for special educators, who alone can impart education and training to children with special needs in general schools as recommended by Rehabilitation Council of India (RCI).

Odisha Special Educator Federation for Divvang (OSEFD). an association always striving to develop the education of disabled students, is making a strong demand to the state government and Chief Minister to appoint special trained teachers in the general schools. If this appointment is made, the students with disabilities will not be deprived of education and more than 6000 special teachers will benefit.

Security and Empowerment of Persons with Disabilities (SSEPD), government of Odisha has mentioned in his affidavit that Diploma in Special Education, B.Ed in Special Education & M.Ed in Special Education teacher trainees who have registered with Rehabilitation Council of India (RCI) are being recruited as Sikhya Sahayaka/ Junior teachers/ Junior teacher Contractual in General

OSEFD said there are about 6000 unemployed people available who have completed two years' special education course from 62 special education training institutes with Rehabilitation Council of India (RCI) registration. But they are sitting at home without employment.

# Going green will be expensive is 'just wrong': Study

ast transition to clean energy is "cheaper than slow or no transition" and the idea that going green will be expensive is 'just wrong', a new Oxford study has

According to a study by Oxford University researchers, transition to a decarbonised energy system by around 2050 is expected to "save the world at least 12 trillion dollars" as against a scenario where we continue to use fossil fuel energy at the current levels.

"Rapid transition to clean energy results in lower energy system costs than a fossil fuel system, while providing more energy to the global economy and expanding energy access to more people around the world," the study said.

The study's 'Fast Transition' scenario has shown a "realistic" possible future for a fossil-free energy system by around 2050, providing 55 per cent more energy services globally than today by ramping up solar, wind, batteries, electric vehicles, and other clean fuels such as green hydrogen (made from renewable electricity).

"Past models predicting high costs for transition to zero carbon energy have deterred companies from investing, and made governments nervous about setting policies.

"But clean energy costs have fallen sharply over the last decade, much faster than those models expected," Rupert Way, a postdoctoral researcher at the Smith School of Enterprise and the Environment, said. For the study, the researchers analysed thousands of transition cost scenarios produced by major energy models and used data on 45 years of solar energy costs, 37 years of wind energy costs, and 25

years for battery storage. They found that the real cost of solar energy "dropped twice as fast as the most ambitious projections" in these models, revealing that over the last 20 years "previous models badly overestimated the future costs of key clean energy technologies".

Doyne Farmer, who led the team

- but that's just wrong.' The study showed that the costs for key storage technologies such as batteries and hydrogen electrolysis are also "likely to fall dramatically"

Meanwhile, the costs of nuclear energy have consistently increased over the last five decades, making it highly unlikely to be cost competitive. "The world is facing a simultaneous inflation, national security and climate crisis, all caused by our dependence on high cost. insecure, polluting, fossil fuels with

volatile prices. "This study shows that ambitious policies to accelerate the transition to a clean energy future as quickly as possible are not only ur-

gently needed for climate reasons, but can save the world trillions in future energy costs," Farmer said.

Since Russia's invasion of Ukraine, the costs of fossil energy have skyrocketed, causing inflation around the world.

The study, conducted before the current crisis, has taken account of such fluctuations using over a century's worth of fossil fuel price data. The current energy crisis underscores the study's findings and demonstrates the risks of continued reliance on fossil fuels.

According to the research, the response to the crisis should include accelerating the transition to low cost, clean energy as soon as pos

The research is a collaboration between the Institute for New Economic Thinking at the Oxford Martin School, the Oxford Martin Programme on the Post-Carbon Transition, and the Smith School of Enterprise & Environment at the University of Oxford, and SoDa Labs at Monash University.

and reptiles. Fishermen used the place to prepare dry fish. A dispute occurred between the Kanika royal estate and Kujang royal estate over the ownership of the area in 1920.

However, after the area was identified as a nursery of rare Olive Ridley turtles, the state government declared it as Gahirmatha marine sanctuary in 1997. The society members undertook a cleanliness drive at Agarnasi island, January 29, 2021. They discovered that the island has been reduced to a length of 700 metre and 200 metre width.

Environmentalist Hemant Kumar Rout said that constant battering of sea waves in the area has intensified after the establishment of Paradip Port. A geo-synthetic tube wall was constructed to save the Pentha village from extinction. However, no such step was taken to save the Agarnasi island which was in the middle of the sea. The island was soon washed away into the sea after being regularly

battered by waves and high tides.

The Gahirmatha marine sanctuarv is famous as the nursery of rare Olive Ridley turtles. Lakhs of turtles travel for over thousands of miles in the sea to reach this place for mating and laving eggs.

The turtles meet at Agarnasi island, Nasi-1, Nasi-2, Madali and other places during their breeding period. Coastal erosion has destroyed this

Recently, the original temple of Devi Panchubarahi in Satabhaya has been gobbled up by the sea.

The extinction of Agarnasi island has aggravated the threat to Suniti, Lanjura, Havelikhati, Barunei, Jambu, Hukitola island and Babar panchavats as these areas are now vulnerable to the sea waves.

Educationist Khitish Kumar Singh said he attended a conference on climate change organised by an outfit 'Prayas' in Bhubaneswar, September 10. Attending this conference. Union Environment Minister Bhupendra Yadav, his deputy Abani Kumar Choubey and state Environment Minister Pradeep Kumar Amat heaped praises on the forest department and state government for the turtle protection initiatives at Gahirmatha. However, many researchers presenting their reports warned that the coastal erosion will only intensify in Gahirmatha in coming days.

When contacted, forest ranger Manas Das spoke on various steps the forest department had taken for protection of the Agarnasi island.

A profusely bleeding Purnachandra was rushed to MKCG Medical College and Hospital here where doctors pronounced him dead on arrival. Acting on a complaint lodged by

# 2 suspects detained in Sonepur

Sonepur, Sept 14: A day after the decomposed carcass of a leopard was found in Chandili reserve forest near Baghapali village under Ullunda Forest range in Subarnapur district, forest officials have intensified their investigation into it and detained two suspects, Wednesday.

It was suspected that the leopard might have died after falling into a trap laid by poachers in the forest. The big cat is believed to have died four days ago. The poachers took away all the claws.

Assistant conservator of forests Prafulla Kumar Dharua, Ullunda forest ranger Dilip Kumar Pradhan and Sonepur ranger Manoranjan Bagh were at the site Wednesday.

Reports said, some goat herders had first seen the carcass and informed the forest department. Subsequently, forest officials reached the spot and initiated a probe into the incident.



It is suspected that some poachers killed it and took away its claws. The forest has allegedly turned into a poachers' haven with live wires being used to kill wild animals at night. A few weeks ago, a resident of Baghapali had died after coming in contact with live wires laid in the forest.

# **Energy Awakening**

The late Nobel laureate chemist Richard Smalley was once asked to rank global challenges in order of urgency. While citing the usual concerns about poverty, hunger, conflict, and resource access, he put energy security at the top of his list. Smalley argued that all other challenges have the potential to be resolved if we can ensure reliable energy supplies.

Today, with even G7 countries experiencing the cascading effects of energy insecurity on their economies and democratic institutions, the world is learning the hard way that Smalley was right. We have limited means of international governance or science-based decision-making regarding energy security. Let us hope, therefore, that the rude awakening provided by the current global economic crisis and the war in Ukraine will lead to more constructive international action and sensible domestic energy policies.

One indication that it will came on July 6, when the European Parliament voted to continue classifying nuclear energy and natural gas as "environmentally sustainable economic activities" under the European Union's "taxonomy" regulations. The measure passed by a narrow margin of 328 votes to 278, with 33 abstentions, but the fact that such a vote was even called, and - better still – that common sense prevailed, represents a tectonic shift for Europe's environmental agenda.

The EU's energy policy exemplifies what geographers call the "social amplification of risk." Perhaps most notably, Germany's decision to phase out domestic nuclear power following the 2011 Fukushima accident in Japan ran contrary to the findings of a United Nations expert panel, which has not detected any causal cancer clusters linked to the incident even after ten years of detailed data recording. Japan itself has acted more sensibly, keeping nuclear power online for baseload power generation.

Both within the G7 and elsewhere, misapplication of the "precautionary principle" by forces at both ends of the political spectrum too often trumps the sensible use of science in decision-making. Even Right-wing European politicians are gravitating toward environmental populism, as Serbia's cancellation earlier this year of a lithium mining project demonstrated.

The Serbian government's decision will adversely affect the prospects for renewable energy, because lithium-ion batteries are essential for battery storage in smart grids and

related green infrastructure. In the United States, meanwhile, despite the litany of executive orders on critical minerals, many projects remain beset by environmental conflicts. Even the recently passed Inflation Reduction Act will face barriers to implementation, as environmental groups are already geared up to oppose its mining provisions.

Much of the current battle over climate change reflects a fundamental clash in people's understanding of the relationship between nature and social and political order. While scientists have rightly lamented the fossil-fuel industry's "merchants of doubt," a Utopian view of linear solutions in energy delivery also has contributed to our current impasse. Well-intentioned activists like Greta Thunberg have done a great job raising environmental awareness, but less so when it comes to promoting environmental literacy.

Consider the need for baseload power for energy delivery. Many critics of fossil-fuel subsidies pay scant attention to the fact that only nuclear energy and fossil fuels have the capacity to provide significant power in the absence of massive battery farms for solar and wind or pumped hydropower storage infrastructure.

Environmentalists will need to make concessions to permit the extraction of critical metals for this infrastructure. Recycling itself entails energy demand, and shifting to a circular economy requires us initially to have a large enough stock of material to recycle. This in turn implies the challenge of making products that are more easily recycled. We need to calculate the tradeoff between durability, recyclability, and innovation for new technologies to figure out the optimal timing for what economists call "planned obsolescence."

Given the wide range of technical issues and the persistent tensions with China and Russia. G7 countries will need to emphasize coordination of energy policy. The G7 should first establish a science panel focused on energy security to guide investment in a diversified range of sources. The panel's output should be predicated solely on scientific and engineering constraints rather than on domestic political considerations. National legislation, including eminent-domain regulations, also may be needed to implement the panel's recommendations.

The 2023 G7 summit in Japan – a country that has shown remarkable pragmatism in securing and diversifying its energy – is less than a year away. A working group to develop such a panel should get down to business right away. Solutions regarding both climate-change mitigation and energy security should now be framed by long-term contingency planning for a diversified energy mix that is congruent with fundamental laws of nature, not political expedience. The 'no free lunch' cliché is abundantly true when it comes to meeting energy demand.

Existing mechanisms such as the Energy Charter Treaty, the International Energy Agency, or the International Renewable Energy Agency lack the requisite mandate and have many members that benefit from the status quo. The G7, by contrast, has the potential to set standards that not only ensure energy security for the world's major advanced economies, but also create a feasible science-based model for other countries to emulate.

### Boondoggle

his typically North American term for an unnecessary or wasteful project is often applied in two specific ways, either to describe work of little or no value done merely to appear busy, or in reference to a governmentfunded project with no purpose other than political patronage. It can also be used for an unnecessary journey by a government official at public expense. Part of its oddity lies in its sudden emergence into public view in an article in the New York Times on 4 April 1935. This had the headline "\$3,187,000 Relief is Spent to Teach Jobless to Play ... Boon Doggles Made". The "boon doggles" of the headline turn out to be small items of leather, rope and canvas, which were being crafted by the jobless during the Great Depression as a form of make-work. The article quoted a person who taught the unemployed to create them that the word was "simply a term applied back in the pioneer days to what we call gadgets today". He suggested that boondoggles had been small items of leatherwork which were made by cowboys on idle days as decorations for their saddles. The word instantly became famous.

# DO DALIT LIVES MATTER?

**RISING CASTE-BASED VIOLENCE IS AN OUTCOME OF THE RESENTMENT OF UPPER CASTES TOWARDS THE DALITS** 

n the 1850s, whenever social activist Savitribai Phule would leave home for the school for girls and lower caste students that she and her husband founded, elite caste residents would fling cow dung and mud at her. So repetitive was this practice that she started carrying a fresh set of clothes to change into on reaching the school. In 1923, the Bombay (now Mumbai) legislative council passed a resolution allowing the socalled lower castes to use public utilities managed and maintained by the government. Following this historic deci-

sion—granting human rights is habitually considered historical in India—in 1924, the Mahad municipal council passed a resolution to build a publicly-managed water tank accessible to the (former) untouchables. But the elite castes would not have it. They launched massive protests against the resolution. After almost three years, in 1927, Dr BR Ambedkar was forced to undertake the Mahad Satyagraha to translate the regulation into practice. When he and his associates tried to draw water from the public pond, the elite caste mobilised its members, who pelted stones at the Satyagrahis.

Why are Dalits subjected to brutal forms of violence, and why is the frequency of such cases rising over the past few years?

In March, Suraj Singh drove his motorbike over 800 km from Surat to Pali, his home district, to stab Jitendrapal Meghwal. What provoked Singh's long, arduous journey? Singh was offended by Meghwal, a Dalit, for he had posted his picture on social media in which he was twisting his moustache and the caption read, "I am not rich, but I am royal at heart." This stabbing is not an isolated incident. Dalits are attacked, stabbed, and lynched for sporting a moustache across the country. Stone-pelting by members of so-called upper castes on Dalit marriage processions in which the groom rides a horse is a typical affair. In February, the wedding

procession of a Dalit IPS officer needed police protection because the members of elite castes had warned him against riding a horse.

Recently in the Jalore district of Rajasthan, nine-year-old Indra Meghwal, a Dalit, was beaten mercilessly by his Rajput teacher for allegedly drinking water from a pot "reserved" for the teacher. After Meghwal died, the police, though still investigating the incident, claimed the beating had nothing to do with the water pot (and, therefore, caste). Even if it did not, what motivated—or compelled—a fully grown man to unleash such a brutal attack on a child that he died?

In pre-modern eras, inequality was considered natural and godgiven, especially by the dominant groups. They did not have to acknowledge equality exists even in the realm of ideas. But things have changed. Today, equality, human rights, and social justice are forces so powerful even those who oppose them must at least pay lip service. But inwardly, they see the with anger at the prospect of losing power and social superiority. The constitutional-legal guarantees of equality and social justice make them feel helpless, and frustration builds up. This is a better explanation than any of what motivated the teacher in Jalore to thrash little Indra.

We see another expression of this long-standing frustration in the diatribes against reservation, in the countless narratives that begin like this: "I know a Dalit family which is rich, but they still enjoy reservation..." Or, "My daughter scored 90% in the entrance exam but was unable to get a seat because someone with a reservation who scored 50% got the seat instead....

The advocates of so-called merit and victims of reservations never question why seats in educational institutions are not expanding to meet growing demand, why jobs are decreasing, or why too few opportunities are available? Instead of the government or the economic system, the blame for failure or disappointment is shifted to historically marginalised peoples, who get accused of robbing caste elites of their prospects.

The 19th-century German philosopher Friedrich Nietzsche introduced the concept of ressentiment to refer to the sense of "hostility directed toward an object

that one identifies as the cause of one's frustration..." The upper caste consciousness in India and white racists in the United States identify themselves as victims of affirmative action. They harbour hostility towards the Dalit-Adivasi and African-Americans, respectively. African-Americans have been attacked over affirmative action numerous times in the United States Prof John Fobanjong, in his 2001 book, "Understanding the Backlash Against Affirmative Action," explains the rise of racist 'skin-head' groups in the United States during the recession of the 1970s and 1980s When double-digit unemployment and out-of-control inflation pushed many into the margins, resentments and stresses among middle to lower-class white families grew Their anger was directed at groups that appeared to be receiving and benefiting from affirmative action.

In India, violence against reservation policy has an indirect manifestation, as the Dalits are attacked for sporting a moustache or riding a horse, i.e., over cultural symbols. But these attacks have an economic angle. In other words, they are not isolated from the immediate questions of economic reservation and egalitarian politics. When they see a Dalit, Adivasi or backward class citizen in better socio-economic conditions, they view it as "theft" of what they consider is "rightfully" theirs. They fail to see it as a state or economic system failure.

Rising caste-based violence is an outcome of the resentment of upper castes towards the Dalits. It reflects their sense of loss of power due to the pursuit of egalitarian social levelling. This thread connects those upper castes who threw mud at Savitribai Phule, pelted stones at Ambedkar, or drove 800 km on a bike to stab an unknown Dalit.

# Societal rehabilitation of prisoners vital

IT'S IMPORTANT THAT A PRISONER SHOULD COME **OUT AS A REFORMED** PERSON. **PREFERABLY** WITH FAMILIARITY **OF SOME SKILLED WORK**  jails and the treatment meted out to prisoners have improved, it is not good enough, rather alarming in some states

It is encouraging to learn the government is contemplating rehabilitating 90% of prisoners in the country, as mentioned recently by Union Home Minister Amit Shah.

Those well-versed with the conditions in jails would put the most common problems ailing these as overcrowding, poor health and sanitation facilities, lack of hygienic food, discrimination and inequalities among prisoners based on their religion and financial status, among others. In fact, states need to think over the issue of overcrowding in prisons, as until overcrowding is not reduced, jail administration cannot be improved. Overcrowding needs to be tackled given there is a rise in crime rate and that the trial and disposal of cases in courts is tardy. Quite often, even without being convicted, the prisoner lives crucial years of his/her life behind bars under mental agony and emotional distress. Even if there is an acquittal, the years spent in jail will never be back.

Along with modernising jails, it is important to equip them with

risons are a requisite unit of technology to make them safe from the criminal justice system the point of view of security and of the country and require to have good living conditions for serious attention. Over decades prisoners. Importantly, the 'modern' while the conditions prevailing in concept of prisons has already given way to these being called 'rehabilitation centres.' But such centres need to be setup in all states. Financial crunch and lack of space are perhaps the biggest impediments to make this a reality. If prisoners can be categorised with emphasis added to the rehabilitation of women and children, the government can plan such centres over a five year plan. Plus, every effort must be made to keep the undertrials, the most affected, in separate jails as they suffer wretched vears while on trial

States need to relook at the model jail manual brought in 2016 replacing the old jail manual. The Home Ministry says that many remedial points have been incorporated in this manual with emphasis for bringing in basic uniformity in human rights, reform and rehabilitation, rules and regulations for prisoners through computerisation.

Delving deeper into the problem, the decline in morality and rise of hatred, violence and jealousy may be attributed to the rise in criminal and other related types of cases. The reduction in such cases calls for education and awareness generation at all levels so that the incidence of crime goes down.

In 2018, the Supreme Court appointed Justice Amitava Roy panel on prison reforms. The committee submitted its report in February 2020 with major recommendations which included that special fasttrack courts be set up to deal with petty offences to reduce overcrowding and every new prisoner be allowed a free phone call a day to his family members to see him through his first week in jail. Perhaps, the Supreme Court needs to pass directions to start the recruitment process against vacancies in courts. Though various organisations

have studied the problems of prisons and recommended laws to improve jail conditions, there is little follow up. In many cases, prisoners come out of jails as hardened criminals instead of reformed wrongdoers willing to join the mainstream. The emphasis on correctional aspect needs to be strengthened through counselling programmes. The mindset of the prison staff has to undergo a fundamental change and the management of prisons must be marked by discipline and due regard to human rights. Prison reform is not just about prison buildings, but what goes on inside them that need to be changed.

One is inclined to refer here to open prisons, which are quite common in the Western world. In such

prisons, there are no bars or no uniforms. Instead of old style cells. there are rooms with beds, neat toilets, kitchen, televisions. Prisoners go for long walks, tend the garden, and more importantly they are paid reasonably for their work. The advantage is that it makes detainees better prepared to return to society. The management cost of such prisons is 33% lower than traditional prisons. In India, some states have studied the concept. Hoshangabad in Madhya Pradesh has one such open prison built on 17 acres, where convicts during the last few years of their sentence are transferred from other prisons in the state to make them

familiar with reformed environs. It would be prudent if the government framed a national policy on prisons and formed a national commission on prisons. The state and judiciary must ensure that prisoners are only deprived of their liberty and shouldn't be exposed to any form of deprivation and the state must fix accountability upon those who fail to ensure the prisoners' safety and dignity in incarceration.

At the same time, from the societal perspective it's important that a prisoner should come out as a reformed person, preferably with familiarity of some skilled work. The effect of prison life should pave the way for his future.

Ahmedabad, Sept 14: The Gujarat Anti Terrorist Squad (ATS) in a joint operation with the Indian Coast Guard seized 40 kg of heroin worth ₹200 crore from a Pakistani fishing boat off the state's coast Wednesday, officials said here.

Six Pakistani crew members on the boat and two Delhi residents who were supposed to receive the contraband were arrested, they said.

The drugs were being smuggled as part of a racket run by two traffickers including a Nigerian national currently lodged in jails in Punjab, said Gujarat Director General of Police (DGP) Ashish Bhatia. The two arrested Indians were identified as Sartaj Malik and Jaggi Singh alias Virpal Singh.

Based on a tip-off received by the ATS, the fishing boat was intercepted in the Arabian Sea by a joint team of Coast Guard and ATS 40 nautical miles off Jakhau harbour in Kutch district, said DGP Bhatia. As much as 40 kg of heroin that was seized, worth nearly ₹200 crore, was meant to be transported to northern states like Delhi and Punjab by road after being offloaded with the help of Malik and Jaggy, he added.

After the Bills becomes Acts, the newly-included communities will be able to derive benefits under in the list of the existing government Scheduled Tribes for the state. He said the demand

was pending for 15 years. In poll-bound Himachal Pradesh, the Hattee community of the Trans-Giri area in Sirmour district will be included in the list of Scheduled Tribes for the state, Munda said, adding that the decision would ben-

efit 1.6 lakh people Information and Broadcasting Minister Anurag Thakur thanked Modi and Munda for accepting the long-pending demand of the people of the hill state and pointed out that the Hattee community straddles Himachal Pradesh and

Uttarakhand. The Hattees of Uttarakhand in the Jaunsar region have similar traditions and lifestyle and already enjoy the Scheduled Tribe (ST) status

In Tamil Nadu, the Narikoravan and Kurivikkaran communities have been included in the list of STs for the state. The demand of the two communities for inclusion in the list dates back to 1965, which was followed up by successive Chief Ministers of the southern including M

Ramachandran.

In Karnataka, the cabinet approved a proposal for the inclusion of the Betta-Kuruba community as a synonym of the Kadu Kuruba in the list of STs for the state. The major schemes for the STs

include post-matric scholarships, national overseas scholarships, national fellowships, top class education, concessional loans from the National Scheduled Tribes Finance and Development Corporation and hostels for the boys and girls of these communities.

'In addition, they will also be entitled to the benefits of reservation services and ad-

mission educational institutions in accordance with the government's policy,'

an official said.

In Uttar Pradesh, the Gond tribe, along with its five sub-castes, was already approved for inclusion in the ST list for the state. The changes were approved for

four districts in Uttar Pradesh --Kushinagar, Sant Ravidas Nagar, Chandauli and Sant Kabir Nagar. However, the Uttar Pradesh government changed the name of

Sant Ravidas Nagar district to Bhadohi in 2015. The name of the district will be changed to Bhadohi in the Bill pending in Parliament. Himachal Pradesh Chief

Minister Jai Ram Thakur, Parliamentary Affairs Minister Pralhad Joshi, former Chhattisgarh Chief Minister Raman Singh and Tamil Nadu BJP chief K Annamalai thanked the Prime Minister for accepting the demands of their respective states.

Chhattisgarh Chief Minister Bhupesh Baghel also thanked the Prime Minister for the inclusion of 12 communities in the list of STs and recalled that he had written to Modi in this regard last year.

### corruption case Court orders FIR, probe against Yedi

Bangalore, Sept 14:The Additional City Civil and Sessions Judge court Wednesday ordered an FIR to be registered and investigation taken up on a private complaint alleging corruption by former Karnataka chief minister B S Yediyurappa and his family members.

The order comes exactly a week after the High Court of Karnataka on September 7 directed the Special Court to hear the complaint of corruption afresh. The lower court had July 8 dismissed the complaint, as the Governor had refused to give sanction to the complainant, T J Abraham. The HC, however, ruled that the complainant was not the competent authority to seek sanction from the Governor.

The complaint is against Yediyurappa, the then Chief Minister, and his family members, alleging that they obtained bribes



in return for granting BDA (Bangalore Development Authority) contracts. Reacting to the order, Yediyurappa said he has full confidence in the judiciary. "There is no truth in any of these allega-

tions. I will come out of all these (cases). These things are natural, I'm not bothered about it," he said.

Apart from Yediyurappa, his son B Y Vijayendra (BJP state Vice President), grandson Shashidhar Maradi, son-in-law Saniav Sree, businessman Chandrakanth Ramalingam, MLA and then BDA chairperson ST Somashekar (now minister), IAS officer G C Prakash, K Ravi and Virupakshappa are the other accused in the private complaint.

# Cheetahs to travel without food from Namibia to India

Bhopal, Sept 14: Cheetahs arriving from Namibia to Madhya Pradesh's Kuno-Palpur National Park later this week will have to spend their entire air transit period empty stomach, a senior forest department official said.

After taking off from Namibia, food to the felines will be given in KPNP, where they will reach after an hour-long journey in helicopter from Jaipur, some 400km from the national park, the official said.

As a precaution, it is mandated that an animal should have an empty stomach at the time of commencing journey, MP Principal Chief Conservator of Forests (Wildlife) JS Chauhan told PTI.

He said no food will be given to the cheetahs during their journey from Namibia to Jaipur and then further to the national park.

Such a precaution is needed as long journey may create nausea-like feelings in animals leading to other complications, Chauhan said. Asked about travel time between

Namibia and Jaipur, the forest officer said he has no idea in this regard, but the cargo plane bringing the big cats is scheduled to land at the airport in the Rajasthan capital between 6 am to 7 am September 17. # Now, power subsidy in **Delhi missed call away** if one opts to dial for it

With this move, the option to get Delhi govt's power subsidy will no longer be available by default

New Delhi, Sept 14: Delhiites can avail the free electricity scheme from October only if they opt for it, Chief Minister Arvind Kejriwal announced Wednesday.

At a press conference here, he said people can now give a missed call or send a WhatsApp message on 7011311111 from Wednesday to avail the free electricity scheme.

With this move, the option to get Delhi government's power subsidy will no longer be available by default and every year, power consumers will be given an option to continue with power subsidy or

At present, those whose power consumption is less than 200 units do not have to pay any electricity charges. Those whose consumption is up to 400 units get a 50 per cent subsidy.

In his first offline press conference since formation of AAP government in Delhi in February 2020 after which Covid pandemic forced online briefings, Kejriwal said many residents were willing to pay their electricity bills in full and wanted an option to give up

the power subsidy. Kejriwal, however, clarified that the free electricity scheme will continue for those who demand and apply for it.

He said both physical and electronic methods will be available for people to apply for subsidy.

The government had decided a few months earlier that subsidy will be given to those only who will demand and apply for it.

In the electronic method, consumers can give a missed call on the phone number 7011311111 They will receive a message with a link, and clicking on this, they will get a form that can be filled

up and sent back. The number can also be used on WhatsApp by sending 'Hi' and a form will be received that can be filled up and sent to apply for subsidy, he said announcing the phone

An official said that around 90 per cent of power consumers in the national capital pay their electricity bills online.

In the physical method, consumers can fill up a form attached with their power bill and submit it at designated collection centres and the subsidy will continue from October 1, the chief minis-

Those consumers who have got their phone numbers registered for bill payment will be sent messages for applying to get subsidy.

Within 3 days of registration through physical or electronic method, confirmation will be sent to consumers through SMS or e-

mail that subsidy will continue. This facility can be availed electronically from today. Those who apply till October 31 will get the subsidy for the month. Those who do not do so will have to pay their bills but they can apply next month

A comprehensive campaign to inform people about the scheme will be soon started so that no one is uninformed in this regard.

"We will do it once a year so that people can apply to opt for subsidy or withdraw it. I believe those who do not need subsidy will give it up and those who need it will benefit," Kejriwal said.

Some people had demanded that they can pay their power bills and they should be given the option to give up their subsidy. It was a genuine demand because subsidy should be given to those only who need it, he said.

Under the free electricity cheme of AAP government, domestic consumers in Delhi using up to 200 units of power per month are given 100 per cent subsidy. Those consuming up to 400 units are provided 50 per cent or up to Rs 800 as subsidy.


### Army's 'Operation Sadbhavana' plays lead role in developing border areas

### Record-breaking heat increased vulnerabilityof half of all Delhiites

New Delhi, Sept 14: Between March and May, Delhi experienced five heatwaves with record-breaking temperatures reaching up to 49.2 degrees Celsius which increased the vulnerability of half of the city's population which lives in low-income, informal settlements, a report by the World Meteorological

Celsius, says the report

Department said. The report titled 'United in Science' released Tuesday also cited a recent attribution study which concluded that climate change made this prolonged hot weather in Delhi 30 times more likely and that the same event would have been about 1 degree Celsius cooler in a pre-industrial climate.

The report said that by the 2050s, over 1.6 billion people living in over 970 cities will be regularly exposed to three-month average temperatures reaching at least 35 degrees Celsius.

According to the WMO, the number of weather-related disasters has increased by a factor of five over the past 50 years, claiming on average the lives of 115 people and causing USD 202 million in losses daily.

The report showed greenhouse gas concentrations continue to rise to record highs. Fossil fuel emission rates are now above prepandemic levels after a tempo-

rary drop due to lockdowns. The ambition of emissions reduction pledges for 2030 needs to be seven times higher to be in line with the  $1.5\,\mathrm{degree}$  Celsius goal of the Paris Agreement, it said.

The past seven years were the warmest on record. There is a 48

per cent chance that during at least one year in the next five vears, the annual mean temperature will temporarily be 1.5 degrees Celsius higher than the 1850-1900 average. As global warming increases, tipping points in the climate system cannot be ruled out, the WMO said in a statement.

Cities that host billions of people and are responsible for up to 70 per cent of human-caused emissions will face increasing socio-economic impacts. The most vulnerable populations will suffer the most, said the report citing examples of extreme weather in different parts of the world this year.

"Floods, droughts, heatwaves, extreme storms and wildfires are going from bad to worse, breaking records with alarming frequency. Heatwaves in Europe. Colossal floods in Pakistan. Prolonged and severe droughts in China, the Horn of Africa and the United States. There is nothing natural about the new scale of these disasters. They are the price of humanity's fossil fuel addiction," said UN Secretary-General António Guterres.

This year's United in Science report shows climate impacts heading into uncharted territory of destruction. Yet each year, we double-down on this fossil fuel addiction, even as the symptoms get rapidly worse, Guterres said in a video message.

Climate science is increasingly able to show that many of the extreme weather events that we are experiencing have become more likely and more intense due to human-induced climate change. We have seen this repeatedly this year with tragic effect. It is more important than ever that we scale up action on early warning systems to build resilience to current and future climate risks in vulnerable communities. That is why WMO is spearheading a drive to ensure Early Warnings for All in the next five years, said WMO Secretary-General Prof Petteri Taalas.

Baramulla (J&K), Sept 14: Rutba Manzoor (12) was playing cheerfully in the garden outside her house when a leopard pounced upon her and dragged her into the forest. Her mother and sister could do nothing but scream violently. "We are still in trauma. We can-

not forget her face and mutilated body. It haunts us all the time. The scenes of recovering her half-eaten body will always remain as a scar in our lives," Ishfaq Ahmad, Rutba's grief-stricken brother told. Rutba, the daughter of Manzoor

Ahmad from Bernate village in Uri tehsil of Baramulla district, was mauled to death June 14. Her mangled body could be recovered from the nearby forest, only after an intensive search lasting for hours. In the majority of cases in-

volving wild animal attacks, children and adolescents are the targets. It has a long-lasting impact on other young minds. Still shaken by the incident, Rutba's classmate Zehra (14) shared, "I cannot get her out of my mind. She was always so cheerful. Now, every time I go to school, there is this lingering fear of a leopard pouncing upon me. I cannot think of going to school without my parents. I was unable to sleep well for days after my friend's death. Rutba still comes in my dreams.

Human-animal conflicts in Kashmir have resulted in hundreds of fatalities in the past few

A thriving population "Leopards are agile and intelligent beings. They camouflage themselves among the bushes and wait for the opportune time to strike. By experience, they have sensed that unattended children are the most vulnerable," Shafiq Ahmed Handoo,

Regional Wildlife Warden, Kashmir, Like Rutba, Sameer Ahmed (13) of Kalsi Chullan was dragged into the woods on his way back home

from the playground. According to published data. forests cover over 20 per cent of Jammu and Kashmir's total land area. There are 35 conservation reserves, 14 wildlife sanctuaries and five national parks within the state's 15,912 sq km network of protected areas. Of late, the wildlife department is concerned about the increased straying of wolves, leopards,

tigers, black bears and monkeys into residential areas of Kashmir.

According to conservationist Aliya Mir, an increase in the population of black bear and leopard has led to man-animal conflicts.

"The transformation of rice fields into orchards with apples and other trees have provided wild animals with safe hiding spots. Now, it is easier for them to find resting places close to populated areas, though without any human interference," Mir explained.

With the fear of attacks on the rise, the wildlife department has established control centres in several places to ensure timely response and, if possible, prevent such cases. "We are witnessing an increased movement of wild animals even in township areas.

Therefore, we have intensified our awareness campaigns. People do call us for help when they notice a wild animal in their area. Yet, the attacks continue," said Shafiq

Isolating kids at home

"His desperate cries still echo in my mind," said Abdul Jabbar Ganai of Kalsan Boniyar in Baramulla district, whose son Shahid Ahmad Ganai (14) fell prey to a leopard while feeding cattle. 'My other son was present there when Shahid was attacked, but we were all helpless. The leopard dragged him up to 4 km. Later, when we pinpointed the spot, we found only his torn body," narrated the distraught father.

Traumatised by the repeated attacks on children, panicky residents are resorting to extreme measures. "We don't feel safe. The authorities are not doing anything to capture the man-eaters. We do not want to send our kids anywhere, not even to school. We have isolated them at home," a local resident told on condition of

Muzammil (10), a resident of Kreeri, Baramulla, does not want to go to school or even play outside in the garden. "I fear the leopard will eat me. I want to remain inside with my mumma. I want to study online, as we did before. I do not even think of playing outside my home without my mumma. Whenever I hear any noise from outside at night, or even during the day, my heart stops," said Muzammil, who is paranoid after watching social media videos of leopard attacks.

About the psychological impact of such attacks on children, clinical psychologist Wasim Kakroo said, "If parents isolate their children at home, this will affect their overall development. Children have already spent the last few years at home due to Covid-19, and if we do this again, their mental

health can be impacted. Kakroo suggested that children should play under their parents' supervision. "It is tough on parents.. The situation is equally traumatic for a child whose friend or neighbour died in an animal attack. Children who witness such incidents should immediately get help from mental health professionals as it can lead to post-traumatic stress disorder," he warned.

# **How many students** dropped out, asks SC

"Do you have those authentic figures that because of this Hijab ban and the subsequent judgement of the high court, 20, 30, 40 or 50 students have dropped out?," a bench of Justices Hemant Gupta and Sudhanshu Dhulia asked after the counsel appearing for one of the petitioners raised the issue of students, especially girls, dropping out of school.

Senior advocate Huzefa Ahmadi, representing one of the petitioners, referred to a report and said it has testimonies of several students.

"My friend (one of the lawyers) informed me that 17,000 students had really abstained from the exams after this particular judgement," he said to the bench hearing arguments on a batch of pleas challenging the Karnataka High Court verdict refusing to lift the ban on hijab in educational institutions of the state.

Ahmadi said the effect of the government order in the matter

would be that girls, who were earlier going and taking secular education in schools, will be forced

to go back to Madrasas Why should someone feel that one religious observance will obstruct in any manner legitimate or secular education or unity? Why should anyone get provoked if someone wears a Hijab and goes to school? Why should other students have a problem?" he said.

# Govt official rubbishes report on unapproved antibiotic use in India

New Delhi, Sept 14: A Health Ministry official has dismissed as "misleading and inappropriate" a Lancet report claiming that more than 47 per cent of antibiotic formulations used in India's private sector in 2019 were unapproved.

Prof. Y K Gupta, a senior pharmacologist and vice chairman of the Standing National Committee on Medicines (SNCM) which prepared the National List of Essential Medicines (NLEM), said at a Health Ministry event Tuesday these formulations were approved by state drug regulatory authorities.

"Even though the authors have used the term 'unapproved' for formulations not approved by CDSCO, it is pertinent to note that these formulations were approved by state drug regulatory authorities. Therefore, the term 'unapproved'



seems to be inappropriate in this case," Gupta said.

The Central Drugs Standard Control Organisation (CDSCO) is the national regulatory body for pharmaceuticals.

He said after reading media reports on the Lancet study last week. Union Health Minister Mansukh Mandaviva became concerned and called him up at 6 am wanting to be apprised about the issue following a detailed analysis.

Referring to the media reports based on the Lancet study, Gupta said it was not correct to say that the use of antibiotics in India was excessive and underlined that their use in the country is lower than Brazil, Russia and Europe.

"Even though India is the biggest antibiotic consumer in terms of volume, the per-capita consumption rate of antibiotics in India is relatively low compared to many countries. This could be ascribed to our

large population," Gupta said. On perusing the paper, India's reported DID (defined daily doses per 1000 inhabitant per day) was 10.4. In global comparison, higher rates have been reported from Europe, Brazil, Russia, Sri Lanka and Pakistan according to recent estimates. The current study, in fact, reports improvements in per-capita consumption rate of systemic antibiotics of 10.4 DIDs which is lower compared to the rate reported in 2015 (13.6 DID) in another report,





### SK fines Google, Meta over \$71mn

Seoul: South Korea has fined Google and Meta more than \$71 million collectively for gathering users' personal information without consent for tailored ads, regulators said Wednesday, the country's highest-ever data protection fines. Investigations into the two US tech giants found they had been "collecting and analyzing" data of their users, and monitoring their use of websites and applications, the Personal Information Protection Commission said.

### Covid end in sight, says WHO chief

Geneva: The head of the World Health Organization said Wednesday that the number of coronavirus deaths worldwide last week was the lowest reported in the pandemic since March 2020, marking what could be a turning point in the years-long global outbreak. At a press briefing in Geneva, WHO Director-General Tedros Adhanom Ghebreyesus said the world has never been in a better position to stop Covid-19. "We are not there yet, but the end is in sight," he said, comparing the effort to that made by a marathon runner nearing the finish line.

### Jordan building mishap claims 5

Amman: Jordanian teams Wednesday rescued one person alive and worked to save other survivors of a building collapse in the capital Amman, officials said. State media said at least five people have been killed and at least 10 others remain missing. Amer Sartawi, a security spokesman, said eight people also have been injured and one survivor had been rescued Wednesday from the rubble of the residential building. The country's prime minister has ordered an investigation

### **Typhoon Muifa** scare in Shanghai

Beijing: A major typhoon gathered strength Wednesday as it headed over open water toward the Chinese metropolis of Shanghai. Heavy rain was reported in the city of more than 20 million people as Typhoon Muifa approached in the evening. The Hong Kong Observatory classified it as a severe typhoon with maximum sustained winds of 155 kilometers (96 miles) per hour. All flights at Shanghai's two main airports were cancelled and authorities were evacuating people from risky areas.

# EU lays out energy crisis plan

EUROPEAN GAS PRICES HAVE ROCKETED THIS YEAR AS RUSSIA HAS REDUCED FUEL EXPORTS TO RETALIATE FOR WESTERN SANCTIONS OVER ITS INVASION OF UKRAINE, LEAVING HOUSEHOLDS STRUGGLING TO PAY ENERGY BILLS AND UTILITIES GRAPPLING WITH A LIQUIDITY CRUNCH

Brussels, Sept 14: The European Union's executive outlined plans Wednesday for raising more than 140 billion euros (\$140 billion) to cope with an energy crisis that has increased the prospect of winter fuel rationing, corporate insolvencies and economic recession.

European governments have responded with measures ranging from capping prices on consumer electricity and gas bills to offering credit and guarantees to prevent power providers from collapsing under the weight of collateral demands.

"EU Member States have already invested billions of euros to assist vulnerable households. But we know this will not be enough," **European Commission President** Ursula von der Leven members of the European Parliament.

She unveiled plans to cap revenues from those electricity generators that have gained from surging power prices but do not rely on costly gas. She also outlined plans to force fossil fuel firms to share windfall profits from energy sales.

She said the plan should raise more than 140 billion euros for the EU's 27 members to support households and businesses.

But her announcement  $\operatorname{did}$  not include an earlier EU idea to cap Russian gas prices. That idea has divided member states, after Russia warned it could cut of all fuel supplies. Von der Leyen said the Commission was still discussing the idea.

### Google loses appeal against EU's record antitrust penalty

Luxembourg, Sept 14: The European Union's second-highest court Wednesday overwhelmingly upheld the EU's record fine against Google over its Android operating system for mobile phones, slightly reducing the fee for technical reasons.

In a statement, the EU's General court said it "largely confirms the commission's decision that Google imposed unlawful restrictions on manufacturers of Android mobile devices" in order to benefit its search engine.

The court, however, said the fine should be slightly reduced to 4.125 billion euros (\$4.1 billion), instead of the 4.3 billion euros decided by the commission in 2018 after reviewing the duration of the infringement.

Google said in a statement it was disappointed at the EU court's decision. "We are disappointed that the court did not annul the decision in full. Android has created more choice for everyone, not less, and supports thousands of successful businesses in Europe and around the world," the company said.

The levy remains the EU's biggest ever despite Google's arguments that the commission's case was unfounded and falsely relied on accusations it imposed its search engine and Chrome browser on Android phones.

The company also pushed the case that the EU was unfairly blind to the strength of Apple, which imposes or gives clear preference to its own services such as Safari

Google insisted that downloading rival apps was only a click away and that customers were in no way tied to Google products on Android.

The decision by the General Court is not necessarily the end of the story. Both sides can turn to the EU's highest court, the European Court of Justice, for a final say on the fine, which was the equivalent of \$5 billion when levied.

## Russian council faces dissolution after call for Putin's removal

Moscow, Sept 14: A group of St Petersburg local politicians who called for President Vladimir Putin to be sacked over the war in Ukraine faces the likely dissolution of their district council following a judge's ruling Tuesday, one of the deputies said.

Nikita Yuferev said the judge decided that a series of past council meetings had been invalid, naving the way for it to be broken up by the regional governor.

Another council member, Dmitry Palyuga, said the same court then fined him 47,000 roubles (\$780) for "discrediting" the authorities by calling for Putin's removal. Court officials could not be reached by telephone for comment.

Four more members of the Smolninskoye local council are due to appear in court in the next two days. Last week, a group of deputies from the council appealed to the State Duma to bring charges of state treason against Putin and strip him of power, citing a series of reasons including Russia's military losses in Ukraine and the damage to its economy from Western sanctions

Tbilisi, Sept 14: New clashes erupted between Azerbaijan and Armenia Wednesday as international peace efforts intensified a day after nearly 100 soldiers were killed in the worst fighting between the ex-Soviet republics since 2020.

The Armenian defence ministry accused Azerbaijan, which is backed politically and militarily by Turkey, of firing artillery and small arms in a fresh attack

At least 49 Armenian and 50 Azerbaijani soldiers were killed Tuesday along their common border, prompting an appeal for calm from Russian President Vladimir Putin. Both sides blamed each other for the fighting. The clashes have raised fears of another major armed conflict in the former Soviet Union while Russia's military is focused on the invasion of Ukraine.

A full-fledged conflict between Armenia and Azerbaijan would risk dragging in Russia and Turkey, and destabilise an important corridor for pipelines carrying oil and gas just as war in Ukraine disrupts energy supplies

Azerbaijan accused Armenia, which is in a military alliance with Moscow and home to a Russian military base, of firing mortars and artillery at its army units. It said two civilians had been injured since the clashes erupted.

Baku reported 50 military casualties on the first day of fighting and said Wednesday that two civilians had been injured since the clashes erupted. "Our positions are periodically being fired on at the moment," Azerbaijan's defence ministry said. "Our units are taking the necessary response measures.'

# UK inflation falls for first time in nearly a year

London, Sept 14: British consumer price inflation fell for the first time in almost a year in August as a drop in fuel prices offered some unexpected - and probably brief - respite to households and the Bank of England.

Annual consumer price growth slowed to 9.9% from July's 40-year high of 10.1%, the Office for National Statistics said Wednesday. This was its first drop since September 2021 and below expectations in a Reuters poll for it to rise to 10.2%.

However, economists warned inflation was likely to peak at around 11% in October when a new household energy tariff cap begins, and said it could be slow to fall due to underlying pressures and new government fiscal stimulus.

"The Bank of England will have to continue turning the screws,' said Paul Dales, chief UK economist at consultancy Capital Economics.

### **Goldman downgrades** Infosys, TCS to 'sell'

Bangalore, Sept 14: Goldman Sachs downgraded top Indian information technology service providers Tata Consultancy Services and Infosys to "sell" from "buy", citing a potential slowdown in dollar revenue growth in the face of impending macroeconomic stress.

"We believe a slowdown in discretionary IT services spend around the growth and transformation agenda will be quite material and something not yet completely reflected in the street's double-digit revenue growth forecast for the industry for FY24," Goldman analysts said in a note.

Goldman said it remains "more sanguine" on the EBIT margin forecasts than on revenue of Indian IT firms, given multiple levers such as higher employee utilisation, controls on variable pay and annual wage hikes.

India's top IT services firms have started freezing or cutting staff bonuses, worried that tightening budgets at US and European clients who are bracing for a recession will sharply hit their own profit as the pandemic-led boom fades out.

The IT firms made a windfall when pandemic struck the world couple of years back as several global corporations poured millions of dollars to rev up their digital infrastructure.

However, several top tier companies missed profit estimates in the April-June quarter due to higher costs. Goldman upgraded Wipro to "buy" from "sell", citing attractive valuations and a recent pickup in the company's order book.

The IT index has been one of the worst hit sectors, falling over 27% so far this year, underperforming benchmark Nifty 50 index, which is up 4%.

### **Vedanta highest** bidder for 2 coal blocks in Odisha

New Delhi, Sept 14: Vedanta Ltd has emerged as the highest bidder for two coal mines in Odisha on the second day of commercial coal mines auction.

The government put on sale 10 coal mines under the commercial coal mine auction Tuesday and Wednesday. "On the 2nd day of the e-auction today, two coal mines were put up for auction of which both coal mines were MMDR coal mines," the coal ministry said.

The blocks were auctioned under the second attempt of the fourth round of commercial coal mine auction. Both the coal mines are fully explored and have Peak Rate Capacity (PRC) of 20 million tonne per annum.

Jaiprakash Power Ventures had emerged as the highest bidder for a coal block in Madhya Pradesh on the first day of the auction of blocks Tuesday.

Jhar Mineral Resources had emerged as the highest bidder for two mines in Odisha and Sobhagya Mercantile made the highest bid for a mine in Maharashtra.

Under the commercial coal mine auction, a total of 57 coal mines, including the above 10 coal mines, have been auctioned till date with a total cumulative peak rate capacity of 140.75 million tonne per annum.

New Delhi, Sept 14: India's exports rose marginally by 1.62 per cent to \$33.92 billion, while trade deficit more than doubled to \$27.98 billion in August due to increased crude oil imports, commerce ministry data said Wednesday.

The revised data showed that imports rose by 37.28 per cent to \$61.9 billion in August this year.

Trade deficit widened to \$124.52 billion in April-August this fiscal as against \$53.78 billion in the same period last year. The deficit in August last year was \$11.71 billion.

The preliminary data released by the ministry September 3 had shown a 1.15 per cent decline in exports to \$33 billion in August.

During April-August 2022-23, exports registered a growth of 17.68 per cent to \$193.51 billion. Imports during the five-month period of this fiscal grew by 45.74 per cent to \$318 billion. Crude oil imports in August

this year increased by 87.44 per cent to \$17.7 billion. However, gold imports dipped by about 47 per cent to \$3.57 billion, the data showed. On the other hand, silver imports jumped to \$684.34 million during the month under review from \$15.49 million in the same month last year

Rise in import values in August has been witnessed in major commodity groups such as coal, coke & briquettes (133.64 per cent to \$4.5 billion), chemicals (43 per cent to about \$3 billion), and vegetable oil (41.55 per cent to about \$2 billion).

# Whistleblower: China, India had agents working for Twitter

Tesla CEO Elon Musk, who is trying to get out of a \$44 billion deal to buy Twitter, has argued without evidence that many of Twitter's roughly 238 million daily users are fake or malicious accounts, aka "spam bots"

Washington, Sept 14: Twitter's former security chief told Congress Tuesday there was "at least one agent" from China's intelligence service on Twitter's payroll and that the company knowingly allowed India to add agents to the company roster as well, potentially giving those nations access to sensitive data about users.

These were some of the troubling revelations from Peiter "Mudge" Zatko, a respected cybersecurity expert and Twitter whistleblower who



Committee to lay out his allegations against the company.

Zatko told lawmakers that the social media platform is plagued by

weak cyber defenses that make it vulnerable to exploitation by teenagers, thieves and spies" and put the privacy of its users at risk.

"I am here today because Twitter leadership is misleading the public, lawmakers, regulators and even its own board of directors," Zatko said as he began his sworn testimony. "They don't know what data

they have, where it lives and where it came from and so, unsurprisingly they can't protect it." Zatko said. "It doesn't matter who has keys if there are no locks." In a statement, Twitter said its

hiring process is "independent of any foreign influence" and access to data is managed through a host of measures, including background checks, access controls, and monitoring and detection systems and processes.

One issue that didn't come up in the hearing was the question of whether Twitter is accurately counting its active users, an important metric for its advertisers.

India's thermal coal imports are expected to rise 7% on year to 3% to 163 million tonne in 2023, consultancy Wood Mackenzie said.

In contrast, shipments of the fuel resource into China, the world's biggest importer, could fall to 182 million tonne in 2022 and 176 million tonne in 2023, from 246 million tonne in 2021, Woodmac said.

Coronavirus lockdowns stifled demand for the fuel in China while a steep rise in electricity demand triggered a spike in India's imports.

India's economy recovered from weak consumer demand to grow at the fastest pace in a year in the June quarter. On the other hand. China narrowly avoided contracting in the second quarter and has grown at a tepid 2.5% this year due to Covid-19 lockdowns in many parts of the country.





Indonesian supplies to India have risen 43.6% in 2022, at the expense of supplies from Australia, which fell 28.5%, and South African supplies, which declined by a fifth.

India's increasing electricity use has resulted in more imports by utilities, it has also pushed state-run Coal India to boost supplies to power plants at the expense of the non-power sector, government data showed.

New Delhi, Sept 14: The Supreme Court (SC) Wednesday allowed modification of BCCI's constitution and paved the way for its President Sourav Ganguly and secretary Jay Shah to continue in office without having to serve the mandatory cooling-off period.

A bench of Justices DY Chandrachud and Hima Kohli said that an office bearer can have continuous tenure of 12 years which includes six years in State Association and six years in BCCI before the cooling-off period of three years triggers.

The bench said that an office bearer can serve on a particular post for two consecutive terms, both at the BCCI and the State Association level, after which he would have to serve three years cooling-off period. "The purpose of the cooling-off period is not to create undesirable monopolies", the bench said.

The top court's order came on the Board's plea seeking to amend its constitution concerning the tenure of its office bearers including its President Ganguly and secretary Shah by doing away with the mandatory cooling-off period between tenures of office bearers across state cricket associations and the BCCI.

An office bearer can have continuous tenure of 12 years which includes six years in state association and six years in BCCI before the cooling-off period of three years triggers

The BCCI, in its proposed amendment, has sought the abolition of a cooling-off period for its office bearers which would enable Ganguly and Shah to continue in office as President and Secretary despite them having completed six years at respective state cricket

Earlier, the Justice RM Lodhaled committee had recommended reforms in the BCCI which have been accepted by the top court.

The constitution of the BCCI, which was earlier approved by the top court, stipulates a mandatory three-vear cooling-off period for anyone who had served two consecutive terms of three years each in the state cricket association or

While Ganguly was an office bearer in the Cricket Association of Bengal, Shah had served in the Gujarat Cricket Association.

# Apex court modifies Mandhana helps India level series

opening bout 4-2 against world U-23 bronze medalist Hannah Taylor of Canada. Sarita then lost to Anhelina Lysak of Poland 0-7.

Mansi Ahlawat was eliminated after her defeat to Jowita Maria Wrzesien of Poland 3-5 in the 59kg quarterfinal. The Indian was out of repechage contention also after Jowita lost in the semifinal.
