

## Public drinking new trend in Bhubaneswar

Bhubaneswar, Sept 15: Commissionerate Police have collected over ₹60 lakh in fines during the last eight months from offenders for consuming liquor in public places here in the state capital. According to data released by Commissionerate Police, the fine amounting to ₹67,40,140 has been collected for drinking in the open between January and August this year.

It is alarming to note that the trend of public drinking is rising alarmingly in the state capital. In January there were 504 offenders from who fines to tune of ₹25,200 were collected. However, in August this year, the number of offenders rose to 3,730 and the total fined amount stood at ₹18.74.500.

The only two months other than January that saw less than 1,000 offenders were February and April. In the other months the numbers have always been more than 2,000 - March (2,339, fines collected ₹11.66 lakh), May (3,720, ₹16.46 lakh), June (3,596, ₹17.66 lakh), July (3,146, ₹11.52

lakh) and August topping the list of

tipsy offenders at 3,730. Sources claimed that Commissionerate Police intensified action against congregation of anti-social elements following rise in various criminal activities due public drinking in the city during the last couple of months.

The city police should continue the drive against anti-socials for a safer capital city for denizens, especially the womenfolk. Drinking in public places is harmful for the people," advocate Dhitabrata Nayak told Orissa POST.

Sources in the know of things however, pointed out that it is not just people with criminal background who drink in public places. They stated many rich and influential people also sit and drink in their vehicles in front of malls and other eateries. They pointed out that the trend is taking alarming proportions and unless strict measures are enforced against the offenders, the situation may go out of hand. They asserted that prison terms are necessary to prevent drinking in public.

## MONKEY MENACE 'Snakes' turn saviour for Kerala police station

Police personal came upon the idea of using snake replicas as per the advice of a local farmer

Idukki (Kerala), Sept 15: Police personnel are generally considered as the watchdogs and saviours of society. However, it is no exaggeration to say that snakes, that too rubber replicas of the real reptiles, have become saviour of the law enforcers in this district of Kerala. In a forest-fringe police station

in the high-range Idukki, the police personnel struck upon a unique idea to shield themselves from the monkey menace. Such was the danger, that it was becoming extremely

difficult for the officials to maintain their sanctity. Monkey attacks had become the order of the day. So the personnel thought of an innovative idea. They started using replicas of snakes around the Cumbummettu police station that is located on the Kerala-Tamil Nadu border here to scare the troops away.

This trick has been a success at least till now. The Chinamade snakes, which very nearly resemble the real reptiles, can be seen lying in various

spots, including on the grille of the police station building, branches of trees



nearby and so on.

The police came upon this idea of using replicas as per the advice of a local estate keeper who was doing the same thing to keep the monkevs at bay

Cumbummettu PS sub-inspector

PK Lalbhai said no monkey has dared to come anywhere near the station, since the snakes have been placed in and around the building. They feel that the reptiles are real. To confuse the monkeys the position of the snakes are changed once in a while, he added

"We were told that there won't be any more monkey menace if the rubber snakes were tied in places where they usually come in large numbers. There has been no invasion of monkeys since then," Lalbhai informed.

Sunish, another policeman said the monkeys have been posing several difficulties at the station for some years. "They used to come in groups, roam around the station premises and even destroy the vegetable garden in our compound. Sometimes they used to even attack kids. But, after fixing the rubber snakes, the menace has decreased remarkably," he informed.

Sunish said they came to know about the trick of placing rubber snakes from a cardamom farmer in nearby Udumbanchola anddid not waste time to experiment with the replicas.

## OTM revival: HC asks govt to deposit ₹115cr

Cuttack, Sept 15: The Orissa High Court Thursday directed the state government to deposit Rs 115 crore before the official liquidator by October 15, to take over the de funct Orissa Textile Mills (OTM). The next hearing has been scheduled for October 18.

The state government has already deposited Rs 30 crore with the liquidator in the first phase and is ready to deposit the remaining Rs 115 crore to take over the OTM, the Advocate General told the High Court. Similarly, Idco has also deposited Rs 5 crore.

Addressing the issue of individual power supply to the staff quarters which was brought up in another petition, the High Court directed the official liquidator to address the concerns of the company workers and provide one meter to each staff quarters. 

### **Missing Pihu's mom** stages stir at OSCPCR

Bhubaneswar, Sept 15: The mother of minor girl Pihu, who has been missing for around two years, Thursday started an indefinite protest near the office of Odisha State Commission for Protection of Child Rights (OSCPCR) against the inaction by the police.

The 2-and-half-year old baby Pihu went missing while playing near her house at Madhusudanpur under Binjharpur police limits in Jajpur district August 9, 2020.

The hapless parents of Pihu have been running from pillar to post since then to get back their child. The local police initially did not respond to the complaint lodged by parents of missing girl.

Finding no other way, Pihu's mother, Monalisa Nayak sat in protest before the OSCPCR office alleging inaction by the police and concerned government officials. OSCPCR chairperson Sandhyabati Pradhan said, "Following the receipt of a memorandum from missing girl's family, I have forwarded it to the Chief Minister's Office requesting appropriate action in this regard. The decision to refer the case to Central Bureau of Investigation (CBI) will be taken by the CMO.' "I have also talked to the Jajpur Collector and Superintendent of Police about the issue. I also took up the issue with Crime Branch officials. The posters of the missing girl with announcement of monetary awards have been pasted at different places seeking information on Pihu. We have also written letters to district administrations of neighboring districts like Balasore, Dhenkanal, Bhadrak, Kendrapara and Angul seeking information about missing Pihu. We have been taking all the steps to trace the girl," added Pradhan.

## **Rituals in Kapilash** temple hit as priests resign over pay hike

Dhenkanal, Sept 15: The daily rituals of Lord Chandrashekharjew, the presiding deity at the famous Shaivite shrine of Kapilash in this district, were thrown out of gear, Thursday after three priests and six supakars (cooks) resigned from service demanding a pay hike.

As a result, no rituals could be conducted in time at the shrine in the wee hours of Thursday till 2 pm with the deity having to remain without any offerings till 2 pm. Normalcy returned to the shrine after the Endowment department hired priests from outside and conducted the rituals.

The priests hired from outside finally performed rituals and made offerings at around 2 pm. The development has sent the chatters abuzz and sparked sharp resentment among the devotees

Reports said that the priests and supakars of Kapilash shrine were being paid ₹6,400 each per month by the Endowment department. Earlier, they were being paid ₹5.400 each per month but their monthly salary was increased by ₹1,000 from the month of March following their repeated demands. However, they insisted on further pay hike.

A meeting was held at the district Collectorate to discuss their d emands and seek an amicable solution, Wednesday.

The priests and the supakars reiterated their demand for pay hike in the meeting attended by the Collector and the Sub-collector who is also the endowment officer. The Collector made all possible efforts to placate them but the priests and supakars refused to vield till their demands were met. They tendered their resignations and walked out of the meeting.

As a result, the daily rituals of the deity were affected Thursday. The first ritual which had to be completed within 10 am could not be solemnised. Endowment inspector Pradyumna Tripathy confirmed the development stating that the three priests and six supakars insisted on pay hike refus-

ing to relent and resigned from their service despite all efforts by the Collector to placate them. Sub-Collector-cum-endowment officer Snigdharani Dhal said that

they are repeatedly demanding for pay hike. However, the rituals of the deity will never stop. The rituals were conducted after priests from Balaram temple were engaged for the purpose, she added

Berhampur, Sept 15: Political violence has taken to alarming proportions in Ganjam district with violence claiming the lives of eight persons during last six months.

Political people and their asso ciates are being relentlessly killed at the slightest pretexts over gaining control of local political power. However, the accused are managing to go scot-free in most of these cases as police have failed to prove the involvement of the real culprits behind the violence.

This has sparked unrest and a sense of lawlessness in Ganjam district with one after another being killed in regular intervals after the conclusion of panchayat polls. All the murders are results of intense turf war prevailing be tween various political groups. This is also indicative of the deeper malaise and rot prevailing within political groups and the system.

The recent murder of a contractor and husband of a defeated Samiti member candidate of last panchayat polls at Regidi Square under Sadar police limits, September 13 is a case in this point. The slain contractor was identified as Purna Chandra Nahak, 42. of Ramsa village under Rushipur panchayat of Purusottampur block.

His wife Minati Nahak has alleged it to be murder over past political enmity. Minati contested the

Later, another youth Babu Goud of Nabarangpur village under Digapahandi police limits was killed while another youth Pradip Sahu was rendered critical, May 29. Police said termed past political enmity as the reason behind the murder.

Sahu succumbed to his injuries during treatment five days after the incident. Police arrested one person and produced him in the court.

Earlier, one person was killed at Polsara, February 18 over political enmity and another under Aska police limits, March 12. A former sarpanch and two of his associates sustained critical injuries in a violent clash with the members of rival group led by the current sarpanch during Sitala Sashthi festival at Masihakhali village under Kukudakhandi block, June 6. Police arrested the current sarpanch supported by the ruling party and produced him in court.



## Historical building on verge of collapse

LACK OF MAINTENANCE HAS LED TO THE STRUCTURE LYING IN A DILAPIDATED STATE

Mahakalapara, Sept 15: A British era building in Kendrapara district where rulers and officials used to hold secret parleys and also used it as a temporary prison to house freedom fighters is in a very dilapidated state and on the verge of collapse due to lack of proper maintenance, sources said Tuesday. The building has been named 'Jambu Lal Kotha' by locals and is located in this block.

In the building, freedom fighters were tortured to extract information out of them. Many such horror stories are written on the walls of the building. They were forced to do all types of menial works. Anyone opposing the British rule was brought here after their arrest and tortured physically and mentally.

The building was also used to store initially food supplied from foreign countries during the famous 1866 famine. Then the items were

The British rulers and officials also used to supervise the construction of buildings at Hukitola and Batighara false points from this structure. The Jambu Lal Kotha was constructed with large red colour bricks, lime and lac (resins)

The building started decaying after India's independence due to the vagaries of nature. Also local miscreants looted parts of the building. They broke windows and doors made of costly teak wood and sold those.

Locals Biranchi Narayan Das and Subhash Chandra Swain have demanded that

the building be declared 'unsafe' immediately or steps are implemented for its renovation.

## **Useful** Governance

ur world is undergoing an economic transition that will require effective government action on many fronts to manage climate change, ensure public health, and rebuild our middle classes through good jobs and innovation. But are our governments up to it?

There is near-universal skepticism about governments' ability to lead and achieve positive change. Such doubts may be well-placed. Polarisation and authoritarian populism – which are mutually reinforcing – have overrun the public sphere in many countries and undermined societies' capacity to mount collective action, both domestic and multilateral, against common problems.

Moreover, a longer-standing concern about government is that it has neither sufficient information nor the capabilities necessary to achieve positive structural change in the economy. Give governments too much power, the argument goes, and they will direct resources toward the wrong places and become captive tools of special interests. This argument lies at the heart of neoliberalism, and it will have to be overcome for any successor paradigm - like productivism - to succeed.

A more accurate account of government capabilities recognises that they are neither inherited nor static. Rather, once appropriate priorities have been

set, capabilities develop over time through experience, learning, and trust-building with private entities. For public officials, the relevant question is not "Do we have the capacity?" but, <sup>•</sup>Have we established the right priorities and the correct mode of governance?

Skeptics might say that this sounds good in theory but remains unachievable in practice. Just look around, and you can find failures of public governance almost everywhere - locally, nationally, and globally. But, in fact, as Columbia Law School's Charles Sabel and David Victor of the University of California, San Diego, show in a new book, effective governance models do exist and have already made a big difference. The practice is there; it is the theory that is lacking.

Sabel and Victor focus on climate change, which is the greatest policy challenge of our time. It is also an area where governance is doubly difficult: regulations must not only be effective at the national level; they also must be negotiated globally among states with different interests and circumstances.

Sabel and Victor build their argument on the example of the 1987 Montreal Protocol, which has succeeded in curbing ozone-depleting substances (ODS) to the point where the ozone

layer is now on course to full recovery. From the outset, ozone depletion and climate change looked like similar challenges, because both involve significant scientific and technological uncertainty and considerable differences among the positions of advanced and developing economies. That is why the 1992 United Nations Framework Convention on Climate Change - the first global climate agreement - took the Montreal Protocol as its model.

The Montreal Protocol and the UNFCCC both started out as very "thin' regimes, relying on broad commitments to cut emissions - of ODS and greenhouse gases, respectively - by a certain date, but with little operational content. But the two regimes evolved very differently. While the Montreal Protocol made steady progress by bringing firms and governments together to tackle concrete technological problems, climate-change agreements have frequently ended up stalled in global negotiations.

Sabel and Victor call attention to a key difference between the two regimes: the Montreal Protocol created sectoral committees in which ODSemitting firms joined national regulators and scientists in seeking technological alternatives. These groups started small, but they expanded and multiplied as knowledge was accumulated, capabilities were acquired, and trust was built among parties. This approach worked because the actual problem solving was devolved to local actors - namely, the firms with the requisite technological know-how. When innovation stalled, targets were reset. The result was a virtuous loop of on-the-ground innovation and top-level goal setting.

disha is known for coal. It is the second biggest coal-producing state, and by 2030, it will be the country's top coal-producing state. So naturally, Odisha's electricity production is heavily reliant on coal. Presently, more than 90% of electricity comes from coal-based power plants; renewable energy (RE) sources like solar, wind, and biomass play a minimal role.

In 2016, Odisha announced a policy to promote RE in the state. The policy had a modest target of installing 2,750 megawatts (MW) of RE capacity by 2022. But, as of March, 2022, only 617 MW has been installed, which is less than 25% of the target. In comparison, during 2016-2022, the country's RE capacity more than doubled from 46,580 MW to 109,885 MW. Today, Odisha's share in the country's RE capacity is just 0.55%

But due to low RE installation, Odisha has to buy renewable power from other states to meet its mandatory renewable purchase obligations (RPOs). RPOs are an essential policy tool introduced by the central government to increase the installation of RE in the country. Under this, all states are reguired to meet a minimum amount of their electricity requirement through RE. Odisha's RPO target for 2022-23 stands at 14.5%, which is set to increase to 43.33% by 2029 30. So, in 2029-30, close to 45% of electricity demand in Odisha has to be met from renewable sources. Now Odisha has a choice: buy RE from states like Rajasthan, Gujarat, and Tamil Nadu or install 30,000 MW of RE in the state to meet its 2029-30 RPO targets and simultaneously build a vibrant clean energy industry. I believe the choice is obvious: Odisha will gain immensely by installing RE within the state. I say this because Odisha has the

opportunity and obligation to promote RE. The opportunity is that the RE sector can support the next phase of green industrialisation in the state, creating new employment opportunities, as well

as boosting economic activity and income in rural communities. The obligation is because Odisha has one of the highest carbon dioxide (CO2) emissions per capita. It is also one of the most climate vulnerable states, with extreme weather events like cyclones, heatwaves, floods and droughts taking a significant toll on the lives. livelihoods and the economy every year. The energy transition is, therefore, crucial for the state.

So far, investments in the state's RE sector have remained tepid due to many institutional and commercial challenges. This needs to be addressed by the government through innovative policy measures and stronger incentives under the new RE policy, which is set to be released this year.

But before we address the policy challenges, removing a misconception that has pulled down RE development in the state is important. The misconception is that the state doesn't have RE potential. This misconception has been created because of the poor estimation of RE potential by different agencies. For example, till today,

a detailed study on the wind energy potential in Odisha, a coastal state, has not been undertaken. The solar potential has also not been estimated based on thumb rules Our initial estimation is that Odisha's RE potential is at least five times what is being projected by the Ministry of New and Renewable Energy (MNRE).

Take the example of solar power. According to MNRE, Odisha only has 26,000 MW of solar potential. But this estimate has ignored the significant potential of manmade water bodies (where floating solar power can be installed) and large mining wasteland. We estimate that just on water bodies and mining wasteland, 20,000 MW solar plants can be installed. Large RE capacities can also be installed in urban and rural areas through distributed renewable energy plants like rooftop solar plants. Odisha can also prioritise agro-solar farming, given the significant share of monocropped agriculture land and fallow land in the state. This will not only increase the state's RE capacity, it will also enhance income levels for the rural poor. So, low RE potential in Odisha is a myth that needs to be discarded.

As far as policy challenges are concerned, there are many. The foremost is streamlining and building the state's institutional ca pacity for RE promotion and adoption. Presently, Orissa Renewable Energy Development Agency, Engineer-in-Chief and Green **Energy Development Corporation** of Odisha Ltd. have been made nodal agencies for different RE technologies, which often leads to confusion and delays at the implementation stage. A single empowered nodal agency at the fore front of RE promotion in Odisha can help fast-track deployment through proactive measures.

The other aspect is to avoid copy ing the model being implemented in states like Rajasthan and Gujarat which are installing ultra-mega solar plants on large tracts of land. Instead, Odisha's new RE policy should focus on developing smaller plants by making farmers and landowners true partners in RE de velopment. Technologies like agrisolar, rooftop solar, floating solar, pumped hydro stations, and green hydrogen should be prioritised. The policy should also focus on supporting and ensuring RE in stallations by industries with captive power plants, which also have to meet RPO targets.

At a time when the country is steadily cruising along a green technology pathway with clear targets and roadmaps for renewable energy, storage, hydrogen, electric vehicles, Odisha cannot miss the opportunity to build a new clean energy economy. Overall, Odisha should develop the new RE policy for 2022-30 in such a way that it is recognised as a serious destination for RE investments.

## Indo-Saudi ties driven by realpolitik

xternal Affairs Minister S. Jaishankar was in Saudi Arabia on a three-day visit beginning 10 September. It was his first official visit to that country since taking over South Block. He was armed with a letter from Prime Minister Narendra Modi conveying greetings of their upcoming National Day 23 September, to the Crown Prince. At the same time, as a part of reciprocal courtesy, the EAM extended an invitation to the Crown Prince to visit India at an early date. In material terms, the EAM was tasked with consolidating the growing ties between both the countries. Jaishankar began his schedule by interacting with 2.2 millionstrong Indian community which is the largest expatriate group in the Kingdom. The EAM met his counterpart Prince Faisal bin Farhan Al Saud in Rivadh. Both the ministers co-chaired the inaugural meeting of the Committee on Political, Security, Social, and Cultural Cooperation (PSSC), which works under the umbrella framework called India-Saudi Arabia Strategic Partnership. Both the ministers evaluated the progress in relations across the domains - political, trade, energy, investments, defence, security and culture. Several areas were prioritised for further work in improving cooperation, such as food security, healthcare, pharmaceuticals, defence industry and entertainment.

Jaishankar met the Secretary General of the Gulf Cooperation Council (GCC), Dr. Nayef Falah Mubarak Al-Hajraf and discussed India-GCC relations. They signed a MoU on mechanism of consul-

various tribes, sheikhdoms, city states, emirates and kingdoms of most of the Arabian Peninsula. The unification process started in 1902 and ended in 1932. The formal diplomatic relation between India and Saudi were established soon after India became Independent in 1947. The relationship has grown since then with ups and downs. The bilateralism has been backed by visits by Indian Prime Ministers to Saudi Arabia: Jawaharlal Nehru (1955), Indira Gandhi (1982), Manmohan Singh (2010) and Narendra Modi (2016 and 2019). Likewise, in 2019, Saudi Crown Prince Mohamad bin Salman visited India. The elephant in the room has been Pakistan

Today's Indo-Saudi cooperation is not just restricted to the traditional area of oil-energy trade. The relationship has become multi-dimensional including defence, maritime security counter-terrorism. science and technology, strategic oil reserves, investments, tourism and so on. This closeness has been necessitated by the respective needs of the countries. Cooperation in security matters constitutes mutual interest as both countries are concerned by the security issues in their respective regions. While India continues to face cross-border terrorism, Saudi Arabia is vulnerable to recurring missile and drone attacks on its major oil fields. The strikes on Aramco's oil processing plant, Abgaig, and the Khuris oil field 14 September, 2019 are cases in point. All in all, India and Saudi Arabia relations are driven by both realpolitik and strategic interests. They have begun to realise that by focussing on their national and mutual interests, they will benefit a lot more than by letting their relations be dictated by a third party. The visit of the Foreign Minister should enhance the relations and in the immediate as well as long run, it is for the leadership of both countries to give teeth to their talks, agreements as well as the very common place diplomatic tool, the optics.

Under the climate regime, by contrast, firms have been kept at arm's length from regulators, owing to fears that they would capture the process. But this has entrenched conflicts of interest and hampered innovation.

The Montreal Protocol is not the only successful case of what Sabel and Victor call "experimental governance." Additional examples can be found across a wide range of national and sub-national programmes, from the US Advanced Research Projects Agency - Energy (ARPA-E) to Ireland's agricultural-pollution regime. In each case, ground-level experimentation is coupled with higher-level goal setting. The successful practices that emerge from these collaborations are then routinised through dissemination and standard setting

Nor are the success stories limited to environmental policy. ARPA-E, after all, is modeled after the Defense Advanced Research Projects Agency (DARPA), the US agency that is responsible for some of the landmark innovations of our time, including the internet and GPS. At the local level, the most successful initiatives to revitalise communities and create jobs take the form of private-public collaborations that bring together training programmes, businesses, non-profit groups, and public officials to create new pathways to economic opportunity. Effective national industrial policies take a similar collaborative, cross-sectoral approach.

As Sabel and Victor explain, the general strategy in all these domains is to start out with ambitious, somewhat ill-defined goals. Programme leaders must acknowledge the deep uncertainty, and hence the likelihood of mistakes and false starts. There must be incentives for the parties with the most detailed and accurate information - typically firms - to look for solutions, which means that public agencies must establish some combination of sticks (the threat of regulation) and carrots (incentives and public inputs).

Because success depends on frequent reassessments and revisions, setting milestones and monitoring progress is crucial. When solutions do emerge, they can be generalised in the form of standards or regulations. Innovation lies at the center of this process, because higher living standards (including a cleaner environment and better jobs) are possible only through enhanced productivity.

This kind of policymaking differs significantly from the prevailing approaches. From the experimental-governance perspective, the "state vs. market" dichotomy is simply irrelevant. States and markets are complementary, not dichotomous. Economists' standard top-down, principal-agent model of regulation becomes unhelpful.

To succeed, a new paradigm like productivism will have to transcend the stale ideologies of the past. Fortunately, the models of governance that it needs already exist in abundance

## No admission to Ukraine returned students in India

New Delhi, Sept 15: In a setback to thousands of undergraduate medical Indian students who were studying in Ukraine but had to return to the country in view of the war with Russia, the Centre Thursday told the Supreme Court that they cannot be accommodated in medical colleges here for lack of provisions under the law.

In an affidavit, the Centre said that till now, no permission has been given by the National Medical Commission (NMC) to transfer or accommodate any foreign medical students in any Indian medical institute/University.

approval parent of university/Institution in Ukraine). The government said that after such completion of their remaining courses, the certificate, of course, completion/degree is ex-

pected to be issued by the parent institutions in Ukraine. The government said that these students have claimed that when they tried applying under the academic mobility programme at their respective Ukrainian Medical Universities, such universities refused to entertain their appli-

cations for academic mobility in their first semester of the academic year 2022-23. "It is humbly submitted that the aforesaid affidavit (of the student) is completely frivolous and misleading. It is submitted that in so far as the aforesaid academic mobility program is concerned, the same was introduced only for

those students, who were not able to continue their education due to war like situation in Ukraine", the Centre said. It added that in the public notice dated September 6, the phrase preted to mean accommodation of these students in Indian colleges/Universities, as the extant regulations in India do not permit migration of students from foreign universities to India.

The government said that most of the aggrieved students/petitioners had gone to foreign countries for two reasons-firstly due to poor merit in the NEET exam and secondly, affordability of medical education in such foreign countries. "It is humbly submitted that in case these students with (a) poor merit are allowed admission in premier medical colleges in India by default, there may be several litigations from those desirous candidates who could not get seats in these colleges and have taken admission in either lesser known colleges or have been deprived of a seat in medical colleges", the government said.

It further added that in case of affordability, if these candidates are allocated Private Medical Colleges in India, they once again may not be able to afford the fee structure of the concerned Institutions.

## **'Power outage'** at K'taka hosp kills 2 patients

Bangalore, Sept 15: Two patients in the intensive care unit (ICU) of a hospital in Ballari died allegedly during power outage, a charge denied by the Karnataka government, which said it is ready to conduct a probe into the issue that rocked the State Assembly Thursday.

Chief Minister Basavaraj Bommai announced a compensation of Rs five lakh to the kin of the deceased. "The government has decided to give a compensation of Rs five lakh to the families of the victims of Ballari incident," he told reporters here. Maula Hussein (35), suffering from kidney-related ailments, and Chettemma (30), a snake-bite victim, died at the Vijayanagara Institute of Medical Sciences (VIMS) in the district headquarters town of Ballari Wednesday at 9.30 AM and 9.35 AM respectively.



Some reports attributed the deaths to power-cut and a defunct power generator or backup at the government medical college hospital.

Raising the issue during the Zero Hour, the Leader of Opposition Siddaramaiah said there was a power-cut from 8 AM to 10:30 AM and at the same time the generator was also not functioning and three people who were in the ICU died as the ventilators did not function.

Also, seeking to know why the generator was not readily kept available in a working condition. he further said strict action should be taken against errant officials and compensation of Rs 25 lakh each should be immediately given to the family of the deceased.

## **KARNATAKA HIJAB BAN** We are not interpreters of Quran, says top court

New Delhi, Sept 15: The Supreme Court said Thursday it is not the "interpreter" of the Holy Quran and it has been argued before it in the Karnataka Hijab ban matter that courts are not equipped to interpret religious scriptures.

The apex court, which was hearing arguments on a batch of pleas challenging the Karnataka High Court verdict refusing to lift the ban on Hijab in educational institutions of the state, made the observation after a counsel for one of the petitioners said the judgement under challenge is touching upon the Islamic and religious perspective.

"The one way is to interpret the Quran.We are not interpreters of the Quran. We cannot do it and that is the argument raised also that the courts are not equipped to interpret religious scriptures," a bench of Justices Hemant Gupta and Sudhanshu Dhulia said.

The top court heard submissions of several lawyers, who appeared for the petitioners and argued on various aspects including the wearing of Hijab being a matter of privacy, dignity and also au-

tonomy, and whether the practice of wearing it is essential or not. One of the advocates argued the way the high court interpreted the

irresponsibly' against him. Women face discrimination in earnings, jobs: Oxfam

India's female work participation rate was just 25% for 2021, according to federal government data, among the lowest for emerging economies

New Delhi, Sept 15: Discrimination accounts for 100 per cent of the employment inequality women face in the labour market in rural areas and 98 per cent in urban areas, according to a new Oxfam India report.

The findings of the Oxfam "India Discrimination Report 2022" indicate towards discrimination being a driving factor behind the low women's Labour Force Participation

Rate (LFPR) in the country. According to the Union Ministry of Statistics and Programme Implementation (MoSPI), the LFPR for women in India was only 25.1 per cent in 2020-21 in both urban and rural areas. This is considerably lower than Brazil, Russia, China and South Africa, according to the latest World Bank estimates. The LFPR for women in South Africa was 46 per cent in 2021, the report

said. In 2019-20, 60 per cent of all males aged 15 years and above had regular salaried and self-employed jobs, while 19 per cent of all similarlyaged females had regular and selfemployment.

There is also a significant gap in the earnings between men and women in the case of regular and self-employment in urban areas. The average monthly earning is Rs



15.996 for men and merely Rs 6,626 for women in urban areas in selfemployment

'The men's average earning is nearly 2.5 times that of the earnings of women," the report said. Professor Amitabh Kundu, one of the authors of the India Discrimination Report, said, "There have not been many attempts to quantify the discrimination faced by marginalised communities across the country. We have used a statistical method called 'decomposition' to understand differential outcomes in employment. wages, health and access to agricultural credit among various so-

cial groups. This has helped us to quantify the discrimination faced by marginalised communities from

2004-05 to 2019-20.' The findings of the report are unique and this will help the policy makers of the Union and state governments to design programmatic interventions that will tackle discrimination and bring inclusivity in the labour, capital and endowment markets," he added.

Oxfam India recommended active enforcement of effective measures for the implementation of the right to equal wages and work for all women in the country.

"Work to actively incentivise the participation of women in the workforce, including enhancements in pay, upskilling, job reservations and easy return-to-work options after maternity," another recommendation said.

New Delhi/Mumbai, Sept 15: Mining magnate Anil Agarwal has said Gujarat was picked over Maharashtra for the Vedanta-Foxconn's Rs 1.52 lakh crore semiconductor project based on "professional and independent" advice, as the political row in Maharashtra over the facility escalated Thursday. Seeking to soothe frayed nerves

in Maharashtra after the project was shifted out of the state, Agarwal, who is the Chairman of Vedanta, also said his mining group is committed to investing in Maharashtra as well. Gujarat, he said, was chosen as it met the company's "expectations"

Originally, Vedanta and its Taiwanese partner Foxconn were looking at Maharashtra for setting up the chip factory but on September 13 signed a memorandum of understanding (MoU) with the Gujarat government for investing Rs 1.52 lakh crore in the unit. The facility was earlier proposed to be set up in Pune district.

Maharashtra's Deputy Chief Minister Devendra Fadnavis accused the opposition of making false claims over the shifting of the project, while Uddhav Thackeray's Shiv Sena and the Congress stepped up its attack on the government over losing the mega deal.

Fadnavis also questioned the opposition over the Nanar refinery project proposed in Maharashtra's coastal district of Ratnagiri. The project was opposed by the Shiv Sena.

The Thackeray-led Shiv Sena said the mega semiconductor project going to Gujarat was an attack on Maharashtra's "prestige".

This was just the beginning and one day the Eknath Shinde-led Maharashtra government might even "trade Mumbai," said a scathing editorial in Sena mouthpiece "Saamana". NCP president Sharad Pawar told a press conference in Pune that the Centre's assurance to Maharashtra that it will get a bigger project than thesemiconductor plant is akin to trying to "convince a child".



## TRAFFIC WOES, WATER CRUNCH, NOW FLOODS Slow death of India's Silicon Valley?

**Bangalore, Sept 15:** Harish Pullanoor spent his weekends in the late 1980s tramping around the marshes and ponds of Yemalur, an area then on the eastern edge of the Indian metropolis of Bangalore, where his cousins would join him catching small freshwater fish.

In the 1990s, Bangalore, once a genteel city of gardens, lakes and a cool climate, rapidly became India's answer to Silicon Valley, attracting millions of workers and the regional headquarters of some of the world's biggest IT companies. The untrammelled expansion

rife untrainmened expansion came at a price. Concrete replaced green spaces and construction around the edge of lakes blocked off connecting canals, limiting the city's capacity to absorb and siphon off water.

The heaviest rainfall in decades led to flooding in India's IT hub Bangalore in early September

Last week, after the city's heaviest rains in decades, the Yemalur neighbourhood was submerged under waist-deep water along with some other parts of Bangalore, disrupting the southern metropolis' IT industry and dealing a blow to its reputation.

Residents fed up with gridlocked traffic and water shortages during the dry season have long complained about the city's infrastructure.

But flooding during the monsoon has raised fresh questions about the sustainability of rapid urban development, especially if weather patterns become more erratic and intense because of climate change.

"It's very, very sad," said Pullanoor, who was born close to Yemalur but now lives in the western city of Mumbai, parts of which also face sporadic flooding like many of India's urban centres.

Big businesses are also complaining about worsening disruptions, which they say can cost them tens of millions of dollars in a single day. Bangalore hosts more than 3,500 IT companies and some 79 'tech parks' - upmarket premises that house offices and entertainment areas catering to technology workers. Wading through flooded highways last week, they struggled to reach modern glass-faced

complexes in and around Yemalur

where multinational firms including JP Morgan and Deloitte operate alongside large Indian start-ups. Millionaire entrepreneurs were among those forced to escape flooded living rooms and swamped bedrooms on the back of tractors.

Insurance companies said initial estimates for loss of property ran into millions of rupees, with numbers expected to go up in the next few days.

#### **GLOBAL IMPACT**

The latest chaos triggered renewed worries from the \$194 billion Indian IT services industry that is concentrated around the city.

"India is a tech hub for global enterprises, so any disruption here will have a global impact. Bangalore, being the centre of IT, will be no exception to this," said KS Viswanathan, vice president at industry lobby group the National Association of Software and Services Companies (NASSCOM).

NASSCOM is currently working to identify 15 new cities that could become software export hubs, said Viswanathan, who is driving the project. "It is not a city-versuscity story," he told Reuters. "We as a country don't want to miss out on revenue and business opportunities because of a lack of infrastructure."

Even before the floods, some business groups including the Outer Ring Road Companies Association (ORRCA) that is led by executives from Intel, Goldman Sachs, Microsoft and Wipro, warned inadequate infrastructure in Bangalore could encourage companies to leave.

"We have been talking about these for years," Krishna Kumar, general manager of ORRCA, said last week of problems related to Bangalore's infrastructure. "We have come to a serious point now and all companies are on the same page." In the early 1970s, more than 68 percent of Bangalore was covered in vegetation.

By the late 1990s, the city's green cover had dropped to around 45% and by 2021 to less than 3% of its total area of 741 square kilometres, according to an analysis by TV Ramachandra of Bangalore's Indian Institute of Science (IISC).

Green spaces can help absorb and temporarily store storm water, helping to protect built up areas. "If this trend continues, by 2025,

98.5% (of the city) will be choked

with concrete," said Ramachandra, who is part of IISC's Centre for Ecological Sciences.

#### CITY IN DECAY

Rapid urban expansion, often featuring illegal structures built without permission, has affected Bangalore's nearly 200 lakes and a network of canals that once connected them, according to experts.

So when heavy rains lash the city like they did last week, drainage systems are unable to keep up, especially in low-lying areas like Yemalur. The Karnataka government said last week it would spent 3 billion Indian rupees (\$37.8 million) to help manage the flood situation, including removing unauthorised developments, improving drainage systems and controlling water levels in lakes.

"All the encroachments will be removed without any mercy," Karnataka Chief Minister Basavaraj Bommai told reporters. "I will personally go and inspect."

Authorities have identified around 50 areas in Bangalore that have been illegally developed. Those included high-end villas and apartments, according to Tushar Girinath, Chief Commissioner of Bangalore's civic authority.

Last week, the state government also announced it would set up a body to manage Bangalore's traffic and start discussions on a new storm water drainage project along a major highway.

Critics called the initiatives a knee-jerk reaction that could peter out. "Every time it floods, only then we discuss," said IISC's Ramachandra. "Bangalore is decaying. It will die."

## On Hindi Day, K'taka CM promises to make Kannada mandatory

Bangalore, Sept 15: Amid protests and anger in some quarters against observing 'Hindi Diwas', Karnataka Chief Minister Basavaraj Bommai said Wednesday his government is bringing in a legislation to make Kannada mandatory in the state.

Kannada activists have been demanding for many years now for full implementation of Kannada as the administrative language.

Though the chief minister did not specify if it's in the context of administrative language or its scope is beyond it, according to sources, he seemed to be referring to the proposed 'Kannada Language Comprehensive Development Bill', aimed at further strengthening the efforts to give primacy to Kannada. Bommai told the Legislative Assembly that the legislation would be tabled during the ongoing session to make Kannada mandatory and asserted that Kannada is supreme in the state. He said that for the first time a

legal statute is being given in the state, making Kannada mandatory, aimed at protecting the language and its users, and also to grow it further.

The CM was responding to the issue raised by JD(S) legislators and its leader H D Kumaraswamy in the Assembly, opposing celebration of 'Hindi Diwas', calling it forceful imposition of Hindi on Kannadigas.

"India is a union of states with different languages, cultures. There is no scope here to impose any specific language. Our Prime Minister has said very clearly that all mother tongues and regional languages are national languages," Bommai noted. "The government, the state and its people are committed to protect and grow Kannada, there is no compromise on this, and there is no need to worry," he said, adding, "On the issue of the state's land, waters, people and language, we have always taken decisions bevond politics.

## K'taka Council passes anti-conversion Bill

**Bangalore, Sept 15:** Karnataka Legislative Council Thursday passed the contentious anti conversion Bill, amid objections from the opposition Congress and JD(S).

The 'Karnataka Protection of Right to Freedom of Religion Bill' was passed by the Legislative Assembly in December last.

As the Bill was pending for passage in the Legislative Council, where the ruling BJP was short of majority then, the government had subsequently promulgated an ordinance in May this year to give effect to the bill.

Home Minister Araga Jnanendra

piloted the Bill for the consideration of the Upper House today.

Noting that in recent times religious conversions have become widespread, he said there have been mass conversions with allurements and through force, disturbing peace and leading to mistrust among people following different religions.

The Bill does not take away anyone's religious freedom and anyone can practice the religion of his or her choice, but not under pressure and allurements, Jnanendra said.

The Minister had moved some amendments to substitute certain clauses in the Bill like- It (legislation) shall be deemed to have come



into force with effect from the 17th day of May 2022; also that ....The ordinance is hereby repealed- which has now been accepted with the passage of the Bill.

Leader of Opposition in the Legislative Council BK Hariprasad even tore the copy of the Bill in protest as the pro-tem Chairman Raghunath Rao Malkapure was in the process of putting the Bill to vote. Hariprasad termed the Bill as unconstitutional and will affect the right to religion.

Law and Parliamentary Affairs Minister JC Madhuswamy maintained that the Bill was well within the scope of the Constitution of India.

The Bill that has been vehemently opposed by some Christian community leaders, provides for protection of right to freedom of religion and prohibition of unlawful conversion from one religion to another by misrepresentation, force, undue influence, coercion, allurement or by any fraudulent means. Market in the heart of the city.

The rally was peaceful till it reached near Esplanade, where the police had raised barricades to stop the protesters from reaching the main gate of the KMC building. However, the protesters brought down the barricade which led to a scuffle between the agitators and the police. cyber security agency said in its latest advisory. "It has been reported to CERT-In that Indian banking customers are being targeted by a new type of mobile banking malware campaign using SOVA Android Trojan.The first version of this malware appeared for sale in underground

markets in September 2021 with the ability to harvest user names and passwords via key logging,
stealing cookies and adding false overlays to a range of apps," the advisory said.

SOVA, it said, was earlier focusing on countries like the US, Russia and Spain, but in July 2022 it added several other countries, including India, to its list of targets.

The latest version of this malware, according to the advisory, hides itself within fake Android applications that show up with the logo of a few famous legitimate apps like Chrome, Amazon, NFT (non-



fungible token linked to crypto currency) platform to deceive users into installing them.

"This malware captures the credentials when users log into their net banking apps and access bank accounts. The new version of SOVA seems to be targeting more than 200 mobile applications, including banking apps and crypto exchanges/wallets," the advisory said.

The Indian Computer Emergency Response Team or CERT-In is the federal technology arm to combat cyber attacks and guards the Internet space against phishing and hacking assaults and similar online attacks.

The agency said the malware is distributed via smishing (phishing via SMS) attacks, like most Android banking Trojans. "Once the fake android application is installed on the phone, it sends the list of all applications installed on the device to the C2 (command and control server) controlled by the threat actor in order to obtain the list of targeted applications."

The lethality of the virus can be gauged from the fact that it can collect keystrokes, steal cookies, intercept multi-factor authentication (MFA) tokens, take screenshots and record video from a webcam and can perform gestures like screen click, swipe etc. Using android accessibility service.

New Delhi, Sept 15: Prime Minister Narendra Modi will join Russian President Vladimir Putin, Chinese President Xi Jinping and other leaders at the SCO summit in the Uzbek city of Samarkand Friday that is set to deliberate on regional security challenges, boosting trade and energy supplies among other issues.

among other Issues. The summit of the eight-nation influential grouping is taking place amid the growing geo-political turmoil largely triggered by the Russian invasion of Ukraine and China's aggressive military posturing in the Taiwan Strait.

He said India expects that the discussions at the summit will cover topical regional and international issues, reforms and expansion of the SCO, the regional security situation and cooperation perspective. Strengthening connectivity as well as boosting trade and tourism in the region was also part of the agenda.

The foreign secretary said the duration of Modi's visit to Samarkand will be around 24 hours and he will also hold some bilateral meetings.

According to reports in Russian and Iranian media, Modi is likely to hold separate bilateral meet-



ings with Putin and Iranian President Ebrahim Raisi.

In a statement ahead of the visit, the Prime Minister said, "at the SCO Summit, I look forward to exchanging views on topical, regional and international issues, the expansion of SCO and further deepening of multifaceted and mutually beneficial cooperation within

the Organisation." Asked to comment on China's growing influence over the SCO, Kwatra did not give a direct reply but said India remained focused on strengthening its linkages with central Asia and the extended neighbourhood.

The foreign secretary said the SCO is focused on regional cooperation and that India does not

think it is about one country. "We do not see it through the perspective of a third country", he said.

Asked about Pakistan's continued support to various terror groups contrary to the SCO's vision for regional security, Kwatra said there are multiple ways to look at how different countries assess and look at the challenge of terrorism.

#### Terrorist held

In a CCTV footage of the restaurant that emerged after her death, she was seen dancing with Sangwan. The aide is also purportedly seen forcing her to drink water which she instantly spits out.

## 'Massive global failures' in fighting Covid crisis: Lancet

The commission says that governments were not transparent, and criticises UN health body for a slow response



**New Delhi, Sept 15:** Widespread, global failures at multiple levels in the Covid-19 response led to millions of preventable deaths and reversed progress made towards the UN Sustainable Development Goals (SDGs) in many countries, according to a new Lancet Covid-19 Commission report.

The Commission critically considers the global response to the first two years of the Covid-19 pandemic, citing widespread failures of prevention, transparency, rationality, basic public health practice, and operational cooperation and international solidarity that resulted in an estimated 17.7 million deaths.

The report also finds that most national governments were unprepared and too slow in their response, paid too little attention to the most vulnerable groups in their societies, and were hampered by a lack of international cooperation and an epidemic of misinformation. The Commission drew evidence using new epidemiological and financial analyses to outline recommendations that will help has-

ten the end of the Covid-19 emergency, lessen the impact of future health threats, and achieve long-term sustainable develop-



ment. The report warns that achieving these goals hinges upon a strengthened multilateralism that must centre around a reformed

and bolstered World Health Organisation (WHO), as well as investments and refined planning for national pandemic preparedness and health system strengthening, with special attention to populations experiencing vulnerability.

Crucial investments also include improved technology and knowledge transfers for health commodities and improved international health financing for resource limited countries and regions.

The Commission is the result of two years of work from 28 of the world's leading experts in public policy, international governance, epidemiology, vaccinology, economics, international finance, sustainability, and mental health, and consultations with over 100 other contributors to 11 global task forces. "The staggering human toll of

the first two years of the COVID-19 pandemic is a profound tragedy and a massive societal failure at multiple levels," said Professor Jeffrey Sachs from Columbia University, US "We must face hard truths -too many governments have failed to adhere to basic norms of institutional rationality and transparency; too many people have protested basic public health precautions, often influenced by misinformation; and too many nations have failed to promote global collaboration to control the pandemic," said Sachs.

The report noted that collective action should be taken immidiately to promote public health and sustainable development to bring an end to the pandemic.

It also underscores the need to address global health inequities, protect the world against future pandemics, identify the origins of this pandemic, and builds resilience for communities around the world.



## 'Won't participate in Indian Ocean turf war'

Colombo, Sept 15: Sri Lanka will not take part in any "big power rivalry" in the Indian Ocean and it is unfortunate that his country has been made the "punching bag" for Hambantota. President Ranil Wickremesinghe has said, weeks after India and China clashed over the docking of a high-tech Chinese ship at the country's southern port.

Wickremesinghe said the Indian Ocean region needs to be open to all to ensure freedom of navigation. "That is important for commerce to carry on. We have to remember that the bulk of the petroleum supply and energy supply to the world goes through the Indian Ocean. A large amount of shipping goes through the Indian Ocean. We don't want this to be an area of conflict and an area of war," he said in his speech made at the National

Defense College on Wednesday. Sri Lanka will not participate in military alliances and does not want the problems of the Pacific coming into the Indian Ocean, he said while speaking on the crisishit country's position on the geopolitical stage.

'We don't participate in a military alliance, and we certainly do not want the problems of the Pacific coming to the Indian Ocean. We don't want this to be an area of conflict and an area of war. Sri Lanka will not take part in any big power rivalry," Wickremesinghe said.

His remarks came weeks after the Chinese embassy and the Indian High Commission here clashed verbally over the docking of the Chinese ship 'Yuan Wang 5' at Sri Lanka's southern Hambantota port for replenishment

All those are useful ways in which we cooperate with India and the other island states. Then we also value our friendship with the Maldives, those small islands, and we know how important the Maldives is," he said. Wickremesinghe said that the "geopolitics of the Indian Ocean has unfortunately made Sri Lanka the punching bag for Hambantota.""It is not a military port. Though ours is a commercial port it shows our strategic importance that many people come to conclusions which are unwarranted," Wickremesinghe said, in his second public comment on the issue in recent weeks.

He said that there are around 17 ports that are being operated by the Chinese in the Indian Ocean and all the ports are commercial ports.

According to the report by General SVR, a Russian Telegram channel, Putin's limousine was allegedly hit by a "a loud bang from the left front wheel followed by heavy smoke", but he was unharmed as the vehicle drove to safety, Mirror.co.uk reported. The channel said that the President was returning to his official residence in a decoy or "backup" motorcade amid deep security fears.

The motorcade comprised five armoured cars, with Putin in the third, it said, without mentioning the date of the incident. The Russian leader's car "despite the problems



with control" made its way out of the attack scene to reach the safety of the residence, the channel added.

Without providing details, General SVR said more information on the supposed attack were "classified", reports Mirror.co.uk.

Beijing, Sept 15: China said Thursday that it had lodged "solemn representations" with the United States, after a U.S. Senate panel advanced legislation that would enhance U.S. military support for Taiwan.

If the bill continues to go forward, it would affect U.S.-China relations, Mao Ning, a foreign ministry spokesperson, said at a regular media briefing. Mao also described the new U.S. legislation as sending "a serious false signal to the separatist forces of Taiwan independence."



"China is firmly opposed to this and has made solemn representations to the U.S. side that there is only one China in the world, that Taiwan is an inseparable part of China's territory, and that China will unswervingly promote the complete reunification of the country," the spokesperson said.

The Senate Foreign Relations Committee backed the Taiwan Policy Act of 2022 by 17-5, despite concerns about the bill in U.S. President Joe Biden's administration and anger about the measure from Beijing.

The bill comes over one month after China conducted its largestever military exercises around Taiwan in response to an earlier visit to the self-ruled island by-U.S. House of Representatives Speaker Nancy Pelosi.

## Girls worldwide lag behind boys in math: Unicef

DATA FROM 79 MIDDLE- AND HIGH-INCOME COUNTRIES SHOW MORE THAN A THIRD OF 15-YEAR-OLD SCHOOLCHILDREN ARE YET TO ACHIEVE MINIMUM PROFICIENCY IN MATHEMATICS. HOUSEHOLD WEALTH IS ALSO A DETERMINING FACTOR


New York, Sept 15: Girls worldwide are lagging behind boys in mathematics, with sexism and gender stereotypes among the root causes, according to a new report published by the Unicef.

The report titled, 'Solving the equation: Helping girls and boys learn mathematics' features new data analyses covering more than 100 countries and territories. Published on Wednesday, the report finds that boys have up to 1.3 times the odds of obtaining mathematics skills than girls.

Negative gender norms and stereotypes often held by teachers, parents, and peers regarding girls' innate inability to understand mathematics are contributing to the disparity.

This also undermines girls' selfconfidence, setting them up for failure, the report notes. An analysis of data from 34 low- and middleincome countries featured in the report shows that while girls lag behind boys, three-quarters of schoolchildren in class 4 are not obtaining foundational numeracy skills. Data from 79 middle- and high-

income countries show more than



a third of 15-year-old schoolchildren have yet to achieve minimum

proficiency in mathematics. Household wealth is also a deter-

#### mining factor.

The report notes that schoolchildren from the richest households have 1.8 times the odds of acquiring numeracy skills by the time they reach fourth grade than children from the poorest households.

Children who attend early childhood education and care programmes have up to 2.8 times the odds of achieving minimum proficiency in mathematics by the age of 15 than those who do not. The report also notes the impact of the Covid-19 pandemic has likely further exacerbated children's math-

ematics abilities. In countries where girls are more likely to be out of school than boys, the overall disparities in mathematics proficiency are most likely even wider.

#### Oil slumps 3%

New York: Oil futures fell about 3% to a one-week low Thursday on a tentative agreement that would avert a US rail strike, expectations for weaker global demand and continued US dollar strength ahead of a potentially large interest rate increase. Brent futures fell \$2.70, or 2.95%, to \$91.40 a barrel, while US West Texas Intermediate (WTI) crude fell \$2.79. or 3.2%. to \$85.69. The International Energy Agency (IEA) said this week that oil demand growth would grind to a halt in the fourth quarter.

#### Gems & jewellery exports up by 6.7%

Mumbai: The overall gems and jewellery exports rose by 6.7 per cent in August to Rs 26,418.84 crore (\$3,316.08 million) compared to the same month last year, the Gem and Jewellery Export Promotion Council (GJEPC) said Thursday. The gems and jewellery exports stood at Rs 24,749.69 crore (\$3,334.12 million) during August 2021, GJEPC said in a statement. In August, the overall gross export of cut and polished diamonds (CPD) declined 0.84 per cent to Rs 14,955.8 crore (\$1,879.74 million) compared to Rs 15,082.28 crore (\$2,031.64 million) in August 2021.

## **ONLINE GAMING Govt panel calls for regulatory body**

THE MUCH-AWAITED REPORT IS SEEN AS SHAPING THE FUTURE OF THE MOBILE GAMING INDUS INDIA. ESTIMATED TO REACH \$5 BILLION BY 2025. FROM \$1.5 BILLION THIS YEAR. IT COMES AMID RISING **CONCERNS OVER GAMES CAUSING ADDICTION AND INCONSISTENT STATE LAWS DISRUPTING BUSINESS**

New Delhi, Sept 15: India should create a regulatory body to classify online games as based on skill or chance, introduce rules to block prohibited formats and take a stricter stance on gambling websites, a government panel said in a report seen by Reuters.

The panel of Prime Minister Narendra Modi's top officials has for months been drafting regulations for the country's online gaming sector, where foreign investors such as Tiger Global and Sequoia Capital have backed gaming startups Dream11 and Mobile Premier League, hugely popular for fantasy cricket

Simply defining games has been contentious. India's Supreme Court says the card game rummy and certain fantasy games are skill-based and legal, but at least one state court classified games such as poker as chance-based, or akin to gambling, which is banned in most states.

In its confidential draft report dated Aug 31, the panel of government officials calls for creation of a new regulatory body under India's IT ministry to determine which online games qualify as games of skill, then "seek com-

pliances and enforcement.' To streamline the legal framework, the 108-page report says India needs a new federal online gaming law, which will provide regulatory flexibility "with punishment provisions, along with blocking powers, for the government against prohibited gaming formats". Though the panel considered only

online skill games, and not gambling, which is handled by states, it noted that many offshore betting and gambling websites that are il-

legal in India have become popular among Indian users. The new legal framework would apply to both free and pay-to-play skill games. A senior government source

said that although the federal government could classify chancebased games as harmful, it would let states make the final call on whether to allow gambling. The report noted that state gov-

ernments already find it "difficult to implement and monitor geo-fencing measures" to ensure that no user in their region is ac-

cessing an illegal forms of gambling or gaming.

The IT ministry will finalise the report after receiving further comments from panel members including the heads of the revenue and sports ministries. It will then be sent to the cabinet secretariat for approval, though there is no timeline for finalisation.

#### **DE-ADDICTION MEASURES**

A senior gaming industry executive said the recommendation that a regulatory body evaluate different formats of online games could raise entry barriers for new players and increase scrutiny of companies' current offerings.

The government report noted that proliferation of such games among the youth had led to addiction that often caused financial losses, with some reported cases of suicides.

The report calls for laws and rules to include so-called "de-addiction measures" such as periodic warnings and advisories and fixing deposit and withdrawal limits. It also calls for "responsible advertising".

A 2020 report by Indian trade group FICCI and consulting firm EY stated that of Rs 65 billion (\$817 million) garnered by online gaming industry the previous year, transaction-based gaming, including real-money, contributed 71%, or Rs 46 billion

Endorsements by top Indian cricketers and other marketing efforts have boosted appeal and investor interest of real money gaming apps. Dream11 commands a valuation of \$8 billion, while Mobile Premier League is valued at \$2.5 billion, PitchBook data shows. By 2021, there were 95 million paying gamers in India.

For online games such as fantasy cricket on Dream11, paid contests remain the popular attraction. Users can create their teams by paying as little as Rs 14 (17 US cents), with a total prize pool of Rs 7 million (\$88,000) up for grabs by winners. The top ranking performer can take home Rs 275,000 (\$3,462).

After receiving suggestions from India's revenue department, the government panel stated that online gaming companies should be required to report any "suspicious transactions" to the government's Financial Intelligence Unit.

## Saudi pips Russia to become India's 2nd biggest oil supplier

India's monthly oil imports from Russia have been declining after hitting a record in June as Moscow has narrowed the discounts offered for its oil while refiners lifted more *term* supplies

New Delhi, Sept 15: Saudi Arabia emerged as the second-biggest oil supplier to India after a threemonth gap, overtaking Russia by a thin margin, while Iraq retained the top spot in August, data from industry and trade sources showed. India, the world's third biggest oil importer and consumer, shipped in 863,950 barrels per day (bpd) of crude from Saudi Arabia, up 4.8% from the previous month, while purchases from Russia fell 2.4% to 855,950 bpd, the data showed.

Despite Saudi's gain, the share of oil from Organization of the Petroleum Exporting Countries in India fell to 59.8%, the lowest in at least 16 years as India cut African imports.

India has become Russia's No 2 oil buyer after China as others have cut purchases following Moscow's invasion of Ukraine in late February.

The two countries, keen to secure raw materials at discounts compared with supplies from other countries, are seen as cushioning the impact of western sanctions on Moscow.

Higher intake of Caspian sea oil, mainly from Kazakhstan, Russia and Azerbaijan, have hit India's purchases from Africa and other countries.

African oil's share in August halved to 4.2% while Latin America's share fell to 5.3% from about 7.7%. the data showed.

In August, the United Arab Emirates stayed at No 4 while Kazakhstan replaced Kuwait to become fifth-largest oil supplier to India, followed by the United States.

Increased purchases of Saudi and Emirati oil raised Middle East's share in India to 59% in August from 54% in July while that of CIS nations rose to about a quarter from 23%, the data showed.

Russian oil accounted for about 16% for India's overall imports in April-August, the first five months of this fiscal year, at 757,000 bpd compared with 20,000 bpd a year earlier, or a 0.5% share, the data showed.





### Air passenger traffic rose 5% in Aug: Icra

New Delhi, Sept 15: Domestic air passenger traffic rose 5 per cent to 1.02 crore in August and a fastpaced recovery in the traffic is expected this fiscal on the back of normalcy in flight operations and widening vaccination coverage, according to rating agency Icra.

Releasing the monthly domestic air passenger traffic data for August Thursday. Icra further said that international traffic for Indian carriers surpassed the pre-Covid level of around 19.8 lakh by 32 per cent.

'The domestic aviation industry continues to witness recovery, with domestic passenger traffic for August 2022 estimated at around 102 lakh, around 5 per cent higher compared to around 97 lakh in July 2022 and around 52 per cent higher in comparison to the domestic passenger traffic in August 2021, although it fell short by around 14 per cent, compared to pre-Covid levels i.e. August 2019," Icra's Suprio Banerjee said.

In the first five months of this fiscal, domestic passenger traffic is estimated at nearly 5.24 crore, a year-onyear growth of nearly 131 per cent.

Icra noted that the airline's capacity deployment in August was around 37 per cent, compared to theyear-ago period but lower by nearly 10 per cent than the pre-Covid level.

### 'India emerges as Sri Lanka's top lender in 2022' Samsung sets zero emissions target

## 'OLD BOY' HAALAND SINKS DORTMUND

Manchester, Sept 15: The cross reached Erling Haaland at shoulder height, about a meter in front of the Manchester City striker. No problem for this generational talent.

Producing a spectacular acrobatic volley with the outside of his left foot, Haaland completed a late comeback by City against Borussia Dortmund — the German club he left in the offseason — in a 2-1 win in the Champions League Wednesday.

Dortmund kept their former star in check for almost the whole game, with City unusually sloppy in possession and getting increasingly frustrated at Etihad Stadium.

Indeed, Pep Guardiola's team hadn't even had a shot on target before John Stones - a center back playing out of position at right back — popped up just outside the area and, egged on by the home crowd, smashed a swerving shot high into the net from outside

the area in the 80th minute. Haaland's winner four minutes later was even better: Joao Cancelo sent in a cross from the left with the outside of his right foot and Haaland showed amazing agility to leap high and redirect the ball into the net with his left foot

Guardiola said it reminded him of a famous goal scored by Johan Cruyff for Barcelona against Atlético Madrid in 1973-74.

Haaland impressed himself, too, with the goal that took his overall tally in the Champions League to 26 in 21 games. Asked if he thought Dortmund defended well against him, Haaland said: "They didn't stop me. I scored."

The Norway striker has now scored in six straight games for City in all competitions, and 13 in eight games in total. This was one of his quietest games in a City shirt. Yet he still scored.

"That shows his quality," said Dortmund midfielder Jude Bellingham, who put the German team ahead in the 56th. "He's not always in the game, but you give him half a sniff and it ends up in a goal."

City has opened Group G with two straight wins in its latest bid for a first Champions League title, and now heads into a double-header against FC Copenhagen. Two wins against the Danish champions and City might seal a place in the last 16 with two games to spare.

Guardiola was not happy with his team's performance against Dortmund, however. "We played in the wrong gear today (Wednesday)," he said. "No aggression. Incredibly passive."

After a forgettable first half that saw Dortmund successfully smother City, Bellingham gave the visitors the lead by darting in between Manuel Akanji and Haaland who were his teammates last season — and glanced in Marco Reus' cross from the left.

City was transformed after the introduction of Bernardo Silva, Phil Foden and Julian Alvarez in a triple substitution. "They changed our pace and there were two excellent goals," Guardiola said.

New Delhi, Sept 15: Experienced hockey midfielder Namita Toppo, who has played more than 150 international matches after making her senior India debut in 2012, Thursday decided to call time on her career.

The 27-year-old Toppo, hailing from Sundargarh district, was part of the Indian team that won bronze and silver medals in the 2014 and 2018 Asian Games respectively.

"The last 10 years have definitely been the best years of my life. I had a dream to play for my country at the biggest stages and I am so happy that I have been able to achieve my dreams," Toppo said in a Hockey India release.


"I hope I have made a huge impact and I am very thrilled to see the way the Indian Women's Hockey Team has progressed in the last decade. I will keep cheering and supporting for the team while I move on to a new chapter in my life."

Toppo is a product of the Sports Hostel, Panposh, Rourkela. She first represented her state team in 2007 and her performances in domestic competitions saw her getting selected for U-18 Girls Asia Cup in Bangkok, Thailand in 2011 where India won a bronze medal. She was first selected to represent the senior national team in 2012 in the FIH Champions Challenge I in Dublin.

She was a part of the Indian junior team which won bronze at the 2013 FIH Women's Junior World Cup in Mönchengladbach, Germany. Toppo took part in major tournaments like FIH Women's World League Round 2 in 2013 where India won gold, 3rd Women's Asian Champions Trophy in 2013 where India won a silver.

She also took part in the 2014 Commonwealth Games, 2014 Asian Games where India won a bronze and the 2016 Rio Olympics.

Hockey India congratulated the two-time Asian Games medallist for her contribution to the port in the



country's game. "Namita has a made a humungous contribution to Indian hockey. Apart from giving everything on the field, Namita has also been a perfect role-model for the youngsters in the team," national team chief coach Janneke Schopman said.

"Not many players get a chance to play 168 matches for their national teams and Namita has earned each one of those caps. Apart from being a great hockey player Toppo is one of the kindest people I know. She is very thoughtful and she always put the team first.

London, Sept 15: Roger Federer, regarded by many as the greatest male player to wield a tennis racquet and who took the sport to new levels during a career spanning more than two decades, has announced he will retire after next week's Laver Cup in London.

The 41-year-old, who won 20 Grand Slam singles titles and redefined a sport with his artistry and grace, broke the news tennis fans across the world have feared in a lengthy statement Thursday.

A knee injury meant he has not played a match since losing at last year's Wimbledon although many still believed he could come back for one last golden farewell. But he said his age had finally caught up with him.

"As many of you know, the past three years have presented me with challenges in the form of injuries and surgeries," Federer said in an emotional statement posted on Instagram

"Tve worked hard to return to full competitive form. But I also know my body's capacities and limits, and its message to me lately has been clear. I am 41 years old.

"I have played more than 1,500 matches over 24 years. Tennis has treated me more generously than I ever would have dreamt, and now I



must recognize when it's time to end my competitive career. The Laver Cup next week in London will be my final ATP event. I will play more tennis in the future, of course, but just not in Grand Slams or on the tour.'

Federer, who dominated men's tennis for several years after winning his first Grand Slam title at Wimbledon in 2003, has been troubled by injuries in recent years. He has undergone three knee operations in the last two years and his last competitive match was a quarter-final defeat against Poland's Hubert Hurkacz at the 2021 Wimbledon.

Federer had offered some hope to his legions of fans when he said he planned to return to the tour after

teaming up with long-time rival and friend Rafa Nadal to play doubles at the Laver Cup in London next week.

He had also planned to play at the Swiss indoors tournament at home in Basel. "This is a bittersweet decision, because I will miss everything the tour has given me," Federer, who has two sets of twins with wife Mirka, added.

"But at the same time, there is so much to celebrate. I consider myself one of the most fortunate people on Earth. I was given a special talent to play tennis, and I did it at a level that I never imagined, for much longer than I ever thought possible.'

Federer first served notice of his special talent when he beat American great Pete Sampras on his way to the quarterfinals at Wimbledon in 2001.

Two years later he outclassed Mark Philippoussis on Wimbledon's Centre Court to begin his Grand Slam collection. Federer went on to win seven more Wimbledon titles, claimed five US Open titles, six Australian crowns and a single French Open achieved in 2009 to complete his career Slam.

He also holds the record for 237 consecutive weeks as World No.1 and the only omission from his glittering CV is an Olympic singles gold medal, losing to Andy Murray in the 2012 final.
