New Delhi, Sept 20: The Karnataka government order that kicked up a row over hijab was 'religion neutral', the state government told the Supreme Court Tuesday, launching a strong defence of the state and blaming the PFI for the controversy it claimed was part of a 'larger conspiracy'.

Insisting that the agitation in support of wearing hijab in educational institutions was not a 'spontaneous act' by a few individuals, it said the state government would have been 'guilty of dereliction of constitutional duty if it had not acted the way it did.

Solicitor General Tushar Mehta, appearing for Karnataka, told the court the Popular Front of India (PFI) started a campaign on social media which was designed to create an agitation based on 'religious feelings of the people'.

The PFI is widely viewed as a hardline Muslim organisation and has been blamed for several incidents of communal violence, provoking calls for imposing a nationwide ban on it. The organisation itself has rejected the allegations.

Mehta told a bench of Justices Hemant Gupta and Sudhanshu Dhulia that the PFI started the social media campaign over the Islamic headscarf earlier this year and there were continuous social media messages asking students to 'start wearing hijab'.

"In 2022, a movement started on the social media by an organisation called the Popular Front of India and the movement, as an FIR which was lodged subsequently suggested and now culminated into a charge sheet, was designed to create a kind of an agitation based on religious feelings of the people and as a part there were continuous social media messages that start wearing hijab," Mehta said.

"This is not a spontaneous act of few individual children that we want to wear a hijab. They were a part of a larger conspiracy and the children were acting as advised," Mehta told the bench.

Youth beats brother to death

Bhubaneswar, Sept 20: A 21-yearold youth was allegedly beaten to death by his elder brother for neglecting his studies in Nayapalli area here, an official said Tuesday.

According to Nayapalli police, they received information from the outpost at Capital Hospital late Monday night that Rajmohan Senapati of Baramunda area was brought to hospital for treatment and he was declared 'received dead'.

Upon reaching Capital Hospital, police learnt that Rajmohan, who hailed from Itamati area of Nayagarh district, was brought to the healthcare facility by his elder brother—Biswamohan Senapati, 24—around 11:30pm in an unconscious state.

Nayapalli IIC Biswaranjan Sahoo said Rajmohan's body bore multiple injuries. "And when questioned about the injuries, Biswamohan confessed to his crime," said Sahoo.

interrogation, During Biswamohan, an MBA graduate who stays at Nua Sahi under Nayapalli police limits here, said that he was very disturbed as his brother, who stayed with his friends

in Baramunda area, was neglecting his studies for a long.

"On Monday night, Biswamohan asked his brother to meet him at his Nayapalli residence. Upon reaching, Rajmohan was reprimanded by his elder brother over studies. Soon, a mountain was made out of a molehill and Biswamohan beat him mercilessly. An injured Rajmohan left his brother's house for Baramunda where his health deteriorated," the IIC said, quoting the statement of the accused.

After learning about Rajmohan's deteriorating heath, his brother reached Baramunda and rushed him to Capital Hospital.

'We've registered a case (629/22) under Section 302 (murder) of IPC and Biswamohan has been taken into custody," said Sahoo.

KABADDI PLAYERS **SERVED FOOD** STORED IN TOILET

Saharanpur/Lucknow (UP), Sept 20: Kabaddi players at a state-level tournament in Uttar Pradesh's Saharanpur were allegedly served food that was stored in a toilet, prompting the authorities to suspend the district sports officer (DSO) for laxity and blacklisting the caterer.

The incident drew criticism, with

ruling BJP's Pilibhit MP Varun Gandhi asking if Indian sports should be cleansed of politicians and their representatives to reach its zenith. Delhi CM Arvind Kejriwal too

took a swipe at the incident, asking how Indian sportspersons would win gold at the Olympics if they are treated this way. A purported video of the incident

that surfaced on social media showed the athletes, who took part in the sub-junior girls' kabaddi tournament at Dr Bhimrao Ambedkar Stadium in Saharanpur, being served rice and 'poori' stored in the toilet. The tournament was hosted from September 16 to 18 in which over 300 players from 16 divisions of the state took part.

Additional Chief Secretary (Sports) Navneet Sehgal said that Saharanpur DSO Animesh Saxena has been suspended and the District Magistrate (DM) will probe the matter.

DM Akhilesh Singh said, "The rice and 'pooris' were kept in a toilet. The video, which went viral on social media, showed the players taking the food kept inside the toilet.'

'It had also come to our notice that the food was cooked on the swimming pool premises and then stored in the toilet. The 'pooris' were spread on a piece of paper while rice was half-cooked," Singh pointed out.

As many as 1,442 accidents took place due to overloaded/hanging vehicles in 2021. A total of 673 people were killed due to the load condition of the vehicles. Moreover, a total of 834 persons were grievously injured and 588 had minor injuries in accidents involving overloaded vehicles.

Fines have been imposed on other vehicles for various offences. A total of 800 e-challans were issued for flouting other MV rules, 26 vehicles were detained and compounding fees of ₹7, 78,120 was collected

In August, 83 e-challans were issued, 25 vehicles were seized and 81 DLs were suspended during the drive against overloading. Compounding penalties of ₹3, 69,461 were collected. The special drive will continue till September 25. Enforcement squads have been asked to conduct such drives at regular intervals.

PROPOSED UNIVERSITY IN PURI

Exclude river, nallas from acquisition: SC

New Delhi, Sept 20: Raising apprehension about the 'permissible possession' of river and nallas given by the Odisha government to Anil Agarwal Foundation (AAF) for the proposed university in Puri, the Supreme Court Tuesday observed that the water bodies must be excluded from the acquisition and the foundation cannot claim ownership of the water bodies.

"Can river and nallas be given to the purpose of university? Why Permissible possession word is used? It is impermissible. Let the nallas and river be excluded from the purpose of acquisition," the bench said.

A two-Judge bench of Justices MR Shah and Krishna Murari asked the AAF as to what will happen to the portion of land connected with the wildlife sanctuary if the Ministry of Environment and Forest refuses to grant clearance for construction activities in

Senior advocate CA Sundaram submitted before the court that if MoEF doesn't grant environmental clearance, the land will vest with the state government. On the issue of river and nallas, Sundaram submitted that the foundation has been barred from conducting any beautification drive and making any modification to natural water course of river and nallas.

Opposing the PILs filed in the Orissa High Court, the senior advocate submitted that a PIL petitioner has no locus standi at all. He further submitted that only seven land holders comprising 0.3 per cent of the total land are actually aggrieved by the acquisition while 99.7 per cent have taken the compensation and ex gratia. On the issue of environment, Sundaram submitted that the foundation will seek the clearance from the MoEF before commencing construction activities and at that point a PIL pe titioner can move if the foundation is found to be in conflict of environmental norms but at this stage it is premature.

"It is premature for a PIL litigant to file a writ petition saying I apprehend there will be loss to environment," the senior advocate said.

New Delhi, Sept 20: The Supreme Court Tuesday reserved judgement on a petition challenging the abolition of the Orissa Administrative Tribunal (OAT).

SC reserves verdict

A two-judge bench of Justices DY Chandrachud and Hima Kohli concluded the arguments on a petition filed by Orissa Administrative Tribunal Bar Association against a High Court order upholding the notification issued by the Department of Personnel and Training of the central government dated August 2, 2019 which abolished OAT. The bench asked the counsels to file written submissions by Friday



general Ashok Parija submitted that as many as 49,817 cases were transferred to Orissa High Court after the abolition of OAT and 38,226 cases have been disposed of. He further submitted that 11,591 cases are pending currently. Advocate Sibo Sankar Mishra, appearing for Orissa HC. submitted that as many as eight judges of the High Court have been assigned to hear the transferred cases and fresh service matters.

The HC had earlier noted in its order that there was sufficient material to support the view of the state government that OAT has not served the purpose of delivery of speedy justice to litigants.

The district authorities and local bodies have been asked to create awareness among the public regarding water pollution caused by idol immersion and appeal the public to purchase eco-friendly idols made up of natural clay and

coloured with natural dyes. In case of immersion of idols in rivers and lakes, arrangements should be made for construction of temporary confined ponds, with earthen bunds and removable synthetic liner. Identify the immersion sites at the points where the flow in stream is naturally available, it said. Within 24 hours of the immersion. the leftover materials from the immersion site should be removed for disposal at designated municipal dump sites and the supernatant water may be allowed to flow into the

water, suggested the OSPCB.

They have been advised to conduct immersion the idols at their homes in eco-friendly manner or immerse the idols in the design nated on-land temporary artificial ponds or tanks located nearby or artificial movable tanks arranged by the local bodies.

As per the Odisha Prevention and Control of Water Pollution (Procedure for Immersion of Idol after Pujas) Rules, 2021, idol makers who violate the norms could be prohibited from idol making for two years. The deposition of the idol manufacturers towards registration fees will also be forfeited.

Further, for violation of norms by the Puja committee organisers, the concerned local bodies can impose penalty on such organisers.

In case the Puja Committee is lo cated within the panchavat area. ₹3,000 fine will be imposed while ₹5,000 fine will be collected in case the committee is located in the area of municipality or Notified Area Councils (NAC)

Kurmi stir for ST tag in Odisha, 2 other states

Kolkata/Baripada/Ranchi, Sept 20: Kurmis Tuesday blocked railway tracks in various parts of eastern India demanding Scheduled Tribe (ST) status and inclusion of Kurmali language in the Eighth Schedule of the Constitution, affecting train services in West Bengal, Jharkhand and Odisha.

Agitators squatted on railway tracks at various places, leading to cancellation, short-termination and diversion of several trains.

Train services of South Eastern Railway (SER) were partially affected due to blockades at Kustaur and Nimdih stations in Adra division, Khemasuli and Bhanjpur stations in Kharagpur division and Aunlajori station in Chakradharpur division since 4am, a railway official said.

Basant Mahanta, an advocate, alleged that the state government has not recommended the inclusion of Kurmi community in the ST list despite the CM's assurance. Around 25 lakh Kurmis reside in Odisha, mainly in Mayurbhanj, Sundergarh, Balasore, Jajpur and

Sambalpur districts. The stir comes barely two days after Patnaik wrote a letter to Union Tribal Affairs Minister Arjun Munda seeking the inclusion

of 160 communities in the ST list. Patnaik, in the letter, claimed that since 1978 the Odisha government has recommended the inclusion of 160 communities of the state in the ST list but the recommendations have not been accepted.

The chief minister said that these communities were "victims of historical injustice" due to delay in their inclusion in the ST list.

Climate Inequality

f the United States' Pledge of Allegiance were rewritten for the world of the twenty-first century, the clause "and justice for all" could well be L changed to "and climate justice for all," given that issue's paramount importance. A painful lesson from the last few decades - not only in the US but around the world - is that the adverse effects of climate change are not distributed equitably among countries and communities. While the climate crisis has devastating implications for all of us, the United Nations Secretary-General António Guterres rightly points out that "the poor and vulnerable are the first to suffer and the worst hit

According to the world's authoritative climate-science body, the Intergovernmental Panel on Climate Change (IPCC), declines in crop production and quality, increases in crop pests and diseases, and other disruptions have disproportionally affected the poor, just as increasingly frequent and extreme heat disproportionally threaten children and the elderly. As climate change simultaneously disrupts food, human, water, and ecosystem security, we can expect many more adverse cascading effects.

Extreme flooding, for example, is expected to become twice as frequent in the flood-prone areas that are home to some 450 million people. More broadly, the IPCC points to 2017 research showing that by 2030, 122 million people

(mostly the poorest 20 per cent across 92 countries) could be pushed into extreme poverty by higher food prices and other climate-driven in-

Compounding the injustice, the biggest contributors to climate change are not necessarily those most affected by it. According to a 2020 report by Oxfam and the Stockholm Environment Institute, between 1990 and 2015, the richest 1 per cent of the global population accounted for twice the carbon dioxide emissions relative to the poorest 50 per cent.

Yet poor countries bear a larger share of the costs, simply because around 75 per cent of people living in poverty depend on agriculture, which is extremely sensitive to irregularities in weather and broader climatic changes. Poor countries are also more prone to resource conflicts, and they tend to lack adequate technology, infrastructure, policies, and resources for adaptation.

Moreover, climate change amplifies pre-existing forms of inequality and drives more migration and forced displacements. In Latin America, one of the most unequal regions in the world, many native groups - such as the Guna people in Panama, the inhabitants of the Mexican state of Chiapas, and some Aymaran groups in Bolivia – have lost their towns to ris-

ing sea levels, drought, water scarcity, deforestation, changing rainfall patterns, and natural disasters. Worse, when these groups are forced to leave their traditional lands, they often end up in urban slums, where they face double discrimination as migrants and indigenous peoples.

This human tragedy is growing in scale. The UN World Migration Report 2022 notes that in 2020, natural disasters, extreme temperatures, and droughts displaced 30.7 million people in 144 countries and territories. And contrary to popular belief, the report explains that most new internal displacement in Latin America and the Caribbean that year was due to natural disasters, rather than to violence and conflict.

Climate change also has unequal adverse effects on health and education. The UN's Human Development Report 2019 forecasts that between 2030 and 2050, climate change will cause some 250,000 additional deaths per year from malnutrition, malaria, diarrhoea, dengue, and heat stress. And rising temperatures will increase malnutrition and food insecurity and expand the geographical range of disease-transmitting mosquito species, hampering school attendance, performance, and achievement.

These problems have made climate-justice policies and strategies essential to the Global South, and particularly to Latin America. Policymakers will need to focus on ensuring a fairer distribution of obligations and duties not just between states but also across segments of the population and

Furthermore, climate justice demands that developed countries and multinational corporations assume responsibility for the negative externalities they generate. They must pay their "climate debt" to the rest of the world and acknowledge the intergenerational implications of climate-driven inequality. Like the poor today, younger and future generations will pay the biggest price for a problem they didn't cause.

This year's international gatherings at the UN General Assembly and the Climate Change Conference (COP27) in Sharm el-Sheikh will succeed only if the international community makes progress toward a new framework to provide developing countries with the financial and technological support they need to adapt to climate change

Though concrete measures to deliver climate justice are well known, they have proved difficult to implement. Still, there have been promising steps in the right direction. In the US, for example, the Biden administration has launched a "whole-of-government initiative" (Justice40) to ensure that federal agencies deliver 40 per cent of the overall benefits of clean energy, sustainable housing, and clean water to underserved communities. It has also created an Environmental Justice Advisory Council that other countries should consider replicating.

Although major economies bear the largest responsibility for curbing the devastating effects of climate change, all countries must adopt responsible policies to mitigate the damage and protect their most vulnerable inhabitants.

In Costa Rica, we understood the importance of enacting such policies very early on. That allowed us to become an early leader in renewable energy and the first tropical country to halt and then reverse deforestation. Sustainability policies have improved conditions for indigenous and vulnerable communities here as well as in Colombia and Ecuador, by helping communities find new ways to increase income (diversification of means of life) and promote climate-aware and resilient agriculture techniques (such as retaining soil moisture or using crop varieties better adapted to droughts).

These and many other actions taken in various countries should encourage those who will soon meet again in the framework of COP27 and the UNGA. The challenge is to scale up all the efforts underway to win the race against humanity's greatest existential threat, leaving no one behind.

It's not a word that rises unbidden to the lips of English speakers today, nor - if the record is to be trusted - at any time. It means a thing without value or use. It was borrowed from French, where it may still be found in dictionaries, though firmly marked as literary. According to the lexicographer Emile Littré, who compiled a famous dictionary of French in the middle decades of the nineteenth century, it's a bastardised form of the Latin breviarium, the source of breviary for the service book used by Roman Catholic priests. The link had been explained by another lexicographer two centuries earlier. Randall Cotgrave wrote in his French-English dictionary of 1611 that the word came to mean "foolish charms or superstitious prayers, used by old and simple women against the toothache, and any such threadbare and musty rags of blind devotion", hence something valueless.



DEPRIVATION, DISPARITY

IT IS INDEED **DISTRESSING TO NOTE THAT DEPRIVATION HAS NOT BEEN ADDRESSED JUDICIOUSLY BY** THE POLITICAL **LEADERS OF THE COUNTRY**

eprivation, which is the consequence of socioeconomic disparity in our system, primarily due to the caste-system and other attendant factors, is still a crucial problem despite 75 years of Independence having passed and the matter still not receiving the attention it deserves. The compartmentalisation of the traditional Hindu society into various caste-groups is a social institution dictating superior and lesser beings among its members. This system that places the untouchables at the bottom of the caste-pyramid is one of the obvious institutions of caste-inequality, a system of legalised inequality, wherein the allocation of roles and status is governed by its own principles, determining the social, economic, political and ritualistic structure of individuals in relation to each other.

The caste-system in India has had its impact on all aspects of life; on the past, present, and future, based on purity and pollution. Unfortunately, birth determines the individual's social status throughout his life and also his access to various resources. The deprived masses described as Scheduled Castes and Scheduled Tribes in the Constitution are in fact low castes and tribes in the Hindu social order, treated as 'caste-less', outcastes or untouchables and have been subjected to deprivation and discrimination for centuries.

The last seven decades of Independence witnessed a massive social mobility and transformation as well as the emergence of 'the educated' among the deprived castes, generally looked down upon with contempt by the larger society for their mobility on the crutches of reservations. Although untouchability is outlawed and the caste-system is not overtly practiced, at least in the bigger cities, there are other ways of isolating and segregating them similar to abolition of slavery in the USA, where injustice to African Americans continued until the passing of the Civil Rights Act.

But in our country, the emergence of the 'educated among the deprived' and their journey from traditional defiling occupations to white-collared office jobs was negligible and even exposed them to various psycho-

logical and physical vulnerabilities causing mental health strains. This continues even today.

It is indeed distressing to note that deprivation has not been addressed judiciously by the political leaders of the country. One may refer here to a recent report 'Status of Adivasi Livelihoods Report, 2021' (SAL), brought out by the Professional Assistance Development Action which showed the startling deprivation of adivasis in terms of income, food security and child nutrition as well as in access to public services, education and landholding. This comes at a time when leaders are talking big about the achievements of the country in the last 75 years and on the other hand the ruling NDA-led by BJP saying precious little has been done to improve their lot.

The SAL further found that 55 per cent of adivasi households in Jharkhand and a similar percentage in Odisha are food insecure in varying degrees. Insignificant landholding is another crucial contributor to the poor livelihood outcomes of adivasis. Also around 89 per cent in Jharkhand and around 70-75 per cent in Odisha were found to be marginal farmers or landless labourers. That India has a woman tribal leader as the President of the nation, it

would be worth keeping a watch on whether at the end of five years the adivasis' lives improve.

Though adivasis constitute 8.6 per cent of the total population of the country, they make up 50 per cent of the people who have been displaced or dispossessed from their land for the extraction of minerals, construction of large dams or establishing wildlife sanctuaries or even for widening roads and highways after Independence The condition of Scheduled Castes who live in rural and backward regions of the country may be slightly better but not great. The idea of development has

been lopsided and efforts to lift the lower castes into the mainstream of life and activity has not fructified. The main reason for this is the fact the upper castes, who have been in positions of authority, had very little idea of the poverty and squalor of the lower castes. Moreover, they were ignorant of the social position of these castes in the backward regions of the country and the exploitation. even torture, they have been subjected to for years together.

What appears strange is the failure of successive governments to tackle this deprivation though many big projects have been taken up - all geared to make life easy for the rich and middle income sec-

tions of society. For decades since Independence, there was no national plan of rehabilitation and this section found no solace though they were divested of their small plot of land for so-called development projects.

Over the years all talks of 'social change' and/or 'structural re form' were echoed by political leaders and social analysts but these had little effect on transforming the lives of tribals. Obviously, those who visualised these aspects/phrases were ignorant of the condition of tribals and other lower castes and what measures were needed to improve their incomes. Even now, there is no structured plan to reach out to the deprived.

The communitarian approach to living has not become a reality. Not just education per se but lack of social education deprived us to view human beings not on the basis of caste, class or religion but as responsible members of society. The egoistic approach of our leaders percolated to the ground levels and social discrimination continued.

The obvious question that arises is what needs to be done at this juncture? Reservation has not solved the problem as those lower castes who have received employment forget about their suffering brethren. In fact, they refused to keep contact with their larger family as also of the original village or town. Thus, the strategy has to be different

One is inclined to refer here to a recent observation in Bangalore of the noted author, Arundhati Roy, who stated: "What is it that has brought us to a situation where people who are oppressed, people who have no employment, people who are sufferings deeply are voting for further hellishness upon themselves?" Further, she asked: "What has brought people to believe propaganda more than the reality of their experiences every day in their own homes and in their kitchen? Why is it that people who have been oppressed by the caste system for centuries vote for those very people who uphold that system?" These answers need to be investigated before we can assure a life of dignity to the deprived and oppressed

nmanned aerial vehicles, commonly known as drones, have existed for a long time. but they've mostly been used in military operations. It's only been in the last decade or so that drones have become widely available, allowing farmers, businesses and others to use them in a variety of ways. And yet, I am still waiting for my first delivery of biryani by

Why is it taking so long? Do I need to donate a drone to my local birvani

Now you may be asking, "Why do you need biryani by drone? Why can't you just use a delivery platform such as Uber Eats or Zomato?"

These are good questions. All I can say is that I've been teased by the whole concept of delivery by drone. And I've been patiently waiting to experience it firsthand. I'm eager to see if a drone can bring food to me without cutting an overhead wire and knocking out power for my entire neighbourhood.

It has been more than eight years

since Francesco's Pizzeria made India's first food delivery by drone, sending a pizza to a customer 1.5 km from the restaurant. The restaurant's chief executive was confident that such deliveries would be routine in a few years. But as far as I know, hardly anyone has been able to get pizza by drone, though Domino's and other pizza companies have been testing the concept. More exciting to me is the

prospect of getting biryani by drone. This is still in the testing phase, unfortunately. Biryani by Kilo, the birvani and kebab chain. recently made several test deliveries by drone in Hyderabad. I was very happy to hear this. I would be even happier if the company responded to my email, asking an important question: How do I sign up for a test delivery?

Drones are already being used successfully in a number of ways, including these three:

1. Aerial views. Drones provide overhead shots during outdoor events without requiring a helicopter or balloon. They allow movie directors to easily give us an aerial view, in case we are wondering what the scene looks like to a bird.

2. Spraying pesticides. Farmers are using drones to apply pesticides to their crops. They're also using drones to check the health of their crops, monitor field conditions and awaken the farmhands from their naps

3. Delivering medicine. During the pandemic, the Indian government used drones to deliver medicines and vaccines to rural parts of Telangana. This initiative was called "Medicines from the Sky."

Unfortunately, it's going to be a long time before I experience an initiative called "Birvani from the Sky." Getting any type of package delivered by drone is a long way away. As Thomas Black of Bloomberg.com noted in a recent column, the challenges of home delivery are both technical and strategic.

The technical challenge is mostly about safety. How do you get a drone

to navigate all the hazards in a dense city and deliver a product to an individual home? The drone may deliver an item to your doorstep, but return to the Flipkart distribution center with the underwear on your clothesline.

Using a parachute to drop the package may be more feasible, as long as you don't mind fishing your new cellphone out of your neighbour's swimming pool.

Strategic concerns pose a bigger hurdle, according to Black. While a delivery van can make a delivery to you and other consumers during the same trip, bringing down the cost of each delivery, drones can make only a single delivery at a time. This point-to-point delivery is quite inefficient. You'd be paying too much to get a delivery by drone.

In an urgent situation, it might be worth it. If I need medicine urgently, a drone could drop it off within a few minutes. If I need biryani urgently, I might need to dash to the nearest restaurant.

Spot the disease

Sir, October will be observed as the International Breast Cancer Awareness Month. Contrary to general perception, breast cancer is a disease that is completely curable if diagnosis is made at the right time. A high index of suspicion is very vital to catch an early breast malignancy. Breast malignancy is one of the few malignancies that has strong socioeconomic predilections. Women must be taught the art of palpating or examining their own breasts. In this context, the role of local doctors is of paramount importance as they have to spot the disease and refer the patients to specialists. Irrespective of the stage, breast cancer treatment is a long drawn process that tires the patient and their relatives physically, mentally and financially. Radiotherapy and chemotherapy, two key treatment modalities apart from surgery, have to be used judiciously by the doctors and, most of the times, they do so. A gap in treatment, disobeying the advice of the treating doctor, is like a loose cycle chain, and the patient may be deprived of the benefit of the entire treatment they may have received till that point in time. Patients who complete a standard treatment protocol will be asked to follow-up regularly for at least the first five years, and not missing the visit is crucial for the woman. Breast cancers are known to run in families and if a mother or a sister is affected by the disease, it is imperative for the daughter and other sisters to undergo basic tests like mammography, which is an X ray of the breast, as per the oncologist's advice. Rahul, Kejriwal promise to restore OPS

Vadodara/New Delhi, Sept 20: Congress leader Rahul Gandhi and Aam Aadmi Party chief Arvind Kejriwal Tuesday promised to restore the old pension scheme (OPS) for government employees if voted to power in Gujarat, amid a renewed focus on the issue in the recent state elections.

Rahul Gandhi said the old pension scheme (OPS) has been reintroduced in party-ruled states of Rajasthan and Chhattisgarh and it will now be done in Gujarat too."By abolishing the old pension, the BJP has made the elderly dependent from self-reliant," he said in a tweet in Hindi. "The government employees

who strengthen the country have a right: The old pension."We restored the old pension in Rajasthan, Chhattisgarh. Now the Congress government will come in Gujarat and will bring the old pension," Gandhi also said, using the hashtag #CongressDegiOldPension.

Thousands of retired government employees in Gujarat recently held protests demanding the re-introduction of the scheme.

Rajasthan Chief Minister Ashok Gehlot, who announced the revival of the OPS in the budget speech in February, on Tuesday said that the scheme will be implemented in both Gujarat and Himachal Pradesh if the Congress forms government

Kejriwal, who is campaigning in Gujarat, said Punjab Chief Minister Bhagwant Mann has issued an order considering the implementation of the old pension scheme in the AAP-ruled state."Government employees in Gujarat have taken to the streets in large numbers. Their main demand is the implementation of the old pension scheme. I guarantee them that when AAP forms a government, we will implement the OPS in Gujarat," Kejriwal told reporters.

The old pension scheme was discontinued on April 1, 2004 and replaced by the National Pension Scheme (NPS). Under the old scheme, the employee used to get the Dearness Allowance-linked pension. In this scheme, the pensioners used to get the benefit of enhanced pension every six months due to the periodic hike in dearness relief.

However, this DA-liked per

was discontinued for all government employees who joined service on or after April 1, 2004, effectively reducing the burden of the pension bill on the state exchequer. These employees were covered under the NPS

Samajwadi Party president Akhilesh Yadav had in January announced the restoration of the old pension scheme as a poll plank in Uttar Pradesh, while attacking the BJP for scrapping the scheme in 2004. It was dubbed as a game changer by some poll observers who predicted an increase in the Samaiwadi Party's support among the state government employees. Though the SP failed to dislodge the BJP, its performance improved. BSP president Mayawati, while addressing an election meeting in Auraiya, too had promised the OPS.

According to the Uttar Pradesh Rajya Karmchari Sanyukt Parishad, there are about 10 lakh teachers and employees who are not getting the benefits of the old pension scheme. Gehlot had announced the revival of the old pension scheme for the state employees during the state budget 2022-23 presented in February.

Monsoon starts retreating

New Delhi, Sept 20: The south-west monsoon Tuesday started withdrawing from parts of south-west Rajasthan and adjoining Kutch in Gujarat, with at least eight states, including rice bowl states of Uttar Pradesh and Bihar reporting deficient rains.

It was for the first time since 2016 that the monsoon started withdrawing in the third week of September."Southwest monsoon has withdrawn from parts of southwest Rajasthan & adjoining Kutch today, against its normal date of withdrawal from southwest Rajasthan of September 17," the India Meteorological Department (IMD) tweeted.

The weather office said the conditions for withdrawal of monsoon - no rains for five days, formation of anti-cyclone and dry weather conditions over the region - were met."The line of withdrawal of the southwest monsoon passes through Khajuwala, Bikaner, Jodhpur and Naliya," it said.

According to the weather office, India had received 7 per cent excess rains, but eight states - Uttar Pradesh, Bihar, Jharkhand, Delhi, Punjab, Tripura, Mizoram and Manipur - recorded deficit rainfall. The south-west monsoon season begins on June 1 and continues till September 30. India received 878.5 mm of rainfall between June 1 and September 20, which was 7 per cent higher than the normal rainfall of 822 mm for the period under review

The deficient rains in Uttar Pradesh, Bihar, Jharkhand, West Bengal and Madhya Pradesh has hit sowing for paddy in the states. As of September 16, the area sown to paddy was 18.90 lakh hectares less than the previous year during the kharif season.

Lucknow, Sept 20: A fresh attempt is being made in Uttar Pradesh ahead of the 2024 Lok Sabha elections to form a front of smaller parties.

The coalition that will maintain an equal-distance from BJP and Congress will be like the Bhagidari Sankalp Morcha (BSM) that was conceptualised in the state ahead of the 2022 Assembly polls.

The parties that are expected to be a part of this coalition include Shivpal Yadav's Pragatisheel Samajwadi Party-Lohia (PSPL), the All India Majlis-Ittehadul Muslimeen (AIMIM), and Suheldev Bhartiya Samaj Party (SBSP) led by Om Prakash Rajbhar.

PSPL national spokesperson Deepak Mishra said, "PSPL national president Shivpal Yadav has always called for opposition unity and has also stated in no uncertain terms that our party will not enter into any alliance with the SP. For PSPL, any association with the Congress or the Bahujan Samaj Party (BSP) is unlikely to last in the prevailing state of affairs. Hence, a third front without these four parties is what the party workers

and senior leaders are looking at." SBSP president Om Prakash Rajbhar said, "When a party like the BJP has entered into alliances with more than 50 parties, the opposition will also have to join hands to challenge them. I do not think people should have any problem understanding this.'

The AIMIM has already announced that an alliance of the opposition parties was needed if like-minded political parties want to oust the BJ P from power in 2024.

"We are all in for an opposition alliance, particularly in UP. We have backed the idea of Bhagidari Sankalp Morcha and are of the view that the idea should crystalize before parliament elections," said AIMIM's state convenor and president Shaukat Ali.

Sources said that Shivpal Yadav was likely to emerge as the leader of the proposed front because Om Prakash Rajbhar had lost credibility after he dumped AIMIM before the Assembly polls and joined hands with SP.

Other smaller parties like Mahan Dal and Janwadi party are also tipped to join the front.

E-vehicle sales see sharp uptick in Raj

Jaipur, Sept 20: The popularity of electric vehicles is gaining momentum in Rajasthan, where the number of such vehicles has jumped six times in three years, as people are increasingly adapting to the emerging mobility model.

Looking at the comfort and easy mobility in city life, the sale of two-wheelers is the highest, while the sale of four-wheelers is the lowest, as consumers are still apprehensive about the charging infrastructure, particularly on highways and in the outskirts.

According to Rajasthan's Transport Department data, the sale of electric vehicles in the state has increased approximately six times till the first week of September since 2019.

"There is continuous increase in the sale of electric vehicles in the state, as more and more people are shifting towards better and advanced technology. The rising trend is also due to the policy of the state government, which is providing grants on purchase of e-vehicles," Transport Department Commissioner K L Swami told PTI.

A total of 6,627 electric vehicles in three segments -- two-wheelers. three-wheelers and four-wheelers - were purchased in the state in 2019.

After a slight slump in e-vehicle sales in the year 2020 (5,599 vehicle sales) due to the pandemic, the sale shot up to 23,451 in the year 2021.

As per the data, till September first week this year, a total of over 42,900 electric vehicles have been sold in the state, which includes about 28.000 motorcycle/scooters, 13,400 three-wheelers, 1,500 light motor vehicles.

Jaipur, Sept 20: As tourists come back to Rajasthan bringing smiles on the faces of several stakeholders hit hard by the pandemic in the last two years, the state tourism department also seems to be scripting a success story by taking innovative steps and turning challenges into opportunities in a short span of time.

And it has started paying off. People from around the world have been making bookings for big, fat weddings in the desert state.

'Yes, it is true that tourism is seeing a revival. We are receiving bookings, inquiries for weddings. In fact, this time, there is also a surge in film shoots, shooting for OTT series and ad films here," said Prithvi Singh, a prominent hotelier



Rajasthan chief secretary Usha Sharma confirmed, "The revival of the tourism sector has been great after going through a difficult time due to the Covid-19 pandemic. Even in the months of April, May and June, increasingly more and more domestic tourists were seen travelling to different parts of the country. It is for the first time that a budget of Rs 1000 crore has been allotted by the Rajasthan government for tourism. Of this Rs 600 crore has been earmarked for infrastructure development and Rs 400 crore for marketing and branding," she added.

With the tourist surge in Rajasthan, domestic footfalls have surpassed the pre-Covid numbers.

Till June-end, 36.48 million domestic tourists visited the state compared to 22.36 million in the first six months of 2019 which was the normal year before the pandemic began in 2020, confirmed tourism officials.



Electric crematorium for animals in Varanasi

be used as fertilizer. Anil Kumar Singh, additional executive officer; Zila Panchayat, said:



"The electric crematorium for animals is the need of an hour. The crematorium would come up in Cholapur development block and is expected to get operational by next month." Singh said the estimated cost of

the crematorium was around Rs 2.24 crore and it was being constructed on around 0.1180 hectares of land. Initially it would be operated through electricity but later there

or solar power.

Bees to be used to keep elephants at bay INDO-ASIAN NEWS SERVICE

Pilibhit, Sept 20: Incredible as it may sound but forest officials in Uttar Pradesh have decided to use tiny bees to keep elephants at bay and prevent man-animal conflict.

Naveen Khandelwal, the Divisional Forest Officer of Pilibhit Tiger Reserve (PTR), said: "Beehives have produced outstanding results in drastically reducing the intrusion of elephants in cropped fields and village habitations in East African countries.'

"Researchers have found that the tip of the elephant's trunk is extremely sensitive and goes through excruciating pain when stung by a bee. This makes elephants respond with alarm to the buzz of aggressive bees. They quickly move away from the sound source.'



"Besides, beekeeping has the additional advantage of producing honey, potentially diversifying and bettering the livelihoods of local communities. We have identified the villages and the training of beekeeping will be initiated there very soon.'

The Dudhwa Tiger Reserve (DTR) and PTR authorities have now embarked upon an innovative plan that will ensure peaceful cohabitation by promoting bee-keeping and using advanced technology. The plan also encapsulates a coordinated strat-

Mumbai, Sept 20: In a stunning move, the Maharashtra government has sacked Shiv Sena leader Kishore Tiwari as Chairman of the Vasantrao Naik Sheti Swavlamban Mission (VNSSM), ostensibly for inviting Prime Minister Narendra Modi to visit the family of a farmer who committed suicide last Saturday.

Hitting back, Tiwari pointed an accusing finger at Deputy Chief Minister Devendra Fadnavis for the "lightning speed" in which he was relieved of responsibilities as the VNSSM chief.

Tiwari, ironically, was appointed to the crucial post in August 2015 by Fadnavis when he was the Chief Minister in the previous Bharatiya Janata Party-Shiv Sena coalition government

The deceased farmer was Dashrath L. Kedari, 42, from Pune who penned a mentioned the Prime Minister in a suicide note - narrating his plight due to debts and other issues - before ending his life on Saturday.

"What is wrong in drawing the PM's attention to the issue? Rather than devising solutions to stop farmers' suicides, the state government decided to silence the person raising their cause. This is sheer vendetta and nothing but political terrorism," she said sharply.

Congress chief spokesperson Atul Londhe said that the state government's act shows the "total insensitivity of the BJP, Fadnavis and other top leaders" to the misery of the farmers in Maharashtra and elsewhere.

"Instead of hastily removing Tiwari, if their government had displayed the same speed to address the cause of the farmers. thousands of innocent lives could have been saved," Londhe pointed out.

Nationalist Congress Party's chief spokesperson Mahesh Tapase felt Tiwari did "the right thing by speaking about the farmers' distress directly with the PM" and urging Modi to witness first-hand their sufferings in the state where he had launched his 'Chai Pe Charcha' (March 2014).

"The state government obvi-

ously was embarrassed and scared that they could be exposed as to what compelled a small farmer to wish Happy Birthday to the PM and then end his life. This is the price Tiwari has paid for highlighting the farmers' cause," he said.

In his letter, Tiwari had urged the PM to meet the farmer's family, or direct Finance Minister Nirmala Sitharaman to go there during her upcoming visit to Pune soon.

The government retaliated with a terse notification issued by a Deputy Secretary Sanjay A. Dharurkar late on Monday, saying that the appointment of Tiwari - who was heading the VNSSM since August 2015 (when Fadnavis was the CM) - has been cancelled.

No reasons were assigned for the abrupt step in Dharurkar's order, and the Divisional Commissioner. Amravati, has been handed over the additional charge of VNSSM till further orders.

Unfazed, Tiwari vowed that he will continue to raise the farmers' voice without let-up as he has been doing for the past over 30 years, raise their demands and seek solutions from the state and Centre.

Noida wall collapse

Noida, Sept 20: A portion of a housing society's boundary wall collapsed here on Tuesday morning, killing four construction workers and injuring eight, police said.

All 12 who had been buried under the rubble while repairing a drain adjoining it at the Jal Vayu Vihar in Sector 21 around 10 am were labourers, they said. A team of Sector 20 police station later detained a sub-contractor, Gul Mohammad, who supplied labourers for the job, an official said.

Multiple JCBs were deployed to clear the debris of the collapsed stretch of the wall that was located adjacent to a drain, officials said as police and fire department personnel swung into action for immediate rescue and relief measures.

'A total of 12 labourers were pulled out of the rubble. Four of them died while others suffered injuries in the episode," Additional Deputy Commissioner of Police (Noida) Ashutosh Dwivedi said. The deceased have been identified as Pushpendra Singh (25), Panna Lal (25) and Amit (18), all from Budaun district in Uttar Pradesh, and Dharam Veer from Sambhal district, police said.

The injured was identified as Pappu Singh (25) of Budaun. He is undergoing treatment at the district hospital, they added. Uttar Pradesh Chief Minister Yogi Adityanath condoled the loss of lives in the incident, his office said.

"Uttar Pradesh Chief Minister Yogi Adityanath expressed grief over the loss of lives in the wall collapse incident in Gautam Budh Nagar. He directed senior officials

to rush to the spot and conduct relief work on a war footing," the Chief Minister's Office said in a tweet in Hindi.

He also directed the officials to ensure proper treatment of the injured, it said. Police Commissioner Alok Singh, Joint Commissioner Love Kumar and Noida Authority CEO Ritu Maheshwari reached the spot. Fire service officials, including its chief Arun Kumar Singh, are also there to oversee the relief work, the officials said.

Maheshwari said repair work was being carried out on the drain when the accident occurred. "The Jal Vayu Vihar society is an old-construction society. The boundary wall was also constructed by the society itself and looked weak," she said.

The work on the drain outside the society was being carried out on its request by a Noida Authority contractor through a tender, she said. "The labourers repairing the drain came under the wall which suddenly collapsed. There were 12-13 people at the spot. Of those rescued, one is injured and the remaining are fine," Maheshwari said. On the contractor being cautioned by locals that the boundary wall was weak, the Noida Authority CEO said the matter will be investigated.

"A joint investigation by police, district administration and Noida Authority will be carried out and if negligence is found on anyone's part then action will be taken against them. "The contractor was working on the drain and not the boundary wall." she said.

HC orders demolition at Rane's bungalow In 2019, 9,633 books were stolen

Mumbai, Sept 20: The Bombay High Court Tuesday directed the Mumbai civic body to demolish the unauthorised construction at Union minister Narayan Rane's bungalow in Juhu area here, noting it had violated the Floor Space Index (FSI) and Coastal Regulation Zone (CRZ) rules.

Floor space index (FSI) is the maximum permissible floor area that can be built on a particular plot or/piece of land. A division bench of Justices R D Dhanuka and Kamal Khata said the Brihanmumbai Municipal Corporation (BMC) cannot be permitted to consider and allow the second application filed by a company run by the Rane family seeking regularisation of the unauthorised construction as it would "encourage wholesale construction of unauthorised struc-

The high court in its order said the BMC's stand that it could consider the second application for regularisation of the construction was inconsistent with its own order rejecting the first application. The bench noted that the HC had in June this year accepted the BMC's first order.

"If the regularisation application is allowed to be heard which the BMC is bent upon allowing, then it would lead to encouragement of wholesale construction of unauthorised structures," the court said.

Sheopur, Sept 20: As the eight cheetahs brought from Namibia are trying to acclimatise to the new environment in Madhya Pradesh's Kuno National Park, experts are monitoring them from a hole in a loft near their quarantine enclosures to ensure least human intervention, a forest of-

All the cheetahs - five female and three male and aged between 30 to 66 months - are in good health and under the constant monitoring of experts, Divisional Forest

Officer (DFO) Prakash Kumar Verma said Tuesday. The eight felines - named Freddy, Alton, Savannah, Sasha, Obaan, Asha, Cibili and Saisa - are staying in six quarantine enclosures and will remain there for a month, he said.

The KNP, spread over an area of 750 sq km, is situated on the northern side of Vindhyachal mountains. Prime Minister Narendra Modi on Saturday released these cheetahs brought from Namibia, 8,000 km away from their native place, into quarantine enclosures at the KNP in Sheopur district as part of a proj-



ect to revive the population of the animal which became extinct in India in 1952.

Some members from the African

team of experts have gone back after witnessing the grand welcome of the cheetahs in their new home and ensuring they are now

under good care, officials said. Namibian experts including veterinarian Dr Ana Vincent and two others, who brought the cheetahs here, are currently staying at the KNP while other members of the team have left the place, Chief Conservator of Forest (CCF) Uttam Kumar Sharma told PTI. Indian veterinarians Dr Jitendra Jatav and Dr Omkar Anchal from the Madhav National Park in Sheopur along with Namibian experts are keeping a watch movement of the cheetahs, DFO Verma said.

"The experts are monitoring the movements of cheetahs from a loft, located 50 to 100 metres from the enclosures, to ensure the felines do not sense human presence in the vicinity. The loft is covered with curtains and the movement of cheetahs is being witnessed from a hole," he said.

The Namibian team also brought health kits for the carnivores, he said, adding that adequate kits are also available with the park management here. A plan has been chalked out for the monitoring and keeping the cheetahs in good health, he said.

According to the protocol, the cheetahs need to be quarantined for a month each before and after shifting from one continent to another, he said. They were being fed buffalo meat as per the opinion of experts, he said, adding that all the felines appeared cheerful and in good spirits in their new home.

They were served food on Sunday evening for the first time since their arrival from the African country to India on Saturday, an official had said earlier. These animals are believed to take food once in three days, he added.

Earlier on September 19, Akali Dal leader Sukhbir Singh Badal had posted on Twitter, "Disturbing media reports quoting co-passengers say Punjab Chief Minister Bhagwant Mann was deplaned from a Lufthansa flight as he was too drunk to walk. Alert level raised at Taupo volcano

Wellington: The alert level at New Zealand's Taupo volcano was raised to Level 1 for the first time Tuesday. Although this is the first time the volcanic alert has been raised to Level 1, this is not the first volcanic unrest at Taupo, said GeoNet, which provides geological hazard information for New Zealand. "There have been 17 previous episodes of unrest over the past 150 years. Several of these were more severe than what we are currently observing at Taupo," said a GeoNet statement.

1 person dying of hunger every 4 seconds: NGOs

Geneva, Sept 20: One person is estimated to be dying of hunger every four seconds, over 200 NGOs warned Tuesday, urging decisive international action to "end the spiralling global hunger crisis".

Organisations from 75 countries have signed an open letter expressing outrage at skyrocketing hunger levels and recommendations for action," the NGOs said in a statement, warning that "a staggering 345 million people are now experiencing acute hunger, a number that has more than doubled since 2019".

"Despite promises from world leaders to never allow famine again in the 21st century, famine is once more imminent in Somalia. Around



the brink of starvation in 45 countries," they said. Pointing out that as many as 19,700 people are estimated to be dying of hunger every day, the NGOs said that this translates to one person dying of hunger every four seconds.

"It is abysmal that with all the technology in agriculture and harvesting techniques today we are still talking about famine in the 21st century," Mohanna Ahmed Ali Eljabaly from the Yemen Family Care Association, one of the letter's signatories, said in the statement.

'This is not about one country or one continent and hunger never only has one cause. This is about the injustice of the whole of humanity," he said in a statement.

UK cops make 47 arrests to deter further disorder in Leicester

London, Sept 20: The UK police said Tuesday that they have made 47 arrests as part of an ongoing operation to deter further disorder in the eastern England city of Leicester, which saw scenes of violence over the weekend in a spillover of clashes since an I ndia-Pakistan cricket match.

It comes as the Indian High Commission in London issued a strongly worded statement condemning the violence against the Indian community and called for protection for those affected.

Global Fund gets powerful assistance

US President Joe Biden will host The Global Fund's Seventh Replenishment Conference, the public health partnership's fundraising campaign, Wednesday in New York ASSOCIATED PRESS

New York, Sept 20: The Global Fund to fight AIDS, Tuberculosis, and Malaria will get some highpowered help this week to reach its USD 18 billion goal to fund another three years to slow the spread of these diseases.

The Global Fund and the Clinton Global Initiative, which is holding its first gathering of political, business and philanthropic leaders since 2016 in New York this week, has also announced a new longterm partnership to drive donors of all sorts toward supporting The Global Fund's work.

Global Fund Executive Di Peter Sands told The Associated Press that fundraising through the Replenishment Conference is "always a bit of a rollercoaster."

However, he is hopeful that the fund will reach its goal by the end of the conference, even though he recognizes that donors, especially governments, face financial decisions complicated by the Covid-19 pandemic and the war in Ukraine.

"Yes, there are many other demands and governments are facing lots of domestic political pressures around the cost of living, energy and all this kind of stuff," Sands said



"But I think there's also recognition that however tough things might be in some of the rich countries in the world, the way these things are translating in poorer, marginalised communities is a

matter of life and death.' He is encouraged by Japan and Germany pledging 30 per cent increases in their donations to The Global Fund, as well as the United States' increased participation.

If the Global Fund reaches its\$ 18 billion goal, it hopes to use the donations to save 20 million lives and avert more than 450 million new infections of AIDS, tuberculosis and malaria

Since The Global Fund was created in 2002, it has saved 50 million lives and reduced the combined death rate from HIV, tuberculosis and malaria by more than half in the countries where the Global Fund invests.

That track record helps attract more investments.

Clinton Foundation Vice Chair Chelsea Clinton said the foundation has worked with The Global Fund for nearly two decades to fight HIV, tuberculosis and malaria, as well as build sustainable health systems in the

Russia unveils plan to annex parts of Ukraine

London/Kyiv, Sept 20: Russianinstalled leaders in occupied areas of four Ukrainian regions set out plans for referendums on joining Russia this week, a step an ally of President Vladimir Putin said would alter the geopolitical landscape forever. Russian officials portrayed the

move as one that would give Moscow a claim to territory that it could defend with any means possible. Ukraine dismissed it as a stunt by Russia to try to reclaim the initiative after crushing losses on the battlefield.

"Sham 'referendums' will not change anything," tweeted Ukraine's Foreign Minister Dmytro Kuleba. Russian-installed officials announced planned referendums for September 23-27 in the Luhansk, Donetsk, Kherson and Zaporizhzhia provinces, representing around 15% of Ukrainian territory or an area about the size of Hungary or Portugal. Russia already considers Luhansk and Donetsk, which it partially occupied in 2014, to be independent states. Ukraine and the West consider them parts of Ukraine illegally occupied by Russian invaders.

In a post on social media addressed to Putin, the leader of the self-proclaimed Donetsk People's Republic (DPR), Denis Pushilin, wrote: "I ask you, as soon as possible, in the event of a positive decision in the referendum - which we have no doubt about - to consider the DPR becoming a part of Russia.'

Some pro-Kremlin figures framed the referendums as an ultimatum

to the West to accept Russian territorial gains or face an all out war with a nuclear-armed foe.

"Encroachment onto Russian territory is a crime which allows vou to use all the forces of self-defence,"Dmitry Medvedey, a former Russian president and now hawkish deputy chairman of Putin's Security Council said on social media. "This is why these referendums are so feared in Kyiv and the West," he wrote. "They would completely change the vector of Russia's development for decades. And not just of our country. The geopolitical transformation of the world would be irreversible once the new territories were incorpo-

rated into Russia.' Washington and the West have so far said weapons they supply to Ukraine should not be used to fire on Russian territory, though they have not extended this to territory they view as unlawfully annexed,

such as Crimea, which Russia seized in 2014. Margarita Simonyan, editor-in-chief of the pro-Kremlin RTTV station, said the votes could either deliver a victory for Russia or a much wider and more serious war. "Today a referendum, tomorrow recognition as part of the Russian Federation, the day after tomorrow strikes on Russian territory become a full-fledged war between Ukraine and NATO and Russia, untying Russia's hands in every respect," Simonyan, who is regarded as a hardliner, wrote on Telegram. But Ukrainian officials portraved

the move as one of desperation at a time when Russian forces are being pushed back. Andriy Yermak chief of staff to Ukrainian President Volodymyr Zelenskiy. dismissed the threat of referendums as "naive blackmail" and as a sign that Russia was running

London, Sept 20: The UK's 10day state mourning came to an end with national flags back at full mast across government buildings Tuesday, a day after Queen Elizabeth II's state funeral in London and a private burial ceremony in Windsor.

The Queen, Britain's longestserving monarch, died peacefully at her Balmoral Castle residence in Scotland September 8. She was laid to rest beside her late husband, Prince Philip, in a private burial service at St George's Chapel in Windsor Castle.

The government said over 250,000 $\,$ people had turned out to queue for many hours over the past week to file past the Queen Lying-in-State at Westminster Hall ahead of her state funeral at Westminster Abbey in London Monday.

It involved a spectacular day of ceremonial events that included a grand procession through London and on the approach to the Queen's final resting place in Windsor Castle. Millions around the world watched her coffin lowered into the Royal Vault at St George's Chapel after the Instruments of State-the Imperial Crown, Orb and Sceptre - were removed as a symbolic end of an era.

The private burial, attended only by close family, coincided with the release of a photograph of the Queen walking in Balmoral, Scotland, in 1971.

British Prime Minister Liz Truss, who is in New York for the United Nations General Assembly, said she was "hugely honoured" to have been invited to form a government by the late Queen just two days before she passed away.

Truss was the late Queen's 15th Prime Minister, her first being war-time leader Sir Winston Churchill.

Pakistan flood-borne diseases kill over 1.5K

Karachi, Pakistan, Sept 20: At least nine more people have died from water-borne diseases in flood-hit areas of Pakistan. officials said Tuesday, warning they risked losing control of the spread of infections in a crisis that UNICEF described as 'beyond bleak"

An intense and long monsoon dumped around three times as much rain on Pakistan than on average in recent weeks, causing major flooding which killed 1,559 people, including 551 children and 318 women, according to the

disaster management agency. This figure does not include those killed by disease in the aftermath. Hundreds of thousands of people displaced by the floods are living in the open and as flood waters spread over hundreds of kilometres start to recede, which officials say may take two to six months, stagnant waters have led to diseases like malaria, dengue fever, skin and eye infections and acute diarrhoea.

The World Health Organisation (WHO) has said the surge in diseases has the potential for a "second disaster". In Sindh, the region worst hit by the floods, the provincial government said nine people died of gastroenteritis, acute diarrhoea and suspected malariaMonday, bringing the total number of deaths from diseases to 318 since July 1.

Credit market grows 11.1 pc

Mumbai: Led by a 122 per cent spike in retail loan volume, the overall credit market grew 11.1 per cent in FY22 over the previous year to Rs 174.3 lakh crore, according to a credit bureau report. According to credit bureau CRIF High Mark, the total lending market stood at Rs 174.3 lakh crore as of March 2022, registering an 11.1 per cent growth over March 2021. Commercial, retail and microfinance lending portfolios contributed 49.5, 48.9, and 1.6 per cent, respectively to this growth. Giving a break-up, the report said personal loans saw a full 46 per cent growth in originations by value, and a much higher 122 per cent growth in originations by volume in FY22 over the previous year, and the sector is dominated by state-run and private banks along with nonbanking entities.

Digit Insurance IPO on hold

Mumbai: Digit Insurance, a company backed by Canadian billionaire Prem Watsa's planned initial public offering (IPO) put on hold, a Securities and Exchange Board of India (SEBI) regulatory document showed Tuesday. The IPO has been kept in "abeyance" and certain observations have been issued, the document on SEBI's website said without elaborating. While SEBI gave no reasons for its decision, a source familiar with the watchdog's thinking said concerns had been raised by the regulator that privately held Digit issued shares to more than 200 individuals in the past financial year, which is not allowed under Indian laws and regulations. Digit will need to review SFRI's concerns and resolve them at an appropriate forum, the source added. A Digit spokesperson declined to comment and SEBI did not respond immediately to Reuters' queries.

KKR, Hero to invest \$450mn

Bangalore: US private equity giant KKR & Co Inc and India's Hero Group have agreed to invest \$450 million in the motorcycle maker's renewable energy arm, the companies said Tuesday, as the Indian firm looks to expand its renewable energy capacity. Hero Future Energies (HFE), founded in 2012, is an independent power producer with a diversified portfolio of 1.6 GW of operating solar and wind projects. "This investment will position HFE for continued growth and support its efforts to expand its renewable energy capacity and capabilities across technologies such as solar, wind, battery storage, and green hydrogen, and into new markets over time," the companies said in a joint

Retail inflation for farm, rural workers up in Aug

Food inflation stood at 6.16 per cent and 6.21 per cent for agricultural labourers (CPI-AL) and rural labourers (CPI-RL) respectively, in August 2022 compared to 5.38 per cent & 5.44 per cent respectively in July 2022 and 2.13 per cent & 2.32 per cent respectively during the corresponding month of the previous year.

The All-India CPI-AL and CPI-RL for August 2022 increased by 9 points each to stand at 1,140 and 1,152 points, respectively. The CPI-AL was 1,131 points in July 2022, while CPI-RL was 1143 points in the

The major contribution towards the rise in general index of agricultural labourers and rural labour-

Markets extend gains Oil ministry says windfall tax response to dynamic situation

New Delhi, Sept 20: The oil ministry Tuesday said the levy of windfall profit tax was a response to a dynamic situation and its design provides for recalibration based on market inputs and feedback.

"Crude oil prices have witnessed extreme volatility in 2022. This has resulted in very high prices for end consumers at petrol pumps. Countries around the world have implemented various measures to mitigate the adverse impacts on consumers. 'Windfall tax' is one of the measures which helps in dealing with the situation," the ministry said in a statement.

India first imposed windfall profit tax July 1, joining a growing number of nations that tax super normal profits of energy companies. While duties were slapped on the export of petrol, diesel and jet fuel (ATF), a Special Additional Excise Duty (SAED) was levied on locally produced crude oil.

Coal rush! Energy crisis fires global hunt for polluting fuel

Dar es Salaam, Sept 20: The sleepy Tanzanian port of Mtwara mainly dealt in cashew nuts until late last year. Now it bustles with vessels loading up with coal, as Russia's invasion of Ukraine drives a worldwide race for the polluting fuel.

Tanzania traditionally exports thermal coal only to neighbouring countries in east Africa; sending it further afield was out of the question, as it required trucking the material more than 600 km from mines in its southwest to Mtwara, the nearest Indian Ocean port. Europe's crippling energy crisis has changed all that.

Prices for thermal coal, used to generate electricity, have leapt to

record levels as a result of the war, which has led to many European countries losing access to vital supplies of natural gas and coal from their top provider Russia.

Buyers in Europe and beyond are now vying to pay top dollar for coal from often remote mines in places such as Tanzania, Botswana and even potentially Madagascar. The resurgent coal demand, driven by governments trying to wean themselves off Russian energy while keeping a lid on power prices, clashes with climate plans to shift away from the most polluting fossil fuel.

"European players, after the Russian war, are going to any place where there is coal," Rizwan Ahmed, managing director of coal miner Bluesky Minings said in



Dar es Salaam, Tanzania. "They are offering to pay very good prices.'

Commodities trader Cargill has seen a marked rise in coal shipments into Europe in recent months, said Jan Dieleman, president of Cargill's ocean transportation division, with the company transporting 9 million tonnes of coal globally in the June-August period compared with 7 million a year earlier.

"Europe is competing with other buyers and the alternative is more expensive, which is gas," said Dieleman. "Europe should be able to source coal and we will see very

strong flows into Europe from Colombia, South Africa and even further away.

Even though the window of opportunity may be short should the geopolitical winds shift, some countries with coal resources see the margins to be gained as too good a chance to miss.

Front-month physical thermal coal at Australia's Newcastle port - a global benchmark - was trading at \$429 a tonne on Sept. 16, just below an all-time high of \$483.50 in March and up from around \$176/tonne this time last year.

Mtwara has seen 13 vessels load up with coal since November last vear when it launched its first-ever coal shipment, according to a port official; the latest, the MV Miss

Simona, a bulk carrier with 34,529 tonne capacity, docked last week. loaded up and sailed off to France.

Since the end of June, 57 cargo orders - requests for available vessels - to ship Tanzanian coal have been seen on the spot freight market compared with just two in the same period last year, according to analysis from maritime and commodities data platform Shipfix.

Global seaborne thermal coal imports reached 97.8 million tonnes in July, the highest level on record and up more than 9% year-on-year, an analysis from ship broker Braemar shows. The volume dropped to 89 million tonnes in August, largely due to export disruptions from major producer

Oz tear into Indian attack Saliva ban now permanent

Mohali, Sept 20: India's frailties with the ball were laid bare as Australia gunned down a formidable 209-run target rather comfortably for a four-wicket win in the first T20I here Tuesday.

KL Rahul (55, 35b, 4x4, 3x6) and Hardik Pandya (71 n o, 30b, 7x4, 5x6) helped India post a daunting 208/6 after Australia put the hosts

Australia were dominant in the run chase, romping home in 19.2 overs. Last year's World Cup hero Matthew Wade (45 n o, 21b, 6x4, 2x6) and Cameron Green (61, 30b, 8x4, 4x6) played special knocks to make short work of a stiff target.

It was a formidable total but the way Australia started, an early finish was on the cards. Opening for the first time in international cricket, Green was in a menacing mood as he hammered comeback man Umesh Yadav (2/27) for four successive boundaries in his first T20 since February 2019.

There wasn't heavy dew but no swing was on offer for both Umesh and Bhuvneshwar Kumar (0/52). The batters were able to hit through the line, making the Indian attack look very ordinary.

The stand out bowler for India, Axar Patel (3/17), removed opposition skipper Aaron Finch to get a much-needed breakthrough. However, more carnage was in store as Green, who is not even part of Australia's T20 World Cup squad, toyed with the bowling while Steve Smith (35, 24b, 3x4, 1x6) enjoyed from the other end.

In the eighth over, he slog swept Yuzvendra Chahal (1/42) for a couple of sixes and a four for a 19-run over. India dropping Green and Smith also did not help their cause.

At 109/1 in 10 overs, Australia were running away with the contest before India fought back with three quick wickets, two of those coming

via Rohit Sharma's brilliant DRS calls, which sent Smith and Glenn Maxwell back in the hut. With five wickets in hand, Australia needed 55 off the last 24 balls.

However, Australia debutant Tim David (18) in the company of the experienced Wade went ballistic in the death overs to complete a fine run chase. Two big overs in which Bhuvneshwar leaked 15 and Harshal 22 sealed the home team's fate.

Earlier, Rahul made a statement with a high-quality knock before Hardik smashed an unbeaten 71. Suryakumar Yadav (46, 25b, 2x4, 4x6) also played some breathtaking strokes. Expecting dew, Australia opted to bowl.

After Rohit Sharma and Virat Kohli fell cheaply, Rahul and Survakumar shared a 68-run stand off 42 balls. Rahul's walk across the stumps to dispatch Josh Hazlewood (2/39) over the cow corner made his intent clear before he whipped Green (1/46) for a massive six over deep square leg. Suryakumar's style of play is often awe-inspiring and the Mohali crowd got to see him at his lethal best.

India were able to maintain their tempo in the middle overs as Suryakumar picked up leggie Adam Zampa for two successive sixes

over long on and deep midwicket. Hardik then took over and pushed India past 200. He smashed three consecutive sixes off Green in the 20th over including a flat one in the mid wicket region. The last five overs yielded 67 runs.

Dubai, Sept 20: The use of saliva to polish the ball was Tuesday banned permanently as the ICC announced a slew of changes to its Playing Conditions, which will come into effect October 1.

The game's governing body also changed running out of the nonstriker by the bowler from the 'Unfair Play' section to the 'Run out'

The changes were announced after the Chief Executives' Committee (CEC) ratified recommendations made by the ICC Cricket Committee, led by former India captain and BCCI president Sourav Ganguly.

The ICC had earlier barred use of saliva to shine the ball in view of the COVID-19 pandemic and the Custodian of cricket laws, the Marylebone Cricket Club (MCC) in March had completely banned its application in its amendments to the 2022 code.

"This prohibition has been in place for over two years in international cricket as a Covid-related temporary measure and it is considered appropriate for the ban to be made permanent," the ICC said in a statement.

Mandeep terms **Pro League good** test ahead of WC

Bangalore, Sept 20: Star Indian forward Mandeep Singh Tuesday said the upcoming Pro League will be a perfect platform to "test" themselves ahead of the marquee FIH World Cup, set to be held in Odisha next year. Ahead of the World Cup 2023, the Indian team will compete in the Pro League from October 28-November 6.

"It is always good to compete against strong teams before a major competition. The Pro League will be helpful once again to prepare ourselves for the World Cup, and will also give us a chance to test ourselves before the tournament," the 27-yearold said in a Hockey India statement.

The Olympic bronze medallist Indian team was drubbed 7-0 by Australia in the final of the Birmingham Commonwealth Games.



The fifth ranked Indian team is placed in a tough Pool D along with England, Spain and Wales. The group topper will make the quarterfinals straightaway while the next two teams will have to fight it out in the cross-overs.

"Our Coach Graham Reid always tells us to focus on what we can control and not worry about things beyond our control. Irrespective of which teams we have in our group, we are focusing on preparing ourselves to the best of our skills, and according to our plans," Mandeep said.

"We are confident that if we stick to our basics, and focus on the areas where we need to improve upon in training, we will be able to perform well in the tournament and have a great showing," he added.

The quadrennial showpiece will be held across two venues in Odisha across Bhubaneswar and Rourkela, and will see 16 teams compete in the tournament.

"There is always an excitement in the air when we get a chance to play in front of the home fans. Getting a chance to perform against the best teams in the world once again in India will be an exciting affair and hence, we are eager for the World Cup to begin," he concluded.

BATTLE FOR POST OF PRESIDENT IN HOCKEY INDIA ELECTIONS

Katyal, Nath stand in way of Tirkey

New Delhi, Sept 20: Former India captain Dilip Tirkey, who is the frontrunner for Hockey India president's post, will be up against Uttar Pradesh Hockey chief Rakesh Katyal and Hockey Jharkhand's Bhola Nath Singh in the elections of the national federation to be held October 1.

But there is a twist in the tale as Uttar Pradesh Hockey secretary general RP Singh has requested Katyal to withdraw his nomination and support Tirkev instead.

"We are happy to know that a former player like Dilip Tirkey has filed his nomination for president. I request Mr. Rakesh to take back his nomination. I am sure that Mr. Rakesh will think about the development and growth of hockey and take back his nomination,' Singh wrote in his letter to Katyal. "We believe Dilip will take right steps towards the development of hockey and we wish him luck."

Katyal, however, said that he is yet to take a call on whether to contest or not. "I have filed my nomination letter for president's post. Yes, I got a request to withdraw my nomination but I have not made up my mind yet. As of now I am in the race but if things work out between all parties, I might as well withdraw," he told this agency. The last date for withdrawal of nominations is September 23.

The 44-year-old Tirkey, a playerturned-politician and administrator, is the country's most capped

player with 412 international caps. Hockey Jharkhand president Bhola Nath, a former national-level wrestler, has also thrown his hat in the ring for the president as well as secretary general's positions.

Besides Bhola Nath, Delhi Hockey president Hitesh Sindwani and Hockey Maharashtra vice president Manoj Bhore will also be contesting for the secretary general's post. Bhola Nath too confirmed that he has filed his nomination for both the positions.

As per Hockey India Constitution, it is mandatory to

have one male and one female nomination for the vice president and joint secretary's positions.

Hockey Jammu & Kahmir's Asima Ali and Hockey Karnataka chief SVS Subramanya Gupta are the lone woman and male candidates for the vice president's post.

Smriti moves to 2nd

Dubai, Sept 20: Star India opener Smriti Mandhana Tuesday achieved a career-best World No.2 rank in T20Is and climbed to the seventh spot in ODIs in the latest ICC Women's Player Rankings, riding on her stupendous show against England.

The left-handed batter had aggregated 111 runs in the threematch T20I series against England. The performance helped her jump

Mandhana, a former top-ranked batter in ODIs, also jumped three slots to number seven after a matchwinning 91 in the first ODI against England.

Among other Indians, skipper Harmanpreet Kaur has zoomed four spots to ninth place in ODIs, all-rounder Deepti Sharma gained one place to reach 32nd position and wicketkeeper Yastika Bhatia jumped eight places to 37th following India's seven-wicket win in Hove on Saturday. Deepti also climbed six places to 12th in bowlers'

For England, Emma Lamb and Sophie Ecclestone have gained three slots each and are 64th and 72nd among batters, respectively, while Charlie Dean is up to 86th in the list.

Dean is also up four places to 20th among bowlers, while Kate Cross is in the top 10 after grabbing two wickets with her seam bowling. In the T20I rankings, Kaur (up



new-ball bowler Renuka Singh (up three places to 10th among bowlers) and spinner Radha Yadav (up four places to 14th among bowlers) made notable gains. All-rounders Sneha Rana and Pooja Vastrakar are in joint-41st position.

England's Sophia Dunkley jumped 12 spots to 32nd after leading the run-aggregate with 115 runs in the T20I series, while Alice Capsey is now 20th among batters.

Zimbabwe players Sharne Mayers (up 28 places to 39th among batters), captain Mary-Anne Musonda (up 10 places to 50th among batters) and Precious Marange (up 24 places to 34th among bowlers), who are featuring in the ongoing ICC Women's T20 World Cup Qualifier in Abu Dhabi, have also moved up the rankings.

EVES AIM FOR RARE SERIES WIN IN ENGLAND

Canterbury, Sept 20: A confident Indian team will back itself to seal its first series victory in England since 1999 with another win over the hosts in the second women's ODI here Wednesday.

Having endured a woeful 1-2 defeat in the T20I series, the Harmanpreet Kaur-led Indian side raised its standards in all the departments of the game to bounce back in three days' time and defeat England by seven wickets in the series-opener at

Hove on Sunday. England are missing some of their senior players but India looked a much better team in the first game and they would be looking to

ride the momentum. In 1999, the Indian team had won the ODI series 2-1 with Anjum Chopra striking a hundred and a half century.

It is also a farewell series for the great Jhulan Goswami as India do not have any 50-over assignment till June 2023. Playing her first game since March, the 39-year-old world record holder for most wickets showed little signs of rustiness and was the most economical among the lot, returning with fig-

ures 10-2-20-1. Indian vice-captain Smriti Mandhana led the batting show with a sublime 99-ball 91, while wicketkeeper batter Yastika Bhatia also struck a fifty, before skipper Harmanpreet finished off the clinical chase with an unbeaten 74.


The captain will be expecting the middle-order to step up and hope opener Shafali Verma does well as she has not scored a half-century in more than 10 innings now.

England on the other hand will hope that their batters put up a big total as they will rely heavily on in-form Sophia Dunkley, who had a successful T20I series.

Dunkley and Alice Capsey once again looked dangerous in the middle before a one-handed catch by Harmanpreet broke the partnership and triggered a collapse.

If India manage to win the second game, it will be a massive confidence booster for a team trying to find its feet in 50-over cricket.
