
### **Finally OCS in Odia**

BHUBANESWAR: The Odisha government has taken the decision to conduct OCS examinations in Odia language. A letter to this effect has already been sent to the Odisha Public Service Commission (OPSC) by the General Administration department of the state government. The OPSC has been asked to prepare questions both in English and Odia with the candidates having the option of giving the answers in any of the two. The aspirants can speak in Odia during the interview as well. With this new development, candidates appearing October 16 in the preliminaries of OCS can write their answers in Odia.

### ₹ hits 7-month low

**MUMBAI:** The rupee plunged by 83 paise – its biggest single-day loss in nearly seven months -- to close at an all-time low of 80.79 against the US dollar Thursday after the US Federal Reserve's interest rate hike and its hawkish stance weighed on investor sentiments. Moreover, the strength of the American currency in the overseas market weighed on the rupee. At the interbank foreign exchange market, the local currency opened at 80.27, then fell further to an all-time intra day low of 80.95 against the dollar. It finally ended at 80.79, down 83 paise over its previous close of 79.96. The rupee suffered its biggest singleday fall since February 24 when it had declined by 99 paise.





## ₹2.7K crore for irrigation

Funds increased to ₹875.78 crore for development of infrastructure at two hockey World Cup venues

Bhubaneswar, Sept 22: In an effort to enhance irrigation facilities in Odisha, the State Cabinet headed by Chief Minister Naveen Patnaik approved Thursday tenders of more than ₹2,700 crore for execution of several projects.

The Cabinet has approved the financial bids for construction of 40 lift irrigation projects with intake points on different rivers in the districts of Keonjhar, Kalahandi, Bolangir, Bargarh, Gajapati, Jajpur, Kendrapara, Angul and Cuttack.

These projects will be executed at an investment of ₹1,879.61 crore including maintenance and operational costs. These projects are likely to be completed in three years, Chief Secretary Suresh Chandra Mahapatra informed after the meeting.

Similarly, the panel has also approved the financial bids for execution of pressurised underground pipeline (UGPL) irrigation network system for the left command of lower Suktel irrigation project with distribution network. A tender worth ₹637.14 crore was approved for this project, which will be completed in 30 months.

Another tender of ₹201 crore has also been approved for construction of integrated barrage (in-stream storage structure) across Kochila river near Kuturia village in Bhadrak district and across the Baitarani river near Dhobabil village of Jajpur district, Mahapatra informed.

This storage structure will control the flood situation in Kochila river and will rejuvenate the

## ₹510cr sanctioned for MLA quarters

Bhubaneswar: The State Cabinet approved Thursday a tender worth ₹510 crore for construction of 195 Type-VI and 105 Type-VII quarters at MLA Colony and GA Land in Unit-IV here on a turnkey basis. The lowest quoting bidder M/s KEC International Ltd has been awarded the work, which is targeted for completion within a period of 30 months, informed Chief Secretary SC Mahapatra after the meeting.

Baitarani river. It will also fulfil drinking and domestic requirements of the people of Dhamnagar block of Bhadrak district and Dasarathpur block of Jajpur district, Mahapatra added.

The Cabinet has also decided to enhance the funding for infrastructure development and modernisation of the Kalinga Stadium in the state capital and Birsa Munda Hockey Stadium in Rourkela. The estimated cost for the completion of the projects has been enhanced from ₹432.45 crore to ₹875.78 crore.

Out of the revised project cost, the Cabinet approved ₹562.58 crore from budgetary allocation of the State government spreading across three financial years starting from 2020-21. The remaining amount is to be funded through District Mineral Foundation, (DMF) Sundargarh, Odisha Sports Development Fund (OSDF) and Corporate Social Responsibility (CSR) fund. The entire project is scheduled to be completed by December 2022.

## Panic button must for all public transport vehicles

All vehicles with OD number plates to also have location tracking device for safety of women and children

Bhubaneswar, Sept 22: With an aim to enhance the security of women and children travelling in public transport vehicles, the Odisha government has made it mandatory the installation of vehicle location tracking (VLT) devices with panic button. All new public transport vehicles will have to install the system from January 1, 2023.

The State Commerce and Transport department has recently issued a notification in this regard. As per the notification, all public transport vehicles having yellow number plates to be registered on or after January 1, 2023 will have to comply with the requirement at the time of registration.

Similarly, such vehicles registered on or before December 31, 2022, will have to install the devices by March, 2023. The Transport Commissioner will issue detailed guidelines and process for fitment

of VLT device and panic button, said Joint Commissioner Road Safety department, Sanjay Kumar Biswal here Thursday.

All commercial vehicles including passenger buses, goods carriers, mini-buses, school buses, cabs/taxis and e-vehicles will compulsorily be equipped with the VLT gadgets for the safety of women travellers,

Biswal stated.

Women in distress can press the emergency buttons near their seats and expect quick response from the police. A Command and Control Centre (CCC) will receive the SOS immediately after a person in distress presses the panic button. It will immediately alert the police about the location of the vehicle and appropriate action will be taken accordingly, the official informed.

The Union Ministry of Road Transport and Highways earlier had mandated that VLT devices and emergency buttons be fitted in all public service vehicles with effect from April 1, 2018. Since then the Centre has empowered the states to implement this rule through notification.

The Centre has been providing financial assistance from the 'Nirbhaya' fund to states to install VLT devices and emergency buttons in the public transport vehicles. The Centre and State have shared the costs at 60-40 ratio, a source said.

## **NABARANGPUR AS PUNSIHMENT**

Keonjhar, Sept 22: Odisha government's Health and Family Welfare department transferred Thursday the chief district medical officer (CDMO) of Keonjhar, Dr Sujata Rani Mishra to Nabarangpur. This development came after 13 crib deaths were reported from the Keonjhar district headquarters hospital (DHH) in 18 days. Senior paedtrician Dr Kishore Kumar Prusty has replaced Dr Mishra as the Keonjhar CDMO.

The transfer order came four days after a huge controversy erupted over the crib deaths with the kin of the deceased alleging\_ that the newborns had died due to medical negligence.

Opposition parties had lambasted the state government over the issue. BJP leader Mohan Majhi has sought a judicial probe into the death of the cribs.

Majhi said Thursday that just by transferring the CDMO will not serve any purpose. He asserted the need to improve healthcare facilities at the DHH. "We demand an investigation into the alleged medical negligence due to which the newborns have died. Stern action should be taken against those responsible," Majhi had said.

## Centre heat on PFI; over 100 nabbed

New Delhi, Sept 22: In near simultaneous raids Thursday across the country, a multi-agency operation spearheaded by the National Investigation Agency (NIA) led to the arrest of 106 activists of the Popular Front of India (PFI) in 11 states for

allegedly supporting terror activities in the country, officials said.

The maximum number of arrests were made in Kerala (22) followed by Maharashtra and Karnataka (20 each), Tamil Nadu (10), Assam (nine), Uttar Pradesh (eight), Andhra Pradesh (five), Madhya Pradesh (four), Pondicherry and Delhi (three each) and Rajasthan (two). Among those arrested are 14 office-bearers of the PFI.

According to officials, the arrests were made during the raids which have been termed as the 'largest-ever investigation process till date'. Details of the arrested activists were not available immediately, but officials said the arrests were done by the NIA, the ED and the police forces of 11 states so far.

The officials said the searches are taking place at the premises of persons involved in terror funding, organising training camps, and radicalising people to join proscribed organisations and create unrest in the country.

In a statement, the PFI said 'the raids are taking place at the homes of national, state and local leaders. The state committee offices are also being raided'. "We strongly protest the fascist regime's move to use agencies to silence dissenting voices," it said. Continued on P4

## **UNABATED SUICIDES** IN BHUBANESWAR

Bhubaneswar, Sept 22: Suicide cases in the Odisha capital continued unabated with another young woman ending her life Thursday at her rented flat in Pahala locality. The deceased has been identified as Sujata Rath, a resident of Nayagarh district. This is the fourth death by suicide in the last two days in the Odisha capital.

Sujata was staying with her family in a flat at Surekha Vatika apartments near Hanspal under Pahala police limits. She recently shifted to another flat in the same complex with her alleged boyfriend and business partner.

Sources said, Sujata's live-in partner had left the the flat three days back. Her family members got worried when she did not respond to their calls Thursday Sujata's kin then went to her flat which was locked from inside. They broke into the flat when she did not open the door despite repeated knocking.

One of the family members then spotted her body hanging from the ceiling fan in one of the rooms. They informed the Pahala police station. Personnel from the Pahala PS reached the spot, brought down the body and sent it for post-mortem. Police have also started an investigation into the matter after registering an unnatural death case (12/22) in this regard. However, no complaint has still been filed against the deceased's live-in partner, police informed.

Police also said that efforts are on to locate Sujata's partner. They suspect that Sujata took the tragic step after suffering lossess in her business.



## 24 students defy death after boat capsizes

Anuppur, Sept 22: Twenty four students showed a lot of heart and courage Thursday after the boat they were travelling in capsized in the Sone river in Annuppur district of Madhya Pradesh. They did not lose their cool and beat all odds to swim to the shore, district officials informed. In fact, if sources are to be believed, the 24 students attended classes at their educational institution, before returning home in another boat later in the day.

The incident took place at 10.30am in Chachai area, some eight kilo-

quarters, Annuppur sub-divisional magistrate Kamlesh Puri told mediapersons

"All 24 students in the boat jumped off it and managed to swim to safety. The cause of the boat capsize is being investigated. The students were on their way to their educational institution when the accident took place," Puri said.

"I really have to praise their courage and presence of mind. They did not panic and constantly shouted words of encouragement to one another as they swam ashore. It helped that all of them are good



swimmers, but even then in such situations people tend to lose their cool," Puri added.

As per locals, students from Bakeli, Pondi, Kodayali, Khada, Manpur and some other villages

use the boat services to reach a facility called the 'School of Excellence' on the other side of the river due to the absence of a bridge

Villagers informed that they have no idea as to why the bridge still hasn't been built despite being sanctioned more than seven years ago.

'The bridge is in the making for the last seven years. All the administrative formalities have been completed and yet construction work has not begun. Today by god's grace, disaster was avoided, but it always may not be the case. Work on the bridge should begin as soon as possible," some villagers said.





## **Security, extra costs blamed for** early closure of chemist shops

Bhubaneswar, Sept 22: Medicine shops are one of the key emergency services that remain open 24X7 in many cities across the world and India but the scenario in Bhubaneswar is quite different. Here, people in emergency won't find a drug store open beyond midnight, except for those on the premises of hospitals.

When asked about the reasons behind early closure of the shops, some shop owners cited security as the major challenge while some others said it would entail additional expenditure as they have to hire more number of pharmacists to man the shops at night.

Speaking on the issue, Amrit Pattojoshi, a doctor and health expert, said, "24X7 service by medicine shops is very much necessary because in cases of certain medical emergencies like diarrhoea, abdominal pain, fever and blood pressure, and especially when it happens at night, one requires medicines immediately. So, 24-hour chemist shops would definitely come to the rescue of these people.

"Since Covid-19 is still with us, meeting doctors at hospitals is not that easy. Nowadays, doctors treat and see patients via phone and through online and prescribe medicines. So, in that case 24-hour medicine shops are very much needed," he added.

He said that chemist shops are available in every corner of the City and it's more important that they remain open till late night because it is far more convenient for the patients to get medicines from a shop rather than going to a hospital for small emergencies. The government can open such 24-hour facilities in different parts of the Capital city. Moreover, ordering medicines online is expensive as you have to order in bulk.

Utkal Chemists and Druggists Association president P Satyanarayan said that opening medicine shops for 24 hours is not financially viable for shop owners as it requires hiring of more number of pharmacists.

Shambu Nath Swarup of Apollo Pharmacy at Jaydev Vihar said, "Security is a major concern. Usually we open the shop till 11pm. It is not safe to keep money at shops during night.

Sai Krishna of SAI Medicines at Nayapalli here, said, "Every sector in the healthcare industry requires varying levels and methods of surveillance and security. A hospital

is much different from a chemist shop. Although a medicine store is much smaller than a hospital or clinic, it still faces the risks of break-ins, burglaries, vandalism and physical assault.

Unlike bigger hospitals, there are limited people in these shops to tackle such offences, he added.

Raising concern over inconveniences faced by people to find a medicine store in the city late at night, Sagar Kumar, a city resident, said that in major cities, 24x7 medical shops or chemist shops are available but here this is missing. "We hope the authorities will take steps in this direction," he stated.

## ECoR to run spl trains from Oct



## Bihar's help sought to check fake drug supply

Bhubaneswar; Sept 22: The Odisha government has sought the help of Bihar to stop supply of fake medicines from the neighbouring state, official sources said.

The state government's action in this regard came after huge quantities of fake tablets used to treat high blood pressure, was seized during raids by officials of the state drug controller in Cuttack and Bhubaneswar recently.

## Cabinet nod to land for three institutions

Bhubaneswar, Sept 22: The State Cabinet Thursday decided to allocate required land for two Central institutions and Rajendra University. Bolangir.

The government has sanctioned lease of 5 acres of government land free of premium for establishment of the Central Research Institute for Homoeopathy (CIRH) at Jatni in Khurda district.

Similarly, 3.125 acres of land has been allotted for establishment of a branch of the National Centre for Disease Control (NCDC) at Andharua on the outskirts of Bhubaneswar.

The Cabinet has decided to provide 50.437 acres of land in favour of Rajendra University in Bolangir for infrastructure development.

Moreover, the panel has decided to widen & strengthen Sonepur-Binka-Rampur - Dunguripali road

in Subarnapur district with a cost of Rs 87.07 crore. A target has been set for completion of the work in 18 months. This would ensure better connectivity and reduce traffic congestion. It will usher in industrial and economic development of Subarnapur district, said Chief Secretary SC Mahapatra.

With a view to attracting quality professionals to make tourism as an engine of economic growth, the Tourism department has proposed to restructure the Odisha Tourism Service (OTS) cadre. The government also proposed to divide the entire destinations of the state into tourism divisions.

The tourism destinations of the state have been proposed to be divided into seven divisions and one division to function at the national capital. Each tourism division will be headed by an OTS cadre officer in the rank of joint director or deputy director. The entire



tourism destinations of 30 tourism districts shall be kept under these seven tourism divisions for effective management, said Mahapatra.

The Cabinet, once again, extended the licence of the fair price shop (FPS) dealers for another six months. The public distribution system (PDS) is managed by 13,630 FPSes out of which 6,562 are institutional dealers and 7,068 are private dealers.

FPS licence granted to dealers

was valid from April 1 to September 30. 2022. Now, the licences were extended for a further period of six months - from October 1, 2022 to

March 31, 2023. This will facilitate renewal of existing FPS licences if there is no genuine public complaint or no action has been initiated under Essential Commodities Act against the existing dealer, sources said.

In an aim to ensure adequate supply of limestone to local industries, the Cabinet has decided to bring limestone into the purview of Long-Term Linkage (LTL) Policy and sell limestone to the industries through IDCOL/OMC.

This decision will ensure steady upply of limestone through LTL to state based end-user industries, he added.

A proposal for 15 per cent reservation of seats in government physical education colleges for the students staying in government sports hostels also received Cabinet nod.

The CM-led panel also approved the appointment of Sarita Supkar, former controller of examinations, Rama Devi Women's University and retired OAS officer Sanat Kumar Mohanty as members of the Odisha Public Service Commission (OPSC).

Besides, the Cabinet has approved amendments to recruitment rules of several government services.

## 47 silver bricks, ₹14L cash seized from car -

Bhubaneswar, Sept 22: Excise bricks, weighing over 139 kg, silver ornaments packed in 19 packets, and Rs 14 lakh cash from a car near Tangi toll gate in Cuttack district.

Excise officials said that acting on a tip-off on illegal transportation of ganja from Ganjam district, they searched West Bengalregistered four-wheelers. During the search of one vehicle, they found the silver bricks, 37 kg silver ornaments and cash kept in several secret chambers of the vehicle.

The silver bricks were packed in paper and stored inside a secret chamber in the back seat of the vehicle. Officials suspected that the car was designed to smuggle gold and silver items.



The environment ministry notified the Forest (Conservation) Rules, 2022 under the Forest (Conservation) Act (FCA) June 28 to replace the earlier rules, notified

The FCA was enacted in 1980 to help conserve the country's forests. It strictly restricts and regulates the de-reservation of forests or use of forest land for non-forest purposes without the prior approval of the Centre.

Neptune is located 30 times farther from the Sun than Earth, and orbits in the remote, dark region of the outer solar system.

The planet is characterised as an ice giant due to the chemical make-up of its interior. Compared to the gas giants, Jupiter and Saturn, Neptune is much richer in elements heavier than hydrogen and helium.

This is readily apparent in Neptune's signature blue appearance in Hubble Space Telescope images at visible wavelengths, caused by small amounts of gaseous methane. Webb's Near-Infrared

Camera (NIRCam) images objects in the near-infrared range from 0.6 to 5 microns, so Neptune does

## Tribals all set to run depots, sell kendu leaf on their own

Nayagarh, Sept 22: Tribals in Daspalla block of this district have found a way to reap the benefits of the Forest Rights Act (FRA) or community forest resources right as they are all set to establish a kendu leaf depot and market on their own without the intervention of the government to boost their livelihoods.

The matter came to the fore after the tribals visited Nuagaon village under Amapani panchayat of Koksara block in Kalahandi district and underwent training on management of kendu leaf depot.

In coming days, they will sell a bundle of leaves at ₹4 instead of ₹1.40 as practiced earlier. Moreover, they will not sell the leaves to the state government but market on their own. The new move will help them increase their earnings involving their family members in the job.

Reports said that kendu leaf is collected mostly in the tribal and Dalit dominated regions of Daspalla block. Collection starts from the start of March and concludes by the first fortnight of June. The tribals make it a point for proper growth of trees so that it will give them maximum number of leaves. Kendu leaves are collected in abundance

from trees which grow on the plains. The leaves sprout more on the and dry summer winds blow. The

tribal women try to make most of

the opportunity. Their day starts around 5.00am daily as they leave home for the forests to collect leaves. They return home around 11am and sit down to prepare bundles by segregating the good leaves from the

They used to prepare bundles of 21 leaves each and sell each bundle at ₹1.40 at the kendu leaf depot. However, the earning falls far short of their need. The change came after the tribals learnt that there is more profit in sale of kendu leaf under Forest Rights Act. They decided to implement it in their district and underwent training for the purpose in Kalahandi district.

A tribal Lakshmidhar Jani of Sanakamiti village said a social outfit Nirman in assistance with Paul Hamlyn Foundation has been undertaking field visits of tribals to augment their livelihood. They explained it to them that how the tribals in Nuagaon of Kalahandi district could boost their earnings by exercising their rights as enshrined in the Forest Rights Act or community forest resources right.

They were urged to undergo a training programme to know more about the Forest Rights Act which will help them to boost their earnKulurukumpha, one from Takara, eight from Bhogabari and 18 from Tumandi villages took the training.

They visited Nuagaon in Kalahandi district where they had a firsthand experience on the benefits of self establishment of kendu leaf depot. This will be implemented from 2023 making them first in the district in exercise of Forest Rights Act.

Sadhab Majhi, a woman of Putubari village said that earlier the women used to prepare bundles of 21 leaves and sell it at ₹1.40 to the state government. Henceforth, they will prepare a bundle of 25 leaves and sell it for ₹4 to various firms and outside traders. Various companies have already started contacting them to purchase their leaves and giving them orders.

Sukanti Behera of Banka Taila village said earlier the government had to open depots at Sanakamiti, Bhogabari, Narajipada, Gura, Tilabari areas for purchase of kendu leaves but now on the government will no more be required to open depots. They will do all the work from collecting the leaves and its marketing. This will help them earn more to manage the expenses of their family, she added.

## **Education & Poverty**

The COVID-19 pandemic caused the most significant global disruption in education in modern history. With nine out of ten children around the world affected, two decades of progress on educational access and

In response to this crisis, United Nations Secretary-General António Guterres convened the Transforming Education Summit in New York this month. But the summit is about more than regaining lost ground. The goal is to mobilise a global movement that can bring education to the forefront of the political agenda and push policymakers to achieve the UN's Sustainable Development Goal for education (SDG4): "ensure inclusive and equitable quality education and promote lifelong learning opportunities for all.'

It is not hard to see why education needs to be transformed. Even before the pandemic, the state of education worldwide was far from ideal. With 300 million children out of school, an estimated 57% of ten-year-olds in low- and middle-income countries cannot even comprehend a simple text.

To give every child the best chance to succeed, we must aim higher. Making education more inclusive and equitable means addressing glaring inequalities in opportunities and investment. It also means eradicating the self-reinforcing mechanisms, also known as poverty traps, that perpetuate existing disparities

For starters, education must allow all students to develop their capacity for learning by starting with the building blocks of knowledge and critical thinking: literacy, numeracy, and scientific reasoning. Doing so would help students distinguish fact-based arguments from fake or unsubstantiated claims. Education should also enhance the capacity for lifelong learning and re-learning – a crucial skill in today's rapidly changing job market.

But at a time of growing political polarisation, education should go beyond academic skills and develop students' capacity to live together. This would require education systems that emphasise civic responsibility, democratic governance, respect for human diversity, and an active commitment to sustainable development.

For education to be transformed for the better, schools themselves need to change. For example, in developing countries, an estimated 90% of children with disabilities still don't attend school. All schools need to become safe and healthy learning spaces where every child or young person feels accepted

learning resources should be considered public goods, free and open to all and protected. Educators are the most critical factor for education, and we need more of them -69 million, to be exact - in order to achieve the UN goal

of ensuring universal basic education by 2030. But to transform education. teachers must also transform themselves, shifting from merely transmitting content to developing their students' problem-solving skills, and from reciting preconceived answers to posing challenging questions. The problem is that teachers are under-trained, undervalued, and underpaid. The only way to have more and better teachers is by strengthening their training, showing them more trust and respect, and ensuring that they receive higher pay.

The pandemic has demonstrated the promise and the peril of digital learning. In the midst of lockdowns, digital technology allowed many schools and teachers to reach otherwise-isolated students. Yet, in low- and middleincome countries, many children still lack access to necessary equipment and reliable connectivity. Worldwide, two-thirds of children and young people below the age of 25 still have no home internet connection.

The digital revolution has the power to expand access and enrich learning. But if left to the market alone, it may exacerbate existing inequalities. Educational teaching and learning resources should be considered public goods, free and open to all.

But it would take more than access to digital resources to reduce disparities in investment and educational opportunities. According to recent data from the Global Education Monitoring Report, rich countries invest an average of \$8,500 per year on each school-age person. Upper-middle-income countries invest about \$1,000 per student, lower-middle-income just \$275, and

It is not just inequality between countries that is a source of concern. Withincountry gaps between children from higher-income households with bettereducated parents and children born to lower-income and less-educated families are no less disturbing – particularly in the developing world, where less than half of children have access to pre-primary education, compared with 91% in high-income countries.

Closing these gaps requires treating the financing of public education as an efficient and socially responsible investment; we need to invest more in education, and to invest more equitably and efficiently. A growing body of research has shown that education has the highest rate of return - particularly early-childhood education, which yields \$17 in value for every \$1 invested. The problem is that investment in education is context-dependent. A country that suffers from high inequality and an abundance of cheap labor attracts unsophisticated investments that create low-productivity jobs. Without the need for a skilled labour force, governments have little incentive to invest in education. As Daron Acemoglu, Simon Johnson, and James A. Robinson have shown, institutional frameworks tend to be weaker in such countries. Economic and political power is typically concentrated in the hands of the wealthy, who oppose the progressive tax increases necessary to finance universal quality education. The result is a poverty trap.

It is often said that education plays an essential role in promoting sustainable economic growth. But environmentally destructive and economically inefficient poverty traps are the opposite of sustainable. Achieving the UN's SDGs would necessarily require eradicating them. Only with a more equitable model can we successfully enshrine education as a human right.

## Brouhaha

t's a negative word for some unpleasant confusion; a more neutral alternative might be the equally odd-looking hubbub. We know the word came from the French word spelled the same way: it's found in French from sixteenth century on, but it only arrived in English at the end of the nineteenth century. It seems to have been used in French drama as a noise made by the devil, who cried brou, ha, ha!. Many etymologists will say that the word was just a noisy nonsense exclamation that imitated the thing it referred to. But there is a theory, put forward by Walther von Wartburg, that it actually comes from the Hebrew barukh habba, meaning "welcome" — literally "blessed be the one who comes" — a phrase that appears several times in the Book of Psalms and which is used in Synagogue prayers and as a greeting at Jewish weddings and other occasions.

## **GOVERNANCE OF WATER**

he floods, droughts, heatwaves, and fires that are two fundamental facts. First, damage to freshwater supplies is increasingly straining human soci eties, especially the poor, with far-reaching implications for economic, social, and political stability. Second, the combined impact of today's extreme conditions is unprecedented in human history, and is overwhelming policymakers' ability to respond.

In East Africa, a devastating four-year drought has destroyed millions of livelihoods and left more than 20 million people at risk of starvation. In Pakistan, recent flooding has submerged one-third of the country, killing at least 1,500 people so far and wiping out 45% of this year's crops. In China, an unprecedented heatwave has caused acute water shortages in regions that account for one-third

of the country's rice production. Moreover, droughts and fires in the United States and Europe, and severe floods and droughts across India, have reduced global grain yields and food exports, highlighting the extent to which our food production depends on large, stable volumes of water. Add to this the impact of the war in Ukraine on grain and fertilizer supplies, and there is a substantial risk that today's global food crisis will persist. For the first time in our history, human activities are jeopardising water at its very source. Climate change and deforestation are reshaping the monsoon season, causing ice on the Tibetan plateau to melt, and affecting freshwater supplies to more than one billion people. Rising global temperatures are changing evaporation patterns and reducing moisture feedback from forests, disrupting downwind rainfall. And a destabilised global water cycle is itself aggravating climate change. For example, the depletion of water in the soil and forests is reducing their ability to sequester carbon.

Water-use restrictions, power cuts, and other stopgap measures can no longer paper over the fact that our water governance and management systems are not

suited for a world of radical environmental change. All our current arrangements rest on the assumption, now invalidated, that the water supply is relatively stable (within the bounds of natural variability), predictable, and manageable in localised ways. But the water crisis is global, and it can be solved only with transformational thinking and new governance.

We must recognise that all our key environmental challenges are connected to water - whether there is too much or too little, or whether it is too polluted for human use. The task now is to understand the links between water, climate change, and biodiversity loss, and to properly define, value, and govern water as a global common good. Thinking about water in this way will allow us to mobilise collective action and design new rules that put equity and justice at the center of our response.

For too long, most governments have either ignored market failures or responded to them with quick fixes, rather than mobilising the public and private sectors around common ambitions. The public sector must see itself as a market shaper that works with all stakeholders in the water economy to create pathways for innovation and cess to clean water and sanitation.

and provide enough water for food, energy, and natural systems.

A key lesson from past challenges that demanded systemic innovation is that a clearly defined mission is needed to organise our efforts. Mission-oriented policies allow governments to steer innovation and knowhow directly toward meeting critical goals. When guided by an inclusive "common-good" approach, they are uniquely capable of delivering solutions to challenges that require tremendous levels of coordination and financing across many years. Climate change, biodiversity loss, and water crises are precisely such challenges.

Mission-based strategies can help governments innovate with purpose, direction, and urgency But to be effective, policymakers must heed the experience and wisdom of the ordinary citizens, communities, and innovators who know how to prosper in a world of water scarcity, higher temperatures, and altered coastline and river systems.

We must now recognise threats to the global freshwater system and translate our awareness into collective action. Because water scarcity will jeopardise all the other Sustainable Development Goals, it should solidify our collective de-

industrial levels (as specified in the Paris climate agreement), and to preserve the natural systems that ensure stable rainfall and runoff patterns. In tackling these global challenges, we must hardwire the principles of equity and justice into whatever new arrangements we devise. No community can thrive without a reliable supply of clean water. But safeguarding this global common good requires new policies

Law and economics must both be reoriented to ensure universal access to clean drinking water, sanitation, and hygiene, and to build more resilient and sustainable food systems. Incentives must change so that the private sector can do its part to provide access to technology and innovation to poor and rich countries alike. This will require long-term finance and novel mechanisms to regulate how the public and private sectors work together.

The UN 2023 Water Conference - the first in almost 50 years – will be a pivotal moment for the international community to start mapping out a future that works for everyone. In preparing for it, we can take inspiration from Nicholas Stern, who rewrote the economics of climate change, and Partha Dasgupta, who rewrote the economics of biodiversity. As the cochairs of the Global Commission on the Economics of Water, our goal is to transform the world's understanding of the economics and governance of water, placing a much stronger emphasis on equity, justice, effectiveness, and democracy

We can still redefine our relationship with water and redesign our economies to value water as a global common good. But the window of opportunity is closing. To have a chance of avoiding climate catastrophe and adapting to unavoidable change, we must ensure a resilient water future for poor and rich societies alike.

Fortyfive per cent of students make a wrong career choice as more than 95 per cent schools and colleges do not offer counselling or mentoring facilities to students. The problem is more acute in semi-urban and rural areas of the country Against this backdrop, academic

institutions all over the world are implementing the mentor-mentee strategy to judge the mentality of students at the earliest. The mentor can identify each and every student in his group and offer proper counselling, whether it is academic or career, thus making the student aware of his interests, potentiality and goals.

Students are confused about the course, syllabus, examinations and employment opportunities and if these are addressed by the mentor, they can go in the right direction. Conducting classes regularly, examinations and evaluation in time are not sufficient to produce good students. The much needed claris to be injected into their minds.

Recently, UGC released guidelines on assistance to disabled students which state that higher education institutions should have a provision of support for all activities, which include registration, academic support, facilitating comfortable stay and conveyance, fee payment at the counter, sponsorship facilities, class timetable, schedules and academic almanac, grievance redressal procedures, release or issue of mark sheet, certification, diploma, transcript, migration, counselling, fellowship and scholarships which could help the students. But the same is application to all students.

Innovative changes are necessary to streamline the higher education system to create skilled manpower ready to be employable by the industry. The UGC identified mentorship as a major factor for the overall development of the student and issued guidelines for its proper implementation by the higher educational institutions. The state governments too, have been laying emphasis on the task of mentorship.

Realising the importance of mentorship in higher educational institutions, the Human Resource

Dev University organised a sixday offline faculty development programme on 'Mentoring Skills and Facilitation Skills for Rural Higher Education Institutions'. More universities are likely to follow this trend and the much needed attention for understanding the student mindset from the beginning of their admissions is felt now among the academia.

The recent reforms in higher education after the implementation of NEP-2022 have created confusion not only in the minds of students, but also of teachers and other staff members of academic institutions, particularly in rural areas.

Time has come to introspect on the working pattern of teachers and other staff members of academic institutions. The mechanical way of teaching and learning is to be evaluated and mentoring activities to understand the student mindset are to be implemented in higher educational institutions which can produce productive workforce for society.

## Rhino conservation

Sir, In India and Nepal combined, there are about 3,500 rhinoceroses. The International Union for Conservation of Nature (ICUN) has placed the one horned rhinos under 'vulnerable' category in its red list. Many of India's rhinos, nearly seventy per cent, are housed in Assam's Kaziranga National Park. Last year, China revoked the ban on the use of 'medicinal parts' of rhinoceros and tigers. Lifting of ban on use of certain parts of wild animals almost means legalising poaching because the body parts of dead animals -- bones of tigers and horns of rhinos -- can be used for medicinal purposes though the same has not been authenticated. The problem lies with India's close proximity to China. Rhino horns are used for water purifying purpose and as an aphrodisiac in some parts. Countries like Yemen prepare daggers from rhino horns. In India, the whole northeast and northern part of West Bengal are on high alert because of their international borders. Rhinoceros poaching is quite common in India. Assam borders Bhutan, so the rhinoceros of Manas National Park are particularly in danger. Barring a brief period, rhinoceros population in Manas has always been steady. Preserving the rhino habitat and taking protective measures conducive for the rhino population to flourish have paid dividends. As per the latest numbers, there are 54 Rhinos in Manas National Park, which is now a UNESCO world heritage site. The efforts put in by the experts can be gauged by the fact that rhinos are intensely territorial animals who resist shifting their base. The "Indian Rhino Vision 2020 (IRV 2020)" programme met with considerable success - it almost achieved its aim of attaining 3000 greater one-horned rhinos in seven protected areas of Assam by 2020 though it fell short of achieving its target in three of the seven areas. The programme owes its success to a collaborative effort from all stakeholders. Ganapathi Bhat, AKOLA

## Prez poll: Congress issues notification



## **How PFI spread its wing across country**

Multi-agency teams spearheaded by the NIA arrested 106 functionaries of the radical Islamic outfit Popular Front of India (PFI) Thursday in near simultaneous raids at 93 locations in 15 states for allegedly supporting terror activities in the country, officials said

New Delhi, Sept 22: In a major crackdown on the Popular Front of India (PFI), the National Investigation Agency (NIA) and the Enforcement Directorate (ED) Thursday raided premises linked to PFI in 10 states across the country and arrested more than 100 top PFI

leaders and functionaries An official said that the agency

had learnt that the PFI was indulging in terror funding besides imparting training to the youth in order to radicalise them

"We have seized incriminating documents, digital devices, cash to the tune of ₹10 lakh along with weapons. We have learnt that camps were organised where conspiracies were hatched to carry out terror-related activities in the country," said a source.

## What is PFI?

The Popular Front of India was established in 2006 in Kerala. E. Abubacker, the chairman of PFI, is also a resident of Kerala. The organisation established its headquarters in Kozhikode, which was later changed to Delhi, PFI national general secretary Nasaruddin Elamaram is also a founding mem-

A number of radical groups, which were active in southern India, wanted to form a group. These highly-radicalised groups decided to come on a single platform.

"The National Development Front of Kerala, Karnataka Forum for Dignity, and Manitha Neethi Pasari of Tamil Nadu came together to form the PFI after dismantling their individual outfits," the official said.

According to sources, the PFI has now spread its network to twodozen states across the country The sources said that in the name of fighting for Muslim rights, the PFI won the trust of many Muslim youth who joined the outfit in different capacities. It rapidly started opening office in different states where further recruitments were made. The PFI has also spread its netwrok overseas. The agencies have learnt that PFI receives funds from Muslim countries in the name of donation. While the PFI members claim that they use these funds to fight for the rights of Muslims and Dalits, the agencies have found that they use these funds to carry out terror activities.

#### The action of agencies

Central agencies NIA and ED Thursday conducted raids across 11 states, including Assam, Bihar, Kerala, Andhra Pradesh, Delhi, Uttar Pradesh, Karnataka, Telangana, Tamil Nadu and Rajasthan, and arrested more than 100 suspected PFI activists for allegedly supporting terror activities in the country.

'Twenty persons each were arrested from Karnataka and Maharashtra, followed by Tamil Nadu (10), Assam (9), Uttar Pradesh (8), Andhra Pradesh (5), Madhya Pradesh (4), Puddicherry (3), and Rajasthan (2),"said an NIA source.

What next? Sources have claimed that the Centre has decided to ban PFI for its alleged involvement in terror activities. A high-level meeting was held between Union Home Minister Amit Shah and top agency officials on this count

# AP to stop confining pigs to crates following PETA appeal

Amaravati, Sept 22: In a victory for animal rights activists, the Andhra Pradesh government has stepped in to stop the use of gestation and farrowing crates in pig farming.

Following an appeal from People for the Ethical Treatment of Animals (PETA) India to prohibit the manufacture, sale, and use of gestation and farrowing crates in pig farming, the Directorate of Animal Husbandry of Andhra Pradesh has issued a circular in structing the district animal husbandry officers to ensure compliance with the group's request within their jurisdictions.

The circular cites Section 11(1)(e) of the Prevention of Cruelty to Animals Act, 1960, which prohibits the confinement of any animal in a receptacle that fails to offer a reasonable opportunity for movement, such as gestation and farrowing crates. Gestation crates or "sow stalls" are metal cages, es-

## Now, govt approval must for fee hike

IT IS BELIEVED THAT THE STATE GOVERNMENT HAS TAKEN THIS STEP AFTER A SERIES **OF COMPLAINTS RAISED AGAINST A SECTION** OF PRIVATE EDUCATIONAL INSTITUTES IN THE **STATE ABOUT HIKING THEIR FEES** WITHOUT ANY PRIOR NOTICE



Guwahati, Sept 22: From now on. private educational institutions in Assam cannot hike their fees without prior approval of the state government's regulatory body, officials said.

The Assam Non-Government Educational Institutions (Regulation of Fees) (Amendment) Bill, 2022, passed in the Assembly, has recommended penal measures against private educational institutions in the state that don't complv with the provisions of the Fee Regulation Act.

According to the bill, "subject to the provisions of section 10 of the Act, the Fee Regulatory Committee shall recommend maximum limits of fees to be charged by the different categories of Non-Government Educational Institutions in every year before starting of the academic session".

Private educational institutions will have to file applications before the government constituted Fee Regulatory Committee for exemption and fixation of their fee structure by October 31. The amendment bill also said that if the non-government educational institutions fail to apply before the Committee, Rs 10,000 penalty will be imposed on them for non-submission of the applications before the deadline.

After the deadline, a late fee of Rs 5,000 per month will also be charged. "In the event of non-submission of the proposal by the non-government educational institutions before starting of the new academic session to determine their fee structure, the Fee Regulatory Committee shall suo moto determine the fee structure of that particular institution which shall be binding on such school.' the amendment bill added.

## Assam to use 'SAANS' to stop neonatal deaths

Guwahati, Sept 22: Following the success of a pilot project to reduce neonatal mortality with a special equipment 'SAANS', the Assam government has decided to use the air pressure machine developed by a Bangalore-based start-up across its hospitals, officials said Thursday.

'SAANS' is a portable neonatal Continuous Positive Air Pressure (CPAP) system that can provide lifesaving breathing support to infants in hospital settings as well as during travel. A senior official of the start-up InnAccel Technologies claimed that the machine was used with some babies at Gauhati Medical College and Hospital as a pilot project and demonstrated "excellent results". "Following this, more than 50 SAANS devices have been deployed across medical colleges in Assam to date with more deployments underway to district hospitals," he said.

For development of the machine, InnAccel Technologies, incubated at the Centre for Cellular and

Molecular Platforms (C-CAMP) joined hands with the SAMRIDH Healthcare Blended Finance Facility to strengthen respiratory support for newborns and pediatric populations in Assam.

SAMRIDH is a multi-stakeholder innovation and financing platform supported by the United States Agency for International Development (USAID) and implemented by IPE Global."Through this partnership, InnAccel Technologies will receive access to affordable finance and technical assistance to expand the production and distribution of SAANS,' said the maker of the indigenous lifesaving device to reduce neonatal mortality due to Respiratory Distress Syndrome (RDS).

The partnership between InnAccel, C-CAMP and SAMRIDH with support from the National Health Mission, Assam and the Government of Assam will help deploy 307 units of SAANS in the state, the company official said.

The distribution of these quantities of machines is expected to

that he had purchased the land in 1992 and asked him why he needs the no-objection certificate from

the Waqf board. The registrar, according to Rajagopal, told him that the Tamil Nadu Waqf board has sent a 250page letter to the Deeds Department stating that any land transaction in Tiruchendurai village must be done only with a no-objection certificate from it.

The Tamil Nadu Waqf board also stated that the entire land property in the village belonged

The local people were shocked vhen they came to know about the directive from the Waqf board and almost everyone in the village has the land in his/her name. BJP Tiruchi district secretary, Alur Prakash said, "The entire village is a Hindu-dominated area. How can Waqf board own this property."

He further said. "The Chandrashekhara Swamy temple in the village has 389 acres of land and is a 1500-year-old temple. Is this land also Waqf property.' Meanwhile, the Tiruchi district collector told Rajagopal and others who had apprised him of the issue that the matter would be investigated and further action would be taken in the days to come.

## TN students below par in numeracy levels: Study

Chennai, Sept 22: A recent study conducted by the National Council For Educational Research and Training (NCERT) has revealed that the students of Class 3 in Tamil Nadu schools are abysmally poor in numerical ability tests.

The students fared poorly in the language proficiency tests as well, shockingly in the Tamil lan-

The Foundational learning study, 2022, was conducted by the NCERT for the Nipun Bharat scheme under the Union Ministry of Education.

The study found that 29% of Tamil Nadu's Class 3 students could not complete the basic numerical abilities including number identification, multiplication, division, identifying patterns comprising numbers and shapes and identifying dates and months in calendars. This makes the state the most backward as far as the numerical ability of the students of Class 3 is concerned.

Tamil Nadu is followed by Jammu and Kashmir (28%). Assam (18%), Gujarat (18%) and Chhattisgarh (18%). The national average of the number of students who could not comprehend numerically was only 11%. Interestingly the Gross

Enrolment Ratio at the national level is only 27.1 while that of Tamil Nadu is 51.4. This data clearly shows that Tamil Nadu is lagging behind other states in The state fared poorly in the

language category as well with 48 percent of students not knowing basic knowledge and skills in Tamil while 43% did not know the basics of English.

The test was conducted with the children being made to read out loud and asked questions from texts that were not in the school

syllabus. The study was conducted among 2937 class 3 students from 336 schools. The study was undertaken among government schools, private schools and aided schools students. The NCERT in its report said that only 46% of the students were able to read 80-100 let-

read 80% of the words in English fluently.

## Tea growers pick up the pieces after rain havoc

Nilgiris (Tamil Nadu), Sept 22: As incessant rains battered the Nilgiris district of Tamil Nadu in July and August, John PT (67) was worried about his one-acre tea garden. A farmer from Kavvunni in Pandalur taluk, John was least prepared for the losses that poured in.

There was a drastic drop in both harvest and earnings. On average, John gets 500 kg of tea leaves a month. However, in August, the yield dipped to 124 kg "I usually earn Rs 5,500 at a rate of Rs 11 per kg, but the rains brought it down to Rs 1,364," he said, adding that he did the farm work all by himself as he could not afford to pay labourers.

Most farmers in the region have up to five acres of tea gardens, and the rains did not spare anyone. They claimed the harvest has dipped by around 80 per cent, but the government has not assessed crop damage yet. "It is normal to have poor harvests in summer and monsoon seasons. But we never faced a loss of this magnitude,' John said.

Tamil Nadu recorded 98 per cent excess rainfall between June 1 and August 8, with the Nilgiris receiv-

ing the highest rainfall of 67.50 mm. On the other hand, data from the Regional Agricultural Research Station (RARS), Wayanad, showed a respective increase of 65% and 62% in the region's rainfall in July and August.

Though located in nearby Kerala. Gudalur and Pandalur taluks depend on the RARS for weather data rather than the monitoring station in Ootv.

The tea industry in the Nilgiris and Wayanad witnessed a neartotal shutdown from August 1 to 15 due to poor leaf supply.

Both districts together have 292 green-leaf processing units (bought leaf factories). As most of them were affected, over 50,000 farmers, lakhs of daily labourers, tea leaf suppliers and factory staff were left in the lurch

According to Shajeesh Jan P, Assistant Professor, Department of Agricultural Meteorology, RARS, there were only seven sunny days in July, which probably led to leaf blights due to fungal attack.

"As it rained heavily, the plants froze without any fresh sprouts. At the same time, the fungus affected the leaves," said a scientist at a plantation in the Nilgiris dis-



trict, requesting anonymity. "Though leaf blights affect farms more or less every year, especially in winters and at the peak of monsoons, its impact was particularly high this year." In short, the plucking of tea leaves picked up pace only in the third week of August, even as the rains continued to play spoilsport.

No work, no earnings

The tender tea leaves are handplucked every 10 to 15 days and sheared every 20 days. Depending on their expertise, labourers earn Rs 240 to 700 a day by plucking 40 to 100 kg of green leaf a day.

Ranjini Joy (38), a Chermabadi resident who works in a farmers' society at Pothukolly, said she did not earn anything when leaf-plucking stopped for two weeks. Her husband had to shift to Coimbatore in search of work. "Several farm labourers have temporarily shifted to Coimbatore, Tirupur, Kozhikode and Bengaluru to find jobs," said Joy.


Sheeba Solomon (36), whose husband is a farm labourer at Kayyunni, hardly got 10 days of leaf-plucking work in August. With two school-going children, her family had to struggle to meet their daily needs. "The public distribution system saved us from starvation. I borrowed money from women's self-help groups and took wage advance to meet the expenses related to the household and education of children," she said.

Her mother, also a daily wage labourer in the tea garden, did not get work for three weeks. "We suffered a setback of at least Rs 25,000 in earnings," said Sheeba, who is constantly worried about a possible landslide as the family lives near a hillock.

For many like Navaneetham Mahendran (47), the struggle was manifold as she had to send money to her children studying in Coimbatore. "My husband's provision store at PRF Colony in Kayyunni also incurred losses.' She said the shutdown of plantations and small farms also affected women's self-help groups as there was no money flow.

Though rains have subsided ঽ now, the green-leaf supply has not rebounded. A production unit needs a minimum of 10,000 kg of tea leaves a day to operate. "As supply dipped, most of us were forced to shut our units for two weeks," said-Rahul J Chordia, a partner in Royal Valley group, Coonoor.

# K'taka hijab row: SC reserves verdict

New Delhi, Sept 22: The meandering 10-day arguments on Karnataka's hijab row concluded Thursday, with the counsel for Muslim petitioners making a last gasp effort to have the ban on the Islamic headscarf in classrooms lifted, insisting the state should be concerned more about education than an apparel.

They also flagged the pet 'Beti Bachao, Beti Padhao' slogan of Prime Minister Narendra Modi to buttress their point of women empowerment while remonstrating alleged attempts at stopping Muslim girls from attaining education by banning the hijab.

A number of counsel for the Muslim girls insisted during the often abrasive arguments that preventing them from wearing the hijab to the classroom will put their education in jeopardy as they

might stop attending classes. After the arguments put forth by the counsel for the Muslim girls, the apex court reserved its verdict on a batch of pleas challenging the Karnataka High Court judgement refusing to lift the ban on hijab in educational institutions.

An exasperated bench of Justices Hemant Gupta and Sudhanshu Dhulia had on Wednesday asked the counsel appearing for the petitioners to wrap up their rebuttal arguments within an hour on Thursday, saying "we are losing our patience" and that there was an "overdose of hearing".

"We will give one hour time to all of you. You finish that. Now, it is an overdose of hearing," the judges had told senior advocate Huzefa Ahmadi. The counsel appearing for the petitioners argued on various aspects, including on the state government's February 5, 2022 order which banned wearing clothes that disturb equality, integrity, and public order in schools and colleges.

Ahmadi, appearing for some of the petitioners, told the bench the state has not been able to point out as to which fundamental right of other students was infringed on account of Muslim girl students wearing the hijab. The counsel for Karnataka, however, insisted the state government's circular was "religion neutral" with no reference to the hijab.

## **RUSSIANS FLEE AFTER MILITARY CALL-UP** protests spread

Kyiv/New York, Sept 22: Some draft-age Russians headed abroad Thursday to escape their country's biggest conscription drive since World War Two, while explosions shook southeastern Ukraine on the eve of referendums planned there by pro-Moscow separatists.

President Vladimir Putin's new mobilisation campaign escalates a war that has already killed thousands, displaced millions, pulverised cities, damaged the global economy and revived Cold War confrontation.

Though polls have suggested widespread domestic backing for Russia's intervention in Ukraine, mass conscription may be a domestically risky move after past Kremlin promises it would not happen and a string of battlefield failures in Ukraine.

"Every normal person is (concerned)," said one man, identifying himself only as Sergey, disembarking in Belgrade after a flight from Moscow. "It is OK to be afraid of the war.'

Anti-war protests in 38 Russian cities saw more than 1,300 people arrested on Wednesday, a monitoring group said, with more planned for the weekend. Some of the detainees had been ordered to report to enlistment offices on Thursday, the first full day of conscription, independent news out-

Dubai, Sept 22: Clashes between Iranian security forces and protesters angry over the death of a 22year-old woman in police custody have killed at least nine people since the violence erupted over the weekend, according to a tally Thursday by The Associated Press.

Widespread outages of Instagram and WhatsApp, which protesters use to share information about the government's rolling crackdown on dissent, continued Thursday Authorities also appeared to disrupt internet access to the outside world, a tactic that rights activists say the government often employs in times of unrest.

The demonstrations in Iran began as an emotional outpouring over the death of Mahsa Amini, a young woman held by the country's morality police for allegedly violating its strictly enforced dress code. Her death has sparked sharp condemnation from the United States, the European Union and the United Nations. The police say she died of a heart attack and was not mistreated, but her family has cast doubt on that account.

The protests have grown in the ast four days into an open challenge to the government, with women

removing their state-mandated headscarves in the streets and Iranians setting trash bins ablaze and calling for the downfall of the Islamic Republic itself."Death to the dictator!" has been a common cry in the protests.

Demonstrations have also rocked university campuses in Tehran and far flung western cities such as Kermanshah. Although widespread, the unrest appears distinct from earlier rounds of nationwide protests triggered by pocketbook issues as Iran's economy staggers under heavy US sanctions.

The unrest that erupted in 2019 over the government's abrupt gasoline price hike mobilised working class masses in small towns. Hundreds were killed as security forces cracked down, according to human rights groups, the deadliest violence since the 1979 Islamic Revolution.

Iran's state-run media this week reported demonstrations in at least 13 cities, including the capital, Tehran, as protesters vent anger over social repression. Videos online show security forces firing tear gas and water cannons to disperse the protests. London-based Amnesty International reported that officers fired birdshot and beat protesters with batons.

At least nine people have died in the confrontations, according to an AP count based on statements from Iran's state-run and semiofficial media. Officials have blamed unnamed foreign countries, which they claim are trying to foment unrest. In Amini's home province in the northwest, Kurdistan, the provincial police chief said four protesters were killed by live fire.

## **Quake shakes** Mexico, 2 dead

Mexico City, Sept 22: A powerful earthquake of magnitude 6.8 struck Mexico early Thursday, causing at least two deaths, damaging buildings and setting off landslides.

The earthquake struck at 1.19 am near the epicentre of a magnitude 7.6 quake that hit three days earlier in the western state of Michoacan. It was also blamed for two deaths. The US Geological Survey said that Thursday's earthquake was centred 31 miles (50 kilometres) south-southwest of Aguililla, Michoacan, at a depth of 15 miles (24.1 kilometres).

Michoacan's state government said the quake was felt throughout the state. It reported damage to a building in the city of Uruapan and some landslides on highways. President Andrés Manuel López Obrador said via Twitter that it was an aftershock from Monday's quake and was also felt in the states of Colima, Jalisco and

Guerrero. Mexico City Mayor Claudia Sheinbaum said via Twitter that two people died — a woman who fell down the stairs of her home and a man who had a heart attack. Residents huddled in streets as

seismic alarms blared. The earthquake rattled an already jittery country. Monday's more powerful quake was the third major earthquake to strike on  $\rightarrow$ September 19 — in 1985, 2017, and now 2022.

The 2017 and 2022 September 19 quakes came very shortly after the annual earthquake drill conducted every September 19 to commemorate the devastating 1985 temblor that killed some 9,500 people.

## Secret vaccinations help Zimbabwe mothers protect children church attitudes, but also advise

More than 700 children have died from measles in Zimbabwe in an outbreak first reported in April

Harare (Zimbabwe), Sept 22: Dozens of women holding babies rushed to take their places on wooden benches at a clinic in Zimbabwe while a nurse took a separate group of anxious mothers and their children through a back door and into another room.

The nurse quickly closed the door behind them. The women were all at the Mbare Polyclinic in Zimbabwe's capital, Harare, to get their children vaccinated against measles amid a deadly outbreak in the southern African country.

But those who were taken to the back room were getting their children vaccinated in secret, and in defiance of religious doctrine that forbids them from using modern medicines."The advent of the measles outbreak saw children dying so they are now coming secretly and we are helping them," said Lewis Foya, a nurse at the More than 700 children have

died from measles in Zimbabwe in an outbreak first reported in April. Many were unvaccinated because of religious reasons, Information Minister Monica Mutsvangwa said. The government has announced a vaccination drive but, as with COVID-19, some religious groups are stubbornly opposed to vaccines and have hindered the campaign.



Apostolic groups that infuse traditional beliefs into a Pentecostal doctrine are among the most skeptical of modern medicine in Zimbabwe. Followers instead put

their faith in prayer, holy water and other measures to ward off disease or cure illnesses

"They have a belief that if they get vaccinated, they become unholy so that's the doctrine that they pass down to the women," said Foya. He said the patriarchy in the church means women have "no power to openly say no" to instructions. Children are then in

There has been little detailed research on Apostolic churches in Zimbabwe but studies by the United Nations children's agency, UNICEF, estimate it is the largest denomination with around 2.5 million followers in a country of 15 million.

Some allow members to seek health care. Many are still resistant. So to save their children, some mothers visit clinics in secret, sometimes under the cover of night and without their husbands knowing. A group of Apostolic church members who are open to modern medicine have been trying to change women to go against church rules if it means helping their children. 'We encourage women to get

their children vaccinated, maybe at night," said Debra Mpofu, a member of the Apostolic Women Empowerment Trust. "It's really necessary for the women to protect their children so it's important for them to just sneak out." The secrecy is necessary because members found to have visited health care centers are shamed and forbidden from taking part in church activities.

The World Health Organisation warned in April of an increase in measles in vulnerable countries due to COVID-19 disruptions, with more than 40 countries postponing or suspending their regular immunization campaigns.

#### **US Fed feeds recession fears**

London: Federal Reserve Chair Jerome Powell vowed Wednesday that he and his fellow policymakers would "keep at" their battle to beat down inflation, as the US central bank hiked interest rates by threequarters of a percentage point for a third straight time and signaled that borrowing costs would keep rising this year. "No one knows whether this process will lead to a recession or if so how significant that recession would be," Fed Chair Jerome Powell told reporters after the rate hike announcement. "The chances of a soft landing are likely to diminish to the extent that policy needs to be more restrictive, or restrictive for longer."

### **Bank of England raises rates to 2.25%**

London: The Bank of England raised its key interest rate to 2.25% from 1.75% Thursday and said it would continue to "respond forcefully, as necessary" to inflation, despite the economy entering recession. ## ₹58,521 crore in taxes lost in 5 key industries

New Delhi, Sept 22: The exchequer is estimated to have lost ₹58,521 crore in taxes in 2019-20 due to illicit trade in goods in 5 key industries, including FMCG, mobile phone, tobacco products and alcohol, a Ficci report said Thursday. The report estimates the size of

illicit markets in these industries at a little over ₹2.60 lakh crore for the year 2019-20, with the FMCG industry accounting for 75 per cent of the total illicit value of goods in five key industries. "The estimated tax loss to the gov-

ernment due to illicit goods in these five key industries is ₹58.521 crore," said the report titled 'Illicit Markets: A Threat to Our National Interests' by FICCI's Committee Against Smuggling and Counterfeiting Activities Destroying the Economy (CASCADE).

The two highly regulated and taxed industries, tobacco products and alcoholic beverages, account for nearly 49 per cent of the overall tax loss to the government due to illicit markets in these five key industries.

The maximum number of jobs (7.94 lakh) were lost due to illicit trade in the FMCG packaged foods industry, followed by tobacco industry (3.7 lakh), FMCG household and personal goods industry (2.989 lakh), alcoholic beverages industry (97,000), and mobile phone industry (35,000).

The tax loss to the government due to illicit trade in these five sectors stood at ₹17.074 crore (FMCG packaged foods), ₹15,262 crore (al-



coholic beverages), ₹13,331 crore (tobacco products), ₹9.995 crore (FMCG household and personal goods), and ₹2,859 crore (mobile phones).

"The impact of the illicit market of these key industries on the economy is pervasive and significant because of the backward linkages of these industries with other sectors of the economy resulting in a multiplier effect. Higher the multiplier, higher is its overall effect on the economy," the report said.

Of the total illicit market size of ₹2.60 lakh crore, FMCG industry (household and personal goods, packaged foods) constitute over ₹1.97 lakh crore. This is followed by alcoholic beverages at ₹23,466 crore, tobacco products (₹22,930 crore) and mo-

bile phones (₹15,884 crore). The report highlights that to deal with the menace of illicit markets in India, addressing the demand and supply gap of legitimate goods, strengthening the domestic manufacturing sector, increasing awareness among consumers, rationalisation of tariffs to reduce tax arbitrage, creation of a conducive environment for innovation and better international coordination and cooperation are some of the way forwards.

#### Since Falcon Group is one of the leading exporters in seafood, what challenges have you faced from other international competitors such as China, Vietnam or Thailand?

China is largely an importer but Vietnam. Thailand and mainly Ecuador are our strong competitors. Vietnam provides value addition to the shrimp and Ecuador has a stronghold with the US markets due to its proximity. However, we have decided to set up two factories in Andhra Pradesh that will not only help in improving our procurements but also will add value to our products.

#### What technological changes have you seen?

■ When I joined in 2006, an urgent need was felt in terms of mindset shift. We decided to upgrade our systems and introduce various technological changes. This was faced by a lot of resistance and since most of our business deals in fish trade which involves dealing with the farmers in the rural areas, the changes were not easy. However, things have started to turnaround in last few years, but we have been cautious as it is important to develop trust and friendship with our suppliers as well as buyers.

■ What are the challenges you

## dealt with during pandemic?

During the first year of the pandemic, we subdued our business in order to reduce losses to both our suppliers and us. Since we largely deal in highly perishable items, we cannot hold stocks for a longer period. Post pandemic period has come with a different set of challenges. The biggest has been the increase in freight charges. The rates have surged from \$4,000 to \$14,000. While demand has increased, the phenomenal change in freights is eating up into our profits. Moreover, since we largely cater to the US market, inflation has led to fall in consumption in current situation.

## ■ What are your future expansion plans?

We are primarily aiming to be the biggest exporter in seafood in Asia. We are setting up new factories in Andhra Pradesh in this regard. Moreover, we have explored a sector, which has huge potential and scalability and we are looking at ₹800-1000 crore investment in two years. Apart from this, we are also planning to expand into real estate business in Odisha and have aimed to launch 5-6 million square ft projects in next 3-4 years. However, we are not really focused in making profits but ensuring quality and want to bring a mindset shift in real estate by delivering highquality houses to users at very affordable prices as quality is more important than quantity

## Internet calling, messaging apps may need telecom licence

THE GOVERNMENT IN THE BILL HAS PROPOSED A PROVISION TO WAIVE FEES AND PENALTY OF **TELECOM AND INTERNET SERVICE PROVIDERS**

New Delhi, Sept 22: Over-the-top players like Whatsapp, Zoom and Google Duo which provide calling and messaging services may require licences to operate in the country, according to the draft

telecommunication bill 2022. The draft bill has included OTT as part of the telecommunication service. "For provision of Telecommunication Services and

Telecommunication Networks, an entity shall have to obtain a license," the draft bill released Wednesday evening said.

The government in the bill has proposed a provision to waive fees and penalty of telecom and internet service providers.

The ministry has also proposed a provision for the refund of fees in case a telecom or internet provider surrenders his license. "Seeking your views on the

draft Indian Telecom Bill 2022,' Telecom Minister Ashwini Vaishnaw said in a post on a so-

cial media platform in which he also shared the link of the draft bill.

The last date for public comment on the draft is October 20. According to the draft, the cen-

tral government may, "waive in part or full any fee, including entry fees, license fees, registrations fees or any other fees or charges, interest, additional charges or penalty" for any licence holder or registered entity under the telecom rules.

The bill proposes to exempt "press messages that are intended to be published in India" of correspondents accredited to the central or state government from interception.

However, the exemption will not be granted in case of any public emergency or in the interest of the public safety, sovereignty, integrity or security of India, friendly relations with foreign states, public order, or to prevent incitement to an offence, according to the draft.

In such cases "any message or class of messages, to or from any person or class of persons, or relating to any particular subject, brought for transmission by, or transmitted or received by any telecommunication services or telecommunication network, shall not be transmitted, or shall be intercepted or detained or disclosed" to the authorised officer, according to the draft bill.

Canterbury, Sept 22: Skipper Harmanpreet Kaur smashed a scintillating unbeaten ton (143 n o, 111b, 18x4, 4x6) to power India to a comprehensive 88-run win in the second ODI, that sealed country's first series win against England since 1999.

India bundled out England for 245 in 44.5 overs with medium pacer Renuka Singh (4/57) leading charge Wednesday night. Danni Wyatt's 58-ball 65 (6x4) was the lone bright spot, in an otherwise, dismal show by England batters.

The last time Indian women won an ODI series in England was in 1999 when they triumphed 2-1.

Chasing the imposing total, what England needed was a brisk start, but Renuka denied them by dismissing two top-order batter in Emma Lamb (15) and Sophia Dunkley (1). Tammy Beaumont (6) was run out as the hosts were reduced to 47/3 by the end of the

eighth over.

Sent into bat, Harmanpreet enjoyed a fine 112-run stand for the fourth wicket with Harleen Deol (58, 72b, 5x4, 2x6). She also added 50 with Pooia Vastrakar (18) and another 71 runs in four overs with Deepti Sharma (15 n o) for the unbroken sixth wicket stand.

## IPL TO RETURN TO ITS **OLD FORMAT IN 2023**

New Delhi, Sept 22: The Indian Premier League (IPL) will return to its original, pre-COVID-19, homeand-away format from the 2023 season, BCCI President Sourav Ganguly has conveyed to the Board's affiliated state units.

The IPL has been held at only a few venues since the outbreak of COVID-19 in 2020 as the lucrative league unfolded behind closed doors across three venues in UAE Dubai, Sharjah and Abu Dhabi. In 2021 too, the tournament was held across four venues – Delhi, Ahmedabad, Mumbai and

However, with the pandemic under control, the cash-rich league will return to its old format in which each team plays one home and one away match.

'The next season of men's IPL will also go back to the home and away format with all ten teams playing their home matches at their designated venues," read a Ganguly's note to state units. The note gave them a "snapshot" of the ongoing domestic season.

The BCCI is conducting a fullfledged domestic season for the first time since 2020 and all multi-day tournaments will also return to the traditional home and away forWomen's IPL likely

The BCCI is also working to host the inaugural edition of the much-anticipated Women's IPL early next year. PTI had last month reported that the tournament is likely to take place in March after the Women's T20 World Cup in South Africa.

The BCCI is currently working on the much-awaited Women's IPL. We are expecting to start the first season early next year." Ganguly wrote in the letter dated September 20.

The Women's IPL is expected to raise the standard of women's cricket in India.

Besides the Women's IPL, the BCCI is also launching a girls U-15 ODI tournament. "We are glad to introduce a girls U15 One Day tournament from this season Women's cricket has seen phenomenal growth across the world and our national team has been performing well. This new tour nament will create a pathway for our young girls to play at the national and international level," Ganguly wrote.

"It is not ideal," Southgate said of some of his key players not playing for their clubs, "but we feel they have been, and can be, important players for us. It is not a perfect situation but there is still a lot of football to be played before Qatar.'

## Bajrang blames doctors for poor Worlds show

New Delhi, Sept 22: Star wrestler Bajrang Punia remains baffled by the on-spot doctors' decision to use 'rigid tape' on his bleeding head, which severely hampered his focus ahead of the quarterfinal clash against USA's John Michael Diakomihalis during the World Championship. Bajrang, gunning for his maiden

world title, suffered a head injury in his opening bout against Cuba's Alejandro Enrique Vlades Tobier in the very first minute of the clash in Belgrade. The on-spot doctors rushed to the

mat and applied 'rigid tape', which is actually used to stabilise knee and ankle. Mostly tennis players and bas ketball players use that tape.

"God knows why they did that? It caused irritation because my hairs were getting pulled as it had stuck on my head. They did not even put cotton on the wound and



directly applied the tape. I had to cut my hair from a certain spots to get rid of that. It took me almost 20 minutes to remove that," Bajrang told this agency.

"Instead of devising a strategy against the American, me and my team was jostling to get that tape removed from my head. All I had about 20-25 minutes before I clashed with the American and all of that time was lost," the 28-year-old rued.

Dr. Anand Dubey, who is attached with Bajrang as his personal physio, said ideally the doctors should have used a cohesive tape.

"The rigid tape can actually cause skull swelling because even a gentle touch would cause irritation and pull the hair. You know how wrestlers keep putting their hands on rival's head. So we decided to remove that and applied a cohesive tape," explained Dubey

"The cohesive tape is flexible. Once impact is made when it comes in contact with a body part during an attacking move, it would come back to original shape automatically, won't cause irritation or pull hair," he said.

The only Indian wrestler to have won four world medals, Bajrang said losing by technical superiority to Diakomihalis was not something he was expecting.

"I had lost to this guy 10-9 in 2019. I am not saying that I would have beaten him easily but I was at least expecting a close fight. First, the head injury and then this taping issue, really hurt my chances," he said.

Bajrang's team decided against getting stitches, preferring to keep the wound open. Explaining the reason, Bajrang's personal coach Sujeet Mann said, "Stitches can open in the middle of a bout if you receive a blow at the same spot. There's always that mental block that it may open again, so we did not want Bajrang to worry about that.
