50 killed as anti-hijab protest rages in Iran

TEHRAN: Protests flared in Iran for an eighth straight night over the death of a young woman arrested by the morality police, verified social media posts showed, hours after counter-demonstrations mobilised by authorities. At least 50 people have been killed by security forces in the anti-government protests, Iran Human Rights, an Oslo-based organisation, said - more than three times the official death count of 17, which includes five security personnel. The street violence, which IHR says has spread to 80 towns and cities, was triggered by the death of Mahsa Amini, a 22-year-old Kurd who had spent three days in a coma after being detained by the morality police in Tehran.


CJI: Lawyers must be rational in thinking

The raids, part of Operation 'Megha Chakra', were launched after the agency registered two cases under relevant provisions of the Information Technology Act based on inputs from the Crime Against Children (CAC) unit of Interpol, based in Singapore, which had received it from the New Zealand Police, the officials said.

The agency is questioning suspects about illicit material found on their electronic devices so as to identify the victims and the abusers.

Dehradun, Sept 24: Outrage over the killing of 19-year-old Ankita Bhandari, who worked as a receptionist at Vanantara resort in Pauri district's Yamkeshwar block owned by Haridwar BJP leader Vinod Arya's son Pulkit Arya, escalated as details emerged of her trauma in the days preceding her death.

The body of Ankita who worked in an Uttarakhand resort was recovered from a canal Saturday, police said as the ruling BJP swung into action to expel its leader whose son, the main accused, owned the property and the administration began demolishing the structure.

Violent protests erupted in areas surrounding the resort with locals breaking glass panes and some trying to torch a pickle factory in its premises. However, the fire did not spread much as the weather was

BJP's Yamkeshwar MLA Renu Bisht's car was also attacked near the Cheela canal close to Rishikesh from where the young woman's body was recovered, six days after her parents found her missing from her room. However, the crowds, seething with anger, succeeded only in breaking the rear windscreen of her car and Bisht was escorted to safety by police

As the ripples of anger spread, Chief Minister Pushkar Singh Dhami promised that no one would be spared and that a Special Investigation Team (SIT) headed by Deputy Inspector General P Renuka Devi had been constituted to probe

all aspects "It is a tragic incident. Such a heinous crime has been committed against our daughter. Action is being taken against those involved in it. The father and brother of the main accused Pulkit Arya have been expelled from the BJP," Dhami told reporters.

"Demolition of the resort owned by the main accused is underway Some of its rooms have also been sealed so that evidence is not destroyed. We have also issued an order to identify all resorts built illegally on government or forest land and demolish them." he added.

The administration had started demolishing the structure Friday night on grounds of illegalities.

Vinod Arya had formerly served as chairperson of Uttarakhand Mati Board with a state minister's rank. His other son Ankit, who was also in the BJP, has now been removed as vice president of Uttarakhand OBC Commission.

Ankita had called a friend the night before she was reported missing to say she was in trouble, according to local reports.

Bhubaneswar, Sept 24: A Biju Janata Dal (BJD) Zilla Parishad (ZP) member of Puri district was found hanging from the ceiling of Vihar area of Sishupalgarh locality here Saturday, police said.

The deceased was identified as Dharmendra Kumar Sahoo alias Tuku, 48, BJD ZP member of Nimapara Zone 11 in Puri district. He was a native of Khandiakuda village under Gop block.

Sahoo had mentioned in his Facebook post about videos on his two cellphones. He wrote that the videos should be made public.

Similarly, the CCTVs installed at his residence were found damaged while a video came to the fore showing Sahoo jumping off the boundary wall.

Meanwhile, reports said police have recovered the mobile phones of Sahoo near his residence with help of a sniffer dog.

The phones were found switched off since 2:43am Saturday. The cell-

XI JINPING RUMOURED TO BE UNDER HOUSE ARREST

New Delhi, Sept 24: Social media is abuzz with reports of Chinese President Xi Jinping being under house arrest.

The trending posts with hashtag 'Xi Jinping' started trending on Twitter after a few reports came from China stating that the Chinese president has been put under house arrest by the People's Liberation Army (PLA). Under the hashtag. many people shared funny memes and messages against President Jinping. The news came to the surface after Chinese human rights activist Jennifer Zeng share a video on Twitter. In the video, a few military vehicles can be seen running on a road. Zeng said the convoy was 80 km long and the rumour was that Xi Jinping had been put under house arrest.

Sharing the video Zeng wrote, "#PLA military vehicles heading to #Beijing on Sep 22. Starting



& ending in Zhangjiakou City, Hebei Province, the entire procession is as long as 80 KM. Meanwhile, rumour has it that #XiJinping was under arrest after #CCP seniors removed him as head of PLA."

According to the news reports, 60 per cent of flights in China were grounded Friday. However, any explanation in this regard was not issued by the Chinese government. On social media, it is said that the Chinese Army General Li Qiaoming has taken over as the new president.

Mahakalapara, Sept 24: Climate change, environmental pollution and rampant trafficking have posed serious threats to the chameleons residing in the saline mangroves and casuarina forests of Kendrapara district.

The chameleons, known for their unique ability to change the colour of their skin, are found in large numbers in Kajalpatia saline forests under Batighar panchayat of this block. These species are mostly known for their distinct range of colours as they are able to alter the hues and brightness of their skin when they sense trouble or spot

Their skin turns green when they rest on green leaves, brown on sand dumps camouflaging themselves perfectly as per their environment. It is quite interesting to see that they even imitate the colour of a tree's trunk while walking on them. This quality is genetic as well as due to the release of some chemical substances in the skin which they do to catch their prey and adapt to the changing environment.

They have another feature that no other animals can boast of. Their eves can move independently of each other, enabling them to look in two different directions at once.

These multi-coloured reptiles spread their population rapidly when they find their surroundings conducive for reproduction. They breed during the rains and winter and can be found in the saline mangroves and casuarina forests.

These reptiles measure more than a foot in length and catch



their prey by darting the tongue for over one foot. The insects and other small animals which it prevs cannot escape from its mouth due to presence of sticky substance on


its tongue.

However, their population has sharply declined in recent times due to climate change, discharge of toxic effluents and fumes from industrial plants. The reptiles were seen in large numbers before the 90s. However, their population witnessed a sharp decline after cyclonic storms like Super Cyclone in 1999, Phailin in 2013 and Hudhud in 2014 swept the district and the state. They also face threat from the poachers who catch them from the iungles and sell them to outside and international traders for a premium. The price of one of these reptiles is over Rs 1 lakh in the international market. This reptile has got value in international market for its leather and its use as a pet.

The reptile is included in schedule-2 and part-1 as a rare species in the Wildlife Conservation Act-1972. There is provision of punishment if anyone is caught catching or poaching these reptiles. Recently, Forest officials raided and arrested some youths when they were busy negotiating a deal to sell some chameleons. Environmentalists have demanded steps for the conservation and protection of this rare reptile.





I-T official caught taking ₹5L bribe

Khurda, Sept 24: Central Bureau of Investigation (CBI) sleuths caught an Income Tax (I-T) official taking ₹5 lakh bribe from a jeweller at Sriramnagar here, Saturday.

Sources said that Suman Sundar Sahoo, the I-T official, had been demanding ₹40 lakh as bribe from Debendra Kumar Sahu, the owner of Shanti Jewellers located at Marwadi Patti in Khurda, as the later had reportedly not paid the requisite tax.

Later, Sahoo took gold ornaments worth ₹15 lakh from the jeweller in order to settle the issue.

Even after taking gold ornaments, the I-T official continued to ask money from the jeweller. With no

Khurda Road-Bolangir railway project in limbo

Bhubaneswar, Sept 24: The Khurda Road-Bolangir new railway line project is being further delayed due to non-issuance of forest clearance by the Centre, an official said Saturday.

Out of the total length of 301 km of the Khurda Road-Bolangir new railway project, 91 km from Khurda Road to Nuagaon has been commissioned while work is in progress from Nuagaon to Daspalla (91 km to 106 km) and target is set to commission it by March 2023, sources said.

The work from Daspalla to Buguda (106 km to 121 km) is going slow due to non-issue of Stage-I forest clearance from the Ministry of Environment and Forests (MoEF), the source said.

Similarly, work from Buguda to Banigocghha is yet to start due to non-issue of the Stage-I forest clearance. In total, the Centre is yet to issue required forest clearance from 112 to 180 km while the work from 180 to 275 km is in progress and work at 275-301 km has already been commissioned.

For forest clearance, the state government has already sent its proposal to the MoEF regional office. Bhubaneswar. This issue was also raised during the recent meeting of the Regional Empowered Committee, the source informed.

The state government has given land free of cost from 112 km to 301 km and bearing 50 per cent construction cost for the Khurda Road-Bolangir railway project. However, due to non-issue of the Stage-I forest clearance by the Centre, the work cannot start in between 112 km to 118 km, an official said.

Earlier, Union Railways Minister Ashwini Vaishnaw had informed the Parliament that the completion time of the Khurda Road-Bolangir new line project cannot be ascertained at this time.

This project involves acquisition of 6162 acres land and diversion of 1844 acre forest land, out of which 5208 acres land has been acquired and diversion of 170 acres forest land has been completed. Further, acquisition of 954 acres land and diversion of 1674 acre forest land have been taken up, he had informed the Parliament

NOC issued for OWS officials to appear in recruitment tests

Bhubaneswar, Sept 24: The ST and SC Development department has issued a no objection certificate (NOC) for Odisha Welfare Service (OWS) and Odisha Subordinate Welfare Service (OSWS) officials wishing to appear in various recruitment examinations, an official said Saturday.

Many youths, who have joined the OWS and OSWS under the department, have also been preparing for recruitment examinations conducted by UPSC, OPSC, SSB, OSSC and OSSSC. And in order to appear for such examinations, the officials need NOC or permission from the department.

As the employees have a right to seek better career opportunities for themselves, the department grants permission or NOC in all cases in a very routine and me-



"In a bid to get the permission or NOC, the officials had to visit the department on many occasions, wasting their as well as the department's time. Delay in granting permission/NOC also at times leads to frustration among the applicant employees," a senior official in know of the development said.

In a bid to save time, the ST and SC Development department has recently issued an order giving standing permission and NOC in favour of all OSWS and OWS offi-

cers working under its administrative control to apply for any job elsewhere or to appear in any recruitment examination subject to a few conditions.

According to the department, the conditions include, the employee shall not neglect his/her official duties/responsibilities, the employee must take prior permission of the competent authority for leave and for leaving headquarters for appearing in any recruitment examination or job interview.

"The permission or NOC cannot not be treated as permission of the department to relieve an employee from its administrative control," said the official.

In case of selection for the job applied for, the employee must seek approval of the department through proper channels to be relieved from his/her current service, added

Despite efforts, national animal fights for survival

o you know India once had 1,00,000 tigers? Over the years, this number kept dwindling as Britishers and the erstwhile maharajas took up hunting. Meanwhile, no comprehensive law was in place to look after the wildlife till the 1960s even as widespread hunting of tigers was reported all over India, says wildlife expert Harshwardhan.

Queen Elizabeth II of Britain along with her consort, Prince Phillip, who visited Ranthambore in the early 60s reportedly to hunt tigers, was hosted royally by the then government, he said. Then came Project Tiger (PT) in

1973 where the WWF-International assumed a lead role and clueless forest officers adopted a fudging tactic to show increasing tiger numbers.

Even now, things have not changed and the tiger faces yet another challenge -- its forest cover is shrinking thereby increasing man-animal con-

Almost 10-15 tigers and tigresses are roaming outside almost all the best breeding reserves in India as dominant males do not allow newly-born, young and sub-adult males to remain inside

In its reply, the government said that due to the increase in their population and density around Ranthambore, more cases relating to missing tigers, territorial fights between tigers and deaths have surfaced.

The ratio between male and female tigers in RTR is 1:1.3, which is unnatural. Most of the tigers, out of the 32 females, at present in the breeding age have also contributed to an increased population, the data said.

"The tiger population has increased in Ranthambore and we have already passed the carrying capacity. There are around 55 mature tigers while as per our carrying capacity, we have space for around 40-45 mature tigers only. As a result of this overpopulation, tigers migrate or end up fighting with other tigers in territorial battles," said a senior forest official.

from their agitation and opposed establishment of a port till the last drop of blood is in their body.

They refused to believe the claim that no one will be displaced for the project and the lands under private ownership will not be acquired. They wanted the state government to publish notification in this regard through the district Collector.

However, Tata Group has started acquiring land for the roads and rail routes after the local youths announced their support for the project. The youths believe that the establishment of the port will usher in development and employment and no one will have to work as migrant labourer away from home.

It is being claimed that the port will be set up completely inside the sea but the locals refused to believe the claims. They questioned the district administration's silence on the issue.

Meanwhile, what has aggravated the situation is the foray of Adani group into Tajpur port project on Digha coast. The West Bengal government approved the Adani group's bid for establishment of Tajpur port, September 19. The Adani group will spend over ₹25,000 crore including ₹15,000 crore for the port and ₹10,000 crore on other industries in the project which will generate employment for over 25,000 peo-

Notably, Subarnarekha port project will not be possible if the Tajpur port project becomes functional as Subarnarekha sea mouth is just 38 km away from Tajpur. Speculations are rife that whether Subarnarekha port project will be commercially viable if Tajpur port is established before it. Moreover, the locals in West Bengal are not opposing Tajpur port project while their state government is providing all facilities to Adani Group for establishment of the port.

The Subarnarekha port is more conducive for commercial operations. However, the fate of the project hangs in the balance with the locals continuing to oppose it_ and state government failing to resolve the impasse.

Probe ordered into toll collection

PROBE EXPOSES SCAM IN MGNREGS

Bhapur, Sept 24: Many projects under MGNREGS have turned out to be gravy trains for unscrupulous officials and contractors in three panchayats under Bhapur block of Nayagarh district. Crores of rupees have been embezzled from projects through forged bills. In fact, some of those have not been executed at all.

Collector Poma Tudu had earlier received allegations about largescale irregularities in the rural job scheme in three panchayats. Locals had earlier protested against fund misappropriation in some MGNREGS projects.

Following a directive from the Collector, an investigation was conducted and the irregularities came to light. The investigation revealed that nine officials including the BDO were complicit in the fund embezzlement from the projects of the rural job scheme.

Women lead battle for forest rights in Nayagarh 24 villages in Nayagarh

Bhubaneswar, Sept 24: After a decade of struggle, the women of Nayagarh district lead the battle for forest rights from the front; having reclaimed what they think is theirs and winning the rights over forests resources in 24 villages. Narrating their hardships to protect the forests, the block-level women federation president in Ranpur Shashi Pradhan said that the women of Navagarh district see forest as a "source of their livelihood" and have been "protecting it since 1984".

"Women have been protecting and conserving these forests since 1984. People living in the villages had no idea about these rights. The women took charge and decided to hold awareness campaigns on Forest Rights Act," Shashi said.

Community and forest resource rights were granted to Kodalapalli and Sinduria village together as they led the



fight for the rights jointly.

Explaining why the forests are managed mostly by women in Nayagarh district, Shashi said that there was "mismanagement" when the forests were taken care of by the men.

"The women of these villages always fought back. They would visit those invaders' village, hold meeting with their block presidents and once even confiscated their vehicles when their forests were illegally invaded by them," Anita told PTI.

On November 2, 2021, 24 villages in Nayagarh district had received 14 community rights (CR) and community forest resource rights (CFRR) titles.

The titles were assigned to the villages under the the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights Act).

'We view these forests as our source of livelihood. There are various kinds of resources here. Be it herbs, shrubs, fruits or vegetables, we get everything from here," another forest-dweller of Ranpur said.

Cashew cultivation is one of the primary sources of income for the people living in Kodalpalli and Sinduria village, they said.

There is at least 20 acres of land for cashew cultivation in these two forest areas. The work is primarily managed by 15 families in Kodalpalli and 7 families in Sinduria village and they manage to earn around ₹2 lakh to ₹3 lakh per

annum," Shashi said. She further stated that all villagers possess medical insurance cards and that, each family earns around ₹50,000 a year only via forest-conservation and cashew cultivation.

Averse to NGOs

n Friday, India's Prime Minister used the words "urban naxals" to describe those he said were stalling construction of the Sardar Sarovar. This continues a common theme where he has attacked what is called civil society which he sees as an enemy. On 21 February 2016, he said at a rally in Bhubaneswar that he was "a victim of a conspiracy by NGOs." This conspiracy was aimed at "finishing" him and removing his government. As evidence for this he said: "You would have seen that morning to night, I am being attacked. Some people keep at it." Civil society was "also upset because I told a few NGOs to give us an account of the foreign funds that they spend here. They ganged up and said 'beat Modi, beat Modi, he's asking us for an account of our expenditure'," he said, adding: "They conspire from morning to night on 'how do we finish Modi, how do we remove his government, how do we embarrass Modi?" But my friends, you have voted me to rid the country of these diseases."

It appears that Modi has to a large extent succeeded in achieving this goal. In December 2019, Parliament was told that since Modi had taken office, 14,500 NGOs had been barred from accessing foreign funding. Funding has collapsed 90% from \$2.2 billion in 2018 to \$295 million in 2019. It is not known how many Indians were affected because of this, not only the employees of the NGOs but those people who they were working with and for:

Modi's attack on NGOs manifested in different forms of coercive action and through the use of criminal law. Most notably, through changes in the FCRA law. The Foreign Contribution (Regulation) Act appeared in 1976 as a piece of legislation aimed at preventing external interference in India's electoral process and democracy. It prohibited the receiving of foreign money to political parties and their candidates, journalists and newspaper publishers, judges, bureaucrats and members of Parliament.

In time, economic liberalisation meant that many of these categories were allowed to receive foreign money and the Indian government actively promoted the bringing in of such money. That was the foreign direct investment which was made welcome and whose numbers Indian governments were proud of. For instance, the media, both print and television and certainly online, which came to be the dominant form of media, could not only receive foreign in vestment, it was dominated by it. The larges media companies in India were Facebook and Google, which were entirely foreign owned and managed. Newspapers could receive equity investments from foreign firms as also could news channels. Even political parties managed to get themselves off the hook on FCRA. In January 2013, a public interest litigation was filed in Delhi High Court claiming that the Bharatiya Janata Party and the Congress had received donations from the same company,

which were in violation of the FCRA Act. On 28 March 2014, the court held that the BJP and Congress were guilty of FCRA violation and in May asked the Modi government and the Election Commission to act against the two parties. In July and August, the Congress and BJP moved petitions in the Supreme Court against the high court decision.

This change happened in the Budget of 2016, when the definition of foreign source was changed, legitimising the donation received by the political parties. Unfortunately this change was written in fairly slipshod fashion and the Modi government had amended the wrong version of the law. And so another amendment was passed in 2018 to again try and get the parties off. This finally happened in March 2018, through the amendment of a repealed law, a slightly farcical operation.

With this change, and later with the electoral bonds scheme, the BJP and other parties were free to accept unlimited and even anonymous contributions from foreign sources. What remained regulated in the law were nongovernment organisations, NGOs. And these were relentlessly squeezed and defunded through FCRA amendments under Modi.

Along with the farm bills on which protests are currently on, Modi also passed a law last year which would tighten the provisions under which NGOs could receive foreign money. The changes were in the main four: first that the 23,000 NGOs which had an FCRA licence to receive foreign money could receive funds only in the Sansad Marg branch of the State Bank of India in New Delhi. The second change was that the NGO could spend only 20% of the money it received on 'administrative expenses'. Salaries, travel expenses, rent and such things that constitute the bulk of what most NGOs spend their outlay on could only receive 20% of the total. Third, that the law now prevented an NGO from redistribution of funds it had received to other NGOs even if they were FCRA-compliant. This would hit the sector because NGOs do not compete with one another as the rest of the private sector does and operate as networks. This change would damage their alliances and capacitv to work with one another. Fourth, the law required NGOs registering or renewing their FCRA licence would have to mandatorily give the Aadhaar numbers of all office bearers, directors or other key functionaries. It also gave the government the authority at its discretion to suspend FCRA for as long as it wanted. This is, needless to say, not how the rest of the private sector is treated. The corporate sector is not ordered to spend their money in a particular way or regulated in this seemingly arbitrary fashion. The action is reserved for NGOs

The antagonism towards civil society was not new. As Chief Minister, Modi had said in a 2014 speech: "Another conspiracy — a vicious cycle is set up. Funds are obtained from abroad; an NGO is set up; a few articles are commissioned; a PR firm is recruited and, slowly, with the help of the media, an image is created. And then awards are procured from foreign countries to enhance this image. Such a vicious cycle, a network of finance-activity-award is set up and, once they have secured an award, no one in Hindustan dares raise a finger, no matter how many the failings of the awardee."

As Prime Minister he had the agency and the freedom to go alongside his desire to severely damage if not entirely finish off of India's civil society. And in substantial measure, through innovative ways, he has achieved this.



TAMING DISASTERS

aas, Tauktae, Amphan, Nisarga, Nivar are specific names that cause chill through the spine. Add floods, earthquakes, landslides and droughts to this list of cyclones that India has to withstand from time to time. While the respective governments have done creditably well to restrict damage, there may be scope for improvement, especially in the process integration area during and immediately after the disaster. The Yokohama message (1994) suggests the following – a) poor and socially disadvantaged people in developing countries are worst affected as they are the least equipped to cope with the situation; b) disaster prevention, mitigation and preparedness are better than disaster response; c) disaster response alone yields temporary relief at a very high cost; and d) prevention contributes to lasting improvement in safety. Can we create a flexible, adaptable, and intelligent disaster management framework to deal with disasters in a decentralised vet fast and highly co-

ordinated manner? There are five major types of natural disasters, namely, geological (landslides, earthquakes, subsidence), biological (epidemic diseases affecting people or livestock, veld fires), hydrometeorological (floods, cyclones, storms, drought), technological (industrial pollution, nuclear activities, toxic waste, dam failure, transport accidents) and environmental (deforestation. loss of biodiversity). And there are three significant phases of disaster management, namely "before," "during and immediately after," and "after."

Any country would focus on risk profiling and capacity building during the "before" phase. In risk/vulnerability profiling, one maps a region with likely hazards or disasters, their severity, probability of happening, and possible impact (in the areas like economic social, physical, and environmental). Floods are more lethal in the USA, whereas wind storms and epidemics are most destructive in Asia and Africa respectively. As a continent, Europe is doing better as far as the casualty in disasters is concerned. One needs to learn and update the profile continuously.

Once the risk profiling is done, the focus can be shifted to preparedness and capacity building. One needs to integrate mitigation with the development process for creating resilience. An earthquake measuring six on the Richter scale causes more havoc in India than in the USA or Japan. Resilience comes with infrastructure, partnership, public awareness, an early alert system, research, and training. Narrowing the sea beaches or build ing hotels on hills, we are not only disturbing the ecology but also limiting our resilience.

The focus shifts to response, rescue and relief in the "during and immediately after" phase of a disaster. We have made significant progress in averting past hindrances like the delayed response of government officers, absence of early warning systems, lack of resources to undertake measures like mass evacuation, non-familiarity with (and non-existent at times) standard operating procedures to be followed in providing relief. Thanks to mobile telephony, communication is no longer a first casualty postdisaster. However, coordination between various stakeholders is still an area of concern. No incident other than a disaster probably requires as many organisations to act together as army, government, NGOs, professional bodies, social organisations, international bodies, and media. Besides, so many subject matter experts (SMEs) from various fields work in unison like legal, medical, financial, economic, geological, social, engineering, communication, and counselling.

In the "after" phase, a country focuses on reconstruction and rehabilitation, which is the most important phase from the survivors' point of view. This phase also requires several organisations and SMEs to work together. However, the "uncertainty" factor is greatly reduced here; extent of damage is already assessed; imminent dangers can be factored in; learning from similar catastrophe in the past can be invoked. Financial viability and intent are the significant contributors here.

It is evident that while the "before" and "after" phases allow time and space for planning activities, the "during and immediately after" phase is attended to in a reactive post-hoc manner: Major challenges of this phase are posed by the "uncertainty" factor of the incident. Extent of damage is directly related to the nature of disaster, location and severity. For example, an earthquake will cause less havoc if its epicenter is inside a forest rather than in a populous city. The rescuers and the other participating bodies react as they encounter the "problems" much in a discovery mode; taking a holistic view of the entire damage and the ripple effects may become too theoretical or infeasible. This "during and immediately after" phase can run for hours (for an earthquake), days (in case of flood), weeks (in case of landslide) and months (say, COVIDlike pandemics); these varying timeframes add to the overall complexity for handling a disaster.

The whole problem can be simplified as having the high-level input (comprising type, severity, and location of the disaster), the output (which is immediate relief and stability), and the ultimate objective (of bringing back normalcy as quickly as possible, minimising the loss of lives and the economic loss) which remain the same for all disasters. However, each such scenario becomes one of its own with respect to the events (i.e. various disasters), agents (i.e. participating organisations), entities (e.g. life, infrastructure, potable water, shelter, food, health) and various activities to be carried out by the agents (e.g. impact analysis, planning and mobilisation, search and rescue, relief and aid). The present state of an entity will warrant action from the agent(s) and any action can potentially change the state of one or more entities. Needless to say that coordination and communication between the agents (i.e. organisations and SMEs) are of paramount importance here. The process modelers are thus needed to create this activity versus state transition mappings. The simulators can simulate the activities for an event based on past experiences in order to optimise the benefit from each action. The AI (artificial intelligence) and ML (machine learning) practitioners can contribute by making the model selflearning and self-enriching one.

To sum things up, a structured approach toward attending unstructured events like human- or God-inflicted disasters may be achieved through process abstractions keeping the specificity largely undercover. However, it is easier said than done. It is a call to the process modelers, simulators, and AI and ML practitioners to devise a framework that can dynamically decipher the best possible action under a given situation.

Preparing for next global catastrophe

fter two and a half years of lockdowns, quarantines, and mask mandates, billions of people around the world have returned to their normal lives. But in many ways, this newfound sense of post-pandemic normalcy is misleading. Beating COVID-19 will not mark the end of our current age of global instability, but rather the end of the beginning.

Of course, it is important to remember that the battle against COVID is still far from over. More people have been infected in 2022 than in the previous two years combined, and while vaccines have brought down death rates, more than a million people worldwide have died this year after contracting the virus. And as governments begin to roll out updated booster shots, the world must brace itself for a major fall surge and the possible emergence

of dangerous new variants.

But even if COVID were to disappear soon, our goal must not be to return to the status quo ante. In the pre-pandemic world, governments and communities were woefully ill-prepared – not just for a deadly pathogen, but also for an explosive confluence of political and economic crises. If we continue to

view the end of this pandemic as our only goal, the new normal will be just as fragile as the old one. Global leaders should recognise

that, far from being an outlier, the pandemic might be a harbinger. Even as COVID continues to spread, the likelihood of another pandemic increases by 2% each year. Moreover, the threat of new pandemics is just one of several looming catastrophes – including climate change, war, and food insecurity - that conspire to make social and economic stability a thing of the past. Simply put, the world is not prepared. The pandemic is a case in point. Instead of crafting an equitable global response in advance, leaders had to scramble to ensure that lower-income countries could get access to vaccines. Despite immense challenges, the COVAX has been remarkably successful. So far, COVAX has delivered more than 1.75 billion vaccine doses to 146 countries. Of these. 1.5 billion went to 92 low-income countries. By January 2022, COVAX helped lower-income countries to achieve an average vaccination rate of 20%, enough to protect the most at-risk groups

But the next time we face a global crisis, we must act faster and more

decisively. Crucially, any potential protection mechanism must be fully funded, or at least have pre-approved contingent funding in place, so that lower-income countries have access to lifesaving countermeasures immediately. But developing an adequate global response also requires a change in mindset. Even now, as G20 leaders map out how to prepare for future pandemics, there are no detailed proposals that address how the world's poorest economies will obtain vaccines.

Fortunately, COVAX itself provides a useful model for how to design future protection mechanisms. By treating the protection of the world's most vulnerable as its primary objective, COVAX has helped ensure that 63% of older people and 75% of health-care workers in lowerincome countries are fully vaccinated. But if COVAX had been created and fully funded before the pandemic, its impact could have been even greater. COVAX worked because it was built on global health networks that were already in place and had the resources, expertise, and infrastructure to mount a rapid global effort. But that effort stretched these agencies to the limit. If these organisations had built-in surge

capacity and contingency funding, the response could have been faster and more efficient.

The willingness to take risks is critical. With COVAX, officials secured billions of vaccine doses without knowing if those vaccines would work or how many doses would be needed. But the economic, social, and political repercussions of allowing millions of people to get sick or be displaced would have been far more costly.

Even though the COVAX model is not a one-size-fits-all solution for future calamities, it does offer useful lessons that could apply to crises beyond public health. For example, private-sector actors, led by Stripe, Alphabet, Shopify, Meta, and McKinsey, are exploring a Climate Advance Market Commitment that would promote and invest in climate solutions, based on COVAX's innovative financing mechanism. Whatever policies we put in place to prepare for future global crises, we must do so quickly. Whether we like it or not, the next disaster is only a matter of time. Preparing for it must be our new normal.

The rupee's slide

Sir, This refers to "Rupee at new low of 81," Orissa POST, September 24. The rupee is yet again facing renewed pressure as the dollar continues to strengthen in the wake of the US Federal Reserve's latest 75 bps interest rate hike to tame inflation. The rupee's slide was softened by the RBI's intervention to smoothen volatility; the cumulative impact of such interventions over the 12 months though has shrunk the RBI's war chest of foreign exchange reserves by almost \$94 billion to \$545.65 billion. Indian companies reliant on imports of raw materials or services for the smooth functioning of their businesses are hard hit. They are struggling to contend with rising costs at a time when domestic demand is still to regain a durable post-pandemic footing. The higher import bill is also bound to add inflationary pressures to an economy already beset by persistently elevated inflation and further complicates monetary policymakers' efforts to rein in the price gains. And the Fed's projection of further steep monetary tightening, of at least another 125 bps, is only likely to lead to more outflows. PFI violence: Kerala CM promises action

Thiruvananthapuram/Guwahati, Sept 24: Kerala Chief Minister Pinarayi Vijayan Saturday said the violence during the PFI-sponsored hartal in his state was "premeditated" and assured strict action against the culprits while his Assam counterpart Himanta Biswa Sarma batted for banning the Islamist outfit, whom the NIA accused of encouraging youth to join terrorist groups including the Lashkar-e-Taiba (LeT).

In Maharashtra's Pune, "Pakistan Zindabad" slogans during a PFI protest drew the ire of the BJP, with a party MLA warning those who raised such slogans would not be spared. Days after the National Investigation Agency-led a multiagency pan India raids against the Popular Front of India (PFI) for its alleged support to terror related activities, it said the documents seized during the nation-wide raids conducted at the outfit's offices and its leaders contain highly incriminating materials targeting prominent leaders of a particular community.

In a remand report submitted before the NIA special court here seek-



ing custody of 10 people in connection with a case registered here, the agency alleged the radical Islamist outfit encouraged youth to join terrorist groups including LeT and Islamic State of Iraq and Syria (ISIS).

It said the PFI spreads "dis-affection against India by wrongful interpretation of government policies to the particular section of people" to create hatred against the state and its machineries. "During the investigation, based on materials collected, it has been disclosed that the accused named in the FIR were actively involved in the organised crimes and unlawful activities repeatedly, to terrorise other religious sections of the society besides creating fear in the mind of general public based on the larger conspiracy hatched among themselves and others," the report said.

The Ministry of External Affairs (MEA) said instances of "fake job rackets" offering lucrative jobs in Thailand by dubious IT firms have come to the notice of Indian missions in Bangkok and Myanmar.

"Instances of fake job rackets offering lucrative jobs to entice Indian youths for the posts of 'digital sales and marketing executives' in Thailand by dubious IT firms involved in call centre scam and cryptocurrency fraud have come to our notice recently by our missions in Bangkok and Myanmar," the MEA said

"The target groups are IT skilled youth who are duped in the name of lucrative data entry jobs in



Thailand through social media advertisements as well as by Dubai and India-based agents," it said in an advisory.

The MEA said the victims are reportedly taken across the border illegally, mostly into Myanmar, and held captive to work under harsh conditions. It advised Indian nationals not to get "entrapped" in such fake job offers being floated through social media platforms or other sources.

"Before travelling on tourist/visit visa for employment purposes, Indian nationals are advised to check/verify credentials of foreign employers through concerned Missions abroad, and antecedents of recruiting agents as well as any company be-

fore taking up any job offer," it said. The Indian embassy in Myanmar recently rescued over 30 Indians out of 60 who were trapped in that country's Myawaddy area after falling prey to an international racket promising jobs in Thailand. Myawaddy area in southeastern Myanmar's Kayin state bordering Thailand is not fully under the control of the Myanmarese government and certain ethnic armed groups hold sway over it.

Lucknow, Sept 24: Increased mananimal conflict in and around the three main tiger reserves in Uttar Pradesh have emerged as a major cause for concern in recent years.

The Pilibhit Tiger Reserve (PTR), Dudhwa Tiger Reserve (DTR) and the upcoming Amangarh Tiger Reserve (ATR) have reported more than three dozen deaths due to attacks by the big cat family -- two dozen killed in Dudhwa alone since 2020.

Wildlife experts say that deforestation which is reducing the forest size, expansion of human settlements and agriculture and overgrazing by livestock have led to increased man-animal conflicts.

The sugarcane crops in these areas provide a safe haven for the big cats that hide among the crops

and attack any 'intruder'. "The problem is that people cut down trees for firewood and extend the boundaries of human settlements in and around the tiger reserves. As the forest area gets shrunk, the big cats venture out and this leads to man-animal conflict. People also send their cattle to graze in the forest which again, attracts the wild animals," said Brij

"There is no gap between human habitats and forest area in the plains. Often people fail to detect the presence of a wild animal till they come face to face in a potential man-animal conflict situation. Therefore, a safe zone is necessary. We plan to develop at least a 500metre safe zone to separate villages and forest," said a forest official in Bijnor where the ATR is located.

Pilibhit and Dudhwa are the two tiger reserves that are most susceptible to such conflicts.

The forest officials tell us not to move out alone but how do we earn a livelihood by staying at home? Whenever there is any incident, we are told to take care of ourselves and stay at home. The government should set up some fencing to ensure that wild animals do not venture out of the forest area," says Keshav Ram, a resident of Bhood Gautia village.



Two years ago, the World Wide Fund for Nature-India (WWF-India) had prepared a team of 'Bagh Mitra' to help tackle the increasing number of man-animal conflicts in the Terai region of Uttar Pradesh.

A total of 50 Bagh Mitras were se lected in Lakhimpur Kheri and 75 in Pilibhit district. They were trained in sensitizing residents, understanding tiger/leopard behaviour, pug marks identification and providing support in rescue operations.

Anil, a Bagh Mitra from Mohammadi in Lakhimpur said,

"We were trained in general tips and tools used in case a big cat strays close to a village. We have nearly 15 villages in the region. We can now identify carnivores through their pug marks and the steps to be taken

In a significant move, the Uttar Pradesh government has made the man-animal conflict a 'State Declared Disaster' bringing such incidents under the ambit of the State Disaster Response Fund (SDRF) to ensure better coordination and relief during such mishaps in the state.

This will enable faster monetary relief to the victims of attacks by wild animals.

As per the provisions of the order, in cases of human death due to man-animal conflict, relief of Rs 5 lakh would be given to the family of the deceased while the disbursement of compensation for injury would be in accordance with the SDRF guidelines.

Rather than recovering the money and punishing the guilty, the Delhi Jal Board (DJB) extended the contract of the embezzlers by a year and also raised the service fee paid to them, apart from relaxing terms of contract," a source from the L-G's office said.

The official alleged that in this case of corruption which amounted huge financial losses to the DJB, cash worth more than a whopping Rs 20 crore was collected as water bills from individuals, which went to a private bank account rather than the Board's bank account for several years.

'Pak zindabad' slogans Village opts for 'evening digital detox' during PFI protest in Pune

Pune, Sept 24: A video of protesters purportedly raising 'Pakistan zindabad' slogans during an agitation held here by the Popular Front of India (PFI) has surfaced on social media, prompting BJP leaders in Maharashtra to demand strong action against the slogan shouters.

The city police said they were looking into the matter.

The PFI had organised a protest outside the district collector office in Pune city Friday to denounce the recent nationwide raids on the organisation and the arrest of its activists. During the protest, the police detained around 40 protesters.

A video of "Pakistan zindabad" slogans being raised when the protesters were taken into custody and made to sit in a police vehicle went viral on social media.



When asked about the pro-Pakistan slogans by the protesters, the city police said they were investigating the matter.

"We have already registered a case against the PFI members for unlawful assembly and we are looking into the slogans matter," said Sagar Patil, Deputy Commissioner of Police. An offence against more than 60 protesters has been registered against more than 60 protesters at the Bundgarden police station for organising the agitation without permission, for unlawful assembly and for blocking the road, another official said.

Taking to Twitter, Bharatiya Janata Party (BJP) MLA Nitesh Rane said those who raised pro-Pakistan slogans should remember that they will not be spared. He also demanded a ban on the PFI.

"To all those shouting Pakistan Zindabad slogans in support of PFI in Pune.. Chun chun ke marenge.. Itna vaad rakana!!!

MLA Ram Satpute sought a strict action against those who raised slogans, and said the Pune police should arrest them.

In a massive crackdown on the PFI, multi-agency teams spearheaded by the National Investigation Agency (NIA) had, on Thursday, arrested 106 leaders and activists of the radical Islamic outfit in nearsimultaneous raids in 15 states for allegedly supporting terror activities in the country.

Maharashtra and Karnataka accounted for 20 arrests each, Tamil Nadu (10), Assam (9), Uttar Pradesh (8), Andhra Pradesh (5), Madhya Pradesh (4), Puducherry and Delhi (3 each) and Rajasthan (2).

Talking to PTI, sarpanch Mohite said the coronavirus-induced lockdown and the subsequent spell of online classes brought mobile phones into the hands of children for long hours even after school ended for the day, while television viewing hours of parents got ex-

"When physical classes resumed, teachers realised children had become lazy, did not want to read and write and were mostly engrossed in their mobile phones before and after the school hours. There weren't separate study rooms in the homes of the villagers. So I put forth the idea of a digital detox," he said.

"I had proposed a one-and-a-half hour period at first. Initially, there was hesitancy as people were wondering if it was possible to keep away from mobile and TV screens. On Independence Day, we convened a gram sabha of women and decided to purchase a siren. Then ASHA

Mumbai, Sept 24: Cheering vironmentalists, Maharashtra will get 18 new wildlife reserves and 7 proposed sanctuaries, taking the total of such protected areas in the state to 52, officials said here.

Chief Minister Eknath Shinde approved the proposals at a meeting of the State Wildlife Board in the presence of Forest Minister Sudhir Mungantiwar and others, which will now take the protected areas in the state to around 13,000 square km.

The 18 new reserves are: Velhe-Mulshi (87.41 square km) and Lonavala (121.41 square km) in Pune-Raigad districts, Naneghat (98.78 square km) in Pune-Thane districts, Bhorgirigad (37.64 square kms) in Pune district, Dindori



(62.10 square km), Surgana (86.28 square km), and Taharabad (122.45 sq.kms) - all in Nashik district.

Besides, there is Khareghat (97.45 square km), Chinchpada (93.91 square km) in Nandurbar district, Ghera Manikgad (53.25 square km), Alibaug (60.03 square km) in Raigad district, Gumtara (125.50 square km) in Thane district, Rajmachi (83.15 sq.kms) in Thane-Pune districts, Jawhar (118.28 square km), Dhamani (49.15 square km), Aherigarh (80.95 square km) in

Palghar district, Atpadi (9.48 square km) in Sangli district, and Ekara (102.99 square km) in Chandrapur district. The CM said that Conservation Reserve Areas (CRAs) are declared for the purpose of protecting the habitats of flora and fauna in the territory adjacent to national parks or sanctuaries or connectors to such reserved areas.

The proposed CRAs include Saptashringigad in Nashik district, Bhairavgad in Thane dis-

On the raids on PFI offices and officebearers in the state, he said both NIA and Karnataka police have taken suitable action regarding the Popular Front of India's activities in the state. Earlier, State Health Minister Dr K Sudhakar alleged that the Congress launched the 'PayCM' targeting Bommai because the party cannot tolerate a Chief Minster from





the Baha'i community, in 1918. Commemorating these events, September 23 is celebrated as Haifa Day. Many people in Bangalore may not know that there is a 'Mysore Lancers Haifa Memorial' in the city, which is located near RT

The memorial was a tribute to those brave soldiers from Mysore Lancers (a personal force of the then Maharaja of Mysuru, Nalwadi Krishnaraja Wadiyar) who showed exemplary bravery in freeing the city of Haifa from the Ottoman empire exactly 104 years ago.

Allied powers in World War-I. Mysore Lancers along with the Jodhpur Cavalry and British's 15th Imperial Cavalry Brigade soldiers charged on Turkish positions in and around the city of Haifa, which is now in Israel, a member of the Mysore royal family said.



"The Indian soldiers were armed only with lances and swords while the Turks were armed with artillery and machine guns," a member of the Urs family told PTI.

According to him, World War-I also paved the way for the British 15th Imperial Service Cavalry Brigade to defeat the Ottoman and German soldiers and to liberate a strategically





The designation gave several facilities and concessions to Afghanistan in terms of defence and security-related assistance and equipment.

Typhoon batters Japan; 2 killed

Tokyo: Two people were killed and tens of thousands of households left without power after typhoon Talas lashed Japan's Shizuoka prefecture with heavy rain Saturday. A man in his 40's died after his house was hit by a landslide in Kakegawa, while a 29-year-old man was found dead after his car plunged into a reservoir, Xinhua news agency quoted Kyodo News as saying in a report. The 15th typhoon of the season, which came just a week after a powerful typhoon battered the country's southwest, saw winds at its centre blowing at about 65 kph, with peak gusts of about 90 kph.

89 dead as boat capsizes in Syria

Damascus: At least 89 people died from a boat that sank off the Syrian coast, the Syrian Health Ministry said. Twenty others have been rescued and sent for medical treatment at the al-Basel hospital in the Syrian coastal city of Tartous after the boat sank in the Syrian waters, Health Minister Hassan al-Ghabbash said in a statement Friday. The boat set off from Lebanon Tuesday carrying illegal migrants of various nationalities to "unknown destinations," Syrian General Director of Sea Ports Samer Kobrosly said, citing testimonies from the survivors

At least 50 people have been killed by security forces in the antigovernment protests, Iran Human Rights, an Oslo-based organisation, said -- more than three times the official death count of 17, which includes five security personnel.

Iranian police in just one province have arrested over 700 people during more than a week of protests following the death of a young woman in custody, Tasnim news agency reported Saturday.

General Azizollah Maleki, police chief of Guilan province, announced "the arrest of 739 rioters including 60 women", the Iranian

Iranian law requires all women to wear a head covering and loosefitting clothing while in public places. The rule has been enforced since the 1979 Islamic Revolution, and it is obligatory for every woman in the country.

Russia holds votes in occupied Ukraine

Ukraine, Western leaders and the United Nations condemned the votes as an illegitimate precursor to illegal annexation

Kyiv, Sept 24: Russia launched referendums Friday aimed at annexing four occupied regions of Ukraine, drawing condemnation from Kyiv and Western nations who dismissed the votes as a sham and pledged not to recognise their results.

Ukrainian officials said people were banned from leaving some occupied areas until the four-day vote was over, armed groups were going into homes, and employees were threatened with the sack if they did not participate.

Ukrainian President Volodymyr Zelenskyy said in a nightly address that the votes would be "unequivocally condemned" by the world, along with the mobilisation Russia began this week, including in Crimea and other areas of Ukraine occupied by Russia.

The votes on becoming part of Russia were hastily-organised after Ukraine recaptured large swathes of the northeast in a counter-offensive earlier this month.

With Russian President Vladimir Putin also announcing a military draft this week to enlist 300,000 troops to fight in Ukraine, the Kremlin appears to be trying to regain the upper hand in the grinding conflict since its February 24 invasion



ple in parts of Ukraine occupied by Russia, and said they should resist efforts to mobilise them to fight.

"Hide from Russian mobilisation in any way you can. Avoid draft orders. Try to move to the territory of free Ukraine," he said, urging those who did end up in the Russian armed forces to "sabotage," "interfere" and pass on intelligence to Ukraine.

By incorporating the four areas, Moscow could portray attacks to retake them as an attack on Russia itself - potentially using that to justify even a nuclear response.

NATO Secretary-General Jens Stoltenberg said the military alliance would step up support for Ukraine in response to the referendums. "We will never recognise these referenda which appear to be a step toward Russian annexation and we will never recognise purported annexation if it occurs," added the Group of Seven leading industrial democracies.

Interference won't be tolerated: China on Taiwan

United Nations, Sept 24: China underscored its commitment Saturday to its claim to Taiwan, telling world leaders that anyone who gets in the way of its determination to reunify with the selfgoverning island would be "crushed by the wheels of history.

The language was forceful but, for Chinese leadership, well within the realm of normal

"Only when China is fully reunified can there be true peace across the Taiwan Strait," Wang Yi, China's foreign minister, said at the UN General Assembly. He said Beijing would "take the most forceful steps to oppose external interference.'

China vehemently defends its claim on Taiwan, which separated from the mainland after a 1949 civil war and now functions with its own government. A recent visit by the speaker of the US House of Representatives, Nancy Pelosi, markedly ratcheted up tensions between Washington and Beijing.

The language, while pointed, reflected China's usual vehemence about the island; it's claim rarely goes unmentioned in major international speeches. Taiwan is a core issue of China policy, and Wang's appearance — instead of his boss. Chinese leader Xi Jinping — was a signal that the speech was not

Tokyo, Sept 24: A lavish, taxpayer-funded funeral for Japanese former Prime Minister Shinzo Abe has triggered a public backlash against the ruling party he led for years

Some opposition lawmakers are boycotting Tuesday's state funeral and a man set himself alight in an apparent protest against the \$12 million event, to be attended by foreign dignitaries including US Vice President Kamala Harris and Indian Prime Minister Narendra Modi.Here is what you need to know about why the funeral for Abe – Japan's divisive but longest-serving premier - has become a lightning rod for public anger.

WHY ARE PEOPLE OPPOSED?

Opposition has largely been fuelled by revelations of links Abe and his Liberal Democratic Party (LDP) had to the Unification Church, which became widely known after he was gunned down on the campaign trail in July.

The suspect in the shooting accused Abe of promoting the group, which critics call a cult due to its mass weddings and aggressive fund-raising tactics. The suspect said the church had impoverished his family, according to police. Since then an investigation by

the LDP has concluded that 179 of its 379 lawmakers had interacted with the church. The rising cost of the funeral, which the government estimates at 1.65 billion yen (\$11.5 million), has added fuel to the fire at a time of economic hardship for many. Japan's last fully state-funded

GOVERNMENT SAID? Kishida has apologised and pledged to win back public trust by asking LDP lawmakers to sever ties with the Unification Church. He has acknowledged the funeral lacks overwhelming public support but has repeatedly sought to justify his decision.

He has praised Abe's domestic and diplomatic contributions as well as his legacy of his lengthy tenure as reasons why a state funeral is warranted.

During his two stints in office, from 2006 to 2007 and 2012 to 2020, Abe's nationalist rhetoric and muscular defence policy riled many Japanese wary of any change to thecountry's pacifist constitution drawn up after World War Two.

MP records death of 27 big cats in 2022, highest in country

adhya Pradesh, which is known as the 'tiger state' Lof India, has also earned the dubious distinction of accounting for the highest number of deaths of these majestic striped

Till July 15 this year, of the total number of 74 tiger deaths registered in the country, Madhya Pradesh alone accounted for 27 of them highest for any state during this period, the data published by the National Tiger Conservation Authority (NTCA) on its website has

The centrally located state is followed on this front by Maharashtra, which registered 15 deaths during the period. Karnataka comes next with 11 fatalities, Assam five, Kerala and Rajasthan four each, Uttar Pradesh three, Andhra Pradesh two, Bihar, Odisha and Chhattisgarh one each, among other states, as per the NTCA figures.

According to officials, territorial fights, old age, ailments, poaching and electrocution are some of the prominent reasons for their deaths. Madhya Pradesh had regained the coveted tag of being the 'tiger state' of the country in the 2018 census.

As per the All-India Tiger Estimation Report 2018, the state was home to 526 tigers, the highest for any state in the country. There are six tiger reserves in the state, namely Kanha, Bandhavgarh, Pench, Satpura, Panna and Sanjay Dubri.

Of the 27 tiger deaths this year, nine were males and eight females. In other cases, the gender of the animals was not mentioned in the data. The deceased included adults, sub-adults and cubs.

Tigers live, breed and hunt in forests and they are at the top of the food chain. As apex predators, their presence indicates a healthy and broader ecosystem. Expressing concern over the rising number of tiger deaths

wildlife enthusiast and Right to Information (RTI) activist Ajay Dube said, in Panna, no tigers were found about 10 years

back. After that, the NTCA advised the states to set up their own Special Tiger Protection Forces (STPFs) for safeguarding the big cats, especially from poachers

The Centre has made budgetary provisions for supporting the STPFs, but the MP government has so far not constituted any such force due to its own vested interests, he alleged. If established, this force will check, besides poaching, other activities like illegal mining and felling of trees in the forest areas,

The nation's first dog squad for wildlife crimes was set up in Assam under the initiative of biodiversity organization 'Aaranyak' in 2011 with one male Belgian Malinois named Zorba.

The dog squad known as the 'K9 unit' has over the years evolved into a "very efficient and well-trained one" in tracking down wildlife crimes, said Bibhab Talukdar, the secretary general of the body which has undertaken the effort.

The squad, set up in 2011 by the biodiversity organisation 'Aranyak" with just one Belgian Malinois, now has seven

trained dog squad in Assam, billed as the first with more than one handler for each of them. Two other dogs are undergoing training here, Talukdar said.

> Zorba, the first canine of the squad, is credited with helping to nab 60 poachers, 50 of them in Kaziranga National Park, which is known globally for its onehorned rhinos. The dog had served mostly in KNP from 2012 till his retirement from service in 2019. On Independence Day that year he was honoured with a traditional 'gamosa' and a citation. He was also deployed on various occasions in other national parks. One incident of his expertise in tracking poachers stands out in Orang National Park in the state

BYJU's clears dues to acquire Aakash

New Delhi: Edtech major BYJU's has finally paid the remaining dues of nearly ₹1,983 crore (over \$245 million) to global VC firm Blackstone in the \$1 billion acquisition of Aakash Educational Services. People close to the development told IANS that BYJU's paid the remaining dues to Blackstone within the extended deadline that ended September 23. According to BYJU's financial report FY21, "as per the terms of the agreement for acquisition of Aakash Educational Services, consideration to the extent of ₹1,983 crore was due to be paid by the company to the sellers in June, 2022. This has been deferred to September 23, 2022". Blackstone has nearly 38 per cent stake in Aakash and BYJU's has paid nearly 75 per cent of the Aakash acquisition amount.

BPCL signs pact with Petrobras

New Delhi: State-owned **Rharat Petroleum Cornoration** Ltd (BPCL) Saturday said it has signed an agreement with Brazilian national oil company Petrobras for sourcing crude oil from the Latin American nation as part of plans to diversify its sourcing needs. BPCL imports a large volume of crude oil which is turned into fuel such as petrol and diesel at its three oil refineries at Mumbai. Bina in Madhya Pradesh and Kochi in Kerala. New Delhi, Sept 24: Annual Foreign Direct Investment (FDI) nearly doubled to \$83 billion as 'Make in India', the flagship scheme of the government to facilitate investment and foster innovation. completed eight years.

As per the Ministry of Commerce and Industry, FDI inflows stood at \$45.15 billion in 2014-2015. The year 2021-22 recorded the highest ever FDI at \$83.6 billion.

FDI equity inflows in India dipped by 6 per cent to \$16.6 billion during April-June period of the current fiscal.

According to the ministry, to attract foreign investments, the government has put in place a liberal and transparent policy wherein most sectors are open to FDI under the automatic route.

'The year 2021-22 recorded the highest ever FDI at \$83.6 billion. This FDI has come from 101 countries, which has been invested across 31 states and UTs and 57 sectors in the country. On the back of economic reforms and 'Ease of Doing

Business' in recent years. India is on track to attract \$100 billion FDI in the current financial year," the ministry said Saturday.

It said the Production Linked Incentive (PLI) scheme across 14 key manufacturing sectors was launched in 2020-21 as a big boost to the Make in India initiative.

The PLI scheme incentivises domestic production in strategic growth sectors where India has comparative advantage. This includes strengthening domestic manufacturing, forming resilient supply chains, making Indian industries more competitive and boosting the export potential. The

PLI scheme is expected to generate significant gains for production and employment, with benefits extending to the MSME eco-system.

Recognising the importance of semiconductors in the world economy, the government has launched a \$10 billion incentive scheme to build a semiconductor, display and design ecosystem in India.

Complemented by sincere efforts of domestic toy manufacturers, the growth of the Indian toy industry has been remarkable in less than two years despite the Covid-19 pandemic.

The import of toys in FY21-22 reduced by 70 per cent to ₹877.8 crore. There has also been a distinct improvement in the quality of toys in the domestic market.

Simultaneously, the efforts of the industry have led to an export of toys worth ₹2,601.5 crore in FY21-22, which is an increase of more than 61 per cent over ₹1,612 crore in FY18-19.

India's toy export registered tremendous growth of 636 per cent in April-August 2022 over the same period in 2013, said the ministry.

Fisker to sell electric **SUV** in India with view to local production

New Delhi, Sept 24: US startup Fisker Inc will begin selling its Ocean electric sport-utility vehicle (SUV) in India next July and could begin manufacturing its cars locally within a few years. the company's chief executive officer told Reuters.

Sales of electric cars in India will gather pace by 2025-26, Henrik Fisker said in an interview in New Delhi, adding that the company wants to secure a first-mover advantage.

"Ultimately, India will go full electric. It may not go as fast as the US. China or Europe, but we want to be one of the first ones to come in here," Fisker said.

Electric cars currently make up just 1% of India's roughly 3 million annual car sales, with insufficient charging infrastructure and high battery costs partly to blame for the slow shift.

Fisker rival Tesla Inc put its India entry plans on hold after failing to secure a lower import tariff for its cars. Like Fisker, it first wanted to import vehicles to test the market before committing to local manufacturing.

While Fisker admitted it is 'very expensive" to import vehicles into India, the company wants to use the Ocean to build its brand, with its premium pricing likely to limit numbers, he said.

The Ocean retails at around \$37,500 in the United States but importing it to India would add logistics costs and a 100% import tax. That would put it out of reach of most buyers in a market where the bulk of cars sold are priced under \$15,000.

'Ultimately, if you want to have somewhat of a larger volume in India, you almost have to start building a vehicle here or at least do some assembly," Fisker said.

Pune, Sept 24: Finance Minister Nirmala Sitharaman Saturday said the rupee has "held back very well" when compared to other currencies against the US Dollar.

The Reserve Bank and the Finance Ministry are keeping a very close watch over the devel opments, the finance minister told reporters after the domestic currency sunk to a lifetime low against the greenback.

'If any one currency which has held its own and did not get into fluctuation or volatility as much as other currencies it is the Indian rupee. We have held back very well," she told reporters here on the final day of her three-day visit to Pune district which is a stronghold of NCP chief Sharad Pawar.

She also asked a reporter to do a study on how the other currencies are behaving against the US dollar in the latest round of depreciation.

According to experts, the latest round of depreciation is triggered by adverse global developments starting with the geopolitical tensions triggered by the Russian invasion of Ukraine earlier this year.

New Delhi, Sept 24: India was the fastest growing Internet of Things (IoT) module market with more than 264 per cent growth in the second quarter this year, a report showed.

Although growing on a lower base, the growth in IoT modules in India was driven by smart meters, telematics, point of sale (POS) and automotive applications, according to Counterpoint Research.

Global cellular IoT module shipments grew 20 per cent (year-overyear) in Q2 2022.

"The IoT module market is going through a critical phase where the Chinese brands have become bigger, making it very difficult for international brands to grow in silos," said senior research analyst Soumen Mandal.

The global cellular IoT module market continued to recover despite a tighter supply chain, Covid-19 lockdowns in China and macroeconomic headwinds.

The growth was driven by the ongoing digital transformation involving potential applications around critical infrastructure and logistics catered by some key fastgrowing low-tier cellular technologies such as Cat-1 and NB-IoT.

FAIRY-TALE FAREWELL FOR INDIAN WOMEN'S CRICKET GREAT AS INDIA WHITEWASH ENGLAND IN JHULAN GOSWAMI'S LAST WALTZ

London, Sept 24: A fairy-tale ending befitting her glorious career marked Jhulan Goswami's last waltz as India Women beat England by 16 runs in the third and final ODI to record their first clean sweep in this country. That the feat was achieved at the Mecca of Cricket -Lord's - made it doubly satisfying.

Sent into bat, India were all out for a paltry 169, and at that point it looked like the tourists may have fallen many runs short of making the match a memorable one for their legendary seamer, who is calling it quits after two decades of incredible service to the game.

However, the Indians managed to eke out a win as Charlotte Dean (47) was adjudged run out in controversial fashion, for backing up.

Dean, who nearly pulled off a stunning win for the hosts after they were reeling at 65/7 and then 103/8, was out of her ground and Deepti Sharma simply held the ball to remove the bails, leaving the English flabbergasted.

On expected lines, the day revolved around the 39-year-old warhorse Jhulan, who is leaving the scene as women's cricket's highest wicket-taker, having started her journey way back in 2002.

Harmanpreet Kaur, who let Jhulan call the toss in a touching gesture, was unable to hold back her tears, even as the Cricket Association of Bengal (CAB) planned to name a stand at the Eden gardens after the 'Chakdaha Express'. She fin-

She was lucky to have got her first wicket of the day with a short one, her second scalp came when the pacer bowled Kate Cross with her ball number 10,001 in ODIs, again something which no other player has achieved

England captain Amy Jones's decision to field first seemed to have paid dividends as India kept losing wickets at regular intervals to be bundled out in 45.4 overs. India were in deep trouble at 29/4 pretty early into their innings, but then came the revival.

All-rounder Deepti Sharma topscored for the visitors with an unbeaten 68 off 106 balls, while opener Smriti Mandhana was the second highest scorer, making exactly 50 runs in 79 deliveries.

Barring these two, and Pooja Vastrakar (22), to some extent, none of the Indian batters could make any substantial contribution in the final game of the series, which the tourists had pocketed with wins in the first two matches.

Roger Federer bids adieu with a defeat in his last professional match – a doubles at the Laver Cup alongside Rafael Nadal

London, Sept 24: Roger Federer's trophy-laden career ended with defeat Friday, but for once the result hardly mattered as the Swiss maestro bid adieu with tears in his eyes and cheers ringing in his ears.

The 20-time Grand Slam champion returned after more than a year away to play tennis. He played alongside Rafael Nadal, the Spaniard with whom he shared one of tennis's most captivating rivalries.

Federer could have sealed victory in the Laver Cup doubles clash when he served at match point in a tense deciding tie-break. But it was not to be as Americans Jack Sock and Frances Tiafoe ripped up the script, winning 4-6, 7-6, 11-9 for Team World.

After a brief moment of stunned silence around the packed arena, the crowd rose to salute the 41-year-old Federer, whose elegance, charisma and sportsmanship have graced tennis and
