

Lt General Chauhan is India's new CDS

NEW DELHI: Nine months after the death of General Bipin Rawat in a helicopter crash, the government Wednesday named Lt General Anil Chauhan (Retired) as the new Chief of Defence Staff (CDS), India's top military officer. Lt General Chauhan had retired as Eastern Command Chief in May 2021. He has held several appointments and has extensive experience in counterinsurgency operations in Jammu and Kashmir and the North-East. General Rawat, who had been India's first CDS, and his wife were killed in December after a military chopper crashed in Tamil Nadu, killing 13 on board. He had taken charge as CDS in January 2020.

Jayanti Patnaik passes away at 90

BHUBANESWAR: Former Odisha CM JB Patnaik's wife and veteran Congress leader Jayanti Patnaik breathed her last Wednesday evening. She was 90. The four-time Lok Sabha MP had been suffering from agerelated complications. She was rushed to a private hospital here after her condition deteriorated where she breathed her last while undergoing treatment. The first chairperson of the National Commission for Women, Jayanti was elected to the Lok Sabha from Cuttack constituency in 1981 and 1984 while in 1998 she was elected from the Berhampur constituency.

Govt bans PFI, associates

The Centre has accused the group of spreading terror in India and also said it has links with several banned organisations like SIMI and IS

New Delhi, Sept 28: The government Wednesday banned the Popular Front of India (PFI) and several of its associates for five years under a stringent anti-terror law. It accused these bodies of having 'links' with global terror groups like IS.

Besides PFI, the organisations that were also banned under the

Thiruvananthapuram: The Indian Union Muslim League (IUML) welcomed Wednesday the Centre's decision to ban the Popular Front of India (PFI) for its alleged terror activities, but said that the RSS should also be similarly outlawed Senior IUML leader MK Muneer said the radical outfit had misinterpreted the Quran. Meanwhile RJD president Lalu Prasad called Wednesday the Rashtriya Swayamsevak Sangh a 'Hindu extremist organisation' that deserved to be banned. "It is the RSS, which is all about Hindu extremism (kattarpanth), which deserves to be banned first," Lalu said in Delhi." The CPI(M) said it opposes the extremist views of PFI, but does not support the way the government is tackling it by banning the outfit. It also pointed out that experience has shown that bans on organisations like the RSS and the Maoists were not effective.

Can deadline for **HSRP be extended:** Orissa HC asks govt

Cuttack, Sept 28: The Orissa High Court asked Tuesday the Transport Department of the state government as to whether the deadline for affixation of High Security Registration Plate (HSRP) on vehicles can be extended. The court asked the department to reply as soon as possible as the next hearing of the case will take place September 30, the last date for affixation of the HSRP.

The high court made the observation while hearing a petition filed by two bus owners. In their plea they said that the state government has set the HSRP deadline without the availability of proper facilities

It should be stated here that the Odisha government has made affixation of HSRP on vehicles mandatory in Odisha, October 1 onwards. Strict fines will be enforced on offenders, officials had said earlier. However, they had also stated that those who have applied for the number plate online before the last date will not be fined. They will have to carry the online booking slip.



Unlawful Activities (Prevention) Act (UAPA) are 'Rehab India Foundation', 'Campus Front of India', 'All India Imams Council', 'National Confederation of Human Rights Organisation', 'National Women's Front', 'Junior Front', 'Empower India Foundation' and Rehab Foundation (Kerala).

So far more than 150 people allegedly linked with PFI have been detained or arrested in raids across seven states that started Tuesday and continued Wednesday. This move came five days after a similar pan-India crackdown against the 16year-old group. Then more than 100 people had been arrested and several dozen properties were seized.

In a notification late Tuesday night, the Home Ministry said some PFI founding members are leaders of the Students Islamic Movement of India (SIMI) and the group has links with Jamat-ul-Mujahideen (JMB) in Bangladesh. Both JMB and SIMI are banned

in India.

PFI and its associates or affiliates or fronts have been working covertly to increase the radicalisation of one community by promoting a sense of insecurity in the country, which is substantiated by the fact that some PFI cadres have joined international terrorist organisations like the Islamic State (IS), the Home Ministry notification claimed. It added that Uttar Pradesh. Karnataka and Gujarat governments had also recommended a ban on PFI.

The opposition Congress in Kerala and its coalition partner Indian Union Muslim League (TUML) also welcomed the Centre's move, but said the RSS should also

be similarly outlawed (See Box). PFI sources however, said that the party will seek legal recourse as it feels that the ban is 'unconstitutional and illegal'.

The Home Ministry also claimed investigations have established clear links between PFI and its associates or affiliates or fronts. It said 'Rehab India Foundation' collects funds through PFI members. Some PFI representatives are also members of 'Campus Front of India' 'Empower India Foundation', and 'Rehab Foundation, Kerala'.

Investigations in various cases have revealed that PFI and its cadre have been repeatedly engaging in violent and subversive acts. the

ministry claimed. Criminal violent acts carried out by PFI include chopping off the limbs of a college professor, killings of persons associated with organisations espousing other faiths, obtaining explosives to target prominent people and places and destruction of public property, it added. **P9**

Seat belts mandatory for all car occupants

RULE VIOLATORS WILL BE PENALISED ₹1.000. SAY SOURCES

Bhubaneswar; Sept 28: The Odisha government is contemplating to make seat belts mandatory for all passengers in a car very soon. sources said Wednesday, Violators will have to shell out ₹1,000 if found breaking the rule, they added.

In the wake of the fatal accident of former Tata Sons chairman Cvrus Mistry near Mumbai, the Ministry of Road Transport & Highways (MoRT&H) has asked all states including Odisha to strictly implement seat belt norms for M1 category motor vehicles (comprising not more than eight seats in addition to the driver seat).

Following this letter from the

Centre, the Transport department has asked the commissioner to issue necessary instructions regarding use of seat belts as per provisions under Central Motor Vehicles Rules (CMVR), 1989 and

bring it to the notice of the public. Section 194B of the MVA 1988 mandates the use of safety belts, and sub-section 1 of Section -194 B, says that 'whoever drives a motor vehicle without wearing a seat belt or carries passengers not wearing a safety belt shall be punishable with a fine of ₹1000'. Also rule -12(1) of CMVR, 1989 specifies that all vehicles other than two and three-wheelers shall be equipped with a seat belt

for the driver and person occupying the front seat. Continued on P4

Malala turns producer to empower women

Los Angeles, Sept 28: Nobel Laureate Malala Yousafzai has inked a programming agreement with Apple TV+. She unveiled Tuesday here, the first line-up of films and TV projects with the streamer, backed by her banner 'Extracurricular'. Malala said that the team at 'Extracurricular' aims to bring to the table 'the voices of women of colour, and debut writers'.

Entertainment website 'Variety' said in its report that the deal involves dramas, comedies, documentaries, animation and children's series and will see the Pakistani activist team up with Oscar winner Adam McKay's production house on a feature film.

The film, titled Disorientation, with McKay's 'Hyperobject Industries' is an adaptation of Elaine Hsieh Chou's acclaimed book of the same name. Billed as a 'sharp-edged, celebrated satire', the story revolves around a college student's revealing dissertation on a young poet. The makers are yet to rope in a director for the project.

We aim to give them a platform so that they can pursue their passion," Malala was quoted as saying by 'Variety'. 



Sahoo death: Oppn seeks Dash's scalp Special devpt councils reconstituted in 9 dists

Bhubaneswar, Sept 28: The state government has reconstituted the special development councils (SDCs) in nine districts having a 50 per cent tribal population.

The decision was taken a day after Chief Minister Naveen Patnaik released the 'Encyclopaedia of Tribes' in Odisha, covering the traditions and cultures of all the 62 tribal communities living in the state. A notification issued by the state government said that the SDCs were reconstituted in Mayurbhanj, Malkangiri, Keonjhar, Koraput, Nabarangpur, Rayagada, Gajapati, Kandhamal and Sundargarh. Opposition parties claimed that with such initiatives, the BJD government was trying to woo tribals ahead of the next Assembly elections due in 2024. "The state government takes such initiatives to help BJD leaders and appease people," alleged BJP state vice-president Bhrugu Buxipatra. In a letter to Union Tribal Affairs Minister Ariun Munda, Patnaik had demanded the inclusion of 160 communities of Odisha in the Scheduled Tribes list of the state.



Bhubaneswar, Sept 28: Opposition BJP and Congress Wednesday staged protests demanding removal of School and Mass Education Minister Samir Ranjan Dash from Cabinet for his alleged involvement in the death of BJD Zilla Parishad (ZP) member Dharmendra Sahoo.

Sahoo, a ZP member from Puri district, had allegedly committed suicide at his residence here September 24. The 48-year-old politician represented the ZP zone no 11 under Gop, which comes under the Assembly constituency of the minister.

While the BJP protested at Jayashri square by burning tyres and blocking the Puri-Bhubaneswar National Highway, the student unit of the Congress gathered at the official residence of Dash in Bhubaneswar. The BJP workers and leaders including Puri district pres ident Ashrit Pattanayak, Bramhagiri MLA Lalitendu Bidyadhar Mohapatra and party's state vicepresident Pravati Parida participated in the road blockade. They demanded immediate removal of Dash from the Cabinet for his alleged in-

order for the arrest of Dash, demanded BJP MLA Mohapatra.

Similarly, demanding the resignation of the minister, hundreds of activists of the student wing of the Odisha Pradesh Congress Committee Wednesday gathered at the official residence of Dash.

Carrying posters and shouting slogans, the Chattra Congress workers had a scuffle with the police while trying to barge into the minister's residence. The Congress activists hurled eggs and tomatoes at the minister's house.

President of the state unit Chhatra Congress Yasir Nawaz alleged that the Chief Minister himself is protecting Dash, who is involved in the death of the BJD leader.

Right to information not always equal

any South Asian countries have made progress in adopting Right to Information (RTI) laws, but ensuring everyone the benefits of the law is proving more of a challenge.


Pakistan, followed by India, Nepal and Bangladesh have all enacted RTI law in the past two decades after years of advocacy efforts by civil society groups. And while it's a key tool for holding governments accountable, its use by poor communities remains restricted.

India's RTI legislation, considered to be one of the most robust laws in South Asia, remains untapped by poor and marginalised communities as they often have limited access or are unaware of their rights. It could learn from Bangladesh.

Rural women, who stand to benefit from RTI law, are among the least likely to use it.

Social barriers in the form of traditional social norms restrict the ability of many women to travel to government offices in unfamiliar towns. They worry about how government bureaucrats will treat them. Moreover, there are built-in structural barriers in the architecture of the information disclosure system, which accepts only written applications in order to provide information. This is difficult to achieve in rural areas where female literacy is low.

In states where RTI adoption is high, requesting information prompts government officials to act "almost like

magic". Once an application is submitted, the government is required to provide results immediately But in less progressive states like Uttar Pradesh and Bihar, where incomes and literacy rates are lower and awareness about RTI is limited, government officials openly undermine transparency norms, refuse to provide the requested information, and reject RTI appeals on spurious grounds.

These practices mock transparency laws, as the poor have a hard time dealing with obdurate bureaucracy. The awareness and use of RTI law among the rural poor and women in Uttar Pradesh is also quite low.

STATES REFUSE TO PROVIDE THE REQUESTED INFORMATION, AND REJECT RTI APPEALS ON SPURIOUS GROUNDS

Research has found that rural men only take an interest in the law when they can use it in their daily activities. For rural women, local government institutions do little to overcome the many distinct barriers they face to access information.

India's more restrictive states could take cues from the Community **Empowerment Programme of** Bangladesh, which is supported by the World Bank and the Bangladesh Rural Advancement Committee. The group set out to empower the poor (including rural women) who face constraints in obtaining information. They created RTI 'informediaries'-- a cadre of information intermediaries from within the community, who are equipped with an effective understanding of the law and can motivate others to access information.

The 'informediaries' held RTI clinics aimed at developing better-informed citizens.

These 'informediaries' serve as a link between citizens and public offices. In Bangladesh, many came from Polli Samaj a popular theatre group already accepted within the community. Their main aim was to gather information queries from the community and submit RTI applications to the relevant government or NGO offices who act as facilitators between poor citizens and the state. When the relevant information was received it was passed on to the applicants.

Based on their popularity, the 'informediaries' were able to establish a close rapport with public officials through their repeated visits. This allowed them to access information with relatively greater success. In many instances, the 'informediaries' were effective in enhancing women's access to information by addressing multiple barriers. It meant women could access information without physically visiting public offices, saving both time and money.

Studies in Mexico suggest expanding the use of RTI laws to disadvantaged communities requires trustworthy intermediaries.

Tripathy stated that Scheduled Tribe people living in the villages of Niyamgiri hills are living in very poor condition due to lack of medical facilities, ambulance and fire brigade. There are no potable drinking water, primary health centre and schools in these villages, he submitted.



ising global temperatures may lead to more frequent and longer-lasting droughts in India, while posing significant risks to people and ecosystems around the world, according to a study

Researchers from the University of East Anglia (UEA) in the UK found that even a modest temperature increase of 1.5 degrees Celsius will spell serious consequences in India, China, Ethiopia, Ghana, Brazil and Egypt.

The study, published recently in the journal Climatic Change, guantified the projected impacts of alternative levels of global warming upon the probability and length of severe drought in the six countries. "Current pledges for climate change mitigation, which are projected to still result in global warming levels of 3 degrees Celsius or more, would impact all the countries in this study," said Jeff Price, Associate Professor of Biodiversity and Climate Change at UEA,.

"For example, with 3 degrees Celsius warming, more than 50 per cent of the agricultural area in each country is projected to be exposed to severe droughts lasting longer than one year in a 30-year period," Price said in a statement.

Using standard population proiections, the researchers estimated that 80 per cent to 100 per cent of the population in Brazil, China, Egypt, Ethiopia and Ghana, are projected to be exposed to a severe drought lasting one year or longer



in a 30-year period. For India, nearly 50 per cent of

the population is projected to be exposed to a severe drought lasting one year or longer in a 30-year period, they said

In contrast, the study found that meeting the long-term temperature goal of the Paris Agreement, that is limiting warming to 1.5 degrees Celsius above pre-industrial levels, is projected to greatly benefit all of the countries in this study. Meeting the target will greatly

reduce exposure to severe drought for large percentages of the population and in all major land cover classes, with Egypt potentially benefiting the most, the researchers said.

In the 1.5 degrees Celsius warming scenario, the drought probability is projected to triple in Brazil and China, nearly double in Ethiopia and Ghana, increase slightly in India, and substantially increase in Egypt, they said.

The study found that in a 2 de-

or India, nearly 50 per cent of the population is projected to be exposed to a severe drought lasting one year or longer in a 30-year period

ndia and China both have large areas currently under 'permanent' ice and snow cover. However, in the 3 degrees Celsius warming scenario, 90 per cent of these areas are projected to face severe droughts lasting longer than a year in a 30-year period

grees Celsius warming scenario, the probability of drought is projected to quadruple in Brazil and China, double in Ethiopia and Ghana, reach greater than 90 per cent probability in Egypt, and nearly double in India. In a 3 degrees Celsius warming scenario, the probability of drought projected to be in Brazil and China is 30-40 per cent; 20-23 per cent in Ethiopia and Ghana; 14 per cent in India but nearly 100 per cent in Egypt, according to the researchers.

In a 4 degrees Celsius warming scenario, the probability of drought projected in Brazil and China is nearly 50 per cent: 27-30 per cent in Ethiopia and Ghana: nearly 20 per cent in India; and 100 per cent in Egypt, they said.

In most countries, the study found that the projected increase in drought probability increases approximately linearly with increasing temperature. The exception is Egypt, where even slight amounts of global warming potentially lead to large increases in drought probability, the researchers found.

"Not only does the area exposed to drought increase with global warming, but it also increases the length of the droughts," said Professor Rachel Warren, who led the study. "In Brazil, China, Ethiopia, and Ghana droughts of longer than two years are projected to occur even in a 1.5 degrees Celsius warming scenario," Warren added.

Sluggish construction of Jira bridge angers Bargarh locals

Bargarh, Sept 28: Ambapali town is a part of the Bargarh municipality, but is separated by the Jira river. Communication between Bargarh and Ambapali has been severely affected for some years now after a bridge built during the British rule in India collapsed.

Work to construct a new bridge has already begun. However, no one knows when it will be operational due to the tardy pace of work. Inhabitants of both Ambapali and this town, who are facing commuting woes on a daily basis, are angry at the slow pace of work.

Sources said construction of the new bridge started in 2018 and it was scheduled for completion in mid-2020. Locals alleged that work is getting delayed due to administrative apathy. Opposition leaders however, slammed the state government for 'deliberate delay' in completing the construction of the bridge.

"The project should have been completed in two years, but work is moving at a snail's pace. The main reason for delay is due to 'fixing' of the tender to allot work



to a particular contractor. Now after getting the contract, he is sitting idle on it. The delay is escalating the construction cost and funds are being misappropriated," alleged BJP's district unit president Ashwini Sarangi.

Congress leader Pradip Debata said, "The government has been boasting of development. But where is it? The bridge over Jira river is a perfect example of government apathy. People of both Bargarh and Ambapali have been facing commuting hardships due to the absence of a bridge. No one is aware when the new bridge will be ready.'

A resident of Ambapali, Suresh Mohapatra alleged that political row over the construction of the

bridge is affecting the common man. "The bridge is important as it is the only way to reach the Bargarh-Bolangir and Bargarh-Raipur national highways. For four years, work is going on and yet there is no idea when we can use

the bridge," Mohapatra said.

Bargarh MLA Debesh Acharya, however, quashed the claims of the opposition. "The government has always focused on the development of Bargarh. Funds were provided by Chief Minister Naveen Patnaik for the new bridge. There are some technical issues which have affected construction. A new executive engineer has joined and the work will be completed by March next year," asserted Acharya.

Wild yams provide health and wealth to tribals

Koraput, Sept 28: The humble wild yam is a staple of the tribal population of Odisha. The region is home to many yam varieties, including the famed 'jangali kanda', which provide nutrition and boost the immune system. Not to say, the seven particularly vulnerable tribal groups in Koraput survive on 122 types of wild trees, creepers, bushes, fruits and tubers!

"The collection of wild yams is an age-old practice. All our forefathers did it," says Trilochan Muduli of Bolyguda village in Koraput district. Muduli belongs to the Paraja community, a particularly vulnerable group.

Harvesting and protecting all forest food sources are part of the traditional knowledge of many tribes here, among which yam stands out. The reason is its ability to provide both nutritional cushion and commercial benefits to the forest-dwelling

communities. This boiled spud is often served with ragi gruel or rice. A popular

recipe calls for cooking the chopped tubers with pulses, eggplant and onion, liberally seasoned with garlic, chilly, turmeric powder and salt. The yam also finds its way into traditional curries when prepared with hill gram, horse gram and bhodei. Sometimes, it is fashioned into a soup, called ambila,

along with rice powder. The tubers collected from the

forest are also prized for their use in traditional medicines for treating arthritis, cold, fever, cough, menstrual disorders and skin diseases. Shuaram Chalan, a traditional healer or dishari, has been practising for 40 years and learnt the trade from his father. He buys yam and many other forest products from tribal communities, in addition to cultivating wild yams on his land.

A recent research by Dr Debabrata Panda at the Central University of Koraput brought the benefits of jangali kanda to the fore. "During the post-Covid-19 days,

we studied the lifestyle and food patterns of tribal communities and found that despite having a vitamin deficiency, the population was not deficient in nutrients and minerals," Dr Jayant Nayak of the Central University told.

In the paper, Panda claims that wild yams could be the key to fill the nutrition gaps in Koraput tribals. As indicated by the research, yam is recognised as the fourth most important tuber that plays a prime role in the food habits of forest-dwelling communities during periods of food scarcity. **Twin effect**

Each family of the Gunji and Lenja villages of Boipariguda block collects wild yams from the forest on the hillock and sells it in the market. A family collects as much as 20 to 25 kg of vam in a month, saves some of it for personal consumption and sells the rest, earning between ₹2,000 to ₹3,000.

Tulshi Jani of Jhiaguda village says, "We consume it daily, and sell the surplus to disharis (traditional healers). Disharis from Similiguda, Lamtaput, Potangi, Kotpad and Kundra purchase yams from us at the rate of ₹200 per kg. They collect up to 50 kg of the tuber in a month." For most villagers, around 60% of their household income comes from yams.

Usually, a group goes into the forest to get the yams, which are enough to provide for one hamlet or almost 10 families, who divide the produce among themselves. There is a market for Odisha's yams in Chhattisgarh as well. Ghasi Harijan of Badamundipadar in Koraput supplies vams from the forest in Kundra, which lies on the border with the neighbouring state. "Medium-scale businessmen

come to me for wild yams. I get them directly from the forest dwellers or buy them from the local market," says Harijan. "From Mayend to July-end, wild yams help me earn ₹15,000 to ₹20,000 per month," says Harijan.

Returning the favour

The tribal population returns the favour that nature does by taking up forest conservation activities. Both men and women follow thengapali (thenga means stick and pali means turn), where they patrol the forest area with a stick in hand and protect it from poachers and smugglers.

In Maliguda and Pukulpada, locals have demarcated their forests from the neighbouring villages to have better control over conservation practices. Twelve years ago, Maliguda shared a large forest area with Kurkuti village, but it became difficult to govern the conservation activities

'We were on the verge of losing all green cover," explains Mangala Mali, president of Maliguda Vana Surakhya Samiti (VSS). Alarmed by the situation, Maliguda residents collectively decided to demarcate their 60 acres of forest land.

ndia's conduct in the recent Samarkand Summit (15-16 Sept) of the Shanghai **Cooperation Organization** (SCO) threw light on a foreign policy gone much too beyond the conventional track. Having hobnobbed with its QUAD partners at the summit level and reaping generous praise from them, having engaged in military and naval drills with all the other three members. Japan, Australia and the US in the recent past, what was 'democratic' India doing in an assembly of authoritarian despots and antidemocrats, or in other words, in an alliance of anti-Western liberal-values states? With the benefit of a keen eye on India's recent foreign policy behaviour a discerning observer can hazard some guesses.

With the remark that the "this is not the era of war (but peace). that it is the era of "democracy, dialogue and diplomacy" in his oneon-one meeting with Putin, Modi was taking a significant gamble. While the remark expectedly found resonance among some Western liberal countries like France, Germany and the USA, the Indian PM, by rubbing shoulders with all the anti-American countries, Russia's Putin, Turkey's Erdogan and Iran's Raisi, was conveying to the Western alliance that he was acceptable to both sides and could ideally play the role of a mediator though he was seemingly playing to the American gallery. Having purchased Russian crude at heavily subsidised prices for its refineries all through Russia's 7-month long invasion of Ukraine, defending a dictatorial regime by consistently voting against or abstaining on several anti-Russian (anti-war) UN resolutions, and now, by mildly admonishing Putin he was clearly indicating to Russia that India's will-o-the-wisp policy of moving according to the wind under the shelter of national interest and multi-alignment could make the latter side with both opposing sides now forming part of a new Cold War matrix. But then, by the token of being the newly anointed fifth largest economy (surpassing the UK) Modi was conveying to his Russian partner of many years that the game was up when the tide was turning against Moscow. Though Putin conveyed

Similarly, though connectivity was a key concern for India, China stole the show under India's nose, interacting with all the four Central Asian members in getting their consent to support its Belt and Road Initiative while US sanctions against Iran have dissuaded India from using the Chahbahar port to seek connectivity between the Central Asian region and India. The bigger question remains

with the eighth month running of Russia's invasion of Ukraine - what is the way out? Evidently, the Ukraine war was the primary subject of discussion at the recent

UNGA, and UN Secretary-General António Guterres' statement that the world is "now in great peril" sounded prescient without a solution. With Ukraine refusing to go into negotiations with Moscow after the former's lightning strike and catch-up victory over Russia in its eastern province, would Putin go in for a surrender or armistice? Neither of the scenarios stand credible with Putin by contrast augmenting his tone and calling for all means and forces at his disposal to renew the assault on Ukraine. He doubled it up by calling for referendums in Russian occupied territories in the East and South of the Donbas. The referendums were swiftly held as precursor to their annexation, the same way as Crimea in 2014, much against Europe's consternation.

In this scenario one can only think of a possible tactical nuclear weapon launch by Russia to end the war (though at a heavy cost) as Biden had surmised a few days back. In these traumatic times the role of China needs a rethink. Despite all the bonhomie that Xi exhibited for his life-long friend, the Taiwan imbroglio may have put Beijing in a bind. Beijing may no longer like to take an extreme position for fear of Western sanctions and may call for peaceful annexasituation may have weighed heavy on Xi as he hurriedly left Samarkand on the evening of 16th even before the valedictory rounds were over.

In this chaotic world wrought by the end of tyranny, the search for order will predominate

one military defeat, or one outrage, or one obscure and symbolic act can spread instantaneously on social media, men like Putin and Iranian Supreme Leader Ali Khamenei sleep uneasily.

But while these regimes have no real future, there is no clear and institutionally viable alternative to replace them, and that is where the geopolitical danger lies. After all, we are not talking about just any two countries. Russia is a nuclear-armed great power. Iran is the major pivot state of the Middle East and Central Asia, on the brink of becoming a nuclear power.

Even when democracy succeeds, it does not emerge overnight in states with no real tradition of it. Years of turmoil often ensue. The 1990s in Russia, following the collapse of the Soviet Union, were a period of rampant crime, economic chaos, and mismanaged reforms that left roughly 70 per cent of Russians living at or below the poverty line. It was from this maelstrom of dysfunctional democracy that Putin finally emerged

Ironically, Iran went through much less of a painful, drawn-out political transition in 1979, because democracy was never the mullahs' goal. Instead, they quickly replaced the Shah's autocracy with clerical despotism. But the mullahs have so destroyed their society that a post-theocratic Iran could be ungovernable or even disintegrate along various ethnic and geographical lines

That is why the democratic triumphalism that will accompany these regimes' downfall in the coming years will rapidly give way to the sobering recognition of an awesome political void in Moscow and Tehran, with perhaps more radical forces - Russian ultra-nationalists and Iranian Revolutionary Guards - waiting in the wings. The more destructive a tyranny has been, the more pervasive the subsequent anarchy often is.

In this chaotic world wrought by the end of tyranny, the search for order will predominate. Among intellectuals and policymakers, the fear of anarchy will replace the fear of autocracy. This is easier to imagine when one considers just how difficult it will be to stabilise the utterly broken states and societies that Putin and the mullahs will have left in their wake. The decline of autocracy will only make the work of democracy that much harder.



Butterscotch

Butterscotch is a form of caramel, made with butter and brown sugar, plus a touch of vanilla. Some argue that the second part is actually scorch, from the manner of its making. The Collins Dictionary says that it may have been called that because it was first made in Scotland. Neither suggestion is supported by evidence, though the Scottish link seems plausible because Keillers of Dundee was one firm that made butterscotch commercially. The Oxford English Dictionary's first citation (indeed, its only citation) is from 1865. It's not hard to take that back a while: the first example one can find is from The Boy's Autumn Book of 1847. Although that was published in New York it quotes a British itinerant seller of sweets. It's worth quoting at some length for the period flavour (to coin a phrase): Well, you know, next morning I put my things in my cart, ready for Nottingham goose-fair: the brandy-balls here, by themselves-the butter-scotch there-the tuffey in this place-the black-jack in that; then I filled in with cure-all, and hard-bake, and peppermint pincushions: really it was beautiful to look at, I'd done it so nicely. Wikipedia states that the first maker of butterscotch was Samuel Parkinson of Doncaster, in 1817. The firm did make it during the nineteenth century and Doncaster became famous for it. The Parkinson papers are deposited at the Doncaster Archives, from where Dr Charles Kelham says they begin only in 1848 although an article published in The Doncaster Review in September 1896 asserts that "It was on the 11th of May 1817, that the late Mr. Samuel Parkinson commenced the manufacture of butter-scotch." If he did so, it may be unlikely, from the lack of written evidence before 1847, that he called it by that name. Other writers argue that the sweetmeat has no link with Scotland. Charles Earl Funk noted in Horsefeathers in 1958: "All directions for the preparation of this candy after it is properly cooked close with some such statement as: Pour upon oiled paper or wellbuttered pan and when slightly cool score with a knife into squares." He points out that one sense of scotch was to score or cut a shallow groove in something. This seems more reasonable than to assume it was originally Scots, especially in view of the known early history of its manufacture in England. But, as often with word histories, it can't be proved.

THE REASONS BEHIND INDIA'S CONSISTENTLY LOW RANKING ON **HDI ARE POVERTY. INEQUALITY AND EXCLUSION OF A** LARGE SECTION OF **SOCIETY FROM EDUCATION AND** for the last two years. India's low ranking in all aspects of human development like education, healthcare, life expectancy and especially the decline in living conditions and life expectancy of women seems alarming. While we are lagging behind Sri Lanka, China, Bangladesh and Bhutan we are just above Pakistan, Nepal and Myanmar. The HDI was designed to emphasise not only the economic de-

velopment of a country, but also the ability of its people to live a happy, long and healthy life as the best measure of a country's development. India's low ranking on HDI indicates a dismal state in all areas of human development.

The life expectancy of the general population in the world has decreased compared to the previous year due to the pandemic. The average human life expectancy in the world has decreased from 72.8 to 71.4 years. In case of Indians, for first time in 75 years, the average life expectancy has decreased by about one and a half years -- it

n the recently published UNDP's has decreased to 67.2 years from last Human Development Index vear's 70.7 years.

What's ailing India's HDI score

To measure how people are facing poverty in different areas of their lives, the UNDP has developed a Multidimensional Poverty Index. In the latest report, UNDP has given India's MPI score at 0.123. It is in between Indonesia and Haiti. A little more than a quarter of India's population (27.9%) is known to be suffering from multidimensional poverty or extreme poverty, while more than 22% of Indians have a daily income of less than ₹160.

The report also mentions the Gender Inequality Index. In 2020, it was 0.493 and in 2019, it was 0.486, while in 2021, a slight improvement was observed and it rose to 0.490. However, compared to other countries, India's position in this field is still very low. Out of 191 countries, India ranks 132nd, between Ghana and Marshall Islands.

The main reasons behind India's consistently low ranking on the HDI are poverty, inequality and the exclusion of a large section of society from education and healthcare. In the past few years, especially during the last eight years, the government expenditure on social sectors like agriculture, education and health-

care has decreased. Despite big announcements of the government, the majority of the people are deprived of education and healthcare. Compared to many countries, India's expenditure on education and healthcare is low. For last two decades, though the target of spending on education remained at least 6% of GDP, the actual expenditure remained far behind. It was 3.5% in 2011-12 and 2.8% in 2018-19.

According to the Economic Survey - 2021, the government's expenditure on education has been steadily decreasing over 10 years. In 2011 12, 11.4% of government expenditure was spent on education, while in 2020-21, this decreased to 10.4%. As a result, the government education system is getting crippled day by day. Lakhs of teaching posts are vacant in government-run schools and colleges. Out of the total 11 lakh schools in the country, more than 4 lakh schools have less than 50 children, while less than 20 children study in 1.1 lakh schools.

Another reason why India lags behind in HDI is lack of access to quality healthcare. A large portion of our population remains far away from quality healthcare due to lack of necessary government expen-

diture. The number of doctors and nurses in public healthcare sector is much lower than most countries A large chunk of people's medical expenses coming out of their own pockets highlights the dire crisis in our healthcare system. According to a study by Oxfam, 6.3 million Indians have been pushed into poverty in the last few years due to increased healthcare costs. While the global rate of government expenditure on healthcare is 6% of GDP. in India the Centre has announced to spend only 2.5% by 2025.

The alarming rise in inequality is yet another reason behind our dismal position on HDI. The gap between rich and poor is widening rapidly due to the adoption of neoliberal economic policies by our governments. According to UNDP, India's richest 1% own 21.7% of the country's wealth. It is unfortunate that our country is constantly lagging behind in the HDL Unless our policymakers show sincerity in this direction, there is no doubt that our performance in HDI will deteriorate further.

Livestock in danger

Sir, In the frenzy of cheetahs, we have forgotten about livestock, which contribute a large part of India's economy. If sincere efforts had been made with regard to animal husbandry, cows and buffaloes would not have suffered such terrible diseases. Lumpy virus is spreading in cattle in many states. According to government data, 7,300 cattle have died so far, of which 3,359 have died in Punjab, 2,111 in Rajasthan, 1,679 in Gujarat, 62 in Jammu and Kashmir, 38 in Himachal Pradesh, 36 in Uttarakhand and 29 in Andaman and Nicobar. India produces the largest amount of milk in the world. In 2020-21, our country produced 20.90 million tonnes of milk, which generated an income of ₹13 lakh crore to the Indian dairy industry. But milk production has declined by 15% to 20% in many states due to the spread of the Lumpy virus. Most of the rural population depends on quacks to treat their livestock. There are two reasons behind this. The first is that the state government is not filling up the sanctioned posts of veterinarians, and the second is that there are very few interested people who choose to become veterinarians. In fact, the 2018 Digital Trends report from Econsultancy, a leading digital marketing organisation in London, reveals that only 7% of healthcare and pharmaceutical companies have gone digital, compared with 15% of companies in other industries. The pandemic has taught a lesson to the healthcare industry on the value and importance of digitisation of medical services, which provide the dual benefits of lower costs and higher quality. In fact, in Austria, emedication has been successfully running for years, with Electronic Medical Record allowing patients there to view all their e-results anytime and anywhere. Similarly, doctors in Sweden and Denmark send e-prescriptions to pharmacies. Also, the National Health Service in UK is working with Google to deploy Artificial Intelligence in the medical field. Digital transformation in medical services will give patients the opportunity to manage their treatment independently and share data with doctors. Gone are the days when you had to maintain a physical file on every doctor's appointment. Medical history is critical in emergency situations when a physical copy may not be available. New Delhi: A Delhi court Wednesday granted bail to AAP MLA Amanatullah Khan in a case related to alleged irregularities in the Waqf Board, saying that "prima facie the allegations against the accused are not grave and serious in nature". According to the FIR, Khan while working as chairman of the Delhi Waqf Board had indulged in several irregularities, including illegally recruiting 32 people by violating all norms and government guidelines.

Lawyers ban Ankita murder accused

Kotdwar (Ukd): The main accused in Ankita Bhandari case on Wednesday could not file their bail application in a court here after a local body of lawyers decided to boycott them, even as protests wer held demanding a CBI probe into her murder. New Delhi, Sept 28: The Supreme Court Wednesday issued notice to Centre on a PIL seeking to debar all those persons, against whom charges have been framed, from contesting election, as per the Law Commission's report.

The plea, filed by advocate Ashwini Upadhyay, sought direction to the Centre and the Election Commission to take steps to debar persons, against whom charges have been framed in serious offences, from contesting elections. It contended that February 2,

2014. the Law Commission submitted its 244th report on decriminalisation of politics, but Centre did nothing. Later, it submitted a report on electoral reform and suggested steps for electoral and democratic reforms, but the Centre did nothing on it too, it added.

After hearing arguments from Upadhyay, a bench of Justices KM Joseph and Hrishikesh Roy sought a response from Law and Justice



and Home ministries, and the Election Commission. The plea sought a direction to the Election Commission to use its plenary power conferred under Article 324, to amend the Election Symbols (Reservation and Allotment) Order 1968, to insert such a condition (restriction) for the contestants.

'There is an increase of 44 per cent in the number of MPs with declared criminal cases since 2009. Similarly, 159 (29 per cent) winners in Lok Sabha 2019 Elections have declared serious criminal cases including cases related to rape, murder, attempt to murder, kidnapping, crimes against women etc," said the plea. It further added that out of 542 winners analysed during Lok Sabha

elections in 2014, 112 (21 percent) winners had declared serious criminal cases against themselves. Out of 543 winners analysed during Lok Sabha elections in 2009, 76 (14 percent) winners had declared serious criminal cases against themselves. "There is an increase of 109 per cent in the number of MPs with declared serious criminal cases since 2009," added the plea.

The petitioner argued that con-

sequences of permitting criminals to contest elections and become legislators were extremely serious for democracy and secularism. "The injury caused to people at large because criminalisation of politics is at extreme level and political parties still setting-up candidates with serious criminal an-

tecedents," added the plea It further argued that raising the threshold to the stage of framing of charges, the chances would be considerably reduced of false cases being maliciously foisted on the candidates. The plea added that the police have filed its charge sheet to prosecute the accused and the court has applied its mind to the police report. "The plea added that the additional protection envisaged by the Law Commission in its 244th report is that charges should have been framed at least one year before the scrutiny of nominations. During this period, candidates could also apply to the High Court under Section 482 of the CrPC or under Article 226 for quashing of the charges against him," said the plea, adding that it would only deter political parties from giving tickets to criminals.

DA hiked by 4% staff, pensioners

New Delhi, Sept 28: Ahead of Diwali festival, the Union Cabinet Wednesday increased the dearness allowance (DA) and dearness relief by 4 per cent effective July 1, 2022, benefiting 41.85 lakh central government employees and 69.76 lakh pensioners.

The additional instalment of DA and dearness relief (DR) is an increase of 4 per cent over the exist ing rate of 34 per cent of basic pay/pension. The combined impact on the exchequer on account of both DA and DR would be ₹12.852.5 crore per annum, said Information and Broadcasting Minister Anurag Thakur while briefing reporters about the decisions of the Union Cabinet.

Central government employees and pensioners will become entitled to higher amount of DA and DR respectively, with effect from July 1, 2022, Thakur said.



The increase in the DA and DR is based on the percentage increase in 12 monthly average of All India Consumer Price Index for the period ending June, 2022. The impact of enhanced dearness allowance to the employees on the exchequer is estimated at

₹6,591.36 crore per annum and ₹4,394.24 crore in 2022-23 (8 months from July, 2022 to February, 2023).

Govt extends free ration scheme by three months

Under this scheme, 5 kg of foodgrain per person per month is provided free of cost for all the beneficiaries covered under the National Food Security Act (NFSA).

New Delhi, Sept 28: Senior advocate R Venkataramani was appointed as the Attorney General of India Wednesday for a term of three years, according to a notification.

He will succeed K K Venugopal, whose term will end on September 30. "The President is pleased to appoint R Venkataramani, Senior Advocate as Attorney General for India for a period of three years from the date he enters upon his office," read the notification. He would most likely join the constitutional office October 1, a day after Venugopal demits office.

Venugopal, 91, was appointed to the post in July 2017. He was reappointed as the top law officer of the country for three months June 29. He is perhaps the oldest person to hold the office of AG. Venugopal had expressed his unwillingness to continue in the constitutional post



due to his advanced age. Another senior advocate, Mukul Rohatgi, had last week declined the offer to be the attorney general. There was no specific reason behind his decision, Rohatgi had said. Rohatgi had been the attorney general in the first Narendra Modi government between June 2014 and June 2017. Venugopal had succeeded him. The attorney general is the top law officer of the government and enjoys the right to appear in any court in India. Besides handling government litigations, the AG also advises government on complex legal issues. Born April 13, 1950 in Puducherry, Venkataramani, 72, has practised in the Supreme Court for decades.

Apex court acquits death row convict for rape, murder

THE SUPREME COURT PULLED UP THE **UTTAR PRADESH POLICE FOR FAULTY INVESTIGATION**

New Delhi, Sept 28: "Court cannot make someone a victim of injustice to compensate for the injustice to the victim of a crime", the Supreme Court Wednesday said while acquitting a death row convict for the rape and murder of a six-year-old.

The top court, which pulled up the Uttar Pradesh police for faulty investigation, also said by not conducting the investigation properly, the prosecution has done injustice to the family of the victim.

It said that when the offence is heinous, the Court is required to put the material evidence under higher scrutiny but the erroneous approach on the part of the Sessions Court and the High Court has led to the "poor man" being ordained to be dispatched to the gallows.

A bench of Justices S Abdul Nazeer, AS Bopanna, and V Ramasubramanian said that it cannot shy away from the fact that it is a ghastly case of rape and murder of a six-year-old child.



"By not conducting the investigation properly, the prosecution has done injustice to the family of the victim. By fixing culpability upon the appellant without any shred of evidence which will stand the scrutiny, the prosecution has done injustice to the appellant. Court cannot make someone, a victim of injustice, to compensate for the injustice to the victim of a crime", the bench said.

The top court passed the verdict on an appeal filed by a man called Chotkau who was convicted for the offences punishable under Sections 302 (murder) and 376 (rape) of the IPC and sentenced to death by the Sessions Court, which was also confirmed by the Allahabad High Court on a reference.

The bench said that this is a case where the convict is "so poor" that he could not afford to engage a lawyer even in the Sessions Court and after his repeated requests to the trial court, the service of an advocate was provided as amicus.

"In cases of such nature, the responsibility of the Court becomes more onerous. When we analyse the evidence with such a sense of responsibility, we are not convinced that the guilt of the appellant stood established beyond a reasonable doubt. Therefore, the appeals are allowed and the conviction and penalty are set aside. The appellant shall be released forthwith if not wanted in connection with any other case", the bench said.

The top court was critical of the approach of the High Court and the trial court and said, "Before wrapping up, it is necessary to say something about the approach adopted by the Sessions Court and the High Court. In cases of this nature, the court is obliged to assess the evidence on the test of probability'

The bench said that though wide discretion is given to the Court to consider the "matters before it"such evidence has to be sifted carefully before recording satisfaction.



PFI LEADERS, CADRES GO

Chennai, Sept 28: After the Union Home Ministry imposed a ban for five years on the Popular Front of India (PFI) Wednesday, several leaders and cadres of the organisation have gone into hiding.

Sources in the state police told IANS that many of the leaders and cadres who were present in public after the September 22 raids and arrest of senior leaders by the NIA are now not seen in public.

Tamil Nadu state president of the PFI, Mohammed Shaik Ansari in a statement after the ban said that the organisation would fight the ban legally. The state leader also termed the ban "illegal and undemocratic".

While the state president has put a bold face by issuing a statement, almost all the other leaders of the front are not being seen in public.

Sources in the Tamil Nadu police told IANS that some PFI leaders who were arrested from the state September 22 were taken to Delhi and most of the second rung leaders fear that they may also be taken to the national capital and hence many of them have gone into hiding.

With the ban coming into effect. the leaders are not certain what the future will be if arrested and hence most of them have not




Agra, Sept 28: Green activists in the Taj city hailed the Supreme Court's order to double the area of the Keetham Lake bird sanctuary, now called Sur Sarovar Pakshi Vihar, on the Delhi-Agra National Highway 2.

The area under the sanctuary will now increase from 403 hectares to 799 hectares, after the new order of the apex court which has accepted the recommendation of the Central Empowered Committee, constituted after a local environmentalist, Sharad Gupta, filed a petition objecting to arbitrary reduction in the area by the Uttar Pradesh Forest Department

Gupta said he had filed rejoinders and objections at every level of discussion and sounded the concerned agencies with the matter relating to the eco-sensitive zone requirements. "But when there was no positive reaction I had to move the apex court," he said.

The Keetham Lake forest area is a green buffer zome between the Mathura refinery and Agra.

Home to hundreds of bird species, migratory and local reptiles, including more than 300 pythons;



Along the Yamuna river bank, on the national highway to Delhi, the site also has a famous sloth bear shelter home and a hospital for elephants run by Wildlife SOS, close by.

In the wake of the court order, environmentalist Devashish Bhattacharya said, "We have been struggling for long years to protect the eco-sensitive zone around Sur Sarovar, from encroachers. The delayed recognition will definitely help conserve the rich flora and fauna of the area and perhaps promote eco-tourism. The need is to firmly demolish all illegal structures in the vicinity of the sprawling lake.'

The Keetham wetland is rich in natural resources and attracts a large number of migratory birds. Action should be taken to ensure that the lake gets only treated nonpolluted water from the Agra Canal. Also, there is a need for desilting the lake to clear the pollutants. Agra now has four internationally recognised tourist attractions.

'TN decision to ban online gaming unconstitutional'

New Delhi, Sept 28: The Indian gaming sector stakeholders termed the decision of the Tamil Nadu cabinet to ban online gaming as "unfortunate and unconstitutional", which will eventually only benefit gambling operators and badly affect the fast-growing sector.

Roland Landers, CEO of The All India Gaming Federation said that this decision is disappointing because "it disregards the six decades of established legal jurisprudence and also the recent judgment of the Madras HC which struck down a similar law"

"What is also surprising is that the state government has already appealed against the judgment of Madras High Court and the

Supreme Court had recently issued notices on the same. Instead of waiting for the SC judgment and, in the meantime, respecting the categorical decision by their own HC, they seem to have taken another unconstitutional decision which will eventually only benefit online gambling operators," Landers said in a statement.

The Madras High Court had struck down the state's ban on online games like rummy and poker with stakes, and the Tamil Nadu government had then appealed to the Supreme Court.

The state government had told the apex court that teenagers and youths were losing their entire earnings and savings by indulging in online games.

In its petition, it also said that while rummy could be consid-

New Delhi, Sept 28: The Left parties Wednesday said they oppose the extremist views of the Popular Front of India (PFI) but do not support the way the government is tackling it by banning the outfit under the anti-terror law UAPA.

In a statement, the CPI(M) alleged that the PFI and the RSS have been engaged in killings and retaliatory killings in Kerala and coastal Karnataka, vitiating the atmosphere to create communal polarisation.

"However, the notification of the PFI as an unlawful association under the Unlawful Activities Prevention Act (UAPA) is not the way to tackle this problem. Past experience has shown that bans on organisations like the RSS and the Maoists were not effective," it said. It suggested that there has to be firm administrative action under

the existing laws against the PFI whenever it indulges in illegal or violent activities.

"A ban is not a solution to tackle this problem. We have seen what our own experience and India's experience have been. RSS was banned thrice after Mahatma Gandhi's assassination. Has anything stopped?" CPI(M) general secretary Sitaram Yechury told reporters in Thiruvananthapuram.

"We have also seen a ban on CPI (Maoist). Even today the security forces are at loggerheads with them and the two continue to battle each other in

certain parts of the country. "We have to politically isolate such forces which spread extremism and terror tactics and administratively take firm action against their criminal activities. That is the manner in which this has to be



In in PFI Office extremist views and has been indulging in violent activities against

its perceived opponents. The CPI(M) has been strongly opposed to these extremist views and has always condemned the violent activities of the PFI,' it said. Calling on the government to expose PFI's

sectarian and divisive ideology, the Left party said that the organisation has to be fought politically among the people.

There are also extremist organisations like the Sanatan Sanstha and the Hindu Janajagruti Samiti, elements of whom have been implicated in the killings of noted secular writers and personalities. Justice Sudhir Kumar Jain granted "statutory bail" to Ramkrishna and the National Stock Exchange's ex-group operating officer Anand Subramanian in the colocation scam case being probed by the CBI. It relates to alleged manipulation of the computers at the country's largest stock exchange.

Another bench of the Delhi High Court issued notice to the Enforcement Directorate (ED) on the bail application of Ramkrishna in the snooping and phone tapping case.

Justice Jasmeet Singh issued notice on the bail plea by Ramkrishna, a former Managing Director of the NSE, and granted time to the investigating agency to file its response

An FIR was registered in the colocation case in May 2018, amid fresh revelations about alleged irregularities at the stock exchange. The CBI is probing alleged improper dissemination of information from the computer servers of the market exchange to stock brokers. The CBI arrested Subramanian February 24 and Ramkrishna March 6, a day after her anticipatory bail application was dismissed by the trial court.

She was arrested by the CBI in a case that was registered in May 2018 related to the alleged manipulation of the bourse. The ED arrested her later July 14 in the phone tapping case.

ASI explores Bandhavgarh, finds Buddhist remains

BANDHAVGARH TIGER RESERVE, HOME TO THE MAJESTIC BIG CATS, IS LOCATED ABOUT 500 KM FROM MP CAPITAL BHOPAL

During the exercise held from May 20-June 27, the ASI's Jabalpur Circle also reported many ancient sculptures, including large monolithic sculptures of various avatars of Lord Vishnu like 'Varaha' and 'Matsva', and "board games made in natural caves", officials said.

Superintending Archaelogist of the Jabalpur Circle, S K Bajpai, who led the team, shared details and images from the exploration during a media interaction at the ASI headquarters here.

"This is the first time ASI has explored Bandhavgah since the 1938 exploration by archaelogist N P Chakravarti. Many structures there were documented, we reported and documented more structures, in-



cluding ancient caves, temples, Buddhist remains, maths, sculptures, water bodies, mural inscriptions in old scripts like Brahmi and Nagari," Bajpai said.

Other agencies have done some exploration in the intervening period though, he added. A special permission was taken from the forest authorities to explore the

area in Umaria district of Madhya Pradesh, he said, adding that he "encountered a tiger and elephants" during the job, but "caves gave us shelter". "For me, the most startling finding is the remains of the Buddhist structures in the region where a Hindu dynasty ruled. It suggests religious harmony, but who built these Buddhist structures is not known yet, " the ASI official said.

A votive stupa and a Buddhist pillar fragment containing miniature stupas carving, which roughly date back to 2nd-3rd century AD have been documented as part of this exploration, according to information shared by the ASI

But what is also very noteworthy is the names of old cities like

Mathura and Kaushambi, located in Uttar Pradesh, found in ancient inscriptions we have documented, Bajpai said. "Names of these cities located far away from Bandhavgarh suggest that there were trading ties and people from other cities may have donated something, but again, it is a matter of conjecture," another senior ASI official said

Coins belonging to Mughal-era ২ and Sharqi dynasty of Jaunpur Sultanate have also been found, he said

ASI officials said a total of 35 temples have been documented, nine earlier and 26 temples or re-mains of temple of Kalachuri period in the latest exploration.



Hasanzadeh also said rioters broke the skull of one of the Basij members. He added that five Basiiis are hospitalised in intensive care.

BoE to buy UK bonds to avert financial crisis

London: The Bank of England sought to quell a fire-storm in Britain's bond markets, saying it would buy as much government debt as needed to restore order after new Prime Minister Liz Truss' tax cut plans triggered financial chaos. Having failed to cool the sell-off with verbal interventions over the previous two days, the BoE announced Wednesday the immediate launch of its emergency bond-buying programme aimed at preventing the market turmoil from spreading. It said it would buy up to 5 billion pounds (\$5.31 billion) a day of British government bonds of at least 20 years' maturity starting Wednesday and running until October 14. The announcement, which represented a sudden reversal of the BoE's plans to start selling bonds it had amassed since the global financial crisis of 2008-08, immediately pushed down borrowing costs. The 30-year gilt yield was set for its biggest drop in records going back to 1992. But sterling fell by about 1% against the dollar and euro, putting it on track for its biggest monthly decline since October 2008, just after Lehman Brothers collapsed. By 2:48pm (1348 GMT) it was trading down 0.5% at \$1.0679, a fall of 12% in the last three months.

₹ BREACHES 82 MARK Mumbai: The rupee plunged below the 82 mark for the first time in day trade before settling down by 40 paise at 81.93 against the US dollar 2.03 Dr Reddys Labs Wednesday due to heavy forex outflows amid strengthening US treasury yields. China's yuan slides to 14-year low

Beijing: China's yuan fell to a 14-year low against the dollar Wednesday despite central bank efforts to stem the slide after US interest rate hikes prompted traders to convert money into dollars in search of higher returns. A weaker yuan helps Chinese exporters by making their goods cheaper abroad, but it encourages capital to flow out of the economy. That raises costs for Chinese borrowers and sets back the ruling Communist Party's efforts to boost weak economic growth. The yuan fell to 7.2301 to the dollar, its lowest level since January 2008. One yuan was worth about 13.8 cents, down 15% from this year's March high. The yuan has exceeded expectations it might fall to 7 to the dollar after the Federal Reserve started aggressive rate hikes to cool inflation that is at a four-decade high. The Fed has raised rates five times this year and says more increases are likely.

Part of the reason for the draw down is the RBI has lagged the US Federal Reserve with interest rate hikes. The Fed, which has raised rates by 300 basis points from nearzero in March to 3.00%-3.25%.

For its part, the RBI, which only started hiking in May and has raised the repo rate by just 140 basis points, appears nearly done. It is forecast to hike by a mere 60 basis points more in this cycle, with 50 due this week.


SURYA EQUALS CAREER-BEST 2ND POSITION IN T20IS
