

to death after house set afire in revenge act

Keonihar. Oct 2: A vouth was brutally hacked to death by some co-villagers over past enmity after his house was set on fire at Hundula village under Sadar police limits in Keonjhar district, late Saturday night.

The deceased was identified as Pranab Mohanta, 25, son of Prakash Mohanta of the village. Police detained two persons identified as Bhuban Das and his son Shakti Prasad Das of the same village over a complaint lodged by the deceased's father. The body was sent for post-mortem and an investigation launched into the incident.

Police said that the deceased had assaulted the youngest son of Bhuban, a shopkeeper in the village, Saturday. Bhuban's family members had lodged a complaint at Sadar police station but police visited the spot and left the place after placating both the groups.

This infuriated Bhuban's family members. Bhuban decided to settle scores and visited Pranab's house at night with some village youths. Panicked over their arrival. Pranab hid himself inside the house by bolting the door from inside. They poured petrol on his house and set it on fire and latter burnt chilli powder to suffocate him. Feeling suffocated and caught in fire, Pranab ran out of his house when the miscreants caught him and hacked him to death.

When contacted, Sadar IIC Sunil Kar said the detainees are being auestioned in this connection and the actual reason behind the murder could be ascertained after completion of the probe.

4 killed as tourist bus turns

INDONESIA STADIUM STAMPEDE KILLS

Jakarta, Oct 2: In one of the world's worst sports tragedies, at least 125 people died at an Indonesian football stadium when thousands of angry home fans invaded the pitch and police responded with tear gas that triggered a stampede, au-

thorities said Sunday. The tragedy Saturday night in the city of Malang, which also left 323 injured according to police, was one of the world's deadliest sport-

ing stadium disasters. Arema FC supporters at the Kanjuruhan stadium marched onto the pitch after their team lost 3-2 to the visiting team and bitter rivals. Persebaya Surabaya.

Police, who described the unrest as "riots", said they tried to force fans to return to the stands and fired tear gas after two officers were killed. Many of the victims were trampled or choked to death, according to police.

At least 125 people died, East Java deputy governor Emil Dardak told broadcaster Metro TV Sunday evening, significantly lowering officials' earlier death count of 174 because of double counting.

'Some names were recorded

twice because they had been referred to another hospital and were written down again," he said, citing data collected by local police from 10 hospitals. Survivors described panicking

spectators in a packed crowd as tear gas rained down on them.

"Officers fired tear gas, and automatically people were rushing to come out, pushing each other and it caused many victims," 43-yearold spectator Doni, who declined to give his last name, told AFP.

"Nothing was happening, there was no riot. I don't know what the issue was, they suddenly fired tear gas. Thats what shocked me, didn't they think about kids, women?" President Joko Widodo ordered

an investigation into the tragedy, a safety review into all football matches and directed the country's football association to suspend all matches until "security improvements" were completed.

A hospital director told local TV that one of the victims was five years old. Images taken from inside the stadium during the stampede showed police firing huge amounts of tear gas and people clambering Contd....P4

Kaniha, Oct 2: At least four tourists from Kaniha area of Angul district died and over 25 others were injured after a trailer truck collided with the bus carrying them, Saturday night. The accident took place in Hazaribagh district of neighbouring Jharkhand.

As per sources, a total of 55 tourists from Kaniha were returning to state from Gaya in Bihar by a bus. The passengers hailing from Angul, Dhenkanal, and Mayurbhanj districts were on the bus, officials said. On the way in Jharkhand, a trailer truck rammed into the bus and it overturned.

Four of the tourists died on the spot and over 25 others were injured, a senior police officer



said in Jharkhand. The injured were admitted to a hospital in Hazaribagh. The kin of the deceased and the injured have left for Jharkhand to receive the bodies, sources said. Chief Minister Naveen Patnaik

Srinagar, Oct 2: Two days ahead of Union Home Minister Amit Shah's visit to Jammu and Kashmir, terrorists Sunday attacked a security forces team in Pulwama district of the Union territory killing a special police officer (SPO) and injuring a CRPF jawan, officials said.

Director General of Police Dilbag Singh did not rule out possibility of the terrorist attack linked to the high profile visit of Shah to Jammu and Kashmir, beginning October 4.

'Deputy Superintendent of Police, headquarters, was inspecting a check point when terrorists opened fire on the joint party of police and CRPF, killing an SPO and injuring a CRPF jawan. We have identified the attackers and will share details later as the operation is in progress," the J&K police chief told reporters in Jammu. He said the case will be worked out shortly.

This was the second major terrorist attack in Jammu and Kashmir over the past five days. Twin blasts had ripped apart two parked buses in Udhampur district of Jammu region within eight hours during the intervening night of September 28 and 29, and injured two persons.

He said the Udhampur blast was carried out by the LeT ahead of the home minister's visit to convey "all is not well" on the security front in the Union Territory.

However, the case was solved with the arrest of a Lashkar-e-Taiba (LeT) terrorist along with five improvised explosive devices.

Meanwhile, Jammu and Kashmir Lieutenant Governor Manoj Sinha and political parties condemned the attack. Former and Mehbooba Mufti also condemned the attack.

With drained battery, Mars Orbiter craft quietly bids adieu

THE MANGALYAAN ORBITER FUNCTIONED FOR ALMOST 8 YEARS, WELL BEYOND ITS DESIGNED MISSION LIFE OF 6 MONTHS

Bangalore, Oct 2: Mars Orbiter craft has run out of propellant and its battery drained beyond the safe limit, fuelling speculation that India's maiden interplanetary mission 'Mangalyaan' may have finally completed its long innings.

The ₹450 crore Mars Orbiter Mission (MOM) was launched onboard PSLV-C25 November 5, 2013, and the MOM spacecraft was successfully inserted into Martian orbit September 24, 2014 in its first attempt.

Right now, there is no fuel left. The satellite battery has drained, sources in the Indian Space Research Organisation (ISRO) told PTI. The link has been lost. There was, however, no official word from the national space agency headquartered here.

With fuel on board, ISRO had been performing orbital manoeuvres on MOM spacecraft to take it to a new orbit to avoid an impending eclipse in the past.

But recently there were backto-back eclipses including one that lasted seven-and-half hours, officials said on condition of anonymity, noting that all the propellant on board the ageing satellite had been consumed.

As the satellite battery is designed to handle eclipse duration of only about one hour and 40 minutes, a longer eclipse would drain the battery beyond the safe limit, another official said.

ISRO officials noted that the Mars orbiter craft functioned for almost eight years, well beyond its designed mission life of six months. It has done its job and yielded significant scientific results, they



said. The objectives of the mission were primarily technological and included design, realisation and launch of a Mars Orbiter spacecraft capable of operating with sufficient autonomy during

the journey phase; Mars orbit insertion capture and in-orbit phase around Mars.

The MOM - a technology demonstration venture -- carried five scientific payloads (total 15 kg) collecting data on surface geology, morphology, atmospheric processes, surface temperature and atmospheric escape process.

The five instruments are Mars Color Camera (MCC), Thermal Infrared Imaging Spectrometer (TIS), Methane Sensor for Mars (MSM), Mars Exospheric Neutral Composition Analyser (MENCA) and Lyman Alpha Photometer (LAP).

MOM is credited with many laurels like cost-effectiveness, short period of realisation, economical mass-budget, and miniaturisation of five heterogeneous science payloads, ISRO officials pointed out.

Highly elliptical orbit geometry of MOM enabled MCC to take snap shots of 'Full disc' of Mars at its farthest point and finer details from closest point. The MCC has produced more than 1,000 images

and published a Mars Atlas. Meanwhile, plans on a followon 'Mangalyaan' mission to the red planet, however, are yet to be firmed up.

ISRO came out with an 'Announcement of Opportunity' (AO) for future Mars Orbiter Mission (MOM-2) in 2016 but officials acknowledged that it's still on the drawing board, with the coming 'Gaganyaan', 'Chandrayaan-3' and 'Aditya - L1' projects being in the space agency's current priority list.

The AO had said, "It is now planned to have the next orbiter mission around Mars for a future launch opportunity. Proposals are solicited from interested scientists within India for experiments onboard an orbiter mission around Mars (MOM-2), to address relevant scientific problems and topics."

IISc develops algorithm to detect seizures

The development has the potential to do away with the current practice of manual evaluation of Electroencephalogram (EEG) which can be often tedious and sometimes lead to errors

esearchers at the Indian Institute of Science (IISc) have joined hands with AIIMS Rishikesh to create an algorithm that can help decipher brain scans and identify the occurrence and type of epilepsy

The development has the potential to do away with the current practice of manual evaluation of Electroencephalogram (EEG) which can be often tedious and sometimes lead to errors

Epilepsy is a neurological condition where the brain emits sudden bursts of electrical signals in a short amount of time, resulting in seizures, fits and sometimes even death

Based on the point of origin of the brain's erratic signals, epilepsy is classified as either focal or generalised epilepsy. Focal epilepsy occurs when the erratic signals are confined to a specific region in the brain. If the signals are at random locations, then it is termed as generalised epilepsy, an IISc statement said.

"The research aims to differentiate EEG of normal subjects from epileptic EEGs. Additionally, the developed algorithm attempts to identify



the types of seizures. Our work is to help the neurologists make an efficient and quick automated screening and diagnosis," says Hardik J. Pandya, Assistant Professor at the Department of Electronic Systems Engineering (DESE) and the corresponding author of the study published in Biomedical Signal Processing and Control.

During the course of their study, the team noted a novel algorithm that can sift through EEG data and identify signatures of epilepsy from the electrical signal patterns.

After initial training, the algorithm was able to detect whether a human subject could have epilepsy or not -based on these patterns in their respective analyses -- with a high degree of accuracy, the researchers say.

To develop and train the algorithm, the researchers first examined EEG

data from 88 human subjects acquired at AIIMS Rishikesh. Each subject underwent a 45-minute EEG test, divided into two parts: an initial 10minute test when the subject was awake, which included photic stimulation and hyperventilation, followed by a 35-minute sleep period when the subject was asked to sleep. Next, the team analysed this data and classified different wave patterns into sharp signals, spikes and slow waves. Spikes are patterns where a sig-

nal rises and falls within a very short duration of time (70 milliseconds), while sharps are those with rises and falls spread over a slightly longer duration (250 milliseconds) and slow waves have a much longer duration (400 milliseconds).

An epileptic subject shows a different set of patterns compared to a healthy individual. The researchers developed an algorithm to calculate the total number of sharp waves -- the Cumulative Sharp Count - and use this as a parameter to detect if the subject is epileptic or not (a higher value indicates a greater chance that the subject is epileptic).

The algorithm also calculates the sum of areas under the spikes and sharp curves to distinguish between focal and generalised epilepsy (a greater value indicates generalised epilepsy as opposed to focal epilepsy, which has a lower value).

The researchers add that the study shows a way to identify absence seizures (those that involve a brief, sudden lapse of consciousness), using a Cumulative Spike-Wave Count; in some cases, these absence seizures are critical and can be fatal.

The team then ran their algorithm on a new set of EEG data from subjects for whom the classification (whether they had epilepsy, and if so, what type of epilepsy they had) was already known to the doctors. This blind validation study successfully classified the subjects accurately in nearly 91 per cent of the cases.

"We hope to refine this further by testing on more data to consider more variabilities of human EEGs until we reach the point where this becomes completely translational and robust," says Rathin K. Joshi, a PhD student in DESE and first author of the study. IISc said that a patent has been filed for the work and the algorithm is being tested for its reliability by physicians at AIIMS Rishikesh.

It is pertinent to mention that Nayak recently made a sensational claim about the involvement of School and Mass Education Minister Samir Ranjan Dash in Sahoo's suicide case. The BJP in a presser recently released an audio recording purportedly of a telephonic conversation between Nayak and Sahoo just few hours before the latter's death. Sahoo reportedly spoke to Nayak for more than an hour, during which the former allegedly named as many as seven persons, holding them responsible for him taking the extreme step. Nayak Sunday said, "Three cops asked me about my relationship with Sahoo and Minister Dash. They have seized the mobile phone that contained the audio recording and returned my sim cards. I am fully cooperating with the police in the investigation. There are no allegations against me in this case. The police assured me that they will visit Gop and Nimapada area after Durga Puja and will do detailed investigation to bring forth the truth."

Since the objective of using green hydrogen is really to reduce carbon dioxide, the applications to target first should be those that will yield the largest reductions in emissions. Liebreich's ladder shows which they are. The applications in the (green) top row are an efficient use of valuable green hydrogen.

But green hydrogen currently costs much more to make than less clean types of hydrogen. Using it to produce the 180 million tons per annum of ammonia required globally for fertiliser production would have a severe knock-on effect on food prices.

So it is difficult to see how this transition is going to occur.

Green hydrogen is made from water. Using renewable ("green") electricity, equipment called electrolysers separates the hydrogen from oxygen in water (H2O). The process is called electrolysis.

Green hydrogen production emits no carbon dioxide, but the construction of renewable electricity infrastructure currently uses fos-



sil fuels, which do emit carbon dioxide. Hydrogen has traditionally been made from non-renewable energy sources like coal ("black duced is known as "blue hydrogen". Although the costs of renewable power generation have been coming down, the cost of electrolysis is still not commercially competitive.

Today, green hydrogen has an estimated energy equivalent cost of between USD 250 and USD 400 per barrel of oil at the factory gate, according to the International Renewable Energy Agency, Future cost reductions are forecast but these are uncertain. Current oil prices are around USD 100 a barrel - much less than it would cost to use green hydrogen instead of conventional petroleum products. The costs of transporting hy-

drogen must be taken into account too. Unfortunately, the physics of hydrogen is against low-cost hydrogen transport. It is much more challenging than oil-based liquid fuels, liquefied petroleum gas or liquefied natural gas.

Ocean transport of hydrogen has to be at very low temperatures (-253 C). Petrol or diesel doesn't need costly refrigeration: it is transported at ambient air temperature.

And hydrogen carries only 25 per cent of the energy that a litre of petrol does, making it much more expensive to transport and store the same amount of energy.

Alternative ways to transport hydrogen have been investigated. Because ammonia (NH3) is much easier and cheaper to transport than hydrogen, the International Renewable Energy Agency has recommended "storing" hydrogen in ammonia for shipping. But that requires additional equipment to put the hydrogen into ammonia and strip it out at its destination.

These processes add costs of about USD2.50-USD4.20/kg (equivalent to USD123-USD207 per barrel of oil) according to the agency.

Hvdrogen is more difficult to handle than conventional fossil fuels. It is a colourless, odourless and tasteless gas, unlike conventional hydrocarbons.

Marine life research centre in Kendrapara mooted

Kendrapara, Oct 2:Environme ntalists and nature conservationists have called for an urgent need to set up a marine life research centre in Kendrapara district with Bhitarkanika National Park rich in biodiversity and playing host to a large number of aquatic and marine creatures, a report said.

The proposal assumes significance with rapid coastal erosion gobbling up large tracts of land mass in the district. The matter was put forth at a meeting of the Gahirmatha Marine Turtle Protection and Mangroves Conservation Society (GMTPMCS), held Saturday.

Presiding over the meeting, society president Satya Prakash Mohanty said, apart from the rich biodiversity in Bhitarkanika, the district is also home to albino crocodiles, marine creatures like dolphins, rare Olive Ridley turtles, octopus, horseshoe crabs, other varieties of crabs, jelly fish and shells which make it a nature's paradise.

He said that the life cycle of the creatures like horseshoe crabs, other crabs and some shells and their medicinal qualities are still



unexplored and calls for extensive research to unravel the mystery.

Environmentalists Hemant Kumar Rout, Ashok Kumar Swain, Prabhu Prasad Mohapatra and Ashis Kumar Senapati said that arrival of rare Olive Ridley turtles at a particular point of time in a vear, their mass nesting, return of female turtles and birth of the hatchlings from eggs and their homebound journey in the sea continue to baffle humans and still remain a mystery.

The turtles were previously visiting Ramachandi coast in Puri district for mass nesting but they have stopped coming to the place since 2012. This makes it all the more important for establishment of a research centre in the district.

This centre is expected to hold research on the life cycle of this rare turtles and find out reasons for abandoning the Ramachandi coast, they observed.

Similarly, the rare albino crocodile 'Gori' has drawn the attention of the tourists from all over the world. This rare albino has been kept in an enclosure in Dangamal sanctuary. However, this year, 16 albino crocodiles have been traced in the area during a census. There is a need for research on the life cycle of these reptiles, they added. When contacted, ADM Pitambar Samal welcomed the demand and assured that attention of the authorities concerned will be drawn in this connection.

Nuapada, Oct 2: The state government is providing financial assistance to the families having lost their homes and land in the areas prone to fully and partially submergence of the under-construction Lower Indra irrigation project in Kharial and Komna blocks of Nuapada district.

However, some members of LIBSS Committee, an outfit for the project-affected people, were accused of misappropriating compensation funds in the names of some ineligible and non-displaced people.Some unscrupulous officials are involved in it.

Locals had earlier drawn attention of the district administration and the higher authorities concerned towards the irregularities, but no steps were taken. Meanwhile. Niran Harijan (Ashok), a resident of Chandopala village in Penderaban panchayat has taken up the issue with the district administration, top officials of the irrigation project and the water re-

sources department. According to sources, the government has made provision of rehabilitation and compensation for the people affected and displaced by the project at Tikhali village as per the Rehabilitation and Resettlement(R&R) policies, 1994 and 2006.

However, some ineligible people were enlisted as displaced ones and are being handed out compensation while many genuine oustees are deprived of their benefits, it was alleged.

Many people have also managed to get funds sanctioned in the names of their kin. Locals have demanded a thorough investigation into the irregularities. Niran Harijan has sent copies of his memorandum to the secretary of the water resources department, the Collector, the director of the R&R, the RDC (Southern range) and the special land acquisition officer.



six-foot-high statue of Mahatma Gandhi, made of scraps, was Sunday installed on the campus of a government-run Industrial Training Institute (ITI) here. 'We use scrap materials to build artefacts. This serves two purposes - it cleans the environment and also develops the innovative talent of the students," the principal observed.

Organisers go to great lengths as bullocks missing in Bhuban

UNIQUE BULLOCK FESTIVAL

Bhuban, Oct 2: Rapid mechanisation of the farm sector has played spoilsport in organisation of festivals that hold social and cultural significance and bind people together as a community.

The non-availability of bullocks for the centuries-old bullock festival observed on the occasion of Vijavadashami here in Dhenkanal district is a case in this point. Reports said that a committee had to spend over ₹1.5 lakh to buy a bullock.

With cultivation shrinking in the state and farmers getting increasingly dependent on modern equipment, bullocks have vanished from the households

This has affected the social and cultural life of people. It has also left its direct impact on the historical bullock festival as people have failed to get healthy bullocks for the festival.

Things have come to such a pass that people are either searching for the animal or hiring them on rent from outside or even spending several lakhs to buy a pair of bullocks.

The festival was started in Bhuban by the members of Thoria community decades ago. Consent of the presiding deity Maa Banajari is taken before the festival. Revelers from places, near and far, come to Bhuban to witness the festival. In the days before Independence, people would depend on bullock carts to go from one place to another. The businessmen of Bhuban area also would use bullock carts to go to different areas carrying their commodities.

Their long association with bullocks developed a unique bonding. In order to honour these animals instrumental in earning livelihood, the Thoria communitv started the bullock festival. Goldsmiths and silversmiths later supported it.

Bhuban town gets decorated with colourful lights, gates and festoons during the festival. Most of the houses also receive a fresh coat of paint and those who work away also return home as relatives gather in the village.

The bullocks decorated with beads, fur and colourful saddles are taken out in a procession that covers three to four kilometre with loud music. It starts in the evening and goes on until next morning. On this occasion, arisa pitha, a kind of famous sweet cake, is prepared in homes.

What makes the event more special is that goddess Durga and Hara-Parvati are worshipped at 12 pandals. And for the last couple of years, the 'Ravana Podi' utsav is also being celebrated here, attracting people from various parts of the state and outside.

The festival first started with only a pair of bullocks and later 150 more were part of it. However, the number of participating bullocks decreased with

the festival becoming very expensive with passage of time. This year, the festival will see participation of 32 bullocks

Earlier, the dress rehearsal for festival used to begin from the day of Mahalaya. To tame the bullocks, the animals are taken on a round of the Bhuban town amid bursting of crackers and playing of musical instruments.

This year the practice session started from Ganesh puja as the festival could not be held for last two years due to Covid pandemic.

Some organisers have their own bullocks while other are hiring from outside at prices anything ranging between ₹5.000 to ₹10.000. However, what is surprising is that a committee of Maudamani Mahalkshmi Yuvak Sangha at Badahaat has purchased a bullock for ₹1.5 lakh.

Debendra Kumar Sahoo, president of the committee said that these days healthy bullocks are not available and several lakhs of rupees are being spent right from the practice session till the culmination of the final festival and the immersion ceremony.

He said that despite spending several lakhs in buying bullocks, they are having a sense of satisfaction for upholding the age-old tradition.

Sibananda Sahu, president of Bania Sahi Dussehra Committee said many committees are forced to hire a bullock by spending around ₹10,000.

Recently, some committee members entered into an agreement with some farmers by paying half the price of a bullock

The farmers will rear the animals throughout the year and would only lend those during the festival.

To keep the relations intact with the farmers, the committee members visit their houses during the festival and felicitate them with new clothes and sweets. This helps in strengthening amity and brotherhood in the region, he observed.

THE MOTHER

t was a foregone conclusion that Russia would veto a United Nations Security Council (UNSC) resolution September 30 that sought to condemn its referendums in four Ukrainian regions of Luhansk, Donetsk, Kherson and Zaporizhzhia as illegal. The resolution further desired to declare them invalid and urge all countries not to recognise any annexation of those territories by Moscow. This was despite 10 votes out of 15 going in favour of the resolution and 1 against with four countries - China, India, Brazil and Gabon - abstaining. The resolution, if passed, would also have demanded an immediate halt to Russia's "full-scale unlawful invasion of Ukraine" and the immediate and unconditional withdrawal of all its military forces from that country. The veto and defeat of the resolution was rather a commonplace event as countries holding veto powers had exercised this option umpteenth times in the past in keeping with their respective geopolitical agenda. It was only natural that Russia would also follow this beaten track and veto the resolution intended to declare it as an international pariah.

What, however, has caused a diplomatic stir is India's decision to abstain only days after Prime Minister Narendra Modi had formulated a position that India would not countenance war and advocate peace. Modi had recently stated that this was not the era of war. The two different stances are self-contradictory and by hindsight it appears there was no need for raising false expectations in the West about India returning to its age old policy of non alignment and not siding with Russia at the UN forum.

Britain's ambassador to the UN, Barbara Woodward, explained the position of 10 countries in favour of the resolution by saying that Russia's actions violated the UN Charter. The area Russia is claiming to have annexed is more than 90,000 square kilometres which is being described as the largest forcible annexation of territory since the Second World War. This, of course, may be debatable if China's forcible occupation of Indian territory during the last three years is taken into account.

There is not much doubt, despite Russia's claims to the contrary, that the referendums on whether the regions wanted to join Russia were "pre-determined" in Moscow. These were engineered at a time when Russia was finding it difficult to vanquish Ukraine.

Russian Ambassador Vassily Nebenzia's claim at the UNSC that the results of the referendums reflected the refusal of the residents of the four regions to return to Ukraine sounds ludicrous. His accusation that the Western nations on UNSC had betrayed their "open" hostility by putting forward a resolution condemning a council member is predictable enough

What China's Ambassador to the UN Zhang Jun said to justify his country's abstention has at least a veneer of logic. He said the sovereignty and territorial integrity of all countries should be safeguarded, but the UNSC should try to calm the crisis "rather than intensifying conflicts and exacerbating confrontation.

Likewise, Brazil's Ambassador, asserted the referendums "cannot be perceived as legitimate," but his country abstained because the resolution was not for de-escalating tensions and finding "a solution for the conflict in Ukraine.

Without spelling out the reason for its abstention, Gabon's representative said that his country supported the UN Charter, was against war and called for a diplomatic solution to the conflict.

But, Indian diplomacy cut a sorry figure by its explanation for abstention. It was the least convincing. What India's permanent representative to the United Nations (UNPR) Ruchira Kamboj, said was neither here nor there. She said India was "deeply disturbed" by the recent events in Ukraine and "always advocated" there could be no solution at the cost of human lives. She iterated the Prime Minister's earlier message that it is "not an era for war." This is wishy-washy. India had hoped for getting cheaper crude oil from Russia benefiting from the West's sanctions since the invasion of Ukraine but that situation seems to have changed lately. Besides, Russia is its most important military hardware supplier and benefactor. As such it is in no position to act openly against Russia. In such a situation it is undiplomatic and foolhardy to have created a false impression that India might deviate from its former foreign policy vis-a-vis Russia.

Sticking to the truth might always seem to be a good idea. Even in complex foreign policy. India today is being viewed as a bumbling nation with no clear idea of where it wants to place itself.

In this context, a bill that commits to keep public services free is remarkable and is a safeguard for the poor.

Further, the bill commits to free healthcare in public facilities not only for residents but for all persons in the state. This is extremely critical for large numbers of migrants and those who may find it difficult to prove their resident status. It is therefore in the true spirit of fraternity, the minimum a state can offer to fellow Indians from other states. The bill also commits to safeguarding people's rights to free emergency care in all facilities including private facilities. This right (of accessing free emergency care from private hospitals) though is restricted to residents and does not apply to all persons in Rajasthan. The bill also stipulates several other rights related to patient's rights to privacy, right to information and confidentiality. While affirming the right to access free healthcare services from all public facilities, the bill falls short on clarifying the nature of rights and obligations. What is the kind of healthcare that people will have the right to avail? Healthcare needs to be affordable.

accessible, responsive and of good quality. People living in remote, difficult-to-reach areas, who are in the greatest need of healthcare are not able to reach services that are far. Right to health does not mean much for them if the facilities are not guaranteed to be close to where they live. While the bill states that the government health facilities will be made available based on distance, terrain and population density, no parameters have been laid down. It may continue to make government services inaccessible to people living in hilly and desert areas, and they may

continue to fend for themselves.

There is clear evidence that health facilities in India, public and private, often provide poor quality and unresponsive care. It was expected that the bill would therefore commit to certain standards of quality care for government and government funded private facilities. The bill has left the development of quality standards to subsequent rules, which makes it as much ineffective, and uncertain. The bill stipulates formation of district and state health authorities to plan, advice and monitor and redress complaints related to implementation of the right-to-health. There is no representation of the employees such as medical officers and ANMs, and no representation of citizen groups such as patient networks or of civil

society such as those from NGOs or CBOs or of private providers. Such exclusion makes it a highly bureaucratic structure, and does not differentiate the executive func tionaries from grievance prevention and redressal functionaries. Another significant problem

with the bill is that it bars the jurisdiction of civil courts to entertain any suit related to a complaint that is within the jurisdiction of the grievance redressal body constituted under the act. This is not only unconstitutional but will restrict even the existing rights of citizens to approach the courts for is sues related to their right to survival. Finally, as a common saying goes, you have to put your money where your mouth is. Rajasthan allocates about 6% of its annual state budget to healthcare, which is higher than some other states but is still clearly inadequate. The National Health Policy of 2017 recommended that states spend at least 8% of their budget on healthcare.

By guaranteeing free access to government health services in an era where there are declining gov ernment investments in health care and increasing reliance on private healthcare, the Rajasthan right-to-health bill is indeed a landmark bill. It marks the first definitive step in the chequered history of making health care a fundamental right of the people of India. We can ask for more though

Clearer commitments and standards on access and quality, making oversight and redressal mechanisms more participatory and allocating adequate financial resources alone would make the right to healthcare to all citizens a reality. The journey has only begun. At this stage, other states can learn from the provisions and omissions in this bill to draft their own right to health acts.

That is as true for climate change and biodiversity loss as it is for this year's energy and food crises, COVID, and mounting debt distress. As a result, climate action and reactionary populism could remain tangled for decades to come, amid climate disruptions, sharpening inequalities, and a social contract fraving everywhere. According to a recent study of 25 countries over more than a decade, right-wing populist parties have had a consistently negative impact on climate ambition, making international targets even harder to reach. As the host of the foundational 1992 Earth Summit, Brazil previously had a reputation as a leading consensus-builder in multilateral negotiations; yet in the space of just a few years, it has come to be associated with diplomatic volatility and environmental destruction. If we are going to manage the increasingly disruptive effects of climate change, collective intelligence must prevail over populist division and disinformation. Some countries are already showing the way. In Australia, for example, voters

that had become one of the most obstinate climate laggards in the G20. And in Slovenia, a populist prime minister was denied a second consecutive term when his party was defeated by the environmentalist Freedom Movement party. As in many countries around the world, social movements in Brazil have been organising on an unprecedented scale. Groups from the Amazon - especially those representing traditional communities, women, and young people - are leading the charge, and others, including financial and private-sector players, have joined with them. An international system subverted by populist priorities would be catastrophic for open societies and effective climate policies. Those of us who believe in science, the wisdom of local communities, and the power of diplomacy must get wise to the threat. If populism is normalised, it will derail effective climate action just when it is needed most. Climate policies have become populists' most inviting target; the rest of us must become populists' most formidable adversaries.

Cachinnatory

Cachinnatory refers to loud or immoderate laughter. Though this may seem to be celebrating boisterous high spirits, it dates from the early nineteenth century, at a time when gentlemen in England did not laugh out loud, at least not in public. It has about it a sense of the distaste we feel when persons nearby are carousing too loudly for comfort. That master of the second-rate novel. Sir Edward Bulwer-Lytton, was a great user of the word and illustrated its exuberance in his Paul Clifford of 1842: "If Paul's comrade laughed at first, he now laughed ten times more merrily than ever. He threw his full length of limb upon a neighbouring sofa, and literally rolled with cachinnatory convulsions; nor did his risible emotions subside until the entrance of the hung-beef restored him to recollection". It also appears in Fan by Henry Harford, published in 1892, in which the heroine is visiting London Zoo: "The laughing jackasses laughed their loudest, almost frightening her with their weird cachinnatory chorus". The Romans clearly knew of this unrestrained outpouring of immoderate humour, since the word is from Latin cachinnare with the same sense.

Cacoethes

An English word starting with a kak sound suggests something bad or Aunpleasant, by analogy with words such as cacography for bad handwriting and cacophony for a horrible discordant noise. These join a plethora of medical terms, mostly long obsolete, that include cacothymia, a disordered state of mind, and caconychia, decaying nails.) Cack, dung or faeces, is a distant relative. Cacoethes is of the same sort. It's an uncontrollable urge to do something, especially something harmful. The first part is from Greek kakos, bad. To it has been added ethos, a disposition, making a word for a bad habit. It arrived in English unchanged via Latin. It's almost, but not quite, as rare as some of those medical terms. appearing sporadically in prose of the more elevated or pretentious sort. In a dictionary of quotations of 1808, D E Macdonnel commented that cacoethes was never written alone, but always in combination with some other word. That's not true today, but one of his phrases is a Latin tag still known and quoted: cacoethes scribendi. It's from the Satires of the Roman author Juvenal: "Tenet insanabile multos scribendi cacoethes": in English. "many suffer from the incurable disease of writing". Aspiring wordsmiths should note that an uncontrollable urge to write doesn't necessarily lead to anything worth reading. Macdonnel also listed the vastly less common cacoethes loquendi, a compulsive desire to speak, where the second word derives from Latin loqui, to speak (also the source of loquacious); and cacoethes carpendi, where carpendi is from Latin carpere, to pick, pluck or seize. He defined this as a rage for collecting, but more usually it has been an irresistible desire to criticize or find fault.

IF POPULISM IS NORMALISED, IT WILL DERAIL **EFFECTIVE CLIMATE ACTION** JUST WHEN IT IS **NEEDED MOST**

populist politicians have increasingly positioned themselves as climate doubters and delayers, and this new approach is proving to be quite insidious. By slowing effective action, the tactics of today's populists

are becoming an existential threat. This trend is reversible, but it is tenacious. Following former US President Donald Trump's dismantling of America's climate commitments, the Biden administration has managed to pass landmark climate legislation despite notable headwinds. But opportunities for populist climate spoilers remain. A recent study in 'Nature' shows that, even though supporters of climate policies vastly outnumber their opponents nationwide, most Americans believe the opposite to be true. Given this "false social reality," the climate legislation promises to be a wedge issue in November's midterm elections.

Perhaps even more significant is Brazil, where reactionary populism threatens to become normalised under President Jair Bolsonaro. It is no coincidence that Steve Bannon, Trump's former chief strategist, sees Brazil's election as an inflection point for the international system: in his words, the "second most important election in the world."

There are multiple reasons why climate action is an especially appealing target for aspiring and incumbent authoritarians, but none has anything to do with the climate itself. The first reason is the perceived cost. Even though decarbonising and building more resilience into the economy will ultimately be much cheaper than covering the costs of a runaway climate crisis, such outlays will forever be exposed to political opportunists' bad-faith attacks.

Moreover, populists will smear policies geared toward international accords like the 2015 Paris climate agreement as an abdication of sovereignty. It is no surprise to see Brexit architect Nigel Farage now agitating for a referendum on the United Kingdom's stated commitment to achieve net-zero emissions. A simplistic notion of national sovereignty has also underpinned Bolsonaro's refusal to discuss the Amazon in international fora, even though its role as a carbon sink is vital for the rest of the world. Bolsonaro's failure to fight criminal activity in the Amazon has allowed for the wanton destruction of Brazil's forests, rivers, and people. As is true of other right-wing populists, "sov-

New Delhi, Oct 2: Eight per cent of the rural households in the country receive water only once a week, while about 74 per cent of them receive it all seven days, according to a new government study. The national study conducted by

the Jal Shakti ministry released on Sunday has revealed that about four per cent of households receive water for 5-6 days in a week and 14 per cent receive at least 3-4 days in a week. "Close to three-fourths of the

HHs (74 per cent) received water all 7 days a week. Out of the remaining 26 per cent, 4 per cent received water for 5-6 days in a week, 14 per cent received at least 3-4 days in a week, and the balance 8 per cent received water only once

a week," the study said The average duration per day supply has been found to be three hours. Four out of five (80 per cent) households reported that their daily requirements of water are being met by the household tap connections, the study claimed.

Among the households without working tap connections, eight states, including, Jharkhand, Chhattisgarh, and Uttar Pradesh had a higher proportion of households where tap water was not available. At least six states had than 30 per cent households which had not had tap water in last seven days Under the 'Har Ghar Jal' vil-

lages, 91 per cent of the households were found to have a working tap connection on the day of the survey, which is relatively higher

than the overall national proportion (86 per cent). Of these, 88 per cent received ad-

equate quantity (55 litres per person per day of water), 84 per cent received a regular supply, and 90

per cent received potable water through household tap connections.

Among the aspirational districts covered in this assessment, 78 per cent of the households were found to have a working tap connection on the day of the survey, which is relatively lower than the overall national proportion (86 per cent).

Of these, 85 per cent received adequate quantity (>55 LPCD of water), 77 per cent received a fully regular supply, and 88 per cent received potable water through household tap connections. Overall, 62 per cent of the households were found to have a fully functional tap connection, it said.

For the study, a total of 13,299 villages were surveyed, of which 11 per cent were SC-dominated villages and 23 per cent were domi-

nated by the STs. Functionality of household tap connections is defined under JJM as household taps having infrastructure for providing water in adequate quantity (at least 55 LPCD), of prescribed quality on a regular basis.

Out of the 3,01,389 households sampled for the assessment, water was not available in 42,238 households on the day of the survey. The on-site testing and lab test results of the water indicates that more than 4 out of 5 households (87 per cent) of the sampled households in the state received potable water. Punjab, Tripura, Bihar, Goa, Kerala, West Bengal, Arunachal Pradesh, and Puducherry were found to provide more than 55 LPCD of water in more than 95 per cent households.

Customs on high alert in TN

Chennai, Oct 2: The Customs and Central Excise are on a high alert in Chennai, Madurai, Tiruchi, and Coimbatore airports after the cases of smuggling gold showed an increase.

The Central Industrial Security Force (CISF) arrested a part-time worker at Chennai airport on Saturday with 1.9 kg of gold worth 83.86 lakh. The contract worker belonged to a private agency and was in charge of the restroom. CISF found that he was taking out 12 gold bits hidden in the cleaning mop and some inside the sole

of his shoes A couple of days ago Chennai air customs arrested two passengers with 483 grams of gold and 50 cartons of cigarettes. The men had arrived from Dubai and were apprehended.

Customs officials said that in Tiruchy, Coimbatore, and Madurai airports there were also seizures of gold in the past couple of days with most of the gold coming from the middle eastern countries.

A senior official said, "The culture of carriers bringing in gold through international airports in Tamil Nadu seem to have increased and the department has got some inputs on an organised network behind this.

"Customs have taken all the precautions to prevent smuggling of gold. We have directed the companies to be vigilant about the sup-

An FIR under IPC sections 222 (Intentional omission to apprehend on the part of public servant bound to apprehend person under sentence or lawfully committed), 224 (Resistance or obstruction by a person to his lawful apprehension) 225 A (Omission to against errant police officials.

Punjab Director General of Police Gaurav Yadav said the CIA incharge has been arrested while asserting that no laxity will be tolerated. He said police teams have fanned out to nab Tinu.

Earlier in 2017, Tinu, who faces several cases including murder and extortion in various states, had escaped with the help of another gangster and his aide from Harvana after throwing pepper spray in the eyes of a police official. Later in December that year, he was arrested by the Bhiwani police from Bengaluru.

According to some studies, around 174 lakh persons are bitten annually worldwide and more than 55,000 people die annually of the disease

In India, dogs are rein wild and some domestic anisponsible for about 97 per cent of human rabies, followed by cats (2 per cent), jackals, mongoose and others (1 per cent). The disease is endemic throughout the country.

"Bites by all warm-blooded animals necessitate post-exposure prophylaxis. As rabies is practically 100 per cent fatal, bites by dogs and cats in particular must be considered as a 'medical emergency' and the 'life-saving' post exposure prophylaxis must be provided immediately," say the National Guidelines for Rabies.

The National Rabies Control Programme was approved to address the issue of rabies in the country during the 12th Five Year Plan as Central Sector Scheme to be implemented under the Umbrella of NHM with two components -Human and Animal Components.

The Human Component for the rollout in all States and UTs through nodal agency NCDC, and Animal Health Component for pilot testing in Haryana and Chennai through the nodal agency, Animal Welfare Board of India.

The Human Health Component has been rolled out in 26 states and UTs. Rabies is almost always fatal for human if post-exposure prophylaxis is not administered immediately after the bite.

It infects the central nervous system, ultimately affecting the brain and resulting in death.













'Kamalabai' vs 'Penguin Sena' Maha calling: Greet with

Mumbai, Oct 2: The bitterness between the Uddhav Thackerayled Shiv Sena and the BJP appears to be growing by the day as leaders from both the parties are increasingly indulging in acerbic attacks, with the former labelling the ruling outfit as 'Kamalabai' and getting the 'Penguin Sena' jibe in return.

The Thackeray faction has been calling the group of rebel lawmakers led by Chief Minister Eknath Shinde as 'gaddar' (traitors) and taunting them with '50 khoke (boxes)' remark, implying that each MLA of the Shinde faction got Rs 50 crore to switch loyalty.

Leading the attack against the dissidents is Aaditva Thackeray. who last month dubbed state Health Minister Tanaji Sawant as "khekda" (crab).

And this verbal exchange is expected to escalate further ahead of the crucial polls to the cash-rich Brihanmumbai Municipal Corporation (BMC), which both the warring sides are vying to win.

The Thackeray-led Maha Vikas Aghadi (MVA) government had collapsed June 29 this year after a revolt by Shinde and 39 other legislators against the Sena leadership. Shinde was sworn in as the chief minister the next day along with BJP's Devendra Fadnavis as his deputy.

The acrimony between the Thackeray-led Sena and the BJP has intensified ever since.

Of late, the Shiv Sena has started using the word 'Kamalabai' for the



'Kamalabai' is a reference to the Bharativa Janata Party's (BJP) poll symbol - Kamal or lotus, while the term 'Penguin Sena' is used by the opponents to deride the Thackeray-led Sena

Bringing penguins to Mumbai was a pet project of Aaditya Thackeray, son of Uddhav Thackeray and chief of Yuva Sena, the party's youth wing

This verbal war is not just limited to the Thackeray-led Sena and the BJP alone as the former has also been passing vitriolic remarks against the party's rebel legislators, who are now part of the state government

BJP. While Kamal is the election symbol of the BJP, 'bai' in Marathi means a woman. It all started after the Shiv Sena referred to the BJP as Kamalabai in its mouthpiece 'Saamana' last month. It riled the BJP so much that its

Mumbai unit president Ashish Shelar shot off a letter to Uddhav Thackeray, who is also the editor of 'Saamana', and asked him whether his faction be called as 'Penguin Sena'.

However, the Sena continues to address the BJP as Kamalabai and in return the latter addresses the Uddhav faction as 'Penguin Sena'. Addressing party workers in suburban Goregaon last month, Uddhav Thackeray attacked the BJP and said, "What is the relation between Kamalabai and Mumbai. I have used the word Kamalabai for the first time because I want to make them realise that this Shiv Sena is Balasaheb's Shiv

Sena. Kamalabai is not the word I coined, it is (Sena founder) Balasaheb (Thackeray) who did it."

The Uddhav Thackeray faction believes that although 40 MLAs and 12 MPs rebelled against the leadership, it is the BJP that engineered the split.

The term Kamalabai was mostly used by Bal Thackeray in private and was later used in 'Saamana'. Congress MP and senior journal ist Kumar Ketkar, who has seen the Shiv Sena from close quarters for over five decades, told PTI.

Even though the two parties were ideologically aligned on the issue of Hindutva, Bal Thackeray was never very fond of the BJP, he added. Senior journalist Prakash Akolkar said Bal Thackeray first used the word Kamalahai in 1985

In his book 'On My Terms', Nationalist Congress Party (NCP) chief Sharad Pawar says that when in September 2006, his daughter Supriva Sule's candidature was announced for the Rajva Sabha, Bal Thackeray called him up to offer his support. When Pawar said the Sena was in alliance with the BJP, his instant reply was - "Oh don't worry about Kamalabai (the BJP). She will do what I say.³

Akolkar said 'Penguin Sena' is a direct jibe at Aaditya Thackeray, who was instrumental in bringing penguins to the city zoo. The zoo is managed by the cashrich BMC, which the Sena controlled for over 25 years.

The project is criticised by the BJP and also by the Congress for high maintenance costs that it incurs.

A Government Resolution (GR) issued Saturday had appealed to Maharashtra government employees and officers to greet people by saying "Vande Mataram" instead of "Hello" during official or personal phone calls.

It is not mandatory, but the heads of departments should encourage their staff to do so, the GR said. It said 'Hello' depicted western

culture and the word did not have



any specific meaning. "The word is just a formality which does not arouse any emotion," the GR said. Greeting people by saying 'Vande Mataram" will create a feeling of affection, it said, adding that an awareness campaign should be conducted to promote it.

At the event in Wadha Sunday, Mungantiwar said, "If people want to say 'Jai Bhim' or 'Jai Shri Ram', or even mention their parents' names while answering a phone call...all forms are ok with us. Our appeal is to avoid saying Hello while receiving a call." During the

independence movement, a slo-

gan like "Inquilab Zindabad" (long live the revolution) was banned by the British rulers, he said.

"But, it inspired many people to join the (freedom) movement and eventually we got independence, Even Mahatma Gandhi had supported (chanting of) Vande Mataram and he had written so in a column published at that time," he said in a statement.

8 decades old paddle steamer restored

Kolkata, Oct 2: Built eight decades ago by a British company, a paddle steamer started its journey once again as a heritage cruise on the Hooghly river Friday, after it was restored and modernised.

The heritage vessel, 'PS Bhopal', the first of its kind in the Indian subcontinent, was unveiled in its new avatar before the Durga Puja festival by the Kolkata Port, now called Syama Prasad Mookherjee Port (SMP).



"This vessel which faced near death situation is now revived for the next 25 years. The main idea is to offer the ship to a private operator for its proper maintenance which had many challenges," port chairman Vinit Kumar said.

The renovated steamer which houses a marine museum on its lower deck with artefacts from across the country was thrown open for the public from the Manof-War jetty in central Kolkata.

It also has an AC hall with Burma teak and an open area on the top deck. Jaswant Singhee of Eastern Navigation, the private partner that refurbished the vessel for Rs 6 crore, thanked the port authori ties to be part of this unique project to restore the only historic paddle ship in the country.

This is Baghbazar Sarbojanin, the oldest community Durga Puja in the megapolis, known for its carnival-like atmosphere during the five days of worship of the Goddess.

ing Tharoor who was a prominent member of the grouping.

Kharge said all senior leaders and youth leaders urged him to contest the polls as no member of the Gandhi family -- Sonia Gandhi, Rahul Gandhi and Priyanka Gandhi Vadra -- wanted to become the party chief."All my colleagues told me to fight the party president poll and on their calling and encouragement, I got inspiration as they extended their cooperation...Because Sonia Gandhi, Rahul Gandhi, and Privanka Gandhi do not want to become president," he said. Kharge

asserted that he had not entered the poll fray to oppose anyone but to strengthen the Congress through his views and to take forward the party ideology.

He said that in line with 'one person, one post' principle of the party, he resigned as Leader of Opposition in Rajya Sabha on the day he filed the nomination. Kharge elaborated on his political journey of struggles and successes, and asserted that working for a party is not a part-time job but a full-time work.

"I have been working full-time. If I sat in Parliament then I would get up only in the evening at the time of shut down. It is my habit that whatever I take up, I work sincerely," he said. Asked about Tharoor's remarks that Kharge is a candidate of continuity and status quo, the Rajya Sabha MP said, 'He (Tharoor) may have his views...The status quo and reforms he talks of will be decided by the 9.300-odd delegates, after that a committee will be formed (Congress Working Committee). The committee as a whole will decide all policy matters that will be formulated by consensus and we will implement that.

Florida, Carolinas face daunting recovery after Hurricane Ian

Miami, Oct 2: The remnants of Hurricane Ian drifted through Virginia early Sunday, while storm-ravaged residents in Florida and the Carolinas faced a disaster recovery expected to cost tens of billions of dollars.

The storm's toll on human life also was expected to rise as floodwaters receded and search teams pushed farther into areas initially cut off from the outside world seeking stranded survivors and the remains of anyone who may have perished.

At least 50 storm-related deaths have been confirmed since Ian crashed ashore Florida's Gulf Coast with catastrophic force Wednesday as a Category 4 hurricane, packing maximum sustained winds of 150 miles per hour (240 km per hour).

Florida accounted for the bulk of fatalities, with 35 tallied by the sheriff's office in coastal Lee County.

Ukraine presses counteroffensive

Kyiv, Oct 2: Ukraine Sunday claimed full control of the eastern logistics hub of Lyman, Kyiv's most significant battlefield gain in weeks, providing a potential staging post for further attacks to the east while heaping further pressure on the Kremlin.

The stinging setback for Russian President Vladimir Putin came after he proclaimed the annexation of four regions covering nearly a fifth of Ukraine Friday, an area that includes Lyman. Kyiv and the West have condemned the proclamation as an illegitimate farce.

"As of 1230 (0930 GMT), Lyman is fully cleared," Ukrainian President Volodymyr Zelenskiy said in a short video clip on his Telegram channel. "Thank you to our troops ... Glory to Ukraine!"

Russia's defence ministry said Saturday that it was pulling troops out of the area "in connection with the creation of a threat of encirclement". It did not mention the city in its daily update on fighting in Ukraine Sunday although it said Russian forces had destroyed seven artillery and missile depots in the Ukrainian regions of Kharkiv, Zaporizhzhia, Mykolaiv and Donetsk. Russian forces captured Lyman

from Ukraine in May and had used it as a logistics and transport hub for its operations in the north of the Donetsk region. Losing it is Russia's largest battlefield loss since Ukraine's lightning counteroffensive in the northeastern Kharkiv region last month.

Serhiy Gaidai, governor of the Luhansk region that neighbours Donetsk, said control over Lyman could prove a "key factor" in helping Ukraine reclaim lost territory in his region, whose full capture Moscow announced in early July after weeks of grinding advances. Britain's Ministry of Defence de-

US, Oz, Japan vow to work together against China

Washington, Oct 2: The defense ministers of the United States, Australia and Japan agreed Saturday to boost military cooperation in the face of China's growing ambitions "to shape the world around it" Washington is pressing a diplo-

matic offensive to counter Chinese influence across the Asia-Pacific. "We are deeply concerned by

China's increasingly aggressive and bullving behavior in the Taiwan Strait, and elsewhere in the region," US Defense Secretary Lloyd Austin said as he welcomed his counterparts from

Australia and Japan to the US military headquarters for the Pacific region in Hawaii

"Our interest lies in the upholding of the global rules-based order. But we see that order under pressure in the Indo-Pacific as well, as China is seeking to shape the world around it in a way that we've not seen before," said Richard Marles, the Australian defense minister.

On Thursday, Washington announced an \$810 million aid package for Pacific Island nations where the United States plans to intensify its diplomatic presence. Vice President Kamala Harris traveled last week to Japan and



South Korea and said the United States would act without fear or hesitation throughout Asia, including the Taiwan Strait.

Beijing considers Taiwan to be part of China and also claims the thin and busy channel of water that separates the two.

Harris visited the demilitarized zone between the two Koreas. Her trip was designed to show Washington's commitment to defending South Korea against North Korea.

SUBMARINE DEAL

Austin also held a bilateral meeting with his Australian counterpart, focusing on a 2021 agreement between the United States, Australia and Britain that would provide nuclear-powered submarines to Canberra.

The Australian minister said delivery timelines would be a major factor in Canberra's decision -due to be announced early next year -- on which supplier to choose.

Rebel violence in eastern Congo causes hunger to soar

Nyiragongo (Congo), Oct 2: Hunger is soaring across parts of Congo's war-torn North Kivu province where the fighting between M23 rebels and government soldiers has been raging since November, according to aid workers, civilians, and health workers.

At least 26 million people more than a quarter of the population — acutely face food insecurity in large part because of violence. Economic fallout from the Covid-19 pandemic and war in Ukraine are also making things worse.

Only 10 per cent of those targeted by aid groups this year received the full recommended food assistance because of a lack of funds and security concerns restricting access.

Humanitarians warn that if the fighting continues, millions of people could face severe hunger.



"The situation was already dire and this conflict is just adding another layer and making everything worse," said Marc Sekpon, head of Congo's food security coordination body, a group

of international aid agencies focused on food security strategy and intervention.

During trips to three towns in Rutshuru and Nyiragongo in September, where nearly 200,000

The hospital has nothing to feed malnourished children, he says. And when it is able to provide families with nutritional supplements, parents sometimes sell it and use the money to feed the whole familv instead of giving it to their children, he said.

Doctors Without Borders said it's seen a 50 per cent increase in the admission of severely malnourished children in the hospital in Rutshuru town between January and July this year compared with the same period last year.

Inflation may ease next fiscal on normal rains: RBI report

New Delhi, Oct 2: Persistently high inflation remains a key policy concern for the Reserve Bank, which has raised rates aggressively so far this year, but the pressure might ease next fiscal assuming normal rains and further normalisation of global supply chains without any exogenous shocks, according to an RBI report.

The Reserve Bank of India (RBI) expects retail inflation to come under control at 5.2 per cent in the next financial year beginning April, down from 6.7 per cent it has forecast for the current year.

"For 2023-24, assuming a normal monsoon, a progressive normalisation of supply chains, and no further exogenous or policy shocks, structural model estimates indicate that inflation will average 5.2 per cent," RBI said in its 'Monetary Policy Report

September 2022'. The central bank is mandated to keep retail inflation in a range of 2-6 per cent. However, inflation has been above

the RBI's upper tolerance level since January 2022 mainly due to adverse supply shocks amid geopolitical tensions arising out of the Russia-Ukraine war since late February

Both the countries are key suppliers of foodgrains, edible oil, fertilisers and energy resources such as crude oil and natural gas.

Even as inflation has eased from its April peak of 7.8 per cent, it remains at unacceptably high levels, the central bank said in the report

Friday, the Reserve Bank hiked the key reporate by 0.50 per cent



to 5.90 per cent to bring inflation under control. During the May-August period of this fiscal, it raised the policy repo rate by 140 basis points or 1.4 per cent.

The six-member Monetary Policy Committee (MPC) of the RBI met four times during April-September 2022, including an off-cycle meeting in May, in the backdrop of a sharp jump in global commodity prices and uncertainties around the pace of monetary policy normalisation globally.

RBI Governor Shaktikanta Das, while announcing the policy, said the world already witnessed two major shocks of the pandemic and the Ukrainian situation over the last two-and-a-half vears and a third shock comes in the form of aggressive monetary policy ac-

tions by central banks globally. The RBI projects the inflation to remain above the upper tolerance level of 6 per cent through the first three quarters of 2022-23 (till December) and expects it to come under control from January 2023 onwards

For the January-March quarter of 2022-23, it has projected the retail inflation to average 5.8 per cent and further down to 5 per cent in the April-June 2023-24 period.

Even as the forecast for the next fiscal looks soothing, upside risks remain on a host of factors such as further ratcheting up of geopolitical tensions, higher crude and commodity prices, longer than expected supply chain disruptions and escalation in global financial market volatility due to aggressive monetary policy actions.

Shortfall in domestic kharif crop output, unseasonal rains or firming up demand may also add up to the upside risks.

"The downside risks could arise from an early resolution of geopolitical tensions," the RBI report said.

Further correction in global commodity prices due to slowing global demand, and improvement in supply conditions with the ebbing of the pandemic will help in bringing down inflation.

New Delhi, Oct 2: After infusing funds in the last two months, for eign investors turned sellers again in September and pulled out over ₹7.600 crore from the Indian equity markets amid hawkish stance by the US Fed and sharp depreciation in rupee.

With this, the total outflow by Foreign Portfolio Investors (FPIs) from the Indian equity markets has reached ₹1.68 lakh crore so far in 2022, data with depositories showed. FPI flows are expected to remain volatile in the coming months on slew of global and domestic factors, experts said.

"The UK government's expansionary fiscal policies amid elevated global inflation roiled the global currency markets and resulted in risk-off sentiment in equities." said Shrikant Chouhan Head - Equity Research (Retail), Kotak Securities. On the domestic front, there is some fuel related concerns, besides marginal drop in GDP estimates, he added.

According to the data, FPIs have sold equities worth a net ₹7,624



crore in September. This came following a net investment of ₹51,200 crore in August and nearly ₹5,000 crore in July.

Prior to that, FPIs were net sellers in Indian equity markets for nine months in a row beginning October 2021. Although FPIs started the month of September on a positive note, the pace of net flows was lower compared to August on the back of enhanced global uncer-

FPIs turn net sellers again Fuel sales surge on festive demand



New Delhi, Oct 2: Petrol and diesel sales in India jumped in September as economic activity picked up with the nearing festival season and the ending of the monsoon raised the demand, preliminary industry data showed

Petrol sales soared 13.2 per cent to 2.65 million tonnes in September when compared to 2.34 million tonnes of consumption in the same month last year. Sales were 20.7 per cent higher than Covid-marred September 2020 and 23.3 per cent more than pre-pandemic September 2019. Demand was, however, 1.9 per cent lower than the previous month of August 2022.

Diesel, the most used fuel in the country, posted a handsome 22.6 per cent rise in sales in September to 5.99 million tonnes when compared to the same month last year. Consumption was up 23.7 per cent over September 2020 and nearly 15 per cent higher than pre-Covid 2019. The fuel, which had seen a near 5 per cent drop in sales in August when compared to the previous month of July, saw demand rise 1.3 per cent month-on-month. Industry sources said the ending

of monsoon rains in most parts of the country and a pickup in agriculture season led to a rise in diesel demand. Rains usually restrict mobility and demand from the farm sector, which uses diesel in irrigation pumps and trucking.

Also, the approaching festival season led to a pick-up in economic activity and a rise in demand.

Auto fuel sales had dipped in July and August owing to the monsoon and reduced demand. This dip had come after a surge in June that was supported by increased summer travel to colder areas of the country to escape from the heat and vacations during annual breaks at educational institutions.

As the aviation sector opened up, India's overall passenger traffic at airports inched closer to pre-Covid-19 levels. Accordingly, jet fuel demand jumped 41.7 per cent to 5.44.700 tonnes during September when compared to the same month last year. It was 81.3 per cent higher than September 2020 but nearly 12 per cent lower than pre-Covid September 2019.

The sources said while domestic air travel is back to pre-Covid levels, international traffic is lagging because of continued restrictions in some countries.

Reliance Jio to launch 4G enabled laptop at ₹15,000

ONDC seeks public comments on issues

New Delhi: ONDC, a government entity to democratise e-commerce in India, has sought public comments on 24 issues pertaining to payments, fulfilment of orders, refunds and cancellations to build trust among network participants. Open Network for Digital Commerce (ONDC) has floated a consultation paper to seek views on steps it is taking to build trust so that more and more participants (buyer apps, sellers apps, payment gateways and delivery apps) take advantage of the fastgrowing e-commerce sector. "This is an open consultation. The last date for submitting responses is 31st October 2022," the 43-page paper titled - Public Consultation: Building Trust in the ONDC Network - said.

The laid-off employees were informed Friday that they would be paid for 45 days and that they would no longer be needed to report for work. "The crypto market has been in the grip of a bear market because of the current global economic slowdown," WazirX was quoted as saying in a statement.

"The Indian crypto industry has had its unique problems with respect to taxes, regulations and banking access. This has lead to a dramatic fall in volumes in all Indian crypto exchanges," it added.

One of the sources said "the workforce has been cut from several departments including customer support, HR, and other departments. Managers, Analysts, Associate Managers/Team leaders were among those laid off."

MAJORITY OF CONSUMERS YET TO RECOVER FROM THE PANDEMIC-LED SLUMP

Mumbai, Oct 2: That the rich got richer during the pandemic has become more evident with research data showing just 20 per cent of the population are leading the discretionary consumption wagon as the rest are still recovering.

The pandemic has not impacted affluent consumers' income levels in the country is clear from the fact that the top 20 per cent of the population account for the

bulk of discretionary consumption - 59 per cent in rural areas and 66 per cent in urban areas, Tanvee Gupta-Jain, chief economist at UBS Securities India, said in a report

Citing an in-house UBS survey (conducted in August among 1,500 higher-income consumers) results, she says more than half of the respondents have bought gold/ jewellery as planned or more in the past three months and more than half of them planning to invest in properties and buying cars/two-wheelers over the next two years.

That the rich will continue to drive consumption demand is clear from the UBS survey findings, with more than 70 per cent of respondents anticipating their income will increase in 2023. Similarly, nearly 70 per cent of

the respondents expect festive spending to rise, while 20 per cent expect stable spending on online shopping, healthcare, online entertainment, household consumables like groceries, food, etc. Spending on durables and education is likely to remain largely the same. Only 9 per cent expect a slowdown in their festive spending.

The survey also shows that 55 per cent of respondents want to buy a car and two-wheeler over the next two years. As much as 50 per cent of unique respondents are planning to purchase property over the next two vears (33 per cent for primary residence and 32 per cent for secondary/investment property), but



this is lower than 56 per cent in the last survey

According to a UBS analysis, during the pandemic, the formal sector gained market share at the cost of the informal economy as the rich continued to increase their spending on branded goods through online shopping, healthcare, online entertainment, and household consumables like groceries. food.

Across age groups, income expectations diverge, with younger age groups (below 44) being more optimistic than their elders (45-54 years) likely on improved labour market conditions in the organised sector, she said, adding that optimism about income growth and a better financial situation is a key metric to track for continued normalisation in household consumption The survey further showed that

nearly three-quarters of the respondents noted stable or increasing income levels (versus 54 per cent in the August 2021 survey) and only 23 per cent saw a decline in income since last year (versus 42 per cent in the last survey).
