Migrant's palm chopped

Paralakhemundi, Oct 3: In a barbaric incident, a migrant labourer of Kalaba village in Gajapati district had to lose his limbs when he asked for his wage to the agents who had engaged him at a factory in Uttar Pradesh.

The incident came to the fore Monday. Shanka Murmu of Kalaba village under Adaba police limits in Gajapati had gone to Uttar Pradesh September 13 on the assurance of four middlemen of his locality that he would get Rs 20,000 a month by working at a cement factory there.

However, what happened to Murmu after he asked for his wage couldn't have been more brutal.

"When I asked for money after working for almost a week, they (the four middlemen) got infuriated and chopped off my right palm and left foot," said Murmu, adding that they initially admitted him to a private hospital at Jhansi in Uttar Pradesh before abandoning him at his village.

They also threatened me of dire consequences if I dared to approach police against them," he said.

According to the state government data, 28,570 middlemen, who were registered under the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act 1979, have sent 13.43.972 labourers outside Odisha from 2013 to April 2022. However, Umi Daniel. director, migration & education, Aide et Action International, claimed that at least 25 lakh have migrated from Odisha

When contacted, Gajapati superintendent of police (SP) Jayaram Satapathy said that they have not received any formal complaint in connection with the incident.

District Labour Officer Loknath Panda said Murmu is undergoing treatment at Mohana community health centre. "Let him recover, we'll do the needful," Panda added.

Murmu's case is one among the many. It was sometime in December

2013, when a labour contractor of Andhra Pradesh chopped the right palm of Nilambar Dhangdamajhi, a 22-year-old tribal farmer from Kalahandi district, for not agreeing to his demand.

Umi Daniel, director, migration and education, Aide et Action International, blamed it on the poor implementation of antihuman trafficking laws.

Bhubaneswar, Oct 3: The Election Commission of India (ECI) Monday announced that the bypoll to Dhamnagar Assembly segment in Bhadrak district, which has been lying vacant following the death of BJP MLA Bishnu Charan Sethi September 19, will be held November 3.

According to the ECI, a gazette notification in this regard will be issued October 7.

"The last date for filing nominations by candidates is October 14. While October 15 has been set as the date for scrutiny of the nominations, the last date for withdrawal of candidatures has been fixed for October 17," as per the ECI.

It said the voting will be conducted November 3. While November 6 has been fixed for the counting of votes and announcement of results, November 8 has been set as the date for the completion of the election process.

With the ECI announcing the date for the bypoll, three major political parties—BJD, Congress and BJP—Monday said that they were fully prepared for the byelection.

The bypoll was necessitated by the death of BJP MLA Bishnu Charan

Bhubaneswar, Oct 3: Ruling BJD MLA and former minister Bijaya Ranjan Singh Bariha died at a private hospital here Monday, his family said.

Bariha, a five-time lawmaker from Padampur assembly constituency in Bargarh district, was 65 years old. He was admitted to the hospital with kidney-related ailments and later put on a ventilator as his condition deteriorated, his son Brajraj Singh said.

He breathed his last around 1am and his body was taken to his assembly segment.

Chief Minister Naveen Patnaik and many other dignitaries condoled the death of Bariha. Bariha was the sixth legislator to have died after the 2019 elections.

Kolkata, Oct 3: A Durga idol in Kolkata in which the 'Mahisasura' was replaced by a crudely-crafted Mahatma Gandhi-look alike created controversy.

Akhil Bharatiya Hindu Mahasabha (ABHM), organisers of the puja near Ruby Crossing in southwest Kolkata, however,



changed the appearance of the idol

after a police complaint was lodged. 'The Durga idol here initially had a Mahisasura whose face looked similar to that of Mahatma Gandhi. The similarities are just a coincidence. After its photos went viral, a police team visited the pandal and asked us to change the face. We changed it," said ABHM state working chief Chandrachur Goswami.





ITMS on mishap-prone stretches soon

Bhubaneswar, Oct 3: The state government, in bid to check mishaps on major roads, is planning to implement Intelligent Traffic Management System (ITMS) in all the accident-prone stretches.

This was revealed during the State Road Safety Council meeting held recently under the chairmanship of Transport Minister Tukuni Sahu.

At present, ITMS named as Deesha is being implemented on 140 km stretch of National Highway 16 – from Rameswar to Panikoili. The Finance department has allocated Rs 175 crore for expansion of this scheme to other stretches, sources said.

It was decided at the meeting to request the Finance department to allocate funds every year for implementation of ITMS in all the vulnerable road stretches and near all the black spots, said

To detect traffic violators and provide emergency services to

the needy, highway patrol has already been rolled out in all the 36 mini stretches of the state. On an average 57 cases of traffic rule violations per month have been detected by each patrol team during January to June 2022.

The team found that all these 36 mini stretches are highly vulnerable to mishaps. The Police department has been asked to ensure improvement in the enforcement activities, the sources said.

cided to relocate one or two highway patrol vehicles to Manguli-Malipada stretch.

Similarly, in order to stop unplanned growth on NH, the government is planning to relocate the commercial clusters or amenities like dhabas, shops and other roadside vendors to a safer distance on the back side of NH with approach roads.

In this context, it was decided to examine shifting of the godowns from cities to the outskirts in future. Food Supplies and Consumer Welfare and Housing & Urban Development departments have been requested to take action in this regard.

It was known from the meeting that though 5,21,449 number of traffic violations were detected by the police during January to June 2022, only 23,294 driving licences (DLs) were forwarded to RTOs for suspension which is only 4.46 per cent of the cases detected. Crime Branch has been asked to ensure that DLs of all the offenders are suspended.

During the same period, though RTOs have issued 1,29,794 e-challans for various road safety violations only 24,692 DLs of the offending drivers have been suspended, which is only 19.02 per cent of the cases detected. The road safety council emphasised on improvement in the cases.

During winter, the number of accidents rises during night hours due to dense fog. To avoid such type of accidents, stringent action will be taken against the owner of the vehicles that do not use/fit backlight and reflective tapes, the sources said.

This drive will commence from October itself. The State Truck and Bus Owner's Associations have been directed to persuade the vehicle owners to put backlight and reflective stickers and not to park the vehicles on roads

State logs 67 fresh Cov cases, 2 deaths

Bhubaneswar, Oct 3: The state's Covid-19 tally rose to 13,34,434 Monday as 67 more people, including seven children, tested positive for the infection, a health bulletin said.

The death toll rose to 9,197 as two more persons from Puri and Mayurbhanj districts succumbed to the disease, it said.

Besides, 53 other coronavirus patients have died due to comorbidities so far, the bulletin said. The state had recorded 131 in-

fections and a fatality Sunday. Odisha now has 1,148 active cases, while 13,24,036 patients have recovered from the dis-

ease, including 193 in the last 24 hours. The daily positivity rate was at 1.06 per cent as the new cases were

detected from 6.351 samples tests. Meanwhile, India logged 3,011 new coronavirus infections tak-

ing the total tally of Covid-19 cases

to 4.45.97.498, while the active cases dipped to 36,126, according to the Union Health Ministry data updated Monday.

The death toll climbed to 5,28,701 with 28 fatalities which includes 20 deaths reconciled by Kerala, the data updated at 8am stated. The active cases comprise 0.08 per

cent of the total infections, while the national Covid-19 recovery rate increased to 98.73 per cent, the ministry said. A decline of 1,318 cases has been recorded in the active Covid-19 caseload in a span of 24 hours.

India's Covid-19 tally had crossed the 20-lakh mark August 7, 2020, 30 lakh August 23, 40 lakh September 5 and 50 lakh September 16. I

t went past 60 lakh September 28, 70 lakh October 11, crossed 80 lakh October 29, 90 lakh November 20 and surpassed the one-crore mark December 19.

The country crossed the grim milestone of two crore May 4 and three crore June 23 last year.

ED attaches couple's assets over ₹1cr in fraud case

Bhubaneswar, Oct 3: The Enforcement Directorate has attached movable and immovable properties to the tune of ₹1,05,68. 381 belonging to Bedabyas Barik and his wife Sarmila Panda who are accused of duping a Delhi-based lady of around ₹5 crore. The ED launched an investigation following the registration of a case in this regard by the anti corruption branch of Central Bureau of Investigation (CBI) here to ascertain the illegal monetary trail of the accused couple.

"Investigation was initiated under PMLA, 2002 on the basis of FIR No. RC-06(A)/2019-BBS (RC0152019A0006) registered by ACB, CBI, Bhubaneswar under Section 120-B r/w Section 409, 420, 465, 467, 468 & 471 of Indian Penal Code, 1860 and Sections 13(2) r/w



Corruption Act, 1988 (as amended)," informed ED in a press note

Investigation under PMLA revealed that Bedabyas during his tenure as the head cashier at the Cuttack Branch of Bank of Maharashtra between 2008-2012 persuaded the victim, Sukanti Barick to deposit money in various schemes like Recurring Deposit (RD) and Fixed Deposits (FD) of Bank of Maharashtra promising high returns against her investment. Subsequently, she deposited huge amount of money in the above

However, the accused did not invest the money in the victim's account and misled her by giving fake RD receipts / FDRs in lieu of the money received from her. He misappropriated the whole amount to the tune of ₹4.78 crore including interest against the de-

The ED sleuths also found that the accused had invested the amount fetched through illegal means for acquiring different assets in his and relative's name.

"Accordingly, the properties as acquired by the accused using the proceeds of crime, as identified during investigation, have been attached under Section 5(1) of PMLA, 2002," added ED.

Bhubaneswar, Oct 3: As human civilization is progressing forward, conflicts between human beings and other creatures existing in natural ecosystems are increasing by the day. Consequent to such conflicts, these creatures are getting reduced in numbers and their habitats are getting shrunk by the detrimental impacts of human activities.

This enchanting beats of drums are more than enough to make your feet tap and make the environment around durga puja pandals electrifying. Dhak beats are an integral part

of Durga Puja and this year when the festivities are back with a bang after two years of Covid curbs, the dhakis (drummers) from various districts of Odisha mostly from Puri and Cuttack districts have turned up here in large numbers with the hope to earn something substantial.

Covid has hit the livelihood of dhakis hard as they had not been able to earn a single penny during the festival for the past two

years. Some of them were doing some odd jobs to eke out a living while some others went for farm ing in their village.

Kashinath Nayak of Bilasuni, Niali in Cuttack district said that he and his family were coming to Bhubaneswar durga puja for the last 40 years but they had to suffer a lot due to Covid-19. "Since puja had stopped completely, we had to do farming to run the family. We used to earn around ₹30,000 by beating drums at puja pandals in Capital city," he added.

All the dhakis come from far away villages of the state. They look forward to the festival which comes only once a year with huge expectations. The Durga festival provides an alternative opportunity for these dhakis, said Sachinandan Nayak of Saheed Nagar Durga Puja Committee.

Nayak said Durga Puja festival is incomplete without the dhakis. "We offer them money and take care of their lodging and board-



ing expenses for full five days of festival. Most of the dhakis are generally farmers or daily wage earners and by playing at the puja they are able to earn some good money," he said. Some others also come to the city

Ailing tusker dies in Mayurbhanj forest

ELEPHANT DEATH IN THE DISTRICT WITHIN A FORTNIGHT

Baripada, Oct 3: There is no let-up in elephant deaths in the state as yet another tusker succumbed to a wound on its leg at Mashinakati reserve forest under Betanoti forest range in Mayurbhanj district, Monday.

This is the third elephant death within a fortnight in the district after the death of two calves at Nato forest under Kaptipada forest limits under Bangiriposhi forest range. The tusker aged within 35 to 40 years was ailing for the last few days due to a deep wound it had developed on its front left leg. A team of veterinarians had conducted a surgery on the leg, Sunday morning. However, it did not show any sign of improvement and died a few hours after the surgery, Monday.

The matter came to fore after Forest officials recovered the carcass, Monday. It is suspected that the animal might have died due to wrong treatment and high dose of anesthesia administered to it before conducting surgery. Baripada DFO Santosh Joshi, deputy director Samrat



Gouda of Similipal Tiger Conservation Proiect, ACF Rabi Narayan Mohanty, Ranger Ghanshyam Singh, Gaja Sathis, forest officials and members of green brigade were present.

Environmentalists and animal lovers have alleged that the animal died of septicemia after infection from its wound spread to its whole body.

The veterinarians have conducted a post-mortem of the carcass and sent the samples collected from the carcass for laboratory examination to ascertain the actual reason of its death.

Reports said that the tusker was found roaming alone at Dumapada, Khadishola, Kanchannagar, Mashinakhati and Tungadhua areas under Betanoti forest range after getting separated from its herd.

A thick plastic rope laid as a trap to ensnare wild animals for poaching was coiled around its front left leg when the animal was wandering aimlessly in the forests. A deep wound developed on its leg after it failed to free

itself from the rope. The pachyderm failed to walk properly as the wound spread further and became septic giving out stink. Moreover, blood continued to ooze out from the wound.

Betanoti forest officials noticed the animal during patrolling and informed their higher-ups. A team of doctors Brajaraj, Rudranarayan Mohapatra from Wildlife Trust of India, Indramani Nath from OUAT, Piyush Soren from Similipal Tiger Reserve huddled together and conducted a surgery. Sunday morning. However, the animal failed to recover and died.


A case was registered in this connection and all the 10

Berhampur truck terminal remains a non-starter

Chhatrapur, Oct 3: Construction of a proposed truck terminal on Berhampur outskirts has remained a non-starter as the land identified for the project is yet to be handed over to the state Commerce and Transport department.

Reports said that Berhampur city and its outskirts witness regular traffic snarls as hundreds of trucks carrying cargo from various parts enter Berhampur town daily for delivery at

Moreover, hundreds of trucks also visit the godown of Food Corporation of India at Jagannathpur on the city outskirts for loading and unloading of cargo. Similarly, goods train carrying fertilizer and wheat also arrives at Jagannathpur railway station. The goods are loaded in trucks from here and transported to various blocks in Ganjam. Trucks traveling to Berhampur city, Jagannathpur FCI godown and railway station ply on the National Highway-16 connecting the city. As a result, hundreds of trucks can be seen parked on the highway. This leads to regular traffic snarls and accidents.

Realising the situation, the department decided to construct a truck terminal on Berhampur outskirt. The state government also gave its approval to the project. Around 14.661 acre land was identified as Girisola mouza under Chikiti tehsil for establishment of the truck terminal.

The department also informed the Chikiti tehsildar on the development no steps were taken to handover the land to the department.

Later, the department again wrote a letter-2261, May 11 to the Berhampur subcollector and urged him to direct the Chikiti tehsildar to handover the land.

Sources said that the land identified at Chikiti tehsil is held in the name of Finance department. Later, the district administration wrote a letter to the Principal Secretary, Finance de partment and urged him for transfer of the land in the name of state Commerce and Transport department.

olarisation is fast becoming the order of the day across the globe and now it is Brazil's turn to experience it in the ongoing bitterly fought and scurrilous Presidential election. With the high stakes, campaigning rose to such an acrimonious pitch that the Far-right incumbent Jair Bolsonaro called his arch rival, Left-wing candidate and former President Luiz Inácio Lula da Silva "a thief," while the latter dubbed him a "mad man." But the results, after over 99 per cent of the votes cast were counted, show there is no clear winner, though Lula's vote share is 48.4% against Bolsonaro's 43.2%. According to Brazil's electoral system, if the winning candidate fails to get over 50 per cent of the ballot, there will be a second run-off. Hence, the decisive battle for the Presidency will be fought on 30 October when the electorate will give their final verdict on who will be their next President.

Exuding confidence, Lula has used a football metaphor to strike a chord in the hearts of the soccer-crazy nation. Soon after the results were announced he said the run-off "is simply extra time" when two soccer teams are made to play for 15 more minutes to score the winning goal. "We will rest for 15 minutes and then get back out on to the pitch to score the goals we did not score in normal time," he said. His task is now to convince the voters to give him 2 per cent more votes than he has secured.

At this stage the battle is delicately poised. Winning outright in the first round was always going to be difficult for any candidate. The last time it happened was 24 years ago. Incumbent President Bolsonaro and Lula had tried to convince the electorate that they would not need the run-off election. For the 76-year-old Lula surging ahead of Bolsonaro is indeed a remarkable comeback. He could not run in the 2018 election because he was in prison after being convicted of corruption charges. But the ruling was later annulled. Lula was pronounced not guilty and the judge, who had ordered prison term for him, was slammed for showing animus against him.

The current results have shown the pollsters were wrong in writing off Bolsonaro who has got back his confidence to clinch the issue in his favour. He became so nervous before the polls that he made wild allegations about possible manipulation of the electronic voting machines and even threatened that if he lost the race there would be frightful consequences. This was a hint that he would try to hang on to power the way his favourite, former US President Donald Trump, had attempted through violence by his supporters at the Capitol Hill. The fact that he is now silent on his fears of possible electoral fraud and threat not to accept the verdict shows he is highly encouraged by the poll outcome. This is because Brazilian society seems to be nearly vertically split between Left and Far-right supporters.

One major reason for Lula bouncing back is the ruthless exploitation of the Amazon rainforest during the tenure of Bolsonaro. The latter is for opening up the rainforest for economic exploitation. There are allegations that his government allowed illegal trade in timber. Deforestation and forest fires have soared during Bolsonaro's term in office. Climate activists have warned that if he is re-elected, the area could reach a tipping point. Voters in Brazil have many other pressing concerns such as rising food prices, which have contributed to an increase in poverty and hunger. Bolsonaro acknowledged these concerns in a statement after the results were out. "I understand that a lot of the vote was down to the situation the Brazilian people are in. I do understand that there is a desire for change but some change

Bolsonaro's handling of the COVID-19 pandemic has been so bad that over 700,000 lives were lost. He called it "a little flu" and relied on quacks. This antagonised a sizable number of the electorate.

Though Lula has an edge over Bolsonaro, the final outcome may go either way, given the sharp polarisation evident from Donald Trump's exhortation of the voters to choose Bolsonaro.

Cacography

We should use this word for bad handwriting or bad spelling more often, it's too useful and relevant to let it fade away. It derives from the Greek graphos, "writing", prefixed with kakos, "bad". We're more familiar with this as the beginning of cacophony, "bad noises" (despite the association of ideas, it has nothing to do with our cack-handed, which derives from Old English cack, "excrement"). When cacography began to appear in English at the end of the sixteenth century it did so with the sense of "bad spelling". It was beginning to be thought that the old way of spelling words by personal preference ought to give way to a standardised system; the introduction of printing had a lot to do with this. So cacography was seen as the opposite of orthography, "correct spelling". In the following century cacography was used to mean bad handwriting as well, as the opposite of yet a third Greek word, calligraphy, "fine writing". The word is marked as archaic in my dictionaries, though it still turns up from time to time. A typical usage was that by the horror writer H.P.Lovecraft, who described the manuscript of his novel Quebeck as "136 pages of crabbed cacography" (in reference presumably to the handwriting rather than the spelling). Someone who exhibits either failing

f ever any person justified this epithet for a man who behaves dishonourably, especially towards a woman, it was Major-General Sir Harry Paget Flashman, VC, KCB, KCIE. George MacDonald Fraser, who died in January 2008, borrowed the fictional bully of Tom Brown's Schooldays and made him the hero of a series of novels. Their conceit was that Flashman ended his life as a famous and highly decorated soldier, though by his own admission he had throughout been a scoundrel, cheat, lecher, poltroon and cad. Cad is the classic British contemptuous epithet of the nineteenth century. It appears, for example, in Jerome K Jerome's Passing of the Third Floor Back: "That you and your wife lead a cat and dog existence is a disgrace to both of you. At least you might have the decency to try and hide it from the world not make a jest of your shame to every passing stranger. You are a cad, sir, a cad!" Its history is as weird as one might like. The word started life as cadet, either a military trainee or a member of a younger branch of a family. That developed into caddie, now solely a golfer's bag carrier, but in the eighteenth century any lad or man who hung about in the hope of getting casual work as an errand-boy, messenger or odd-job man. Both cadet and caddie were shortened to cad. Early on — for reasons unknown — it had the sense of an unbooked passenger who had been picked up by the driver of a horse-drawn coach for personal profit. By the early 1830s, it had come to mean the conductor of one of those new-fangled London omnibuses, the man who rode inside to take the fares. Might the job have been one that was taken as casual employment by caddies? In 1895, George Augustus Sala commented in London Up to Date: "An omnibus conductor, nowadays, would, I suppose, were the epithet of 'cad' applied to him, resent the appellation as a scandalous insult; and, indeed, 'cad' has come to be considered a term of contempt, now extended to any mean, vulgar fellow of whatever social rank he may be." The shift seems to have happened at the university of Oxford. Lads from the town who hung about colleges in the hope of casual work of the caddie type were called cads by the undergraduates.

THE COST OF FREE FOOD

A DIRECT CASH SUBSIDY OF A FIXED AMOUNT **DOES NOT PROTECT THE RECIPIENT FROM FOOD INFLATION**

s the right to food a statutory right, a fundamental right or a human right? India is a signatory to the 1966 International Covenant on Economic, Social and Cultural Rights from which the right to food is derived. So, this right has elements of being a human right, beyond sovereign borders. India's own National Human Rights Commission (NHRC) has held it to be a fundamental right, linking it to Article 21 of the Constitution (right to life with dignity) along with Articles 39 (a) and 47. These latter both part of Directive Principles, require the State to provide a right to adequate means of livelihood (Article 39 (a)) and a duty to raise the level of nutrition and standard of living (Article 47). The Commission has said that starvation is tantamount to denial of fundamental rights. It also said that proof of starvation need not mean starvation deaths. The crisis has to be recognised much earlier. The NHRC called for a paradigm shift in public policy, and to ensure adequate food and nutrition to all citizens as paramount objective. The prevalence of hunger and distress is to be interpreted as injury and requires that the State be penalised for such a state of affairs. In short, even if it costs a lot to the exchequer, removal of hunger should be a top policy priority.

This view of the NHRC is important in light of the government's recent decision to extend the free food grain programme for another three months. That extra cost will be ₹44,000 crore. The Pradhan Mantri Gareeb Kalvan Anna Yojana (PMGKAY) would be the longest running and largest free food distribution scheme in the world, running for 33 months and more if extended beyond December.

The right to food as recognised by India's international obligation, since it is a signatory to the International Covenant does not mean that the food should be given free. But a situation of grave distress manifested through starva-

tion deaths implies that free food is an imperative. Twenty years ago, the right to food campaign started in India as an offshoot of a PIL in the Supreme Court. That PIL was prompted due to the fact that State granaries then had gigantic stocks of food grain while there was evidence of starvation and malnutrition around the country.

One of the consequences of the sustained national campaign was that the National Food Security Act (NFSA) was passed in 2013. There were a lot of objections especially from fiscal hawks who were worried about the huge financial burden. There were objections from cabinet level ministers as well. The NFSA entitles each household 5 kilo per person per month of rice, wheat or jowar/bajra at 3, 2 or 1 rupees per kilo. One minister had quipped, that since it costs ₹20 to produce a kilo of rice, and ₹3 to get it under this Act as a right, why would any farmer bother to produce rice at all? This was not ridicule, but pointed to the heavy fiscal cost. The NFSA covers three fourth of the rural and half the urban population, i.e. nearly 81 crore persons. The poorest are given 35 kilo of food grain per family per month under the Antyodaya Anna Yojana. With a steep subsidy there is always the possibility that recipients sell the food in the secondary market. What the PMGKAY did was to extend the food grain completely free. If there was leakage under NFSA surely the possibility exists under PMGKAY too. How is that leakage to be prevented?

The PMGKAY was started in April 2020 because of COVID. India did not want a livelihood crisis to become a full-blown food crisis. It has served us well and at a time of food inflation it protects families from food price rise. A direct cash subsidy of a fixed amount does not protect the recipient from food inflation. But the scheme has been extended six times. The latest extension to December 2022 was given because of the upcoming elections in Himachal Pradesh and Gujarat. There is now ample evidence that PMGKAY has given electoral benefits to the incumbent political party.

Interestingly, the current extension was opposed by the Finance Ministry, owing to the higher fiscal burden. The extension alone will cost ₹44,000 crore. Cumulatively

PMGKAY has cost ₹4.5 lakh crore to the exchequer which amounts to 2% of India's annual GDP. Owing to rising oil prices the fertiliser subsidy is likely to go up to ₹2 lakh crore this year, although only ₹1 lakh crore has been budgeted. The Finance Secretary was sanguine and confident of meeting the fiscal deficit target this year, since tax collections have been very good. But his statement was made before the cabinet decision to extend PMGKAY. Also, the high advance taxes paid under income tax could lead to a big amount of refunds, which we will know only next year. The question then is to accommodate PMGKAY, will we be sacrificing something else? It was under fiscal pressure that the government had to launch Agnipath. the short-term military service scheme for non-commissioned personnel. Increase in support of free food means cutting back on maybe health, education, infrastructure, military or pension benefits. The government cannot escape these difficult fiscal tradeoffs.

If growth slows down, and tax collection is not as buoyant as expected, and if subsidy and welfare spending commitments increase, then how is the circle to be squared? Remember that interest rates are rising, so the cost of borrowing for the government too will go up. The debt to GDP ratio could rise to 95%. Interest burden alone could top ₹7 lakh crore or even higher. At the same time schemes such as free of subsidised food, free mid-day meals for school children, nutrition programme for pregnant mothers all have a human right and fundamental right element. The beneficiaries have a "claim" on these. India is also thinking of going in for universal basic income, which will add to the fiscal burden. How to weed out political corruption

THE REAL WEAPON TO TACKLE **CORRUPTION HAS NOT BEEN ACTIVE DUE TO THE PRESENCE OF A QUID PRO QUO BETWEEN** INDUSTRIALISTS, **BUREAUCRATS**, **POLICE AND POLITICIANS** ing new in the country, developments in the past two decades or so easily prove that political parties have lost all sense of ethics and morality. This has been so due to the close nexus between corporate houses and politicians, not just at the Centre but in states as well.

Recently, Delhi Chief Minister Arvind Kejriwal and his party AAP functionaries alleged that the BJP through 'Operation Lotus' was trying to poach Delhi and Punjab legislators by offering each of them ₹20-25 crore. Kejriwal alleged that the saffron party had so far poached 286 MLAs in different states and spent ₹7000-8000 crore on horse trading. "From where did they get this money? . . . this is the most corrupt (Central) government in the history of Independent India," he alleged. This does not necessarily mean that other political parties in the country are not entangled in grave corruption cases. The recent disclosures of cash, jewellery and land parcels involving around ₹110 crore and subsequent arrest of West Bengal's industry minister as also chairperson of School Service Commission is testimony to the fact of the gross irregulari-

Elections have been directly linked with a slew of illegal activities in various regions of the country. Revenues from corrupt practices eventually find their way into the coffers of political parties. It may be mentioned here that way back in 2000 the National Commission to Review the Working of the Constitution observed that electoral compulsions for funding had formed the cornerstone of the whole corruption system.

There is no general explanation for political corruption, the extent and the forms it takes vary consistently with the political environment. The degree and nature of corruption vary depending on the sort of regime under which it occurs. As is generally agreed by social scientists, the major cause of political corruption in India can be associated with elections.

The lack of active use of the Right to Information Act 2005 (RTI) by the Indian public encourages politicians to engage in blatant corruption. All anti-corruption units are directly controlled by the government, which may explain why ministers and lawmakers often obtain a free pass by pressuring

Commission has recently written to the Union Law and Justice Ministry proposing mandatory disclosure of all contributions received by political parties in excess of ₹2000, instead of the current threshold of ₹20,000, besides seeking the capping of cash donations to a party at 20% of total contributions received by it or ₹20 crore, whichever is less.

Election The Chief Commissioner, seeking to carry forward the EC's ongoing action against alleged financial improprieties by Registered Unrecognised Political Parties, recently wrote to the Law Minister mooting amendments in the election law and rules that require all parties, including recognised national and regional parties to maintain a higher level of transparency to curb the use of

black money in elections. Tackling corruption requires strong political will and dedication as well as good governance, administrative accountability, procedural facilitation and public engagement through public audit committees acting as watchdogs. But these are all on paper and the real weapon to tackle corruption has not been active due to the presence

The rise in political corruption ties in appointment of school teach-the anti-corruption units. Keeping of a quid pro quo between indusin the country is a daunting challenge. Though corified in written examinations in view this matter and also the close nexus between elections and politicians. The Indian government has made a few initiatives to tackle corruption at the federal level. Citizens can seek access to any public information under the RTI and they are bound to receive information within thirty days.

It has to be agreed that it is the judiciary that has played a significant role in dealing with corruption and exposing political and business leaders. There are landmark judgements in certain cases, which set a barometer. There is need to strengthen the judiciary through prompt settlement of cases and building judicial infrastructure.

It is also necessary that civil society organisations should come forward and organise sustained movements against corrupt political leaders so that their image is tarnished in the public eye. Unless resistance is organised from grassroots levels, it would be very difficult to bring down corruption. Over and above this, educated and sincere persons should enter political parties and bring about the muchneeded change. It goes without saying that increasing corruption affects the process of development and those who are marginalised and impoverished tend to suffer the most. Sooner the loopholes are plugged, the better it is.

No online betting ads: Centre

New Delhi, Oct 3: The Central government Monday advised the online news websites and OTT platforms to refrain from broadcasting advertisements of online betting

The government has noted that betting is an illegal activity and its advertisements can't be shown on digital news platforms in India.

The Ministry of Information and Broadcasting observed that promotional content and advertisements of betting platforms are still visible on certain news platforms and OTT platforms.

"It has also come to the notice of this Ministry that some online offshore betting platforms have started using news websites as a surrogate product to advertise betting platforms on digital media," said the ministry in an advisory to the digital media platforms.

The online advertisement intermediaries are also advised not to target such advertisements towards the Indian audience, said the Ministry.

'It has been observed that since betting and gambling are illegal, advertisements of online offshore



betting and gambling platforms are prohibited. In this regard, it may be noted that in accordance with the Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules 2021, advertisements of betting platforms, being an illegal activity, can't be shown on digital media,'

said the Ministry. In respect of the advertisements of the surrogate news websites operated by the online betting platforms, it may be mentioned that the logos of the concerned news websites are strikingly similar to the betting platform

The concerned betting platforms and the corresponding news websites are also not registered with any legal authority under Indian laws. noted the Ministry.

Accordingly, the online and offshore betting platforms appear to be promoting betting and gambling under the garb of news as sur-

JEE paper leak case: CBI detains Russian national

had booked Affinity Education Pvt Ltd and its three directors, Siddharth Krishna, Vishwambhar Mani Tripathi and Govind Varshney, besides other touts and associates for alleged manipulation of examination.

associates and touts, were manipulating the online examination of JEE (Mains) and facilitating aspiring students to get admission into top National Institutes of Technology in consideration of huge amounts by solving the applicants' question papers through remote access from a chosen examination centre in Sonepat

IAF inducts Made-In-India helicopter

Jodhpur, Oct 3: The Indian Air Force (IAF) Monday inducted the first fleet of indigenously-built Light Combat Helicopter (LCH), which has been developed primarily for mountain warfare after a requirement for it was felt during the Kargil war in 1999.

Developed by state-run aerospace major Hindustan Aeronautics Ltd (HAL), the 5.8-tonne twin-engine gunship chopper is armed with airto-air missiles, 20 mm turret guns, rocket systems and other weapons.

The fleet comprising four helicopters was inducted into the IAF at a ceremony at the Jodhpur Air Force Station in presence of Defence Minister Rajnath Singh, Chief of Air Staff Air Chief Marshal VR Chaudhari and other senior military officials.

The LCH would be an effective platform in hitting enemy targets. tanks, bunkers, drones and other as-

sets in high-altitude regions, military officials said.

In his address, Singh described the induction of the indigenously-built LCH into the IAF as a "momentous occasion" for India's defence production. "The IAF has been playing an important role in protecting India's sovereignty and I am confident that its overall capability will enhance further following induction of LCH," Singh said in his address.

"We have been focusing on boosting the country's defence production following certain developments.... Security of the country has been our foremost priority and it will remain so," he said.

The defence minister also complimented the IAF for reposing confidence in indigenously developed platforms. Air Chief Marshal Chaudhari said the capabilities of LCH are on a par with the helicopters of its class globally.

Mann govt wins confidence motion

The Assembly had taken up discussion on confidence motion, with AAP MLAs hitting out at the BJP over 'Operation Lotus', alleging a bid to topple the six-month-old government

Chandigarh, Oct 3 The Punjab Assembly Monday "unanimously passed the confidence motion moved by Chief Minister Bhagwant Mann September 27, even as Congress members staged a walk-

The BJP members have already announced to boycott the assembly

After a lengthy discussion on the confidence motion, Speaker Kultar Singh Sandhwan put it to vote. He asked MLAs to raise hands who were in support, and then asked those who were against the motion of confidence.

Announcing the results, Sandhwan said 91 AAP MLAs supported the motion.

He also said one of the three SAD MLAs who was present in the House and a lone BSP MLA did not oppose the motion.

No Congress, BJP or lone Independent MLA was present in the House at the time of voting. AAP has 92 MLAs, including

the Speaker, in the House. "So, 93 MLAs have supported

the motion and none is against it. Thus, the motion is unanimously passed," the Speaker said.

In the 117-member Punjab Assembly, the AAP has 92 members, Congress 18, SAD 3, BJP 2, BSP 1 while 1 is an Independent.

The assembly had taken up discussion on confidence motion, with AAP MLAs hitting out at the BJP over 'Operation Lotus', alleging a bid to topple the six-month-old gov-

The AAP had earlier claimed that at least 10 of its MLAs were ap-

proached by the BJP with an offer of Rs 25 crore to each of them in a bid to topple the Mann government under its 'Operation Lotus'.

However, as the discussion began, Congress MLAs staged a walkout, as they were demanding that the Speaker should allot them time to speak and raise issues during the Zero Hour.

The two BJP MLAs — Ashwani Sharma and Jangi Lal Mahajan -have been boycotting the session as they accused the AAP government of violating the Constitution by bringing the confidence motion in

Punjab debates stubble burning issue

Chandigarh, Oct 3: With the onset of paddy harvest and crop residue burning season in Punjab and Haryana, the debate on air pollution is again strife in the northwestern region, comprising the national capital.

However, what is different this winter and giving hope to affected citizens across the region is that instead of the annual inter-state political blame game, the Aam Aadmi Party-led governments, in the saddle in both Punjab and Delhi, can offer a coordinated solution to effectively tackle this problem, said climate and farm experts.

At a workshop organised in Chandigarh by Delhi-based Climate Trends Monday, experts from Panjab University and PGIMER Chandigarh and representatives from respective pollution control boards and farmers discussed the

ground solutions. Krunesh Garg, Member Secretary, Punjab Pollution Control Board, said: "Crop diversification is not the long-term solution, because it does not mean that biomass will not be produced by other crops." "It'll just be another kind of biomass waste, like from cotton and mustard coming from Rajasthan to Punjab. The issue with respect to the burning of this waste will always remain. So we need to find solutions, both in situ and ex-situ. A combination of these can only be effective.

"It's not that the problem is not being addressed, we are mapping it down to the block and village level, but it'll take 4-5 years for proper problem resolution," he added. Explaining that counting the number of farm fires is an inaccurate measure of understanding stubble burning, he said the acreage of land being put on fire is the parameter to be measured.

During the kharif season of 2022, paddy has been grown in approximately 31.13 lakh hectares, an increase from 29.61 lakh hectares

in 2021, resulting in 19.76 million ton paddy straw generation this year, vs 18.74 mn ton last year.

Adarsh Pal Vig, Chairman, Punjab Pollution Control Board, said: "There was a time when it was recommended to burn biomass waste. As we have mechanised more in the last few decades. the problem has increased." "The solutions will eventually have to be adopted by farmers because it is a social and a psychological problem where behaviour and attitude of farmers also needs to be addressed. We must highlight the stories of those farmers who have succeeded in not burning stubble and make sure they interface with

other farmers and encourage and motivate them." He noted that ambient air pollution is normally considered a problem only in cities even though the burning is being done in villages, as the National Clean Air Programme and the Air Quality Index are all focussed on

"Urbanisation and the exploding density of population in cities are beyond carrying capacity and causing a problem. Due to other contributing factors, big cities like Delhi are already sitting on a tipping point and stubble becomes that straw every season."

This year, the monsoon's weak onset and delayed progress in northwestern India and deficit pre-monsoon rains depleted the soil mois ture and delayed the sowing of the kharif crop. This already meant a delayed harvest which was further postponed by widespread and prolonged spells of rain during the end of September in many parts of northwestern India.

Nataraj Subash, Principal Scientist, ICAR-Indian Agricultural Research Institute, said: "We must focus on integrated farming which includes about three to four crops and livestock. We have 64 prototype models that are currently being tried out with a few farmers and the successful models have been sent to the government.

In Amritsar, farmers also blocked the Amritsar-Delhi rail track at Vallah, demanding stern action against the person responsible for the incident.

Addressing the gathering, General Secretary, KMSC, Sarwan Singh Pandher alleged: "The conspirator of the Lakhimpur Kheri massacre is still enjoying prime post while the innocent farmers present at the site of the incident have been sent to jail after regis-

tration of cases against them. Another farmer leader Gurbachan Singh Chaba said the success of the Delhi farmer's agitation was due to the sacrifice of 750 protesters and Lakhimpur Kheri 'martyrdom' was one of the most



significant among them.

Through today's rail roko agitation we demand that farmers should be released and killers of farmers should be hanged and appropriate action should be taken against those responsible for the Lakhmipur Kheri," said Chaba.

Bharati Kisan Union (Doaba) members staged a protest in Phagwara and demanded the sacking of Union Minister Ajay Mishra and withdrawal of "cooked up" cases registered against farmers during their stir against now-repealed agri laws.

They attacked the BJP-led gov ernment at the Centre over the continuation of Ajay Misra 'Teni' as a minister citing the alleged involvement of his son in mowing down of farmers protesting against the three farm laws that have now been repealed.

Led by BKU(D) vice president Kirpal Singh Moosapur and general secretary Satnam Singh Sahni, the protesters staged demonstration at Sugar mill crossing on national highway here, raised slogans against central government and Misra.

Communal clash in Guj town over displaying religious flag

Vadodara, Oct 3: Two groups clashed and hurled stones at each other over putting up a religious flag in Savli town in Gujarat's Vadodara district, a police official said Monday, adding 36 people have been arrested.

The incident occurred on Saturday night after a group of people objected to members of another community trying to put up a religious flag alongside their flag on an electricity pole in Dhamiji ka Dera locality, a local police official

"The matter escalated and both the communities started hurling

stones at each other. Nobody was injured but a vehicle and a shop were damaged by rioters," said sub-inspector AR Mahida.

Cross First Information Reports (FIRs) were lodged by both the groups late Saturday night, following which a case was registered for rioting, unlawful assembly, rash act endangering human life etc of the Indian Penal Code against 43 people, Mahida said.

A total of 36 people from both communities have been arrested so far. he said.

Police security has been beefed up in the communally sensitive area and the situation is under control, he added.



'Accountability of state in targeted violence rare'

Ahmedabad, Oct 3: Social activist Teesta Setalvad has said the country had rarely seen accountability of the state as far as targeted violence is concerned, and added that survivors and citizens supporting them are among the "fallout" of such violence.

Delivering the Girish Patel Smarnanjali Lecture here Sunday, Setalvad said the story of targeted violence begins with the build-up that is created with hate speeches and hate writings.

The survivors of such violence have to face difficulties in ensuring punishment for the perpetrators, she

"What is fallout? State accountability happens rarely in our country. How many people have been punished in (the riots of) 1984, 1992 and 2002? These are the questions before us. And the difficulties that survivors have to face to ensure punishment and citizens for supporting them are the issues that come up," she said.

Setalvad was recently arrested by Gujarat police in a case of the alleged fabrication of evidence to frame innocent people in the 2002 Gujarat riots cases in which a large number of people, especially those from the minority community, were killed. She was recently granted interim bail by the Supreme Court.

Setalvad said working on a deeply polarising issue among the public is not an easy one and added that



the impact of social media on polarization is also overwhelming.

"The people in power who are controlling social media are the same that have spent 70-80 years in the society, on the roads, among doctors, lawyers, and cultural organisations to capture them. Power is degenerative, but they have worked hard," she said.

The process being witnessed in the country is that of people perpetrating the violence and the party in power lending its support, and this has an old history, she said.

What happened after the demolition of Babri Masjid December 6,

1992, appears to repeat itself, she claimed.

'We saw a harking back to an earlier period. We need to understand the phenomenon as to what was happening in the country between 1986 and 1992, and what are we looking at now and what happened in between. Today, one also has to grapple with the media, which are carrying out a set agenda of targeting individuals and movements who have in any way threatened it,'

She said the buffer against polarisation and hate politics will build on its own if one is success-

the rights activist said.



Bomb scare on Iranian flight in Indian airspace



New Delhi, Oct 3: The Indian Air Force Monday said it scrambled its fighter jets after receiving information of a bomb scare on a Chinabound Iranian civilian plane that was flying over the Indian airspace.

An intimation was received of the bomb scare on an airline bearing Iranian registration, when it was transiting through Indian airspace, the IAF said, adding the plane was offered the option to land at Jaipur or Chandigarh but the pilots refused to divert.

According to ATC sources, the Mahan Air flight W581 was on its way from Tehran to Guangzhou in China when an alert was triggered. "IAF fighter aircraft were



scrambled, which followed the aircraft at a safe distance. The aircraft was offered the option to land at Jaipur and then, at Chandigarh. However, the pilot declared his unwillingness to divert to either of the two airports.'

"After a while, intimation was received from Tehran to disregard the bomb scare, following which, the aircraft continued on its journey towards its final destination," it said. Sources said the IAF was informed about the bomb scare by the Delhi ATC and then, Sukhoi aircraft were scrambled by the IAF. It is learnt that the IAF scrambled Sukhoi aircraft from its bases in Punjab and Rajasthan. Later, Iranian news agency IRNA, quoting a statement from Mahan Air, reported that the flight landed safely. The news agency said the statement was released in reaction to the news regarding

the bomb threat. "As soon as the pilot was alerted about the possibility of a bomb attack, he informed the control tower and requested an emergency landing in India," it said and added that such reports seem to be aimed at disturbing security and mental peace. Meanwhile, a senior Delhi Police officer said they received a call about the bomb scare on an Iran-China flight from the Air Traffic Control but soon they were informed by the ATC that the flight was not landing in Delhi.

The IAF also said that all actions were taken by the force as per the laid down procedure, jointly with the Ministry of Civil Aviation (MoCA) and Bureau of Civil Aviation Security (BCAS).

It is learnt that the ATC at Delhi airport remained in contact with the IAF when the aircraft was in

New Delhi, Oct 3: Delhi Environment Minister Gopal Rai Monday launched an advanced 'Green War Room' here to monitor air pollution and ensure effective implementation of the winter action plan to curb it.

The war room will work from the seventh floor of the Delhi Secretariat where a 12-member team comprising environment scientists and other officials will be deployed, the minister said while addressing a press conference here.

He said environment scientist Dr BMS Reddy will be in-charge of the war room while environment engineer NK Joshi has been ap-



pointed as assistant in-charge. "We have launched an advanced 'Green War Room' from today and it will work round the clock

"It will monitor air pollution levels 24X7 and ensure that all necessary measures are taken to curb pollution in accordance with the amended GRAP. The war room will also analyse pollution data of the city," Rai said.

Graded Response Action Plan (GRAP) is a set of anti-air pollution measures followed in the capital and its vicinity according to the severity of the situation.

Delhi Chief Minister Arvind Kejriwal had Friday announced a 15-point winter action plan to combat pollution in the city. Under the plan, the GRAP has been enforced in Delhi from October 1.

Five dead, 64 injured as fire engulfs Durga Puja pandal

Bhadohi (UP), Oct 3: Three children were among five people killed and 64 injured after a fire broke out in a Durga Puja pandal here due to overheating of a halogen light, officials said Monday. District Magistrate (DM) Gaurang

Rathi said the fire broke out around 9.30 pm Sunday when a halogen light at the pandal overheated, causing an electric wire to catch fire. Soon the fire engulfed the wooden scaffolding and the tent, he said.

The cause of the fire was ascertained by a special probe team constituted by Additional Director General Ram Kumar, he added.

A total of 67 people were injured in the fire and three of them --Ankush Soni (12), Jaya Devi (45) and Naveen (10) -- died. Later, Arti Chaubey (48) and Harshvardhan (8) died during treatment, a senior official said. Superintendent of Police Anil Kumar said an FIR has been lodged at Aurai police station against members of the concerned puja samiti as negligence was found in organising the event.

The FIR has been lodged under sections 304A (causing death by negligence), 337 (whoever causes hurt to any person by doing any act

Aurangabad, Oct 3: As many as 200 railway stations across the country will get a facelift with modern amenities, Railways Minister Ashwini Vaishnaw said here Monday.

He attended the foundation stone laying ceremony for a coach maintenance factory at the Aurangabad railway station in Maharashtra.

"Tendering process for 47 railway stations is completed while physical work has started at 32 stations," he said.

He said the railways is being transformed. "The government has prepared a master plan to revamp 200 railway stations. Overhead spaces will be created on the stations which will have world-class facilities including waiting lounges and food courts, besides amusement facilities for children." the minister said.

Vaishnaw also said that railway stations will act as the "platform" for the sale of regional products.

Speaking on the contribution of the Marathwada region in Maharashtra in the making of Vande Bharat trains, the minister said, "the country will have 400 'Vande Bharat' trains in future and 100 of these trains will be manufactured in the coach factory at Latur in Marathwada. The necessary changes in the factory are already being made".

SKELETONS MUST BE PULLED OUT TO PAY FOR SIN

he dead tell no tales but the skeletons of a bygone era must nevertheless be pulled out and bashed to pay for the sin of standing up to the rulers of the time.

The Supreme Court may have closed all pending petitions arising out of the 2002 Gujarat riots on the ground that the cases have become infructuous with the passage of time, but the political leadership of the period - now firmly ensconced in the Centre-continues to rummage the cupboard for revenge- wreaking relics.

After using an apex court ruling as justification, the Gujarat government had moved with lightning speed to set-up a Special Investigation Team (SIT) in June to arrest activist Teesta Setalvad, former Director General of Police RB Sreekumar and former IPS officer Sanjiv Bhatt for "conspiring to abuse the process of law by fabricating false evidence". Bhatt who is already in jail was brought out and re-arrested. Another ex-IPS officer Rahul Sharma was also summoned to record his statement though for the time being he has not been arrested.

The latest to face the axe is Gujarat cadre, IPS officer, Satish Chandra Verma. The officer who was part of the investigation team in the Ishrat Jahan fake encounter has been dismissed from service, the Union Home Ministry informed the Delhi High Court. He had petitioned the Delhi High Court against his charge-sheeting and allied matters in September 2021 which had directed the union home ministry against taking any 'precipitative steps'. Verma moved the Supreme Court which refused to stay the government order but told the Delhi High Court to hear his request November 22 and decide the case within three months.

When Narendra Modi took over as Chief Minister in Guiarat in 2001 he had summarily transferred five IAS officers for the perceived sin of being close to his predecessor and patriarch Keshubhai Patel. Three of them subsequently quit service. The tone was set. Those who dared to oppose him, even differed, were beset with problems. Take the case of DGPs (now retired), Kuldip Sharma and RB Sreekumar. Sharma, then additional director general of police,

CID, had August 1, 2005 sent a three page report to then then state Chief Secretary, Sudhir Mankad, recommending CBI inquiry against his own minister,



in this case Amit Shah in a cooperative bank scam. Sharma was immediately shunted out from the premier state investigation agency to the non-descript post of Managing Director, Gujarat Sheep and Wool Development Corporation (GSWDC). Sreekumar was sidelined and superseded for opposing Gujarat Assembly elections after the 2002 riots in his report to the then chief election commissioner, JM Lyngdoh. As chief of the state intelligence bureau he had reported Modi's speeches during his 2002 statewide 'Gauray yatra" as inflammatory. Sreekumar was charge-sheeted

and accused of leaking information to the media, all of which he challenged and won in courts. Sreekumar had filed detailed affidavits before the Nanavati-Shah judicial inquiry commission probing the riots. Sreekumar was arrested along with activist Teesta Setalvad in June this year and charged with criminal conspiracy and forgery regarding 2002 riots cases. While Teesta has been granted provisional bail by the Supreme Court, Sreekumar was provided temporary bail by the High Court September 29.

Shamima Kauser's efforts for justice for her daughter Ishrat Jahan who was killed along with three others in a fake encounter near Ahmedabad in 2004, fell by the wayside. College girl Ishrat and the three others, the police claimed then, were part of a lashkar-e-toiba terror module, out to assassinate Chief Minister Modi. The proceedings in the case were dropped in 2019 after the government declined permission to prosecute police officers DG Vanzara and NK Amin. Earlier in 2018 former Gujarat DGP PP Pandey was discharged from the case. The last three police officers, GL Singhal. Tarun Barot and Anaju Chaudhary were discharged in April last year. Apparently with the change in government at the Centre, the CBI decided against appealing the denial. However the same administra-

tion that refused to sanction prosecution of some, has the knives out for Verma. He was a member of the High Court appointed Special Investigation Team (SIT) which concluded that the Ishrat Jahan encounter was fake, after which the CBI registered a case against the police officers involved.

Within days of Modi becoming Prime Minister, Satish Verma and another Gujarat cadre IPS officer, Rajnish Rai were transferred out of the state. If Verma was shunted out as Chief Vigilance Officer of in North Eastern Electric Power Corporation Ltd, Shillong, Meghalaya, Rai was sent as CVO in the Uranium Corporation of India Ltd. (UCIL) at Jaduguda, Jharkhand.

If Verma's has been an ordeal by fire, Rai has been hounded mercilessly as well. Verma's 1100 page petition before the Guwahati bench of CAT, states, among other things,

that his services as CVO of NEEPCO were curtailed as he had red-flagged a Rs 450 crore transportation scam which also involved a relative of then minister of state(Home) Kiran Rijiju and for investigating a fraudulent land deal in Gujarat.

A bright IPS officer of the 1992 batch with a scintillating record of service, Rajnish Rai fell foul of the Modi establishment in Gujarat when he investigated the Sohrabuddin Sheikh fake encounter case and arrested fellow DIG DG Vanzara and IPS officers Rajkumar Pandian and Dinesh MN of Rajasthan cadre. It was his investigation that led to the arrest of former Gujarat Minister of state for Home, Amit Shah who is now the Union Home Minister. After Modi came to power at the Centre, not only were all the cases against officers arrested by him dropped, but these officers were rewarded with plum postings while Rai was put in the dock. Rai has taken voluntary retirement and joined the IIM, Ahmedabad as associate professor but the centre refuses to relent and he continues to battle it in courts.

Imran dodges contempt charges

Islamabad, Oct 3: Pakistan's former prime minister Imran Khan dodged contempt charges Monday after a court here accepted his written response and withdrew the show cause notice issued to him in a case pertaining to 'threatening' a female judge.

The 69-year-old Pakistan Tehreeke-Insaf (PTI) chief appeared before the Islamabad High Court (IHC) on Monday, where the case was heard by a larger bench, headed by IHC Chief Justice Athar Minallah and comprising Justices Mohsin Akhtar Kayani, Miangul Hassan Aurangzeb, Tariq Mehmood Jahangiri and Bahar Sattar.


During the hearing, Khan's lawver told the court that his client had submitted his third reply to the show cause notice after the first two replies were termed as unsatisfactory, Chief Justice Minallah who was presiding over the proceedings, said that the bench had read the affidavit provided by Khan and it was wrapping up the case.

"We take a lot of care in contempt of court cases," Justice Minallah said, adding that the court was "dismissing" the notice issued to Khan. "This is the unanimous decision of the larger bench," he re-

Dubai, Oct 3: Iran's supreme leader Ayatollah Ali Khamenei responded publicly Monday to the biggest protests in Iran in years, breaking weeks of silence to condemn what he called "rioting" and accuse the United States and Israel of planning the protests

The unrest, ignited by the death of a young woman in the custody of Iran's morality police, is flaring up across the country for a third week despite government efforts to crack down

On Monday, Iran shuttered its top technology university following an hours-long standoff between students and the police, that turned the prestigious institution into the latest flashpoint of protests and ended with hundreds of young people arrested.

Speaking to a cadre of police students in Tehran, Khamenei said he was "heartbroken" by the death of 22-year-old Mahsa Amini in police custody, calling it a "sad incident". However, he sharply condemned the protests as a foreign plot to destabilise Iran, echoing authorities' previous comments.

This rioting was planned," he told a cadre of police students in Tehran. "These riots and insecurities were designed by America and the Zionist regime, and their emplovees."Meanwhile Sharif University of Technology in Tehran announced that only doctoral students would be allowed on campus until further notice following hours of turmoil on Sunday evening, when witnesses said antigovernment protesters clashed with hardline pro-establishment students.

The witnesses, who spoke on the condition of anonymity for fear of reprisals, said the police kept hundreds of students holed up on campus and fired rounds of tear gas to disperse the demonstrations. The university's student association said that police and plainclothes officers surrounded the school from all sides and detained at least 300 students as protests rocked the campus after nightfall. Plainclothes officers beat a professor and several university employees, the association reported. The state-run IRNA news agency sought to downplay the violent standoff, reporting a "protest gathering" took place and ended without casualties.

Iran's latest protest movement, which has produced some of the nation's most widespread unrest in years, emerged as a response to Amini's death after her arrest for allegedly violating the country's strict Islamic dress code. However, it has grown into an open challenge to the Iranian leadership, with chants of "Death to the dictator" echoing from the streets and balconies after dark The demonstrations have tapped into a deep well of grievances in Iran, including the country's social restrictions, political repression and ailing economy long strangled by American sanctions

Ukrainian troops claim new gains

Kyiv, Oct 3: Ukrainian troops continued to push forward Monday with their offensive that has embarrassed Moscow, with Kviv officials and foreign observers hinting at new gains in the strategic southern region of Kherson that the Kremlin wants to annex.

Kherson has been one of the toughest battlefields for the Ukrainians, with slower progress when compared with Ukraine's breakout offensive around the country's second largest city of Kharkiv, in the northeast, that began last month.

Kherson is one of the four regions illegally annexed by Moscow last week after a "referendum" orchestrated by the Kremlin. The lower house of the Kremlin-controlled parliament is set to ratify the treaties Monday, and the upper house will follow the next day.

Kremlin spokesman Dmitry Peskov said Monday that two of those regions, Donetsk and Luhansk, are joining Russia with their administrative borders that existed before a conflict erupted there in 2014 between pro-Russian separatists and Ukrainian forces.

He noted that the issue of the borders of the two other regions -Zaporizhzhia and Kherson — re-

mains open."We will continue to discuss that with residents of those regions," Peskov said in a conference call with reporters. He did not provide additional details.

Ukrainian media outlets on Monday highlighted an image of Ukrainian troops displaying flags at a marker for the village of Khreshchenivka, which is in the same area of Kherson where troops apparently have broken through

Ukraine has pressed its counteroffensive in the Kherson region since the summer, relentlessly

pummeling Russian supply lines and making inroads into the areas west of the Dnieper River held by the Russians.

The Ukrainian military has suc-

cessfully used U.S.-supplied HI-MARS multiple rocket launchers to repeatedly hit the main bridge across the Dnieper in the city of Kherson and a dam that served as a second main crossing.

It also has struck pontoon bridges that Russia has used to supply its troops on the western bank of the river after the main crossings were made inoperable.

Despite the successful strikes on supply lines, Ukrainian offensive operations in the south so far have been slower and less successful compared with the northeast, as the open terrain easily exposed the attacking force to Russian artillery fire and airstrikes.

Russian military bloggers close to Moscow have increasingly acknowledged that Ukraine has superior manpower, backed by tank units, in the area.

A Russian-installed official in the Kherson region, Kirill Stremousov, admitted in a video statement on Monday morning that the Ukrainian forces "have broken through a little deeper." However, he insisted that "everything is under control" and that Russia's "defense system is working" in the region.

KIM SETTLES SEC **CRYPTO CHARGE**

New York, Oct 3: Kim Kardashian has agreed to pay USD 1.26 million to settle Securities and **Exchange Commission charges** that she promoted a cryptocurrency on Instagram without disclosing she'd been paid USD 250,000

The SEC said Monday that the reality TV star and entrepreneur has agreed to cooperate with its ongoing investigation. The SEC said Kardashian failed to disclose that she was paid to publish a post on her Instagram account about EMAX tokens, a crypto asset security being offered by

EthereumMax. Kardashian's post contained a link to the EthereumMax website, which provided instructions for potential investors to purchase EMAX tokens. "The federal securities laws are clear that any celebrity or other individual who promotes a crypto asset security must disclose the nature, source, and amount of compensation they received in exchange for the promotion," Gurbir Grewal, director of the SEC's division of enforcement, said in a prepared statement.

Kardashian has agreed to not promote any crypto asset securities for three years. "Ms. Kardashian is pleased to have resolved this matter with the SEC. Kardashian fully cooperated with the SEC from the very beginning and she remains willing to do whatever she can to assist the SEC in this matter. She wanted to get this matter behind her to avoid a protracted dispute. The agreement she reached with the SEC allows her to do that so that she can move forward with her many different business pursuits," a lawyer for Kardashian said in a statement.

While Kardashian is well known for reality TV, currently appearing on "The Kardashians" on hulu, she is also a successful businesswoman. Her brands include SKIMS, which has shapewear, loungewear and other products, and a skincare line called SKKN.

Cryptocurrency is facing increasing attention from Congress. The latest bipartisan proposal came in August from Sens. Debbie Stabenow, D-Mich., and John Boozman, R-Ark. It would hand the regulatory authority over Bitcoin and Ether to the Commodities Futures Trading Commission.

BRACING FOR CRISIS US, Philippine forces hold combat drills

Manila, Oct 3: More than 2,500 US and Philippine marines joined combat exercises on Monday to be able to respond to any sudden crisis in a region long on tenterhooks over South China Sea territorial disputes and increasing tensions over

The annual military drills are some of the largest so far between the longtime treaty allies under newly elected Philippine President Ferdinand Marcos Jr. His predecessor, Rodrigo Duterte, was an outspoken critic of US security policies and frowned on military exercises with American forces he said could offend China.

Called Kamandag, the Tagalog acronym for "Cooperation of the Warriors of the Sea," the drills involve 1,900 US Marines and more than 600 mostly Philippine counterparts in mock amphibious assaults and special operations, US and Philippine military officials said. America's HIMARS missile launchers and supersonic fighter jets will take part in live-fire maneuvers that will end on October 14, they said.

The venues include the western island province of Palawan, which faces the South China Sea, and the northern Philippines, across the Luzon Strait from Taiwan.

Philippine Rear Admiral Caesar Bernard Valencia said the exer-

om Kippur, also known as the Day of Atonement, is the holiest day in Judaism and is a 25-hour long day of fasting and praying. The Jewish holiday has a rich history, with its rules and traditions being among the most extensive in the Jewish tradition. It comes with its own unique prayers that distinctly set it apart from other holidays.

History

The fast of Yom Kippur is explained in the Bible, described in the Book of Leviticus as a day of cleansing, where the Jewish people atone for their sins, become pure, and pray that they are inscribed in the Book of Life.

However, its cultural significance goes far beyond its biblical roots. This is to the extent that many otherwise non-observant Jews will still go out of their way to observe the holiday in at least some capacity - most notably by attending synagogue services. For others, especially in Israel, the holiday is known as the day when nearly the entire country shuts down, with all businesses closed and roads quiet.

What happens on Yom Kippur? Yom Kippur is marked as one of the two major fasts, alongside Tisha Be'av, and lasts 25 hours.

Coal production rises 12% in Sept

New Delhi: The country's coal output rose a 12 per cent to 57.93 million tonne in September, India's coal output stood at 51.72 MT in the year-ago period. Of the top 37 mines, the output of 25 blocks has been more than 100 per cent and another five mines' production stood between 80 and 100 per cent in the last month. The dispatch of coal also went up marginally by 1.95 per cent to 61.18 MT in September, over 60.02 MT in the corresponding period last year.

Exports drop by 3.52% to \$32.62bn

New Delhi: India's exports contracted by 3.52 per cent to \$32.62 billion in September against \$33.81 billion in the same month last year, while the trade deficit widened to \$26.72 billion, according to government data. Imports during the month, however, grew by 5.44 per cent to \$59.35 billion as against \$56.29 billion in September 2021, the data showed. The exports during April-September 2022-23 rose by 15.54 per cent to \$229.05 billion. Imports during the period increased by 37.89 per cent to \$378.53 billion. The trade deficit during the first six months of the fiscal has widened to \$149.47 billion as against \$76.25 billion during April-September 2021-22.

Vodafone in talks for UK merger

London: Vodafone is in talks with CK Hutchison about merging their businesses in Britain to create a market leading mobile network that could accelerate the roll-out of 5G services and expand broadband availability. New Delhi, Oct 3: Manufacturing activities in India eased marginally in September but remained in good shape amid companies hiring more workers and cooling price pressures, according to a monthly survey released Monday. The seasonally adjusted S&P

Global India Manufacturing Purchasing Managers' Index (PMI) indicated a strong improvement in the health of the Indian manufacturing industry, as companies stepped up production in tandem with a sustained increase in new work intakes. The factory growth dipped to a

three-month low in September due to a moderation in demand and output, despite easing inflationary pressures and strong business confidence, the survey showed.

The PMI at 55.1 in September continued to be in expansion mode for the 15th consecutive month but was slightly lower than 56.2 recorded in August.

"Rates of expansion remained historically high, despite easing

from August. To accommodate

higher sales and greater output needs, firms hired extra workers and acquired more inputs. The upturn in input buying was aided by cooling price pressures. Purchasing costs rose at the slowest pace in just under two years, while output charge inflation receded to a seven-month low." the survey said.

A PMI score above 50 indicates expansion and a print below that level reflects contraction in manufacturing activities. Input costs rose at the slowest pace since October 2020 and most firms reported no change in purchasing prices.

Indian manufacturing industry remains in good shape, despite considerable global headwinds and recession fears elsewhere

SBI report warns of freebies time-bomb

THE REPORT URGES THE APEX COURT TO CAP SUCH SPENDS AT 1% OF STATE GDP

Mumbai, Oct 3: With states after states competing to offer freebies, a report has suggested that the Supreme Court-led panel could cap such welfare schemes at 1 per cent of the state's GDP or 1 per cent of its own tax collection.

Citing the examples of just three states, a report penned by Soumya Kanti Ghosh, the group chief economic adviser to State Bank of India, said annual pension liabilities of the poor states of Chhattisgarh, Jharkhand and Rajasthan are estimated at Rs 3 lakh crore.

When looked in relation to these states own tax revenue, pension liabilities are quite high for Jharkhand, Rajasthan and Chhattisgarh at 217, 190 and 207 per cent respectively.

While for states contemplating the change, it would be as high as 450 per cent of own tax revenue in case of Himachal Pradesh, 138 per

cent of own tax revenue in case of Gujarat and 242 per cent of own tax revenue for Punjab, which is also planning to revert to the old pension system wherein the benefici-

aries pay nothing. Such guarantee amount is significant at 11.7 per cent of GDP for Telangana, 10.8 per cent for Sikkim, 9.8 per cent for Andhra, 7.1 per cent for Rajasthan, and 6.3 per cent for UP. While the power sector accounts for almost 40 per cent of

Prosus NV calls off \$4.7bn acquisition deal of BillDesk

New Delhi, Oct 3: Prosus NV, which owns PayU, has terminated a \$4.7 billion (about Rs 38,400 crore) deal to acquire Indian payments firm BillDesk after conditions on the deal weren't met.

In a statement, Prosus said certain conditions precedent weren't met by the deadline at the end of September. Approval of the Competition Commission of India (CCI), which was one of the conditions precedent, was received September 5 but Prosus did not specify which other conditions were not met.

A condition precedent is a stipulation that defines certain conditions that must either occur or be met by either party to ensure progress or execution of a contract.

The amalgamation of BillDesk with PayU of Prosus would have created a digital payments giant with an annual total payment volume (TPV) of \$147 billion.

Its closest rivals in India such as Razorpay and CCAvenue, which is owned by Infibeam, are estimated to have an annual TPV of over \$50 billion and \$18-20 billion, respectively.

This would have been the large acquisition of Prosus, a Dutch ecommerce company.

Platinum imports at record high **LOOPHOLE IN TAX CHANGE**

As per reports some bullion importers are importing refined gold disguised as platinum alloy

Mumbai, Oct 3: India's platinum imports in September jumped multifold to a record high as refiners imported a large amount of gold containing small amounts of platinum but registered the purchases with customs as platinum alloy to avoid paying higher duties, government and industry officials said.

Such masking was possible due to what a tax official said was a loophole created by a change in policy in July whereby differential import duties were levied on gold, silver



and platinum, distinct from previous policy of having the same taxes for all the three precious metals.

"The duty change allowed importers to explore loophole in the system. They initially in August imported small quantity with 3% platinum and got cleared from Delhi customs as platinum alloy," said a senior industry official, who declined to be named.

As their imports were cleared, they brought in more gold as platinum and soon other refiners and trade houses joined them, which lifted India's platinum imports to around 27 tonne in September from 1.14 tonne a year ago, trade and government sources said.

In entire 2021 India had imported 10.59 tonne of platinum, according to data compiled by Ministry of Commerce and Industry

A Mumbai-based bullion dealer said refiners were taking advantage of government rule that says, "An alloy containing 2% or more, by weight, of platinum is to be treated as an alloy of platinum." "The rule was framed when platinum prices were higher than gold. In recent years platinum prices crashed. But still traders couldn't use the rule as the import duty on both the commodities was same. After July's duty hike, refiners started using this loophole," the dealer said.

mport duty on platinum has been increased to a total of 15.4 per cent with effect from Monday through a notification by the Finance Ministry. It is being presumed that the increase in duty on platinum is to plug a loophole which is helping bullion importers to make record profits. Gold attracts 15 per cent import duty, as opposed to platinum alloy that invites a duty of 10.75 per cent which observers say is a case of misdeclaration and duty





It was the third straight penalty miss by Benzema against the Osasuna goalkeeper. He had two penalties saved by Herrera in April when Madrid won. And things were clearly not going Benzema's way as shortly after the striker had a goal disallowed for offside.

Vinicius Junior had opened the scoring in the 42nd after finding the

far corner with what appeared to be a cross attempt into the area, but the visitors equalised with a header by Kike Garcia in the 50th.

Osasuna went a man down when David Garcia was sent off for the foul on Benzema that prompted the penalty. It was Osasuna's first draw after four wins and two losses this season, keeping the Pamplona club in sixth place. It got the point at the Santiago Bernabéu Stadium despite playing without the suspended Chimy Ávila, one of its best players.

Bumrah out of T20 World Cup: Shah

New Delhi, Oct 3: India's pace spearhead Jasprit Bumrah has been ruled out of the ICC T20 World Cup due to a back injury, the BCCI announced Monday. That Bumrah is ruled out of the big-ticket event due to a stress fracture was first reported by this agency September 29.

Bumrah's absence will certainly affect India's chances in the marquee event in Australia as death bowling still remains a grey area. The BCCI was awaiting medical reports while the pacer did his rehab at the National Cricket Academy but it was a foregone conclusion that he would be out for months.

"The BCCI Medical team has ruled out Team India fast bowler Jasprit Bumrah from the ICC Men's T20 World Cup squad. The decision was taken following a detailed assessment and in consultation with the specialists," BCCI secre-



tary Jay Shah said in a statement. While the BCCI will be naming a replacement for Bumrah in the squad for the marquee tournament soon, one among Mohammed Shami and Deepak Chahar will

make it to the main squad. Bumrah has had a history of back problem due to his slinging unorthodox front-on action which puts a lot of load on his back. He was ruled

out for three months in 2019 also with

a minor stress fracture but this

time, it could well be a case of at least four to six months of no show.

This year, Bumrah has played only 5 games each in three formats apart from 14 games for Mumbai Indians in the Indian Premier League. The question that is now being asked is whether Bumrah was rushed too quickly and could have been kept under wraps till the start of the T20 World Cup.

"That would have been a double edged sword. Here you are talking about World T20. How can Bumrah. coming back from back injury, be directly fielded in a high stakes game like Pakistan? What if he broke down there?" a BCCI source, who was aware about the development, told PTI on conditions of

India women to open campaign against Pakistan

India's second match will be against the West Indies February 15 before they take on England and Ireland February 18 and 20 in Gqeberha. The final will be played February 26 in Cape Town, with a reserve day available on the next day in case of major interruptions in play on the designated date.

Caputi 1st woman ref in Serie A

Milan, Oct 3: Atalanta moved joint top in Italy with a 1-0 win over Fiorentina while, at Sassuolo, Maria Sole Ferrieri Caputi became the first woman to referee a Serie A match.

Atalanta's Ademola Lookman scored the only goal of the game in the 59th minute, although it was all about the assist by Luis Muriel. Atalanta moved level with Napoli, which beat Torino 3-1 on Saturday. They are three points above defending champion AC Milan and Lazio.

There was a moment of controversy shortly before halftime when Fiorentina forward Christian Kouamé was shown a straight red card after contact with Atalanta midfielder Marten de Roon but it was revoked after the referee reviewed the incident



on the pitchside monitor.

Atalanta finally broke the deadlock 14 minutes into the second half when Muriel gathered a throwin with his back to goal, turned and skipped past two players before pulling it back for Lookman to tap in from close range.

Caputi became the first woman to referee a Serie A game when she

took charge of Sassuolo's 5-0 win over Salernitana. There was little controversy in a dominant performance by the home side, although Ferrieri Caputi did award a penalty for Sassuolo's second goal

Juventus rebounded from a disappointing defeat to promoted Monza with a 3-0 win over Bologna. Filip Kostic netted his first goal for the club in the first half and Dusan Vlahovic and Arkadiusz Krystian Milik scored after the break. Milik also sent a header onto the post late on. It was only a third win in eight league matches for Juventus and sent it to seventh

in the standings. After beating Juventus before the international break for their first-ever Serie A win, Silvio Berlusconi's Monza made it two wins out of two with a 3-0 victory at bottom club Sampdoria.
