

RETAIL INFLATION REMAINS ABOVE 7%

New Delhi: Retail inflation spiked to 7.41 per cent in September, mainly due to costlier food items. For the ninth month in a row, retail inflation has remained above the Reserve Bank of India's (RBI) tolerance level of six per cent. This information was released by the RBI in a release Wednesday. Retail inflation was at seven per cent in August and 4.35 per cent in September 2021. With inflation remaining above the six per cent level, RBI, now, will have to give a report to the government giving reasons for failure to contain inflation at four per cent with a bias of two per cent on either side. **P11**

State youths seeking jobs elsewhere

Employment exchanges in Jajpur, Angul, Rayagada districts register sharp decrease in renewals

Bhubaneswar, Oct 12: Although the districts of Jajpur, Angul and Rayadada have been witnessing an increase in the number of industries, the employment exchanges there have been observing a sharp fall in renewal of registrations. It is probably an indication of job aspirants seeking their future outside the state.

According to sources, a total of 40.272 youths had renewed their employment cards with the district employment exchange of Jajpur in 2014. However, the number decreased sharply to 20,441 in 2021. The district, which had 12 steel

and chrome factories in 2014, has now added six more cement and a tube manufacturing plants. The Kalinganagar and Jaraka industrial areas have at least 10 iron ore purification plants. However, not a single registered job seeker in the district employment exchange has been appointed by any of these factories, sources said.

Jajpur District Collector Chakravarti Singh Rathore declined to comment on the declining renewal of registrations at the district employment exchange. "When it comes to job opportunities at

Kalinganagar industrial area we have been giving priority to Odia youths. However, I'll check the ground reality before commenting on the reported decrease in renewal of registrations," said Rathore.

According to sources. Angul had 422 industries in 2014 and now the number of establishments has grown to 556. In 2014, approximately 919 youths were registered with the district employment exchange. Now the number of renewals have come down to 315 in 2022.

Angul employment officer Manas Ranjan Mohanty said that employment exchanges are no more the lone source of finding jobs for youths.

Rayagada district had 1.509 industries in 2014 and now has 3,592 in 2022. In 2016, 555 youths had renewed their registrations with the employment exchange. However, only 138 job seekers have got their registrations renewed this year.

Miscreants decamp with ₹11L in broad daylight

Sambalpur, Oct 12: Miscreants have snatched cash of ₹11 lakh from the owner of an AC repairing shop here. The incident took place Tuesday, but came to light Wednesday after an FIR was lodged at Town police station here.

As per the FIR, owner Mohammed Jisam along with an employee reached the shop at around 11.00am carrying a bag. He placed the bag in front of the shop while opening the shutter. However, two youths appeared out of nowhere in a bike and the pillion rider picked up the bag which had ₹11

lakh and then they sped away according to the FIR. Jisam caught hold of the handle of the bag and tried to wrest it back. However, the two miscreants managed to evade his grasp and fled.

Following the complaint filed by Jisam, police have started an investigation into the matter. They have detained one suspect and are interrogating him. Police are also examining the CCTV footage in the locality. Police have also said that the miscreants were well aware of Jisam's movements and that helped them to escape after committing the crime.

San Francisco, Oct 12: Users of Facebook, including many celebrities were in for a rude shock Wednesday when they woke up to find the number of followers drastically reduced. Among those were Facebook founder and CEO Mark Zuckerberg's followers whose numbers decreased from over 11.9 crore to just 9.995. As per reports, on Facebook's mobile application, Zuckerberg's profile page was not available due to some technical error. On the webpage, however, the highly diminished number of followers is visible.

According to some media re-



ports, a software bug triggered the sudden drop in followers. However, others claimed it to be a technical glitch while others said that this decrease in numbers could be due to a cyber attack.

Reports also said several American news outlets also saw a massive dip in their numbers of followers, including 'NYT', 'Washington Post', 'The Hill', 'USA Today', 'New York Post' and 'Newsweek'. 'USA Today' saw a dip of 13,723 and 11,392 followers Monday and Tuesday. Bangla writer Taslima Nasreen

also said that she lost a substantial chunk of followers. "Facebook created a tsunami that wiped away

my almost 9,00,000 followers and left only 9,000 something on the shore. Is this some kind of Facebook comedy," the exiled Bangladeshi writer said on Twitter

There was no official statement available from Facebook on this development. However, a Meta spokesperson said, "We're aware that some people are seeing in- \rightarrow consistent follower count on their Facebook profiles. We're working to get things back to normal as quickly as possible and we apologise for any inconvenience. Our technical people are working roundthe clock to rectify this deficiency."

Bhubaneswar: After a long pandemic-induced hiatus, the Film Society of Bhubaneswar (FSB) is back with the annual documentary film festival to be held here at Odissi Research Centre from October 14.

One of the oldest registered film societies in the State, FSB has been functional for the last 18 years. It works towards building cinema literacy for the folks in and around the city, by organizing regular screenings, workshops, and festivals.

For its comeback, the third edition of Indian Documentary Film Festival Bhubaneswar, (IDFFB) -2022 has a stellar lineup of documentaries, whose critical acclaim



can be traced to Cannes 2021, Cannes 2022, film festivals at Sundance, Rotterdam, Locarno, IDSFFK, Busan, and New York among others. The festival will conclude October 16.

Backstage by Odisha's Lipika Darai that gives rich insights into a slowly decaying art form will be the opening film of the festival. The film portrays the lives and times of the puppeteers of Odisha. Movies like All That Breathes

by Shaunak Sen and A Night of Knowing Nothing by Payal Kapadia are expected to strike a chord with the viewers.

The former follows the story of two Indian brothers, who have dedicated themselves to rescuing birds that are being poisoned by pollution while the other explores the relationship of a university student who writes letters to her estranged lover, L. The letters show a glimpse of the world around her, while also giving us a faithful reflection of contemporary India. Similarly, Hridoy Bosot by Sankhajit Biswas addresses the deep rooted anxiety and turmoil of the LGBT+ community in India.

The three day festival will also see interactions and conversations with ace filmmakers including Lipika Singh Darai. Praveen Morchhale, Kasturi Basu, Surbhi Dewan, Sapna Bhavnani and Debalina Majumdar among others. The complete schedule of screening can be found on FSB's social media handles.

FSB president Subrat Beura said 34 films in different languages like Bengali, Hazari, Manipuri, Monpa, Odia, Kashmiri, Urdu, Kachari, Assamese and Dangi will be screened at the festival.

"Unlike the other major cities of India, Bhubaneswar does not have a proper film festival in the cultural calendar. Despite all obstacles, FSB has managed to organize 12 film festivals and 10 major retrospectives, masterclasses, talks with visual artists and filmmakers, with the continuing effort to take Cinema to newer audiences, cineastes and students," said FSB executive committee member Sanchita Dwivedi.

Section 66A: The scrapped law that still haunts many

SC asks DGPs and Home Secretaries of the states and officers of the UTs to instruct police not to register complaints with respect to alleged violations of Section 66A

New Delhi, Oct 12: The Supreme Court Wednesday directed that no citizen can be prosecuted under Section 66A of the Information Technology (IT) Act, 2000, which it had scrapped way back in 2015.

Under the annulled Section, a person posting offensive content could be imprisoned for up to three years and also fined.

Underlining that liberty of thought and expression is of 'cardinal' significance, the top court had March 24, 2015 done away with the provision, saying the public's right to know is directly affected by Section 66A of the IT Act.

A bench headed by Chief Justice UU Lalit said in all cases where citizens are facing prosecution for alleged violation of Section 66A of the IT Act, the reference and reliance upon the said provision shall stand deleted.

Narsingh Pula of Siripeta village said his fowls started sneezing and of Ranikhet (New Castle Disease).

In fact, Ranikhet and Fowlpox wiped out the entire flock in Siripeta, Panighata and Banktiguda villages in Khairput block last year. According to Binayak Mishra, district livestock coordinator for Somks, a regional NGO that promoted better animal husbandry practices, goats and cattle succumbed to Peste des Petits, Goat Pox, Haemorrhagic Septicaemia and Black Quarter diseases

The tribal income thus suffered a massive setback in the district, where over 58 per cent of the population struggled with poverty, according to Niti Aayog's National Multidimensional Poverty Index for 2021. Though vaccines were the only way to save their poultry,



farmers had to travel 80 km to the district headquarters to buy them from unregistered agents for Rs 50 to 60 per bird and Rs 100 to 120 per goat.

A shot in the arm

Mathili and Khairput blocks got their solar-powered vaccine coolers in January 2022 under the Odisha government's two-year pilot project to assist local farmers in tackling livestock mortality. Costing Rs 1.06.000, it comprises solar panels, a refrigerator, a small cold storage box to take vaccines to the customers, and other essential inputs supplies

Each refrigerator can store up to 100 litres of various vaccines. In the event of a power outage, they can maintain cooling for 24 to 30 hours. These functions are of utmost importance as erratic power supply and absence of cold storage facilities impair vaccine efficiency in remote settlements, said Khairput Block Veterinary Officer Tushar Mishra. Vaccine availability and its de-

The Department of Animal Husbandry and Veterinary Services initially trained two farmers running large-scale livestock enterprises on how to keep farm animals in good health. The solar panels and fridge were installed at their houses, from where vaccine vials were supplied to other 40 tribal youth, who were trained by the department in January. These para-veterinarians earn a living by selling vaccines, but they have to bear their travel expenses them-

In Khairput block, the cold storage facility is placed at the house of Madhu Bhumia of Pushpali Colony. Agriculture is steadily becoming unprofitable. I supplement my family's income by selling vaccines that the department provides. In the last three months, I have saved around Rs 8.000. Bhumia beamed

Between 40 and 60 lakh RTI applications are filed every year, but less than 3 per cent Indian citizens have ever filed an RTI plea, said experts.

"The anti-corruption law will become obsolete if we don't use it on a greater scale. More use of RTI by citizens will certainly reduce the attack on RTI activists who expose corruptions," said former State Information Commissioner Jagadananda here Wednesday.

Inaugurating a function to mark

Clinic, a city-based social forum,

Jagadananda made a strong pitch for use of the law at the grassroots level and called for a sustained awareness campaign among the citizens including tribals in interior areas about RTI Act.

Former bureaucrat and advocate Sribhusan Sukla said the government should make the administration's work so transparent that there is minimum requirement to file RTI applications. "The system should function in a way that we don't need to file RTI applications. I should be able to access the information that I need, not just the information that the government wants to publicise," he said.

adical action is needed to end stigma and discrimina-L tion against people with mental health conditions and their families globally, according to a report published in The Lancet journal.

The Lancet Commission Report on Ending Stigma and Discrimination in Mental Health, which sets out key recommendations to achieve this goal, is a result of collaboration of more than 50 contributors worldwide.

Through this report, the commission aims to define stigma, summarise the evidence of how people with lived experience of mental health conditions worldwide currently experience stigma and assess the impact of largescale programmes to combat stigma among others.

The report summarises the evidence received for effective interventions through an umbrella review of 216 review papers, most of which address aspects of pub-

lic stigma. The clearly emerging core finding is that forms of social contact, direct or indirect, between people who do and do not have lived experience of mental health conditions is the most effective evidence-

based way to reduce stigmatisation.

The expedition is aimed at inculcating discipline, confidence and a spirit of adventure amongst the cadets.

More inclusive policies, legislation and plans that were more effective in reducing stigma were generally linked with communitybased treatment, programmes of public education and media activities, including participation of champions, who had lived experience of mental health conditions.

Increasing inclusivity in programmes for individuals with various learning disabilities, such as through use of hearing aids, Braille texts, and sign language, audio-visual displays and diagrams for people with poor literacy and communication problems have contributed to improved access to care. Peer victimisation was reduced

after an average of 25 weeks of involvement in a programme using social contact to bring peers with and without disabilities together for shared activities in school and community settings, the report said. In relations to suicide, the re-

port claims, results showed that psycho education and interpersonal contact significantly reduced stigma, which was sustained at 1month follow-up.

The Commission has provided a four-part definition of stigma in



its report: Self-stigma, stigma by association, public stigma and structural stigma.

Self or internalised stigma occurs when people with mental health conditions are aware of and agree with the negative stereotypes with others and turn them against themselves

Stigma by association, the report says, refers to the attribution of negative stereotypes and discrimination to family members or

mental health staff, such as blaming family members for the onset of substance abuse conditions.

Public or interpersonal stigma is better understood through three separate but related components: knowledge, attitudes and behaviours.

While knowledge refers to the absence of accurate knowledge and attitudes to the negative emotional reactions towards the affected, behaviour refers to the rejection and social exclusion of the affected by discrimination.

Structural, systemic or institutional stigma refers to the policies and practices that work to the disadvantage of the stigmatised group, intentionally or unintentionally.

Stigma, according to the report, is often seen as a barrier to policy change, sometimes through lack of public demand for governmental action and investment, and also through misinformation, misunderstanding and lack of awareness of positive policy options among policy makers.

Globally, people with mental health conditions commonly experience restrictions in employment, voting, property ownership, marriage and divorce.

The Lancet Commission, through this report, recommends using person-first language, rather than identity-first language, that is, a person with a mental health condition or with a lived experience of a mental health condition.

Culture, the report goes on to say, also has a strong influence on stigma because of the role that it plays in deciding what is considered socially accepted behaviour and on defining the causes of mental health conditions and how they are treated.

Mahakalapara, Oct 12: The cashew forests on a Mahanadi islet close to Bahakud village under Ramnagar panchayat of this block in Kendrapara district are bearing the brunt of erosion by the sea with the water level rising continuously. Hundreds of cashew trees have been washed away after being battered by high tidal waves.

The cashew forest is spread over 233 acres of sand bed. Earlier there were around 5,000 cashew trees. However, hundreds of them were washed away due to the cyclonic storms that lashed the district be tween 1999 and 2019. The storms that have battered the district are Super Cyclone (1999), Phailin (2013),

Hudhud (2014), Titili (2018) and Fani (2019)

Environmentalists fear that the rest of the forest and the river islet will soon lose their existence if urgent measures are not taken to check the coastal erosion. With climate change impacting the whole world, a rise in sea level is causing the mayhem, they said. The tidal waves are gushing towards land mass and eroding vast tracts of lands. As a result, many river islets and land masses are slowly losing their existence after being gobbled up by the tidal waves. Two other cashew forests are also located within Ramnagar panchayat. Nationalising Energy

lthough uncertainty prevails in today's global energy market, one thing has become clear: Governments are reasserting their central L role. The motive is pragmatic rather than ideological, and the details vary from one country to another, but the trend is unmistakable. Governments of all political hues are taking back control of a market that had largely been left to private firms with only limited regulation. In many Western economies, this arguably represents the largest shift in the balance of public and private economic power since World War II.

The state's newfound assertiveness stems partly from huge price increases that threaten large-scale energy poverty and the collapse of some energyintensive businesses. After years of underinvestment in the sector, the surge in energy demand in the wake of the COVID-19 pandemic, especially in Asia, inevitably caused prices to jump. The cost of natural gas to consumers in the European Union rose by 12% in the second half of 2021.

But this was merely a prelude to the current price spikes resulting from Russia's invasion of Ukraine. The EU's plan to cut its imports of Russian natural gas by two-thirds by 2023, together with Russia's reduction of supplies to countries including Germany and Finland, caused the European benchmark price to increase fivefold over the 12 months to June of this year.

On one estimate, average consumer energy bills in Britain - which imports little Russian gas but relies on the global market for 50% of its daily needs - were predicted to be four times their 2021 level by early next year.

A second powerful factor compelling government intervention is climate change. The surge in energy demand over the past year has been led by coal, which remains the dominant source of power in Asia, causing greenhouse-gas emissions to return to their prepandemic level. Despite strong growth in renewables such as wind and solar, the world's continued reliance on hydrocarbons means that, absent further government intervention, emissions will continue increasing for several years to come.

None of these challenges can be addressed by market forces alone. Without a carbon price or other regulatory measures that only governments can put in place, people will continue to use gasoline-fueled cars. Market forces can do little to help families facing a sudden rise in the cost of an essential commodity. Nor can markets redistribute the windfall gains made by companies such as Saudi Aramco, which reported a record profit of \$48.4 billion in the second quarter of this year, to the many smaller businesses for which energy is a crucial input.

State intervention in the energy market is taking many and varied forms. The German government has announced plans for 2% of the country's land area to be used for the

production of wind power, and is devising emergency rationing schemes to manage anticipated winter energy shortages following Russia's cutoff of gas supplies. All British households initially received a £400 (\$450) handout, to help them cope with rising energy bills, partly funded by a windfall tax on oil and gas producers. But that proved insufficient and, upon becoming Britain's new Prime Minister, Liz Truss capped household energy bills for two years and offered short-term support for business users. To increase domestic energy supplies, she granted new North Sea oil and gas licenses and lifted the moratorium on fracking. The United Kingdom's green agenda nominally remains in place with no new gasoline- or dieselpowered cars to be licensed from 2030, but, for the moment, government intervention is focused on price controls and increased hydrocarbon production.

Across the Atlantic, US President Joe Biden's recently enacted Inflation Reduction Act provides \$27 billion to help low- and middle-income American households convert to cleaner energy, as well as funding to maintain the country's loss-making nuclear-power sector. In France, President Emmanuel Macron is in the process of fully nationalizing the power utility EDF, a former flagship of French industrial strength that has suffered two decades of managerial and technical failure. And energy-price controls have been tightened there and across much of continental Europe. Unfortunately, these and many other recent government initiatives are piecemeal responses to the fundamental challenges of energy insecurity and climate change. Too many measures are insufficiently thought through, provide poor value for money, and fail to address underlying obstacles to change For example, a major shift to electric vehicles makes sense only if both charging networks and secure supplies of the advanced materials on which EVs depend are available. Small universal cash handouts are costly and do not address concentrated long-term energy poverty. Policies to increase wind-power generation are irrelevant unless the infrastructure to cope with distributed electricity supplies is in place. Governments reach for short-term solutions that demonstrate that they are acting. But the resulting policies are not always the cheapest or the most effective, and many turn out to be no more than temporary fixes. In none of the countries mentioned above is there a settled consensus on the shape of long-term energy policy. Nonetheless, the trend toward greater government intervention in the energy sector is well established. As the limitations of particular policies are revealed, policymakers will respond with more intervention, not less. The role of the state will have to expand further, not least to address the investment gap that has emerged. Additional funds are needed to meet future demand for all forms of energy and associated infrastructure. Financing the transition to a low-carbon economy will require vast sums. Governments are likely to be the main source of the necessary capital, as well as supplying guarantees and subsidies to the private sector. But whether governments, many with finances already overstretched by COVID-19, will respond adequately is far from certain. In the UK, the opposition Labour Party, now well ahead in the polls, has promised to create a new publicly owned Great British Energy company to deliver a carbon-free electricity sector by 2030

These reforms were meant to establish a rulebased, fair, free market capitalistic system by breaking the shackles of socialist era, license-raj and economically slow growing system in India. These reforms set in motion India's stride towards becoming a free-market economy through liberalisation, privatisation and globalisation. They intended to get India free from the major ailment of 'rent -seeking' which had crippled the economic growth. Recently, as India celebrated her 75 years of Independence, the country also overtook the United Kingdom to become the world's fifth largest economy. At this crucial juncture it is important to evaluate the impact of economic re-

forms on rent-seeking in India. Gordon Tullock propounded the concept of rent-seeking in 1967 which was later popularised by Anne Krueger in 1974. It evolved from the studies of Adam Smith. Rent-seeking is an economic concept that occurs when an entity seeks to gain wealth without any reciprocal contribution of productivity. The term rent in rent-seeking is based on the economic definition of "rent. which is defined as economic wealth obtained through shrewd or potentially manipulative use of resources. An example of rent-seeking is when a company lobbies the government for grants, subsidies. or tariff protection. Rent-seeking comes in many forms from lobbying or donating funds.

The relationship between the government and the businesses in pre-1991 period can be defined with a focus on cronyism. Crony capitalism is a pervasive form of capitalism in which the government colludes with select business households to provide them with license for business and rig the competitive market space to favour colluding private entities in exchange for money or other such considerations. The roots of cronyism lie in this period of license, permit and quota raj as the government tightly con-

trolled all the economic activities. This stifling control provided many opportunities for collusion and rent-seeking was highly prevalent. Arvind Subramanian and Dani

Rodrik have also argued that in the 1980s, India followed a pro-business approach which means favouring selected business households rather than providing a favourable condition for all businesses. The image of then Prime Minister Indira Gandhi sharing the stage with industrialist Dhirubhai Ambani in a political rally was the manifestation of the economic policy being followed where instead of removing impediments to competition, the government was busy garnering political support from existing business groups.

The 1991 economic reforms were touted to be a watershed moment which would redefine the relationship between the government and corporate houses. As it brought an end to the license-permit-quota rai, it was believed that with foundation of free market being laid, chronic ailments of rent-seeking would also cease to exist. However, this proved to be a pipedream.

To some extent the reforms were successful, and they did lead to emergence of new sectors with new players like Information Technology. However, rent-seeking did not just persist but continued to prosper. The most important reason, as many experts believe, is conveniently leaving electoral funding reforms which form the crux of existence of rentseeking in first place, as corporates form the major source of political funding. Various loopholes

have been found even in the recently enacted electoral bonds system. Despite liberalisation, state continues to exert its hold over other factors of production which is land, banking and finance and most importantly allocation of natural resources. In such a scenario, rent-seeking only prospered instead of ceasing to exist, with increase in productivity of the economy post liberalisation. The freemarket economy fell prey to crony capitalism. Raghuram Rajan in his book 'Saving Capitalism from the Capitalists', states that the biggest threat to free market comes from cap italists themselves as they continue to depend on politicians to extract illegitimate market benefits. One of the ways, developed by

The Economist magazine, to meas ure prevalence of rent-seeking in any nation is by knowing how the richest people in that country make their money. If their source is where government has a strong hold like giving license, or allocation of natural resources, real estate or defence, then it is likely that rent-seeking dominates the economy. However, if their money comes government independent domains or open sectors like IT or consumer goods, then in such cases cronyism is likely to be less powerful

In the Medium, Small and Micro enterprises (MSME) segment, it is very interesting to note that out of 63 million enterprises in India. there are only 1 million formal employers. The archaic complex regulatory system is the reason why most of the firms intend to operate at a small scale. These complex regulatory norms are the main source

of bureaucratic rent-seeking. If these small firms decide to increase their size or become formal, they are required to comply with 1536 laws, 70,000 compliances approximately and more than 5000 filings. That is why more than 80 per cent of the firms in MSME segment are micro enterprises. This also allows big corporations to keep any competition at bay. All of this comes at a huge cost of potential growth and employment loss to the nation.

One of the recent instances is the government announcement of Production Linked Incentive (PLI) scheme to give a boost to invest ment. Under this scheme, the government offers incentives (4-6% of incremental sales) to selected firms. Earlier the parameters used to select the firms were that it should be a small or medium enterprise, labour intensive and export oriented. However, later other firms were also included like the LED under the PLI scheme, despite having booming consumer demand and low technology for production. Because of this, other players too started demanding to be included in the PLI scheme, making it a typical case of rent-seeking. Experts argue such initiatives never work, and mostly drain the treasury than increasing competitiveness in the market. The special support offered to sectors by cherrypicking them only encourages rent-seeking. India already has plenty of experience with such policies being implemented in 1970s. To increase investment government must provide level-playing field to all the industries by removing the impediments in competitive free market economy.

The above evidence points out that economic liberalisation was not successful in addressing the problem of rent-seeking. In fact, with higher GDP in the economy post liberalisation, rent-seeking increased too. No wonder. India ranked ninth in the Global Crony Capitalism Index developed by 'The Economist' magazine. The reason behind this is the non-addressal of critical institutional, economic and administrative issues which continue to be breeding grounds for cronyism and corruption.

None of this is a recipe for an ideal outcome. The task of ensuring a continuous and affordable energy supply is too important to be left to the market and too complex to be taken over by ministers and bureaucrats. The involvement of both is necessary, but neither, alone, is sufficient.

Logic points to cooperative arrangements whereby governments set energy objectives and standards, and private-sector firms compete to play a part in meeting the overall goals. But achieving such collaboration and balance currently seems no more than a distant aspiration.

Inclusive education

Sir, According to a recent UN report based on census 2011, 75 per cent of children with disabilities in India do not attend any educational institute in their lifetime. Inclusive education refers to a model of learning where children with disabilities (CWD) attend the same schools with non-disabled peers. CWDs are very bright and talented kids, but they may just learn in a different manner. But in most mainstream schools, the number of students is so large that teachers can't really pay attention to the individual needs of students. India has a number of laws and policies on education but data and ground-realities show that an ecosystem of inclusion has not yet been achieved. Current laws ignore preparedness for inclusive learning. The prerequisites for a truly inclusive classroom are: preparation of the child, the parents and the receiving school. However, the existing laws on education in India have ignored to give stress on the equal preparedness of the stakeholders when it comes to inclusive and effectual learning for CWDs. Even though the Rights of Persons with Disabilities Act, 2016 makes inclusive education a statutory guarantee, the Rights of Children to Free and Compulsory Education Act, 2009 does not even define inclusive education. Lucknow, Oct 12: The Uttar Pradesh government has asked all District Magistrates and police chiefs to impose fines on those found burning stubble in fields. As per the directives issued by

the state's Chief Secretary Durga Shankar Mishra, anyone caught burning agriculture residue or waste in their fields, the fine is ₹2,500 if the field is less than 2 acres, ₹5,000 if the field is 2 to 5 acres and ₹15,000 if the size of the field is above 5 acres

Mishra has asked concerned officials to ensure that no agricultural waste is burnt in fields. He said a campaign should be organised to sensitise farmers against the ill effects of crop burning but if anyone is caught burning waste, then action should be initiated against them.

A government spokesman said. 'The Chief Secretary has said that 14 instruments and machines have been identified for dealing with agricultural waste. It has been directed that farm banks, where common use instruments and machinery can be kept, should be set up and equipment given to indi-

vidual farmers as per need. Individual farmers will get 50 per cent subsidy while Farmer Producer Organizations (FPOs) cooperatives and panchayats will get 80 per cent subsidy for establishment of machinery banks." The purchase of instruments

and machinery should be com pleted by October 15.

As per the directives, agricultural waste from fields of those farmers who burnt this waste last year, should be collected and stored in cow shelters.

Of the farm residue so collected, 25 per cent should be used for mixing in the fodder for cattle. At least 20.000 tonnes of agricultural waste should be sent to cow shelters during this financial year and a scheme started by the government earlier, 'Parali do Khad lo' should be promoted extensively.

The official said that a penalty on farmers should be the last resort and an extensive sensitisation programme should be carried out first where farmers are told about the ill effects of burning agricultural waste and its impact on air, soil and water pollution. Interactive sessions should be organised between farmers and agriculture experts.

Agra, Oct 12: Frederic Fugen, Vincent Cotte and Aurelien Chatard flew by the Taj Mahal, one of the Seven Wonders of the World, Tuesday to achieve something that had never been done before.

Titled the Taj Mahal Fly-by proj ect, Red Bull Athlete Frederic jumped out of a Cessna 172 airplane at altitude of 5,000 feet about two kilometres away from the Taj Mahal, and using his wingsuit, he flew nearby the monument to achieve something that had never been done before - an individual proximity fly-by. Special thanks to DGCA, Ministry of Civil Aviation, Archaeological Survey of India and District Magistrate of Agra. The trio performed one jump early evening Tuesday, and had a few more planned Wednesday. The jump saw them light up the sky with green and orange colours to create a beautiful aerial display as tourists and visitors at the Taj Mahal were left enthralled.

Frederic Fugen is one of the most talented and innovative skydivers, wingsuit pilots and base jumpers on the planet.

As part of the Soul Flyers, a group of international athletes that perform wingsuit projects around the world, he has executed some truly incredible flights. Among his craziest projects have been Door in the Sky, when he jumped



off a mountain peak and flew into an airplane; Sky Skiing, when he performed a 45-second ski routine in the sky before landing and skiing down a mountain; Flying past the Pyramids of Giza, when he conducted a wingsuit flight superclose to the pyramids; Base jumping off Burj Khalifa, when he per-

formed the highest-ever base jump and parachute off a building; and many others

Recently Frederic came up with the idea of a project around one of the country's most iconic monuments - the Taj Mahal, a UNESCO World Heritage site and often hailed as one of the 7 Wonders of the

World. And he achieved this feat Tuesday.

Joining Frederic on this project were frequent collaborators Vincent Cotte and Aurelien Chatard, who have been part of some of his best-known aerial projects in recent years

J&K departmental stores now allowed to sell beer

Srinagar, Oct 12: Beer lovers can now rock in Jammu and Kashmir as authorities have permitted departmental stores to sell the beverage under its liberalised liquor licensing and sale policy.

The Administrative Council (AC) meeting chaired by Lieutenant Governor, Manoj Sinha has approved the proposal authorising departmental stores to sell beer and other Ready to Drink (RTD) beverages in urban areas.

An official statement Tuesday said, "The Administrative Council approved incorporation of liberal provisions in Jammu and Kashmir Liquor License and Sale Rules, 1984 and Excise Policy, 2023-24 for grant of License JKEL-2A for retail sale of Beer and Ready to Drink (RTD) beverages in departmental stores in urban areas of UT.



The statement added that the departmental stores in a commercial complex, approved by the competent authority, fulfilling conditions like having total carpet area of minimum 1,200 sq feet, annual turnover of minimum ₹5 crores in Jammu and Srinagar cities and ₹2 crores for stores in other urban areas will be eligible under the scheme. Moreover, chain of departmental stores having annual turnover of more than ₹10 croreswill be eligible to apply for separate licenses for each of its store.

HUMAN SACRIFICE IN KERALA **Mastermind a pervert: Police**

Kochi, Oct 12: In the human sacrifice case, a pervert is the prime accused, who exploited the fears of a man and his wife over their financial woes and two women were killed following torture, police said here Wednesday.

Strongly condemning the human sacrifice, the ruling CPI (M) stressed the need for a new legislation to curb such superstitious practices and sought strict implementation of the existing laws.

Advocate B A Aloor, known for representing the accused in sensational cases appeared for the trio.

Speaking to reportes on solving the case that became sensational, Kochi City Police Commissioner Nagaraju Chakilam said the 52year old Mohammed Shafi, the prime accused, is a history-sheeter.

He took undue advantage of the concerns of Bhagaval Singh (68) and his wife Laila (59) over their financial problems. Shafi convinced the couple that human sacrifice would solve their financial issues and brought them under his influence. Singh was a traditional massage therapist.

In the human sacrifice case, the two victims had inall the three accused have direct participation in both the killings, but the accused couple did not have a history of crime.

SC seeks Centre's response by Oct 31

New Delhi, Oct 12: The Supreme Court Wednesday asked the Centre to furnish by October 31 its affidavit in response to petitions challenging the validity of certain provisions of a 1991 law, which prohibit filing of a lawsuit to reclaim a place of worship or seek a change in its character from what prevailed August 15, 1947.

When a bench headed by Chief Justice U U Lalit was told the Centre has not yet filed its response to the petitions, Solicitor General Tushar Mehta, appearing for the government, said it is under consideration as to what to respond to and whether to respond.

The bench, also comprising Justices Ajay Rastogi and S R Bhat, asked Mehta how much time was required to submit the affidavit. 'Two weeks, that is what my in-

struction is." Mehta said, adding some time was needed considering the sensitivity of the matter.

"On the last occasion, Tushar Mehta, Solicitor General, had prayed for some time to place his submissions on record by way of an affidavit in response. Solicitor General prays for further time of two weeks to do the needful. Let the affidavit in that behalf be filed on or before October 31." the bench said.

The top court was hearing the pleas, including the one filed by advocate Ashwini Upadhyay who has said sections 2, 3, 4 of the Places of Worship (Special Provisions) Act. 1991 be set aside on grounds including that these provisions take away the right of judicial remedy to reclaim a place of The 1991 provision is an Act to prohibit conversion of any place of worship and to provide for the maintenance of the religious character of any place of worship as it existed August 15, 1947 and for matters connected therewith or incidental thereto

During the hearing, senior advocate Rakesh Dwivedi, appearing for Upadhyay, told the bench his plea challenges the validity of certain provisions of the Act and that he has circulated a set of questions of law which requires consideration in this case.

The apex court said the counsel appearing in the matter may give questions which according to them would require consideration by the court. While hearing the matter September 9, the apex court had said the pleas challenging the validity of certain provisions of the 1991 law can be referred to a five-judge constitution bench for adjudication and asked the Centre to file a reply.

Iran anti-hijab stirs: Over 100 protestors charged

Tehran: Iran has charged more than 100 people in two provinces over the wave of protests triggered by the death in custody last month of Mahsa Amini, the judiciary said Wednesday. Protests erupted across Iran September 16, when Amini died three days after falling into a coma following her arrest in Tehran by the morality police for an alleged breach of the Islamic republic's strict dress code for women. Police have made hundreds of arrests and prosecutors vowed swift justice for "rioters". Tehran province accounted for 60 of the prosecutions while 65 people have been charged over the "recent riots" in the southern province of Hormozgan, the judiciary's Mizan Online news website reported. "Given that the rioters played a central role in the organisation of illegal gatherings, arson and attacks on public and private property, and sowed terror among the population, the prosecutor has carried out swift investigations in these cases," Hormozgan chief justice Mojtaba Ghahremani told Mizan Online.

Beijing, Oct 12: China's ruling Communist Party is set to slide back to its founder Mao Zedong's era soon as President Xi Jinping is set to break the decades-old 10-year term rule to cling in power and perhaps for life, amid mounting pressure from the US-led West against Beijing's aggressive quest to become a dominant world power. On Sunday, 2,296 delegates "elected"

under the ideological parameters set by 69-year-old Xi, will attend the carefully-choreographed Communist Party's once-in-a-five-year Congress which is widely expected to endorse his continuation in power.

In the century-old history of the CPC, Mao remained at the helm until his death in 1976, ruling the most populous country and subjecting it to his ideological experiments like the Cultural Revolution during which millions of intellectuals were



exterminated and wiped out much of the country's civilisational past to create a new socialist order.

Mao's mercurial leadership was marked by brutal campaigns to purge the remnants of the capitalists and traditional elements from society and implement his Wang Yang who was Chinese Communist Party boss of economic powerhouse Guangdong province, is now being considered as the top contender to be China's next premier as he has displayed a liberal streak that has been less visible since Xi Jinping took power

brand of Communism called Mao Zedong Thought. It ended up disastrously driving the communist nation to near bankruptcy.

Mao's successor, Deng Xiaoping, who earned the title of Paramount Leader for his sedate and pragmatic leadership putting the coun-

try on the path of economic development reversing Mao's hardline policies, introduced the collective leadership system with a ten-year term limit and 68-year age limit to avoid the ills of the one leader domination of the party. The 12th Congress of the CPC

back in 1982 under the leadership of Deng set China's political and ideological direction for the next 35 years. The same Congress set a new ideological direction for the party giving high priority to economic development through market reforms and opening to the world. The 1982 Congress also resolved

formally to repudiate Mao's personality cult, absolute power and leadership-for-life and restore the principles of collective party leadership, including an evolving convention of term limits.

Since then, all of Xi's predecessors, Jiang Zemin and Hu Jintao followed the 10-year norm. Incidentally, China recorded extraordinary economic growth during their tenures. propelling it to become the second largest economy after the US.

Over three and half decades later, the party which controls all limbs of governance including the military the judiciary and legislature are in the cusp of returning to the 'One Leader' rule amid its toughest period of economic slowdown exasperated by the 'Zero Covid' policy, increasing adversity with the US and the West besides un-easy relations with neighbours like India and Japan.

India-UK trade deal on 'verge of collapse' over visa comments

London, Oct 12: The India-UK free trade agreement (FTA) is reportedly on the "verge of collapse" after the Indian government was angered by comments made by UK Home Secretary Suella Braverman questioning action over visa overstayers from the country, a UK media report claimed Wednesday.

'The Times' newspaper quoted government sources to say that ministers in New Delhi were 'shocked and disappointed" by the "disrespectful" remarks made by Braverman, who said she had concerns of an "open borders" offer to India as part of an FTA.

The likelihood of meeting the Diwali deadline for the pact, set by former Prime Minister Boris Johnson, is now believed to be diminishing.

"There's still a lot of goodwill but if certain individuals are still embedded in the [UK] government it will paralyse the talks," the newspaper quoted a source as saying. Last week, Braverman, the Indianorigin Home Secretary said in an interview that she feared a trade deal with India would increase migration to the UK when Indians already represented the largest group of visa overstayers.

"I have concerns about having an open borders migration policy with India because I don't think that's what people voted for with Brexit," she told 'The Spectator' weekly news magazine.

Meanwhile Prime Minister Liz Truss's spokesman said Britain still wants to agree a free trade deal with India by Diwali later this month.

Asked if the government still wanted a trade deal by this date, the spokesman said: "Yes, we are working on this high ambition free trade deal that would put the UK at the front of the queue to supply India's growing middle class.

New Delhi, Oct 12: In twin blows to Indian economic revival, higher food prices drove retail inflation to a five-month high of 7.4 per cent while factory output fell for the first time in 18 months.

The second consecutive month of rise in consumer price index (CPI)-based inflation will add to the pressure on the Reserve Bank of India (RBI) to again raise interest rates to tame high prices.

Headline CPI inflation surged to 7.4 per cent in September from 7 per cent in the previous month, official data released Wednesday showed.

Higher inflation was led by food items. Food inflation surged to a 22month high of 8.6 per cent while core inflation rose to a 4-month high of 6.3 per cent. This is the second successive quarter where the average is higher than 7 per cent.

Irregular rainfall is said to be the primary reason behind higher inflation in vegetable and fruits. While inflation in cereals has also inched up, the steps taken by the



government and a reasonably healthy Kharif output are expected to address the concerns behind the further hike in prices

Separately, the Index of Industrial Production (IIP) declined 0.8 per cent in August with heavy rains dampening construction activity and electricity demand, and the bleak manufacturing output belying the hope generated by the robust GST eway bill data.

Official data released by National Statistical Office (NSO) Wednesday showed that the retail inflation based on Consumer Price Index (CPI) was at 7.41 per cent in September as against 7 per cent in August. In year ago same month, it was at a comfortable level of 4.35 per cent.

IIP contracted by 0.8 per cent in August, mainly due to a decline in output of the manufacturing and mining sectors. Official data showed that the previous low in industrial output growth was a contraction of 3.2 per cent in February 2021.

Factory output, measured in terms of the Index of Industrial Production (IIP), had expanded by 13 per cent in August 2021. The IIP grew by 2.2 per cent in July this year.

The manufacturing sector



shrank by 0.7 per cent in August 2022 compared to the 11.1 per cent growth recorded in the year-ago period, as per the data released by the Statistics and Programme

Implementation Ministry. The power sector showed a growth of 1.4 per cent against a 16 per cent rise a year ago. The mining sector witnessed a contraction of 3.9 per cent in August 2022, whereas there was a growth of 23.3 per cent in the year-ago period.

During April-August this year, IIP rose 7.7 per cent against 29 per cent growth in the same period a year ago. Capital goods output, which is a barometer of investments, rose five per cent in August 2022 compared to 20 per cent growth in the year-ago month.

The consumer durables segment declined 2.5 per cent from 11.1 per cent growth a year ago. The primary goods segment, which accounts for nearly 34 per cent of the index, expanded 1.7 per cent in August compared to 16.9 per cent growth in the year-ago period.

The ministry said the growth rates over the corresponding pe riod of the previous year are to be interpreted, considering the unusual circumstances on account of the Covid-19 pandemic since March 2020.

New Delhi, Oct 12: The government will extend a one-time grant of ₹22,000 crore to three state-owned fuel retailers to cover for the losses they incurred on selling domestic cooking gas LPG below cost in the last two years, I&B Minister Anurag Thakur said Wednesday

The Union Cabinet headed by Prime Minister Narendra Modi at a meeting Wednesday, approved the one-time grant to three oil marketing companies - Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL) and Hindustan Petroleum Corporation Ltd (HPCL), Thakur told a news briefing.

The grant will be for covering the



losses they incurred on selling LPG below cost to consumers from June 2020 to June 2022. The three firms sell domestic LPG at governmentregulated prices to consumers.

However, to insulate consumers from fluctuations in international LPG prices, the cost increase was not fully passed on to consumers of domestic LPG, an official statement said. Accordingly, domestic LPG prices have risen by only 72 per cent during this period, it said adding this led to significant losses for the three firms.

"Despite these losses, the three PSU OMCs have ensured continuous supplies of this essential cooking fuel in the country. The government has therefore decided to give a one-time grant to the three PSU OMCs for these losses in domestic LPG," it said.

The Union Cabinet approved a one-time grant amounting to ₹22,000 crore to the three oil marketing companies (OMCs).

'This decision will help the PSU OMCs to continue their commitment to the Atmanirbhar Bharat Abhiyaan, ensuring unhindered domestic LPG supplies and also supporting the procurement of Make in India products.

The bank had crossed the ₹5 lakh crore mark in January 2021, the bank said in a statement, adding it is the first lender to achieve the ₹6 lakh crore milestone in the residential home category

As a part of the festive offer, SBI will offer a concession of up to 0.25 per cent on home loans, 0.15 per cent on top-up loans, and 0.30 per cent on loans against property, the bank said, adding the offer also includes waiving off the processing fees up to January 31, 2023.

Commenting on the milestone, its chairman Dinesh Khara said SBI has over 28 lakh home loan customers. Alok Kumar Choudhary, managing director-retail banking & operations, said the interest rate for new loan buyers and loan takeovers starts at 8.40 per cent and top-up

loans begin at 8.80 per cent.

State Bank of India did not offer details such as the credit score conditions or the ticket size of the loan to avail of the lower rates. It further said the festive offer also includes waiver of the processing fees, balance transfers/takeovers and top-up loans.

Meanwhile, the largest pureplay mortgage player HDFC, which is awaiting its merger with its banking subsidiary HDFC Bank, said it's also offering discounted interest rates to new borrowers to the tune of 20 bps or at 8.40 per cent.

According to HDFC website, the festive offer is valid up to November 30, and the low rate will be applicable to those borrowers who have a minimum credit score of 750.

Leading banks and mortgage players have increased their lending rates by up to 0.50 percentage point after the Reserve Bank of India last raised its reporate by 50 bps to tame inflation.

Dubai, Oct 12: A "flying car" built by Chinese electronic vehicle maker Xpeng Inc made its first public flight in the United Arab Emirates, as the company works towards launching the electric aircraft on international markets.

The X2 is a two-seater electric vertical take-off and landing (eVTOL) aircraft that is lifted by eight propellers - two at each corner of the vehicle. The company says it has a top speed of 130 km (80 miles) per hour.

The unmanned, 90-minute test flight in Dubai was described by its manufacturer as an "important base for the next generation of flying cars.'

'We are making step-by-step (moves) to the international market," said Minguan Qiu, general manager of Xpeng Aeroht. "First we selected Dubai city because Dubai is the most innovative city in the world.



The demonstration was held with an empty cockpit, but the company says it carried out a manned flight test in July 2021.

Unlike airplanes and helicopters, eVTOL, or "electric vertical takeoff and landing," vehicles offer quick point-to-point personal travel, at least in principle.

The pilot-less vehicles could one day ferry passengers across town high above congested roadways. But the sector still faces major challenges, including battery life,air traffic control and safety, and infrastructure issues.

Relief despite disappointment

MBAPPE SCORES IN PSG'S DRAW WITH BENFICA AS REPORTS SWIRL; MAN CITY, REAL MADRID ADVANCE IN SPITE OF STALEMATES IN CHAMPIONS LEAGUE

Rome, Oct 12: Happy or not, Kylian Mbappe continues to score goals for Paris Saint-Germain. Manchester City, meanwhile, just isn't the same without Erling Haaland.

Still, City — despite a 0-0 draw at FC Copenhagen — joined holder Real Madrid Tuesday as the first teams to advance to the knockout phase of the Champions League.

On the same day when reports emerged that Mbappe is frustrated at PSG and wants to leave during the January transfer window, the France striker converted a penalty in a 1-1 draw with Benfica. It was Mbappe's record 31st goal for PSG in the competition, passing Edinson Cavani for the club record.

Mbappe had been close to joining Real Madrid on a free transfer this summer but finally agreed to stay at PSG for two more years with an option for an extra season. The 23year-old Frenchman celebrated his latest goal by holding his arms out wide and rushing toward the stands at Parc de Princes — with no outward sign of discontent.

Mbappe also had an acrobatic potential late winner waved off by the VAR, leaving PSG level on points

with Benfica atop Group H. CITY STOPPED

With Haaland rested, 10-man City was held to a 0-0 draw at FC Copenhagen, a team languishing in the bottom half of the Danish league. Copenhagen became the first team to stop City from scoring this season in a match overshadowed by early video-review decisions.

One of those VAR calls resulted in a red card for City left back Sergio Gomez in the 30th minute for pulling back Hakon Arnar Haraldsson as the last man, harming the visitors attacking ambitions at the atmospheric Parken Stadium.

Chelsea moved to the top of the group on with a 2-0 win at Milan, which played most of the match with 10 men after former Blues defender Fikayo Tomori was sent off in the 18th minute after also giving away a penalty.

Jorginho converted the spot kick and Pierre-Emerick Aubameyang doubled the visitors' advantage in the 34th. Chelsea moved a point above Salzburg, which drew 1-1 at Dinamo Zagreb in the other Group E match. Milan and Dinamo are three points below Chelsea. JUVENTUS CRISIS

Juventus descended further into crisis and was left on the verge of elimination from the Champions League following a 20 loss at Maccabi Haifa that also included an injury to key winger Angel Di Maria.

Omer Atzili scored two first-half goals as Haifa earned their first Champions League win in two decades. Juventus were left third in Group H behind PSG and Benfica with two games to play.

BELLINGHAM'S CONSISTENCY

At 19, England midfielder Jude Bellingham has scored in all four of Dortmund's Champions League games this season. Young players took center stage as Sevilla took the lead with a header from 20-year-old defender Tanguy Nianzou before Bellingham knocked in Thomas Meunier's low cross for a 1-1 draw.

Only Haaland (5 goals) and Mbappe (4) have scored more Champions League goals this season. Bellingham also became the highest-scoring English teenager in a single Champions League season, overtaking Wayne Rooney's record of three goals in 2004-05.

India not up to USA standards: Dennerby

Bhubaneswar, Oct 12: India head coach Thomas Dennerby admitted that his team was no match to the USA after they suffered a 0.8 humiliation in their FIFA U-17 Women's World Cup opener but insisted that the home team is capable of playing better.

Dennerby had claimed that India can compete against any team in the age-group showpiece, his comment coming on the basis of the close game (1-3 loss) the team played against Sweden, who failed to qualify for the showpiece event, in the lead up to the tournament.

"I did not expect to let in so many goals because defending has been quite good when they played against Sweden two and half weeks ago. We defended very well, we had two shots on the bar and we were creating chances. But honestly USA were one level up even if you compare with Sweden at least," the coach said Tuesday.

Dennerby had earlier said that India had prepared well for the U-17 World Cup. However, during an interaction with media, he said that they haven't played any side of the standard of USA in the leadup to the showpiece.

"No doubt USA are really a good

side. If you look at the USA players, the skillfulness, their speed and you cannot find any weak point in their team. So far the games we have played earlier this year, no team was up to this level," Dennerby said.

"We have not played against any team which sends in top quality corners and players like six feet tall coming in and jumping very high and heading with top class quality," the Swede added.

He said the Indian team can do better, adding that the players were nervous due to the big occasion. "It was definitely very tough for us. But of course I also know that team India can play a little bit better than this. My feeling is that the girls were a little bit too nervous, could not handle the situation as it was their first World Cup game," he said.

"In the beginning, we did not even try to pass the ball to each other. There was something in the way, not comfortable enough to start playing. I was screaming the girls to start playing.

"After 3-0, it was for USA to just play their game and have fun and it was tough for us. But the good thing is there are two more games to go and I hope we can show everyone that India is much better than this. We can have a much better game than this against Morocco."

Discus thrower Kaur banned

NEW DELHI: Top Indian discus thrower Kamalpreet Kaur, who achieved stardom for her exploits at the Tokyo Games, was Wednesday banned for three year for using prohibited substance stanozolol, the Athletics Integrity Unit (AIU) has announced. Her ban will be effective from March 29, 2022. Kamalpreet was handed a provisional suspension in May this year after testing positive for the steroid, which was found in her sample that AIU collected at Patiala March 7. Stanozolol is classified as an anabolic steroid and is in the list of banned substances as per World Athletics. Kamalpreet had refused the anlysis of her B sample. Kamalpreet had finished sixth at the Tokyo Games in a splendid show with a best throw of 63.70m.

No aid for Djokovic's visa

MELBOURNE: Novak Djokovic won't get official support with lobbying from Tennis Australia should he seek to enter the country for the first major of 2023, a year after he was deported because he was not vaccinated for COVID-19. The 21-time Grand Slam champion wasn't allowed to defend his Australian Open title last January after a tumultuous 10day legal saga that culminated with his visa being revoked on the eve of the tournament. Djokovic originally was granted an exemption to strict vaccination rules by two medical panels and Tennis Australia in order to play in the Australian Open but, after traveling to Melbourne believing he had all his paperwork in order, the exemption was rejected by the Australian Border Force. "It is not a matter we can lobby on. It is a matter that definitely stays between the two of them." Australian Open tournament director Craig Tiley said Wednesdav.
