Bhadrak/Bhubaneswar, Oct 14: Internecine squabble in ruling Biju Janata Dal (BJD) was out in the open Friday, when disgruntled party leader Rajendra Das filed his nomination as an independent candidate for the byelection to Dhamnagar Assembly seat in Bhadrak district.

Rajendra, a former BJD MLA, was apparently miffed over the party giving the ticket to Abanti Das, who also filed her nomination at the returning officer and sub-collector Laxmiprasad Sahu in the block office Friday.

Abanti, the Thihidi block chairperson, was accompanied by a huge crowd of supporters and party leaders for her nomination filing. Sources said as many as six

Himachal to vote Nov 12; Guj later

PRESS TRUST OF INDIA

New Delhi, Oct 14: Elections to the Himachal Pradesh Assembly will be held November 12, the Election Commission (EC) announced Friday. The counting of votes will be December 8, Chief Election Commissioner Rajiv Kumar told a press conference here.

The Commission did not announce the elections for the Gujarat Assembly, the term of which ends February 18, 2023. Over 55 lakh voters are eligible to exercise their franchise for 68 Assembly seats in Himachal Pradesh, Kumar said.

The CEC said the Commission was following past precedence in keeping the announcing in abeyance the schedule for all warrat assembly.

There are 1.86 lakh first-time voters, 1.22 lakh aged 80-plus and 1,184 voters who are above 100 years of age. In 2017 elections, BJP had won a clear majority by winning 44 seats.

Black hole found firing jet at another galaxy

THIS IS THE FIRST TIME A JET HAS BEEN OBSERVED TO COLLIDE WITH A LARGE GALAXY LIKE RAD12-B

London, Oct 14: A team of astronomers, with the help of citizen scientists, has discovered a unique black hole spewing a fiery jet at another galaxy. The black hole is hosted by a galaxy around one billion light years away from Earth named RAD12. The work was published in Monthly Notices of the Royal Astronomical Society (RAS).

Galaxies are typically divided el into two major classes based on their morphology – spirals and da



ellipticals. Spirals have optically-blue ra looking spiral arms with an abundance of cold gas and dust. In spi-

ral galaxies, new stars form at an average rate of one Sun-like star per year. In contrast elliptical galaxies appear yellowish and lack distinct

features such as spiral arms.

Star formation in elliptical galaxies is very scarce; it is still a mystery to astronomers as to why the elliptical galaxies we see today have not been forming new stars for billions of years. Evidence suggests that supermassive or 'monster' black holes are responsible. These 'monster' black holes spew gigantic jets made of electrons moving at very high speeds at other galaxies, depleting the fuel required for future star formation: cold gas and dust.





he unique nature of RAD12 **L** had been observed in 2013 using optical data from the Sloan Digitised Sky Survey (SDSS) and radio data from the Very Large Array (FIRST survey). However, follow-up observation with the Giant Meterwave Radio Telescope (GMRT) in India was required to confirm its truly exotic nature: The black hole in RAD12 appears to be ejecting the jet only towards a neighbouring galaxy, named RAD12-B. In all cases, jets are ejected in pairs, moving in opposite directions at relativistic speeds. Why only one jet is seen coming from RAD12 remains a puzzle to astronomers.

A conical stem of young plasma is seen being ejected from the centre and reaches far beyond the visible stars of RAD12. The GMRT observations revealed that the fainter and older plasma extends far beyond the central conical stem and flares out like the cap of a mushroom (seen in red in the tricolour image). The whole structure is 440 thousand light years long, which is much larger than the host galaxy itself.

RAD12 is unlike anything known so far; this is the first time a jet has been observed to collide with a large galaxy like RAD12-B. Astronomers are now one step closer to understanding the impact of such interactions on elliptical galaxies, which may

leave them with little cold gas for future star formation. Research lead Dr Ananda Hota

says, "We are excited to have spotted a rare system that helps us understand radio jet feedback of supermassive black holes on star formation of galaxies during mergers. Observations with the GMRT and data from various other telescopes such as the MeerKAT radio telescope strongly suggest that the radio jet in RAD12 is colliding with the companion galaxy. An equally important aspect of this research is the demonstration of public participation in making discoveries through the RAD@home Citizen Science research collaboratory.' Rescued, injured Indian Rock

Python goes under knife

Berhampur, Oct 14: An injured Indian Rock Python underwent surgery at a veterinary hospital here. The 9-feet-long reptile was rescued by forest personnel and snake rescuers from a bus stand Tuesday.

The area falls under the Berhampur forest range in Ganjam district. The snake had sustained injuries on its head and mouth.

Most of the times, an Indian Rock Python can be easily identified by its large size, dark irregular patches, pinkish head and slow locomotion.

"With the help of the Forest officials, we rushed it to the veterinary hospital for treatment and the veterinary doctors suggested surgery," said Swadhin Sahoo, who



led the rescue operation.

Veterinary surgeon Kiran Bisoi said the critical surgery, which took over an hour, was performed on its head as well as in the mouth at the veterinary hospital in Berhampur Wednesday.

The snake will be kept under observation for at least 15 days. Forest officials could not ascertain how it got injured. Sahoo suspected that the local people might have attacked the reptile during which it was injured

Fresh ray of hope for Satkosia tiger project

Angul, Oct 14: Now, the Satkosia tiger project in Angul district is in doldrums. But the Forest department, which has been blamed for the alleged failure of the tiger project, is busy bolstering the security and infrastructural aspects of the project area

This has signalled a fresh hope in giving a new lease of life to the tiger project, which has been put on hold for the last four years after the National Tiger Conservation Authority (NTCA) stalled the project November 15, 2018.

This has happened after death of tiger Mahaveer while tigress Sundari which was brought from Bandhaygarh National Park has been sent back to its habitat. Locals and wildlife activists are unsure if the tiger conservation project will ever be effective and successful.

However, learning from the past mistakes, the Forest department has laid stress on strengthening the infrastructure and security of the



to rework on the project again in future. Meanwhile, an NTCA team has taken stock of the Satkosia re-

Rich in biodiversity, Satkosia wildlife sanctuary is spread over 795.52 sq km in Angul, Cuttack. Nayagarh and Boudh districts. It was accorded wildlife sanctuary status in 1976. Its area has been expanded later. In 2002, the elephant project was introduced here while the tiger project was started in 2007.

In the 2014 wildlife census, only two tigers were present in the sanctuary. The government planned

for tiger conservation in Satkosia in 2016. The Central government was proposed to bring tigers from other states. On June 21, 2018, a male tiger called Mahaveer was brought from Kanha National Park of Madhya Pradesh and a tigress called Sundari was brought from Bandhavgarh June 28. Mahaveer was released into the sanctuary July 6 while the tigress was re-

leased August 17. However, owing to mismanagement of the Forest department, the tigress killed two people lead-

The tigress was brought back to its enclosure November 6, 2018. On November 14, the tiger project got a severe jolt as the tiger Mahaveer was found dead. Hence, the NTCA had to postpone the project.

On March 23, 2021, the tigress too was sent back to Bandhavgarh National Park. The project has been put on hold for some period while infrastructure development has been given top priority now.

As part of the exercise, antipoaching squad and watchers have been appointed. A new system like web patrolling has been launched. Under this system, the staff engaged will have to patrol in a circular way and monitor wildlife movement, detect issues in the sanctuary, growth of flora, and keep tabs on people's movement in forests. Security has been tightened against poachers.

As for the future of the project, regional chief conservator of forests (RCCF) and field director of Satkosia tiger project M Jogjayanad said that infrastructure for the



Delayed promotions slowing down reforms in Railways

For a ministry said to be in a hurry to overhaul its functioning, the inordinate delay in making key appointments in the Railway Ministry often leaves babus and observers baffled. Now, after "rigorous efforts" for over a year, the ministry has finally announced the appointment of 20 officers as divisional railway managers (DRMs)

Earlier, it was given out that the delay was caused by the cumbersome integration of cadres and other "reforms" that Railway Minister Ashwini Vaishnaw was overseeing. This apparently also included the removal of the age barrier of a minimum of 52 years for becoming eligible for the post of DRM. However, insiders have informed DKB that if the government ended up maintaining the 52-year criterion, there is little justification for delaying these appointments for more than a year. Some rail babus even speculate whether the ministry will adopt the same method for the appointment of divisional managers and Board members.

Despite the much-lauded merging of all eight organised Group A services of railways into one Indian Railways Management Service (IRMS), ostensibly to eliminate cadre conflicts and departmentalism, and introduce uniformity, it has clearly not given the desired results. There are still some 11 posts of GM Railways still vacant, besides other key vacancies in the ministry. Delayed decisions on key appointments only make the ministry's challenges more daunting.

hough only large dictionaries include it and the Oxford English Dictionary says it is obsolete or archaic, candent has retained a toe-hold on usage in the sense of something glowing, as if with white heat, largely in Science Fiction and fantasy novels whose authors delight in obscure language. Neal Asher used it in The Voyage of the Sable Keech: "The rock blew apart in a candent explosion, hurling pieces of itself out into space", as did Robert Asprin in his fantasy anthology Shadows of Sanctuary: "Shards punched through knife holes and widened them to let quicklime spill down in a candent stream". Clark Ashton Smith wrote it into The Black Abbot of Puthuum: "Noon, with its sun of candent copper in a blackish-blue zenith, found them far amid the rusty sands and iron-toothed ridges of Izdrel", and Poul Anderson borrowed it for The Long Night: "The stars were scattered about in their myriads, dominantly ruby and ember, some yellow or candent, green or blue." It was almost completely replaced by incandescent in the first decades of the nineteenth century. Both are relatives of candour, candid and candidate, the linking thread being the concept of whiteness. The last three are from Latin candidus, white, Candent is from the verb candere, to be white or to glow, and incandescent derives from the related verb incandescere, to become white-hot.

his word popped up in a book of short stories: So, the land there is thickly I forested to the north and the forest grows even more thickly and densely to the south. MUSK'S COVERT WAR

EVEN WITH CURRENT POLICIES OF CONTENT MODERATION, **SOCIAL-MEDIA PLATFORMS ARE AWASH IN DISINFORMATION THAT IS CORRODING PUBLIC TRUST AND UNDERMINING** THE ESSENTIAL **FUNCTION OF FREE AND INFORMED POLITICAL DISCOURSE**

n 1897, the American newspaper magnate William Randolph Hearst sent illustrator Frederic Remington to cover the Cuban War of Independence. When Remington relayed that "there will be no war," Hearst allegedly cabled back: "You furnish the pictures, and I'll furnish the war.

It's an old story with a wellknown moral: Wealth confers power, and power begets a craving for more power. A familiar corollary follows: He who controls the means of mass communication controls how reality is constructed and conveyed.

The means of mass communication have changed since Hearst's time, but the behaviour of plutocrats has not. Having used Twitter quite effectively to promote his own businesses, Elon Musk recognises that the platform commands significant influence in contemporary public life. While he has since tried to wriggle out of the deal that he signed to buy the platform, he may have no choice but to follow through. In any case, it is worth considering his stated reason for pursuing ownership

of the company. "Given that Twitter serves as the de facto public town square,' Musk tweeted on March 26, 2022, "failing to adhere to free-speech principles fundamentally undermines democracy." In deciding to buy the company, he explained a week or so later, "I don't care about the economics at all ... my strong, intuitive sense [is] that having a public platform that is maximally trusted and broadly inclusive is extremely important to the future of civilization." And so, as a self-described "free-speech absolutist," Musk claims to be saving society's public square by reversing Twitter's policies to prohibit politicians like former US President Donald Trump and US Representative Marjorie Taylor



Elon Musk's defence of 'free-speech absolutism' is fundamentally bogus. If the billionaire culture warrior's now-reluctant purchase of Twitter goes through, the platform will be overrun by toxic disinformation, including deep fakes, insipid propaganda, calls for violence, doxing, and other forms of illiberal anti-speech acts

Greene from using the platform to propagate demonstrable lies and disinformation in the name of free speech

Musk's call for "absolute freedom" of speech may sound simple enough in the abstract, but the implications are troubling. For example, Musk's understanding of free speech would validate conspiracy theorist Alex Jones' defense of his reckless and injurious lies, including his outrageous claim that the 2012 Newtown school massacre, in which a gunman murdered 26 people (20 of them six- and sevenyear-olds), was staged by "crisis actors." A Connecticut court has iust rejected that view, ordering Jones to pay nearly a billion dollars to the families of the Newtown victims.

The court is right. No freedom whether of speech or action – is absolute. On the contrary, meaningful freedom requires ground rules to limit abuses that would otherwise render it a dead letter. That is why we have laws against fraud in the marketplace of goods and services. Without such constraints, false and deceptive claims would proliferate, fomenting levels of mistrust that inevitably invite

market failure. The same goes for the marketplace of opinions and ideas. Freedom of speech is not a license deliberately or recklessly to issue statements that harm others or put their property rights at risk. That is why we have laws against defamation and the intentional infliction of emotional distress - as the Alex Jones case reflects. It is also why we have laws proscribing incitement to imminent violence, perjury, and lying to the authorities about criminal activity.

Some limits on speech have also been deemed essential to safeguard free and fair elections. For

example, there are laws in many states in the United States that proscribe deliberately spreading false information about polling locations, voting times, ballot authenticity, or voting instructions, nor can you make provably false claims about your status as an incumbent or about your campaign's affiliations. And as the criminal prosecution of participants in the violent mob that sought to block the peaceful transition of power at the US Capitol on January 6, 2021, makes plain, the freedom to hold unpopular political views does not confer a right to violent insurrection.

Even with current policies of content moderation, social-media platforms are awash in disinformation that is corroding public trust and undermining the essential function of free and informed political discourse. Such subversive tactics designed to crash the marketplace of opinions and ideas are, in fact, "anti-speech acts." Their only purpose is to debase political discourse itself.

Musk has already offered a preview of the changes he might make at Twitter. What starts with reinstating Trump's account, allowing him to disseminate more demonstrable lies about election fraud and his political opponents, may imply, more broadly, further evisceration of Twitter's standards. Musk's claim that he will save society's "public square" is fundamentally bogus. He will fuel its disintegration by permitting it to be overrun by toxic disinformation, including deep fakes, insipid propaganda, calls for violence, doxing, and other forms of illiberal anti-speech acts.

sequences of the woeful war in Ukraine, we can decipher two deeply dismaying fallouts. One, the entire world comunable to stop the war, or bring about a ceasefire. Second, the individual countries are finding it difficult to structure or restructure their equations and partnerships. India and the West, namely the United States and members of European Union are a case in point. The partnership between India and the US was segueing to mutual trust and dependence, and between India and EU members bilaterally and through Free Trade Agreement. Now, sudden ruptures are visible.

On 6 October, the German Foreign Minister Annalena Baerbock, in a joint press conference with her Pakistan counterpart, in Germany stated, "Berlin had a role and responsibility with regard to the tensions on Kashmir." She added, Germany supports "intensively the engagement of the UN to find a peaceful solution to the

dispute". At the same time, the American Ambassador to Pakistan, Donald Blome made a three-day visit to PoK and referred to the disputed territory as 'Azad Kashmir'. An informal note justified the visit as, "To promote US-Pakistan partnership and highlight the two

n an assessment of the con-countries' deep economic, cultural and people-to-people ties."

India has naturally reacted strongly to both the incidents in Germany and in PoK. New Delhi munity including the West is has reminded them that the 'Kashmir issue' between India and Pakistan has to be settled bilaterally as per the historic Shimla Agreement. The outsiders have no role in it. Both Germany and USA have recognised this established strategic position. Why now rake it up? Obviously, it is an attempt to arm-twist India into joining the anti-Russia-China tent led by the West. But is this the way to win the confidence of a potential partner? Both countries knew where it will hurt New Delhi. So they have plunged into such tactics that amounts to blackmail!

On American action vis-à-vis Pakistan, it is difficult to fathom into the thinking of Biden administration. In fact, interestingly, Biden's foreign policy has been seen in fits and starts, riddled with contradictions. He is facing a lot of flak from within the country. Think tanks, analysts and research organisations are pointing out the lack of clarity and consistency of Biden's policy. It is hard to detect if Biden's approach to Pakistan is aimed at decoupling Islamabad from Beijing or coupling New Delhi with the American camp. Either way it is a self-defeating move. However, for some recon-

dite reasons, Biden administration has sanctioned 460 million USD to maintain the F-16s which 66 million USD in immediate humanitarian assistance to Islamabad after the ravaging floods. This is understandable. But what is not, even in diplomatic courtesy terms, is the US Secretary of State Antony Blinken speaking effusively about Pakistan in a reception hosted by Pakistani community in USA to Bilaval Bhutto, the Foreign Minister. Biden has still no Ambassador to New Delhi while their Ambassador to Pakistan suddenly visits PoK!

The analysts in USA are critical of such actions. They suggest that Pakistan is unstable, volatile and a hotbed for religious schisms and extremism. To repose confidence in such a fragile regime is imprudent. Writing in The New York Times, a Fellow of the Brooking Institute suggested that the US should disentangle itself from the Pakistan military and support the civilian administration.

Likewise, Michael Kugelman, Director of the South Asia Institute in Washington, a non-partisan policy forum, cautions against reading too much into Blome's visit to PoK. He says, "New Delhi will not make a major policy shift under external pressure, especially in Kashmir." He cautions

Kugelman, however, admits that "Baerbock's comment is tough to assess. Very rarely do senior Western officials publicly express a desire for the Kashmir issue to be internationalised."

There are certainly communication gaps on both sides. New Delhi has perhaps not been able to explain its exposition on its 'strategic autonomy'. The Western bloc should be giving enough elbowroom to India, and more important. trust and confidence, to carry out the transition. On the contrary, they are making it worse by sudden U-turns on Kashmir.

New Delhi should also rethink some of its recent positions in the United Nations and its reactions to world events. As I said in this column last week, New Delhi should take positions in keeping with her core foreign policy obiectives and strengths, standing up for rule of law, freedom and human rights. Abstaining continuously on such issues does not carry confidence.

Sir, This refers to "India-UK trade deal on verge of collapse over visa comments," Orissa POST, Oct 13. Britain wants Indian trade. But it does not want Indians. Punjab, Haryana fail to reach agreement

Last month, the Supreme Court had nudged the two Chief Ministers to meet and work out an amicable solution to the SYL canal row, which has been a bone of contention between the two states for several decades

Chandigarh, Oct 14: Punjab Chief Minister Bhagwant Mann and his Harvana counterpart Manohar Lal Khattar failed to reach an agreement on the contentious Sutlej Yamuna Link canal during a meeting here Friday.

Though Mann called Haryana Punjab's "younger brother", he said his state does not have any water to share with the neighbouring state and the question of constructing the canal does not arise.

He said in case Haryana faces shortage of water, both Punjab and that state can approach Prime Minister Narendra Modi and request him to arrange water from either Yamuna or Ganga or anywhere else. During the meeting at Harvana Niwas here, he also sought reassessment of water from the rivers.

On the other hand, Khattar said Punjab did not agree on the construction of the SYL canal in its territory. "No consensus was arrived at in the meeting," Khattar told reporters.

He said Punjab wanted to raise the issue of river water first, but Haryana wanted to discuss the construction of the canal according to

the directions of the Supreme Court. Khattar said his government will apprise Union Jal Shakti Minister Gajendra Singh Shekhawat of the meeting.

Punjab has been maintaining that the quantum of water flowing through Ravi and Beas rivers had come down considerably, and therefore, it was seeking reassessment of the water's volume.

Haryana has been seeking completion of the canal to get its share of 3.5 million acre feet of the water, and also that Punjab should comply with the 2002 and 2004 Supreme Court orders for the completion of the canal. Currently, the state is getting 1.62 million acre feet (MAF) of the Ravi-Beas water.

Addressing the media after the meeting, Mann said he had done his homework on the SYL issue and stressed that he represented Punjab's side strongly.

He pointed out that Haryana at present was getting 14.10 million acre feet of water, more than Punjab. According to Mann, his state gets 4.22 MAF water from Ravi and Beas, while Haryana receives 3.50 MAF water, whereas from Sutlej, Punjab gets 8.02 MAF while Haryana receives 4.33 MAF



water. Further, he said Punjab does not get any water from Yamuna while Haryana gets 4.65 MAF water and that it also gets 1.62 MAF water from the Sharda Yamuna link.

"In all, Punjab gets 12.24 MAF water while Haryana gets 14.10 MAF water," the Punjab Chief Minister claimed

"Haryana asked us to begin constructing the canal in Punjab. We said when we do not have water, why build the canal?" Mann said. "We treat Haryana as our younger brother. But if we do not have something, how can we give it?"

He also sought to target the Shiromani Akali Dal and the Congress over the SYL issue. The Centre had on September 6 informed the Supreme Court that the Punjab government was "not cooperating" in resolving the dispute. Then Attorney General K K Venugopal. appearing for the Centre, had told

the bench that the apex court had in 2017 called for an amicable settlement and that it was trying to bring the two states on the same page through its Water Resources Ministry. "Unfortunately, Punjab has not been cooperating," the top law officer had said. However, the counsel for Punjab

had last month told a bench headed by Justice S K Kaul that the state government was very keen to resolve the issue amicably.

The Punjab Assembly in July 2004 had enacted the Punjab Termination of Agreement Act, annulling all inter-state agreements signed by the state relating to the sharing of water from Ravi and Beas. However, a constitutional bench of the Supreme Court, while answering the Presidential Reference November 11, 2016, had held that the act was un-

Court nixes plea for carbon dating of Gyanvapi shivling

GYANVAPI MASJID COMMITTEE ARGUES THAT THE OBJECT BEING CALLED A 'SHIVLING' IS ACTUALLY A FOUNTAIN

Varanasi, Oct 14: In a jolt to Hindu petitioners, a Varanasi court Friday rejected the petition seeking carbon dating of the purported 'Shivling' found in the Gyanvapi mosque complex.

Vishnu Shankar Jain, advocate of the four Hindu petitioners seeking carbon dating of the 'shivling', said they would now approach the apex court with their demand.

The petitioners had claimed that the 'Shivling' found in the 'wuzu khana' or reservoir of the mosque during survey work May 16 was part of the property. The Hindu side demanded carbon dating and other scientific tests of the Shivling-like structure.

Carbon dating is a scientific process that ascertains the age of an archaeological object or archaeological finds.

The Gyanvapi Masjid committee had opposed the carbon dating plea filed by the Hindu side.

Last month, four of the five

Hindu women petitioners filed a plea seeking scientific investigation on the 'Shivling'.

They contended that it was necessary to determine its age. The women have claimed that ancient idols of Hindu Gods and Goddesses are located inside the mosque.

The mosque committee objected to scientific investigation, arguing that the case was about worshipping at a shrine inside the mosque and had nothing to do with its structure. The object being called a 'Shivling' is actually a fountain, they argued. Last week, the court asked if the purported 'Shivling' can be made a part of the case and whether a scientific investigation can actually be

Vishnu Shankar Jain, lead advocate for Hindu women, told reporters that he tried to convince the court on both counts.

"We said two things - that in our prayer we asked for rights to pray before visible and invisible deities inside the mosque complex. The Shivling was earlier covered by

water and when the water was removed it became a visible deity and so it is part of the suit," he said.

On September 12, the Varanasi district judge dismissed a challenge by the mosque committee that argued that the case by the Hindu women seeking permission for year-long worship inside the mosque complex has no legal standing. Their challenge was rejected on all three counts they cited. The most important of these is the 1991 law, which freezes the status of a place of worship as it existed August 15, 1947. The petitioners do not want ownership, just the right to worship, the court ruled.

Earlier this year, a lower court in Varanasi ordered the filming of the centuries-old mosque based on the women's petition. The videography report, controversially leaked by the petitioners, claimed a 'Shivling' was found in a pond used for 'Wuzu' or the mandatory purification rituals before Muslim prayers.

The Gyanvapi mosque, located in Varanasi, the constituency of Prime Minister Narendra Modi, is one of the several mosques that Hindu hardliners believe were built on the ruins of temples.

It was one of the three templemosque rows, besides Ayodhya and Mathura which the BJP raised in the eighties and nineties that gained national prominence.

Scam-tainted Vyapam rechristened yet again

It is the third time that Vyapam has been renamed since the multi-crore scam in 2013

Bhopal, Oct 14: Scam-tainted Vyapam, which was renamed as the Staff Selection Board (SSB) in February this year, will now be called the 'Madhya Pradesh Employees Selection Board' (MP-ESB). The Shivraj Singh Chouhanled BJP government has renamed the board twice within a span of seven months, while it is the third time that Vyapam has been renamed since the multi-crore scam broke in 2013.

The state government first rechristened it as the Professional Examination Board (PEB) in 2015. In February this year it

Hand pump spews out liquor as police seize underground drums

Guna (MP), Oct 14: Hand pumps are generally associated with supplying water but in Bhanpura vil lage in Madhya Pradesh's Guna district a hand pump spew out liquor when police busted an illegal liquor den and seized huge stock, an official said Wednesday.

Police raided the village Monday and during a search, they recovered a total of eight drums filled with raw liquor buried underground or hidden under fodder in agriculture fields

A hand pump attached with the drums of raw liquor hidden underground was also recovered When police personnel started pumping it, liquor started coming out from the other end (joined by a pipe), said Guna superintendent

of police, Pankaj Shrivastava. Police also recovered huge quan-



tities of country-made liquor stored in drums which were hidden under the debris of fodder in farms.

Prime facie, people dealing in illegal liquor trade had dug underground pits to hide liquor-filled drums. They were using a hand pump to take out liquor from these drums which are then filled in pouches and five-litre cans, Shrivastava said.

He said police conducted the raid on a tip-off but the persons involved in the sale of illegal liquor managed to flee.

Police have identified eight persons and a search is on to nab them, the police officer said. He said the village is dominated by a community and country-made liquor is being produced in almost every household there. Shrivastava said the police had conducted raids in the past also. Further investigation is underway, he added.

We have placed 11 cameras to monitor its movement. Five more cameras will be installed soon," Bhopal divisional forest officer (DFO) Alok Pathak told PTI.

The official said a tiger marks a territory of around 25 square kilometres and then moves in it, killing and resting.

"The livestock has been moved out of the MANIT campus completely. Now we think it will move out. Around 50 forest personnel are monitoring the movement of the tiger. It is currently in a low-lying area like a ravine spread over 300-400 acres connected to the cam-

pus," Pathak added. He said the some 5,000 hostellers and 1,000 kin of staff live on the campus, some 100 acres of which is

covered by thickets. Tigers from Ratapani Wildlife Sanctuary, spread in Raisen and Sehore districts close to Bhopal, sometimes move into the Kerwa area of the state capital. This time, one of them, identified as T-123-4, has strayed into the educational facility, he said.

The top court was hearing a plea filed by Kapoor challenging the arrest warrants issued against her for allegedly insulting soldiers and hurting the sentiments of their families in the web series aired on her OTT platform ALTBalaji.

"Something has to be done. You are polluting the minds of the young generation of this country. It is available to all. OTT (Over The Top) content is available to all. What kind of choice are you providing to the people?....On the contrary you are polluting the minds of youngsters," a bench of Justices Ajay Rastogi and CT Ravikumar said.



The court made the observation after senior advocate Mukul Rohatgi, appearing for Kapoor, submitted that a petition has been filed before the Patna high court but there is no hope the matter will be listed for hearing soon.

He said the top court had earlier granted protection to Kapoor in a similar matter. Rohatgi said the content is subscription based and that there is freedom of choice in this country. The court, which stopped short of imposing costs, then wondered what kind of choice is being given to people.

Two Indians missing in Kenya since July: MEA

New Delhi, Oct 14: Two Indian nationals went missing in Kenya in July and India has been in touch with the Kenyan authorities on the matter, the Ministry of External Affairs (MEA) said Friday.

The Indians have been identified as Zulfigar Ahmad Khan and Zaid Sami Kidwai, according to MEA spokesperson Arindam Bagchi.

"As far as we understand, there were two Indian nationals, Zulfigar Ahmad Khan and Zaid Sami Kidwai, and they have been missing in Kenya since mid-July. A police complaint was filed there soon after that," he said. "Subsequently, a habeas corpus petition was filed in the Kenyan court.

"We understand that the issue is now sub-judice in the high court of Kenya and a number of hearings have taken place," Bagchi said. He said the Indian High Commission in Kenya has been in continuous touch with the Kenvan authorities. "We are also, I think, in touch with some family members... We are keeping a close eye on the issue... I am afraid they're still missing," Bagchi said. To a question on the latest ad-

visory by the Indian embassy in Ukraine asking Indian nationals to avoid all non-essential travel to and within that country. Bagchi said it was issued in view of heightened sense of risk

Electoral bond scheme transparent, SC told

New Delhi, Oct 14: The Centre Friday told the Supreme Court that the electoral bonds scheme is an absolutely transparent mode of political funding.

No breakthrough at India-China diplomatic dialogue

New Delhi, Oct 14: India and China agreed on Friday to hold the next round of military-level talks at an early date to resolve the remaining issues in eastern Ladakh and create conditions for the restoration of normalcy in the bilateral ties, the Ministry of External Affairs (MEA) said.

It was the only decision taken at a meeting of the Working Mechanism for Consultation and Coordination on the India-China Border Affairs as there was no breakthrough to resolve the issues at the key friction points of Demchok and Depsang.

The MEA said the two sides agreed to continue discussions through diplomatic and military channels to resolve the remaining

issues "at the earliest" so as to create conditions for the restoration of normalcy in the bilateral relations

"To achieve the objective of resolution of remaining issues along the LAC in the Western Sector in accordance with the existing bilateral agreements and protocols, they agreed to hold the next (17th) round of the Senior Commanders meeting at an early date," the MEA said in a statement. Though the two sides disengaged

from Patrolling Point 15 (PP-15) last month, there has been no progress on resolving the standoff in the Demchok and Depsang The MEA said the two sides

reviewed the situation along the Line of Actual Control (LAC) in the Western Sector of the India-

China border areas.

Eastern Ladakh is officially referred to as the Western Sector. India and China held a high-level military dialogue July 17 that lasted for nearly 12 hours and a half.

In line with a decision taken at the meeting, the two sides carried out disengagement from The eastern Ladakh border standoff erupted May 5, 2020, following a violent clash in the Pangong lake areas

Both sides gradually enhanced their deployment by rushing in tens of thousands of soldiers and heavy weaponry

Japan to scrap century-old law

Tokyo: Japanese cabinet ministers Friday approved the scrapping of a law that stipulates women pregnant at the time of a divorce must wait 100 days before marrying again. The law, in place for more than a century, does not apply to men and was originally intended as a way to aid the identification of the father who is financially responsible for a newborn baby. Critics have campaigned for a withdrawal of the 1896 law -- which had banned remarriage for six months until being revised in 2016 -- calling it outdated and discriminatory.

UK gives GBP 10mn more for Pak flood

Islamabad: The UK on Friday announced an additional GBP 10 million humanitarian assistance for flood relief efforts in Pakistan, bringing the country's total contribution to GBP 26.5 million. According to Pakistan's National Disaster Management Authority, the unprecedented floods that have submerged huge swathes of the country have so far killed nearly 1700 people and destroyed or damaged 2 million houses. As many as 546,000 people are living in relief camps. The disaster has also damaged 12,716 km of roads and 22,000 schools. In total, 745 health centres have been damaged or destroyed.

Sikh family killings: **Not guilty pleaded**

San Francisco: The man accused of kidnapping and then killing the eight-monthold baby and her family earlier this month Thursday pleaded not guilty. Jesus Salgado allegedly kidnapped eightmonth-old Aroohi, her parents, and her uncle at gunpoint from their trucking business October 3. The 48-year-old accused entered his not-quilty plea Thursday morning, KFSN TV reported, adding that the accused is scheduled to return to court next month and remains in jail on no bail.

Harry Potter's Hagrid no more

Washington: Scottish actor Robbie Coltrane, best known for playing the lovable half-giant Rubeus Hagrid in the Harry Potter movies, has died. He was 72. The actor's agent Belinda Wright said he died Friday at a hospital in Scotland. She did not give a cause. Truss takes U-turn to survive

London, Oct 14: British Prime Minister Liz Truss fired her finance minister Kwasi Kwarteng Friday and scrapped parts of their economic package in a desperate bid to stay in power and survive the market and political turmoil gripping the country.

Kwarteng said he had resigned at Truss's request after being forced to rush back to London overnight from IMF meetings in Washington.

Truss, in power for only 37 days, then told a news conference she would now allow a key business levy to rise from next year, raising 18 billion pounds, as she accepted she had gone "further and faster" than markets had been expecting.

Truss appointed Jeremy Hunt, a former foreign and health secretary, to replace Kwarteng.

'You have asked me to stand aside as your Chancellor. I have accepted," Kwarteng said in his resignation letter to Truss, which

Dubai, Oct 14: Iran's Supreme Leader Ayatollah Ali Khamenei said Friday that no one should dare think they can uproot the Islamic Republic, in his toughest warning to protesters since Mahsa Amini's death in police custody ignited nationwide unrest now in its fourth week.

Demonstrations by people from all walks of life over the Iranian Kurdish woman's case have evolved into widespread calls for the downfall of Khamenei and for "Death to the Islamic Republic'

Khamenei compared the Islamic Republic to an unshakeable tree. "That seedling is a mighty tree now and no one should dare think they can uproot it," he said in remarks shown on state TV.

Police deployed heavily Friday in a predominantly ethnic Arab city after activists called for protests, a witness said, as the unrest showed no sign of abating

Some of the deadliest unrest has been in areas home to ethnic minorities with long-standing grievances against the state, including Kurds in the northwest and Baluchis in the southeast.



Rights groups say more than 200 people have been killed in the crackdown, including teenage girls.

Amnesty International said at least 23 children have been killed by security forces in Iran during the protests. The victims, aged between 11 and 17, include 20 boys and 3 girls. Amini died Sept 16 after being arrested in Tehran by Iran's morality police for "inappropriate attire"

Iran has blamed the violence on enemies at home and abroad, including armed separatists and Western powers, accusing them of conspiring against the Islamic Republic and denying security forces have killed protesters. State TV reported at least 26 members of the security forces have been killed

Detained kids end up in psychological centres

Dozens of Iranian children have been killed and hundreds detained after being caught up in protests over Mahsa Amini's death, some of them even ending up in "psychological centres", it has emerged. Fed up over the lack of change, the country's Gen-Z teens -- those born before 2010 -- have come of age and been credited for their bravery while facing off with the security forces. "Iranian Zoomers are frustrated/angry with the status quo and aren't afraid to say it online and push outside the red lines" of the Islamic republic, tweeted Holly Dagres, an Iran specialist at the Atlantic Council think tank. The report said families were being "kept in the dark" about the whereabouts of their children, and that their cases were going ahead without proper legal representation. Amnesty International said Iran's "unrelenting brutal crackdown" involved an "all-out attack on child protesters" that had cost the lives of at least 23 minors.

Russia is not looking to destroy Ukraine: Putin

Putin's comments appeared to suggest a slight softening of his tone as the war nears the end of its eighth month REUTERS

Astana, Oct 14: Russian President Vladimir Putin said Friday there was no need for massive new strikes on Ukraine and that Russia was not looking to destroy the country.

Putin told a news conference at the end of a summit in Kazakhstan that his call-up of Russian reservists would be over within two weeks and there were no plans for a further mobilisation.

He also repeated the Kremlin position that Russia was willing to hold talks, although he said they would require international mediation if Ukraine was prepared to take part.

But Putin - who has said he would be ready to use nuclear weapons to defend Russia's "territorial integrity" - also warned of a "global catastrophe" in the event of a direct clash of NATO troops with Russia.

He was speaking after a week when Russia has staged its heaviest missile attacks on Kyiv and other Ukrainian cities since the start of its invasion of Feb 24 - an action that Putin has said was retaliation for an attack that damaged a Russian bridge to unilaterally annexed Crimea.

Putin also described India and China as "close allies and partners" and said that the two Asian giants always talked about the need to initiate a dialogue and resolve the Ukraine conflict peacefully, nearly a month after Prime Minister Narendra Modi told him during a summit that today's era

Indian PhD student in Australia has been stabbed multiple times in the face, chest and abdomen by a man he had never met before, prompting India to demand strict action against the perpetrators.

The incident took place October 6, as Shubham Garg walked along the Pacific Highway, Sydney, New South Wales Police Force said.

Police have arrested Daniel Norwood and the 27-year-old suspect is charged with attempted murder after Garg, allegedly suffered multiple stab wounds to the face, chest and abdomen, the Daily Telegraph newspaper reported.

Garg suffered multiple stab wounds to his face, chest, and abdomen. He sought assistance from a nearby house before being taken to Royal North Shore Hospital. The man underwent surgery and remains there in a serious but stable condition, the NSW Police Force said.

Garg was approached by an unknown man near the Pacific Highway Lane Thursday. The unknown man allegedly threatened him while demanding cash, media reports said. The man refused and was allegedly stabbed a number of times in the abdomen before the assailant fled, the reports said.

Following extensive inquiries by detectives, a search warrant was executed on a home on the Pacific Highway at Greenwich at about 3.40 pm Sunday. Norwood was arrested at the scene and was taken to Chatswood Police Station, where he was charged with one count of attempted murder after the alleged stabbing, the statement said.

Meanwhile, the Ministry of External Affairs (MEA) in New Delhi Friday said that the High Commission in Canberra is in touch with the local authorities over the incident and expects action to be taken against the perpetrators.

The Indian High Commission in Canberra and the consulate in Sydney are in close touch with the local authorities and a suspect is in custody. "It is a sad incident. He (Garg) is in a hospital and treatment is being done," Bagchi said.

US House Jan 6 committee votes to subpoena Trump

Washington, Oct 14: The US House of Representatives committee probing the Jan 6, 2021, attack on the US Capitol by Donald Trump's supporters voted unanimously Thursday to subpoena the former president, a move that could lead to criminal charges if he does not comply.

The House select committee's seven Democratic and two Republican members voted 9-0 in favor of issuing a subpoena for Trump to provide documents and testimony under oath in connection

with the storming of the Capitol. The vote came after the committee spent more than two hours making its case - via statements from members, documents, and recorded testimony - that Trump planned to deny his 2020 election defeat in advance, failed to call off the thousands of supporters who stormed the Capitol, and followed through with his false claims that the election was stolen even as close advisers

told him he had lost. Federal law says that failure to comply with a congressional subpoena is a misdemeanor, punishable by one to 12 months imprisonment. If the select committee's subpoena is ignored, the full House must vote on whether to make a referral to the Department of Justice, which has the authority to decide whether to bring charges.



According to the data released Friday, imports during the month under review increased by 8.66 per cent to \$61.61 billion. The trade deficit in September 2021 was \$22.47 billion.

During April-September 2022. exports recorded a growth of \$16.96 billion to \$231.88 billion. Imports rose by 38.55 per cent to \$380.34 billion, while the trade deficit widened to \$148.46 billion against \$76.25 billion in September 2021, the data showed.

Exports of key sectors such as engineering, RMG (ready-made garments) of all textiles, plastic, cashew and carpet recorded negative growth in September this year.



The boom in India comes despite economic challenges elsewhere in the world, with broadening inflation in the aftermath of the Russia-Ukraine war and

sharply higher interest rates. The spending is also being boosted by credit expansion, which hit a 10-year high of 16.2% in August as firms and consumers took out loans to fund investments and purchases, according to the central bank.

The retail boom is also a boon for the government - goods and services tax collections, a barometer of consumer demand, rose 26% yearon-year in September, data showed.

INDIA START FAVOURITES AGAINST SRI LANKA IN PURSUIT OF SEVENTH WOMEN'S ASIA CUP TITLE

Sylhet, Oct 14: A ruthless Indian team would look to reassert their supremacy and aim to win an unprecedented seventh Asia Cup title when they clash with Sri Lanka in the final here Saturday.

The tournament brought to fore India's depth as the younger crop of players has shouldered the burden of taking the team to the final without any tangible contribution from skipper Harmanpreet Kaur and her deputy Smriti Mandhana.

Such has been the impact of the Indian team, that skipper Harmanpreet played only four games (81 runs) and in total faced a only 72 balls in those matches. Even Mandhana, who led in three games, skipped one game and didn't need to contribute much.

The biggest takeaway from a tournament like this is that Indian team's junior members could react to pressure situations in a perfect manner when they were thrown at the deep end of the pool.

The most heartening aspect was how three 'seasoned' youngsters -18-year-old Shafali Verma (161 runs and 3 wickets), 22-year-old Jemimah Rodrigues (215 runs) and 25-yearold Deepti Sharma (94 runs and 13 wickets) put their hands up and carried the team through to the summit clash.

The only blip in an otherwise flawless campaign was a defeat against arch-rivals Pakistan due to some bizarre planning by coach Ramesh Powar and Harmanpreet. India won't get a chance to settle scores with Pakistan at least in this edition as Sri Lanka knocked them out in the semifinals.

At least on paper, the summit clash is a complete mismatch as only one Sri Lankan batter (Oshadi Ranasinghe) has managed to scale the 100-plus strike-rate.

Only two batters – Harshitha Madavi (201 runs) and Nilakshi de Silva (124 runs) - have accumulated 100 plus runs across matches.

Even their most well-known woman cricketer Chamari Athapaththu has scored 96 runs at a below par strike-rate of 85 plus. In bowling, only left-arm spinner Inoka Ranaweera (12 wickets) has looked the part.

To put it bluntly, the quality of competition in Asia Cup isn't great and India as a team in terms of talent quotient as well as experience is a few lightyears ahead of the other neighbouring nations.

Hence, Sri Lanka might find it extremely difficult to upset the Indian applecart although in the last edition in Malaysia, four years back, Bangladesh did shock the favourites in the final.

The Sri Lankan women enthralled the cricket lovers across the globe with a celebratory dance

video (after beating Pakistan), which has since then gone viral. But if Saturday, they could get past Harmanpreet's team, it will be an icing on the cake with its men's team having already won the Asia Cup, a month back.

What would make India runaway favourites is the depth in their slow bowling department where Deepti, Rajeshwari Gayakwad and Sneh Rana have all been very economical.

Such have been the conditions that seamers Renuka Singh and Meghna Singh were not required much. Meghna, in fact didn't play the semifinal against Thailand.

The track at the Sylhet stadium has been on the slower side where stroke-making is extremely difficult. In the round robin encounter between the two teams, India batted first and scored 150 and bowled out Sri Lanka for 109.

New Delhi, Oct 14: The BCCI Friday named seasoned pacer Mohammed Shami as injured Jasprit Bumrah's replacement in the Indian team for the upcoming T20 World Cup in Australia.

"The All-India Senior Selection Committee has named Mohammed Shami as Jasprit Bumrah's replacement in India's ICC Men's T20 World Cup squad. Shami has reached Australia and will link up with the squad in Brisbane ahead of the warm-up matches," BCCI secretary Jay Shah was quoted in a press release.

That Shami would replace Bumrah in the main squad was reported by PTI last month. Mohammed Siraj and Shardul Thakur have been named as backups and will travel to Australia shortly. The tournament will be held from October 16 to November

Bumrah has been ruled out of competitive cricket for an indefinite period due to stress related injury on his back. Shami had last played in T20 Internationals during the last edition of the ICC T20 World Cup in the UAE.

He was supposed to play in the six T20Is at home against Australia and South Africa but tested positive for CIVID-19 and had to remain in isolation. On return he had to prove his fitness before NCA approved his trip to Australia. Shami has played 17 T20Is and has taken 18 wickets.

India's Pakistan tour in plan

NEW DELHI: The Indian cricket team may tour Pakistan after a gap of 15 years, the BCCI has indicated ahead of its all important Annual General meeting (AGM) October 18 in Mumbai. The BCCI has shared with all its state unit representatives a lowdown of the work done during the past year along with future plans and schedule of the national team's tours, which includes Asia Cup in Pakistan next year. According to the report, the Indian team will be participating in the ICC Women's T20 World Cup (South Africa), ICC Women's U-19 T20 World Cup (South Africa), Asia Cup (Pakistan) and ICC Cricket World Cup, India. With England, Australia, West Indies and Sri Lanka having already toured Pakistan in the past few years, it will be interesting to see how things pan out as BCCI will need central government's permission to allow the team to travel to Pakistan. "Obviously, when the time comes, it will be a government decision. But there is one aspect. The government allows India versus Pakistan contests in global and continental events. So there is a chance of India travelling but it will be too early to completely commit that a team will go to Pakistan. But putting it on report is a broad hint," a senior BCCI source told PTI on conditions of anonymity.

Govt denial couldcost BCCI ₹955cr

New Delhi, Oct 14: The BCCI could lose around ₹955 crore (USD 116 million) if the central government sticks to its decision to levy 21.84 percent tax surcharge on ICC's broadcast revenue from the 2023 ODI World Cup, according to a Board report. India is to host next year's 50-over showpiece in October-November.

Tax surcharge refers to "an additional charge, fee, or tax that is added to the cost of a good or service beyond the initially quoted price". A surcharge is often added to an existing tax and is not included in the stated price of the good or service.

As per ICC norm, the host nation is required to get tax exemption from the government for hosting tournaments organised by the global body.

Since India's tax rules don't allow such exemptions, the BCCI has already lost close to ₹193 crore (USD 23.5 million) as the government didn't exempt tax surcharge for hosting the 2016 ICC T20 World Cup. The BCCI is still fighting that case in the ICC tribunal

"The next ICC major men's event, which is the ICC Cricket World Cup 2023, is scheduled to be held in India in the month of October & November in 2023. The BCCI was obligated to deliver a tax exemption or a tax solution to the ICC for this event, latest by April 2022," stated the report circulated among state units ahead of the Board's October 18 AGM in Mumbai.

"This time line was further extended by the ICC Board till 31st May 2022. At the start of this financial year, the BCCI had advised the ICC that in line with the tax order for the 2016 event, it was expected that a 10% (excluding surcharges) tax order could be obtained as an interim measure for the 2023 event within the required time frame.

'The ICC has now received a



20% (excluding surcharges) tax order for its broadcast revenue for the 2023 event from the tax authorities in India.

According to the BCCI document shared with the state bodies, the adverse impact on the Board's revenue from the ICC, if a 21.84 percent tax is paid, would be USD 116.47 million.

It is understood that the BCCI is still trying to negotiate and bring down the tax surcharge percentage to 10.92 percent from the existing demand of 21.84. If the BCCI can reduce the tax surcharge to 10.92 percent, then the revenue loss would be around ₹430 crore (USD 52.23 million).

"It is to be noted that any tax cost incurred by the ICC for the 2023 event in India will be adjusted with the BCCI's share of revenue from the ICC," the report further stated.

The BCCI's share from the ICC's central revenue pool for the tenure 2016 to 2023 is USD 405 million (Rs 3336 crore approximately). The ICC is expecting USD 533.29 million (Rs 4400 crores approx) from the broadcasting revenue of the 2023 event in India.
