TRUSS THROWS IN **TOWEL AMID CRISIS** PRESS TRUST OF INDIA

London, Oct 20: Embattled British Prime Minister Liz Truss resigned Thursday as the Conservative Party leader. Truss said she can no longer deliver the mandate she was elected on last month, ending her tenure at 10 Downing Street after just 45 days in the job following an open revolt against her chaotic leadership.

The 47-year-old outgoing prime minister will stay in charge until her successor is elected by the governing Tory party, with a speededup leadership election to be completed by next week.

Truss was Britain's third female Prime Minister after Margaret Thatcher and Theresa May.

Truss' former leadership rival, Rishi Sunak, is seen as a frontrunner in the race for PM, but a consensus within a divided Tory party remains elusive, with the Opposition Labour Party renewing calls for an immediate general election.

"I recognise though that given the situation, I cannot deliver the mandate on which I was elected by the Conservative Party," Truss said in a brief statement outside 10 Downing Street.

Odisha may escape **Cyclone 'Sitrang' fury**

As per IMD predictions, the storm is expected to head towards West Bengal and Bangladesh after skirting some coastal districts of Odisha

Bhubaneswar, Oct 20: In wha may be a major relief for Odisha, the India Meteorological Department (IMD) said Thursday that the anticipated Cyclone 'Sitrang' in all probability will skirt the Odisha coast and move towards West Bengal -Bangladesh coasts. However, due to its effect, a number of districts in Odisha are likely to experience heavy to very heavy rainfall.

In a special bulletin, the Regional Meteorological office of the IMD informed that a low pressure area has formed Thursday morning over north Andaman Sea and adjoining areas of south Andaman Sea and Southeast Bay of Bengal Thursday morning. It is very likely to move west-northwestwards and concentrate into a depression over east central and adjoining southeast Bay of Bengal around October 22 and into a deep depression October 23.

"Subsequently, it is likely to recurve northwards and intensify into a cyclonic storm over west-central and adjoining east-central Bay of Bengal by October 24. Thereafter,



it is likely to gradually move northnortheastwards and reach near the West Bengal-Bangladesh coasts by October 25, skirting Odisha," IMD DG Mrutunjay Mohapatra said. He however, said the IMD is yet to make a forecast on the intensity and wind speed of the cyclone.

Mohapatra said coastal Odisha will experience heavy to very heavy rainfall in isolated places. Rainfall due to the effect of Cyclone 'Sitrang' is likely to commence from the early hours of October 23 over

coastal districts of Odisha. Under its impact, heavy rain-

fall (7 to 11cm) would occur at one or two places in the districts of Kendrapara, Jagatsinghpur and Puri October 23 and in the districts of Balasore, Bhadrak, Kendrapara, Jagatsinghpur, Mayurbhanj, Jajpur, Cuttack, Khurda and Puri, the next day.

Revenue Minister Pramila Mallik said that collectors of a number of districts, including Ganjam, Puri, Khurda, Jagatsinghpur, Kendrapada, Bhadrak and Balasore have been asked to keep adequate stocks of essential medicines, drinking water and other items in good quantities.

Plea against lengthy court holidays been filed, but to no avail. On this

Mumbai, Oct 20: The Bombay High Court said Thursday it would hear after Diwali holidays, a public interest litigation (PIL) challenging the practice of courts taking long vacations, thereby affecting filing and hearing of cases. The Bombay High Court's Diwali vacation is from October 22 to November 9.

It should also be stated here that the Supreme Court will be having Diwali holiday's October 24 to October 29. However, with October 30 being a Sunday the apex court of India will reopen October 31.

The PIL has been filed by Sabina Lakdawala challenging the vacations taken by the high court. Lakdawala's lawyer Mathews Nedumpara said the petitioner was not against judges taking holidays but members of the judiciary



time so that the courts remain functional throughout the year.

The plea was filed before a division bench of Justices SV Gangapurwala and RN Laddha seeking urgent hearing. The bench asked the lawver why the petition was filed now when the high court calendar for 2022 was made available in November last year itself. The Bombay high court said it

would hear the plea November 15. It is pertinent to mention here that earlier also, such pleas had

occasion however, the Bombay High Court has decided to hear it.

Courts in India usually take three breaks every year - summer vacation (one month), Diwali (two weeks) and Christmas (one week). However, during the holidays, special vacation benches are available for urgent judicial work.

In her petition, Lakdawala said the long court vacations are relic of the colonial era and have contributed to a collapse of the judicial delivery system. The plea has sought for a declaration that closing courts for more than 70 days for any kind of vacation is a violation of fundamental rights of litigants because it leads to courts becoming unable to hear cases for lack of time.

"Requisite break for lawyers and judges can be provided without the entire institution being shut down," the plea said.

Firecrackers seized

BHUBANESWAR: Commissionerate Police busted Thursday an illegal firecracker shop in Unit-I locality here and seized goods worth ₹20 lakh. The shopkeeper who did not have a licence to sell firecrackers was also arrested, police said. Personnel from the Capital police station raided the shop after getting a tip-off from a reliable source. Police said that such raids will continue leading up to Diwali.

Google fined ₹1,337cr

NEW DELHI: The Competition Commission of India (CCI) imposed Thursday a penalty of `1,337.76 crore on Google for abusing its dominant position in multiple markets in the Android mobile device ecosystem. The fair trade regulator has also directed Google to cease and desist from unfair business practices. In a release, the CCI said it has directed Google to modify its conduct within a defined timeline.

Tusker kills woman in Sundargarh village

Sundargarh, Oct 20: An elderly woman was killed by an elephant while another person was injured at Kulba village under Ujjwalpur Forest Range in Sundargarh district Thursday morning. The deceased was identified as

Renuka Sahu of Kulba village while the injured was Binod Luhara, who belonged to a neighbouring village. Sources stated that Renuka was attacked by the tusker when she had stepped out of her house early in the morning. A few minutes later Binod who was treading the same path was also attacked. However, despite being injured he managed to flee the spot. He was later rescued by others and rushed to the district headquarters hospital where he is undergoing treatment.

The attack took place after the Forest department personnel who were on night patrolling had left the place. Sources said that the elephant has been roaming in the nearby forests for some time now. They informed that the pachyderm stays inside the forest during the day and sneaks into neighbouring villages at night in search of food.

Locals demanded adequate compensation for the family of the deceased when police officials reached the spot. They also demanded free treatment for the injured person.

This is the second such incident in a week. An elderly woman hadbeen trampled to death by an elephant in the village October 14.

Jeypore airstrip gets DGCA permission

New Delhi, Oct 20: India suffered an income loss of USD 159 billion, 5.4 per cent of its gross domestic product, in the service, manufacturing, agriculture, and construction sectors due to extreme heat conditions in 2021, according to the 'Climate Transparency Report 2022'. It said that heat conditions led to the loss of 167 billion potential labour hours, a 39 per cent increase from 1990-1999

Labour productivity in India is projected to decline by five per cent



India incurs \$159bn loss due to heat in 2021

from the 1986-2006 reference period if global temperatures increase by 1.5 degrees Celsius, the report said. The decline will increase to 2.1 times more if global temperatures increase by 2.5 degrees Celsius, and 2.7 times at a three-degree Celsius scenario.

The report also said that drastic reduction of green cover in India is leading to the rise in temperatures. Unless green cover is increased and water conservation maintained in a proper manner there will be no respite from extremely high temperatures

From 2016 to 2021, extreme events such as cyclones, flash floods, floods, and landslides caused damage to crops in over 36 million hectares. a USD 3.75 billion loss for farmers in India, the report said The annual damage from river flooding in India is likely to increase by around 49 per cent at 1.5 degree Celsius of warming. The

damage from cyclones will increase by 5.7 per cent, if temperatures do not decrease, the researchers pointed out. 'The annual expected damage from tropical cyclones and river

flooding at three degrees Celsius is 4.6 to 5.1 times that from 1.5 degrees Celsius," the report said. The rainfall pattern in India has



RTI exposes Sentence Review Board's inertia

Bhubaneswar, Oct 20: Close on the heels of Orissa High Court's recent concerns over overcrowded jails in the state, a Right to Information (RTI) plea has exposed 'poor' functioning of the State Sentence Review Board (SSRB), which helps in decongesting the jails after a review

It is learnt that most of the jails, especially the district and sub jails, are holding inmates far more than their sanctioned strength

Replying to the RTI application filed by rights activist Biswapriya Kanungo, the state Prisons Directorate and Correctional Services revealed that the board had met nine times against the mandatory 13 times during the period from January 2019 to April 2022.

Similarly, the SSRB has been mandated to consider release of prisoners serving life terms and those who have already spent 14 years of actual imprisonment. The directorate also said in its reply that as the board has recommended the state for the release of 405 inmates between 2019 and April 2022. Out of that, the board has recommended for the premature release

of only one woman prisoner. As per rules, prisoners convicted of serious offences are also eligible for premature release after

The guidelines further enjoined that the period of incarceration even in such cases should not exceed 25 years.

As per the information, the board considered the premature release of five inmates each who served 26 and 27 years, four persons who served 28 years and one convict who served 29 years in jail.

As many as four convicts were selected for premature release after they spent 30 years while one each after they served 34, 35 and 36 years respectively in jail.

The board recommended the release of 28 prisoners who had served 20 years during the above period. Interestingly, a person aged above 75 years was released from jail during the above period.

Although the Odisha Human Rights Commission has suggested the names of six convicts for premature release, the SSRB has rejected the cases citing various technical issues.

'The board has never been taking into consideration the socio economic condition of the convicts' families while scrutinizing the suggestions sent by jail authorities for premature release. A convict is not sent to jail as a punishment but to bring changes in their behaviour. But, keeping convicts in jails for so long, in spite of NHRC suggesting a maximum period of 25 years, is shameful and a cruel joke on the jail reforms," Kanungo said.

Bhubaneswar, Oct 20: Following Centre's direction to make vehicle location tracking (VLT) system mandatory in public transport vehicles and goods carriages under Nirbhaya Scheme for women's safety, the State Transport Authority (STA) Thursday signed a memorandum of understanding (MoU) with Bharat Sanchar Nigam Limited (BSNL) for development, management and operation of an application.

The agreement was signed by additional commissioner of Transport (Technical) Dhananjaya Senapati and BSNL, Cuttack general manager Pradeep Kumar Mallick.

The STA will implement VLT application for safety and enforcement as per AIS-140 Standard to track the public transport and

commercial vehicles in the state.

BSNL under 'Vahan Suraksha' model will develop, deploy, integrate and commission a VLT software for tracking and monitoring of vehicles covered under the project. The telecom service provider will also develop mobile application for various stakeholders and users and commission Geographic Information System (GIS) map for vehicle location tracking system.

Speaking at the event, state transort commissioner Arun Bothra said, "The objective of the project is to introduce a tracking system as required for implementation of central notifications for continuous monitoring of public transport vehicles for safety of passengers, better road safety and better support for enforcement services. This will also help in keeping track of public buses running as per the permit."

A command control centre is



being set up in Bhubaneswar to track the vehicles plying across the state. The 24X7 integrated command control centre will use both Global Positioning System (GPS)based vehicle tracking and the GSM/GPRS channel for triggering emergency alerts. The common emergency toll lines, motor vehicles wing, the police control room and related enforcement units will

be looped into a real-time data sharing network with the command centre functioning as an interface for stakeholder agencies

Most states failed to collect mining data



o states, barring Chhattisgarh and Odisha, have started the system of collecting data related to mining operations and thus failed to detect production loss and verify the mineral output claimed by miners, according to a report

This apart, states like Gujarat, Kerala, Rajasthan, Uttar Pradesh and West Bengal could not furnish the extraction figures of major minerals, said the Natural Resource Accounting report.

The report prepared by the government accounting standards advisory board under the aegis of Comptroller and Auditor General (CAG) of India further said that since states like Guiarat, Kerala Meghalaya, Rajasthan, Tamil Nadu, Uttar Pradesh and West Bengal could not provide the extraction figures of major minerals, their accounts had to be based on production figures only.

Further, Madhya Pradesh did not have extraction as well as production figures and accordingly their asset accounts

There is no system for issuance of premits/transit passes for coal on advance payment of royalty, which is a pre-req-

uisite as per the MMDR Act, 1957. There is no control and monitoring of the mining officers on production and dispatch of coal from the mine head. The lessees have their own system of issuing permits/passes and weigh-bridges for measurement, which has no involvement of mines department per-

sonnel, it said. The department also does not have any weigh-bridges or check gate to monitor actual dispatch of coal.

Assessment of revenue is done solely on the basis of returns furnished by the lessees.

"This system is highly susceptible to illegal mining, pilferage of minerals leading to windfall gains to the lessees and connected parties and commensurate loss to the state exchequer," it said.

The state government may take suitable action to establish control and monitoring system and may also look into any case of pilferage of resources leading to revenue loss to the state exchequer.

'Snowfall in India is expected to decrease under 15 degrees Celsius scenario by 13 per cent when compared with the reference period's snowfall levels. At three degrees Celsius of warming, the decrease is expected to be 2.4 times the 1.5 degrees Celsius scenario. It will then create unbearable heat conditions in India," the report stated.

Earth's global surface temperature has increased by around 1.1 degrees Celsius compared with the average in 1850-1900.

To address climate change, countries adopted the Paris Agreement in 2015 to limit global temperature rise in this century to well below two degrees Celsius, preferably to 1.5 degrees Celsius, compared to pre-industrial levels. Suruchi Bhadwal director at 'The Energy and Resources Institute' said, "Extreme weather events in our regions have shown that the effects of climate change are increasing, and more and more people are being affected. So a preventive system has to be put in place.'

Erosion-hit villagers stage hunger strike PRESS TRUST OF INDIA

Kendrapara, Oct 20: Residents of some villages in the state's Kendrapara district, which have been affected by sea erosion, launched an indefinite hunger strike Thursday, seeking immediate rehabilitation to safer places.

The proposed rehabilitation plan for the 40 affected families of the Satabhaya cluster of villages here is moving at a snail's pace, according to the protesters. 'We were forced to adopt such a

path for the fulfilment of our demands," one of the protesters said.

Kendrapara sub-collector Niranjan Behera said the district administration would take proper steps for their rehabilitation after examining their demands.

ministration had relocated 571 families of Satabhaya to a rehabilitation colony at Bagapatia, 12 km from the sea. Forty families that were "left behind", however, are yet to find a new home, the agitators said.

Around 200 people of these 40 families "have been left in the lurch" with the government yet to provide them any land in the rehabilitation colony, according to Sarbeswar Mallick, another resident.

"We're now spending sleepless nights as a cyclone is approaching the coast," added 65-year-old Karunakar Mallick. A low-pressure area has formed over the Bay of Bengal on Thursday, and it is likely to intensify into a cyclonic storm over the next four days and approach the coast next week.

India's typhoid burden decreasing, trend shows

yphoid burden is decreasing in India, although overall cases are higher than previously estimated, shows a multiyear study of nationally representative antibiotic prescription data.

The researchers found that young adult patients account for close to one-third of the typhoid cases and children less than 10 years old account for more than a million cases annually. The study, published in the BMJ Open journal, calls for including Indian's own typhoid vaccine in its national immunisation programme.

"The key findings of the study include decline in cases from 9.9 million in 2013 to 7.9 in 2015 -- largely in the north and west regions, but children less than 10 years account for more than a million cases annually, males and boys have the highest burden," Dr. Shaffi Koya, Research Fellow at Boston University School of Public Health. US, told PTI.

"10 different antibiotics accounted for 73 per cent of all prescriptions. Combinations and cephalosporins were the most prescribed antibiotics. Cefixime-ofloxacin combination is the preferred choice except in south India," Koya said.

The data came from prescriptions of a panel of 4,600 private sector primary care clinicians selected through a multistage stratified random sampling. The data had 671 million pre-

scriptions for antibiotics extracted from the IQVIA database for the years 2013, 2014 and 2015.

The members directed the Collector to take steps to ensure that industrial units abide by anti-pollution measures.

Lokayukta to probe ₹50L MGNREGS scam

Nayagarh, Oct 20: Lokayukta has ordered an investigation into alleged irregularities worth ₹50 lakh in some Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) projects at Bhadikila panchayat under Odagaon block in Nayagarh district.

As per reports, Lokayukta held a hearing of the case September 28. Now, a division bench of the Lokavukta pronounced the verdict that Lokayukta director will look into the matter and submit a report on this by December 5.

Notably, funds worth ₹80 lakh sanctioned for some projects under MGNREGS had been misappropriated through forged bills in Bhapur block earlier. Now, funds worth ₹50 lakh for some MGN-REGS projects have been embezzled in Odagaon block. Some media houses had reported on the matter September 25.

The Naked Ayatollah

The nationwide protests in Iran over women's rights and abuses by the religious morality police have once again shined a light on the country's ruling clerical class and the seemingly limitless powers of the Supreme Leader, Ayatollah Ali Khamenei.

The Islamic Republic of Iran has a two-tier government. The first tier, ostensibly representing the sovereignty of the people, includes a president who serves as the executive of a highly centralised state, a parliament charged with creating and debating laws, and a judiciary that vets and interprets those laws. The second tier, representing the sovereignty of God, consists of just one man: the Supreme Leader, or Faqih.

The Faqih has an absolute monopoly over state power. He appoints the head of the judiciary and can dismiss the president at will. He is the commanderin-chief of the army, and he can veto any law passed by Parliament. The office is both anachronistic and utterly unique, allowing for the institutionalisation of clerical control over all aspects of government.

It is also heretical. Far from being the foundation of Shia Islam, as Iran's clerical regime claims, the concept of the Fagih represents neither the historical consensus nor the current majority view of Shia political thought. It is a wholly made-up office, concocted by the man who first claimed the po-

sition for himself: Ayatollah Ruhollah Khomeini. Shi'ism, like Christianity, is messianic. Shia doctrine posits that the temporal world and all its imperfections will be swept away by the appearance of a figure known as the Mahdi, who will one day rule over the earth. Until then, all governments are temporary and illegitimate, as any exercise of direct political power would be considered a usurpation of the Mahdi's divine authority. Thus, for most of the last 1,400 years, Shia clergy have refused to interfere in governmental affairs, instead adopting a position of political quietism.

To be sure, Iran's leading ayatollahs did fight alongside the country's merchants and young intellectuals to create the first indigenous democratic movement in the Middle East. The Persian Constitutional Revolution of 1906 as it came to be known, resulted in the creation of a progressive constitution guaranteeing basic rights and freedoms for all Persians, an independent parliament (the National Consultative Assembly), free elections, and a clear separation of powers.

But the Constitutional Revolution was shortlived. In 1921, a British-backed military coup established the Pahlavi dynasty in Iran. The

constitution was discarded, Parliament was defanged, and the state reverted to dictatorship The Pahlavis brutally suppressed any political activity by the clergy. While a few promi-

nent clerics participated in Iran's second revolution of the century, the socalled Nationalist Revolution of 1953, it wasn't until Iran's third revolution, in 1979, that the clergy left the mosques and entered government.

That development owed everything to Khomeini's unprecedented interpretation of the Mahdi. Countering 14 centuries of Shia doctrine, he argued that, in the absence of the Mahdi – the sole legitimate leader of the Islamic state - political power should rest in the hands of the Mahdi's representatives on Earth: that is, the clergy. Put another way, rather than waiting for the Mahdi to return at the end of time to create the perfect society, the clergy should be empowered to create the perfect society for him so that he will return at the end of time. Khomeini called this theory the Valayat-e Faqih, or "the guardianship of the jurist."

This was an astounding assertion and a radical religious innovation in Shia Islam. Yet Khomeini went even further, arguing that political authority should rest not with the whole of the clergy but with a single "supreme" cleric. He then insisted that, as the deputy of the Mahdi, the supreme cleric's authority should be identical not just to the Mahdi's, but to that of the Prophet Muhammad himself. "When a mujtahid [a qualified jurist] who is just and learned stands up for the establishment and organisation of the government." Khomeini wrote in his political treatise Islamic Government, "he will enjoy all the rights in the affairs of the society that were enjoyed by the Prophet."

No Muslim cleric had ever made so startling a proposal. The notion that any human being could have the same infallible, divine authority as the Prophet contradicts centuries of Islamic theology. The theory was so plainly heretical that it was immediately rejected by almost every other ayatollah in Iran, including Khomeini's direct superiors, the Avatollahs Boroujerdi and Shariatmadari, as well as nearly all the grand ayatollahs in Najaf, Iraq - the religious centre of Shia Islam.

What made Khomeini so alluring was his ability to couch his radical doctrine in the populist rhetoric of the time. Once his colleagues had been intimidated into silence and Iran's pious masses had been stirred to action, Khomeini was free to seize control of the post-revolutionary government. Before most Iranians knew what they had accepted, he had injected his interpretation of the Mahdi into the political realm, transforming Iran into the Islamic Republic and proclaiming himself the country's first Faqih: the supreme temporal and religious authority.

In 1989, Khomeini died and the office of Faqih passed to his handpicked successor, Ali Khamenei, with little clerical or popular resistance. Even though the Faqih was supposed to be Iran's most learned religious authority, Khamenei was little more than a mid-level cleric – not even an ayatollah - with thin credentials. Nevertheless, he was given the office largely because practically every other qualified religious authority in Iran - including Khomeini's first choice as successor, Grand Ayatollah Ali Montazeri - had decried the doctrine of the Fagih as anathema to Islam.

Now 83 and in ill health, Khamenei is widely believed to be grooming his eldest son. Moitaba – a cleric of even lower rank than he was when selected - to succeed him as the next Supreme Leader. That would strip away any last remnant of religious legitimacy the office still maintains, exposing the Faqih for what it actually is: a synonym for Shah.

Should that happen, the protests that would follow could dwarf the uprisings we are seeing today. Already, one of the most frequent chants heard on the streets during the current protests has been "Mojtaba, Bemiri, Rahbari ro Nabini": "Mojtaba, We'll See You Die Before

INSTITUTIONS HAVE AN IMPORTANT ROLE TO PLAY IN DRAWING PRIVATE CAPITAL TOWARD LONG-TERM PROJECTS THAT COULD SPUR DEVELOPMENT IN COUNTRIES AND SECTORS THAT CAPITAL **MARKETS PERCEIVE AS HIGH-RISK**

o spur development and fight climate change, emerging-market and developing economies (EMDEs) will need huge amounts of investment in green infrastructure over the next few decades. But many of these countries have limited fiscal space, especially after the shocks of the last few vears. Given this, to meet the EMDEs' infrastructure needs, we must mobilise excess private savings in the advanced economies. The question is how.

The first step toward building a bridge between private savings and infrastructure investment in EMDEs is to understand investors needs. Institutional investors, like all other types of debt and equity investors, have their own incentives, constraints, and objectives, all of which inform their allocations of funds, including which types of projects (greenfield vs. brownfield) to support, where, and at what stage of the project cycle (development, construction, or operation). Inadequate risk coverage, lack of data, and the heterogeneity of project structures, regulatory environments, and contractual standards can all act as barriers to investment.

The challenge is to define "at tractive investment opportunities" and match investors to them in a more systematic way. Central to this effort should be the provision of a wide range of well-structured investment products tailored for different types of institutional investors and their respective risk/return profiles. For example, institutional investors (such as pension funds) might be inclined to participate at a project's earlier stages (prior to operation) if refinancing risks are covered and construction risk is addressed.

Currency risk poses another challenge for investors in EMDEs. Here, export credit agencies may be able to help, though often at

complexity of the instruments that are available – is yet another potential barrier to infrastructure investment in the EMDEs. Fixed-income instruments - including bonds (project, municipal, sub-sovereign, and green bonds, as well as sukuk), and loans (direct and co-investment lending to infrastructure projects and syndicated project loans) - can help solve this problem, as they could appeal to a broad range of institutional investors in the EMDEs.

Multilateral finance institutions have an important role to play in drawing private capital toward long-term projects that could spur development in countries and sectors that capital markets perceive as high-risk. By providing funding, guarantees, or both, such institutions can de-risk projects and crowd in private investment. They can also bring partners into specific deals through syndications.

For its part, the private sector has a number of instruments at its disposal with which to manage risk. For example, companies can use risk-transfer and credit-enhancement instruments, which are currently being piloted by national and multilateral development banks. These include guarantees, insurance policies, and hedging mechanisms under which, for a fee, a provider agrees to compensate the concessionaire (or its lenders) in case of default or loss arising from some specified circumstance.

Political-risk insurance is particularly important here. Some sectors-such as telecommunications or electricity – are more prone to regulatory volatility or the effects of political pressure (including on prices). This implies the need for greater scrutiny from infrastructure investors and customised riskmitigation mechanisms.

A project's financial structure is key. Experience shows that a diverse mix of funders for a project – including domestic, international, and multilateral banks and owners – can deter political intervention and act as a buffer against shocks. And just as strategic alliances with foreign entities provide local actors with a hedge against political intervention. partnerships with local compa nies can help an infrastructure operator transcend the "foreign investor" label.

In transforming today's savings-liquidity glut into muchneeded investment in green EMDE infrastructure, the public and private sectors both have important roles to play. Policymakers must increase the transparency of legal frameworks and achieve political and regulatory stability, recognising that the public sector will ultimately bear the high transaction costs incurred by private investors when they channel fi nancial resources to EMDEs.

Institutional investors and other financial intermediaries, as well as non-banking financial institutions, often highlight the lack of a pipeline of investment-ready projection ects. To improve their options, the public sector should take more responsibility for project design in situations characterised by significant complexity and regulatory risk, especially when risks are harder to identify and meas ure in advance. The costs of this process can largely be recouped when public-private partnerships (such as concessions) are estab lished. Public-sector planning and priority-setting is essential.

But private investors must also embrace a more active role, including by taking advantage of the risk management tools at their disposal Sophisticated, developed financial markets and instruments would help, by enabling financial agents to take on risks that are in line with their appetites and capacities.

It will not be easy. But with these building blocks, we can construct the most important infrastructure of all: the bridge connecting advanced-country savings and EMDEs' financing needs.

What is more, we are witnessing in China the homologation of positions which points to a personality cult, a practice no longer noticed in recent times.

International political analysts like to point that resistance to Jinping's autocratic style exists in places like Hong Kong, Tibet and Xinxiang, and it will grow. That perspective merits a debate and may be that, dissent can be exacerbated and exploited by China's adversaries like the West in future. But as of now, the prevalent political mood represented by Jinping consists of a few ambitions. One, China wants to collect political dividends for its economic successes. Second, Chinese dream is to become a world power. Beijing seeks to supplant US as the numero uno in the world politics, or share the leadership space. Third, Chinese leadership be-

Jinping for the third term economic growth, political disci-Communist Party the bat-should put forth their system as a viable and replicable option for the world.

The implications of the concentration of power in the hands of Jinping are twofold – national and international. Domestically, China has moved from a one-party to a one-leader country. Internationally, Beijing increasingly prefers greater assertion and continued claim to a world power status to an approach of maintaining a low international profile while steadying its economic growth. This trend has been evident in recent times as Beijing has been making stronger claims to territories and mineral rights in places like South China Sea and traditional Japanese Islands. These claims have alienated East Asian countries like Vietnam, Philippines, South Korea and Japan which are aligned with the USA in security terms, while accommodating China on limited trade and investment.

This is the stark and hard choice many countries have to make, between the USA and China. In doing so, there are atleast three strategies adopted by different countries. One is hedging, which is no longer viable. As the competition between the two big powers intensifies, countries

Second variable is how countries like to play their respective world roles. They will be 'contributor' to a world order or 'recipient' of what is being shaped in other words, shaper or taker.

The third variable in building concrete partnership is 'reliability' of the USA as an international guardian. The US' reputation as a trusted ally and as a defender of democracy is not strong

Where does India stand? New Delhi has been hedging in the name of neutrality. It has been non-aligned between USSR, now Russia and USA. But it is a different ball-game with China, especially when China is a border country occupying and demanding Indian territory. New Delhi goes with USA on security arrangements like Quad and with China on economic groupings like BRICS and SCO.

Admittedly, many countries want to retain their strategic autonomy - South Africa, Brazil, Chile for example. Such stances remind us of the non-aligned movement created in 1960s by India and others, immediately after the decolonisastrategy in an inter-dependent world which later began globalising. However, this strategy can be recalibrated as an 'Alliance of the Progressives', in actual terms, Alliance of the Non-Aligned. Since the latter term is an oxymoron, the former terminology is preferable.

What it means in practical terms is that the alliance of the progressives will be both dispositional and situational corresponding to a country's political values and to its legitimate national interest. India very well fits into this formation -'the third-way' in international politics. Alliance of progressives will enjoin upon in open a country to speak up for progressive values irrespective of whichever country is offended by them. In the alliance of progressives, the national interest of a country will not be downplayed; it would be jointly defined among allies, not by a country alone leading to conflict with other countries. Let India be a leading part of the third way, reformulating the strategy of non-alignment it initiated decades ago. The third way is certainly worth exploring.

New Delhi, Oct 20: Indian Prime Minister Narendra Modi's office said Thursday he would launch a drive this weekend to give government jobs to 1 million people, starting with 75,000 immediate appointments, as he tries to tackle criticism of widespread unem-

Modi's office said the 75,000 new recruits would join 38 ministries or departments of the federal government at various levels of seniority.

"As per the directions of the prime minister, all ministries and departments are working towards filling up existing vacancies against sanctioned posts in mission mode," it said. It was not immediately clear if it meant there were 1 million vacancies in government departments, or if some jobs would be created.

The aim is to fill up the posts by September next year, Modi said in June on Twitter.

India's unemployment peaked at 23.5% in 2020 in the first full year of Covid-19, then fell back as restrictions eased. But it has remained around 7% since, according to data from Mumbai-based the Centre for Monitoring Indian Economy, higher than the global average.

The PMO said this will be a significant step forward towards fulfilling the continuous commitment of the prime minister to providing job opportunities for the youth and

Indian, US militaries conduct 'Tiger Triumph' exercise

New Delhi, Oct 20: The Indian and US militaries carried out a three-day joint humanitarian assistance exercise in Visakhapatnam in line with the growing strategic cooperation between the two countries.

The exercise concluded Thursday. "This week's Tiger Triumph exercise was the second collaboration between the Indian and US militaries to coordinate disaster relief in the region," a readout by the American side said.

The first exercise, also based out of Visakhapatnam, took place over the course of nine days in November 2019 and featured more than 500 US Marines and sailors and approximately 1,200 Indian sailors, soldiers, and airmen. "This year's exercise involves fifty combined participants, and is focused on staff planning, with an emphasis on processes for streamlining diplomatic, operational, and logistical coordination," the readout said.

Tiger Triumph marked the third time in 2022 that the Indian and US militaries have worked together in Visakhapatnam. In February, the US joined India and more than thirty other nations for India's biannual Exercise Milan.

The new recruits, selected from across the country, will join 38 ministries or departments of the Government of India. The appointees will join the government at various levels in Group A and B (Gazetted), Group B (Non-Gazetted) and Group C.

The posts on which appointments are being made include the central armed force personnel, sub-inspectors, constables, LDC, steno, PA, income tax inspectors and MTS among others, it read.

These recruitments are being done by ministries and departments either by themselves or through recruiting agencies such as UPSC SSC and the Railway Recruitment Board. For expeditious recruitment. selection processes have been simplified and made tech-enabled, the PMO said. Kerala HC cancels 'Civic' Chandran's anticipatory bail

Kochi, Oct 20: The Kerala High Court Thursday set aside a sessions court order granting anticipatory bail to writer and social activist 'Civic' Chandran in a sexual harassment case against him on a complaint by a Dalit woman, saying he had knowledge that she belonged to SC community.

The sessions court had granted him the relief on the ground that the accused was a reformist and against the caste system and it was highly unbelievable that he would touch the body of the victim fully knowing that she belongs to the Scheduled Caste (SC).

Disagreeing with the findings of the lower court, Justice A Badharudeen said the fact that the accused and the complainant woman were very familiar to each other was discernible from prosecution records and therefore, his knowledge about her being a Dalit can be discerned from the materials available on record. "Having appraised the facts of the case with a view to find whether a prima facie case is made out alleging commission of offences under section 3(2)(va) and 3(1)(w)(i) of the SC/ST Act, the said case is specifically made out," the high court said. It also said that a non bailable offence under section 354 (molestation) of IPC was also made out in the instant case.

WB TEACHERS' RECRUITMENT SCAM

Arrest of Bhattacharya not illegal, says top court

Delhi, Oct 20: The Supreme Court Thursday declined to interfere with the arrest of Trinamool Congress leader and West Bengal Board of Primary Education's for-Chairman Manik Bhattacharya by Enforcement Directorate (ED) in connection with the money laundering matter regarding the teachers' appointment scam.

Dismissing Bhattacharya's plea,

a bench of Justices Aniruddha Bose and Vikram Nath said: "We cannot hold the arrest of the petitioner by the Enforcement Directorate illegal as the issue of money laundering or there being proceeds of crime had not surfaced before the Single Judge or the Division Bench of the High Court.'

During the hearing, Bhattacharya's counsel, senior advocate Mukul Rohatgi, had argued that the court had granted him protection from arrest in the CBI matter and it should be extended

in the case of the ED. The counsel further argued that Bhattacharya appeared before the ED on every occasion, but they claim that he was not cooperating. The bench said "while testing

the legality of an arrest made by an agency otherwise empowered to take into custody a person against whom such agency considers subsistence of prima facie evidence of money laundering, we do not think a general protective order directed at another investigating agency could have insulated the petitioner from any coercive action in another proceeding started by a different agency, even if there are factual similarities vis-a-vis the allegations".

Solicitor General Tushar Mehta, representing the ED, had opposed the extension of protection granted to the Trinamool MLA in the CBI case, to the money laundering probe, saying the ED is an independent agency and investigating the matter separately.



Nitish may ditch 'Mahagathbandhan'

Patna. Oct 20: Political strategistturned-activist Prashant Kishor on Thursday took a fresh jibe at Bihar Chief Minister Nitish Kumar, his former mentor, reiterating that the latter may ditch the 'Mahagathbandhan' and return to the BJP-led NDA.

Kishor, who had on the previous day claimed that Kumar could do vet another volte face and return to the NDA, attacked the JD(U) de facto leader for letting party MP Harivansh continue as the Rajya Sabha deputy chairman.

 $The \, election \, strategist \, had \, also \,$ told PTI on Wednesday that Kumar has kept a line of communication open with the BJP through Harivansh.

"After having snapped ties with the BJP. Nitish Kumar should have



asked Harivansh to step down. If he insisted on occupying the post, he could have been expelled from the JD(U). But Nitish is having this arrangement to keep options open for the future." Kishor alleged at a public meeting in West Champaran district, where he has been for three weeks as part of a state-wide 'padayatra', after which he is expected to float a political party. Kishor, who seems to have a love-hate relationship with Kumar. added Thursday that the Bihar CM "sought votes in the name of defeating BJP in 2015 assembly polls, but cheated the public to realign two years later. He is pretending to be at war with BJP again. But he may again do a turnaround".

"And this man has the temerity to call me a stooge of the BJP," fumed the celebrated political strategist, asking with rhetorical flourish "who had gone to assist Mamata Banerjee in defeating BJP in the assembly polls last year? Was it Nitish, Lalu or Tejashwi?"

Kishor, who has handled many a successful election campaign of leaders as diverse as Narendra Modi, Jagan Mohan Reddy and Captain Amarinder Singh, had announced his retirement from political consultancy after the West Bengal polls last year.

Bihar BJP MLA stirs row with comments on Hindu deities

Patna, Oct 20: In an embarrassment to the BJP in Bihar, one of its MLAs has been accused of hurting Hindu sentiments by pointing out that even those who did not worship Goddess Lakshmi, Saraswati and Lord Hanuman were not denied the attributes that worship of these deities was expected to bestow.

Lalan Paswan, who represents Pirpainti assembly seat in Bhagalpur district, while announcing his decision not to hold a feast in the memory of his mother

who died last week, purportedly rationalised that those who do not worship these Hindu deities still enjoyed wealth, education and power.

More people support internet shutdown: Survey

New Delhi, Oct 20: A study on Thursday claimed that more people were in support of internet shut down to maintain law and order than those opposing it, and a sizable number of people were in favour of surveillance as well.


The survey was done in partnership with Konrad Adenauer Stiftung.

"Support for internet shutdowns by governments on law and order grounds was also greater than opposition to it. The only issue, perhaps, on which a not so conservative opinion was seen, was that of government regulation of social media content," the study stated.

Among all respondents, 36 per cent were in support of the idea of internet shut down for law and order purposes, while 26 per cent found it wrong, and 38 per cent expressed no opinion.

A similar sentiment was found about government surveillance in the survey, while it was acknowledged, it was not considered immoral by many. "A sizeable proportion of them (respondents) saw nothing wrong with it (surveillance)," it said.

"Most smartphone and internet users were found to hold the be-

BJP, BSP in tussle for Muslim votes in UP No fine for not wearing mask

Lucknow, Oct 20: The BJP and the Bahujan Samaj Party (BSP) in Uttar Pradesh are now locked in a tussle for the Muslim votes, ahead of the Lok Sabha elections in 2024.

In an unprecedented move, BSP president Mayawati appointed former MLA Imran Masood as party's coordinator for western UP, within an hour of his quitting the Samajwadi Party (SP) to join the BSP on Wednesday.

The BSP, which does not have any Muslim leader worth his name left in the party, is now banking solely on Imran Masood to woo Muslims in western UP. Masood, who belongs to an influential Muslim family in Saharanpur, has hopped from the Congress to SP and now BSP within the past one year, eroding his own credibility.

Mayawati said, "Masood and others joining the BSP after the Azamgarh parliamentary by poll and before the urban local body polls, is a positive sign for the politics of UP as it shows that the Muslim community believes that it was not the SP but the BSP that was needed to get rid of the malicious politics of the BJP."

Mayawati's declared dependence on Imran Masood, especially for the upcoming municipal polls, shows the BSP's desperation to win back Muslims and regain its relevance in UP politics before the general elections.

a substantial number of tickets to Pasmanda Muslims in the upcoming municipal polls. The mood in the BJP is upbeat, especially after the party won the bypolls in Azamgarh and Rampur, both dominated by Muslims.

UP chief of All India Pasmanda Muslim Mahaz, Waseem Raeen, said that results are a clear indication that Muslims are no longer averse to the BJP. He said that the All India Pasmanda Muslim Mahaz has got a boost after PM Narendra Modi emphasized on reaching out to the marginalised Pasmanda Muslims.

The group is now focussed on projecting "the right picture" to the marginalised sections of Muslims. "In UP, we are already trying to reach out to the community and tell people that no discrimination has been done against them in providing benefits of PM Awas Yojana or free distribution of ration," Raeen said.

As per the All India Pasmanda Muslim Mahaz, 85 per cent of Muslim population in the country is of Pasmanda Muslims or OBC Muslims (like Ansari, Raeen and others) while the remaining 15 per cent is of "Muslim-Brahmins", like Kidwai, Bukhari, Khan, Pathan who constitute the upper layer of the population.

If the BJP succeeds in wooing Pasmanda Muslims, there would be no stopping the party from returning to power in 2024 -- a fact that is making the BSP work doubly hard towards regaining lost ground among Muslims now.

New Delhi, Oct 20: The Delhi government Thursday issued an order withdrawing the Rs 500 fine for not wearing masks in public places in the national capital.

The Delhi Disaster Management Authority (DDMA) in a meeting last month decided to stop levying the penalty after September 30, amid a decline in COVID-19 cases.

The authority in its meeting on September 22 noted that the positivity rate of the COVID-19 infection has come down substantially and majority of the population has been vaccinated, the order read."And, whereas, the DDMA has decided that compulsory wearing of masks under the Epidemic Act may not be extended beyond September 30 and hence, a fine of Rs 500 for not wearing masks in public places would also stand withdrawn after September 30," it read.

The order advised people to wear masks in crowded public places. Earlier, even as an official order abolishing the mask mandate was awaited, several district authorities in Delhi had either stopped fining people Rs 500 or given relaxations.

Delhi recorded 107 fresh COVID-19 cases with a positivity rate of 1.64 per cent on Wednesday, according to health department data. On Tuesday, the positivity rate was 2.04 per cent, 3.61 per cent on Monday, 1.59 per cent on Sunday, 2.12 per cent on Saturday and 1.75 per cent on Friday. The number of active cases now stands at 488. The number of daily cases in the city had touched a record high of 28,867 on January 13 during the third wave of the pandemic.

anything but unanimous and there were many differences, according to the minutes of the meeting.

Delhi Chief Secretary Naresh Kumar had in the meeting said that the current situation was comfortable but people cannot lower their guard as variants keep coming up. Niti Aayog member (health) Dr V K Paul had in the meeting emphasised that surveillance was still needed as the virus is still present, and its mutations and variants have emerged from time to time.

The chief secretary had suggested that a "self discipline mode" could be tried now as people are well aware of their responsibilities and about Covid-appropriate behaviour. Delhi Revenue Minister Kailash Gahlot in the same meeting had reiterated that there were

"practical difficulties" in the enforcement of the mask mandate, and had stressed the need to relax the rule.

The meeting, chaired by Lieutenant Governor V K Saxena and Chief Minister Arvind Kejriwal in attendance, had summarily agreed that though wearing of masks was useful in maintaining Covid-appropriate behaviour, the order of compulsory wearing of masks under the Epidemic Act may not be extended beyond September 30.

Experts had mixed views on the lifting of the mask mandate, with some saying the government could have waited for two months for the festive season to end, while others said people should voluntarily be allowed to discipline themselves.

The 43-year-old accused was identified as Suresh Gupta, resident of Budh Vihar, Phase-I. He was running the factory making fake cumin seeds by using grass, jaggery vinegar and stone powder, the officials said.

More than 400 sacks of fake cumin seeds weighing a total of over 28 tons were recovered, police said, adding the value of recovered items exceeds Rs 1 crore. Special Commissioner of Police (Crime) Ravindra Singh Yadav said police had received input about the factory in which fake

cumin seeds were being made.
Considering it a matter of grave
concern related to public health,
information was further worked
upon, Yadav said. On the inter-



vening night of Tuesday and Wednesday, it was confirmed that Gupta was running an illegal factory in Kanjhawala area and was manufacturing fake cumin seeds in huge quantity. Police were also tipped off that he will transport a large consignment of the same outside Delhi. Immediate raid was planned to bust the illegal factory, the senior police official said.

"Our team acted swiftly and raided the place of information and Gupta, owner of the illegal factory, was apprehended and more than 400 sacks of fake cumin seeds weighing around 70 kg each were recovered," he said.

"The staff of Food Safety Department was also called at the place of recovery and the samples of fake cumin seeds were collected. The fake cumin seeds were made so well that nobody can discern that they are not real," he added.

This is in addition to the restrictive actions mentioned in Stage 1 of GRAP," the CQAM said in an order, adding that various agencies responsible for implementing measures under GRAP have been advised to ensure strict implementation of actions under Stage 2 of GRAP.

Under Stage 2 of GRAP, the use of diesel generators is also not allowed except for essential services related to national security, defence-related activities, projects of national importance, telecommunication, data services, med-

ical, railway and metro rail services, airports, inter-state bus terminals, sewage treatment plants, and water pumping stations.

The CAQM has also suggested the use to water sprinklers and vaccum based road sweepers. Further, the dust prone areas must be identified and fog guns be set up over there.

The CAQM has advised the people to follow a few steps to combat air pollution

air pollution.

It said that people should use public transport and minimise the use of personal vehicles. The CAQM also said that dust generating construction activities should be avoided and air filters should be replaced regularly.

Shivajinagar resembled a river and cars and bikes were seen floating in water. People struggled hard to save their belongings. At HSR Layout, nearly 200 families were affected when water gushed into their houses including the basements of a few apartments

Anugraha Layout in Bilekahalli was badly affected as the entire colony was waterlogged. The road in front of Disha Centra in Balagere in Varthur ward resembled a river even 12 hours after the rain.

According to Jagadish Reddy, a resident of the area, the basement of many apartments in the area was flooded submerging many vehicles after

the downpour. The Outer Ring Road, which was badly hit a month ago due to heavy rains remained unaffected, an office-bearer of the Outer Ring-Road Companies' Association told PTI.

84% of Indians say global warming is happening

GLOBAL WARMING IS NOW AN IMPORTANT ISSUE FOR CONTEMPORARY INDIANS AND ITS EFFECTS SEEM VISIBLE IN THE COMMUNITIES WHERE THEY LIVE

New Delhi, Oct 20: A massive majority -- 84 per cent -- of Indians seem convinced that global warming is a reality that can no longer be ignored.

This is 15 per cent higher than in 2011 when 69 per cent of Indians were of the opinion that global warming was now a reality.

The survey was conducted between October 2021 and January 2022 and covered a scientifically designed random sample size of 4.619 adult Indians who were above 18 years of age. A similar

survey on climate change was conducted in late 2011 and the responses have been compared to get an inkling about awareness

levels of Indians. Awareness levels were not very high without the respondents being provided with a definition and a short description. For instance, the survey reveals that 54 per cent of Indians either know just a little about global warming or have never heard of it while a small minority of 9 % stated that they know a lot about global warming.

Speaking on the subject, Dr Anthony Leiserowitz of Yale



University said, "It is important to note, however, that lack of awareness of the issue does not mean that individuals have not observed changes in local weather and climate patterns, as evidenced in the Observations, Vulnerabilities, and Resilience to Local Weather Events

section later in this report." About three in four people in India have noticed changes in rainfall in their area in the last 10 years. India is geographically diverse, and different parts of the country experience different patterns of heat, rainfall, and extreme weather. A large majority of people in India

say they have observed changes in local climate and weather patterns in their own area.

Nationally, more than four in ten people in India (46 per cent) say the average amount of rainfall in their local area has increased over the past 10 years, while 30 per cent say it has decreased, and 22 per cent say it has stayed about the same. Compared to 2011, a higher percentage of people in India now say the average amount of rainfall in their local area has increased over the past 10 years (+12 percentage points), while a smaller percentage

say it has decreased (-16).

Graham Brady, chair of the 1922 Backbench Committee in charge of Tory elections, said that potential candidates are expected to file their nominations by 2 pm local time on Monday for a final two contestants to be shortlisted.

Unless there is parliamentary consensus struck around a single candidate, the final two will be put up for an expedited online voting

process before the wider Tory party membership to be concluded by October 28. "It [100 MPs] should be achievable by any serious candidate, who has a realistic prospect of going through," said Brady, as he confirmed the likelihood of three possible candidates emerging, given the 357 Tory MPs in the House of Commons. "It is up to the Members of Parliament whether we have one or two candidates. If there are two candidates acting in the national interest, our members can make their views known," said Tory Party chairman Jake Berry, who will oversee the online voting for the membership.

In case only one candidate emerges with the requisite support in time for the 2 pm deadline on Monday the party would have



a new leader in place later that day. If there is a clash between two final contenders, the leader would

be in place by next Friday Rishi Sunak, the British Indian support of 137 MPs in the last round of voting within the Tory parliamentary party back in July and was the clear frontrunner of the race among his colleagues.

RUSSIA SEEKS TO REGAIN GROUND

Kyiv, Oct 20: Russia's troops fought Thursday to regain lost ground in areas of Ukraine that Russian President Vladimir Putin has illegally annexed while Moscow tried to pound the invaded country into submission with more missile and drone attacks on critical infrastructure.

Russian forces attacked Ukrainian positions near Bilohorivka, a village in the Luhansk region of eastern Ukraine. In the neighbouring Donetsk region, fighting raged near the city of Bakhmut. Kremlinbacked separatists have controlled

parts of both regions for 81/2 years. Putin declared martial law in Luhansk, Donetsk and southern Ukraine's Zaporizhzhia and Kherson regions on Wednesday in an attempt to assert Russian authority in the annexed areas following a string of battlefield setbacks and a troubled troop mobilisation.

The unsettled status of the illegally absorbed territory was especially visible in the Kherson region's capital, where military officials have replaced Kremlininstalled civilian leaders amid a mass evacuation and an ongoing

Ukrainian counteroffensive.

Kherson city was one of the first urban areas captured by Russia when it invaded Ukraine, and it remains a prime target for both sides because of its key industries and major river port. Thousands of the city's 250,000 residents streamed out of the city in anticipation of intensified assaults.

President Volodymyr Zelenskyy's office said on Thursday that Ukrainian forces continued to engage the enemy, mounting 15 attacks on Russian military strongholds in the Kherson region, Meanwhile, Russia continued its stepped-up attacks on

Ukraine's energy infrastructure, dispatching drones and missiles to eight regions.

At least three civilians died and 14 were wounded in overnight attacks across Ukraine, according to the Ukrainian president's office. In Kryvyi Rih, Russian strikes damaged a power plant and another energy facility, cutting electricity to the central Ukraine city of about 600,000 residents.

Apart from being Zelenskyy's hometown, Kryvyi Rih is home to several large metallurgical factories that are key to Ukraine's economy. Islamabad, Oct 20: A Pakistani court Thursday dismissed appeals by the country's top anti-corruption watchdog against the acquittal of former President Asif Ali Zardari in a slew of graft cases filed against him over two decades ago.

The National Accountability Bureau (NAB) had filed these graft cases against 67-year-old Zardari in the 1990s.

The Pakistan People's Party (PPP) leader was later acquitted in 2014 and 2015. However, the NAB challenged Zardari's acquittal in the Islamabad High Court (IHC).

But after its failure to present any evidence, the NAB on Wednesday filed an application expressing its desire not to further pursue these cases, as the available evidence was based on photocopies, which did not comply with the country's laws of evidence. The anti-corruption body also told the court that it wanted to withdraw its appeals.

Beijing, Oct 20: China Thursday dropped a subtle hint that President Xi Jinping, who is widely expected to get endorsed by the ongoing Congress of the ruling Communist Party for a record 3rd term, will attend next month's G20 summit in Indonesia.

Also, the Chinese Foreign Ministry flaunted the "diplomatic success" achieved under the 10year rule of Xi, saying during his reign China has "robustly" upheld its sovereignty and security. The once-in-a-five-year Congress of the Communist Party of China (CPC) being held here from October 16 is widely expected to endorse an unprecedented 3rd five-year term or perhaps a lifelong tenure in power to Xi later this week besides enhancing his powers through constitutional amendments. Barring Xi, the Congress would endorse a whole set of new top-level leaders and officials, including the Premier,



heralding a new administration under the Chinese President who is all set to breach the mandatory retirement for CPC leaders after 10-year tenure. Xi, who is completing 10-year tenure this year, will be the first Chinese leader after party founder Mao Zedong to continue in power, formally ending three decades of rule followed by his predecessors to retire. In a media briefing here, officials of the CPC claimed that Chinese diplomacy has achieved "unprecedented and historic" breakthroughs during Xi's tenure. "We give active support to the G20 Presidency of Indonesia and support Bali summit's theme of 'recover stronger, recover together'," Ma Zhaoxu, a member of the CPC Committee ofthe Ministry of Foreign Affairs and Vice Minister, said.

Woman charged with sending bee swarm on deputies at eviction

Springfield (US), Oct 20: A Massachusetts woman stands accused of using a swarm of bees as a dangerous weapon, according to a county sheriff, after she allegedly unleashed a hive of angry insects on deputies trying to serve an eviction notice last week.

The incident unfolded when Rorie Woods, a 55-year-old professional beekeeper, drove up to the

home in Longmeadow while deputies were in the process of enforcing the eviction notice, the sheriff's department said in a statement on Wednesday.

The residence, outside Springfield in the south-central part of the state, belonged to a man who had been litigating against his removal for years, garnering support of anti-eviction activists, including Woods, a department spokesperson said in an email Thursday.

When she arrived at about 9:15 a.m. local time, towing a stack of manufactured beehives with a SUV, Woods exited the vehicle and tried to open the lids to unleash the bees, the department said.

"A sheriff's deputy tried to stop her, but as the agitated bees started getting out and circling the area, he pulled back," the office said.

She then smashed the lid of one hive and flipped it off the flatbed, agitating the bees, the sheriff said on Wednesday.

They swarmed the area, stinging several officers and bystanders who were nearby. One deputy was taken to the hospital where he was Meanwhile Woods put on a pro-

fessional beekeeper suit to protect herself, and she carried a tower of bees to the front door of

the home, trying to stop the eviction. At that point, deputies arrested her.

"I support people's right to protest peacefully but when you cross the line and put my staff and the public in danger, I promise you will be arrested," Hampden County Sheriff Nick Cocchi said.

Attempts to reach a lawyer for Woods were unsuccessful.

Woods, who lives in Hadley, Massachusetts, about 25 miles (40 km) north of Longmeadow, faces four felony counts of assault and battery by means of a dangerous weapon and three counts of assault by means of a dangerous weapon.

She also faces a misdemeanor disorderly conduct charge. Local media reported that Woods pleaded not guilty to the charges.



Steel prices nosedive 40% in last 6 months

New Delhi, Oct 20: Steel prices fell about 40 per cent to ₹57,000 a tonne in the domestic market over the last six months on subdued export orders in the wake of the 15 per cent export levy, according to SteelMint.

In early 2022, the prices of hot rolled coil (HRC) started showing an upward trend. It had become a matter of concern for the user industries as movements in steel prices have a direct impact on industries like real estate and housing, infrastructure and construction, automobile and consumer goods.

The steel prices in the domestic market peaked at ₹78,800 per tonne in April. After 18 per cent GST levy, the price was about ₹93,000 per tonne. The prices started to fall from April-end and came down to ₹60,200 per tonne towards the end of June, according to SteelMint data. It continued to fall in July and August and came down to ₹57,000 per tonne by mid-September.

SteelMint cited "government tax on steel products, subdued overseas demand and high inflation and energy costs" as the reasons for the fall in steel prices. All prices are excluding 18 per cent GST.

On the outlook, it said domestic HRC prices to remain range-bound in the next quarter. As steel exports are likely to remain less than usual and inventory pressure is likely to sustain, mills are unlikely to increase the prices over the next two

SEBI clears govt proposal to turn Vi dues into equity

GOVT'S STAKE IN VODAFONE AFTER THE CONVERSION COULD BE OVER 30%, MAKING IT ONE OF THE LARGEST SHAREHOLDERS

New Delhi, Oct 20: India's capital market regulator approved the government's proposal to convert dues of over \$1.92 billion by telecom operator Vodafone Idea to equity, two senior government officials said Thursday.

Last year, India had appro rescue package for debt-strapped telecom companies that allowed them to convert interest on deferred adjusted gross revenue owed to the government into equity.

Among the country's three major telecom players, in-



cluding Bharti Airtel and Reliance Industries' Jio, the government package was seen as a bailout for Vodafone Idea, which was on the verge of bankruptcy.

'SEBI (Securities and Exchange Board of India) has approved the government's proposal to come in as a financial investor. This has been communicated to the telecom ministry," one of the officials, who did not want to be named, told Reuters.

The government's stake in Vodafone after the conversion could be more than 30%, the official added, which would make it one of the largest shareholders in the company along with UK's Vodafone

New Delhi, Oct 20: The Competition Commission Thursday imposed a penalty of ₹1,337.76 crore on Google for abusing its dominant position in multiple markets in the Android

mobile device ecosystem. Besides, the fair trade regulator has directed the internet major to cease and desist from unfair business practices. In a release, the Competition Commission of India (CCI) said it has also directed Google to modify its conduct within a defined timeline.

In April 2019, the regulator ordered a detailed probe in the matter following complaints by con-



sumers of Android-based smartphones in the country. Android is an open-source, mobile operating system installed by Original Equipment Manufacturers (OEMs) of smartphones and tablets.

The allegations of unfair business practices pertained to two agreements -- Mobile Application Distribution Agreement (MADA) and Anti Fragmentation Agreement (AFA) - which were entered into by the OEMs of Android OS with Google

In the release, the regulator said it has imposed a penalty of ₹1,337.76 crore on Google for abusing its dominant position in multiple markets in the Android mobile device ecosystem apart from issuing the cease and desist order.

As per the release, CCI said that mandatory pre-installation of entire Google Mobile Suite (GMS) under MADA, with no option to un-install the same, and their prominent placement amounts to imposition of unfair condition on the device manufacturers and thereby contravenes competition law.

"These obligations are also found to be in the nature of supplementary obligations imposed by Google on OEMs and thus, in contravention of Section 4(2)(d) of the Act, it added. Section 4 of the Competition Act pertains to abuse of dominant position.

Further, CCI noted that the internet major has leveraged its dominant position in the app store market for Android OS to enter as well as protect its position in non-OS specific web browser market through Google Chrome App.

"Google has leveraged its dominant position in the app store market for Android OS to enter as well as protect its position in Online Video Hosting Platforms (OVHPs) market through YouTube and thereby contravened provisions of Section 4(2)(e) of the Act," the release said.

UCO Bank, Yes Bank in talks with Russia to finalise trade mechanism

New Delhi, Oct 20: Indian lenders UCO Bank and Yes Bank are in talks with their Russian counterparts over a payment mechanism_ for trade between the two countries, a senior government official said Thursday.

Reuters had reported large lenders are reluctant to process direct rupee trade transactions with Russia for fear of becoming the target of sanctions over the invasion of Ukraine, and New Delhi is counting on smaller banks like UCO and Yes.

Banks are discussing the currency pair for the payment mechanism and the options include the Indian rupee paired with the Russian rouble or Saudi Arabia's riyal, the official said.

"Few of the Russian banks are joining hands with UCO Bank and Yes Bank. It will be primarily rupeebasis trade, could be rupee-rouble or could be rupee-rival." the official, who did not want to be named, told reporters in New Delhi.

The official did not explain how the rupee-riyal mechanism will be designed to settle trade between New Delhi and Moscow
