Put Lakshmi, Ganesha on currency: Kejriwal

Delhi CM who got the idea during Diwali celebrations feels that the country will prosper with this move

New Delhi, Oct 26: Delhi Chief Minister Arvind Kejriwal has a solution to the country's economic progress and prosperity - print images of Goddess Lakshmi and Lord Ganesha on new currency notes. His demand, however, drew sharp reactions from the BJP, which called it an 'unsuccessful attempt' to hide the 'ugly' anti-Hindu face of AAP in view of upcoming elections in Gujarat and Delhi Municipal Corporation.

Claiming that Indian economy was not in good shape, Kejriwal said at a press conference here that the country needed a lot of effort to get the economy back on track along with the 'blessings of our gods and goddesses

'Today, I am appealing to Prime Minister Narendra Modi and the Centre that our currency notes have the image of Mahatma Gandhi on one side. It should remain as it is but on the other side, there should be an image of Ganesha and Lakshmi," Kejriwal said.

Kejriwal said that idea the two

deities on currency notes came to him while performing Diwali puja Monday. "We want India to become a developed and prosperous country. It will only happen when we have the blessings of Goddess Lakshmi and Lord Ganesha." the Delhi CM said.

Lashing out at Kejriwal, the BJP said his demand was the height of Uturn as he was 'trying' to be a Hindu. BJP spokesperson Sambit Patra said that Kejriwal has taken this new stance to appease the people of Gujarat and Delhi. "His hypocrisy is on show. One should remember that the Aam Aadmi Party government had recently warned people of legal action for celebrating Diwali with firecrackers in Delhi.

Meanwhile BJP's Northeast Delhi MP Manoj Tiwari said 'Kejriwal, who has so far protected his party leaders who insulted Hindu gods and goddesses, is now trying to save his face in view of the elections'. He was referring to the upcoming elections to the Municipal Corporation of Delhi (MCD) and the

HC rejects former AG Mohanty's plea

CUTTACK: The Orissa High Court dismissed Wednesday the plea of former Advocate General (AG) Ashok Mohanty, an accused in Artha Tatwa ponzi scam. Mohanty had requested the high court to exclude him from the chit fund case. However, while rejecting Mohantv's plea the high court, ordered the CBI court to continue regular hearing of the case. Mohanty was arrested in 2014 for allegedly receiving property worth ₹1.01 crore at Bidanasi locality as a 'gift' from Artha Tatwa Group chief Pradeep Sethi. He was accused of abusing his official position and misappropriating funds.

Kharge eyes success in Gujarat, Himachal

NEW DELHI: Mallikarjun Kharge took charge Wednesday as the Congress' first non-Gandhi president in 24 years, citing Rahul Gandhi's slogan 'daro mat' to energise workers. He also declared that the party will demolish the government's 'system of lies, treachery and hatred'. He said his immediate task will be to lead the party to power in Himachal Pradesh and Gujarat, where it faces an aggressive BJP and an eager AAP. "We will have to strongly perform in these states and we will need everyone's strength and energy to succeed," Kharge said.

Rotate officers in sensitive posts: CVC

The vigilance watchdog has pointed out that the only way to prevent corruption is to stop people staying in a particular position for a long time

New Delhi, Oct 26: The Central Vigilance Commission has asked and central government departments to regularly identify sensitive posts and ensure the rotation of officers manning them within the prescribed time limit. This, sources said, will act as a major deterrent against corruption.

The move came after the CVC noticed that many of the organisations are not following the guidelines about the identification of sensitive posts in letter and spirit.

In an order, the commission said the Chief Vigilance Officers (CVOs) - who act as distant arm of the panel to check corruption – in consultation with the chief executive/management of the respective organisations, should immediately undertake an exercise to identify sensitive posts in their organisations.

"In future, an exercise to review and identify sensitive posts may be conducted after an interval of every three years. Accordingly transfer measures should be undertaken. said the order dated October 25.

"Identification of sensitive posts



the tools for effective implementation of preventive vigilance mechanism," the probity watchdog said.

Periodical rotation of officials holding sensitive posts would help eliminate the scope of developing vested interest by the officials and would also reduce the scope of indulging in corrupt activities, the CVC said in the order to secretaries of all central government departments and chief executives of public sector banks, insurance

companies and enterprises. "In view of the ever-changing scenario and increasing use of technology in the functioning of organisations, it is important that the list of sensitive posts is reviewed and updated at regular intervals," the CVC order further said.

"However, it has been observed that the guidelines issued by the commission about the identification of sensitive posts are not being followed in letter and spirit by many of the organisations and the exercise to review the existing lists of sensitive posts and to identify new areas/posts as sensitive, has not been undertaken for a long time," said the order seeking its strict compliance with immediate effect.

Reacting to the order, anti-corruption activist Ajay Dubey said all government departments must ensure strict adherence to the CVC guidelines in checking corruption. There are instances of government departments not following the Central Vigilance Commission's guidelines on rotational transfer in toto," stated Dubey.

Dhamnagar bypoll: BJP moves ECI against Lohani

New Delhi/Bhubaneswar. Oct **26:** The opposition BJP came down heavily Wednesday on Odisha's Chief Electoral Officer (CEO) SK Lohani even as the official claimed that action has been taken in the alleged 'cash-for-vote' allegation which emerged during campaigning for the Dhamnagar Assembly

Keeping in mind Unilever's popularity one can be sure that many of these products had already made their way into consumers' homes before their recall. So what happens then to those consumers?

nearby area because the girl he liked was in the sister school located there.


"Our sister school was located at a nearby area and I used to cross a ditch to reach the girl's school to look for the girl I liked during those days,"




Movie on Netaji's last years lands in trouble







Archana produced in court over Parija case

Bhubaneswar, Oct 26: Archana Nag, the prime accused in the high profile blackmailing case in Odisha, was produced at the sub-divisional judicial magistrate (SDJM) court here Wednesday in connection with a case filed by film producer Akshay Parija.

Parija had claimed in his FIR at Nayapalli police station that Archana had shot intimate pictures with a woman after serving him intoxicating drinks at a hotel in the City and demanded Rs 3

crore from him. She even threatened to kill him by cutting him to pieces if he did not

comply, he claimed.

The 26-year-old woman from Kalahandi district was arrested October 6 and sent to jail on the charge of blackmailing rich and influential persons along

with running a sex racket. She was taken into custody on the basis of a complaint at Khandagiri police station by a woman, whom she had allegedly used in the sex racket. The same woman was purportedly involved in the case in which the film pro-

ducer filed his complaint. When approached by the media while being taken to the court premises on Wednesday, Archana told reporters, "Don't spread false information without any evidence. Archana also said, "I will speak at the appropriate time.'

She is accused of extorting lakhs of rupees from politicians, businessmen and influential persons by blackmailing them with videos of intimate moments between them

climate change on children" "Already, 1 in 3 children live in countries that face extreme high temperatures and almost 1 in 4 children are exposed to high heatwave frequency, and it is only going to get worse. More children will be impacted by longer, hotter and more frequent heatwaves over the next 30 years, threatening their health and wellbeing. How devastating these changes will be depends on the actions

"At a minimum, governments must urgently limit global heating to 1.5 degrees Celsius and double adaptation funding by 2025. This is the only way to save children's lives and futures and the future of the planet," she added.

The data published in the agency's report underscores that young children face greater risks than adults when faced with extreme heat events.

This is because they are less able to regulate their body temperature as compared to adults. The more heatwayes children are exposed to, the greater the chance of health problems including chronic respiratory conditions, asthma, and cardiovascular diseases.

"The world urgently needs to invest in building their resilience -- and in adapting all the systems children rely on to meet the challenges of a rapidly changing climate," Unicef maintained.

Children should be protected from the escalating impacts of heatwaves, Unicef said, in a call for "urgent and dramatic emissions mitigation measures to contain global heating -- and pro-

Responding to the report, UN Secretary-General Antonio Guterres said: "The last seven years have been the hottest on record... The climate crisis is a child rights crisis.'

Cuttack, Oct 26: The Orissa High Court Wednesday accepted a proposal submitted by Amicus Curiae Mohit Agarwal for the deployment of drones to monitor illegal prawn culture ponds or gherries encroaching wetlands in at least four coastal districts of the state.

"A division bench headed by Chief Justice S Muralidhar has accepted my proposal and has directed the state government to provide necessary infrastructure and funds to deploy drones for monitoring the illegal gherries, which are coming up even within 24 hours of their demolition by the authorities." Agarwal said

The districts in which the drones will be deployed are Balasore, Kendrapara, Puri and Ganjam and the state government has been asked to submit an affidavit in this regard by the next date of hearing December 5, Agarwal said. The Amicus Curiae had made the proposal for the deployment of drones.

"All remedial actions are being taken by the CEO office as quickly as possible to ensure free and fair elections," Lohani asserted.

Meanwhile Lohani informed that a total of 106 polling booths in Dhamnagar have been identified as sensitive booths. Adequate precautions including security arrange ments are being done for peaceful polling in these booths, Lohani added while talking to reporters here. Webcasting will be done in 50 per cent of the booths while 26 micro-observers will be deployed in the sensitive booth, the CEO stated.

Diabetes is a long-term condition where the body fails to regulate the amount of sugar in the blood. In type 1 diabetes, sometimes known as juvenile diabetes, an organ called the pancreas doesn't make the hormone, insulin, needed to process blood sugar. For the roughly 9 million people with type 1 diabetes, they need daily insulin injections to manage their disease.

Type 2 diabetes, in contrast, arises slowly over time; often people don't know they have it until they experience one of the many complications that result from the disease, such as a heart attack or

body develops a degree of resistance to insulin and the pancreas doesn't make enough of it. Usually this comes about from an unhealthy

diet and a lack of exercise. Over 500 million people worldwide have type 2 diabetes, and treatment often involves medications to manage their blood sugar plus a recommendation for im-

online to help seamlessly control blood sugar levels in type 1 diabetes. For a number of years, continuous glucose monitors and insulin pumps have been available to people with diabetes. More recently, sophisticated systems have been developed that link the glucose monitor directly to the insulin pump, so that the delivery of insulin can be continually adjusted according to the glucose level.

New drugs are showing far better results than the previous classes of diabetes medications. GLP-1 receptor agonists and SGLT2 inhibitors not only manage blood sugar at least as well as previous drugs, but are more effective in protecting against some of the serious heart and kidney problems that often result from diabetes.

And finally strategies that improve the level of care for people with diabetes have been developed. Multi-disciplinary teams improve outcomes in diabetes. The scale of implementing this is enormous; it's a social, policy, and economic challenge to reach the growing number of people needing care, particularly in countries whose health systems are not up to the task. But as evidenced by the decline in global diabetes deaths. efforts appear to be paying off, at least in the higher-income coun-

But with data showing that people are living longer, and evidence for new treatments and models of care, the evidence points to healthcare moving in the right direction. The gains have been small, thus far, but with more time, research funding, and healthcare support, signs are that the "epidemic" of people with diabetes can be helped to live longer, more fulfilling lives. Man dies, son critical in road accident

Basudevpur, Oct 26: A man was killed while his son sustained critical injuries in a road mishap at Matha Square in Radhaballavpur on Basudevpur-Jamujhadi road in Bhadrak district in the wee hours of Wednesday.

The deceased was identified as Jagat Mallick, 60, a resident of Khirakona village under Simulia police limits in Balasore district. His son, Prashant Mallick was critical and fighting for life in a hospital, sources said.

Kendrapara, Oct 26: Migration to other states in Kendrapara district due to extreme climatic conditions hampering agriculture and lack of livelihood opportunities.

Moreover, with income from agriculture dipping due to vagaries of climate, lack of irrigation facilities and other reasons, people are increasingly resorting to migration to earn a livelihood.

The matter came to the fore after buses from Kerala and other states were seen camping in Aul, Pattamundai, Rajnagar, Rajkanika, Mahakalapara and other blocks to ferry the migrants back to their workplace in their respective states. The buses had arrived in these areas before the start of Diwali and were seen ferrying the migrants even before the festival could end. Scores of migrants who had come home to participate in the festivals were seen boarding buses to their workplaces. This is indicative of the acute unemployment problem plaguing Kendrapara which is predominantly an agricultural district.

Sudarshan Rout, a native of Satabhaya panchayat under Rajnagar block said that farmlands are now left uncultivated and fallow due to lack of any support system.

The district neither has any mine nor industries to support them. Similarly, the district also lacks employment opportunities. Over 57,000 graduates and technically qualified youths have registered their names in the district employment office but they are yet to get any jobs. This has prompted the youths to migrate to other states and earn a livelihood for their families. These are not only the words of Sudarshan but that of many youths who were seen boarding the bus for Kerala.

Bharat Behera, also from Satabhaya, said that all the seven villages in the panchayat have been washed away into sea due to rapid erosion of the coast. Over 571 families of these villages were rehabilitated at Bagapatia. Every family in Satabhaya has lost their farmlands to the sea.

The food stocks provided by the government lasts only for a fortnight while the rest 15 days they have to earn to feed themselves

and their families. The price rise of essential commodities is also impacting them. Hence, they are migrating to other states to earn better to meet their expenses, he said.

Sarojkanta Swain of Gupti works in a plywood company at Perumbavoor in Ernakulam district of Kerala. He comes home before Ganesh Puja every year and goes back to his workplace after attending Lakshmi Puja and Kali puja festival. He said that vagaries of climate always plays truant for agriculture while there is lack of any government support to tide over the crisis. Moreover, lack of any industries is also prompting the youths to migrate to Kerala, Tamil Nadu and Surat.

The company has sent buses as there are ore workers from the district wo Kerala. He said that why would they travel for over 2,000 km to work if there was opportunity to work in the district.

Jagannath Das, a senior resident of Rajnagar area said over 60 buses have come here to ferry the migrants to Kerala, Tamil Nadu and Surat after puja. These migrants are working at various plywood, cotton mills and pisciculture units in these states. Most of the youths after appearing their Class-X examination are leaving for other states. Women and minor girls are also going outside the state. A private agency has estimated that over 51 per cent of the families living in Rajnagar, Mahakalapara, Aul, Pattamundai and Rajkanika blocks have migrated outside the state for work. Many times their share of harassment and torture in their workplace hogs the headlines. This problem can be resolved if small. medium industries could be established in the district and farmers can be taught to cultivate climate resistant crops, he added.

Summit of Future

ince early 2020, the number of people affected by hunger has risen by 150 million – a trend that has been exacerbated by the three Cs: conflict, climate change, and COVID-19. And when it comes to global threats, rising food insecurity is just the tip of the iceberg. As the recent failure of the Nuclear Non-Proliferation Treaty Review Conference also showed, we urgently need new, innovative governance approaches and institutions if we are going to tackle our biggest challenges.

To improve the international community's tools for managing enormous, complex global problems, the United Nations is planning to hold a Summit of the Future in September 2024, which will be preceded by a ministerial meeting in September 2023. Among other things, this intergovernmental process will highlight the need for more capable responses to the rising risks of nuclear war, runaway climate change, resurgent poverty, and threats to human rights.

Though no significant global problems will be solved overnight, the Summit offers a rare opportunity to achieve some high-profile near-term wins, and to strengthen the conditions for even more ambitious global-governance improvements in years to come. The hope is that the Summit will deliver three new global policy frameworks: a Declaration on Future Generations, a Global Digital Compact, and

a New Agenda for Peace.

In Rethinking Global Cooperation, a recent collaborative study from the Doha Forum and the Stimson Center, we offer several recommendations for realizing these instruments' full potential. First, with the aim of establishing future generations' well-being as a global public good, a Declaration on Future Generations should offer formal legal recognition of future generations' rights, by establishing an explicit "duty of care" for all member states. Countries that shirk that duty could then be held to account.

Such changes would represent a continuation of recent progress toward recognising the links between well-being, the environment, and rights. Earlier this year, the UN General Assembly adopted a resolution declaring that access to a clean, healthy environment will now be considered a universal human right. Similarly, the 2030 Agenda for Sustainable Development represents a large-scale mobilisation of investment that will largely benefit future generations, as well as determining what opportunities today's young people will have when they become adults.

Second, because rapid advances in technology pose new and growing risks to human

rights – even as they create opportunities for development – we need a more holistic, networked, and multilateral approach to technological governance. A Global Digital Compact could meet that need, provided that it addresses the three dimensions of the technological lifecycle: innovation, infrastructure, and information.

In the first dimension, a new compact must ensure that technological development – from ideation and sourcing to creation and deployment – promotes public interests, safeguards environmental sustainability, and adheres to basic human-rights norms. With respect to infrastructure, it should foster universal access to essential technologies and connectivity; and, in keeping with the 2030 Agenda, such infrastructure should be environmentally sustainable and secure. And when it comes to information, a digital compact should establish mechanisms to prevent the development or ownership of technology from adversely affecting human rights, and to ensure that human-rights standards apply equally online.

Finally, a new peace agenda should recapture the spirit of the original 1992 Agenda for Peace. We need more dynamic approaches to sustaining peace and promoting justice and security. This could mean developing new foresight capabilities, enhancing the role of country-level UN Resident Coordinators, creating a new UN Peacebuilding Commission audit tool, and updating disar-

mament agreements to address new technologies such as artificial intelligence. To achieve greater inclusiveness in international peacebuilding, we recommend that the Women, Peace, and Security (2000) and Youth, Peace, and Security (2015) agendas be complemented with targeted investments in education and strategies to build trust and partnerships in regions plagued by violence and exclusion.

With multiplying crises, the world desperately needs imaginative thinking, skillful diplomacy, coalition-building, and courageous leadership in support of these and related proposals. We must do everything within our power to ensure that the Summit of the Future is a success.

By rethinking global cooperation through novel and lasting partnerships, we can ensure that "the future we want" becomes a reality for today's young people and all those who come after them.

are a miserly or stingy person. The second part has nothing whatever to do with any of the more common senses of skate. A writer in the San Francisco Chronicle in September 2007 was way wide of the mark when he wondered if a cheapskate was managing to avoid paying his share by adroitly sliding past the transaction, as though on skates or a skateboard. And there's nothing in the least fishy about the word. Well, up to a point. The origin, as often with slangy words, isn't easy to fathom. Skate began to appear in print in the US at the end of the nineteenth century, almost simultaneously meaning a worn-out horse, a mean or contemptible person, and a second-rate sportsman. Cheap was added early on to refer to a person's tight-fisted nature rather than any of his other perceived inadequacies. An early example appeared in the Newark Daily Advocate of Ohio in 1896 in a story about a streetcar motorman who was remonstrating with a driver of a coal wagon: "You're a gol dinged, insignificant, pusillanimous, ragged, cheap skate of a tenth assistant barnyard corporal." The best suggestion we have is that skate was originally a Scots contemptuous word, still known in a weakened sense in Australia and New Zealand, where it's usually written as skite. We retain it in blatherskite for a person who talks at great length without making much sense. It appeared first in a slightly different form in a Scots song, Maggie Lauder, written by Francis Semphill about 1643. This was a camp song among American soldiers during the War of Independence and remained popular in the decades that followed. We guess that this may have helped skate or skite to be preserved among emigrant Scots and others in the US during the nineteenth century.

ctuarial experts and progovernment scholars were perfectly right in showing the exchequer's high financial burden of the government employees' Old Pension Scheme (OPS), which provides a defined benefit and no employee contribution. But they were utterly wrong in recommending in its place the New Pension Scheme (NPS), which entails the defined contribution from the employees and some uncertain, paltry postretirement benefit to them. These pundits' excessive concern about financial costs made them relegate the government's inalienable social security responsibility to the back seat.

The new pension scheme is not a freshly baked one; it was announced way back in December 2003 and launched April 1, 2004. Its purported goal was to reduce the ever-increasing pension burden − ₹65,000 crore a year - on central and state governments at that time with a 20% expected rise every year.

The central government first introduced the NPS and gradually all the state governments, except that of West Bengal, applied it to their respective employees

it to their respective employees. Naturally, the employees reject the scheme: but their refusal and protests are more vocal now than at the time of its introduction two decades ago. Unfortunately, the protests against any unsavory policy changes become vehement only when the people feel their actual impact, not when the changes are made to nip them in the bud. For instance, the opposition to the rising oil prices is more tangible now, when people are acutely feeling their burden, than at the time when the administered price mechanism to facilitate this rise was dismantled about two decades ago. So, are the employees now agitating since the new pension scheme did not immediately affect those in active service at that time since those recruited after January 1, 2004, were brought under the scheme's purview.

Now, the employees in state after state are launching agitations seeking revival of the OPS. Already, Rajasthan, Chhattisgarh and Jharkhand have reverted to the old scheme; Delhi and Punjab have decided to follow suit while AP employees are on agitation demanding the poll promise of their CM YS Jagan Mohan Reddy to restore the old scheme. Also, employees in Tamil Nadu and several other states

are in agitation.

So, a continuation of the new scheme is not sustainable after a few states have budged to the employees' pressure, no matter the experts' warning of the financial unsustainability of state finances.

Under the new scheme, the employees contribute to the pension fund every month, throughout their career, a sum equal to 10% of their Salary and Dearness Allowance and the government contributes another 14% (hiked from original 10%). At the time of retirement, the corpus total of contributions plus investment returns) is used to purchase a fixed annuity, with an option to withdraw a portion, as a lump sum. So, under the new scheme employees need to contribute and the market determines the return and pension sum, whereas the old scheme did not require any of the employee's contribution but assured a pension sum, equal to 50% of the last drawn salary, a fair amount of pension; ILO Social Security Convention 102 held in 1952 suggested pension to be equal to 50% of insurable salary.

True, the pension scheme in question pertains to only the government employees (less than 4% of the workforce) – at the best to about 35 lakh central government and a little more than one crore state government employees (34.65 lakh central employees and 1.06 crore state governments' employees as per the latest available data); it actually affects fewer than this number because the new pension

scheme is applicable only to those recruited after January 2004.

Notwithstanding its insignificant share in total employment, the government in a welfare state is expected to function as an ideal employer and to set an example to the private sector by providing decent salaries and post-retirement benefits to its employees thereby eventually ensuring equal pay for

equal work' norm in the society. Overall, old age security is not getting adequate attention while the number of senior citizens, aged 60+ is rapidly increasing. Their share in the total population has increased from 5.5% in 1951 to 8.6% in 2011. India, with a 138 million 60 plus population, in 2021 (104 million as per the 2011 census), accounts for 12.5% of that category in the world; the UNPF forecasts the number to rise to 173 million by 2026 and an NSO's report anticipates it to swell to 194 million in 2031. The old-age dependency ratio in the country climbed from 10.9% in 1961 to 14.2% in 2011 and is further projected to increase to 20.1% in 2031.

The situation calls for adequate financial support for the elderly. But the pension system in the country, even to the organised sector workers, is defective and unscientific. The pension benefits available to different segments of society depict the anomaly.

For instance, an MLA gets a full pension for a lifetime for serving five years; the Madhya Pradesh MLA gets the pension even for one day's service. Similarly, a seven-time MLA from Haryana Assembly is getting ₹2.38 lakh monthly pension. A Telangana one-time elected MLA gets ₹50,000 monthly pension and ₹75,000 if elected more than three times. AP MLA gets a monthly pension of ₹30,000 and Tamil Nadu ₹40,000; different states have fixed different sums for their legislators.

Compare this with the millions of employees covered under the Employees Provident Fund (EPF) pension. Most of the executives who had drawn a lakh of rupees and more are getting pension amounts around ₹1,500; recently retired may at best be getting a thousand rupees more. This is because their pension is calculated based not on their total salary but on the insurable salary on which contributions were collected. The scheme which came into being in 1995 till recently had ₹6,500 insurable salary limit (now raised to ₹15,000). As per the pension formula, one gets a maximum pension

of ₹3,250 after 35 years of service. The minimum EPF pension was raised to ₹1,000 after the government found that 83% of EPF pensioners were getting a monthly pension of less than that amount and 27% getting even lesser, less than ₹500. So, during the post-retirement life the workers who had contributed for not only the pension fund but to the national wealth through decades of hard work fall below the poverty line levels of income; even the destitute pension given as part of the governments' welfare programmes is at times higher than the EPF pension. For instance, Telangana government gives an old age pension of ₹2,000, AP at present gives still more, ₹2500 and has proposed to raise it to ₹2,750 from January 2023.

All this suggests that there is an urgent need to raise the pensions to all those workers who are not getting equal to half their last drawn salaries but not to reduce the pensions of those few who are already getting it. Governments are expected to improve the existing levels of benefits, if they cannot, they should not at least reduce them; they should not bring in inferior schemes which amount to a reduction. Viewed from any angle, it is unjust not to revert to the OPS.

Chances are that you have answered 2. If so, your primal brain has decided it. If you said 5 then you had applied your logical or executive part of your brain. These two parts of the brain, according to Nobel Prize winner, Daniel Kahneman, System 1 (Fast Thinking) & System 2 (Slow Thinking) are responsible for our actions.

How both the systems work or when they can be put into best use? In the current age of technology with low attention span, speed with accuracy takes precedence. Faster is often deemed smarter!

A slightly deeper understanding of the functioning of the brain will help us in better problem solving. As per 2 Systems Theory, System 1 is quick, involuntary, intuitive, effortless and reactive. It is generally the default mode. On the other hand, System 2 is lazy, deliberate, conscious and logical.

System 1 is the primitive part of our brain and is same like any other primates. It helps us in Fight-Flight-Freeze (3F) reactions. It detects threats and protects us from impending danger. It helps us to avert crisis and react spontaneously to keep us safe. For instance, if I throw a plastic snake towards you, System 1 will detect a threat and signal your brain to make you run for safety. Then after some time your System 2 will find out that it is not a real snake.

Is not a real snake.

System 2 is unique to humans. It is the thinking and learning part of our brain. But System 1 has to force System 2 to start. It has to be switched on as it is generally on sleep-mode. Therefore, a deliberate effort has to be made to wake-up System 2. System 2 brings in focus. While learning and practicing, System 2 enables us to grasp and store the learnt information. Then System 1 helps in easy retrieval as it gets ingrained in our muscle memory.

grained in our muscle memory. In the mathematical calculation at the beginning if we had learnt the rules (i.e., addition comes after division) then System 1 will provide the answer in super quick time or else System 1 will decide the answer on its own which might be devoid of logic. If there is an easy way to arrive at a solution our brain will take that route every time. It is the Law of Least Mental Effort. The default brain System 1 overpowers System 2 most of the time.

So, both the Systems feed each other and have to be put to best use as per situations. Therefore, being aware of the functioning of our brain or how it processes information, we can definitely improve on the quality of the outcome. System 2 (Slow Thinking) helps us to learn a skill or a technique, acquire knowledge and build focus for deep learning. With this learning, System 1 can use it for automatic responses and you can rely on the reflex actions at the heat of the moment. In fact, slow thinking prepares us for fast thinking!

A simple advice is to divide the tasks into FT/ST (Fast & Slow Thinking). Routine or simple tasks are carried out by System 1 whereas in tasks which demand cognitive skills, interpretation or analysis, System 2 plays a dominant role.

It is less about math and more about the science of brain functioning. If System 2 had learnt the rules then the answer is fast and correct or else....Finally, it is about learning slowly for right and fast answers.

The Railways is busy laying new tracks along the route that connects Maharashtra to Telangana. Inasmuch as the developmental activities have their own place, it is equally important to ward off undesirable negative impact of infrastructural measures in tiger landscapes. When free movement of tigers is hampered, putting in place mitigation measures like identifying vulnerable stretches that are prone to train-animal collision is vital. Curvatures, or simply turns on tracks, have to be spotted; necessary instructions need to be passed on to the autopilots to be cautious while traversing such areas. Underpasses as well as overpasses have to be expedited in crucial wildlife habitats. These structures have to be scientifically built keeping in mind the size and movement of animals. Augmentation of manpower could help and so could enhanced warning boards to alert locopilots in sensitive stretches. A three-year-old leopard walked into a cage trap set in Unit 16 of Aarey Colony in the small hours of Wednesday and later taken to the rescue centre at the adjoining Sanjay Gandhi National Park, he said. A one-and-half-year-old girl was attacked and killed by a leopard in Unit 15 of Aarey Colony Monday morning.

New Delhi, Oct 26: New Congress president Mallikarjun Kharge Wednesday set up a 47-member Steering Committee that includes former prime minister Manmohan Singh and the party's ex-presidents Sonia Gandhi and Rahul Gandhi.

The interim panel headed by him would take the place of the Congress Working Committee, the apex decision-making body, till a new CWC is formed after Kharge's election is ratified at the party plenary. All members and permanent invitees of the last CWC have been retained in the committee except Vivek Bansal

Bansal, a former MLA who was a permanent invitee in the previous CWC, is now the in-charge for Harvana affairs of the party.

None of the special invitees to the previous CWC under Sonia Gandhi have found a place in the new Steering Committee announced by Kharge hours after he took over as the new party Congress president. Shashi Tharoor, who contested against Kharge, is not among the panel members. He was



earlier heading the Professional Congress wing of the party but resigned ahead of the party's presidential election.

The CWC special invitees not included in the new panel are Ajay Kumar Lallu. Chinta Mohan. Deepender Singh Hooda, Sachin Rao, besides Seva Dal chief organiser Lalji Desai, IYC chief Srinivas B V, NSUI chief Neeraj Kundan, Mahila Congress chief Netta D'Souza and president of Intuc G Sanjeeva Reddy.

Anand Sharma, a CWC member and a prominent leader of the G23 dissident group that was pushing for organisational overhaul, has been retained in the Steering Committee

Earlier in the day, soon after Kharge took over as the new chief, all CWC members and office bearers of the party tendered their resignations to the new party chief to enable him to choose his own team. There is a tradition of all office bearers of the Congress resigning soon after the election of the new president. "All the CWC members. AICC general secretaries and in-charges have tendered their resignation to Congress president,' said AICC general secretary

Organisation KC Venugopal. According to a communication from the AICC general secretary (Organisation), the steering committee members include senior party leaders Priyanka Gandhi Vadra, A K Antony, Ambika Soni, Anand Sharma, K C Venugopal, Randeep Surjewala and Digvijaya

"As per Article XV (b) of the Constitution of the Indian National Congress, the Congress president has constituted the Steering Committee which would function in place of the Congress Working Committee," Venugopal said in the

The CWC is the highest decision-making body of the Congress and the Steering Committee will now take all decisions till the ratification of Kharge's election at the party's plenary session attended by all PCC delegates.

According to the party Constitution, 11 members of the CWC will be nominated and 12 will be elected. Besides, the leader of the party in Parliament and the Congress president will also be the members of the working committee. The session is likely to be held in March next year.

India to expand NaVIC: ISRO chief

New Delhi, Oct 26: India plans to expand its regional satellite navigation system NaVIC in a bid to increase its use in the civilian sector and also by ships and aircraft travelling far from the country's borders.

The Navigation with Indian Constellation (NaVIC) uses seven satellites to provide real-time positioning and timing services in India and an area extending upto 1,500 km from the country's borders.

However, several satellites of the constellation have outlived their lives and the Indian Space Research Organisation (ISRO) now plans to replace at least five of these with the improved L-Band, which would enable it to offer better global positioning services to the


"We have five more satellites in production, they have to be launched periodically to replace the defunct satellites. The new satellites will have L-1, L-5 and S Band," ISRO Chairman S Somanath told PTI in an interview here.

Somanath was speaking on the sidelines of the India Space Congress organised by the SatCom Industry Association.



He said the NaVIC system was not in a "full-fledged operational regime" as some of its seven satellites have failed. Somanath said the space agency has also approached the government for permission to launch an additional 12 satellites in the Medium Earth Orbit (MEO) to expand the reach

New Delhi. Oct 26: Defence Minister Rajnath Singh Wednesdav told his Russian counterpart Sergei Shoigu that the Ukraine conflict should be resolved through dialogue and diplomacy and the nuclear option should not be resorted to by any side.

In telephonic talks, Shoigu briefed Singh on the evolving situation in Ukraine, including his concerns about possible "provocations through use of 'dirty bomb", the defence ministry said.

The conversation took place at the initiative of the Russian defence minister amid escalation of hostilities between Russia and

"Singh reiterated India's position on the need to pursue the path of dialogue and diplomacy for an early resolution of the conflict," the ministry said. "He pointed out that the nuclear option should not be resorted to by any side as the prospect of the usage of nuclear or radiological weapons goes against the basic tenets of humanity," it said.

It said the two ministers also discussed bilateral defence cooperation as well as the deteriorating situation in Ukraine.

There has been intensification of hostilities between Russia and Ukraine with Moscow carrying out retaliatory missile strikes targeting various Ukranian cities in response to a huge blast in Crimea nearly two weeks back. Moscow blamed Kyiv for the blast.

The Indian embassy in Ukraine has asked Indian nationals to leave the country at the earliest in view of fresh wave hostilities.

Centre resolves over 3K pension related cases

New Delhi, Oct 26: The Department of Pension and Pensioners' Welfare (DoPPW) has resolved 3,150 pending pension-related grievances during the ongoing special Swachhata campaign, an official statement issued on Wednesday said.



The DoPPW is the nodal department for formulation of policies relating to pension and other retirement benefits of central government pensioners/ family pensioners.

During the campaign, which began on October 2 and would end on October 31, the department has targeted to resolve 4.200 pending pension grievances to ensure speedy redressal and to enhance "ease of living" for 68 lakh central government pensioners, said the statement issued by the Personnel Ministry.

As October 21 this year, which is within 20 days of the start of the campaign, 3,150 pension grievances have already been resolved, it said.

The department is convening inter-ministerial meetings with ministries and departments concerned to resolve all grievances within the due time period.

The DoPPW has issued 30 circulars under easing of rules and processes, 3.094 e-files have been closed and a total of 26 cleanliness campaigns have been conducted, according to the statement.

Chennai, Oct 26: A probe by the National Investigation Agency (NIA) into the Coimbatore explosion case would be recommended to the Centre, the Tamil Nadu government said here Wednesday.

The state government also announced raising a special police force to foil sabotage and bolster its intelligence wing.

In a high-level meeting chaired by Chief Minister MK Stalin at the Secretariat, the present status of investigation related to the explosion was taken up and it was decided to set up a special force to prevent similar incidents

23 October, 75-kg explosives were seized in Coimbatore from the residence of 29-year-old Jameesha Mubeen who was killed after a gas cylinder exploded.

The explosion happened while he was moving past a temple on a car in Tamil Nadu's western textile city and he had allegedly tried to evade a police check post.

Senior officials of the NIA held discussions in Coimbatore Wednesday with Tamil Nadu police over the explosion and the inves-



tigation. Quoting Stalin's directives to officials in the meet here, the government said it was decided to recommend to the Centre to entrust the case to the NIA.

The move is considering the possibilities of links transcending Tamil Nadu borders and the likelihood of international connections emerging during the investigation of the explosion case, an official release here said.

As part of measures to further strengthen security, the government said it would set up new police stations at the three localities of Karumbu Kadai, Sundarapuram and Koundampalayam in Coimbatore. During Stalin's review of the overall law and order and security scenario in the state, it was decided to install additional high-tech surveillance cameras in key cities of Tamil Nadu including Coimbatore.

The Chief Minister directed officials to post additional personnel in the intelligence wing and protect and encourage informers. Chief Secretary V Irai Anbu, Director General of Police C Sylendra Babu and top state and intelligence officials took part in the high-level meeting. Coimbatore was brought under a tight security cover, following the explosion in front of Kottai Eswaran Temple in the heart of the city in the communally sen-

sitive Ukkadam area, on Diwali eve. In the meanwhile, over 100 BJP workers and sections of local people held a prayer meeting and lit lamps in front of the Lord Shiva temple to thank the presiding deity for protecting the city and its people from a "big disaster".

Led by BJP Mahila Morcha president and Coimbatore South MLA Vanathi Srinivasan, a group of women sat on the ground and lit lamps. Kottai Eswaran temple is formally known as Sangameswarar temple. The Unlawful Activities (Prevention) Act has been invoked in the Coimbatore explosion case and five men - associates of Mubin -- have been arrested so far and the state police is currently prob-

Chennai, Oct 26: The internal fight within Tamil Nadu's opposition AIADMK has escalated, with deposed party leader and former Chief Minister, O. Panneerselvam appointing office bearers in various districts of the state.

Panneerselvam, who still claims to be the party coordinator, has appointed more than 500 office bearers in various districts of the state.

The AIADMK, in its general body meeting held July 11, had expelled Panneerselvam and his associates from the primary membership of the party. His bitter opponent and former party Co-Coordinator, K. Palaniswami was appointed as the party's interim General Secretary then.

After his expulsion from the party, Panneerselvam moved the Madras High Court with the single judge bench suspending the appointment of the new office-bear ers and staying the expulsion of him and his associates.

However, the division bench vacated the stay and directed to maintain the status quo of the July 11 party general council meeting which had expelled Panneerselvam.

The Panneerselvam faction moved Supreme Court which stayed the proceedings and ruled that no elections be carried out in the AIADMK till it hears the matter of the tussle between the two warring factions November 21.

With Panneerselvam announcing the new appointments, the AIADMK official faction led by Palaniswami has come up in arms against the decision. A senior AIADMK leader told

IANS: "The Supreme Court is to hear the tussle between the two leaders on November 21... what was the hurry for announcing the posting of new office

Another senior AIADMK leader aligned to the official faction told IANS: "I am not coming out in the open as the case is being heard in the Supreme Court November 21, and OPS appointing new office bearers is not good given that the case regarding elections to the interim General Secretary is being heard by the Supreme Court and Palaniwami has told the court that there would not be any elections till it gives a verdict.

October 21, the Indian Navy ship on patrol in the Palk Bay near the India-Sri Lanka International Maritime Boundary Line (IMBL) fired shots at a fishing boat which had 10 people on board.

K. Veeravel, the 30-year-old fisherman, sustained bullet injuries on his thigh and stomach.

The Coastal Marine Police at Vedaranyam have registered a case against Indian Navy based on a complaint filed by the boat's owner, Selvakumar.

The Indian Navy, however, said that they found a suspicious-look ing boat, and even after repeated requests the boat did not stop, and hence it fired the warning shots as per Standard Operating Procedures.

The Navy immediately informed the Air Force base at Ramanathapuram and airlifted the injured fisherman to Ramanathapuram Government Hospital and later to Madurai



Government Medical College.

The fishermen said that they feared that the Sri Lankan Navy was at the Palk Bay and they had cut off their nets and were retracting when they heard some inaudible messages. After this incident many fishermen are apprehensive of

going into the sea. Sivakrishnan, a fisherman from Vedanaranyam, told IANS: "We are afraid of going into the deep sea. Anything can happen in the sea and we have been constantly in fear of the Sri Lankan navy attacking us if we cross the International Maritime Boundary Line, but now our own Navy is attacking us and this is quite unfounded. We have decided not to go

to the sea for the time being."

The decision by the fishermen has created an unprecedented crisis in the Vedaranyam area as most of the houses are dependent on fish and without the catch, the hustle and bustle at the market are over

INTERNET USE BY TERRORISTS TO BE FOCUS OF UN MEET

New Delhi, Oct 26: Ways to check the use of social media, new fund-raising methods and unmanned aerial systems by terror groups across the globe will be the focus of a two-day special meeting of the UN Security Council Counter-Terrorism Committee (UNCTC) this week in India.

British Foreign Secretary James Cleverly, External Affairs Minister S Jaishankar, his counterpart from Gabon, Shirley Ayorkar Botchwey, and Foreign Minister of Ghana Reem Ebrahim Al Hashimy are among those attending the meeting October 28 and 29, officials said Wednesday.

The meet will begin October 28 with a solemn ceremony at the Tai Mahal Palace hotel in Mumbai. where the participants will pay homage to the victims of the 26/11 Mumbai terror attack. The second day's deliberations will be in Delhi. The Taj Mahal hotel was one of the targets of the horrific 26/11 terror attacks nearly 14 years ago.

Secretary (West) in the Ministry of External Affairs Sanjay Verma told a media briefing that the larger purpose of the unprecedented UNCTC meeting in Mumbai will resonate with the "rest of the world because what happened in 2008 was an attack on what would be the identity of India in the financial and commercial space'

Ruchira Kamboj, India's permanent representative to the United Nations (UN) and the current chair of the UNCTC, said the meeting will focus on dealing with the challenge of the use of new and emerging technologies for terrorist purposes. Jaishankar, along with the member states of the UN Security

meeting will be hosted in Mumbai and Delhi 28 and 29 October, respectively

The overarching theme of the meeting would be 'countering the use of new and emerging technologies for terrorist purposes', the MEA said

>> The United Nation Security Council's (UNSC) two-day meeting in India on counter-terrorism will focus on dealing with use of internet, new payment mechanism and drones by terrorists

Council (15 current and five incoming) and senior UN officials, will lay a wreath at the 26/11 memorial site in the memory of the victims. A number of family members of the victims of the 26/11 attack are scheduled to speak at the ceremony.

'We will be honoured to hear the voices of the victims of the 2008 Mumbai terror attacks as well as the 2016 Brussels bombings. The meeting will be followed by an informal session on combating terror financing in the local and regional context," Kamboj, in her capacity as the chair of the UNCTC, said at the briefing.

On October 29, the participants will hold wide-ranging deliberations on checking terror groups using emerging technologies. Asked about China repeatedly blocking efforts at the UN to designate Pakistan-based terrorists. Verma, without naming any coun-

try, said the proposals ran into objections based on technicalities and subjectivities that are guided by "geostrategic alliances", far removed from the original cause for which the listing process was







Wife attempts suicide, hubby records incident

The woman fails in her first attempt but succeeds in hanging herself in the second attempt.



The woman's father Raj Kishore Gupta told reporters that his son-inlaw Sanjeev Gupta called him in the afternoon and said that his wife Shobhita had committed suicide.

"I rushed to her house in Gulmohar Nagar and found her body on the bed. Sanjeev was busy pumping her chest but she was lifeless. When I questioned Sanjeev, he showed me the video and I was shocked that he made no effort to save her but was busy recording the incident. He also did not rush her to the hospital," he said in a statement.

The Hanumant Nagar police have been informed of the incident by the deceased's family and the body has been sent for post mortem. Sanjeev Gupta is being questioned by the police. The couple had been married four years ago.

"Received Ambassador Sun Weidong of China for a farewell call. Emphasized that the development of India-China relations is guided by the 3 Mutuals. Peace and tranquility in the border areas is essential," the external affairs minister tweeted.

"The normalisation of India-China relations is in the interest of both countries, of Asia and the world at large," he said in a statement. India has been asserting that

the Sino-India ties must be based on three mutuals: mutual sensitivity, mutual respect and mutual interest. In his farewell remarks at an event Tuesday, Sun said it is natural for China and India to have some differences but the focus should be to seek common ground for development while resolving the pending issues through dialogue. Last month, the Indian and Chinese militaries carried out disengagement from the Patrolling Point 15 in the Gogra-Hotsprings area last month.

DELHI-NCR'S AIR IMPROVES, **BUT STILL 'POOR'**

New Delhi, Oct 26: Delhi's air quality improved Wednesday morning on the back of favourable wind speed but it remained poor.

The Air Quality Index (AQI) stood at 262 at 6 am, improving from 303 at 4 pm Tuesday. It was 312 at 4 pm Monday, the day of Diwali. The neighbouring cities of

Ghaziabad (262), Noida (246), Greater

Noida (196), Gurugram (242) and Faridabad (243) reported "moderate" to "poor" air quality. An AQI between zero and 50 is considered "good", 51 and 100 "sat-

isfactory", 101 and 200 "moderate", 201 and 300 "poor", 301 and 400 "very poor", and 401 and 500 "severe". Delhi's particulate matter

(PM) 2.5 pollution levels on Wednesday morning were three to four times above the national standard of 60 microgram per cubic metre for 24 hours.

The capital had recorded "very poor" air quality Tuesday after residents in many parts of the capital flouted the ban on firecrackers on Diwali night, but the pollution levels for the next day were the lowest since 2015, thanks to warm and windier conditions that diluted its effect.

In the last two years, Delhi and its neighbouring areas had witnessed "severe" air quality post Diwali, which was celebrated in November, with intense smog enveloping the region for days as stubble burning peaks during the month while low temperatures and calm winds trap pollutants.

Since Diwali was observed early in the season this year, moderately warm and windier conditions prevented the rapid accumulation of pollutants from firecrackers and reduced the effect of stubble burning.

Kerala Guv 'withdraws pleasure' against FM

CPI(M) central committee member Sujan Chakraborty told reporters the state government has "money for fairs, games and other activities" but does not have funds for NCC camps.

The ruling party refuted the allegations, saying that the Mamata Banerjee government in West Bengal is trying to run all the projects despite the Centre not releasing the state's dues amounting to about Rs 1.97 lakh crore.

"State governments fund 25 per cent for the camps, while the Centre provides 75 per cent," another NCC official said.

222mn kids facing climate disaster, poverty: Report

New Delhi, Oct 26: About 51 per cent of children in India are living under the dual impacts of poverty and the climate emergency, according to a new study.

There are almost 350 million children across Asia, including 222 million in India, who are gripped by both grinding poverty and climate disaster, the 'Generation Hope: 2.4 billion reasons to end the global climate and inequality crisis' report stated.

Developed by child rights NGO Save the Children and climate modelling from researchers at the Vrije Universiteit Brussel, it also stated that Cambodia topped the list of Asian countries most likely to face this "double threat", with 72 per cent

of children in the country affected, followed by Myanmar (64 per cent) and Afghanistan (57 per cent).

However, India was ranked the highest globally in terms of overall number of children facing this "double threat" of poverty and climate disaster, it stated.

While 351.9 million children in India are estimated to be affected by at least one extreme climate event a year, some of them are at particular risk because they are living in poverty and so have fewer resources to protect themselves and recover, the report stated. The climate emergency and

Islamabad: A plane carrying the body of an outspoken Pakistani journalist who was shot and killed by Nairobi police while living in hiding in Kenya touched down at an airport in Islamabad just after midnight Wednesday, officials said. Arshad Sharif was killed Sunday night when the car he was in sped up and drove through a checkpoint outside the Kenyan capital and police opened fire.

2,700 yr-old rock carvings unearthed

Baghdad: Archaeologists in northern Iraq last week unearthed 2,700-year-old rock carvings featuring war scenes and trees from the Assyrian Empire, an archaeologist said Wednesday. The carvings on marble slabs were discovered by a team of experts in Mosul Iraq's second-largest city, who have been working to restore the site of the ancient Mashki Gate, which was bulldozed by Islamic State group militants in 2016. Fadhil Mohammed, head of the restoration works, said the team was surprised by discovering "eight murals with inscriptions, decorative drawings and writings".

JKN said it has established a subsidiary in the United States, JKN Metaverse Inc, to own the Miss Universe Organisation. The Miss Universe pageant is broadcast in 165 countries, according to IMG.

In a statement, Chakrapong described the purchase as "a strong strategic addition to our portfolio." JKN, which is involved in content distribution, beverages, food supplements, beauty and consumer products, said the Miss Universe name will be used to promote its consumer products.

Moscow, Oct 26: Russian President Vladimir Putin Wednesday monitored drills of the country's strategic nuclear forces involving multiple practice launches of ballistic and cruise missiles, in a show of force amid the heightened tensions with the West over the conflict in Ukraine.

Defense Minister Sergei Shoigu reported to Putin that the exercise was intended to simulate a "massive nuclear strike" by Russia in retaliation for a nuclear attack on the country.

The maneuvers followed Putin's warning about his readiness to use "all means available" to fend off attacks on Russia's territory in a clear reference to the country's nuclear arsenals.

During the Russian drills Wednesday, a Yars land-based intercontinental ballistic missile was test-fired from the northern Plesetsk launch site. A Russian nuclear submarine in the Barents Sea launched a Sineva ICBM at the Kura firing range on the far-eastern Kamchatka Peninsula. As part of the exercise. Tu-95 strategic bombers also launched cruise missiles at practice targets.

The Kremlin said in a statement that all tasks set for the exercise were fulfilled and all the missiles that were test-fired reached their

The Russian drills came as NATO was holding its own annual nuclear exercises in northwestern Europe that will run until October 30. The drills dubbed Steadfast Noon

land, sea and air components of the nuclear triad have taken place on an annual basis to train the country's nuclear forces and demonstrate their readiness. A previous such exercise was held just days before Putin sent troops into Ukraine.

London, Oct 26: Britain's new Prime Minister Rishi Sunak Wednesday delayed the announcement of a keenly awaited plan for repairing the country's public finances until Nov 17, twoand-a-half weeks later than originally planned.

The postponement, Sunak's first policy decision since taking over from Liz Truss Tuesday, pushed up British borrowing costs in financial markets but by far less than seen in the panic bond selling caused by Truss's September taxcutting plan.

Finance minister Jeremy Hunt announced the delay in a televised statement, saying it would take



more time to ensure the new plan took into account the latest economic forecasts.

'The prime minister and I have decided that it is prudent to make that statement on the 17th of

The plan is expected to set out how the government will plug a budget shortfall of as much as 40 billion pounds (\$46 billion). Unlike Truss's plan last month, it will be fully audited by Britain's fiscal watchdog.

A statement from Sunak's office said he told his newly assembled cabinet that it was "important to reach the right decisions and there is time for those decisions to be confirmed with cabinet."

Britain's credibility in financial markets was shaken last month when Truss announced her unfunded tax cuts, triggering a bond market rout so severe the Bank of England had to intervene and Truss was forced into a U-turn and eventually resigned.

Germany unveils cannabis liberalisation plan, with caveats

The cannabis plan is one of a series of reforms outlined in last year's coalition deal between the three socially liberal parties in Chancellor Olaf Scholz's government

Berlin, Oct 26: Germany's health minister unveiled a plan Wednesday to decriminalise the possession of up to 30 grams of cannabis and to allow the sale of the substance to adults for recreational purposes in a controlled market.

Berlin will check with the European Union's executive commission whether the plan approved by the German government is in line with EU laws and would proceed with legislation only if it gets the green light, Health Minister Karl Lauterbach said.

Lauterbach said the new rules could serve "as a model for Europe. Realistically, they won't take effect before 2024," he said.

The plan calls for cannabis to be grown under license and sold to adults at licensed outlets to combat the black market, Lauterbach said. Individuals would be allowed to grow up to three plants, and to buy or possess 20 to 30grams of

If the legislation comes as planned, "this would be, on the one hand, the most liberal cannabis liberalisation in Europe, and on the other hand, it would also be

ket," Lauterbach said. He said "better youth and health protection" are the key aims of the government's proposal.

"It could be a model for Europe," which has a patchwork of often restrictive laws, he said.

The minister, who himself was

long sceptical about cannabis legalisation, argued that the current system isn't working, with consumption rising and the illegal market flourishing. He said 4 million people in Germany, a nation of 83 million, used cannabis last year and a quarter of 18- to 24-year-olds have used it.

Lauterbach said Germany didn't want to emulate the model long practised by the Netherlands, Germany's northwestern neighbour. It combines decriminalisation with little market regulation. Germany will examine whether cannabis can be consumed where it is sold, but it doesn't currently plan to allow that, Lauterbach said. The same goes for the sale of the substance in edible form.

Shops that sell cannabis would n't be allowed also to sell alcohol or tobacco products, and couldn't be located near schools.

The government does not plan to set a price, but does intend to set quality requirements, the health minister said.

He left open whether a "cannabis tax" above and beyond the standard sales tax, which could be used to fund information on the risks of the drug, would be levied but said

Bangalore, Oct 26: The global economy is approaching a recession as economists polled by Reuters once again cut growth forecasts for key economies while central banks keep raising interest rates to bring down persistently-high inflation.

One bright spot is that most major economies already in a recession or heading into one are starting with relatively low unemployment compared with previous downturns. Indeed the latest poll expects the smallest gap between growth rates and joblessness in at least four decades.

CBDT extends returns filing deadline for firms till Nov 7

New Delhi, Oct 26: The Finance Ministry Wednesday extended the deadline for filing income tax returns for the assessment year 2022-23 by businesses till November 7.

The last date for filing ITR by companies who are required to get their accounts audited was October 31.

The Central Board of Direct Taxes (CBDT), the apex decisionmaking body in matters of income and corporate tax, in a notification said since it had last month extended the deadline for filing audit reports, hence the ITR filing due date too is extended.

"CBDT... Extends the due date of furnishing of Return of Income under sub-section (1) of section 139 of the Act for the Assessment Year 2022-23, which is October 31, 2022... To November 7, 2022," the CBDT notification said.



The last date for filing ITR by companies who are required to get their accounts audited was October 31

Domestic companies are required to file their income tax returns by October 31, 2022, for the Financial Year 2021-2022. The due date to file ITR will be November 30, 2022, for companies which are subject to transfer pricing norms.

India, China trade crosses \$100bn during Jan-Sept

Beijing, Oct 26: India and China bilateral trade continued to boom, crossing \$100 billion for the second year in the first nine months of 2022 while India's trade deficit climbed to over \$75 billion, according to trade data released by Chinese customs.

The total bilateral trade, amidst the military standoff in eastern Ladakh, went up to \$103.63 billion, registering a 14.6 per cent increase compared to last year during the same period.

China's exports to India climbed to \$89.66 billion, registering an increase of 31 per cent, data released by China's General Administration of Customs (GAC) said



However, India's exports in the past nine months stood at \$13.97 billion, registering a decline of 36.4 per cent. As a result, the total trade deficit went up to over \$75.69 billion.

In 2021, the India-China bilateral trade hit a record high of over \$125 billion crossing the \$100 billion mark in a year when the relations touched a new low due to the standoff by the militaries in eastern

Last year, China's exports to India went up by 46.2 per cent to \$97.52 billion while India's exports to China grew by 34.2 per cent to \$28.14 billion. The trade deficit for India stood at \$69.38 billion in 2021.

New Delhi, Oct 26: Slapped with a second hefty fine for anti-competitive practices, Google India Wednesday said it remains committed to users and developers and is reviewing the antitrust body's order to evaluate next steps.

The Competition Commission of India (CCI) Tuesday slapped a ₹936 crore fine on Google for "abusing" its dominant position on its Android mobile app store and ordered it not to prevent app developers from using third-party billing or payment processing services in India.

That penalty came just days after a ₹1,337.76 crore fine was imposed on it for abusing the dominant po-



operating system.

Commenting Tuesday's CCI order, a Google India spokesperson said Indian app developers have benefited from the technology, security, consumer protection, choice and flexibility that Android and Google Play provide.

"And, by keeping costs low, our model has powered India's digital transformation and expanded access for hundreds of millions of Indians," the spokesperson said. "We remain committed to our users and developers and are reviewing

the decision to evaluate next steps Google had called last week's penalty "a major setback for Indian consumers and businesses", and stated that it will review the order

Appeals against CCI orders can be filed in the National Company Law Appellate Tribunal (NCLAT).

The search engine giant has faced criticism globally for mandating software developers using its app store to only use its proprietary in-app payment system that charge a commission of up to 30 per cent on purchases made within an app. In Tuesday's order, CCI asked

Google to "cease and desist" from anti-competitive practices and not restrict app developers from using third-party billing or payment-processing services.

CCI asked Google to follow a nondiscriminatory policy against other apps that allow payments via Unified Payments Interface (UPI).

Goa, Oct 26: There were attacks and there were defences. There were scoring opportunities and so were the misses and saves. But in the end, it all came down to the face-off between the custodians. where the Colombian – Luisa Agudelo – nailed it.

Luisa first had some aid from the post when she denied Nigeria's fifth shot in the penalty shootout – a potential match-winner, struck by Omamuzo Edafe - before a clear save against Comfort Folorunsho leading her side into the FIFA U-17 Women's World Cup final with a 6-5 victory via sudden death at Pandit Jawaharlal Nehru Stadium here.

The game might got finished goalless at the end of stipulated time, but those 100 minutes (including added-on times in both halves) were action-packed. The start was slow as players from both the sides looked nervous as they made passing errors and lacked ball control at crucial junctures.

However, it was the Flamingos. as the Nigerians are known as. who got into their stride first. They, were relentless with most of their attacks from the right side. But, Colombian defence was strong enough to deny the Nigerians any opportunity to

trouble their custodian Luisa.

Colombia gradually got into their stride as they missed a superb chance to take the lead in the 16th minute. Gabriela Rodriguez managed to steal the possession in the opposition-half before sending in a low cross from right flank into the box and the Nigerian goalie Faith Omilana and a defender fumbled close to the post. Orianna Quintero was on the spot and managed to take the shot but Faith put her body on the line to deny the Colombians the lead.

In the 25th minute, Colombian skipper Linda Caicedo, who was the main threat for the Flamingos throughout the match, played it for Orianna in the right flank, before the latter sent in a cross to find Yesica Munoz, who went for a finesse shot only to miss the target.

Mary Espitaleta almost broke the deadlock three minutes later when her direct free-kick from just outside of the Nigerian box hit the crossbar before ricocheted only for Yesica to head straight into the hands of Nigerian goalie. Despite creating some clear scoring opportunities, neither of the sides failed to break the deadlock with the players headed into the tunnel goalless at the halftime.

After the change of ends, Colombians looked to attack more, which somehow hurried the

Flamingos to make passing. Linda was the centre of most of the Colombian attacks as they continued to create chance after chance only to be disappointed with the

final result - missing out on a goal. Despite having less ball possession compared to their opponents, Colombians were on top throughout the game, leave the first 10-15 minutes. Their defence, which was looking fragile in the beginning, slowly found confidence and started to deliver. The Colombians have eight shots on target compared to Nigeria's two throughout the match.

Both the sides tried their best to find the winning strike but failed to do so as the match went into the penalty shootout. where Colombians began the proceeding. For Colombia, Gabriela, Stefania Perlaza, Mary, Linda, Juana Ortegon and Natalia Hernandez hit the target, while Yesica's effort was saved by substitute goalie Chikamso Jiwuaku.

For Nigeria, Edet Offiong, Edidiong Etim, Miracle Usani, Taiwo Afolabi were on target before Omamuzo's strike hit the post to Luisa's left. Shakirat Oyinlola kept Nigeria in the game before Luisa saved Comfort effort and denying the Flamingos a chance to secure a berth at the summit clash in the process.
