6 YEARS SINCE DEMONETISATION

Cash with public at record ₹30L-cr

The intent of demonetisation, which was criticised by many experts for poor planning and execution, was to make India a 'less cash' economy

Mumbai, Nov 6: Currency with the public has jumped to a new high of ₹30.88 lakh crore as of October 21, illustrating that cash usage is still robust even six years after the demonetisation move.

At ₹30.88 lakh crore, the currency with the public is 71.84 per cent higher than the level for the fortnight ended November 4, 2016.

November 8, 2016, Prime Minister Narendra Modi had announced the decision to withdraw ₹500 and ₹1,000 denomination notes with the ultimate aim of reducing corruption and black money in the economy. The intent of the move, which was criticised by many experts for poor planning and execution, was to make India a 'less cash' economy.

As per the fortnightly data on money supply released by the RBI Friday, the currency with the public increased to ₹30.88 lakh crore as on October 21. The central bank data



for Reserve Money had put the currency in circulation at ₹17.7 lakh crore November 4, 2016.

Currency with public refers to notes and coins used by people to transact, settle trades, and for buying goods and services. The figure is arrived at after deducting cash with banks from the currency in circulation. Cash usage has been steadily rising in the economy, even as newer and far convenient digital alternatives of payments have become popular. The COVID-19 pandemic, which laid an emphasis on contactless transactions, also gave a fillip to such digital modes.

A 2019 RBI study on digital payments had partly addressed the issue. "Although digital payments have been growing gradually in recent years, both in value and volume terms across countries, data also suggests that during the same

time, currency in circulation to

GDP ratio has also increased in

consonance with the overall eco-

nomic growth," it had said. "... An increase in digital payments to GDP ratio over a period of time does not seem to automatically imply a fall in the currency to GDP ratio of the country," it had added.

It had said that after demonetisation, India has witnessed a significant increase in digital transactions, although the digital payments to GDP ratio in the country has been traditionally low.

In a recent note, economists at SBI had said the currency in circulation declined by ₹7,600 crore in the Diwali week, which was the first such decline in nearly two decades if one were to exclude the 2009 festivities.

5cr unused doses of **Covaxin set to expire**

Hyderabad, Nov 6: Nearly 50 million doses of Bharat Biotech's COVID-19 vaccine, Covaxin lying with the firm are set to expire early next year as there are no takers owing to poor demand, company sources said.

Due to lack of product demand, production stoppage of Covaxin-a two dose jab, was initiated by Bharat Biotech earlier this year, though the vaccine maker has established manufacturing to reach an annualised capacity of 1 billion doses at the end of 2021.

"Bharat Biotech has more than 200 million doses of Covaxin in bulk form and approximately 50 million doses in vials ready to use. Due to lack of product demand, production stoppage of Covaxin was initiated several months ago, earlier this year," sources told PTI.

"Covaxin doses in vials are set to expire during early 2023, resulting in losses for the company,' sources further said.


However, the quantum of loss that Bharat Biotech would incur in the event of all the 50 million doses expiring next year is not known.

So far, 219.71 crore doses of COVID-19 vaccines, including Covaxin have been administered under the nationwide vaccination drive. As the infection rate has been sturdily declining globally, exports of Covaxin were negatively impacted with poor off take by foreign countries.

BJP retains Dhamnagar

Bhubaneswar, Nov 6: Defeating the Naveen Patnaik-led BJD, the BJP was able to retain the Dhamnagar MLA seat in Bhadrak district with its candidate Suryabanshi Suraj winning by a margin of 9,881 votes.

Suraj garnered 80,351 votes while his nearest rival BJD candidate Abanti Das got 70,470 votes. BJD rebel candidate Rajendra Das polled 8,153 votes. Congress was in fourth position as its nominee Baba Harekrushna Sethy got only 3,561 votes. The voting for the bypoll was conducted

November 3 at 252 polling booths and 68.98 per cent polling was recorded.

The BJP, which slipped to third position in the last bypoll for Brajarajnagar, has fought the bypoll unitedly. Many senior leaders including Union Ministers Dharmendra Pradhan, Bishweswar Tudu, former Union Minister Pratap Sarangi and state president Samir Mohanty campaigned for the party candidate. The organisation set up by Manmohan Samal and Bishnu Sethi has also helped the party to win the MLA seat, said party insiders.

The BJD, which had played the women and

Tirupati temple richer than Wipro, Nestle

At current trading price, the net worth of Tirupati temple is more than several blue-chip Indian firms

New Delhi, Nov 6: Tirupati's world famous Lord Venkateswara temple's net worth of over ₹2.5 lakh crore (about USD 30 billion) is more than the market capitalisation of IT services firm Wipro, food and beverage company Nestle and state-owned oil gi-

ants ONGC and IOC Tirupati Tirumala Devasthanams (TTD), keeper of the temple dedicated to Tirupati's presiding deity, for the first time since its founding in 1933 declared its net

Its assets include 10.25 tonnes of gold deposits in banks, 2.5 tonnes of gold jewellery, about ₹16,000 crore of deposits in banks, and 960 properties across India. All these total to over ₹2.5 lakh crore.

At current trading price, the net worth of Tirupati temple is more than several bluechip Indian firms, according to stock exchange data.

Bangalore-based Wipro had a market cap of ₹2.14 lakh crore at close of trading Friday,



while UltraTech Cement had a market value of ₹1.99 lakh

Swiss multinational food and drink major Nestle's India

unit, with a market cap of ₹1.96 lakh crore, too was valued below it.





NHRC seeks info on under-trials

Bhubaneswar, Nov 6: The National Human Rights Commission (NHRC) has asked the chief secretaries of Odisha and other states to submit detailed reports on under-trial prisoners (UTPs) languishing in jails. Hearing a plea filed by senior

Supreme Court lawyer Radhakanta Tripathy, the apex rights body has asked the chief secretaries to file the reports within two months.

Tripathy had informed the commission that most problems that UTPs are facing are borne out of poverty, lack of proper legal help and insensitivity within judiciary

"Most under-trials are from weaker sections of the society, illiterate and unfortunate victims of circumstances," Tripathy said, seeking the NHRC's intervention for ensuring fair trials to the UTPs.

Tripathy said that the SC has made it clear that unless a crime is devious and attracts a punishment of seven years or more, no arrest is to be made. But this is being ignored and the police across the

no arrest is to be made country continue to make arrests based on flimsy charges. Enforcing the SC order in itself would re-

duce the number of prisoners in the

country by half, he said. According to India Justice Report, around eight in 10 prisoners in Indian jails are awaiting trial while the rate of occupancy increased from 118 per cent to 130 in 2021.


There has been an increase of 7.7 lakh in the number of people arrested in 2021 as compared to 2020. While 1.47 crore people were arrested in 2021, 1.39 crore were arrested in 2020. The prisoner population in 1,319 jails grew by 13 per cent from 4,88,511 in December 2020 to 5,54,034 in December 2021.

Across India, 24,003 under-trials have been in jails for three to five vears and 11,490 for more than five years of which Uttar Pradesh and Maharashtra have the lion's share.

Significantly, appalled over the poor living condition of prisoners in Odisha jails, the High Court had directed the DG. Prisons to ensure clean toilets and prisoner wards in all the jails in state in 2021.

Now, app to assess structural integrity of bridges

BRIDGES NATURALLY VIBRATE. AND TO STUDY THE ESSENTIAL 'MODAL FREOUENCIES' OF THOSE VIBRATIONS IN MANY DIRECTIONS, ENGINEERS TYPICALLY PLACE SENSORS

here could be a smartphone application to know if San Francisco's Golden Gate Bridge. or any other bridge for that matter, is holding up well, according to a study

The new study shows that mobile phones placed in vehicles, equipped with special software, can collect useful structural integrity data while crossing bridges. In doing so, they could become a less expensive alternative to sets of sensors attached to bridges themselves.

'The core finding is that information about structural health of bridges can be extracted from smartphone-collected accelerometer data," says Carlo Ratti, co-author of the study.

The research was conducted, in part, on the Golden Gate Bridge itself. The study, involving researchers from the Massachusetts Institute of Technology (MIT), US, showed that mobile devices can capture the same kind of information about bridge vibrations that stationary sensors compile

The researchers also estimate that depending on the age of a road bridge, mobile-device monitoring could add from 15 per cent to 30 per cent more years to the structure's lifespan.

"These results suggest that massive and inexpensive datasets collected by smartphones could play an important role in monitoring the health of existing transportation infrastructure," the authors write in their new paper, published in Nature

Communications Engineering. Bridges naturally vibrate, and to study the essential 'modal frequencies' of those vibrations, engineers typically place sensors, such as accelerome-

ters, on bridges themselves. Changes in the modal frequencies over time may indicate changes in a bridge's structural integrity.



To conduct the study, the researchers developed an Android-based mobile phone application to collect accelerometer data when the devices were placed in vehicles passing over the bridge

To conduct the study, the researchers developed an Android-based mobile application to collect accelerometer data when the devices were placed in vehicles passing over the bridge. They could then see how well those data matched up with data record by sensors on bridges themselves, to see if the mobile-phone method worked.

"In our work, we designed a methodology for extracting modal vibration frequencies from noisy data collected from smartphones," lead researcher Paolo Santi said.

"As data from multiple trips over a bridge are recorded, noise generated by engine, suspension and traffic vibrations, (and) asphalt, tend to cancel out, while the underlying dominant frequencies emerge," Santi added.

In the case of the Golden Gate

Bridge, the researchers drove over

trips by Uber drivers with activated phones as well, the study said. The team then compared the resulting data to that from a group of 240 sensors that had been placed on the

their method would fare in that setting. To do so, they studied a bridge in Ciampino, Italy, comparing 280 vehicle trips over the bridge to six sensors that had been placed on the bridge for seven months.

Here too, the researchers were encouraged by the findings, though they found up to a 2.3 per cent divergence between methods for certain modal frequencies over all 280 trips, and a 5.5 per cent divergence over a smaller sample. That suggests a larger volume of trips could yield more useful data.

"Our initial results suggest that only a modest amount of trips over the span of a few weeks are sufficient to obtain useful information about bridge

modal frequencies," Santi mentions. Looking at the method as a whole, Professor at MIT, Markus Buehler observes, "Vibrational signatures are emerging as a powerful tool to assess properties of large and complex systems. ranging from viral properties of pathogens to structural integrity of bridges as shown in this study.

As Ratti acknowledges, there are ways to refine and expand the research, including accounting for the effects of the smartphone mount in the vehicle, the influence of the vehicle type on the data, and more.

"We still have work to do, but we believe that our approach could be scaled up easily — all the way to the level of an entire country," Ratti said.

"It might not reach the accuracy that one can get using fixed sensors installed on a bridge, but it could become a very interesting early-warning system. Small anomalies could then suggest when to carry out further analyses," said Ratti.

Post-pandemic, confidence in vaccines has declined considerably

T't's one of the greatest achievements of modern science. Within only a year of SARS-CoV-2 (the coronavirus that causes Covid-19) being identified, safe and effective vaccines were developed, tested, and had begun to be rolled out. Since the first doses were administered nearly two years ago, they're estimated to have saved tens of millions of lives.

And yet Covid vaccines attracted considerable opposition before their development was even complete. While vaccine hesitancy is not a new phenomenon, Covid vaccines were met with particularly virulent hostility among conspiracv theorists and other anti-vaxxers.

Meanwhile, the vaccines' rapid development and approval gave way to a new group of vaccine sceptics. These people don't consider themselves "anti-vaxxers", and didn't necessarily oppose other vaccinations, but had concerns over the speed at which Covid vaccines were tested and approved.

This leads to the question of

whether, despite the undeniable success of Covid vaccination campaigns, public confidence in vaccines has decreased since the onset of the pandemic.

Researchers sought to answer this question in our recently published study, in which we compared vaccine confidence pre-pandemic and since the rollout of Covid vaccines. We compared the results of two

online surveys carried out in November 2019 and January 2022. involving more than 1,000 adults. The survey responses showed that confidence in vaccinations in the post-pandemic group was considerably lower than in the pre-pandemic group.

A drop in vaccine confidence was observed regardless of participants' age, gender, religious beliefs, education and ethnicity.

One notable difference between the two surveys was that while in the pre-pandemic group middleaged participants were significantly more vaccine-hesitant than

This observation could be partly explained by the fact that Covid is known to cause more serious illness in older patients, whereas it doesn't commonly lead to hospitalisation and death in young people. So it's conceivable that older people felt more motivated to get their jab, and were more appreciative of the protection it aforded them

Both in 2019 and 2022, participants who held religious beliefs were significantly more vaccine-hesitant than atheist and agnostic ones. Meanwhile, respondents from black and Asian backgrounds were more hesitant than those of white

ethnicity. There was no association between gender and vaccine confidence in either survey. While providing useful insights

into how the pandemic affected public perspectives on vaccination, this study does have limitations. When we ran the first survey in 2019, we couldn't have expected a pandemic to break out only a few months later. So the study was not originally designed to follow up the participants' opinions over time (called a longitudinal study).

Instead, the researchers used the same methods to recruit a second group of participants for the 2022 survey, and asked them the same questions so we could compare the outcomes (a cross-sectional study). As a result, their findings should be interpreted with caution, as they don't reflect the changing opinions of the same group of people over time, but rather provide snapshots of two comparable groups at two distinct moments in time.

They did, however, add a single

question to the 2022 survey ask ing participants to report their change in vaccine confidence since Covid. Nearly one in four said their confidence in vaccines had dropped since the pandemic.

How can we rebuild declining vaccine confidence?

Promoting confidence in vaccines is crucial to help us fight infectious diseases that are already among us, as well as new ones that will undoubtedly emerge in the future. So how can we address this challenge?

A key element is to reassure the public about the safety of vaccines. Although, like all medications, they carry a very small risk of serious side-effects, these risks are minuscule compared with the damage caused by the diseases they protect against.

For example, in the case of Covid, many people hesitate to get vaccinated because they're concerned about the rare side-effect of myocarditis (inflammation of the

Sonepur, Nov 6: Cotton farming is gradually picking pace in parts of Subarnapur district. The district produces quality cotton which has good demand abroad. Given the current MSP fixed by the government, the district is expected to produce cotton worth ₹48 crore in the current year.

However, the farmers earlier used to resort to distress sale in the absence of procurement and good marketing facility. Those days are gone and now the traders from Maharashtra are buying their cot-

These days, scores of farmers have shifted their focus on cotton farming in parts of the district.

lease basis. Some of them even settled here. Local farmers learnt the techniques of the cotton farming from the Andhra farmers.

Now, thousands of farmers are growing cotton at Tentulimahada, Badakhamar, Anandapur, Jatosingha, Bagabar, Mursundhi, Kenjhariapali, Bhalpadar, Khandahata, Durjantaila under Biramharajpur; Kalapathar, Jaloe, Sonepur and in some parts of Tarava block.

The Central government has fixed the MSP of cotton per quintal at ₹6,080. A procurement centre is at Badakhamar under Birmaharajpur. Significantly, the Cotton Corporation of India (CCI) has decided to procure cotton from the farmers at MSP.

However, farmers say, selling their produce to the CCI at the MSP will be a loss for them, as previous year the Maharashtra traders had bought cotton at ₹9,510 per quintal. The farmers had good returns by selling the yield to the private traders.

"We want to sell our produce to traders and cotton mills because of high price," farmers said.

Shahadev Mahakur, a cotton farmer of Anandapur said that this year they have got a good harvest – 15 quintal per hectare. This year, cotton rate will be high and farmers are expecting good returns.

When asked about the prospects of cotton farming, district agriculture officer Gourishankar Singh said that a decision was taken to open the procurement centre at Badakhamar this year. "In Tamil Nadu and Maharashtra, cotton farmers have suffered crop loss. Cotton mill owners in those states are eager to buy cotton from Odisha. In view of such situation, the cotton farmers of Subarnapur are at a vantage point to make a big buck by selling their produce at the price higher than the MSP.

Textbooks sold off as scrap in govt school

Paradip, Nov 6: In a shocking incident, books meant for distribu tion among students of government schools in this port town were sold off to a scrap dealer after those were allegedly eaten away by white ants.

The matter was reported from Sanjay Gandhi School at Nua Bazaar in Paradip port town where the books were sold to a scrap dealer Raghua Sahu for ₹400. This cluster school in Paradip is included in Mo School Yojana under 5T initiative of the state government. The school has 15 teachers and a peon with 330 students on its rolls in 2021-22 session. The school has undergone repairing and transformation thrice from 2019 onwards at an expenditure of ₹1 crore.

The books were meant for distribution to students of government schools under Ujjwal and Utthan schemes when schools remained closed during Covid pandemic in 2020-21 educational years. them off after those were allegedly Many students failed to study prop-

erly due to closure of the schools Realising the situation, the state government had decided to supply books to students from Class-II to Class-V under Ujjwal scheme and for students from Class-VI to Class-VIII under Utthan scheme.

The state School and Mass Education department had supplied these books to schools for distribution but the authorities chose to keep it with them instead and sold eaten away by the white ants.

Cluster resources centre coordinator (CRCC) Sukant Swain operates from a room in this school When questioned, the CRCC and school authorities tried to shift the burden and blamed each other for the development. This reporter met the scrap dealer Sahu and tried to figure out the matter when he was coming out of school carrying the books.

Sahu confirmed the develop-

ment stating that all the books weighed 72 kg and he had paid ₹400 to the school in the presence of four lady teachers and

The CRCC said that the teachers have sold these books. Headmistress Sabita Kumari Parida feigned ignorance on the development stating that the books were in possession of CRCC and he might have sold these books. Block education officer Pabitra Kar said he has no knowledge about the incident as he is in a hospital on a health emergency. DEO Niranjan Behera also feigned ignorance about the incident.

A local Arabinda Swain demanded a probe into matter and action against the teachers and education authorities. Rabindra Ojha, vice-president of school committee alleged that the school authorities always sell off the old articles whenever a repairing or renovation work takes place in the school.

Charred body of missing youth found in Kandhamal dist

Luna embankment caves in due to wanton sand mining

Marshaghai/Drabish/Patkura, **Nov 6:** With rampant sand mining from Luna riverbed, a 40-metre stretch at Jalapoka panchayat under Marshaghai block of Kendrapara district caved in. Following this, communication on this route connecting two panchayats has been disrupted since Saturday.

Reports said, the right saline embankment of Luna river had developed a thin crack Friday night. It gradually widened before collapsing into the river. It is the only road that facilitates communication to people of two panchayats to the block headquarters.

Locals have expressed their displeasure over the development, alleging that wanton sand mining from the river bed near the embankment is weakening the road. After the collapse of the em-

However, it was learnt that the embankment was earlier strengthened from Pakhyat to Karilopatana, but the work was botched up.

Contacted, the superintending engineer of the Cuttack north irrigation division blamed the low water flow in the river adding that it has posed danger to the embankment. The repair of the damaged embankment will be started soon, he said.

Champua's women farmers show the way with solar-powered cold storage

Champua, Nov 6: Farmers in many cases are deprived of getting right price for their produce due to lack of marketing and preservation facilities. Some women farmers in Champua area of Keonjhar district have set an example for others by setting up a cold storage which is run by solar energy. This has made them self sufficient.

Women members of Baba Jhadeswar Self Help Group (SHG) of Maheswar village have been managing a solar-powered cold store facility given by OMBADC.

Its storage capacity is 5 metric tonne. ₹15 lakh was spent for the project in 2021-22, with 100 percent subsidy to the beneficiaries from the Horticulture department.

Since then, the women members of this SHG have never looked back. They have taken up vegetable farming and they store their produce in the cold store till the time they get good prices in return.



Prajwalit Mohant, one of the beneficiaries said that earlier they used to face a lot of problems after harvesting vegetables. "The vegetables could not be kept for a long time when they are unsold. They used to rot and go waste. Now, that

problem is over. Farmers have to keep their harvested vegetables for a long time in the cold store till they feel confident to sell them at right price to customers or

traders," Mohant observed. The labour they invested in

raising crops does not go in vain after the cold storage facility was put in place in the area. These farmers are making good profits from the project.

"Earlier, farmers felt compelled to sell their vegetables within a day or two after harvest. Now, the cold store has provided them preservation facility. Local people also pay rent to use the cold

store," they said. They observed that such cold stores are required in various parts of the district so that more people would be encouraged to take up vegetable farming.

DEATH OF 4 PERSONS IN ACCIDENT

Plaint filed against NHAI

Keonjhar, Nov 6: Two days after the death of four persons in a gruesome road accident at Badapasi under Sadar police limits in Keonjhar district, a complaint was lodged at the Sadar police station holding the National Highway Authority of India (NHAI) and the consultancy agency responsible

for the mishap, Saturday. The complaint was lodged by former MLA candidate Jagabandhu Mohanta of Ghasipura Assembly segment. Mohanta has alleged that the accident occurred due to the negligence, irresponsible and whimsical attitude and error in road construction works by the NHAI authorities and the con-

sultancy agency. Mohanta has written letters to SP, Keonjhar, NHAI authorities, state police DG and Union Road and Transport secretary demanding action over the mishap. He alleged that the mishap occurred as the vehicles were moving on one side of the road due to



incomplete road works and no warning sign or information on maximum speed limit was displayed at the site.

Sadar police IIC Sunil Kar said that he could comment only after the FIR lodged is available to him. Advocate Suraj Mohapatra said it is necessary to probe whether the consultancy agency had the permission to obstruct the road and the guidelines of NHAI has been observed or not.

Bibi Back

The pendulum in Israel politics has swung to the opposite direction with vengeance in just one year. A great experiment in the history of the country in inclusive governance comprising Right, Left, centre and Israeli Arabs has miserably failed and is now being replaced by another first ever in its history - a government by a coalition that includes Far-right and ultra-orthodox. The election – fifth in less than four years - has not only brought back to power Benjamin Netanyahu, known by his pet name Bibi, ousted a year back, but turned Israel dangerously Far-right. This is a trend gaining ground across the world and even in nearby Europe, even though Left politics is getting firmly entrenched in one South American country after another, the latest being Brazil.

In fact, Israel has been drifting Right for years. According to one estimate about 60% of the Israeli electorate is Right-wing against 12-14% voting for the Left and the remainder belonging to the so-called centre. But while polling had clearly indicated that the Religious Zionism - a bloc of three extremist parties that collectively embody racist, Jewish supremacist and anti-Arab sentiments - would do well in the election, the extent of their success has surpassed all expectations.

The elections this time were fought primarily to ascertain whether Netanyahu, who is still facing trial for corruption, has the popular mandate to recapture power. The results confirm his return as Prime Minister once more with a slender majority in the 120-seat Knesset (Israeli Parliament), chalked up with the help of the Far-right and rabidly anti-Arab, anti-Palestinian outfits. Such a fallout is sending shockwaves both to the Middle East and the rest of the world. The triumph of the racist Far-right signals the new government may have to acquiesce to the Religious Zionism's agenda of deportation of 'disloyal' Palestinian citizens of Israel and the annexation of the occupied West Bank. The strategy adopted by Netanyahu by joining hands with these groups has greatly helped his extremist allies become part of mainstream politics. Itamar Ben-Gvir, the new icon for anti-Arab forces, was a follower of the banned Kach terrorist group, with a conviction for inciting racism. For years he was dismissed as politically untouchable. After the recent election he now controls the third-largest political force in Israel, thanks to Netanyahu who is expected to appoint him

Such a scenario has already caused alarm across the world. The Joe Biden administration has made it clear that it will have no truck with Ben-Gvir. Such a stand, however, does not seem to cut much ice with Netanyahu who is hoping for the return of Donald Trump as US President in 2024 on the wave of a Republican resurgence. The mid-term poll in the US gives encouraging indications for such an eventuality as Biden's popularity has dangerously nosedived.

Netanyahu, undoubtedly, is also too seasoned a hardliner to dance to the tune of the Far-right. He needs this coalition for his own survival. His immediate agenda is to get a law passed to postpone or even cancel his trial. A guilty verdict or a plea bargain that would drive him away from politics will cause an existential crisis for him. He is also bent on packing his men in the Supreme Court in order to make a mockery of Israeli democracy and firmly establish his grip on power

He may, however, find it difficult to implement his other agenda of thwarting Iran's nuclear ambitions through airstrikes at Iran's strategic installations. His efforts to block the Biden administration's plan to clinch a nuclear deal with Iran may not succeed. This is because the US at this stage is unlikely to invite fresh troubles in the Middle East as its hands are already full.

Mohammad Shtayyeh, Prime Minister of the Palestinian Authority, said the results "confirm that we have no partner in Israel for peace." He may sound too alarmist. The only encouraging possibility, as Israel watchers point out, is that Netanyahu may fall back on the coalition forged by the outgoing government of the caretaker Prime Minister Yair Lapid's Right and centre bloc which has made a respectable showing.


With the growth in the expense and complexity of experimental equipment in many fields (astronomical instruments and accelerators in particle physics are two examples) and increasing constraints on research budgets, the need for mechanisms that will help researchers to share such scarce and costly resources has become ever more pressing. The collaboratory concept has developed in the nineties as a method that may enable researchers to work together on projects even though they might be thousands of miles apart. Using information technology, they would be able to schedule and set up experiments, control instruments remotely, share data, and communicate with each other in a "laboratory without walls". The term seems to have been coined by Professor William Wulf of the University of Virginia in an unpublished paper in 1989 as a blend of collaboration and laboratory. The term has not appeared much in the UK, perhaps in part because the British pronunciation of laboratory on its second syllable makes the blend less felicitous.

Collyrium

Great men," wrote Ralph Waldo Emerson, "are a collyrium to clear our eyes from egotism, and enable us to see other people and their works." At the time, 150 years ago, his educated readers would have been familiar with the word in the sense of a medicated salve for the eves (and with its plural collyria), though it's now much less common. In fact, it's all Greek to most of us, which is only reasonable since it's originally Greek, from kollurion, a poultice, a word taken from kollura, a type of coarse bread roll. The Greek writer Lucian used it in the first century BC to explain how a trickster was able to remove seals from documents and replace them undetected afterwards. One method was to make a mould of the seal using "the substance called collyrium; this is a preparation of Bruttian pitch, bitumen, pounded glass, wax, and mastic". Not the sort of thing you'd want near your eyes. The shift in sense came about in part because the Romans and their successors gave the name to a variety of solid medicines that were made up into cakes held together by gum.

THE POLITICS OF INFLATION

ising inflation has put the United States on edge. While much of the focus so far has rightly been on the pain that price increases inflict on ordinary Americans, many are concerned about the longterm political effects. With polls suggesting that angry voters will likely hand Republicans control of one or both houses of Congress in the US midterm elections next week, today's inflationary surge may affect US politics long after price pressures ease.

But popular anger reflects a fundamental misunderstanding of the forces driving inflation in the US and beyond. For starters, while the level varies from country to country, today's inflation is a global phenomenon. Annual consumer-price inflation is at 8.2 per cent in the US, 10.1 per cent in the United Kingdom, 10.4 per cent in Germany, and 11.9 per cent in Italy. Among emerging and developing economies in Asia, yearon-year inflation is at 5.7 per cent in South Korea, 7.4 per cent in India, and 85.5 per cent (not a typo) in Turkey.

While the current outlook for the world economy is undoubtedly grim, we must not lose perspective. Today's inflationary pressures are nothing like the hyperinflationary episodes of the twentieth century. Interestingly, while developing countries in Latin America and Africa have experienced periods of extreme hyperinflation, the worst episodes on record are Hungary's 1946 bout, followed by Germany in 1923. Back then, inflation accelerated so rapidly that the price of restaurantgoers' lunch would often increase as they ate.

Then as now, soaring prices had profound political consequences. In fact, inflation affects politics more than any other economic indicator. As a recent report in The Economist shows, contrary to popular belief, there is

little correlation between economic slowdowns and political leaders' popularity (I believe the same is true of the unemployment rate). But, based on my experience as an economist and an adviser to the Indian government, I suspect that a rigorous statistical study would show that inflation disproportionately affects political leaders' reputations.

This is partly because people do not need data to experience inflation at gut level. The trade balance is just a figure they hear on the news, the latest jobless claims figures do not mean much to them if they have not lost their own jobs, and it takes so long for GDP data to reflect slowdowns that even this indicator may feel abstract. But you do not need to wait for government data or news reports to learn about inflation. The data are available to you every

time you go shopping. It is no wonder, then, that ris-

ing inflation is the issue that most concerns US voters. People are often well-informed about inflation and invariably expect the government to be fully in command of it. That makes inflation a key correlate of political (un)popularity. When I was advising the Indian government and annual inflation was hovering close to 10 per cent, I remember an elderly uncle phoning me as he was grocery shopping to ask earnestly, 'Why are you doing this? Prices have risen again.

But, contrary to the impression one gets from the confident pronouncements of experts, our understanding of inflationary surges is still rudimentary. We know enough to avoid the mistakes of 1946 and 1923, but beyond that, dramatic price movements

remain a confounding challenge for policymakers.

President Joe Biden's administration has been criticised for failing to see that the \$1.9 trillion American Rescue Plan might lead to price increases. It was obvious to virtually every economist that this enormous COVID-19 relief package would cause some inflation, but it is easy to see why US policymakers were wary of acknowledging the risk. High inflation can quickly turn into a self-fulfilling prophecy. A government official who says there will be inflation is almost guaranteed to drive up consumer prices just by saying so.

Many officials within the Biden administration surely could see that the rescue package would cause some inflation, even if they could not say so publicly. But they correctly determined that help ing lower-income families withstand the pandemic was worth the risk. And, lest we forget, the main driver of today's soaring prices, in the US and worldwide, is Russia's invasion of Ukraine, which severely disrupted global energy supplies.

Although pandemic-relief efforts in the US could have been improved with some minor tweaks policymakers got it right by risking a moderate increase in inflation to protect the most vulnerable Americans during the worst stage of the crisis. Ignoring this is short-sighted and morally wrong. But, as the Republicans may be about to prove, doing so can be a winning political strategy.

released by various agencies at various points of time. by and some others result in debates: at times uproarious! Every October the Global Hunger Index (GHI) is released. It's a tool that attempts to measure hunger globally; prepared by European NGOs -- Concern Worldwide and Welthungerhilfe. The organisations measure and rank countries on the hunger index at global, regional and national levels. They do not go beyond that. However, in a country like ours we have regional disparities in all developmental parameters and therefore the existence of hunger related disparities cannot be ruled out within the country. Besides, GHI disproportionately focuses on a particular segment of population - those less than five years old. Therefore, the stated objective of GHI to reduce hunger around the world is debatable. The use of the word hunger

sensationalises the whole issue. It takes us back to the famine era when millions of people died of starvation. There were great famines in India -- the great Bengal famine of 1770, the India famine of 1899. The most recent one was the Bengal famine of 1943 in which over four million people died. Famines in India have resulted in more than 30 million

There are many global indices deaths in the 18th, 19th and 20th centuries. Droughts combined with policy failures have pericould have been avoided and/or its impact reduced substantially had the then British government prioritised this catastrophe. Under the pretext of World War II, the responsibilities to save lives were simply ignored. Famines in India largely ended after the Bengal famine of 1943. Even as droughts have impacted lives of millions of people in different parts of country from time to time in post-Independence period the hardship was localised and the government of the day has always come out with policy measures to mitigate the misery of people in such eventualities. Of course there have been sporadic reports in some parts of the country of abject poverty, mass emigration, child selling out of despair, deprivation and despondency. We heard about one such incident about four decades ago in Kalahandi district of Odisha.

Children's nutrition: NFHS provides estimates of underweight, stunting and wasting. Child nutrition indicators show a slight improvement at all India level. Stunting (low height for age) has marginally declined from 38% to 36%, wasting (low weight for height) has declined from 21% to 19% and underweight from 36% to 32% at all India level. These conditions affect preschool children (those less than six years of age) disproportionately and compromise a child's physical and mental development. They also increase the vulnerability of children to infections. Besides, undernourished mothers give birth to deficient babies who are again susceptible to infections.

As per UNICEF findings, over a third of India's children are stunted. We are a country with limited resources. But we have one endowment in abundance our children. The overall development of a human being is laid in early childhood; health and education being the two most vital

provide comparative state level ingredients. If the foundation is not data, including the main pointers laid in early childhood any intervention later will not compensate Almost one dozen nutrition pro-

grammes have been under implementation during the last 50 years. Mostly these food distribution programmes benefit children. Expectant and lactating mothers are also included in these schemes. This must continue. At the same time newborns, infants and toddlers need special attention. We have successfully overcome many bigger health related issues such as smallpox, malaria and polio. We have also succeeded in reducing maternal and child mortality substantially.

We should lose no more time in debating over the GHI rankings. Instead, all our agencies should focus on the findings of NFHS to steer a new course to improve the nutrition practices of our children. The fact remains that they are the most vulnerable section of society - they don't belong to any trade union or pressure group. Nor they vote! We always say that children are the future of this country. We are morally bound to take care of their present.

Millions trapped

Sir, Brick kilns in India are operated in a largely unregulated manner and they remain outside the purview of workplace laws. Millions of brick kiln workers in the country are trapped in bonded labour and are regularly cheated out of their wages. They are toiling amid punishing heat and life-threatening pollution at tens of thousands of small-scale brick kilns. A human rights organisation says that millions of workers in India's brick kiln industry are trapped in a perpetual cycle of imposed debt and low wages, which forces them to bring their children to work alongside them in the hot and dusty kilns. The report adds that the living conditions at the kilns are dire, with the air filled with dust and other chemicals, and entire families live in cramped rooms. While bonded labour is illegal under Indian law, and even though the government has taken some steps to address the issue, it didn't go far enough and the law is not implemented by corrupt or under-resourced officials.

Sir, Stubble burning has become a contentious issue with Delhi turning into a gas chamber. Delhi Chief Minister Arvind Kejriwal and his Environment Minister Gopal Rai have taken the blame for the farm fires with a rider that the Centre is also responsible for the present situation. The Centre has accused the Punjab government of not utilising the funds for the purpose for which it was meant. The Air Quality Index (AQI) has fallen from "very poor" to "severe" category. This is a matter of grave concern. It may be recalled that the Delhi government had blamed the Punjab government when the AAP was not in power in that state. Farm fire episodes have gone up by 19% in Punjab over the last year, according to Indian Agricultural Research Institute. Persuasive diplomacy has failed in farm fire control $\,$ projects in Punjab both under the AAP and the Congress regimes. Punjab needs to learn from the experiences of neighbouring Haryana. Admittedly, putting out farm fires is a complex task. Meanwhile, the AAP government in Delhi has devised a slew of measures to keep the people away from the effects of air pollution. Primary schools in Delhi have been closed, while 50% of Delhi government officers have been advised to work from home.

BJP wins 4 of 7 seats but loses to KCR Lanka arrests 15 fishermen

New Delhi/Mumbai/Patna, Nov 6: The BJP won in four out of seven assembly constituencies in six states, retaining the three seats it held, in the by-election results declared Sunday, while the TRS and RJD won one each after a stiff contest with the saffron party.

Rutuja Latke, the candidate of the Shiv Sena (Uddhav Balasaheb Thackeray), won the by-election to Andheri (East) in Mumbai, the seat earlier represented by her deceased husband, after major parties including the BJP did not field candidates. The second-highest number of votes (14.79 per cent) went to the None Of The Above (NOTA) option in the constituency.

The BJP said the result of the November 3 by-election was a stamp of approval by people on Prime Minister Narendra Modi's policies as it retained Gola Gokarannath in Uttar Pradesh, Dhamnagar in Odisha and Gopalganj in Bihar where it had fielded the kin of its party MLAs whose death necessitated the polls.

BJP candidate and former chief minister Bhajan Lal's grandson Bhavya Bishnoi defeated his nearest rival and Congress nominee Jai Prakash in Haryana's Adampur by a margin of around 16,000 votes, maintaining the family's winning streak. Candidates of AAP and INLD lost their deposits as they failed to

secure one-sixth of the votes polled. The resignation of Bhavya's father Kuldeep Bishnoi necessitated the by-election after he left the Congress and joined the BJP.

The Adampur seat has been held by the Bhajan Lal's family since 1968, with the late leader representing it on nine occasions, his wife Jasma Devi once and Kuldeep on four occasions. Chennai, Nov 6: Sri Lankan Navy has arrested 15 Indian fishermen, including a minor, from Tamil Nadu on charges of fishing in their country's waters after crossing the International Maritime Boundary Line (IMBL).

The navy also confiscated two boats of the fishermen. The fishermen are from Rameswaram in Ramanathapuram district of Tamil Nadu. A 12-year-old boy was also among the fishermen arrested in the sea. According to Rameswram fishermen, around 2,500 people had gone fishing on Saturday evening and while they were fishing at Dhanushkodi near Talaimannar, the Sri Lankan Navy reached the spot and chased them away.

Fishermen association leaders said that 15 fishermen were surrounded by the Naval vessels and arrested. Two mechanized boats were also in the custody of the Sri Lankan Navy. The fishermen have been taken to the Talaimannar Naval camp and after questioning will be handed over to the Sri Lankan fisheries department.

Several fishermen from Tamil Nadu have been arrested by the Sri Lankan Navy on charges of crossing the IMBL and their mechanised fishing boats confiscated. The confiscation of costly mechanized fishing boats have brought serious financial woes to the fishermen.

Centre's panel revokes anti-pollution curbs

New Delhi, Nov 6: The Centre's air quality panel Sunday directed authorities to lift the ban on plying of non-BS VI diesel-run light motor vehicles in Delhi-NCR and entry of trucks into the capital imposed under the final stage of the Graded Response Action Plan.

The restrictions were imposed three days ago. "As the present AQI level of Delhi is around 339 which is about 111 AQI points below the threshold for invoking the GRAP Stage-IV actions (Delhi AQI > 450) and preventive/mitigative/ restrictive actions under all stages up to Stage-IV are underway, there is a likelihood of sustaining the improvement in AQI.

The forecast by IMD/ IITM also does not indicate any steep degradation further," an order from the Commission for Air Quality Management read, GRAP stage IV is a stage of disruptive restrictions that impacts a large number of stakeholders and the public at large. There are no stricter measures, than as laid in GRAP Stage-IV, that could be taken to improve upon the air quality scenario, the commission said.

The 24-hour average air quality index stood at 339 at 4 pm, dropping from 381 a day ago. It was 447 on Friday, according to the Central Pollution Control Board.

It had jumped to 450 on Thursday, just a notch short of the 'severe plus' category, prompting the authorities to invoke the final stage of anti-pollution curbs, including a ban on non-BSVI diesel light motor vehicles.

The CAQM had also directed the closure of all industries running on non-clean flues in the region, "even in areas which do not have PNG infrastructure and supply".



Navy plans to stop Chinese spy ship

Kolkata, Nov 6: The Indian Navy will not allow the Yuan Wang-6 to enter the country's Exclusive Economic Zone (EEZ) that extends up to 200 nautical miles into the sea.

Though it is known fact that the Yuan Wang-6 is a spy ship of the People's Liberation Army Navy (PLAN), sent to the Indian Ocean Region to track India's missile tests from the APJ Abdul Kalam Island off the Odisha coast, she is officially registered as a research and survey vessel. While foreign vessels, including warships, can freely sail through the EEZ, Indian law forbids any survey, research or exploration there by a foreign nation without permission.

In 2019, the Indian Navy had forced the Chinese research vessel Shi Yan 1 out of India's EEZ after it was found lurking near Port Blair. The Shi Yan 1 is also considered a PLAN spy ship masquerading as a research vessel. That move by the Indian Navy had led to a diplomatic row with China

but India had put her foot down. According to sources, the Indian Navy will do the same this time round if the Yuan Wang-6 attempts to enter India's EEZ.

The destination of this vessel is not marked to any port but to 'open sea' and that is where she will have to remain, a senior of-

Ranchi, Nov 6: Jharkhand, which is known for rich mineral deposits, has also earned a bad reputation as an increasing number of crimes. including murder, rape, mob lynching, etc, are being reported from

Around 2014, when the term of 'mob lynching' started to be used for such incidents, opposition parties had described Jharkhand as "lvnching-khand'

The statistics of the frequent incidents of mob violence in the state corroborate this. During the Assembly's Budget session this vear, the Jharkhand government in response to a question by CPI-ML MLA Vinod Singh, had said that between 2016 and 2021, there were 46 incidents of mob lynching in the state

In 2022, about a dozen incidents of mob violence have come to the dozens of people thrashed 45-year old Imran Ansari in Dhawaiya village under the Gomia block of Bokaro district. The villagers alleged that this man had illicit relations with a woman of another religion in the village.

The incident led to communal tension in the village and surrounding areas. To control the situation, more than 300 policemen were deployed and prohibitory orders had to be implemented. A

total of 11 people were arrested. On October 3, 22-year-old Ejaz Khan was beaten to death by a mob in the Dumartoli village in Gumla district located on the Jharkhand-Chhattisgarh border, over accusations of stealing a goat in

Chhattisgarh

On the night of September 25, a mob assaulted four people, inaccusing them of witchcraft, in Aswari village under Saraiyahat block of Dumka district. The mob also forced them to drink excreta and urine and branded them with

On the night of September 4, a mob of hundreds killed three women, calling them witches, in Ranadih village of Sonahatu police station area, 50 km from Ranchi. The son of one of the women was also among the mob. When the police reached the village the next day, they had to face opposition from the villagers during the search

In February this year, 17-year-old Rupesh Pandey was beaten to death

by a mob during the Saraswati Puja immersion procession in Barhi, Hazaribagh. The matter was also raised in Parliament.

In the first week of January, a mob thrashed tribal youth Saniu Pradhan on the charge of stealing wood and then later burnt him alive, in Besrajara Bazar under the Kolebira police station area of Simdega. More than a dozen people were arrested in this case.

In May, 45-year-old Shamim Ansari was thrashed to death by a mob in the Bharano police station area of Gumla district just because he had protested against cutting a

The Jharkhand government had also passed the Anti-Mob Lynching Bill in the assembly in December last year to curb the incidents of mob lynching, but in March this vear, the Governor returned the bill with some objections

In this Bill, life imprisonment and fines ranging from Rs 5 lakh to Rs 25 lakh have been proposed in case of death in mob lynching. The cost of treatment of the victim of lynching will be given from the number

The Bill defines attacks by two or more people as mob lynching. Governor Ramesh Bais had returned the Bill, objecting to this point, and seeking a redefinition of

State Parliamentary Affairs Minister, Alamgir Alam, said, "By removing the points to which the Raj Bhavan has objections, the government will pass this bill again in the next session and give it the form of law.'

He had told the House that the government is contemplating setting up a fast-track court for speedy disposal of mob lynching cases.

S Ali has filed a PIL in the Jharkhand High Court regarding the incidents of mob lynching in the state. According to the data he had collected on mob lynching in the state, from March 17, 2016, to March 13, 2021, 42 people were lynched, of which 23 died and 19 were seriously injured.

Advocate Yogendra Yadav savs that the trend of mob violence in the state is very dangerous, and reasons like superstitions, love affairs, caste and religious hatred, and enmity are the main reasons.

Along with taking steps like setting up a special cell for probes, and fast-track courts, it is necessary that a massive public awareness campaign should be launched to check this trend, he said.

HIGH DENSITY OF LEOPARDS AT KUNO MATTER OF CONCERN FOR CHEETAHS BUT BOTH CAN CO-EXIST, SAYS EXPERT

Bhopal, Nov 6: As eight Namibiaborn cheetahs complete more than 50 days in their new home Kuno National Park in Madhya Pradesh. a South Africa-based animal conservationist has expressed concern over the high density of leopards in the sanctuary, but said the two carnivores have a history of coexistence as well.

The cheetahs were flown from the African country and released in the Kuno National Park (KNP) in Sheopur district with much fanfare September 17 at a function by Prime Minister Narendra Modi as part of a project to revive their population in India, seven decades after they were declared extinct.

Since their arrival at KNP, the big cats have been kept inside quarantine enclosures, where they completed 51 days November 6.

According to animal conservationist Vincent van der Merwe, who manages the cheetah metapopulation in South Africa, the high density of leopards in KNP is a matter of concern for the

Experts in the past have expressed apprehension about a possible conflict between leopards and cheetahs in the national park.

"The high density of leopards is a matter of concern for cheetahs in KNP. But, two spotted animals have a history of co-existence in South Africa, Namibia and India since centuries," Merwe, who has been given the responsibility to get 12 cheetahs from his home country to India, said

In Africa, home to most of the cheetahs in the world, leopards are known to attack the fastest

Africa," the 40-year-old conservationist, who flew with the eight spotted cats from Namibia to KNP in September, told PTI over the phone from South Africa.

His statement has come at a time when presence of 70 to 80 leopards have been noticed in KNP's core and buffer area spread over 1,200 sq km.

"I form part of a combined Namibian and South African team providing founder animals for reintroduction and giving technical advice to India. As part of this team, I was invited to accompany the founder cheetahs," he said about his September visit to KNP.

Merwe, who oversaw 31 chee tah translocation projects in South Africa, said the adult fastest mammal on the earth avoids leopards and even chases them away.

"But cheetah cubs and sub-adults

do fall prey to leopards," he added. Speaking about the Metapopulation Initiative, the expert said it is a private group that coordinates cheetah relocations between the network of metapopulation reserves to prevent inbreeding, cheetah overpopulation or local extinction.

"It offers service to metapopulation reserves by identifying cheetahs for swapping or surplus cheetahs for relocations to reserves where their population needs to be augmented," said Merwe, who is managing population of the spotted cats in South Africa for the last

A metapopulation programme works by nurturing several populations of the big cat in mostly private game reserves, and swapping cheetahs between these sites to

Elton, Freddie now in larger enclosure

wo out of the eight Cheetahs that were brought from Namibia have been released into a larger enclosure, the officials department said. The big cats were released Saturday. Both are male and are named as 'Elton' and 'Freddie'. Notably, since their arrival at Kuno National Park, all have been kept inside quarantine enclosures, where they completed 51 days November 5. Officials monitoring the daily movement and the health condition of the Namibian

cheetahs at their new habitat at Kuno, said that one more big cat will be released into a larger enclosure by Sunday evening. Prime pressed his happiness over the release of the two cheetahs. Great news! Am told that after the mandatory quarantine, 2 cheetahs have been released to a bigger enclosure for further adaptation to the Kuno habitat. Others will be released soon. I'm also glad to know that all cheetahs are healthy, active and adjusting well, Modi posted on Twitter along with a video.

The wildlife expert said he is hoping to obtain permission from the South African government to return to India with an additional 12 cheetahs for KNP.

"A large founder population will be required to establish cheetahs at Kuno," added Merwe.

The Indian government has urged its South African counterpart to make cheetahs available for its reintroduction efforts, he said.

"As manager of the Cheetah Metapopulation in South Africa, I am in a position to source suitable cheetahs from South Africa. The decision to send cheetahs to India for reintroduction lies with the South Africa government," Merwe said. He said the eight cheetahs at KNP were in good health

KNP Director Uttam Sharma has admitted there were 70 to 80 leopards in the park. An adult cheetah weighs 40 to 50 kg and a leopard between 50 and 60 kg.

According to Sharma, who also keeps a watch on the Namibian cheetahs at KNP, the large animal can eat as much as 6 to 8 kg meat at one sitting if not chased away.

A cheetah does not return to eat its leftover kill like a leopard or tiger. Suppose a cheetah kills a chital (deer) weighing around 30 kg, it will automatically leave behind around 22 kg meat of the kill for leopards and hyenas, the KNP director explained.

Asked how many days a cheetah eats, Sharma said the world's fastest animal cannot keep its kills safe Bigger carnivores like leopard and also hyena can snatch kills from cheetahs. "Even a pack of jackals is believed to be able to snatch a prey from cheetahs," he said.

A tiger hides its prey in a bush for another day to eat, but this is not the case with a cheetah as its kill gets snatched, the forest officer added. A full-grown tiger weighing 200 kg eats 18 to 20 kg of its kill at the first go, Sharma said. In other words, tigers scavenge, while cheetahs are fresh meat eaters, he said.

The eight cheetahs at KNP five females and three males - are in the 30-66 month age group and named Freddy, Alton, Savannah, Sasha, Obaan, Asha, Cibili

Elated RTI activist comes with bullock cart to get 9,000-page info

Shivpuri (MP), Nov 6: For Right to Information (RTI) activist Makhan Dhakad it was an occasion that he had to celebrate as he was finally getting 9,000 pages of information, which he had sought, after a two-month-long struggle and payment of Rs 25,000. So elated was he that he reached the local civic body office on a bullock cart amid the beating of drums to collect the documents.

Dhakad, who resides in Bairad town of Shivpuri district in Madhya Pradesh, created a buzz among locals when he reached the municipality office with a band Friday afternoon to collect the loads of papers containing information about the Pradhan Mantri Awas Yojana (PMAY) that he had sought under the RTI. A video of his act surfaced on social media.

Talking to reporters, Dhakad said he had filed an application seeking information about the PMAY about two months back, but the Bairad civic body denied the in-



The activist said that he was asked to pay Rs 25,000 by the civic body, but despite the payment, the information was not provided to him. He then appealed to the higher appellate authority of the Urban Administration Department in Gwalior, which ordered the civic body to provide the information

The RTI activist claimed that he had arranged funds by taking loan from his acquaintances.

"So when I was told that the information I had sought under RTI was ready. I decided to celebrate the occasion by hiring a band and going on the bullock-cart to carry 9,000 pages of information," he said. He said it took him and his four friends two hours to count the

When asked, Chief Municipal Officer of Bairad Nagar Parishad, JN Para, told PTI that the civic body provided information to Dhakad only after he deposited the fee. Four employees were assigned the work and it took five days to arrange the photocopies of all the documents asked by the activist, he said.

Trikut hill in Deoghar is a famous religious tourist centre. On April 10, at around 6 pm, three people were killed and more than one and a half dozen injured when one of the ropeway wires broke.

A total of 78 people on 23 out of 24 trolleys of the ropeway were trapped mid-air. Of these, 28 people were rescued on the same day, while 48 people were left hanging without any food or water for the next 36 to 45 hours

After 45 hours of high-risk rescue operations by the Indian Air Force, the National Disaster Response Force, the Indo Tibetan Border Police and Army, 46 of trapped people were saved, while two died during the rescue operation. One victim died even before the trolley fell.

It was revealed that the private company running the ropeway did not maintain it as per norms nor in the safety audit conducted three weeks before the accident by a gov-The agency identified 24 defects

in the 1,770m ropeway, which were ignored by the company. The Jharkhand government issued a notification for the formation of an inquiry committee

headed by state Finance Secretary,

Ajoy Kumar Singh April 19. The committee was instructed to the complete the investigation within 60 days but it only reached the accident spot 70 days after the

accident to start its work. The committee was unsuccessful in completing its report due to the delay in receiving the report of the shaft that caused the accident, from the metallurgical lab, said

sources.

However, it is to be noted that the state Tourism Department received this report almost a month ago but it still has not reached the inquiry committee. In wake of the tragedy in Guiarat's Morbi, the probe panel wrote to the Tourism Department, demanding the lab report, and will submit its report soon, said sources.

Meanwhile, the Haradih-Budhadih bridge, built on Kanchi river near Ranchi at an outlay of Rs 13 crore, was washed away even before its inauguration, due to heavy rains triggered by cyclone Yaas May 27, 2021.

Chief Minister Hemant Soren then announced the formation of a high-level committee to investigate it and warned that corruption would not be tolerated.

In Jharkhand, more than three dozen bridges have collapsed in the last decade due to substandard construction, but no action against the culprits, except of suspension for a few months, has been seen in any of these cases

EC seeks cut in expenditure limit

New Delhi, Nov 6: The Election Commission has proposed reducing the amount a candidate contesting polls can pay in cash for campaign-related expenditure from the existing Rs 10,000 to Rs 2,000 to make their transactions more trans

parent, sources said. In the proposal submitted to the government recently, the poll panel recommended that the Conduct of Election Rules should be amended to ensure that all cash payments in excess of Rs 2,000 made to a person or entity for election-related expenses are made either through account payee cheques or online and digital means.

This, the sources said, is part of efforts to bring greater transparency in the expenditure by individual candidates contesting polls and to remove "fungibility". As of now, the

candidates have to ensure that all payments in excess of Rs 10,000 are made by cheque, draft or bank transfer through a bank account opened exclusively for the purpose of election expenditure.

According to the EC's instructions, candidates have to open a separate bank account exclusively for election expenditure purposes.

at least one day before filing of nomination. Candidates also have to maintain day-to-day accounts, cash book and bank book from the date of filing of nomination to the date of declaration of results (both dates inclusive).

They have to include all expenses incurred on the date of filing of nomination as well. A candidate has to submit the election expenditure account to the District Election Officer (DEO) within 30 days of

the declaration of the poll results. While announcing the schedule for Gujarat polls, the EC had said that for the purpose of maintaining purity of elections, it has issued a Standard Operating Procedure for flying squads and static surveillance teams constituted for checking excessive campaign expenses and distribution of items of bribe in cash or in kind in the constituencies during the election process.

The ruling BJP may have realised that simultaneous polls may not enhance its own electoral prospects. But the EC has done something unthinkable

when it announced Assembly polls in Himachal Pradesh to be held on November 12 and did not declare poll dates for Gujarat. The EC, in the past, has been declaring poll dates simultaneously in these two states and the Model Code of Conduct (MCC) came into effect the same day. The EC has the power to club election dates if two or more states go to polls within a span of six months. In the case of Himachal and Gujarat, the difference was less than a month and the EC was expected to follow precedents and norms. The BJP is reaping the harvest as no MCC is in force in Gujarat and plenty of freebies, schemes, projects and other steps are being announced on a daily basis.

Who will be LoP in RS?

China posts 6-month high Covid-19 count

Beijing: China Sunday reported its highest number of new Covid-19 infections in six months, a day after health officials said they were sticking with strict coronavirus curbs, likely disappointing recent investor hopes for an easing. China recorded 4,420 new locally transmitted Covid-19 infections Saturday, the National Health Commission said, the most since May 6 and compared up from 3,659 new local cases a day earlier.

Nine killed in Syria shelling

Idlib: Syrian government forces shelled tent settlements housing families displaced by the country's conflict in the rebel-held northwest early Sunday, killing at least nine people and wounding dozens, opposition war monitors and first responders said. The shelling was the latest violation of a truce reached between Russia and Turkey in March 2020 that ended a Russian-backed government offensive on Idlib province.

COP27 puts climate costs on agenda

Sharm el-Sheikh (Egypt), Nov 6: Delegates at the the UN's COP27 climate summit in Egypt agreed to discuss whether rich nations should compensate poor countries most vulnerable to climate change for their suffering.

"This creates for the first time an institutionally stable space on the formal agenda of COP and the Paris Agreement to discuss the pressing issue of funding arrangements needed to deal with existing gaps, responding to loss and damage," COP27 president Sameh Shoukry told the opening plenary.

The item was adopted to the agenda in Sharm el-Sheikh, Egypt, Sunday, as world leaders arrived for the negotiations scheduled to run through November 18.

The loss and damage discussions now on the agenda at COP27 will not involve liability or binding compensation, but they are intended to lead to a conclusive decision "no later than 2024, Shoukry said. "The inclusion of this agenda reflects a sense of solidarity for the victims of climate disasters," he added.

Negotiators spent a frantic two days ahead of the meeting discussing whether to formally consider the issue of loss and damage, or reparations, to vulnerable nations suffering from climate change. The issue, which has weighed on the talks for years, was agreed just hours before the meeting officially opened. In an opening speech, the head of the UN's panel of climate scientist highlighted the urgency of cutting greenhouse gas emissions and adapting to the effects

of global warming. The outgoing chair of the talks, British official Alok Sharma, said countries had made considerable progress at their last meeting in Glasgow, including on setting more ambitious targets for cutting emissions, finalising the rules of the 2015 Paris agreement and pledging to begin phasing out the use of coal — the most heavily polluting fossil fuel.

We kept 1.5 degrees (2.7 Fahrenheit) alive," he said, referring to the most ambitious goal of the Paris pact, to keep temperature increase since pre-industrial times under that threshold.

Yet now those efforts were being "buffeted by global headwinds," he warned. "(Russian President Vladimir) Putin's brutal and ille-

gal war in Ukraine has precipitated multiple global crisis, energy and food insecurity, inflationary pressures and spiralling debt," said Sharma.

"These crises have compounded existing climate vulnerabilities and the scarring effects of the pandemic." However even the most optimistic scenarios assuming countries do everything they have pledged put the world on course for 1.7 C of warming (3.1 F), he warned.

"As challenging as our current moment is, inaction is myopic and can only defer climate catastrophe," said Sharma. "We must find the ability to focus on more than one thing at once." The UN's top climate official also appealed to countries both to engage constructively in the negotiations and take the necessary action back home.

WORLD IS BURNING

Earth's warming weather and rising seas are getting worse and doing so faster than before, the World Meteorological Organisation warned Sunday in a somber note as world leaders started gathering for international climate negotiations. "The latest State of the Global Climate report is a chronicle of climate chaos," United Nations Secretary-General Antonio Guterres said. "We must answer the planet's distress signal with action -- ambitious, credible climate action.' In its annual state of the climate report, the United Nations' weather agency said that sea level rise in the past decade was double what it was in the 1990s and since January 2020 has jumped at a higher rate than that. Since the decade began, seas are rising at 5 millimeters a year (.2 inches) compared to 2.1 millimeters (.08 inches) in the 1990s. The last eight years have been the warmest on record, the WMO said in a report

'US urges Ukraine to be open to Russia talks'

Washington/Kyiv, Nov 6: The United States is privately encouraging Ukraine to signal an openness to negotiate with Russia, the Washington Post reported, as the State Department said Moscow was escalating the war and did not seriously wish to engage in peace talks.

The newspaper cited unnamed sources as saving the request by American officials was not aimed at pushing Ukraine to the negotiating table, but a calculated attempt to ensure Kyiv maintains the support of other nations.

US and Ukrainian officials acknowledged that Ukrainian President Volodymyr Zelenskiy's ban on talks with Russian President Vladimir Putin had generated concern in parts of Europe. Africa and Latin America, where the war's effects on costs of food and fuel are felt most sharply, the Post said.

Zelenskyy signed a decree October 4 formally declaring the prospect of any Ukrainian talks with Putin "impossible" but leaving the door open to talks with Russia

"Ukraine fatigue is a real thing for some of our partners," it quoted an unnamed US official as saving.

The White House National Security Council had no immediate comment on the accuracy of the report. A State Department spokesperson responded: "We've said it before and will say it again: Actions speak louder than words. If Russia is ready for negotiation, it should stop its bombs and missiles and withdraw its forces from Ukraine.'

Meanwhile, Russian forces are stepping up their strikes in a fiercely contested region of eastern Ukraine, worsening the already tough conditions for residents and the defending army following Moscow's illegal annexation and declaration of martial law in Donetsk province, Ukrainian authorities said.

China plans monkey reproduction experiment in space

hina is planning to send monkeys to its new Tiangong Space Station to study how they grow and reproduce in a zerogravity environment.

A report from the South China Morning Post, cited scientist Zhang Lu, who leads scientific instruments for the space station, reported that the research would be carried out in the space station's largest module, which would be used for life science experiments.

As per the report, the experiment will be carried out in Wentian, the largest module of the space station.

The researchers suspected that long-term exposure to cosmic rays, which are hundreds of times stronger in orbit than on Earth, could hurt the quality of sperm and eggs.



Despite being raised in cages, laboratory monkeys may exhibit negative responses such as de-

creased activity, hair pulling, or refusal to eat, according to the re-

searcher, who asked to remain

anonymous. The monkeys can become frightened during the rocket trip to the space station.

The scientist further explained that on the ground, a monkey in panic mode might be soothed with toys, music, or even by simply being allowed to interact with other monkeys

The astronauts will face a new task in figuring out how to take care of the monkeys and keep them content and comfortable in space.

The Wentian module has two biological test cabinets which currently have only enough room for algae, fish or snails, but they are expandable and reconfigurable.

The challenges of a life sciences experiment in space increased exponentially with the size of the animals used, said Kehkooi Kee, a professor with the school of medicine at Tsinghua University who led an in-orbit stem cell experiment conducted by Chinese astronauts.

However, larger animals, especially the monkeys, shared more similarities with humans.

According to Kee, the astronauts will need to feed them and deal with the waste. Meanwhile, experts pointed out that there are still many difficulties involved in conducting such studies on complex living forms such as rats and primates. Soviet researchers in the Cold War era managed to get some rats to overcome physical challenges and engage in mating during 18 days of space flight. But there were no signs of pregnancy and none of them gave birth after returning to Earth.

Arizona poll workers face midterm threats

Arizona, Nov 6: Election workers in Arizona's most fiercely contested county faced more than 100 violent threats and intimidating communications in the run-up to Tuesday's midterms, most of them based on election conspiracy theories promoted by former President

Donald Trump and his allies. The harassment in Maricopa County included menacing emails and social media posts, threats to circulate personal information online and photographing employees arriving at work, according to nearly 1,600 pages of documents obtained by Between July 11 and August 22, the county election office documented at least 140 threats

and other hostile communications, the records show. "You will all be executed," said one. "Wire around their limbs and tied & dragged by a car," wrote another. The documents reveal the consequences of election conspiracy theories as voters nominated candidates in August. Many of the threats in Maricopa County, which helped propel President Joe Biden to victory over Trump in 2020, cited debunked claims around fake ballots, rigged voting machines and corrupt election officials.

In Maricopa, a county of 4.5 million people that includes Phoenix, the harassment unnerved some election workers, according to previously unreported incidents documented in the emails and interviews with county officials.

Mcap of seven of top-10 firms rises

New Delhi: Seven of the top-10 most valued firms together added ₹1.33.707.42 crore in market valuation last week amid an overall positive trend in equities, with Reliance Industries emerging as the biggest winner. Last week, the BSE benchmark jumped 990.51 points or 1.65 per cent. Reliance Industries, Tata Consultancy Services (TCS), HDFC Bank, Infosys, State Bank of India, HDFC and ITC were among the gainers, while ICICI Bank, Hindustan Unilever Limited and Bharti Airtel faced erosion from their market valuation. The market capitalisation (mcap) of Reliance Industries iumped ₹44,956.5 crore to ₹17,53,888.92 crore. Reliance Industries remained the most valued domestic firm, followed by TCS, HDFC Bank, Infosys, ICICI Bank, Hindustan Unilever State Bank of India, Bharti Airtel, HDFC and ITC.

Coal despatch to power sector dips

New Delhi: The despatch of coal to the power sector registered 5.5 per cent decline at 56.49 million tonne last month. The coal supply to the power sector was at 59.79 million tonne (MT) in October 2021. "The power utilities dispatch has reduced by 5.51 per cent to 56.49 MT during October 2022 as compared to 59.79 MT in October 2021," provisional statistics of the coal ministry showed. However, in April-October period of ongoing financial year, the dispatch increased 13.07 per cent to 413 MT from 365.25 MT in the year-ago period. The overall despatch of the dry fuel to different sectors in October also dropped to 67.02 MT from 70.21 MT in the year-ago period. The supply to captive power plants also fell to 3.54 MT from 4.97 MT.

■ RIL to buy METRO Cash & Carry India

New Delhi: Reliance Industries is set to acquire German retailer METRO AG's Cash & Carry business in India in a deal estimated at around 500 million euros (Rs 4,060 crore), industry sources said. The deal includes 31 wholesale distribution centres, land banks and other assets owned by METRO Cash & Carry here, they said. This is going to help Reliance Retail, the country's largest retailer, expand its presence in the B2B segment. Discussion between billionaire Mukesh Ambani-led Reliance Industries and METRO was going on for the past few months and last week the German parent firm agreed to the offer from Reliance Retail, they added. METRO Cash & Carry's customers include retailers and kirana stores, hotels, restaurants and caterers (HoReCa), corporates, SMEs, companies and institutions.

New Delhi, Nov 6: It is the country's largest airline and has been ruling the Indian skies for long. But as the aviation sector slowly claws back to normalcy after two years of pandemic-induced carnage, IndiGo is facing heat from competition which has been compounded by staff woes, changes in top management and a fleet diversification.

Just as it managed to put behind a public feud among its promoters, IndiGo is now grap pling with employees leaving for better offers, slippages on its On-Time Performance (OTP) and a handful of technical snags denting its image. according to analysts.

IndiGo had a domestic market share of 57.7 per cent in September, more than 1,600 daily flights and 279 planes but of late, the OTP has slipped to 84.1 per cent in September from 90.1 per cent in April this year. In February 2020, before the pandemic, the airline had a market share of 48 per cent.

Just as the Indian skies opened up and air traffic began to rise, IndiGo saw a change in CEO with Ronojoy Dutta stepping down ahead of his tenure which was to end in January 2024. Now, Pieter Elbers is at the helm as CEO.

While there has been no official word on attrition at the budget carrier, people in the know said many employees are quitting, especially

ndiGo started its journey in August 2006 and during this more than 16 years-journey, quite a few airlines have also gone out of business, including Jet Airways and Kingfisher Airlines

With Air India set to consolidate its low-cost airlines -- Air India Express and AirAsia India -- into one entity, and Akasa Air also flying, the skies are getting more competitive for IndiGo

with opportunities coming up as the global aviation space recovers after the pandemic. IndiGo had 26,164 permanent

employees, which included 3,791 pilots and 6,398 cabin crew, at the end of March 2022. In July, dissatisfaction among certain sections of the airline's employees came to the fore as a large number of staff called in sick, resulting in massive flight delays. During the pandemic, the airline had slashed salaries of pilots by up to 30 per cent.

The airline's loss in the September quarter widened to ₹1,583.34 crore on higher fuel costs and forex losses.

In the last three-four years, IndiGo was having prime slots and there was little competition. Also, the industry as a whole is facing issues with respect to OTP as more aircraft are flying and air traffic has increased.

FPIs invest ₹15,280cr in equities

New Delhi, Nov 6: After withdrawing funds in the last two months, foreign investors came back strongly in the first week of November and infused ₹15,280 crore in Indian equities on hopes that US Federal Reserve would go soft on rate hikes.

Going forward, Foreign Portfolio Investors (FPIs) flows are expected to remain volatile in the near term given the headwinds in terms of monetary tightening, geo-political concerns among others, Shrikant Chouhan, Head of Equity Research (Retail), Kotak Securities, said.

According to the data with depositories, FPIs invested ₹15,280 crore in equities during November 1-4. This came following a net outflow of just ₹8 crore last month and ₹7,624 crore in September.

Prior to these outflows, FPIs were net buyers in August to the tune of ₹51,200 crore and nearly ₹5.000 crore in July Before that. foreign investors were net sellers in Indian equities for nine months in a row which started in October last year. So far this year, the total outflow by FPIs in equities has

Mumbai, Nov 6: Twitter Saturday updated its app in Apple's App Store to begin charging \$8 for soughtafter blue check verification marks, in Elon Musk's first major revision of the social media platform.

Before Musk took over, blue check marks next to a person's user name meant Twitter confirmed the account belonged to the person or company claiming it. It was not immediately clear how or if Twitter planned to verify the identity of

the user beyond charging a fee. According to the iOS notification, other benefits in the update include "half the ads", the ability to post longer videos to Twitter and pri-

ority ranking for quality content. Twitter's new boss flagged the updates earlier this week in his push



work and make it less reliant on ads. Twitter is currently free for most users. Twitter's update said the new service with verification will be available in the United States, Canada, Australia, New Zealand and the United Kingdom.

"As soon as we confirm it's working well in the initial set of countries and we have the translation work done, it will roll out worldwide," Musk said in a tweet Saturday. In a separate tweet, Musk also

added that "fixing search is a top priority" on Twitter. 'We can beat that," he replied in

another tweet when a user pointed out that YouTube gives creators 55% of ad revenue. "Twitter will soon add ability to

attach long-form text to tweets, ending absurdity of notepad screenshots. Followed by creator monetization for all forms of content," Musk added in a tweet.

acing trolls on social media, former Twitter CEO Jack Dorsey Saturday apologised to sacked Twitter employees, saying that he grew the micro-blogging platform too quickly. "Folks at Twitter past and present are strong and resilient. They will always find a way no matter how difficult the moment. I realize many are angry with me. Russia becomes country's top oil supplier in Oct

New Delhi, Nov 6: Russia has become India's top oil supplier in October, surpassing traditional sellers Saudi Arabia and Iraq. according to data from energy cargo tracker Vortexa.

Russia, which made up for just 0.2 per cent of all oil imported by India in the year to March 31, 2022, supplied 935,556 barrels per day (bpd) of crude oil to India in October -- the highest ever. It now makes up for 22 per cent of India's total crude imports, ahead of Iraq's 20.5 per cent and Saudi Arabia's 16 per cent.

Russian oil in March while it increased to 266,617 bpd in the following month and peaked to 942,694 bpd in June. But in June, Iraq was India's top supplier with 1.04 million bpd of oil. Russia in that month became Imports dipped marginally in

October, according to Vortexa. Iraq slipped to No 2 slot with

oil from where it is cheapest.



In a statement, Sri Lanka Cricket said it will take strict action against the player if found guilty."In consultation with the (International Cricket Council), (we) will expeditiously initiate a thorough inquiry into the matter and take stern action against the player if found guilty," the statement said.

Thapa punches to unique feat

New Delhi, Nov 6: India's Shiva Thapa became Sunday the firstever male boxer in the history of Asian Championships to win six medals after he out-punched Minsu Choi of South Korea to progress to the semifinals in Amman, Jordan. The seasoned Thapa (63.5kg) prevailed 4-1 over Choi in the light welterweight quarterfinal to secure his sixth consecutive medal. The 28-vear-old dominated from the start to the end, using his jabs to great effect.

With the win, Thapa is assured of at least a bronze medal in the ongoing edition, bettering his own position as the most suc-



cessful Indian boxer in the tournament. Thapa's haul includes a gold (2013), two silver medals (2017 and 2021) and as many

bronze medals (2015 and 2019). Thapa overtook Kazakh legend Vassiliy Levit, an Olympic silver medallist and two-time world

bronze medal winner, who was the only other male pugilist with five Asian Championships medals.

Two-time Commonwealth Games (CWG) bronze medallist Mohammad Hussamuddin (57kg) and Govind Kumar Sahani (48kg) also progressed to the semifinals as India's medal count continued to swell.

Up against South Korea's Haengseok Lee in the quarterfinal bout, Hussamuddin fell behind early with his rival landing clean punches in the opening round. With the prospects of an upset looming, Hussamuddin utilised his experience to make a comeback. He went all out in the next two rounds to dominate his way

to a 5-0 win and guarantee yet another medal for India.

Hussamuddin will face the 2021 World Championships silver medallist Serik Temirzha in his semifinals bout November 10.

In the other quarterfinal, Thailand Open gold medallist Ananta Chopade (54kg) bowed out of the competition after suffering a 0-4 loss to Seidekmatov Sanzhai of Kyrgyzstan.

Earlier late Saturday night, Anikushita Boro (56kg) and Lovlina Borgohain (75 kg) prevailed over Tsubata Arsia of Japan and Valentina Khalzova of Kazakhstan, respectively, to progress to the semifinals, thereby assuring India of two medals.
