## **Justice Chandrachud to** take over as CJI today

New Delhi, Nov 8: Senior-most Supreme Court judge and CJI-designate Dhananjaya Y Chandrachud is all set to become the 50th head of the Indian judiciary Wednesday when President Draupadi Murmu would administer the oath of office to him at Rashtrapati Bhawan here.

His illustrious father YV Chandrachud was the longest-serving Chief Justice of India (CJI) and remained at the helm from February 22, 1978 to July 11, 1985.

Justice Chandrachud will serve as the CJI for two years till November 10, 2024. Supreme Court judges retire at the age of 65. He succeeds Uday Umesh Lalit,

who had recommended him as his successor to the Centre October 11. President Draupadi Murmu had appointed him as the next CJI October 17.

Justice Chandrachud, born November 11, 1959, was elevated to the top court May 13, 2016.

He has been part of several Constitution benches and landmark verdicts of the top court including on matters relating to the Ayodhya land dispute, the right to privacy and adultery.

Justice Chandrachud was also part of the benches which delivered path-breaking judgements on decriminalising same-sex relations after it partially struck down Section 377 of the IPC, the validity of the Aadhaar scheme and the Sabarimala issue.

Recently, a bench headed by him expanded the scope of the Medical Termination of Pregnancy (MTP) Act and the corresponding rules to include unmarried women for abortion between 20-24 weeks of pregnancy. The Justice Chandrachudled bench had also passed several directions to assuage the miseries faced by people during the Covid-19 crisis, terming the brutal second wave of the pandemic last year as a 'national crisis'.

# **Ritualists-rationalists clash**

Bhubaneswar/Berhampur, Nov 8: Two groups, claiming themselves as traditionalists and rationalists, clashed in Bhubaneswar and in Berhampur town Tuesday over consumption of food on lunar eclipse day which prompted the police to intervene and control the situation.

A clash took place at Lohia Academy building under Kharavela Nagar police limits in Bhubaneswar where a group of people identifying themselves as rationalists organised a community feast and was opposed by a number of people claiming to be traditionalists.

The second group, most of them youths, forcibly entered the Lohia Academy premises when the community feast was going on and attacked the rationalists, police said.

Police intervened when the situation turned volatile and even people who were eating biryani served at the community feast were thrashed. As the condition escalated, the police picked up about 12 members of both groups as a preventive measure.

In Berhampur, a group claiming to be traditionalists allegedly threw cow dung at a temporary camp where non-vegetarian food was served at a community feast. They also tore down posters which said there is no harm in consuming food on and during lunar or solar eclipse.

This led to the police resorting to lathi charge in order to disperse

# NGT slaps ₹12cr fine on Srimandir admin

Bhubaneswar, Nov 8: The National Green Tribunal (NGT) has slapped a fine of ₹12 crore on Shree Jagannath Temple Administration (SJTA) over damage caused to the environment due to illegal quarrying of laterite stone on land belonging to Lord Jagannath in Khurda, an official said Tuesday.

The SJTA has been asked to deposit the fine amount with the Khurda Collector: The money would be used for restitution, reclamation and renovation of excavated sites in the district.

While asking the Khurda Collector to complete the restoration work within four months, the environment watchdog asked the Khurda administration to submit an Action-Taken Report in this regard by March 31, 2023.

The NGT move came while hearing pleas filed by Bidu Bhusan Harichandan and Dilip Kumar Samantaray, represented by lawyer Sankar Prasad Pani, in 2018.

Pani had informed the tribunal that laterite stone mining was rampant at 40 different sites measuring an area of around 500 acre covering several villages in Khurda. He alleged that the persons involved in stone mining have neither obtained the necessary environmental clearance nor consent to

operate from the State Pollution Control Board (SPCB) and other authorities. They have cut down many trees in the area of mining, the

# NO NEW ₹2K NOTES PRINTED SINCE 2019 The Reserve Bank of India had

New Delhi, Nov 8: An RTI reply has disclosed that no new ₹2,000 denomination currency notes were printed during 2019-20, 2020-21 and 2021-22.

The RTI application filed by IANS disclosed that the Bharativa Reserve Bank Note Mudran (P) Ltd printed 3,542.991 million pieces of Rs 2,000 notes in the financial year 2016-17, which drastically came down to 111.507 million notes in 2017-18 and was further reduced

to 46.690 million notes in 2018-19. The RTI reply received from the Bharatiya Reserve Bank Note Mudran (P) Ltd revealed said that '0' number of Rs 2,000 denomination currency note was printed in 2019-20, 2020-21 and 2021-22.

introduced the Rs 2.000 note after the government announced the demonetisation move that banned old Rs 500 and Rs 1,000 currency notes on November 8, 2016. A recent reply in the Parliament

(August 1) said that the number of fake currency notes of Rs 2,000 denomination seized in the country as per NCRB data increased substantially between 2016 and 2020, from 2,272 to 2,44,834 pieces.

As per the data, the total number of fake Rs 2,000 notes seized in the country in 2016 was 2,272, which increased to 74,898 in 2017 before reducing to 54,776 in 2018. The figures in 2019 stood at 90,566 pieces, before registering a remarkable spike in 2020 to 2,44,834 pieces.

Washington, Nov 8: Non-stick pans and pots could be releasing millions of ultrasmall Teflon plastic particles during cooking as they gradually lose their coating, researchers have said.

According to a study published in the journal 'Science of the Total Environment', a single crack on the surface of a Teflon-coated pan can release around 9,100 plastic particles.

Researchers including those from Flinders University in Australia have assessed how millions of tiny plastic particles potentially come off during cooking and washing of non-stick pans and pots. The researchers have highlighted the release of 2.3 million microplastics and nanoplastics from

broken coating, indicating an increased risk of exposure to these chemicals during cooking.

Microplastics are pieces of plastic that measure below five millimetres and nanoplastics measure less than 1 micrometre. Teflon is the brand name of the

chemical Polytetrafluoroethylene a synthetic polymer containing just carbon and fluorine that is one of the most well-known and widely used 'forever chemicals.'

The name 'forever chemicals' comes from the fact that they are not broken down easily in the environment and remain a persistent issue for generations, it was learnt.

According to Cheng Fang, a coauthor of the study from the University of Newcastle in Australia, the non-stick coating material Teflon is generally a fam-



ily member of PFAS.

PFAS are chemicals that are commonly found in non-stick cookware, firefighting foams and commercial products that resist grease

Several researches have linked the use of these chemicals to several health disorders, including reduced immunity, hormone disruption and increased risks of different types of cancer.

"Given the fact PFAS is a big concern, these Teflon microparticles in our food might be a health concern, [which] needs investigating because we don't know much about these emerging contaminants," Fang said.

"We estimate that thousands to millions of Teflon microplastics and nanoplastics might be released during a mimic cooking process,' scientists wrote in the study.

Youhong Tang, another author of the study from Flinders University, said, "It gives us a strong warning that we must be careful about selecting and using cooking utensils to avoid food contamination." Researchers are of the opinion that further studies are needed to assess the risk of Teflon microplastics and nanoplastics during cooking since Teflon is a family mem-

ber of PFAS.



bers had not lodged a police complaint till the last report came in. Earlier, a girl pursuing bachelors' degree in computer applications hanged herself from the ceiling of her room in Infocity police limits Monday evening. The victim was identified as Poonam Sahani of Sikharchandi area.

Poonam's family members told the police that she was under severe mental pressure over poor performance in the semester examinations. Monday evening, she told her mother about feeling uneasy and went into her room asking the family members not to disturb her. When the victim's elder sister went to call her for dinner after a few hours, she found her hanging from the ceiling with her stole. Police are investigating the incident after registering a case (79/22) in this regard.

Two other persons including a youth also committed suicide in Saheed Nagar police station area here Monday. A 40-year-old man committed suicide by hanging himself from the ceiling fan with a towel in his rental accommodation at Basuaghai area under the police limits while 25-year-old Anurag Das hanged himself from the ceiling fan in his room at an apartment in Bomikhal area late Sunday night. He also cut his wrist before hanging himself.

Notably, an engineering student Ratikanta Das, 20, of Khurda had ended his life by consuming poison in front of his hostel room on the outskirts of the City, Sunday.

"It is quite unfortunate that Bhubaneswar is witnessing a rise in suicide cases. The police are not holding regular counselling sessions to educate vouths about handing mental instability and depression," said Abhinna Chandra Nayak, an intellectual in the City.

# Beer may help you to counter Alzheimer's

ertain compounds found in beer hops, the source of bitterness, aroma, and flavour in beer, can even help protect against Alzheimer's disease (AD), researchers have revealed

Research published in the journal ACS Chemical Neuroscience reports that chemicals extracted from hop flowers can, in lab dishes, inhibit the clumping of amyloid beta proteins, which is associated with Alzheimer's

'Nutraceuticals' or foods that have some type of medicinal or nutritional function are the key.



The hop flowers used to flavour beers have been explored as one of these potential nutraceuticals, with previous studies suggesting that the plant could interfere with the accumulation of amyloid beta pro-

teins associated with Alzheimer's. To identify these compounds, Cristina Airoldi Alessandro Palmioli and team created characterised extracts of four common varieties of hops using a method

similar to that used in the brewing process. In tests, they found that the extracts had antioxidant properties and could prevent amyloid beta proteins from clumping **Extracts of hop flowers used** in preparing beer have antioxidant properties and could prevent amyloid beta proteins associated with Alzheimer's

in human nerve cells.

The most successful extract was from the Tettnang hop, found in many types of lagers and lighter ales.

When that extract was separated into fractions, the one containing a high level of polyphenols showed the most potent antibiotic and aggregation-inhibiting ac-

tivity It also promoted processes that allow the body to clear out misfolded, neurotoxic proteins.

Finally, the team tested the Tettnang extract in a C. elegans model and found that it protected the worms from Alzheimer'srelated paralysis, though the effect was not very pronounced.

The researchers say that although this work may not justify drinking more bitter brews, it shows that hop compounds could serve as the basis for nutraceuticals that combat the development of Alzheimer's.

AD is a debilitating neurodegenerative disease, often marked by memory loss and personality changes in older adults.

Part of the difficulty in treating the disease is the time lag between the start of underlying biochemical processes and the onset of symptoms, with several years separating them.

This means that irreversible damage to the nervous system occurs before one even realises they may have the disease. IANS

# 'Efforts to revive ancient ship-building technology'

Bhubaneswar, Nov 8: A three-day national Dhara event – 'Samudramanthan', organised under the aegis of 'Azadi ka Amrit Mahotsav' with a focus on the state's rich maritime history and to create the vision document on maritime traditions-2047, kicked off Tuesday.

The programme was inaugurated at the SOA Deemed to be University here with speakers shedding light on India's maritime history.

Coinciding with the inauguration of the historic Bali Yatra at nearby Cuttack, the event has been organised by the Indian Knowledge System Division of Ministry of Education in association with the Ministry of Culture and SOA.

The event will include panel and roundtable discussions on the country's maritime history locations, traditions, ship building, navigation, trade and cultural exchange, maritime security and international law which will be held at the Odisha Maritime Museum at Cuttack over the next two days.

The inaugural programme was addressed by Sanjeev Sanyal, author and member, Economic Advisory Council of the Prime Minister, GS Murthy, National Coordinator, IKS Division, Priyanka Chandra, Director, Azadi ka Amrit Mahotsav, Ministry of Culture and Pradipta Kumar Nanda, pro-vice chancellor, SOA. Nachieketa K Sharma, director, University Outreach Programme, SOA welcomed the speakers while Jyoti Ranjan Das, Dean (Students' Welfare) proposed the vote of thanks.

Sanyal, in his keynote address, highlighted India's ancient maritime exploits saying it is the only country in the world after which an ocean has been named. "India wielded enormous influence in South East Asia through its trade, culture and geo-politics during the time," he said adding that efforts were on to revive the ancient 'stitched ship technology' practised by Indians to build ships centuries ago.

History has recorded Odisha's maritime exploits of the past which made it a knowledge powerhouse because of its highly developed maritime traditions where seafarers traded extensively with the countries to the east, west and south of the Indian subcontinent. The famous Baliyatra, an annual event held on the edge of the Mahanadi river in Cuttack, is intended to celebrate the journey of ancient mariners from the Odisha coast to Bali island in distant Indonesia.

# Exposure to third hand smoke may trigger skin diseases

cute exposure to thirdhand smoke may increase the risk of skin diseases such as contact dermatitis and psoriasis, according to a small study.

Thirdhand smoke (THS) comprises the residual pollutants from tobacco smoke that remain on surfaces and in dust after tobacco has been smoked. It can remain on indoor surfaces indefinitely, causing potentially harmful exposure to both smokers and non-smokers.

Acute exposure of the skin to thirdhand smoke elevates biomarkers associated with the initiation of skin diseases. Biomarkers are natural substances that indicate a biological state, most commonly a disease.

The study, published in eBioMedicine, claims to be the first one to be performed on humans

exposed dermally to THS.
"We found that exposure of

human skin to THS initiates mechanisms of inflammatory skin disease, and elevates urinary biomarkers of oxidative harm, which could lead to other diseases, such as cancer, heart disease, and atherosclerosis," said researcher Shane Sakamaki-Ching from University of California.

The research, which took place at UC San Francisco, involved the participation of 10 healthy, nonsmokers who were 22 to 45 years old.

For three hours, each participant wore clothing infused with THS and either walked or ran on a treadmill for at least 15 minutes each hour to induce perspiration and increase uptake of THS through the skin.

"Alarmingly, acute dermal exposure to THS mimics the harmful effects of cigarette smoking. We found acute THS exposure caused elevation of urinary bio-



markers of oxidative damage to DNA, lipids, and proteins, and these biomarkers remained high after the exposure stopped," said Sakamaki-Ching.

akamaki-Ching. "Cigarette smokers show the same elevation in these biomarkers. Our findings can help physicians in diagnosing patients exposed to THS and help develop

regulatory policies dealing with

remediation of indoor environ-

ments contaminated with THS, "said Sakamaki-Ching.

Prue Talbot, a professor of cell biology in whose lab Sakamaki-Ching worked, explained that skin is the largest organ to contact THS and may thus receive the greatest exposure.

"There is a general lack of knowledge of human health responses to THS exposure," said Talbot, the

paper's corresponding author.

"If you buy a used car previously owned by a smoker, you are putting yourself at some health risk. If you go to a casino that allows smoking, you are exposing your skin to THS. The same applies to staying in a hotel room that was previously occupied by a smoker."

The THS exposures that the ten participants were subjected to were relatively brief and did not cause visible changes in the skin. Nevertheless, the molecular biomarkers in blood that are associated with early-stage activation of contact dermatitis, psoriasis and other skin conditions were elevated. "This underscores the idea that dermal exposure to THS could lead to molecular initiation of inflammation-induced skin diseases," Sakamaki-Ching said.

The participants did not know the clothing had THS. Blood and urine samples were then collected from the participants at regular intervals to identify protein changes and markers of oxidative stress induced by the THS. Control exposure participants wore clean clothing.

Next, the researchers plan to evaluate residues left by electronic cigarettes that can come into contact with human skin. They also plan to evaluate larger populations exposed to longer periods

The Jeypore MLA also laid the foundation stone of a room for keeping the relics of the deceased at Bhootnath crematorium. The total cost of the project is estimated to be ₹5.56 lakh. A park will also be built at a cost of ₹25 lakh at Dhanwi Township in this city. Bahinipati also asserted that there will be no dearth of funds for the development and upgrading of the historic water body.

Prior to the ceremony, an MoU was signed Saturday between Jeypore Municipality representing the Koraput district administration and HAL for renovation of Jagannath Sagar'

It should be stated here that Jagannath Sagar' was created more than three centuries back by the erstwhile royals of Jeypore over 300 acres of land. However, due to encroachments, dumping of garbage and lack of maintenance, the water body has shrunk to 55 acres.

According to the MoU, HAL will pay ₹7 crore in three phases during a three-year period. The funds will be spent on construction and installation of the main gate, an amusement centre for children, a resting place for senior citizens, an open air theatre, walkway, drainage system and a café, sources from HAL said. HAL will pay ₹1 crore in the first phase, ₹3.50 crore in the second and ₹2.50 crore in the third. The initial amount of ₹1 crore will be provided in four installments, sources said.

The development and renovation of 'Jagannath Sagar' has become a reality because of the efforts of local denizens and as the matter was raised consistently in the Odisha Assembly by Bahinipati.

Chief Secretary Suresh Chandra Mahapatra took notice of the issues raised by Bahinipati. Apart from the funding by HAL, a detailed project report of ₹8 crore has been prepared and submitted to the Odisha government for its appraisal and final approval. A survey has also been undertaken to prevent flow of polluted water into the water body.

# SPARKS CONCERN IN GANJAM POST NEWS NETWORK

RAPID SPREAD OF DENGUE

Berhampur, Nov 8: The rapid spread of dengue is posing serious concern among the residents of Ganjam district and it is a huge challenge to the healthcare personnel, sources said Tuesday. Currently 149 people in 21 blocks of Ganjam district and also within the Berhampur Municipal Corporation are down with dengue.

Patrapur block has reported the highest number dengue cases with 33 persons including eight kids affected by the disease. Locals pointed out that many of those affected by the virus have come to Patrapur from outside the state and they are spreading the disease. However, even then, the number of people infected this year is much lesser to the 333 cases reported last year.



When contacted, chief district medical officer (CDMO) Dr Umashankar Mishra said even though the disease is spreading quickly, there has not been a single casualty due to the virus in the last nine years in Ganjam district. He also informed that a special ward has been set up on the first floor of the casualty department in MKCG Medical College and Hospital for treatment of dengue patients. The ward has been operational since August 17. Mishra stated that a team of doctors are treating dengue patients round the clock

# Patrolling intensified to check bird poaching in Chilika lake

Berhampur, Nov 8: Wildlife personnel intensified Tuesday patrolling in and around the Chilika lake to curb birds from being poached on the eve of 'Chhadakhai' festival, which is celebrated a day after 'Kartik Purnima'

The measures are being implemented because birds are hunted by local people on this occasion as they eat non-vegetarian stuff after staying away from it during the month of Kartik. Chilika lake, the largest brackish water lagoon in India, spread over the districts of Ganjam, Puri, and Khurda, witnesses a large congregation of winged guests from several countries during the onset of winter.

"To curb poaching of the avian guests on the occasion of 'Chhadakhai', patrolling has been intensified from Sunday with two additional mobile teams. Special emphasis has been given in vulnerable areas like Nalabana, the bird sanctuary, and Tangi range" said PK Panda, assistant conservator of forest (ACF), Chilika wildlife division. The ACF said patrolling would also be carried out in the nearby areas of the lake.

An estimated 40,000 migratory birds of different species have already congregated in the lagoon so far, officials said.

Checking of vehicles, including fishing boats and motorcycles has been intensified in the range area, said Choodamani Murmu, range officer, Tangi.



# Loans sanctioned in name of tribals misappropriated

Nilagiri, Nov 8: Loans allegedly sanctioned in the name of 12 tribal families in Nilagiri-based Large Agriculture Multi-purpose Cooperative Society (LAMPS) have been misappropriated. This was alleged by former MLA Chittaranjan Sarangi. He has demanded an investigation into the loan fraud.

Twelve tribal families living at Nuasahi and Jamudisahi have been burdened with loans of huge amounts even though they have not taken any such assistance from LAMPS, sources said.

It was alleged that some people along with unscrupulous staff of LAMPS managed to obtain copies of the voters' identity cards, Aadhaar, land documents of the tribals and forged their signatures and fingerprints. They have misappropriated loans worth lakhs.

The fraud came to the fore through an

RTI query a few days back. The tribals were shocked to know about the fraud. The tribal families had earlier drawn attention of the LAMPS authorities towards such financial wrongdoings.

The society had conducted an investigation into the matter and had suspended the branch manager, an accountant of Nilagiri LAMPs and secretary of Sajanagad LAMPS.

However, loan amounts pending in the names of these tribals were not struck off from official records.

The tribal families met the former legislator in this regard and urged him to sort out the issue. The MLA staged a dharna. Assistant Registrar of Cooperative Society, Urmila Das and branch manager of Nilagiri LAMPS, Arun Kumar Maiti met the MLA and assured that the loans in the official records would be struck off. A letter has also been written to higher authorities.

Farmers stare at losses as LI project goes awry Soro: After the withdrawal of monsoon, hectares of farmlands in upland areas of Soro block in Balasore district are dry due to insufficient rainfall. Farmers are struggling to save their crops while a newly set up lift irrigation (LI) project is lying defunct. Now, the farmers have lost all hope of saving their crops as they are unable to provide water to their parched farmlands. They alleged that the Lift Irrigation department is not taking any steps to repair the project to make it useful for the distressed farmers. Notably, the lift irrigation project was made operational in Nadigaon panchayat in 2017 at a cost of ₹7 lakh. Power supply to the project has been snapped by authorities due to unpaid bills to the tune of ₹35,000, sources said. They also pointed out that unless remedial measures are taken soon, farmers stare at huge losses.

# Roe Roe Your Vote

idterm elections in the US November 8 are the first to be held since the Presidential election. In spite of the January 6, 2021 attack on the US Capitol by pro-Donald Trump supporters, Joe Biden was declared President. The current midterm election results will have far-reaching consequences for both the US and the rest of the world. The future of US democracy is on trial just as President Joe Biden's handling of the deepening US economic crisis and the growing polarisation among Americans

As it normally happens in almost every midterm, this time as well the ruling Democrats are expected to fare poorly and Republicans may be catapulted into centre-stage of the US decision making process gaining control over the House of Representatives and even the Senate.

At stake are all 435 seats in the House of Representatives and about a third of the Senate – the two bodies making up the Congress. The current tally in the House of Representatives is 220 belonging to Democrats and 212 to the Republicans with three vacancies. In the Senate, 35 of the 100 seats are up for election and of these, Democrats have 14 against the Republicans' 21. Several states will also elect secretaries of state and governors.

Poll predictions favour a Republican win for a variety of reasons, including a negative outlook for the US economy and a sharp drop in Biden's approval rating that is hovering around 40 per cent. A majority of Republicans are out to capitalise on the cost of living crisis. On the contrary, Democrats are trying to downplay the economic issue and are pitting the future of democracy at peril in the hands of Trump and his followers as their main agenda. The spectre of threat to democracy has loomed large following the recent vicious attack on House Speaker Nancy Pelosi's husband. Added to this is the Supreme Court's overturning of the Roe vs Wade verdict which was in favour of abortion. The latter led to a surge in registrations and more than half of registered voters say abortion will be a key factor to determine their choice. Biden's win was facilitated, among other things, by the support of women voters. During the midterm as well, women are expected to rally behind Democrats for the anti-abortion verdict. Whether women voters would respond the way they did in 2020 is doubtful since they are now concerned about the cost of living and rising gas prices.

Realising that his Presidency has so far caused widespread disenchantment among people, Biden chose the peril of democracy in his solemn speech November 2 as the centre point of the Democrats' election propaganda. The Republican opponents were, however, quick to dismiss it as alarmist posturing. On the contrary, Trump's violent rhetoric on the so-called electoral fraud is spreading like wildfire.

Meanwhile, Elon Musk, the new owner of Twitter has openly asked people to support Republicans. Author Stephen King has said whether people pay for the Blue Tick of Twitter or not, they should vote Blue (Democrat). A meme doing the rounds says Voting is just like Driving. To go backward choose 'R' and to go forward choose 'D'.

A triumph for Republicans will mean a crippled administration, facing legislative stagnation, hostile committees and investigations on matters such as Hunter Biden's business dealings. Trump, who has actively campaigned alongside Republican congressional candidates, still enjoys a certain level of popularity, investigations into his alleged smuggling of classified documents notwithstanding. In fact, the former President has maintained a favourable rating of around 44 per cent. Moreover, in 2020 liberals had turned up to vote with the agenda of ousting Trump. But, the enthusiasm seems to be on the wane now.

In such a scenario, Republicans regaining control of the House of Representatives and possibly the Senate may be a shot in Trump's arm. Whether he would contest the Presidential race or any other moderate Republican would replace him is a million dollar question. If Trump announces his intention to run in 2024, electoral attitudes may also change as his track record of intolerance and hate campaign would surely be revived to scuttle his chances. The midterm is set to redefine US politics like never before.

## Comeuppance

t's a common enough word that few people stop to think how odd comeuppance really is. Why should it mean the punishment or fate that someone deserves, a just retribution or just deserts? The Oxford English Dictionary directs enquirers about its origin to sense 74 of the verb come, implying that it derives from come up. That's reasonable, since the most common early written form in the US where the word seems to have been invented around the middle of the nineteenth century - was come-up-ance, which we may guess is the situation or consequence of having come up. The OED and some other dictionaries suggest it refers to coming up before a judge or court for judgement. That's supported by the earliest evidence for the related expression come-uppings, known in American English from rather later: I was led away, and I got my come-uppings, or the other fellow's come-uppings, for I wa'n't to blame any, and I always said so, and I guess the judge would say so too, if it were to do over again (The Minister's Charge, by William Dean Howells, 1886), Curiously, come-upping is recorded in Cornish dialect in 1880 in the sense of a flogging. It's possible that it's a quite separate form, which was taken to the US by migrants and became associated with come-up-ance.

conkerer plays the British game of conkers. A brief description Amay be desirable for those unfamiliar with it. Conkers has two players, each armed with a nut of the horse chestnut threaded on a string. Players take turns hitting their opponent's nut with their own. The player whose nut breaks first loses. Conker is a dialect word that originally meant a snail shell, with which the game was first played, though without the strings (it would be classed as animal cruelty these days, as the shells were frequently still occupied). Frederick Ross described it in A Glossary of Words Used in Holderness in the East-Riding of Yorkshire of 1877: "In the boy's game of conkers the apexes of two shells are pressed together until one is broken, the  $% \left\{ 1,2,\ldots ,n\right\}$ owner of the other being the victor." Strangely, for a game often considered to be an immemorial part of the English annual round of boy's games, the snail sense is first recorded only from the early nineteenth century, and the horse chestnuts one from the 1880s. The word might be from conch, but could equally well be a respelling of conqueror, since the game was often spoken of and spelled that way in the nineteenth century.

## **FOCUS MELTING GLACIERS**

# A HIMALAYAN THREAT

√he COP27 has just begun in the Egyptian coastal city of Sharm el-Sheikh and the planet is sending a distress signal. "Sea level rise, glacier melting, torrential rains, heat waves -- and the deadly disasters they cause -- have all accelerated," warns the World Meteorological Organisation in a report. While the world will debate as usual, reports have clearly indicated that it is still nowhere near the scale and pace of emission reductions required to put us on track toward a 1.5 degrees Celsius world. In fact, there has been a warning that national governments need to strengthen their climate action plans now and implement these in the next eight years, which means that the onus would now be on emerging economies including India.

Dealing with just one implication of global warming, it is in fitness of things to refer to an article way back in 2013 in 'Nature' where scientists cautioned that rising temperatures in the Himalayas raise the threat of glacial lake outburst, which is even more relevant today. Of the 8,800 glacial lakes in the Himalayas, over 200 have been classified as dangerous. Himalayan nations were urged to build an international network to monitor risks such as those from glacial lakes and give early warning of hazards. Will the issue get the focus it de

serves or get lost in new pledges? According to available data, the Himalayan river basins cover an area of 2.75 million square kilometres and have the largest irrigated area of 5.77,000 square kilometres, and the world's largest installed hydropower capacity of 26,432 MW. The melting glaciers fulfill the water requirements of over a billion people of the region. Obviously, these people will be affected when much of the glacier ice mass melts and gradually stops supplying water to inland rivers. While the Ganga and the Brahmaputra basins in India get a big chunk of their water from monsoons, the situation is different for the Indus, which is largely dependent on the glaciers. However, changing rainfall patterns and rising global temperature will affect the Ganga and the Brahmaputra basins as well

As is evident, majority of glaciers in the Himalayan region are melting due to rising temperatures. Studies conducted by the Geological Survey of India, the Wadia Institute of Himalavan

Geology, the National Centre for Polar and Ocean Research and the Indian Institute of Science have observed accelerated heterogeneous mass loss in Himalayan glaciers. According to the Ministry of Earth Science, the mean rate of Hind Kush Himalayan glaciers is around 15 metres per year which is 12.7-13.2 metres in Indus, 15.5-14.4 metres in Ganga and 20.2-19.7 in Brahmaputra river basins.

The landslides that have occurred in recent years have been triggered by a plethora of natural and man-made factors such as heavy rainfall, earthquake, active geological features, deforestation, large-scale land use changes, among others. It needs to be mentioned here that our investment in pro-active scientific approaches -- natural hazard surveillance or flood forecasting -- is not sufficient and technologically sound. In the absence of science policy-based instruments, the destruction has been grave over the years.

However, in the first detailed inventory of glaciers at the Alaknanda river basin, which contributed the maximum water to river Ganga, scientists from IISc and IITs discovered a reduction of 59 sq km in the glacier area over a period of almost 50 years, between 1968 and 2020. This meant that 8 per cent of the total area of glaciers decreased. Scientists have said that regional climate change was a big reason behind the development. This study of the river basin, which took over two years to complete, was published in the

'Geocarto International' journal by Taylor & Francis. The average retreat rate of glaciers in the basin was 11.75 m per annum.

The analysis of climatic parameters in the basin suggested substantial evidence of deglaciation due to global warming, especially since the winter temperature increased by 0.03 Celsius per year between 1968 and 2020. The team of scientists studied almost all satellite imagery since 1968 meticulously and found that though the area of the glaciers reduced in the river basin, the number of glaciers increased from 98 to 116.

Scientists said the increase in numbers was a cause for concern. Small portions of the glaciers were melting in a way that they would not contribute water to the river and hence, there would be a "cascading effect" on the water security of the people living downstream, they observed. "They are melting faster and forming new water bodies such as lakes near the glacier. If the glaciers melt faster in the future, these water bodies will get added water and may overflow, causing destruction," experts pointed out.

The seasonal runoff from Himalayan glaciers provides different water services to about 800 million people for the purposes including irrigation, hydropower and drinking water. As the glaciers melt unconventionally, it will eventually result in water shortages. The greater runoff causes the rivers to flood. Glacier melting. in some measure, affects snowfall. A regular reduction in usual winter snowfall leads to water

Thus, the melting of these glaciers is undoubtedly a major cause of concern as it is expected to have a massive impact on the water supply for the rivers. Experts believe that continued melting will lead to change in glacier basin hydrology, downstream water budget and impact on hydropower plants due to variation in discharge, flash flood and sedimentation.

Excessive melting doesn't help water to mix with rainfall and groundwater, which is used for crop irrigation and future supply during drought. The ratio of runoff to rainfall determines both groundwater recharge and groundwater depletion. Increased glacial melting would disturb this even distribution sustaining a large population until now. It has been amply evident that the increased melting of Himalayan glaciers has been causing flooding disasters and this is expected to continue in the next few years. What would happen after that is the Ganga and the Indus flowing with radically reduced pace may result in acute water stress, mass migration, and

unseen conflicts. A study of IIT Indore last year found that the total river runoff, glacier melt, and seasonality of flow are set to increase until the 2050s, and then decrease, with some exceptions. Researchers have called for greater focus on the problems and to assess the current status and potential future changes of rivers for sustainable water resource management for agriculture, hydropower, drinking, sanitation, and hazard situations.

Climate change and global warming are indeed dangerous phenomena, and their consequences are severe for humans, affecting them in all possible ways. Even water. which is the basis for human survival, has been affected in various ways due to the ravages of nature and glacial melt is a key reason. There is thus an immediate need to ensure that warming is controlled by checking emissions of greenhouse gases to counter the disastrous effects of glacier melting. Experts and organisations working in the field should come out with an action plan to control such melting in the coming years.

# Wear seatbelt, protect others from your skull

**HUMAN BEINGS WERE ONCE HAPPY TO DRIVE CARS AT 20** KM PER HOUR, **BUT THAT WAS A CENTURY AGO** 

If you are sitting in the rear seat of a car, you may be tempted to ignore the seatbelt. Nothing's going to happen to you. It's the people in the front who need to protect themselves. The worst that will happen to you, in case of an accident, is getting your hair all messed up.

This would be true, of course, if every car were traveling as fast as a tractor. Human beings were once happy to drive cars at 20 km per hour, but that was a century ago, when horse carriages were common and people complained about the price of hay.

Cars can go much faster these days and they're so smooth that you don't feel the speed, unless you're standing on the side of an expressway. When a car is flying down the road and hits another vehicle hurtling down the road (or even a stationary object), all passengers in the car are at risk of sustaining severe bodily harm.

But it's not just the momentum of the car that puts all passengers at risk – it's the fact that a car can be impacted on all six sides: front, back, left, right, top and bottom.

It's rare that a car flips over or zooms off a bridge, but it does happen. And the passengers who walk away from such accidents usually have something in common: they were wearing seatbelts.

That's why I'm happy to hear that the police in India are starting to be stricter about seatbelts. Mumbai police recently issued a notification saying that seatbelts would be mandatory for all passengers beginning on Nov. 1. Warnings would be given until Nov. 10 and e-challans issued from Nov. 11 onwards.

In response to the new rule, standup comedian Atul Khatri tweeted a photo of a man wearing a T-shirt with a seatbelt imprinted on it, saying, "Mumbaikars! Please wear seatbelts from today or buy this t-shirt." As you can imagine, Mumbai

police were not amused. They immediately tweeted that from Nov. 11 onwards, an e-challan would be issued to anyone who jokes about seatbelts. Actually, what the police tweeted

to Khatri was this: "We shall keep them in stock for you, along with our challans. Your safety is never a joke! PS: If this ever will be basis for a stand up routine, ensure the message of safety is sent out as well." If Khatri has taken their message to heart, his comedy routine may sound like this:

"Listen everyone, you must always wear a seatbelt - it doesn't matter whether you're in the front seat, back seat or even on the roof. Let me give you several reasons why seatbelts are important:

"Firstly, numerous studies have been conducted showing that seatbelts protect not only passengers inside cars but also trees. If you're not wearing a seatbelt, you might get thrown out of the car into a tree. The poor tree has not done anything wrong, but now might be slightly injured and might also feel guilty about your broken skull."

"Secondly, the seatbelt keeps you in place. By wearing a seatbelt, you are not only protecting yourself, you are protecting other passengers from being struck by your flying skull. Please keep your skull to yourself!"

"Thirdly, the seatbelt can save you money. You won't end up with a hefty hospital bill and you won't have to pay fines to the police. Your insurance company may even give you a discount for not getting any challans.

"Fourthly, the seatbelt ensures that you get to spend more time on earth. Without a seatbelt, you may get thrown all the way to the moon.'

## **Economic blunder**

## Landmark verdict

Sir, After the verdict of the Supreme Court endorsing the 103rd Amendment in the Constitution, the poor upper castes will be able to get the benefit of reservation in education and jobs. This verdict has also accepted the efforts of the government to bring up the economically weaker sections of the general category. The majority members of the Legislative Bench emphasised in the judgement that reservation to the economically weaker sections is also necessary to ensure the progress towards the goal of an egalitarian society in an all-inclusive manner. Post the Parliament enacted a law in 2019 to provide reservation to the EWS through the 103rd Constitutional amendment; its legality was challenged by calling it as a violation of the basic structure of the  $\stackrel{\sim}{\rightarrow}$ Constitution. 

# India's urban cities to see population boom: Report

Mumbai, Nov 8: India is projected to see an explosion in its urban population in the coming decades, but its cities already cannot cope and climate change will make living conditions harsher still.

Mumbai grew by some eight million people in the past 30 years to a population of 20 million, and is forecast to add another seven million by 2035. Like other megacities, Mumbai's housing, transport, water and waste management infrastructure has not kept pace, with around 40 percent of

people living in slums. These crowded collections of ramshackle buildings, side by side with some of India's richest neighbourhoods. often have no regular water, power supply or proper sanitation.

As the world's population approaches eight billion, most of them in the developing world, it is a situation replicated globally.

Those living on the outskirts of Mumbai commute for hours to work, with many hanging out of doors on packed trains, and others travelling by car or motorbike on clogged, pothole-filled roads that flood during the monsoon.

# Can't punish accused on suspicion alone: SC

New Delhi, Nov 8: The law does not permit courts to punish an accused on the basis of moral conviction or on suspicion alone, the Supreme Court said while acquitting three men sentenced to death for the gangrape and murder of a woman in Delhi's Chhawla area in 2012.

The court made the observation while noting that a kind of agony and frustration may be caused to the society in general and to the family of the victim in particular if the accused involved in the heinous crime go unpunished or are acquitted. The bench said the prosecution failed to provide leading, cogent, clinching and clear evidence, including those related to DNA profiling and call detail records (CDRs), against the accused, and said that the trial court also acted as a "passive umpire".

The three men were accused of abducting, gangraping and brutally killing the 19-year-old woman in February 2012. Her mutilated body was found three days after she was abducted.

A bench of Chief Justice U U Lalit and Justices S Ravindra Bhat and Bela M Trivedi acquitted the convicts in a 40-page order passed Monday. The bench said that since the prosecution failed to bring home the charges levelled against the accused beyond reasonable



doubt, the court was left with no alternative but to acquit the accused. though involved in a very heinous crime. "It may be true that if the accused involved in the heinous crime go unpunished or are acquitted, a kind of agony and frustration may be caused to the society in general and to the family of the victim in particular, however, the law does not permit the courts to punish the accused on the basis of moral conviction or on suspicion alone," the bench said.

It added, "The court is constrained to make these observations as the court has noticed many glaring lapses having occurred during the course of the trial. It has been noticed from the record that out of the witnesses examined by the prosecution, 10 material witnesses were not cross-examined and many other important witnesses were not adequately crossexamined by the defence counsel."

# Climate change to impact mountains: Study

New Delhi/Johannesburg, Nov 8: Climate change will negatively impact mountain landscapes and human activity globally by increasing the risk of hazards such as avalanches, river floods, landslides, debris flows and lake out-

burst floods, a study has warned. The study, published in the journal PeerJ, shows how complex mountain systems respond in very different and sometimes unexpected ways to climate change, and how these responses can affect mountain

landscapes and communities. "Worldwide, mountain glaciers are in retreat because of global warming and this is causing impacts on mountain landforms, ecosystems and people. However, these impacts are highly variable," said Professor Jasper Knight, from the University of the

Witwatersrand in South Africa. 'The latest report by the Intergovernmental Panel on Climate Change (IPCC) treats all mountains as equally sensitive and responding in the same way to climate change. However, this ap-

proach is not correct," said Knight. The researchers noted that mountains with snow and ice work completely differently to low-latitude mountains where snow and ice are generally absent. This determines how they respond to climate

Under the threat of climate change, mountain landscapes all over the world have the risk of becoming more hazardous to communities surrounding them

and what future patterns of mountain landscape evolution we can expect, they said.

Mountain snow and ice globally provide water for hundreds of millions of people, but this water supply is under threat because of changing weather patterns and as mountain glaciers get smaller and smaller.

In future, the water crisis in dry continental areas of Asia, North America, South America and Europe will only get worse, according to the researchers.

The study also shows how climate change will negatively impact on mountain landscapes and human activity. This includes an increasing risk of hazards such as avalanches, river floods, landslides, debris flows and lake outburst floods

These are made worse because of glacier retreat and permafrost warming. Alpine ecosystems and endemic species are already threatened with local extinction and mountain slopes are becoming greener as lowland forests spread to higher altitudes, the researchers said. The researchers said mountain communities and cultures are also affected by climate change. Transhumance -moving livestock from one grazing ground to another in a seasonal cycle -- and traditional agriculture are dying out as grazing areas shrink and as water becomes scarcer, they said. The study authors noted that tourism, mining, urbanisation and commercial forestry are also pushing out these traditional practices, adding that mountain heritage landscapes and indigenous cultures and knowledge are not adequately studied or valued. The research shows that mountains should be considered and protected as integrated biophysical and socioecological systems, where people as well as physical landscapes are important.

Nagpur, Nov 8: Aerosol pollution in Maharashtra is likely to move to 'highly vulnerable' red zone from the current 'vulnerable' orange zone in 2023, which may lead to drop in visibility levels and pose a host of health problems for its citizens, a study revealed.

As per a release issued by Asar, an organisation working for environmental causes, high aerosol amounts include particulate matter (PM2.5 and PM10) comprising sea salt, dust, sulphate, black and organic carbon. If inhaled, these substances can be harmful to people's health, it said.

Aerosol optical depth (AOD) is the quantitative estimate of the aerosol present in the atmosphere and it can be used as a proxy measurement of PM2.5. The study titled 'A deep insight into state-level aerosol pollution in India', conducted by Associate Professor Dr Abhijit Chatterjee and PhD scholar Monami Dutta from Bose Institute, Kolkata, provides an insight into

Maharashtra can witness an AOD rise of about 7 per cent between 2019 and 2023, he said. The study has identified thermal power plants, solid fuel burning and vehicular emissions as main sources of aerosol pollution in the state, he said.

Emissions from thermal power plants increased from 31 per cent to 39 per cent between 2005 and 2019), mainly due to the increase in capacity and dependence on coalbased power generation, the study stated. Maharashtra needs to turn down the capacity of thermal power plants by 41 per cent (10 GW) to move to the blue zone, author of the study Monami Dutta said.

The state government should not only restrict sanctioning of new thermal power plants, but should also focus on reducing the current capacity by at least 10 GW, she said.

# 37% of Delhi women drinking more alcohol since pandemic

New Delhi, Nov 8: Over 37 per cent of women in Delhi believe that their alcohol consumption has increased in the last three years, indicating the impact of the pandemic on alcohol habits, a survey has claimed.

Over 45 per cent women said that the reason for their increased drinking frequency was "stress," the survey said. The survey conducted by the Community against Drunken Driving (CADD), an NGO, cited the pandemic, the ensuing lockdown, increased availability of alcohol, and changed expenditure pattern, as factors that contributed to the increased drinking among women.

New Delhi, Nov 8: Reporting of major crimes in the national capital has increased by 440 per cent in the last 10 years from 2012 to 2021, according to a report.

The report launched by the Praja Foundation on State of Policing and Law & Order in Delhi' also highlights the pendency in the investigation of cases as well as trial proceedings in Delhi. No immediate reaction was available from the Delhi Police on the report.

According to the report, registered crimes of theft and chain snatching have increased by 827 per cent and 552 per cent respectively from 2012 to 2021. While registered crimes of molestation, rape and kidnapping/abduction have increased by 251 per cent, 194 per cent and 39 per cent respectively.

The report further stated that 41 per cent of total rape cases were registered under POCSO Act in 2021. In the same year, it has been seen that 91 per cent of total kidnapping and abduction victims were children while the conviction rate was 38 per cent for crimes against women and only 52 per cent for crimes against children.

The report added that 99 per cent of crimes against women and children are pending for trial as of 2021 and at this rate, it would take 27 years to provide a judgment to all such cases

Milind Mhaske, CEO, Praja Foundation said although it is a



good sign that more citizens are coming forward to report a crime, a sharp rise in crimes against women and crimes against children in Delhi is still concerning.

Citing an example, he said that 86 per cent of Delhi's victims of human trafficking from 2017 to 2021 were children under the age

of 18 years. Moreover, 89 per cent of all victims of human trafficking in 2021 were trafficked for forced

"Policing and law and order are systematic factors important to address the rising crime rate in Delhi. However, cases pending at the investigation and judiciary stages justice to the victims. In 2021, 56 per cent of cases were pending investigation for crimes against women, which decreased minutely from 58 per cent in 2017. The pendency in the investigation of crimes against children has remained constant at 53 per cent in 2017 and 2021," Mhaske said.

The CEO of Praja Foundation attributed the delay in investigation of cases due to vacant positions in the Delhi Police force."There was a 12 per cent vacancy in police staff in 2021-22, of which the highest vacancy was for the post of Additional Deputy Commissioner of Police (74 per cent). Police inspectors, sub-inspectors and assistant police inspectors play an important role during an investigation. While in 2020-21, there was a 13 per cent vacancy in these posts,' added Mhaske. There is a pendency in trials at the judiciary level as well.



The high court had held that considering the provisions of the Andhra Pradesh Admission and Fee Regulatory Committee (for Professional Courses offered in Private **Un-Aided Professional Institutions**) Rules, 2006, the fee cannot be enhanced/fixed without the recommendations/report of the committee.

The top court said several factors such as the location of the professional institution, nature of the professional course, cost of available infrastructure are required to be considered by the Admission and Fee Regulatory Committee while determining or reviewing the tuition fees. It said the college management cannot be permitted to retain the amount recovered/collected pursuant to the illegal government order.

"In view of the above and for the reasons stated above both the appeals fail and the same deserve to be dismissed and are accordingly dismissed, however, with cost which is quantified at ₹5 lakh to be equally paid by the appellant as well as the State of Andhra Pradesh to be deposited with the Registry of this Court within a period of six weeks" the bench said.

# Farmers blame lack of disposal options as stubble burning rises

The Aam Aadmi Party, which is in charge of the government in both Delhi & Punjab, has taken responsibility for failing to curb stubble burning and aims to resolve the problem by November next year

Khamanon, Nov 8: Smoke billows out of the fields in India's Punjab state as several thousand acres of crop stubble are set on fire, wrapping surrounding areas in a thick, grey blanket.

The national capital Delhi and surrounding areas are enveloped in a layer of smog each winter as cold, heavy air traps construction dust, vehicle emissions and smoke from the crop stubble burning in the states of Punjab and Haryana.

Raging farm fires in these states have become a common sight as farmers burn crop waste to clear their fields after a harvest and prepare for the next sowing. Typically, the harvesting of summer-sown crops starts in October and sowing for the winter crop is carried out a couple of weeks after the harvest.

Farmers in Punjab, known as India's grain basket, claim they have no other option to get rid of their crop waste."If, instead of burning, the stubble has to be disposed off in any other manner,



then that involves a lot of expenditure," Paramjit Singh, general secretary of a prominent farmers' union in Punjab, told Reuters.But he said the stubble fires hurt locals more than the people in Delhi. about 280 km (170 miles) south of Khamanon town in Punjab's Fatehgarh Sahib district.



### Princess gives up royal duties

Copenhagen: Princess Martha Louise, the daughter of Norway's King Harald, said Tuesday she no longer will officially represent the Norwegian royal house following "many questions relating to me and my fiancé's role". Last week, National Security Council spokesperson John Kirby accused North Korea of covertly supplying a "significant number" of the ammunition to Russia. He said the United States believes North Korea was trying to obscure the transfer route by making it appear the weapons were being sent to countries in the Middle East or North Africa.

# **US votes with Biden agenda at stake**

Washington, Nov 8: Americans Tuesday cast the final ballots in US midterm elections that will determine whether Democrats lose control of Congress, and with it the ability to push forward on President Joe Biden's agenda in the next two years.

The party that controls the White House typically loses seats in midterm elections. Nonpartisan forecasts suggest Tuesday's results will be no exception, as concerns about high inflation and crime outweigh the end of national abortion rights and the violent Jan. 6, 2021, assault on the Capitol in voters' minds.

Thirty-five Senate seats and all 435 House of Representatives seats are on the ballot. Republicans are widely favored to pick up the five seats they need to control the House, while the Senate - currently split 50-50 with Democrats holding the tie-breaking vote - could come down to a quartet of toss-up races in Pennsylvania, Nevada, Georgia and Arizona

But even before the midterm elections were completed, the 2024 presidential election was taking shape. Former President Donald

Dubai, Nov 8: Iran's courts will deal firmly with anyone who causes disruption or commits crimes during a wave of anti-government protests, the judiciary said on Tuesday, signalling the authorities intend to hand down harsh sentences to convicted demonstrators

One of the biggest challenges to Iran's clerical leaders since the 1979 Islamic Revolution, the demonstrations have already persisted for eight weeks despite tough security measures and severe warnings from security

More than 1,000 people have been indicted in Tehran Province alone in connection with what the government calls "riots".

"Now, the public, even protestrs who are not supportive of riots, demand from the judiciary and security institutions to deal with the few people who have caused disturbances in a firm, deterrent and legal manner," judiciary spokesman Masoud Setayeshi said. The anti-government demonstrations erupted in September after the death of a Kurdish woman Mahsa Amini, who had been detained by morality police for allegedly flouting the Islamic Republic's strict dress

code imposed on women. The activist HRANA news agency said that 318 protesters had been killed in the unrest as of Saturday, including 49 minors. Thirty-eight members of the security forces had also been killed. it said. State media said last month that more than 46 members of the security forces, including police officers, had been killed. Government officials have not provided an estimate of any wider death count.

London, Nov 8: Nearly one in six people living in England and Wales last year were born outside the country and Indians constituted the largest chunk at 1.5 per cent of residents, according to latest statistics based on the country's 2021 census data.

The UK's Office for National Statistics (ONS) found that India remained the most common country of birth outside of the UK last year at 920,000 people, followed by

Poland at 743,000 people or 1.2 per cent of residents and Pakistan at 624.000 (1 per cent).

One in six usual residents of England and Wales were born outside the UK, an increase of 2.5 million since 2011, from 7.5 million (13.4 per cent) to 10 million (16.8 per cent)," the ONS said in a release. "India remained the most common country of birth outside the UK in 2021," it said.

The top three countries of birth outside the UK for England and Wales remain unchanged as India,



Poland and Pakistan since the last census 10 years ago, with the numbers rising across all categories - India from 694,000, Poland

from 579,000 and Pakistan from 482,000 in 2011.

The census data also shows that Polish (760,000, 1.3 per cent).

Romanian (550,000, 0.9 per cent) and Indian (369,000, 0.6 per cent) were the three most common non-UK passports held by residents in England and Wales in 2021.

London remained the region with both the largest proportion of people born outside the UK and the largest proportion of people with non-UK passports. In 2021, more than four in 10 (40.6 per cent) usual residents in London were non-UK born, and more than one in five (23.3 per cent) had a

non-UK passport. This is a marginal increase since 2011, when 36.7 per cent of London residents were non-UK born and 21.0 per cent had a non-UK passport. The number of people who listed Romania as their country of birth grew by 576 per cent since the previous census, from 80,000 in 2011 to 539,000 in 2021 – marking the highest out of any country, driven by working restrictions for Romanian

citizens being lifted in 2014. "The census paints a picture of how the make-up of the population has changed in the past decade. That decade, of course, saw us leave the EU as well as live with the pandemic," said Jon Wroth-Smith,

Census Deputy Director.

'While these events may have had an impact on people's decisions or ability to migrate or travel at a given time, the census tells us about the change over the whole decade - who was living here in March 2021, compared with March 2011. We can see Romanians have been a big driver in this change, while there have also been increases due to migration from India, Pakistan and Poland, as well as southern European countries such as Italy," he said.

# Banks inadequately pricing risks: SBI report

Amid a decadal high credit growth of over 18 per cent, deposit growth has been falling way behind

Mumbai, Nov 8: Amidst liquidity tightening and a decadal high credit growth of over 18 per cent and deposit growth falling way behind, a report has warned that banks are not adequately pricing their risks from both asset and liabilities sides.

Liquidity crunch is primarily because the Reserve Bank has been sucking out funds from the system as it fights to tame inflation which has been much above its band of 4 per cent for the past 10 months of the year. This has prompted the RBI to frontload its inflation fight by increasing the policy rates by 190 basis points to pre-pandemic levels since the war on Ukraine began.

The average net durable liquidity injected into the banking system in April 2022 was ₹8.3 lakh crore, which is nearly a third of that now at ₹3 lakh crore. Atop this, the government has spent a large part of its cash balances in the Diwali week, and as a result the net LAF (liquidity adjust facility) in the system, which was hitherto negative, has improved of late. Bonus payments by the government and the private sector also



Even as the banking system has moved closer to a calibrated liquidity coupled with higher signaling rates, one thing has still not changed is that credit risks are not getting adequately priced in, even as credit demand is at a decadal high and liquidity remains significantly downsized, argues Soumya Kanti Ghosh, the group chief economic adviser at the State Bank of India, in a report.

According to the report, what is still intriguing, however, is that even as the banking system is witnessing net LAF deficit, market sources point out that risk premia over and above core funding cost

are not fairly acknowledging the inherent credit risk.

For example, short tenor working capital loans for less than one year are given at lower than 6 per cent and are linked to onemonth/three-month T-bill rates. while 10- and 15-year loans are being priced at less than 7 per cent.

It is to be noted that 10-year G-Sec is currently trading around 7.46 per cent, while the 91-day T-bill is trading at around 6.44 per cent and 364day T-bill at around 6.97 per cent.

The average core funding cost of the banking system is at around 6.2 per cent now, while the reverse repo rate is at 5.65 per cent. No wonder, banks are currently engaged in a fierce war to raise deposits, with rates being offered up to 7.75 per cent in select maturities. Additionally, banks are now mobilising certificates of deposit (CDs) at rates as high has 7.97 per cent for a 360 days paper. Further, a few banks have raised CDs at 7.15 per cent for 92 days.

Thus a significant part of the funding gap is also being made up by CD mobilisation. The out standing CDs stood at ₹2.41 lakh crore on October 21, compared to just ₹ 0.57 lakh crore a year ago.

The CP market is also witnessing significant churn with primary issuances of the short-term paper coming down drastically to ₹ 0.78 lakh crore after touching a high of around ₹ 2.9 lakh crore in November 2021.

The yields have also increased by 255 basis points (bps) since April 2022 and was at 6.92 per cent in October 2022, he says in the report.

The report also notes that the good thing is that such pricing war for both fund raising and lending is mostly restricted to AAA-rated borrowers and ultimately it should also lower the risk weighted assets thereby lowering the capital re-

# OMCs' Q2 loss at ₹2,749cr

New Delhi, Nov 8: State-owned oil marketing companies (OMCs) IOC, BPCL and HPCL posted a second consecutive quarterly loss totalling ₹2,748.66 crore in July-September as a one-time LPG payout by the government could not mask the losses from petrol and diesel prices freeze.

According to stock exchange filings by the three fuel retailers, the losses were due to erosion in the marketing margin on petrol, diesel and domestic LPG The losses would have been

higher but for the ₹22,000 crore one-time government grant paid to make up for losses incurred on selling cooking gas LPG at rates below cost in the last two years. Losses were despite robust refining margin extending into the second quarter.

Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL), and Hindustan Petroleum Corporation Ltd (HPCL), which are supposed to revise petrol and diesel prices daily in line with cost, have not changed rates for record seven months in a row.

IOC October 29 reported a net loss of ₹272.35 crore for the July-September quarter, which came on the back of ₹1,995.3 crore loss in the previous three months. November 3, HPCL reported a loss

"OMCs still have under-recoveries on diesel," he had told reporters November 2 when asked if there is a price reduction in the offing in line with softening international oil prices.

# Rate hikes unlikely to impact asset quality of home loan portfolios: Icra

Mumbai, Nov 8: The ongoing rate hikes are unlikely to impact repayments by home loan borrowers despite an increase in the monthly instalments, a rating agency said Tuesday. Mortgage lenders have limited headroom to extend the loan tenures given the fact that the prime home loan segment already has long tenures, and a further extension in loan tenures will lead to overall tenures extending beyond the working life of the borrower, rating agency Icra said.

As a result, equated monthly instalments (EMIs) will go up by 12-21 per cent for prime home loans, while the same will go up by 8-13 per cent in the case of the affordable home loan segment, its sector head for financial sector ratings Manushree Saggar said.

"While there is an expectation of a further increase in interest rates. lenders have limited headroom to increase loan tenures: thus, EMIs would have to be revised upwards. However, this is unlikely to impact the HFCs asset quality indicators significantly," Saggar said. Even with revised EMIs, the

fixed obligation to income ratio (FOIR) is expected to increase by less than 10 percentage points and hence remain manageable, unless the original loans were given at aggressive FOIRs, she added. The RBI has hiked rates by 1.90%

since May in response to the runaway inflation, which has been transmitted into rates paid by home borrowers as well. Icra said the increase in FOIRs could also be partly offset by the expected increase in income levels with the improvement in the operating environment.

That may not sound like much. but it gave the highly volatile cryptocurrency a market value of \$21 billion, according to data platform CoinGecko

Not bad for a coin that was created as a "joke" satirising wild speculation in the crypto market and named after an internet meme of a Shiba Inu dog.

'Trading dogecoin around Elon tweets has become a lucrative form of speculation," said Matthew Dibb, chief operating officer of Singaporebased crypto investment manager Stack Funds.

Musk has indeed played a big role in the rise of dogecoin since its lighthearted launch by two software engineers in 2013. His tweets expressing support for the coin, including one calling it the "people's crypto", helped its price come from almost nowhere to surge about 4,000% in 2021.

Crypto watchers said the latest price jump, following the Twitter deal, was fuelled by investor bets that Musk would make dogecoin a



part of the platform's payments system. "There's a lot of speculation that Twitter will provide a test bed for doge adoption and experimentation for different uses,"

Doge has lifted other dog-themed coins in its wake, chiefly Shiba Inu, which has the same motif of the Japanese canine breed as doge and is designed to be compatible on the Ethereum blockchain. Shib, which trades at just \$0.00001, jumped by a third in the days after Musk closed the Twitter deal.

Unlike bitcoin, both doge and shib have near unlimited supplies, meaning it would take more than mere speculative hoarding to drive

### their prices up. AT MERCY OF MUSK?

Bets that Musk may allow crypto payments with dog tokens were kindled by his tweet last week of a picture of the Shiba Inu dog wearing a Twitter T-shirt.

Yet the early rally has stalled, with many crypto investors stumped about how serious he really is about dogecoin.

Musk, the world's richest person, called dogecoin a "hustle" on a talkshow in May last year, for in-

Garcia took a tight first set and went on to a 7-6(7-4), 6-4 victory over Aryna Sabalenka to win the championship of the WTA Finals Monday night.

The sixth-ranked Garcia became the second player from France to win the season-ending event after Amelie Mauresmo in 2005, also the last time the WTA Finals were held in the US.

Tied in the deciding game of a match with just one break point, Garcia's service winner gave her a second chance to close it out. When Sabalenka sent a forehand long, Garcia dropped to the court on her back and put clenched fists over her eves.

The event was moved to Texas from China over concerns about the safety of Peng Shuai, a Grand Slam doubles champion who accused a former government official there of sexual as-Coronavirus restrictions also played a part in the decision. Garcia won

her last six sets after dropping the first in a winner-take-all match against Daria Kasatkina in group play. The 29-year-old is the oldest WTA Finals winner since Serena Williams at 33 in 2014.

The only player to win titles on all three surfaces this season, Garcia was just as comfortable as Sabalenka on the temporary indoor hard court at Dickies Arena near downtown Fort Worth.

No.7 player from Belarus just her third loss in 12 career hard-court finals The 24-year-old Sahalenka was trying to become the first from her country to win the WTA

without a break of serve in a meeting of the tour (Garcia) and tournament (Sabalenka) leaders in aces coming into the match. Garcia won six consecutive points in the tie-breaker, capped by her 10th ace of the first set for a 6-2 lead. Sabalenka's third double fault ended the set. Garcia finished with 11 aces to four for Sabalenka.

Two break chances came quickly in the first game of the second set, but Garcia only needed one. She ripped a forehand winner down the line on Sabalenka's serve to go in front for good.

match by beating top-ranked Iga Swiatek. That semifinal victory ended a 15-match winning streak against top-10 opponents that was the longest on tour in 35 years.

Going into the WTA Finals, Sarcia was the only entrant in the eight-player field to beat Swiatek — but was ranked 45th when she did it at the Poland Open in July Garcia went on to her best Grand Slam finish, reaching the semifinals at the US Open.

Garcia's fourth victory of the season, second only to Swiatek's eight, came in the second 6-7 meeting in WTA Finals history. The other was Maria Sharapova-Serena Williams in 2004.

Veronika Kudermetova and Elise Mertens beat defending champions Barbora Krejcikova and Katerina Siniakova 6-2, 4-6, 11-9 to win the doubles title.



# Grassroots development should be priority: Bhutia

Bangalore, Nov 8: Former India football captain Bhaichung Bhutia feels that investing in grassroots development is the only way out to take the game forward in the country. He said footballers of all age in the country should have enough competitive matches to be able to do well in international tournaments

"You need to invest in the youth. grassroots development and then the player and the club benefit out of it and that's how football grows in the country. This is the only way if you want to really take football forward in India," Bhutia told PTI on the sidelines of an event here

"We have to reach out to the kids in rural, district and state levels. Sadly, we are not making them compete. Kids are not being able to train and compete within their own age group. That's been the biggest challenge.

The legendary striker also advocated the need to adopt the formula followed by European clubs. which invest in young talent and groom them to become quality players.

"This model should be replicated by Indian football clubs. That's how you invest in grassroots. You are looking at grassroots very raw and then taking talent and training to become a really great asset for the club and the country, that's where the club also generates revenue," Bhutia said.

"A lot of clubs in Africa and South America get raw talent from the grassroots, train them and then sell them to big clubs in Europe. They go back and play for their country and that's where the country also benefits out of the talent. That's how football grows. This is the model which I really think helps.' Meanwhile, former India

women's cricket team captain Mithali Raj is keeping her options open for the women's IPL tournament slated next year - player or mentor or even owning a team. The BCCI recently announced that the inaugural women's IPL will take place in March next year before the men's tournament.

Kunal Shah-backed Masai School, which offers courses in software development and data analytics, has raised USD 10 million in a Series B fundraising round led by Omidyar Network India, with sporting stalwarts Mithali and Bhutia also joining as investors and partners.

"I am keeping that role open, whether as a player or in a franchise in some way as a mentor," she told PTI in an interview Tuesday.

"But right now, nothing is clear, there are five teams. How they are going to do, whether it's a bidding or auction, so until there is some concrete information, I am keeping pretty much all things open," said Mithali, who retired from international cricket earlier this year. Asked if owning a team is an option, she said, "Maybe, yes"
