Exports enter -ve territory after 2 yrs

New Delhi: India's exports entered negative territory after a gap of about two years, declining sharply by 16.65 per cent to USD 29.78 billion in October, mainly due to global demand slowdown, even as trade deficit widened to USD 26.91 billion, according to data released by the commerce ministry Tuesday. Key export sectors, including gems and jewellery, engineering, petroleum products, ready-made garments of all textiles, chemicals, pharma, marine products, and leather, recorded negative growth during October. HC slams Guj govt over bridge collapse


Ahmedabad: Days after 135 people were killed when a suspension bridge collapsed in Morbi, the Gujarat High Court Tuesday asked the state government as to why no expression of interest (EoI) was invited for maintenance and operation of the British-era structure and how 'largesse' was given to an individual without floating a tender. The High Court made the observation while hearing a suo motu (on its own) Public Interest Litigation (PIL) on the collapse of the suspension bridge on the Machchhu river October 30, five days after it was reopened following renovation. The Ahmedabad-based Oreva Group had been maintaining and managing the ill-fated suspension bridge.



Bhubaneswar, Nov 15: The state government and the Centre Tuesday announced measures to resolve the agrarian crisis in the state in the midst of the intensified stir by farmers demanding payment of crop insurance claims and input subsidy.

The announcements were made a day after the farmers reportedly prevented BJP's Pradip Purohit from filing his nomination for the December 5 Padampur bypoll. Dubbing the measures as

drought-hit areas of the state. "About Rs 200 crore will be spent from the state exchequer to support the distressed farmers," a release issued by the Chief Minister's Office (CMO) said.

The announcement of central relief was made by Union Agriculture and Farmers' Welfare Minister Narendra Singh Tomar though a social media post.

G Udayagiri shivers at 7.2 degrees Celsius

Bhubaneswar, Nov 15: Cold conditions prevailed in the state Tuesday, with the G Udayagiri in Kandhamal district recording the lowest temperature of 7.2 degrees Celsius. the India Meteorological Department (IMD) said.

Two places recorded temperatures below 10 degrees Celsius. the other being Similiguda in Koraput district (9 degrees Celsius).

As many as 20 locations across the state recorded temperatures below 15 degrees Celsius, with the mercury plummeting to 10.5 degrees Celsius in Phulbani in Kandhamal district and 11 degrees Celsius each in Daringbadi in Kandhamal and Bhawanipatna in Kalahandi.

Other places that recorded low temperatures include Kirei in Sundargarh (11.5 degrees Celsius), Chiplima in Sambalpur (12), Jharsuguda (12.6), Keonjhar (13), and Bargarh (13).

The twin cities of Bhubaneswar and Cuttack saw the temperatures drop to 16 and 16.4 degrees Celsius respectively, which are 3.6 and 2.2 notches below normal respectively.

The Regional Meteorological Centre, while forecasting chilly conditions for the next three-four days, attributed it to dry and cold winds blowing from the northwest.

EOW ARRESTS 3 CYBER CROOKS

Bhubaneswar, Nov 15: The Economic Offences Wing (EOW) of Odisha Police claimed to have cracked a multi-state network of cybercriminals allegedly involved in cheating people, with the arrest of three persons in this connection.

The network was operating from Rajasthan, EOW DIG JN Pankaj said, Tuesday. The DIG said that two persons- Mahmud Khan and Munfed Khan—have been arrested with help of Rajasthan police. They were brought to Odisha on fiveday remand after being produced before a local court in Rajasthan.

The group, as revealed so far, has opened nearly 2,000 mule accounts in different parts of the country, mainly in Odisha, West Bengal, Bihar and Assam, he said.

EOW also arrested Anil Khiller of Baisinga in Mayurbhanj who used to supply the SIM cards to the scamsters in Rajasthan. He has procured and sent at least 1,200 SIM cards to these scamsters.

The arrests came when EOW was probing allegations of opening mule accounts with Indian Post Payment Bank in the name of innocent/rustic persons, especially in Nabarangpur, by giving the impression that the account holders would get benefits under government schemes through these accounts. But these accounts were used for illegal money transactions in cyber-

India's population growth slows down

New Delhi, Nov 15: As the global population reaches 8 billion, India, formerly a powerful driver of the number of people on the planet, is experiencing a marked slowdown.

Falling fertility rates in the South Asian country have forced at least one state to consider reviewing policies that encouraged families not to go beyond having two children.

The world's population is estimated by the United Nations to have hit 8 billion on November 15. with China and India accounting for more than a third of the total India estimates its population at 1.38 billion, slightly lower than the 1.4 billion that the World Bank estimates for China.

India will become the most populous country in 2023, according to the United Nations.

But India's annual population growth has averaged 1.2% since 2011, compared with 1.7% in the 10 years previously, government figures show.

Further slowing can be expected. India's total fertility rate (TFR) - children per woman - fell to 2 in the latest assessment period, for 2019-2021, from 3.4 in 1992-93, according

In Odisha, the total fertility rate dropped **21%** in only 11 years, between 2008/10 and

to a government report issued last month. It estimated that the average must be 2.1 for the population to reproduce itself.

2019/21

Increasing use of contraceptives and rising education among girls could have contributed to the decline in fertility rates, the government says. The use of family-planning methods jumped to 66.7% in 2019-21~from~53.5% in 2015-16.

That indicated that India's national population policies and health systems were working, the United Nations Population Fund (UNFPA) said in comments shared with Reuters.

"As India invests in its younger people, it needs to make plans for a demographic transition to take better care of a greater proportion of older people in the future," the UNFPA said.

Cuttack, Nov 15: Bringing laurels to the state, the Baliyatra on Mahanadi riverbed here has made it to the Guinness Book of World Records Tuesday as over 2,100 students made around 22,473 paper boats in 35 minutes during an event organised by the Cuttack Municipal Corporation (CMC) to commemorate Odisha's glorious maritime past.


Expressing happiness, Cuttack Collector Bhabani Shankar Chayani said that altogether 2,121 students of around 22 schools were able to make 22,473 paper boats during an event hosted by CMC at Barabati Stadium. "The record was achieved today on the sidelines of Baliyatra,"

Sources said the CMC had contacted the headquarters of the Guinness Book of World Records

in London for an attempt to make 10,000 paper boats in just 15 minutes. Subsequently, the record book authorities issued the protocol for organising the event and the civic body roped in 3,000 students, who were also trained on making paper boats.

The previous record was made by an art school in Guiarat wherein altogether 1,304 participants folded miniature paper boats in 2016, it was

"The record to beat was 1,304 participants. And what was achieved here was 2,121. There were a host of guidelines. The minimum time was 15 minutes and three sculptures each. It was not a time-based record but it was for the number of people making the origami sculptures. Around 23,000 boats were made," said Rishi, an official adjudicator for the Guinness







Bhubaneswar, Nov 15: Odisha is a maritime state and for its strategic location, it has the potential to become a coastal shipping hub in the country, said Chief Secretary SC Mahapatra here Tuesday.

The Chief Secretary said this while inaugurating a two-day summit on Prime Minister Gati-Shakti Multimodal Maritime organised here by Paradip Port Authority, state and Union governments.

"Our coastline is quite suitable for the development of deep ports. Eastern part of India including Odisha is growing at a faster rate. Odisha is supplying thermal coal, iron ore and manganese to a large number of states in India. The growth rate will be faster in coming years," Mahapatra said.

The PM Gati-Shakti is a platform that would address the critical issues of reducing logistic cost of mineral transport substantially

shipping, he said. It is a comprehensive and converged platform of all the related departments of both state and Centre along with other major stakeholders, he added.

mendations of this two-day summit. Joining the inaugural session as guest of honour, Divisional Railway Manager Rinkesh Roy said, "East Coast Railway (ECoR)

is No-1 freight loading zone in the entire Railways. Paradip is the second largest port in terms of the volume handled through the rail link network. The region has a

huge mining and industrial belt." He said that the ECoR is on its path for augmentation of its rail network in Odisha from mining and industrial points to the Paradip port.

Addressing the summit, Shipping Ministry joint secretary (Sagarmala Projects) Bhusan Kumar informed about the converged mechanism put in place for successful implementation of Gati-Shakti projects in

Kumar said that the Ministry of Ports, Shipping & Waterways prioritised improvement of connectivity to more than 50 non-major operative ports through PM Gati Shakti. In this comprehensive port connectivity plan, more than 107 connectivity gaps were identified for abridging port connectivity.

Inland Waterways Authority of India (IWAI) vice chairman Jayant Singh said, "Inland waterways are the low hanging fruit in seamless multimodal transportation. Odisha with its long stretches of water mass across different regions possesses immense potential for development of inland waterways.'

Paradip Port Trust chairman PL Haranadh said that the port in its 56 years of cargo handling service would attain a record 125 MMT annual traffic in the financial year 2022-23. During the Amrit Kal, Paradip will be the port of the millennium by having a capacity of more than 500 MMT by 2047, he said.

'Foreign power' trying to plunder Odisha: Ex-MLA

Bhubaneswar, Nov 15: Senior Biju Janata Dal (BJD) leader Sanjay Das Burma alleged that some 'foreign power' is trying to loot state's mineral resources and also plunder 'Ratna Bhandar' of Lord Jagannath in Puri.

Das Burma, BJD general secretary and former MLA, made the statement while addressing the BJD's Janasampark Yatra at Malasahi in Puri district Sunday. A video of his speech went viral Tuesday creating a murmur in the ruling party as well as in state politics. "All efforts must be made to defeat these forces and foil their conspiracy to loot the wealth of the state," he said.

"Some foreign power has an eye on our wealth. They are trying to loot Odisha's rich mineral resources and (Srimandir) Ratna Bhandar. We have to defeat these elements .. foil their conspiracy," the BJD leader said while appealing to women to foil such efforts.

The former legislator, however, did not name the 'foreign power' and

whom he was referring to. Stating that he was given important positions including ministerial posts by Chief Minister Naveen Patnaik, the BJD leader said that he was made the government deputy chief whip on his first election to assembly and later made BJD's youth wing president.

"However, today the situation has changed. Some people think every decision and action taken by them will be accepted by all. A fitting reply will be given to such conspirators," Das Burma said.

The opposition BJP and Congress welcomed Das Burma's statement.

"We have been saying for a long time that Odisha's mineral resources are being looted, but the government did not bother. Now, a ruling party leader is saying the same thing. Thanks to him that the truth is coming out," said state BJP spokesperson Biranchi Tripathy.

The ruling BJD did not comment on Das Burma's statement.



India's population growth slows...

In Odisha, an eastern state, the TFR dropped 21% in only 11 years, between 2008/10 and 2019/21, maybe too fast from the point of view of the government there.

"Odisha may need to relook at the policy framework that promotes a two-child norm." the state's Planning and Convergence Department said in a June note seen by Reuters. The policies discourage exceeding two but do not encourage reaching that number.

The northeastern state of Assam. with its TFR higher than the national average, is still pushing in the other direction. In January, it implemented a policy that made anyone with more than two children ineligible for government jobs and election to local and civic bodies.

"This is the need of the hour to have such a legislation in place, Assam Chief Minister Himanta Biswa Sarma told Reuters.

But such measures have limited impact on fertility, the UNFPA said, citing global experience. "Most such schemes have had only a marginal impact on fertility and in some cases have even been counterproductive," the UN agency said.

"A decision in this regard has been taken by the technical advisory committee constituted by the Government of India and the insurance companies. Guv urged to commute man's jail term

Bhubaneswar, Nov 15: In a first such incident, the Odisha Human Rights Commission (OHRC) has reportedly requested the governor, a constitutional authority, to consider the release of a murder convict serving life sentence exercising his constitutional powers under article 161 of the Constitution of India. The convict, Gopal Das alias Ashok, while studying in Agarpara College in Bhadrak had murdered a fellow student over rivalry during the college elections.

March 19, 1997, a local court in Bhadrak convicted Das and sentenced him to life imprisonment. Das has been in the jail for the last

Meanwhile, his brother Laxmidhar in 2019 approached the OHRC seeking its intervention for the commutation of the life sentence of Das who had by then served 22 years in jail. While hearing the



plea, the commission later recommended Das's name to the State Sentence Review Board for consideration January 6, 2021.

However, the board rejected the recommendation over some technical grounds. The board reasoned that the matter could not be taken for consideration twice within a pe-

Notably, the board had earlier rejected a separate recommendation by the jail authorities due to negative report of the district administration regarding the release of Das in 2020. The convict was reportedly involved in theft case while released from jail for a short period in furlough few years back so the district administration sub-

mitted a negative report. The OHRC in November 2021 sent another recommendation which was also rejected by the board in its meeting held January 12, 2022

So, the commission sent the recommendation to the Principal Secretary to the Governor directing him to place the matter before the governor and submit the action taken report or comments over the issue by December 27, 2022.


Sperm counts decline globally, including India

n international team of researchers has found a sig-Anificant decline in sperm counts over the years in many countries globally, including India.

Sperm count is not only an indicator of human fertility but also that of men's health, with low levels being associated with increased risk of chronic disease, testicular cancer and a decreased lifespan, the researchers said.

The decline reflects a global crisis related to modern environment and lifestyle, with broad implications for the survival of the human species, they said.

The study, published Tuesday in the journal Human Reproduction Update, used data from 53 countries. It includes an additional



seven years of data collection (2011-2018) and focuses on sperm count trends among men in regions not reviewed previously, specifically South America, Asia and Africa.

The data shows, for the first time, that men in those regions share the significant decline in total sperm counts (TSC) and sperm concentration (SC) seen previously in North America, Europe and Australia. The study shows an accelerated post-2000 decline in TSC

"India is part of this larger trend.

In India, due to availability of good data (including 23 estimates in our study one of the countries with the richest data), we have more certainty that there is a strong and sustainable decline, but it's similar globally," Professor Hagai Levine of Hebrew University of Jerusalem in Israel, told PTI. "Overall, we're seeing a significant worldwide decline in sperm counts of over 50 per cent in the past 46 years, a decline that has accelerated in recent years. Levine said.

While the current study did not examine the causes of sperm count declines, Levine pointed to recent research indicating that disturbances in the development of the

reproductive tract during fetal life are linked to lifetime impairment of fertility and other markers of reproductive dysfunction.

"Additionally, lifestyle choices and chemicals in the environment are adversely affecting this fetal development," Levine explained.

"Our findings serve as a canary in a coal mine. We have a serious problem on our hands that, if not mitigated, could threaten mankind's survival. "We urgently call for global action to promote healthier environments for all species and reduce exposures and behaviors that threaten our reproductive health.' Levine said. The scientist noted that a separate study in India should be done, better by following the same population over time.

No let-up in dengue cases in Ganjam dist

4 new cases reported Tuesday, tally now 161

Berhampur, Nov 15: There is no let-up in spread of dengue in Ganjam district as the disease continues to spiral with each passing day. With the addition of four new cases Tuesday, the number of affected persons has gone up to 161 in the district. The new cases have been reported from Kukudakhandi, Buguda, Shergad and Digapahandi blocks. All the four have been admitted to the MKCG Medical College and Hospital here and are undergoing treatment, district health department officials said.

Two of the newly-infected persons have contracted the disease during their stay outside the state. Among them is a 62-year-old man who was working in Chennai and had just returned home in Buguda. Similarly a 20-year-old man working in Surat tested positive for dengue after returning to his native village in Shergad block.

A 40-year old woman of Krupasindhupur village under Kukudakhandi block was suf-



fering from cough and fever. After her blood sample was tested, it turned out to be dengue positive. A 36-year-old youth of Siddheswar village under Digapahandi block is the latest to contract the disease.

CDMO Dr Umashankar Mishra said that health officials are conducting awareness programmes across the district. Pesticides are also being sprayed in all water bodies and drains which are the breeding grounds for dengue-causing Aedes mosquitoes

However, it should be stated here that despite the best efforts of the district administration, the disease is spreading fast.

Villagers warn of Padampur bypoll boycott

Padampur: With the bypoll to Padampur Assembly seat round the corner, residents of Baidapali village have warned of boycotting the election over road connectivity issues. The warning has activated the district administration. PANEL FORMED TO MAINTAIN VIGIL OVER WILDLIFE SANCTUARY

Baripada, Nov 15: Every year, parts of the Similipal Wildlife Sanctuary in Mayurbhanj district face the brunt of forest fires due to human intervention. These wildfires keep on raging for days together and destroy flora and fauna during the summer. This has become a cause of concern for the district administration as well as the sanctuary authorities.

Keeping this development in view, a recently-formed district level fire management committee has included a part of the Similipal sanctuary in its action plan aimed at preventing fires during the summer of 2023. The plan will be put in place from December so that all norms are in order to prevent wildfires from breaking out during the summer months.

As the tourist season is under way, visitors are being thoroughly checked before they enter the sanctuary area. Departmental staff has been pressed into service at different tourist sites inside the sanctuary, Ashok informed

Deputy Director of Similipal Tiger Project, Samrat Goud said that strict vigil is being maintained to prevent the outbreak of forest fires. He added that teams will be kept ready 24x7 to nip in the bud any impending sign of wildfires.

₹60L allocated for three Amrit Sarovar projects

Khandapara, Nov 15: The administration has approved an outlay of ₹60 lakh for excavation of ponds in the Amrit Sarovar scheme to be implemented under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) in three panchayats of Khandapara block in Nayagarh district.

Notably, the groundwater level has been plummeting alarmingly in various parts of the state due over exploitation and the absence of recharging systems. Hence, excavation of new ponds

and renovation of old ones will come handy in conserving water in the monsoon season and recharging the groundwater, it was said.

Officials said, the block administration had earlier sent a proposal to the district administration for digging of 10 Amrit Sarovars (ponds) in Khalisahi, Banamalipur and Shalajharia panchayats. These projects will be executed under MGNREGS.

The district administration has given approval to the three projects. Once the projects are operational, water woes in the three panchavats will decrease considerably, officials said.

Elephant poacher nabbed in Keonjhar

Keonjhar: Forest officials arrested Tuesday a person involved in the poaching of a pregnant elephant in Kalapata reserve forest under Telkoi range in Keonihar district. The accused was identified as Chagulu Patra, a resident of Similipal village. He had allegedly shot arrows at the elephant injuring the animal and leading to its death. "A case (OR-27T/2022-23) had earlier been registered in connection with the jumbo poaching, November 7. One of the accused has been arrested and produced in court. Further investigation into the matter is underway," Keonjhar divisional forest officer (DFO), HD Dhanraj informed. The arrest came two days after the DFO suspended Purnachandra Mohanta, a forester of Talpada section and issued showcause notices to ranger Shivaji Mohan Rao and guard Jharana Sahu for the death of the female jumbo and its unborn calf. They have been asked to respond by Wednesday. Some villagers had gone to Kalapata reserve forest November 7 and found stench emanating from a place. They alerted the forester of Talapada section. Officials rushed to the spot and recovered the decomposed carcass of the female elephant.

Bolangir, Nov 15: Tension ran high Tuesday after officials of the district administration in Bolangir and villagers of Khuntpali affected by Lower Suktel irrigation project were involved in a face-off during an eviction drive. Villagers demanded that issues of their rehabilitation and relocation must be solved before they move out.

Residents of Khuntpali, including women and children staged a road block to prevent the administrative team from entering the village. Sensing the mood of the villagers. officials did not enter and instead held talks with the agitators to diffuse tension.

The villagers questioned the frequent visit of the administrative team without resolving the issues. They informed that they had submitted a seven-point charter of demand to the district collector, but their demands were yet to be met.

Irregularities mar MGNREGS projects



They said officials will be allowed to enter the village only after their demands are fulfilled.

In the demands, the villagers have said that the priest of the village deity should not be evicted till the temple is relocated to a separate place. They alleged that they are yet to get land for construction of new houses despite spending a part of the compensation they had received for displacement from the village. They demanded for homestead land to 12 displaced persons and land for construction of houses to original residents residing at the rehabilitation colony. They also said that clean drinking water facilities, Anganwadi, school, playgrounds and ponds should be set up as part of their rehabilitation.

The face-off led to an impasse at the village. Later, ADM/project director of Lower Suktel irrigation project, Mahendra Mohapatra reached the site and held discussions with the villagers. He urged them not to disrupt work after receiving the compensation amount. The villagers pointed out that over 80 per cent of villagers have already been displaced while 20 per cent still live in the village. SDPO Tophan Bag intervened and assured that only those houses that have been com-

pletely vacated will be demolished. Following Bag's assurances, the administrative team entered the village and demolished the houses that have been completely vacated.

Gloomy Economy

The misplaced confidence of RBI Governor Shaktikanta Das may have made him gloat over the INR strengthening because it went up 63 paise against the dollar one fine day recently. But then it crashed again the very next day. It is obvious India's economy is not really strong. One proof of this is that the RBI is dipping into reserves for survival. The argument that this is being done to cushion the Indian rupee against the volatility fuelled by US Fed's rate hikes and high commodity prices is hardly tenable. The fact that in the past 12 months over US\$ 16 billion reserve has been spent is not a sign of a healthy economy. Multiple repo rate adjustments have debilitated the poor and the middle class. India's foreign exchange reserves dropping to a two-year low should be a matter of concern for the economy as the pace of foreign inflows into the country's markets lessens amid global monetary policy tightening. The rupee has, in a short span of time, gone from one of the world's best performing currencies to one of the worst. It has depreciated 2 per cent versus the dollar since September 21, ranking among the worst-performing emerging market units. Over the time period, it has fared worse than 14 other emerging market currencies. Prior to September 21. the rupee had outperformed many of its peers.

As India is 85 per cent dependent on imports to meet its oil needs, a weakening rupee will make its purchases expensive, further fuelling inflation which has remained above the RBI's upper tolerance band for eight consecutive months. In fact, experts caution that India's economy will grow well below its potential over the next two years, with inflation staying above the mid-point of the RBI's tolerance band despite recent interest rate hikes.

Growth could be faster than many other economies, but so far as job creation is concerned, it would be too slow. This means the hope of pulling millions out of poverty will recede further. This is ominous as India is already ranked as one of the worst in the world in tackling hunger.

Growth is projected to slow down sharply to an annual 6 per cent in the third quarter from 13.5 per cent in the second. It is even likely to decelerate further to 4.4 per cent in the fourth quarter. The median expectation was for 6.9 per cent growth in the 2022-23 fiscal year, slightly above the International Monetary Fund (IMF) and the World Bank (WB) projections of 6.8 per cent. It is now pegged at 6.1 per cent next year.

The deteriorating global economic situation suggests there may be even further downgrades in coming months. India's GDP growth is expected to decelerate to 5.7 per cent in 2022 from 8.2 per cent last year due to higher financing costs and weaker public expenditures. Such a gloomy picture is being painted by none other than the United Nations Conference on Trade and Development (UNCTAD). As the global economic crises worsen further due to Russia's invasion of Ukraine, sanctions against Russia by the West and Russia's retaliatory economic measures, urgent policy corrections are the need of the hour. This is vital for protecting the country's poor and middle class as the UNCTAD's estimates suggest the country's GDP growth is likely to decelerate to 4.7 per cent in 2023.

Without course correction and coordinated multilateral policies such as substantial debt relief and large-scale social welfare measures, the crisis will continue to persist in developing and low-income countries. UNCTAD's prescriptions are multilateral synchronisation of monetary and fiscal policies, a substantial debt-reduction programme for developing and low-income countries, and a massive increase in official development assistance.

Viewed in this perspective, Prime Minister Narendra Modi's claim that "India's economy is expected to grow by 7.5 per cent this year, which will be the highest among the world's largest economies" sounds rather too unre-

India's growth trajectory during the current fiscal may become better than many G20 countries in an economically depressed world. But, the optimism should be tempered given the stark realities of massive unemployment, worsening inequalities and poverty.

■ Cosmeceutical

his is a blend of cosmetic and pharmaceutical which has appeared only in the nineties. It's a well-known term in the pharmaceutical business, which is still most commonly encountered in the USA, but is now increasingly being used elsewhere, and which is moving into more general contexts. It refers to a product which is marketed as a cosmetic, but which contains biologically active ingredients that have an effect on the user. Examples are anti-wrinkle creams, baldness treatments moisturisers and sunscreens. They are causing problems world-wide for regulatory authorities, such as the American Food and Drugs Administration, which must decide when a product crosses the line between being merely a cosmetic and becoming a drug, the latter having much more stringent controls on its development, testing and supply. Much seems to depend on the labelling of the product: one describing itself as a deodorant would probably be classed as a cosmetic, whereas one labelled as an antiperspirant might well be classified as a drug because it claims to close the pores of the skin. More prescription drugs are being sold across the counter; some may soon become "cosmeceuticals" or "nutriceuticals" - active chemicals sold as cosmetics or food (Economist, Apr 1995). Photodamage, the deterioration of skin due to sun exposure and aging, is the biggest market segment for cosmeceuticals (The Scientist, Jan 1998).

Costus

■his Asian spice was well-known in the classical world, but it is comparatively rare today in the West. It wasn't used much in food, as the Greeks and Romans disliked its burning taste, but they appreciated what Pliny called its "exquisite scent" and also used it in medical prescriptions. It is the root of a tall herb, whose botanical name is Saussurea lappa, which even today grows wild only in the highlands of Kashmir. Its name comes to us from Sanskrit through Greek and Latin. Another name for it is putchuk, from a language that's variously suggested as being Telugu, Hindi or Malay. It is recorded in the Anglo-Indian Dictionary Hobson-Jobson of 1886; the authors remarked that it was exported from Bombay and Calcutta to China, where it was used as the chief ingredient in joss sticks. The English herbalist Nicholas Culpeper knew of it under the name of cost or coste: "Being boiled in oil, it is held to help the gout by anointing the grieved place with it". In modern usage, its name has reverted to costus, the Latin form. It is still used as a medical herb in some places, being antiseptic and helpful against asthma and bronchitis, among other things. Its oil is used in perfumery and sometimes in aromatherapy. In the fourteenth century another herb with a similar aroma, from the Mediterranean this time, was introduced to Britain. The English name of the oriental herb was borrowed for it, but as it was often used to flavour ale, it became commonly known as alecost. (Another name was costmary, because it was widely associated with St Mary.) However, that herb's popularity declined after hops appeared on the scene in the early fifteenth century.

INDIA & AN UNENDING WAR

SPECULATION IN SOME DIPLOMATIC AND MEDIA CIRCLES THAT INDIA WOULD ACT AS A PEACEMAKER IN THE UKRAINE **WAR WAS LARGELY BELIED AS THE INDIAN SIDE NEVER BROACHED THE MATTER SERIOUSLY**

n his virtual address to the COP27 at Sharm El-Sheikh, Egypt, November 8, Ukrainian President Volodymyr Zelenskyy said he was open to negotiations with Russia if the latter was focussed on safeguarding Ukraine's territorial integrity, withdrawing from all occupied territories including Crimea, compensating Kviv with war reparations, respecting the UN charter, and bringing to justice perpetrators of war crimes with the promise never to commit such act again.

This was a tall order as a Ukraine fatigue had set in for the Western powers and NATO, bearing them down in supplying Ukraine with military and financial aid. The Biden administration had an important reason in putting Ukraine under pressure to negotiate an end to the war, and that was the midterm polls which have now thrown up unexpected results in the Republicans having come in majority in the House with the Senate taken by the Democrats. Despite Biden's appeal to work with the Republicans. it is very likely that they would be blocking further aid and defence supplies to Ukraine. The EU members are equally worried that come winter, Russia will close its entire gas taps and put the major European economies like Germany, France and Italy to misery.

Putin on the other hand has been playing his cards close to his chest in opting for a withdrawal strategy while continuing his aggressive strikes on Ukraine's infrastructure and utilities, destroying nearly 40% of its water and power supplies besides severely bombarding major cities including Kviv.

It needs to be noted that while Zelenskyy was delivering his address ay COP27, the Indian Foreign Minister was in Moscow, the first time that he was undertaking a bilateral visit since Russia's invasion. EAM Jaishankar met Russian Foreign Minister Lavrov and Deputy PM Manturov (who leads the intergovernmental commission) and discussed a range of issues including currency swap arrangement (which remained undecided), trade, energy, investment, defence, space, nuclear and connectivity. Calling Russia a 'time-tested friend' and qualifying his statement that India's friendship with Russia has been largely advantageous to the Indian people in procuring cheap oil, the Indian Minister had no qualms in saying that all this works out well to India's advantage. On the



While India risks a goodwill deficit among its Western friends on its ambivalent stance on the Ukraine war which could stand to risk its global image, and with China continuing to aggrandise with its eyes on its Western front, the future seems deadly uncertain

 $other\,hand, repeating\,PM\,Modi's\,al$ leged admonition to Putin that this was not the era of war and advising the path of diplomacy and dialogue, India was playing to both sides knowing fully well that Ukraine has been seriously ruffled with India's continuing cheap oil purchases from Russia "at the cost of Ukraine's blood" as Foreign Minister Kuleba had pointed out bluntly. Incidentally, Jaishankar met Kuleba on the sidelines of the ASEAN India Meeting and the EAS Summit in Phnom Penh though the meeting expectedly did not produce any positive outcome.

Speculation in some diplomatic and media circles that India would act as a peacemaker in the Ukraine war was largely belied as the Indian side never broached the matter seriously. Thus an opportunity which India could have used to broker peace and gain goodwill among its Western friends was lost. With the arms chest closing up from US and NATO, Ukraine would have no option but to head for a final 'do or die' push after its takeover of Kherson. This could give a new twist to the war with Russia's withdrawal from one of its key cities where it had a held a referendum to join Russia a month ago. The Russian grouse has been that the Western powers, including NATO, have conspired in defanging Russia's clout on its own border and that had to be countered. On the other hand, the US ploy of bleeding Russia through feeding Ukraine with arms and financial support to continue the war has clearly not worked though Ukraine has had battlefield successes in the recent past and has recovered some ground in the Donbas region, mostly around the Donetsk area.

Interestingly, PM Modi has reached Bali to attend the G20 Summit (Nov 15-16) where India will be handed over the Presidency by Indonesia Dec 1. The main issues being discussed at the G20 would be the Ukraine war, climate change, global economic growth, post-COVID health issues and digital transformation. Xi's meeting with Biden in Bali Nov 14, their first face-to-face meeting since Biden took over as President, hogged headlines. While Biden reiterated USG's 'One China' policy and ruled out the possibility of a new Cold War with China, Xi drew the red line on Taiwan and responded to Biden's accusations of human rights violations in Jinxiang, Tibet and Hong Kong cursorily with, "America had their own democracy while China had theirs." Xi conveyed China's willingness to do business with America (USG's regulations on the Chinese semi-conductor industry with decline of China's property sector and steep decrease in GDP growth have blunted Beijing) in the light of US diversifying global supply lines and embracing India for 'friendshoring'.

This would give India a lead in its economic relations with the US notwithstanding the latter's indirect support for Russia in the war. Jaishankar's meeting with his US counterpart Blinken in the Cambodian capital therefore went off on a good note in view of India's forthcoming presidency of the G20 which has been welcomed by the U.S. Defence Minister Rajnath Singh

in a recent address to the National Defence College said, "We believe in a multi-aligned policy realised through diverse engagements and multiple stakeholders. India does not

believe in a world order where a few are considered superior to others. Targeting China, the Minister talked of "enlightened self-interest" and "strategic morality", predicated on the respect for "the legitimate strategic imperative of all civilized nations". While in Moscow, Jaishankar had added, "We are clearly on the side of peace, respect for international law and support for the UN Charter, we support any initiative that de-risks the global economy and stabilises the global order." India is known for its democratic values though there has been a serious attrition which the global community has well noticed.

No wonder India was rapped on its knuckles in the Universal Periodic Review (UPR) at UNHCR, Geneva Nov 11. In a meeting attended by 130 countries, India was grilled for over three hours on issues ranging from human rights concerns to anti-terrorism mechanisms (UAPA and AFSPA, besides NRC and CAA), treatment of minorities, women and children, and behaviour towards human rights defenders besides lack of transparency in administering the FCRA. India's democracy came under severe criticism from countries ranging from the US, Canada, Mexico to Europe, Africa and even Asian countries such as Malaysia. Pakistan had its way on Kashmir supported by Turkey on the need for peace in the sub-continent.

India needs to therefore strongly take up the cause of the Global South and reiterate its position on the escalating energy and food insecurity and fuel crises which signal a global doomsday with the Ukraine war showing no respite. Quoting Freud in her book, Violent Fraternity, Shruti Kapila gives the example of a family of hedgehogs trying to come together during winter to give each other warmth but falling apart when their skins prick each other. Could it be likened to the European theatre? As Freud says, "The ambivalent but ultimately reversible play between love and hatred causes war but also offers the potential for peace." While India risks a goodwill deficit among its Western friends on its ambivalent stance on the Ukraine war which could stand to risk its global image, and with China continuing to aggrandise with its eyes on its Western front, the future seems deadly uncertain.

Nobody loses when democracy works well

YOU CAN BE A WINNER WITHOUT WINNING AN ELECTION. AND YOU CAN BE A LOSER WITHOUT LOSING AN ELECTION Tlove it when democracy works well and an election goes smoothly - almost perfectly.

But enough about Brazil's national election.

This year's US midterm election went fairly well, despite the usual rumors of votes being dumped, voting machines being manipulated, and dead people voting for the wrong party.

The way I see it, there were more winners than losers. Almost everyone who runs for office. whether in the United States, India or any other country, begins the race as a winner. It takes courage to run for office. You have to put yourself out there and become a punching bag for the other candidates. You have to face the possibility - in many cases, probability - that you will lose the election, perhaps in a landslide. But that itself does not make you a loser. The way I see it, you are only a loser if you fail to get more

than one vote. You are only a loser if the sole person who votes for you is the person staring back at you in the mirror. You are only a loser if you can't get your spouse or kids to vote for you, if your siblings make all sorts of excuses, if your mother says the lines at the polls are too long, and you're going to

lose anyway, so why bother? The election results themselves do not usually make anyone a loser. It's not whether you come first or last that determines if vou're a winner or loser – it's how you ran the race. Did you engage in thoughtful debate or make fun of your opponent's weight? Did you try occasionally to use your brain or merely say something profane? Did you exhibit dignity and grace or spread ideas from a Twitter-verified nutcase?

The way I see it, the US election had many winners on both sides of the aisle. Winners galore. Winners wearing red, winners wearing blue,

winners out the wazoo. But alas, there were some losers

too. Losers who may one day become winners, not by winning elections but by exhibiting the characteristics of winners. What are these characteristics? Well, here are just three:

1. When winners lose an election, they concede gracefully. They congratulate the person who got the most votes. They do not become "election deniers." An election denier is a candidate who, upon losing an election, denies that an election ever took place. "There was an election?" they ask. "It may have looked like an election, but I wouldn't call it an election." Election deniers are different from results deniers. Results deniers are the type of people who look at the numbers on a scale and say, "This can't be true. I didn't gain 5 kg just snacking during Diwali. Someone rigged the scale!

2. Winners have principles and

one of those principles is to tell the truth. They do not pledge to increase employment and then do so by telling so many lies that media organisations are forced to hire more fact checkers. They don't make promises that they don't intend to keep. And they don't make up stories about crowd sizes at their rallies, or whether they were top students in college.

3. Winners don't try to belittle their opponents based on race, ethnicity, gender identity, sexual orientation, religion, disability, economic status, or lack of hair. They focus their energy on their plans to improve the lives of the everyday citizen, not the person who drives a luxury car and complains that the voting places do not have drive-through lanes.

You can be a winner without winning an election. And you can be a loser without losing an election. At least that's the way I see it.

Morbi bridge crash: HC raps Gujarat govt

Ahmedabad, Nov 15: Days after 135 people were killed when a suspension bridge collapsed in Morbi town, the Gujarat High Court Tuesday asked the state government as to why no expression of interest (EoI) was invited for maintenance and operation of the British-era structure and how "largesse" was given to an individual without floating a tender.

The High Court made the observation while hearing a suo motu (on its own) Public Interest Litigation (PIL) on the collapse of the suspension bridge on the Machchhu river on October 30, five days after it was reopened following renovation.

The High Court wanted to know from the state government as to whether a 2008 Memorandum of Understanding (MoU) and a 2022 agreement with Ajanta Manufacturing Private Ltd (Oreva Group) imposed any conditions regarding fitness certification and if so, who was the competent authority required to do so.

The Ahmedabad-based Oreva group had been maintaining and managing the ill-fated suspension bridge. "This (2008) agreement with Ajanta (Oreva Group) is oneand-a-quarter pages agreement, absolutely without any conditions. This agreement is by way of an understanding, largesse of the state for ten years, and no tenders floated, no expression of interest," a division bench of Chief Justice Aravind Kumar and Justice Ashutosh Shastri observed.

The company had informed the Morbi Collector on various dates (four times) in 2020 that until and unless an agreement is executed, it will not commence the repairing work of the suspension bridge, it

Aspiring footballer dies after botched surgery

Chennai, Nov 15: A city-based student who had recently undergone a medical procedure for a knee-related issue, died here Tuesday following multiple organ failure, with her friends and relatives alleging medical negligence.

The Opposition parties lashed out at the government over the incident, even as the latter appealed that the issue should not be politicised. The victim, 17-year old Priya, an aspiring footballer, died at the Rajiv Gandhi Government General Hospital (RGGGH) here, where she was undergoing treatment following a "complication" that arose from a knee-related surgery she underwent recently at a local government hospital at Periyar Nagar in the city, officials said. She was subsequently shifted to RGGGH.

Following disturbed blood circulation, her right leg was amputated and she was under the care of a team of multi-disciplinary experts including Urologist and Orthopaedic in the Intensive Care Unit, they said. Due to the blood flow issue, her kidney, heart and lungs got affected on Tuesday and she breathed her last, they said.

Her friends and relatives later staged a protest, alleging medical negligence at the local hospital and refused to accept her body saying they would do so only after their demand for action against those responsible was met.

Police and medical authorities held talks with them and assured of action, before her mortal remains were accepted by the relatives. An official said two doctors with the local hospital at Periyar Nagar were suspended and indicated they might face criminal action as well. Health Minister Ma Subramanian said Chief Minister M K Stalin has announced an interim relief of Rs 10 lakh to the family of the deceased and job on compassionate grounds for one member

Stone quarry collapse: Eight bodies recovered

Aizawl, Nov 15: A total of 12 people have been confirmed to have died in Mizoram after a large portion of a stone quarry collapsed and fell on them while they were working, officials said Tuesday, adding at least eight bodies have been retrieved so far.

The incident took place Monday noon at Maudarh village in Mizoram's Hnahthial district. An official of the Mizoram Disaster Management and Rehabilitation Department earlier said at least 15 workers were buried alive after a huge portion of a stone quarry of a private company suddenly collapsed when the workers were working in the stone pit.

Gurung said search operations were underway to rescue four more

"Continuance of the search and rescue operation is very difficult after the evening. Big stone boulders and other challenges are causing troubles to the rescuers,' Gurung said.

NHRC notice to Telangana over ragging

Taking suo-motu cognisance, the NHRC said Tuesday that the incident amounted to human rights violations due to the sheer negligence, lack of supervision and inherent failure of the college administration to ensure the safety of the students within its cam-

Eight students of a business school in Hyderabad were arrested in connection with the alleged incident of ragging, including a student being beaten up, which assumed a communal colour after a video of it had gone viral.

The NHRC sought a report from the chief secretary within six weeks regarding the action taken in the incident and the reasons for the prima facie failure of the institution to take adequate steps to prevent ragging in accordance with the UGC regulation.

3 out of every 5 child brides went through teenage pregnancy: Report

New Delhi, Nov 15: Three out of every five child brides, surveyed as part of a study across four states, went through teenage pregnancy, a new report has claimed.

The report by NGO Child Rights and You (CRY) said under-age marriage has a detrimental impact on girls' sexual and reproductive health (SRH) as majority of them become mothers before attaining adulthood. The study was conducted in 40 villages of eight blocks from four districts namely Chittoor, Chandouli, Parbhani, and Kandhamal in Andhra Pradesh, Uttar Pradesh, Maharashtra and

14 to 20). The study claimed that only 16 per cent parents and parents-in-law and 34 per cent of child brides or grooms are aware of the negative consequences of child

Almost every other elderly person turning up to get their details registered for online payment of old age pension has a similar story to share

Srinagar, Nov 15: Thousands of old age pensioners in Kashmir have been running from pillar to post to ensure they continue receiving the meagre government financial support as the payment process has been moved to online

Rahti, a 75-year-old widow from the Saida Kadal area of the city said she has been visiting the Social Welfare Office here for the past three days with all documents to prove her eligibility for the pension that she has been drawing for many

years now.
"We were told to update our de-

tails here or else we would not get our pension," Rahti said. However, she returned home each day without getting her details uploaded to the official network, which would ensure she keeps receiving her monthly assistance of Rs 1,000.

Several district social welfare officers PTI spoke to said pensioners are having to undergo the grind because of insufficient staff at the registration counters.

Rahti said the monthly assistance she receives from the government was all she had to survive on. "The queue is too long, there are so many people here waiting to update their details. I will try again Monday," she said while



heading home after another day

of efforts ended in vain. Ghulam Rasool from the Bemina area of the city said the procedure was cumbersome. "I have a disability which is why I cannot work. This pension is my only sustenance. I was told to get a disability certificate from the chief medical officer (CMO)," he said.

Rasool said he would be lucky if he could get the disability certificate in just two visits to the CMO's office. Mughali, a frail looking elderly woman hailing from a village in Ganderbal, was upset as she was turned back from the registration counter after waiting for several hours in the queue.

She was told to get an age certificate from the block medical officer (BMO). "Khabar su kati chu behwaan (wonder where the BMO office is)," Mughali said as she left the premises

Among other changes brought to the pension scheme, a woman receiving widow pension will have to get an unmarried certificate every three years to be eligible for the monetary assistance.

While the director of social welfare did not respond to calls, several district social welfare officers said there was insufficient staff at the registration counters. Many applicants do not have all documents needed to register for online transfer of pension.

New Delhi, Nov 15: A Delhi court Tuesday granted regular bail to actor Jacqueline Fernandez in a Rs 200 crore money laundering case involving conman Sukesh Chandrashekar, saying the fact that the accused was not arrested during the investigation makes it a case for grant of bail.

Special Judge Shailendra Malik granted the relief on the condition that the accused will not leave the country without the court's prior permission, and directed her to join the investigation as and when asked by the ED.

"However without expressing much on the merits of the matter which of course would be decided during the trial, it is vet to be examined if there was a knowledge, intention or connection of applicant in taking those gifts and of proceeds of crime in this case. In that sense I find that accused/ applicant is entitled to relief of bail, more particularly when she was not arrested during the investigation,' the judge said



"In the present case accused/applicant being a woman having been not arrested by the ED in facts and evidence of present case, to my mind is certainly entitled for exemption of section 45 (of Prevention of Money Laundering Act) on account of her being woman," he added.

The court noted that in December last year, when Fernandez was stopped before taking a flight to Muscat, she was not served with any notice requiring her to appear before the ED, and before that she had already appeared during the investigation on two occasions.

New Delhi, Nov 15: Fifty-one former and sitting parliamentarians face Prevention of Money Laundering Act cases lodged by the Enforcement Directorate, the Supreme Court has been informed.

Police officials are also trying to get in touch with the accused's friends and will probe whether he was in relationship with multiple women after killing Walkar or he was cheating on her when they were together."We will approach some of his friends whom he met before being in relationship with the woman," the official said, adding his social media account is also being analysed to get details about their common friends.

New Delhi, Nov 15: India climbed two spots to rank eighth out of 63 in the Climate Change Performance Index (CCPI) 2023, thanks to its low emissions and the increasing use of renewable energy

The report was published on Monday by three environmental non-governmental organisations that track climate performance of the European Union and 59 countries, which together account for over 92 per cent of the greenhouse gas (GHG) emissions in the world.

The rankings by Germanwatch, NewClimate Institute and the Climate Action Network are based on how well the countries are doing to halve their emissions by 2030 --

an essential aspect to keep the 1.5degree Celsius goal within reach and prevent dangerous climate change. The CCPI, which has been published since 2005, aims to enhance transparency in international climate politics and it enables comparison of individual countries' climate protection efforts and progress.

The report leaves the first three places empty as "no country performed well enough in all index categories to achieve an overall very high rating". It puts Denmark in fourth place, followed by Sweden

India earned a high rating in the GHG Emissions and Energy Use categories, while it got a medium rating in Climate Policy



and Renewable Energy sections. China, which is the world's biggest polluter now, fell 13 places to 51st in this year's CCPI and received an overall very-low rating due to plans for new coal-fired power plants

The US rose by three ranks to the 52nd place. Iran (63rd), Saudi Arabia (62nd) and Kazakhstan (61st) fared the worst. The report said India is "on track" to meet its 2030 emissions targets, compatible with a well-below 2-degree-Celsius scenario. "However, the renewable energy pathway is not on track for the 2030 target," it said.

Since the last CCPI, India has updated its Nationally Determined Contribution (NDC) and announced a net-zero target for 2070. Net zero means achieving a balance between the greenhouse gases put into the atmosphere and those

The NDCs are national plans to limit global temperature rise to well below 2 degrees Celsius, preferably to 1.5 degrees Celsius in accordance with the Paris Agreement. In August, India released its updated NDCs and now stands committed to reducing emissions intensity of its GDP by 45 per cent by 2030 from the 2005 level.

It aims to achieve about 50 per cent cumulative electric power installed capacity from non-fossil fuel-based energy resources by 2030. These NDCs are, however, contingent on delivery of finance

The G-20 draft statement also noted there were different views on the situation and sanctions against Russia, saying that the G-20 was not the forum for resolving security issues.

Russian Foreign Minister Sergey Lavrov, who led the Russian delegation to the summit, denounced the Biden administration push to condemn Moscow

In a video address to the summit, Zelenskyy joined Biden in trying to persuade the G-20 to further isolate Russia diplomatically and economically, despite a souring global financial outlook that has tested many nations' resolve.

Zelenskyy reiterated 10 conditions for ending the conflict that began in February, among them a complete withdrawal of Russian troops and full restoration of Ukrainian control of its

The European Council president, Charles Michel, also urged other global powers to intensify pressure on Russia. But it was unclear how many nations would embrace the relatively tough language in a final statement.

At the summit, Biden met with Turkish President Recep Tayvip Erdogan, who played a pivotal role this summer in brokering a deal to open up Ukrainian grain exports to ease global food shortages.

Russia rains missiles across Ukraine cities

Kviv/Kherson, Ukraine, Nov 15: Russia rained missiles on cities across Ukraine Tuesday in a salvo of strikes that follow its humiliating withdrawal from Kherson, even as signs grew that its retreating forces were pulling even further back from the Dnipro River in the south.

Air raid sirens blared and explosions rang out in nearly a dozen major cities after one of the biggest volleys of missiles so far, following a pattern in recent weeks of Moscow lashing out far from the front after battlefield losses.

In the capital Kyiv, flames poured out of a five-storey apartment block, one of two residential buildings the authorities said had been struck there. Other strikes or explosions were reported in cities from Lviv and Zhytomyr in the west to Kryvy Rih in the south and Kharkiv in the east. Regional officials reported some of the attacks had knocked out electricity supplies.

The widespread attacks came four days after Russian troops abandoned Kherson city in the south, the only regional capital Moscow had captured since its invasion,

Putin declared it an eternal part of Russia. Russia had said last week its troops would occupy positions that were easier to defend on the opposite bank of the Dnipro River. But video images filmed in the town of Oleshky, across a collapsed bridge from Kherson, appeared to show Russian forces had abandoned their bunkers there too. Further east, Russian-installed administrators said they were pulling out civil servants from the region's second biggest city, Nova Kakhovka, located on the river bank next to a huge, strategic dam.

Natalya Humenyuk, a Ukrainian military spokesperson, said Moscow appeared to be repositioning its artillery 15-20 km (10-15 miles) further from the river, to protect its guns from Ukrainian counterstrikes.

Amid tensions with China, Taiwan shows off military drones

Taichung (Taiwan), Nov 15: Taiwan displayed its self-developed drone technology Tuesday, amid rising concerns over China's threats to use force to assert its claim to the self-governing island republic.

The National Chung-Shan Institute of Science and Technology, which develops military technology, offered a rare look at the Chien Hsiang drone designed to destroy enemy radars, and other unmanned



combat aerial vehicles.

A dozen of the single-use drones, officially termed loitering munitions, are carried on a truck. Launched with a built-in rocket, they are guided by a propeller engine before crashing into their targets.

Any country that is "confident in itself" will come up with strategies and develop defence technologies, said Chi Li-ping, director of the institute's Aeronautical System Research Division.

Unmanned combat aerial vehicles are "a future trend", Chi said. "This is why we are doing research about it and laying out some strategies."

Taiwan's army began taking delivery last month of the first of 100 helicopter drones ordered from the institute. Chi emphasised their importance in relaying images to the army's command and communication systems for analysis

and forwarding to combat units. Taiwan has also developed the Teng Yun, which resembles the American MQ-9 Reaper unmanned aerial vehicle and can stay aloft for up to 24 hours. China, meanwhile, has forged ahead with developing its own drones, some models of which have been exported.



The FCDO note reads: "His Majesty's Treasury issued an amendment to the UK's 'High Risk Third Countries' list 14 November 2022 through a Statutory Instrument. The amendment removes Pakistan from the list in accordance with the decision taken by the Financial Action Task Force (FATF) 21 October 2022.

"The FCDO recognises the progress Pakistan has made to ঽ improve money laundering and terrorist financing controls.

ONGC Videsh to retake Sakhalin-1 stake

New Delhi: ONGC Videsh Ltd, the overseas arm of stateowned Oil and Natural Gas Corporation, has submitted an application to Russian authorities to retake a 20 per cent stake in the Sakhalin-1 oil and gas fields in the far east region of the country, the company said. Russian President Vladimir Putin last month disbanded Exxon Neftegaz - a regional subsidiary of US super major ExxonMobil - as operator of the Sakhalin-1 and transferred the project and all of its assets and equipment to a new operator. The other former foreign shareholders in the project - Japan's Sodeco consortium and ONGC Videsh have to apply to the Russian government to regain their shareholdings in the project. "ONGC Videsh Board in its meeting held October 18, 2022, has approved submission of its consent to claim the company's right in Sakhalin-1." ONGC said in its notes to a stock exchange filing.

Hero Electric in pact with NIDEC Japan

Nine Russian banks open special vostro A/Cs for trade in ₹

New Delhi, Nov 15: As many as nine special vostro accounts have been opened with two Indian banks after permission from the Reserve Bank of India to facilitate overseas trade in rupee, a top government official said Tuesday.

Sberbank and VTB Bank -- the largest and second-largest banks of Russia, respectively -- are the first foreign lenders to receive the approval after the RBI announced the guidelines on overseas trade in the rupee in July.

Another Russian bank Gazprom - which does not have its bank in India - has also opened this account with Kolkata-based Uco Bank.



"Nine accounts have been opened. One in Uco Bank, one in Sber, one in VTB and 6 with IndusInd Bank. These six are different Russian banks," Commerce Secretary Sunil Barthwal told reporters here.

The move to open the special vostro account clears the deck for settlement of payments in rupee for trade between India and Russia, enabling cross-border trade in the Indian currency, which the RBI is keen to promote.

The RBI has allowed the special vostro accounts to invest the surplus balance in Indian government securities to help popularise the new arrangement. UCO Bank already has a vostro account-based facility in Iran. Gazprombank, or GPB, is a privately-owned Russian lender and the third-largest bank in the

country by assets. Last month, the RBI and finance ministry asked the top management of banks and representatives of trade bodies to push export and import transactions in the rupee. They want banks in India to connect with their foreign counterparts for opening special rupee vostro accounts to facilitate crossborder trade in the Indian currency rather than the popular mode

of the US dollar. On when the rupee trade will begin with Russia, the secretary said there is a process involved in it and hopefully it would materialise soon. Barthwal said he held a meeting with officials of UCO Bank, RBI and the Department for Financial Services and discussed ways to promote rupee trade.

After a see-saw session, the 30share BSE Sensex rose 248.84 points or 0.40 per cent to settle at 61,872.99 -- surpassing its previous closing peak of 61,795.04 on November 11. During the day, the index witnessed a high of 61,955.96 -- its 52-week intraday high - and a low of 61,436.90.

The broader NSE Nifty advanced 74.25 points or 0.41 per cent to finish at 18,403.40.

PowerGrid topped the Sensex gainers' chart, rising 2.20 per cent, followed by ICICI Bank, Bharti Airtel, UltraTech Cement, SBI, Dr Reddy's, Titan, M&M and HDFC

In contrast, Bajaj Finserv, ITC, Reliance, Sun Pharma and Nestle India were among the laggards, shedding up to 0.76 per cent.

midcap gauge climbed 0.08 per cent and smallcap index ended marginally higher by 0.01 per cent.

Budget may tweak capital gains tax regime

New Delhi, Nov 15: The Budget may tweak capital gains taxes levied on equity, debt and immovable property to bring parity in varied tax rates and holding period, a senior official said.

Explaining the rationale, the official said there needs to have an alignment in tax rate and holding period for all the asset class. Changes in capital gain tax expected in Budget, the official said. The Budget for 2023-24 fiscal would be presented in Parliament February 1, 2023.

When asked about possible tinkering in capital gains tax, Central Board of Direct Taxes (CBDT) Chairman Nitin Gupta said: "It's part of budget process, can't divulge." Under the Income Tax Act,

gains from sale of capital assets both movable and immovable - are subject to 'capital gains tax'. The Act, however, excludes movable personal assets such as cars, apparels and furniture from this tax.

The official said the current capital gains tax structure is 'complicated' and hence needs a relook.

"We are looking at the suggestions that have come in from stakeholders," the official added. Depending upon the period of holding an asset, the long-term or shortterm capital gains tax is levied. The Act provides for separate rates of taxes for both categories of gains. The method of computation also differs for both the categories.

Currently, long term capital gains on shares is taxable at 10% when holding period exceeds 1 year.

New Delhi, Nov 15: India's top oil and gas producer ONGC reported a 30 per cent fall in September quarter net profit after the government brought a new tax on windfall profits arising from a spurt in international energy prices.

Net profit of ₹12,825.99 crore, or ₹10.20 a share, in July-September 2022-23 is compared with ₹18,347.73 crore, or ₹14.58 per share net profit in the same period a year ago, Oil and Natural Gas Corporation (ONGC) said in a statement.

Profit fell 15.6 per cent over the preceding June quarter when it had reported ₹15,205.85 crore net profit

Net profit fell despite the company's gross billing for crude oil it produced soaring 37.7 per cent to USD 95.49 per barrel in July-September from USD 69.36 a barrel a vear back

State-owned ONGC sells crude oil, which is refined at refineries to produce petrol, diesel and other petroleum products, at international benchmark rates which soared following the Russian invasion of Ukraine.

Top ad agency tells clients Twitter is now 'high-risk'

San Francisco, Nov 15: As several advertisers pause spending on Twitter, GroupM, part of WPP which is the world's biggest ad company, is reportedly telling its clients that buying ads on the platform is now a 'high-risk' venture. According to Platformer, GroupM with \$60 billion in annual media spend is concerned about Elon Musk's takeover of Twitter.

"Given the recent senior departures in key operational areas (specifically Security, Trust & Safety, Compliance), GroupM have updated Twitter's brand safety guidance to high risk," the company reportedly told clients in an internal Slack message.

"While they understand that our policies remain in place, they feel that Twitter's ability to scale and manage infractions at speed is

Turin, Nov 15: Novak Djokovic beat Stefanos Tsitsipas for the ninth straight time by 6-4, 7-6(7-4) in the players' opening match at the ATP Finals. Djokovic has beaten Tsitsipas in his third straight tournament following wins in Astana, Kazakhstan and at the Paris Masters.

Good news for Novak Djokovic is set to be granted a visa to play in next year's Australian Open despite his high-profile deportation in January. The Australian Broadcasting Corp Tuesday said it had confirmed newspaper reports that the immigration minister had overturned a potential three-year exclusion period for Djokovic.

The Australian Border Force has previously said an exclusion period could be waived in certain circumstances — and that

each case would be assessed on its merits. Immigration Minister Andrew Giles' office declined comment on privacy grounds, meaning any announcement on Diokovic's visa status would have to come from the 35-year-old Serbian tennis star.

Djokovic wasn't allowed to defend his Australian Open title this year after a tumultuous 10-day legal saga over his COVID-19 vaccination status that culminated with his visa being revoked on the eve of the tournament.

Djokovic arrived at Melbourne Airport as the world's top-ranked tennis player with a visa he'd obtained online and what he believed to be a valid medical exemption to the country's strict laws for unvaccinated travelers because it was endorsed by Tennis Australia and the government of Victoria state, which hosts the tournament.

Confusion reigned, generating global headlines. As it transpired, that medical exemption allowed him entry to the tournament, which required all players fans and officials to be vaccinated for the coronavirus, but not necessarily to enter the country. It was rejected by the Australian Border Force.

Alex Hawke, Australia's immigration minister at the time, used discretionary powers to cancel Djokovic's visa on character grounds, stating he was a "talisman of a community of anti-vaccine sentiment.'

Australia has had a change of government and changed its border rules this year and, since July 6, incoming trayelers no longer have to provide proof of COVID-19 vaccinations. That removed the major barrier to entry for Djokovic.

It allowed him to apply to new Immigration Minister Andrew Giles to reconsider his visa status. In his favor, Diokovic left Australia quickly after his visa was revoked and has not publicly criticized Australian authorities.

As the Department of Home Affairs website explains, applicants in Djokovic's circumstances must explain in writing to Australia's border authorities why the exclusion period should be put aside — "you must show us that there are compassionate or compelling circumstances to put aside your re-entry ban and grant you the visa.'
