

SC to hear plea on Morbi today

New Delhi, Nov 20: The Supreme Court is scheduled to hear Monday a plea seeking the constitution of a judicial commission to probe the Morbi bridge collapse incident in Gujarat which claimed over 130 lives. A bench of Chief Justice DY

Chandrachud and Justice Hima Kohli will hear the PIL filed by advocate Vishal Tiwari, which said that the accident depicted the negligence and utter failure of the authorities. On November 1, Tiwari had mentioned the matter for urgent listing, and the top court had said it would take up the matter soon.

According to reports, the death toll in the collapse of the Britishera bridge October 30 on the Machchhu river in Morbi in Gujarat has gone up to 134.

"From the past decade, various incidents have taken place in our country wherein due to the mismanagement, lapse in duty, and negligent maintenance activities, there have been cases of huge public casual ties which could have been avoided,' Tiwari has said in his PIL.

The more than a century-old bridge, located around 300 km from state capital Gandhinagar, had reopened after extensive repairs and renovation. It was crammed with people when it collapsed around 6.30pm October 30.In his plea, Tiwari has sought the constitution of a judicial commission under the chairmanship of a retired judge of the apex court to initiate a probe in the matter.

The plea has sought directions to the states to form a committee to survey and conduct assessment risk of old and risky monuments and bridges to ensure environmental viability and safety.

It has also sought a direction to the states to constitute a construction incident investigation department so that fast and prompt probes can be done whenever such incidents occur.

New Delhi, Nov 20: The UN climate summit in Egypt concluded Sunday with a landmark decision to establish a fund to address loss and damage, but the outcome on other crucial issues such as India's call for phasedown of all fossil fuels reflected little progress.

India termed COP27 "historic" for securing an agreement on establishing a fund to address loss and damage due to climate change-induced disasters, saying "the world has waited far too long for this".

On the establishment of a work programme on climate action in agriculture and food security, Union Environment Minister Bhupender Yadav said the responsibilities to reduce emissions should not be shifted to smallholder farmers.

'For India, there were many positives to be drawn from COP27. The most significant for us was the inclusion of sustainable lifestyle in the Sharm El-Sheikh Implementation Plan. 'It is Hon'ble Prime Minister

The success of the talks hinged on progress on this track. Shooting at US gay nightclub kills five

Colorado Springs, Nov 20: Five people were killed and 18 injured in a shooting at a gay nightclub Saturday night in Colorado Springs, Colorado, police said.

A suspect was in custody and was being treated for injuries after the attack at Club Q, Colorado Springs police Lieutenant Pamela Castro told a news conference.

Police got the initial phone call just before midnight about the shooting, Castro said, adding that upon arrival, officers located one person who was believed to be the suspect inside the club.

She did not give any information

on the motive for the attack and declined to say what kind of firearm

was used in the shooting. In its Google listing, Club Q describes itself as an "adult-oriented gav and lesbian nightclub hosting theme nights such as karaoke, drag

Kolkata, Nov 20: Miracles do occur and the Baral family from Puri will certainly agree. An octogenarian, presumed killed by the super cyclone that lashed the Odisha coast 23 years ago, has been reunited with his family.

After the cyclone that left over 10,000 people dead in Odisha, Kritichandra Baral landed up



in Visakhapatnam, Andhra Pradesh. He had lost his memory and occupied a portion of a pavement in the port city.

AJ Stalin, who was then a corporator of Greater Visakhapatnam, took pity on the man and stopped near him every day to provide food. On hearing Stalin's car stop, the man would walk up and accept the packet of food before returning to his corner on the pavement. This went on for several years.

One afternoon, the corporator stopped his car as usual and also honked but the man didn't arrive.

Stalin got out and after a search found the man. He was ill and unable to move. This was in 2012.

Stalin then got in touch with the Missionaries of Charity (MOC) and requested them to take care of the man. After necessary police clearance, the MOC took charge and Baral's health condition improved. Despite all efforts, his memory could not be revived though.

The man would at times utter the word Srikakulam, the name of a city and district in Andhra Pradesh, though. As Baral got stronger, the MOC shifted him to a centre near Srikakulam. He would accompany the missionaries when they went out to the villages. The MOC had hoped that somebody would recognise him there but this did not happen.

"A couple of days ago, I received a call from the MOC. In the past,

"Baral has three sons. One of them has lost his eyesight. The two others were dumbstruck when they saw their father's photograph and then started weeping. They are a well-to-do family and said how their father went missing after the cyclone and was presumed dead," said Ambarish Nag Biswas, secretary, West Bengal Radio Club





and Hospital (SCBMCH) in Cuttack and other medical college and hospitals (MCHs) of the state during a high-level meeting held at the Lok Seva Bhawan here Sunday.

In the meeting, Health and Family Welfare (H&FW) secretary Shalini Pandit outlined the details of the quality check, process of procurement, and supply of medicines to the patients by Odisha State Medical Corporation Limited (OSMCL) through Niramaya counters at government health facilities. The issues relating to demand for specific brand medicines raised by a number of kidney patients were also discussed in the meeting.

Deliberations in the meeting showed that the medicines required during the kidney transplant surgery and post-transplant treatment were being supplied free of cost at Niramaya counters. The quality of the medicines was thoroughly tested in NABL-accredited laboratories before being procured and supplied to the hospitals, it was learnt.

OSMCL followed a robust method of online procurement, transparent quality test and purchase.

Data showed that kidney transplant started at SCBMCH in March 2012. As many as 187 successful transplantations have so far been conducted at the SCBMCH. Currently, about 120 post-transplant patients were under medication. Out of them, around 75 per cent (90 in absolute numbers) were taking the medicines supplied through OSMCL, said the official

"Only around 30 patients demanded medicines of specific brand from private medicine stores raising a baseless complaint that the medicines supplied by OSMCL had side effects. The medical experts present in the meeting apprised that the same medicine supplied by OSMCL for kidney patients was also being used by around 400 patients under critical care in other departments like Nephrology, Rheumatology and Dermatology," the official pointed out.

UGC set to unveil framework for 4-year UG programmes

New Delhi, Nov 20: The University Grants Commission (UGC) has finalised the framework for the fourvear undergraduate programme (FYUGP) that will be implemented in all higher education institutions from the upcoming academic session 2023-24

According to the UGC, next week, these rules for four-year undergraduate courses will be shared with all universities across the country.

Besides all 45 central universities, the FYUGP will also be implemented in most of the state and private universities from the next academic session. Apart from this, many deemed universities are also going to give consent to implement the programme.

From 2023-24, where all new students will have the option to opt the four-year undergraduate courses, the FYUGP would likely to get the UGC's approval for old students as well. This means that the students who have taken admission in normal three-vear undergraduate courses this year may also get an opportunity to join the four-year degree programme from the

next session. According to the UGC, a four-vear undergraduate course will be provided for all students, but students

ACCORDING TO THE UGC, A FOUR-YEAR UNDERGRADUATE COURSE WILL BE PROVIDED FOR ALL STUDENTS, BUT STUDENTS WILL NOT BE FORCED TO OPT IT. IF A STUDENT WISHES, HE CAN CONTINUE WITH THE THREE-YEAR

UNDERGRADUATE COURSE will not be forced to opt it. If a student wishes, he can continue with the three-year undergraduate

course. According to UGC chairman M. Jagadesh Kumar, the complete scheme of four-year undergraduate courses will be made



public soon.

The UGC chairman has said that students already enrolled in universities will also get an opportunity to be a part of four-year undergraduate courses. "Such students who are in first or second year, if they wish, they can also be provided with the option of fouryear undergraduate courses. However, it will start only from the new session starting next year i.e. 2023-24.

The UGC will also give freedom to various universities to make some rules and regulations. "Necessary rules can be fixed in this regard in the academic council and executive council of universities. If the university wishes, students studying in the final year can also be given the opportunity to be a part of 4-year undergraduate courses," he added.

Explaining the reasons for these important changes, the UGC chairman said that if only new students

Expedite new rly line work: Minister Sahu to Vaishnaw

Bhubaneswar, Nov 20: Tukuni Sahu, Minister of Commerce and Transport Department wrote a letter to Union railway minister Ashwini Vaishnaw Sunday demanding sanction of new railway line between Bargarh and Nuapada, via Padampur.

In the letter Minister Sahu said "I have received a memorandum from the people of Padampur submitted to CM Naveen Patnaik, requesting to sanction the important new railway line between Bargarh and Nuapada, via Padampur"

"With reference to the above new line, from Bargarh Station to Nuapada Rd Station, Dated 15.12.2018, Minister Dharmendra Pradhan in a public meeting announced that Central Government has sanctioned the project and same was also highlighted by the cabinet Minister in his social media account."

It may be noted that since the year 2018, CM Naveen Patnaik and our government have been requesting Ministry of Railways to sanction the important railway line between Bargarh and Nuapada, via Padampur. The project has a Rate of Return (RoR) of 17.31 per cent as per study undertaken by East Coast Railway and communicated to Ministry of Railways vide letter Dated 11.01.2019.

Minister said that this railway project can offer an important communication link to the people of the two districts of Odisha and act as a potential catalyst for rapid economic development of Western Odisha. With this new line, the Western Odisha region will get a shorter and quicker connectivity with the coastal Odisha through the

Khurda - Balangir line. However, contrary to the above announcement by Dharmendra Pradhan, Ministry of Railways in 2019 communicated that the proposed new line has been shelved as it didn't appear to be financially viable, despite the high RoR, which is much beyond the requirement for approving a new line.

approving a new line. Further, vide letter Dated 10.10.2019, railway board asked the state government to contribute free land and RR cost for land acquisition for considering the project. And on this request, CM approved not only free land for the entire project (Private, Government and Forest Land) but also pledged Rs 300 crores towards construction of the project, so that it becomes even more lucrative for Indian Railways to sanction the project. The same has been communicated to Ministry of Railways.

Therefore, in the interest of the people of Odisha, I would request you to reconsider the decision of your ministry and sanction this very important railway line and entrust East Coast Railways to begin the land acquisition process and start construction work expeditiously.

The proposal for a loss and damage finance facility was put forward by the G77 and China (India is part of this group), least developed countries and small island states. Vulnerable countries had said that they would not leave COP27 without it.

The conference agreed to set up a 'transitional committee' to decide how the money will be provided and who will contribute to the fund. Its recommendations will be discussed at COP28 next year.

The hope at COP27 was to include a phasedown of all fossil fuels, including oil and gas, as pro posed by India and backed by many developed and developing countries including the EU and the US, but the final agreement did not essentially build on what was agreed upon in COP26. Negotiators said intense discussions took place on the matter late into Saturday night but it could not find a place in the agreement. Many countries seemed dissatisfied with the final package but chose not to intervene as it would have risked the loss and damage deal that poor and vulnerable nations wanted for long. A number of parties rued the agreement leaving out the call for peaking of emissions before 2025 and the weakening of language on the transition to green energy.

Choice overload can sometimes lead to decision paralysis

t's been a long day. Your partner messages you: "let's just order in, I don't feel like cooking". With a sense of relief, you open your usual takeaway app and start

your usual takeaway app and start scrolling through the many restaurants and dishes available. Thai, pizza, burgers, Korean,

Lebanese... oooh this one has free delivery! Hmm, but they're far away and I am famished... Soon that sense of relief is replaced by overwhelm and inability to decide what to order. And your partner is not much help either!

Sound familiar? What you are experiencing is called choice overload. This can sometimes go as far as leading to complete decision paralysis (when you give up and make a toastie instead) and ultimately leads to an overall reduced satisfaction with the choices we make. Thankfully, marketing and psychology scholars have studied this phenomenon for years and can provide tips to make your life

a little easier. But first, we need to

understand it to fix it.

In the dinner scenario above, "choice set complexity" – how choices are presented, how many options there are, how different the options are in their characteristics, how much we already know about each option – is the culprit.

There are simply too many things to consider making the most optimal choice: cuisine, delivery time, delivery costs, distance, healthy or indulgent, and so on. What seems a simple decision at first glance, soon turns into quite a complex one. With people making approximately 200 choices a day when it comes to food alone, you can easily relate to the fatigue our brains

feel at the end of a day. Being presented with yet another complex and multifaceted decision will lead to cognitive overload: it means your brain simply doesn't have the cognitive resources (brain power) to consciously process all the options and consider all the information needed to make an optimal choice.

WITH PEOPLE MAKING APPROXIMATELY 200 CHOICES A DAY WHEN IT COMES TO FOOD ALONE, WE CAN EASILY RELATE TO THE FATIGUE OUR BRAINS FEEL AT THE END OF A DAY

As a matter of fact, our brains are rather limited in the amount of information they can process consciously at any given time.

Especially if a scenario is combined with high decision task difficulty – when there are time constraints (kids need to be in bed soon), we are likely to be held accountable (buying a wine for dinner at our boss' rather than for ourselves), or potential losses are

significant (buying a house) – it is no wonder the brain blows a fuse trying to make the most optimal decision. And therein lies the problem and the solution: you don't always have to make the optimal choice. What's wrong with "good enough"?

Expectation-disconfirmation – the expectation that the perfect choice must exist if so much choice is available to you – is seated in the idea that people tend to want to optimise results, rather than satisfice. It is like striving for happiness in life rather than contentment. Another reason you may experience choice overload is because you explicitly don't want to put effort into making the decision.

This is called minimising of cognitive demand goals (for example, forfeiting deciding what to cook to ordering take out).

So after a long day, when you have no energy left, accountability is low, and the potential consequences are minor, consider satisficing your choice: Reduce the choice task to a binary one immediately. Only give yourself the choice of two options, randomly chosen, or the first that came to mind. For example, before you open a delivery app, decide you have to choose between the first two cuisines that pop up.

Stick with your first choice. Don't waiver: Once you've decided, commit to your decision. Do you really want to spend all that time and effort reanalysing and going back and forth when the result is of minor consequence?

Of course, not all choices are without grave consequences. When you are buying a house, you do want to consider all information needed to make an optimal decision.

Choice overload is likely because your brain is trying to connect all the dots consciously. So what do you do then? With a few simple tricks, even the luxury problem of what to order for dinner can be eliminated, now, you have some brain space left to agree on what to watch on Netflix as you dig into your pizza... or laksa. PTI

A standing committee of the Zilla Parishad (ZP) which conducted an investigation found preliminary evidences of corruption. The committee found that machines were rampantly used in the MGNREGS projects instead of manual labour while information plaques were not set up near the

project sites After reports of irregularities appeared in various sections of the media, the Forest department tried to conceal the evidences by redoing some of the works, it was alleged. "After the irregularities surfaced, records and cash books are being checked. If need arises, ZP will recommend an investigation

by an expert team," said Debasish Patnaik, chairperson of the Zilla Parishad. Reports said, three check dams and over 90 stone-packed dykes have been constructed at a cost of ₹2.5 crore funded by CAMPA and MGNREGS in Gochha reserve for-

est under Odagaon range. However. there were media reports about massive irregularities in the projects. Thereafter, Congress demanded an investigation into the scam.

People's representatives had raised the issue at the meetings of Panchayat Samiti and Zilla Parishad. They all pressed for an impartial probe into the irregularities.

Block chairperson Loknath Sahoo had accepted a proposal August 19 for a Vigilance probe while Patnaik had September 14 decided that the matter will be investigated. However, days rolled on, but no steps were taken. It has been alleged that some leaders are involved in the scam and hence there was delay in conducting a thorough probe.

Later a standing committee of the Zilla Parishad comprising vicechairperson Bishnupirya Behera, members Saroj Ransingh and Sanjukta Padhiary, chief executive officer Subash Chandra Ray, assistant conservator of Forests Himansu Sekhar Muduli, ranger Asish Kumar Kahnr and forester Sandhyarani Nayak carried out inspection of the projects and unearthed the irregularities.

The cash book records, files and MB books of all such works will be checked and an expert team may further look into the matter. DFO Khyama Sarangi said that after the irregularities surfaced some projects had been redone.

Sonepur BDO gets Lokayukta notice

Sonepur; Nov 20: An investigation has detected irregularities in allotment of Pradhan Mantri Awas Yojana (PMAY-Gramin) in Tarada panchayat under Binika block of Subarnapur district. The Lokayukta has slapped a notice to the BDO and two beneficiaries of PMAY in this regard.

According to the report, Brundaban Mishra, a youth of Phulamuthi village had filed a written complaint about irregularities in the PMAY at the Lokayukta in August this year. The Lokayukta issued notices



November 16 to the Binika BDO and two PMAY beneficiaries - Ugrasen Mishra and Hadu Mishra of Phulamuthi village – to submit their replies within six weeks. The next hearing of the case will be

held December 27.

It was alleged that some government officials working in the Panchayati Raj department are involved in the PMAY scam. Sources said many rich and affluent persons have been allotted PMAY housing units in the 2020-21 fiscal. However, scores of poor people eligible to get houses have been deprived of their benefits.

Brundaban had written several times to the Subarnapur Collector and the Vigilance department about the PMAY irregularities in Phulamuthi village. However, officials of the block administration after probing the matter did not

find any.

Later, Brundaban wrote to the RDC northern range in Sambalpur regarding the irregularities. The RDC had directed District Collector Sunil Narwane to conduct a probe. Sonepur BDO Soumyaranjan

Swain, Binika tehsildar Mukteswar Panigrahi and DRDA APD Alok Mishra looked into the matter and found irregularities in the PMAY.

In the report, they stated that people who are not eligible had been allotted houses under PMAY in violation of the guidelines. One of the beneficiaries has a pucca house while another draws a monthly pension of ₹10,000.

Sambalpur, Nov 20: To ensure that no one sleeps under the open sky on winter nights, the Sambalpur Municipal Corporation (SMC) has formed three night squads to shift people found along the roadsides to shelters for urban homeless (SUH). Enforcement Officer of the SMC, Subhankar Mohanty has said like that of the previous year. the three squads - one each for Sambalpur, Burla and Hirakud are moving around the city at night and interacting with the people, near the railway station, and bus stands and hospitals, for whom the open sky is their only roof. After getting their consent, the

quarters hospital (DHH), while the other three facilities are located at Badbazar in Sambalpur, Burla and Hirakud in the SMC area.

According to SMC officials, the SUH at Badbazar can accommodate up to 100 people and the facilities at Burla and Hirakud can accommodate 50 people each. The SUH on the premises of the DHH can provide shelter to 35 people but it mainly caters to the attendants of patients who come to the DHH.

Women Self-Help Groups (WHGs) are managing the SUHs in the city now, said Mohanty. "We will soon put up banners and hoardings appealing to the people to apprise the civic body if they find any homeless person sleeping under the open sky on a wintry night. The mobile numbers of the members of the three squads will also be displayed in the banners and hoardings," Mohanty added.

Pratyusha then did not demand a ticket for her in the 2019 elections.

With the 2024 polls approaching, Pratyusha is now moving from

villages to villages under the Nayagarh Assembly segment and strengthening her base among the voters. However, the two senior women leaders holding parallel meeting October 31 has altered the situation. Irani conducted a meeting of Balugaon zone of the party at Nayagarh which was attended by BJP's national spokesperson Sambit Patra, October 31. The same day, Pratyusha displayed her strength by conducting a merger

meeting at Sakeri panchayat under Zilla Parishad zone no-2 of Odagaon block. The parallel meetings by the two senior women leaders on the same day only ripped open the fissures prevailing in the saffron party.

Later, Irani again conducted a workers' meeting at Bhadikila under Odagaon block, November 12. Earlier, the two were jointly seen at party meetings but now they are working separately.

BJP spokesperson Patra also attended the Bhadikila meeting and indirectly confirmed it is Irani who is going get the party ticket in 2024. Patra said that Irani is a good organiser building up the party organisation from the core. If her work is any indication then she is surely going to become the MLA in 2024 elections. Political analysts feel that Patra's support to Irani might cost Pratyusha dearly.

Meanwhile, speculations are rife that the party leaders might take disciplinary action against Pratyusha for breaching the dis-

cipline in the party. When contacted, BJP's district president Lala Manoj Ray said that there is no opposition against anybody for becoming a candidate and everybody is entitled to strengthen the party organisation. However, conducting a merger meeting without informing the district president and not submitting a list of the persons joining the party to him amounts to indiscipline. He said that the state president of the party has been informed about Pratyusha's activities and he will have the final say in this regard.

Pratvusha ruled out creating any disturbances in the party. She said that she was assured of a party ticket in 2024 election when she joined BJP in 2019. She said that Union Minister Dharmendra Pradhan, Irani Ray and district president Lala Manoj Ray were present in the merger meeting. She is not creating any fissures but strengthening the party organization, she reiterated.

Irani Ray said that the charge of 🗎 building the BJP organisation in the Nayagarh Assembly segment rests with her.

The party ticket will not go to the person who makes a self declaration of his/her candidature. Onewho receives the party ticket will become the candidate, she added.

US-China Thaw

The world can breathe a little more easily now since the two great powers – the US and China – have decided to call a truce and give up the path of brinkmanship. At least an illusion has been created to this effect. The optimists will find substance in the promise made by US President Joe Biden and his Chinese counterpart Xi Jinping to bring the world back from the danger of a resumption of cold war which appeared to be a distinct possibility. For, when the US and China speak the language of conciliation instead of confrontation, as they had been doing for the past few years, the rest of the world especially the Asian nations, can heave a sigh of relief. The simple reason is that the trajectory of economic growth and development has, as always, a political underpinning. This is why the recent G-20 summit emphatically announced that there is no mechanism for halting war and conflict, but for advancing the member countries' economic interests that considerably hinge on the political climate.

Dramatically, a remarkable change of attitude has been brought about in the approach of the Americans and the Chinese towards each other. This is a welcome development at a time when the world's economic outlook is gloomy with the looming threat of recession and deceleration of growth everywhere. One may wonder why Xi, who had stressed in his aggressive rhetoric at the 20th Chinese Communist Party Congress last month the need for a "fighting spirit" in a hostile international environment, is now singing a different tune. Similarly, Biden is sounding less belligerent towards China than what he was doing a month back.

Most of the time, foreign policies are geared to suit domestic interests, especially during elections. This time too, domestic interests seem to be influencing foreign policies of both China and the US. Xi appears to be keen on mending China's relations with the rest of the world after successfully manoeuvreing to be China's undisputed and most powerful leader getting a historic third term as the party and the country's supreme boss. This new position of strength appears to have boosted his confidence to chart a new course of international relationships in which he wants to be looked upon as a reassuring figure.

Similarly, Biden has successfully campaigned in domestic politics to reemerge as a liberal leader who can be trusted more than the rabid Right wing Republicans headed by former President Donald Trump in the recent Mid Term elections. This has given him the confidence to adopt constructive foreign policies that can bring economic benefits he desperately needs to stave off the crisis that has so far plunged his presidency into dire straits.

These are the weighty reasons for China and the US trying to adopt a collaborative approach and resume the mechanism of dialogue that was stalled after the House Speaker Nancy Pelosi's visit to Taiwan three months back.

Though both sides talked tough on thorny issues, there is marked change in their approach. While laying down a hard line on Taiwan, the Chinese President's three-hour meeting with Biden was described by the US President as "candid and clear" on subjects ranging from Taiwan to trade. China did accuse the US of breaching the "One China" policy in its pledge to protect Taiwan, but Biden reassured Xi that the US remained committed to the policy and "a new cold war" could be avoided. Xi got what he wanted in his meeting with Biden, as a limited apparent rapprochement made him appear more responsive. He seems to know other countries feel a higher comfort level to engage with China after seeing cordiality with Biden. This is why Xi has seized the moment and sought to reset relationships with these countries on a more positive footing.

At the first political show in his new avatar, Xi has tried hard to get international endorsement of his new role. His main goals are to repair Sino-US relations and relations with other countries, stabilise the North Korean situation and win over Europe. No tangible agreements have yet been signed, but, hopefully, the ice has been broken. Xi seems to send out a message that the US and the West can do business with China.

This is the most important development the world can hope for to tide over a snowballing economic crisis threatening massive job loss and food security. Added to this is the success of the COP27 agreement where the developed nations have, finally, agreed to set up a loss and damage fund that is expected to counter balance calamities caused due to climate change and more importantly the 1.5 C margin.

PANDORA'S BOX OPEN

't has been quite common to hear from the upper castes that the reservation system hampers growth. They often argue that the system discriminates against them and say it doesn't judge based on merit. Not just this, but a section criticises Dalits for getting benefits through the reservation system. In fact, on social media platforms such as Twitter, it has been a daily routine for this section of upper castes to ridicule Dalits and call them "fools" who got jobs only because of the reservation system that doesn't reward "merit". In this battle, this section of "upper castes" is accompanied by a section of nonresident Indians, who too routinely disparage this system. The strange argument put by this section is that this system is the root cause of casteism: so to remove casteism, they argue, the reservation system has to be removed first. This section ignores the very fact that this quota system has been introduced to address the

Actually, the bitter truth is that this section of upper castes has been unable to digest the fact that the socially marginalised Dalits have been progressing well, thanks to benefits of quota system. Having said that, it is also a fact that a section of them is marginalised due to economic reasons. As a result, the Narendra Modi-led BJP government brought the Economically Weaker Section (EWS) quota through the 103rd Constitutional Amendment. Recently, the Supreme Court upheld the government's decision of 10% reservation for people belonging to EWS for admission to educational institutions and government jobs. Obviously, many aren't happy with this verdict as they view it against social justice.

social injustice caused by casteism.

Before the introduction of EWS quota, there have been reservations for STs, SCs and OBCs. Still, some gaps remain to be addressed but it is no denying that the reser-

vation system has benefitted these sections. Similarly, this EWS quota addresses the economically marginalised section of the forward castes. True, the forefathers of a large section of "upper castes" were superior in society but that can't be the reason to ignore the marginalised section of this caste.

The argument that the EWS takes away the benefits of the SCs, STs and OBCs is quite exaggerated as their quota remains the same. Currently, there is 15%, 7.5% and 27% reservation for SCs. STs and OBCs respectively. EWS is an additional quota, and it doesn't interfere with that prevailing. For a society to prosper, the marginalised sections need to be uplifted. And EWS aims to do precisely this and is a welcome step as it addresses one of the economic inequalities of society. It is wrong to vilify marginalised people from the forward castes. Unfortunately, for a section of Leftists and Liberals, it has been a daily routine to unnecessarily criticise all people of forward castes because of some of the wrong deeds done by a section of their forefathers.

Apart from this, due to EWS, the forward castes can no longer claim the reservation system discriminates against them. Many

of them, who don't use their caste to identify themselves and are habituated to calling Dalits, STs and OBCs "casteist" today are going to benefit from the same reservation system they despised the most, only if they satisfied the criteria needed to come under the umbrella of EWS. Definitely, this strengthens the reservation system as now some of its fiercest critics are going to get benefits.

Coming down to sheer politics, it is estimated that the "upper castes" constitute around 25% of the country's population. Currently, this section has been seen as the major vote bank of BJP, which too introduced this EWS quota to pacify the "upper castes" ahead of the 2019 Lok Sabha elections. Only a few months ago, it lost power in Madhya Pradesh, Rajasthan and Chhattisgarh to the Congress, and it was said that a major reason for the defeat was the growing dissent of the forward castes against the BJP. Importantly, the party didn't waste any time and was quick to introduce the EWS quota, which was beneficial.

The Supreme Court verdict on EWS quota has been welcomed by most Opposition parties, including Congress and CPM. The latter has only expressed its concern about the criteria to decide the EWS quota. It believes the present ₹8 lakh per annum and 5 acres of agricultural land would allow a large population, which is not poor, to access benefits of reservation and this would discriminate against the poorest of the poor. However, one of the Opposition parties opposing the EWS verdict is the ruling DMK in Tamil Nadu.

This speaks of the clout the "upper castes" enjoy in general among most political parties, which no longer are ready to ignore their issues. Remember, the Congress still has a committed vote bank among a section of the forward castes, particularly the Brahmins. And with the acceptance of the verdict the party has in a way pacified the anger of a section of "upper castes" that their interests don't matter to any political party. Of course, the benefit of the reservation decision would in all like lihood pay off more for the BJP as it has maintained that the quota is aimed at empowering the EWS who don't benefit from the caste based reservation.

Lastly, there are concerns about the limit of reservations. This EWS exceeds the 50 per cent ceiling for reservations. However, in the end their getting reservation should put an end to the bickering against the backward classes for bagging quota benefits. Nevertheless, there are drawbacks that remain within the reservation system that need attention for further reforms. A political consensus is thus critical, as the quota system did not give birth to the evils of casteism. Now that every caste is a beneficiary, the big question is whether the reservation debate will eventually end. Or will new demands from those 'deserving' and left out emerge? Remember, the reservation system opened the Pandora's Box, and the lid may not be closed entirely.

Putting tyrants in the dock

nyone hoping that Russian President Vladimir Putin will soon find himself in the dock of the International Criminal Court should take several long, deep breaths. While Putin's war of aggression in Ukraine has not gone as planned, his grip on power remains unchallenged. And even if the ICC were to indict Putin for war crimes, it has no police force to arrest him. The international community simply lacks such enforcement tools. But Putin's accomplices may not be as impervious as their leader. Over the past decade, we have seen a sharp increase in the number of tyrants and their henchmen brought to justice, particularly in domestic courts and "hybrid" tribunals that combine national and international components In September, a hybrid court formed by Cambodia and the United Nations upheld the life sentence of former Khmer Rouge leader Khieu Samphan, who was convicted of crimes against humanity in 2014 for his part in the 1970s genocide. In 2016, a similar hybrid tribunal formed by the African Union and Senegal convicted the former Chadian dictator Hissène Habré of crimes against humanity in a case that I helped prosecute. Peru, Guatemala, Egypt, and Burkina Faso have convicted their former leaders for human-rights crimes in domestic courts. In a case I am currently working on, the Gambian government seeks to

prosecute exiled former President Yahya Jammeh before a hybrid court. And in September, Guinea began criminal proceedings against ex-strongman Moussa Dadis Camara for a 2009 massacre.

Crib

he use of the term for a baby's cot is more common in US English than in The use of the term for a papy's corts more common in cortage. Britain, where it's mainly reserved for a model of the Nativity of Christ, with a manger as a bed. The verb to crib in the sense of plagiarism or stealing another's schoolwork is mainly British English, though both US and British English know crib notes. Both varieties of English share the sense of a barred container or rack for animal fodder, a manger. This is the original, which turns up in English around the year 1000 and which is from an Old German word whose descendants are to be found in modern Dutch and German. There are other senses of crib. especially that of a small house. cabin or hovel (from an extension of the sense of an animal stall), which eventually led to the meaning in the South Island of New Zealand of a small house at the seaside or at a holiday resort, to thieves' slang of the early nineteenth century for a house, shop or public-house and to the slightly later US slang usage for a saloon, a low dive, or brothel (and also the current US Black English sense of one's room, house or apartment). The baby's bed doesn't arrive until the seventeenth century as an application of the barred container idea, others from the same source being a repository for hops during harvest and a wickerwork basket or pannier. A shift from container to contents may explain why it has sometimes meant a light meal or a workman's lunch, though it's also suggested that an eighteenth-century slang sense of the stomach may be the direct link. The basket sense was used in particular for one in which a poacher might conceal his catch. The experts guess this may have led to the thievery sense around the middle of the eighteenth century. Much rests on an appearance in Samuel Foote's play The Nabob of 1778: "A brace of birds and a hare, that I cribbed this morning out of a basket of game."

Crimony

t's certainly a mild exclamation or cry of astonishment or annoyance, now much weaker in force than when it was first used, back in the seventeenth century, when it was usually spelled crimine or criminy. Most dictionaries that include it spell it criminy, though many variant forms exist, such as criminey, crimany, criminee and crimeny. These variations show that the word has usually been transmitted orally rather than in writing. The usual explanation is that it is a form of Christ, much like another somewhat dated mild expletive, crikey, which came along later; but the Oxford English Dictionary suggests that it might just be a variant form of crime. There is also an elaborated version, crimanetly, known regionally in the US, which also turns up in numerous variations, such as criminetlies, criminetly and crimanightie. The Dictionary of American Regional English has a map showing where its researchers have found these expanded versions – mainly in the northern states of the central and western US, together with California.

panied by a surge in trials held under what is known as "universal jurisdiction," the principle that allows countries to prosecute the worst human-rights crimes committed anywhere in the world. More than a hundred defendants are currently being prosecuted, mainly in Europe, for atrocities committed in countries such as Syria, Iraq, and Rwanda. And just this month, a French court convicted a former Liberian rebel of crimes against humanity as an armed group commander during that country's civil war.

But this surge of activity has not received as much attention as the ICC, which in 20 years has not sustained the atrocity conviction of any state official at any level anywhere. Yet, these prosecutions are more organic than those conducted by the ICC, because they rely on victims' activism and on special war-crimes units operating within the police forces and judiciary in European countries, some of which have opened wide-ranging "structural investigations" into human-rights violations abroad. The European Union has assembled several joint investigation teams for cross-border investigations, coordinating this work through its so-

d Criminal Justice, recent developments herald the emergence of a new "international justice ecosystem."

The most recent additions to this fledgling movement are three independent investigative mechanisms created by the UN for atrocities committed in Myanmar and Syria and by the Islamic State (ISIS). These investigative bodies build war-crimes cases and transfer them to national prosecutors acting under universal jurisdiction. Such investigations have already led to several convictions, including the landmark case of a former Syrian intelligence officer who was sentenced to life in prison in Germany in January for the murder and torture of prisoners at a detention facility in Damascus.

Other developments also mark a worldwide shift toward greater accountability for war criminals. The UN Human Rights Council has created commissions of inquiry in almost a dozen countries, tasking them with laying the foundations for future criminal accountability. Many in the international legal community, including Rapp and the International Commission of Jurists, advocate the creation of a standing independent portunity to demonstrate its relevance. The ICC's chief prosecutor, Karim Khan, has seized the moment and announced the opening of the court's largest-ever field office in the country. One hopes that the ICC and Ukrainian prosecutors will be able to go beyond the foot soldiers who have been tried for war crimes

have been tried for war crimes since the invasion began and move up the Russian chain of command. Their work will benefit from the nascent international-justice ecosystem. Six of Ukraine's neighbours, together with the ICC, have formed a joint investigation team. In March, the Human Rights Council created a well-staffed commission of inquiry on Ukraine to identify violators and to ensure that "those responsible are held accountable." And a dozen other countries have opened their own universal-jurisdiction investigations into war

crimes committed in Ukraine. Putin himself, unfortunately, may still be out of reach. But justice is on the march, and it is coming for war criminals – in Ukraine and around the world.

Poonawala allegedly strangled Walkar, 27, on May 18 and sawed her body into nearly three dozen pieces which he kept in a 300-litre fridge for almost three weeks at his residence in South Delhi's Mehrauli before dumping them across the city over several days past midnight.

Auto blast suspect had terror links: CM

Bangalore, Nov 20: The explosion inside a moving autorickshaw near a police station in Mangaluru was triggered by explosives concealed in a cooker and it is an act of terror intended to cause damage, Karnataka Director General of Police, Praveen Sood said Sunday.

The suspect, who was the passenger in that vehicle had terror links, Chief Minister Basavaraj Bommai said and added that sleuths of the National Investigation Agency and Intelligence Bureau have joined the Karnataka police in investigation. According to preliminary probe, it appeared to be a low intensity improvised explosive device and further investigation would bring out more details, Bommai told reporters here.

The chances of a Tamil Nadu link also surfaced as it has now emerged that the suspect was in possession of two fake Aadhaar cards, one with an address from TN, and another with a Hubballi address. Nepal's missing rare vulture found in Bihar

Patna, Nov 20: A winged visitor, a rare white-rumped vulture, from Nepal which went missing some ten months ago, was found by Bihar's bird ringing station officials at Darbhanga after it went off the radar despite being radio tagged.

The bird, belonging to a critically endangered species, was last sighted in the Himalavan nation's Tanahun district, and was found in a weakened condition as it was

starving for want of food, accord ing to officials. The white-rumped vulture was listed as a critically-endangered species in 2000 as its population declined rapidly, primarily as a result of feeding on carcasses of animals treated with the veterinary drug diclofenac, Chief Wildlife Warden PK Gupta said.

White-rumped vultures, found generally near human habitations, were very common in the Indian subcontinent, besides Myanmar, Thailand, Laos, Cambodia, and



southern Vietnam These hirds feed mostly on the ground, but roost and nest in trees and cliffs, and spend much of their time soaring on wind currents, searching for carrion.

The bird is medium-sized and dark with blackish plumage, a white neck-ruff, and a white patch of feathers on the lower back and upper tail, from which the name was derived. An adult white-rumped vulture is 75 to 85 cm tall. The bird, which went missing, was being used for research and monitoring of the vulture safe zone by Nepalese authorities, Gupta said.

ticles, all of which are written in English."It will be ok if you are going to stay at a local community level and never connect with the global community. Basic understanding you can give in a regional language, but if you want to update your skills, it is not going to help you," he said.

In the first phase, Hindi textbooks on medical biochemistry, anatomy, and medical physiology have been released. Following Madhya Pradesh's lead, the Uttarakhand government has also announced similar measures to be implemented from the next academic sessions.

According to the state's Medical Education Minister Dhan Singh Rawat, a committee will prepare a draft of the new syllabus for colleges after studying the MBBS Hindi syllabus in government colleges

of Madhya Pradesh.

Last week, Tamil Nadu Minister for Higher Education K Ponmudy also said the state government was now involved in introducing MBBS courses in Tamil and a committee of three professors was formed in that regard. Karan Juneja, an MBBS doctor and national secretary of IMA-Junior Doctors Network, said instead of offering medical education in regional languages, the government should focus on improving infrastructure and school education.

"We have seen students who come 🔶 from rural areas, without any English background, managing well with the subjects and the language. They adapt to the environment and improve themselves. Offering them education in Hindi or any other lan-guage will be detrimental for their growth," Juneja said.

Coming soon: Doorstep garbage collection in Greater Noida villages

Noida, Nov 20: The facility of doorstep collection of garbage will soon be launched across the 124 villages under the Greater Noida Authority, benefitting lakhs of residents, according to officials.

The facility is currently available only for developed sectors in Greater Noida.

Participating in a programme to mark 'World Toilet Day' Saturday, Greater Noida Authority CEO Ritu Maheshwari noted that the villages in the area and some newly developed city sectors do not have doorto-door garbage collection facility.

"At the beginning of the new year, a (private) agency will be selected to collect garbage from homes in these villages and sectors,' Maheshwari said.

She also said that the authority has planned 32 more public toilets besides the 30 that are already under construction, according to an official statement.

"At present, 19 public toilets are ready, while work is underway on 11 others. Of these 30, nine are pink toilets (dedicated to women) and the rest are common public toilets. All these are being made on BOT (build-operate-transfer) basis at a cost of Rs 3.72 crore, Maheshwari said.

"Besides these, approval has been received for the construction of 32 public toilets and tenders for their construction will be issued soon. The project's cost is estimated to be around Rs 4.28 crore," she said. On the occasion, the senior IAS officer also exhorted the general public to use public toilets instead of defecating in the open and help keep Greater Noida clean.



Vulture population increases in ATR

Bijnor, Nov 20: The Amangarh Tiger Reserve (ATR) in Uttar Pradesh has witnessed a rise in the population of vultures

According to a survey, the conservation efforts have yielded desired results and the vulture population has risen from 141 last year to 165 this year. Bijnor divisional forest officer Anil Kumar Patel said: "A three-day census was carried out from November 16 to 18, which revealed 143 Griffin vultures and 22 baby vultures in Amangarh Tiger Reserve area as compared to 141 sighted in the 2021 survey." There has been a sharp overall decline in the vulture population, except for a few species like the Griffon vulture, which is included in the 'near threatened' category of the IUCN Red List.

Lucknow, Nov 20: The Uttar Pradesh government's initiative to build extra toilets for girls and develop other infrastructure in elementary schools has resulted in a big jump in students' enrolment and attendance, a state government report said.

Compared to 61 per cent toilets for girls in elementary schools across the state in November 2019, it rose to 97 per cent in November this year, the report said.

The enrolment and attendance in schools increased to 1.91 crore in 2022-23 vis-a-vis 1.52 crore in 2016-17 due to the infrastructure push, including the setting up of multiple hand wash units, it said. Reports from districts, however,

also highlighted the problems in their upkeep as in many schools, students and local people com-

plained that the toilets were either locked or not cleaned daily.

Vijay Kiran Anand, director general of School Education, told PTI that Chief Minister Yogi Adityanath holds a monthly meeting to review the progress of Operation Kayakalp with all divisional commissioners and district magistrates.

At state, district and block levels, control rooms have been established to monitor the progress and facilitation of work and monthly IVRS (Interactive Voice Response System) calls are being from state to every head teacher of schools for their feedback and to know the challenges, he said.

A three-tier comprehensive monitoring mechanism through Prerna dashboards, from state to block levels, has also been developed to ensure time-bound completion and saturation of child-friendly essential infrastructure in schools,



Anand added. He said Operation Kayakalp was selected in the 'best practice' category by the Union Education Ministry and a presentation was given to Prime Minister Narendra Modi on it in June. A report from Ballia said 2,249 schools are running under the Basic Education Council.

Sushil Yadav, principal of government school in Kakraso village said there are 514 students in the school which has four toilets.

The department has not provided any safai (cleanliness) staff. So, they have to depend on the gram panchayat staff for getting them cleaned, he added.

A report from Jhansi said most of the schools have separate toilets for girls.

Many parents in Bhai Jalalabad Bada blocks complained that toilets in schools remain locked for most of the time, forcing students to relieve themselves in nearby fields.

In Baghpat, basic education officer Kirti said schools in the district already have separate toilets for boys and girls. A Meerut report said enrolment has increasedin schools due to construction of additional toilets for girls.



The move is based on the recommendations by an expert committee constituted to review the inclusion of stents in the list based on requirement. The National Pharmaceutical Pricing Authority (NPPA) will now fix the price of coronary stents. On November 6, the Standing National Committee on Medicines (SNCM) had submitted its recommendation for inclusion of coronary stents in the National List of Essential Medicines (NLEM), 2022 in two categories -- Bare Metal Stents (BMS) and Drug Eluting Stents (DES) which include metallic DES and bioresorbable vascular scaffold (VBS)/biodegradable


Kathmandu, Nov 20: Nearly 60 per cent polling was recorded Sunday in Nepal's parliament and provincial assemblies elections, marred by sporadic violence and clashes that left one person dead and disrupted voting at several polling stations, official sources said.

The polling started at 7 am local time at over 22,000 polling centres and closed at 5 pm. More than 17.9 million voters

were eligible to cast their votes to elect a 275-member House of Representatives. A minor explosion took place near Sharda Secondary School polling station in Dhangadhi Sub-metropolitan City in Kailali district.

However, there was no casualty, officials said, adding that voting continued in the polling station despite the incident with just half-anhour interruption.

Some incidents of heated arguments between party cadres were reported from 11 areas in Dhangadi, Gorkha and Dolakha districts. However, it did not affect the polling,

Japan's PM sacks 3rd minister in a month

Tokyo, Nov 20: Japan's Prime Minister Fumio Kishida sacked his internal affairs minister Sunday over funding irregularities, in a blow to his scandal-prone Cabinet that has already lost two ministers in one month.

Internal Affairs Minister Minoru Terada has been under fire over several accounting and funding irregularities. In one, he acknowledged that one of his support groups submitted accounting records carrying a dead person's signature.

"I apologise for the series of resignations," Kishida said. "I'm aware of my heavy responsibility for their appointment." He told reporters that he will announce Terada's replacement Monday.

Dhaka, Nov 20: Two Islamist militants, who were sentenced to death for killing prominent Bangladeshi-American secular blogger Avijit Roy and his publisher, escaped dramatically from the premises of a crowded court here Sunday with the help of unidentified bikers who sprayed some chemical on police and created a smoke screen before whisking away the convicts.

Kuala Lumpur; Nov 20: Malaysia's next government appeared to be leaning to the religious right as a coalition of Malay nationalists won support of an influential bloc Sunday after tightly fought general elections failed to produce a clear winner. The nation's king still has to approve any deal.

The unprecedented hung parliament after Saturday's divisive polls saw the rise of the the Malaycentric Perikatan Nasional, or National Alliance, led by former Prime Minister Muhviddin Yassin. It stunned many Malaysians who had hoped for stability and unity after political turmoil that has seen three prime ministers since

2018 polls. Muhyiddin's alliance was an underdog that enjoyed an unexpected surge of votes with 73 out of 222 parliamentary seats. Its hard-line ally is the Pan-Malaysian Islamic Party, the biggest winner with a haul of 49 seats - more than double what it won in 2018. Known as PAS, it touts Sharia, rules three states and is now the single largest party. Its rise has stoked fears of greater Islamisation in the country.

Opposition leader Anwar Ibrahim's reformist multiethnic alliance topped the race with 82 federal seats, but fell far short of the 112 needed for a majority.

In negotiations Sunday, Muhyiddin's coalition edged closer to a victory after securing the backing of a political bloc in Sarawak, a state on Borneo island, that won 22 seats. He still needs a nod from another key player, the long-ruling United Malays National

Organization, to muster a majority. The arrangement, if confirmed by the king, means that Muhyiddin

Zahid, who has come under pressure to resign after UMNO's second drubbing at the polls, warned that any members who violated party rules will be sacked and will have to vacate their parliamentary seat under a new law that bans switching of parties

His statement came amid a split in the once-powerful alliance that had ruled Malaysia since independence from Britain until corruption scandals brought it down in 2018.

The palace said in a statement that Sultan Abdullah asked political chiefs to submit their choice for prime minister and for the alliance that will be formed for a parliamentary majority by Monday. The monarch said his decision will be final as he urged Malaysians to accept the outcome to ensure a stable government.

Many rural Malays, who form two-thirds of Malaysia's 33 million people - which includes large minorities of ethnic Chinese and Indians - fear they may lose their rights with greater pluralism under Anwar's alliance. This, together with corruption in UMNO, has benefited Muhyiddin's bloc.

Among other key election losers was two-time former Prime Minister Mahathir Mohamad, who at 97 is leading a separate Malay movement. He suffered a shocking defeat to the National Alliance. Muhyiddin took power in March 2020, defecting from Anwar's alliance and joining hands with the UMNO-led coalition in a move that triggered the government's collapse. The partnership was beset by infighting and he resigned after 17 months

ume of transactions processed during the preceding three months. However, it gave the existing TPAPs, such as PhonePe and Google Pay, which exceed the de-

sired market cap, two additional years, starting next year to comply with the directive.

Earlier this year, the RBI came out with a consultation paper on charges in payment systems, which made a case for a tiered charge to be imposed on UPI transactions in line with Immediate Payment Service (IMPS) transactions.

The government later issued a statement noting that UPI is a digital public good with immense convenience and productivity gains for the economy, and there are no plans to levy any charges for UPI services.

FPIs invest ₹30k cr in Indian equities in Nov

New Delhi, Nov 20: Foreign investors have been aggressively buying Indian equities in November. investing ₹30,385 crore this month so far, on stabilisation in rupee and resilience of the domestic economy compared to global counterparts.

However, going forward, buying by Foreign Portfolio Investors (FPIs) is unlikely to turn very aggressive as high valuations in India are a headwind, said VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services.

Further, valuations in markets like China, South Korea and Taiwan are very attractive now and so more FPI money is likely to move to these markets, he added.

According to data with the depositories, FPIs invested a net sum of ₹30,385 crore in equities during November 1-18. This came following a net outflow of just ₹8 crore last month and ₹7,624 crore in September.

Prior to these outflows, FPIs were net buyers in August to the tune of ₹51,200 crore and nearly ₹5.000 crore in July. Before that. foreign investors were net sellers in Indian equities for nine months in a row which started in October last year.

So far this year, the total outflow by FPIs in equities stands at ₹1.4 lakh crore.

The latest spurt in net inflows can be attributed to the recent surge in equity markets, stability in Indian economy compared to its global



counterparts and stabilisation in rupee, Morningstar India Associate Director - Manager Research Himanshu Srivastava said.

On the global front, lower than anticipated rise in inflation in US raised hopes that the US Federal Reserve may not go for further aggressive rate hikes, which also eased recessionary concerns in the US. This helped improve sentiments and directed foreign flows towards Indian shores, he added.

In addition, stabilisation in the global market scenario also helped in enhancing risk appetite among foreign investors.

Strong recovery was seen in the global markets as China slightly eased its 'zero-COVID policy', said Shrikant Chouhan, Head - Equity Research (Retail). Kotak Securities. In terms of sectors, FPI buving

were seen in IT, autos and telecom, Vijayakumar added. On the other hand, foreign investors have pulled out ₹422 crore from the debt market during the pe-

riod under review. Apart from India, FPI flows were positive for the Philippines, South Korea, Taiwan and Thailand so far this month.

Nitin Aggarwal, Senior Group VP, Research-Banking & Insurance, Institutional Equities, Motilal Oswal Financial Services, said since January, additions have been slowing down as the market volatility increased post the Russia-Ukraine conflict.

"Also, there has been increasing noise about rising inflation and interest rates around the globe. Given such uncertainties, there has been a conscious strategy by brokers to spend less on customer acquisition in this phase. This is to ensure an efficient conversion ratio of leads," he added.

The decline in incremental addition in October from the preceding month could also be due to the festive season as there were effectively only 18 working days in October 2022 as compared to 22_ working days in September.

New Delhi: India's largest oil and gas producer ONGC will this year reverse years of decline in production and gradually raise output thereafter as it invests billions of dollars to produce from newer discoveries, company's management told investors in a call. Oil and Natural Gas Corporation in fiscal year 2021-22 produced 21.707 million tonne of crude oil, which is refined to produce petroleum products like petrol and diesel, and 21.68 billion cubic meter (bcm) of natural gas, which is used to produce electricity, manufacture fertilizer and as CNG in automobiles. In current fiscal year (2022-23), crude oil production is slated to rise to 22.823 million tonne and gas to 22.099 bcm. In the following fiscal year, oil production will climb to 24.636 million tonne and to 25.689 million tonne in 2024-25, the management told investors in a call post announcement of second quarter earnings last week.

The RBI's Monetary Policy Committee (MPC), which makes recommendations to the central bank regarding interest rates, is set to meet again early next month amid expectations of another repo rate hike.

By October-end 2022, banks have increased their EBLRs by 190 bps in tandem with the increase in the policy repo rate since May 2022, according to an RBI article.

Further, banks have also increased their 1-year median marginal cost of funds-based lending rate (MCLR) by 85 bps from May to October 2022.

From October 1, 2019, all banks have to lend only at an interest rate linked to an external benchmark, such as RBI's reported rate or Treasury Bill yield. As a result, monetary policy transmission by banks has gained traction.

However, the banks have raised the interest rates on term deposits by a much lower margin.

The median term deposit rates (average card rates on retail deposits) on fresh deposits increased

by 48 bps from May to October 2022. Banks have increased their bulk deposit rates higher than retail deposit rates. Across bank groups, the article

said, transmission to lending and deposit rates of private sector banks (PVBs) has exceeded that of public sector banks (PSBs) in the current tightening period. Credit growth for PVBs has been

higher than for PSBs in the current interest rate tightening period beginning May this year.

In view of the increase in credit demand, private banks have increased their lending and deposit rates to maintain higher net interest margins (NIMs). The next meeting of the MPC is scheduled during December 5-7, 2022.

New Delhi, Nov 20: The government is considering to remove the penal offences which are already covered under the Indian Penal Code (IPC) from the GST Act to make it more taxpayerfriendly, an official said.

The proposal, part of the exercise to decriminalise GST law, is likely to be taken up in the next meeting of the GST Council. Once approved by the GST Council, the Finance Ministry will propose amendments to the GST law, which could be taken up in the upcoming winter session of Parliament next month.

"Law committee has finalised the changes in Section 132 of the GST Act as part of the exercise to decriminalise the law," the official told PTI.

The offences that are similar

to those covered under the Indian Penal Code would be removed from GST law, the official added.

The amendments would be placed before the GST Council for approval. Thereafter, it would go to Parliament for effecting changes in the GST Act.

Once approved by Parliament, states would be required to amend their state GST laws

Tax experts said primarily fake billing offences could be part of the decriminalisation exercise. They may also include supplies of goods or services or both without proper invoices and issues of invoices or bills without a supply of goods.

Also, the act of availing input tax credit using fake invoices could be covered under the offences mentioned in the IPC.

AMRG & Associates Senior Partner Rajat Mohan said it is anticipated that offences around issuing and accepting fake invoices could be moved to the

Indian Penal Code. "Maximum sentence under section 420 of IPC for cheating cases is 7 years, whereas the same is ring-fenced to 5 years in GST code. With this change, deceitful taxpayers could be charged for up to 7 years of imprisonment under section 420 of IPC, irrespective of the tax evaded," Mohan said.

This would be a massive departure from current GST provisions, whereby punishment under Section 132 of GST law depends on the quantum of tax evaded. Mohan added.

FTAs don't always accelerate export growth: Report

380 infra projects show cost overruns

New Delhi: As many as 380 infrastructure projects, each entailing an investment of ₹150 crore or more, have been hit by cost overruns of more than ₹4.58 lakh crore, as per a report. According to the Ministry of Statistics and Programme Implementation, which monitors infrastructure projects of ₹150 crore and above, out of 1,521 projects, 380 reported cost overruns and as many as 642 projects were delayed. "Total original cost of implementation of the 1521 projects was ₹21,18,597.26 crore and their anticipated completion cost is likely to be ₹25,76,797.62 crore, which reflects overall cost overruns of ₹4,58,200.36 crore," the ministry's latest report said.

New Delhi, Nov 20: Countries negotiating free trade agreements (FTAs) need to keep in mind eight 'myths' which surround these pacts, like they lead to accelerated increase in exports and promote domestic manufacturing, according to a report by think-tank GTRI.

The report by Global Trade Research Initiative (GTRI) claims to dispel these 'myths', including that FTAs weaken the WTO (World Trade Organisation), countries are rushing to do FTAs, and these pacts promote investment and lower prices.

It is 'erroneously' believed that most world trade happens through the FTA route, but in reality, it is less than 20 per cent, said the report titled 'FTAs: Fabulous, Futile, or Flawed?"

It is also not true that countries

world over are rushing to do FTAs and in fact these pacts are 'enthusiastically' embraced mainly by east Asian economies or countries that have lowered their customs duties close to zero.

"Major industrial countries/regions do FTAs selectively. The USA has no FTA with significant economies like the European Union, China, Japan, ASEAN (Association of Southeast Asian Nations), or India. The EU currently has 41 trade agreements. But these represent just 32 per cent of the EU's external trade. Most of its FTAs are with raw material suppliers and

small countries," it noted. While the FTAs have potential, they could not dent the multilateral trading system as far as standard trade instruments like tariffs are concerned, as about 83-85 per cent of the world trade takes place outside these pacts and under the



WTO rules.

On the myth that FTAs lead to accelerated increase in exports, it said that since less than 20 per cent of world trade is happening at concessional customs duties, India needs additional strategies to promote 80 per cent of trade outside

this route. "Also, the mere signing of an FTA does not guarantee an increase in exports. Chances of an increase in exports due to the signing of FTAs are low if import duties in the partner country are low. From this count, FTAs are of minimal use for increasing exports to Singapore, or Hong Kong, as regular (Most Favoured Nation) import duties are zero," it said.

Trade agreements with Malaysia, Japan, Australia, New Zealand and Brunei benefit only a few product groups as most imports into these countries happen at zero duty.

"The share of ASEAN in India's export was 10.4 per cent in 2010, the year of the signing of the agreement. The share has remained almost the same, even after over a decade. During this period, India's deficit with ASEAN has expanded from USD 6.7 billion to USD 24.2 billion. A quantum jump in India's export will require enhancing competitiveness at all levels and changing the product profile of Indian exports," it pointed out.

Further, it said zero-duty imports of finished goods from the FTA partners may disrupt many domestic manufacturing programs.

"The US has an active Make in USA programme...In India, programmes like Production Linked Incentive Scheme (PLI), Phased Manufacturing Performance (PMP) recommend zero or low-duty import of inputs and high duty on finished goods to support indigenous production," it added.

The report further said there is mixed evidence that these agreements promote investments and lower prices in the respective countries that are entering into the pact.

Al Khor (Qatar), Nov 20: Qatar opened Sunday the Middle East's first FIFA World Cup before global leaders and soccer fans who have poured into this energy-rich nation after it was battered by a regional boycott and international criticism. With American actor Morgan Freeman's dulcet voice and an Arabian theme with camels, the opening ceremony began with a

promise of 'everyone is welcome'. Regardless of the outcome of Qatar versus Ecuador on the pitch, Doha already has drawn Saudi Arabia's powerful Crown Prince Mohammed bin Salman to the opening ceremony and inaugural match of the tournament.

That Prince Mohammed, whose nation had closed Qatar's only land border to the world through the kingdom over a years-long political dispute, will attend shows how far the rapprochement between the two nations has gone. Qatar also faced criticism from the

West as groups they funded initially in Syria's civil war became extremists. Qatar later would deny that it ever funded Islamic extremists, despite criticism from across the American political spectrum from Hillary Clinton to Donald Trump. Qatar, like Saudi Arabia, follows an ultraconservative version of

Islam known as 'Wahhabism'. Yet the

country allows alcohol to be served in hotel bars and at a FIFA Fan Zone in the country. Already, some in the country have criticised what they view as Western cultural extravaganzas of the tournament - likely leading to the stadium beer ban.

Al-Qaida issued a communique Saturday criticising the Qataris for hosting a tournament 'bringing immoral people', homosexuals, sowers of corruption and atheism'.

"We warn our Muslim brothers

from following this event or attending it," the group said, calling on scholars not to support it. However, the al-Qaida arm did not directly threaten the tournament and has been weakened by years of drone strikes from American forces and engulfed by Yemen's ongoing war. On hand Sunday night at the

opening was UN Secretary-General António Guterres, Algerian President Abdelmadiid Tebboune. Egyptian President Abdel Fattah el-Sissi, Senegalese President Macky Sall, Palestinian President Mahmoud Abbas and Rwandan President Paul Kagame.

Doha, Nov 20: FIFA earned record revenues of USD 7.5 billion in the four years of commercial deals tied to the 2022 World Cup in Qatar, the governing body of soccer said Sunday. FIFA revealed its earnings to officials from more than 200 of its members. It is \$1 billion more than the income from the previous commercial cycle linked to the 2018 World Cup in Russia.

The extra income was buoyed by commercial deals with the World Cup host country. 'Qatar Energy' joined as a top-tier sponsor, and new third-tier sponsors include Qatari bank 'QNB' and telecom firm 'Ooredoo'.

FIFA also added second-tier sponsor deals this year from financial plat-

Abu Dhabi, Nov 20: Max Verstappen won a record-extending 15th race of the year at the Abu Dhabi Grand Prix here Sunday to conclude one of the most dominant seasons in Formula One (F1) history. A year on from Verstappen's tense and controversial win over Lewis Hamilton to seal his first title, there was little drama at the Yas Marina Circuit.

Verstappen stayed ahead of his teammate Sergio Perez at the start and was never seriously challenged after that on his way to victory. "Incredible to win again here, 15th win of the season is unbelievable, he said. "It's been really enjoyable to work with the whole team and to be able to achieve something like this this year."

Ferrari's Charles Leclerc held off Perez's challenge on old tyres to finish second and clinch second

place in the championship standings, thwarting Red Bull's bid to have their drivers place first and second.

Leclerc finished three points ahead of Perez in the standings. That meant Verstappen's refusal to yield sixth place to his teammate at the last race in Brazil was not decisive at the end of the season.

'I knew the only possibility to beat Checo (Perez) today was with a different strategy and playing with the tyre management, which we did really well today," Leclerc said. "I really hope next year we can do a step forward to fight for the cham-

pionship," he added. Leclerc and Ferrari seemed able to challenge Verstappen for the title at the start of the season, but Red Bull improved their car performance advantage through the season. Errors on track from Leclerc and in Ferrari's race strategy held them back too. Four-time champion Sebastian

Vettel was placed 10th for Aston Martin as he retires from F1 after 16 years. A hydraulic problem ended Lewis Hamilton's race for Mercedes as the seven-time champion finished an F1 season without a win for the first time in his career.
