THUMPING VICTORY FOR BJD

Naveen magic works as Barsha logs 37,508 more votes than her late father to achieve a landside victory over her BJP rival Purohit

Bhubaneswar, Dec 8: The BJD steamrolled to victory in the Padampur bypoll, after Chief Minister Naveen Patnaik unleashed his charisma on the tribal-dominated constituency by personally going down to campaign for his party's rookie candidate Barsha Singh Bariha, who won the electoral battle Thursday against BJP's Pradip Purohit by a margin of 42,679 votes. A total of 10 candidates were in fray for the bypoll.

Though Patnaik had refrained from physical campaigning in bypolls since 2019, he made an exception this time after opposition BJP emerged victorious in the recent by election to the Dhamnagar constituency.

After the end of the 23rd rounds of counting, Barsha polled a total of 1,20,807 votes (58%), while Purohit Chief Electoral Officer (CEO), SK Lohani said. Congress candidate Satva Bhusan Sahu was a poor third with 3,594 votes. Incidentally Barsha is the daughter of late BJD MLA Bijay Ranjan Singh Bariha, whose death in October necessitated the bypoll.

Patnaik spoke to Barsha over telephone and congratulated her for the 'spectacular' victory, a statement issued by the Chief Minister's Office (CMO) said.

This was the second consecutive time that the BJD emerged triumphant in Padampur. Bijay Ranjan had won the seat in 2019. An overwhelmed Barsha thanked Patnaik. who is also the BJD president, for campaigning for her, asserting that it proved to be a 'game changer'.

"Thanks to our CM and the people of Padampur for choosing me. My late father's goodwill was also a factor that worked in favour of the BJD in the by-poll," the 29-yearold law graduate said.

The BJP said it will introspect on the reasons behind its defeat in Padampur. "Her (Barsha's) victory

is unexpected. A large chunk of Congress votes shifted to the BJD. I accept the verdict of the people with humility," Purohit told reporters. "I never imagined that I would be defeated in this manner." he added.

Union Minister Dharmendra Pradhan also took to Twitter to congratulate Barsha. "We respect the people's mandate. My heartiest thanks to all who voted for the BJP. We will try to further strengthen the party in the coming days through welfare initiatives and public relations," Pradhan said.

Cong wrests HP; BJP 7.0 in Gujarat

AS SAFFRON SURGE CONTINUES IN GUJARAT, ANTI-INCUMBENCY HURTS IT IN NORTHERN STATE

Ahmedabad/Shimla, Dec 8: Riding high on the charisma of Prime Minister Narendra Modi, the BJP retained Thursday power in Gujarat for a record seventh straight term pulverising the opposition to secure the biggest maiority ever in the state. This was the seventh successive time, the BJP retained its hold on the state equalling the Left Front's rule in West Bengal from 1977 to 2011.

However, the saffron party lost Himachal Pradesh to the Congress after a close fight and the hill state continued with the tradition of nearly four decades of voting out the incumbent party. Congress leaders credited its general secretary Priyanka Gandhi for the win which came as a boost for the grand old party in the home state of BJP president JP Nadda.

For the Aam Aadmi Party (AAP) which had exuded confidence before the Gujarat polls, there was some consolation. It opened its account in Gujarat by winning five seats after its 'blank' debacle in 2017.

As Modi continued to hold sway over voters and addressed 31 election rallies in Gujarat, the BJP crossed the three-fourths majority and in the process checkmated AAP in triangular contests and also pushed the Congress down to its all time low.

Gujarat state BJP president CR Patil said Bhupendra Patel, the party's 60-year-old soft-spoken face, would continue as the chief minister and his swearing-in ceremony would be held December 12. Patel won the Ghatlodia seat in Ahmedabad by a huge margin of 1.92 lakh votes. The BJP, which

complaint lodged by Benudhara Khuntia of Bada Khandaita village, under Biridi police limits in Jagatsinghpur December 5, 2022. As per the complaint, Khuntia along with a few others were engaged in paddy farming on Railway lands adjacent to Cuttack-Paradip railway line near Bada Khandaita passenger halt for the last 40 years. Khuntia alleged that Sahoo sent a message to him through a Railway staffer asking him to meet him at his office December 2, 2022

Accordingly, Khuntia went to the office where Sahoo demanded Rs 8.000 from the former to allow him do cultivation on the railway land. The accused also threatened Khuntia that he would cut and destroy the paddy using Railway Protection Force (RPF) if he refuses to pay the bribe amount.

Finding no other way, a poor Khuntia lodged a complaint at the CBI office in Bhubaneswar.

'The complaint was verified by a team of CBI, ACB, Bhubaneswar, in presence of independent witness on 06.12.2022. Verification of the said complaint confirmed that the said public servant had demanded undue advantage of Rs 8,000 from the complainant towards above said purpose," said the CBI.

ASHOK SWAIN'S OCI CARD CANCELLATION

Delhi HC seeks Centre's response in four weeks

New Delhi, Dec 8: The Delhi High Court Thursday sought the Union government's response on a petition filed by Sweden-based Prof Ashok Swain against the cancellation of his Overseas Citizenship of India (OCI) card.

A single-judge bench of Justice Prathiba M Singh issued notice to the Ministry of Home Affairs, External Affairs Ministry and Indian Embassy in Sweden and Latvia, and granted four weeks' time to file the response. The HC posted the matter to February next year.

Swain, a native of Puri, is the head of the Department of Peace and Conflict Research, Uppsala University, Sweden. He is also a Unesco Chair on International Water Cooperation since 2007. Swain, who has been living in Sweden for the past 32 years, was granted an OCI card January 14, 2020 by the Centre.

In the petition filed in Delhi High Court, Swain contended that his OCI card was cancelled in February 2022 because of his statements criticising the policies of the incumbent Indian government. He submitted that he has never engaged in anti-India activities.

"It is submitted that the petitioner has never engaged in any inflammatory speeches or anti-India activities. As a scholar, it is his role in the society to discuss and criticise the policies of the government," the petition reads.

cookies and digital fingerprints. "At least 5 million people have had their online identities stolen and sold on bot markets for Rs 490 on average. Out of all the affected people, 6,00,000 are from India, making the country the most affected by this threat in the world,"

said the researchers. At least 26.6 million stolen logins were found on the analysed markets. Among them were 7,20,000 Google logins, 6,54,000 Microsoft logins and 6,47,000 Facebook logins. In addition, researchers found 667 million cookies, 81 thousand digital fingerprints, 538 thousand auto-fill forms, numerous device

screenshots, and webcam snaps. "Digital bots are becoming increasingly common. They oper-

ate in fields such as customer service, search engine optimisation and entertainment. Yet not all bots may serve good intentions -many of them can be malicious," said security researchers.

The most popular types of malware that steal and gather data include RedLine, Vidar, Racoon, Taurus, and AZORult. RedLine is the most prevalent of them all.

"The 2easy marketplace was launched in 2018. At first, it was considered to be smaller compared to other markets. Yet the situation has dramatically changed since then. Now, 2easy sells morethan 6,00,000 stolen data logs from 269 countries," said the report.

"How will this ping-pong battle settle?" the bench asked. "Till the Collegium system is there, till it is upheld, we have to enforce it. You want to bring another law, nobody stops you from bringing another law," the bench stated.

"We may at the end say only this that the scheme of the Constitution stipulates the court to be the final arbiter of the position of law. The power to enact a law is with the Parliament. However, that is subject to scrutiny by the courts," it asserted. "Any law declared by this court is binding on all stakeholders. That is the only signal I want to send," Justice Kaul observed.

The apex court said if a section of the society starts deciding which law to follow and which not to follow, then there will be a breakdown. "When you lay down a law, you expect the courts to enforce it unless the law is set aside," the

Electricity in elementary schools still a dream 6.69 per cent of students claimed

Bhubaneswar, Dec 8: A study report on the state of elementary education in Odisha was published Thursday. Several civil society organsiations (CSOs) of the state, including the Atmashakti Trust, Shramajeebee Mancha and Mahila Shramajeebee Mancha, jointly conducted the fact-finding study using online forms collecting data from all the stakeholders part of programmes such as the learning recovery programme (LRP), Right to Education (RTE) campaign, and others who experienced dropout and migration.

The study was conducted between November and December, covering 1,404 villages of 74 blocks of 13 districts. Data was collected from 5,543 respondents on LRP, from 1,912 respondents on RTE norms, 244 respondents on dropouts, and 152 on migration.

As per the study report, the state government had directed the learning recovery programme (LRP) to be conducted in 54.446 government and government aided schools, among 37,97,830 students of class 3 to 9, with involvement of 2,29,799 teachers in the 30 Districts of the state. As per the fact-finding re-

to have not received any LRP education materials. 22.89 per cent of students rate the LRP teaching methodology as average and 21.78 per cent reported the absence of an activity calendar based on the Learning Outcomes (LO) in their school. 44.71 per cent of students surveyed felt completely lost in education. 49.58 per cent are finding difficulty in coping with their studies. 37 per cent found the LRP learning unfriendly and said they found it difficult to read the LRP books provided by the school. Similarly, as per the report, on

RTE campaign status, 23.80 per cent of schools are short of 1 teacher compared to the number of sanctioned posts in their school 28.19 per cent, 16.32 per cent, and 6.64 per cent of schools are short of 2, 3, and 4 teachers, respectively. 17 per cent of schools are short

of 1 classroom compared to the number of classes in the school. Similarly, 26.26 per cent, 24.95 per cent, 11.09 per cent, and 5.54 per cent, of schools are short of 2, 3, 4, and 5 classrooms respectively.

The study found that 11.66 per cent of schools don't have drinking water facilities, 15.01 per cent of schools are using non-drinkable water sources. 11.24 per cent of schools do not have separate kitchen sheds. 14.70 per cent of schools don't have toilet facilities. 20.61 per cent of schools do not have separate toilets for boys and girls. 44.04 per cent of toilets in schools lack water facilities. The students do not use 30.07 per cent of toilets in schools, leaving them useless. 75.63 per cent of schools don't have playgrounds. 41.32per cent of schools don't have a boundary wall. The survey revealed that 28.35 per cent of schools do not have electrical connections. 88.13 per cent of schools need repairing. And 13.44 per cent of School Management Committee (SMC) members never participate in monitoring the school work.

The fact-finding on dropout, which covered 1,921 schools, found that 244 students (Class-III-VIII) had dropped out of school. With all those smartphone notifications, it's no wonder you lose focus on what you're trying to do do. Your phone doesn't even need to ping to distract you. There's pretty good evidence the mere presence of your phone, silent or not, is enough to divert your attention. So what's going on? More im-

portantly, how can you reclaim your focus, without missing the important stuff?

When you look at the big picture, those pings can really

Although estimates vary, the average person checks their phone around 85 times a day, roughly

once every 15 minutes. In other words, every 15 minutes or so, your attention is likely to wander from what you're doing. The trouble is, it can take several minutes to regain your concentration fully after being interrupted by your phone.

If you're just watching TV, distractions (and refocusing) are no big deal. But if you're driving a car, trying to study, at work, or spending time with your loved ones, it could lead to some fairly substantial problems.

The pings from your phone are "exogenous interruptions". In other words, something external, around you, has caused the interruption.

We can become conditioned to feeling excited when we hear our phones ping. This is the same pleasurable feeling people who gamble can quickly become conditioned to at the sight or sound of a poker

What if your phone is on silent? Doesn't that solve the ping problem? Well, no. That's another type of interruption, an internal (or endogenous) interruption.

Think of every time you were working on a task but your attention drifted to your phone. You



online, but you probably checked anyway. In this situation, we can become so strongly conditioned to expect a reward each time we look at our phone we don't need to wait

for a ping to trigger the effect. These impulses are powerful. Just reading this article about checking your phone may make you feel like ... checking your phone.

What do all these interruptions mean for cognition and wellbeing? There's increasing evidence push notifications are associated with decreased productivity, poorer concentration and increased distrac-

tion at work and school. But is there any evidence our brain is working harder to manage the frequent switches in attention?

One study of people's brain waves found those who describe themselves as heavy smartphone users were more sensitive to push notifications than ones who said they were light users.

tination in returning to a task can also leave you feeling guilty or frustrated. There's certainly evidence suggesting the longer you spend using your phone in unproductive ways, the lower you tend to rate your wellbeing.

We know switching your phone to silent isn't going to magically fix the problem, especially if you're already a frequent checker.

Start by turning off all non-essential notifications. Then here are some things to try if you want to reduce the number of times you check your phone:

Charge your phone overnight in a different room to your bedroom. Notifications can prevent you falling asleep and can repeatedly rouse you from essential sleep

throughout the night. Interrupt the urge to check and actively decide if it's going to benefit you, in that moment. For example, as you turn to reach for your phone, stop and ask yourself if this action serves a purpose other than distraction.

2 jumbos stuck in dug-well rescued

Baripada/Kuliana, Dec 8: Two elephants which had fallen into an abandoned dug-well were rescued in an operation spanning over eight long hours at Dehurisahi, Katharuma village under Kuliana block in Mayurbhanj district, late Wednesday night.

The animals after their rescue were reunited with their herd. The incident occurred when a herd of 35 elephants strayed into farmlands to eat paddy crops. The village is close to Similipal wildlife sanctuary under Baripada forest range.

Six elephants of the herd fell into an abandoned dug-well. While four of the animals managed to escape, a tusker and a calf failed to climb out of the muddy well for long hours.

Locals spotted the pachyderms in the water-filled pit this morning and informed the forest officials. On being informed, Chandua fire personnel and Baripada forest ranger Lakshmidhar Behera rushed to the spot and sought the help of villagers in rescuing the two elephants.

The fire and forest personnel as well as the villagers put up timbers and tree branches on the wall of the dug-well following which the animals could climb on it and come out of the well



Farmers allege scam in crop loan disbursal

COOPERATIVE BANKS SANCTION RABI LOANS TO FARMERS TO MAKE THEM PAY FOR PREVIOUS KHARIF LOANS

Jajpur, Dec 8: Cooperative banks have been caught on the wrong foot after farmers of this district alleged large scale irregularities in sanctioning of crop loans in the name of fake farmers. The matter came to the fore after

farmers alleging irregularities demanded a high-level inquiry to unravel the wrongdoings.

Reports said that farmers here have borrowed from the cooperative societies as well as central cooperative banks to raise their Rabi crops but the loan amounts, instead of being handed over to them, are being used to repay previous loans. The loans sanctioned for Rabi crops are adjusted against the previous

This is being done in violation of the directives issued by the Registrar of Cooperative Societies in June, this year.

Notably, the Registrar of Cooperative Societies (RCS) had issued a direction to all the Deputy Registrars of Cooperative Societies (DRCS). Assistant Registrars of Cooperative Societies (ARCS) and



the heads of all central cooperative banks in June, this year.

In the letter, he had said that the secretaries or managing directors of Primary Agriculture Cooperative Societies (PACS) or Large Area Multipurpose Societies (LAMPS) shall not keep the loan passbooks or the Kishan Credit Card (KCC) cheque books of farmers with them or use them for any means under any circumstances.

It is alleged that the loan books of farmers who had taken loans for 2022-23 Kharif season are only being renewed. As many as 1,01,739 farmers had taken ₹54,115.59 lakh as loan during the last Kharif season. The amount farmers had taken in previous loans is now being naid as Rabi loan.

According to available reports, so far only 30,244 farmers have been sanctioned with ₹14,959.37 lakh Rabi loan.

The loan is only being recovered in pen and paper as the amount each farmer had taken in previous loan is being sanctioned as loan for Rabi crops. Fearing that the cooperative banks might charge them more interest, the farmers keep their mouth shut and agree to this wrongdoing.

In reality, not a single penny is being paid to the farmers as loan for Rabi crops. While the pockets of farmers remain empty, the burden of additional Rabi loan and the accruing interest has shaken the farmers to the hilt.

Moreover, if the satellite report is taken into consideration, 10,158 acres of farmlands have gone uncultivated in the district during this period. The shrinking of farmlands is also indicative of a decline in the number of farmers.

This ultimately gives rise to doubts on large scale irregularities in sanctioning of loans in the name of fake farmers. Farmers claimed that a

clear picture could emerge if a high-level inquiry is undertaken to unravel the corruption.

Reports said over 122 PACS affiliated 10 cooperative banks operate in Jajpur district. The farmers are sanctioned loans for cultivation in Kharif and Rabi seasons through the cooperative banks.

Farmers alleged that it is nothing but a bait or allurement for them. The banks are not directly recovering the Kharif loan but collecting it on the pretext of sanctioning Rabi loan.

Farmers alleged that they had suffered crop loss during the last Kharif season due to floods and cyclonic storms. They were planning to make good of the loss and waiting for the disbursal of Rabi loan. However, the manipulative practice by the cooperative banks has hit them hard.

A farmer Gopinath Biswal alleged that he is now repaying his due for Kharif loan by taking the Rabi loan. He is forced to do this as he will have to pay 13 per cent more interest for the Kharif loan. He is not receiving a pie towards the Rabi loan. Left with no option, he has to borrow from the local money lenders.

Umerkote youth makes cheap drone at ₹4 lakh for agri works

Umerkote, Dec 8: A youth in Nabarangpur district has built a drone for agricultural works at a minimal expense of ₹4 lakh. It was on display at the Make in Odisha (MiO) conclave and is cheaper than the drones available in the market.

The youth was identified as Subhashis Sahu, son of Sujata and Rabindra Kumar Sahu of Gulipatna Sahi in Umerkote of Nabarangpur district and a B.Tech student in agriculture science at Centurion University.

His work has brought him glory and made the state proud as the drones used in agricultural works cost around ₹12 lakh in the market. Earlier, he had become the talk of the town by con-

structing a small ship. His work did not go unnoticed as the Chief Minister awarded him for his invention at the Make in Odisha (MiO) conclave. He received ₹1 lakh in cash, a certificate and a memento as recogni-

tion for his unique innovation. Notably, over 1,300 projects were on display at the Odisha start-up programme in MiO conclave out of which experts selected only 300 projects for the second phase. Later, 300 entrepreneurs made a presentation of their projects in PDF format thorough online



mode, November 26.

Out of those, the experts selected 22 projects where the entrepreneurs made a detailed presentation highlighting the attributes of their projects. The experts finally selected 10 projects including the drone constructed by Subhashis of Umerkote.

Subhashis has been a meritorious student from his childhood. His pursuit has always been to do something new. According to Subhashis, the drones

available in the market for agricultural work cost around ₹12 lakh and need skilled labourers to operate them.

Moreover, these drones can only spray pesticides on around 15 hectare of land at a time and will not be able to fly during rain and heavy wind.

However, the drone constructed by him costs only ₹4 lakh and can fly even in adverse weather conditions. The drone can identify the location where the pests have attacked the crops on the farmland with the help of a camera and inform the farmers.

The drone can fly even in adverse weather conditions like rain and heavy wind and spray pesticides over 25 hectare of land at a time. It can fly for long hours with a load of 10 kg of pesticides. Moreover, anyone can operate it and no skilled hand is required.

When contacted, Subhashis credited his success to his Professor Dr Sekhar Kumar Sahu of the Centurion University He was able to build the drone under his guidance and constant supervision. He said that he will apply for patent after his design is turned into a product.

He, however, will not sell the design but will build a brand and market the product, he said. The state government will provide him an accommodation for office where he will work on development of his drone. The state government has also promised to provide him financial and expert assistance to further his endeavour, he added.

FIFA's Follies

ount on the International Federation of Association Football, better known as FIFA, to come up with a fatuous slogan for the World Cup in Qatar: $\,$ "Football Unites the World." An official promotional video has Argentina's Lionel Messi and Brazil's Neymar mouthing the words in Spanish and Portuguese, respectively. Is it true? Does football really unite the world?

Of course not. It does not even unite nations. Back home in Brazil, the team's vellow and green colours have been coopted by supporters of the recently ousted president, Jair Bolsonaro (backed by Neymar), which has annoyed supporters of President Luiz Inácio Lula da Silva, backed by the team coach, Tite, and the dyed-blond striker, Richarlison.

The idea that sporting events unite the peoples of the world is an old obsession, going back to Baron Pierre de Coubertin's invention of the modern Olympic Games in 1896. Sports, in the baron's mind, and that of an endless succession of sporting officials, ought to transcend politics, international tensions, and any other discord. FIFA, too, subscribes to the fantasy of a world without politics, where conflict is confined to the playing fields.

In fact, the choice to hold this year's tournament in Qatar, a tiny oil-rich sheikdom with no footballing history or evidence of robust local interest in the game, is itself political. The country's ruling emir craved the prestige

of a global event, and Qatar had the money to buy it. Thick envelopes are said to have been slipped into the pockets of voting FIFA officials. And FIFA was richly rewarded for giving broadcasting rights to Al Jazeera, Qatar's statefunded TV channel.

FIFA evidently was not bothered much by Qatar's poor human-rights record, abuse of immigrant workers, and laws that punish homosexuality - certainly no more than even dodgier venues bothered the international sporting officials in the past. After all, the last World Cup tournament was held in Russia, which was already under international sanctions. And the 1936 Olympics took place in Hitler's Berlin.

But the fact that tiny Qatar, the first Arab country to host the World Cup tournament, wields such clout shows how much power has shifted in recent times. And FIFA, like the International Olympic Committee, always bends to the power of money, making it clear that neither the players nor visiting European dignitaries should wear armbands with the words "OneLove." That expression of support for people's right to love who and how they want was seen as a political statement, and FIFA cannot allow sports and politics to mix.

Except that it can and does. It has been perfectly acceptable for Iranian, Saudi, or Qatari

fans to express solidarity with the Palestinian cause by waving Palestine's flag in the football stadiums. So, while the Dutch minister for sport, Conny Helder, could do no more than wear a tiny "OneLove" pin, the Qatari official sitting next to her calmly tied an ostentatious Palestinian band around his arm.

Only the German team protested openly against the ban on expressing support for sexual freedom, covering their mouths in a group picture. They were quickly told by FIFA to stop or face serious consequences. Any criticism of human-rights violations in Qatar was swiftly met with accusations of racism, backed by FIFA's Swiss chief, Gianni Infantino, who reminded fellow Europeans of the "3,000 years" of Western imperialism. T-shirts bearing the words "woman" and "freedom" were prohibited as well, lest they irritate the Iranian theocracy, which is being challenged with those slogans at home.

So much for international unity. Just as notable is the lack of national unity. It was interesting to see how many Iranian women without headscarves were in the stands watching their national team. Even more remarkable was that demonstrators in Tehran and other Iranian cities, protesting the regime's efforts to bask in the glow of football victories, cheered when their team lost to the United States, of all countries.

Most remarkable of all was the refusal of the Iranian players themselves to sing the national anthem before their opening match against England. They were warned by the Iranian Revolutionary Guard Corps not to repeat this brave act of defiance in support of the demonstrations at home.

Then there was the extraordinary defeat of the young German team, which had tried to stand up for its sympathies. Like most national teams, the German side is multiethnic. One of their players, İlkay Gündoğan, has a Turkish background. Jamal Musiala, their best midfielder, has a Nigerian father. And the top German defender, Antonio Rüdiger, is a Muslim whose mother is from Sierra Leone.

When the team failed to proceed to the knock-out stage, only because Spain lost to Japan, conservative pundits in Germany blamed a lack of the traditional German fighting spirit. Members of the far-right Alternative für Deutschland party even said that lack of spirit was due to the team's desire to wear "woke" "OneLove" armbands. Even before this World Cup, the mixed national team was attacked in certain right-wing circles for not being truly German.

One of the ironies of modern football is that national teams whip up passions in a kind of carnivalesque performance of patriotic partisanship. That is why national rulers like to drape themselves in their country's footballing colours. But the players themselves are mostly colleagues in club teams all over Europe, speak several languages, and are often close friends off the field, making them unsuitable avatars for this type of chauvinism. They are members of an extremely wealthy, truly cosmopolitan, elite – just the type right-wing populists like to hate.

So, the football stars are, in a sense, united, even if the World Cup unites no one else. Still, one can understand why FIFA chose its slogan. "Money makes the world go round" would have been a little too honest.

ou may still on occasion encounter this term for a knight's warhorse, You may still on occasion encounter this term for a language though these days it's almost always employed by writers of historical novels. A work which is a science-fictional variation on the theme is Timeline by Michael Crichton (1999). The hero is sent back by time machine to medieval France but misses the last bus home. DEPENDENCE ON THE **DEVOLUTION OF TAXES AND GRANTS FROM** THE UPPER **TIERS HAS RISEN OVER THE**

♥he Reserve Bank of India's recent release of the annual 'Report on Municipal Finance' is undoubtedly a good yardstick to assess the poor state of municipal finances exists in the country today. As is well known, the 74th amendment, which came into force in 1993, suggested 18 functions that local bodies have to manage. But sources of funds being too meagre and localised revenue generation being insufficient, urban development has been greatly affected. The demographic skew in rural and semi-urban areas has been very much manifest. Cities are treated like piggy banks to fund programmes outside cities while infrastructure requirements in cities languish, reducing their growth potential.

"Most municipalities only prepare budgets and review actuals against budgeted plans but do not use their audited financial statements for balance sheet and cash flow management, resulting in significant inefficiencies," the report said. As is well known, local selfgovernance was introduced in India through 73rd and 74th amendment to the Constitution in 1992 through which multiple powers and functions were devolved to local governments. Functions were devolved separately for urban and rural India -- urban local bodies (ULBs) and the panchayati raj institutions, respectively.

The state of India's municipal finances has been quite critical for decades. An analysis of the structure and composition of revenue and expenditure of 35 metropolitan municipal corporations for the period 1999-00 to 2003-04 reveals that there is a mismatch between functions and finances of ULBs, which primarily explains the vertical imbalance. Out of 18 functions to be performed by municipal bodies in India, less than half have a corresponding financing source. Own taxes and user charges of the ULBs in India are grossly inadequate to meet their expenditure needs.

The availability and quality of es-

sential services for urban population in India has consequently remained poor. The rapid rise in urban population density, however, calls for better urban infrastructure, and hence, requires greater flow of financial resources to local governments. With own revenue generation capacity of municipal corporations declining over time, dependence on the devolution of taxes and grants from the upper tiers has risen. This calls for in-

novative financing mechanisms. RBI's analysis of municipal finances for the period 2017-18 to 2019-20 reveals that the combined budget size of the municipal corporations in India is much smaller than that of the Central and state governments. The composition of municipal revenue in India has changed considerably over time, with increased reliance on transfers. Also, the ratio of revenue expenditure to capital expenditure is lower than that of the Centre and the states. The report noted that Indian cities are far behind in being able to generate the resources required for providing good quality infrastructure and services to their citizens and lack financial autonomy. India lags the levels achieved by OECD and other BRICS countries. It may be mentioned here that countries such as Austria, Greece, Ireland, Lithuania, Mexico, Netherlands, Turkey, United Kingdom, were dependent on grants from the general government. However, the municipal finances of the developing countries and especially those in South Asia have been quite precarious like that of India.

Among the BRICS nations, the local governments in Brazil and Russia depended on general government grants whereas China and South Africa generated their own tax and non-tax revenues. Both China and South Africa generated more than 50% pof revenue through tax and non-tax sources while India generated only about 40% through these sources.

As the report rightly suggested. the increase in urban infrastructure in the country has not been on par with the pace of urbanisation that has taken place in the last decade or so as the performance of the urban local bodies has been rather poor. The dependence on the devolution of taxes and grants from the upper tiers has risen over the years. Alternative sustainable resource mobilisation through municipal bonds needs to be explored as per the report.

India's big development targets in areas like climate change, education and healthcare require a much higher degree of local autonomy. It goes without saying that city governments need more pow ers to raise revenue and need to be aggressive in this matter. They need to invest these resources to improve the lives of urban citizens. Water, power, sanitation, roads are critical constraints in India's desire to attract higher levels of manufacturing investment. Most studies predict India's urban population will surpass its rural population around the 100th anniversary of the nation's independence - around 2047. Once urban voters become crucial to electoral fortunes, state governments will have no alternative but to focus attention on city infrastructure. According to recent World Bank estimates, India will have to invest USD 840 billion over the next 15 years, or an average of USD 55 billion per annum into urban infrastructure to effectively meet the needs of its fast-growing urban population. Improvement of roads is of prime necessity in cities and towns and most of these are in pitiable conditions due to lack of repairs. For regular maintenance huge funds are required and for this toll tax may be levied. With the dwindling financial position of municipalities, there is possibly no other option but to resort to this method.

It is to be noted that the Adam group has been roped in for redevelopment of Dharavi, one of the biggest slums of the world. Such redevelopment can be considered in most metros with public-private participation, if necessary, as such development is sure to bring in money from sales of commercial spaces. How this project pans out is worth a watch.

However, overall, says the report, despite institutionalisation of the structure of local governance in India, there has been no appreciable improvement in the functioning of municipal corporations!

Tith climate change already affecting the lives and livelihoods of milthe need for a coordinated global response has never been more urgent. But to mobilise the huge sums required to finance the investments we need to ensure a climate-resilient future, the world must establish institutions that can support large-scale green projects and programmes in developing countries. Fortunately, we already have such institutions in place: multilateral development banks (MDBs).

When multilateral lending institutions emerged in the aftermath of World War II, some questioned their financial sustainability and capacity to mobilise private capital for public projects. But the MDB model has proven to be dynamic and able to leverage governments' capital contributions many times over. Given their access to cheap funds, highly rated MDBs can also offer long-term loans at relatively low cost, making them wellpositioned to provide the scale of support needed to address the complex challenges of climate change.

But the MDB model has yet to achieve its full potential. A recent independent report commissioned by the G20 finds that multilateral lenders are constrained by capitaladequacy requirements that place excessive limits on how much risk

they can assume. As a result, capital is being underutilized at a time when the world needs it most. The lions of people around the world, report recommends a series of measures, including more accurate risk assessment, that would enable MDBs to use capital more efficiently and increase their lending capacity. Over time, according to the report, these reforms could increase MDBs' lending capacity by hundreds of billions of dollars without hurting their AAA credit ratings.

While implementing these recommendations requires further analysis, MDBs already have a significant advantage over other lenders: preferred creditor treatment. This longstanding practice puts multilateral institutions ahead of other creditors in sovereign-debt repayment. But private investors and credit-rating agencies are unsure how to quantify the value of this convention, because it is not written into bond and loan contracts. And the unavailability of consistent, detailed data about MDB credit performance heightens uncertainty about the effect of this mechanism on credit performance.

That is why the G20 panel commissioned an independent analysis to model the effect of preferred creditor treatment practice by comparing multilateral lenders' credit performance to that of commercial lenders. The results were striking: based on publicly available data, borrowing countries are 3-4 times less likely to default on sovereign loans owed to multilateral institutions than they are on sovereign debt owed to commercial lenders, and MDBs' expected credit losses were 14 times lower. MDBs' existing capital-adequacy frameworks, the panel concluded, underestimate the value of this preferential status, as do the methodologies of credit-rating agencies. More accurate risk weighting could free up substantial MDB capital, and greater transparency of MDB credit histories would also boost private-sector interest in lending alongside MDBs.

MDBs' other major advantage is their ability to "call on" contingent government commitments and convert them into paid-in capital if they are at risk of defaulting on their obligations to creditors. But that has never happened, and analyses reviewed by the G20 panel found that such capital calls are extremely unlikely. Recognising that callable capital provides MDB creditors with additional financial security, rating agencies factor that into their bond ratings.

And yet most MDBs do not currently assign any value at all to their own callable capital. They should. Since such contingent commitments cover the extreme tail risk of default, multilateral lenders can safely adjust the risk parameters of their capital-adequacy frameworks to create more headroom for increased lending. Doing so would not materially increase risk and would preserve their bonds' sterling ratings. MDBs can also innovate in ways that enhance their lending capacity. The G20 panel recommends that multilateral lenders use private insurance, securitisation, and thirdparty guarantees to free up space on their balance sheets. It also proposes offering new forms of hybrid non-voting capital to private and public actors, and for shareholders to extend temporary callable capital to support higher lending during crises. These innovations are scalable and adaptable to each lender's unique circumstances. Moreover. they do not require changes in multilateral institutions' articles of agreement, shareholding structures, or governance. They also have wider strategic benefits.

For the past few decades, multilateral lenders have excelled at prudent capital management. But by improving their capital efficiency, they could turn a successful model into a powerful tool for creating a sustainable, carbon-neutral world.



SP defends Mainpuri bastion

Out of the six Assembly seats in five states where bypolls were held Monday, the Congress and the BJP won two each while one each went to the BJD and RLD after counting of votes Thursday

New Delhi/Lucknow, Dec 8: The Samajwadi Party retained the highprofile Mainpuri Lok Sabha seat, while the BJP wrested Rampur Sadar assembly seat in UP from it and Kurhani constituency in Bihar from the ruling Nitish Kumarled alliance in results of the December 5 by-elections announced Thursday.

The ruling BJP in UP, however, lost Khatauli to Samajwadi Party ally Rashtriya Lok Dal (RLD). The Congress retained its two assembly seats - Bhanupratappur in Chhattisgarh and Sardarshahar Assembly seat in Rajasthan's Churu district. The party is in power in the two states.

Dimple Yadav, the wife of SP chief Akhilesh Yadav, defeated her nearest rival and BJP candidate Raghuraj Singh Shakya by 2,88,461 votes in Mainpuri, a pocket borough of SP patriarch Mulayam Singh Yadav's family.

The win would provide some solace to Akhilesh Yadav after the defeat in the Uttar Pradesh assembly elections early this year and the loss of Azamgarh and Rampur Lok Sabha seats to the BJP in June bypolls.

Samajwadi Party ally Rashtriya Lok Dal's Madan Bhaiya defeated his BJP rival Rajkumari Saini by a margin of over 22,000 votes in Khatauli. Saini is the wife of former BJP MLA Vikram Singh whose disqualification from the state assembly following his conviction

in a 2013 Muzaffarnagar riots case necessitated the by-election.

Madan Bhaiya polled 97,071 votes, while Saini received 74,996, according to the Election Commission.

The BJP, however, for the first time won from SP leader Azam Khan's bastion Rampur Sadar which he represented before he was disqualified for his conviction in a hate speech case.

In Bihar, BJP candidate Kedar Prasad Gupta defeated Manoj Singh

Kushwaha of Chief Minister Nitish Kumar's JD(U) by 3,645 votes in Kurhani seat.

The JD(U) had snapped ties with the BJP four months ago.

In the cliffhanger of a contest, Gupta polled 76,653 votes while Kushwaha finished with 73,008 votes. The by-election was necessitated by the disqualification of RJD MLA Anil Kumar Sahani. The RJD is a constituent of the ruling Mahagathbandhan (grand

"The victory is an affirmation of the people's faith in the leadership of Prime Minister Narendra Modi and a resounding slap in the face of Mahagathbandhan which came to power by fraud and continues to cheat the masses", said Samrat Chaudhary, senior BJP leader and former minister, as he joined the jubilations outside the counting centre in Muzaffarpur.

Congress' Anil Sharma defeated Ashok Kumar Pincha of the BJP by a margin of 26.850 votes in Rajasthan's Sardarshahar assembly, with Chief Minister Ashok Gehlot describing it as "people's seal of approval" on his government's "good governance and public welfare schemes".

This is the 10th time the Congress won the seat since Independence. The bypoll was necessitated following the demise of senior Congress leader and MLA Bhanwarlal Sharma, who is Anil Sharma's father.

Congress candidate Savitri Mandavi won Bhanupratappur Assembly a margin of 21,171 votes against her nearest rival Brahmanand Netam of the BJP, a poll official here said.

Mandavi, the wife of Congress MLA Manoj Singh Mandavi whose death necessitated the by-election, polled 65,479 votes, while the BJP's Netam secured 44,308 votes, he said.

Former IPS officer Akbar Ram Korram, who contested as an independent, gave a spirited fight and polled 23,417 votes.

SC dismisses petition over mass killing of KPs

New Delhi, Dec 8: The Supreme Court has dismissed a curative petition seeking reconsideration of its 2017 order dismissing a plea which had sought investigation into the alleged mass murder of Kashmiri Pandits in the valley in 1989-1990.

A three-judge bench headed by

Chief Justice D Y Chandrachud rejected the plea and said no case is made out. "We have gone through the Curative Petition and the connected documents. In our opinion, no case is made out within the parameters indicated in the decision of this Court in Rupa Ashok Hurra vs Ashok Hurra. The Curative Petition is dismissed," the bench also comprising Justices S K Kaul and S A Nazeer said.

The curative petition, filed by an organisation of Kashmiri Pandits, 'Roots in Kashmir', had said the apex court was not justified in dismissing the writ petition at the admission stage in 2017 merely on presumption that the instances referred to in it pertained to 1989-1990 and no fruitful purpose would emerge as evidence is unlikely to be available at this late iuncture.

"This really amounts to failure of justice or gross miscarriage of justice caused to the petitioner in view of the fact that the petitioner has stated in the writ petition as well as in review petition that this court has not only entertained the writ petition and also passed necessary direction for trial etc. In cases where the incident pertains to even more than 30-32 years," the peti-



tion had said.

A curative petition is the last legal recourse in the apex court and is generally heard in-chamber unless a prima facie case is made out for reconsideration of the verdict

The organisation had initially filed a writ petition in the top court seeking investigation and prosecution of several persons in connection with killing of Kashmiri Pandits during 1989-90, 1997 and

Besides seeking other directions, it had also sought transfer of investigation of all the FIRs and cases of murder and other allied crimes against Kashmiri Pandits in the years 1989-90, 1997 and 1998 to some independent investigating agency like the CBI or the NIA or any other agency appointed by the top court.

The organisation had said in its plea that the Jammu and Kashmir Police had failed to make any progress in hundreds of FIRs pending with them.

EC accepts name change of SC: Jallikattu can't be TRS to Bharat Rashtra Samithi termed blood sport

Hyderabad, Dec 8: The Election Commission on Thursday informed TRS President and Chief Minister K Chandrasekhar Rao that it has accepted the name change of his party from Telangana Rashtra Samithi to Bharat Rashtra Samithi.

In a letter to the TRS chief, the EC cited a request from the party to accept its name change and said, "I am directed to refer to your letter issued on 05-10-2022 on the subiect cited and to say that the commission has accepted your request for change in the name of your party from Telangana Rashtra Samithi to Bharat Rashtra Samithi. The necessary notification in this regard will be issued in due course."



The EC's letter was made known to the media by KCR's office. Telangana's ruling TRS on October 5 changed its name to 'BRS', heralding the party's foray into 'national politics.' A resolution to this effect was passed at the party's general body meeting here. Rao read out the resolution and announced that the party's general body meet unanimously resolved to change the name from TRS to BRS.

Following the communication

People are not going to kill the animal. Blood may be an incidental thing," the bench, also comprising Justices Ajay Rastogi, Aniruddha Bose. Hrishikesh Roy and CT Ravikumar

The top court, which Thursday reserved its verdict on a batch of pleas challenging the Tamil Nadu law allowing "Jallikattu", made

the remark in response to the submission of senior advocate Shyam Divan, appearing for some of the petitioners, who insisted "Jallikattu"is a blood sport. "Blood sport used to be a very

common event across the world and it involves animal, fight or contest and great degree of brutality and cruelty. Secondly, there is scholastic material which appears to indicate that there are movements across the world which diminished cruelty from citizen's perspective. This combined with legal awareness and general reforms," Divan said.

The bench remain unimpressed and asked." How are you describing this as blood sport? Nobody is using any weapon. What is your understanding of the concept? Here people are bare handed. There may be cruelty involved but it cannot be termed as blood sport. Don't show us definitions. Tell us how?"

Divan submitted the term blood sport was used because it included killing or maiming inno-

No peace for families living near shell of Noida twin towers

Noida, Dec 8: Embattled residents of Noida's upscale Emerald Court complex must endure the deafening noise from machines drilling through the rubble of the razed twin towers well into the New Year, experts warn.

Mountains of earth, metal and concrete fly in the face of claims that workers had already carted away 60 per cent of 80,000 tonnes of debris of the skyscrapers demolished after the Supreme Court deemed them illegal and ruled that the remains of the 104-metre structures must be cleared by November 28.

Mayur Mehta of Edifice Engineering, which carried out the demolition and is overseeing the disposal of the rubble, said that the company had expected to be able to finish the work "in a month", but then came the ban on construction activities because of poor air quality and work was stopped for 25 davs last month. "We are now going

at full speed," Mehta told IANS. He denied allegations of violating noise pollution rules at the site where Apex and Cayenne stood till the demolition of the two towers comprising 914 apartments in all August 28. "The ambience-level sound was 64 decibels (dBA), near



the machines it was 78 dbA and at Aster-2, which is closest to the site,

the level was 58 decibels," he said, adding the Central Building

Research Institute was part of the survey and that all stakeholders accepted the findings and deemed the levels safe for residents.

At any given time, until 8 p.m. six to seven such machines work at the site. sandwiched between Emerald Court and ATS Village. Others said the pace of work has

slowed because of the quest for high-value iron. At least three residents were show-

ing visible signs of the impact frompollution, which has impeded their speech and other functions.

Sea port construction resumes at Vizhinjam

Thiruvananthapuram, Dec 8: With the fisherfolk calling off their over 130-day-long agitation, for now, against the Vizhjinjam sea port here two days ago, construction resumed there Thursday with trucks full of material rolling into the project site.

Visuals of the project site shared by a source in Adani Group showed the trucks loaded with construction materials rolling in and the surrounding area being devoid of protestors who were camped there for over four months.

The agitation was called off Tuesday and on the next day the protestors informed the Kerala High Court that the tent set up at the protest site outside the port was being removed.

The submission was made during hearing of a plea moved by Adani Group for contempt action against the protestors for not complying with the court's orders to not obstruct the way to the project site.

With the agitation being called off and the protestors assuring to remove the tent at the protest site, the High Court had closed the contempt pleas.

Subsequently, the construction work commenced Thursday at the port and the source said that the barge movement will start soon and in a few days it will be working at full swing.

The priority would be given to

completing the construction of the 2,960 metres long breakwater of which around 1,400 metres have been completed, the source said.

The source also said that 60 per cent of the reclamation for backyard construction has also been completed.

The agitators had been alleging that the unscientific construction of groynes, the artificial sea walls as part of the upcoming port, were some of the reasons for the increasing coastal

Plantation on 2L ha in NE to meet huge demand for rubber

Agartala, Dec 8: Under the NE-MITRA project, at least two lakh hectares of land would be brought under natural rubber (NR) cultivation in seven northeastern states with an investment of ₹1,000 crore to meet the country's growing demand for NR, Rubber Board chairman Sawar Dhanania said Wednesday.

He said that the northeastern states including Assam and Tripura, currently cultivate rubber in around two lakh hectares of land and annually produce 1.12 lakh tonne natural rubber

Dhanania, who is in Tripura for the past four days and holding meetings with various stakeholders and state government officials, said that India is now producing 7 lakh MT of natural rubber against the requirement of 12.50 MT.

To meet the domestic requirement of natural rubber, the country needs to expand the rubber cultivation in more traditional and non-traditional areas, he told the media. He added that four tyre manufacturing companies would invest ₹1.100 crore to undertake rubber plantation over an additional 2.00.000 hectares in northeast India in the next five years and the mission has already started.

The Rubber Board has identified a vast stretch of land in the northeast region and West Bengal for rubber cultivation.

To a question, he said that intercropping in the rubber gardens and rubber cultivating areas is increasing with various other crops being produced.

Beekeeping (or apiculture) is also

a viable scheme in the natural rubber cultivable areas. Referring to his meeting with Tripura Chief Minister Manik Saha, he said that to build up infrastructure, the state government would invest ₹500 crore.

Claiming that rubber cultivation is most eco-friendly, he said that rubber trees consume maximum carbon dioxide from the air and release maximum oxygen to nature. After 30 years, furniture with longevity was manufactured from the old rubber trees in the south Indian states and in Tripura. In the coming years, many more factories to make furniture from rubber trees are coming up in the country, Dhanania said

Another senior Rubber Board official said that the area under natural rubber in the country in 2021-22 was 8.26.660 hectares and the tappable area under rubber was 7,18,800 hectares in 2021-22, only 5,26,500 hectares (73.2 per cent) has contributed to the NR production during the year. The average yield, measured in terms of production per hectare of the tapped area, increased to 1,472 kg per hectare in 2021-22 from 1,442 kgha in the previous year. India consumed 12,38,000 MT of NR in 2021-22, an increase of 12.9 per cent from the 10,96,410 MT

consumed in 2020-21. At present, Tripura, which is the second largest NR producing state in the country after Kerala, is cultivating natural rubber on 89,264 hectare of land and annually producing 93.371 tonnes of rubber worth ₹1691 crore. About two lakh families, including tribals, are directly and indirectly associated with rubber cultivation in Tripura.

HIV CASES

Guwahati, Dec 8: Since April, 2,269 people have tested positive for HIV in Assam, which is much higher than the previous two years according to official data.

A total of 5,57,747 samples were tested from April to October this year. Of that, 2,269 samples turned out to be positive for HIV (human immunodeficiency virus), according to the Assam State AIDS Control Society (ASACS).

Among these patients were 131 pregnant women, it said.

In 2021-22, a total of 2,366 HIV cases were detected in the state, while it was just 1,288 in 2020-21.

ASACS Assistant Director Rajib Sarma said Assam has 25,073 people living with HIV (PLHIV) as per NACO HIV Estimation Report 2021. "Out of this, 45 per cent of PLHIVs are female. Children living with HIV are 3 per cent," he

The total number of people alive by taking Anti-Retroviral therapy (ART) is 10,765 in the state.

"The HIV prevalence rate in India is 0.21 per cent and the same rate in Assam is 0.09 per cent,'

As far as the HIV prevalence in the districts is concerned. Kamrup Metropolitan has the maximum number of cases at 7,610, followed by Cachar at 5,200 cases, Nagaon at 1,602 cases and Dibrugarh at

"81.63 per cent is transmitted through heterosexual route, 5.54 per cent is through HIV-infected syringe and needles, parent to child is 4.76 per cent, through homosexual route is 4.61 per cent, 0.85 per cent through blood and blood products, and 2.61 is not specified," Sarma said.

To create HIV awareness among the people, the ASACS is using the press, outdoor advertising, folk arts and social media, among

Meghalaya: Drones to send medicines to remote areas

Shillong, Dec 6: Meghalaya will begin utilising larger drones from March 2023 to deliver up to 25 kg of medicines, anti-snake venom vials and other healthcare necessities in the remote, mountainous and farflung areas to save time and costs, officials said Tuesday.

Director of the Meghalaya Health Systems Strengthening Project, Ramkumar S said that the state government unveiled the northeast region's first drone delivery hub and network, in partnership with TechEagle, one of the fastest-growing drone delivery startups.

The project started with the launch of Asia's first drone delivery hub built at the Jengjal Sub-Divisional Hospital in West Garo Hills district Monday afternoon by the state's Health and Family Welfare Minister James PK Sangma.

The first official drone flight took off from the hospital and delivered medicines to Padeldoba primary health centre in less than 30 minutes which would have otherwise taken 2.5 hours by road.



Sangma said "We are seeing something that is unparalleled in any place of the world. It is a matter of pride for the state of Meghalaya that we would be the first state to institutionalise this initiative and have a system that can be expanded to other areas of the state as well."

Ramkumar S said that the ground-breaking effort intends to improve the universal access to healthcare in the state by delivering vital supplies like drugs, diagnostic samples, vaccines, blood and blood components quickly and safely to different regions of the state using a dedicated drone delivery network.

He said that the project aimed at providing access to life-saving drugs and other medical essentials to far-flung and hard-to-reach areas of the state.

Organised by the Union Ministry of Tourism, the objective of the International Tourism Mart is to highlight tourism potential of the northeast region in domestic and international markets.

The International Tourism Marts are organised in the northeastern states on a rotation basis.





Saudi Arabia, China sign strategic deals

Rivadh, Dec 8: Saudi Arabia and China showcased deepening ties Thursday during a visit by President Xi Jinping, including one with tech giant Huawei, whose growing foray into the Gulf region has raised US security concerns.

King Salman signed a "comprehensive strategic partnership agreement" with Xi, who received a lavish welcome in a country forging new global partnerships beyond the West.

Xi's car was escorted to the king's palace by members of the Saudi Royal Guard riding Arabian horses and carrying Chinese and Saudi flags, and he later attended a welcome banquet.

The Chinese leader held talks with Crown Prince Mohammed bin Salman, de facto ruler of the oil giant, who greeted him with a warm smile. Xi heralded "a new era" in Arab ties.

The display stood in stark contrast to the low-key welcome extended in July to US President Joe Biden, with whom ties have been strained by Saudi energy policy and the 2018 murder of Jamal Khashoggi that had overshadowed the awkward visit. The United

Its vote share fell sharply to 27 per cent from 42 per cent in 2017, with the AAP cornering most of these anti-BJP votes. Debutant AAP was seen securing 13 per cent votes.

In Himachal Pradesh, the Congress found itself in a better position, winning in 40 seats and a vote share of 43 per cent. But the dismal showing in Gujarat would impact the party's bargaining power vis-a-vis other opposition parties. Also, losing Gujarat badly could add



India's top 100 firms create ₹92.2 trillion wealth in 5 years

Technology sector has been the largest wealth-creating sector between 2017 and 2022, followed by the financial sector

Mumbai, Dec 8: Two Adani group companies -- Adani Enterprises and Adani Transmission - have uprooted the traditional leader Reliance Industries in annual wealth creation in 2022 so far, while the top 100 of them created a massive Rs 92.2 lakh crore of wealth, during the 2017-22 period, according to a report.

However, Reliance Industries has smashed all records to emerge as the largest wealth creator during the five-year period ending March 2022, says the leading brokerage Motilal Oswal in its 27th annual wealth creation study.

The Gautam Adani group companies have been rallying to dizzying heights in the year as the group snapped up many assets and diversified into newer areas.

The rally was so high that Adani September 16 became the second richest person in the world with \$155.7 billion, only second to Elon Musk who had \$253.5 billion of net worth, according to the Forbes real-time billionaires list. The spike was following the stocks of Adani Enterprises, Adani Ports and Adani Transmission hitting record highs on that day.

Adani, who owns 75 per cent each in these three companies, has added more than \$70 billion to his fortune in 2022 in mid-September. As against this, Ambani was pushed to the distant eighth slot with a net worth of \$92.3 billion.

creators, respectively between 2017 and 2022. Adani Enterprises and Adani Transmission are also the top all-round wealth creators, said the report.

The study is based on the analyses of the top 100 wealth creating companies during the 2017-22 and the wealth created is calculated as change in the market capitalisation of these companies between 2017 and 2022, duly adjusted for corporate events such as mergers, de-mergers, fresh issuance of capital, buyback, etc. These companies created Rs

92.2 lakh crore of wealth during this period, which is the highest ever so far, the report said, adding Reliance has smashed all records to emerge as the largest wealth creator during the five-year period.

This is for the fourth time in a row that Reliance has emerged as the largest wealth creator over 2017-22. This takes Reliance's overall No.1 tally to 9 in the last 16 five-year study periods.

While TCS, Infosys and HDFC Bank remain among the top 5 wealth creators, Adani Transmission is the fastest wealth creator for the second time in a row

with a CAGR (Compounded Annual Growth Rate) of 106 per cent, and Adani Enterprises is the most consistent wealth creator for the second successive year.

Over 2017-22, Adani Enterprises has emerged as the most consistent wealth creator, outperforming the Sensex in all the last five years, and offering the highest price CAGR of 97 per cent. The company is also the best all-round wealth creator, followed by group company Adani Transmission.

The technology sector has emerged as the largest wealth creator after a gap of eight years, while the public sector turned out to be the worst. The only public sector unit that created wealth is Gujarat Gas, but its contribution is just 0.3 per cent of the total wealth created.

FPIs bet on financial services

India's outperformance is expected to continue going forward as the US, Europe and China continue to grapple with their own problems including high inflation, possibility of slowdown in economic growth

New Delhi, Dec 8: The Indian financial services space seems to be in a sweet spot as foreign investors have made a net investment of Rs 14,205 crore (\$2.1 billion) in the sector in November amid strong credit growth and manageable non-performing loan portfolio.

The investment comes following a net withdrawal of Rs 4,686 crore from financial services stocks in October on account of profit booking.

Overall, foreign portfolio investors (FPIs) have made a net investment of Rs 36,238 crore in the country's equity markets in November. Of this, the financial services sector attracted Rs 14.205 crore, which accounts 39 per cent of total investment made by FPIs in equities, data with National Securities Depository Limited (NSDL) showed.

Most of the buying was concentrated in the first half of the month of November 2022.

Manish Chowdhury, Head of Research at Stoxbox, said the financial services sector is coming out of a lean period and is doing well due to a strong uptick in loan FPIs inject ₹14,205 crore in financial services in Nov

growth and manageable non-performing loan portfolio.

'We believe that an expected acceleration in capex spending should ultimately trickle down to enhanced incomes which would open opportunities on a wide range of financing frontiers including housing, vehicle, SME, etc. The margins of these companies should also benefit from low-cost deposits garnered earlier," he added.

At the end of November, assets under custody of the financial services sector stood at Rs 16.13 lakh crore.

After the financial services stocks, fast moving consumer goods (FMCG) emerged as the second most preferred sector with a net investment of Rs 3.956 crore. The inflow was mainly driven by steady consumption.

"Consumption stocks are drawing inflows amid steady private consumption in Urban India and expectations of a revival in rural demand given the healthy sowing of the Rabi crop," Hitesh Jain, Lead Analyst - Institutional Equities

at YES Securities, said.

According to Bajaj, commodity prices have fallen sharply in recent times which may have reduced the input cost for the FMCG company that could translate into expansion in margin for this segment.

The FMCG sector was followed by information technology at Rs 3,859 crore, auto at Rs 3,051 crore and oil, and gas sector at Rs 2,774 crore.

"IT companies remain attractive for FPIs given the under-ownership and considerable dilution in the valuation of IT stocks," YES Securities' Jain said.

On the other hand, consumer durables saw the maximum selling by FPIs in November at Rs 1,275 crore. Besides, power and telecommunications witnessed sales of Rs 1,100 crore and Rs 1,084 crore respectively.

As far as overall FPI flows are concerned in the equity markets, it will depend upon the US Federal Reserve's policy meeting which is scheduled on December 13-14. However, risk-on sentiments seem to have improved recently as prospects of rapid quantitative tightening cycle have receded amidst fallen bond vields.

Startups see 35% slide in funding

New Delhi, Dec 8: As the funding winter deepens amid growing layoffs, India saw a massive 35 per cent drop in funding this year, from \$37.2 billion in 2021 to \$24.7 billion (till November in 2022) and edtech startups saw a significant 39 per cent drop compared to the same period last year, a report showed Thursday.

The significant drop in funding is attributed to a decline in latestage investments, which fell by 45 per cent from \$29.3 billion in January-November 2021 to \$16.1 billion for the same period this year, according to data provided by Tracxn, a leading global market intelligence platform.

Seed stage rounds also experienced a contraction and dropped by 38 per cent as compared to the previous year. The number of big ticket (\$100 million and above) funding rounds dropped by 35 per cent to 55 as compared to 85 in the reported period. The number of funding rounds saw a drop of 30 per cent, from 2,647 last year to 1,841 this year, the report said.

BYJU's raised \$1.2 billion in 2 such more than \$100 million rounds, followed by VerSe and Swiggy, raising \$805 million and \$700 million, respectively.

Earlier this week, foodtech platform HealthKart raised \$135 million in a funding round led by Temasek, with participation from A91 Partners and Kae Capital, somewhat breakThe funding winter, which

began in Q4 of 2021, will persist in 2023 as well. In order to survive the drought, startups are taking unit economics more seriously, which has been illustrated through the series of mass layoffs that have_ occurred this year," said Neha Singh, Co-Founder, Tracxn.

Led by the edtech sector, Indian startups have laid off more than 16,000 employees to date, and the number is only growing

This year saw enterprise applications, fintech and retail emerge as the top performing sectors in terms of funding. However, fintech and retail were not adverse to the effects of the funding slowdown and saw a drop in funding -- 57 per cent and 41 per cent, respectively -- compared to the same period last year.

The disruption to the fintech sector has been brought on by an RBI policy that prohibits non-bank financial institutions (NBFIs) from loading their prepaid instruments using credit lines and the ruling impacted the business model of companies like Slice and Uni Cards.

Furthermore, with crypto experiencing major volatility in asset prices this year, crypto exchanges across the globe as well as in India are facing operational difficulties.

Bangalore led the maximum total funding raised, the most active investors of the year being Lets Venture. AngelList and Y Combinator.

Navi Mumbai, Dec 8: The buildup to the series has been far from ideal but the Indian women's cricket team will be keen to give a tough time to the all-conquering Australia in the five-match T20 rubber beginning here Friday.

With two months go for the T20 $\,$ World Cup in South Africa, the Harmanpreet Kaur-led side should also exactly know where they stand following the five games.

Head coach Ramesh Powar was suddenly sacked three days before the series opener and former India batter Hrishikesh Kanitkar is now in charge of the support staff as the designated batting coach.

India managed to win the Asia Cup in October though they were guilty of experimenting a tad too much which cost them a league game against Pakistan.

In the recent past, India have managed to compete against the mighty Australia but failed to get over the line. One such case was their last meeting in the Commonwealth Games final in August when India threw it away after a blinder from Harmanpreet in the run chase.

The batting has a settled look with star batter Smriti Mandhana expected to score the bulk of the runs. Her opening partner Shafali

Navi Mumbai, Dec 8: Indian women's cricket team skipper Harmanpreet Kaur on Thursday denied any fallout with Ramesh Powar who has been sacked as the head coach with less than two months to go for the T20 World Cup.

In a repeat of the 2018 saga when Powar was replaced as the head coach after being at loggerheads with then captain Mithali Raj, the former India spinner once again faced the axe and was shunted to the National Cricket Academy, reportedly on request of Harmanpreet.

Harmanpreet, however, categorically denied the reports of rift and termed it a "decision" taken by the BCCI. "Well, it's nothing like that. I've always enjoyed working with Ramesh sir whenever I got an opportunity. We have learnt a lot from him and grown as a team," she said on the eve of their five-match T20I series against Australia.

"It's the BCCI's decision who's moved to NCA. He will work there as the spin coach, and whenever we'll go to NCA, Ramesh sir is always available.

The board has now roped in Hrishikesh Kanitkar as the batting coach of the team and he will be at the helm for the series against Australia. Former India all-rounder Kanitkar was in charge when they won a series in Sri Lanka and Harmanpreet said he's the "apt candidate" for the job and that the team is in the right hands.

Hailing his "calmness", she said: "We had a very good experience with him when we were in Sri Lanka. He was always available whenever it's needed. He brings a lot of experience to the team. We are only looking forward and how we proceed further. We are in right hands. We are fully okay with whatever the decision BCCI is taking.

"He's very calm. We needed someone who can give that calmness on the field. You would have seen that in the past at a crucial time, the girls need that support, someone who can guide with calmness and tell us what and how to do with some clear thoughts. We had experienced that in Sri Lanka.'

She further said the team was very excited when they got to know that Kanitkar was coming on board. "It would have been difficult if it was a new coach, but we have already worked with Hrishi sir.

"I don't think there will be any problem. If a new coach would have come we would have to explain a lot of things, how we are working. He already knew the type of work we were doing. I don't think there would be any major changes. When we got to know that he's coming on board, the team got a lot positivity because we really liked the way he worked with us in Sri Lanka.3

The Indian skipper also spoke on the BCCI's decision to bring in pay equity which means the centrallycontracted men and women players would get the same match fee. As per the new policy, the women players will now get Rs 15 lakh per Test, Rs 6 lakh for an ODI and Rs 3 lakh for a T20I. The new pay structure will come into effect from

the series against Australia. "It's an outstanding decision taken by the BCCI. Equal pay is something that brings a lot of motivation to the current players and the upcoming stars. It gives a lot of responsibility; we know many people are watching us whenever we go out and play. We want to give our 100 per cent.'

"Definitely this was the first step. I'm sure there would be many more to come. I'm sure the BCCI must be thinking about (equal pay) in domestic cricket as well,

Harmanpreet said. "Domestic cricket is very important. Now, the Women's IPL is coming, and all those things will be important for domestic cricketers. There is money involved, and with that we will get a lot of good domestic matches. Things will come to you. We just need to perform.'

Harmanpreet said their main objective is to win an ICC global title which has been missing from their trophy cabinet.

We have to play good cricket now, taking a lot of responsibility as a team. Every tournament, we are reaching finals, but we are yet to win that big trophy. But the way we are playing, a lot of things have changed in the country.

India will play the first two T20Is at the DY Patil stadium December 9 and 11, before moving to CCI for the remaining three fixtures December 14, 17 and 20. The series will be a good preparation for the T20 World Cup in South Africa, starting February 10.

Labuschagne, Head tons prop Australia



Adelaide, Dec 8: Marnus Labuschagne (120 batting, 235b, 11x4) and Travis Head (114 batting, 139b, 12x4) posted unbeaten centuries in a 199-run stand to lead Australia to 330/3 against West Indies at stumps on day one Thursday of the second cricket Test.

Labuschagne scored his third century in as many innings against West Indies. Head scored his first Test century on his home ground – Adelaide Oval – in the day-night match.

Both teams made injury-enforced changes following Australia's 164run win in the series-opener in Perth last weekend. Marquino Mindley, one of three changes for the depleted West Indies, left the field with a hamstring strain after bowling just two overs on debut.

The Australians got on top early after stand-in captain Steve Smith won the toss and opted to bat first. Usman Khawaja (62, 129b, 9x4) shared a 34-run opening stand with David Warner (21) and 95 with Labuschagne for the second wicket before his dismissal for 62 triggered the only slight wobble in Australia's innings.

came off 125 deliveries. West Indies skipper Kraigg Brathwaite cycled through seven bowlers in pursuit of a wicket on a pitch that favored the bat, with only Joseph (1/81), Holder and Thomas getting any rewards.

Clarke hits out at 'inconsistent' **Cricket Australia**

Melbourne, Dec 8: Former Australia captain Michael Clarke has accused his country's cricket board of double standards and making David Warner the "scapegoat" in its messy handling of his captaincy ban following the balltampering scandal.

Four years after the Warner is still living with the leadership ban while accomplice Steve Smith happens to lead Australia in the ongoing day-night Test against the West Indies.

Not prepared to let his family be the "washing machine for cricket's dirty laundry", an angry Warner Wednesday withdrew his application for revocation of lifetime leadership ban, saying the independent review panel wanted him to go through "public lynching".

Showing support to his former teammate, Clarke said the Cricket Australia's review of the scandal has been inconsistent. "You can tell he's disappointed and frustrated,' Clarke said on Big Sports Breakfast. "I think the other thing that probably hurts a little bit more is the fact Steve Smith is going to captain this Test match.

"I can understand Davey's disappointment. In regards to where Davey is with his age, he's unfortunately missed out on the captaincy opportunity in my opinion. I don't think that's the concern, it's the fact it's taken so long to process this or to get to where it's at.

"I see it as very inconsistent. I find it very hard to believe it's okay for one but not okay for the other to have a leadership role. If CA decided all the guys involved in what went down in South Africa, none of them were going to play a leadership role, I think that's a fair call."

Clarke feels Warner has been made the scapegoat for the incident that happened in 2018. "But if it's okay for one, if it's okay for Smithy, it's got to be ok for (Cameron) Bancroft and it's got to be okay for Warner.

"I don't know if it's fair to make David Warner the complete scapegoat and say everyone else can go back to normal. We'll forgive you but we won't forgive Davey."

Clarke further said he wasn't 100 per cent supportive of any of the three being involved in a leadership role and that the scandal would linger until they retire.

Formers slam India's 'outdated' approach

New Delhi, Dec 8: Former players Virender Sehwag and Venkatesh Prasad has slammed India's "outdated" approach following their ODI series loss in Bangladesh.

Expressing anguish over India's miserable run in white ball cricket, former seamer Prasad urged the think tank to make "tough calls", while Sehwag urged Rohit Sharma and Co to "wake up".

In his usual quirky style, Viru took to Twitter to describe his anguish: "Cryptos se bhi tez gir rahi hai apni performance yaar. (Our performance is falling faster than cryptos). Need to shake up - wake up.'

India earlier lost 0-1 to New Zealand in a rain-curtailed ODI series. Playing non-stop cricket, the star-studded Indian batters looked out of place while bowling has been below par.

That India have not won a major ICC title since their Champions Trophy triumph in 2013 was once again highlighted by Prasad.

"India is innovating in so many fields across the world. But when it comes to playing Limited overs cricket, our approach is a decade old," Prasad wrote in a series of tweets.

"England after the 2015 WC first round exit took tough calls and turned around to become such an exciting team, India need to take tough calls. And change approach drastically. We haven't won a T20 WC since the IPL started & last 5 years have been poor in ODI's apart from winning inconse-

quential bilateral. "Haven't learned from our mistakes for too long and far from being an exciting team in limited overs cricket. CHANGE," he added. India will look to secure a consolation win in the third ODI in Chattogram Saturday.

Former coach Madan Lal lashed out at India, saying the team lacked "intensity and passion" and was heading in the wrong direction.

"Definitely the Indian team is not going in the right direction. I have not seen the intensity in the team off late. I have not seen 'Josh' in them in the last couple of years," Lal told PTI in an interview.

'They are not looking like an Indian team at all. That passion of playing for the country is missing. Either their bodies are too tired or they are just going through the motions. And this is a serious

However, errors again crept up in his game as Prannoy rushed on to a couple of shots and allowed Lu to turn the ta-
