# HONOURS DEGREE **AFTER FOUR YEARS**

The draft 'curriculum and credit framework for four-year undergraduate programmes' prepared in accordance with National Education Policy is likely to be notified Monday

New Delhi, Dec 10: Students will be able to get an undergraduate (UG) 'Honours' degree after completing four years instead of three. according to new draft norms prepared by the University Grants Commission (UGC).

The draft 'curriculum and credit framework for four-year undergraduate programmes' (FYUP) prepared in accordance with National Education Policy is likely to be notified Monday.

"Students will be able to get a UG degree in three years on completion of 120 credits (measured through the number of academic hours) and a UG Honours degree in four years on completion of 160 credits. If they wish to go for a research specialisation, they will have to undertake a research project in their four-year course. This will get them an Honours degree with research specialisation," the draft read.


The FYUP also allows multiple entry and exit options for students. If they leave before three years, they will be allowed to rejoin within three years of their exit and will have to complete their degree within a stipulated period of seven years.

The curriculum for FYUP, as suggested in the document, consists of major stream courses, minor stream courses, courses from other disciplines, language courses, skill courses, and a set of courses on environmental education, understanding India, digital and technological solutions, health and wellness, yoga education, and sports and fitness.

At the end of the second semester, students can decide to continue with their chosen major or change their major.

Students will also have the option to go for a UG either with single major or double majors.

"A student has to secure a minimum of 50 per cent credits from the major discipline for the 3-year/4year UG degree to be awarded a single major," read the document.



#### PRADHAN HINTS AT **EARLY POLLS IN STATE**

Bhubaneswar, Dec 10: Senior BJP leader and Union Minister Dharmendra Pradhan Saturday indicated at early Assembly elections in Odisha.

Speaking to media persons here, Pradhan said, "I have heard that elections might be conducted early here (in state). The election may hap pen after eight months or 15 months. A lot of developments will take place in between.

A number of issues will crop up ahead of the next elections and political parties will fight the electoral battles with their own agenda he said. "We have fought the 2019 general election and emerged as the principal opposition party in the state. People of Odisha have a lot of trust in Prime Minister Narendra Modi and will continue it," he said.

Commenting on BJP's defeat in Padampur bypoll, Pradhan said, "We humbly accept the mandate of the people. Whoever made the comments on insulting women should not forget that BJP got 78,000 votes there, which includes women votes." ### **Babus-contractors nexus** bleeds OCCL of ₹20 crore

Bhubaneswar, Dec 10: The nexus between the Odisha Construction Corporation Limited (OCCL) officials and contractors has resulted in the state-owned firm incurring losses to the tune of over ₹20 crore, if a recently released Comptroller and Auditor General (CAG) of India report is any indication.

In a report, which was tabled in the recently-concluded Winter Session of the Assembly, the CAG said that OCCL, which is under the administrative control of Water Resources (WR) department, did not

achieve turnover targets in three years—2017-18, 2018-19 and 2020-21. The actual turnover decreased by over 52 per cent from ₹874 crore in 2016-17 to ₹422 crore in 2020-21

It said the cost estimates of the projects were not prepared as per the schedule of rates. "Due to overblown cost of dredger and pipelines in the estimates, undue benefit of ₹7.72 crore was extended to the contractor in removal of shoal in the upstream side of Mahanadi barrage," it pointed out.

OCL incurred avoidable expenditure of ₹4.74 crore due to adoption of excess hire charges of machinerv for compaction of earth in six test checked projects, it said.


"Undue benefit of ₹5.61 crore as extended to workers in two projects due to payment of prohibited conveyance charges on stones issued from the

> worksite," the CAG report read. Advances of ₹3.66 crore relating to 138 works remained outstanding against

suppliers for over a year. Similarly, advances of ₹3.53 crore against 446 officials were lying outstanding as of March

2021, it added. OCCL had neither prepared any three-year corporate plan nor annual plans for submission to the WR department. "In the absence of such plans, there was a high risk that the company did not have a clear-cut, well documented strategy in place to achieve its aims and objectives vis-à-vis the mandate assigned to it when it was set up by the administrative department," the CAG pointed out.

#### Sukhu to be crowned **Himachal CM today**





Shimla, Dec 10: Sukhwinder Singh Sukhu, who headed the Congress campaign committee in Himachal Pradesh, will be the next Chief Minister of the hill state.

Mukesh Agnihotri, the leader of the opposition in the outgoing Assembly, will be the Deputy Chief Minister, the party said after a meeting of the Congress Legislature Party (CLP). Sukhu, the 58-year-old MLA from Nadaun in Hamirpur district, was elected the CLP leader and will take oath as the CM Sunday, the party said. In a meeting Friday, the MLAs had unanimously passed a resolution authorising the party president to pick the legislature party leader. The Congress wrested power from the BJP in the northern state winning 40 of the 68 Assembly seats.

## France to make condoms free even for minors

AGENCIES Paris, Dec 10: France will make condoms free in pharmacies for anyone up to age 25 in the new year, President Emmanuel Macron has announced.

The move comes as the government says sexually transmitted diseases (STDs) are on the rise among young people, and as this year's exceptional inflation is cutting especially deeply into the budgets of France's poorest.

Girls and women 25 and under already can get free birth control in France as part of government

efforts to ensure that young people of all incomes can prevent unwanted pregnancy. Existing measures don't apply to men, however, or specifically address access for transgender or nonbinary people.

Macron had said Thursday that condoms would be free in pharmacies for anyone 18-25 starting

January 1. But after a French TV presenter and others challenged him on social networks Friday over why the condom measure did not include minors, the president agreed to expand the program.

"Let's do it," Macron said in a selfie video that he shot from the sidelines of a summit in Spain. He later tweeted: "A lot of minors also have sex ... They need to protect themselves too.'

Macron, who was France's youngest-ever president when he was first elected in 2017 at age 39, also promised stepped-up efforts to prevent and test for HIV and other sexually transmitted viruses.

France's state healthcare system covers some birth control costs but not all, and doctor appointments for low-income patients often require long waits. Abortions in France are available free for everyone. Several other European countries offer free or subsidised contraception.

proving access to contraception. In 2018, the French government started reimbursing the costs of condoms to individuals, if purchased in a pharmacy with a prescription from a doctor or midwife.

Earlier this year, the government made contraception free for all women up to 26 years old - a move that affected three million women. Contraception had previously been free for women and girls 18 or younger.

Macron added in a tweet that the healthcare measures include free emergency contraception for all women in pharmacies, and free STD screenings without a prescription, except HIV, to those under the age of 26.

#### Stuck in borewell for 80 hours, MP boy dies

Bhopal, Dec 10: The boy, who fell into a deep borewell in Betul district of Madhya Pradesh Tuesday evening, could not be rescued as his body was found Saturday morning. The rescue operation was started soon after the incident was reported, but the boy had stopped responding by Wednesday.

NDRF and SDRF teams under the supervision of district administration continued rescue operation. They dug a tunnel at the side of the borewell. However, the process took more than 80 hours and by the time, they could reach to the boy.

The rescue operation completed by early Saturday and the doctors declared the boy dead. Betul district administration later issued an official statement Saturday, stating that the boy died hours before he was rescued. CM Shivraj Singh Chouhan expressed his condolences and announced a compensation of ₹4 lakh to the family.



ABHA ID is a unique health ID for citizens to access medical records anytime and anywhere in India. It



gives complete digitised history of their health, which gives a better understanding of their health status to doctors and other healthcare providers for appropriate and timely diagnosis and treatment, it

According to sources, the United Nations officially designated Universal Health Coverage Day in 2017. The theme for this year is 'Build the World We Want: A Healthy Future for All', which underscores the role and importance

of health coverage in building a

healthy future for all. In order to achieve the feat, the Health and Family Welfare (H&FW) campaign across the state with special emphasis on ABHA ID creation, improving utilisation of e-Sanjeevani (telemedicine services) and strengthening of all e-Health initiative at sub-centre level from October 12, 2022, a senior official said

# **Chief Secy told to pay ₹5 lakh** aid in Barbil custodial death

Bhubaneswar, Dec 10: The National Human Rights Commission (NHRC) has asked the Chief Secretary to pay Rs 5 lakh as compensation to the next of kin of a man who died by suicide in police custody at Barbil in Keonjhar in 2019.

Hearing a plea filed by Supreme Court lawyer and human rights activist Radhakanta Tripathy, the commission also asked the Chief Secretary to submit the compliance report along with proof of payment within six weeks.

In his petition, Tripathy had sought the intervention of the commission and demanded compensation for the next of kin of Suresh Naik who committed suicide in the custody of Barbil police in Keonjhar district November 21, 2019.

Taking cognizance, the commission served a notice on the Keonihar superintendent of police (SP) seeking his response over the allegations in the petition. The Keonjhar SP submitted the copy of magisterial enquiry report of incident along with chemical examination report June 17, 2022.

The NHRC examined the enquiry report by the Judicial Magistrate First Class (JMFC) of Barbil who denied fetching any evidence indicating foul play or ill-treatment on the deceased by the police officials at the Barbil police station.

However, the NHRC observed that had the guard deployed to keep a watch on Naik, been alert. the deceased could not have got an opportunity to die by suicide and

Hearing a plea filed by Supreme Court lawyer and human rights activist Radhakanta Tripathy, the commission asked the Chief Secretary to submit the compliance report along with proof of payment within six weeks

"for this, the state cannot escape its liability for the death of the person in police custody."

'Nevertheless, there is no apparent foul play or ill treatment to the deceased by public servant as it reveals from the enquiry report of the magistrate, but it remains sacrosanct that arrest can cause in calculable harm to a person's reputation and self esteem and therefore, it rests upon the police official to keep a proper vigil over the arrestee/detenue to minimize self-inflicting harm also," the commission observed in its order.

The NHRC reiterated that as the deceased was under the custody of police so it was the responsibly of the latter to take all precautionary measures to ensure that a person under its custody does not harm himself. The commission also referred to the observations of the Supreme Court in DK Basu vs. State of West Bengal 1997(1) SCC 416 over the matter.

The NHRC found that the state or its machinery fails to discharge the vicarious liability under the law and the state cannot escape liability for the death of the person in police custody. On May 30, 2022, the NHRC had issued a show cause notice upon the Chief Secretary seeking his response as to why the compensation of Rs 5 lakh should not be granted to the next of the kin of Naik.

The Chief Secretary was directed to submit his reply by July 17, 2022. The commission recommended for the compensation after the state failed to submit any response in this regard within the stipulated time period, it was learnt.

### State to host 3 G20 meets

Bhubaneswar, Dec 10: Union Minister Dharmendra Pradhan Saturday said three G20 sub-committee meetings on education, energy and culture will be held in Odisha in April next year.

Konark and Bhubaneswar are likely to be among the venues for 200 such meetings to be held in the run-up to the main summit.

On December 1, India assumed the presidency of the G20 forum, taking over from Indonesia. G20 is an inter-governmental

forum that addresses global economic issues such as financial stability, climate change mitigation, and sustainable development. It comprises Argentina, Australia, Brazil, Canada, China, France, Germany, India, Indonesia, Italy, Japan, the Republic of Korea, Mexico, Russia, Saudi Arabia, South Africa, Turkey, the UK, the US and the European Union, with representatives of the International Monetary Fund and the World Bank.

## BJD will win over 125 MLA seats in 2024, says Singh

BJP claims to form government; Congress says it will get 60 seats

Bhubaneswar, Dec 10: Following the Dhamnagar and Padampur byelections, three principal political parties in the state

BJD, BJP and Congress - have made tall claims for the next Assembly election due in 2024. Senior BJD MLA

Susanta Singh expressed confidence and said that his party will win the Assembly elec-

tions with more than 125 seats, no matter when the elections are held.

During the 2019 election, BJD lost some seats with a small margin. However, Chief Minister Naveen Patnaik will prepare a special roadmap for the election and tickets will be given on the basis of performance, popularity and ground report in 2024,

"From 36 seats in the western Odisha, BJD will win over 30 seats. We will request the Chief Minister to contest the 2024 election from western Odisha," Singh claimed. Leader of Opposition Jai Narayan Mishra claimed that his party will form government in the state with two-third majority in 2024.

On the other hand, Congress MLA Suresh Routray claimed that his party would get 2024. The Congress along with another party will form a coalition government, he

While the Dhamnagar bypoll was necessitated following the death of BJP MLA Bishnu Charan Sethi, the byelection to Padampur Assembly constituency was necessitated by the demise of BJD MLA Bijaya Ranjan Singh Bariha.

The University of Queensland (UQ) research, published in Proceedings of the National Academy of Sciences, analysed almost three million chess moves played by more than 8,000 people in 18 countries before and during the pandemic.

It found wearing a mask substantially reduced the average quality of player de-

"The decrease in performance was due to the annoyance caused by the masks rather than a physiological mechanism, but people adapted to the distraction over time," said Dr David Smerdon from UQ's School of Economics.

The data showed masks were more likely to decrease performance in situations where there was a demanding mental task with a high working memory load.

"This is something to keep in mind for occupations in the STEM fields of science, technology, engineering and mathematics

as well as other professions that demand a high level of working memory such as language interpreters, performers, waiters and teachers," Smerdon added.


Dr Smerdon, an Australian chess Grandmaster, said while mask mandates had helped to curb the spread of Covid-19, almost nothing was known about their impact on cognitive per-

"At the moment there are no large studies on the impact of mask wearing on the general population," he said.

The study found that while mask wearing had a negative impact on chess performance, the effect subsided after four to six hours of playing.

"The results suggest that the effect of masks may depend on the type of task, the duration of the task and working memory load," he added

Understanding the impact of mask wearing on decision-making could help individuals and organisations better evaluate when and how to use them.

The Registrar General of the High Court filed a status report in the apex court through advocate Sibo Sankar Mishra following the top court's order dated November 28. It was submitted in the status report that the members of the Sambalpur Bar Association and

the Kacheri square November 30 and raised slogans by using mikes/loudspeakers on demand of establishment of permanent bench of High Court in Western

"The persuasion of the District Judge to them to refrain from doing so by referring to the orders of apex Court did not yield any result. The police personnel present though tried several times to clear up the road but failed. As a result, the District Judge, Sambalpur as well as other Judicial Officers were prevented from entering the court premises and had to return without being able to hold court. As a result, none of the 924 cases listed in the Samablpur District Courts could be taken up thus causing enormous inconvenience to the litigant public," the report reads.

Citing the report of Sambalpur district judge, Orissa HC informed the apex court that the members of Bar staged dharna December 7

It was further submitted that Bar Council of Odisha had written a letter to the BCI seeking action against the advocates named in FIR but no information is available till date whether BCI has taken any action against

the agitating advocates. The Bar members also held agitations in Koraput, Balasore, Ganjam, Deogarh and Dhenkanal, the HC submitted.

The Registrar General further submitted that the averments made by the Central Action Committee of All Bar Associations of Western Odisha regarding boycott of the Court of the Chief Justice of the High Court of Orissa from October 27 to November 9 are misleading and incorrect. Out of 943 cases listed, 665 cases were disposed of during this period as the advocates and litigants appeared in either virtual or physical mode, the HC submitted.

"It may be humbly stated that there was no occasion to place such facts before the apex Court as no judicial working hours was lost during the period under reference. The Court of the Chief Justice has been functioning in hybrid mode thereby allowing the advocates/litigants to pursue their litigations in either of the modes i.e. physical and virtual," the status report reads.

#### Man dies, 8 hurt in road mishap

The series of mishap left a man dead and eight others injured, added Rout.

## Lots of 'breakthroughs', still no cure for dementia


🕇 e often hear about 'dementia breakthroughs' in the news-new genes being discovered, new blood tests being developed, new drugs being tested.

However, there remains no effective or accessible cure for dementia. This is of great frustration to people living with dementia, and their carers and loved ones. Two new 'breakthrough' drugs

have been in the news. While they may not bring much relief to those living with the disease today, we are learning more about dementia, and getting closer to a treatment. A bit about dementia

Dementia is an umbrella term to describe a group of conditions characterised by a loss of brain function. This includes the ability to remember, plan and make decisions.

Up to 70 per cent of all dementia is attributed to Alzheimer's disease. Other types of dementia include vascular dementia,



frontotemporal dementia, and Lewy body disease. Because Alzheimer's is the most common form of dementia, most "dementia breakthroughs" often refer to 'break-

throughs' in Alzheimer's. Searching for treatments Alzheimer's disease takes a long

time to develop, up to 30 years or more. For a long time, scientists had only a limited understanding of the disease. To develop the right drugs, it's crucial to have the right tools to be able to understand how

the disease progresses. Over the past 20 years, breakthroughs in brain imaging, brain fluid analysis and, more recently, blood tests, have enabled us to measure key Alzheimer's proteins - amyloid and tau - in living people. This has allowed scientists to understand how these proteins develop over time.

We have also been able to clarify which risk factors - age, sex, genetics, environment, lifestyle-contribute to the development of cognitive decline and Alzheimer's. This provides important insights into who and what to target.

Studies now suggest Alzheimer's begins with the buildup of amyloid in the brain. As amyloid builds up, tau then begins to develop. Researchers think it's this tau buildup that leads to brain cell death and cognitive decline. Some scientists refer to amyloid as the "trigger", as once the trigger has been pulled, the "bullet" (tau) is on its way.

Two new drugs Two drugs that have received a lot of attention in recent weeks are aducanumab (marketed as Aduhelm) and lecanemab. Both drugs showed substantial reduction in amyloid in the brain. But whether this reduction in amyloid resulted in a meaningful benefit in memory and thinking is less clear.

In two aducanumab trials, patients did not show any meaningful benefit. But six months later, the drug maker Biogen released and subsequently published new data reporting participants on the highest dose had 22 per cent slower cognitive decline compared to partic-

ipants on a placebo. Recently, drug companies Eisai and Biogen announced the results of a lecanemab trial. Around 1,800 participants with early Alzhemier's were given the drug or a placebo over 18 months. They found a reduction in brain amyloid and tau levels in those taking the drug when compared to participants taking a placebo.

Importantly, lecanemab resulted in a 27 per cent slower decline in memory and thinking ability. This was also accompanied by greater quality of life, as reported by par-

ticipants and their caregivers. This translates to roughly a sixmonth benefit in memory and thinking ability. This is not much. In addition, questions have been raised about whether the drug may be less effective for people with higher risk of developing Alzhemier's, including those with certain genes, women, and culturally and linguistically diverse populations

There are also substantial side effects that accompany both drugs. Of most concern are brain swelling and small brain bleeds as detected on brain scans. These were observed in 21-40 per cent of participants. The risk of these side effects will need to be an important discussion between patients, their families and their doctors.

# **Spread of lumpy virus sparks** panic in Bhadrak villlages



Pregnant cows may die if they are not provided treatment in time. As treatment is expensive, farmers demanded free vaccination of their livestock. CDVO said that LSD is spreading in Aradi and assured preventive vaccination soon



Aradi, Dec 10: Lumpy skin disease (LSD) has broken out in several panchayats under Chandbali block of Bhadrak district. The LSD is spreading fast among livestock in a number of villages under the coastal block, triggering panic Reports said, scores of cattle

have been affected by the LSD in Sundarpur, Olaga, Aradi and Nandapur panchayats. As the infection is spreading, locals demanded immediate step for preventive treatment of the disease.

Unofficial sources claimed that over 50 cattle are now infected by the lumpy virus in the four panchayats. Both cows and calves are getting infected. Though there is no cure, the disease has preventive vaccines, it is said.

Livestock farmers lamented that Sundarpur LI centre has no facility of preventive vaccination. The animal husbandry department is doing little for prevention of the disease, locals alleged.

In such situation, farmers have to spend a lot while seeking service of private veterinary doctors for preventive vaccination.

On the other hand, the LSD is



making harsh economic implications on the farming community in the coastal pocket. It is going to pose a major threat to human health too, locals feared.

The disease is characterised by 2-5 cm-wide nodules that appear all over the body, particularly around the head, neck, udders and genitals. The lumps open up into large, deep wounds. The virus also causes prolonged morbidity among the affected cattle.

The affected cattle may die if their treatment is delayed. Lumpy skin disease is a viral infection that afflicts cattle and water buffaloes. There is no treatment for this disease, although the symptoms can be managed and healthy animals recover, said a local livestock inspector. He added that the LSD virus is a poxvirus that belongs to the same genus as sheep pox and goat pox viruses. It spreads through blood-sucking insects like mosquitoes, flies and ticks as well as through saliva and contaminated water and food.

On the other hand, pregnant cows may die if they are not provided treatment in time. Whatever treatment is available now is expensive, said farmers. Livestock farmers demanded free preventive vaccination of their livestock.

Chief district veterinary officer Subhendu Mishra said that the LSD is spreading in Aradi area. He assured that quick steps will be taken to address the disease through preventive vaccination

## Plantation drives a damp squib due to irregularities in Phulbani

CRORES SPENT FOR THE PURPOSE HAVE GONE DOWN THE DRAIN

Phulbani, Dec 10: The Forest department is pumping crores of runees in plantation drives in forested areas, but in many cases, the exercise has allegedly become futile in Phulbani range of Kandhamal district due to irregularities and lack of post-plantation care, reports said

It was alleged that funds to the tune of crores have been misappropriated in the name of forest regeneration in many blocks of Kandhamal district.

Here is a case in point. Under MGNREGS, a massive plantation drive was undertaken in Ganjuguda panchayat under this range in 2021-

The forest department planted 10,000 saplings of different species on a patch of 50 hectare of land near Baida village by spending ₹8.59 lakh. An information plaque was set up near the project, stated that ₹7.72 lakh was spent towards wages of job card holders while ₹87,000 was

spent for sapling purchase.



saplings were planted on the 50hectare patch. Locals are very skeptical of the official information, given the present miserable condition of the plantation on the land. Only a few dry plants are found standing on the land, locals lamented.

Locals sought to know why the department planted saplings of khau, jackfruit, sishu, jamun and barada species inside a sal forest.

It was alleged that though some people had been engaged to take care of the saplings, the latter have plantation sites under this range. When asked about it, forester Monalisha Panda said that funds for sapling maintenance were pro-

vided up to December, 2021. "Fund was spent on weed cleaning, pit digging and re-plantation in places of dead trees. After December, 2021, no fund has been provided for postplantation care. A proposal has been sent to the DRDA for postplantation care of the saplings, Panda added.

The plantation sites will be inspected, said Phulbani DFO Prashant Kumar Patel

### **Irregularities galore** in MGNREGS projects

Navagarh, Dec 10: Irregularities have allegedly been marring obexecuted under MGNREGS in Nayagarh district. Cases of irregularities are reportedly surfacing from some blocks with each passing day. MGNREGS funds worth over ₹40 crore have been misappropriated through forged bills in Bhapur block while over ₹50 lakh was embezzled in Odagaon block.

Around ₹5 lakh has been misappropriated in Dasapalla block. Moreover, irregularities worth ₹1 crore have been committed by the Forest department under MGN-REGS in Odagaon block.

It was alleged that while irregularities are increasing, the administration has failed to contain them.

According to an allegation, ₹8.99 lakh was sanctioned for renovation of Poibadi Bandh in Tendabidha panchayat in 2020-21. However, the pond was not renovated, but ₹5 lakh meant for renovation has been embezzled through a forged bill. An information plaque was set up near the project, but dates of project's starting and deadline have not been mentioned. "The pond has been leased out to an SHG in September 2021 for three years. Its water has not been drained out. How and when its renovation work was carried out,' locals sought to know.

A tribal resident of Poibadi village on condition of anonymity said that this is how development works are being carried out. "All development works are confined to pen and paper. The administration is taking no action against the corruption. Hence, irregularities are growing up in many panchayats. In Dasapalla block, there are several instances of irregularities," he added.

Executive officer of Zilla Parishad, Subash Chandra Ray said that the irregularities will be investigated and action will be taken against those involved in the scam. "After receiving allegations, we are investigatingand taking action in different blocks," he added.

## Harmless Pretending

f one cannot actually be a leader one can pretend one is a leader. It is like wearing combat fatigues and strutting about like a real warrior. This is L especially useful when the audience doesn't know one is pretending and

The G20 was founded after the Asian financial crisis as a place to discuss global economic and financial issues. This means that it is a talking shop, unlike, say the United Nations Security Council, which wields real power. One key indicator that it has no power is that the G20 presidency is assigned by rotation and changes yearly. Meaning everyone gets it by turn. The honour, if one can call it that, of the presidency is to host the others in your country and at your taxpayers' expense. The G20 is meant to discuss trade but it includes nations which are currently in a trade war (America and China) or might not have a free trade treaty with the others. It is meant to discuss climate but includes the nations that were and continue to be the greatest villains in terms of carbon emissions. It includes nations that are treaty allies in the military terms (Europe and the US) meaning an attack on one of them triggers an attack on all of them. And it also includes nations against whom specifically these treaties have been written (Russia) and against whom these nations are currently arming rivals. It includes nations that have

no borders and whose citizens can move and work and invest freely in each other's countries (European Union). It includes nations that are democracies but also those that are dictatorships and even kingships (Saudi Arabia).

The wealthiest G20 nation is America, which has an average per person income per year of over \$70,000 or ₹56 lakh. India is the poorest nation and our per person income is a little over \$2000 or ₹1.6 lakh per year.

Few know who held the previous G20 presidency (Indonesia) or the one before that or the one after this one (Brazil). This is because the presidency is not a position of power or prestige. But we are being told that it is a great honour that India has been 'chosen' as the current president, for a period of one year. We have heard it from the government and we have heard it from those it is associated with. We shall hear it endlessly over the next year, leading up to September 2023, when these presidents, kings and prime ministers will descend on India. Across the country events will be held, par ticularly in states that are important in 2024.

To manage this at our end, the prime minister has deputed the former head of the Niti Aayog, the body which replaced the Planning Commission. Meant to be a think tank for the government, nobody is quite sure of what the Niti Aavog had done other than act as cheer leader for the government. Perhaps there will be some real work in event management of the

G20. There is no permanent secretariat of the G20 and the costs are shared by the current, previous and next holders of the presidency, meaning we will likely continue to bear some of the cost for another year after we have lost

Among the other things that the G20 summit comprises of is a meeting of civil society or NGOs. It will be interesting to see what India has to say to these groups that it has waged war on since 2014, while they continue to work in many of the other G20 nations (the democracies among them, at least).

Other meetings include those with parliamentarians and perhaps India's Opposition might be given the chance at last to speak, though we will see if that happens. It might well be the case that they will continue to be muzzled and that our leader will use the opportunity to give the other G20 parliamentarians the benefit of his wisdom. We could be in for some dazzling words on freedom of expression and tolerance.

Our actual problems are less likely to be discussed. China does not want to talk about the border issue even with us, let alone with third parties. The problem in Ladakh with continue. Easier and cheaper access to these nations for our workers and tourists to other G20 nations is unlikely to come up or be considered. And this should not surprise us because talking shops are for talk and not for action.

Some 50 years ago, ZA Bhutto arranged an Islamic summit that was designed to show Pakistan as the leader of the Islamic world. It was no such thing of course but what is wrong with some harmless pretending?

The G20 summit will give our leader the chance to do event management on a truly global scale and one looks forward to it very much. It will be spectacle with little real meaning for the population but the entertainment will be assured. There will be no end to the claim that this is India's moment to lead the world, or at least lead it till the next leader takes over.

## **DISRUPTING THE DISRUPTORS**

**TECH COMPANIES SHOULD BE FORCED TO DEMONSTRATE SAFETY AS A CONDITION OF MARKET ACCESS** 

fter a decade of unconstrained growth - when it seemed that a new bilday - the tech industry has finally hit a rough patch. Elon Musk's erratic behaviour following his takeover of Twitter has left the financially leveraged platform in a precarious state. The crypto exchange FTX's sudden implosion has vaporised a business that was recently valued at \$32 billion, taking many other crypto firms with it. Meta is laying off 11,000 people, 13% of its workforce, and Amazon is shedding 10,000. What are we supposed to make of these setbacks? Are they isolated incidents. or signs of structural change?

Twitter was already struggling. After taking on debt and overpaying for the platform, Musk immediately began cutting costs, declaring that the company was losing \$4 million per day. His first layoffs swept out 80% of the company's contractors and half of its permanent staff, including key engineers and most of the content-moderation team.Musk then reversed the bans on Donald Trump and thousands of far-right provocateurs, as well as ending the enforcement of rules against "harmful misinformation" about COVID and vaccines. Many advertisers have paused their campaigns to avoid having their brands associated with toxic content. As I write, Twitter is in chaos.

As the second-largest crypto exchange, FTX (and its founder, Sam Bankman-Fried) came out of nowhere, built a huge public profile, and then blew up - all in the space of a few years. Details are still emerging, but the bankruptcy specialist now serving as FTX's CEO says he has never seen "such a complete failure of corporate controls and such a complete absence of trustworthy information." The ripple effects are being felt across the crypto industry.

Meta's layoffs reflect the company's stalled growth after a meteoric 17-year run. Young people have embraced TikTok, undermining the growth of Meta's Instagram platform, and Apple has introduced a tool that lets iPhone users opt out of sharing data with platforms

like Facebook and Instagram, costing Meta as much as \$12.8 billion this year. Meanwhile, Meta CEO Mark Zuckerberg has made a huge bet on virtual reality attempting to create a general-purpose operating system for an industry that does not yet exist. The company has already spent \$36 billion on this vision, with little to show for it.

Other tech companies are also retrenching, owing to a broader postpandemic reversion to the trend line for online retail, as well as disappointing results from some individual products. But more to the point, I believe the global economy is in the early stages of a structural change that will leave the tech industry - the biggest beneficiary of the prior economic regime - particularly vulnerable to disruption.

The economic environment of the past decade was ideal for business. Interest rates and inflation across the advanced economies were exceptionally and persistently low. Peaceful relations among major powers underpinned easy access to global markets and sustained supply chains that optimised labour costs. But while prolonged economic stability benefited market leaders in every industry. it lulled executives, investors, and politicians into complacency. Many took on more risk, seemingly without consequence, leading to a mispricing of risk throughout the economy. When the pandemic hit in early 2020, it shocked most of the economy. But lockdowns and quarantines were great for tech companies, which kept hiring through the first half of this year, seemingly unaware that they, too, might be subject to disruption.

Russia's invasion of Ukraine changed everything, catching most corporations and even governments off guard. I believe it will be remembered as the trigger that ushered in a new economic era. with interest rates, inflation, geopolitical tensions, and instability at significantly higher levels than in the past decade. There has been a loss of trust among major powers, and it will be many years be fore governments are once again willing to subordinate other issues to economic interests.

For tech, a new economic environment presents both challenges and opportunities. Many tech businesses will not recover. Crypto. Twitter; and Meta's best days appear to be behind them. Other tech businesses, probably including Amazon and Apple, will recover, but perhaps more slowly than they would like. Some new opportunities will emerge. Enterprises that are restructuring manufacturing and supply chains will need technologv. As workers leverage their newfound bargaining power to demand a greater share of the returns, demand for tech-based automation will likely increase. And as consumers adjust to new economic realities, they will stand to benefit from a range of applications and services that do not exist today.

While it may be too much to ask, policymakers should seize this mo

ment to steer the tech industry in more desirable directions. For years, the industry - particularly the social-media platforms - has weakened democracy, undermined public health, and jeopardised public safety. To the extent that policymakers have done anything to rein in the industry, they have focused on privacy and competition efforts that have accomplished too little and come too late.

The focus of policymakers and regulators should shift from symp toms to root causes: namely, the industry's culture, business models, and structure. The culture of the industry is hyper-focused on speed scale, and profits, without regard for consumer safety. Too many products - including major internet platforms, self-driving cars, artificial intelligence, smart devices, crypto, deep fakes, and facial recognition – are simply unsafe. There are no rules requiring tech companies to put consumer safety first; worse, the economic incentives encourage exactly the opposite kind of behaviour. Similarly the "surveillance capital ism" business model-which uses big data and behavioural economics to manipulate behaviour - is an assault on human autonomy analogous to child labour. And it is an assault that has spread from internet platforms to many other industries, including healthcare, transportation, and financial services.

Finally, the concentration of economic power in the tech industry prevents new ideas and business models from coming to market. With today's macroeconomic disruption, policymakers have an opportunity to make up for years of laissez-faire policies. Tech companies should be forced to demonstrate safety as a condition of market access. Surveillance capitalism should be banned. Monopolistic business practices must be outlawed, and monopolies broken up.

Protecting democracy, public health, and public safety is good politics. It also happens to be the right thing to do. There will never be a better time.

## Strategic concerns or economic interests

**NEW DELHI HAS NOT YET GRASPED** THE URGENCY OF **BUILDING ITS ECONOMY** 

Baerbock was in India recently on a two-day visit. The purpose and the timing of the visit coincided with Germany finishing its term as the president of G-7 group this month as India takes over as the president of G-20 countries. Some observers suggest that it was a make-up visit after the Foreign Minister from the Green Party of Germany had advocated international involvement in resolution of the Kashmir issue between India and Pakistan.

However, in the words of the Foreign Minister, the focus of her visit consisted of three areas - economic cooperation, climate crisis mainly dealing with the energy question that enhances the use of renewables, and security Germany leading in the replacement of fossil fuel will help India to make that

change-over in the energy sector. Let us decipher from her statements, and interactions with her counterpart and other officials. Germany's current strategy on India that may impact the growth of relations between two countries. It was assumed that the Western counties including Germany were looking for a substitute country to China for their investment.

The Foreign Minister of Germany had specifically menby the Chancellor despite concerns seem to respond to this need. nation. This perception was clearly dispelled by Baerbock. She said "no" in response to a specific query that Germany was treating India as a replacement for China. Baerbock made a distinction between Germany's policy on China and that with India. She said that they have a value partnership with India whereas their relations with China are economic. Germany has been maintaining that China poses 'systemic threat to the world". Baerbock reiterated that position in New Delhi.

Observers wonder whether the Minister's statements on China and Indo-Pacific sit somewhat awkwardly with the more conciliatory position towards China taken by Chancellor Olaf Scholz. The Chancellor recently visited China to meet with President Xi Jinping. Scholz was accompanied by a high-powered group of businessmen from Germany's largest corporations. China has been Germany's largest economic partner since 2016, with the latter's firms pouring around 10 billion euros in new investments into the Chinese market in 2022 alone. Scholz also controversially approved Chinese investments in Hamburg port, which is Germany's largest. The deal was pushed through from numerous ministries about national security risks posed by it.

The clear gap between Scholz's actions and Baerbock's statements seem to signal a divide over China in the coalition government that replaced Angela Merkel in December 2021. Scholz belongs to centre-left Social Democratic Party while Baerbock belongs to the Alliance 90/The Green Party, another part on the left of the political spectrum.

Germany is the strongest economy in the EU. It has built its economic power systematically and assiduously. German foreign policy is a function of its economic strength. It will want to separate its economic interests from the security concerns. Whilst it may go with NATO for its security imperatives, it will deal with China for its economic needs. The Minister said it would be better if political values and economic needs are coterminus. If not, economic interests will override other priorities. New Delhi has not yet grasped the urgency of building its economy. Given the size and potential of the market in India, the entire democratic world will like India to grow and be ready to absorb the investment. But the priorities of the leadership in Delhi do not

tention of big economies until they find viable alternatives matching China's size and structures it has build so far. New Delhi must be wary of this gap.

Europe is wary of India's attitude towards Russia as New Delhi is about Europe's towards China. New Delhi could use it as bargaining tool by being proactive in the Ukrainian war in terms of bring about a ceasefire if not complete cessation of the conflict.

Yet. the other strategic option is to explore a "third way' between being pro-USA or pro-China. Germany may be exploring this as a pragmatic and progressive line of thinking based on the concept of strategic autonomy. New Delhi has a similar approach. There is then a clear convergence between Germany and India. Is it worth pursuing? At the same time, if Europe can impress upon Beijing to give up its expansionism, and India can persuade Russia to avoid military aggression, we could fast progress towards a rule-based world order!



for areca nuts produced from Mizoram and Tripura was badly affected this year after the Assam government launched a crackdown on arecanut smuggled from Myanmar. However, the areca nut grown in Mizoram and Tripura had to transport in the other states of the country through the Assam territory only," the Rajya Sabha member had said.

He said that the Assam government was acting on the instructions of the Union Home Ministry to curb illegal import of areca nuts from Myanmar.

#### WOMAN RESCUED, 31 ARRESTED

Hyderabad, Dec 10: A day after a woman was kidnapped here, she was safely rescued from the abductors and 31 people were arrested in connection with the incident, police said on Saturday.

A group of about 50 people barged into the house of the woman, who is studying Bachelor of Dental Surgery (BDS), and kidnapped her under Adibatla police station lim-

The woman was forcibly taken away in a car, reportedly before her engagement, even as her mother suspected the hand of one man who had proposed to her daughter earlier.

"The woman has been rescued. She also attended her examination today. So far, 31 accused have been arrested. No one will be spared from stringent legal action," po-

Asked about the incident and the person responsible for the kidnapping, a senior police official said: "It is a kidnapping case. She has been rescued and she is safe. We are further investigating".

The youngsters armed with sticks entered the house and ransacked it before taking the woman forcibly, police said, adding that the assailants attacked her relatives and neighbours when they resisted. The accused had also damaged some parked vehicles, according to CCTV visuals.



# BJP trying to 'buy' AAP councillors: Kejriwal

Patel will take oath as the 18th Chief Minister of Guiarat at a function at the Helipad ground near the new secretariat in Gandhinagar December 12. Prime Minister Narendra Modi and Union Home Minister Amit Shah along with the chief ministers of other BJP-ruled states would attend the swearingin function, party sources said.

Meanwhile, hectic consultations were underway for picking ministers of the new government. Patel and state BJP chief CR Paatil flew to Delhi in the evening and were expected to hold consultations with the top leadership of the party including Prime Minister Modi, Shah and BJP chief JP Nadda.

## Drug trials may soon be done on human tissues developed in labs

New Delhi, Dec 10: Pre-clinical trials of new drugs could soon be done on human tissues and cells developed in laboratories and not iust on animals as the Union Health Ministry is working on bringing in amendments to the New Drugs

and Clinical Trials Rules, 2019. A recent draft notification to amend the rules stated that alternative technology platforms such as human organ on chips, microphysiological systems and other in vitro or cell-based assays can be used prior to and in conjunction with animal testing to establish the safety and efficacy of new drugs before human clinical trials.

Pre-clinical tests are important for establishing the safety and efficacy of investigational drugs. In September, the US Congress approved a landmark FDA Modernization Bill that allows a pharmaceutical drug developer to use alternative methods -- including cell-based assays, organ on chips, micro-physiological systems and other human biology-based test methods -- for establishing the safety and effectiveness of new or investigational drugs in the laboratory, along with animal testing, ahead of human clinical trials.

Once the amendments to the New Drugs and Clinical Trials Rules, 2019, are approved and notified by the Union Health Ministry, and cutting-edge technologies that

India will become the second counpromise a significant reduction in time as well as costs in bringing try in the world after the US to adopt and promote such innovative novel drugs and effective therapies while reducing cruelty on animals, official sources said. "Human bio-specimens such as

blood, tissues and urine made available during planned surgeries through the informed consenting process are being used to develop in the laboratory organ systems, organoids and organ on chips that mimic actual human organs for pre-clinical testing of drugs before human clinical trials," an official source explained.

These alternative technologies have shown the potential to improve the success rate of preclinical and clinical discoveries by 70 per cent to 80 per cent compared to drugs developed using animal models alone which continue to show a failure rate as high as 80 to 90 per cent.

This reduces the risk posed to humans through exposure to ineffective and toxic drugs tested on animal systems alone that fail to replicate human systems. It also enables the discovery of new drugs in a time-bound and cost-effective manner which is likely to boost new drug discovery and clinical innovation in the country, the source explained.

Moreover, since there are genetic differences in different human races and ethnicities this technology will also be useful in testing the effectiveness of drugs in a given population when they have been testedpreviously on another population, ethnicity and geography.

# Heavy rain lashes Tamil Nadu

Cyclone Mandous that touched ground at Mahabalipuram Friday night has led to heavy and intense rains in Tamil Nadu, Pondicherry and Karaikal

Chennai, Dec 10: Cyclonic storm Mandous, which crossed the coast at Mamallapuram near here, has weakened into a deep depression but the weather system impacted the city and its neighbourhoods, uprooting a number of trees. Around 400 trees fell in the city

under the impact of 70 kmph wind speed when the weather system crossed the coast in the intervening night of December 9 and 10, Tamil Nadu Chief Minister M K Stalin said. Four persons were killed, he said without elaborating. Civic agencies, including the Greater Chennai Corporation here, were involved in removing the fallen trees.

"The cyclonic storm Mandous (meaning treasure box) weakened into a deep depression over north Tamil Nadu coast. To move nearly west-northwestwards and gradually weaken into a depression by noon of 10th December," the IMD Chennai said in a tweet in the early hours of Saturday.

Stalin, who reviewed the situation at Kasimedu area, told re-

porters that the government anticipated the situation and put in all preventive measures and could therefore prevent major damage.

"With advanced planning, this government proved any disaster can be managed," he said. Around 400 trees fell due to the impact of the high wind speed. Many trees had fallen on electric poles but the clearing work was on in full swing, he said. Around 25,000 civic workers were involved in various activities. There was no waterlogging in the 22 subways in the city and vehicular traffic was smooth. Rescue work was being expedited in the neighbouring dis-Chengalpet, of Kancheepuram and Villupuram. With the cyclone causing damage to electric poles and trans-

formers, power had been sus-

pended in 600 places and it has been set right in 300 of them. The rest of the work will be over by evening, Stalin said.

Estimation of the loss was being done and if required Central assistance will be sought, the Chief Minister added. Earlier, state Revenue and Disaster Management Minister KKSSR Ramachandran said over 9,000 people have been lodged in 205 relief centres.

Between 6 am Friday and 6 am today, 30 domestic and international flights were cancelled as airport operations were affected due to the cyclone. The airport runway was briefly closed in the early hours today. Besides, nine outbound flights were cancelled while 21 incoming airplanes were diverted to other cities today.

Chennai, Dec 10: The Tamil Nadu forest department has warned people not to spread rumours of wild animal attack after it found out that a woman had given false information that she was attacked by a leopard.

The Gudalur division forest department officials found that the claim made by the woman, A R Suseela of Puthiravayal, Gudalur, that she was attacked by a leopard was false.

The woman had alleged that while she was returning home from the office on a two-wheeler November 30, she was attacked by

a leopard at Marthomanagar road. Forest range officer N Raiendran who conducted the investigation told media persons that the woman did not have a two-wheeler driving license and she had met with an accident after ramming her scooter into the rear of another vehicle.

The forest official also said that there were no pug marks or hair of the leopard in the place where the woman had claimed that she was attacked by the big cat.

The forest officer said that the department monitored the area for six days and had found that there was no leopard in the area.

## WB should adopt TN's Climate Resilience model, say experts

THE STATE IS FIRST TO LAUNCH ITS OWN CLIMATE CHANGE MISSION TO MAKE TAMIL NADU A CLIMATE SMART STATE

Kolkata, Dec 10: As the severe impact of climate change had hit West Bengal in a major way during the last few years, a number of environmentalists have urged Chief Minister, Mamata Banerjee to take key learnings and implement Tamil Nadu's Climate Resilience model.

They have noted that in order to address this climate change issue, the Tamil Nadu government has set up a special-purpose vehicle, named Tamil Nadu Green Climate Company (TNGCC), and thus become a pioneer among the Indian states on this count.

 $According \, to \, them, the \, TNGCC \,$ is supposed to formulate plans to reduce overall greenhouse gas emissions in the state besides developing strategies to reduce emissions through green energy and renewable energy and increasing forest cover in the state among others. According to city-based prominent lawyer and environment activist, Subhash Dutt, West Bengal has been blessed at the same time by the Sundarbans in south Bengal



north Bengal

"However, both these are witnessing the impacts of climate change. For a huge state like ours whose people and their livelihood are extremely vulnerable to risks posed by climate change, exploring and setting up a unique mission to build climate resilience or take key learnings from a state like Tamil Nadu is ideal. It is extremely important that the mission is under the leadership of the chief minister as it will ensure accountability and implementation on the ground, he added. According to Anjal Prakash, research director and adjunct associate professor of Indian School of Business, recently it was

witnessed how the mangrove forests of Sundarbans, the first line of defence against climate changes in West Bengal, was affected because of frequent cyclones.

"There is an urgent need for protecting the people against the recent rise in extreme weather events, particularly cyclones. At the same time, Himalayans in north Bengal are equally vulnerable. In such a situation the political leadership in West Bengal should work towards a programme, especially a

cell that could actually help integrate climate change and climate science into new understanding and new knowledge by using information from key reports," he added. According to Nabo Dutta, a city based environmentalist, for the West Bengal government it is worth learning from the initiative taken by the Tamil Nadu government on this count. "Setting up such a mis-

sion or dedicated body to work on climate issues will yield results only when their suggestions and recommendations are implemented on the ground," he added.

### Heads roll in Safari Park as 27 spotted deer die in 2 months

Kolkata, Dec 10: Heads have started rolling at Bengal Safari Park at Siliguri in Darjeeling district in West Bengal over frequent deaths of spotted deer there.

On Friday, IANS reported that as many as 27 spotted deer died within a period of just two months at the Bengal Safari Park reportedly due to gross negligence on part of the safari park authorities. Even before 24 hours have passed since then, the state forest department has issued a notification transferring both the director and assistant director of the safari park.

Confirming the transfers, state forest minister, Jyotipriyo Mullick said that he has taken the matter quite seriously and the director and the assistant directors of the Bengali Safari Park have been removed. A thorough probe has been ordered to find out the reason behind so many deer deaths and to suggest corrective measures to avoid such tragedies in future,"



Because of the broken fencing walls, the deer reportedly used to come out of the enclosure and consume waste food near the staff canteen and mushrooms which resulted in food poi-

This week, an Australian Kangaroo Alex, which was rescued from the clutches of the wildlife smugglers in north Bengal and sheltered in Bengal Safari Park, died reportedly because offood-poisoning after consuming mushrooms.

Tarn Taran (Punjab), Dec 10: A rocket-propelled grenade was fired at a police station in Punjab's border district of Tarn Taran, the second such attack in the state in the last seven months with DGP Gaurav Yadav on Saturday describing it as a "strategy of the neighbouring nation to bleed India by a thousand cuts" There was no casualty in Friday

night's RPG attack in which windowpanes of a building adjoining the Sarhali police station were damaged, officials said. According to preliminary information, it was a military-grade hardware, the DGP said, adding it was suspected to have been smuggled from across the border.

"There is a clear indication that it is a strategy of the neighbouring nation to bleed India by a thousand cuts," the DGP said pointing to Pakistan which has been sponsoring terrorism in India. In coordination with the BSF

and central agencies, the Punjab Police will investigate the matter, he said. Some unidentified people fired the projectile which hit the Saanjh Kendra adjoining the Sarhali police station on the Amritsar-Bathinda highway on Friday night, police said.

Saanjh Kendra centre provides services like copy of FIRs, passport verification and no-objection certificates. Earlier in May, a rocketpropelled grenade (RPG) was fired at the Punjab Police's intelligence headquarters located in Mohali.

Director General of Police Gaurav Yadav, who visited the site, said that according to preliminary investigation, the grenade was fired by using an RPG from the highway at 11:22 pm and it hit the Suvidha Centre of the Sarhali po-

lice station. "We have registered an FIR under UAPA (Unlawful Activities (Prevention) Act) in this regard." the DGP told the media here. Yadav said police have recovered the rocket launcher and propeller.

'We are investigating technically and forensically. We are collecting clues from the scene of the crime to reconstruct what happened," the DGP said. A forensic team and a squad of the army have reached the site.

The DGP said that the "cowardly attack" was carried out at night as the "enemy nation was feeling rattled" after the seizure of huge quantities of heroin and cache of arms and ammunition in the last one month which were sent through drones.

This year alone, there were more than 200 drone crossings and in the last one month, several drones were intercepted, heroin, weapons and ammunition seized. he said."It appears that our enemy nation was feeling rattled and to distract this, the cowardly attack was carried out at night,' the DGP said.

The police are exploring all angles and theories. The handlers and operators in Pakistan and elements which were in touch in Europe and North America and their links are also being probed to arrest the real perpetrators,

The DGP further said the movement of drones has increased, especially in Tarn Taran and Amritsar, and last month many drones were shot down.

To a question, the DGP said there appears to be many similarities between this attack and the Mohali RPG attack incident, though forensic details were being examined

#### Man caught with lover kills son

Dewas, Dec 10: A 45-year-old man allegedly chopped off his minor son's hands and strangled him to death after the latter saw him in a compromising position with a relative in Madhya Pradesh's Dewas district, police said Saturday.

The incident took place in Bangarda village of Barotha police station area on Monday, while the accused and his paramour were arrested on Friday, superintendent of police Dr Shivdayal Singh said.

The accused allegedly chopped off his 15-year-old son's hands and threw them in a 400-feet deep borewell. He then strangled the boy and dumped the body in some bushes close to a field, he said.

The boy had allegedly seen his father and his 35-year-old aunt in a compromising position. The accused had been in an illicit relationship since the last five years, another officer said. According to the police, the boy's body was found on Tuesday evening and a search was launched for the severed hands.

A post-mortem revealed that the teen had been strangled to death, following which a case of murder was registered against an unidentified person. The boy's father was questioned about why he had not reported his son missing and after hours of grilling, he admitted to the murder, police said. The police have recovered the severed hands and a rope and sickle used in the

Srinagar, Dec 10: The residence of Jaish-e-Mohammed (JeM) militant commander Ashiq Nengroo was demolished by the authorities in Jammu and Kashmir's Pulwama district Saturday, officials said. The two-storey house at New

Colony in Rajpora had come up on state land, the official claimed. It was demolished by the district administration in the presence Nengroo is a wanted JeM com-

mander and an accused in the 2019 Pulwama attack in which 40 CRPF personnel were killed. In April this year, the central government declared Nengroo as a "designated terrorist" under the Unlawful Activities (Prevention) Act.



In a notification, the Union home ministry said Nengroo has been involved in the infiltration of terrorists into Jammu and Kashmir and has also been responsible for perpetrating various terror incidents in the Union Territory.

He is running a terror syndicate in Kashmir and is now "engaged in a perilous campaign to orchestrate terror in Jammu and Kashmir", remote controlled from Pakistan, the ministry had said. of child sexual abuse make it imperative for the state and other stakeholders to create awareness regarding the prevention of child sexual abuse and its timely recognition and the remedy available in law. Children must be taught the difference between safe touch and unsafe touch. While this was previously couched as good touch and bad touch, child rights activists have urged parents to use

The CJI said the families of victims are hesitant to file a complaint with the police. So one must be very careful about entrusting excessive powers to the police

the word safe and unsafe because the word good and bad have moral implications and may prevent them from reporting the abuse.

"Above all, there is an urgent need to ensure that the so-called honour of the family is not prioritised above the best interest of the child." He said the state must encourage the families to report abuse even when the perpetrator is a family member.

In this direction, the Railways recently completed a major portion of work on the longest rail tunnel in the country in the Ramban sector of Jammu region.

The project manager of this tunnel said that major portion of the work on the rail tunnel which is 12.75 km long in the entire Udhampur-Baramulla-Srinagar Rail (UBSR) Link in Jammu and

This route will also see the construction of the world's highest railway bridge and India's first cable-stayed Railway Bridge, reported the Greater Kashmir. It is one of the most remarkable projects by the government and once completed will be revolutionary for the Union Territory of Jammu and Kashmir.













Berlin: German police say they have ended a hostage situation in the eastern city of Dresden, following reports of shots fired Saturday morning. Police had urged people to avoid an area in the city center and ordered Dresden's Christmas market to remain closed while the operation was underway. Shortly after noon police announced on Twitter that the hostage situation was over. "Two outwardly uninjured people are in our care," they added. #### Sikh woman stabbed to death

Toronto: A 40 year-old Sikh woman died in Canada after being stabbed multiple times at her home in Surrey, British Columbia, the Royal Canadian Mounted Police (RCMP) said. Police said they found Harpreet Kaur suffering from multiple and life-threatening stab wounds in a home in the 12700-block 66 Avenue just before 9.30 pm on Wednesday. the CBC News reported. Kaur's husband was taken in as a suspect but has since been released. She was taken to hospital, where she succumbed to her injuries.

#### **SL bans transport** of beef, mutton

Colombo: Sri Lanka Saturday suspended the transportation of beef and mutton at district and provincial levels after a large number of cattle and goats died in the last two days due to unusually cold weather in areas of north and eastern provinces. President Ranil Wickremesinghe issued the orders to ensure public health safety, officials said. According to the statistics by the Department of Animal Production and Health, 358 cattle and 191 goats have died in the northern province, while 444 cattle, 34 buffaloes and 65 goats died in the eastern province.

# Russia grinds on in eastern Ukraine

Kyiv, Dec 10: Russian forces have turned the eastern Ukrainian city of Bakhmut into ruins, President Volodymyr Zelenskyy said, while Ukraine's military Saturday reported missile, rocket and air strikes in multiple parts of the country that Moscow is trying to conquer after months of resistance.

The latest battles of Russia's 91/2 month war in Ukraine have centered on four provinces that Russian President Vladimir Putin triumphantly — and illegally claimed to have annexed in late

Zelenskyy said the situation "remains very difficult" in several frontline cities in eastern Ukraine's Donetsk and Luhansk provinces. Together, the provinces make up the Donbas, an expansive industrial region bordering Russia that Putin identified as a focus from the war's outset and where Moscow-backed separatists have fought since 2014. "Bakhmut, Soledar, Maryinka, Kreminna. For a long time, there is no living place left on the land of these areas that have not been damaged by shells and fire," Zelenskyy said in his nightly video address. naming cities that have again found themselves in the crosshairs. Some buildings remain standing in Bakhmut, and the remaining residents still mill about the streets. But like Mariupol and other contested cities, it endured a long siege and spent weeks without water and power even before Moscow launched massive strikes to take out public utilities across Ukraine.

The Donetsk region's governor, Pavlo Kyrylenko, estimated seven weeks ago that 90% of the city's prewar population of over 70,000 had fled in the months since Moscow focused on seizing the entire Donbas.

#### **Ukraine gets** more US aid

KYIV: The United States announced new military aid for Ukraine on Friday and vowed to disrupt Russian ties with Iran, which a British envoy said involved Moscow seeking hundreds of ballistic missiles and offering unprecedented military support in return. Tehran and Moscow have denied Western accusations that Russia is using Iranian drones to attack targets in Ukraine, where officials warned Friday of a winter-long power deficit after repeated Russian attacks on its energy infrastructure.

Staff reported missile attacks, about 20 airstrikes and more than 60 rocket attacks across Ukraine between Friday and Saturday. Spokesperson Oleksandr Shtupun said the most active fighting was in the Bakhmut district, where more than 20 populated places came under fire. He said Ukrainian forces repelled Russian attacks in Donetsk and neighboring Luhansk.

Meanwhile, the winners of this year's Nobel Peace Prize from Belarus, Russia and Ukraine shared their visions of a fairer world and denounced Russian President Vladimir Putin's war in Ukraine during Saturday's award ceremony in the Norwegian capital. Oleksandra Matviichuk of Ukraine's Center for Civil Liberties dismissed calls for a political compromise that would allow Russia to retain some of the illegally annexed Ukrainian territories, saying that "fighting for peace does not mean yielding to pressure of the aggressor, it means protecting people

## Massive protest against Pak court acquits Hasina's govt in Dhaka

Dhaka, Dec 10: Tens of thousands of supporters of Bangladesh's main Opposition party BNP Saturday held a "grand rally" in the capital here demanding Prime Minister Sheikh Hasina's resignation and fresh elections.

Seven lawmakers of the Bangladesh Nationalist Party (BNP) announced their resignations to protest against the government led by Hasina. Dhaka's Golapbagh area, the venue of the rally, was under heavy security surveillance. The party activists chanted "Sheikh Hasina is a vote thief' as the party leaders addressed the rally eastern part of the capital Dhaka city.

Residents of the capital, inluding office-goers, faced difficulties and many were seen waiting for public transport on the road since morning. Activists say the rally could attract 1 million people. The ruling Awami League activists also staged several pro-government processions. Seven BNP lawmakers announced their resignation at the rally. #### Iran again summons **UK, German envoys**

Tehran, Dec 10: Iran Saturday again called in the British ambassador, marking the 15th time in less than three months a foreign envoy has been summoned, as protests shake the country. The foreign ministry called in British ambassador Simon Shercliff, a day



after his German counterpart, Hans-Udo Muzel, had to appear, the state news agency IRNA said.

This brings to at least 15 times in about 10 weeks the number of times envoys, almost all from Western countries, have been summoned.

This is a reaction of Iranian diplomacy to unprecedented pressure against Iran," IRNA said. Shercliff has now been summoned five times since the demonstrations sparked by the death of Kurdish-Iranian woman Mahsa Amini, 22.

She died in custody on September 16 after her arrest by the morality police in Tehran for allegedly violating the country's strict dress code for women. Iran calls the protests "riots" and says they have been encouraged by its foreign foes.

## HK tycoon Jimmy Lai jailed on fraud charge

Hong Kong, Dec 10: Pro-democracy Hong Kong tycoon Jimmy Lai was sentenced Saturday to five years and nine months in prison for fraud, convicted of violating a lease contract for the headquarters of a liberal newspaper he used to run.

Lai, 75, was found guilty of two counts of fraud for covering up the operations of a private company, Dico Consultants Ltd, at the headquarters of the now shuttered



Apple Daily newspaper, in what was ruled a breach of its land lease. Hong Kong's most prominent China critic, Lai has been behind bars since December 2020 and has served 20 months for unauthorised assemblies. He was the head of Next Digital, the parent company of Apple Daily that shut down in June 2021 after a police raid.

Another Next Digital executive, Wong Wai-keung, 61, was found guilty of fraud and jailed for 21

Montreal, Dec 10: The update to the IUCN Red List of Threatened Species highlights a barrage of threats affecting marine species, including illegal and unsustainable fishing, pollution, climate change and disease.

The IUCN Red List now includes 150,388 species, of which 42,108 are threatened with extinction. More than 1,550 of the 17,903 marine animals and plants assessed are at risk of extinction, with climate change impacting at least 41 per cent of threatened marine species. "Today's IUCN Red List update

ing marine life around the globe. As the world looks to the ongoing UN biodiversity conference to set the course for nature recovery, we simply cannot afford to fail," said Bruno Oberle, IUCN Director General. "We urgently need to address the linked climate and biodiversity crises, with profound changes to our economic systems, or we risk losing the crucial benefits the oceans provide us with.'

Abalone species are sold as some of the world's most expensive seafood, with unsustainable extraction and poaching primary



threats compounded by climate change, disease and pollution.

Twenty of the world's 54 abalone species are now threatened with extinction, according to the first global Red List assessment of these species.

In South Africa, poaching by criminal networks, many connected to the international drugs trade, have devastated population of the endangered perlemoen abalone (Haliotis midae). Increasingly frequent and severe marine heat-

waves have caused mass mortalities, killing 99 per cent of Roe's abalones (H. roei) in its most northerly reaches of Western

Australia in 2011. Marine heatwayes have exacerbated abalone diseases worldwide, affecting the critically endangered black abalone (H. cracherodii) in California and Mexico, and the vulnerable green ormer (H. tuberculata), found from the English Channel to Northwest Africa and

the Mediterranean. Marine heatwaves also kill the algae that abalones depend on for food. Pollution from agricultural and industrial run-off cause harmful algal blooms, which have eliminated the endangered Omani abalone (H. mariae), a commercial species found in the Arabian Peninsula, across half of its range. Toxins such as antifouling boat paint further deplete population. Dugong population in East Africa and New Caledonia have entered the IUCN Red List as critically endangered and endangered respectively; the species remains vulnerable globally.

## Musk likely to lose world's richest title

The abrupt decision to buy Twitter in April has put Musk in a difficult spot and at the risk of losing the famed title

London, Dec 10: Tesla has lost nearly half its market value since its founder, Elon Musk, bid for Twitter in April, reducing his net worth by about \$70 billion and putting his title as world's richest person at risk.

Shares in the electric car company traded at \$340.79 April 13, the day before Twitter revealed in a securities filing that the billionaire had made a hostile bid to buy the social media company for \$43.4 billion, the Guardian reported.

Since then the Tesla share price has plunged by 49 per cent to \$173.44, also due to concerns Musk's net worth drops nearly \$70 bilion

However, Tesla shareholders worry about how he is dividing his time between the social media site and his many other ventures such as the rocket company SpaceX, and that running Twitter is too much of a distraction.

He is under pressure to turn around Twitter, which was already struggling before he bought it, making a \$221 million net loss last year, the Guardian reported.

## Air India nears deal for 150 Boeing 737 Max jets

New Delhi, Dec 10: Air India is close to signing an order with Boeing Co to acquire up to 150 737 Max jets, the Economic Times newspaper reported Saturday, citing sources.

The Tata Group-owned Indian carrier will likely place a firm order for 50 737 Max planes with an option to pick up as many as 150, the ET report said.

Industry sources had said in July that Air India was moving closer to a decision on a mega order worth \$50 billion at list prices to be split between Airbus and Boeing, which included up to 300 narrowbody and 70 wide-body jets.

The reported order would be a win for Boeing, which has said that it was looking to boost its capacity in India to keep pace with rising demand in the world's fastestgrowing major aviation market.

Boeing's last mega order in India came in 2021 when low-cost airline Akasa struck a deal to buy 72 737 MAX jets, valued at nearly \$9 billion at list prices.

Indian skies are dominated by low-cost carriers including IndiGo, SpiceJet and AirAsia India, with majority of them operating Airbus narrow-body planes. SpiceJet, Boeing's biggest customer in India, has 155 MAX planes on order.

Communication, the reasons for losses of the BSNL and the MTNL are high employee cost over the years, debt burden, stiff competition in the market, and lack of 4G services (except on a limited basis

in certain areas). "On October 23, 2019, the government approved the revival plan for BSNL and MTNL. It inter-alia approved the reduction in employee costs through

Voluntary Retirement Scheme

(VRS), debt restructuring by raising of sovereign guarantee bonds, administrative allotment of spectrum for 4G services through capital infusion, monetisation of core and non-core assets, and in-principle approval of merger of BSNL and MTNL," the Rajya Sabha was told in a written reply.

As a result of these, BSNL and MTNL have become EBITDA (Earnings Before Interest, Taxes, Depreciation, and amortization) positive since the financial year 2020-21.

Further, to transform BSNL into a viable public sector undertaking, the government approved a revival package for BSNL amounting to Rs 1.64 lakh crore July 27, 2022.

The revival measures focus on infusing fresh capital for upgrading BSNL services, allocating spectrum, de-stressing its balance sheet and augmenting its fibre network by merging Bharat Broadband Nigam Ltd (BBNL) with BSNL. With the implementation of these measures, BSNL is expected to turn-around and become a profit earning entity, said the Ministry.

The Ministry informed that BSNL and MTNL have been playing a crucial role along with private telecom players in the development of the telecom infrastructure and expansion of telecom services.

# In Saudi, Xi calls for oil, gas trade in yuan

Riyadh, Dec 10: President Xi Jinping told Gulf Arab leaders that China would work to buy oil and gas in yuan, a move that would support Beijing's goal to establish its currency internationally and weaken the US dollar's grip on world trade.

Top oil exporter Saudi Arabia and economic giant China both sent strong messages during Xi's visit on "non-interference" at a time when Riyadh's relationship with Washington has been tested over human rights, energy policy and Russia.

Any move by Saudi Arabia to ditch the dollar in its oil trade would be a seismic political move, which Riyadh had previously threatened in the face of possible US legislation exposing OPEC members to antitrust lawsuits.

At the start of talks, Prince Mohammed heralded a "historic new phase of relations with China", a sharp contrast with the awkward US-Saudi meetings five months ago when President Joe Biden attended a smaller Arab summit in Riyadh.

Asked about his country's relations with Washington in light of the warmth shown to Xi, Foreign Minister Prince Faisal bin Farhan Al Saud said Saudi Arabia would continue to work with all its partners. "We don't see this as a zero sum game," he said.

'We do not believe in polarisation or in choosing between sides," the prince told a news conference after the talks.

Though Saudi Arabia and China signed several strategic and economic partnership deals, analysts said relations would remain anchored mostly by energy interests, though Chinese firms have made forays into technology and infrastructure sectors.

"Energy concerns will remain front and centre of relations," Robert Mogielnicki, senior resident scholar at the Arab Gulf States

Saudi Arabia agreed a memorandum of understanding with Huawei this week on cloud computing and building high-tech complexes in Saudi cities. The Chinese tech giant has participated in building 5G networks in Gulf states despite US concerns over a possible security risk in using its technology.

Saudi Arabia and its Gulf allies have defied US pressure to limit dealings with China and break with fellow OPEC+ oil producer Russia over its invasion of Ukraine, as they try to navigate a polarised world order with an eye on national economic and security in-

China and the two countries reaffirmed in a joint statement the importance of global market stability and energy collaboration, while striving to boost non-oil trade and enhance cooperation in peaceful nuclear power

Xi said Beijing would continue to import large quantities of oil from Gulf Arab countries and expand imports of liquefied natural gas, adding that their countries were natural partners who would cooperate further in upstream oil and gas development.

Beijing has been lobbying for use of its yuan currency in trade instead of the US dollar

A Saudi source, speaking before Xi's visit, told Reuters that a decision to sell small amounts of oil in yuan to China could make sense in order to pay Chinese imports directly, but "it is not yet the right time".

Most of Saudi Arabia's assets and reserves are in dollars including more than \$120 billion of US Treasuries that Riyadh holds, and the Saudi riyal, like other Gulf currencies, is pegged to the dollar.

Berkshire Hathaway release related to share buyback from 2018, which said: "Under the amendment adopted by the Board of Directors, share repurchases can be made at anytime that both Warren Buffett, Berkshire's Chairman and CEO, and Charlie Munger, a Berkshire Vice Chairman, believe that the repurchase price is below Berkshire's intrinsic value, conservatively determined. Another reason behind the pro-

posed buyback is Paytm's strong net cash, cash equivalent and investable balance of Rs 9,182 crore (as of September 2022)

Analysts at Dolat Capital, a brokerage firm, believe that buy back at the current valuation makes sense, given declining need for organic capital allocation and "very compelling valuation for the Paytm business"

"We view this move to be very positive and would enhance business confidence. Maintain Buy with TP of Rs 1,400," Dolat Capital analysts noted.

Paytm made the proposed share buyback announcement after achieving consistently strong growth for multiple quarters due to its strong business model and subsequently rising monetisation from businesses such as payments, devices and financial services.

This is reflected in the company's strong 76 per cent v-o-v revenue growth at Rs 1,914 crore and 224per cent y-o-y surge in contribution profit at Rs 843 crore in Q2FY23.

It deceived the Argentine defense as Weghorst took a touch, held off his marker and slotted home a finish on the stretch.

Enzo Fernandez hit the post near the end of extra time and was then the only Argentina player to fail to score in the shootout. Martinez's saves were from attempts by Van Dijk and Steven Berghuis, after which he pulled his shorts high and danced a jig.

Ishan overshadows Virat feat

Chattogram, Dec 10: Ishan Kishan (210, 131b, 24x4, 10x6) was an epitome of insane power-hitting as his record-breaking fastest double hundred provided a healing touch in India's crushing 227-run consolation victory over Bangladesh in the inconsequential third ODI here

Despite the record margin of victory – biggest by any team against Bangladesh, the 1-2 series defeat will certainly rankle the Indian team as both matches slipped away from their grasp after being in pole position.

Virat Kohli (113, 91b, 11x4, 2x6) struck his 44th ODI hundred, which helped him surpass Australian great Ricky Ponting's 71 international centuries. Kohli now has 72 international centuries (44 in ODIs, 27 in Tests and 1 in T20Is) to his name, with only Sachin Tendulkar (100 centuries) ahead of him in

The century came Kohli's way after nearly 40 months of barren spell but it was easily overshadowed by Kishan's blitzkrieg as his splendid knock formed the cornerstone of India's mammoth total of 409/8 after back-to-back inept batting performances.

The total was always going to be insurmountable and Bangladesh were never in contention as they were bowled out for 182 in 34 overs with all the Indian bowlers being amongst wickets.

Axar Patel (2/22), Shardul Thakur (3/30), Umran Malik (2/43), Mohammed Siraj (1/27) and Kuldeep Yadav (1/53) never really allowed the home team batters to dominate as they shared the spoils among themselves.

Kishan's blistering innings and the intent he showed while catching Bangladesh attack by the scruff of its neck would definitely put the team management under pressure to take some tough calls as it moves into the World Cup year. In fact, such was his domination that Rohit Sharma's world record ODI score of 264 was in danger of being

Apart from Rohit's three double tons, the two other Indian batters to achieve the feat are maestro Tendulkar and Virender Sehwag.

Having completed his maiden ODI century in 85 balls, Kishan batted in T20 mode as records kept on tumbling. That 156 of his runs came in sixes and boundaries tells a lot about the relentless assault he unleashed on the Bangladeshi bowlers.

The West Indies' Chris Gayle held the previous record with his 138-ball double ton against Zimbabwe in 2015. After touching the three-figure mark, Kishan raced to next 100 runs in just 41 balls.

Kohli was also at his sublime best en route to his 72nd international century as the duo bossed the innings with a 290-run partnership off just 190 balls.

Having scored his maiden T20I hundred earlier this year against Afghanistan in the Asia Cup, Kohli recorded his first ODI ton since August, 2019. In a reminder of the famous six off Haris Rauf in the T20 World Cup, he picked a backof-a-length delivery from Ebadot Hossain for a six to reach his century in 86 balls.

Once both were gone, India managed just 70 runs in the last 10 overs while losing five wickets. Having already conceded the threematch series after losing the first two ODIs following ordinary batting, India under KL Rahul brought in Kishan to open with the struggling Shikhar Dhawan.

## Dhawan begin MOROCCO'S DREAM RUN CONTINUES Boland puts Australia

En-Nesyri header helps Morocco to pull off one of the biggest upsets in FIFA World Cup history as they send Portugal, Ronaldo packing to become the first African nation to reach the semifinals

Doha, Dec 10: Morocco became the first African country to reach the World Cup semifinals by beating Portugal 1-0 Saturday, likely ending Cristiano Ronaldo's chances of ever winning football's biggest prize.

Youssef En-Nesyri scored the winning goal in the 42nd minute to continue Moroccos improbable run that has generated an outpouring of pride in the Arab world during the first World Cup to be staged in the Middle East.

The 37-year-old Ronaldo, one of soccers greatest players, didn't start for the second straight game but came on as a substitute in the 51st minute and missed a chance to equalise in stoppage time.

The five-time world player of the year is set to finish his career without capturing the World Cup or ever getting to the final. He headed right off the field after the final whistle and was crying as he walked down the tunnel.

Morocco will play either France or England in the semifinals. It is a seminal moment in World Cup history, with an African nation finally advancing to the levels typically only reached by European or South American teams. Cameroon (1990), Senegal (2002) and Ghana (2010) all reached the quarterfinals but got no further.

Adelaide, Dec 10: Pace bowler Scott Boland (3/9) took three wickets in an over Saturday to put Australia in command of the second cricket Test against West Indies.

Australia bowled out West Indies for 214 on Day 3 before declaring their second innings on 199/6 early in the last session, setting the visitors a target of 497 to win with more than two days remaining in the day-night match at the Adelaide Oval.

Boland then entered the attack in the sixth over and snared three second-innings wickets without conceding a run to have the tourists reeling on 15/3. He took a wicket with his first ball, having skipper Kraigg Brathwaite (3) caught behind with a delivery that straightened.

Boland also trapped Shamarh Brooks (0) lbw with a delivery that moved back off the seam two balls later and had Jermaine Blackwood (0) caught low at gully by Cameron

wicket when Tagenarine Chanderpaul, after scoring a watchful 17 from 28 balls, feathered a catch down the legside to wicketkeeper Alex Carey as West Indies slipped to 21/4 in the ninth over. Devon Thomas and Jason Holder each scored eight to help West Indies reach 38/4 at stumps.
