### 22% of Gujarat **MLAs** have criminal cases

New Delhi, Dec 11: About 22 per cent of winning candidates or 40 out of the total 182 in the recently concluded Gujarat Assembly elections have criminal cases against their names, according to an analysis conducted by the Association for Democratic Reforms (ADR).

Cricketer Ravindra Jadeja's wife Rivaba Jadeja is among the top three candidates who have shown high income as per their ITR declarations. Out of the 40 winning candidates with criminal cases lodged against them, 16 per cent or 29 candidates have serious criminal cases pending against their names.

Three victorious candidates have cases of attempt to murder registered against their names under IPC Section 307, according to ADR's analysis. Four winning candidates have cases related to crimes against women registered against them. One among these has a rape case registered against him under IPC Section 376. Out of the total 40 winning candidates with criminal cases against them, 26 belong to the BJP, nine from the Congress and two from AAP. Two Independents and one candidate of the Samajwadi Party are also in the list.

Of these, 20 candidates with serious criminal cases lodged against them belong to the BJP, four are from the Congress, two from the AAP, two are Independents and one is from the SP.

As per ADR's analysis, 83 per cent or 151 out of 182 winning candidates are billionaires. Of this, 132 belong to BJP, 14 from Congress, three Independents and one each from AAP and SP. These candidates have declared assets worth over ₹1 crore each, the report said.

## **Toddler flung** out of cab, dies; mother molested

Palghar, Dec 11: A ten-month-old girl died after she was flung from a cab on the Mumbai-Ahmedabad highway in Maharashtra's Palghar district while her mother was allegedly molested. The driver of the cab was arrested, police said Sunday.

The woman and her child had boarded the van, which operates from Chinchoti to Vapi, Saturday to go to Mastan Naka in Manor, a police official said.

The woman was allegedly molested by the cab driver and some co-passengers while she and her child were returning from Pelhar to Poshere in Wada tehsil.

It is being probed whether she jumped off the vehicle with the child or whether she was pushed off and the infant flung out by the accused, the police official said.

'The child was declared dead on arrival at a nearby hospital, while the woman is undergoing treatment for injuries. The driver was arrested during the day," he said.

The driver has been charged under sections 302 (murder) and 354 (assault or criminal force to outrage modesty of woman) of Indian Penal Code, he said.

# **Cybercrimes surge in state**

■ From obscene video calls to UPI frauds, cybercriminals have a field day, while cops grope in the dark

Bhubaneswar, Dec 11: Even Odisha don't have mobile connectivity cybercrimes go on increasing in the state each year.

According to official data, 1,475 cybercrime cases were registered in 2019, which increased to 1,931 cases in 2020 and further to 2,037 last vear.

Similarly, the fraud amount has also increased during the past three years. Cyber criminals swindled ₹16.18 crore from people in Odisha in 2019. This increased to ₹35.07 crore in 2020 and further to ₹40.39 crore in 2021.

It means the amount stolen by cyber crooks increased by nearly 150 per cent during a span of just three years.

In total, 5,443 cybercrime cases were registered and ₹91.65 crore cheated from cyber victims in Odisha in the past three years.

However, recovery has remained poor as the Odisha police man-

aged to recover only ₹1.37 crore against the cheated amount of ₹91.65 crore.

The state has been frequently witnessing cybercrimes in recent years. There has also been a rise in such frauds in the state capital Bhubaneswar over the last two vears. About 146 cybercrimes were reported from Bhubaneswar urban police district in 2021 as compared to 108 in 2020.

In the maximum number of cases, unidentified cyber crooks took away money from the victims by offering them high returns through different schemes, obscene video calls, during online trading,

installation of mobile towers and UPI transactions. In some cases, the victims lost money after clicking on malicious links sent by the cyber criminals to their phones.

In March this year, a case was registered with cyber police that scammers allegedly duped a Keonjhar businessman of ₹2.35 crore by luring him with the promise of high returns for a life insurance policy he had bought.

In another tragic case, a bank manager from Subarnapur district allegedly committed suicide after being blackmailed by a cyber

gang from Rajasthan. One of the gang members made a nude video call to the bank official and later threatened to implicate him in a pornography case. They extorted ₹26 lakh in 40 transactions from the bank official who jumped off a bridge into Ang river August 10 after being unable to meet the demands of the

A cyber expert said that one hour from the deduction of money to cyber fraud is treated as a golden hour, during which the victim has to inform the authorities to get back the lost money.

To curb the rising cybercrimes, a cyber crime cell has been opened in the offices of superintendents of police while cyber police stations have been opened at 14 places.

Training is being given to police officers who are investigating cybercrimes, MoS for Home, Tusharkanti Behera stated in a recent reply in the Assembly.

A cyber forensic laboratory has been functioning in Bhubaneswar since November 22, 2017. People can lodge complaints online through the national cybercrime reporting portal www.cybercrime.gov.in.

Standard operating procedures (SOPs) on investigation of objectionable viral picture and videos in social media and seizure of digital devices have been issued to the SPs, Behera said.

# 17-yr-old Army aspirant drowns in Mahanadi

The deceased was identified as Sohail Khan, son of Muhammad Dawood Khan, of Jagatpur area, said inspector in-charge (IIC) Rabindra Nath Meher.

# Harbinger of prosperity: Blackbuck numbers double in Ganjam

LIKE THE BISHNOI COMMUNITY IN RAJASTHAN, THE PEOPLE OF GANJAM DISTRICT HAVE BEEN PROTECTING THE SPECIES

Berhampur, Dec 11: The blackbuck, the most elegant species of the antelope family, is on the list of endangered animals but in Ganjam district its number has almost doubled in the last six years.

There has not been a single case of blackbuck poaching for the past few years thanks to the protection given to them by locals at Balipadara-Bhetnani area near Aska, said Dilip Kumar Rout, DFO of Ghumsar South.

Like the Bishnoi community in Rajasthan, the people of Ganjam district have been protecting the blackbucks as they consider that seeing one is harbinger of prosperity for them, former Wildlife Warden of Odisha SS Srivastav

The number of blackbucks, locally called 'Krushnasara Mruga' or 'Kala Bahutia', has increased from 3.806 in 2015 to 7.358 in 2021. In 2011 their population in the area was 2194, Rout said. The southern Odisha district is in fact the only habitat of the mamal at present in the state and one can see hordes of blackbacks roaming freely in the area. This is in sharp contrast to the situation in Balukhand-Konark wildlife sanctuary in Puri district where blackbucks, which were seen till 2012-13, are not seen any more.

Blackbuck is included in the Schedule-1 of the Wildlife (Protection) Act-1972 and is listed as near threatened in IUCN Red list

Improvement of habitat, protection by local people and forest staff are the reasons for the in-



crease in the number of blackbucks in Ganjam, Rout said. Some blackbucks have died in accidents while moving across roads, fighting among themselves and dog bites. "But not a single poaching case was reported in the last some years," he said.

Since 2019-20 a total 48 blackbucks had died in the area and of them 18 due to the road mishaps, Rout added

'The blackbuck occupies a vital place in our religion, which encourages the local people to protect them. Sighting a living one is believed to break a long spell drought and a blessing for the prosperity of the area," said the president of Blackbuck Protection Committee (Ganjam) Amulya

Upadhyaya. The villagers do not harm the animals even if they destroy crops. Though the region is not protected by the government, the animals roam freely due to the protection given by the villagers, he said.

The Committee along with the forest workers is involved in creating awareness among the people to protect the species, Upadhyaya added.

The DFO said meadow development programmes for increasing food, water and safety of the animal was taken up in the area under the Integrated Development of Wildlife Habitats scheme. Salt licks and water holes have also been created.

Besides a watch tower and a rescue-cum-treatment centre have been set up in the area to treat injured blackbucks.

With accidents during crossing  $roads\ becoming\ the\ major\ reason$ for the death of blackbucks in Ganjam, speed-breakers have been created in vulnerable areas. Signage advising vehicle drivers to reduce their speed limits in blackbuck habitats have also been put up, he said.

### Couple killed over sorcery

tised sorcery, an official said Sunday. The bodies were found in a pool of blood outside their house in Rasool Jhumukipatiya Sahi under Daitari police station Sunday morning.

"It appears that suspicion of practising witchcraft was behind the murders. One person was detained. Further investigation is underway," Keonjhar SP ঽ

Mitrabhanu Mahapatra said. The couple's daughter said that her parents were sleeping outside their room Saturday night.

"I was sleeping inside a room. After hearing a scream, I came out and saw that my parents were lying in a pool of blood," she said.



#### **Chief Secy reviews** work ahead of **Hockey World Cup**

Bhubaneswar, Dec 11: Chief Secretary Suresh Chandra Mahapatra Sunday reviewed the progress of the ongoing construction of the Inter-State Bus Terminal (ISBT) at Baramunda and BMC ICOMC building, and the functioning of the Multi-Level Car Parking (MLCP) facility in Saheed Nagar area here.

The ISBT project, being exe-Bhubaneswar Development Authority (BDA) over 15.5 acre of land, will have facilities that will enhance the convenience of the passengers such as office spaces, parking, food court, restaurant and commercial spaces. The Chief Secretary was apprised about the detailed master plan and of the details of the execution plan for the timely completion of the proj ect. Later, Mahapatra directed BDA officials to complete the work by

While visiting the MLCP building at Saheed Nagar, Mahapatra advised the officials of BMC and Bhubaneswar Smart City Limited (BSCL) to enforce no parking zones and to ensure safe passage for the commuters from the park ing building to the nearby market areas. The MLCP will accommodate at least 250 equivalent

Mahapatra, who also visited the new 12-storey BMC ICOMC building at Janpath, took stock of the capital city's ongoing landscaping works and the street art ahead of the Hockey World Cup scheduled

in January 2023. He visited the south lake zone where various citizen amenity activities are being planned like a park for children, cycling track, walking track which will cater to the localities of Satva Nagar Saheed Nagar, and Kharavel Nagar. He directed officials for development of proper parking place on the front side.

The Chief Secretary also visited the national level painting camp and state level sculptures camp at Kalabhumi which are a part of the STAMP 3.0 initiative undertaken by Odisha Lalit Kala Academy and BMC to set up a platform where the state's art and culture will be showcased before the people visiting Bhubaneswar from across the country as well as from different countries during the FIH Men's Hockey World Cup in

#### **Hundreds of Olive** Ridley mating pairs sighted in deep sea

Kendrapada, Dec 11: Hundreds of mating pairs of endangered Olive Ridley turtles were sighted by the Forest personnel at the deep sea within Gahirmatha Marine Sanctuary.

With the sighting of mating pairs, the surveillance in the Gahirmatha has been tightened in the prohibited zone of the sanctuary to provide a congenial atmosphere for the endangered marine fauna. Gahirmatha Marine Sanctuary ranger in charge Manas Kumar Das said the Forest personnel have come across hundreds of Olive Ridley mating pairs in deep sea on Habalikhati site.

He said the Forest personnel have failed to sight mating pair at the coast water due to adverse weather and climatic condition.

The mating of the Olive Ridley sea turtles has just started and it is expected to continue till January mid week, Das said. Since the last few years, the Nasi –II beach proves to be the most favourite nesting place of the marine species.

# NCST seeks report from state on child deaths in Keonjhar

Bhubaneswar, Dec 11: The National Commission for Scheduled Tribes (NCST) has sought actiontaken reports (ATRs) from the state's Chief Secretary, Health and Family Welfare department commissionercum-secretary and the director general of police (DGP) in connection with the allegations of negligence by the staff at the district headquarters hospital (DHH) in Keonjhar that resulted in the death of 13 children in September this year.

Hearing a plea filed by rights activist Himanshu Sekhar Nayak, the NCST asked the officials to submit the ATRs within seven days of the receipt of the order. The commission

also noted that if the concerned officials fail to submit the reports within the stipulated time, it would be compelled to issue summons for their personal appearance.

Quoting media reports, Nayak has informed the commission that as many as 13 children died within 18 days at the Keonjhar DHH in September this year due to alleged negligence of the staffers there.

'The sudden deaths irked the parents and locals who later held a protest before the hospital, demanding detailed probe and stringent action against the persons responsible," Nayak said.

The parents of deceased kids also alleged of the indifference of the staffers of the hospital and the absence of doctors and officials, including the Chief District Medical and Public Health Officer Sujata Rani Mishra, he said.

"Apart from the short supply of oxygen, relatives of the infants alleged the on-duty doctors were absent when the condition of kids worsened. There were no doctors present in the hospital through the whole night of September 17 and nurses were seen running for oxygen," Nayak added.

According to the Health and Family Welfare department, as many as 6,304 HWCs were operational in the state to provide com-

prehensive primary healthcare. Around 4,792 sub-centres, 1,260 primary health centres (PHCs), 105 urban primary health centres (UPHCs), 44 urban health and wellness centres (UHWCs) and 100 AYUSH dispensaries have been converted and strengthened

In the HWCs, 12 types of primary healthcare services, along with expanded range of diagnosis and drugs, were being provided. Besides, specialist and super specialist consultations were also being provided through telemedicine (eSanjeevani) services by linking with district headquarter hospitals (DHHs), medical colleges and hospitals (MCH) and other tertiary level healthcare institutions.

Yoga sessions and various types of wellness activities were conducted at HWCs as part of preventive health. Population-based screening of common NCD like hypertension, diabetes, oral, breast, cervical cancer, and other communicable diseases like leprosy were conducted regularly by HWC team including ASHAs, it was learnt.

Earlier, Odisha bagged the first prize for generation of highest number of ABHA (Ayushman Bharat Health Accounts) IDs during Universal Health Coverage Day 2022 campaign.

# Indian student leads 'plogging' missions to clean up UK streets

n Indian student and awardwinning environmentalist from the University of Bristol in south-west England has inspired a trend of plogging, or jogging combined with litter picking, across various cities of

Vivek Gurav, originally from Pune, was inspired by the Swedish concept of "plogging" - which combines "jogga" (jogging) with "plocka upp" (a pick-up) – to encourage people who use their local streets the most to take pride in keeping them clean.

In India, he set up a plogging community known as "Pune Ploggers" back in 2018, with over 10,000 members who have collected over 1 million kilograms of rubbish and wanted to continue the trend when he took up his scholarship position at Bristol University in

September last year. Since then, his university says he has covered over 420 miles on 120 plogging "missions" joined by volunteers from 180 countries and is now taking the drive to 30 UK cities.

"I have only been plogging in Bristol but I kept getting asked by people in Manchester, Leeds, Derby, to come plogging there," said Gurav.

'So, I decided to do a plogging challenge across 30 UK cities. Ultimately, I want to set-up a UKwide plogging community like I did back in India. So, if I can go out plogging across the UK, orientate people, give them a blueprint, then they can start their own groups,' he said. The former app developer hopes to be joined by fellow ploggers, environmentalists and keen runners as he visits each city via public transport. His plogging across Derby, Nottingham, Leeds,



Sheffield, Manchester, Liverpool, Leicester, Birmingham and Worcester is being tracked across his social media.

Earlier this year, his efforts won him the Points of Light Award from 10 Downing Street, which honours people making a difference

in their communities. Gurav was recognised for his 250 running challenges across Bristol to tackle litter and bringing together over 140 volunteers to clear over 3,750 kilograms of litter.

"The award came as a surprise I believe this award amplifies the cause of climate action that I have been trying to promote through litter picking," said Gurav.

"Every individual matters, every action counts in the race to fight climate change and this award strengthens this belief of my entire community of ploggers based in India as well as UK to keep going," he said. "I hope this award will really

support and amplify our cause. When I told my parents they asked if I was lying. They are really happy and my father said he was very proud of me," he added.

Professor Judith Squires, Acting Vice-Chancellor and President of the University of Bristol, said the student's drive to change the world for the better has been nothing

short of inspiring. "Together with his volunteers he has picked up thousands of tonnes

of rubbish. It has taken hard work intelligence and generosity of spirit -all traits that Vivek has in spades," she said. The University of Bristol notes that Gurav's life has changed dramatically since he moved to the UK for his Master's in Environmental Policy and Management MSc. Such has been his plogging success that Gurav was recently invited to Egypt to speak at the Conference of Youth (COY) 17, the Official Youth Constituency of the United Nations Framework Convention on Climate Change (UNFCCC).

Gurav graduated from his Master's last month and is working for an environmental consultancy while continuing his plogging missions. According to the University of Bristol, he plans to use the skillshe has learnt to help make India more sustainable.



It is important to note that immersive daydreaming and vivid fantasy activity isn't by default maladaptive. What makes daydreaming "maladaptive" is when it becomes difficult to control, when time to daydream takes precedence over real life, and when the compulsion to daydream interferes with important life goals and reWhy does it happen?

Researchers suspect that people who struggle with maladaptive daydreaming may have an innate ability for immersive imaginative fantasies. Many discover this ability early on in childhood, realising fantasy and daydreams can be used to regulate distress. By creating an inner world of comfort, they're able to escape from reality.

Many discover their ability to create imaginative fantasies in childhood, but not all maladaptive daydreamers may use daydreaming as a coping strategy. For example, daydreaming activity can distract from an unpleasant reality which may help to cope with trauma, difficult life events or social isolation. But doing so can lead to a vicious cycle of compulsive fantasy, where using fantasy to avoid negative emotions exacerbates the urge to daydream.

In many ways, daydreaming becomes an addictive behaviour that fuels the very problems it was intended to alleviate. Perhaps unsurprisingly, maladaptive daydreaming tends to occur alongside other disorders, the most common being ADHD, anxiety, depression and obsessive compulsive disor-

der (OCD). There seems to be a strong relationship between OCD and maladaptive daydreaming. One study found that over half of participants with maladaptive daydreaming also exhibited signs of OCD. This may suggest possible shared mechanisms between the two disorders, including intrusive thoughts, dissociation and a lack of cognitive control.

Though maladaptive daydreaming has been garnering an increasing amount of attention online and through social media. it's not yet formally recognised in

psychiatric diagnostic manuals. This means many health professionals may be unaware of the condition, leading to misdiagnosis or dismissal of symptoms, creating further distress, isolation. and shame for maladaptive daydreamers. Many instead turn to online forums for peer support and

Berhampur, Dec 11: Thirty-oneyear-old Ch Nageshu Patro from Ganjam district works as a guest lecturer in a private college during daytime and at night moonlights as a porter at Berhampur railway station.

tant dream for him. Since then Patro has been on a mission to educate as many kids as he can. He does not want kids coming from marginalised backgrounds to discontinue their studies due mon-

etary problems of the family. Patro has been registered as a porter in the railway station since 2011. He decided to appear for the class XII examination in 2012 through correspondence course. After passing the HSC examination, he did his graduation and later his post graduation from Berhampur University. He did all his higher education by self fi-

nancing, working as a porter at night. He said nowadays people are using trolley bags and escalators, so earning as a porter or collie has come down and urged Railway Minister Ashwini Vaishnaw to do something for the porter community working hard at railway stations.

## Israeli Far-Right

The killing of a man by an Israeli soldier in broad daylight in the occupied West Bank has once again brought back the spectre of violence and bloody confrontation between Israeli armed forces and Palestinians. Benjamin Netanyahu's return to power as Prime Minister with the help of rabid, Right-wing forces last month raised fears about such a prospect, but many in Israel hoped the exigencies of holding on to the government may force the ruling parties to temper their anti-Arab and anti-Palestine rhetoric. The killing of 23-year-old Ammar Mufleh has, instead, sparked widespread anger among Palestinians with calls on social media to step up resistance acts against the Israeli occupation. The video of the shooting of an unknown Palestinian shows a cold blooded murder by an Israeli soldier. Mufleh appeared to strike the soldier and attempt to take hold of his rifle before the soldier pulled out a handgun and shot him several times. The Palestinian slumped down on the road and the two men, who had been trying to free him from the soldier holding him, were seen stunned by the act of killing an unarmed man. Of course, at another level, the reaction of the Israeli soldier seems justified since, had he not shot the attacker, his weapon would have been snatched and he could have been dead today.

UN's peace envoy Tor Wennesland was reportedly 'horrified' by what he saw in the video footage and raised the matter in the Security Council. Since January, about 140 Palestinians have been killed in the area by Israeli forces, while Palestinian attacks have left 30 Israelis dead

Such bloody confrontation has been the norm, but what shocks the world is the response of the incoming national security minister, Itamar Ben-Gvir, the pivotal figure of the Far-Right Jewish Power party. Instead of chastising the officer for a virtual public execution, he hailed him as a hero. This might have been necessitated because Israel depends heavily on its armed forces for the very survival of the country.

The Religious Zionism bloc, led by Ben-Gvir and the Jewish supremacist Bezalel Smotrich, is now the third-largest group in the Knesset (Parliament). It had been catapulted into this position in last month's elections by whipping up racism and homophobia. Ben-Gvir has been aptly described as "the modern Israeli version of an American white supremacist and a European fascist." His track record buttresses such an impression. He has been convicted of racist incitement and advocacy of terrorism. Israel's Arab minority is fearing eviction from their homes as he has repeatedly pledged to relocate Bedouins and Palestinian Israeli citizens to neighbouring Arab states.

In fact, since January, tempers have been rising and many Palestinians have lost their lives in the occupied territories of the Gaza Strip, West Bank, and East Jerusalem so far. But, reports suggest a perceptible change in the behaviour of the Israeli forces in the occupied territory following the victory of the Far-Right. A new stage of conflict between the Israel government and the Palestinians seems to be on the cards. A more aggressive policy under Prime Minister Benjamin Netanyahu, who has cobbled together the most Far-Right Israeli cabinet ever, is all set to be followed. Netanyahu is now sharing power with Smotrich, who opposes Palestinian statehood, and Ben-Gvir who is an anti-Palestinian religious settler.

In a way, Netanyahu becomes instrumental in the rise of the Far-Right. This is more for his personal reasons than for any ideological commitment. He is on trial for corruption charges which he denies. He can escape the law only if he succeeds in distorting Israel's justice system through new legislation mooted by his Far-Right and ultra-Orthodox allies. This seems to be a trade-off. Netanyahu can dodge the laws by letting the Far-Right reshape the policies in the occupied territories. At the moment, a radical wave is sweeping Israel as the recent voting patterns revealed about 60 per cent of voters now consider themselves Right wing. Only three years back, this figure

The killing of Mufleh appears to be an outcome of the changing political climate. Smotrich supports the annexation of the West Bank, the expansion of settlements and the demolition of Palestinian homes. Ben-Gvir plans a provocative ministerial visit to Haram al-Sharif, site of the third-holiest shrine in Islam, under the pretence that Israeli Jews are struggling for their reli-

On the other hand, Netanyahu has not yet said a word on the fresh spate of violence. This will most likely encourage the Far-Right to carry out its agenda of hatred which could be a sure fire recipe for disaster.

The concept is that of removing links from a trading chain, what is called in more colloquial language "cutting out the middleman", or putting the producer of goods or services directly in touch with the customer. It is currently a buzzword in several fields but particularly in banking, because banks have seen much of their traditional market drift away to businesses which trade directly with the public by telephone or post. Another key area is that of insurance, where telephone-based direct traders have creamed off much of the business that used to go through local insurance brokers. Other middlemen already affected are share brokerages and travel agencies where big providers of services are using electronic communications and the Internet to bypass them and so lessen the trading distance between them and their customers, in the words of one expert "to use information to replace mobility". The adjective and participle is disintermediated.

#### Ditto

This commercial term was originally Italian. Merchants from that country, you may recall, were versed in bookkeeping and accountancy very early. Double-entry bookkeeping, for example, was invented in that country and was popularised in a famous book of 1494 by Luca Bartolomes Pacioli, a monk and friend of Leonardo da Vinci, though there are known examples of the method going back to the thirteenth century. It was in the early seventeenth century - about a century after Frater Pacioli's work appeared - that ditto is first recorded in an English book. At first, English used it like Italian, to avoid having to repeat the name of a month already mentioned: Anno 1577. Decemb. 13. are under massive pressure from climate change and the challenge of supporting eight billion people in a sustainable way Key ecosystem services – such as timber from forests, pollinators, and ocean fishing - must be conserved and cherished, yet they are being rapidly eroded. The ongoing 2022 United Nations Biodiversity Conference (COP15) in Montreal offers a chance to build on humanity's shared vision of living in harmony with nature. Biodiversity is an important

goal for World Bank Group programmes. But to reverse its loss, economic decisions must take nature into account. That is why we are working to help countries integrate nature into their economic growth models, development plans, and climate agendas. Doing so means establishing policies that consider nature's real economic value, building institutions that support nature, developing publicprivate partnerships to support that goal, and mobilising finance from all sources to transform economies and policies - going well beyond isolated interventions.

Fishing is a good example of why nature matters for growth and development. Globally, fish stocks are declining, owing to the triple threat of climate change, overfishing, and pollution. If business as usual continues, the world could lose up to 25% of fish catches by the end of the century. That should concern everyone, for several reasons.

First, we are already facing one of the largest food-security crises in modern history. Since fish are an important dietary component for 3.3 billion people, a reduced supply will exacerbate food crises now and in the future. Fish are rich in nutrients that are particularly important for child development, and they are an especially valued source of protein for the poor, because they are easier to obtain and cheaper to preserve than other sources. Hence, fish contribute 50% or more of the total animal-protein intake in Ghana, Mozambique, and Sierra Leone. Moreover, a fish shortage

will affect the entire food chain, because fish products are important components of other foods, including livestock feeds.

Second, as fish become scarcer or migrate to colder and deeper waters because of climate change, many fishers will be forced to travel farther to catch them, to change the way they fish, or to find new jobs. Many will not be able to adapt. Among the 38 million people globally who are employed directly in fishing, the most vulnerable will be the hardest hit. This includes smallscale fishing communities, which are often located in remote areas that are already disproportionally affected by climate change. Women, who make up 50% of employees in the broader aquatic-food value chain, will also be significantly affected. For those with little formal education, alternative livelihoods will be hard to find

Third, the impact of these threats will grow over time. Fish

stocks do not respect international boundaries. Without the right regulations and incentives, fleets will continue to maximise their catches in the short term, with major economies overfishing far beyond their territorial waters. If all countries do this, a bad problem will become much worse. Fifty years ago, about 10% of global fish stocks were being fished at biologically unsustainable levels, according to the Food and Agriculture Organisation of the UN. Today, that figure has risen to 35%. While many countries will suffer, the poorest communities stand to lose the most

Faced with these challenges conservation efforts that merely stop nature loss are no longer enough. Rather, we need to reverse the decline, which means changing how we produce

One approach is to invest in nature-based solutions that protect nature while also supporting economic development, creating livelihoods, and helping countries mitigate and adapt to climate change. Consider mangroves, which are rich in biodiversity, act as nursery areas for fish, protect more than six million people from annual flooding, and absorb carbon emissions. They are estimated to have an economic wealth valued at \$550 billion. Another example is seaweed farming, which has the potential to create jobs, alleviate food insecurity, and absorb carbon.

The World Bank Group is working across many fronts to help countries recognise both the value of nature and the risks that would follow from losing it. Often working through ministries of finance, we provide funding, knowledge, policy advice, and technical capacity to mobilise partners behind nature-based solutions. With our support, countries are identifying promising new interventions that can be replicated and scaled up.

For example, by involving different stakeholders in marine planning, Vietnam is reducing conflicts over resource use across sectors. In China, we're working with the Chongqing and Ningbo municipalities to reduce the amount of marine plastic that reaches the ocean from river effluent, building on earlier projects that helped establish China's water-treatment capacity. By applying technologies like satellites and drones, we are helping Tanzania and other countries obtain real-time data on coastal and marine degradation, so that they can act to prevent it. And through innovative financial instruments such as blue carbon credits, Ghana aims to restore 3,000 hectares of mangroves and bring in more private funding.

We are working to expand efforts like these. Near-term goals include more financing for projects in poor countries, a bigger role for the private sector, and coordinated action from local communities to national governments. But if we are going to stop biodiversity loss, much more needs to be done, both by us and the global community.

# **Emotions to surpass economy**

rime Minister Narendra Modi's magic worked with a record victory of 156 Gujarat seats for the BJP as he toils hard with Union Home Minister Amit Shah. From now on it may be an intense Hindu makeover, surpassing the economy, to continue the spree till 2024 Lok Sabha election.

The economic rhetoric of five trillion dollar would remain there as it was also in Gujarat for a state GDP of one trillion dollar, though it could not create the mood that the party may have liked. That led its leaders to walk the extra mile. The magic attraction of Modi finally did the trick as also party's capability to muster over 16 lakh people at the polling stations in a jiffy in the second phase December 5. The party's financial and manpower strength virtually wiped out Opposition parties.

The big election of 2024 once again may not be contested on an economic blueprint as it is not easy to make it a reality in an inflation and recession-hit world economy torn by wars, sanctions, low or little growth and high unemployment. India may be doing better with over 6% growth, but it may not be enough to lure voters or provide work to the needy.

Controversies, BJP poll managers know, are vote catchers. The party may again gamble on polarisation, population or the divide with unique packs in each state. It has almost now centred on the Uniform Civil Code (UCC) to create a wave across the country. The discussion on the issue of personal laws touches almost all Indians. That gives an opportunity to woo communities and widen the divide.

A small instance with larger import was witnessed in the Rajya Sabha, December 9, with introduction of a private member's bill by BJP MP Kirodi Lal Meena. He demanded a panel to prepare and implement the UCC. This divided the House. Expectedly, Congress, TMC, DMK, CPI-M, CPI, IUML, MDMK, Samajwadi Party and RJD lodged strong protests amid uproar. Chairman Jagdeep Dhankhar called for division and the motion was cleared with 63 votes in favour and 23 against. The controversy officially begins.

Yes, notwithstanding controversies, the UCC has become the next major agenda and vote drawer. The adage that the BJP is always in campaign mode becomes a reality. It takes precedence over the Union Budget preparations, allocations or populist moves that a government puts on the agenda. The UCC would be garnished with the population control policy for sharpening the campaign.

If the BJP concentrates on scrapping the junking of 10-year-new cars, started by UPA, in all the states, it would touch the heart of several crore families. It can be a game changer as Switzerland has taken the first step to do away with electric vehicles. Anger simmering against forced junking of cars and tractors is increasingly being witnessed among farmers of Uttar Pradesh, Haryana, Uttarakhand, Odisha, West Bengal, Punjab and several others.

While there may or may not be freebies, the free food dole is likely to get an extension till the Lok Sabha polls along with many other programmes for tribals, and disadvantaged groups. The minorities are to be given special favour in allotments of PM Awas Yojana houses, jobs in EWS quota, allocations to religious schools, madrasas and some other programmes. It is interesting to note that backward minority communities are gradually being attracted to the Hindu party. The subtle campaigning among minority groups of different religions by RSS leader Indresh Kumar has caught their fancy

The minority denominated constituencies in the Northeast. Telangana. Andhra Pradesh and Karnataka would be approached by the party cadre for the next one year religiously to lure them to vote for the BJP. The party is in touch with different churches. Various programmes tailored for each of the states is aimed at swinging the mood in favour of the saffron party. The approach, packaging and methods are special to each state concentrating on welfare and the popular imaging.

The novel campaign plank has been designed to surpass the economic issues and capture the electorate's imagination. The clear aim being to win the elections with a mix of emotions, connect and divide and to perpetuate its rule till 2047 or the centenary of Independence.

# MCD poll fallout: Delhi BJP chief quits

New Delhi, Dec 11: Delhi BJP chief Adesh Gupta Sunday resigned from the post, days after the party's defeat in the municipal corporation polls to the Aam Aadmi Party

The BJP's Delhi unit vice-president Virendra Sachdeva has been appointed as the acting president. "The resignation of Adesh Gupta as Delhi BJP president has been accepted as per the direction of BJP national president Jagat Prakash Nadda. Delhi unit vice- president Virendra Sachdeva is being appointed working state unit chief till the next order," BJP's national general secretary Arun Singh said in a communication. Soon after taking over charge

as acting president at the Delhi BJP office, Sachdeva exhorted party workers to start working for a victory of the party on Delhi's all the seven Lok Sabha seats in the 2024 elections

"I am grateful to the party's central leadership for giving this responsibility to an ordinary worker

Gupta told reporters that he took "moral responsibility" for party's defeat and decided to step down from Delhi BJP president post. The AAP won 134 wards in the polls and ended BJP's 15-year rule at the civic body.

Sachdeva, who was associated with RSS earlier as a volunteer, discharged duties on various posts in the Delhi BJP, including district president of Chandni Chowk and Mayur Vihar. Appointment of Sachdeva, whose ancestors came to India from Pakistan after partition, temporarily rested speculations over Gupta's exit and claims on his post by several party leaders. "The party may decide to con-

tinue with Sachdeva as the president if his performance as working president is impressive,' said a senior Delhi BJP functionary. Several leaders were set to be in the race for the post, including MPs Parvesh Verma. Ramesh Bidhuri, Meenakshi Lekhi and Gautam Gambhir, party's co-incharge for Jammu and Kashmir Ashish Sood, Kapil Mishra and state general secretary Harsh Malhotra.

The demand for an organisational overhaul in the Delhi BJP had begun immediately after the party's loss in the MCD elections. Amid the clamour for change, Gupta had in a meeting on the result day (Thursday) asserted he was not going to give up to "conspiracies" against him.

Gupta's performance has been under the scanner since he took charge as president of the Delhi BJP in June 2020. Under his leadership, the party failed to win bypolls to some MCD wards in 2021 as well as the Rajender Nagar Assembly bypoll.

According to some Delhi BJP functionaries, Gupta's resignation does not mean much as he was anyway nearing the end of his term. The organisational elections of the BJP at the national level are scheduled to be complete in January 2023. BJP leaders said the party constitution mandates that organisational restructuring should be done in 50 per cent of state units ahead of changes at

Ahmedabad, Dec 11: A total of 151, or 83 per cent, of the 182 MLAs elected in the recent Assembly polls in Gujarat are 'crorepatis' (worth over Rs 1 crore), up from 141 in the 2017 polls, as per a study conducted by the Association for Democratic Reforms (ADR) and Gujarat Election Watch.

The study showed the ruling BJP has 132 crorepati MLAs, followed by 14 of the Congress, all three Independents, and one each of the Aam Aadmi Party and the Samajwadi Party. The BJP won the seventh straight term in Gujarat by winning a record 156 seats in the 182-member House.

Of these 151 'crorepati' legislators, 73 have assets of more than Rs 5 crore and 73 have assets in the Rs 2 crore to Rs 5 crore range. The average assets per winning candidate in Guiarat now stands at Rs 16.41 crore, almost two times the figure for 2017, which was Rs 8.46 crore.

The richest legislators are BJP's Mansa MLA JS Patel (Rs 661 crore), Siddhpur MLA Balvantsinh Rajput (Rs 372 crore), also of BJP, and BJP's Rajkot South MLA Ramesh Tilala (Rs 175 crore), the study showed.

# HIGH COURT Govt, judiciary not adhering to timelines: Parl panel

New Delhi, Dec 11: Amid a standoff between the government and the Supreme Court Collegium over the appointment of judges, a parliamentary panel has asked the Executive and the Judiciary to come up with "out of box thinking" to deal with the "perennial problem" of vacancies in high courts.

The department-related standing committee on Law and Personnel in its report tabled in Parliament on Thursday said it is not in agreement with the comments of the Department of Justice in the Union Law Ministry that "time for filling up of vacancies of judges in the higher judiciary cannot be indicated"

The timeline has been drawn in the Second Judges Case and also in the Memorandum of Procedure (MOP) regarding the appointment of judges, it pointed out. "But regrettably, those timelines are not adhere to by both, the Judiciary and the Executive, which is leading to delay in filling up of the vacan-



cies," it lamented.

It said as per the data provided by the government, as on December 31, 2021, there were three high courts of Telangana, Patna and Delhi where vacancies were more than 50 per cent and 10 HCs where vacancies are more than 40 per cent of their respective sanctioned strength.

"These all are large states, where judge to population ratio is already skewed and such level of vacancies

is a matter of deep concern," the panel headed by senior BJP leader Sushil Kumar Modi observed. The government and the

Judiciary, the committee noted, should come up with some out of box thinking to deal with this perennial problem of vacancies in the HCs". The committee also said that it is "surprised" to note that the Supreme Court and the government have failed to reach at a consensus on revision of the Memorandum of Procedure (MOP) for the appointment of judges to the Supreme Court and the high courts, though the same is under consideration of both for "about seven years now".

The committee expects the government and the Judiciary to finalise the revised MOP, which is more efficient and transparent. There are 25 high courts in the country. As on December 5, 778 judges are working in the high courts against the sanctioned strength of 1,108.

On November 25, the government had asked the Supreme Court Collegium to reconsider 20 files related to appointment of high court judges. The government had expressed "strong reservations' about the recommended names. Out of the 20 cases, 11 were fresh cases and nine were reiterations made by the top court Collegium.

The government has returned all the names related to fresh appointments in various high courts on which it had "differences" with the Supreme Court Collegium, sources had said.

# **Every family in J&K to get unique ID**

BJP WELCOMES MOVE, OTHER PARTIES RAISE CONCERNS

Jammu, Dec 11: The Jammu and Kashmir administration is planning all families in the Union territory with each of them having a unique alpha-numeric code -- the objective being easy selection of eligible beneficiaries of various social wel-

The proposed move to allot Family ID has been welcomed by the BJP but panned by other parties which raised concerns over personal data safety.

At the recent national conference on e-governance in Katra in Reasi district, Jammu and Kashmir Lt Governor Manoi Sinha and Chief Minister of Haryana Manohar Lal Khattar released the Digital J&K Vision Document, unveiling the government plan to create an authentic, verified and reliable database of all families of the Union territory. According to the vision document, "Each family will be provided with a unique alpha-numeric code called JK Family ID. The data available in the family database would be used to deter mine eligibility through automatic selection of beneficiaries for receiving social benefits.'

The database would identify each and every family in J&K and would collect the basic data of the family, provided with the consent of the family, in a digital format.

The document further reads that all the applicable laws and regulations in respect of data protection shall be complied with in the management of data.

To thwart risks and protect sensitive and critical data, it said the Jammu and Kashmir government plans to work on an information security policy and also envisages formulation of appropriate cyber security framework

Commissioner Secretary of the IT Department Prerna Puri said the objective of creating the database,

Once the data in the JK Family ID database is authenticated and verified, a beneficiary will not be required to submit any more document to avail a service, she told PTI. The Congress, National Conference and the PDP slammed the proposed move. Congress chief spokesperson and former legislator Ravinder Sharma questioned the government's intention and also its capacity to protect such digital databases from cyber attacks.

"Why does the government wish to peek into everything? They already have enough data through Aadhaar and are providing benefits through direct bank transfer (DBT) mode," Sharma said.

Referring to cyber attacks by Chinese entities and ransomware attack on the AIIMS servers, he said in such a situation, protection of personal data of the people is a major challenge.

National Conference provincial president Rattan Lal Gupta termed

Now who the government is trying to identify through this database," PDP leader Virendra Singh Sonu said. However, the BJP welcomed the move and said the people who have to stand in queues to get various benefits and certificates will benefit once a verified database is prepared.

The new database will be helpful in many ways as people have been alleging that Census 2011 was not correct and many people have been wrongly added under BPL category, he said, adding a similar family database is already there in Harvana and so there is nothing

The vision document itself acknowledges that in the absence of coherent policies relating to data security and privacy, the progress of digital transformation is bound to be slow and fraught with several risks. Senior Superintendent of Police, Security, MY Kichloo said vulnerabilities and possibilities of cyber attacks will remain when it comes to digital storage of data.

'We will face the same problems in Jammu and Kashmir which are faced across the country viz-a-viz data. Whenever a database is prepared by the government, an IT audit is conducted by experts," he said. As far as data protection is concerned, the officer said, the Jammu and Kashmir government will soon issue a notification under Section 70 of the Information Technology (IT) Act to declare all information structures of government offices and public sector undertakings as protected systems.

In case of data breach, the quantum of punishment would be 10 years which would work as a deterrent, Kichloo said.

Chief Town Planner of the Jammu Development Authority Jagdish Raj Hans said the exercise would be helpful in more ways than just extending benefits of government schemes

"Currently, JDA is conducting a socio-economic survey for revising the master plan and a door-todoor survey of nearly 9,000 households is being undertaken with the help of a Delhi-based consultancy firm. If a bigger database with all social indicators of families of J&K becomes available, then we would not have to do this sample survey," he said.

According to the vision document, over the next five years the government aims to enhance the efficiency, effectiveness, transparency and equitability in the delivery of public services and all the functions of the government using emerging technologies.

The BJP government at the Centre asserts that the Citizenship (Amendment) Act, 2019 will be implemented but is vet to frame the rules, leading to allegations from various quarters that the saffron party is using it as a political card to polarise the nation.

The Citizenship Act, 1955 was amended to provide citizenship to Hindu, Sikh, Buddhist, Jain, Parsi and Christian religious minorities fleeing persecution from Pakistan, Bangladesh and Afghanistan and seeking refuge in India till 2014.

The Opposition protested the Act as being based on religious criteria and wanted it to be

The protests against the Act in Assam were led by the All Assam Students Union (AASU) and the Krishak Mukti Sangram Samiti (KMSS) but the stir was different from those in other parts of the country as agitators asserted that the state cannot be a dumping ground for foreigners irrespective of their religion.

The agitation in Assam had

turned violent, with five people losing their lives in police firing and KMSS leader Akhil Gogoi and four others being arrested. The stir was called off with the onset of the Covid-19 pandemic. litical mileage.

In the aftermath of the agitation, two new political parties --Assam Jatiya Parishad (AJP) led by the then AASU leader Lurinjyoti Gogoi and Raijor Dal headed by Akhil Gogoi – were born in Assam.

"The BJP uses CAA as a political tool, particularly during elections, and it has not framed the rules as it wants to keep the 'foreigners' issue' alive in Assam. What's worse is that the party has brought a communal angle through the Act with its narrative 'Hindu khatre mein hain' (Hindus are in danger)," AJP president Lurinjyoti Gogoi told PTI.

The CAA has made the Assam Accord and the National Register of Citizens (NRC) irrelevant, he claimed. The Centre must give constitutional safeguards to Assam like those accorded to other northeastern states against further settlement of 'foreigners', Raijor Dal working president Bhasco de Saikia said.

We are firm on our opposition to the Act which we consider to be a part of the BJP's communal politics and if they frame the rules, the 'foreigners' should be taken to other states," Saikia said

The RSS and the BJP, however, asserted that both the CAA and NRC are not against any Indian and that the communal narrative has been created by some for po-

RSS chief Mohan Bhagwat had pointed out here last year that no Muslim will face any persecution due to CAA.

Chief Minister Himanta Biswa Sarma had also asserted that the CAA is for those who are victims of Partition and persecuted in a communal country created on the basis of religion.

Sarma had claimed that so-called secular protesters at the national level tried to give a communal colour to the protests in Assam.

Political writer and analyst Sushanta Talukdar said the government has been delaying the implementation of CAA as it is wary of adverse reactions in Assam and Tripura where the ruling BJP has high stakes.

'The Centre is apprehensive of exposing linguistic and ethnic fault lines in the Northeast and antagonising its own and alliance partners' electoral support base because, without adequate constitutional safeguards, the Act could lead to the marginalisation of indigenous people by the migrant population which might result in their loss of political power and identity," Talukdar added.

### Pilgrim footfall at Vaishno Devi in 2022 at 9-year-high

Jammu, Dec 11: Nearly 87 lakh pilgrims have paid their obeisance at the famous Mata Vaishno Devi Shrine atop Trikuta hills in Reasi district of Jammu and Kashmir so far this year, the highest in the past nine years, an official of the shrine board said Saturday

The inflow of the pilgrims is expected to pick up further in the coming days as the year draws to close, the official said, hoping that the figure may surpass 90 lakh by the end of December.

Till December 6 this year, 86.40 lakh pilgrims visited the cave shrine for the blessings of Mata Rani - a manifestation of the Hindu mother goddess, Durga or Adi Shakti which is highest annual figure in the past nine years, a shrine board official told PTI.

He said about 13,000 pilgrims on an average are visiting the shrine at present on a daily basis but the number is likely to go up in the coming weeks ahead of the new year celebrations. The official said the highest

number of more than 11.29 lakh pilgrims visited the shrine in June, while the lowest number of 3.61 lakh pilgrims offered their prayers at the temple in February. Despite a stampede at the shrine

on the New Year's Day that left 12 pilgrims dead and 16 others injured, January recorded a turnout of more than 4.38 lakh pilgrims. More than 7.78 lakh pilgrims

visited the shrine in March, 9.02 lakh in April, 9.86 lakh in May, 9.07 lakh in July, 8.77 lakh in August, 8.28 lakh in September, 7.51 lakh in October and 6.01 lakh in November, the official said.

Only 17 lakh pilgrims, the lowest in more than three decades, visited the shrine in 2020 when the shrine, for the first time in its history, remained closed for five months due to the outbreak of the Covid-19 pandemic and reopened for visitors August 16 (2020)

From 13.95 lakh in 1986 when the shrine board took over the affairs of the shrine for better management, there has been a steady increase of pilgrim footfalls with each passing year, touching an all time high of 1.04 crore turnout in 2012 against 1.01 crore the previous year (2011).

The pilgrim arrivals at the shrine touched 31.15 lakh in 1991 and reached 74.17 lakh in 2007. However, the number dropped to 67.92 lakh in 2008 which was attributed to the twomonth long Amarnath land row agitation but again went up to 82 lakh in 2009 and 87.2 lakh next year (2010).

The pilgrim arrivals dropped from 93.24 lakh in 2013 to 78.03 lakh in 2014 and further to 77.76 lakh in 2015 and 77.23 lakh in 2016. It increased to 81.78 lakh in 2017 and 85.87 lakh in 2018 but again dropped to 79.40 lakh in 2019 – the year when the central government revoked special status under Article 370 of the constitution to Jammu and Kashmir and bifurcated the erstwhile state into the Union Territories of Jammu and Kashmir, and Ladakh.

# Work on Jammu's artificial lake project back on track

Jammu, Dec 11: Work on construction of the Tawi artificial lake here, which is aimed at giving a boost to tourism in Jammu province, has finally taken off after encountering scores of delays in the past 13 years.

The artificial lake and river front beautification work in the Tawi river will be completed at a cost of Rs 280 crore by April next year.

If all goes as planned, the gated Tawi barrage project (artificial lake) would be completed by April 2023 along with ongoing work on other components of artificial lake,

including river bank protection. development of Tawi river front on the pattern of Sabarmati, Jammu Mayor Rajinder Sharma told PTI.

'We should be happy that at least work has now started again (after many delays). It is a difficult task. But we hope it will be completed by the deadline," he said.

The Mayor said the lake will totally change the tourism landscape of Jammu. The lake at the entry point will have great attractions. It will beautify Jammu, which is known as the city of temples, Sharma said.

Indiresh Prajapati, who is an expert on lake projects, said work

is going on full swing. The bed work, channelisation of water, embankment constructions and diversions are being done. It is a difficult task. he said

The project, which was launched in 2009 by the Congress-NC government, has been marred by delays, missing as many as seven deadlines, before work came to a standstill in 2018.

The state government has spent more than Rs 58 crore on the project in the past decade, after its foundation stone was laid by the then Chief Minister Omar Abdullah December 5, 2009. After missing the first target date in 2022, the contractor missed deadlines in 2012, 2013, 2015, 2016, 2017 and 2018 when the work stopped.

In 1986, then Governor Jagmohan gave his approval to the lake project. The state government began the construction project in 2008-09 after much delay.

As per the project plan, an automechanical barrage would be constructed on river Tawi, one km downstream of main Tawi bridge, the officials said.

# **New Himachal CM braces for a bumpy road**

Shimla/New Delhi, Dec 11: The decisive move on new leadership in Himachal Pradesh notwithstanding, the Congress has its task cut out in the hill state as it faces the twin challenge of keeping factional fighting at bay and delivering on ambitious poll promises.



## Bombay HC CJ Justice Datta elevated to SC

New Delhi, Dec 11: Chief Justice of Bombay High Court Justice Dipankar Datta was Sunday elevated as a judge of the Supreme

Once he takes oath, the number of judges in the top court will go up to 28. The sanctioned strength of the Supreme Court, including the Chief Justice of India, is 34. The Department of Justice in the Union Law Ministry issued a notification announcing the appointment.

Born on February 9, 1965, Justice Datta turned 57 this year and will have a tenure till February 8, 2030, in the apex court where the retirement age is 65.

"In exercise of the powers conferred by clause (2) of Article 124 of the Constitution of India, the President is pleased to appoint Shri Justice Dipankar Datta, Chief Justice of the Bombay High Court, to be a Judge of the Supreme Court of India with effect from the date he assumes charge of his office.' the notification read.

His name was recommended by the Supreme Court Collegium then headed by Justice U U Lalit (now retired) in September last vear. Another notification issued by the ministry said Justice Sanjay Vijaykumar Gangapurwala, seniormost judge in the high court after Justice Datta, will be the Acting Chief Justice of the Bombay High Court after the incumbent relin-

quishes his charge. Justice Datta was elevated to the bench of the Calcutta High Court as a permanent judge on

June 22, 2006. He was made the Chief Justice of the Bombay High Court on April 28, 2020. Justice Datta is the son of late Justice Salil Kumar Datta, who served as a judge of the Calcutta High Court, and brotherin-law of Justice Amitava Roy, who was a former judge of the apex court.

### Cops break Sharmila's fast, shift her to hosp

Hyderabad, Dec 11: Police foiled the indefinite fast of YSR Telangana Party (YSRTP) president, Y S Sharmila and shifted her to a hospital here in the small hours of Sunday, after her health deteriorated. Sharmila had launched the indefinite hunger strike at the party headquarters here on Friday in protest against alleged denial of\_ permission to continue her statewide 'padayatra'.

Police forced media personnel, party leaders and cadres to move away from the location and foiled Sharmila's fast before she was "forcefully" shifted to the hospital at around 1.00 AM today, the party said. Sharmila, did not even consume water, which resulted in her health condition deteriorating rap-

Doctors, who were monitoring her health, stated that Sharmila's blood pressure and glucose levels had fallen to alarming levels, and expressed concern over dehydration, which could lead to electrolyte imbalance, potent enough to pose danger to her kidneys, a release from the party said.

Sharmila, daughter of former Chief Minister of undivided Andhra Pradesh Y S Rajasekhara Reddy, submitted a memorandum to the Ambedkar statue near Hussain Sagar lake on Friday in protest against denial of permission to her 'padayatra' and sought to hold a fast there.

As such fasts are not allowed at the Ambedkar statue, where activities like garlanding and submission of memoranda take place usually. Meanwhile, a statement from the private hospital, where Sharmila was admitted, said she has low blood pressure, weakness and giddiness besides dehydration and orthostatic hypotension.

## SUVs bought with Nirbhaya funds used by Shinde's faction

Mumbai, Dec 11: Some of the vehicles procured by the Mumbai Police earlier this year under the Nirbhava Fund to fight crime against women are being used for providing Y-plus security to the MLAs and MPs of the Shiv Sena faction led by Maharashtra Chief Minister Eknath Shinde, a police official said on Sunday.

In June this year, the city police force procured 220 Boleros, 35 Ertigas, 313 Pulsar motorcycles and 200 Activa two-wheelers using the ₹30 crore corpus that it had received under the Nirbhava fund. The development prompted the op-

position Shiv Sena (UBT), Congress and Nationalist Congress Party (NCP) to attack the Shinde-led government, as they asked if the security of the ruling legislators was more important than protecting

The Nirbhaya Fund is being given to the state governments by the Centre since 2013 to implement schemes related to women's safety." After the vehicles were procured in June, they were distributed to all 97 police stations, cyber, traffic and coastal police units in July," the official said.

"Of these vehicles, 47 Boleros were requisitioned from several police stations by the Motor



Transport Department of the Mumbai Police following an order from the VIP Security section of the state police stating that they are required for use as an escort vehicle for MPs and MLAs of the Shinde faction to provide Y-Plus security cover to them," he said.

However, 17 of the vehicles which were used for the security of these lawmakers were returned to police stations after the requirement was fulfilled, he added."But 30 Boleros are yet to be returned, which has impacted the police patrolling in the jurisdiction of respective police stations," the official said.

Hitting out at the state government, Maharashtra Congress spokesperson Sachin Sawant said, "Is the security of ruling MLAs more important than protecting women from abuse? It is appalling and outrageous to see the Nirbhaya Fund, which is meant for the Nirbhavas of Maharashtra being used for the security of MLAs. NCP spokesperson Clyde Crasto

said, "SUVs bought with Nirbhaya Fund diverted to provide Y-plus security to Shinde legislators. Shameful misuse of power by the Shinde-Fadnavis government. Eknath Shinde's legislators must hang their heads in shame."

President of NCP's Maharashtra unit Jayant Patil said the Nirbhaya Fund was set up by the United Progressive Alliance (UPA) government for the protection of women. "It is shocking that vehicles procured for helping the police to carry out their duties of protecting women are being misused for the protection of the breakaway MLAs. he said.



#### **Setback for BJP in Delhi, Himachal**

The BJP created a record in Gujarat. But a full-blown war has broken out in Delhi and Himachal BJP after the defeat of the party in MCD and Assembly polls. The BJP had not expected loss in Himachal Pradesh as J P Nadda belongs to the state and the party had decided to retain Jairam Thakur as

Chief Minister despite an adverse feedback. It may be music to the ears of young Anurag Thakur as he will now re-build the party. Anurag's name was doing the rounds earlier also as Chief Minister. Clearly, Himachal may see the return of the Dhumals. But the war is bitter in Delhi as most of its top leaders are sheepish after each one of them lost a majority of seats to AAP in their own constituency. The best performers were Gautam Gambhir and Dr Harsh Vardhan where they were able to ensure the victory of around 50% of wards under their belt. There is a demand that the entire BJP be overhauled and the majority of MPs be denied tickets in the 2024 Lok Sabha polls.

#### **Kejriwal gearing up**

nvind Kejriwal is gearing up to make a mark in the South beginning with Karnataka. The state will go to polls in

March next year and the AAP convener and Delhi Chief Minister Kejriwal thinks that people in Karnataka are looking for a new face and party. It is not as if AAP had not tried to expand its wings in Karnataka earlier. The AAP contested the Lok Sabha polls way back in 2014. But much water has flowed in the Cauvery since the AAP's maiden effort since then. The AAP roped in the former director of Infosys, V Balakrishnan, and the founder of India's first low-cost airline, Air Deccan, GR Gopinath. Kejriwal is busy chalking out strategy in Karnataka.

#### **Will Jaiswal** get extension?

t is no secret that the CBI has not been playing ball with the powers that be as was the case earlier. CBI's current director Subodh Kumar Jaiswal, a Maharashtra cadre IPS officer, is made of a different mettle. He is stickler to the rules and considered a tough nut. Since he was selected for the post in May 2021 by a panel composed of the PM, CJI and Leader of the Congress in Lok Sabha, the government also had some hesitation. The government is extremely comfortable with the ED's Director, Sanjay Mishra and gave him a record tenure of almost five years by giving one extension after the other. But the record of CBI under Jaiswal is no less. Since Jaiswal's tenure will end in May 2023, there are reports that the government may consider giving him an extension rather than bring a new person in the election year. The government has already amended the

law enabling it to extend the tenure of ED and CBI directors up to five years.

#### Agencies press pause button

All of a sudden, the Centre's probe agencies have pressed the pause button in Maharashtra, Punjab and a couple of other states. The ED, CBI and Narcotics Control Bureau are smoking the peace pipe. Though some leaders of rival parties may be summoned by these agencies, there will be no coercive action or pro-active approach. It is said that the BJP leadership wants some breathing space as the political churning is going on and a lot of behind the scenes activities are at a feverish pitch. Therefore, there is no need to accelerate cases against other senior leaders of the Shiv Sena (Thackeray), NCP and Congress.



#### Blast kills 3 in UK

London: Three people were killed and several others were missing after a "devastating" explosion Saturday flattened a low-rise apartment block in Jersey, authorities said. Chief Minister Kristina Moore confirmed at least three fatalities, after a suspected gas leak in the Channel island's port capital St Helier. Security camera footage showed a fireball engulfing the three-storey, bayside building followed by thick smoke. The fire was put out but emergency services were conducting "significant work" at the scene, and the rescue operation could take days, police said.

#### Shehbaz's son returns home

Lahore: Suleman Shehbaz, the absconding son of Pakistan Prime Minister Shehbaz Sharif, returned to the country in the early hours of Sunday after four years of self-exile in London, according to the PML-N, local media reported. His return comes days after the Islamabad High Court barred the Federal Investigation Agency (FIA) and NAB from arresting him in an assetsbeyond-means reference, while hearing his petition for protective bail that would enable him to surrender before a trial court. Suleman had been in London with his family since 2018 when the National Accountability Bureau (FIA) registered multiple cases against him ahead of the general election and he left Pakistan after appearing in a few hearings, Dawn reported.

#### SpaceX launches Japan's spacecraft

Washington: A Japanese startup's spacecraft was launched to the Moon Sunday in the country's first-ever lunar mission and the first of its kind by a private company. The launch was carried out by Elon Musk's SpaceX in Cape Canaveral in the US state of Florida after two postponements for additional pre-flight checks. The spacecraft, produced by Tokyobased startup ispace, blasted off aboard a Falcon 9 rocket, live footage of the launch showed.

#### **Dorothy Pitman Hughes no more**

New York: Dorothy Pitman Hughes, a pioneering Black feminist, child welfare advocate and community activist who co-founded Ms Magazine with Gloria Steinem and appeared with her in one of the most iconic photos of the second-wave feminist movement, has died. She was 84. She died in Tampa, Florida, at the home of her daughter and son-in-law. Her daughter said the cause was old age.

United Nations, Dec 11: The era of classifying terrorists as "bad" or "good" on the basis of "political convenience" must end immediately, a concept note circulated by India in the UN Security Council here has said, underlining that categorising terror acts by intent as religious or ideologically motivated will dilute the shared global commitment to fighting terrorism.

India, the current president of the 15-nation UN Security Council, will hold two signature events on reformed multilateralism and counter-terrorism to be chaired by External Affairs Minister S Jaishankar December 14 and 15.

India proposes to organise a briefing of the Security Council December 15 on 'Global counter-terrorism approach - principles and the way forward" under the 'Threats to international peace and security caused by terrorist acts'.

Ahead of the meeting, India's Permanent Representative to the United Nations Ambassador Ruchira Kamboj, in a letter to Secretary-General Antonio Guterres, asked that a concept note intended to guide the discussions on the topic be circulated as a document of the Security Council.

"The terrorist attacks in New York on September 11, 2001 were a turning point in the global approach to counter-terrorism. Since then, London, Mumbai, Paris, many parts of West Asia and Africa have also experienced terrorist attacks," the concept note last week said.

It added that these attacks highlight that the threat of terrorism is grave and universal and that terrorism in one part of the world seriously impacts peace and security in other parts of the globe.

"The threat of terrorism is transnational. Terrorist actors and their supporters, facilitators and financiers collaborate while remaining in different jurisdictions to organise acts anywhere in the world. A transnational threat can be defeated only by the collective efforts of all States Members of the United Nations," it said.

## Drones leave 1.5mn in darkness

Since October, Moscow has been targeting Ukraine's energy infrastructure with large waves of missile and drone strikes

Kyiv, Dec 11: All non-critical infrastructure in the Ukrainian port of Odesa was without power after Russia used Iranian-made drones to hit two energy facilities, leaving 1.5 million people without power, officials said Saturday.

"The situation in the Odesa region is very difficult," President Volodymyr Zelenskyv said in his nightly video address. "Unfortunately, the hits were critical, so it takes more than just time to restore electricity... It doesn't take hours, but a



few days, unfortunately."

Norway was sending \$100 million to help restore Ukraine's energy system, he added.

Serhiy Bratchuk, spokesperson for Odesa's regional administration, said electricity for the city's population will be restored "in the coming days," while complete restoration of the networks may take two to three months.

Washington, Dec 11: NASA's Orion capsule barreled through Earth's atmosphere and splashed down in the Pacific ocean Sunday after making an uncrewed voyage around the moon, winding up the inaugural mission of the US agency's Artemis lunar program 50 years to the day after Apollo's final moon landing.

The gumdrop-shaped Orion cap-

sors, plunked down in the ocean off Mexico's Baja California peninsula, executing a key demonstration of how future lunar astronauts would safely return to Earth.

The capsule committed to its fiery, 20-minute plunge at 24,500 miles per hour (39,400 kph) into Earth's atmosphere when it shedded its service module, exposing a heatshield that reached peak temperatures of nearly 5,000 degrees

Fahrenheit (2,760 degrees Celsius). Orion blasted off November 16 from the Kennedy Space Center at Cape Canaveral, Florida, atop NASA's towering next-generation Space Launch System (SLS), now the world's most powerful rocket and the biggest NASA has built since the Saturn V of the Apollo era.

# Russia remains India's OF TOP-10 COS LOSE ₹1.67TRN top oil supplier in Nov

India's appetite for Russian oil swelled ever since it started trading on discount as the West shunned it to punish Moscow for its invasion of Ukraine

New Delhi, Dec 11: Russia has for the second month in a row remained India's top oil supplier in November, surpassing traditional sellers Iraq and Saudi Arabia, according to data from energy cargo tracker Vortexa.

Russia, which made up for just 0.2 per cent of all oil imported by India in the year to March 31, 2022, supplied 9,09,403 barrels per day (bpd) of crude oil to India in November.

According to Vortexa, an energy intelligence firm, India imported 8,61,461 bpd of oil from Iraq in November and 5,70,922 bpd from Saudi Arabia. The United States was India's fourth largest supplier at 4,05,525 bpd.

As per Vortexa, India imported just 36,255 barrels per day of crude oil from Russia in December 2021, compared to 1.05 million bpd from Iraq and 9,52,625 bpd from Saudi Arabia.

There were no imports from Russia in the following two months, but they resumed in March, soon after the Ukraine war broke out in late February

India imported 68,600 bpd of Russian oil in March, while it increased to 2,66,617 bpd in the following month and peaked at 9,42,694 bpd in June. But in June, Iraq was India's top supplier with 1.04 million bpd of oil. Russia, in that month, became India's secondbiggest supplier.

Imports dipped marginally in the following two months. They stood at 8,76,396 bpd in September before rising to a record 9,35,556 bpd in October, according to Vortexa.

External Affairs Minister S Jaishankar December 7 told the Raiva Sabha that Indian refiners

The valuation of Infosys eroded by Rs 29,330.33 crore to Rs 6,60,184.76 crore and that of Bharti Airtel fell by Rs 7,705.08 crore to Rs 4,64,529.84 crore. ICICI Bank's mcap diminished by Rs 104.62 crore to Rs 6.49.102.84 crore.

However, Hindustan Unilever (HUL) added Rs 24,882.17 crore, taking its market valuation to Rs 6,39,370.77. HDFC Bank's valuation jumped Rs 13,493.73 crore to Rs 9,09,600.11 crore and that of Adani Enterprises advanced Rs 8,475.91 crore to Rs 4,55,521.65 crore.

State Bank of India's mcap grew by Rs 7,942.90 crore to Rs 5,50,157.69 crore and HDFC gained Rs 1,129.55 crore to Rs 4.86,755.77 crore.

# Power deficit drops to 0.2% in November from 2% in April '22

THE DISCOMS REDUCED THEIR DUES BY ₹24,680CR IN THE LAST SIX MONTHS TILL NOVEMBER 2022

New Delhi, Dec 11: Power deficit, or the gap between electricity required and supplied, has fallen from 2 per cent in April this year to 0.2 per cent in November 2022, as per latest government data.

However, the power deficit has increased sequentially from 0.1 per cent (124 million units) in October 2022. It stood at 0.2 per cent (233 million units) in November 2021.

The data showed that the deficit was 2.752 million units (MU) in April this year, which came down to 199 MU in November 2022. The power deficit was 609 MU (0.4 per cent) in May, 796 MU (0.6 per cent) in June, 434 MU (0.3 per cent) in July, 465 MU (0.4 per cent) in August and 312 MU (0.2 per cent) in September.

During the April-November period of this fiscal, power deficit rose to 0.6 per cent from 0.4 per cent in the same period in 2021.

Power deficit in actual terms increased to 5,691 MU in April-November 2022 from 4,058 MU in the year-ago period. Power deficit in the entire fiscal 2021-22 was 5,787 MU (0.4 per cent).

Union Power Minister RK Singh recently told the Lok Sabha in a written reply that against a peak demand of 215 GW, capacity of 408.7 GW has already been installed

and 25,580 MW of thermal power capacity and 76,130 MW of renewable energy capacity is under installation

The whole country has been connected by one integrated grid which can transfer 112 GW power from one corner of the nation to another, he had stated.

Experts said the meagre power deficit is either because of technical reasons or due to discoms' inability to pay for the required power supply.

They also said the power deficit would be completely eliminated as the government has taken many steps to improve the financial health of the discoms, with main focus on reducing their outstanding dues towards generating com-

panies (gencos). "With the implementation of Electricity (LPS and Related Matters) Rules, 2022, remarkable improvement has been seen in recovery of outstanding dues of Suppliers including Generating Companies, Transmission Companies and Traders," a power ministry statement had stated.

The total outstanding dues of states which were at Rs 1,37,949 crore as June 3, 2022 have been reduced by Rs 24,680 crore to Rs 1,13,269 crore with timely payment of just four EMIs (equate monthly installments), it had added.

## Air India nears historic order for up to 500 jets

Paris, Dec 11: Air India is close to placing landmark orders for as many as 500 jetliners worth tens of billions of dollars from both Airbus and Boeing as it carves out an ambitious renaissance under the Tata Group conglomerate, industry sources said Sunday.

The orders include as many as 400 narrow-body jets and 100 or more wide-bodies, including dozens of Airbus A350s and Boeing 787s and 777s, they said. speaking on condition of anonymity as finishing touches are placed on the mammoth deal in coming days.

Such a deal could top \$100 billion dollars at list prices, including any options, and rank among the biggest by a single airline in volume terms, overshadowing a combined order for 460 Airbus and Boeing jets from American Airlines over a decade ago.

Even after significant expected discounts, the deal would be worth tens of billions of dollars and cap a volatile year for an industry whose jets are back in demand after the pandemic but which is facing mounting industrial and environmental pressures.

## THE GHOST OF INSTAGRAM HAUNTS MICROSOFT'S FUTURE

US Federal Trade Commission December 8 sued Microsoft to block its \$69 billion acquisition of video-game developer Activision Blizzard, arguing that the combination would hurt consumers because it would give the software company an unfair edge against competitors of its Xbox gaming consoles and cloud-gaming business

New York, Dec 11: Facebook is Microsoft's antitrust boogeyman. The US regulatory agency, the Federal Trade Commission, is seeking to block the software titan's \$69 billion deal for gaming giant Activision Blizzard, partly to stop domination of the industry as it evolves

The FTC's leader Lina Khan might be making up for regulators who waved through Mark Zuckerberg's \$1 billion purchase of Instagram. Though Microsoft's deal is different, punishment under Khan's regime seemed inevitable. The FTC is concerned that Microsoft, the owner of the Xbox

gaming console, will withhold popular games made by Activision including "Call of Duty" and "World of Warcraft" from competing platforms including Sony's PlayStation and Nintendo's Switch. Microsoft has tried to appease this concern. This month, the company led by Satya Nadella agreed to offer games to Nintendo and Sony for 10 years.

The question is what happens after that. Microsoft could try to corner the market by forcing consumers to not only buy the Activision games from Microsoft, but the platform as well. It's not a stretch either. Outlook, Teams, and  $other\,Microsoft\,operating\,systems$ are now all a crucial part of daily life that enterprises buy collec-



tively, not to mention the \$1.8 trillion giant's cloud capabilities. Still, how the future shakes out

#### **Iranian currency** slides to new low

Dubai, Dec 10: Iran's troubled currency fell to a new low against the US dollar Saturday amid continued unrest and the country's increasing isolation in the face of Western criticism of its security crackdown and ties to Russia.

The dollar was selling for as much as 370,200 rials on the unofficial market Saturday, up from 367,300 Friday, according to the foreign exchange site Bonbast.com.

The rial has lost 13.8% of its value since nationwide protests erupted after the death in police custody of a 22-year-old Kurdish Iranian woman, Mahsa Amini, September 16. The unrest poses one of the biggest challenges to theocratic rule in Iran since the 1979 Islamic Revolution.

The economic Ecoiran website said traders saw little hope for the revival of Iran's nuclear deal with world powers and saw Western pressure increasing over Tehran's crackdown against the protests and its military ties with Russia.

These include the alleged sales of drones used by Russia in the war in Ukraine, which Tehran and Moscow have denied.

"Some (traders) say current international conditions are such that the chances of reviving the nuclear deal are low, and this has caused cautious buvers to enter the dollar market," Ecoiran said. "The price of this currency is on an upward path."

"From the point of view of some (traders), this news (of U.S. and Western pressure on Iran) can attract the attention of currency speculators," Ecoiran said, adding that the central bank may still be able to support the rial.

Al Khor, Dec 11: Kylian Mbappé's immense sense of joy was written all over his face after Saturday's game. ### Ban threat looms large on Messi

Disciplinary proceedings start against Argentina skipper

Doha, Dec 11: Argentina may face a huge crisis ahead of their World Cup semifinal match against Croatia. Sources said Sunday that FIFA has initiated disciplinary proceedings against Argentina skipper Lionel Messi following the criticism that he had lashed out at the match referee Antonio Mateu Lahoz after the quarterfinal game Friday against the Netherlands.

It has also been alleged that during the quarterfinal game, Messi was involved in an argument with Dutch coach Louis van Gaal. Messi had apparently rushed to the touchline and got into an argument with the veteran coach. It has also been alleged that during a TV interview immediately after the game, Messi had abused a Dutch player. If any one of these allegations is proved, then Messi could face a three-game ban. If that happens, then Messi will miss not only the semifinal, but also the final if Argentina qualify for the summit clash.

The game between Argentina and the Netherlands bordered on high tension with players and the coaching staff coming close to clashing on a number of occasions. Apart from verbal spats, fights broke out during and after the game. Denzel Dumfries of the Netherlands received two yellow cards and was sent off after the penalty shootout. After the match, Lahoz was criticized by Messi and Argentinian goalkeeper Amy Martinez. FIFA has decided to open disci-

plinary proceedings not just against Messi, but also against the Argentina Football Association. The association may also face stiff financial penalty for the actions of the players on the field. It will indeed be a huge blow for

Argentina if Messi is banned from taking part in the semifinals. He has been the fulcrum of the side. In the quarterfinals against the Dutch, he created one goal and scored the other from a penalty.

The semifinal between Argentina and Croatia will be played Friday.



# Moroccans across the world erupt in ecstacy

#### HISTORIC FEAT BY ATLAS LIONS AS THEY REACH WC SEMIFINALS

Rabat, Dec 11: Ecstatic Moroccans poured into the streets of their capital and in cities across the North African country Saturday, waving flags, honking horns and lighting flares to celebrate the national soccer team's historic victory over Portugal at the World Cup.

Morocco beat the Portuguese 1-0 in Qatar, knocking Cristiano Ronaldo out of the tournament and making the Atlas Lions the first African and first Arab team to reach the World Cup semifinals.

The capital, Rabat, was bursting with joy while Morocco fans also celebrated in the streets of Doha and in cities across Europe, where many Moroccans live.

"We were so stressed as if we were on the pitch with the players, but now we want the trophy," said Mohamed Amine, who was celebrating here. "The players, this team lifted Morocco's reputation high among the football nations of the world," he added.

The victory has Morocco fans full of confidence for the days ahead even though they now face defending champions France in the semifinals Wednesday.

"I am so happy that I don't even know if I can express myself, but if we are here now, I believe that we can make it to the final," Yasmine Benmehredj said during celebrations in the Moroccan capital. "I think we can win this World Cup."

In Qatar, hundreds of elated fans clad in green and red outside Al Thumama Stadium celebrated Morocco's win, chanting, ululating, banging on drums and waving the national flag. Some chanted: "Congratulations to us for this beginning! It will only go on and on!"

"This is unbelievable. It's the first time ever," said Saleh al-Rayes, a 27-year-old fan from Saudi Arabia in Doha. As an Arab at the first World Cup held in the Middle East, al-Rayes said he feels a sense of inclusion and representation in the world of soccer, a spot that has been dominated by European and South American teams. "You come in as an underdog and then you win. It's Arab pride," al-Rayes said. "All Arab countries were here in the stadium supporting Morocco," he added.

Morocco's phenomenal run in Qatar also reverberated Saturday across Africa. "Continental history!" the Confederation of African Football wrote on Twitter after Morocco's victory.

### **Injured Rohit ruled** out of first Test against Bangladesh

Chattogram, Dec 11: India captain Rohit Sharma was ruled out Sunday of the first Test against Bangladesh, starting here Wednesday, due to a thumb injury. Rohit had hurt his left thumb December 7 while fielding in the second ODI against Bangladesh in Mirpur. Sources had earlier also said that chances of Rohit being available for the Test series against Bangladesh was doubtful. However, the BCCI was waiting for the official confirmation

from its medical team. "India captain Rohit Sharma met with a specialist in Mumbai for his left thumb injury, which he sustained during the second ODI against Bangladesh. He has been advised appropriate management for this injury and will not be available for the first Test against Bangladesh," the BCCI said in a statement.

"The BCCI medical team will take a call on his availability for the second and final Test at a later stage. The All-India Senior Selection Committee has named Abhimanyu Easwaran as his replacement for the first Test," the BCCI added.

Pacer Navdeep Saini and uncapped Saurabh Kumar were named as replacements for injured Mohammad Shami and Ravindra Jadeja earlier by the BCCI. Left-arm pacer Jaydev Unadkat was also added to the Indian squad a couple of days back.

# India level series with super over win
